# **CM Revanth Reddy Addresses Key Issues in Informal Chit Chat**

**TPN, Telangana:** Chief Minister Revanth Reddy held an informal "Chit Chat" session today, where he made several strong statements regarding ongoing HYDRA operations and other pressing matters in Telangana. He emphasized that no one, regardless of their political affiliation, will be exempt from the demolition drives led by HYDRA, the Hyderabad Disaster Response and Assets Monitoring and Protection Agency.

Revanth Reddy highlighted that HYDRA is now targeting illegal constructions beyond the Outer Ring Road (ORR), including many celebrity and politicianowned farmhouses. He expressed concerns about the environmental impact, particularly with drainage being released into Osmansagar and Himayatsagar. "Should the people of Hyderabad drink that water? That's why the demolitions," he said.

The Chief Minister also pointed out that KTR, "if you took a farmhouse on lease but you failed to mention this in his affidavit, you should be disqualified", questioning the legality of the farmhouses. He emphasized that HYDRA's actions are impartial, targeting illegal constructions regardless of whether they belong to example of Congress leader Pallamraju's importance of students' futures. building, which was one of the first to be

demolished.

Revanth Reddy announced plans to elevate HYDRA to the status of a police station, further empowering the agency. He challenged anyone to provide a list of illegal constructions by his family members, promising to demolish them as well.

The Chief Minister also touched on the controversial 111 G.O, stating that while the previous government attempted to abolish it, the regulations remain intact. He accused the BRS party of transferring its vote bank to the BJP during the parliamentary elections, suggesting that this was why Kavitha received bail in five months, while other accused, like Kejriwal and Sisodia, have not.

Revanth Reddy addressed the issue of loan waivers, noting that his government has deposited Rs. 17,933 crores so far. He criticized Harish and KTR for their remarks on the loan waiver scheme and invited them to submit any grievances to the collectors for further review.

#### **Industrial Smart Cities**

## 2 for Andhra Pradesh, 1 for Telangana





**TPN**, **New Delhi**: In a significant move, the Union Council of Ministers, led by Prime Minister Narendra Modi, has approved the development of 12 industrial smart cities across ten states, with Andhra Pradesh securing two and Telangana one. These cities will be part of six major industrial corridors planned to boost economic growth and create job opportunities across the country.

Union Minister Ashwini Vaishnaw announced that the central government has allocated Rs. 28,602 crore for these projects. The industrial smart cities will be located in Orvakal and Kopparthy in Andhra Pradesh, and Zaheerabad in Telangana, among other locations across India.

Union Minister Ram Mohan Naidu, speaking at a press meet in Delhi, confirmed that Kopparthy in Kadapa district will be developed into a smart city, with 2,596 acres of land dedicated to this project. The industrial hub in Kopparthy is expected to create 54,500 jobs. Similarly, Orvakal in Kurnool district will have an industrial hub developed on 2,621 acres, generating employment for 45,000 individuals.

The government will invest Rs. 2,137 crore in the development of Kopparthy and Rs. 2,786 crore in Orvakal. Additionally, Naidu mentioned that the central government would also focus on developing the Bengaluru-Hyderabad and Visakhapatnam-Chennai industrial corridors as part of this initiative.

## **AMARARAJA BATTERIES PLANT** IS GOING BACK TO AP FROM **TELANGANA..?**

TPN, Telangana: There is a buzz that Amararaja Batteries is planning to shift their plan of installing a new plant to Andhra Pradesh. In May 2023, due to protests by local people, the project has not yet started, and no construction has taken place. The company was supposed to invest ₹9,600 crores over a span of 10 years. It was projected that thousands of jobs would be created due to

this investment. Recently, Mr. KTR, who was the key person in bringing the company to Telangana, has stated that the company is planning to go back to AP. He blamed Mr. Revanth Reddy, stating that the Chief Minister of Telangana is not caring and not capable of stopping the company's shift.

Amararaja Batteries, a company owned by the Galla family of Chittoor, was founded by Mr. Galla Ramachandra Naidu in 1985. The company has become the largest manufacturer of automotive batteries in India. His wife, Galla Aruna Kumari, and his son, Galla Jayadev, are involved



in politics and are currently with the Telugu Desam Party.

In 2022, the then Chief Minister of AP, Mr. YS Jaganmohan Reddy, allegedly started troubling the company as part of a political vendetta. The AP Pollution Control Board issued notices to the company and asked them to close two plants, citing high pollution as the reason. Mr. Galla Jayadev, who was the MP of Guntur at that time, went to the courts and obtained a stay order.

However, the repeated attempts by the AP Government led Mr. Galla Jayadev to leave politics and start the plant outside

Pradesh. Andhra received an invitation from the Government of Telangana under BRS and laid the foundation stone in Mahabubnagar District to manufacture Lithium-Ion Batteries, which are key for electric vehicles.

Now, the situation in AP has changed. The government has changed, and the TDP-JSP-BJP alliance is in power. As

there has been no progress in the plant installation in Telangana and with a favorable government now in AP, Mr. Galla Jayadev is reportedly considering shifting the plant installation to Andhra Pradesh.

As per the buzz, he is now in talks with the Chief Minister, Mr. N. Chandrababu Naidu. Moreover, he had a meeting with Mr. Pawan Kalyan, who holds the portfolio of Environment. Since the company had faced pollutionrelated issues, he consulted with Deputy CM Mr. Pawan Kalyan to sort out that issue. Very soon, they are expected to announce their decision.

# CM Launches 10-Day 'Praja Palana' Program to Streamline Ration and Health Card Distribution



TPN, Telangana: Telangana Chief Minister of digital health cards, inspired by France's A. Revanth Reddy has announced the "Praja Palana" program, a 10-day initiative starting on September 17, aimed at streamlining the distribution of ration and digital health cards across the state. ## **Congress MLA Kale** Yadaiah's Vehicle Attacked with Eggs by **Party Cadre**

TPN, Telangana: Congress MLA Kale Yadaiah's vehicle was attacked with eggs by disgruntled party workers in Chevella, Telangana. Yadaiah, who recently shifted from the Bharat Rashtra Samithi (BRS) to Congress, has been facing growing discontent from within the party ranks, despite the initial enthusiasm surrounding his defection.

The incident occurred during Yadaiah's visit to distribute Kalyana Lakshmi and Shaadi Mubarak cheques to beneficiaries in the constituency. The event, however, was disrupted when Telangana Congress workers, allegedly followers of Chevella Congress in-charge Bheem Bharadwaj, threw eggs at Yadaiah's vehicle in a public display of protest. The act drew significant attention and led to a temporary halt in the proceedings.

The protest reportedly stems from allegations by Bharadwaj's supporters, who claim that Yadaiah has not been cooperative and has failed to keep them informed about government actions and developments in the constituency. The situation escalated when supporters of Bharadwaj clashed with Yadaiah's followers, leading to further disruption.

The police were called in to intervene, and they managed to disperse the clashing groups, restoring order to the scene. The distribution of cheques, however, was halted and could not proceed as planned.

## Colleges Owned by BRS MLA Receive Notices for Alleged Illegal Construction

TPN, Telangana: Revenue officials issued notices to MLR Institute of Technology (MLRIT) and the Institute of Aeronautical Engineering in Dundigal, located in the Medchal-Malkajgiri district on the outskirts of Hyderabad. These colleges are owned by Bharat Rashtra Samithi (BRS) MLA Marri Rajasekhar Reddy. The notices are part of an ongoing crackdown on unauthorized constructions, targeting properties alleged to be built in the Full Tank Level (FTL) and Buffer Zone of Chinna Damaracheruvu Lake.

The two institutions are part of a chain of educational facilities run by the family of BRS leader Malla Reddy, who is the father-in-law of Rajasekhar Reddy. This action is a continuation of the Hyderabad Disaster Response and Asset Protection Agency (HYDRAA) efforts to address encroachments on water bodies, parks, and open lands.

Recently, the focus of HYDRAA has expanded to include educational institutions after a police case was filed against BRS MLA Palla Rajeshwar Reddy. He is accused of constructing Anurag University in the buffer



zone of a water body at Venkatapuram, Medchal-Malkajgiri district. The allegations state that the Anurag Group of Institutions, under Gayatri Educational Trust, illegally built a college building, damaging Nadam Cheruvu, a tank restored under Mission

Kakatiya Phase-IV.

The crackdown by HYDRAA has included demolitions of structures owned by various prominent figures. This includes recent demolitions of properties belonging to popular actor Nagarjuna, AIMIM politicians, and others. The agency is targeting educational institutions built by Rajeshwar Reddy, Malla Reddy, and AIMIM MLA Akbaruddin Owaisi, which are alleged to be in the FTL and buffer zones of lakes.

On Tuesday, BJP corporators approached **HYDRAA** Commissioner A. V. Ranganath request action against College, which is reportedly built in the FTL of Salakam Cheruvu Lake. Ranganath confirmed

that several parents had requested postponement of demolitions during the ongoing academic year to avoid disrupting students' education.

Kavitha was initially arrested by the Enforcement Directorate from her Banjara Hills residence in Hyderabad on March 15, followed by her arrest by the CBI from Tihar Jail on April 11. Despite these challenges, Kavitha remains resolute in her belief that she will be exonerated.



## **Revanth Reddy to Install Telangana Thalli** Statue, Criticizes KCR's Leadership

TPN, Telangana: Telangana Chief Minister A. Revanth Reddy announced that the long-awaited angana Thalli statue will be placed in the state's secretariat on December 9, 2024. Speaking at the groundbreaking ceremony for the statue, Reddy highlighted the importance of the event, calling December a day of celebration for the people of Telangana. He used the occasion to criti-



Revanth Reddy accused KCR's government of neglecting Telangana's cultural heritage, pointing out that despite spending approximately ₹22.5 lakh crore over 10 years, they couldn't allocate even ₹1 crore for the Telangana Thalli statue. He emphasized that this reflected a larger problem, accusing KCR of equating himself with Telangana and sidelining the state's true identity. According to Reddy, KCR's leadership was more focused on personal gains rather than serving the cultural and public interests of the people.

Furthering his criticism, Revanth Reddy spoke out against the construction of Pragathi Bhavan, the official residence of KCR, which he said distanced the government from its people. He argued that the purpose of a secretariat is to serve the state, ensure public prosperity, and allow ministers to remain accessible. However, he noted that the previous govern-



ment had blocked public access to Pragathi Bhavan, effectively cutting off the administration from the people it was supposed to represent. Reddy assured that his administration would prioritize transparency and accessibility, ensuring that the secretariat would become a place where public concerns are addressed, rather than ignored.

In a politically charged move, Revanth Reddy also announced the installation of a Rajiv Gandhi statue in front of the secretariat, along with the Telangana Thalli statue. He defended the decision by pointing out that the Martyrs Memorial, which honors those who died for Telangana's creation, already exists in the area. He argued that a statue of Rajiv Gandhi, given his significant role in India's governance, was appropriate alongside the memorial. Although Reddy did not directly mention any names, his comments appeared to be aimed at KT Rama Rao (KTR), the working president of the BRS. He suggested that some people were trying to create controversy over the space, intending to use it for different purposes.

## KTR Accuses Revanth Reddy of Hypocrisy Over Rajiv Gandhi Tribute

TPN, Telangana: BRS president working KT Rama Rao (KTR) criticized Telangana Chief Minister A. Revanth Reddy for what he described as "hypocritical love" towards Rajiv Gandhi. On Wednesday, August 28, KTR took to X (formerly Twitter) to express his views, accusing Revanth of inconsistency and betrayal in his political stance.



KTR pointed out that Revanth's newfound admiration for Rajiv Gandhi was insincere and opportunistic. He alleged that Revanth, after becoming the President of the Pradesh Congress Committee (PCC) through questionable means, was now trying to portray a false image of loyalty to the Gandhi family. KTR reminded the public that Revanth had previously criticized Sonia Gandhi, calling her derogatory names such as a demon and a ghost. He suggested that this sudden show of respect for Rajiv Gandhi was a political maneuver aimed at gaining favor with Congress leadership.

Further intensifying his attack, KTR labeled Revanth as a "betrayer" of Telangana. He argued that it would be shameful for Revanth to install the Telangana Thalli statue, a symbol of Telangana's cultural pride, given his past actions and stance on Telangana's statehood. KTR asserted that those who were against the formation of Telangana, alluding to the Congress leadership, should not be honored in the state. ## **Harish Rao Criticizes Government** Over Failure to Support Farmers

TPN, Telangana: Former Minister and MLA Harish Rao has publicly criticized Chief Minister Revanth Reddy for failing to support farmers effectively, particularly regarding the procurement of pulses. In an open letter addressed to CM Reddy, Rao expressed disappointment over the government's handling of agricultural issues and the unmet promises made to farmers.

Rao highlighted that despite the central government announcing a minimum support price (MSP) of ₹8,682 per quintal for pulses this year, no buyers have adhered to this rate. Consequently, farmers have been forced to sell their produce at much lower prices, ranging between ₹6,000 and ₹6,500 per quintal, resulting in a loss of over ₹2,500 per quintal. He

criticized private traders for exploiting the situation and turning it into a game at the expense of farmers' welfare.

The former minister condemned the government's failure to establish procurement centers under Markfed, stating that this negligence has turned into a curse for pulse farmers. Rao pointed out that farmers in districts such as Khammam, Mahbubabad, Vikarabad, Kamareddy, Sangareddy, Narayanpet, and Suryapet are suffering due to the lack of proper procurement infrastructure.

Rao accused the government of reneging on its promise to provide an additional ₹500 bonus over the MSP, which was supposed to benefit



farmers. He criticized the government for failing to deliver on its manifesto promises and for neglecting its responsibility to purchase crops at the support price.

In his letter, Rao emphasized that under Congress rule, the process of cultivating and selling crops has become increasingly challenging for farmers. He urged the state government to wake up to the problems faced by the agricultural community and to implement effective measures, including the immediate setup of procurement centers through Markfed. Rao demanded that the government act to prevent further losses for farmers and to address the inadequacies in its agricultural policies.

# Madhavi Latha Accuses MIM of Targeting Hindus Amidst Temple Vandalism

TPN, Hyderabad: BJP leader Madhavi Latha, has made serious allegations against the MIM (Majlis-e-Ittehad-ul-Muslimeen) party, claiming that they are obstructing peace among Hindus. Her statements come in the wake of a recent incident where idols were reportedly destroyed at a temple located opposite the Santosh Nagar police station.

In response to the vandalism, Madhavi Latha led a protest at the temple, during which participants chanted "Rama Naam" as a form of demonstration. Following the protest, a case was filed against her, a move she describes as an attempt to intimidate her and undermine her political efforts.

Latha alleges that the destruction of the temple idols is part of a broader strategy by MIM to destabilize the situation and make it difficult for Telangana Chief Minister Revanth Reddy, who is involved in efforts to protect local ponds from encroachment. She suggests that the vandalism is also meant to pressure the Chief Minister by creating disturbances similar to those experienced during the BRS

In her remarks, Latha questions the MIM's authority to challenge the Chief Minister and criticizes their influence over the state's political landscape. She asserts that while many may be intimidated by MIM, she is not and is prepared to confront them directly.

Latha has also raised concerns about the occupation of Wakf Board lands and urged the Muslim community to remain vigilant. She warns against any attempts to disrupt the upcoming Vinayaka Chavithi celebrations and calls for a collective effort to maintain peace and security.

## Activist Calls for Action on Himayathsagar **Reservoir Encroachments**

TPN Hyderabad: Activist Lubna Sarwath has raised concerns about unauthorized constructions in the full tank level (FTL) and afforestation foreshore zone of the Himayathsagar drinking water reservoir. She has urged Telangana Chief Minister K. Chandrashekar Rao and Hyderabad Disaster Response and Assets Monitoring and Protection (HYDRA) Commissioner AV Ranganath to take immediate action to address these encroachments.

In her letter to HYDRA. Sarwath highlighted the ongoing demolitions of illegal structures by the agency, which have so far reclaimed over 40 acres of land. These demolitions have affected properties linked to various political figures from Congress, BJP, and All India Majlis-e-Ittehadul Muslimeen



(AIMIM). The effort is part of a broader initiative to remove encroachments from lake beds and other protected areas.

Sarwath's letter references multiple sources to substantiate her claims. She cites a preliminary digital study of satellite maps from the National Remote Sensing Centre (NRSC), the Hyderabad Metropolitan Development Authority (HMDA) Master Plan 2031, Google Earth satellite imagery, and the Dharani land portal. According to these sources, significant portions of Kotwalguda V and Shamsabad M in the Ranga Reddy district fall within the afforestation foreshore zone for the Himavathsagar reservoir and some parts are within the FTL of the reservoir.

She emphasized that these constructions threaten the ecological balance and water resource management of the reservoir. Himayathsagar urging authorities to act promptly to remove these illegal encroachments and restore the designated zones.

## SBI Branch Manager and Associates Arrested in ₹175 Crore Fraud Case

TPN Hyderabad: The manager of The a State Bank of India (SBI) branch in Hyderabad and his accomplices have been arrested in connection with a massive ₹175 crore fraud case. The accused, Madhu Babu Gali, 49, who managed the SBI branch in Shamsheer Gunj, and Upadhya Sandeep Sharma, 34, a gym trainer, have been charged with facilitating fraudulent transactions money diversion in exchange for commissions.

Cybersecurity Headquarters in Hyderabad uncovered the scam after numerous complaints were flagged on the NCRP portal. These complaints related to six SBI accounts in the Shamsheer Gunj branch, which were identified for suspicious activity. Data analysis revealed that substantial transactions occurred in these accounts within March and April 2024, totaling around ₹175 crore, and involved approximately 600 complaints.

The investigation revealed that the primary fraudster, based in Dubai, and his five associates deceived impoverished individuals opening bank accounts, which were then exploited for cybercrimes and hawala operations. On August 24, authorities arrested Mohammed Shoeb Taugeer and Mahmood Bin Ahmed Bawazir, who were crucial to the scheme. Shoeb managed the account openings and document

preparations, while Bawazir handled the funds.

The fraudsters convinced poor individuals to open six accounts at the SBI Shamsheer Gunj branch by offering them commissions. These accounts were heavily transacted in March and April, with funds diverted to Dubai via cryptocurrency. The accomplices followed instructions from the Dubai-based mastermind, using the accounts for large-scale

financial crimes.

The public is advised against opening bank accounts for others or engaging in suspicious activities. If you suspect involvement in such schemes, report to 1930 or cybercrime.gov.in.

The operation, led by Deputy SPs Hari Krishna and KVM Prasad under the supervision of SP Devender Singh, involved Inspectors D Srinu, Mahender, and various constables.



The Nirbhaya case involved a 23-year-old paramedic student who was brutally raped and assaulted in a moving bus in Delhi in 2012, leading to her death and widespread protests across India.



President Murmu further commented on society's tendency to forget such heinous crimes, stating, "Societies that are scared to face history resort to collective amnesia." She added, "Time now for India to face history squarely."

The President called for a comprehensive approach to tackle the issue, saying, "Let us deal with this perversion in a comprehensive manner to curb it right at

the beginning."

The recent incident at the RG Kar Medical College and Hospital in Kolkata, where a 31-year-old doctor was raped and murdered on August 9, has sparked nationwide outrage. Junior doctors across the country have refused to see non-emergency patients, demanding justice for the victim and greater safety measures for women in hospitals.

## Former Jharkhand CM Champai Soren Joins BJP, Cites Threat to Tribal Identity

Assam Chief Minister Himanta Biswa Sarma alleged earlier in the day that Soren had been under surveillance by the Jharkhand Police for the past five months. Sarma claimed that two sub-inspectors were caught monitoring Soren at a Delhi

Champai Soren, who briefly served as the 12th Chief Minister of Jharkhand, explained that his decision to join the BJP was driven by a need to protect tribal identity in the state's Santhal Pargana region, which he claims is under threat from "rampant" infiltration from Bangladesh.

"The dignity of our mothers, sisters, and daughters is in danger," Soren said, citing the increasing number of infiltrators in areas like Pakur and Rajmahal. He argued that only the BJP is serious about addressing these issues, while other parties are focused on vote bank politics.

Soren also expressed frustration with the JMM leadership, claiming that his government's programs were abruptly canceled without his knowledge, leaving him with no platform to voice his concerns.

## Over 24,000 Indian-Americans Set to Attend 'Modi & US' Event in Long Island

More than 24,000 Indian-Americans have registered to attend the "Modi & US' Progress Together" event on September 22, which will be held at the Nassau Veterans Memorial Coliseum in Long Island, New York. The event, hosted by the Indo-American Community of USA (IACU), is set to be a major gathering celebrating the vibrant Indian-American community.

The Nassau Veterans Memorial Coliseum, with a seating capacity of 15,000, will host Prime Minister Narendra Modi, who is scheduled to deliver a keynote address. The event will also feature cultural performances and appearances by notable Indian-Americans from various fields including business, science, entertainment, and the arts.

The IACU has reported that registrations have come through 590 community organizations across the United States, with strong participation from the tri-state area. "We're committed to ensuring as many people as possible can participate in this historic event," said a key organizer. The organizers are working to expand seating arrangements and prioritize final seat allocations based on confirmations from attendees.

In addition to Modi's address, the event will showcase the diverse cultural tapestry of the Indian-American community, including representation from various religious groups such as Jews, Zoroastrians, Jains, Christians, Sikhs, Muslims, and Hindus, as well as speakers of different Indian languages like Hindi, Telugu, Punjabi, Tamil, Bengali, Malayalam, and Gujarati.

This gathering follows Modi's previous high-profile events in the U.S., including his address at Madison Square Garden in



2014 shortly after becoming Prime Minister and the "Howdy Modi" event in 2019 at Houston's NRG Stadium, where he was joined by former President Donald Trump. Prime Minister Modi is also scheduled to address the UN General Assembly on September 26. His visit to the U.S. comes amid a competitive presidential race between Donald Trump and Democratic nominee Kamala Harris, who is the first woman of Black and Indian heritage to be nominated for the presidency.

The UN General Assembly's high-level debate will take place from September 24-30, with UN Secretary-General António Guterres presenting his report before the debate begins. The UN will also host the Summit of the Future on September 22-23, aimed at forging a new international consensus on global challenges.

This event marks a significant moment for the Indian-American community and underscores the ongoing strong ties between India and the United States.



Japan Issues Highest Storm Warning as Typhoon Shanshan **Approaches** Kyushu

Shanshan, the strongest storm of the year, bears down on the southern island of Kyushu. Authorities have issued the highest "special warning" for violent storms, high waves, and storm surges, advising around 56,000 people to evacuate from the affected areas.

Chief Cabinet Secretary Yoshimasa Hayashi warned that Typhoon Shanshan is expected to bring extremely strong winds, with gusts reaching up to 252 kilometers per hour (157 miles per hour), and heavy rainfall. "It is expected that violent winds, high waves, and storm surge at levels that many people have never experienced before may occur," Hayashi said.

Japan is on high alert as Typhoon the region, prompting major disruptions. Auto giant Toyota announced the suspension of production at all 14 of its factories due to the storm's approach. The Japan Meteorological Agency (JMA) predicted that southern Kyushu could receive up to 1,100 millimeters (43 inches) of rain in the 48 hours leading up to Friday morning, which is about half of the region's annual average.

In central Aichi prefecture, a landslide triggered by the storm buried a house in Gamagori, leaving two people unaccounted for. Rescuers managed to pull a woman in her 70s from the rubble, though she was found unconscious and not breathing. Efforts continue to locate the remaining missing individuals.

dramatic, with video footage from NHK TV showing roof tiles being blown off, broken windows, and fallen trees. Local resident reports from Miyazaki described the intense storm, with one resident saying the carport roof was completely blown away and that the shaking felt like an earthquake.

The typhoon has caused significant travel disruptions as well. Japan Airlines canceled 172 domestic and six international flights, while ANA canceled 219 domestic and four international flights over Wednesday, Thursday, and Friday, affecting approximately 25,000 passengers. Kyushu Railway has suspended some Shinkansen bullet train services and warned of potential further disruptions.

In a significant development, Bangladesh's caretaker government has lifted the ban on Jamaat-e-Islami, the country's main Islamic party, and its affiliated groups. The decision came after a review found insufficient evidence linking the party to "terrorist activities," according to a gazette notification issued on Wednesday.

The ban was initially imposed by former Prime Minister Sheikh Hasina's administration under an anti-terrorism law. The government had accused Jamaat-e-Islami of inciting violence during student-led protests that escalated into a broader uprising against Hasina, leading to her resignation and departure to India on August 5.

The caretaker government, which assumed power following Hasina's resignation, concluded that there was "no specific evidence of involvement of Jamaat" or its affiliates in terrorist activities. The party has consistently denied allegations of violence and condemned the previous ban as "illegal, extrajudicial, and unconstitutional."

Jamaat-e-Islami has faced legal and political challenges in recent years. Since 2013, the party has been unable to contest elections due to a court ruling that deemed its registration inconsistent with Bangladesh's secular constitution.

Shishir Monir, a lawyer representing Jamaat-e-Islami, announced plans to file a petition early next week with the Supreme Court to seek the restoration of the party's registration.

#### Altercation Reported at **Arlington National Cemetery During Trump Visit**



Arlington National Cemetery confirmed on Tuesday that an incident involving two members of Republican presidential candidate Donald Trump's campaign staff had occurred during Trump's visit earlier this week. The incident reportedly involved a "verbal and physical altercation" between the campaign staff and a cemetery official, according to NPR.


Trump visited Arlington National Cemetery on Monday to participate in a wreath-laying ceremony commemorating the 13 servicemembers who lost their lives during the U.S. withdrawal from Afghanistan in 2021. The ceremony was intended to honor the fallen heroes of the withdrawal.

The altercation reportedly took place when a cemetery official attempted to prevent Trump campaign staffers from filming and photographing in restricted areas where servicemembers are buried. According to NPR, the Trump staff members "verbally abused and pushed the official aside."

Trump campaign spokesperson Steven Cheung contested the report, denying any physical altercation. "There was no physical altercation as described and we are prepared to release footage if such defamatory claims are made," Cheung stated. He described the incident as involving a "private photographer" and an unnamed individual who allegedly had a "mental health episode."

Arlington National Cemetery issued a statement confirming that an incident had occurred and that a report was filed. The statement reiterated that federal law prohibits political campaign or election-related activities within Army National Military Cemeteries. This includes restrictions on photographers, content creators, or any other persons attending for or in support of a partisan political candidate's campaign.

The cemetery's statement did not address why the Trump campaign was allowed to visit the cemetery as part of the campaign or provide a copy of the report. The incident underscores ongoing tensions and sensitivities surrounding political activities and events at national military cemeteries.



#### **NASA Extends Astronauts' ISS Stay Amid Spacecraft** Change; Assures Safety

NASA has announced that astronauts Sunita Williams and Butch Wilmore will extend their stay aboard the International Space Station (ISS) until February 2025, six months longer than originally planned. This extension is due to a change in their return spacecraft from the Boeing Starliner to the SpaceX Crew

The decision to delay their return was made after the Boeing Starliner experienced technical issues. Despite concerns about the extended mission, NASA has assured that there is no immediate danger to the astronauts. The ISS is well-stocked with provisions, including food, water, clothing, and oxygen. "The space station is well-stocked with everything the crew needs, including food, water, clothing and oxygen," NASA stated. Recent cargo resupply missions have bolstered the station's supplies. Two spacecraft recently delivered essential items: one carrying "8,200 pounds of food, fuel, supplies" and another delivering "three tons of cargo." Regular resupply missions are planned to ensure the astronauts' needs are continually met.

The extended stay requires special arrangements for the astronauts. On the ISS, the zero-gravity environment allows astronauts to sleep anywhere, using sleeping stations attached to surfaces. They can also stay connected with Earth through video calls, audio calls, and emails.

The ISS features the Advanced Resistive Exercise Device (ARED), a gym that helps astronauts maintain muscle mass and bone density through resistance exercises such as squats, deadlifts, and bench presses. Additionally, Williams and Wilmore have access to the Vegetable Production System (Veggie garden), enabling them to grow fresh produce and flowers in space, which they are using to experiment with crop growth techniques.

## Nifty Surges Past 25,000 as Record-Breaking **Streak Continues; IT Sector Leads the Rally**



Under the terms of the merger agreement signed on February 28, Viacom18's media assets will be integrated with Star India Pvt Ltd (SIPL) through a court-sanctioned arrangement. This merger, val-

PPSL's original application for the payments aggregator license was rejected nearly two years jection was based on non-compliance with Press Note 3, which mandates prior approval for investments from countries sharing land borders with India. The scrutiny was particularly focused on investments from China's Ant Group Co. The Centre had earlier rejected a post-facto approval request for these investments.

Earlier this year, the RBI directed Paytm Payments Bank (PPBL) to cease new credit and deposit operations, as well as other banking activities, following a comprehensive audit that revealed consistent non-compliance issues. This



disruption impacted PPSL significantly, as it contributed approximately 60% (around ₹900 crore) of the company's revenue in the first quarter of FY25. The ongoing regulatory challenges have led to a decline in key operational metrics.





Once the screenshot is taken, users can ask questions about the content displayed on their screen. For instance, if you're reading an article, you can inquire about its summary or specific details. Gemini's responses are based solely on the captured screenshot, but it can also fetch additional information from the Internet if needed. Notably, the screenshot is not saved to the device, and long screenshots are not supported.

The 'Ask about this video' feature, however, is specifically designed for YouTube videos that have captions enabled. When activated during playback, it allows users to ask questions about the video's content. Gemini generates responses based on the captions rather than analyzing the video itself. Unfortunately, this feature does not extend to other video platforms, regardless of caption availability.

These new functionalities appear as options at the top of the Gemini floating window. Users will see "Ask about this screen" or "Ask about this video" with corresponding icons when the feature is available. By tapping these options, Gemini can provide contextual answers and summaries, enhancing the user experience with more interactive and helpful AI capabilities.

More details about the iPhone 17 will likely emerge following the iPhone 16's release. Apple's September 9 event, titled "It's Glowtime," will also feature announcements for new Apple Watch models and AirPods.

## **Dawid Malan Announces Retirement** from International Cricket

Dawid Malan, England's former world No. 1 T20I batter, has announced his retirement from international cricket at the age of 37. The left-handed batter shared the news in an interview with British Daily 'The Times', following his exclusion from the upcoming white-ball series against Australia.

Malan's illustrious career saw him achieve significant milestones, including becoming one of only two England men's players alongside Jos Buttler—to score centuries in Tests, ODIs, and T20Is. Despite these accomplishments, he had not represented England since the 50-over World Cup in India last year.

Reflecting on his career, Malan noted that Test cricket, which he once viewed as the pinnacle of the sport, was mentally taxing. He admitted to struggles with consistency, saying, "Test cricket was always the pinnacle for me growing up. At times I played well but in between just wasn't good enough or consistent enough, which was disappointing because I



felt I was a better player than that."

Malan's international career began in 2017 with a memorable T20I debut against South Africa, scoring 78 off 44 balls. He made a significant impact during the 2017-18 Ashes tour with a resilient 140 in Perth. Malan's T20I career was particularly notable, especially after England's ODI World Cup victory in 2019. His recordbreaking 48-ball century against New Zealand in Napier and his

ascent to the top of the ICC's T20I batting rankings in September 2020 marked his dominance in the format.

He played a pivotal role in England's T20 World Cup win in Australia in 2022, although he missed the knockout stages due to a groin injury. Over his career, Malan accumulated 4,416 runs across 22 Tests, 30 ODIs, and 62 T20Is.


