Strategy Behind the Slow Pace of Cases Against YCP Leaders

TPN, Andhra Pradesh: There were high expectations that after coming to power, the Alliance Government would take swift action against YCP leaders accused of crimes, scams, and other anti-social activities. With access to all relevant data on YCP leaders, many believed that action would be immediate. However, the slow pace of action has left the cadres of TDP, Janasena, and others disappointed. Even some media houses, supportive of TDP, have run debates on this issue, indirectly pressuring the government to act swiftly.

Key figures such as Mr. Vasudeva Reddy, implicated in the liquor scam. and Venkata Reddy, involved in mining scams, remain absconding. The question arises: how, with full knowledge of their activities, did the



government fail to prevent them from escaping? The focus has primarily been on cases such as the attack on the TDP office and the attack on Mr. Naidu's residence. Meanwhile, TDP leaders continue to accuse YCP leaders like Roja and Vidadala Rajani of land grabbing and other activities,

but no cases have been filed against them.

One prominent figure, Mr. Peddireddy Ramachandra Reddy, who engaged in many illegal activities during the YCP regime, also remains free. His involvement in the burning of the Tahsildar's office in Madanapalle Jaganmohan Reddy's public image. was exposed, and Mr. Naidu even requested officials to visit the site by helicopter. Yet, no case has been regi stered against Mr. Peddireddy to date.

According to sources, BJP has granted permission to Mr. Naidu to pursue cases against YCP leaders but with conditions. Currently, Mr. YS Jaganmohan Reddy has 12 Rajya Sabha MPs on his side, two of whom have resigned and are ready to join TDP. The NDA government requires Mr. Jaganmohan Reddy's support in the Rajya Sabha, especially with the upcoming "One Nation, One Election" bill. Additionally, Jagan has a majority in the Andhra Pradesh Legislative Council. Taking this into account, BJP has reportedly suggested two strategies: first, to demoralize the YCP cadre, and second, to tarnish YS

The goal is to politically weaken Mr. Jaganmohan Reddy, demoralizing his party's leaders and cadre. Public debates and exposure of Jagan's actions are part of this plan, aimed at creating a lack of confidence in YS Jaganmohan Reddy among his MPs and MLCs, encouraging them to leave YCP. Once a significant number of YCP members have defected, legal cases and arrests will accelerate.

The recent controversy surrounding the Tirumala Laddu episode appears to be a well-timed and planned move, with more such incidents likely to follow until YCP's support base crumbles. Only then will the cases against YCP leaders be pursued more aggressively. This is reportedly the NDA's strategy.

Who Is the IO of the Fake Case Against Jatwani? Who Is Protecting Him?

TPN, Andhra Pradesh: In the case of Kadambari Jatwani, it has come to light that a fake case was framed against her, which led to her arrest. The case was initiated based on a complaint filed by Mr. Kukkala Vidyasagar, who has been identified as A1 and was arrested today. According to the police, a fabricated document related to a land transaction was used to frame the case. The allegation against Jatwani and her family was that they attempted to sell this land to Kukkala Vidyasagar, intending to defraud him of Rs. 5 lakhs.

As per the process, after receiving the complaint, an investigating officer (IO) had to be appointed. It was Mr. Kranthi Rana Tata who entrusted the investigation to Inspector Sridhar Babu, reportedly loyal to Mr. Rana according to department sources. Inspector Sridhar Babu, along with Kasi Viswanadham, Valivela Srinivas, and Shariff, allegedly formed a team and, with the help of an advocate from Prakasam District, prepared a fake land document. They then planted this document at Jatwani's home in a carefully orchestrated operation.

The Commissioner of Police's report has revealed these details, yet no action has been taken against the team involved. Speculation is rife that a higher official, reportedly close to Inspector Sridhar Babu, is shielding the team. Although three IPS officers, along with ACPs and Inspectors involved in the operation, have already been suspended, the individuals who prepared the fake document and conducted the investigation based on their fabricated evidence remain untouched. This has sparked a discussion within the department about why these individuals have not yet faced any consequences.

Choreographer Jani Remanded for 14 Days, **Transferred to** Chanchalguda Jail

TPN, Hyderabad: The Upparpally court has sent renowned choreographer Jani Master to judicial remand for 14 days in connection with a sexual assault case. He will remain in custody until October 3, following the court's orders.

Jani Master has been at the center of a controversy after allegations surfaced of him sexually assaulting a dancer, sparking widespread discussion in the film industry. He is facing charges under the POCSO Act, as well as Sections 376, 506, and 323(2) of the IPC. The Cyberabad police apprehended Jani Master in Goa and brought him to Hyderabad for further investigation.

After a private interrogation at the Rajendranagar CCS office, Jani Master was presented before the Upparpally court, where the remand order was issued. Subsequently, he was transferred to Chanchalguda Jail. In a related development, Jani Master has applied for bail at the Ranga Reddy

He dismissed the claim that animal fat was found in the ghee as a baseless myth. Jagan emphasized that the laddus are still being prepared using the traditional methods that have been followed for decades.

Jagan criticized Chandrababu Naidu, accusing him of politicizing religious issues and misleading the public. "Is it dharma to play with the sentiments of devotees?" Jagan asked, condemning Chanthe issue for political gains. He pointed out that the tendering process for ghee takes place every six months, and samples were also tested during Chandrababu's tenure as Chief Minister. 



Corruption Allegations Against Junior Assistant Arun Kumar Spark Inquiry in Vijayawada **Govt Hospital**



TPN,Vijayawada: Superintendent Venkateswara Rao has responded to recent reports by Point News concerning corruption allegations against Junior Assistant Innolu Arun Kumar at the Vijayawada Government Hospital. Following these reports, a committee has been formed to investigate the complaint against Arun Kumar, and action will be taken based on the evidence gathered.

Arun Kumar, however, maintains his innocence, stating, "I am honest and unaware of any wrongdoing. If anything comes up, Superintendent Venkateswara Rao will handle it." Despite his claims, victims accuse him of numerous corrupt activities over the past decade, with suspicions that higher hospital officials are shielding him.

The victims pointed out the disparity between Arun Kumar's official salary of Rs 50,000 and the Rs 1.5 lakh in monthly bank loans he reportedly repays. There are also allegations dating back to 2017, when Arun was in charge of postmortems, that he looted gold from the

bodies of deceased orphans.

Arun has been linked to several scandals, including the alleged collection of large sums from private hospitals during inspections. It is claimed that he receives Rs 90,000 from hospital owners but collects Rs 5 lakh for signing inspection re-

Additionally, Arun Kumar has been accused of siphoning the stipends of nursing students at the School of Nursing. The victims fear that the committee formed by Superintendent Venkateswara Rao may be biased in Arun's favor. They demand that Arun be removed from his position before a fair investigation can begin.

The inquiry will determine whether Superintendent Venkateswara Rao upholds justice or if he is involved in covering up the corruption, as alleged by Arun Kumar.



Tirupati Laddoo **Controversy: Protecting** Religious Sanctity or Political Agenda?

The Tirupati Laddoo, revered as a sacred 'prasad' by millions of devotees, is at the center of a legal and political storm. A petition in the Supreme Court has raised serious concerns about alleged animal fat in the laddoos distributed at the Sri Venkateswara Temple in Tirupati. The allegations, primarily concerning the violation of Hindu religious customs, have struck a deep chord with the sentiments of countless devotees. However, the controversy also raises important questions about the management of religious institutions and the intertwining of faith and politics in the public domain.

Religious Rights and Constitutional **Protection**

The petition filed by lawyer Satyam Singh is grounded in Article 25 of the Indian Constitution, which guarantees the right to freedom of religion, including the practice and preservation of religious customs. The claim that animal fat was found in the sacred prasad is seen as a gross violation of these fundamental religious rights. Devotees regard the Tirupati Laddoo as a divine blessing, and any suggestion of contamination with non-vegetarian substances, particularly beef and pork, is seen as a severe affront to Hindu customs.

This issue is more than just a matter of religious sensibilities. If proven, it could indicate larger systemic problems in temple management, suggesting negligence or malpractice by those entrusted with the responsibility of maintaining the sanctity of one of the holiest Hindu shrines. The petition calls for reforms in the administration of temples, urging culturally sensitive and transparent management practices. This reflects a broader concern among many devotees, who feel that religious institutions are not being managed with the reverence they deserve.

Chandrababu Naidu's Allegations and Political Fallout

Former Andhra Pradesh Chief Minister Chandrababu Naidu's comments have fueled the controversy, with his accusation that the YSR Congress government was responsible for the alleged use of animal fat in the Tirupati Laddoo. According to Naidu, the previous administration had tarnished the sanctity of the temple by allowing such practices. He cited a Gujarat laboratory report which allegedly confirmed traces of beef tallow, fish oil, and lard in the ghee used to make the laddoos.

Naidu's allegations have predictably drawn

sharp political reactions. The BJP, an ally of Naidu's Telugu Desam Party (TDP), has termed the alleged use of animal fat an unforgivable sin, with some leaders hinting that individuals from other religions within the Tirumala Tirupati Devasthanams (TTD) board may have been responsible for the lapse. This has further complicated the issue, suggesting a communal angle to the controversy.

YSR Congress' Denial and Charges of **Political Diversion**

On the other side, the YSR Congress and former Chief Minister Jagan Mohan Reddy have dismissed the allegations as baseless and politically motivated. Reddy, along with his party leaders, has accused Naidu of employing diversionary tactics to gain political mileage. Senior YSR Congress leader YV Subba Reddy, who served as the TTD chairman, has gone so far as to accuse Naidu of damaging the sanctity of the temple and playing with the faith of millions of Hindus for political gain.

The political overtones of this controversy cannot be ignored. With both sides trading accusations, the real issue—the religious sanctity of the Tirupati Laddoo—risks becoming a casualty of political brinkmanship. It is essential to separate political rhetoric from the genuine concerns of devotees who are deeply hurt by these allegations.

The Need for Accountability and **Transparency**

At its core, the Tirupati Laddoo row highlights the need for transparency and accountability in the management of religious institutions. Temples like the Sri Venkateswara Temple are not merely places of worship; they are cultural and spiritual landmarks that hold immense significance for millions of people. Any allegations of malpractice, particularly when it comes to sacred offerings like prasad, must be thoroughly investigated.

The Supreme Court's intervention in this matter is timely and necessary. It must ensure that the religious rights of devotees are upheld while also addressing the systemic issues in temple administration. If the allegations of animal fat being used in the laddoos are proven false, it is important that those responsible for spreading misinformation are held accountable. On the other hand, if there is truth to the claims, immediate corrective measures must be taken to restore the faith of devotees.



"This matter sheds light on numerous issues related to temple desecration, land disputes, and other dharmic practices," he stated, asserting that now is the time to consider a national-level board to oversee temple-related issues across India.

Kalyan called for a comprehensive national debate involving policymakers, religious leaders, the judiciary, and the media to unite against what he termed the "desecration of Sanatana Dharma." He urged all stakeholders to come together to safeguard religious sentiments and ensure respect for Hindu traditions.

The controversy was intensified by comments from Andhra Pradesh Minister Nara Lokesh, who shared a video of Chief Minister N. Chandrababu Naidu discussing the use of animal fat in the preparation of Tirupati prasadam. Lokesh expressed shock over the findings, asserting that the use of animal fat disrespects the religious sentiments of countless devotees.

Adding to the allegations, TDP spokesperson Anam Venkata Ramana Reddy claimed that lab reports confirmed the presence of animal fats in the ghee supplied to the temple, which he argued offends the Hindu community.

As the controversy continues to unfold, Kalyan's call for a dedicated board reflects a growing demand for accountability and preservation of religious practices in the state.

Mamata Banerjee's Big Move Against INDIA Ally-Ruled Jharkhand

West Bengal Chief Minister Mamata Banerjee has attributed the devastating floods in the state to what she describes as a "man-made disaster," specifically blaming the Damodar Valley Corporation (DVC) for the release of water from Jharkhand reservoirs. In a letter to Prime Minister Narendra Modi, she criticized the DVC for its "unprecedented, unplanned, and unilateral" discharge of nearly 500,000 cusecs from the Maithon and Panchet dams, resulting in severe flooding across South Bengal.

Banerjee noted that the floods have affected over 1,000 square kilometers, impacting nearly 5 million residents, causing significant damage to crops, infrastructure, and homes. She warned that if this approach continues, the West Bengal government may sever ties with the DVC altogether. The Chief Minister stated that the state is currently experiencing the worst floods since 2009, calling the situation a product of sheer neglect.



both the DVC and the Jharkhand government were effectively offloading their On Wednesday, Banerjee claimed that water problems onto Bengal, stating that

the release of water was a tactic to protect their own interests. Following her statements, the West Bengal government enacted measures to seal its borders with Jharkhand, halting the entry of heavy vehicles in an attempt to mitigate the impact of the floods.

In response, BJP leaders have criticized Banerjee's actions. Assam Chief Minister Himanta Biswa Sarma accused her of deflecting blame from her own government's failures and using the situation for political gain. BJP leader Suvendu Adhikari further alleged that Banerjee is trying to distract from a recent high-profile crime in Kolkata by threatening to cut ties with the DVC.

The Union Power Ministry has stated that all water releases from the dams were made in consultation with the Damodar Valley Reservoir Regulation Committee, which includes representatives from both West Bengal and Jharkhand, and emphasized that the decision to release water was not taken lightly.

AAP Demands Govt Accommodation for Arvind Kejriwal

The Aam Aadmi Party (AAP) has formally requested government accommodation for outgoing Delhi Chief Minister Arvind Kejriwal, asserting that he is entitled to it as the convener of a national party. During a press conference on Friday, AAP Rajya Sabha MP Raghav Chadha announced that the party would be writing to the Union Ministry of Housing and Urban Affairs, hoping for a swift response within one or two days.

Kejriwal, who resigned earlier this week, is expected to vacate his official residence within 15 days. Chadha emphasized that all national party leaders are entitled to two essential resources: an office and accommodation to operate from Delhi. AAP achieved national party status following the Gujarat assembly elections in 2022, where it secured several seats and a notable vote percentage.

The Centre had previously provided AAP with an office after a prolonged struggle and court intervention, allowing the party to relocate to its new office on Ravi Shankar Shukla Lane in Mandi House just last month.

Chadha urged the Centre to act without delay or political bias, asserting that Kejriwal's entitlement to government accommodation is a rightful demand. He pointed out that other leaders of national parties, including BJP President JP Nadda, Congress President Mallikarjun Kharge, and BSP leader Mayawati, have all been granted government accommodation in the capital.

The party's national secretary will draft the letter to the Ministry of Housing and Urban Affairs, with Chadha expressing hope that the request would not require legal action. He noted that Kejriwal would soon relinquish all official privileges following his resignation, emphasizing that he does not own property or a personal residence.

As the leader of a national party, Kejriwal's need for government accommodation is framed as a matter of rights according to existing laws, and AAP remains committed to ensuring that he receives this support from the government.





PM Should Have Set a Different Example": Priyanka Gandhi on Kharge's Letter

Priyanka Gandhi Vadra expressed her disappointment over Prime Minister Narendra Modi's lack of response to a letter from Congress chief Mallikarjun Kharge, instead allowing BJP President JP Nadda to issue an "inferior and aggressive" reply. In her remarks, Priyanka highlighted the toxicity in current political discourse, emphasizing that the Prime Minister should have set a more respectful example.

Kharge had written to Modi on Tuesday, urging him to "discipline" BJP leaders for their "objectionable and violent" statements directed at Rahul Gandhi, the Leader of the Opposition in the Lok Sabha. The Congress president pointed out specific instances where BJP figures, such as Minister of State for Railways Ravneet Singh Bittu, labeled Gandhi a "number one terrorist." He also cited a comment from Sanjay Gaikwad, an MLA from BJP ally Shiv Sena, who offered ₹11 lakh to anyone who would cut off Gandhi's tongue in response to his remarks about scrapping the reservation system.

In his response, Nadda not only deflected the criticisms but also brought up past insults directed at Modi by Congress leaders. He took a jab at Rahul Gandhi, asserting that the party was attempting to relaunch a "failed product" that voters have repeatedly rejected.





Maldives Expresses Gratitude to India for Budgetary Support

expressed his appreciation for India's financial assistance, following the Indian government's decision to extend budgetary support through the rollover of a USD 50 million Treasury Bill. In a post on X, Zameer highlighted that this gesture underscores the strong friendship between the Maldives and India.

The State Bank of India (SBI) subscribed to the USD 50 million Treasury Bills issued by the Maldivian Ministry of Finance for an additional year after the previous subscription matured on September 19. This marks the second such rollover in 2024, following an earlier extension in May.

Jammu And Kashmir Phase 1 Polling Turnout Didn't Reach 2014 Election Level

In the first phase of the Jammu and Kashmir assembly elections, voter turnout has not only disappointed but has also failed to match the 2014 assembly election figures. This election marks the first assembly polls in a decade, yet the anticipated surge in participation did not materialize. According to the Election Commission, a voter turnout of 61% was recorded for the 24 seats contested, a drop from the 66% seen in 2014 despite various challenges, including calls for boycott from separatist groups.

Factors such as improved security and the absence of boycott calls were expected to encourage higher voter participation. Notably, the participation of the Jamaat-e-Islami was also seen as a potential boost. However, the results indicate that in several constituencies, especially in South Kashmir, voter turnout has decreased compared to 2014.

For instance, in the Pampore assembly seat, turnout fell from 47% in 2014 to just 42%. Similarly, the Rajpora seat in Pulwama recorded a slight decrease, from 47% to 45%. The DH Pora seat saw a significant drop from 77% in 2014 to 65% this year, while Dooru's turnout declined from 63% to 57%. In Shangus, Anantnag, the voting percentage plummeted from 67% to 52%.

While the recent parliamentary elections in Jammu and Kashmir had witnessed a record-breaking turnout, raising hopes for robust participation in the assembly polls, the first phase's turnout suggests otherwise. Political parties campaigned vigorously, yet their efforts did not translate into increased votes in many areas.

The second phase of polling is scheduled for September 25, followed by the third phase on October 1. Votes will be counted on October 8, as all eyes remain on the future turnout and its implications for the region's political landscape.



SEBI Bans Axis Capital from Debt Assignments **Over Violations**

The Securities and Exchange Board of India (SEBI) has imposed restrictions on Axis Capital Limited (ACL), a wholly owned subsidiary of Axis Bank, barring it from accepting new assignments as a merchant banker, arranger, or underwriter in the debt segment. This action comes in response to alleged violations of regulatory norms related to non-convertible debentures (NCDs) issued by Sojo Infotel, for which ACL served as the merchant banker.

According to SEBI's findings, ACL was accused of providing guarantees or indemnities concerning the redemption of NCDs, disguising these actions as underwriting. Such practices are prohibited under existing regulations, as they pose significant risks to the financial system and could disrupt the orderly functioning of the market.

SEBI's investigation highlighted concerns about the integrity of the underwriting process and the potential for such violations to undermine investor confidence and market stability. By acting outside its permitted scope, ACL risked not only its reputation but also the broader integrity of the financial markets.

The regulator's order emphasizes the need for strict adherence to established guidelines in the capital markets. By restricting ACL's activ-



ities, SEBI aims to reinforce compliance and maintain a level playing field for all market participants.

As a result of this ruling, ACL is currently prohibited from engaging in any new assignments until further notice. The implications of this restriction could affect the company's operations and its ability to participate in future debt offerings.

SEBI's actions underscore its commitment to upholding regulatory standards and ensuring that financial institutions operate within the legal framework designed to protect investors and maintain market order. The ongoing scrutiny of merchant banking practices reflects the regulator's proactive approach to safeguarding the financial system against potential risks.

The Adani Group is poised to acquire ▲ a 46.64% promoter stake in ITD Cementation India, as reported by the Economic Times. At 55, Anura Kumara Dissanayake has gained momentum with his anti-corruption stance and propoor policies. He leads the People's Liberation Front (PLF) and is contesting under the National People's Power (NPP) coalition. Though his party



holds only three seats in parliament, Dissanayake has garnered significant support, with pre-election surveys showing him leading with 36% of voter preference.

Dissanayake advocates for stronger state intervention and a more closed-market approach to protect local industries and workers, positioning himself as the candidate for those disillusioned by mainstream politics.

Namal Rajapaksa: The Rajapaksa Dynasty's New Face

Namal Rajapaksa, 38, represents the Sri Lanka Podujana Peramuna (SLPP), the party founded by his uncle Basil and associated with the powerful Rajapaksa family. As the son of former President Mahinda Rajapaksa Rajapaksa Rajapaksa family.



japaksa and nephew of Gotabaya Rajapaksa, Namal's entry into the race is seen as an attempt to unite the SLPP and challenge Wickremesinghe's bid for re-election.

With a strong anti-corruption platform, Bopage is focused on pro-poor policies and opposes Sri Lanka's current alignment with the IMF programme.



As a relatively new face in national politics, Bopage aims to represent the aspirations of ordinary Sri Lankans, especially those who participated in the massive protests that changed the country's leadership in 2022.

The 2024 presidential election will shape the future of Sri Lanka's economic and political landscape. With voters set to choose between continuity under Wickrem-



esinghe or a new direction from a range of opposition candidates, the outcome will determine whether the country remains on its current reform path or moves towards a different approach to recovery.

Amazon Launches Al Video Generator for Ads



Amazon has unveiled a new artificial intelligence (AI) video generator tool designed to create advertisements, allowing advertisers to produce engaging video content using just a single product image. The videos can range from six to nine seconds in length, produced at a resolution of 720p and 24 frames per second. Each video takes up to five minutes to generate and provides users with four variations to choose from.

In addition to the video generator, Amazon has introduced a new live image capability for its existing

AI image generator, aimed at enterprise clients. This feature allows users to create short, animated campaign images, reminiscent of looping GIFs that often appear in online advertisements.

While Amazon demonstrated the live image feature, specific details about the video generator remain sparse. An Amazon spokesperson indicated that the generated ads follow a structured template consisting of two scenes, complete with headlines, background music, and a call to action. Advertisers can also customize the soundtrack, and the brand logo appears in the upper-right corner of the frame.

However, it remains unclear whether users can provide natural language prompts for specific instructions or if there are options for editing generated videos. As Amazon continues to innovate in the advertising space, these tools could provide a significant advantage for brands looking to enhance their marketing efforts.

TikTok Users **Controversial Trend** of Eating Dirt for **Health Benefits**



A surprising trend has emerged within the health and wellness community, with TikTok users advocating for the consumption of dirt as a remedy for various ailments. This peculiar practice, dubbed "geophagy," claims to improve gut health, skin conditions, and even aid in weight management. Fertility and hormone coach Stephanie Adler is a prominent voice in this movement, encouraging her followers to explore the potential benefits of eating organic soil. In a viral TikTok video, she asserted that just one teaspoon of biodynamic soil contains more microorganisms than there are humans on Earth.

In tandem with this trend, e-commerce platforms like Amazon and Etsy have started selling edible clay and soil products, ranging in price from ₹900 to ₹2,200. These products, which come in forms like powders and clay chunks, are marketed with promises of anti-aging benefits, enhanced skin health, and balanced oil production. One vendor on Amazon markets edible red clay for \$11.99 (about ₹1,002), touting its ability to unclog pores, tighten skin, and promote a healthy complexion.

Interestingly, some recent research supports the idea that consuming dirt could have genuine health benefits. A 2019 study highlighted the role of soil in shaping the human gut microbiome, which is essential for overall health. Historically, humans have consumed soil as a supplement to their diets, and certain types of soil have been used for detoxification and medicinal purposes.

Moreover, studies suggest that certain compounds found in dirt may help absorb body fat, offering potential weight loss benefits. Experts from the University of Helsinki noted that direct contact with natural soil can alter skin microbiota, fostering a healthier balance of microorganisms and possibly preventing immune system disorders.

Arecent report from the U.S. Federal Trade Commission (FTC) has raised significant alarms about the data management practices of major social media companies, including Meta Platforms, TikTok, and Twitch. The report, released on Thursday, critiques these platforms for their lack of transparency and inadequate user data controls, particularly regarding the use of artificial intelligence systems.

The FTC's analysis scrutinized how companies manage user data, concluding that many have "woefully inadequate" data retention and management policies. Notable platforms such as YouTube, X (formerly Twitter), Snap, Discord, and Reddit were also evaluated, although specific practices were not disclosed in the report.

commonly found in these foods further exacerbates obesity and inflammation, increasing the likelihood of heart disease.

Many ultra-processed foods, such as packaged snacks and ready-to-eat meals, contain excessive sodium. A diet high in salt is strongly associated with hypertension (high blood pressure), which can damage arteries and elevate the risk of heart attacks and strokes. Additionally, high salt intake can cause fluid retention, further stressing the heart and increasing the risk of heart failure.

Ultra-processed foods are calorie-dense and nutrient-poor, leading to weight gain and a higher risk of obesity. Obesity is a significant risk factor for heart disease and is closely linked to metabolic syndrome—a cluster of conditions that includes high blood pressure, high blood sugar, and abnormal cholesterol levels.

These foods often contain artificial additives that can trigger chronic inflammation and oxidative stress in the body, damaging blood vessel linings and promoting arterial plaque buildup.

Recent studies suggest that ultra-processed foods negatively affect gut health, which is increasingly recognized as vital for heart health. Disruptions in gut bacteria can lead to systemic inflammation, further linked to heart disease.





Vikram Rathour Joins Rajasthan Royals as Batting Coach

Rajasthan Royals have announced the appointment of Vikram Rathour as their new batting coach, further strengthening their coaching staff. This move follows the arrival of cricketing legend Rahul Dravid as head coach, marking a significant development for the franchise. Dravid, who recently concluded a successful tenure with the India men's team culminating in T20 World Cup victory, will reunite with Rathour, who previously served as a batting coach under Dravid in the Indian setup.

Despite a brief international playing career, Rathour has been instrumental in shaping the future of Indian cricket, particularly in nurturing emerging batting talent. Dravid expressed his enthusiasm for Rathour's appointment, highlighting the duo's shared history and mutual understanding. "Having worked closely with Vikram for many years, I can confidently say that his technical expertise, calm demeanor, and deep understanding of Indian conditions make him a perfect fit for the Royals," Dravid stated. He emphasized their strong rapport and past successes, hoping to replicate that at Rajasthan Royals.

The objectives for Rathour and Dravid mirror those they pursued in their coaching roles for India. Since India's last T20 World Cup win in 2007 and the end of an ICC Trophy drought in 2013,



both men have faced challenges. Similarly, the Royals, having claimed their only IPL title in 2008, have also underperformed over the years. However, under captain Sanju Samson, the team has shown promise, coming close to their second title in 2022 when they finished as runners-up to the Gujarat Titans.

Rathour expressed his excitement

about joining the Royals, stating, "It's a privilege to be part of the Royals family. The opportunity to work again with Rahul and alongside a talented group of young cricketers is hugely exciting. I look forward to contributing to the team's vision and working toward developing top-class players for the Royals." With this new coaching partnership, the Royals aim to build a for-


midable team for future IPL seasons.

Travis Head's Century Leads Australia to Victory Over England in 1st ODI

Travis Head's outstanding performance, featuring a career-best 154 not out, propelled Australia to a seven-wicket victory over England in the first one-day international at Trent Bridge. Chasing a target of 316 runs, Australia reached 317-3 with six overs to spare, marking their 13th consecutive ODI win against all opponents and taking a 1-0 lead in the five-match se-

Australia's victory was aided by Marnus Labuschagne's surprising success with the ball after losing the toss. England appeared set for a huge total at 201-2, with Ben Duckett nearing a century at 95. However, Labuschagne, bowling as a part-time leg-spinner, caught Duckett off his own bowling and quickly dismissed Harry Brook for 39, who was captaining England for the first time. Labuschagne finished with impressive figures of 3-39, helping to dismantle England's batting line-up, which lost its last six wickets for just 59 runs.

Adam Zampa, marking his 100th ODI appearance, also contributed signifi-



cantly, taking 3-49 in his full quota of overs. Labuschagne later showcased his batting prowess, partnering with Head for an unbroken 148-run stand, scoring 77 not out off 61 balls.

Despite nearly getting caught early in his innings, Head went on to achieve his sixth ODI century from 129 balls, featuring 20 fours and five sixes. He surpassed his previous highest ODI score of 152 against England in Melbourne two years ago, reaching 150 with a spectacular six off Liam Living

After winning the toss, England had strong contributions from Duckett and Will Jacks, who scored brisk fifties. However, after Jacks was dismissed for 62, England's innings fell apart. Captain Brook admitted their total was below par, while Australia's captain, Mitchell Marsh, praised the team's resilience amid illness affecting several players, including fast bowlers Mitchell Starc and Josh Hazlewood. The series continues at Headingley on Satur-

Bumrah Shines as India Dominates Bangladesh in Opening Test

Jasprit Bumrah's exceptional bowling left Bangladesh's batting lineup in disarray, as India established a commanding 308run lead by the end of the second day's play in the opening Test. Bumrah took 4 wickets for 50 runs, partnering effectively with Mohammed Siraj, Akash Deep (2/19), and Ravindra Jadeja (2/19) to dismiss Bangladesh for just 149 in their first innings, in response to India's 376.

After securing a 227-run lead, India faced a rocky start in their second innings, losing skipper Rohit Sharma (5) and Yashasvi Jaiswal (10) early, with the score at 28. Rohit edged a delivery from Taskin Ahmed to gully, while Jaiswal fell to an expansive drive off Nahid Rana.

Despite the early wickets, Shubman Gill stabilized the innings alongside



Virat Kohli, adding 39 runs for the third wicket. Gill showcased impressive stroke play, including a standout boundary through covers. However, Kohli's leg-before dismissal to spinner Mehidy Hasan Miraz late in the day slightly dampened India's progress.

Bumrah's incisive bowling was the

highlight, as he claimed the first breakthrough by dismissing Shadman Islam, who fell victim to an in-cutter. This set the tone for the Bangladesh innings, with Bumrah also taking the wickets of Mushfigur Rahim, Taskin Ahmed, and Hasan Mahmud.

Bangladesh's middle-order struggled, with Litton Das (22) and Shakib Al-Hasan (32) forming a brief partnership before their dismissals. Litton's unnecessary slog sweep off Jadeja was caught by substitute fielder Dhruv Jurel, while Shakib's reverse sweep de-

flected off his boots to Rishabh Pant.

Akash Deep quickly added two more wickets, hastening Bangladesh's collapse. Despite a few moments of resistance, they ultimately faltered, with India's bowlers capitalizing on their timid approach.



Yuzvendra Chahal Shines With Successive Five-Wicket Haul For Northamptonshire

Indian leg-spinner Yuzvendra Chahal showcased his exceptional bowling skills by taking a five-wicket haul in his second consecutive match for Northamptonshire, leading the team to a convincing nine-wicket victory over Leicestershire in the English County Championship. Chahal's performance was pivotal, as he followed up his earlier figures of 4/82 with an impressive 5/134, totaling a remarkable nine-wicket match haul.

After bowling Leicestershire out for 316, Northamptonshire was set a modest target of 137 runs. The team comfortably chased this down in just 30.3 overs, losing only the wicket of Gus Miller, who scored 11 runs. Skipper Luke Procter anchored the innings with an unbeaten 68, while George Bartlett contributed a solid 54 not out to secure the win.

Leicestershire resumed play on the final day at 69/4, and Scott Currie and Tom Scriven fought back with a strong partnership. Currie notably reached a century, scoring 120 runs before Chahal ended his innings, marking his fifth wicket of the match. Chahal's bowling proved crucial in dismantling Leicestershire's middle and lower order, with key dismissals including that of captain Lewis Hill, who managed just 14 runs, and Liam Trevaskis for 2 runs.

Despite conceding runs during a challenging 110-run partnership between Currie and Scriven, Chahal remained determined and eventually claimed Currie's wicket, leaving Leicestershire reeling at 303/9. The innings concluded shortly after, with Saif Zaib adding to the bowling success by dismissing Louis Kimber.

In his previous outing, Chahal had delivered another stellar performance with figures of 5/45 and 4/45 against Derbyshire, contributing significantly to Northamptonshire's 133-run victory. With these back-to-back stellar performances, Chahal continues to prove his value in the County Championship and remains a key player for his team.



Inoka Ranaweera Named in Sri Lanka's T20 World Cup Squad

Sri Lanka has included experienced spinner Inoka Ranaweera in their 15-member squad for the upcoming ICC Women's T20 World Cup 2024. The 38-year-old left-arm orthodox spinner last represented Sri Lanka during their unbeaten run in the T20 World Cup Qualifier earlier this year.

Ranaweera replaces pace bowler Kawya Kavindi in a squad that largely maintains the core that led to their Asia Cup triumph. Veteran Chamari Athapaththu continues as captain, steering a team that has shown impressive form recently, including series victories in England and South Africa.

The selectors have placed their trust in 18-year-old opener Vishmi Gunaratne, who demonstrated remarkable maturity during the South Africa tour. Middle-order batter Kavisha Dilhari, also noteworthy for her performances in that series, joins the squad alongside Harshitha Samarawickrama, who was named Player of the Match in the Asia Cup final against India.

Sri Lanka is placed in Group A alongside cricketing giants India, Australia, Pakistan, and New Zealand. They will begin their World Cup journey on October 3 against Pakistan, aiming to build on their recent successes and make a strong impact in the tournament.
