

## Telangana to introduce family digital health cards: CM Revanth Reddy

TPN, Hyderabad: Telangana Chief Minister Revanth Reddy recently held a meeting with officials from the Medical and Health Department to discuss the government's plan to introduce family digital health cards. The meeting was attended by prominent figures such as Ministers Damodara Rajanarsimha, Uttam Kumar Reddy, and Government Chief Secretary Shantikumari, alongside senior officials from various departments.

During the review, the Chief Minister outlined the government's proposal to implement a "One State, One Digital Card" system, which aims to streamline access to various welfare schemes, including healthcare and ration benefits. The digital card would consolidate essential information for each family, making it easier for citizens to avail government services efficiently.

As part of the initiative, the government plans to issue family digital cards across the state. These cards would not only provide access to welfare schemes but also include a comprehensive health profile for every family member. This health profile is intended to ensure that individuals' medical histories and health data are readily available, enabling more personalized and efficient healthcare services.

To kickstart the program, CM Revanth Reddy suggested a pilot project that would cover both urban and rural areas in each constituency. This pilot would help test and refine



the system before its statewide rollout. He directed the officials to take the necessary steps to ensure the smooth execution of the pilot project, emphasizing the need to incorporate feedback from both urban and rural communities.

The Chief Minister also stressed the import ance of a robust monitoring system to oversee the issuance and usage of these digital cards. He suggested a district-wise approach for tracking the distribution and implementation of the cards, ensuring that eligible individuals receive their digital cards without delay.

Additionally, the CM urged the officials to study similar policies and practices in other states like Rajasthan, Haryana, and Karnataka, which have already implemented digital health or welfare systems. Drawing on their experiences, Telangana could develop a more efficient and effective system that benefits all residents. CM Revanth Reddy emphasized the need to ensure that the digital health cards benefit all eligible families, streamlining access to welfare schemes and improving healthcare services across the state. The initiative is a significant step towards enhancing public welfare and ensuring that health services reach every corner of Telangana.

### **HYDRA Demolitions** in Madhapur

TPN, Telangana: HYDRA has commenced demolition activities in Madhapur, targeting illegal structures in Kavuri Hills Park. The Kavuri Hills Association had previously raised concerns about a sports academy operating within the park.

A HYDRA bulldozer was deployed in the area, following a similar operation in Kukatpally where structures within the buffer zone of Nallacheruvu FTL were also demolished. The staff removed the illegal sheds associated with the sports academy, despite claims from the academy's organizers that they hold a 25-year lease from the Kavuri Hills Association. They allege that the demolitions are occurring unfairly before the lease's expiration.

In Kukatpally's Shantinagar, HYDRA demolished around four acres of unauthorized structures, including commercial sheds and temporary residences. Local businesses, including catering services, were operating in this area, raising complaints that prompted inspections. Following these inspections, authorities concluded that the structures violated buffer zone regulations.

During the operation, 16 commercial sheds and retaining walls in designated survey numbers were destroyed, including five catering sheds and various storage facilities. As demolitions began, traders and residents attempted to halt the process, expressing their grievances, but the authorities proceeded with the operation.

TPN, Telangana: Health Minister Da modara Rajanarsimha has come under fire for overseeing a decade of healthcare neglect in Telangana. Despite promises of reform, the state's healthcare system has faced repeated crises, with tragic consequences for the most vulnerable.

In 2017, six infants died within three days at Koti Maternity Hospital, followed by five more infant deaths at Niloufer Hospital over five days.



### We Will Give Rs.500 Bonus to **Farmers for Kharif**

- Minister warns against purchasing grain from border states - Strict action to be taken against millers if they do so - Minister assures the government will purchase every grain



TPN, Telangana: Minister Uttam Kumar Reddy announced that a bonus of Rs.500 will be given to farmers for their Kharif crops. He warned millers not to buy grain from neighboring states, stating that strict action will be taken if they do.

During a review meeting with officials on grain procurement, he emphasized that the government is committed to

buying every grain produced. He said that 7,139 grain procurement centers are being set up. Separate centers will be established for different grades of rice, including fine rice and coarse rice. He also mentioned that 60.39 lakh acres of paddy have been cultivated during the Kharif season, and the estimated yield is 146.28 lakh metric tonnes of grain.

#### Former DCM Rajaiah and MLAs Detained by Police Near Gandhi Hospital



**TPN, Hyderabad:** Former Deputy Chief Minister Dr. Tatikonda Rajaiah, along with Bharat Rashtra Samithi (BRS) MLAs Sanjay, Maganti Gopinath, and former MLA Metuku Anand, were detained by police near Gandhi Hospital in Hyderabad. The leaders were attempting to inspect the hospital as part of a study committee appointed by BRS to assess the conditions of degraded government hospitals in the state.

The police took Dr. Rajaiah and the others to Narayanguda Police Station, preventing them from proceeding with their hospital inspection. The move has sparked outrage within the BRS, with the party's Working



President, K.T. Rama Rao (KTR), condemning the arrests.

KTR criticized the government for obstructing BRS leaders, stating, "Our leaders, who are doctors themselves, are visiting hospitals for public welfare, not for political gains." He called for the immediate release of the detained leaders and questioned the government's fear of transparency regarding public health issues.

KTR emphasized that despite atte mpts to cover up shortcomings in the state's healthcare system, BRS leaders will continue to expose the flaws and advocate for better public healthcare.

The system's failures did not end there. In 2022, four women tragically lost their lives during family planning operations (DPL), leaving their children orphaned. The government had promised free education, jobs, and housing for the children, but none of these commitments were fulfilled.

The scale of the crisis reached new heights in 2019 when 100,000 dengue-related deaths were reported in just June and July. Maternity and pediatric deaths have continued monthly, with no permanent solutions in sight. Critics argue that the previous government, instead of addressing these recurring issues, wasted valuable time by forming ineffective committees.

Minister Rajanarsimha has also been accused of failing to make healthcare accessible to the poor, as government dispensaries, including the one at Nana Ranu Biddha, have fallen into disrepair. Activists are now calling for a truth-finding committee to expose the deteriorating healthcare infrastructure during Rajanarsimha's 10 years in office.

With the healthcare system severely crippled under his leadership, the people of Telangana continue to suffer from a lack of proper medical care.

#### **Dairy Farmers Protest Delayed Payments by Dumping Milk**

TPN, Adilabad: Dairy farmers protested on Monday by dumping milk on the road, demanding the State-owned Vijaya Dairy clear their pending bills. Gathering at the district center, the farmers expressed frustration over the delay in payments, which has hindered their ability to purchase fodder for their cattle and manage daily expenses.

They reported that officials assured them their bills would be settled within a fortnight, yet no payments have been made to date. The farmers emphasized the urgency of their situation, urging the government to take immediate action to resolve the issue. They called for a commitment to regular payments every fortnight to ensure their livelihoods are not further jeopardized. The protest highlights the financial strain faced by dairy farmers in the region and their reliance on timely payments to sustain their operations.

As the state braces for additional wet weather, the IMD continues to monitor the situation closely, urging residents to remain alert and take necessary precautions during this period of heightened weather activity.

## **Protest Erupts in Warangal Over Delay in Farmer Loan Waiver**

TPN, Warangal: Farmers staged a protest on Monday, September 23, at Wardhannapet in Warangal district, demanding timely assistance under the Telangana government's loan waiver scheme. They accused the State Bank of India (SBI) management of non-cooperation.

The protest took place outside the bank, causing significant traffic disruptions.

One farmer expressed frustration, stating, "Officials leave their offices every 10 minutes, and there's no one to assist us. Each time we visit, we are told to wait, but there's no progress." He noted that only two counters were available for processing farm loans, hindering the waiver process.

Under the loan waiver scheme, loans up to Rs 2 lakh are eligible for forgiveness. While the government claims to have alleviated the debt burden by waiving Rs 31,000 crore in farm loans, many farmers continue to struggle to secure assistance.

State Civil Supplies Minister N. Uttam Kumar Reddy clarified that farmers with loans over Rs 2 lakh must repay the excess amount. For instance, a farmer with a debt of Rs 2,30,000 would need to repay Rs 30,000 before the government waives the remaining Rs 2 lakh.

Regarding farmers who have not received their pattadar passbooks due to Dharani-related issues, the Mandal Agricultural Officer (MAO) will verify their cases, allowing for the benefit of the doubt to those who have borrowed for cultivation.

The minister added that a grievance redressal system has been established to address loan issues, unlike during the previous BRS government. He noted, "In 2018, loans for 226,000 accounts totaling Rs 1,400 crore were waived but later returned to the BRS government. No steps were taken to clear loans afterward."

Uttam Kumar also highlighted that from 2014 to 2018, the BRS government waived loans in four phases, amounting to Rs 16,000 crore, but did not disburse funds for loan waivers until 2021, when only Rs 408 crore was released.





## **KTR Condemns Arrest of BRS Leaders at Gandhi Hospital**

On Sunday night, Congress workers allegedly attacked her residence in Gomaram village, Shivvampeta mandal, causing damage with bricks and stones. The incident occurred during Vinayaka immersion, when local Congress leaders reportedly blocked the event and burst firecrackers in front of the MLA's house.

When Manideep Goud, who was inside the residence, questioned their actions, he was assaulted. The attackers continued hurling bricks at the house. BRS leaders arrived and confronted the Congress members, leading to a heated argument. Police eventually dispersed both groups. BRS leaders condemned the attack as cowardly.

### **BRS Leaders** Push for 42% BC **Reservation**, Meet **Justice Eshwaraiah**

TPN, Telangana: BRS leaders reaffirmed their commitment to fighting for 42% reservations for backward classes (BC) in Telangana and urged the Congress government to conduct a caste census as promised in its election manifesto. This resolve was made during a meeting with former National BC Commission Chairman, Justice V. Eshwaraiah, at his residence on Monday.

Justice Eshwaraiah noted that increasing BC reservations to 42% in Telangana is achievable, provided the government is sincere in its efforts. He shared his views with key BRS leaders, including Council Opposition Leader S. Madhusudhanachari, former Minister V. Srinivas Goud, and Rajya Sabha MP Vaddiraju Ravichandra.

The discussions focused on the Congress party's Kamareddy Declaration, which pledges 42% reservations for BCs in local bodies, and the necessity of a comprehensive caste census. They also examined the legal provisions related to these issues and strategized on how to achieve them.

Justice Eshwaraiah emphasized that reforms like increasing reservations are possible when governments are genuinely committed to public welfare. The BRS leaders vowed to create awareness, especially among the youth, and continue their efforts until the reservation is implemented in Telangana's local bodies.

Several senior BRS leaders, including MLCs Shambirpur Raju and L. Ramana, were also present at the meeting.

### Telangana BJP Urges CM to Rescue Struggling **Dairy Farmers**

TPN, Telangana: The Bharatiya Janata Party (BJP) on Monday, September 23, urged Telangana Chief Minister A. Revanth Reddy to take immediate action to save dairy farmers.

BJP leader Gudur Narayan Reddy claimed that dairy farmers were being forced to sell their cattle to slaughterhouses as they could no longer afford to feed them. "The milk producers have been facing hardship as they have not been paid for the milk procured by government-owned dairy firms for the past three months," he said.

Narayan Reddy added that buffaloes and cows had become weak because farmers could not afford fodder. He noted that previously, the government-owned



MLA Sunitha Lakshmareddy expressed her distress, stating the attack was deliberate and demanded a case of attempted murder be registered. She warned that if BRS workers are targeted, further unrest will follow. BRS supporters organized a protest rally against the attack.



### **Case Filed Against HYDRA by Ex-Congress Leader at** SHRC

TPN, Hyderabad: On Monday, September 23, former Congress leader Judson Bakka filed a complaint with the Telangana State Human Rights Commission (SHRC), raising concerns about the rehabilitation of individuals rendered homeless due to recent demolition drives conducted by the Hyderabad Disaster Response and Assets Monitoring Agency (HYDRA) in Hyderabad and nearby districts.

The complaint highlights the demolition of homes in Manemma Colony, Ramnagar, where low-income residents were displaced. Bakka emphasized that the Telangana government should prioritize their rehabilitation.

Another incident detailed in the complaint involves a demolition drive in Adarsh Nagar, Christianpally, Mahbubnagar district. Bakka claims that the affected residents were not given any prior notice before the demolition, despite holding patta documents confirming their ownership. The properties were



demolished under accusations of land encroachment, according to his complaint.

The complaint accuses the Telangana government of violating basic human rights by neglecting to provide adequate notice before demolitions, particularly concerning the homes of poor individuals.

Judson Bakka, a former AICC member, turned rebel against Revanth Reddy and was expelled from Congress in April 2024 for alleged anti-party activities. Since then, he has been a vocal critic of the Revanth Reddy-led Congress government.

### **R. Krishnaiah Set** to Leave YCP and **Join BJP?**

TPN, Telangana: In the wake of the recent assembly elections in Telangana, the YSRCP is facing significant turmoil, with several key leaders departing the party. Reports indicate that R. Krishnaiah, the state member and national leader of the BC Welfare Association, may soon leave YCP to join the BJP.

The BJP, which adopted a BC-centric slogan during last year's elections, aims to strengthen its position by incorporating influential

leaders like Krishnaiah into its ranks. Discussions between Krishnaiah and BJP national leaders have reportedly been productive, with indications that he may be offered a key role within the party.

Krishnaiah's history with the RSS and ABVP spans nearly a decade, fostering strong relationships with various leaders in those organizations. Additionally, Prime Minister Modi and Union Minister Amit Shah extended birthday wishes to him on the 13th of this month, further fueling speculation about his imminent move to the BJP.

As the political landscape shifts in Telangana, the BJP hopes to bolster its voter base by welcoming Krishnaiah and reinforcing its commitment to the BC community.

Vijaya Dairy Development Company had paid farmers every fortnight, but payments had stopped in the last three months for reasons "best known to the company."

Addressing the media, the BJP leader said that most farmers were struggling, as the loan waiver scheme had not reached them and the government had not paid them under the Rythu Bharosa scheme. This, he argued, had deprived them of the financial means to sustain their livelihoods.

"Farmers have been waiting for three months for their payments and are now losing hope of receiving the money," Narayan said. "The situation has deteriorated to the point where they have no choice but to sell their cattle to slaughterhouses."

#### Gongadi Sunita Mahender **Reddy Critiques Komatireddy Venkata** Reddy

TPN, Hyderabad: At Telangana Bhavan, former MLA Gongadi Sunita Mahender Reddy addressed the ambitions of Komati Reddy Venkata Reddy, suggesting that his dreams of dismantling the BRS are misguided. She noted that family disputes within the Reddy clan have surfaced, urging him to focus on resolving these personal issues first. While she expressed respect for Komati Reddy, she criticized his manner of speaking as inappropriate.

Sunita also mentioned his brother, Rajagopal Reddy, who contested the Munugodu constituency as a BJP candidate, and called for support to help him succeed. She accused Komati Reddy of lacking values and making reckless statements. Additionally, she referenced a recent meeting involving KTR, Harish Rao, and SIB Chief Prabhakar Rao, questioning the purpose of their discussions, especially regarding water supply issues to areas like Tapaspalli and the Nawabupeta Reservoir in Gundala Mandal.

Sunita emphasized the need for transparency about Congress's promises and demanded the construction of the sanctioned medical college, which is reportedly being shifted from Yadadri to Kuntisaku.

### **TGSRTC to Launch 70 New Metro Deluxe Buses in Hyderabad**



TPN, Hyderabad: The Telangana State Road Transport Corporation (TGSRTC) is set to expand its fleet by adding 70 new Metro Deluxe buses, supplementing the existing 55 buses already operating in Hyderabad. These new buses will serve key routes, including Uppal, Mehdipatnam, Secunderabad, ECIL, Jagadgirigutta, and LB Nagar.

The new Metro Deluxe buses will be deployed on high-demand routes, such as Ibrahimpatnam, with buses running at intervals of 15-20 minutes to improve frequency. Currently, these buses cover major routes like Uppal-Mehdipatnam, Secunderabad-ECIL, Koti, and Abdullahpurmet, enhancing connectivity for commuters across the city.

Unlike the City Ordinary and Metro Express buses, which are part of the Mahalakshmi scheme that allows women to travel for free, all passengers, including women, will need to pay fares on the new Metro Deluxe buses. The Mahalakshmi scheme, which benefits approximately 14 lakh women passengers daily, will not apply to these buses.

TGSRTC plans to introduce the Metro Deluxe buses in phases to create a new revenue stream. The decision follows a sharp 70% decline in ticket revenue after the launch of the Mahalakshmi scheme, with only 30% of passengers currently paying for their tickets.



### **Cyberabad SOT Seizes** 12 Kilograms of Ganja-Laced Chocolates

TPN, Hyderabad: In a significant operation, the Cyberabad Special Operations Team (SOT) apprehended a man involved in selling ganja-laced chocolates on the outskirts of the city. The arrested individual, identified as Tamk Issar Singh (55), is a resident of Jagadgirigutta and originally from Punjab. According to the police, Singh had been transporting these drug-laced chocolates from Punjab and distributing them primarily to construction workers in the city's outskirts.

During the raid, the SOT team seized 12 kilograms of ganja-laced chocolates, which were packed in 64 separate packets. The illegal chocolates were reportedly being sold to laborers at various construction sites, raising concerns about the spread of drugs in vulnerable communities. DCP Special Operations Team, D. Srinivas, stated that Singh had been operating this racket for some time, bringing in the contraband from Punjab and targeting laborers working on the city's periphery. Authorities are continuing their investigation to trace the supply chain and identify any other accomplices involved in this illegal trade.

The Cyberabad police have intensified their crackdown on drug-related activities in the region, aiming to curb the supply and distribution of illegal substances in Hyderabad.

Anna Augustine had been with the global consulting firm for just four months when the relentless demands of her job took a fatal toll on her physical and mental health.

But it must be changed to make the world better for everyone."

### **First India-US Semiconductor Fabrication Cooperation Of Its Kind A Reality**

In a historic development, India and the United States have launched their first-ever semiconductor fabrication plant cooperation, marking a major milestone in the India-US strategic technology partnership. The collaboration, focused on national security, advanced telecommunications, and green energy applications, was hailed by US President Joe Biden and Prime Minister Narendra Modi as a breakthrough moment comparable to the civil nuclear deal between the two nations.

The semiconductor fabrication plant, or "fab," will focus on manufacturing advanced materials such as infrared, gallium nitride, and silicon carbide semiconductors. These materials are essential for next-generation communications, sensing, and power electronics, which are critical for both national security and commercial applications in sectors such as railways, telecom infrastructure, data centers, and green energy.

The project, which will be supported by India's Semiconductor Mission, is a joint venture involving Indian companies Bharat Semi and 3rdiTech, along with the US Space Force. This cooperation represents the first-ever technology partnership between the US military and Indian businesses for semiconductor technology, making it a landmark moment in tech diplomacy between the two countries.

#### A Watershed Moment for India-**US Relations**

The new semiconductor fab, titled \*Shakti\*, will be India's first national security semiconductor facility and one of the world's first multi-material fabs. It will focus on three main technology areas: infrared semiconductors, gallium nitride, and silicon carbide. These are crucial components for modern warfare, as well as emerging commercial needs in green energy and telecommunications.

PM Modi's vision of transforming India from a "chip-taker" to a "chipmaker" aligns with this project. India currently imports approximately \$1 billion worth of semiconductors annually for national security purposes, but with the establishment of this fab, India is set to reduce its **Conclusion** dependence on imports and develop its semiconductor manufacturing capabilities domestically.

#### Strategic Partnership

The semiconductor fab is a testament to the success of the \*Initiative on Critical and Emerging Technologies\* (iCET), which was launched in January 2023 as part of PM Modi's \*Atmanirbhar Bharat\* (self-reliant India) vision. The project highlights India's growing role in the global semiconductor supply chain, particularly in high-tech manufacturing sectors that are crucial for both national security and economic growth.

This fab is not just India's first, but also a key asset in the broader Quad partnership between the US, India, Japan, and Australia, further deepening ties in the Indo-Pacific region. The collaboration has been compared to the historic civil nuclear deal, signifying its importance in strengthening India-US relations.

#### Advancing India's Technology and Security Goals

The development of this semiconductor fab comes as part of a broader push by India and the US to enhance their technological collaboration, with a particular focus on semiconductors. Both countries have signed multiple agreements related to critical technologies, including the \*Commerce to Commerce MOU\* and the \*Strategic Trade Dialogue\*.

India's ambition to become a leader in semiconductor fabrication has been supported by the US, with this project marking the first true semiconductor fabrication partnership between the two nations. Previous collaborations involved only testing and assembly, but this fab elevates India's position in the semiconductor industry, allowing for full-scale chip fabrication.

Bharat Semi and 3rdiTech have emerged as national champions in this endeavor, becoming the first Indian companies to integrate design and manufacturing (IDM) of semiconductors onshore. This partnership showcases the success of the iCET initiative and the \*Atmanirbhar\* vision, making Bharat Semi and 3rdiTech pioneers in India's semiconductor industry.

in a heart-wrenching letter to In May 2024, a 35-year-old associ-EY's India chairman, Rajiv Memani, wrote about the extreme work pressure her daughter faced. "She worked tirelessly at EY, giving her all to meet the demands placed on her. However, the workload, new environment, and long hours took a toll on her physically, emotionally, and mentally," she said. Anna's managers reportedly assigned her tasks at odd hours, allowing themselves the luxury to watch cricket matches, while dismissing her pleas for rest as they insisted working nights was "normal."

#### The Modern Rat Race

Anna's story reflects a growing crisis in modern workplaces where unending work hours have become synonymous with productivity. Young professionals, particularly in finance, consulting, and law, are expected to work relentlessly, often at the cost of their health. In a culture where long hours are normalized and even celebrated, many are pushed to the brink of burnout.

This toxic work culture is not limited to individual organizations but is deeply entrenched in society. Leaders across industries often promote an unhealthy ideal of hard work. Indian Prime Minister Narendra Modi, for instance, has taken pride in working around the clock with minimal sleep, even though he concedes that such a lifestyle is not for everyone. Similarly, Infosys founder Narayana Murthy recently suggested that young people should work at least 70 hours a week to boost productivity.

While the value of hard work is undeniable, the focus on the sheer ate at Bank of America died after working multiple 100-hour weeks. Despite work-hour restrictions introduced in the banking industry a decade ago following the death of a sleep-deprived intern, long hours and unreasonable demands remain the norm across many sectors.

A Wall Street Journal investigation revealed that "long hours and deference to bosses' commands, no matter how unreasonable, are the norm industrywide." Novice workers are often at the receiving end of this grueling work culture, where they are expected to prove their worth by sacrificing their well-being.

Even beyond finance and consulting, overwork is taking a toll in unexpected areas. In European football, elite players like Manchester City's Rodri have expressed concerns about the increasing number of matches they are expected to play each season. Rodri, who could play up to 75 matches in the 2024-25 season, said, "It is too much. Not everything is about money or marketing. It is about the quality on show."

#### The Broader Crisis of **Exploitative Work Practices**

The crisis extends far beyond corporate offices and football stadiums. In traditional, rural settings, young brides and pregnant women are often burdened with unpaid household labor, drawing a grim parallel to the exploitation faced by overworked professionals like Anna. This back-breaking work often goes unnoticed but is no less destructive to the health and well-being of those who endure it.

#### A Future of Increased **Pressure**

The future of work seems poised to exacerbate these issues further. As artificial intelligence (AI) becomes more integrated into workplaces, the pressure on human workers to keep up with AI's unrelenting productivity will only increase. Unlike human beings, AI doesn't need rest or care, making it a more cost-effective and "productive" alternative to human labor.

This shift towards AI-driven productivity could eliminate the need for companies to invest in the physical and mental well-being of their employees, further undermining the value of human workers. As AI becomes more prevalent, the anti-human nature of certain managerial practices will likely intensify, leading to a workplace culture where burnout and overwork are not only normalized but expected.

#### Conclusion

Anna Augustine's death is a tragic reminder of the devastating effects of modern work culture. As companies chase profits and productivity, the well-being of employees is increasingly being sacrificed. While leaders in business and politics often promote the virtues of hard work, the reality is that many workers are being pushed to their limits. Without meaningful changes to the way work is structured and valued, more lives will be at risk in the pursuit of corporate goals.

This collaboration marks a significant leap in India's semiconductor ecosystem, allowing the country to join a select group of nations with the capability to manufacture advanced semiconductors onshore. It also enhances India's position as a "net security provider" in the region by becoming a "net technology provider."



The elections for the 288 assembly seats in Maharashtra are anticipated to take place in November. Currently, the BJP holds the largest number of seats with 103 MLAs, followed by the Shiv Sena, NCP, Congress, and others. As the election approaches, seat-sharing agreements within the Mahayuti alliance will be crucial for each party's strategy.

## **Escalation in Lebanon: Israeli Strikes Kill 182 Amid Ongoing Conflict**

Israeli air strikes on Hezbollah strongholds in Lebanon on Monday resulted in 182 fatalities, marking the deadliest incident since the outbreak of the Gaza conflict on October 7. This surge in violence comes after Hamas launched an unprecedented attack on Israel, drawing Hezbollah and other Iran-backed groups into the fray.

The Israeli military reported targeting over 300 Hezbollah sites, while Hezbollah responded with rocket fire aimed at northern Israel. The Lebanese health ministry confirmed that the air strikes had also injured 727 people, including many women and children. Civilians in southern towns and villages were urged to evacuate, as Israel warned that its military operations would continue.

In southern Lebanon, the strikes led to widespread displacement, with many fleeing to schools converted into shelters or camping in the streets. Witnesses described heavy explosions, particularly around the ancient city of Baalbek.

Israeli military spokesman Rear Admiral Daniel Hagari emphasized the



intent to conduct extensive and precise strikes on what he termed "terror targets" throughout Lebanon, urging civilians to move away from potential targets. This military escalation is seen as part of Israel's strategy to change the "security balance" in the north, according to Prime Minister Benjamin Netanyahu.

Hezbollah's leadership indicated readiness for further military engagement, declaring a "new phase" in its confrontation with Israel. Following recent air strikes that killed key Hezbollah com-

manders, the group retaliated with rocket attacks, escalating tensions further.

International leaders, including U.S. President Joe Biden, have expressed concern over the potential for a wider conflict. The UN chief warned that Lebanon could become "another Gaza," highlighting the urgent need for diplomatic efforts to prevent a catastrophic escalation. The humanitarian crisis continues to deepen, with thousands displaced and ongoing violence affecting civilians on both sides.



#### **India Probes Netflix for Alleged Visa Violations and Discrimination**

In the email, Yadav detailed concerns regarding Netflix's conduct in India, stating, "We have received certain details regarding the stated company's conduct, visa violation, illegal structures, tax evasion, and other malpractices." Mehta, who left Netflix in 2020, is currently pursuing a lawsuit in the U.S. against the company for alleged wrongful termination, as tion—claims that Netflix has denied.

While Mehta expressed support for the Indian investigation, hoping for transparency in the findings, she did not elaborate on the specifics of the government's allegations. The FRRO and India's home ministry have not responded to media inquiries regarding the investigation.

Netflix, which has around 10 million subscribers in India, has increasingly focused on local content, collaborating with Bollywood actors and producers. However, the streaming giant has faced backlash over certain portrayals in its shows, prompting it to add disclaimers to a series amid public outcry regarding sensitive themes.

Sri Lanka has made history by electing leftist leader Anura Kumara Dissanayake as its new president. In a resounding rejection of the established political dynasties, the people have turned away from figures like the Rajapaksas, Ranil Wickremesinghe, and Sajith Premadasa, who many believe played a role in the country's severe economic collapse.

Dissanayake, popularly known as AKD, won 42.3% of the vote (5.7 million votes) in the second round of counting in the country's first-ever second preference vote count. He defeated Sajith Premadasa of the Samagi Jana Balawegaya (SJB), who garnered 32.8% (4.5 million votes). Wickremesinghe, who had served as president since the economic crisis peaked in 2022, came in a distant third with just 17.3% of the vote. Namal Rajapaksa, son of former President Mahinda Rajapaksa, secured a mere 2.4%.

players, especially India and China, both of whom have vested interests in Sri Lanka's strategic location in the Indian Ocean. Over the past 15 years, Sri Lanka has gravitated towards China, awarding it several lucrative projects, including the development of Colombo's airport and the controversial Hambantota Port, which sits along a crucial shipping lane. His political career began in the 1990s as a student leader, when he became involved with the JVP, a party historically known for its radical left-wing ideology and violent uprisings in the 1970s and 1980s. Over time, however, the JVP tempered its hardline stance, and Dissanayake's rise within the party reflects a shift toward a more flexible, practical approach to governance.

Dissanayake became a Member of Parliament in 2000 and eventually ascended to leadership of the JVP in 2014. His ability to connect with rural and working-class citizens, combined with his tenure as agriculture minister, gave him an edge over the political elite, particularly during the country's economic crises in the 2010s and early 2020s.

Amid skyrocketing inflation, severe food, fuel, and medicine shortages, and swelling debt, Dissanayake's anti-corruption platform and promises of political reform struck a chord with Sri Lankans, particularly the youth, who were fed up with the existing political system.

#### Challenges Ahead for Dissanayake

Dissanayake's victory is both an opportunity and a challenge for his party, the JVP. This is the first time they are in power, and their lack of governing experience could pose difficulties both domestically and internationally. As Sri Lanka faces the monumental task of rebuilding its economy, Dissanayake will need to navigate uncharted waters while managing the expectations of an electorate that is desperate for change.

His presidency will also be closely watched by international while supporting the island nation's recovery and stability.

stabilize Sri Lanka, its closest neighbor. Prime Minister Narendra Modi was quick to congratulate Dissanayake on his victory, expressing his desire to strengthen India-Sri Lanka cooperation. In response, Dissanayake thanked Modi and echoed the sentiment of strengthening ties.

Historically, however, the JVP has been skeptical of India, particularly during the late 1980s when the party protested against Indian imports, including essential medicines. India is also concerned about the Tamil population in Sri Lanka, as Dissanayake's party has had a complex relationship with Tamil nationalism and the LTTE. The JVP opposed the 1987 Indo-Sri Lanka Peace Accord and the implementation of the 13th amendment, which aimed to grant more autonomy to Sri Lanka's Tamil minority.

Most Tamils did not vote for Dissanayake, as they perceive his party to be apathetic toward their political demands. Whether Dissanayake will reach out to the Tamil minority now that he is in power remains to be seen, and India will be closely monitoring his actions in this regard.

#### Geopolitical Realities

Despite his leftist ideology, Dissanayake has shown a willingness to engage with India and adapt to the geopolitical realities of the region. Earlier in 2024, he met with Indian Foreign Minister S. Jaishankar and National Security Advisor Ajit Doval, signaling his openness to maintaining strong ties with India.

However, Dissanayake's domestic focus on economic recovery could lead to some friction with Indian interests. One area of concern is India's wind power project in northern Sri Lanka, which is strategically important due to its proximity to Tamil-majority areas. Any disruption to this project could open the door for Chinese influence, something India would want to avoid.

#### Conclusion

Anura Kumara Dissanayake's presidency marks a significant turning point for Sri Lanka. His ability to balance domestic reforms with the complex geopolitical landscape of South Asia will determine not only his success but also the future of India-Sri Lanka relations. As both countries navigate this new political chapter, India will need to leverage its diplomatic channels to ensure its interests in Sri Lanka are protected, while supporting the island nation's recovery and stability.

Apple's recent iPhone 16 series Alaunch has been met with excitement, but some users of the iPhone 16 Pro are reporting frustrating touchscreen problems. According to a report from 9to5Mac, many users are experiencing unresponsive screens where taps and swipes are ignored, affecting everyday actions like scrolling and typing.

The issue appears to stem from a software bug rather than hardware faults. Specifically, it may be linked to the iOS touch rejection algorithm. With the iPhone 16 Pro's thinner bezels, users may inadvertently touch the edges of the display while holding the device, leading to unintentional touch rejections. This

phone is used without a case, which can leave the edges more exposed.

Feedback on social media platforms, particularly Reddit, reveals that many users are encountering these issues. One iPhone 16 Pro Max user expressed frustration, noting, "It has never happened on any other iPhone model but it happens regularly on my 16 Pro Max." Another user echoed similar sentiments, saying, "Taps and swipes not registering constantly. Typing is just way worse."

Some users who upgraded to iOS 18 on older models, like the iPhone 15 Pro, reported similar touchscreen issues. They indicated that the problems often arise in apps that require scrolling, such as

This arrangement allowed Google to utilize its advertising tools to favor its own interests, effectively enabling the company to "cherry pick the best supply" of ad impressions.



Boland expressed that having Google act as an intermediary posed significant challenges for Facebook, as it created a layer between the social network and advertisers. He elaborated that Google's advertising exchange provided it with a "last look" advantage in online auctions, allowing the company to decide after an ad had been auctioned whether it wanted to purchase it. Boland likened this practice to Google being able to select the best apples from a crate before anyone else could buy them.

The trial, overseen by Judge Leonie Brinkema, will determine whether Google illegally monopolized advertising technology markets. Boland's testimony underscores the challenges Facebook faced in competing against a dominant Google, revealing insights into the competitive landscape of online advertising.

This innovative development is considered a major advancement in improving nutrition through the biofortification of vegetables like lettuce, chard, and spinach, all while preserving their characteristic flavor and aroma. The research findings were published in the Plant Journal, emphasizing the potential of golden lettuce to address nutritional deficiencies without sacrificing taste.






