

AP Aims to Become a Drone Hub, CM Chandrababu at Amaravati Drone Summit

TPN, Andhra Pradesh: The Amaravati Drone Summit-2024, inaugurated by Chief Minister Chandrababu Naidu at the CK Convention Center, aims to position Andhra Pradesh as a leading hub for drone technology in India. Additionally, he revealed that 300 acres of land would be allocated in Orvakallu for the development of drone-related initiatives.

The summit features 50 stalls showcasing various drone technologies, alongside nine panel discussions aimed at exploring the future of drone applications across multiple sectors. CM Naidu reaffirmed his government's commitment to support drone companies and encouraged a global perspective, stating, "Think Globally... Act Globally."

With this ambitious vision, Andhra Pradesh is poised to leverage drone technology not only for disaster management but also for enhancing law enforcement capabilities, ensuring that any misconduct is swiftly addressed with live surveillance capabilities.

Minister Narayana Advocates for Metro Rail Projects At New Delhi

TPN, New Delhi: Andhra Pradesh's Municipal and Urban Development Minister Narayana visited New Delhi for the second consecutive day, where he engaged in crucial discussions regarding the Visakhapatnam and Vijayawada metro rail projects. During his visit, Minister Narayana met with Union Urban Development Minister Manohar Lal Khattar and Special Chief Secretary of the Municipal Department, Anil Kumar Singhal.

AP High Court Issues Bailable Warrants for Four **IAS Officers**



TPN, Andhra Pradesh: The Andhra Pradesh High Court has issued bailable warrants against four Indian Administrative Service (IAS) officers in a contempt of court case, expressing dissatisfaction with their failure to comply with court orders. The warrants were issued by a single bench led by Justice Venkateshwarlu, who highlighted the officials' disregard for the court's directives requiring them to appear in person and explain why their orders had not been implemented.

The IAS officers affected by the ruling include Shasibhushan Kumar, Principal Secretary of the Water Resources Department; SS Rawat, Principal Secretary of the Finance Department; Kritika Shukla, Kakinada District Collector; and Himanshu Shukla, Konaseema District Collector. The court's decision to issue the bailable warrants comes as a response to the officers' non-compliance, which the court views as a serious matter.

The hearing for this case has been adjourned until November 27, allowing time for the warrants to be executed. The High Court's actions underline the importance of accountability and adherence to judicial directives, emphasizing that officials must respect the court's authority and comply with its orders.

This development serves as a reminder to all government officials regarding their obligations to the judicial system, highlighting the consequences of failing to uphold the law and respond to court mandates.

CID Conducts Searches in Liquor Distilleries Across AP

TPN, Andhra Pradesh: The Criminal Investigation Department (CID) has launched a series of searches at various liquor distilleries across the state as part of an investigation into allegations of illicit liquor sales and price-fixing during the previous government. The operation is focused on ensuring compliance with liquor quality standards and examining the overall supply chain of alcoholic beverages.

In the joint Krishna district, the CID is investigating several prominent establishments, including Vijayawada Continental Wines Limited in Kankipadu, BRK Spirits in Gandepalli, Sentini Bio Products Company in Kankipadu, BVS Distilleries in GampalaGoodem, and SravaniAlcho Company.

The ongoing searches are part of a broader



initiative by the CID to address concerns regarding the quality of liquor being produced and distributed within the state. Authorities are also examining records related to sales and supply pricing to identify any irregularities or malpractice that may have occurred during the previous administration.

The CID has been conducting searches in multiple locations across Andhra Pradesh, aiming to uphold the integrity of the liquor industry and ensure that consumers receive quality products. This move is seen as a significant step in regulating the liquor market and holding accountable those involved in

Home Minister Anitha Responds to YCP Criticism Amid Recent Crimes

TPN, Andhra Pradesh: In a strong witnessed an alarming rise in rebuke to the YuvajanaSramikaRythu Congress Party (YCP), Andhra Pradesh Home Minister Anita condemned the party leaders for their criticisms of the coalition government in light of recent crimes, including the rape of Atya girls and the tragic victimization of an intermediate student in Badwelu by her lover.

Anita held a media conference at the TDP central office in Mangalagiri, where she expressed her outrage, stating, "It is a shame that criminals and those with a criminal record who abused the system in the guise of power are talking about the coalition government." TPN, Andhra Pradesh: The Andhra Pradesh government has officially declared that sand is now completely free for residents of the state, according to Minister KolusuParthasarathy. In response to comments from leaders of the YuvajanaSramikaRythu Congress Party (YCP), Minister Parthasarathy urged the public not to believe the propaganda surrounding the issue.

Minister Parthasarathy emphasized that Chief Minister Chandrababu Naidu has made it clear that individuals in need of sand can collect it using their own vehicles. He reassured the citizens that they are only required to pay the cost associated with sand mining. "Those who need sand can take it in their own vehicles, and it is sufficient to cover just the mining costs," he stated.

Minister Parthasarathy also issued a stern warning regarding the misuse of the newly free sand. He cautioned that any diversion or illegal selling of free sand would result in strict penalties for those involved. "The government is committed to ensuring that the benefits of this policy reach the people without corruption," he asserted.

This announcement aims to alleviate the concerns of those reliant on sand for construction and other needs, reinforcing the government's dedication to transparency and accessibility in resource management.

Minister GottipatiRavikumar Criticizes **Jagan for Destroying State Systems**

TPN, Andhra Pradesh: Minister GottipatiRavikumar launched a scathing attack on YCP chief Jaganmohan Reddy, accusing him of committing evils during his five-year tenure that no other chief minister has ever done. Ravikumar assured the public that the coalition government would take strict action against anyone who disrupts law and order, restoring stability to the state.

Additionally, the BJP complaint accuses Anil Borugadda of threatening Satyakumar over the phone, even going so far as to threaten his life. The BJP leaders also stated that Borugadda

insulted Satyakumar using inappropriate language on social media.

According to the BJP, earlier complaints were filed with the Mangalagiri and Tullur police stations regarding these incidents, but no case was registered. The BJP is now urging the Guntur SP to take action and file a case against both Nandigam Suresh and Borugadda Anil.

Allegations of Exploitation at Siddhartha Medical College Hostels

TPN, V.V.S.MadhuBabu: Students at Siddhartha Government Medical College have raised serious concerns over the alleged exploitation by a private supervisor managing their hostel facilities. Since 2015, Satyanarayana has served as the hostel supervisor, appointed by a private individual rather than the college administration. Students report that they collectively pay around ₹35,000 monthly for his supervision, which primarily involves ensuring cleanliness in the bathrooms.

Before 2016, students were responsible for managing hostel sanitation without a formal policy, hiring private workers and paying them ₹20,000 each month. With 500 students residing in the hostel, the financial burden on them



is significant, amounting to ₹7.5 lakh per month in hostel fees. While the college employees eight sanitation workers, an additional 15 workers are funded directly by the students' hostel fees.

Students are frustrated with the lack of action from in-charge principal D. Venkateswara Rao, questioning why he supports a private individual over a govern-

ment-appointed supervisor. Reports indicate that the hostel conditions are inadequate, with poor food quality and safety issues such as collapsing ceilings. Additionally, allegations have surfaced regarding the supervisor's unethical practices, including charging excessive fees for maintenance and demanding commissions for various services.

The students are demanding the removal of the private supervisor and the appointment of a regular employee in his place. They also seek the government's intervention to repair hostel facilities and ensure proper sanitation management. Frustrated by the administration's inaction, around 60 students have expressed their grievances directly to the incharge principal.

Minister Nadendla Manohar Inaugurates Grain Purchase Center

TPN,Eluru: State Civil Supplies Minister Nadendla Manohar inaugurated the Kharif grain purchase center at Chebrolu Rythu Sevakendra in Unguthur Mandal, Eluru district on Tuesday. The event saw participation from key leaders, including ZP Chairperson Ghanta Padmasree, Denduluru MLA Chinthamaneni Prabhakara Rao, and Tadepalligudem MLA Bolishetti Srinivas.

During the inauguration, Minister Nadendla Manohar highlighted the financial challenges inherited from the previous government, including grain arrears amounting to Rs. 1,674 crores and additional debt of Rs. 11 lakh crores. Despite this, the coalition government, under the leadership of Deputy Chief Minister Pawan Kalyan, swiftly cleared farmer dues by negotiating with banks.

Manohar emphasized the coalition government's commitment to farmers, particularly by allowing them the freedom to choose which rice mill to send their grain to,



unlike the previous system of forced randomization. He also assured that payment would be made directly to farmers within 48 hours of handing over the grain to the millers. The government has also taken on the cost of sacks and transportation, ensuring that these costs are deposited into farmers' accounts.

In a significant move to support tenant farmers, the Minister introduced e-crop registration, allowing tenant farmers to register and sell their crops at Rythu Sevakendras for the first time. He also announced a 50% subsidy for tarpaulins to aid in drying grain.



Heavy Rains Flood Anantapur, **Colonies Submerged as Rivers**

TPN, rains in Anantapur have caused widespread flooding, with several colonies submerged as the Pandameru River overflows. The deluge has brought life to a standstill, paralyzing the region.

Floodwaters from the swollen Pandameru River have inundated surrounding colonies. Jagananna Colony, under Upparapally Panchayat, is among the worst affected, with homes completely submerged. As the floodwaters rose, residents sought refuge

Anantapur: Heavy on the roofs of their homes, awaiting rescue. Local authorities quickly launched evacuation and rescue operations, moving affected people to safer locations.

> In addition to the flooding in residential areas, the Muktapuram pond in Kanaganapalli mandal has overflowed, spilling rainwater onto the Hyderabad-Bangalore National Highway. This has caused vehicular traffic to halt, with stranded vehicles unable to proceed due to the submerged roadway. A local

petrol station has also been flooded.

The Kanaganapalli dam has broken, further contributing to the rise of the Pandameru River. Traffic on the Hyderabad-Bangalore highway remains at a standstill, and the Chitravati River in Puttaparthi is also flowing at dangerous levels.

Officials are closely monitoring the situation and continuing rescue efforts to help those affected by the heavy rainfall and flooding.

Leopard Appears At Eluru Dist, Residents Are in Fear



living in fear due to the recent movement of leopards in the area. Reports indicate that the leopards are roaming between Rajamahendravaram and the Tirumala region, causing widespread panic among locals.

Officials from the forest department have determined that the leopard spotted in Rajamahendravaram last month is the same one currently seen in the M. Nagulapalli suburb of Dwaraka Tirumala. Despite the anxiety it has caused, authorities confirm that the leopard has not attacked humans; however, it has been preying on local dogs.

TPN, Eluru: Residents of the district are To monitor the leopard's movements, officials have installed cameras and a cage in the area. They discovered leopard footprints in the sugarcane fields of M. Nagulapalli, and lab tests have confirmed that these prints belong to leopards. Residents of nearby villages have been advised to remain vigilant and exercise caution when working in the fields.

> The first reported sightings of the leopard occurred a few days ago, prompting locals to alert the forest department. In response, officials deployed a team to monitor the situation, setting up 15 trap cameras, two live cameras, and a cage in the suburbs. Recent examinations have confirmed the pres

ence of leopards in the area.

Adding to the concern, another sighting of a leopard was reported on Saturday night along the Bhimadolu Junction-Nagulapalli route. As a result, officials are focusing their efforts on the surrounding areas, including Polasanipalli, Arjavarigudem, and Ambarupeta, enhancing surveillance and installing additional trap cameras.

Villagers have been warned against traveling alone and advised to work in groups while carrying sticks for protection. Authorities reassure residents that they are actively working to capture the leopard and alleviate fears in the community.

The Path to Viksit Bharat: A Misguided Approach

Prime Minister Narendra Mo- crease in agricultural employment India toward industrialization, or di's term has been marked by the catchy slogan "Viksit Bharat," which aims to project an image of progress despite a decade of sluggish economic growth. However, catchy phrases alone won't address India's structural issues. Typically, as economies mature, there's a shift from low-paying agricultural jobs to higher-paying roles in manufacturing and services. Yet, under Modi's leadership, the opposite trend is occurring.

The 2022-23 All India Rural Financial Inclusion Survey highlights this concerning shift: the proportion of rural households reliant on agriculture rose from 48% in 2016-17 to 57% in 2021-22. While some might attribute this to the pandemic's impact, evidence suggests that de-industrialization was already underway prior to COVID-19. The trend of young workers moving away from agriculture had been reversed, with a dramatic innoted even before the pandemic.

Data from the Periodic Labour Force Survey further illustrates this reversal. The share of agricultural workers dropped from 59% in 2004-05 to 43% in 2018-19, reflecting expected industrial growth. However, this trend has since reversed, rising to 46% in 2023-24. While Modi's government touts "aspirational" policies, one must question who truly aspires to a life in agriculture.

Simultaneously, the proportion of workers in manufacturing has decreased to 11%. Initiatives like "Make in India" have not materialized into tangible growth in this sector, raising concerns about the government's capacity to deliver on its promises.

This situation can be interpreted in two ways: either the Modi administration is well-intentioned but ineffective, unable to transition it is ensnared in a cycle of political maneuvering that prioritizes the interests of big businesses over genuine economic reform. Modi's government, supported by corporate allies, seems more focused on large infrastructure projects and corporate tax cuts than on fostering a vibrant small and medium-sized enterprise (SME) sector, which is essential for job creation.

While some steps have been taken to support SMEs, the primary focus remains on larger corporations. Without a robust strategy to facilitate access to capital, technology, and markets for small businesses, the promise of better job opportunities will remain unfulfilled. To truly realize the vision of Viksit Bharat, India must ensure that workers can transition from low-paying agricultural jobs to more secure and lucrative employment in manufacturing and services.

A Troubling Revelation: Justice and Divine Intervention



At a recent event in Maharashtra, Chief Justice of India D.Y. Chandrachud made a startling comment regarding one of the Supreme Court's most contentious decisions: the Ayodhya judgment. He revealed that during the protracted deliberations, he metaphorically sought guidance from the deity at the center of the dispute, implying that a divine solution was found. This anecdote raises significant concerns about the judiciary's integrity and its role in upholding the Constitution.

Chandrachud's statement suggests that the court received divine insight, culminating in a ruling that favored the party involved in the illegal demolition of the Babri Masjid. While the judges acknowledged this act as a crime, they nonetheless legitimized the possession of the land by those who committed it. This "might is right" approach undermines the very foundations of justice. The notion that a direction to provide five acres for a new mosque can equate to justice is farcical, as the core issue remained: can violence and dispossession be sanctioned?

The implications of Chandrachud's remarks extend beyond the Ayodhya case. His comments might explain the revival of disputes like Gyanvapi, contradicting the Places of Worship Act, 1991, which aims to preserve the status quo of religious sites as of August 15, 1947. This opens the floodgates for Hindutva groups to lay claims on Muslim sites across the country, potentially leading to further communal strife.

Moreover, the Chief Justice's appeal to a deity raises questions of conflict of interest. How can a judge seek solutions from a divine figure who is directly linked to the case? Such actions, if reversed—where a judge from a minority community claims divine guidance-would likely provoke accusations of bias.

Chandrachud's reliance on a "divine solution" reveals an unsettling evasion of accountability. It suggests that the flawed reasoning of the Ayodhya judgment may be attributed to higher powers rather than the judges themselves, undermining the credibility of the judiciary.

Judges are sworn to uphold justice according to the Constitution, not divine mandates. While personal beliefs can inspire courage in difficult decisions, the judiciary must remain firmly anchored to constitutional principles. The Ayodhya ruling, made amid a politically charged atmosphere, reflects a failure to uphold justice rather than a courageous stand.

BRICS+ Summit: A New Era

Infrastructure and Economic Growth

In the 1950s, long-distance travel in the United States was hampered by a fragmented road network and poor maintenance, which limited economic activity and labor mobility. The Federal-Aid Highway Act of 1956 dramatically changed this by authorizing the construction of the U.S. Interstate Highway System. This infrastructure project, costing about \$500 billion today, connected remote areas to major markets and facilitated the movement of goods, reducing transportation costs by up to 30%. The highway system is credited with contributing as much as 25% of U.S. productivity growth between 1950 and 1990, highlighting the essential role of infrastructure in economic expansion.

This principle is echoed in Paul Romer's 'endogenous growth theory,' which posits that investments in public infrastructure enhance productivity and foster innovation. Research by David Aschauer also established a link between infrastructure investment and economic productivity, suggesting that the U.S. slowdown in the 1970s was partly due to declining public works.

In India, the government has recognized the critical importance of infrastructure investment, especially through the PM Gati Shakti initiative launched in October 2021. This program aims to address long-standing infrastructure bottlenecks by integrating 44 central ministries and 36 states



onto a single platform that flecting substantial progress utilizes advanced Geographical Information System (GIS) technology. This real-time data-driven approach facilitates better resource allocation and improves project execution.

Gati Shakti seeks to lower India's high logistics costs, which historically range between 13-14% of GDP, compared to the global average of 8-9%. High logistics costs hinder trade competitiveness, as they impose To maximize the impact of Gati significant burdens on firms. By focusing on multimodal connectivity and optimizing resource allocation, Gati Shakti is designed to enhance supply chain coordination and reduce vanced technologies and perthese costs.

The BRICS summit in Kazan marks a significant milestone, expanding from the original BRIC grouping to BRICS+, now including nine member nations with Saudi Arabia slated to join. This expansion reflects a growing interest from approximately 30 additional countries eager to align with BRICS+, as noted by Russian Foreign Minister Sergei Lavrov.

When Jim O'Neill coined the term BRIC in the early 2000s, he forecasted that the economies of Brazil, Russia, India, and China would dominate the global economic landscape by 2050. Today, BRICS+ represents a combined GDP surpassing that of the G7 by about 5 percentage points, with Lavrov stating that the group accounts for 37.3% of the world's GDP—significantly higher than the EU's 14.5%.

At the summit, Lavrov criticized the US-led world order, asserting that the United States is reluctant to relinquish its dominance since World War II. He described the US dollar's leading role in the

international monetary system as maintained through "artificial" efforts, particularly after the US abandoned the gold standard.

BRICS+ aims to challenge the dollar's supremacy by developing an international payment system that can function independently of it. Indian Foreign Secretary Vikram Misri confirmed ongoing discussions about local currency settlements among member nations, although no final agreements have yet been established. The emphasis on using local currencies for trade reflects a desire to bolster correspondent bankpartners.

Western sanctions against Russia following its invasion of Ukraine have intensified Moscow's push to establish this new framework, signaling to the West that it still has robust allies. Iran, another new member of BRICS+, faces severe US sanctions, and the grouping hopes to support each other against a perceived Western hegemony.

Ahead of the summit, Russian Finance Minister Anton Siluanov advocated for new institutions akin to the Bretton Woods system, critiquing the current roles of the IMF and World Bank. However, whether China—benefiting from the existing global order—will support a complete overhaul of these institutions remains uncertain, particularly as it seeks reforms alongside India.

As discussions unfold, much hinges on the upcoming US presidential election. Former President Donald Trump has threatened to impose taring networks among BRICS iffs on countries distancing themselves from the dollar, adding to the complexities of the geopolitical landscape.

> With the dollar commanding 59% of official foreign exchange reserves as of early 2024, BRICS+ faces an uphill battle. All eyes will be on Russia during this pivotal summit, as any announcements regarding the future direction of this coalition could reshape global economic alliances.

Won't Apologise: Udhayanidhi Stalin On 'Sanatan Dharma' Remark

Tamil Nadu's Deputy Chief Minister Udhayanidhi Stalin has made it clear that he will not apologize for his controversial remarks about 'Sanatan Dharma.' Speaking at a wedding in Dindigul district, he asserted that his comments were in line with the legacy of Dravidian leader Periyar, who championed women's empowerment and fought against educational denial.

Stalin stated, "Periyar gave his voice to oppose (this practice). Anna Durai and Karunanidhi also spoke out. I echoed their sentiments, but they've misrepresented what I said and lied about it." He noted that legal cases have been filed against him not just in Tamil Nadu but in various parts of India, with some demanding an apology in court. Firmly, he said, "What I said is said. I am Karunanidhi's grandson and will not apologize for anything."

This marks Udhayanidhi's first public statement on the issue since he assumed the role of Deputy Chief Minister. His initial comments in March, where he stated that 'Sanatan Dharma' should be "annihilated like mosquitos causing malaria and dengue," sparked significant backlash.

Despite strong court observations regarding his statements, his legal team argues that in Tamil Nadu and southern states, 'Sanatan Dharma' has historically been viewed through the lens of untouchability and caste discrimination. They maintain that Udhayanidhi had no intention of offending Hindu sentiments.

In their email, the father expressed their profound sense of helplessness over the brutal crime against their daughter and urged the minister's intervention for a swift investigation.

"After the heinous, unforeseen incident that happened to our daughter, we have been going through tremendous mental pressure and feeling helpless," he stated, highlighting the urgent need for support and guidance.

A BJP state committee member noted that while Amit Shah was scheduled to visit Kolkata on October 24 for upcoming by-elections in West Bengal, his trip has been postponed. India and Singapore Boost Military Ties in Defence Dialogue

The India and Singapore agreed to enhance military cooperation during the 6th India-Singapore Defence Ministerial Dialogue held on Tuesday, co-chaired by Defence Minister Rajnath Singh and his Singaporean counterpart Ng Eng Hen. The discussions focused on strengthening ties through joint training and industrial collaboration.

Both ministers acknowledged the deep-rooted bilateral defense relations, emphasizing a shared commitment to regional peace, stability, and security. They agreed to extend their bilateral agreement on joint military training for another five years and to enhance industrial cooperation. This includes exploring collaboration in advanced fields like automation and artificial intelligence, as well as expanding efforts in key emerging areas such as cybersecurity.



The dialogue comes at a significant time as India celebrates a decade of its Act East policy, with Singapore playing a vital role in fostering economic cooperation, cultural connections, and strategic connectivity with nations in the region. Next year, both countries will also com-

memorate the 60th anniversary of their diplomatic relations.

Prime Minister Narendra Modi recently highlighted the importance of India-Asean (Association of Southeast Asian Nations) relations, especially amid rising global tensions and conflicts. At the 21st Asean-India Summit in Vientiane, Laos, Modi asserted that the 21st century would be defined by India and the Asean bloc, unveiling a 10-point plan aimed at deepening ties in areas such as trade, tourism, cyber initiatives, and health.

Modi reiterated India's commitment to supporting Asean's unity and centrality, particularly regarding the Indo-Pacific region, where China is actively expanding its influence. His remarks reflect growing concerns over China's aggressive moves and their implications for regional security.

Overall, the strengthened military cooperation between India and Singapore is poised to enhance strategic partnerships in the face of evolving geopolitical challenges, reinforcing both nations' roles in promoting stability in the Indo-Pacific region.





Ukraine Not Seeking Nuclear Weapons From The West: President Zelensky



Ukrainian President Volodymyr Zelensky clarified on Tuesday that Ukraine is not requesting nuclear weapons from its Western partners to defend itself against Russia. This statement comes after recent comments he made suggesting that Kyiv might pursue NATO membership or nuclear arms as a means of protection.

In a discussion with journalists, Zelensky emphasized, "We are not asking for nuclear weapons to be given to us." This remark was made shortly after he hinted at Ukraine's intentions to explore nuclear options during a European Union summit. Zelensky highlighted the historical context of Ukraine's nuclear capabilities, noting that the country inherited the world's third-largest nuclear arsenal following the dissolution of the Soviet Union in 1991. However, Ukraine relinquished these weapons in 1994 under the Budapest Memorandum, which included security guarantees from Russia and the United States.

Zelensky lamented the consequences of giving up the nuclear arsenal, stating, "We gave away nuclear weapons. We did not get NATO. All we got was a full-scale war and many victims." He underscored the urgency of Ukraine's situation, asserting, "We need NATO, because we don't have the weapons that can stop Putin." His comments were aimed at reinforcing the necessity of a strong alliance with NATO as a countermeasure to Russian aggression.

The remarks drew a sharp response from Moscow. Russian President Vladimir Putin labeled Zelensky's comments as "a dangerous provocation," warning that any moves toward nuclear armament would provoke a corresponding reaction from Russia. This exchange underscores the heightened tensions in the region as Ukraine continues to navigate its security challenges amid the ongoing conflict.

Zelensky's clarification reflects Ukraine's complex security landscape and its ongoing pursuit of stronger international alliances, especially in light of its precarious situation with Russia.



Hezbollah Launches New Rocket Attacks on Israel

Hezbollah has escalated its conflict with Israel, firing rockets at two military bases near Tel Aviv and one near Haifa on Tuesday morning. This barrage coincides with U.S. Secretary of State Antony Blinken's arrival in Israel to advocate for a renewed ceasefire amidst ongoing hostilities.

The Lebanese armed group stated it targeted Israeli military installations as diplomatic attempts to resolve the year-long conflict in Gaza continue to falter. Hezbollah's actions followed a significant Israeli airstrike on Monday night that resulted in at least 13 casualties in Beirut.

Shortly after Blinken's arrival, which marks his 11th trip to the region since Hamas's attack on

Turkey Seeks BRICS Membership Amid Geopolitical Shifts

As Ukrainian President Volodymyr Zelensky called for support at a conference in Berlin, Turkish Foreign Minister Hakan Fidan met with Russian President Vladimir Putin in Moscow, where discussions reportedly went "fantastically well." Following this meeting, Turkey's Justice and Development Party (AKP) confirmed its formal application to join the BRICS bloc, marking a significant geopolitical move.

AKP spokesman Omer Celik stated that President Recep Tayyip Erdogan has consistently expressed Turkey's desire for BRICS membership, emphasizing that the application process is underway. This development is noteworthy as it positions Turkey—both a NATO member and an EU candidate—within a group perceived as a counterweight to Western influence, particularly dominated by Russia and China.

The BRICS bloc, originally coined by economist Jim O'Neill in 2001, has evolved from a loose association of emerging economies to a more organized group, recently expanding to include Egypt, Ethiopia, Iran, and the UAE. With Turkey's application, nearly 20 other nations are vying for BRICS membership, prompting internal debates among founding members about expansion. Turkey's bid is particularly significant given its strategic location, with coastlines on both the Mediterranean and Black Seas, and its historical ties to NATO.

First Case of New Mpox Variant Detected in Germany

The Robert Koch Institute (RKI) announced on Tuesday that Germany has reported its first case of a new mpox variant. This infection, acquired abroad, was detected on October 18, and health officials are closely monitoring the situation. Despite the detection of this variant, the RKI assessed the risk to the general population as low, emphasizing that close physical contact is necessary for transmission.

In its statement, the RKI reassured the public that while the new variant has emerged, current health risks remain manageable. The institute is committed to ongoing surveillance and will adjust its risk assessment as needed based on evolving circumstances. The emergence of the new variant comes amid heightened global awareness, as the World Health Organization declared mpox a global public health emergency for the second time in August, following an outbreak in the Democratic Republic of Congo that has since spread to neighboring countries.

The situation has prompted health authorities to remain vigilant. The initial signs of the mpox virus spreading beyond Africa were noted on August 15 when global health officials confirmed a case of a new strain in Sweden. This highlights the global nature of health threats and the importance of coordinated responses to emerging infectious diseases. Health experts continue to urge caution and awareness, particularly regarding modes of transmission and preventive measures. Individuals are encouraged to stay informed about health advisories and to practice safety measures, especially in contexts involving close physical interactions.

China and India Reach Agreement on LAC to Ease Border Tensions

China confirmed on Tuesday that it has made "progress" in resuming patrols along the Line of Actual Control (LAC) with India, stating that both nations have reached a solution that is viewed positively by Beijing. Chinese foreign ministry spokesperson Lin Jian indicated that ongoing communication through diplomatic and military channels has facilitated this development.

The announcement follows Indian Foreign Secretary Vikram Misri's earlier statement about an arrangement concerning patrolling at friction points in eastern Ladakh. Misri noted that Indian and Chinese negotiators have been in close contact over recent weeks, leading to this agreement aimed at disengagement and resolution of issues that emerged during the 2020 border clashes.

Under the new arrangement, both countries will resume patrolling according to an "agreed perceived LAC," specifically in areas like the Depsang Plains and Demchok. The agreement includes protocols allowing each country to patrol twice a month with a fixed contingent of 15 personnel, thereby reducing the potential for clashes. Additionally, both sides will notify each other prior to conducting patrols.

Crucially, the arrangement specifies that the Chinese military will dismantle any defensive positions in the Depsang area and will




not obstruct Indian troops in critical zones. While this development marks a significant step toward resolving the border standoff that began after the Galwan clashes in June 2020, it is noted that troop withdrawal will not occur immediately, aside from seasonal adjustments ahead of winter.

This renewed collaboration increases the likelihood of a bilateral meeting between Prime Minister Narendra Modi and Chinese President Xi Jinping during the BRICS summit. Since the Galwan clashes, high-level communication between the two countries had been sparse, but recent meetings between Indian and Chinese officials suggest a thaw in relations is underway. As both nations work towards implementing this new agreement, the potential for improved ties remains on the horizon.

Ambuja Cements, part of the Adani Unit (IU) with a 4 MTPA clinker capac-Group, announced on October 22 its ity and a split Grinding Unit (GU) of 6 decision to acquire a 46.8% stake in MTPA in North India. Orient Cement Ltd (OCL) for an equity value of ₹8,100 crore. The acquisition will be funded entirely through internal resources.

Karan Adani emphasized that OCL's efficient assets, equipped with railway sidings and supported by captive power plants and renewable energy, present a valuable opportunity to increase capacity to 16.6 MTPA in the near future. OCL has also secured a concession from MPPGCL for a new Grinding Unit within the Satpura Thermal Power Plant premises.

Deloitte India forecasts that the Indian economy could grow between 7% and 7.2% in the current fiscal year, driven by robust government spending and increased investments in manufacturing. However, the consultancy warns that a slowdown in global growth may affect future prospects.

Additionally, India's shift toward clean energy is expected to generate new employment opportunities across various sectors. Paytm Posts ₹930 Crore Profit, Shares Drop 4% Amid One-Time Gain



Shares of One 97 Communications fell over 4% on Tuesday following the Ltd, the parent company of Paytm, fintech platform's announcement of

a net profit of ₹930 crore for the July-September quarter (Q2) of FY25. This profit was primarily attributed to a one-time exceptional gain of ₹1,345 crore from the sale of its entertainment ticketing business to Zomato, marking a significant turnaround from a loss of ₹292 crore in the same period last year.

However, without this one-time gain, Paytm reported a loss of ₹495 crore for Q2, reflecting a 70% increase in losses compared to the previous year. The company's revenue rose to ₹1,660 crore, representing an 11% quarter-on-quarter growth, driven by increased activity in payments and financial services.

The company reiterated its commitment to achieving EBITDA profitability before employee stock option plans (ESOPs) by the fourth quarter of FY25. It emphasized that focusing on payments and the distribution of financial services will be crucial for sustainable, profitable growth.

In terms of performance, the payments business generated revenue of ₹981 crore, a 9% increase quarter-on-quarter, while revenue from financial services surged by 34% to ₹376 crore. The number of subscription-paying device merchant sign-ups exceeded January levels, bringing the total merchant subscriptions to 1.12 crore.

To further boost performance, Paytm plans to reactivate merchants and redeploy inactive devices to new users over the next 2-3 quarters, which is expected to enhance its active merchant base and revenue.

Looking ahead, Paytm's strategy includes prioritizing compliance, continuing innovations in merchant payments, driving customer acquisition, and expanding high-margin financial services revenue through new partnerships. The company also plans to leverage Artificial Intelligence (AI) to optimize costs. Additionally, Paytm will introduce default loss guarantees (DLGs) for merchant loans, having secured board approval for a ₹225 crore DLG from a partner over time.



Google Chrome for Android Introduces Identity Check for Enhanced Security

oogle Chrome for Android is set to en-Ghance password security with a new feature called Identity Check, currently in testing. This feature, announced last week, aims to add an extra layer of protection by requiring biometric authentication before auto-filling passwords through the Google Password Manager, particularly outside of trusted locations.

According to a report by Android Authority, in collaboration with tipster Mishaal Rahman, the Identity Check feature will necessitate biometric verification—such as a fingerprint scan—when accessing apps that typically require a PIN or passcode. This adds an important security measure for users who may be accessing sensitive information in less secure environments.

Major Sports Cut from 2026 Glasgow **Commonwealth Games**

Tn a significant blow to India's med-Lal hopes, key sports including hockey, badminton, cricket, and shooting have been removed from the 2026 Commonwealth Games scheduled in Glasgow from July 23 to August 2. This decision aims to streamline the event, limiting it to ten disciplines to keep costs manageable, as the Games will be held across only four venues.

The Commonwealth Games Federation (CGF) announced that the Games will include athletics, swimming, artistic gymnastics, track cycling, boxing, judo, and more, totaling nine fewer events than the 2022 Birmingham edition. The limited schedule has been introduced to facilitate logistics and reduce expenses following the withdrawal of the Australian state of Victoria as the original host due to rising costs.

Glasgow's four selected venues—Scot-Swimming Centre, Emirates Arena, and the Scottish Event Campus—will accommodate the competitions. Notably, the exclusion of shooting is particularly dis-

appointing for India, which has historically excelled in the sport, amassing 135 medals in past Commonwealth Games. Additionally, both the Indian men's and women's teams have consistently performed well in hockey, bringing home multiple medals, including gold in 2002.

Badminton also holds a strong record for India, with 31 medals, including titles in men's and women's singles from the 2022 Games. Cricket, which returned to the Games recently, saw the Indian women's team secure a silver medal. The removal of these disciplines raises concerns about India's overall medal tally in 2026.

Despite the setbacks, para-athletics will remain a vital part of the Games, with six para sports included in the program. CGF CEO Katie Sadleir emphasized that the 2026 Games will strive for sustainability and financial independence, aiming to deliver substantial economic benefits to stoun Stadium, Tollcross International Glasgow and surrounding regions. This approach marks a shift towards a more flexible and collaborative future for the Commonwealth Game.




