Judges Never Said Ghee Was Not Adulterated - Pawan Kalyan



TPN, Tirupati: In response to the ongoing controversy surrounding the alleged adulteration of ghee used in the preparation of Tirumala Laddu, Andhra Pradesh Deputy Chief Minister Pawan Kalyan has clarified his stance following recent comments from the Supreme Court.

The controversy began when former Chief Minister Chandrababu Naidu accused the previous YSR Congress Party government of using animal fat instead of ghee in the sacred laddus. This sparked a movement led by Pawan Kalyan, along with other Jana Sena and Bharatiya Janata Party (BJP) leaders, including Ministers Nara Lokesh and Y. Satyakumar. Pawan Kalyan, in a symbolic act of penance, undertook an initiation, vowing to atone for what he saw as a wrongdoing by the YCP government. As part of this initiation, he cleaned the steps of the Vijayawada Kanakadurgamma Ammavari temple, with the penance set to conclude in two days.

The Supreme Court took up the case based on a petition filed by BJP MP Subrahmanya Swamy, who sought clarity on the allegations made by Chandrababu Naidu. The court concluded that there was no evidence of ghee adulteration, deeming the allegations baseless. In its judgment, the court also advised that religious matters, particularly those involving sacred offerings like the Tirumala Laddu, should not be politi-

Responding to the Supreme Court's remarks, Pawan Kalyan spoke briefly to reporters in Vijayawada. He stated that the Supreme Court judges never explicitly said that the ghee used in the making of the Tirumala Laddu had not been adulterated. Instead, he explained that the judges likely made their conclusions based on the information available to them during the trial.

Pawan Kalyan further pointed out that the court mentioned some discrepancies in the dates on the laboratory reports concerning the ghee adulteration tests. He emphasized that these discrepancies were the source of confusion, and the court indicated that these issues would be clarified in due course.

As the controversy continues to unfold, Pawan Kalyan remains firm in his stance, suggesting that the truth behind the allegations may still come to light with further investigation and clarification.

DCM Pawan Kalyan Ascends Tirumala via Alipiri Stairway

Andhra Pradesh Deputy Chief Minister and Janasena Party leader Pawan Kalyan has arrived in Tirupati to visit the sacred Tirumala temple. The Jana Sena cadre gave him a grand reception upon his arrival. As part

of his spiritual journey, Pawan Kalyan performed a puja at the Alipiri foot mandapam in Tirupati before beginning his ascent to Tirumala on foot, accompanied by his close friend and art director Anand Sai. Given the significance of his visit, heavy security measures have been put in place along the Alipiri staircase route.

This visit comes in the wake of the recent Tirumala laddu adulteration controversy, which prompted Pawan Kalyan to undertake a symbolic penance. As part of his penance, he will visit Lord Venkateswara at the Tirumala temple tomorrow to conclude his initiation.

Following his spiritual visit, Pawan Kalyan is scheduled to hold a Varahi Sabha in Tirupati on the evening of October 3rd, where he is expected to address his followers and the public.





End of Jagan-Era Liquor Shops in Andhra Pradesh

TPN, Andhra Pradesh: One of the most controversial policies during the tenure of former Chief Minister Jagan Mohan Reddy was the state-controlled liquor distribution system. Under this plan, all liquor shops in Andhra Pradesh were brought under government control, eliminating private ownership.

This policy was met with widespread criticism, particularly regarding the quality of the liquor being sold. Many consumers complained about contaminated products, while the steep prices and a cash-only payment system added to the discontent. The flaws in the policy became a major point of contention during Jagan's time in office.

In a significant shift, the new NDA government in Andhra Pradesh has taken decisive action to dismantle the liquor system established by Jagan. As per the latest notification issued by the state government, all the government-run liquor shops from the previous regime will be closed, and new private outlets will be introduced.

Between October 1 and October 9, tenders for private liquor shops will be issued. Each tender will be priced at Rs 2 lakh, and the allocation will be decided through a lottery system on October 11. From October 12 onward, 3,396 private liquor outlets will open across Andhra Pradesh, marking the complete closure of the old government-run shops.

The remaining liquor stock from the Jagan administration will be returned to the Andhra Pradesh excise department, and any tainted liquor will be removed from circulation. The government has also promised to ensure only high-quality liquor is available moving forward.

Additionally, the licensing fees for these new private shops have been significantly increased. Depending on the location and population density, a liquor license could now cost between Rs 50 lakh and Rs 85 lakh, a major hike from previous policies.

This move by the NDA government aims to restore consumer trust and improve the quality of liquor available in the state, while also eliminating the much-criticized policies of the previous regime.

Good News for Ration Card Holders, 4 Crore People to Benefit...!




TPN, Andhra Pradesh: The coalition government in Andhra Pradesh has delivered good news to ration card holders, especially at a time when the prices of essential commodities are rising across the state. Civil Supplies Minister Nadendla Manohar made a key announcement, stating that 4.32 crore people will benefit from the government's decision. This announcement is expected to lead to long queues at ration shops as people take advantage of the scheme.

Minister Manohar revealed that the government has decided to reduce the prices of jaggery and sugar in response to the escalating prices of essential commodities in Andhra Pradesh. He emphasized that this crucial decision comes at a time when prices are soar-

ing, causing hardship for the common people. The government has already reduced the price of jaggery, which was selling for around Rs.180 per kg in the open market, to Rs.160, and later to Rs.150, twice within the same month.

Starting today, Minister Nadendla Manohar announced that sugar will be sold at Rs.67 per kg, and half a kilogram of sugar at Rs.17. The distribution program for sugar and jaggery will be officially launched in Tenali at 3 p.m. today by Minister Manohar. The state's 1.49 crore ration card holders will receive pulses and sugar as part of the scheme, benefiting an estimated 4.32 crore people. From today, 29,811 ration shops across the state will distribute 1 kg of jaggery and 1 kg of sugar to each eligible household.

Home Minister Anitha Brings Good News for Constable Candidates



TPN, Amaravati: In a positive development for aspiring police constables in Andhra Pradesh, Home Minister Anitha has announced the resumption of the recruitment process for 6,100 constable posts, which was stalled over a year and a half ago. The recruitment process had been halted due to the MLC elections for graduates. However, with the coalition government now in place, the process is set to continue.

Minister Anitha confirmed that further tests for the recruitment will begin soon. The Physical Measurement Test (PMT) and Physical Efficiency Test (PET) will be completed within five months. Complete details about the process will be available on

the official website, slprb.ap.gov.in.

The recruitment for these posts was originally initiated by the previous YSR Congress Party (YCP) government in 2022, when a notification was released for 6,100 constable positions. The preliminary written exam was conducted, and results were announced in January 2023, with 95,208 candidates passing. However, the recruitment process came to a halt due to the MLC elections.

Now, with the recruitment back on track, candidates can prepare for the upcoming phases, and the government is committed to ensuring the timely completion of the process.

Govt Allocates ₹10,000 Crore to Revamp Andhra Pradesh Roads

in Andhra Pradesh, led by Chief Minister Chandrababu Naidu and Deputy CM Pawan Kalyan, has announced a significant investment of ₹10,000 crore to address the state's road infrastructure issues. This comes after widespread criticism of the previous YSR Congress Party (YCP) government for failing to build new roads and clear contractor dues between 2019 and 2024.

The newly sanctioned funds will be directed towards both the construction of new roads and the renovation of existing ones, with top priority given to rural areas severely affected by recent floods. A total of ₹614 crore has been allocated for roads under the Panchayatraj department, targeting 3,941 kilometers across 2,534 residential areas. The state government has also set aside ₹3,311 crore for

Furthermore, an additional ₹1,900 crore has both urban and rural regions of the state.

TPN, Andhra Pradesh: The NDA government been approved for the construction of 1,854 kilometers of roads in 162 more residential areas. Loans amounting to ₹693 crore will be sought from the National Bank for Agriculture and Rural Development (NABARD) to fund 1,827 kilometers of new rural roads.

> Panchayatraj officials are preparing to invite tenders for 126 kilometers of new roads with an estimated budget of ₹106 crore. Meanwhile, an additional 4,635 kilometers of roads are set for renovation, with ₹1,122 crore earmarked for pothole repairs and the laying of bitumen (BT) roads.

> In total, ₹7,312 crore will be spent on 16,627 kilometers of new roads across the state, reflecting the government's commitment to improving Andhra Pradesh's infrastructure. The comprehensive road development plan is expected to significantly enhance connectivity and improve living conditions across




Promotion Stagnation in Medical Health Department

Allegations of Corruption and Neglect by Doctors and Staff

TPN, Andhra Pradesh: The Medical Education Department, led by Superintendent Kanu Saigala of a prominent government hospital, has become a source of frustration for many in the medical community. Doctors and staff are voicing concerns about a lack of promotions and career progression within the department. Many have worked for decades, some as long as 30 years, without receiving a single promotion, leading to a sense of disillusionment among the medical profession-

Since the coalition government came into power, there has been hope for change. However, the administration's actions have not met the expectations of the medical community. Doctors are now expressing disappointment, claiming that the

His control over the promotion process is seen as a major obstacle to progress. Allegations also suggest that the same superintendent previously lobbied the former government to increase the retirement age for doctors from 63 to 65 years, reportedly collecting payments from individuals to push the agenda.

> The influence of this superintendent, combined with his connections in the Secretariat, is believed to be preventing the promotions file from moving forward. Even though six Additional DMEs have already been promoted, they have been waiting for their postings for months, with no resolution in sight. Additionally, there are claims that another file, which

for over ten days, remains untouched.

Despite multiple allegations and complaints, no action has been taken against this superintendent, who is rumored to have campaigned for votes in favor of the YCP during the elections. It is further alleged that he has boasted to fellow doctors about giving a crore rupees as a gift to a young leader in the coalition government, possibly securing his influence and protection.

The situation has raised serious concerns about the integrity of the promotion process in the Medical Health Department, with many calling for a thorough investigation into the allegations and demanding transparency in the handling





Chandrababu Would Have Spoken Based on Report -Purandeshwari

TPN, Andhra Pradesh: AP BJP president Daggubati-Purandeshwari stated that former Chief Minister N. Chandrababu Naidu must have made his comments regarding the alleged mixing of animal fat in Tirumala Laddus based on a report. She explained that Chandrababu would only speak after reviewing and confirming the information with the concerned authorities. Purandeshwari also mentioned that the court will evaluate how the government's decisions are being implemented in such cases.

Addressing the recent controversy, she urged people to reflect on whether the courts have the right to question the Chief Minister's statements. These remarks were made during a bridge program held at the BJP state office in Vijayawada, where petitions were being accepted from the public.

Purandeshwari noted that people are sub-



mitting petitions on various issues, with a significant number of them concerning land matters. She added that these petitions are being forwarded to the District Collectors for further action. She emphasized that the Waradhi program is designed to act as a bridge between the government and the people, helping to address their concerns.

Culprits Will Be Caught Soon-Nagababu on Laddu Issue




Pawan's comments reflected this.

Solid Arrangements for Dussehra Celebrations in Indrakiladri



Vijayawada: Legislator Yalamanchili Satyanarayana, popularly known as Sujana Chaudhary, chaired a review meeting at the Model Guest House on Tuesday regarding the Dussehra celebrations set to take place at Indrakiladri from October 3rd to 12th. The meeting was attended by key officials, including Devadaya Dharmadaya Minister Anam Ramanarayana Reddy, Home Minister Vangalapudi Anitha, Vijayawada MP Keshineni Sivanath, Excise Minister Kollu Ravindra, and other legislators.

Sujana Chaudhary emphasized that comprehensive arrangements are in place to ensure a grand celebration this year. He stated that several reviews have been conducted with the relevant authorities to finalize the preparations. Chief Minister Chandrababu Naidu has announced that silk clothes will be offered to the goddess on the auspicious Moola Nakshatra day, October 9th.

Additionally, a temporary stairway will be constructed leading out from the Shiva temple, and a laser show will be featured to showcase the glory of the Indrakiladri site.

The meeting concluded with Sujana Chaudhary and other ministers offering special pujas to Krishna at the Durga Ghat, marking the spiritual significance of the upcoming festival.

Roots of the Israel-Hezbollah Conflict: A 42-Year History (1982-2024)

The long-standing conflict between Israel and Hezbollah, the Lebanese Shiite militant group, has been a defining aspect of Middle Eastern geopolitics for over four decades. Born from the turmoil of war and sustained by regional power dynamics, the relationship between the two has been marked by violence, military engagements, and deep animosity.

1982: The Birth of Hezbollah

Hezbollah, or "Party of God," emerged in the aftermath of Israel's 1982 invasion of Lebanon. The invasion was aimed at dismantling the Palestine Liberation Organization (PLO), which had been using Lebanon as a base for attacks on Israel. This invasion created fertile ground for Hezbollah's formation, especially in the eastern Bekaa region of Lebanon. Iran's Revolutionary Guards



Corps played a significant role in Hezbollah's development, providing training, funding, and ideological guidance to shape the organization.

By 1985, Hezbollah had evolved from a shadowy faction into a potent military force. Its armed wing, the Islamic Resistance, spearheaded attacks on Israeli forces occupying southern Lebanon, using tactics like suicide bombings and human wave assaults. Hezbollah's rise positioned it as a serious adversary to Israel, and the organization began to solidify its reputation as a powerful resistance force.

1992: Nasrallah Takes Command

tween Israel and Hezbollah calated further after an Israeli helicopter strike in 1992 killed Hezbollah's leader, Sheikh Abbas al-Musawi. His successor, Hassan Nasrallah,




then only 32 years old, quickly became a central figure in the group's leadership.

Nasrallah's leadership was tested early when Israel launched "Operation Accountability" in 1993, a large-scale incursion into southern Lebanon aimed at weakening Hezbollah. The group, however, proved resilient, continuing its armed resistance despite the operation.

Over the years, Nasrallah's stature grew as he led Hezbollah through various confrontations with Israel. His reputation as a formidable leader would be cemented by several key events in the mid-1990s.

1996: Operation Grapes of Wrath

In April 1996, Israel launched "Operation Grapes of Wrath," a military campaign aimed at neutralizing Hezbollah's ability to fire rockets into northern Israel. Over the course of 17 days, Israeli forces conducted hundreds of air raids and fired thousands of artillery shells into Lebanon. The operation caused significant civilian casualties, with 175 Lebanese, mostly civilians, killed and more than 300,000 people displaced from their homes.



attack spurred international outcry, prompting a ceasefire agreement by April 26, 1996. While the operation inflicted considerable damage, Hezbollah survived and continued its operations, further enhancing its image as a defender of Lebanese sovereignty.



2000: Israel's Withdrawal from Lebanon




In May 2000, Israel made a significant strategic decision: it unilaterally withdrew from southern Lebanon, ending an occupation that had lasted nearly two decades. This retreat followed a costly war of attrition, in which Hezbollah's relentless attacks on Israeli forces and their South Lebanon Army (SLA) allies had steadily eroded Israeli public support for the occupation.

Nasrallah was hailed as the architect of this withdrawal, and Hezbollah portrayed it as a significant victory over the Israeli military. The Israeli pullout was also influenced

by international pressure, particularly a 1998 UN Security Council resolution demanding Israel's withdrawal from Lebanon. The event remains a pivotal moment in Hezbollah's history, solidifying its position as a dominant military and political force in Lebanon.

people, mostly soldiers, died. Despite Israel's efforts to crush Hezbollah, the group survived, and both sides ultimately claimed victory. For Hezbollah, simply withstanding the Israeli onslaught was seen as a triumph and a validation of its military strategy.



2023-2024: A New Front Opens

The most recent chapter in the Israel-Hezbollah conflict began in 2023, when Israel's war with Hamas in Gaza reignited tensions across the region. Hezbollah, backed by Iran, launched attacks from southern Lebanon in support of Hamas. Cross-border skirmishes escalated over the course of a year, culminating in a significant Israeli airstrike campaign in September 2024.



Israel targeted Hezbollah positions across south-

ern Lebanon and even in the Beirut suburbs. In a major blow to the organization, Israeli forces reportedly killed several senior Hezbollah leaders, including Hassan Nasrallah, in an airstrike on Hezbollah's southern Beirut stronghold.

As of 2024, the conflict between Israel and Hezbollah remains unresolved, with no end in sight. Both sides continue to exchange fire, and the broader regional dynamics—particularly the involvement of Iran and the ongoing Israeli-Palestinian conflict—ensure that this decades-long struggle is far from over.







Congress Politics Is Limited To False Promises: PM Modi At Haryana Rally

As the Haryana Assembly polls approach, Prime Minister Narendra Modi launched a scathing attack on the Congress party, accusing it of perpetuating a culture of "false promises." Speaking at a rally in Palwal district, Modi asserted that Congress's aspirations to form the next government in Haryana are mere daydreams that will never materialize.

Highlighting the hardworking ethos of Haryana, Modi stated, "Haryana has taught us to work and do it hard. Congress's formula is - neither work nor let others work." He contrasted BJP's focus on results and dedication with Congress's history of unfulfilled commitments.

Modi urged the people of Haryana to reelect the BJP with a strong mandate, emphasizing that the state traditionally mirrors the central government. He referenced Madhya Pradesh and Rajasthan as examples where Congress's empty promises were met with a strong rebuke from the electorate, suggesting a similar fate awaits the party in Haryana.



The Prime Minister also addressed infighting within Congress, remarking that such disputes are evident to the electorate, particularly among the Dalit community. "The Dalit community has decided they will not be fooled by dynastic politics and will vote based on merit," he proclaimed, receiving enthusiastic applause from the audience.

Critiquing Congress's long tenure in power, Modi lamented the lack of basic amenities in the state, stating, "Even today, people do not have access to drinking water, pucca houses, sanitation, and toilets." He further condemned Congress for obstructing significant initiatives, including the construction of the Ram Temple and denying full constitutional rights to the people of Jammu and Kashmir.



Bengal Doctors Resume Strike Over RG Kar Hospital

Junior doctors in West Bengal have resumed their indefinite strike, ignited by the tragic rape and murder of a colleague at Kolkata's RG Kar Hospital on August 8. The doctors are pressing for essential demands, including enhanced safety measures for medical professionals across the state. In a statement released on Tuesday, they declared, "We are compelled to return to a full 'ceasework' starting today. Unless we receive clear action from the government on safety and patient services, we will continue our strike."

The striking doctors criticized the slow pace of the Central Bureau of Investigation (CBI) into their colleague's murder, stating, "The CBI has been unable to reach any conclusions, allowing the real culprits to go free due to delays in filing charges." They expressed disappointment over the Supreme Court's handling of the case, noting that hearings have been postponed and judicial processes delayed.

Ten days prior, the junior doctors had temporarily halted their month-long agitation after meeting with Chief Minister Mamata Banerjee, returning to provide essential services but refusing to operate outpatient departments. They had given the government a week to fulfill their demands.

The resumption of the strike follows an eight-hour meeting where the doctors reiterated their ten demands, including improved security measures, better hospital infrastructure, and the dismissal of key officials linked to a "threat culture." Although the state has replaced the Kolkata Police chief and two health department officials, the doctors feel insufficient action has been taken.

Have To Compete, Co-Exist, Confront, Contest With China: Army Chief

Indian Army Chief General Upendra Dwivedi has underscored the complexities of managing tensions with China, stating that India must adopt a strategy that includes competing, cooperating, coexisting, confronting, and contesting with its neighbor. He remarked, "As far as China is concerned, it has been intriguing our minds for quite some time."

General Dwivedi characterized the current situation as "stable but not normal," highlighting the sensitivity of the circumstances. He expressed a desire for the situation to return to what it was before April 2020, particularly concerning ground occupation and the buffer zones established since then. He reiterated the military's readiness, stat-



ing, "Until that situation is restored, the situation will remain sensitive, and we are fully operationally prepared to face any kind of contingency." He emphasized that trust has become the "biggest casualty" in the ongoing tensions.

Regarding ongoing diplomatic efforts, Dwivedi noted that both India and China have engaged in approximately 17 Corps Commander-level talks since April. He acknowledged the progress made but stressed the need for both sides to seek a win-win solution in difficult situations.

In a related update, the Ministry of External Affairs (MEA) described the current state of India-China relations as characterized by ongoing dialogue and efforts to resolve tensions through the Working Mechanism for Consultation and Coordination (WMCC). MEA Spokesperson Randhir Jaiswal highlighted that External Affairs Minister S. Jaishankar has addressed the relationship in various forums, ensuring transparency and regular updates on WMCC discussions.

Have No Role In MUDA Scam, Won't Resign: CM Siddaramaiah

Karnataka Chief Minister Siddaramaiah firmly reiterated on Tuesday, October 1, that he has no involvement in the alleged Mysuru Urban Development Authority (MUDA) scam and stated that he will not resign from his position. Speaking to reporters at Ravindra Kalakshetra, Siddaramaiah emphasized, "I am working according to my conscience, and there is no need for my resignation."

When questioned about calls for his resignation, he criticized opposition parties, asserting, "They are masters in lying. Will it be over if I tender my resignation? They are demanding my resignation unnecessarily. I have not committed any mistakes." He expressed confusion regarding the money laundering charges leveled against him, stating, "I don't know on what grounds these charges are framed against me."

The controversy intensified after Siddaramaiah's wife, Parvathy, decided to return 14 sites to MUDA, a move the opposition claims indicates guilt. The Chief Minister clarified that he was unaware of his wife's decision until she sent a letter. "Parvathy was the owner of 3.16 acres of land that MUDA had encroached upon and subsequently distributed sites. She sought alternative sites or land, which turned into a major controversy," he explained.

Siddaramaiah further criticized the BJP for referencing a statement he made in 2011 as an opposition leader regarding former Chief Minister B. S. Yediyurappa. He highlighted the differences between their cases, stating, "I have no role in this case. Yediyurappa had denotified land. Have I de-notified? Have I given any orders? Is there any money laundering? There is nothing. There is no comparison to his case."

As the political landscape continues to evolve, Siddaramaiah remains resolute in defending his integrity while challenging the opposition's claims.

RBI Reports Major Return of ₹2,000 Notes Post Withdrawal Announcement

The Reserve Bank of India (RBI) announced on Tuesday that an impressive 98% of the ₹2,000 denomination notes have been returned since its decision to withdraw them in May 2023. The total value of these notes in circulation has drastically decreased from ₹3.56 lakh crore to ₹7,117 crore.

On May 19, 2023, the RBI made a surprising announcement about the withdrawal of ₹2,000 notes, citing concerns over their quality and indicating that the notes had fulfilled their intended purpose since their introduction following the demonetization initiative in November 2016. The RBI stated, "98% of the ₹2,000 banknotes in circulation as of May 19, 2023, have since been returned."

Despite the withdrawal, the RBI confirmed that ₹2,000 notes remain legal tender. Citizens can still exchange these notes at any of the 19 issue offices of the RBI. The process allows individuals to either physically exchange the notes or send them by post for credit into their bank accounts.

The RBI's decision to withdraw the high-denomination notes has sparked discussions about the implications for the economy, cash transactions, and overall liquidity. While the return of the notes indicates compliance among the public, concerns about cash availability and the impact on everyday transactions persist.

As the RBI continues to monitor the situation, it aims to facilitate a smooth transition for those holding the ₹2,000 notes. The central bank's proactive measures suggest a commitment to ensuring the integrity of the currency system while addressing any challenges that arise from this significant monetary policy shift.

Will Lay Down Pan-India Guidelines On Demolition Of Properties: SC

The Supreme Court of India announced on Tuesday that it will formulate pan-India guidelines regarding the demolition of properties, emphasizing that any religious structure obstructing public roads, whether a 'dargah' or temple, must be removed to uphold public interest and safety. A bench consisting of Justices BR Gavai and KV Viswanathan clarified that unauthorized constructions, regardless of the individual's religion or belief, should be addressed uniformly across the nation.

During the proceedings, the bench reserved its verdict on a series of petitions alleging that properties owned by individuals accused of crimes were being demolished without due process in various states. The justices highlighted that the mere fact of being an accused or even a convicted individual does not justify property demolition.

"Our guidelines will apply to all citizens and institutions, without favoring any particular community," the bench stated. They reiterated that any religious structure obstructing public space must be removed, asserting that public safety is para-

mount.

The court maintained its earlier order, which requires prior permission for any demolition actions until a decision is reached. The bench stressed that notices for demolition must be sent via registered post to property owners and also displayed on an online portal for transparency.

Moreover, the justices suggested implementing a time window of 10 to 15 days between the issuance of a demolition order and its execution, allowing individuals to make alternative arrangements. The court expressed concern over the distress caused to families, particularly women and children, during abrupt demolitions.

The petitions under review were filed by organizations like Jamiat Ulama-i-Hind, which urged that demolitions should not proceed without following legal protocols. The Supreme Court's discussion also highlighted concerns about unequal enforcement of municipal laws, with some properties facing demolition while others remain untouched.

Biden Urges Ceasefire Amid Escalating Israel-Hezbollah Conflict in Lebanon

Despite U.S. President Joe Biden's calls to avoid ground operations in Lebanon, Israel has initiated "targeted" raids, raising concerns about a potential escalation in the region. On Monday, Biden expressed his discomfort with the situation, urging for an immediate ceasefire amid heightened tensions following the assassination of Hezbollah leader Hassan Nasrallah.

State Department spokesman Matthew Miller confirmed that Israel had informed Washington about its limited operations targeting Hezbollah infrastructure near the border. However, shortly after, the Israeli military announced it had launched "ground raids" on villages in southern Lebanon.

This pattern of escalating military action in response to U.S. calls for diplomacy is familiar. Just last week, Netanyahu ordered airstrikes against Hezbollah shortly after a joint U.S.-French statement advocating for a ceasefire. Brian Katulis from the Middle East Institute noted that the Biden administration has often been caught off guard by Israel's military decisions, despite providing the necessary military support. At the United Nations, as Netanyahu authorized the strike against Nasrallah, Secretary of State Antony Blinken reiterated the U.S. stance, stating that while Israel has the right to defend itself, the focus should be on how to achieve its security objectives effectively.

Ukraine's President Zelenskyy met Trump and Harris

Since the beginning of its full-scale invasion of Ukraine on February 24, 2022, Russia has reportedly lost 651,810 troops, according to the General Staff of Ukraine's Armed Forces. This figure, announced on September 29, includes 1,170 casualties recorded in just one day.

In addition to troop losses, the report details significant losses of military equipment: 8,869 tanks, 17,476 armored fighting vehicles, and 25,495 vehicles and fuel tanks have been destroyed. Other critical losses include 18,795 artillery systems, 1,204 multiple launch rocket systems, 962 air defense systems, 369 aircraft, 328 helicopters, 16,186 drones, 28 ships, and one submarine.

On the same day, Russian strikes on Zaporizhzhia in southern Ukraine resulted in at least 16 injuries, including two children aged eight and 17. The attacks involved multiple "massive aerial strikes" early in the morning, which destroyed a multi-story building and several homes. Reports indicate that Ukrainian emergency services are working to rescue individuals trapped under the rubble in the neighboring Donetsk region, where three fatalities and additional injuries occurred due to Russian attacks on Pokrovsk.

Netanyahu's Direct Address to Iranians: A Call for Change and Peace

In a pointed message to the people of Iran, Israeli Prime Minister Benjamin Netanyahu delivered a speech on Monday that criticized the Iranian regime while expressing hope for a better future. Speaking in English and subtitled in Persian, Netanyahu's address comes amid escalating Israeli military actions against Iranian-backed groups in the re-

Netanyahu condemned Iran's leadership for prioritizing regional conflicts over the well-being of its citizens. "Every day, you see a regime that subjugates you make fiery speeches about defending Lebanon, defending Gaza," he remarked, accusing the Iranian government of driving the region deeper into turmoil.

He emphasized that Iran's support for groups like Hezbollah and Hamas would not go unchallenged. "Iran's puppets are being eliminated," he stated, asserting



that Israel would take any necessary measures to protect its citizens.

The Prime Minister called for a shift in Iran's spending, suggesting that the billions wasted on warfare and nuclear ambitions could instead improve the lives of ordinary Iranians. He envisioned a future where the Iranian regime is replaced, leading to peace between Israel and Iran. "When Iran is finally free - and

that moment will come a lot sooner than people think - everything will be different," Netanyahu declared.

His address follows intensified Israeli military operations, including a major airstrike that reportedly killed Hezbollah leader Hassan Nasrallah, which has drawn reactions from anti-regime Iranians worldwide.

Netanyahu concluded by emphasizing that the people of Iran deserve better than their current situation. "You deserve more. The people of Iran should know - Israel stands with you," he affirmed, expressing hope for a future of prosperity and peace for both nations.

As tensions escalate, particularly following Iran's missile retaliations and Israel's targeted strikes, Netanyahu's remarks reflect both a warning and a call for solidarity with the Iranian people against their regime.



Shigeru Ishiba Becomes Japan's **New Prime Minister**

Japan welcomed a new prime minister on Tuesday as Shigeru Ishiba took office, vowing to reinvigorate the nation's sluggish economy, address a looming demographic crisis, and forge a robust alliance to counter China's influence. Ishiba, 67, who won a closely contested leadership race for the Liberal Democratic Party (LDP), plans to call a general election for October 27.

In a press conference following his appointment, Ishiba emphasized the grave security challenges facing Japan, describing the current environment as the most severe since World War II. "With the Japan-US alliance as a foundation, we will expand the circle of friendly and like-minded countries," he stated, underscoring his commitment to regional peace through strengthened diplomacy and defense.

His cabinet includes 19 ministers, with notable positions filled by Katsunobu Kato as finance minister and Gen Nakatani as defense minister. However, only two ministers are women, highlighting ongoing gender disparities in Japanese politics.

Ishiba's leadership marks a shift from his predecessor, Fumio Kishida, as he aims to restore public confidence and navigate Japan's broader economic and security challenges. Analysts note that Ishiba's experience and voter appeal are key factors in his selection, as the LDP seeks stability ahead of upcoming elections.

The financial markets reacted negatively to Ishiba's selection initially, with the Nikkei index plunging nearly five percent, although it recovered slightly to close up 1.9 percent. His support for potential interest rate hikes and corporate tax increases has raised concerns among investors.

A self-proclaimed defense enthusiast, Ishiba is expected to prioritize military issues, continuing Kishida's pledge to double defense spending and strengthen ties with the US amid rising tensions with China, Russia, and North Korea. He recently expressed support for a collective defense system in Asia similar to NATO, arguing that its absence increases the likelihood of conflict.

With a focus on economic revival and enhanced national security, Ishiba is poised to lead Japan through a critical period, as the nation grapples with both domestic and international challenges.

Japan's Prime Minister Kishida resigns along with his Cabinet

Japan's Prime Minister Fumio Kishida resigned along with his Cabinet on Tuesday, clearing the path for Shigeru Ishiba to assume leadership. Kishida, who took office in 2021, stepped down amid ongoing scandals that plagued his administration, allowing the ruling Liberal Democratic Party (LDP) to introduce new leadership.

Ishiba is expected to officially become Prime Minister later today, following a parliamentary vote dominated by the ruling coalition. He plans to call a snap election on October 27 to seek public approval for his policies. "I believe it is important to have the new administration get the public's judgment as soon as possible," Ishiba stated, though opposition parties criticized him for the short timeframe for parliamentary discussions before the election.


Kishida's resignation was anticipated after he announced his decision to step down at the end of his three-year term in August. His departure was confirmed during a Cabinet meeting, with Chief Cabinet Secretary Yoshimasa Hayashi acknowledging the global expectations for Japan's diplomatic role, especially amid rising tensions from Russia's war in Ukraine and conflicts in the Middle East. Hayashi expressed hope that the next administration would engage in robust diplomacy, emphasizing the need to uphold Japan's commitment to a free and open Indo-Pacific.

Most of the incoming Cabinet ministers, including Ishiba, are expected to be independent of traditional party factions, distancing themselves from the influence of former Prime Minister Shinzo Abe's powerful group, which has been linked to several scandals. As Japan navigates a complex international landscape, the Ishiba administration aims to restore public confidence and strengthen the country's diplomatic standing.



India Launches Anti-Dumping Probe Against Chinese Imports

Tndia has initiated an investigation into the al- Lleged dumping of six products, including specific chemicals, cold-rolled electrical steel, and black toner powder cartridges, imported from China. The Directorate General of Trade Remedies (DGTR), under the commerce ministry, is spearheading this probe following complaints from domestic manufacturers who claim that these imports are causing material injury to their industries.

The products under scrutiny include 1,1,1,2-Tetrafluoroethane (R-134a), Acrylonitrile Butadiene Rubber, certain Antioxidants, polytetrafluoroethylene, black toner powder cartridges, and coldrolled non-oriented electrical steel. Six separate notifications have been issued detailing the applications from various domestic players who argue that the influx of these cheaper imports is detrimental to their business.

SRF Ltd has filed a request for an anti-dumping investigation specifically regarding R-134a, primarily utilized as a refrigerant in automobile air conditioners. Similarly, Apcotex Industries Ltd is seeking a probe into the imports of Acrylonitrile Butadiene Rubber from China, the European Union, Korea, and Russia. This material is crucial in sectors like oil and gas due to its resistance to chemicals and extreme temperatures.

Vinati Organics Ltd has approached the DGTR regarding certain antioxidants sourced from China and Singapore, essential for petrochemical companies involved in plastic production. Additionally, Gujarat



Fluorochemicals Ltd is requesting an investigation into polytetrafluoroethylene, used in electronics and chemicals, while Indrayani Sales seeks a probe into black toner powder cartridges originating from China. POSCO Maharashtra Steel and CSCI Steel Corporation India have filed applications concerning coldrolled electrical steel.

The DGTR stated that they are proceeding with the anti-dumping investigations based on substantial evidence provided by the applicants. If the investigation confirms that the dumped products have harmed domestic industries, the DGTR will recommend imposing anti-dumping duties. The final decision on these duties will be made by the finance ministry.

These anti-dumping investigations aim to ensure fair trade practices, creating a level playing field for Indian manufacturers against the backdrop of increasing cheap imports.

SEBI Introduces Investment Product Bridging Mutual Funds and PMS

The Securities and Exchange Board of India (SEBI) has approved a new asset class that aims to fill the investment gap between mutual funds (MFs) and portfolio management services (PMS). 



For the second quarter of FY25, gross GST collections totaled ₹5.3 lakh crore, a decrease from ₹5.57 lakh crore in the first quarter. However, the overall GST collections for the first half of the fiscal year amounted to ₹10.87 lakh crore, reflecting a 9.6% increase compared to the same period last year.

India's Political Dynasties: Sons Who Followed Their Fathers' Footsteps













TPN, Prudhvi Gagarin: The recent elevation of Udhayanidhi Stalin, son of Tamil Nadu Chief Minister M.K. Stalin, as his deputy marks the formal succession within the Dravida Munnetra Kazhagam (DMK). This step not only aligns with DMK's symbolism, which includes a 'rising sun' as its emblem, but also solidifies Udhayanidhi's position as a future leader. His journey into politics began when he was inducted into the Tamil Nadu Council of Ministers in 2022, setting the stage for his rise to power. Udhayanidhi's path mirrors that of his father, who himself succeeded his father, M. Karunanidhi, by serving as Deputy Chief Minister from 2009 to 2011.

However, their political trajectories differ significantly. M.K. Stalin spent nearly two decades rising through the ranks of the DMK, forming the youth wing of the party and serving as the Mayor of Chennai before being named Deputy Chief Minister. In contrast, Udhayanidhi initially pursued a career in the Tamil film industry as a producer and actor before diving into politics. Despite his recent entry, Udhayanidhi has energized DMK cadres, particularly the youth, and has become a key player as the party prepares for the 2026 Tamil Nadu assembly elections.

Tamil Nadu's political scene has predominantly been a back-and-forth battle between the DMK and the All India Anna DMK (AIAD-MK). Following the passing of J. Jayalalithaa, the AIADMK has been trying to rebuild its influence, leaving space for the DMK to consolidate power with Udhayanidhi's rise.

Southern Dynasties: Gowdas, Naidus, and Raos

The tradition of political heirs extends beyond Tamil Nadu to other southern states, notably Karnataka, Andhra Pradesh, and Telangana. Karnataka's Gowda family stands out, with former Prime Minister H.D. Deve Gowda's sons, H.D. Kumaraswamy and H.D. Revanna, playing significant roles in state politics. Kumaraswamy has been Chief Minister twice and is currently serving as a Union Minister in Prime Minister Narendra Modi's cabinet. His political success, however, was preceded by years of strategic positioning within the state.

In Andhra Pradesh, N. Chandrababu Naidu's son, Nara Lokesh, has followed in his father's footsteps, returning to his father's cabinet and playing an active role in state governance. Meanwhile, in Telangana, K.T. Rama Rao, the son of former Chief Minister K. Chandrasekhar Rao, has made his mark in politics as well. Initially serving as IT Minister, K.T. Rama Rao has now become a central figure in shaping the future

of the Bharat Rashtra Samiti (BRS). However, neither Lokesh nor Rama Rao have been officially named as their fathers' successors, leaving room for further political maneuvering in the future.

Mixed Success in Northern India

While political legacies in southern India have been largely successful, the story in northern India is more mixed. In Punjab, Parkash Singh Badal's decision to elevate his son, Sukhbir Singh Badal, as Deputy Chief Minister yielded some success. The Shiromani Akali Dal (SAD) under Sukhbir Badal won the 2012 assembly elections, marking a rare instance of Punjab voting the same party into power for two consecutive terms. However, the Akali Dal has since struggled to retain its influence, particularly with the rise of the Aam Aadmi Party (AAP) in the state, which has significantly weakened the party's base.

Haryana presents an equally complex picture. The sons of former Chief Minister Bhajan Lal, Kuldeep Bishnoi and Chander Mohan, have been unable to sustain the political legacy of their father. While Kuldeep Bishnoi is currently with the Bharatiya Janata Party (BJP), Chander Mohan has aligned himself with Congress. The Haryana Janhit Congress (HJC), founded by Bhajan Lal, merged with Congress in 2016, further diluting the family's political presence.

Meanwhile, the legacy of Bansi Lal, another former Haryana Chief Minister, saw his sons split across different parties, none of them able to replicate his success. However, the political influence of Devi Lal's family, the third 'Lal' of Haryana politics, remains significant. Devi Lal's son, Om Prakash Chautala, was anointed as his successor and went on to serve as Chief Minister four times, though only once for a full term.

Challenges of Succession


Transferring political power across generations is rarely smooth. Mulayam Singh Yaday experienced this firsthand when his son, Akhilesh Yadav, became Chief Minister of Uttar Pradesh, sparking a bitter feud within the Yadav family. Despite Akhilesh's electoral success, internal conflicts have continued to affect the Samajwadi Party, highlighting the challenges inherent in political dynasties.

While some political heirs have successfully carried forward their family legacies, others have struggled to navigate the complexities of modern politics. The transfer of power through familial lines remains a delicate and unpredictable process, particularly in India's evolving political landscape.

Spotify Resumes Service After Three-**Hour Outage Affecting Thousands**



Cpotify faced a significant out-Sage on Sunday, lasting approximately three hours and impacting over 40,000 users in the United States at its peak, according to Downdetector.com. By 3 p.m. ET, fewer than 600 users were still experiencing issues.

In a post on social media platform X, Spotify reassured users, stating, "Everything's looking much better now!" However, the company has not yet provided an explanation for the outage.

During the downtime, users reported various streaming difficulties. Many were unable to access their playlists, with some stating they could only play songs they had recently listened to. Others experienced random interruptions in playback, leading to frustration and confusion among listeners.

Downdetector tracks outages through various sources, including user reports, and the spike in reports during the outage indicated widespread disruption. While Spotify's service has since been restored, the incident highlights the

challenges streaming platforms face in maintaining consistent availability.

This outage follows a trend seen in recent months, where streaming services have occasionally faced technical difficulties, affecting user experience. As Spotify continues to grow its user base and expand its services, ensuring reliable performance remains a top priority for the company.

Spotify's ability to quickly resolve the issue likely helped mitigate further user dissatisfaction, but the lack of immediate communication regarding the cause of the outage left many users seeking answers. In a digital age where streaming services are integral to daily life, maintaining smooth and uninterrupted service is crucial for user retention and satisfaction.

Mount Everest's Growth Linked to River Changes



Mountain in the world at 5.5 miles (8.85 km) above sea level, continues to grow due to geological processes. While the Himalayas have been rising gradually for the past 50 million years due to the collision of the Indian and Eurasian tectonic plates, recent research has identified an additional factor contributing to Everest's unusual growth.

Scientists believe that a significant alteration in the nearby river systems is playing a crucial role in this phenomenon. Approximately 89,000 years ago, the Kosi River merged with the Arun River, and this merger has been linked to an increase in Everest's height by an estimated 49 to 164 feet (15 to 50 meters). Current uplift rates are measured at around 0.01 to 0.02 inches (0.2 to 0.5 millimeters) per year.

The mechanism driving this growth is known as isostatic re-

ount Everest, the tallest bound. This process occurs when heavy materials, such as rock or ice, are removed from an area, causing the land to rise as it becomes lighter. 


