# **AP Govt Sanctions ₹2,684 Crores** for 'Deepam-2' Scheme

TPN, Andhra Pradesh: The Andhra Pradesh government has sanctioned ₹2,684 crores for the implementation of the 'Deepam-2' scheme, which is part of the Super Six guarantees promised by the coalition government before the elections. Chief Minister Chandrababu Naidu officially launched the scheme in Srikakulam on November 1, marking it as a Diwali gift for the citizens of the state.

As part of the initiative, the government has provided ₹894 crores to petroleum companies for the cost of the first phase of the scheme. This program will provide three free gas cylinders to eligible beneficiaries each year, with the funds handed over to representatives from Hindustan Petroleum, Bharat Petroleum Corporation, and Indian Oil Corporation during a ceremony at the Secretariat.

The 'Deepam-2' scheme aims to support the economically disadvantaged by supplying one cylinder every four months. The government will release the cost of three



gas cylinders in three installments annually. Beneficiaries were given the opportunity to book gas under this scheme starting October 29.

Within 48 hours of booking, the amount spent by beneficiaries on the gas cylinder will be credited to their accounts. The central government provides a subsidy of ₹25 per cylinder, while the remaining ₹876 will be covered by the state government. The implementation of this scheme will impose an annual financial burden of ₹2,684 crores on

the state.

Civil Supplies Minister Nadendla Manohar participated in the program alongside beneficiaries Balamma from Tenali, Bhavani from Eluru, and Mangatayaru from Vijayawada, along with officials from the civil supply department and representatives of the petroleum companies. The 'Deepam-2' scheme reflects the government's commitment to enhancing the living standards of the underprivileged in Andhra Pradesh.

## **Minister Nara Lokesh Envisions \$100 Billion Investment for AP** TPN, Andhra Pradesh: Andhra

Pradesh's Minister for Education, IT, and Electronics, Nara Lokesh, addressed the IT Serve Alliance Synergy Summit, highlighting the potential for a \$100 billion investment in the state as part of India's upcoming data revolution. Speaking to an audience of 2,300 industrialists from 23 countries, Lokesh outlined his vision for leveraging artificial intelligence (AI) to enhance governance and public services.

During his address, Lokesh emphasized the necessity of utilizing AI to tackle long-standing administrative challenges, noting its potential to significantly improve sectors such as education and healthcare. He shared a recent

initiative where his department responded to concerns from disabled students about examination formats, leading to a revision of government orders that limited their subjects.

Lokesh pointed out the massive investment landscape in India, projecting \$300 billion in data services, with Andhra Pradesh poised to attract \$100 billion. He stated, "We will not compete with other states but with other countries in the development of the state," reflecting the government's proactive approach to transforming challenges into opportunities.

He praised innovative drone usage during recent floods, which provided essential support to affected communities, and an-

nounced plans for an AI University in Andhra Pradesh aimed at developing international-level expertise to streamline governance.

Reflecting on his political journey, Lokesh described the past five years as a "dark era" for the state, sharing personal challenges, including a 53-day wrongful imprisonment. He expressed gratitude for his wife Brahmani's support and reaffirmed the Telugu Desam Party's commitment to decentralizing development, assuring that industrialization would not compromise agriculture.

Concluding his remarks, Lokesh expressed optimism about the future, stating that the people would ultimately determine his political trajectory while emphasizing his dedication to serving Andhra Pradesh.

### **Minister Nadendla Announced** Launch of Deepam 2 Scheme in AP

TPN, Andhra Pradesh: Minister Nadendla Manohar announced that the coalition government in Andhra Pradesh is set to launch the Deepam 2 scheme on November 1. In an interview with ABN Andhrajyothy, he highlighted the government's commitment to women's health and welfare despite the financial challenges inherited from the previous administration, which left behind debts amounting to ₹13 lakh crores.

Minister Manohar stated that the Deepam 2 scheme will provide free gas cylinders to beneficiaries, marking it as the first initiative being implemented under the "Super Six" programs. He revealed that free gas bookings commenced on October 29, with over 400,000 bookings recorded on the first day. He confirmed that oil companies have the capacity to fulfill approximately 250,000 bookings daily.

The Chief Minister, Chandrababu Naidu, will distribute the first free gas cylinders in Ichapuram, Srikakulam district, during the launch event. Manohar mentioned that the Chief Minister has already issued advance payment to the oil companies to facilitate the distribution.

TPN, Andhra Pradesh: The Andhra Pradesh government has commenced the design process for a new AP Bhawan in Delhi, inviting tenders for its redevelopment. The State Roads and Buildings Department has requested designs for construction on three specific locations: Godavari, Swarnamukhi Block, and the Nursing Hostel at Pataudi House, covering a total of 11.53 acres.

This initiative follows the formal partitioning of AP Bhawan after the bifurcation of the state. The Union Home Department has approved the allocation of land, designating 8.245 acres to Telangana and 11.536 acres to Andhra Pradesh along Delhi's Ashoka Road and Madhavrao Cynthia Marg. The approved distribution includes 5.781 acres in Godavari and Swarnamukhi blocks, as well as 3.359 acres in the Nursing Hostel and 2.396 acres

# **CID Launches Investigation into** Kadambari Jethwani Case

TPN, Andhra Pradesh: The CID has officially commenced its investigation into the high-profile case involving Mumbai actress Kadambari Jethwani. Jethwani and her parents attended a court hearing today, following the government's order to transfer the case to the CID for further inquiry.

CID officials initiated their investigation

by seizing relevant records from the Ibrahimpatnam police station. They have also arrested the primary accused, Kukkala Vidyasagar, and petitioned the court for his custody to facilitate further questioning. As part of the investigation process, CID officials are re-recording statements from Jethwani and her parents.

The case has gained significant attention, with multiple individuals implicated, including several high-ranking police officers: DGP PSR Anjaneulu, IG

Kanti Rana, DIG Vishal Gunni, ACP Hanumantha Rao, and CI Satyanarayana, along with a lawyer. The government deemed it necessary to involve the CID due to the seniority of the police officers involved and to ensure an impartial investigation.

In a recent court proceeding, the CID requested custody of Vidyasagar for seven days to aid their investigation. However,

the court has scheduled the next hearing for November 4, where it will consider counterarguments from the defense.

Additionally, Vidyasagar's petition challenging the Vijayawada court's remand order was dismissed by the High Court. The judge affirmed that the police acted within legal bounds during his arrest, stating there was no justification to overturn the remand order issued by the 4th Additional Chief Magistrate on September 23.

#### **MLA Kotam Reddy Alleges Sand Corruption During YCP** Regime, Supports Free **Sand Policy**

TPN, Nellore: MLA Kotamreddy Sridhar Reddy, during the 'Free Sand Joy' event at the Rural TDP Office on Wednesday, made pointed allegations against the previous YCP government, particularly targeting Chief Minister Jagan Mohan Reddy's role in the sand trade. Addressing construction workers, builders, and locals, Kotam Reddy

claimed that during YCP's rule, sand was exclusively transported in large tippers, allegedly reserved for those with high-level connections, while regular tractor operators—primarily poorer individuals were sidelined. "When anyone attempted to intervene, calls were made from the CM's office, and SPs and Collectors acted as agents," he asserted, criticizing the sand monopoly that reportedly inflated sand prices to Rs. 5,000-6,000 per truckload, creating a scarcity despite the high cost.

Kotam Reddy voiced support for the coalition's Free Sand policy, saying it has substantially reduced sand costs to Rs. 1,000 and made it readily available for locals. He also criticized the lack of transparency in the YCP government,



where MLAs and MPs reportedly couldn't raise questions about sand distribution. "YCP leaders should now work with the coalition for the people's benefit," he added, noting the public's frustration with prior mismanagement.

In a bid to curb sand smuggling to Telangana, Police Commissioner RajasekharaBabu has ordered strict surveillance at border check posts. A plan to intensify monitoring includes seven new check posts in border villages, bringing the total to 17 in areas adjacent to Telangana, aiming to prevent illegal sand transport. Babu has warned police officials that severe actions will be taken if any sand leaves the district illegally, emphasizing a zero-tolerance policy on sand smuggling.

### **YS Sharmila Calls 'Jagan Bail Cancellation Conspiracy' Comments Absurd**

TPN, Andhra Pradesh: Andhra Pradesh Congress Party President and Jagan Mohan Reddy's sister, Y.S. Sharmila, dismissed recent YCP claims of a "conspiracy" to cancel Jagan's bail as "the joke of the century." Addressing these accusations, Sharmila clarified that recent share transfers are unrelated to Jagan's bail status, explaining that the Enforcement Directorate (ED) has attached immovable properties worth Rs. 32 crores but placed no restrictions on share transfers within the family companies.

According to Sharmila, the ED's attachment order affects only the immovable assets of the companies and has not halted trading or share transfers, as alleged by YCP leaders. She pointed out that, under Ja-



gan's agreement, he had agreed to a 100% share transfer and questioned why concerns over bail cancellation would arise now when they were not an issue during the signing of that agreement.

Sharmila further questioned the legality of YCP's argument by referencing past trans-

actions. "If restrictions on share transfers were valid, then how did shares in companies like Classic Reality, Sandur, and Saraswati get sold to Vijayamma for Rs. 42 crores in 2021?" she asked, adding that such transactions had not impacted Jagan's bail status. She criticized YCP's claims as mere political tactics, stating, "They know well that the share transfer has no connection to the cancellation of bail; this is just politics after the shares have already been sold."

She concluded by emphasizing that both she and Vijayamma were fully aware that these transfers posed no risk to Jagan's bail, accusing YCP of politicizing the family's financial affairs without cause.

The family conflict has fueled a media and political storm, with both sides locked in a battle of words over ownership, legality, and family allegiance. This development underscores the broader political and legal implications, as critics frame the issue as both a personal betrayal and a calculated political maneuver designed to destabilize Jagan's position.

### **Clash Erupts Between YCP and BJP Over** Land Dispute, Leaving Several Injured

TPN, Kadapa: A violent altercation erupted in PeddaDandluru village of Jammalamadugumandal between workers of the YSRCP and BJP over an ongoing land dispute, leading to severe injuries on both sides. The altercation involved supporters of YCP MLC Ramasubba Reddy and BJP MLA Adinarayana Reddy, escalating into a deadly confrontation

with axes and hunting knives, leaving seven individuals seriously injured two in critical condition.

The conflict has deepened political tensions in Jammalamadugu constituency, where the longstanding land dispute between followers of both leaders had previously been brought to the attention of local party officials but remained unresolved. The unresolved nature of the dispute intensified hostilities, resulting in both factions clashing with deadly weapons this time, intent on harming their oppo-



nents.

The violent confrontation has left PeddaDandluru in a state of fear unrest. Witnessand described a scene es of panic as villagers rushed the injured to government hospitals Jammalamadugu in Proddatur. Followand ing the incident, MLC Ramasubba Reddy visited his supporters at

TPN, Andhra Pradesh: CPI Andhra Pradesh State Secretary Ramakrishna, has called for urgent action from the government regarding water projects critical to drought-affected districts, particularly highlighting the Handriniva project. Speaking at a party meeting in Anantapur, he demanded a budget allocation of ₹2,000 crore each for the Handriniva and Veligonda projects in the upcoming November budget. He also urged Minister PayyavulaKeshav to advocate for these essential funds.

Ramakrishna voiced concerns over reports that the Central government intends to reduce the height of the Polavaram project, alleging that such measures are financially motivated to misappropriate the allocated



package funds. He emphasized the need for all political parties to unite in safeguarding the project's benefits for Andhra Pradesh. Furthermore, he called for justice for Polavaram's displaced and affected communities and announced an upcoming meeting in Vijayawada to address these issues.





# **AP Govt Prioritizes Dwakra Communities and Capital Development – Minister Narayana**



**TPN, Vijayawada:** The Andhra Pradesh government is intensifying its support for Dwakra communities, aiming to double the income of impoverished citizens over the next five years. This announcement was made by State Municipal Administration Minister P. Narayana during a one-day training program on the Mepma Self Help Societies Profiling App, held at the Amaravati Convention Hall on Wednesday.

Minister Narayana emphasized the significance of data profiling to effectively reach the intended beneficiaries. He noted that many welfare programs are being implemented under Mepma, with a focus on understanding the specific needs of community members. The Minister criticized the previous government's neglect of Self Help Societies, highlighting that TIDCO houses meant for the poor were not distributed properly.

# **AP Asha Workers Union Demands Wage Increase and Recognition as Workers**

This interdependence underscores the historical reality that sanctions often fail to eliminate adversaries.

Ultimately, the future of India-China relations hinges on recognizing the interdependence fostered by trade. India's current reliance on Chinese technology highlights its need to enhance its innovation capacity, as it contributes less than 3% of global R&D expenditures compared to China's 22.8%. A confrontational stance could be detrimental to India's aspirations, especially when collaboration often vields better results than conflict. As both nations navigate their complex geopolitical landscape, economic ties will likely remain central to fostering a stable and constructive relationship.





# **PM Narendra Modi hails launch of Vadodara aircraft unit**

 $P^{\rm rime}$  Minister Narendra Modi marked a significant advancement in India's defence and aerospace capabilities with the inauguration of the C-295 aircraft manufacturing complex in Vadodara. Joined by Spanish President Pedro Sanchez, Modi launched the Tata Advanced System Limited (TASL)-Airbus facility, which is set to produce C-295 military aircraft in India. This facility represents the first private sector final assembly line for military aircraft in the country.

In a LinkedIn post following the inauguration, Modi described the speed of the project's execution as "breathtaking," highlighting that it took only two years to transform from a foundation stone to an operational facility. He emphasized that this rapid development is indicative of a new work culture and showcases the capabilities of the Indian workforce.

The Prime Minister noted that India's defence production has seen remarkable growth, soaring to ₹1.27 lakh crore in the 2023-24 fis-



cal year. He pointed out that defence exports have also increased dramatically, rising from ₹1,000 crore in 2014 to an anticipated ₹21,000 crore in 2024. This shift underscores India's growing role in the global defence market.

Moreover, Modi highlighted the indigenization efforts within the sector, stating that over 12,300 items have been indigenized in just three years. This push towards self-reliance has been further supported by an investment of over ₹7,500 crore in domestic vendors by Defence Public Sector Undertakings (DPSUs).

The inauguration of the C-295 manufacturing complex is seen as a pivotal moment in India's journey towards enhancing its defence capabilities and achieving self-sufficiency in military production. It reflects the government's commitment to boosting the domestic aerospace sector and reducing reliance on foreign imports.

### **Nothing Hindu-Muslim In Ban On Firecrackers In Delhi: Arvind Kejriwal**

Aam Aadmi Party (AAP) con-vener Arvind Kejriwal addressed the recent ban on firecrackers in Delhi, emphasizing its importance for public health and environmental protection. He firmly stated that the decision is not influenced by any religious considerations, asserting that the focus should be on reducing pollution for the benefit of all citizens.

Kejriwal articulated that Diwali, known as the festival of lights, should be celebrated through lighting diyas and candles rather

than igniting firecrackers that contribute significantly to air pollution. "It's not that we are doing any favour to others. We are doing favour to ourselves because ultimately we and our small kids will suffer from the pollution caused by bursting crackers," he remarked during a press conference.

Earlier this month, the Delhi government issued a comprehensive ban on the manufacture, sale, storage, and use of all types of firecrackers, effective until January 1, 2025. This directive was enforced by the Delhi Pollution Control Committee (DPCC) under the Air (Prevention and Control of Pollution) Act, 1981, and includes restrictions on online sales and deliveries of firecrackers.



Kejriwal rejected the criticism from the Bharatiya Janata Party (BJP) and the Rashtriya Swayamsevak Sangh (RSS), who claim that the ban targets Hindu cultural practices. "There is nothing Hindu-Muslim in it. Everyone's breathing and life is necessary," he stated, emphasizing the universal need for clean air.

He also highlighted that both the Supreme Court and High Court have urged citizens to refrain from bursting firecrackers, advocating instead for the traditional lighting of diyas during Diwali. This stance aligns with the courts' recognition of the environmental impact and health concerns associated with firecrackers.

# All Nominations Done: Congress **Denies Maharashtra Alliance Turmoil**

The Maha Vikas Aghadi (MVA) has finalized nominations for all 288 seats ahead of the upcoming Maharashtra elections, Congress leader Ramesh Chennithala announced on Wednesday. Despite earlier confusion regarding seat allocations among the alliance members—Congress, Uddhav Thackeray's Shiv Sena faction, and the Sharad Pawarled Nationalist Congress Party-Chennithala expressed confidence in their readiness for the elections.

As the nomination deadline approached, concerns arose when the MVA had not officially named candidates for 11 seats. Meanwhile, the ruling Mahayuti alliance, comprising the Bharatiya Janata Party (BJP) and factions of the Shiv Sena and NCP, had not filled four seats. Chennithala acknowledged some "misunderstanding" within the MVA but maintained that there were no significant rifts among the allies.



He criticized the ruling alliance for internal conflicts, noting that BJP leaders were contesting under the banners of the Shinde Sena and Ajit Pawar's NCP. "The BJP is fighting alone... Shinde and Ajit Pawar are finished," he asserted.

Chennithala emphasized that the MVA has treated all partners fairly, countering criticisms faced after the Congress's recent performance in Haryana, where it

initially led but ultimately lost. He assured that there would be no "friendly fights" within the MVA, referencing previous instances where allies contested the same seats.

As of now, the Congress has nominated 103 candidates, while both the Thackeray Sena and the Pawar NCP have fielded 87 candidates each, exceeding the initially agreed-upon quota. The remaining seats are expected to be allocated to smaller allies, though details remain unclear.

On the opposing side, the BJP has announced 152 candidates, with Ajit Pawar's NCP and Shinde's Sena nominating 52 and 80 candidates, respectively. The complexity surrounding candidate nominations highlights the significance of this election, which could serve as a referendum on Maharashtra's recent political turbulence.

Joshi claimed these actions aimed to appease minorities ahead of upcoming bypolls, stating that tampering with revenue records constituted a grave injustice to the people.





### **Russia Conducts Nuclear Drill Amid Ukraine Tensions**

Russia's nuclear forces have initiated a special exercise following orders from President Vladimir Putin, marking a significant escalation in the ongoing Ukraine conflict. This exercise comes as Moscow's senior officials declare the war has entered its "most difficult phase."

This marks the second military exercise ordered by Pu-

tin in just two weeks, as tensions rise over plans by Western nations, particularly the U.S., to provide Ukraine with long-range cruise missiles capable of targeting deep into Russian territory. Moscow has explicitly warned that any such actions would lead to Russia considering the use of nuclear weapons to protect its sovereignty.

The Kremlin has updated its nuclear doctrine, approved by Putin last month, allowing for potential nuclear strikes against non-nuclear states, which serves as a stark warning to the West. During the launch of the nuclear drill, Putin stated, "We will work out the actions of officials to control the use of nuclear weapons with practi-



cal launches of ballistic and cruise missiles." He emphasized that while using nuclear weapons would be an "extremely exceptional measure," readiness is crucial.

In response to escalating tensions, NATO has condemned Russia, particularly over reports that North Korea is sending troops to assist in the Ukraine conflict. The Pentagon has reported that North Korea may be dispatching around 10,000 soldiers to train in eastern Russia, potentially augmenting Russian forces near Ukraine. Concerns are mounting that these troops could be deployed in combat against Ukrainian forces.

# **EU Will Have To Pay A Big Price: Donald Trump's Warning On Tariffs**

During a rally in Penn-sylvania on Tuesday, Republican presidential candidate Donald Trump issued a stern warning to the European Union, claiming they would face significant repercussions for not purchasing enough American exports if he were to win the November 5 election. "The European Union sounds so nice, so lovely, right? All the nice European little countries that get together," he said, before discussing his plans to implement the "Trump Reciprocal Trade Act."

Trump highlighted the trade imbal-

ance, asserting, "They don't take our

ucts. They sell millions and millions

of cars in the United States. No, no,

no, they are going to have to pay a

big price." This rhetoric underscores

his longstanding criticism of trade

relationships, particularly with the

In addition to targeting the EU, Trump has vowed to impose a 10% tariff on imports from all countries and to levy 60% duties on imports from China. **India and China Complete Military Disengagement in Ladakh** 

**T**n a significant development, India and LChina have successfully completed the disengagement process in the Depsang and Demchok regions of Eastern Ladakh, adhering to the previously announced timeline. Army sources confirmed that patrolling in these areas will resume soon, coinciding with Diwali celebrations on Thursday, during which sweets will be exchanged between Indian and Chinese troops.

Indian Army officials stated that the verification process is ongoing, with ground commanders set to finalize the modalities for patrolling. This development follows a pivotal meeting between Chinese President Xi Jinping and Indian Prime Minister Narendra Modi at the recent BRICS summit in Russia, where both leaders established "important understandings" to guide future relations between their countries.

Chinese Ambassador to India, Xu Feihong, emphasized the significance of this high-level dialogue, suggesting that it has laid the groundwork for smoother relations. He remarked, "I hope that, under the guidance of this consensus, our relations will be moving forward smoothly and will not



be restricted or interrupted by specific disagreements." Xu acknowledged that while differences are natural between neighboring countries, the focus should be on effective management and resolution.

The announcement of the disengagement process came on October 21, when India confirmed that a patrolling agreement had been reached. The accord stipulated that troops would revert to their positions prior to the stand-off that began in 2020. As part of the disengagement, both sides agreed to dismantle structures established during the conflict and restore the land to its original condition.

One diplomat briefed on the situation noted, "There are very early talks about potentially restarting something," emphasizing that the focus is now on energy facilities. The notion of halting attacks on energy infrastructure is critical, as both

# **SEBI's Penalty on Research Analyst Raises KYC Compliance Concerns**



The recent ₹7 lakh penalty imposed by the Securities and Exchange Board of India (SEBI) on research analyst Arun N has sparked apprehension among his peers regarding the complexities of compliance with know-your-customer (KYC) regulations. On October 24, SEBI penalized Arun for misleading clients with promises of assured returns and for failing to conduct necessary KYC checks.

The issue of KYC remains ambiguous for research analysts, as there is no clear guideline detailing their responsibilities in verifying client credentials. A senior analyst, speaking anonymously, expressed concern that the lack of clarity might prompt SEBI to issue a circular to define KYC specifications and timelines. Currently, SEBI-registered intermediaries must comply with 2023 KYC registration regulations, but specific and instead depended on Gap-up compliance implications.



In Moderate mode, Chrome will close tabs based on the current demands of the system, optimizing resource use. Maximum mode takes this a step further, closing tabs as soon as they are no longer in use, ensuring that resources are freed up promptly.

These enhancements reflect Google's commitment to improving the browsing experience by making Chrome not only faster but also more adaptable to users' needs. With these tools, users can now enjoy a smoother browsing experience while effectively managing their system's resources. Whether through automatic fixes or personalized performance settings, Chrome aims to empower users with greater control over their online activities.

Apple Inc. has introduced a revamped Mac Mini, marking the first major redesign in nearly 15 years. The new model, which measures just 5 inches across, features the advanced M4 chips, offering enhanced performance and efficiency, as reported by Bloomberg on October 29.

The new Mac Mini models replace the earlier M2 and M2 Pro versions released in early 2023. The M4 edition features a 10-core CPU and GPU, starting at \$599, which matches the price of its predecessor. A higher-end version with enhanced specifications is available for \$799, catering to users seeking greater performance.




