TPN , Hyderabad: Telangana Chief Minister Revanth Reddy asserted that any promise made by the Gandhi family would be fulfilled "100 percent," emphasizing their commitment to social, economic, and political justice. Speaking at an awareness meeting on caste enumeration at Gandhi Bhavan on Wednesday, he reiterated Congress's pledge to conduct a comprehensive caste census in Telangana under the future "Indiramma government."

CM Revanth cited Rahul Gandhi's promise to initiate a caste census, supported by Sonia Gandhi's recent statements at the Tukuguda Sabha. "If the Gandhi family gives their word, it is fulfilled. It is every Congress member's duty to honor Rahul Gandhi's promise," he said, stressing the importance of unity and commitment among Congress members to fulfill this pledge.

Revanth further elaborated on the state's caste enumeration model, stating it could

be a "Telangana model" for the nation. He explained that the census would assess the distribution of government resources based on social justice principles. "Completing the caste census by November 31 will pave the way for a nationwide model," he said, adding that Telangana's documentation would be submitted to the central government.

Referring to recent recruitment processes, CM Revanth countered allegations of favoritism, highlighting that a substantial number of Backward Classes (BCs), Scheduled Castes (SCs), and Scheduled Tribes (STs) were selected in state exams. "Out of 31,383 shortlisted candidates, 57.11 percent were BCs, 15.38 percent SCs, and 8.87 percent STs. Only a small fraction were upper-caste candidates," he clarified, emphasizing Congress's commitment to fair representation.

TPN , Hyderabad: Former Minister and Siddipet MLA Harish Rao asserted that the Bharat Rashtra Samithi (BRS) would win 100 seats if state elections were held immediately. Speaking informally to the media at Telangana Bhavan on Wednesday, Harish Rao expressed confidence in BRS's dominance and took aim at the Congress and Chief Minister Revanth Reddy, who he claimed was only in power due to an opportunity provided by BRS leader KCR.

Highlighting KCR's pivotal role in Telangana's formation, Harish Rao said, "If it weren't for KCR, Telangana wouldn't exist, and Revanth wouldn't have become CM." He remarked that the BRS was poised to remain in power with KCR at the helm for the next five years. Rao accused Revanth of failing the state's farmers by delaying loan waivers, saying, "Revanth's empty promises and excuses have only hurt our farmers."

Rao criticized Revanth's leadership, stating that "even the Congress high command doesn't trust him enough to allow him to fill vacant ministerial posts." He mocked Revanth's recent remarks, calling them a display of misinformation that "would embarrass even Goebbels." Responding to statements about water projects, Harish Rao corrected claims about the Mallannasagar and Kaleshwaram initiatives, reaffirming BRS's commitment to providing clean river water and opposing the demolition of homes for new developments. He added that KCR's vision included bringing fresh water from Kaleshwaram to Musi.

Regarding land issues, Harish Rao questioned Congress's land policies and accused Revanth of selling government land at inflated prices while failing to deliver on promises to rebuild demolished homes. He criticized the CM's refusal to publicly honor Ambedkar, emphasizing that no one could replace KCR's dedication to Telangana's progress.

matters of actress Samantha and actor Naga Chaitanya, as well as her comments on the Akkineni family, led to widespread criticism and resulted in defamation suits filed by actor Nagarjuna and former minister KTR. Although Surekha later apologized, the remarks drew significant negative attention to the party.

In another incident, former Congress MLA Jaggareddy's comments about a district collector went viral, leading to further controversy. Jaggareddy, frustrated that the collector did not answer his calls, made remarks that he later clarified were intended for collectors from the previous administration. He also expressed anger over media misrepresentation and warned of possible legal action. Amid these incidents, CM Revanth and PCC Chief Mahesh Goud emphasized that further breaches of party protocol would not be tolerated. Party leaders were advised to maintain decorum and avoid statements that could disrupt party unity or public perception.

KTR to Revanth Reddy: "You Can't Erase KCR's Role in Telangana"

TPN , Hyderabad : BRS Working President K. T. Rama Rao (KTR) responded strongly to comments by Chief Minister Revanth Reddy, who recently stated he would remove former CM and BRS chief K. Chandrashekar Rao (KCR) from Telangana politics. KTR defended KCR's legacy, emphasizing his critical role in the state's formation and growth.

In a social media post on Wednesday, KTR retorted, "Revanth, while you were finding your footing in politics, KCR was breathing life into the Telangana movement. He sacrificed his position and personal comfort to create a future for Telangana. Do you really think you can erase KCR's contributions?"

Congress Criticized Over Farmer Policies

KTR also took aim at the Congress, accusing it of mismanaging grain procurement, which he claims has harmed Telangana's farmers. "Farmers face hurdles due to delayed procurement processes and lack of direction from the Congress government," KTR posted. He cited grain prices falling from ₹2,300 per quintal to ₹1,800, attributing the decline to Congress policies that "benefit brokers over farmers."

Telangana's Caste Census Will Be a National Model

Telangana as center of caste enumeration research

TPN , Hyderabad: In a significant address at Gandhi Bhavan on Wednesday, Telangana's Deputy Chief Minister Bhatti Vikramarka Mallu underscored the importance of a caste census, promising it would serve as a model for the nation. He emphasized the commitment to social justice and equality enshrined in India's Constitution, questioning the current state of these principles in society. According to the Deputy CM, the state government is prepared

to fulfill its pre-election promise, made by Congress leader Rahul Gandhi, to conduct a comprehensive caste census.

During a meeting with senior Congress leaders, Bhatti stated that Telangana aims to become a research hub for caste-based data collection and analysis, setting a precedent for the rest of the country. He also acknowledged Rahul Gandhi's efforts to understand the aspirations of di-

verse communities across India, recounting Gandhi's interactions with people from all walks of life. Bhatti explained that the caste census is essential to identifying disparities in resource distribution and ensuring equitable sharing among all sections of society, in alignment with the Constitution's objectives.

Deputy CM Bhatti mentioned that the Congress-led cabinet had passed a resolution on February 24 supporting the caste census. Based on this resolution, a detailed survey was sanctioned on October 10, 2024, by the Planning Department, marking a major achievement for the Congress administration.

The Deputy CM highlighted that Congress leaders, including PCC

Chief Mahesh Kumar Goud, are working on formulating a questionnaire for the census, involving input from various sections of society. The survey will cover social, educational, economic, and political aspects, incorporating suggestions from BC, SC, and ST commissions to ensure inclusivity.

Bhatti concluded by stressing that the caste census would be instrumental in understanding societal needs, promoting health, and achieving balanced growth. A state-wide meeting with intellectuals, activists, and progressives is scheduled for November 5 in Hyderabad to gather further insights for the census, which he said will help shape policies based on the equitable distribution of resources.

Police Issues Lookout Circular Against NRI for Threatening MLA Satyam

TPN , Hyderabad: A lookout circular has been issued against NRI Yasa Akhilesh Reddy, residing in London, who allegedly threatened Choppadandi MLA Medipally Satyam and demanded Rs 20 lakh. The incident occurred on September 28, when the MLA received a WhatsApp call from an unknown number in which the caller demanded money, threatened to politically defame him, and further threatened his life.

Following the threat, MLA Satyam lodged a complaint with the Kothapalli police. Authorities promptly launched an investigation, registering a case under relevant sections of the Indian Penal Code. During the investigation, police identified the caller as Akhilesh Reddy, a native of Bhavaninagar, Boduppal in Rangareddy.

In response, Karimnagar police issued a lookout circular through the Bureau of Immigration to prevent the accused from fleeing the country if he returns to India. Karimnagar Rural Assistant Commissioner of Police (ACP) confirmed the issuance and ongoing efforts to track down the accused to ensure the safety of the MLA and uphold the law.



CM Revanth Reddy Appointed as Star Campaigner for Maharashtra Elections

TPN , Hyderabad: Telangana Chief Minister Revanth Reddy has been appointed as a star campaigner for the upcoming Maharashtra Assembly elections. The Congress party, led by Chief Mallikarjun Kharge, released the list of campaigners, which includes key leaders Sonia Gandhi, Rahul Gandhi, Priyanka Gandhi, and Karnataka CM Siddaramaiah, alongside Revanth Reddy. Maharashtra will hold a single-phase election on November 13, while Jharkhand's election will occur in two phases on November 13 and 20. With nominations underway, Congress aims to strengthen its presence following recent losses in Haryana and Jammu & Kashmir.



Caste Census to Be Conducted Transparently, Says TPCC President Mahesh Kumar Goud

TPN , Hyderabad: TPCC President Mahesh Kumar Goud announced that Chief Minister Revanth Reddy and Deputy CM Bhatti Vikramarka are making significant strides in implementing the Caste Census. He emphasized the Congress party's full support for this initiative during a meeting at Gandhi Bhavan on Wednesday.

Goud proposed organizing meetings of District Congress Committee (DCC) presidents across all 33 districts on November 2, urging them to engage the public about the importance of the caste enumeration program. A control room will be established at Gandhi Bhavan to address queries related to education,

employment, and political aspects of the census. He stressed that the caste enumeration program should be taken seriously, as it aims to set a precedent for the country. Goud highlighted that Rahul Gandhi and AICC President Mallikarjun Kharge have both endorsed the caste census, with the Congress government committed to conducting it impartially, ensuring participation from all communities. Minister Ponnampaluri confirmed that arrangements are in place to commence the comprehensive caste survey on November 6, as mandated by the Legislative Assembly. He called for cooperation from all parties and assured that officials would facilitate the process effectively.

Telangana Government Revises Dearness Relief and Allowance for Pensioners and Employees

TPN , Hyderabad: The Telangana state government has announced a revision in dearness relief (DR) for government pensioners, increasing it from 22.75% to 26.39% of the basic pension, effective July 1, 2022. Additionally, the government issued an official order on October 30 to revise the dearness allowance (DA) for specific categories of government employees.

The revised DR applies to pen-

sioners and employees of zila parishads, mandal parishads, gram panchayats, municipalities, municipal corporations, agricultural market committees, and zila grandhalaya samasthas, all of whom are compensated according to the revised pay scales of 2020. The dearness relief also extends to teaching and non-teaching staff of aided institutions, including aided polytechnics, as well as staff at

universities paid according to the revised pay scales.

The DA for employees drawing UGC/AICTE pay scales since 2016 has been increased from 34% to 38% of the basic pay, effective July 1, 2022. This adjustment also applies to teaching staff at universities, government-aided colleges, and medical colleges.

For those on UGC/AICTE pay scales from 2006, the DA has been

revised from 203% to 212% of the basic pay. Furthermore, full-time and contingent employees will see their DA rise to 155.772% of their revised remuneration, effective July 1, 2022.

The revised DA will be paid with the November 2024 salary, disbursed on December 1, 2024, and arrears will be credited to the employees' General Provident Fund accounts.

BR Naidu Appointed TTD Chairman; Five from Telangana Join Governing Body

TPN , Tirumala: BR Naidu has been appointed as the Chairman of the Governing Body of Tirumala Tirupati Devasthanam (TTD), which was announced by TTD officials this evening. The newly formed governing body consists of 24 members, including five representatives from Telangana. The TTD governing body includes three MLAs from Andhra Pradesh: Jyotula Nehru (Jaggampeta MLA), Vemireddy Prashanthi Reddy (Kovuru MLA), and MS Raju (Madakasira MLA). The Telangana representatives are Nannuri Narisreddy, Boongunur Mahender Reddy, Anugolu

Rangashree, Suchitra Ella, and another member, bringing significant representation from the state. Other notable members in the TTD board include former Union Minister Panabaka Lakshmi, Jasti Poorna Sambasivarao, and representatives from Karnataka, Tamil Nadu, Gujarat, and Maharashtra. The diverse composition of the governing body reflects a broad regional representation, which is expected to enhance the administration and outreach of the TTD in managing the Tirumala temple and its associated services.

MLA Kaushik Reddy Challenges CM Revanth and Congress Leaders to Drug Test



TPN , Hyderabad: BRS MLA Padi Kaushik Reddy has publicly challenged Telangana Chief Minister Revanth Reddy and Congress MPs, MLAs, and MLCs to undergo a drug test, calling for greater accountability from state leaders. Speaking at Telangana Bhavan in Hyderabad on Wednesday, Kaushik Reddy affirmed that his support comes from his panchayat, adding that he had previously urged Congress representatives to participate in a drug test. He alleged that, instead, Congress leaders discreetly went to the hospital without prior notice. Kaushik criticized Revanth Reddy for allegedly attempting to implicate him in a drug-related case, which he claimed was an effort by both the Chief Minister and BRS Working President K.T. Rama Rao, though they failed.

Kaushik further stated that the state's citizens are dissatisfied under the Congress rule and accused the government of avoiding transparency. In a related development, a case involving BRS Working President K.T. Rama Rao's brother-in-law, Raj Pakala, and his farmhouse has ignited a war of words between Congress and the opposition BRS, with accusations flying from both sides.

Responding to the drug test challenge, Congress leaders, including MP Anil Yadav and MLC Balmuri Venkat, provided blood samples at Apollo Hospital in Hyderguda. They also demanded that BRS leaders fulfill their part of the challenge, escalating tensions as the political standoff continues.

Congress MLC Venkat Balamuri Challenges BRS Leaders Amid Drug Test Debate

TPN , Hyderabad: Congress MLC Venkat Balamuri has questioned BRS MLA Padi Kaushik Reddy and BRS Working President K.T. Rama Rao over recent drug test challenges, demanding transparency regarding who tested positive for cocaine, where the alleged party occurred, and the individuals involved. Balamuri alleged that associates of KTR are involved in drug use, raising concerns about whether KTR himself is implicated, though unanswered.



Balamuri highlighted that Vijay Madhuri, reportedly close to KTR, was confirmed to have taken cocaine, prompting his demand for clarity from KTR on this issue. He criticized Kaushik Reddy, accusing him of "diverting" from substantive matters, including constituency issues.

Balamuri defended his own tenure, noting his decade-long activism for public causes, during which 88 cases were filed against him. He remarked that while he earned his MLC post through consistent work, Kaushik Reddy achieved his position by allegedly leaking confidential information from the Congress party. He further challenged KTR to undergo a drug test to settle allegations once and for all.

After Congress leaders gave samples at Apollo Hospital, Balamuri urged BRS leaders to do the same, advocating transparency for the public.

BRS Supports B.Ed. Candidates' 'Chalo Indira Park' Protest on November 3

TPN , Hyderabad: The B.Ed. candidates in Telangana have called for a 'Chalo Indira Park' dharna on November 3, demanding justice for nearly 5 lakh candidates. Their primary demands include the removal of the promotion quota for school assistant posts, filling 100% of these positions with B.Ed. qualified candidates, and eliminating the 70% promotion quota allocated to SGTs.

The BRS party has expressed full support for the protest, with leader R.S. Praveen Kumar confirming his participation to back the B.Ed. candidates. He criticized the Congress government for what he called unfair treatment of both unemployed youth and current employees, accusing them of ignoring BRS's request to postpone the Group-1 examination. According to Kumar, the government proceeded hastily with the exams, disregarding public concerns.

The November 3 protest is expected to gather significant support from educators and supporters across Telangana, seeking reform and fair recruitment processes in the state's education sector.

Eleti Maheshwar Reddy Criticizes Congress Government for Corruption

TPN , Hyderabad: BJP leader Eleti Maheshwar Reddy accused the Congress government in Telangana of corrupt practices, stating that mismanagement and rampant corruption have undermined governance in the state. Speaking at the BJP state office, Reddy claimed that the administration has "lost its groove," with corrupt elements thriving.

He highlighted alleged issues with the government's handling of public funds, criticizing it for neglecting public promises while allegedly collecting large sums to send to Delhi. Reddy expressed

concern over the government's failure to act on a reported Rs. 1,150 crore civil supply scam, where he claims grain was handed over again to millers without recovering funds from prior illegal activities. He questioned the involvement of both the Chief Minister and civil supply ministers in this matter, suggesting a possible "dark deal" behind these decisions. Reddy alleged that Congress leaders are benefitting financially from these arrangements with millers, further fueling concerns over the administration's commitment to transparency.



Sabitha Indra Reddy Praises KCR's Development Initiatives in Telangana



TPN , Hyderabad: MLA Sabitha Indra Reddy commended Chief Minister K. Chandrashekar Rao (KCR) for his transformative contributions to Telangana,

highlighting his enduring presence in the state's infrastructure and welfare initiatives. Speaking about KCR's legacy, she noted his visible impact across various development projects and welfare schemes.

Reddy referenced KCR's role in creating Telangana's modern infrastructure, including command control centers, extensive flyovers, and international-standard roads, which she said reflect the state's advancement. She also lauded Mission Bhagiratha, a major water supply initiative, remarking that in villages and towns, people refer to KCR as "Nallas and Nillu," symbolizing his commitment to clean drinking water.

She emphasized KCR's initiatives in agriculture and water management, pointing to the Kaleshwaram Lift Irrigation Project, the restoration of Kakatiya lakes, and the provision of 24-hour electricity. Reddy further highlighted social contributions like gurukul schools, district medical colleges, and the iconic Yadadri temple renovation. Additionally, she praised the construction of district collector offices, the Ambedkar statue at Tank Bund, and the Telangana Martyrs' Memorial, stating these symbolize KCR's legacy in fostering Telangana's identity.

For Reddy, KCR is not only a leader but a "farmer's Bhima," an embodiment of welfare and development, making his name synonymous with Telangana.

Congress to Apologize for Unfulfilled Promises in Telangana- CPI MLA Koonanmneni

TPN , Karimnagar : CPI State Secretary Koonanmneni Sambasivarao called on the Congress government to apologize to the people of Telangana for delays in delivering on pre-election promises. Speaking at a press briefing at the party office in Karimnagar alongside National Executive Member Chada Venkata Reddy and District Secretary Marri Venkataswamy, Sambasivarao criticized the Congress for its slow progress, stating it has been 11 months since they assumed office, yet key pledges remain unfulfilled.

Among the promises he highlighted were free gas for women, monthly assistance

of Rs. 2,500, gold for weddings under the Kalyana Lakshmi scheme, fee reimbursement for students, investment aid through Rythu Bharosa, and timely salary payments for contractual employees. Sambasivarao urged the Congress to release a white paper on the state budget to transparently communicate the reasons for these delays and the government's future plans.

Sambasivarao also alleged that BRS and BJP are stirring unrest in Telangana through "dark deals," complicating law and order issues. He advised the Congress to counter these conspiracies to sustain its government. Additionally,



he cautioned against displacing the poor in the name of Musi River beautification.

On the upcoming centenary of the CPI, Sambasivarao announced that the party will

host year-long programs at the gram, mandal, and district levels to address public issues and reinforce their commitment to the people of Telangana.

Minister Komatireddy Criticizes Opposition for "Unnecessary Noise"

TPN , Hyderabad: Telangana Minister Komatireddy Venkata Reddy criticized opposition leaders for their ongoing criticisms, stating they are making "unnecessary noise" about every initiative taken by the Congress government. Addressing the media, he emphasized that the Congress administration is paying interest on debts left by the previous BRS government and is committed to fulfilling promises, even those not listed in the election manifesto.



The minister highlighted the Congress's decision to conduct a caste census, calling it a historic move aimed at better understanding and supporting Telangana's social structure. Venkata Reddy also accused BRS leaders of lacking genuine concern for the welfare of backward communities, noting that Telangana Pradesh Congress Committee (PCC) leadership is represented by someone from a weaker section, demonstrating the party's commitment to inclusivity.

Venkata Reddy assured that the Congress government will continue to address financial challenges while delivering on its promises, despite ongoing criticism from the opposition.

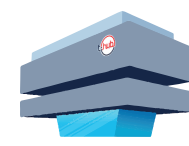
Bandi Sanjay Questions Congress on Unfulfilled 'Kalyanamastu' Promise

Taking to social media on Dhana Trayodashi, Sanjay demanded clarity on when Congress would provide the promised gold and financial support.



Sanjay used hashtags such as "#HandGivenHand" and "#HandBreakOnProgress" to criticize the Congress, alleging it has failed to honor its manifesto commitments. He argued that the Congress's inability to deliver on its promises is similar to the BRS government's shortcomings and predicted that the people of Telangana would reject the Congress in the 2028 elections, just as they had dismissed the BRS.

Confident in his party's prospects, Sanjay stated that the BJP is well-positioned to take power in Telangana, emphasizing the BJP's commitment to fulfilling promises and prioritizing public welfare.



KTR's Brother-in-Law Interrogated by Mokila Police Amid Drug Investigation



TPN , Hyderabad: Raj Pakala, the brother-in-law of Bharat Rashtra Samithi (BRS) working president K.T. Rama Rao (KTR), appeared before the Mokila police for questioning on October 30. Accompanied by his lawyer, Pakala's appearance follows a police raid at his farmhouse in Janwada.

On October 26, Narsingi police, alongside ex-

cise department officials, raided a party at Pakala's residence, where Vijay Madduri, CEO of Fusion AIX Software and Pakala's associate, tested positive for cocaine. Authorities seized 7.6 liters of foreign liquor, 8.1 liters of Indian-made foreign liquor (IMFL), and 6 liters of beer, along with casino gaming equipment.

Pakala was named as the prime accused in an FIR filed under the Narcotic Drugs and Psychotropic Substances (NDPS) Act. Initially evading questioning, he was served a notice at his residence in Orion Villas, instructing him to appear before police on October 28 with relevant documents. On that day, Pakala sought protection from arrest in the Telangana High Court. In response to the situation, KTR accused the Telangana government of targeting his family, asserting that the gathering was merely a housewarming ceremony.

Telangana Government Imposes Ban on Mayonnaise Over Health Concerns

TPN , Hyderabad: The Telangana state government has taken a decisive step to ban mayonnaise due to health risks associated with its consumption. Health Minister Damodara Rajanarasimha issued the order on Wednesday after a review meeting with food safety officials at the Dr. B.R. Ambedkar Secretariat.

During the meeting, Minister Rajanarasimha inquired about the effectiveness of task force committees tasked with monitoring hotels and ensuring the consumption of safe food. Officials informed the minister that mayonnaise is often made from various ingredients, including adulterated and unboiled eggs, which can seriously affect public health.

Citing the Kerala government's recent ban on mayonnaise, the minister acknowledged the potential risks and, following extensive discussions, decided that a similar ban was necessary in Telangana. The state government has since issued formal orders to



enforce this ban, prioritizing the health and safety of its citizens.

This move aims to safeguard the community from potentially harmful food products and highlights the government's commitment to ensuring food safety standards in the state. The ban reflects an increasing focus on public health issues related to food consumption across Telangana.

Harsha Sai Secures Anticipatory Bail in Sexual Harassment Case



TPN , Hyderabad: Popular YouTuber Harsha Sai has received relief from the Telangana High Court amid allegations of sexual harassment. The court granted him anticipatory bail after he argued that the case against him was invalid.

A case was registered against Harsha Sai on September 24 at the Narsinghi police station, where a young woman accused him of raping her under the pretense of marriage. In her complaint, she alleged that Harsha Sai and his father, Radhakrishna, took ₹2 crores from her.

The woman had previously collaborated with Harsha Sai in a film titled Mega, produced under her own banner, Shree Pictures. She was also a contestant on Bigg Boss. Following the registration of the case, Harsha Sai has largely stayed out of the public eye, stating on Instagram that he is prepared for a legal battle. After multiple attempts, he and his father were recently granted bail by the court.

Dasoju Shraavan Criticizes Revanth Reddy's Leadership and Language



TPN , Hyderabad: BRS leader Dasoju Shraavan has sharply criticized Congress leader Revanth Reddy, claiming he played a key role in the political downfall of N. Chandrababu Naidu in Telangana through the "note-for-vote" case. At a media conference held at BRS Bhavan, Shraavan stated that Reddy, known for his divisive tactics, has already undermined senior Congress leaders such as Uttam Kumar Reddy and Madhuyashki since joining the party.

Shraavan likened Reddy to "Bhasmasura," suggesting that his approach would ultimately destabilize Congress. He cautioned Congress members and TPCC chief Mahesh Goud to recognize Reddy's negative rhetoric, which he argued threatens the party's stability. He asserted that no one who respects the Constitution would make claims about "finishing" others, especially at the chief ministerial level. Furthermore, Shraavan emphasized that even opponents of Telangana have not made such threats against Chief Minister K. Chandrashekar Rao (KCR), asserting that KCR's contributions to the state's development should not be disrespected. He challenged Reddy to engage in political discourse rather than resort to derogatory language.

Telangana Government Grants Early Diwali Salaries to GHMC Workers

TPN , Hyderabad: In a festive gesture, the Telangana government has announced that Greater Hyderabad Municipal Corporation (GHMC) workers will receive their salaries a day early in celebration of Diwali. GHMC officials will disburse approximately ₹120 crores to around 27,000 employees, workers, and pensioners. Payments will be made to all individuals whose bills have already been prepared.

The early salary payment has generated excitement among GHMC employees, laborers, and pension-

ers as they prepare for the Diwali celebrations. In related news, Hyderabad in-charge minister Ponnampalapati Prabhakar has urged authorities to ensure that tapas shops are not set up in residential areas. He emphasized the need for caution while using tapas, as they can pose a fire hazard during the festival.

As Diwali approaches, officials are reminded to take necessary precautions to prevent accidents, particularly in small lanes across the state and within the twin cities.



MP Raghunandan Criticizes Government Over Rural Development Fund Diversion



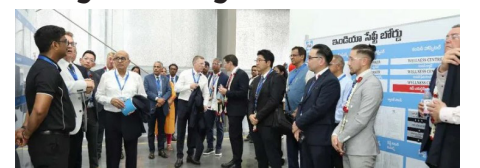
TPN , Hyderabad : Medak MP Raghunandan Rao has strongly criticized the Telangana government, alleging the diversion of rural development funds. Speaking to the media, he emphasized that regardless of the ruling party, the central government would continue to release funds for village welfare. Rao pointed out that while ₹1,200 crore had been allocated six months ago, only ₹200 crore was utilized, with the remainder allegedly diverted.

He expressed concern over pending payments, noting that ₹600 crore owed from the central government remains unpaid, hampering rural development efforts. Rao highlighted that Panchayat secretaries have been forced to use their own money for local projects due to the state government's mismanagement.

Additionally, Rao noted that the central government has released ₹500 crore following the 15th Finance Commission's recommendations and ₹300 crore for the National Health Mission. He called for the construction of health centers to support villages grappling with health issues. Despite the central government's allocation of ₹2,000 crore, he claimed the Telangana government misappropriated these funds, insisting that local development should not be politicized.

Telangana DCA and Excise Dept Uncover Major Narcotics Network in Hyderabad

TPN , Hyderabad: In a significant crackdown, the Drugs Control Administration (DCA) of Telangana, in collaboration with the Prohibition and Excise Department, dismantled a major network involved in the illegal procurement, stocking, and sale of narcotic drugs and psychotropic substances. On Wednesday, officials raided GV Saluja Hospital in Rezimala Bazar, discovering large quantities of narcotics, including Fentanyl, Ketamine, Pentazocine, and Midazolam injections. Investigations revealed that Neha Bhagwath, a resident of Moula Ali, was illegally supplying these drugs to the hospital. Neha, who had two prior cases

under the NDPS Act and was out on bail, was found with an extensive stock of narcotics at her residence, including morphine injections and Fentanyl patches. She confessed to procuring these substances from Dinesh of Pioneer Drug House in Nagpur. Additional suspects Patturi Gopinath, Surender Singh Gusia, and B. Srinivas were apprehended, while Rajender Singh Saluja and his wife, Dr. Amrutha Singh Saluja, remain at large. A case has been registered under the NDPS Act at the Secunderabad Prohibition and Excise Station. Further raids are ongoing at hospitals linked to Neha's illegal supply chain.

Police Brutality: Mahabubnagar CI Allegedly Assaults Social Media Activist

TPN , Hyderabad: In a disturbing incident of police misconduct, Varda Bhaskar Mudiraj, a social media activist, was detained and reportedly assaulted by Mahabubnagar Circle Inspector Appaiah for questioning Chief Minister A. Revanth Reddy's election promises. The incident occurred in the early hours of Tuesday when Bhaskar was picked up from his home in Mahabubnagar One Town without any explanation for his arrest.

RTC to Introduce 82 New Electric Buses in Warangal Region Soon

TPN , Warangal: The Telangana State Road Transport Corporation (TSRTC) is set to introduce 82 new electric buses in the Warangal region shortly. These buses will operate on routes connecting Hyderabad, Nizamabad, Eturunagaram, Mangapet, Khammam, and Bhupalpally.



The fleet will include 18 Super Luxury, 14 Deluxe, 21 Semi Deluxe, and 29 Express buses. The Delhi-based JBM Compa-

ny will manage these buses under a gross cost contract.

Arrangements are underway at the Warangal-2 Depot for maintenance. The Super Luxury buses will accom-

modate 41 passengers, while the Deluxe buses will have 45 seats arranged in a 2+2 configuration, and Express buses will feature 55 seats in a 2+3 setup.

These buses will be equipped with advanced features, including a vehicle tracking system, panic buzzer, USB charging, and a fire detection system, ensuring a safe and comfortable travel experience.

Telangana Govt Departments Must Procure Textiles from TESCO: Tummalala

TPN , Hyderabad: Telangana's Minister for Handlooms and Textiles, Tummalala Nageswara Rao, has directed all state government departments and corporations to procure their textiles exclusively through the Telangana State Handloom Weavers Cooperative Society (TESCO). This initiative aims to provide continuous employment for handloom workers and is part of a broader strategy under Government Order No. 1.



During a review meeting at the Secretariat on Tuesday, October 29, Minister Rao stressed the need for fabric indents to be submitted to TESCO by November 15 for the upcoming fiscal year. He warned that any department or corporation that violates this directive by purchasing textiles from private entities would face consequences.

Rao also addressed delays in supply faced by some welfare departments due to annual changes in uniform colors, suggesting that designs should remain unchanged for a minimum of five years to streamline procurement processes.

It is expected to create thousands of jobs, foster technological advancements, and enhance India's self-reliance in defense manufacturing. Furthermore, once operational, the plant will not only cater to the Indian market but will also focus on exporting and servicing Airbus aircraft worldwide.

A Rational Perspective on China's Economic Landscape

Recently, China reported a third-quarter GDP growth of 4.6% year-on-year, sparking headlines in Indian media that proclaimed "China's economy in free fall." Some outlets questioned whether China could meet its annual growth target of 5%, while others called for "decoupling and de-risking" from China. It's crucial to analyze the Chinese economy comprehensively and objectively, and I would like to share my insights with my Indian friends.

Firstly, it's important to clarify that China's economy is not in free fall and is unlikely to enter such a state. The slowdown in GDP growth during the third quarter can be attributed to a volatile external environment, ongoing internal economic restructuring, and short-term natural disasters. However, from a long-term perspective, the quarter-on-quarter GDP growth rate has been on the rise for eight consecutive quarters.

In the first nine months of 2024, China's GDP grew by 4.8%, outpacing many major economies. Furthermore, advancements in high-tech manufacturing highlight the resilience of China's economy. In the first three quarters of this year, high-tech manufacturing's added value and investment increased by 9.1% and 10%, respectively, while the output of green industries like electric vehicles and lithium-ion batteries continued to show robust double-digit growth.

Secondly, China is confident in achieving its 2024 targets, bolstered by a new stimulus package characterized by unprecedented breadth and depth. This package aims to invigorate the stock and real estate markets while supporting small and medium-sized enterprises. As a result, there has been a noticeable uptick in retail sales, industrial production, and fixed asset investments. During the National Day

holiday, China recorded 765 million domestic tourist trips, reflecting a significant rebound in consumer confidence.

Lastly, it's essential to recognize that China is not a "risk" but remains a primary engine of global growth, contributing over 30% to the world economy. The notion of decoupling from China translates to forfeiting opportunities and future growth. In fact, foreign investment in China is thriving; over 26,000 new foreign-invested companies were established in the first half of this year, with Tesla and Apple significantly expanding their operations.

In a recent meeting at the BRICS Summit, President Xi Jinping and Indian Prime Minister Narendra Modi reaffirmed their commitment to strengthening bilateral relations. Both leaders emphasized the importance of collaboration for the well-being of 2.8 billion people and for regional stability.

Ultimately, the shared goal of development between China and India presents immense opportunities. As both nations strive for modernization—China aiming to become a great modern socialist country by mid-century and India targeting "Viksit Bharat 2047"—mutual cooperation will yield significant dividends. I firmly believe that with the guidance of our leaders, China and India possess the wisdom and capability for a fruitful partnership.

The World Can No Longer Count On An Imploding America



In a significant symbolic gesture, Vice President Kamala Harris addressed voters at the same location where Donald Trump urged his supporters to "fight like hell" on January 6, 2021, shortly before the Capitol was stormed. In her closing remarks ahead of next week's election, Harris framed the choice as one between her presidency, which would focus on a "to-do list full of priorities," and a Trump-led return to "chaos and division." Emphasizing unity, she stated, "Our democracy doesn't require us to agree on everything... the fact that someone disagrees with us does not make them 'the enemy from within.' They are family, neighbors, classmates, coworkers."

Despite this compelling message, the challenge remains whether her intended audience is receptive. Polls show a tight race, with both sides struggling to make a decisive impact. This was evident at Trump's recent Madison Square Garden

rally, where his incendiary comments about his opponent were met with enthusiasm from the crowd. While he focused on immigration, crime, and economic issues, some attendees made derogatory remarks about Puerto Rico and expressed extreme views about Harris.

The fabric of America's democracy appears to be fraying, with many citizens expressing dwindling faith in their institutions. A recent survey indicated that most voters believe Trump would not concede if he lost the 2024 election, and there is widespread doubt about the Supreme Court's ability to make fair decisions. For Trump, addressing issues like migration and living costs resonates with many voters, allowing him to mobilize his base while painting Democrats as a "massive, vicious radical-left machine." Meanwhile, Harris is working to engage her supporters, particularly women concerned about reproductive rights. Michelle Obama reinforced this theme, urging voters not to support Trump, whom she accused of showing contempt for women.

As Harris navigates her role alongside President Biden, she faces the dual challenge of establishing her own identity while addressing the administration's pressing issues. With the election looming, the deeply polarized political environment in the U.S. raises concerns about the country's capacity to lead on the global stage, prompting other nations, including India, to prepare for the implications of this internal turmoil.



The Interplay of Trade and Diplomacy: India-China Relations in Focus

In the realm of international relations, trade has consistently emerged as a pivotal factor shaping diplomatic dynamics. Historical narratives, such as the East India Company's early ventures into the Chinese market for woolen cloth in the 16th century and the later British obsession with tea and Indian opium, underscore how trade relationships can dictate power balances and influence political interactions. Fast forward to today, whispers surrounding India's Kartavya Path suggest that business interests are again instrumental in fos-

tering military disengagement between India and China along the Line of Actual Control (LAC) in Ladakh. The recent agreement between India and China, announced just before the BRICS summit, marks a significant thaw in relations that had soured following a deadly clash in 2020. As Foreign Secretary Vikram Misri noted, this new pact allows both nations to resume border patrols, reaffirming their territorial claims while fostering a framework for mutual compliance. This move is not merely tactical; it reflects a shared desire for stability and cooperation recognized as essential by both parties.

The timing of this agreement is crit-

ical, particularly given that China remains one of India's key trading partners, with bilateral trade reaching \$118.4 billion in 2023-2024. Despite ongoing geopolitical tensions, China continues to be a vital source of goods and industrial products for India. The Indian business community's push for renewed dialogue illustrates the undeniable link between economic interests and military strategies.

Looking ahead, a potential summit between Prime Minister Narendra Modi and President Xi Jinping looms large, signaling an opportunity to deepen economic ties while addressing lingering issues. However, this diplomatic thaw occurs amid China's assertive actions in the Indo-Pacific

region, particularly regarding Taiwan and the South China Sea, creating a delicate balancing act for India.

India's engagement with both the United States and China is pragmatic, focusing on strategic interests rather than ideological alignments. This approach allows India to navigate a multipolar world more effectively, prioritizing cooperation over rigid alliances. The U.S. also acknowledges this complexity with its policy of "managed competition," recognizing the necessity of collaboration amid confrontations. The economic interdependence between the U.S. and China is noteworthy, with trade reaching \$758.4 billion in 2022 despite sanctions. This interdependence underscores the his-

torical reality that sanctions often fail to eliminate adversaries.

Ultimately, the future of India-China relations hinges on recognizing the interdependence fostered by trade. India's current reliance on Chinese technology highlights its need to enhance its innovation capacity, as it contributes less than 3% of global R&D expenditures compared to China's 22.8%. A confrontational stance could be detrimental to India's aspirations, especially when collaboration often yields better results than conflict. As both nations navigate their complex geopolitical landscape, economic ties will likely remain central to fostering a stable and constructive relationship.

PM Narendra Modi hails launch of Vadodara aircraft unit

Prime Minister Narendra Modi marked a significant advancement in India's defence and aerospace capabilities with the inauguration of the C-295 aircraft manufacturing complex in Vadodara. Joined by Spanish President Pedro Sanchez, Modi launched the Tata Advanced System Limited (TASL)-Airbus facility, which is set to produce C-295 military aircraft in India. This facility represents the first private sector final assembly line for military aircraft in the country.

In a LinkedIn post following the inauguration, Modi described the speed of the project's execution as "breathtaking," highlighting that it took only two years to transform from a foundation stone to an operational facility. He emphasized that this rapid development is indicative of a new work culture and showcases the capabilities of the Indian workforce.

The Prime Minister noted that India's defence production has seen remarkable growth, soaring to ₹1.27 lakh crore in the 2023-24 fis-



cal year. He pointed out that defence exports have also increased dramatically, rising from ₹1,000 crore in 2014 to an anticipated ₹21,000 crore in 2024. This shift underscores India's growing role in the global defence market.

Moreover, Modi highlighted the indigenization efforts within the sector, stating that over 12,300 items have been indigenized in just three years. This push towards self-reliance has been further supported by an investment of over ₹7,500 crore in domestic vendors by Defence Public Sector Undertakings (DPSUs).

The inauguration of the C-295 manufacturing complex is seen as a pivotal moment in India's journey towards enhancing its defence capabilities and achieving self-sufficiency in military production. It reflects the government's commitment to boosting the domestic aerospace sector and reducing reliance on foreign imports.

Nothing Hindu-Muslim In Ban On Firecrackers In Delhi: Arvind Kejriwal

Am Aadmi Party (AAP) convenor Arvind Kejriwal addressed the recent ban on firecrackers in Delhi, emphasizing its importance for public health and environmental protection. He firmly stated that the decision is not influenced by any religious considerations, asserting that the focus should be on reducing pollution for the benefit of all citizens.



Kejriwal articulated that Diwali, known as the festival of lights, should be celebrated through lighting diyas and candles rather than igniting firecrackers that contribute significantly to air pollution. "It's not that we are doing any favour to others. We are doing favour to ourselves because ultimately we and our small kids will suffer from the pollution caused by bursting crackers," he remarked during a press conference.

Kejriwal rejected the criticism from the Bharatiya Janata Party (BJP) and the Rashtriya Swayamsevak Sangh (RSS), who claim that the ban targets Hindu cultural practices. "There is nothing Hindu-Muslim in it. Everyone's breathing and life is necessary," he stated, emphasizing the universal need for clean air.

He also highlighted that both the Supreme Court and High Court have urged citizens to refrain from bursting firecrackers, advocating instead for the traditional lighting of diyas during Diwali. This stance aligns with the courts' recognition of the environmental impact and health concerns associated with firecrackers.

Earlier this month, the Delhi government issued a comprehensive ban on the manufacture, sale, storage, and use of all types of firecrackers, effective until January 1, 2025. This directive was enforced by the Delhi Pollution Control Committee (DPCC) under the Air (Prevention and Control of Pollution) Act, 1981, and includes restrictions on online sales and deliveries of firecrackers.

Congress Slams Govt Over India's Economic Challenges

Congress general secretary in-charge of communications, Jairam Ramesh, has raised alarms over potential chokepoints that could hinder India's growth trajectory in the coming years. All Nominations Done: Congress Denies Maharashtra Alliance Turmoil

The Maha Vikas Aghadi (MVA) has finalized nominations for all 288 seats ahead of the upcoming Maharashtra elections, Congress leader Ramesh Chennithala announced on Wednesday. Despite earlier confusion regarding seat allocations among the alliance members—Congress, Uddhav Thackeray's Shiv Sena faction, and the Sharad Pawar-led Nationalist Congress Party—Chennithala expressed confidence in their readiness for the elections.



As the nomination deadline approached, concerns arose when the MVA had not officially named candidates for 11 seats. Meanwhile, the ruling Mahayuti alliance, comprising the Bharatiya Janata Party (BJP) and factions of the Shiv Sena and NCP, had not filled four seats. Chennithala acknowledged some "misunderstanding" within the MVA but maintained that there were no significant rifts among the allies.

He criticized the ruling alliance for internal conflicts, noting that BJP leaders were contesting under the banners of the Shinde Sena and Ajit Pawar's NCP. "The BJP is fighting alone... Shinde and Ajit Pawar are finished," he asserted.

Chennithala emphasized that the MVA has treated all partners fairly, countering criticisms faced after the Congress's recent performance in Haryana, where it

initially led but ultimately lost. He assured that there would be no "friendly fights" within the MVA, referencing previous instances where allies contested the same seats.

As of now, the Congress has nominated 103 candidates, while both the Thackeray Sena and the Pawar NCP have fielded 87 candidates each, exceeding the initially agreed-upon quota. The remaining seats are expected to be allocated to smaller allies, though details remain unclear.

On the opposing side, the BJP has announced 152 candidates, with Ajit Pawar's NCP and Shinde's Sena nominating 52 and 80 candidates, respectively. The complexity surrounding candidate nominations highlights the significance of this election, which could serve as a referendum on Maharashtra's recent political turbulence.

Siddaramaiah Assures Vijayapura Farmers: No Evictions Over Waqf Land Concerns

Chief Minister Siddaramaiah assured farmers in Vijayapura district on Tuesday that they will not face eviction from their lands amid concerns that some properties were incorrectly marked as Waqf land. Addressing local grievances, Siddaramaiah emphasized, "No farmer will be evicted from their land," and confirmed that revenue minister Krishna Byre Gowda, industries minister MB Patil, and Waqf minister Zameer Ahmed Khan supported this decision.

In Tikota taluk, an error in a gazette notification had reportedly designated 1,200 acres as Waqf property, but Patil clarified that only 11 acres were legitimately under Waqf jurisdiction. Joshi claimed these actions aimed to appease minorities ahead of upcoming bypolls, stating that tampering with revenue records constituted a grave injustice to the people.

Russia Conducts Nuclear Drill Amid Ukraine Tensions

Russia's nuclear forces have initiated a special exercise following orders from President Vladimir Putin, marking a significant escalation in the ongoing Ukraine conflict. This exercise comes as Moscow's senior officials declare the war has entered its "most difficult phase."



This marks the second military exercise ordered by Putin in just two weeks, as tensions rise over plans by Western nations, particularly the U.S., to provide Ukraine with long-range cruise missiles capable of targeting deep into Russian territory. Moscow has explicitly warned that any such actions would lead to Russia considering the use of nuclear weapons to protect its sovereignty.

The Kremlin has updated its nuclear doctrine, approved by Putin last month, allowing for potential nuclear strikes against non-nuclear states, which serves as a stark warning to the West. During the launch of the nuclear drill, Putin stated, "We will work out the actions of officials to control the use of nuclear weapons with practi-

cal launches of ballistic and cruise missiles." He emphasized that while using nuclear weapons would be an "extremely exceptional measure," readiness is crucial.

In response to escalating tensions, NATO has condemned Russia, particularly over reports that North Korea is sending troops to assist in the Ukraine conflict. The Pentagon has reported that North Korea may be dispatching around 10,000 soldiers to train in eastern Russia, potentially augmenting Russian forces near Ukraine. Concerns are mounting that these troops could be deployed in combat against Ukrainian forces.

EU Will Have To Pay A Big Price: Donald Trump's Warning On Tariffs

During a rally in Pennsylvania on Tuesday, Republican presidential candidate Donald Trump issued a stern warning to the European Union, claiming they would face significant repercussions for not purchasing enough American exports if he were to win the November 5 election. "The European Union sounds so nice, so lovely, right? All the nice European little countries that get together," he said, before discussing his plans to implement the "Trump Reciprocal Trade Act."



His comments have also raised concerns in Taiwan, as Trump has suggested that the island should compensate the U.S. for its defense and has accused it of taking advantage of America's semiconductor industry. Despite the lack of formal diplomatic ties, U.S. law mandates that Washington provide Taiwan with the means to defend itself against potential aggression from China.

This statement came shortly after the Iran-backed militant group announced Qassem's succession of Hassan Nasrallah, who was reportedly killed in an Israeli strike in Beirut last month.

As Hezbollah adjusts to this leadership change, the potential for conflict remains high, and both sides are likely to monitor each other's moves closely.

Qassem's ascension marks a critical moment for Hezbollah, a group deeply entrenched in regional politics and military operations, particularly in relation to Israel. His leadership will likely face immediate challenges, especially in the wake of Nasrallah's death, which has raised questions

Ukraine, Russia In Talks For Halting Airstrikes On Energy Sites

Ukraine and Russia are reportedly entering early negotiations aimed at potentially halting airstrikes on each other's energy infrastructure, according to a report from the Financial Times. The discussions, which are in their infancy, come as Ukraine faces significant challenges following the destruction of a large portion of its power capacity due to ongoing military actions.



The Financial Times, citing unnamed sources, indicated that Ukraine is eager to revive talks that nearly reached an agreement back in August, with mediation by Qatar. However, those discussions were disrupted after Ukrainian forces conducted an incursion into Russia's Kursk region that month.

One diplomat briefed on the situation noted, "There are very early talks about potentially restarting something," emphasizing that the focus is now on energy facilities. The notion of halting attacks on energy infrastructure is critical, as both

countries have suffered extensive damage to their power systems, impacting civilian life and operations.

As of now, Reuters has not been able to independently verify these reports. Requests for comments from various officials, including the Kremlin, the Russian Defense Ministry, Ukrainian President Volodymyr Zelensky's office, and the Ukrainian Defense Ministry, have gone unanswered.

The context of these discussions is significant, as Ukraine, which initially lacked long-range weaponry at the outset of the conflict, has since developed advanced long-range attack drones capable of targeting critical infrastructure. This shift in military capability has altered the dynamics of the conflict, leading to increased pressures on both sides.

India and China Complete Military Disengagement in Ladakh

In a significant development, India and China have successfully completed the disengagement process in the Depsang and Demchok regions of Eastern Ladakh, adhering to the previously announced timeline. Army sources confirmed that patrolling in these areas will resume soon, coinciding with Diwali celebrations on Thursday, during which sweets will be exchanged between Indian and Chinese troops.



Indian Army officials stated that the verification process is ongoing, with ground commanders set to finalize the modalities for patrolling. This development follows a pivotal meeting between Chinese President Xi Jinping and Indian Prime Minister Narendra Modi at the recent BRICS summit in Russia, where both leaders established "important understandings" to guide future relations between their countries.

Chinese Ambassador to India, Xu Feihong, emphasized the significance of this high-level dialogue, suggesting that it has laid the groundwork for smoother relations. He remarked, "I hope that, under the guidance of this consensus, our relations will be moving forward smoothly and will not

be restricted or interrupted by specific disagreements." Xu acknowledged that while differences are natural between neighboring countries, the focus should be on effective management and resolution.

The announcement of the disengagement process came on October 21, when India confirmed that a patrolling agreement had been reached. The accord stipulated that troops would revert to their positions prior to the stand-off that began in 2020. As part of the disengagement, both sides agreed to dismantle structures established during the conflict and restore the land to its original condition.

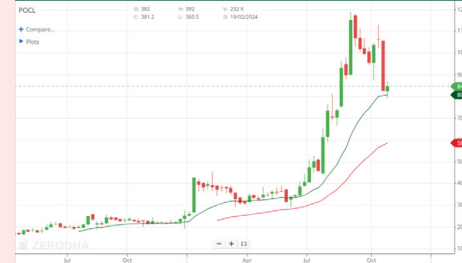

As gold prices remain high, analysts predict that demand may shift in response to price fluctuations. Investors are likely to monitor market conditions closely, adjusting their strategies based on economic indicators and price movements.

Adani flagship firm's net profit zooms eight-fold

Adani Enterprises Ltd, the flagship company of billionaire Gautam Adani's conglomerate, has reported a staggering nearly eight-fold increase in net profit for the September quarter, driven by robust earnings from its airports and new energy divisions. The company's net profit for the second quarter of the fiscal year 2024-25 reached ₹1,741 crore, a remarkable 663% increase from ₹228 crore in the same quarter last year, according to a company statement.

Earnings before interest, taxes, depreciation, and amortization (EBITDA) surged by 46% to ₹4,354 crore, while total revenue rose by 15% to ₹23,196 crore. Notably, aside from the coal trading business, all other core segments of the firm demonstrated significant growth in both revenues and profits.

Adani New Industries Ltd, which encompasses the company's new energy initiatives, reported a 78% increase in pre-tax profit to ₹1,121 crore. Similarly, the airport business saw



a 31% rise in earnings, reaching ₹744 crore, with revenue for both sectors also climbing.

However, the coal trading unit experienced a downturn, with earnings declining to ₹1,916 crore from ₹2,063 crore due to decreased revenues. Despite this setback, the overall financial health of Adani Enterprises remains robust, as the company achieved its highest half-yearly EBITDA of ₹8,654 crore, supported by strong performance from its emerging infrastructure businesses.

Gautam Adani, the chairman of Adani Group,

emphasized the company's commitment to investing in logistics, energy transition, and other sectors crucial to India's economic growth. He highlighted the rapid advancements in capacity and asset utilization within Adani New Industries Ltd and Adani Airport Holdings Ltd as driving factors for this record-breaking performance.

The company has also made strides in its solar business, with solar module sales surpassing 2 GW in the first half of the fiscal year, while exports rose by 64% and domestic sales more than doubled. Additionally, construction on data centers in Noida and Hyderabad is nearing completion, with the Pune center at 38% completion.

With passenger traffic at its seven airports increasing to 45.1 million from 42.6 million year-over-year, Adani Enterprises is well-positioned for continued growth and expansion in various sectors.

SEBI's Penalty on Research Analyst Raises KYC Compliance Concerns



The recent ₹7 lakh penalty imposed by the Securities and Exchange Board of India (SEBI) on research analyst Arun N has sparked apprehension among his peers regarding the complexities of compliance with know-your-customer (KYC) regulations. On October 24, SEBI penalized Arun for misleading clients with promises of assured returns and for failing to conduct necessary KYC checks.

The issue of KYC remains ambiguous for research analysts, as there is no clear guideline detailing their responsibilities in verifying client credentials. A senior analyst, speaking anonymously, expressed concern that the lack of clarity might prompt SEBI to issue a circular to define KYC specifications and timelines. Currently, SEBI-registered intermediaries must comply with 2023 KYC registration regulations, but specific

provisions for research analysts to maintain client identification records are not yet established. In August 2024, SEBI proposed that research analysts follow KYC procedures for their fee-paying clients, but this proposal is still under discussion.

Arun N's case illustrates the enforcement of these regulations. SEBI launched an investigation in March to evaluate compliance from April 2022 to February 2024. It suspected Arun of violating KYC rules by outsourcing KYC activities and making unrealistic return guarantees. The investigation revealed that Arun was onboarding clients through "Gap-up," a Telegram-based platform where investors received trade advice from SEBI-registered experts. While he collected basic client information, he admitted to not conducting direct KYC checks and instead depended on Gap-up

for onboarding.

SEBI's findings confirmed that Arun breached its master circular on KYC requirements, which led to the ₹2 lakh component of his total fine. Arun did not respond to inquiries from Mint regarding the situation.

Legal experts emphasize that SEBI's order reflects heightened scrutiny over the use of third-party platforms for client onboarding and payment processes. Ravi Prakash, head of litigation at Corporate Professionals, noted that while SEBI hasn't discouraged third-party KYC verification, it is not deemed a core activity for research analysts. The expectation is for intermediaries to perform sample checks periodically to ensure KYC record accuracy. As discussions around specific KYC requirements continue, the industry remains vigilant about compliance implications.

Instagram Outage Sparks User Frustration and Humor



A widespread technical glitch left Instagram users frustrated as they faced significant disruptions on the platform. On Tuesday evening, Downtidetector, a site dedicated to tracking online outages, reported a sharp increase in complaints. Users struggled with various issues, including login problems, app functionality, and server connections.

Specifically, the breakdown affected 44% of users who reported malfunctions within the app, while 30% encountered challenges when attempting to post content. Additionally, 25% faced difficulties with server connec-

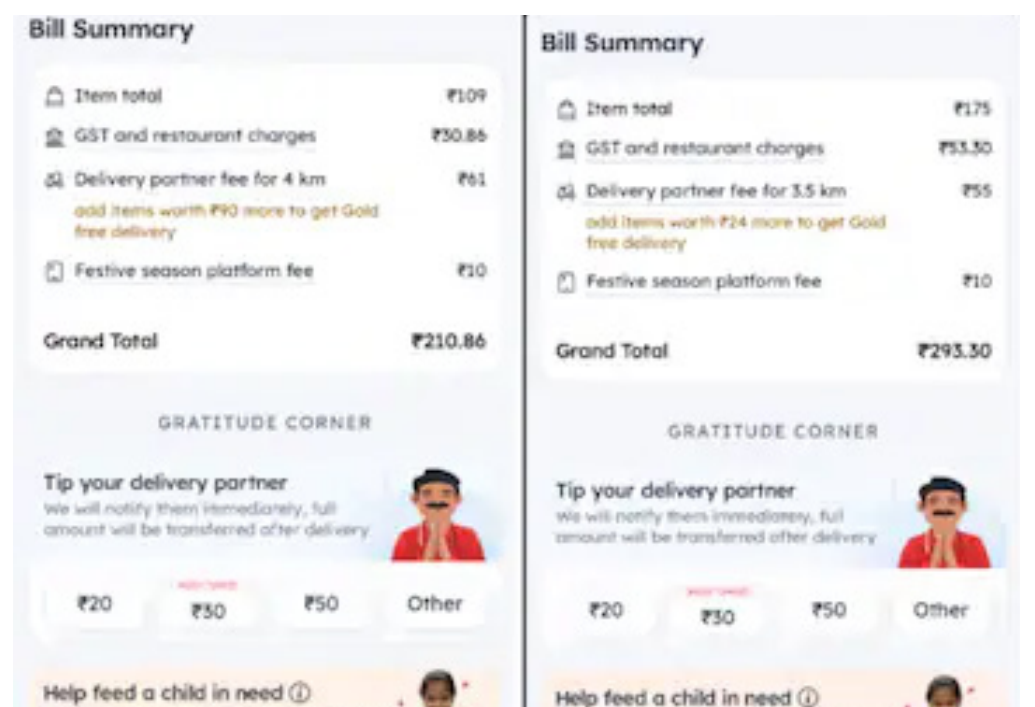
tions. This sudden outage led many to seek refuge on rival social media platforms to express their frustrations and share their experiences.

Zomato Explains Platform Fee Hike As 'Routine Business Matter'



In the midst of the bustling festive season, food delivery giant Zomato made a controversial decision to raise its platform fee for users. The fee has increased from Rs 7 to Rs 10, a move that the company attributes to the need to maintain service quality during peak periods. Originally introduced in 2023 with a modest Rs 2 flat levy per order, the platform fee has seen a gradual increase over time, leading to significant user dissatisfaction. The recent hike has not been well received by a large segment of Zomato's user base, many of whom took to social media to voice their concerns. Users expressed frustration over the rising costs associated with the service, particularly during a time when many are looking to celebrate and enjoy festive meals without added financial burdens.

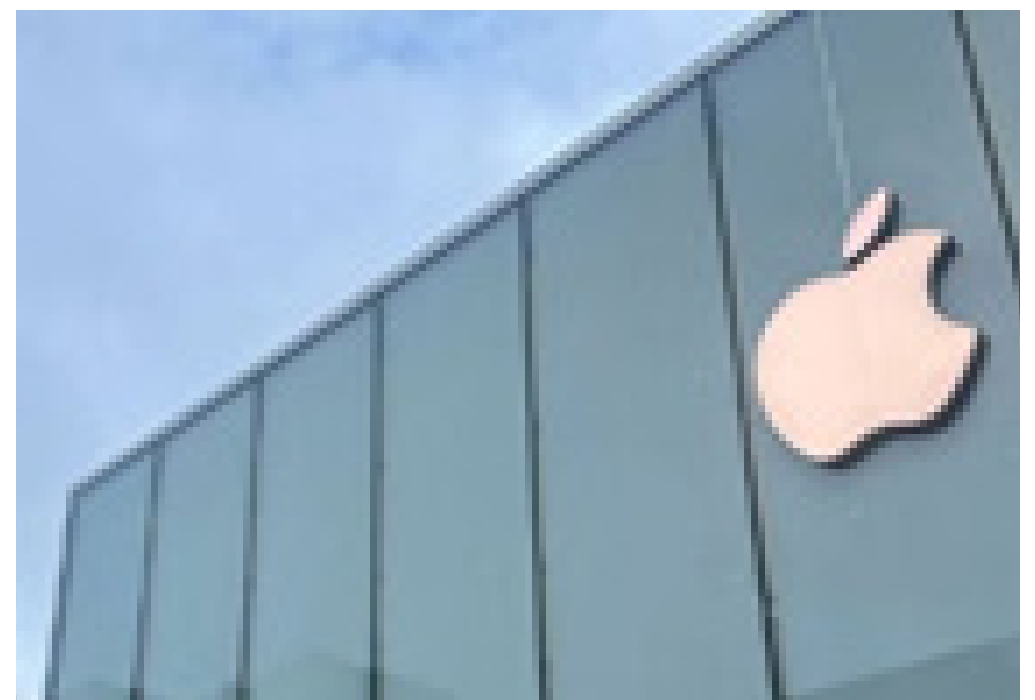

Apple Unveils Redesigned Mac Mini Featuring M4 Chips



Apple Inc. has introduced a revamped Mac Mini, marking the first major redesign in nearly 15 years. The new model, which measures just 5 inches across, features the advanced M4 chips, offering enhanced performance and efficiency, as reported by Bloomberg on October 29.

The updated Mac Mini is significantly smaller than its predecessor, which was first unveiled by former CEO Steve Jobs. The new design is more compact, resembling the size of an Apple TV set-top box, and stands at just 2 inches tall. The device is powered by M4 and M4 Pro processors, part of a broader wave of upgrades to Apple's Mac lineup.

This week has been packed with announcements from Apple, starting with the reveal of a new iMac equipped with the M4 chip. Additionally, Apple launched Apple Intelligence, its new AI platform, designed for the iPhone, iPad, and Mac.

The new Mac Mini features a pair of connectors on the front, similar to those found on the higher-end Mac Studio, and offers an array of ports and

inputs at the back. While maintaining the classic silver finish of previous generations, Apple emphasized the computer's capabilities in managing tasks associated with Apple Intelligence, although older M1 and M2 versions also support this software.

On the accessory front, Apple introduced new USB-C connectors, but it's worth noting that the Mac Mini does not come bundled with a keyboard, mouse, or trackpad—only a power cable is included. Weighing in at just 1.5 pounds, the device is designed for portability and convenience. Preorders began on Tuesday, with the product set to hit stores on November 8.

Pricing Details

The new Mac Mini models replace the earlier M2 and M2 Pro versions released in early 2023. The M4 edition features a 10-core CPU and GPU, starting at \$599, which matches the price of its predecessor. A higher-end version with enhanced specifications is available for \$799, catering to users seeking greater performance.

Scammers Are Using AI to Sound Like Your Loved Ones

Sunil Mittal, chairman of Bharti Airtel, recently highlighted a troubling trend involving scammers who are using AI technology to clone his voice and deceive company executives into transferring substantial sums of money. During the NDTV World Summit, Mittal expressed his astonishment after hearing a recording of the AI-generated voice, which he found remarkably convincing.

Fortunately, the company officials did not fall for this particular scam. However, numerous victims have already been duped out of their money by scammers utilizing voice cloning technology. In recent months, reports have surfaced of individuals losing amounts ranging from a few thousand to over a lakh, demonstrating the alarming rise of AI voice cloning scams.

What is AI Voice Cloning?

AI voice cloning refers to the technology that creates a digital replica of a person's voice. By recording some-



one's voice and training an AI model, fraudsters can impersonate that individual convincingly. While voice cloning has beneficial applications, such as enhancing text-to-speech systems and providing personalized customer interactions, it also poses significant risks when exploited by criminals.

The Ease of Voice Cloning

Cloning someone's voice has become alarmingly easy with AI-powered tools. A simple online search reveals numerous free and paid services that can replicate a voice for as little as \$5 (approximately Rs 420). All it takes is a 30-second audio clip of the target's voice, which can be uploaded

to these services, allowing users to generate speech in that voice.

AI voice cloning scams often prey on individuals' trust by impersonating friends, family members, or authority figures. Scammers frequently pose as law enforcement officials, claiming that a loved one is in custody or has been involved in an accident. They create a false sense of urgency, demanding immediate money transfers for release or medical assistance.

In distressing cases, parents have reported being tricked by scammers impersonating their children's voices, complete with fake cries for help. Such scenarios can be profoundly convincing, even to those who are generally cautious about scams.
