# No Matter Who Gets in the Way, Musi Cleaning Will Not Stop



TPN, Hyderabad: The Telangana government is committed to realizing the Musi River beautification project. As part of this effort, houses in the buffer

zone of the Musi River catchment area are being cleared. In this context, CM Revanth Reddy responded to the ongoing developments.

He firmly stated that the cleaning process will continue, regardless of any obstacles, and emphasized that the dirt and pollution in the river will be left behind. CM Revanth Reddy assured that those displaced by the project will be supported in all possible ways.

KCR's family is now provoking the poor. What has KCR's family ever done for the underprivileged?" Revanth Reddy questioned. He called on the opposition parties to stop making unnecessary criticisms and instead offer constructive suggestions on how to support the displaced people.

# Youth and Farmers **Suffer in Congress Govt Says Harish Rao**

TPN, Telangana: T. Harish Rao, the Siddipet MLA from the Bharat Rashtra Samithi (BRS), expressed strong criticism of the Telangana government on October 6, claiming it has failed the youth of the state. He highlighted a severe unemployment crisis, stating that despite promises of creating 200,000 jobs, there has been no progress even after ten months. Rao emphasized that many young individuals who believed in Congress's six guarantees and campaigned for the party are now grappling with unemployment, which has left them disillusioned and struggling.

#### Neglect of Farmers' Welfare

Rao further condemned the government for its failure to implement key initiatives, particularly those aimed at supporting farmers. He stated that the non-implementation of farmer loan waivers has led to significant financial hardships, leaving many farmers in dire situations. The former finance minister expressed concern that the lack of action has also prevented the increase of pensions for senior citizens, exacerbating their plight.

On social media platform X, Rao urged the government to adhere to its commitments and implement the six guarantees, which he believes should encompass declarations that benefit both farmers and youth. His call to action highlights a growing sentiment among the public regarding the unfulfilled promises made by the Congress-led government.

In a related statement, BRS working president K.T. Rama Rao (KTR) also placed the blame on Congress for the ongoing challenges faced by farmers in Telangana. He cited the irrigation crisis, incomplete crop loan waivers, and the absence of the Rythu Bharosa scheme as critical issues contributing to the distress among farmers, leading to tragic outcomes, including suicides. Together, these concerns underline a pressing need for the government to act swiftly and effectively to address the plight of both youth and farmers in Telangana.

# Jani Master's National Award Suspended



TPN, Hyderabad: The Union Information and Broadcasting Ministry suspended choreographer Jani Master's National Award for Best Choreography on Friday, October 4, due to allegations of sexual assault. Jani Master, whose real name is Shaik Jani Basha, won the award for the song "Megham

Karukkatta" from the film Thiruchitrambalam. He shared the award with co-choreographer Sathish Krishnan. However, the National Film Awards Cell of the I&B Ministry has since issued a statement suspending the award.

In a letter, the deputy director of the cell stated, "In view of the seriousness of the allegations and the matter being sub judice, the Competent Authority has decided to suspend the National Film Award for Best Choreography for the year 2022 to Shri Shaik Jani Basha for the film Thiruchitrambalam until further orders." Jani's invitation to attend the National Awards ceremony on October 8 has also been withdrawn.

#### **Allegations Against Jani Master**

Jani is accused of sexually assaulting a minor dancer in 2019. Based on the complaint, the Cyberabad police arrested him in Goa on September 19 under the POCSO Act of 2012. The court remanded him to judicial custody for two weeks and later granted four days of police custody. The victim, now 21, alleges that Jani assaulted her multiple times between 2019 and 2020 across several cities, including Mumbai, Chennai, and Hyderabad. The Narsingi police have re-registered the case, and Jani faces charges under sections 376(2)(n), 506, and 323 of the Indian Penal Code.

Hyderabad, October 6, 2024: Telangana's Minister for Revenue, Information and Public Relations, and Housing, Ponguleti Srinivas Reddy, announced the upcoming implementation of the new Revenue Act-2024. aimed at alleviating the hardships faced by citizens over the past decade due to the existing Dharani Portal and the Revenue Act of 2020. He emphasized that

the new legislation would serve as a role model for the country.

The new act will be piloted in the Yacharam and Tirumalagiri mandals, with the government taking steps to restore the revenue machinery in villages before its introduction. Reddy stated that revenue officials play a crucial role in maintaining public trust and emphasized the need for a complete vealing issues regarding land overhaul of the revenue system to ensure it is accessible to ordinary citizens.

During a recent meeting with 272 Special Grade Deputy Collectors and Deputy Collectors, Reddy highlighted the importance of improving the revenue service, ensuring that a revenue official is assigned to each village. He expressed concerns over the previous government's hasty decisions that weakened the revenue system and distanced services from the public. Reddy assured that the new act would incorporate beneficial elements from the 2020 Revenue Act while avoiding any pitfalls.

The minister shared his recent experiences speaking with farmers in Tirumalagiri, re-

surveys. He also reiterated the government's commitment to digitizing revenue records to prevent tampering and ensure transparency.

Addressing employee concerns, he promised to resolve financial matters and create Selection Grade Deputy Collector positions in all 33 districts while facilitating IAS status for 17 revenue officials. Reddy also discussed vehicle uniformity for employees, indicating that decisions would be made considering the state's financial situation.

This new revenue initiative aims to restore public faith in the system and provide better services to the citizens of Telangana.

TPN, Telangana: Unseasonal rains have caused vegetable prices to skyrocket in the market, severely impacting the poor and middle-class population. Many can no longer afford to buy vegetables. Along with this, the prices of essential commodities have also surged, leaving people struggling to make ends meet. With vegetable prices on the rise, many are shocked, and some are even returning home without buying anything. People are eagerly waiting for prices to drop.

The drop in crop yield due to the rains appears to be the main reason for this price hike. Currently, vegetable prices are nearing ₹100 per kg. Tomatoes are already selling at ₹100 per kg. in some areas. Last week, onions were priced at ₹60 per kg in Andhra Pradesh and Telangana, but now they've reached ₹80 per kg. Tomatoes, which were priced between ₹50 to ₹60 per kg last week, are now selling for ₹100 per kg in some places, and between ₹80 to ₹90 in others. Market sources predict that by the time of the Dussehra festival, most vegetables may reach ₹100 per kg.

The state consumes 100 tons of cooking oil daily, and during the festive season, this increases to 150 tons. With the rising prices, consumers are facing a heavy burden.

#### **Ginger and Garlic Prices Spike:**

The prices of ginger and garlic have surged by ₹60 per kg within just a week. Ginger has jumped from ₹100 to ₹160 per kg, while garlic has increased from ₹300 to ₹360 per kg. In malls, garlic is being sold for ₹400 per kg. Onion prices have not dropped below ₹60 per kg for the past 15 days. Dried chilies are now priced between ₹200 and ₹250 per kg. Additionally, pulses are also seeing significant price hikes. The price of toor dal has increased by ₹20 per kg in a week, reaching ₹170 per kg. Green gram has risen by ₹30 to ₹150 per kg, black gram has increased by ₹15 to ₹135 per kg, and chickpeas have gone up by ₹5 to ₹105 per kg.

#### Despite Stock, Prices of Cooking Oils Rise

The central government increased the import duty on cooking oils on September 14 to support domestic farmers, as the prices of oilseeds were falling locally. Even though manufacturers had stocks that would last for two months, they immediately increased the prices. Retailers and wholesalers also followed suit, hiking prices without delay. Prices that were normal in the morning rose by the evening of September 15. Existing stocks were sold at new prices, with many retailers transferring them to the black market, selling them at higher prices to hotels and restaurants. Consumers are being told that fresh stocks will only be sold at higher prices. With the upcoming Dussehra and Diwali festivals, cooking oil prices are expected to rise even further. Price control seems to be missing.

While speaking to the media in Nizamabad, Goud responded to BRS Working President K.T. Rama Rao's recent comments about the Musi River beautification project. KTR had alleged

that the project funneled Rs. 30,000 crores in bribes to Delhi. Goud questioned how such an allegation could hold when the Detailed Project Report (DPR) for the project was not yet completed. He asked KTR to clarify his statements.

**Criticism of KTR and BRS Governance** 

Goud also criticized KTR, stating that while

Regarding the Musi River beautification, Goud reassured that the poor would not be displaced without alternative housing. He vowed to take strict action against illegal occupiers of government land, even if they were his family members. On loan waivers, he challenged Minister

Harish Rao to honor his promises and resign if he failed. Goud also confirmed that Nizamabad district would have representation in the upcoming cabinet expansion.

#### **Burning Prices in the Kitchen**

In just 12 days, cooking oil prices have jumped by ₹17 to ₹42 per liter. Onions, garlic, and pulses continue to soar in price. Leafy vegetables, now priced at ₹60 per kg, are also adding to the financial burden of consumers during the festive season.

In Hyderabad, during the festive season, the prices of essential commodities are soaring, and wholesale markets and malls are showing no sign of relief. On September 14, the central government announced an increase in the import duty on cooking oils, but starting the next day, prices began to rise. The duty hike applied only to palm, soy, and sunflower oils, but manufacturers and traders hiked the prices of all cooking oils, taking advantage of the festive season.

TPN, Telangana: At a significant event in Hyderabad's Shilpkala venue, Chief Minister Revanth Reddy distributed recruitment documents to 1,635 candidates selected for government jobs across various departments. The positions include Assistant Executive Engineers, Agriculture Officers, Physical Education Teachers, Librarians, and Veterinary Assistant Surgeons. In his address, Reddy emphasized the government's commitment to creating jobs and rebuilding trust, a sharp contrast to the previous administration's failures.

The Chief Minister highlighted the Congress government's swift action in fulfilling its employment promises. Within 90 days of taking office, the administration issued job appointment documents to over 30,000 individuals. He contrasted this with the failures of the prior government, which he accused of making empty promises in 2015 and neglecting the unemployed. Reddy noted that the Congress victory was built on a promise to restore hope and employment, and today's event was another step in delivering on that promise.

Reddy also underlined the importance of these jobs in the larger context of rebuilding Telangana, stating that these roles are not just employment opportunities but vital responsibilities in the state's ongoing development. He urged the new recruits to draw inspiration from figures



like Mokshagundam Visvesvaraya and those who contributed to Hyderabad's infrastructure. The CM stressed the importance of maintaining public trust through dedicated work.

Looking ahead, Reddy announced plans to distribute over 11,000 teacher recruitment documents on October 9, reflecting the government's commitment to education and public service. He also touched on the upcoming Musi Riverfront development project, assuring residents that better housing and future prospects are part of the plan. Reddy concluded by challenging opposition leaders to prioritize the welfare of the people over personal interests.

# **KTR Blames Congress Government for Farmers' Suicides**

### **Irrigation Crisis and Loan Waiver Failures Criticized Revanth Reddy Called Out for Anti-Farmer Policies**

TPN, Hyderabad: BRS working president KT Rama Rao on Sunday held the Congress-led Telangana government responsible for the tragic suicides of three paddy farmers, which occurred on Saturday. He sharply criticized the government's negligence towards the farming community, highlighting how both land-owning and tenant farmers are struggling due to a lack of sufficient support.

In a statement, Rama Rao pointed out the worsening irrigation crisis, the incomplete implementation of the crop loan waiver, and the absence of the Rythu Bharosa scheme, which had been promised to the farmers. These failures, he said, have left hundreds of farmers in despair. With mounting debts and no relief in sight, many farmers have tragically taken their own lives. "Farmers are dying by suicide due to this crisis, yet the government remains indifferent. The Chief Minister shows no empathy, and there is a complete lack of responsibility from the administration," Rama Rao said.

Rama Rao warned that the farming community is growing increasingly frustrated with the Congress government's inability to address their concerns. He predicted that Chief Minister A. Revanth Reddy would be held accountable by farmers for the anti-farmer policies and broken promises. According to KTR, the Congress government has not only failed to deliver on key initiatives like the Rythu Bharosa scheme but has also failed to provide adequate irrigation solutions, which has further compounded the distress in rural Telangana.



The BRS leader stressed that the government's incompetence is pushing more farmers into financial ruin and despair. However, he urged the farming community not to lose hope and expressed confidence that the current hardships would soon be overcome.

In his message to the farmers, Rama Rao assured them that better days are ahead. "Bad days will pass, and good days will come again. Jai Kisan!" he posted on X, reiterating his belief that farmers will ultimately prevail despite the government's failures.

## **Revanth Reddy does not care** about the education system

**TPN, Telangana:** During a recent press conference, State President Gellu Srinivas Yadav asserted that once Revanth Reddy assumes the role of Chief Minister, he will prioritize revitalizing the education system. Yadav highlighted the pressing issue of unpaid fee reimbursements to colleges, stating that no funds have been allocated so far, leaving students in private institutions struggling. He criticized the lack of a dedicated education minister, resulting in a complete absence of oversight.

#### Addressing Concerns

Yadav questioned the effectiveness of the newly formed education commission, pointing out that there have been no significant actions taken, and expressed concern over Akunuri Murali's apparent negligence. He also challenged the Chief Minister's claim about engineering students consuming cannabis, demanding evidence to substantiate such accusations and urging an apology to the affected students.

Rajender expressed concerns for those losing their homes, asking what alternative arrangements the government is providing. He questioned how the government can promise double-bedroom houses to those displaced when they previously owned homes valued in crores.

He also highlighted discrepancies in project funding, pointing out that while ₹2,000 crores were allocated for the Sabarmati River rejuvenation and ₹22,000 crores for the Namoganga project over 12 years, a staggering ₹1,50,000 crores is proposed for the Musi project.

Rajender demanded transparency regarding who was awarded the project contract. Additionally, he questioned the legality of

TPN, Hyderabad: Telangana politics is Ajay, who contested from Khammam in last year's assembly elections but lost to Minister Thummala, is reportedly eveing Serilingampally due to favorable social dynamics and voting factors, including a significant settler and Kamma caste vote. Ajay believes he has a strong chance of winning if he runs from Serilingampally under the BRS banner.

> It is rumored that Ajay has already requested permission from the party leadership to focus his efforts on Serilingampally and prepare for the upcoming election. However, there is internal debate within the BRS, as many feel Ajay's leadership is more critical in Khammam, where Congress won all the constituencies. His followers maintain that Ajay will remain in Khammam, but the final decision from KCR regarding Serilingampally is awaited.

## Woman Arrested for Murder **Over Ornaments in Kukatpally**

TPN, Hyderabad: The Kukatpally police have arrested a 35-year-old woman, Katari Manjula, in connection with the brutal murder of a 23-year-old labourer, Dharmaram Priyanka, over a dispute involving ornaments. The incident took place on September 30, and the arrest was made on Sunday, October 6.

Manjula, a resident of Jagathgirigutta, had befriended Priyanka, who had recently moved to Hyderabad from Nizamabad and was residing in KPHB. The two women met about a month ago, and Priyanka had entrusted Manjula with her ornaments for safeke eping, as she did not have a secure place to store them.

Tensions flared on September 30 when the two were seen arguing over the ornaments. Priyanka, sensing the situation escalating, called her friends to help resolve the issue. The argument was momentarily defused, and Manjula returned the ornaments. However, she continued to harbour resentment over the dispute.

Later, Manjula invited Priyanka to her home and persuaded her to consume alcohol. Afterward, Manjula lured Priyanka to an isolated area, where she pushed her onto a pile of garbage and brutally slit her throat. In an attempt to mislead the investigatio n and make it appear as a sexual assault, Manjula attacked Priyanka's private parts after the murder.

Following the investigation, police arrested Manjula at her residence and recovered the deceased's ornaments and a vehicle linked to the crime. The case is currently under further investigation.



# Food Safety Department Conducts Raids at **Popular Restaurants, Uncovers Multiple Violations**



ty Department conducted a series of raids at well-known restaurants across Hyderabad, revealing serious food safety violations. The inspections, which took place on Friday, October 4, targeted establishments including Over The Moon Brew Company, Maredumilli Restaurant, and Dine-O-China in Gachibowli, as well as other eateries in the city.

#### **Key Violations Found:**

Dine-O-China: Inspectors uncovered multiple issues, including the absence of a valid FSSAI license, improperly sealed doors and windows allowing pest entry, and clogged drains leading to water stagnation. Additionally, food stored in refrigerators was not labelled correctly, raising concerns about food safety and hygiene.

vealed a live cockroach infestation inside medical fitness certificates for its food hanthe kitchen refrigerator. There were open drains causing water stagnation, uncovered dustbins, and a batch of expired khowa dated August 5, 2024, stored in the refrigerator. Typing this essay on a MacBook Air, tethered to an iPhone Pro (albeit not the latest model) may appear hypocritical, but certain issues warrant discussion using the very tools that exemplify the topic. The hype surrounding the sale of the iPhone 16 across India is a reminder of the industrially produced concoction of glamour, envy, and cultural imperialism that defines many markets in the Global South today. This phenomenon is what can be termed as envy imperialism.

Envy, while often seen as a negative emotion, is a potent economic driver. In the realm of consumer behavior, envy fosters achievement motivation and drives spending. The more one envies, the more one feels compelled to earn, spend, and possess. Since its 2007 launch, the iPhone has become emblematic of this cycle. It is a status symbol that people aspire to own, not merely for its utility but for the social prestige it confers—a modern-day neighbour's envy, owner's pride.

#### **Curation: The First Step Toward** iSlavery

Not all forms of digital glamour are tied to luxury goods; intellectual posturing is another currency in this world of envy. Whether showcasing a new book or boasting of refined tastes like wine, social media is where people craft narratives to signal success and cultural arrival. This careful curation, often unnoticed by the curator, is a step toward what scholars like Jack Linchuan Qiu call \*iSlavery\*. Qiu argues that while smartphones promised emancipation, they have instead created new forms of enslavement. The most dangerous part of this enslavement is how willing we are to participate.



constraints they face in reality. As Kiran V. Bhatia points out, children in Indian slums use social media to access the experiences they aspire to but cannot attain. This digital access seldom translates into upward mobility. They are collateral consumers of a world designed for envy, mere "followers" feeding the data-driven machine of the social media ecosystem.

Brain imaging studies have shown that screen obsession is causing neurological disorders in children and adolescents. But for adults, the dangers are more insidious. Adults have the agency to step away from screens, vet they choose enslavement, tethered to the constant need for validation through digital personas. Whether standing in line for hours to buy the latest iPhone or constructing the perfect "authentic" self for social media, adults are increasingly slaves to their screens.



The dominance of Apple's iPhone across the globe is not just a technological achievement but a cultural one. The possession of an iPhone allows users to flaunt their status, which in turn enables them to signal other forms of affluence. In this sense, the cultural imperialism of the iPhone goes beyond its technological capabilities—it exploits the human need for social validation and feeds off envy.

As Christian Fuchs argues, traditional slavery involved the exploitation of the body. Today's digital slavery exploits the brain—the site of our ideas, emotions, and desires. The relentless pursuit of social validation through smartphones is eroding our ability to engage meaningfully with the world. What remains is a shallow existence, driven by envy and the need to curate an image that aligns with societal expectations.

This relentless cycle of envy and aspiration is

leading to a form of digital \*anomie\*—a state of nothingness. As we become more enslaved to our screens and the devices that shape our social lives, we risk losing touch with the very essence of who we are.

Speaking about a recent roundtable in New York, where Prime Minister Narendra Modi met with top tech executives, Vaishnaw highlighted that three leading CEOs noted an unprecedented level of enthusiasm for India in the last 35 to 40 years.

The Central government has approved five semiconductor manufacturing proposals, totaling nearly ₹1.52 lakh crore in investment. Vaishnaw noted that Micron Technology is set to produce the first made-in-India chips by early 2025. He also mentioned ongoing construction at the CG power semiconductor facility and Tata's ATMP facility in Assam, both crucial for bolstering India's semiconductor capabilities.

The Minister emphasized that the growth of the semiconductor industry aligns with PM Modi's vision for a self-reliant India. Semiconductors are foundational to numerous industries, powering everything from medical devices and mobile phones to vehicles and home electronics.

According to reports, India's semiconductor market is projected to reach \$64 billion by 2026, nearly tripling its size since 2019. "I challenge PM Modi to provide free electricity in all 22 BJP-ruled states before the Delhi Assembly elections in February. If he does, I will campaign for the BJP," Kejriwal stated emphatically. He also referenced exit polls suggesting that the BJP's grip on power is weakening in states like Haryana and Jammu Kejriwal's comments reflect a broader narrative in which he seeks to position AAP as a champion for the common man, contrasting it with the BJP's governance. As the Delhi Assembly elections approach, his challenge could serve to galvanize support among voters who prioritize affordable utilities and good governance.

The response from PM Modi and the BJP regarding Kejriwal's challenge remains to be seen, but the stakes are high as both parties prepare for a politically charged election season.

The tragic death of the woman medic has ignited outrage among her peers, prompting this significant protest. Debasish Halder, a participating doctor, expressed the group's determination: "The support of these people gives us the courage to continue our protest against the gruesome murder of our sister. They warned that the state would bear responsibility if any of them fell ill during the protest. Their demands extend beyond justice for their colleague; they also call for the removal of Health Secretary NS Nigam and accountability for alleged incompetence within the Health department.

Additional demands include establishing a centralized referral system for hospitals, monitoring bed vacancies, and forming task forces to improve essential provisions like CCTV, on-call rooms, and washrooms in medical facilities.



## **BJP Forming Govt For Third Time: Harvana CM**

Haryana Chief Minister Nayab Singh Saini dismissed exit poll predictions on Sunday, asserting that the Bharatiya Janata Party (BJP) will secure a full majority and form the government for a third consecutive term when results are announced on October 8.

Despite most exit polls indicating a potential Congress victory, Saini maintained his party's confidence. "On October 8, we are going to form the government," he stated firmly. He suggested that the Congress would likely blame the Electronic Voting Machines (EVMs) for their defeat, saying, "People will have their say on October 8, and they — Congress — will blame the EVMs."

When pressed about the number of seats the BJP might win in the 90-member assembly, Saini reiterated his confidence, saying, "I have said we will form the government with full majority." He attributed this optimism to the party's efforts to work for all sections of society without discrimination.

Saini's comments came after nearly 67 percent voter turnout was recorded in the Haryana assembly elections, with several exit polls predicting a comeback for the Congress party after a decade in opposition. He countered the predictions by referencing exit polls that also forecast Congress victories in Chhattisgarh and Uttarakhand, emphasizing that such forecasts do not reflect the reality on the ground.

## **SAARC Stagnation Due to Cross-Border Terrorism: Jaishankar**

External Affairs Minister S. Jaishankar has highlighted that the South Asian Association for Regional Cooperation (SAARC) is currently "not moving forward," primarily due to the activities of one of its member states engaging in "cross-border terrorism." His comments, made during a recent event, underscore the challenges facing SAARC, which has not convened for meetings since its last summit in Kathmandu in 2014.

While he did not name the country responsible, Jaishankar emphasized that the ongoing terrorism poses significant hurdles to cooperation among member nations. "If you are all sitting together and cooperating, and at the same time this kind of terrorism goes on... it poses a challenge for us," he said. The Minister asserted that normal-



izing such behavior would be un- dia has engaged in more substantial acceptable, leading to a collective decision to pause SAARC activities. Jaishankar also noted that the lack of SAARC meetings does not imply a halt in regional integration. He pointed out that in recent years, In-

regional cooperation with neighboring countries like Bangladesh, Nepal, Bhutan, Myanmar, and Sri Lanka. Initiatives include restoring railway lines, rebuilding roads, and enhancing energy grids. "What

is happening in the neighborhood is because we are espousing a policy called 'Neighbourhood First," he stated. Furthermore, during his address, Jaishankar discussed historical parallels, recalling Sardar Vallabhbhai Patel's efforts in reconstructing India post-colonialism while navigating the complexities of international relations. He referenced the present-day relationship with China, noting the ongoing border disputes and emphasizing the need for peace and respect for the Line of Actual Control (LAC).

As the regional landscape evolves, Jaishankar's remarks serve as a reminder of the intricate balance required for cooperation in South Asia, particularly in the face of challenges posed by terrorism and geopolitical tensions.





# There's One India: Canada **Reaffirms Support For Territorial Integrity**



Canada has reaffirmed its stance on the territorial integrity of India, a notable statement amid ongoing tensions between the two nations. This marks the first clear declaration since last year's diplomatic fallout following Canadian Prime Minister Justin Trudeau's allegations regarding potential Indian government involvement in the assassination of Hardeep Singh Nijjar, a Canadian citizen and a wanted terrorist in India.

During an appearance at the foreign interference commission in Ottawa, Deputy Minister for Foreign Affairs David Morrison stated, "Canada's policy is very clear that India's territorial integrity must be respected. There's one India, and that's

been made very clear." This affirmation is viewed as a response to the concerns surrounding pro-Khalistan elements within Canada, particularly as it relates to their activities and freedoms.

While Morrison acknowledged the existence of these pro-Khalistan sentiments, he characterized them as "awful but lawful," emphasizing the protections offered under Canadian freedom of speech laws. This clarification is intended to address apprehensions about Canada's stance on Khalistani activism, which has strained diplomatic relations with India.

The relationship between India and Canada has been increasingly fraught, particularly since the allegations made by Trudeau last year, which India deemed "absurd" and politically motivated. The aftermath saw a significant downturn in bilateral relations, including stalled trade talks and heightened diplomatic tensions.

Canada's recent overtures toward India, particularly following the re-election of Prime Minister Narendra Modi for a historic third term, signal an intention to mend fences. Trudeau indicated a willingness to engage on critical issues surrounding national security and public safety.

In June, the Canadian parliament observed a moment of silence for Nijjar, prompting India to hold its own memorial for the victims of the 1985 Air India bombing, which was linked to Khalistani terrorism. The complexity of these issues continues to challenge the diplomatic landscape, with Canada recently arresting four Indian nationals amid its investigations, further complicating the discourse around sovereignty and security.

As both nations navigate these sensitive waters, the reaffirmation of Canada's commitment to India's territorial integrity could serve as a pivotal step in restoring dialogue and cooperation moving forward.

## Adani now blends green hydrogen into natural gas for Ahmedabad

The Adani Group has taken a sig-nificant step towards sustainability by blending green hydrogen with natural gas supplied to households in parts of Ahmedabad. This initiative, spearheaded by Adani Total Gas Ltd (ATGL), aims to reduce emissions and support the group's net-zero targets.



The project commenced with a blend of 2.2-2.3% green hydrogen injected into piped natural gas supplies in Shantigram, as announced in a LinkedIn post by the company. The hydrogen is produced using renewable energy sources like wind and solar power through a process called electrolysis, which splits water into hydrogen and oxygen.

ATGL's Hydrogen Blending System will provide hydrogen-blended natural gas to approximately 4,000 domestic and commercial consumers. The company plans to gradually increase the hydrogen blend to 5% and eventually 8%, expanding its reach beyond Shantigram to other parts of Ahmedabad and further afield as it holds city gas licenses.

"This achievement marks a significant step towards reducing our carbon footprint and transitioning to cleaner energy solutions," said ATGL. The initiative enhances energy security and supports sustainable develop-

ment, reflecting the company's commitment to a greener future.

While state-owned NTPC has previously supplied green hydrogen-blended natural gas in Surat, ATGL's project is currently the largest of its kind. The pilot by GAIL (India) Ltd in Indore also explores hydrogen blending, but on a smaller scale.

Despite the promising aspects of green hydrogen, challenges remain. Its tendency to corrode pipelines limits its immediate use, although tests indicate that blending up to 10% hydrogen in natural gas does not adversely affect infrastructure. ATGL is currently adhering to this guideline while exploring options for higher blends in the future.

Overall, this initiative is a crucial part of India's energy transition, aiming to lower greenhouse gas emissions and combat climate change while providing cleaner energy solutions.

The RBI's MPC meeting, scheduled from October 7 to 9, will be closely monitored, with the outcome set to be announced on Wednesday, October 9. Market experts predict that the RBI will maintain the benchmark repo rate at 6.5 percent, consistent with its stance from August 2024. This decision is anticipated to align with the central bank's objective of controlling inflation while supporting economic growth.

In addition to the MPC meeting, the market will also be affected by foreign institutional investor (FII) activity, US Federal Open Market Committee (FOMC) meeting minutes, and fluctuations in crude oil prices. Last week saw a significant downturn, breaking a three-week winning streak, with the Nifty and Sensex both falling approximately 4.50 percent, closing at 25,014.60 and 81,688.45, respectively.

The selloff was largely attributed to foreign funds shifting investments to China after the country's central bank implemented substantial monetary stimulus by reducing the reserve requirement ratio (RRR) by 0.50 percent. In the previous week, FIIs sold equities worth Rs 40,511 crore, while Domestic Institutional Investors (DIIs) managed to purchase Rs 33,075 crore.

Palka Arora Chopra, Director of Master Capital Services, noted that the Nifty formed a strong bearish candle on the weekly chart, indicating significant selling pressure. The index broke key Fibonacci support at 25,100, with the next critical support level at 24,700. A breach below this level could trigger further declines toward 24,400.

Pravesh Gour, Senior Technical Analyst at Swastika Investmart, highlighted that the Bank Nifty's 100-day moving average at 51,100 serves as immediate support, while the 50,000-49,500 range represents the next support zone. On the upside, key resistance levels are identified at 52,500 and 53,300 during potential pullbacks.

# India's steel production faces challenges due to reliance coal imports

 ${f T}$ o optimize the utilization of available raw materials, the Min-istry of Steel has directed integrated steel manufacturers to incorporate iron ore fines into their steel production processes following beneficiation. This initiative aims to address the limited availability of high-grade iron ore in India and encourage the use of lower-grade ores.

Sources indicate that the ministry has also advised steel players to explore acquiring coking coal mines abroad, thereby enhancing the accessibility of raw materials at competitive prices. "It has been conveyed to them that iron reserves are limited in the country, and to preserve that, players must also use low-grade ore through the beneficiation process. They can also look for coking coal mines outside India," the sources stated.

Iron ore and coking coal are vital raw materials in steel manufacturing through the blast furnace route. Although iron ore is



generally abundant in India, the country is significantly reliant on imports for coking coal. Current practices among major steel producers typically favor high-grade ore, characterized by an iron content of 65 percent or higher, to ensure optimal production efficiency.

Iron ore fines, on the other hand, contain 64 percent or less iron content and are considered low-grade. The process of beneficiation, which involves upgrading the quality of these fines, can add to the overall production costs. Nevertheless, the ministry's push for this approach reflects a strategic effort to bolster domestic steel production while mitigating dependence on imports.

By promoting the use of lower-grade ores, the Ministry of Steel aims to foster a more sustainable and resource-efficient steel industry in India. This initiative not only seeks to ensure the longevity of the country's iron reserves but also aims to strengthen the sector's resilience against global supply chain disruptions. Ultimately, these measures could pave the way for a more competitive and self-sufficient steel industry in India.

# Hyderabad's Future: City to be **Divided into Four Corporations**

However, this tactic can sometimes backfire, as seen with the negative reception to the attacks on both the Mega and Akkineni families. With cinema holding such a central place in Telugu culture, any move that alienates fans can have serious political consequences. Both the YSRCP and Congress may need to reconsider their strategies, as the backlash from fans and voters suggests that targeting beloved film stars and their families could harm their political fortunes more than help them.

# Google can now lock your stolen Android smartphone automatically

🗖 oogle has intro-**U**duced a significant security upgrade for Android smartphones, enhancing protection against theft. This new feature, known as the "theft detection lock," aims to keep personal data secure and render stolen devices unusable to thieves.

Currently being rolled out to Android users in the U.S., the theft detection lock was first observed on the new-

ly launched Xiaomi 14T Pro, as reported by Mishaal Rahman on Threads. This initiative is part of a broader security enhancement that includes three major components designed to address theft-related concerns: theft detection lock, offline device lock, and remote lock.

The theft detection lock activates when it senses suspicious activity, such as multiple failed unlock attempts or when the phone is suddenly powered on after being turned off. This feature will automatically lock the device, protecting sensitive data and preventing unauthorized access.

This means that if a thief attempts to access the device while it is offline, they will still be blocked from accessing personal information.

The remote lock functionality adds another layer of security, allowing users to remotely lock their devices from another device or computer. This is especially useful in situations where a phone is lost or stolen, giving users peace of mind that their personal data remains safe.

# **Scientists Discover a 'Third State'** of Cells: Life After Death

**R**ecent research in biology has unveiled a fasci-nating phenomenon termed the "third state," where cells from deceased organisms exhibit new functions even after death. This groundbreaking exploration is detailed in an article by Peter Nobel, a biologist at the University of Washington, and Alex Pozhitkov, a bioinformatics researcher at the City of Hope Cancer Center, who highlight their findings on xenobots and anthrobots—cells that persist and adapt beyond their host's life.

Published in July in the journal \*Physiology\*, their review emphasizes various studies that showcase the therapeutic potential of these biobots. Nobel and Pozhitkov argue that these findings challenge conventional beliefs about cellular evolution: "The third state suggests that organismal death may play a significant role in how life transforms over time."

A notable example comes from Tufts University, where researchers extracted skin cells from dead frog embryos, observing their reorganization into new multicellular organisms called xenobots. Unlike typical cells, these xenobots exhibited novel behaviors and functions beyond their original roles. Similar capabilities have also been found in human lung cells, leading to the development of anthrobots that can self-assemble and navigate their surroundings.

Several factors, including the time since death, trauma, metabolic activity, age, and health, influence how these cells survive post-mortem. Although the



underlying mechanisms are not yet fully understood, researchers propose a hypothesis involving specialized channels and pumps in cell membranes acting as intricate electrical circuits. These channels generate signals that enable cell communication, facilitating growth and movement.

The implications of anthrobots extend beyond mere scientific curiosity. They could potentially be cultivated from living tissue while patients are still alive, reducing the risk of immune responses when delivering essential drugs. This technology holds promise for treating conditions like atherosclerosis and cystic fibrosis.

While the "third state" is not a means of achieving eternal life—these cells typically survive for four to six weeks—the findings suggest that the line between life and death may be more complex than previously understood.


