Internal Struggles Threaten BJP's Growth in Telangana

TPN, Telangana: There is growing tension within the Telangana BJP between new and old leaders. The senior leaders allege that the newcomers, often referred to as "immigrant leaders," are corrupting the party and sidelining those who have been loval to the BJP for years. These complaints have been directed at the party's leadership, with claims that the new leaders are disrespecting long-time members. This has led to an increasing sense of injustice among the

A recent example of this disconnect is the BJP's membership registration drive, which has been a nationwide success but is reportedly lagging in Telangana. The state's leadership has been criticized for failing to meet even half of the target of 50 lakh new members. The leadership is displeased with the lack of progress and the ongoing internal group politics, which is said to be distracting leaders from their responsibilities.

TPN, Telangana: In a review meeting held at Komurambheem Bhavan, Banjara Hills, Telangana's Transport and BC Welfare Minister, Ponnam Prabhakar, unveiled significant reforms to enhance the quality of education in BC Gurukuls. The minister stressed the importance of improving the pass percentage, setting a target of 100%. He directed officials to organize parent-teacher meetings between the 15th and 31st of this month to gather feedback and involve parents in the education process. Prabhakar also announced that efforts would be made to pay 50% of the rent for Gurukul buildings before the Dussehra festival and to improve infrastructure in rented buildings.

Health and nutrition were also addressed, with ANMs instructed to monitor the height, weight, and anemia status of students. A box will be installed in every Gurukul to allow students to report issues directly, ensuring their concerns are heard.

The minister reaffirmed the government's commitment to education, noting that Rs. 5,000 crores had been allocated for new residential complexes. He also mentioned that transfers and promotions for teaching staff across SC, ST, BC, and minority gurukuls have been completed, further strengthening the education system in Telangana.

Mallu emphasized that the state government, led by Chief Minister Revanth Reddy, is a people's government committed to the welfare of its citizens. He stated, "Our only agenda is to serve the people and protect the heritage of Hyderabad, not for personal gain." The government's work, he said, is driven by a vision to make Hyderabad a sustainable and beautiful global city, retaining its iconic lakes, parks, and rocks, which have contributed to its charm for centuries.

Addressing concerns about the loss of natural resources, the Deputy CM pointed out that over time, many of the city's lakes and parks have been encroached upon, while the once-prominent rocks have disappeared. This, combined with inadequate measures by previous governments to protect water bodies within the Outer Ring Road, has contributed to flooding during heavy rains. The Deputy CM also dismissed criticism regarding the financial feasibility of the restoration projects, stating that the state government is open to suggestions and feedback from all stakeholders. "We are ready to listen to any constructive ideas and work together to ensure the success of this initiative," Mallu said, while reminding the opposition that similar projects, such as the cleaning of the Sabarmati River in Gujarat, have proven suc-

Finally, Vikramarka Mallu urged opposition leaders to act responsibly and provide constructive suggestions rather than politicizing the issue. He warned that any attempts to obstruct the government's efforts for political gain would only harm the future generations of Hyderabad. Congress Government Accused of Deceiving Telangana Farmers

TPN, Telangana: In Telangana, the has since altered this stance, stating Congress government is facing severe criticism for what is described as a series of lies directed at the farming community. Critics label the Congress party a "den of lies," accusing it of misleading the public with manipulated statistics. During the Warangal Rythu

declaration, Congress pledged that if elected, its first priority would be to waive farmers' loans in full. However, after 224 days in power, only half of these loans have been addressed.

Congress leader Revanth Reddy initially claimed that ₹31,000 crores had been waived within the first eight months of governance. Yet, in a recent letter to Prime Minister Narendra Modi, he indicated that only ₹17,000 crores had actually been forgiven. This rais-

es questions about the whereabouts of the remaining ₹14,000 crores and why over 16 lakh farmers have yet to receive the promised loan waivers.

Farmers are left wondering how long they must wait for the fulfillment of these commitments. Critics argue that this represents yet another deceit from the Congress party. Initially, the government promised a loan waiver of up to ₹2 lakhs for all farmers but

that only one person per family will qualify for the waiver.

The inconsistency in messaging from waiving loans for all farmers to restricting it to some—has created confusion. Questions are being raised



about how many farmers in Telangana have taken out crop loans and who actually falls under the ₹2 lakh threshold for waivers.

To clear this confusion and hold the government accountable, there is a growing demand for full transparency regarding the loan waivers and financial calculations, compelling the Congress party to explain its actions to the people of Telangana.

KTR Criticizes CM Revanth's **Frequent Delhi Visits**

TPN, Telangana: KTR expressed his indignation over Chief Minister Revanth Reddy's repeated visits to Delhi, questioning the purpose behind them. He remarked sarcastically that Revanth's trips seemed aimed at counting the number of "Mousse Mootas," rather than focusing on pressing issues in Telangana.

KTR raised concerns about the impact of these frequent trips, emphasizing that poor people are left discussing their struggles in Delhi while the state administration is seemingly neglected. He criticized Revanth for leaving the administration "in the the effectiveness of such a strategy. wind" and questioned who truly ben-



efits from these visits. "In just ten days, you went to Delhi 23 times. Will you continue this pattern for the next five years?" KTR asked, challenging

He further questioned the financial outcomes of these trips, asking, "How much money have your trips brought to the state? Did you at least secure funds for flight fares?" KTR lamented that the self-respect of Telangana's people is being compromised by playing political tricks in the capital.

He concluded by asserting that the Chief Minister's visits appear to be more about preserving his political seat than addressing the needs of the people. "If Congress wins, Delhi will be addressed as 'Jee Huzuru," he remarked, alluding to the perceived subservience of the current administration to central authorities.

Harish Rao Accuses Telangana CM of Misleading on Crop Loan Waiver

TPN, Telangana: Senior BRS leader T. Harish Rao has sent a letter to Prime Minister Narendra Modi, raising serious concerns about the Telangana government's management of the crop loan waiver scheme. In his communication, Rao accused Chief Minister A. Revanth Reddy of "misleading" both the public and the Prime Minister regarding the implementation of waivers for loans up to ₹2 lakh.

Rao noted that Reddy had initially promised a comprehensive waiver by December 9, 2023, which was later extended to August 15, 2024. However, he claimed significant gaps persist in the actual disbursement of these waivers. Citing data from the State



Bank of India (SBI), Rao pointed out that only about 50% of eligible farmers have received their waivers, leaving many still awaiting relief.

The BRS leader further highlighted that the government had imposed 31 conditions, which rendered numerous farmers ineligible for the waiver. He expressed concern that many farmers resorted to private loans with high-interest rates to meet these conditions, exacerbating their financial struggles.

Rao's letter comes amid escalating tensions between the BRS and Congress over agricultural policies, with both parties accusing each other of failing to adequately support farmers. He urged the Chief Minister to fulfill his promises and complete the loan waiver process "before making claims about its success."

From Golden Telangana to Threats: RS Praveen **Kumar Responds to Hanmantha Rao**

TPN, Telangana: BRS senior leader RS Praveen Kumar expressed his discontent regarding the current state of Telangana, asserting that the dream of a "Golden Telangana" envisioned during former Chief Minister KCR's administration has turned into a reality of threats and intimidation. He criticized the prevailing atmosphere under the Congress rule, stating that it fosters an environment of fear.

Kumar referred to a video featuring Congress leader Mynampally Hanmantha Rao, who made alarming remarks directed at BRS Working President KTR and MLA Harish Rao. He condemned Rao's statements, highlighting that every word ut-



tered was a criminal offense. "Listen to the threats from Mynampally Hanmantha Rao. They will pour petrol on KTR and

Harish Rao. They have a clear plan and will face consequences," he stated, emphasizing that such public comments warrant police action.

He pointed out that despite the gravity of the situation, the police have yet to respond to complaints lodged regarding Hanmantha Rao's remarks. Kumar criticized the inaction of law enforcement, noting that victims of Hydra faced illegal action from police when they voiced their grievances against CM Revanth Reddy. He called for accountability and proper response from authorities regarding the threats made by Rao.

Eleti Maheshwar Reddy Challenges CM Revanth Reddy on Loan Waiver Claims

TPN, Telangana: Telangana Legislative Assembly BJP leader Eleti Maheshwar Reddy has condemned Chief Minister Revanth Reddy's recent letter to Prime Minister Modi, criticizing comments regarding the crop loan waiver. Reddy accused the CM of spreading falsehoods to gain political advantage in the upcoming Maharashtra assembly elections. He challenged Revanth

to engage in a public discussion about the letter, urging him to finalize the venue for the de-

Maheshwar Reddy highlighted several inconsistencies in Revanth Reddy's claims, asking pointed questions to hold him accountable. He noted that during the Telangana Assembly election campaign, Revanth promised to waive loans up to Rs. 2 lakh for all farmers, but many farmers remain in debt. He questioned why the Congress government has failed to fully implement the promised loan waivers, despite initial estimates from the State Level



Bankers Committee indicating that Rs. 49,500 crore would be needed for the complete waiv-

Furthermore, Maheshwar Reddy pointed out that only Rs. 17.869 crore has been waived from July 18 to August 15, 2024, benefiting just 22.22 lakh rice donors, which he claims is significantly less than the required funds. He reiterated his challenge for an open discussion on the Congress party's actions regarding the loan waiver, demanding immediate assembly meetings to address farmers' promises and grievances.

Rakesh Reddy Criticizes Congress for **Economic Crisis in Telangana**

TPN, Telangana: BRS leader Rakesh Reddy has sharply criticized the Congress government, asserting that "wherever there is a Congress government, there will be an economic crisis." Speaking to the media on Monday, he linked economic downturns in Karnataka, Himachal Pradesh, and now Telangana to Congress rule, claiming the party has overshadowed Telangana's potential for growth.

Reddy highlighted the significant decline in the state's real estate market, with "For Sale" signs proliferating across Hyderabad. He expressed concern over the faltering textile industry and tourism, noting that Gram Panchayat workers He referenced a letter from Chief Minister have not received their salaries for nine



months, and outsourced employees in SC and ST hostels remain unpaid.

Hearing on Nagarjuna's **Defamation Petition Against** Minister Konda Surekha



TPN, Hyderabad: A hearing took place today in Nampally Manoranjan Court regarding the defamation petition filed by film actor Akkineni Nagarjuna against Telangana Minister Konda Surekha. Senior Counsel Ashok Reddy represented Nagarjuna, arguing that the minister's comments were damaging to his family's honor and reputation. The court announced that Nagarjuna's statement would be recorded tomorrow, with the actor expected to appear in court.

During the proceedings, Advocate Ashok Reddy requested that the statements of witnesses be recorded alongside Nagarjuna's. The court subsequently adjourned the hearing until Tuesday.

The controversy arose from comments made by Konda Surekha regarding Nagarjuna's family, which have drawn condemnation from various celebrities in the film industry. BRS working president K.T. Rama Rao has already sent legal notices in response. Nagarjuna's petition demands criminal action against Minister Surekha for her remarks.

Hydra to Launch New **App for Pond Protection**



TPN, Hyderabad: Hydra Commissioner and Lake Protection Committee Chairman AV Ranganath conducted a review on Monday with officials from the Irrigation, Revenue, National Remote Sensing Agency, State Remote Sensing Application Center, and Survey of India to identify the Full Tank Level (FTL) and buffer zones of the ponds. In the city, ponds, government properties, parks, and areas designated for public use are protected from encroachment. Hydra will introduce the app to prevent such invasions.

The app is designed to ensure that information about any attacks reaches Hydra within seconds. Users will be able to lodge complaints through the app, while officials' observations and actions will be recorded in the field. HYDRA aims not only to protect encroached ponds but also to restore them to their former glory. Additionally, the app will assist in removing debris from encroached ponds. In the first phase, work will commence at Sunnam Cheruvu, Appacheruvu, Errakunta, and Kukatpally Nallacheruvu.

Narsinghi Police Seek to Cancel Johnny Master's Interim Bail



TPN, Hyderabad: In Hyderabad, the Narsinghi police have filed a petition in the Rangareddy district POCSO court requesting the cancellation of interim bail granted to Johnny Master. RSS Conducts Marches to Celebrate 100th **Formation Anniversary**



The conflict between Israel and Hamas has escalated dra-**■** matically over the past year, leading to profound devastation in Gaza. Following a surprise attack by Hamas on October 7, 2023, Israel launched a full-scale air-ground invasion that has since resulted in over 40,000 fatalities. This escalation was marked by Hamas's "Operation Al Agsa Flood," which involved a coordinated assault that claimed the lives of over 1,200 people in Israel, catching the country off guard.

The Onset of Conflict



Hamas operatives executed a multi-faceted attack that included firing over 5,000 rockets, infiltrating through paragliders, and breaching the Gaza wall to engage in violent incursions. In response, Israel initiated a military campaign aimed at achieving three primary objectives: avenging the killings, uprooting Hamas from Gaza, and securing the safe return of hostages. The ensuing conflict has left Gaza in ruins, with more than 66% of its buildings flattened, extensive displacement of civilians, and thousands of casualties resulting from relentless bombings.

Analyzing the Destruction



analysis of satellite images capturing the destruction within ularly concerning, as it leads to soil erosion and adversely the 365 square kilometers of Gaza. Comparing images from September 2024 to those taken before the invasion, the report revealed a staggering toll: 52,564 structures completely destroyed, 18,913 severely damaged, 56,710 moderately damaged, and 35,591 possibly damaged. In total, this amounts to 163,778 impacted structures, illustrating the magnitude of the devastation.

Open-source satellite imagery has also highlighted significant changes, particularly in northern Gaza near the Jabalia refugee camp, which has been a focal point of conflict since its establishment in 1948. Analysts reviewed four images three captured post-invasion and one from 2022—to gauge changes in the urban landscape and agricultural areas.

Visual Evidence of Change



A satellite image taken on September 26, 2024, shows a nearly barren landscape, stripped of vegetation after extensive bombing campaigns. In stark contrast, an image from December 16, 2022, reveals a vibrant area filled with buildings ongoing violence.

Many families have fled southward to escape the violence, Israel has asserted that the conflict's gravity has shifted often moving their belongings on bullock carts, cars, and trucks amidst ongoing air strikes and ground assaults. 

India Advances Deep-Sea Mining With Varaha-3, Collecting Key **Polymetallic Nodules**



The National Institute of Ocean Technology (NIOT) has launched exploratory trials in the Andaman Sea using the Varaha-3, a specialized seabed mining machine. Conducted at a depth of 1,193 meters, these trials are part of India's broader initiative to explore and responsibly harness ocean resources. The Geological Survey of India had previously surveyed the trial sites, identifying them as potential hotspots for valuable mineral resources, particularly polymetallic nodules.

During the trials, Varaha-3 successfully collected polymetallic nodules ranging from 60 to 120 mm in size. These nodules are rich in essential metals such as nickel, cobalt, and copper, which are vital for various industries, especially those focused on renewable energy and electric vehicle production. This successful collection marks a significant advancement in India's capabilities for deep-sea min-

The design of Varaha-3 emphasizes efficiency and minimizes environmental impact, aligning with India's commitment to sustainable ocean

resource management. As part of the Deep Ocean Mission, the Indian government has invested heavily in developing advanced technology for deep-sea exploration. This initiative includes an integrated mining system designed to enhance the efficiency of nodule extraction and transportation while safeguarding marine ecosys-

Indian Army Recovers Huge Cache Of Weapons, Ammunition From Manipur

In a coordinated operation involving the Indian Army, Assam Rifles, Manipur Police, and other security forces, 18 weapons, ammunition, and warlike stores were successfully recovered in Manipur from October 4 to October 6. This initiative reflects the ongoing efforts to enhance security in the region.

The operation commenced on October 4 when the Assam Rifles and Manipur Police executed a joint search in the Khengmol area of Churachandpur district. Their efforts led to the recovery of a 9 mm pistol, five single-barrel rifles, and five improvised heavy mortars, showcasing the effectiveness of their collaboration.

On October 5, based on specific intelligence regarding insurgent activities in the Kakching district, the Indian Army, Assam Rifles, and Manipur Police conducted a thorough search in the Turulmamai area. This operation yielded three carbine machine guns, a 9 mm pistol, two single-barrel rifles, hand grenades, and additional warlike materials, further contributing to the security efforts in the region.



The following day, October 6, another intelligence-based operation in Singtom village of Kakching district resulted in the recovery of a sten machine carbine, a 9 mm country-made pistol, grenades, ammunition, and other military supplies, highlighting the sustained focus on neutralizing insurgent threats.

In Thoubal district, a joint operation on October 5 led by the Assam Rifles and Manipur Police in Chingkham

Ching resulted in the recovery of a carbine machine gun, a 32 mm pistol, grenades, and ammunition. This reflects the comprehensive approach taken by the security forces to secure the area.

Additionally, during an area domination patrol in Thamlapokpi village of Tegnoupal district on October 6, a team from the Indian Army recovered a grenade and more warlike stores.

Violence-affected people returning to native places: Manipur CM

Manipur Chief Minister N Biren Singh announced on Monday that residents affected by recent violence are beginning to return to their homes, emphasizing the importance of healing rather than assigning blame. Speaking during an event for youth who completed a hospitality training program under the Centre's 'Hunar Se Rozgar Tak' initiative, Singh highlighted the hardships faced by the state's residents due to the ongoing

"The people of Manipur have endured

significant challenges, but with God's blessing, those affected are starting to return to their original places," Singh remarked. He stressed the necessity of fostering peace and resolving issues through non-violent means, urging the public to steer clear of further violence.

The Chief Minister also noted the government's ongoing efforts to assist the youth, stating that approximately 400 young individuals have either completed or are currently undergoing training under the tourism ministry's scheme, with 169 already securing placements in various cities. Among those trained are 78 individuals who were displaced due to the recent unrest.

Singh elaborated on a specific training program in perfumery, attended by 30 youths, including 15 who had been displaced. "We will prioritize selecting 2,000 trainees, especially those residing in relief camps," he stated, highlighting the government's commitment to supporting those most affected.

Delhi CM Atishi To Repair 89 Damaged **Roads Before Assembly Elections**

Delhi Chief Minister Atishi announced on Monday that the Aam Aadmi Party (AAP) government will resume various public works, including road repairs, that were reportedly stalled by the BJP while AAP chief Arvind Kejriwal was incarcerated. At a press conference, Atishi stated that her government aims to repair damaged roads ahead of the assembly elections scheduled for early next year.

To kick off this initiative, the government has identified 89 damaged Public Works Department (PWD) roads that require strengthening. Atishi revealed that 74 tenders have already been floated to expedite the repair process.

During the press conference, Kejriwal also spoke, expressing his frustration with the BJP's actions while he was in jail. He stated, "When I was in jail, these people (BJP) stalled various works of the Delhi government. After I returned, I and Atishi inspected the roads and saw they were not in good condition. I wrote to her and requested that Atishi ji get these roads maintained with immediate effect."

Atishi further elaborated on the repair works, mentioning that a total of 6,671 potholes had



been identified during a series of inspections. Of these, 3,454 patches have already been filled, showcasing the government's commitment to improving road conditions in the capital.

The decision to restart these works comes as part of AAP's broader strategy to demonstrate their responsiveness to public infrastructure needs and to address any grievances stemming from stalled projects. As the elections approach, these efforts may be seen as critical in reinforcing AAP's governance credentials among voters

Will Implement NRC In Jharkhand: **Union Minister Shivraj Chouhan**

As political tensions escalate in Jharkhand ahead of upcoming elections, Union Minister Shivraj Singh Chouhan, the BJP's in-charge for the state, announced on Monday the party's intention to implement the National Register of Citizens (NRC). He criticized the Chief Minister Hemant Soren-led government for allegedly favoring infiltrators and compromising the state's demographic integrity.

During a statement to ANI, Chouhan stressed the BJP's commitment to safeguarding the interests of local residents, emphasizing the mantra of "Roti, Mati aur Beti." He pointed out that the tribal population in the Santhal region has dramatically decreased from over 44% to 28%, attributing this change to the influx of Bangladeshi infiltrators.

Chouhan accused Soren's government of engaging in vote bank politics by supporting these infiltrators, stating, "We will implement the NRC in Jharkhand, ensuring that local residents are registered while intruders are identified and removed."

On October 5, the BJP unveiled its election manifesto, titled 'Paanch Prana,' which focuses on



youth and women's welfare in Jharkhand. The manifesto outlines five key promises: Yuva Sathi, Gogo Didi Yojana, Ghar Saakar, Laxmi Johar, and 'Assured Employment.'

The Gogo Didi Yojana pledges monthly financial assistance of ₹2,100 to women, while the 'Assured Employment' initiative commits to creating 5 lakh jobs over five years. The Ghar Saakar promise aims to provide housing for all, and the Yuva Sathi scheme offers ₹2,000 to youth preparing for competitive exams. 

"God save the Tsar!" was among the first public birthday wishes for President Vladimir Putin, who turned 72 on Monday. The greeting, posted by ultra-nationalist ideologue Alexander Dugin on his Telegram channel just after midnight, reflects the fervent support Putin continues to receive from some factions within Russia.

Dugin, known for his advocacy of a vast new Russian empire that includes Ukraine, has been a controversial figure in Russian politics. His daughter was killed in a suspected car bomb in 2022, a tragedy that has further fueled his radical views. Putin, who ordered the invasion of Ukraine in 2022, recently celebrated a record victory in a post-Soviet election, securing a new six-year term that could make him Russia's longest-serving leader in over 200 years.

Nobel Prize in Physiology or Medicine 2024 Awarded to MicroRNA Researchers

The 2024 Nobel Prize in Physiology or Medicine has been awarded to American scientists Victor Ambros and Gary Ruvkun for their pioneering research on microRNA, which has significantly advanced our understanding of gene regulation and the complexity of life.

Their discoveries elucidate how microRNAs control gene expression, enabling the differentiation of various cell types within organisms, including humans. Despite all human cells sharing the same genetic blueprint, microRNAs play a crucial role in determining how these cells develop into distinct forms and functions, from nerve cells to liver cells.

The Nobel Assembly at Sweden's Karolinska Institute announced that the



prize is part of a fund worth 11 million Swedish kronor (approximately £810,000).

Ambros and Ruvkun were the first to identify microRNAs and reveal their essential role in gene regulation for multicellular organisms. Their research demonfor over 1,000 microRNAs, which are critical for the development of complex life forms. Abnormal microRNA regulation is linked to various health issues, including cancer and congenital disorders such as hearing loss.

strated that the human genome codes The researchers conducted their groundbreaking work using the nematode worm *C. elegans*, investigating a mutant strain that failed to develop certain cell types. They discovered that microRNAs were vital for the worm's proper development by inhibiting spe-

cific messenger RNAs (mRNAs), thereby preventing certain genes from being expressed.

Prof. Janosch Heller from Dublin City University expressed his delight at the recognition, noting that their work has paved the way for innovative therapies for diseases like epilepsy and has illuminated the intricate mechanisms controlling cellular processes.

This year's award adds to the illustrious history of Nobel laureates in the field of physiology and medicine, following previous winners such as Katalin Kariko and Drew Weissman in 2023 for their work on mRNA technology, and Svante Paabo in 2022 for his contributions to human evolu-





posed by such surveillance balloons. In light of these developments, the IAF has formulated tactics, techniques, and procedures (TTPs) aimed at addressing similar contingencies.

The successful interception involved a Rafale jet based in Hasimara, West Bengal, which utilized an onboard missile to take down the target. While the specific target was smaller than the one that caused international concern in the U.S., its downing highlights the IAF's capability to neutralize airborne threats effectively. Largest Brain Map Unveils 140,000 Neurons in Fruit Fly

Ccientists have unveiled the most **S**comprehensive map of a fruit fly's brain to date, detailing nearly 140,000 neurons and an astonishing 54.5 million synapses. This groundbreaking achievement is the result of over four years of dedicated work by a research team led by neuroscientists Mala Murthy and Sebastian Seung at Princeton University. The map, termed a 'connectome,' represents the most complete brain diagram produced for any organism so far.

The project utilized advanced electron microscopy images to meticulously reconstruct the fly's brain. While AI-as-

sisted tools were employed to help compile the vast amounts of data, many segments necessitated manual review. In total, the research team and volunteers made over three million manual edits to ensure the map's accuracy. This meticulous process revealed 8,453 distinct neuron types, of which 4,581 were previously unknown to sci-

Among the surprising findings, researchers discovered intriguing details about the interconnections between neurons. They observed that neurons typically involved in sensory processing—particularly visual circuits—often connect to neurons responsible for other senses, including hearing and touch. This discovery underscores the complex integration of sensory information within the fruit fly's brain.

The data derived from this extensive mapping



has already been applied to simulate fruit fly behavior in virtual models. In one experiment, the simulation demonstrated how neurons responsible for detecting sweet or bitter tastes activated motor neurons that control the fly's proboscis. Remarkably, when tested on live flies, the virtual model was more than 90% accurate in predicting neuronal responses and subsequent behaviors.

Although the current map is based on a single female fruit fly, it offers valuable insights into brain function and structure. The research team plans to expand the project to include male flies and explore additional behaviors, such as singing. However, despite these advancements, researchers acknowledge that much remains to be discovered regarding the chemical and electrical communication between neurons, paving the way for future investigations in the field.



Each of the ten IPL franchises is permitted to retain up to six players from their IPL 2024 squad, which includes a maximum of five capped players and two uncapped players.

Former India cricketer Ajay Jadeja expressed confidence that Dhoni will be among those retained. He stated, "MS Dhoni for sure. There's no doubt about that, especially because he's now an uncapped player. His value is unquestioned." Jadeja also emphasized the importance of retain-



ing Ruturaj Gaikwad, the team's current captain, and all-rounder Ravindra Jadeja.

Ex-India batter Aakash Chopra added that CSK's Right to Match (RTM) card could prove advantageous for the franchise. "I don't think they'll retain five players. They might go for 3-4. Ruturaj Gaikwad and Ravindra Jadeja are crucial," he said.

Chopra suggested that if players like Shivam Dube are sold in the auction, their prices could exceed INR 10-11 crores, making the RTM card essential for CSK's strat-

The AFC stated, "The matter will now be referred to the relevant AFC Committee(s) for their decision(s)," indicating that further actions might be taken regarding the withdrawal.

According to Article 5.2 of the AFC Champions In their previous match in Group A, Mohun League 2 2024/25 Competition Regulations, Bagan had played to a goalless draw against Tajikistan's FC Ravshan. The decision to withdraw underscores the club's commitment to player welfare, as they have also communicated their concerns to the Indian Ministry of External Affairs, which has advised caution when traveling to regions like Iran and Israel.


