TPN, Vikarabad: The Telangana government has taken the recent attack on the Vikarabad District Collector, who was conducting a public opinion survey on an industrial corridor in Lagacharla, Polepalli of Dudyala mandal, very seriously. DGP Jitender has been directed to submit a comprehensive report on the incident.

ADG Mahesh Bhagwat has been tasked with reviewing the law and order situation in the area and preparing the report. This report is expected to play a crucial role in determining the government's subsequent actions, as strict measures against those responsible are anticipated.

**TPN**, **Hyderabad**: In response to the recent leaders of the BRS party, accusing them attack on the Vikarabad District Collector, IT and Industries Minister D. Sridhar Babu issued a stern warning. Speaking at the CLP media point on Tuesday, Minister Sridhar Babu emphasized the gravity of the incident and assured that the investigation would soon uncover those responsible for planning the attack 10 days prior.

He assured the public that the government has already launched an inquiry to determine the masterminds behind the incident.

#### **Criticism of BRS Leaders**



TPN , Hyderabad : BRS working president K.T. Rama Rao has accused the Congress government in Telangana of misappropriating approximately Rs. 300 crore from state funds to finance its campaign for the upcoming Maharashtra elections. Speaking to media representatives in Delhi, KTR alleged that these funds were used for advertisements in Maharashangana's achievements.

KTR criticized the Congress for having funds to promote false narratives in Maharashtra while failing to implement its own election promises in Telangana. "Rahul Gandhi is spreading lies, claiming that Congress schemes have been executed in Telangana when, in reality, they remain unfultra newspapers, showcasing filled," he said. According to him, the Congress claims to prioritize welfare but diverts state funds for election campaigns elsewhere.

#### **BJP and BRS Criticized**

Sridhar Babu also commented on the political dynamics, accusing BRS of conspiring alongside BJP, claiming that BJP-governed states acted as "ATMs" for their party. He criticized former Chief Minister KCR for the financial crisis created during his tenure and predicted a Congress victory in the upcoming Jharkhand and Maharashtra assembly elections.

#### **Support for Government Employees**

The minister expressed his dismay at the attack in Lagacharla village and questioned the failure of authorities in preventing it. Following a meeting with the Collector, SP, and IG, Sridhar Babu ordered the police to take strict action. He condemned any form of violence against government employees and stressed that such incidents discouraged officials from carrying out their duties, ultimately harming the public. He urged democratic forms of protest, warning that taking the law into one's hands would not be tolerated.



TPN, Rajanna-Sircilla: Former Minister and Siddipet MLA T. Harish Rao on Tuesday challenged Chief Minister Revanth Reddy to a debate on the various issues impacting Telangana over the past 11 months under Congress rule. Responding to Reddy's assertion that the people of Telangana had lost nothing, Harish Rao invited the CM for a debate on topics such

as farmers' challenges, public debt, healthcare, drinking water, irrigation, power supply, education, and law and order.

Harish Rao Challenges Revanth Reddy to Debate

Speaking after visiting the Sri Rajarajeshwara Swamy temple in Vemulawada, Harish Rao emphasized that all sections of society had suffered under the Congress government. He argued that the state, which had once topped national charts in per capita income, power generation, and other key sectors during former CM K. Chandrashekhar Rao's BRS administration, had lost its leading position.

Harish Rao criticized Revanth Reddy for failing to fulfill his promise of waiving crop loans by August, noting that many farmers' loans remained unpaid. He highlighted the worsening conditions in state-run Gurukuls, where 36 student deaths had occurred, pointing to protests in Nagarkurnool as evidence of neglect.

He further accused the Congress government of neglecting initiatives like \*Rythu Bandhu\*, which supported farmers even during the COVID-19 pandemic, and failing to launch the promised \*Rythu Bharosa\* program. Weavers, who previously benefited from government contracts, faced renewed economic distress and suicides. Rao added that the unemployed, Dalits, shepherds, fishermen, government employees, and journalists had all lost essential support and rights, while law and order had deteriorated.

Harish Rao concluded by asserting that CM Revanth Reddy lacked the moral authority to criticize K. Chandrashekhar Rao, who had significantly advanced Telangana during his tenure.

Meanwhile, the police have registered four cases against BRS leaders and others linked to the incident. Investigations revealed that Suresh, a key follower of Patnam Narender Reddy, incited the crowd to attack. Suresh was reportedly in frequent contact with Reddy and even spoke to BRS working president K.T. Rama Rao before the incident.

Suresh, who has a history of criminal cases, including a rape accusation, allegedly benefited from Reddy's influence to dismiss past charges. The police are actively working to bring all details to light and ensure accountability.

He called on the Election Commission of India to intensify efforts to curb the flow of illicit funds between Telangana and Maharashtra, urging voters in Maharashtra to scrutinize Congress' claims and verify them with Telangana residents. Referring to Congress President Mallikarjun Kharge's remarks on MLA defection, KTR accused the Congress of initiating political horse-trading. "Congress is crying about MLAs being bought like goats, but they are the architects of defection," he said, claiming that the Congress government in Telangana lured around 10 opposition MLAs, un dermining democratic integrity.



### 20 Arrested in **Collector Attack Case**

**TPN**, **Vikarabad**: In connection with the recent attack on the Vikarabad District Collector, IG Satyanarayana has announced significant developments. The incid ent, which involved an assault with sticks and stones, is now believed to be part of a larger conspiracy.

According to IG Satyanarayana, the attack occurred when the Collector visited the village as part of ongoing land acquisition efforts. BRS leader Suresh, who is suspected of orchestrating the visit, remains at large. The police, determined to leave no stone unturned, have registered three non-bailable cases related to the incident and arrested 20 individuals so far. Investigations are underway, including a detailed analysis of Suresh's call records.

Satyanarayana emphasized the commitment of the police department to hold all perpetrators accountable and warned of strict action against any provocative content shared on social media. Authorities are intensifying efforts to locate Suresh and expect to release further details soon. The IG stressed that no one involved will be spared and reiterated the department's dedication to ensuring justice and maintaining law and order.

## **Revanth Reddy Challenges Congress to Change Strategy**



**TPN**, **Telangana**: In a recent appearance at the Indian Express Adda program, Telangana Chief Minister Revanth Reddy made significant remarks about the political landscape, particularly targeting the BJP and its strategies. He highlighted the electoral success of the BJP, claiming their victory in 240 seats, while Congress surged from 40 to 100 seats. However, Reddy pointed out that the defeat wasn't just a setback for the

the Congress party's approach, noting that while the BJP operates with a "business mode" of politics, Congress must adapt to the fast-paced "20-20 format" rather than the slow "Test match" style. He emphasized that Congress, with its focus on human welfare, should align itself to current political realities, making a more dynamic and responsive shift in their strategies to fight the BJP effectively.

KTR also targeted Revenue Minister Ponguleti Srinivas Reddy, alleging misuse of his position by awarding government contracts to his son's company, Raghava Constructions. He questioned the BJP's silence regarding Enforcement Directorate (ED) raids on ministerial properties. "Why are BJP and ED silent? What deals are being made behind closed doors?" he asked. On Ponguleti's threats of arresting him, KTR responded boldly, saying he was prepared to face any inquiry. "File any case, deploy any agency—I am ready to face it. Can Ponguleti and Revanth Reddy say the same?" he challenged.

Addressing unrest in Kodangal, KTR accused Chief Minister Revanth Reddy of forcibly acquiring land for his son-in-law's pharma company, which sparked protests. He denied any involvement in arresting villagers and reiterated that the allegations were politically motivated.

## **Minister Rajanarsimha's Directives to Drug Control Officers**

TPN , Hyderabad : Minister Damodara Rajanarsimha held a key review meeting with officials from the Drug Control Authority (DCA) and TGMSIDC, emphasizing the urgent need for stricter measures against counterfeit and substandard medicine production and sales. He instructed officials to conduct extensive inspections of pharmaceutical industries, drug manufacturing units, medical stores, and pharmacies.

Rajanarsimha highlighted the necessity for additional drug inspectors in areas with high numbers of pharma establishments and called for more drug testing laborato-

ries to meet the growing number of medical shops. Currently, there are 71 drug inspectors, but DCA officials indicated the need for at least 150 more. The minister assured that he would discuss the matter with the Chief Minister to secure the necessary posts.

He also stressed that efforts should be made to curb the sale of intoxicating drugs and urged DCA to support TGMSIDC in procuring quality medicines for government dispensaries. Rajanarsimha reiterated that providing high-quality medicine to patients in government hospitals is a top priority.

This development comes as arguments in the case concluded recently, although the exact date of the verdict is yet to be announced.

The disqualification petitions have been under discussion for the past few days, with extensive arguments presented before the High Court. Previously, a single bench had issued a directive to set a timeline for deciding on the disqualification of the MLAs. However, the Assembly Secretary challenged this decision before a division bench.

With the verdict pending, the defecting MLAs face significant uncertainty. Reports indicate that they are anxious about the outcome and whether it will

# Etala Rajender Slams Land Acquisition in Kodangal

TPN ,Telangana : MP from Delhi, Etala Rajender, strongly condemned the arrests of individuals in Lagicharla village and warned the Telangana government against filing illegal cases. Speaking out against the government's attempt to acquire land for a pharmaceutical project in Kodangal constituency, Rajender emphasized that the land should be acquired with the consent of the farmers, not through coercion. He criticized the government's actions, calling it an attempt to act as a "broker" between pharma companies and farmers, an approach he labeled unjust.

Rajender highlighted the strong opposition from local farmers who have been protesting the acquisition of their land for the pharma company. Despite these protests, including dharnas and boycotts of gram sabhas led by MP DK Aruna, the



government arranged a meeting for land acquisition, further fueling anger among the farmers.

The BJP leader also condemned the government's decision to block internet access and deploy heavy police presence in the area to control the protests. He warned the government that such actions would not go unnoticed and stated that the entire Telangana community would revolt if the cases against the farmers continued. He criticized Revanth Reddy for opposing similar land acquisitions in the past, accusing him of now attempting to grab the farmers' land for his own political gain.

Rajender called for the allocation of government land for the pharmaceutical project, urging the government not to take private lands from farmers. He pledged to support the people in their fight for justice and demanded that the government stop its unjust practices.

Mallu Ravi Accuses BRS of Plotting Collector **Attack in Kodangal** 



TPN, Telangana : Nagar Kurnool MP Mallu Ravi has accused BRS leaders of orchestrating an attack on the Vikarabad Collector under the guise of farmers protesting land acquisition in Kodangal. Ravi claimed that the attack was a deliberate conspiracy by BRS to disrupt the functioning of the people's government. He emphasized that the attack was pre-planned, with evidence showing that BRS leaders, particularly a former MLA, were involved in provoking the incident.

Ravi stated that the collector, who had gone to meet the villagers

regarding land acquisition, was attacked after receiving continuous instructions from the defeated MLA. He stressed that the

attack was not directed at Chief Minister Revanth Reddy, but was an assault on the rule of law and democratic governance.

### Satyavati **Criticizes CM's Decision on Pharma** Companies



TPN, Telangana : Former Minister and MLC Satyavati Rathore has strongly criticized the Telangana government's decision to set up pharmaceutical companies in green crop fields in Lagacharla village, Vikarabad, amidst growing protests from tribal farmers. Rathore demanded the withdrawal of the decision, calling it harmful to the livelihood of the farmers and detrimental to the environment.

Describing the incident where tribal farmers attacked officials as unfortunate, Rathore blamed the current administration for its anti-public policies. She accused the Chief Minister of incompetence, likening his rule to "a stone in the hands of a madman," due to the failure of governance and public service.

## **Minister Ponnam Comments on KTR's Arrest**

TPN , Telangana : Minister Ponnam Prabhakar has stated that the law will take its course regarding the potential arrest of KTR, dismissing any comparison to BJP's Bandisanjay. Prabhakar further pointed out the political alliances between BJP and BRS in Delhi, accusing them of engaging in "wrestling in the lanes" while neglecting key issues affecting farmers.

He stressed the need for prompt action on farmers' grievances, particularly concerning grain procurement. Prabhakar criticized the lack of proper allocation of grain to rice millers with pending dues and highlighted the difficulties faced by cotton farmers. He called on the central government to ensure that cotton farmers receive support without any hindrances, urging both state and central authorities to collaborate to ease farmers' hardships.

The Minister also commented on the government's initiative to

purchase 600 buses through women's associations and emphasized the state's efforts to foster women entrepreneurship. Prabhakar reiterated that farmers should not be ignored and expressed concern over the government's handling of agricultural procurement.

## **Jagadish Reddy Criticizes Revanth Reddy's Leadership**

The MP further criticized the BRS for resorting to violence and

# **CPI Accuses BJP, BRS of Inciting Unrest to Target Revanth**

TPN, Telangana : CPI leader Koonanneni Sambasiva Rao has accused BJP and BRS of conspiring to destabilize the Revanth Reddy government by manipulating the poor. Speaking at a media conference alongside senior CPI leader Narayana, Sambasiva Rao referred to two incidents that recently occurred in the Revanth Reddy constituency—one on October 25 and the second involving the attack on Vikarabad District Collector. He suggested that these incidents were part of a deliberate plan to create political unrest and target the Revanth Reddy government.

Sambasiva Rao claimed that the BJP and BRS were behind these attacks, aiming to create confusion and weaken the govern-



ment. He stressed that an investigation should be conducted to identify the masterminds of these incidents, while also pointing out that the farmers involved were only seeking justice for their land rights.

While authorities confirmed the attack, Collector Jain denied the allegations, stating that he was not assaulted. "Some mischief elements conspired and created trouble. I was not attacked or manhandled," Jain told reporters after speaking with protesting farmers in Kondagal. The protest escalated during a Gram Sabha meeting for the Pharma City project, where villagers reportedly used sticks and stones to target officials.

yanayak, sub-collector Umashankar Prasad, and KADA special officer Venkat Reddy, were targeted. While Jain and Lingyanayak escaped unharmed, Reddy sustained serious injuries. Deputy Superintendent of Police Srinivas was also injured while attempting to protect Reddy.

Following the incident, 55 individuals were detained, and authorities imposed a temporary suspension of internet services in the area. The situation remains tense as the investigation continues.

### **Onion Prices Skyrocket in Telangana**, **Causing Consumer Distress**



TPN , Hyderabad: Onion prices have surged dramatically across Telangana, causing distress among consumers. In wholesale markets, the price of onions has risen to Rs 62-65 per kilogram, depending on quality, while retail prices have soared to Rs 70-80 per kilogram, significantly higher than just a few months ago.

Traders attribute the price hike to ex-

tensive crop damage caused by heavy rains in key onion-growing regions like Karnataka and Maharashtra. "An increase of Rs 2,000 per quintal has been observed. Due to a low supply, prices will likely remain around Rs 80 until the end of November," said Sunil Kumar, a trader at the Osmangunj market.

Onions typically arrive in Hyderabad from Nashik in Maharashtra, Kurnool in Andhra Pradesh, and various parts of Karnataka. The kharif crop in these regions was severely impacted by rainfall in September, leading to reduced supply. "We are receiving about 150 truckloads daily at the Malakpet market, compared to the usual 200," an official explained.

As prices continue to rise, buyers have reduced their purchases, and hotels have scaled back their onion orders, further driving down demand.

### **Advocate Attacked** by Unidentified Persons at IMAX Road

TPN, Hyderabad: A 48-year-old advocate, A Kalyan Vamshikeer, was attacked by two unidentified persons on Tuesday morning while he was on a walk at Khairatabad IMAX Road. The incident occurred around 5:30 am when Kalyan, a resident of Khairatabad, was walking with his pet dog near the KFC joint. Two men on a scooter approached him, began arguing, and one of the suspects attacked Kalyan with a knife, injuring his hand. The other assailant stole Kalyan's mobile phone before fleeing the scene.

Upon receiving the information, Khairatabad police arrived and rushed Kalyan to a private hospital, where he is receiving treatment. A case has been registered, and investigations are underway.

Kalyan, who represents the Bajrang Dal in several cases, has received support from the Advocates Bar Council, which condemned the attack and called for a fair investigation into the incident.

### **Telangana to Celebrate Praja Vijayotsavam from Nov 14**

TPN , Hyderabad: Telangana will commemorate the first anniversary of its "People's Government" with the launch of the Praja Vijayotsavam (People's Governance Victory Festival) on November 14 in Hyderabad. The opening ceremony will coincide with Children's Day and the birth anniversary of former Prime Minister Jawaharlal Nehru.

Chief Minister K. Revanth Reddy will inaugurate an Education Day event at LB Stadium, where approximately 14,000 school students are expected to participate, according to Chief Secretary Shanti Kumari. During the event, the Chief Minister will highlight key initiatives implemented over the past year to improve education in the state. **RTC Bus Driver Steals Gold Jewellery from Passengers** TPN, Telangana: In a shocking incident, an RTC bus driver was caught stealing gold jewellery from a passenger's bag on a bus traveling from Warangal to Nizamabad. The theft occurred despite the Telangana government's Mahalakshmi scheme, which offers free travel for women, promoting RTC bus travel as a safe option.

Hyderabad: In a shocking incident, a man stabbed his wife to death and then set her body on fire at their house in Bandlaguda, near Chandrayangutta, on Monday night. The suspect, Fayaz Qureshi (25), later surrendered to the police.

According to the police, Fayaz, along with his wife Qamar Begum (23) and their two children, Hadiunnisa (5) and Junaid (3), lived in a house in Hashamabad, Bandlaguda. Authorities stated that ongoing marital issues led to frequent fights between the couple. On the night of the incident, the couple had another altercation during which Fayaz stabbed Qamar to death. He then went out, purchased fuel, doused her body with it, and set it ablaze in their bedroom.

Neighbors noticed the fire and alerted the police while attempting to extinguish the flames. Firefighters and police later found the body of the woman, with the children safely in another room.

The body was sent to Osmania General Hospital for post-mortem, and an investigation is ongoing.



TPN, Telangana: BRS leader RS Praveen Kumar has strongly criticized Telangana Chief Minister Revanth Reddy for his recent tours to Delhi, Kerala, and Maharashtra, urging him to focus on the state's pressing public issues instead. On the social media platform X, Praveen Kumar expressed concern over the deteriorating situation in Revanth Reddy's constituency, which he described as a "furnace." He accused

the CM of incompetence, vindictiveness, and irresponsible decision-making, warning that the lives of government officers were at risk due to these actions.

Praveen Kumar questioned the necessity of acquiring more land for the pharma project despite the previous BRS government already securing 19,000 acres, highlighting the growing unrest among farmers. He condemned the government for using officers as "human shields" in the controversial land acquisition process and criticized the CM for neglecting his duty to engage directly

with the affected farmers.

He further expressed sympathy for the officials attacked during the Kodangal incident and slammed the Chief Minister for failing to address the concerns of poor farmers, calling the state's situation under Congress rule "a fire pit" where issues remain unresolved.

A fellow passenger recorded a video showing the driver taking gold ornaments from a woman's bag while the bus was in transit. The incident has raised concerns among passengers, who are now calling for strict action against the driver.

This incident has been met with outrage, with many passengers expressing their disappointment that such a crime occurred under the government's initiative to ensure safety. Passengers are urging RTC officials to investigate the matter thoroughly and take appropriate measures to prevent such incidents in the future.

# **Hyderabad Police Refund Rs 2.91** Lakh to Victim of Cyber Fraud



TPN, Hyderabad: The Hyderabad police successfully facilitated the refund of Rs. 2.91 lakh to a man who fell victim to cyber fraud. The incident began when the victim received a phone call from someone posing as a representative of a private bank. The caller claimed to offer an increase in the victim's credit card limit and requested details of the card. Following this, the fraudster sent an APK file via WhatsApp, which the victim unknowingly installed on his mobile phone.

After installing the application, the victim discovered that Rs. 2.91 lakh had been debited from his account, despite not sharing his OTP. The victim immediately filed a complaint with the National Cybercrime Reporting Portal (NCRP), which identified and removed the malicious malware from his phone.

The police traced the fraudulent transactions, which had been used to make purchases on an e-commerce platform. With the assistance of NCRP, notices were issued to the relevant parties, which led to the blocking of the fraudulent transactions. Subsequently, the full amount was refunded to the victim's bank account.

### **BRS Leaders Arrested** While Heading to Lagachar to Meet Detainees

### **Paddy Arrivals** Surge in Private **Mills Across Telangana**



TPN , Hyderabad: Paddy arrivals have significantly surged in key paddy-growing districts like Nalgonda and Nizamabad. Farmers are bypassing the Civil Supplies Corporation's paddy purchase centers due to issues with moisture content and weighing, instead opting to sell directly to private rice mills, particularly parboiled mills. The parboiled mills have become more attractive to farmers due to their flexibility with moisture content and their immediate milling capabilities. Miryalaguda, now a hub for the milling industry, has over 418 mills, with a majority of the produce being supplied to states like Kerala. The mills in Miryalaguda are processing up to 3000 tractor loads of paddy daily, with that number expected to double as harvest operations in the Nagarjuna Sagar Project command area begin.

However, once paddy arrivals from the command districts increase, millers may tighten their purchasing norms, pushing farmers back to the purchase centers. Millers in Miryalaguda and Suryapet have already bought over two lakh tons of paddy, but issues such as manpower shortages and technical difficulties in mills have led to delays for some farmers. In Nizamabad, private traders are offering slightly higher prices than the MSP, helping to boost competition. Civil Supplies Commissioner D.S. Chouhan and local authorities are actively monitoring the situation.

# Why India Stands Firm Against Patent **Evergreening in Pharmaceuticals**

### How India's Patent Laws Are Shaping Access to Affordable Medicines

India's patent laws have come into focus once again as the Indian Patent Office prepares to hear objections raised by the Sankalp Rehabilitation Trust against US-based pharmaceutical company Gilead Sciences' patent claims on their HIV drug, lenacapavir. This move is part of India's ongoing struggle to curb "patent evergreening," a practice where companies extend the duration of their patents by making minor modifications to existing products, often with minimal or no therapeutic improvements.

#### What is Patent Evergreening?

Patent evergreening is a strategy employed by pharmaceutical companies to extend their monopoly on a drug beyond the initial 20-year patent period. By making small modifications to the original product—such as a new dosage, a different formulation, or a minor change in the drug's delivery method—companies can apply for new patents. This enables them to maintain market exclusivity and charge high prices even after the original patent has expired, limiting access to affordable generic versions.

Countries like India, Brazil, Thailand, and South Africa have laws preventing evergreening practices, prioritizing public health over prolonged monopolies in the pharmaceutical industry. India's approach, shaped by the Patents (Amendment) Act 2005, focuses on balancing incentives for innovation while ensuring the accessibility of essential medications.

#### Section 3(d) and Other Key Provisions of the Indian Patent Act

Section 3(d) of the Indian Patent Act Two landmark cases highlight India's



ent evergreening in India. It states that drugs cannot be patented if they result merely from discovering a new form of an already known substance, unless there is a significant enhancement in the efficacy of the new form. In other words, slight changes in a drug that do not substantially improve its effectiveness are not eligible for patent protection. Section 3(e) of the Act limits patenting combinations of known substances unless they demonstrate a synergistic effect, while Section 3(i) prevents patents on medical treatment methods.

#### **Important Legal Precedents**

Novartis AG v. Union of India (2013) and Roche v. Cipla (2012).

In Novartis AG v. Union of India (2013), the Swiss pharmaceutical giant Novartis sought to patent a new crystalline form of its anti-cancer drug, Gleevec (imatinib mesylate). Novartis argued that this crystalline form was more bioavailable, implying it had a higher efficacy. However, the Indian Supreme Court rejected the patent application, upholding the Indian Patent Office's decision. The court ruled that improved bioavailability did not amount to a substantial enhancement in efficacy as required by Section 3(d). This landmark ruling underscored India's commitment to preventing minor changes in drugs

In Roche v. Cipla (2012), Swiss-based Roche attempted to block Indian generic manufacturer Cipla from producing a lower-cost version of its cancer drug, Tarceva (erlotinib hydrochloride). Roche alleged that Cipla's version infringed on its patent. However, Cipla argued that its generic drug used a different polymorphic form of the compound, distinguishing it from Roche's patented version. The Delhi High Court ruled in favor of Cipla, holding that Cipla's generic version did not infringe Roche's patent. The court emphasized that distinct polymorphs have unique properties, setting a precedent for distinguishing generic forms from patented drugs.

#### A Continuing Battle: Johnson & Johnson's Bedaquiline Case

Last year, India's patent office rejected Johnson & Johnson's attempt to secure a secondary patent for its TB drug bedaquiline, widely used in treating drug-resistant tuberculosis. This decision was celebrated by health advocates, who argued that extending the patent would delay access to affordable generics, vital in fighting India's TB crisis. The case highlighted India's stance against secondary patents that offer little innovation beyond the original drug formulation.

#### **Current Developments: Gilead** Sciences' Lenacapavir Patent Challenge

The Indian Patent Office's decision on this case could set yet another significant precedent, further reinforcing India's efforts to curb evergreening practices.

#### The Need for Vigilant Scrutiny

While India's legal framework under the Patents Act of 1970 and subsequent amendments aims to curb patent evergreening, there are still challenges. Studies have shown that approximately 72% of pharmaceutical patents granted in India are minor or secondary, indicating that companies may still be finding ways to extend their monopolies without offering significant innovation. Experts argue that stronger scrutiny is needed, both from the patent office and public-interest groups, to prevent companies from misusing patents at the cost of public health.

India's patent law, especially Section 3(d), represents a bold approach in prioritizing public health over corporate monopolies in the pharmaceutical industry. By rejecting patent applications for minor modifications that do not improve drug efficacy, India has set an example for other developing nations in balancing innovation with accessibility. As cases like Novartis, Roche, Johnson & Johnson. and Gilead Sciences continue to unfold, India remains at the forefront of the global fight against patent evergreening, aiming to ensure that life-saving drugs remain accessible and affordable for all.

## **Innovative Energy Storage Solutions for Solar Power**



As the global community confronts the escalating climate crisis, the urgency to transition to renewable energy sources has never been greater. Among the most promising alternatives to fossil fuels is solar energy-abundant, clean, and increasingly cost-effective. However, solar power faces a significant challenge: intermittency. Unlike fossil fuels or nuclear energy, solar power generation is dependent on sunlight, which varies by time of day, season, and weather conditions. This makes it difficult to rely on solar energy as a consistent, round-the-clock power source.

To address this issue, the development of advanced energy storage technologies has become a focal point in the renewable energy sector. Energy storage systems enable the capture and storage of excess solar energy during peak sunlight hours, so it can be used when sunlight is unavailable—at night or on cloudy days. These innovations are critical in ensuring that solar power can meet the ever-growing demand for clean energy while reducing reliance on fossil fuels.

One of the most widely discussed energy storage solutions is the lithium-ion battery. These batteries have already revolutionized consumer electronics and electric vehicles, and they hold significant potential for large-scale energy storage. Their high energy density, fast charging times, and declining costs have made them a popular choice for grid-scale solar storage. However, they are not without limitations, including concerns over raw material availability, environmental impact, and the finite lifespan of batteries.

In response to these challenges, researchers and companies are exploring a range of alternative storage technologies. One promising innovation is \*\*solid-state batteries\*\*, which offer greater energy density, improved safety, and longer lifespans compared to traditional lithium-ion batteries. Another approach is \*\*flow batteries\*\*, which use liquid electrolytes to store energy, making them potentially more scalable and less prone to degradation over time.

In addition to battery-based systems, other storage methods include \*\*pumped hydro storage\*\*, which uses excess solar energy to pump water uphill to a reservoir, and \*\*compressed air energy storage\*\*, which stores energy by compressing air and releasing it to generate electricity when needed. \*\*Thermal energy storage\*\* is another intriguing option, where excess solar energy is converted into heat and stored in materials such as molten salt, then released to generate power when the sun is not shining.

### **Bangladesh's Hindu Minority Under Siege**

Since the ousting of Prime Minister Sheikh Hasina on Between August 4 and 20, more than 2,000 attacks August 5, 2024, Bangladesh's Hindu minority, which now comprises just 8% of the population, has found itself increasingly vulnerable to violence and persecution. The political vacuum left in the wake of Hasina's removal has allowed radical Islamist groups to grow in influence, while the interim government, led by Muhammad Yunus, has failed to protect the minority community.

Hindus in Bangladesh have long faced systemic discrimination and violence, but recent events have escalated the situation to alarming levels. A significant demographic shift over the decades, driven in part by forced migrations, has left the Hindu community in a precarious position, particularly as Islamic fundamentalism rises in the country. The violent mobs targeting Hindus since August 5, 2024, have sparked widespread concern and international condemnation. However, the interim government has downplayed the scale of these attacks, even labeling reports of violence as "exaggerated."

against Hindus were reported across the country, many of which occurred in the context of political unrest. These attacks have been perceived as politically motivated rather than purely communal, with the interim government taking a dismissive stance. This narrative was reinforced by the government's reluctance to intervene or provide adequate security during major Hindu events, such as the Durga Puja celebrations in October. Instead of offering protection, the government advised Hindus to limit their celebrations during Islamic prayer times, while Islamist factions openly called for an end to Durga Puja festivities.

During the festival, 35 incidents of violence were recorded, including idol vandalism, bomb attacks on pandals, and disruptions during idol immersion. Hindus were also subjected to economic pressure, with over 49 teachers reportedly forced to resign due to their perceived association with the ousted Awami League.

### Can India Create an 'AI City'? A Vision for Safe Innovation in the Age of AI

As artificial intelligence (AI) continues to evolve at a rapid pace, the potential benefits and risks are becoming increasingly clear. Recently, while watching an animated film called \*The Wild Robot\*, my teenage daughter made an insightful analogy. The movie depicted a robot raised by wild animals, adapting to the jungle in a way that reminded her of \*The Jungle Book\*, except this time, instead of Mowgli, it was a robot. This got me thinking: AI, like that robot, is being "released into the wild" without sufficient understanding of how it will adapt or affect our world. We are in a gold rush of AI innovation, but without a safety net, it feels like we're careening toward a cliff.

AI, especially in its more dangerous forms like deepfakes, poses real threats to society. Just a few days ago, a group of educated individuals in Bengaluru fell victim to deepfake scams, tricked into investing their life savings in fraudulent schemes promoted by manipulated video clips of famous entrepreneurs. Such incidents highlight how AI's ability to clone voices and faces could further undermine trust in public figures, manipulate elections, and cause personal harm. As AI becomes more sophisticated, these risks will grow, with consequences for everything from education to governance. The deepfakes surrounding the US elections, for

instance, may have already influenced public opinion, and we might not fully understand the ramifications for years to come.

Currently, the world is taking two very different approaches to AI. The US has largely allowed AI to evolve without regulation, creating a kind of "Wild Wild West" where anything goes. Meanwhile, the EU has adopted a more cautious stance, attempting to regulate AI heavily but, as a result, stifling innovation. Neither approach is ideal. While India, as a rapidly developing nation, cannot afford to miss the AI revolution, it also cannot ignore the societal risks that come with it.





# "Most Unstable Vehicle": PM Modi's Jibe At Maha Vikas Aghadi In Maharashtra Prime Minister Naren-dra Modi took a sharp

jibe at the Maha Vikas Aghadi (MVA) during a poll rally in Solapur, accusing the alliance of being unstable and embroiled in internal conflict. He compared the MVA to a vehicle with no wheels or brakes, suggesting that its members were fighting among themselves for control, thereby hindering governance. Modi emphasized that Maharashtra needed a stable government, which only the BJP-led MahaYuti could provide.

"The vehicle the MVA is traveling in has neither wheels nor brakes. There's a constant fight among them over who will drive it," Modi said, adding that the MahaYuti coalition, on the other hand, would deliver long-term policies and stability to Maharashtra. He criticized the MVA for wasting time in internal power struggles and pointed out that the alliance had failed to provide coherent leadership.

The Prime Minister also attacked the Congress for its historical governance failures. He accused the Congress of leaving unresolved issues, particularly in areas such as irrigation and farmers' welfare. "Congress ruled the country for decades but failed to solve the issues faced by the people, especially the farmers," Modi said. In contrast, he claimed the BJP government had focused on solving these problems, citing improvements in Solapur's water table due to their efforts.

## "When His House Burned...": Yogi Adityanath's History **Reminder To M Kharge**

As the Maharashtra As-sembly election campaign enters its final stretch, political tensions between Uttar Pradesh Chief Minister Yogi Adityanath and Congress President Mallikarjun Kharge have reached a boiling point. ### **Odisha Chief Minister Warns Employees Against Influencing Transfers and Postings**

The Odisha government has issued a stern warning to its employees, cautioning them against attempting to influence their transfers or postings. In a directive released on Monday, Chief Secretary Manoj Ahuja reminded all secretaries and collectors that exerting any form of "extraneous influence" to affect such decisions would constitute a violation of the state's conduct rules.

The warning refers specifically to Rule 23 of the Odisha Government Servants' Conduct Rules, 1959. The rule clearly prohibits government employees from trying to use official or unofficial channels to influence their appointments, promotions, pay, or any other service-related matters. The directive highlights that employees must adhere to the established



procedures and avoid any actions that could be seen as seeking personal advantage through external pressures.

"The attempt to influence postings or transfers through any form of pressure is a direct contravention of the state's conduct rules," Ahuja's note stated. The move comes amid growing concerns about favoritism and manipulation within the state's bureaucratic system. The government has emphasized that any employee found guilty of violating this rule would face strict disciplinary actions.

This warning is part of Odisha's ongoing efforts to maintain transparency and integrity within its administrative processes. By issuing this directive, the state government aims to send a clear message that it is committed to upholding ethical standards and ensuring that transfers and postings are made based on merit and the needs of public service.

In recent years, the issue of political and unofficial influence in government postings has been a topic of discussion in several Indian states, with various administrations taking steps to curb such practices. The Odisha government's action aligns with broader efforts across the country to create a more professional and accountable civil service.

### **India Urges Reform of UN Security Council, Criticizes Stagnation Since 1965**

Tndia's Permanent Representa-Live to the United Nations (UN), Parvathaneni Harish, called for urgent reform of the UN Security Council (UNSC) during a speech at the General Assembly on Monday. He expressed disappointment over the lack of meaningful progress on the issue, despite decades of discussion. Harish highlighted that the last expansion of the UNSC occurred in 1965, when only non-permanent seats were added, leaving the structure largely unchanged since then.

Addressing the Plenary Meeting in New York, Harish stated, "As we begin this year's deliberations, the reform of the UNSC has once again been identified as a critical and immediate priority at the summit of the future discussions by our leaders. However, despite several decades of reiterating this sentiment, it is disheartening that there have been no results to show since 1965."



He pointed to three main challenges preventing reform: the ineffective intergovernmental negotiation process, resistance from some countries advocating for consensus, and the lack of adequate representation for the Global South.

Harish emphasized that the current intergovernmental negotiations (IGN), which have been ongoing for 16 years, have failed to produce any substantial outcomes. "The IGN remains largely confined to exchanging statements, with no negotiating text, timeline, or defined end goal," he noted. He also criticized the insistence on consensus by a few countries, which has hindered progress, stating that the approach of agreeing on everything before even starting negotiations is a flawed one.

Furthermore, Harish, speaking from India's position as a member of the Global South, underscored the importance of fair representation within the UNSC. He argued that without proper representation of the Global South, the legitimacy and effectiveness of the Council, and by extension, the United Nations, are compromised. He also pointed out that newer multilateral frameworks have demonstrated greater flexibility and adaptability, something the UN system must learn to emulate.





# Saudi Crown Prince Condemns Israel's **Actions in Gaza as 'Genocide'**

Saudi Crown Prince Mohammed bin Salman has strongly condemned Israel's military actions in Gaza, calling them a "genocide" in one of the harshest public critiques of Israel by the Saudi leadership. Speaking at a summit of Muslim and Arab leaders, the Crown Prince condemned Israel's ongoing offensive in Gaza, as well as its strikes on Lebanon and Iran. He issued a stern warning to Israel, urging it not to escalate its attacks on Iranian territory.

The remarks came as tensions in the region continue to escalate, with the Crown Prince joining other leaders in calling for a complete Israeli withdrawal from both the West Bank and Gaza. The Saudi leader's comments are seen as part of a broader effort by the Kingdom to position itself as a champion of Palestinian rights and a critic of Israeli military actions.

Israel, for its part, has consistently denied the accusation of genocide, insisting that its military operations are targeted at Hamas, the Palestinian militant group. This international backlash against Israel's actions is growing, with the US and the UK expressing concern over restrictions on humanitarian aid to Gaza. Saudi Arabia's foreign minister, Prince Faisal bin Farhan Al-Saud, also condemned the global community's failure to end the conflict, pointing to the widespread starvation in Gaza as a result of Israel's blockade and military operations.

The condemnation of Israel's actions signals Saudi Arabia's increasing frustration with the situation in Gaza and highlights its growing influence in the Middle East as a vocal advocate for Palestinian rights.

### **Bangladesh Prosecutor** Seeks Interpol Red Notice for Sheikh Hasina and Aides

Md Tajul Islam, the Chief Prosecutor of the Bangladesh International Crimes Tribunal (ICT), has formally requested the Inspector General of Police (IGP), Md Moinul Islam, to initiate proceedings for issuing a red notice against the country's former Prime Minister Sheikh Hasina and her close associates. This move

is part of an ongoing legal and political battle in Bangladesh, related to war crimes charges and the alleged involvement of Hasina's administration in crimes committed during the 1971 Bangladesh Liberation War.

In his letter to the IGP, Prosecutor Tajul Islam has emphasized the need for international cooperation in bringing these individuals to justice. A red notice from Interpol would formally request the arrest of Sheikh Hasina and her associates in foreign countries, facilitating their extradition to Bangladesh to face trial for the alleged crimes.





### **Trump Pushes for Recess Appointments to Speed Up Administration Formation**

As the Republican Party prepares for a new administration under President-elect Donald Trump, the incoming president has made a bold demand to future Senate leadership: allow him to appoint key officials without the traditional Senate confirmation hearings. Trump's push centers on the use of "recess appointments," a mechanism that permits the president to make temporary appointments while the Senate is in recess, sidestepping the usual confirmation process.

This demand highlights Trump's desire to rapidly build his administration, minimizing potential delays from a divided Congress. By using recess appointments, Trump aims to streamline the process and swiftly fill key positions without waiting for the extended and often contentious Senate confirmation process. This could be particularly important as he looks to implement his agenda quickly in the early months of his presidency.

Trump's insistence on leveraging the recess appointment power underscores his influence over the Republican Party's Senate leadership, following his election victory. The ability to appoint without confirmation hearings would allow him to solidify his team in the face of potential opposition within the Senate, especially given the contentious and polarized political environment.

Recess appointments, while constitutional, have historically been a subject of controversy, with critics arguing that they undermine the Senate's role in providing checks and balances. However, Trump appears determined to avoid the gridlock that often characterizes Senate hearings, particularly as he moves forward with key legislative priorities and the formation of his administration.

Sheikh Hasina, currently serving as Bangladesh's Prime Minister, has long been a controversial figure in the country's politics.

Waltz, 50, is a Green Beret veteran who served in the U.S. Army's elite special forces. Since his election to Congress in 2019, Waltz has become known for his strong foreign policy stances, including criticism of President Joe Biden's handling of Afghanistan and his calls for stronger U.S. support for Ukraine. As a member of the House Armed Services, Foreign Affairs, and Intelligence Committees, Waltz has consistently advocated for a more assertive U.S. military presence, particularly in the Indo-Pacific region, where he has raised concerns about the military's readiness for potential conflicts, especially with China.

While Trump's foreign policy has often been characterized by a more isolationist stance, Waltz has been a vocal proponent of NATO and has supported the Trump administration's push to get NATO allies to increase their defense spending. ## **Israel Opens New Humanitarian Aid Crossing into Gaza Ahead of US Deadline**



Israel's army announced the opening of a new humanitarian aid crossing into Gaza on Tuesday, in a move aimed at addressing the worsening humanitarian crisis in the region. The new "Kissufim" crossing is part of Israel's efforts to increase the volume and routes of aid entering Gaza, with a focus on delivering critical supplies such as food, water, medical resources, and shelter equipment to the central and southern parts of the territory.

The opening of the crossing follows a joint statement by the Israeli Defense Forces (IDF) and COGAT, the Israeli defense ministry agency overseeing civilian affairs in Pal-

estinian territories. The statement emphasized that the operation was conducted in compliance with international law, with coordination between the IDF, COGAT, and the defense ministry to ensure that aid reaches those in need.

This move comes on the eve of a US-imposed deadline, where Washington had warned Israel to improve the delivery of humanitarian aid to Gaza. US Secretary of State Antony Blinken and Defense Secretary Lloyd Austin had earlier made it clear that Israel had until November 13 to address the situation or risk facing consequences, including a potential reduction in military

assistance from the United States, Israel's key ally.

The United States has been pressing Israel to enhance its humanitarian efforts while also calling for increased protection of Palestinian civilians amid the ongoing conflict with Hamas. Although President Joe Biden had repeatedly called on Israel to do more for Gaza, his administration had refrained from taking more drastic actions, such as cutting military aid. In contrast, President-elect Donald Trump has indicated a more lenient stance towards Israel, promising to provide Israel with more freedom to operate in the region.



## India's retail inflation hits 14-month high at 6.21% in October

Tndia's retail inflation ■ surged to 6.21% in October 2024, up from 5.49% in the previous month, primarily driven by rising food prices, according to official data released on Tuesday. This marked the highest inflation rate in 14 months, surpassing the Reserve Bank of India's (RBI) upper tolerance limit of 6%. In comparison, the Consumer Price Index (CPI)-based inflation stood at 4.87% in October 2023.

market sentiment. "The lack of concrete fiscal stimulus measures in China, as well as the ongoing deflationary risks, are weighing on investors' outlook for the global oil market," Wong said.

On the supply side, there are growing concerns about U.S. shale oil production. The "Trump Trade" narrative is expected to shift focus toward the U.S. becoming a dominant supplier of shale gas, especially with North Dakota Governor Doug Burgum—a pro-oil drilling advocate—on the shortlist for Energy Secretary in a potential second Trump administration. This prospect adds to concerns that the U.S. will ramp up oil production, further contributing to oversupply in the global market.

The significant increase in inflation was attributed to a sharp rise in food prices,

which continues to put pressure on household budgets. While specific categories like vegetables, cereals, and pulses saw the most notable increases, experts are concerned that the persistently high inflation rate could further strain consumer spending and impact overall economic growth.

The surge in inflation comes at a time when the RBI has been closely monitoring price pressures, with expectations that it may take further action to curb inflationary trends. The central bank's target range for inflation is between 2% and 6%, with anything above the upper limit typically signaling potential intervention.

In another piece of data released on Tuesday, India's Index of Industrial Production (IIP) showed signs of recovery, expanding by 3% in September 2024. This was a marked improvement from the contraction of 0.1% seen in August 2024, suggesting that industrial activity is picking up. The growth in industrial production was driven by a rebound in manufacturing and mining sectors, providing a glimmer of optimism in an otherwise challenging economic landscape.

While the IIP figures provide some positive news, the rise in inflation could pose challenges for the government and the RBI as they work to balance economic growth with price stability. As inflation remains above target, further policy measures may be needed to prevent the cost of living from spiraling out of control in the coming months.

## Bank of Baroda Forecasts 6.9% GDP Growth for India in Q2 FY24

■ndia's GDP growth is projected to rise to 6.9% in Lthe second quarter (Q2) of 2024, up from 6.7% in Q1, driven by strong domestic demand and positive trends in high-frequency economic indicators, according to a recent report. The uptick in growth comes as the country experiences a revival in several sectors, fueled by the festive season, which started in September and extended into October.

The report noted significant improvements across multiple indicators, including a rise in air passenger traffic and a higher Services Purchasing Managers' Index (PMI), both reflecting increased activity in the services sector. Additionally, the report highlighted improvements in toll collections, vehicle registrations, and non-oil, non-gold imports, all pointing to higher mobility and stronger consumer spending.



Government spending, both at the central and state levels, has also contributed to the economic acceleration, the report said. Key consumption metrics such as auto sales and digital payments have shown marked recovery, indicating a robust consumer environment. PMI data for both manufacturing and services have improved, suggesting balanced growth across major sectors.

Consumer confidence, as reflected in the Reserve Bank of India's (RBI) report from September, remains steady, with rural demand seeing a notable boost.

Sales of two-wheelers and tractors, in particular, have rebounded strongly, signaling healthier demand in rural areas.

Despite these positive developments, inflation remains a concern, with October's price data indicating persistent inflationary pressures. As a result, the RBI is expected to maintain its current interest rates in the December policy meeting, although analysts speculate that a rate cut may be considered by February 2025.

While credit growth has shown signs of slowing down, which could impact future economic momentum, the overall outlook remains positive. The combination of festive demand, improving consumer confidence, and strengthening rural and urban indicators positions India's economy for steady growth in the latter half of the year. India's official GDP data for Q2 2024 will be released by the Ministry of Statistics on November 29.





## **Amazon developing smart** glasses for drivers to shave seconds off deliveries

Amazon is work-ing on developing smart eyeglasses designed to assist its delivery drivers in navigating complex delivery environments. The glasses aim to provide real-time, turn-by-turn navigation on a small embedded screen, guiding drivers not only along their routes but also at each stop, includ-



ing directions within buildings. The goal is third-party couriers like UPS and FedEx. This to streamline the final stretch of the delivery process, improving efficiency during the "last mile," the most expensive and challenging part of the delivery journey.

According to sources familiar with the project, if successful, the smart glasses could help drivers save valuable time by offering directions around obstacles like gates or aggressive dogs, or even inside buildings, such as guiding them off elevators. This technology would also eliminate the need for drivers to use handheld GPS devices, allowing them to focus on delivering more packages in less time. By reducing delivery time, Amazon hopes to cut costs, particularly in the highly competitive e-commerce market where rival companies like Walmart are also stepping up their delivery capabilities.

Amazon has been working for years to build an in-house logistics network, including its own airlines, trucking fleet, and warehouses, with the goal of reducing dependency on cost-effective deliveries.



## **Apple Announces Share Item Location Feature on iOS**

Apple has confirmed the launch of a new feature in iOS 18.2 called \*Share Item Location\*, designed to help users track lost or misplaced items by sharing their location with third parties, including airlines. This feature, which first appeared in the iOS 18.2 Developer beta 2, is now available to users through the iOS 18.2 Public beta update and will be accessible to all users once the full public release of iOS 18.2 arrives.



The study explored the ability of nonbrain cells to "remember" chemical signal patterns, a function usually attributed to brain cells. The results were remarkable: these nonbrain cells showed signs of memory activation, including the turning on of a "memory gene," a process that was previously believed to be exclusive to neurons.

To track this gene activation, the researchers engineered the cells to produce a glowing protein whenever the memory gene was activated, providing a clear visual marker for memory processing. The results were strik-

ing: the non-neural cells displayed a stronger and more prolonged gene response when exposed to the spaced intervals, suggesting that these cells had the ability to "remember" in a way that mimics the processes seen in neurons.

This discovery challenges long-held assumptions about the nature of memory and suggests that memory-like processes might occur outside the brain, in various other tissues of the body. These findings could open new avenues for understanding how memory works and lead to innovative approaches in treating conditions such as Alzheimer's disease, memory loss, and other cognitive disorders, where memory formation and retention are disrupted. The study marks a significant step forward in the field of neuroscience, expanding the scope of memory beyond the brain itself.

The \*Share Item Location\* feature leverages Apple's \*Find My\* network, which uses Bluetooth to locate lost items and provide an approximate location back to the owner. It works with Apple's own AirTags as well as other compatible \*Find My\* accessories. Apple announced the feature through a newsroom post, highlighting its potential to aid in recovering misplaced devices quickly and efficiently.

To use this feature, users can mark an item as lost in the \*Find My\* app on their iPhone, iPad, or Mac, then

generate a \*Share Item Location\* link. This link can be shared with anyone, including a trusted person or airline employee, to assist in locating the item. The recipient can access the location via a website with an interactive map, which can be viewed on any platform, not just Apple devices. The location will update automatically whenever new information is available, and the website will display a timestamp indicating the most recent update.

This feature is particularly useful for travelers, as it enables them to quickly share the location of lost items with airline staff or others who may assist



Their serving was also problematic, winning only 58% of points on their first serve and 47% on their second. In contrast, the Italians were far more efficient, winning 89% of points on their first serve and 83% on their second.

The loss marked Bopanna and Ebden's third consecutive defeat to Bolelli and Vavassori this year. The duo currently sits fourth in the Bob Bryan Group. They will next face top seeds Marcelo Arevalo and Mate Pavic in their upcoming group match on Wednesday. Despite this setback, Bopanna and Ebden reached the semifinals in last year's ATP Finals, and will look to bounce back in their next match.


