Allu Arjun Calls Incident Unintentional **Apologies Extended to Victim's Family Refutes Allegations, Seeks Understanding**



AP Fibernet Issues Notices to Ram Gopal Varma Over Alleged Illegal Funding for 'Vyuham'

The Andhra Pradesh government has sent a shockwave through filmmaker Ram Gopal Varma by issuing notices regarding the alleged illegal funding of his movie Vyuham. The notices were sent by the AP Fibernet Corporation following an inquiry into the payment of Rs. 1.15 crore for the telecast of the film on the Fibernet network, despite no views being recorded.

On the orders of the current Fibernet Chairman, GV Reddy, notices were issued to the then Managing Director of Fibernet and five other officials. According to the notices, the funds were released to Varma's movie Vyuham during the YSRCP regime, without any viewership or corresponding revenue. The notices claim that the payment was made contrary to the established rules and procedures, prompting the Corporation to demand the repayment of the amount, along with interest, within 15 days.

The AP government is taking swift action to address the alleged misuse of public funds. The film's telecast was reportedly part of a broader controversy regarding mismanagement in government spending during the previous administration.

It remains to be seen how Ram Gopal Varma will respond to the notices, as he has yet to



comment on the issue. The case continues to unfold, with the Fibernet Corporation emphasizing that the payment was made without proper justification.

The development has raised questions about the transparency and accountability of government-funded projects under the previous regime, with this case serving as a reminder of the scrutiny now being applied to such practices.

Striving for a Dolly Mota-Free AP During **Tribal Village Visits**

On Saturday, December 21, Andhra Pradesh Deputy Chief Minister Pawan Kalyan visited Ballagaruvu and Gummanthi villages in Anantagiri Mandal of Alluri Seetharamaraju district. He made a significant impact during his visit, walking to the Ballagaruvu hilltop to meet local tribal communities. The villagers warmly welcomed Pawan Kalyan with traditional dances, and he participated by joining in the Thinsa dance and playing the traditional drum.

During the visit, Pawan Kalyan highlighted the Andhra Pradesh government's commitment to improving the lives of tribal communities. He announced that Rs. 350 crore would be allocated annually for the construction of roads and other infrastructure in tribal areas. Additionally, the Panchayat Raj Department has allocated Rs. 105 crore for road construction in Alluri district.

Pawan Kalyan expressed his dedication to alleviating the hardships faced by the tribals, stating, "We are here not for elections or votes but to address the struggles and pain of the people." He emphasized the importance of tribal youth in creating change, noting that 19 development projects have already been launched in Ballagaruvu and Gummanthi villages.

vision, Pawan Kalyan mentioned that the government is focused on building roads to connect tribal villages with a population of at least 100 people. Rs. 250 crore will be allocated by the Center for road construction, starting in January, and the state will continue to fund these initiatives.

He cited a recent incident in Kadapa where students, under the influence of cannabis, misbehaved with a teacher. On a positive note, Pawan Kalyan expressed his admiration for tribal customs and traditions. He also urged the Telugu film industry to establish itself in Andhra Pradesh. He pointed out that the agency areas, with their scenic beauty, could serve as ideal locations for film shoots. This, he believes, would not only showcase the beauty of the region but also create employment opportunities for the local tribal population. Pawan Kalyan emphasized that the state's development relies on the collective efforts of the government and the people, stressing that good work in the service of the community should always be recognized and protected.



Liquor Prices Reduced in AP Ahead of New Year and Sankranti Festivals

In a significant development for liquor enthusiasts in Andhra Pradesh, liquor companies have drastically reduced their basic liquor rates. The reduction comes just ahead of the New Year and Sankranti festivals, providing a boost to liquor lovers who will celebrate with lower prices.

Under the newly implemented liquor policy of the coalition government, about 11 liquor companies have cut their basic rates, with reductions affecting various brands. The reduction in rates is notable, with the price of a quarter of liquor decreasing by up to Rs. 30 at the MRP, and the price of a full bottle dropping by Rs. 90 to Rs. 120, depending on the brand. Minister Atchannaidu Issues Warning to YSRCP MLC

TPN Correspondent Andhra Pradesh, Dec 22 Minister Atchannaidu, in a fiery media interaction on Saturday, gave an indirect warning to YSRCP MLC Duvvada Srinivas, addressing the political tensions in the state. Reflecting on his past experiences, Atchannaidu claimed, "My anger nerve was cut some time ago. They put me in jail during the YS-RCP regime and caused me many problems. Everyone thought I would retaliate after coming to power, but cultivating factions is not my policy."

He further warned, "If I think about it, not a single one will be left. The one who did wrong will not escape. The

law will do its job." This remark, although veiled, was perceived as a warning to his political adversaries.

The minister also criticized the YSRCP for deceiving farmers over the past five years, alleging that the party's claims about the success of farmer assurance centers were false. He accused Former Chief Minister Jagan Mohan Reddy of borrowing Rs. 13 lakh crore without addressing the issues of farmers, including



delayed payments and unpaid dues.

Atchannaidu emphasized that under the current government, farmers' dues are being settled promptly, with money being deposited into accounts within hours. He assured farmers who had suffered due to recent cyclones that their crops would be purchased at fair prices. He also targeted the YSRCP's "Nadu Nedu" program, alleging financial mismanagement, and vowed that an investigation would be Furthermore, conducted. Atchannaidu announced plans to enhance infrastructure, including the construction of a four-lane road connecting Moolapet Port to

Bhogapuram airport, with the first ship expected at Moolapet port next year. The development of 10,000 acres for industrial growth around the port is also underway.

Additionally, he revealed plans to implement mid-day meals for intermediate students from January 1 and ensure faster progress on key development projects.

Minister Nimmala Ramanaidu Criticizes YCP Goverance

Highlights NDA Govt's Plans for Strengthening Irrigation

Ramanaidu pointed to the victory of coalition candidates in the irrigation union elections as a major triumph. "The overwhelming success of our candidates with a 100% strike rate in the irrigation union elections is a slap in the face to Jagan Reddy and the YSRCP. This victory shows that the entire farmer community stands with the coalition," he stated.



YS Sharmila Criticizes Govt for Delaying Free Bus Scheme for Women

NTR District Aims for 2 Lakh Solar-Powered **Homes Under PM Surya Ghar Scheme**

Human Trafficking Ring Busted in Visakhapatnam, 11 Rescued

ing girls trafficked from remote areas of Odisha, Chhattisgarh, Jharkhand, and even Nepal. The operation unfolded at the Visakhapatnam railway station when authorities intercepted

suspicious activity on the Kirandol-Visakhapatnam Express. Upon investigation, they discovered that the traffickers were using fake Aadhaar cards to transport the victims.

The main accused, Ravikumar Bisoy, is now in the custody of the railway police. Bisoy is believed to be part of a larger network that has trafficked over 100 girls so far, exploiting vulnerable individuals from impoverished regions.

The victims rescued in this operation were primarily from Odisha's Navrangpur district, highlighting the trafficking network's reach into remote and underserved areas. Authorities are working to identify other members of the gang and trace the full extent of their operations.

The railway police have commended the swift action of their personnel in preventing the traffickers from escaping and ensuring the victims' safety. Efforts are underway to provide rehabilitation and support to the rescued individuals while a detailed investigation continues. This incident underscores the need for stricter monitoring of human trafficking networks and greater vigilance at transit points like railway stations to protect vulnerable populations from such heinous crimes.

Four Dead, Nine Injured in Tragic Road Accident Near Bullasamudram



TPN Correspondent, Anantapur Dist : A horrific road accident occurred in the early hours of Saturday near Bullasamudram in Madakasira Mandal of Sri Sathya Sai District, leaving four people dead and nine others seriously injured.

The accident took place when a tempo traveler carrying 13 passengers collided with a parked lorry. The victims, identified as residents of Kummaranagepalli village in Gudibanda Mandal, were returning from a pilgrimage to the Tirupati Venkanna Swamy temple.

Among the deceased are Prem Kumar (30), Atharva (2), Ratnamma (70), and Manoj (30). Villagers immediately rushed the injured to Madakasira Government Hospital, where four critically injured passengers were later transferred to Hindupur Government Hospital for advanced treatment. The tempo was transporting family members and relatives, turning the joyous pilgrimage into a devastating tragedy. According to initial police reports, the accident occurred due to poor visibility and the parked lorry's lack of hazard indicators.

The clashes have heightened tensions in the region, with political parties urging their supporters to exercise restraint to prevent further violence. Authorities have assured strict action against those responsible for the attack.

Police Investigate Gruesome Yandagandi Dead Body Parcel Case in Undi Mandal

The case began when a parcel containing a dead body, with a rope tied around its neck, was delivered to the home of a woman named Tulsi via an auto. The parcel also contained a letter demanding ₹1.30 crore, raising questions about whether it was an act of intimidation or extortion.Tulsi's younger sister's husband, who arrived at her home after the parcel was delivered, has been missing ever since. The police are actively investigating his disappearance and exploring possible connections to the case.

The auto driver who transported the parcel has been identified. According to him, a woman hired him for the delivery, but he claimed to have no further knowledge about the contents of the parcel or the individuals involved.

The investigation has also uncovered details



about Tulsi's family, including her younger daughter Revathi, who had a love marriage with someone from a different caste (Agni caste Kshatriya). Speculation has arisen that the incident may be linked to family disputes over property. Rangaraju, a relative with a three-acre farm, is being investigated to determine if there is a connection between him and the crime.

Authorities are also examining similarities between the letter in the parcel and a previous letter Tulsi received when she applied to the Kshatriya Foundation for assistance. While the foundation denied extending help to individuals outside Rajahmundry, the handwriting in both letters appears identical, raising suspicions of a deliberate attempt to mislead or intimidate Tulsi.The case has become a major challenge for the police, who are working to uncover the truth behind this gruesome and perplexing crime.

Congress Slams Modi for Visit to Kuwait While **Manipur Remains Ignored**

The Congress party on Saturday criticized Prime Minister Narendra Modi for prioritizing a visit to Kuwait over addressing the ongoing crisis in Manipur. Modi's two-day trip to Kuwait, aimed at strengthening ties in sectors such as defense and trade, sparked a sharp response from Congress, which accused him of neglecting the people of Manipur.

In a social media post, Congress general secretary Jairam Ramesh took a swipe at the Prime Minister, calling him the "frequent flyer PM" for his overseas trips, while the people of Manipur continue to suffer. Ramesh posted a rhyming remark on X (formerly Twitter), stating: "Such is their fate, As Mr. Modi refuses to find a date, The people of Manipur continue to wait, While the Frequent Flyer PM is off to Kuwait."

The Congress has repeatedly urged the Prime Minister to visit Manipur, claiming that his presence could help restore peace and bring much-needed attention to the violence-stricken state. The ongoing ethnic violence in Manipur, which began on May 3 of the previous year, erupted after a tribal solidarity march in the state's hill districts, protesting the majority Meitei community's demand for Scheduled Tribe status.

The violence has left the region in turmoil, with the Congress party and other opposition groups pressing the government to take swift action to resolve the crisis. Despite these calls, the Prime Minister's focus remains on international diplomacy, with his visit to Kuwait marking another chapter in his series of foreign trips.

Parliament was adjourned sine die on Friday, bringing an end to a tumultuous Winter Session marked by heated debates, political confrontations, and low productivity. The session, which saw significant discussions on the country's constitutional journey and the introduction of two key bills on simultaneous elections, was overshadowed by a bitter exchange between the ruling National Democratic Alliance (NDA) and opposition parties, particularly following allegations of disrespect towards B R Ambedkar.

On the final day, the Lok Sabha session was adjourned within minutes due to ongoing political tensions, with Speaker Om Birla unable to even summarize the session's highlights. In contrast, the Rajya Sabha session saw opposition parties allowing Chairman Jagdeep Dhankhar to deliver his valedictory remarks before adjourning.

According to reports, the Lok Sabha's productivity stood at just 58%, a sharp decline from previous sessions where productivity often exceeded 100%. Rajya Sabha fared slightly better with 40.03% productivity, marking only 43 hours and 27 minutes of effective functioning throughout the session.

In his concluding remarks, Dhankhar urged parties to rise above political differences and restore the sanctity of parliamentary discourse. However, Parliamentary Affairs Minister Kiren Rijiju blamed the opposition, particularly the Congress, for the low productivity, accusing them of disrupting Parliament despite prior agreements to allow the session to function smoothly.

The session witnessed the introduction of five bills in the Lok Sabha, with four of them being passed, while the Rajya Sabha passed three bills. A key highlight was the two bills on simultaneous elections for Lok Sabha and state assemblies, referred to a Joint Committee of Parliament for further deliberation. The session's most contentious moment occurred on Thursday, when a physical altercation broke out between rival MPs, leading to police complaints and an FIR against Congress leader Rahul Gandhi. Both the opposition and BJP accused each other of insulting Ambedkar's legacy, leading to protests inside and outside Parliament. As the session concluded, opposition parties filed notices for breach of privilege against Home Minister Amit Shah and Rahul Gandhi, leaving unresolved tensions for future parliamentary proceedings.



Time Has Come For Change In Approach Of Police In Northeast: Amit Shah

Union Home Minister Amit Shah called for a shift in the police force's approach in the Northeast, following the end of insurgency in the region. Speaking at the 72nd plenary of the North Eastern Council (NEC) on Saturday, Shah emphasized the need to ensure speedy justice for the people, highlighting the significant progress the region has made in terms of peace and security.

Shah noted that Prime Minister Narendra Modi's leadership had led to peace in the Northeast, underscoring the signing of 20 peace accords over the last decade. These accords, Shah said, contributed to the surrender of over 9,000 militants. With the insurgency now behind the region, he called for a new strategy within the police force to ensure justice is served quickly. He advocated for reforms to guarantee that cases are resolved within three years of an FIR being lodged, marking a shift from the focus on counter-insurgency operations to enhancing law enforcement efficiency.

In addition to the shift in law enforcement, Shah highlighted the significant investments made by the central government in infrastructure development across the region. He stated that ₹81,000 crore had been allocated for rail connectivity, while ₹41,000 crore had been invested in improving the road network in the Northeast.

Shah also pointed out the government's focus on boosting organic farming in the region. To support this initiative, the Centre has established the National Organic Corporation Ltd (NOCL). He encouraged the Chief Ministers of the Northeastern states to sign agreements with NOCL to help with the packaging, marketing, and export of organic products. This move aims to enhance the economic prospects of the region while promoting sustainable agriculture practices.

FM Nirmala Sitharaman Chairs 55th GST Council Meeting in Jaisalmer

Union Finance Minister Nirmala Sitharaman is currently chairing the 55th meeting of the Goods and Services Tax (GST) Council in Jaisalmer, Rajasthan, on Saturday. The meeting includes several key participants, including Pankaj Chaudhary, the Minister of State for Finance, as well as Chief Ministers from Goa, Haryana, Jammu and Kashmir, Meghalaya, and Odisha. Additionally, Deputy Chief Ministers from Arunachal Pradesh, Bihar, Madhya Pradesh, Rajasthan, and Telangana are in attendance, along with Finance Ministers from various States and Union Territories, senior officials from the Finance Ministry, and members of the Central Board of Indirect Taxes and Customs (CBIC).

The Finance Ministry's official social media account shared that Sitharaman is leading the GST Council's discussions in Jaisalmer. The GST Council is responsible for making decisions on critical aspects of the GST system, such as tax rates, exemptions, and administrative procedures.

While the official agenda for the meeting has not been disclosed, sources indicate that a key issue on the table will be the proposed rationalization of GST rates on health and life insurance products. The Group of Ministers (GoM) on insurance, headed by Bihar Minister Samrat Chaudhary, has already submitted its report to the Council regarding the matter. The GoM was tasked with reviewing the GST rates on medical and life insurance, both of which are currently taxed at a rate of 18%.

Opposition leaders, including West Bengal Chief Minister Mamata Banerjee, have been vocal in urging the Finance Minister to reduce GST on medical and life insurance premiums. During the monsoon session of Parliament in August, members of the INDIA alliance staged a protest demanding a rollback of the GST on these products, with Congress leader Rahul Gandhi participating in the protest. The issue was previously discussed in the 54th GST Council meeting held in September 2024, which led to the formation of the GoM to examine the concerns and make recommendations.





Syria's New Leaders Appoint Foreign Minister to Strengthen International Relations



SYRIA: Syria's new rulers have appointed Asaad Hassan al-Shibani as the country's foreign minister, as they work to strengthen international ties and bring peace and stability to the war-torn nation. This development comes two weeks after the ousting of Bashar al-Assad, marking a significant shift in Syria's political landscape. The ruling General Command made the announcement on Saturday, with Syrian state news agency SANA reporting that the move reflects the aspirations of the Syrian people to rebuild the country and establish diplomatic relations worldwide.

Ahmed al-Sharaa, the de facto leader following Assad's removal, has actively engaged with foreign delegations since taking power. He has hosted the UN's Syria envoy and senior US diplomats in recent weeks. Sharaa has emphasized that his primary goals are reconstruction and economic development, signaling a willingness to engage diplomatically with international envoys while avoiding further conflicts.

Sharaa's forces, led by the group Hayat Tahrir al-Sham (HTS), seized control of Damascus on De-

cember 8, forcing Assad to flee after more than 13 years of civil war. This marked the end of the Assad family's decades-long rule. The situation in Syria remains uncertain, as it is still unclear whether HTS will impose strict Islamic rule or allow for more democratic governance. HTS had ties with al-Qaeda until Sharaa broke those links in 2016.

The United States, along with other Western powers and many Syrians, welcomed the fall of Assad. However, the future of Syria under Sharaa's rule is still unfolding. Sharaa, who previously served under the command of al-Qaeda in Iraq, has been designated a terrorist by the US since 2013 but had his \$10 million bounty removed by Washington on Friday.

The Syrian conflict has resulted in hundreds of thousands of deaths, a major refugee crisis, and the widespread destruction of cities, leaving the economy in ruins. The new administration's efforts to rebuild and establish international relations are crucial to Syria's future.

Canada PM Trudeau looks set to lose power after key ally vows to topple him

CANADA: Canadian Prime Minister Justin Trudeau's minority government is facing a potential collapse after a key ally, New Democratic Party (NDP) leader Jagmeet Singh, announced plans to bring down the government early next year. Singh, who has supported Trudeau's Liberal government in the past, declared that he would introduce a formal motion of no-confidence when the House of Commons reconvenes from its winter break on January 27.

Singh's decision marks a significant shift in the political landscape, as the NDP has been instrumental in keeping Trudeau's government afloat in recent years. However, tensions have risen between the two parties over several issues, including economic policies and government spending. Singh's move is a direct challenge to the leadership of the Liberal Party and could trigger a federal election if the motion passes.

The no-confidence motion, if successful, would force a gen-



eral election, potentially ending Trudeau's tenure as Prime Minister. The move comes as Trudeau's government has faced increasing scrutiny over its handling of various issues, including inflation, healthcare, and environmental policies.

Singh's announcement has added fuel to the ongoing political debate in Canada, with critics of Trudeau's leadership calling for change. The NDP leader's decision to present the motion signals his determination to hold the government

accountable, particularly on issues that have resonated with his party's supporters, such as social justice, healthcare reform, and addressing economic inequality.

As the country heads into the winter break, political observers will be closely watching how the situation develops in the coming weeks. If the no-confidence motion gains support, it could lead to a snap election that would test Trudeau's political survival and shape the future direction of Canadian politics.

North Korea Criticizes South Korea-US-Japan Talks on Indo-Pacific as 'Insult' to Peace



SEOUL: North Korea has strongly condemned a trilateral meeting between South Korea, the US, and Japan, which focused on strengthening security cooperation in the Indo-Pacific region. The meeting, held in Tokyo on December 11, aimed to address the growing threats posed by North Korea's nuclear and missile programs. However, Pyongyang labeled the talks as an "insult" to peace.

In a harsh editorial, North Korea's official newspaper *Rodong Sinmun* attacked the United States, describing it as a "gangster-like" nation that destabilizes global peace. The paper criticized the US's history of war and its foreign policy, which it claims involves invading other countries and undermining peace. The editorial also accused Japan and South Korea of being complicit in these actions.

North Korea's criticism particularly focused on Japan's defense posture, which has grown closer to the US in recent years. The paper rejected Japan's claims of seeking peace, pointing to its defense cooperation guidelines with the US and its security laws that allow for collective self-defense. These measures, North Korea argues, make Japan a threat to regional stability.

The editorial also took aim at South Korea, calling it the "vanguard" of US policies of invasion and war, accusing it of being a mere puppet of Washington. It condemned Seoul's alignment with US military strategies, further escalating tensions between the two Koreas.

This outburst reflects the heightened tensions on the Korean Peninsula, as North Korea continues to develop its missile and nuclear capabilities, while the US, Japan, and South Korea have worked to bolster their security cooperation in response. Pyongyang's rhetoric underscores the deepening divides and the ongoing diplomatic standoff in the region.

French President Macron Faces Backlash Over Cyclone Response During Mayotte Visit



MIRERENI: French President Emmanuel Macron faced intense criticism from residents of Mayotte during his visit to the Indian Ocean archipelago, which is still recovering from the devastation caused by the region's strongest cyclone in nearly a century. The cyclone, which caused signifi-

cant damage, has left many of tration felt by many on the isthe island's residents grappling with severe shortages, including a lack of access to basic essentials like water.

As Macron toured the affected areas, frustrations boiled over when some residents shouted, "We want water, we want water," demanding immediate assistance. In response, Macron, visibly upset, retorted angrily, "You're happy to be in France... If it wasn't France, you'd be 10,000 times more screwed!" He went on to defend France's response, claiming, "There's no place in the Indian Ocean where people get so much help!" Despite his attempts to defend the government's actions, tensions between Macron and the locals were palpable. One woman was heard disagreeing with the president, signaling that his words did little to alleviate the frus-

land. The exchange underscored the growing discontent over the slow and inadequate response to the cyclone's aftermath.

Mayotte, a French overseas department, has long been one of the poorest regions in France, and the cyclone has exacerbated existing challenges. Residents have criticized the government's relief efforts, citing delays and a lack of resources in the face of the disaster. Macron's visit, meant to reassure the public and demonstrate solidarity, instead became a flashpoint for anger and dissatisfaction.

The incident highlights the broader issues facing Mayotte and other overseas territories, where residents often feel neglected or sidelined by mainland France, especially in times of crisis.





India Launches Probe into Surge in Steel Product Imports

Tndia has launched **L**an investigation into the rising imports of certain steel flat products following a formal complaint from the Indian Steel Association (ISA). The Directorate General of Trade Remedies (DGTR), operating under the Ministry of Commerce, is currently examining imports of non-alloy and alloy steel flat products, which are crucial in industries like construction, automotive, and electrical panels.

The ISA, representing leading steel producers such as ArcelorMittal Nippon Steel, JSW Steel,

and Steel Authority of India, submitted a petition on December 15 under the Customs Tariff Act, 1975. The petition calls for the imposition of safeguard duties on these steel imports, aiming to protect the domestic steel industry from potential harm caused by the surge in foreign products.

The DGTR's investigation will focus on whether unforeseen circumstances have led to a significant increase in imports and if this influx poses a threat to the domestic industry. The inquiry will cover the period from October 2023 to September 2024.

The investigation has been triggered by concerns market dynamics.



over surplus steel production capacity in countries such as China, Japan, and South Korea. These nations have been exporting large quantities of steel, which may be affecting Indian steel manufacturers by driving down prices and increasing competition. The outcome of the probe will determine if any safeguard measures are necessary to protect the Indian steel sector from undue harm.

The DGTR is expected to conclude its investigation within eight months. This move comes at a time when the government is looking to ensure the long-term sustainability of India's domestic steel industry, which is facing pressure from global market dynamics.


According to a regulatory filing with the stock exchanges, the invest-

GST Council Defers Decision on Insurance Premium Tax Cuts

The Goods and Services Tax (GST) Council, in its 55th meeting held in Jaisalmer on Saturday, deferred the decision on potential rate cuts for life and health insurance premiums, citing the need for further technical discussions. This decision follows a long-standing demand from the insurance industry to reduce or exempt GST on premiums, which would ease the tax burden on both insurers and policyholders.

During the meeting, chaired by Union Finance Minister Nirma-



insurance policies. Another recommendation is to exempt GST on premiums paid by senior citizens for health insurance policies. Additionally, health insurance premiums for policies up to ₹5 lakh could be exempt from GST, while the 18% rate would apply to policies with coverage above ₹5 lakh.

The GST Council will continue discussions on these recommendations in its next meeting, as there are still technicalities to be resolved.

Another important agenda item for the GST Council is whether the 5% GST on food delivery platform delivery charges should apply retrospectively from 2022. Currently, food delivery services do not pay GST on delivery charges. The Council is also expected to discuss the inclusion of aviation turbine fuel within the GST framework.

la Sitharaman, members of the Group of Ministers (GoM), led by Bihar Deputy Chief Minister Samrat Chaudhary, debated the issue extensively. While most members of the GoM favored a full exemption on health and life insurance premiums, some suggested reducing



the GST rate from the current 18% to 5%.

RBI Report Highlights Financial Strain of **DISCOMs on State Finances**

A recent report by the Reserve Bank of India (RBI) has raised concerns over the ongoing financial burden of electricity distribution companies (DISCOMs) on State finances. The report reveals that by 2022-23, the total accumulated losses of state DISCOMs had reached a staggering Rs 6.5 lakh crore, which represents 2.4% of India's GDP.

The RBI noted that despite various reform efforts, DISCOMs remain a significant financial challenge for States. To address this issue, the RBI emphasized the need for measures to improve productivity, reduce transmission and distribution losses, and align tariffs with the actual cost of power supply. Additionally, the report stressed the importance of unbundling the

electricity supply industry and privatizing power generation and distribution, which could help strengthen the financial health of DISCOMs and improve State finances overall.

The report also highlighted that, despite several financial restructuring attempts, the outstanding debt of DISCOMs has been growing at an average annual rate of 8.7% since 2016-17. To improve this situation, the RBI recommended prioritizing operational efficiency by minimizing distribution losses, improving metering systems, ensuring timely tariff revisions, and incentivizing the power sector to reduce dependence on government subsidies.



On a more positive note, the RBI report pointed out improvements in fiscal discipline among States. In 2023-24, the gross fiscal deficit (GFD) of States was contained at 2.91% of GDP, well below the 3% limit mandated by the Fiscal Responsibility Legislation (FRL). Furthermore, States increased their capital outlay to 2.6% of GDP in 2023-24, up from 2.2% the previous year, signaling stronger investments in infrastructure.

Looking ahead, the report predicts that States are likely to maintain fiscal discipline in 2024-25, with the GFD budgeted at 3.2% of GDP, indicating a continued focus on sustainable financial management.

Indian Exporters to See Gains from Rupee's Depreciation, but Challenges Remain for Import

Tndian exporters in ▲ sectors like garments, handicrafts, and engineering goods are expected to see 5-10% gains from the recent depreciation of the Indian rupee, according to trade insiders. The rupee hit an all-time low of 85.09 against the US dollar on Thursday and further dropped to 85.10 on Friday. The depreciation of the rupee is likely to benefit traditional export sectors, such as textiles and



leather, which form a significant portion of India's export market.

However, the benefits of the rupee's decline may not be universal. Sectors that rely heavily on imports, such as gems and jewelry and electronics, may see rising oil and commodity prices offsetting any potential gains. For these industries, the falling value of the rupee may increase the cost of raw materials and components, potentially limiting the advantages of a weaker currency.

Moreover, the depreciation of the rupee comes amid a broader trend of currency weakening among other major economies. The Chinese yuan, Japanese yen, and Mexican peso have all seen sharper depreciations against the US dollar, which may reduce the competitive edge that Indian exporters gain from a weaker rupee. Trade insiders also noted that buyers could exert pressure on Indian exporters to pass on these currency-related benefits, further diminishing any longterm advantages from the rupee's fall.

India conducts nearly 60% of its goods trade in US dollars, and the recent depreciation is expected to help traditional sectors that rely on exports. However, challenges such as rising import costs and competitive pressures from other currencies may dilute the overall impact on India's trade performance.





OpenAI Tests New AI Models o3 and o3 Mini to Compete with Rivals



OpenAI announced on Friday that it is testing its new AI models, o3 and o3 mini, marking a significant step in its efforts to develop more advanced reasoning capabilities. The move signals increasing competition with major players like Google, as OpenAI aims to create smarter models capable of handling more complex tasks.

CEO Sam Altman revealed that OpenAI plans to launch the o3 mini model by the end of January, with the full o3 model set to follow shortly thereafter. These new models are expected to outperform OpenAI's previous large language models, attracting new users and investment by offering more robust solutions to difficult problems.

Earlier this year, OpenAI released its o1 AI models, designed to spend more time processing queries and tackling challenging problems across fields like science, coding, and mathematics. According to OpenAI, the o1 models have proven to be more capable of reasoning through complex tasks than previous iterations.

The upcoming o3 and o3 mini models, which are currently undergoing internal safety testing, are expected to surpass the capabilities of the o1 models. OpenAI has also opened an application process for external researchers to test the o3 models ahead of their public release, with the application window closing on January 10.The announcement of the o3 models follows OpenAI's successful launch of ChatGPT in November 2022, which helped ignite an AI arms race in the industry. OpenAI's rapid growth and innovative product releases culminated in a \$6.6 billion funding round in October, cementing its place as a leading force in artificial intelligence development. The company's ongoing advancements with the o3 models underscore its ambitions to push the boundaries of what AI can achieve in solving complex, real-world problems.

Crystal gazing: Could we essentially preserve our species forever?

In AE van Vogt's 1948 sci-fi short story *The Monster*, an alien race lands on a dead Earth. Before they can colonize the planet, they resurrect a human being to understand what caused the extinction of humankind. While this concept of resurrecting the dead may have seemed purely speculative at the time, it now feels eerily timely in light of recent advancements in science.

This September, researchers at the University of Southampton achieved a major milestone in their decade-long project to preserve human data in a form that could last indefinitely. Led by Peter Kazansky, a professor of optoelectronics, the team inscribed the complete human genome — all three billion base pairs of DNA — onto a tiny, coin-sized memory crystal. This "five-dimensional" crystal is made from fused quartz, one of the most durable materials known to man.

The memory crystal, dubbed the "Superman crystal," was designed to withstand extreme conditions that would destroy any other form of data storage. Using ultra-fast lasers, the team encoded the human genome into self-assembled nanostructured voids within the silica, making it capable of surviving temperatures up to



1,000 degrees Celsius, cosmic radiation, and even impacts with a force of up to 10 tonnes per cm². For context, the great white shark's bite force is about 1.8 tonnes, making the crystal vastly more resilient.

The team's work on the Superman crystal is an extraordinary step in preserving human history and knowledge for future generations — a concept not too dissimilar from van Vogt's story. While *The Monster* imagines an alien race resurrecting humanity to learn from its mistakes, today's technological achievements may offer a way for future civilizations to safeguard humanity's legacy long after we are gone. This merging of sci-fi imagination and real-world scientific progress hints at a future where human knowledge can outlast even the most catastrophic events.

Lab-Grown Mini Brains Not Only Survived In Space But Grew Healthier



experiment was to examine how space conditions might influence the progression of brain diseases, such as Parkinson's disease, and to understand the impacts of microgravity on neuron function.

After a month aboard the ISS, the mini brains returned to Earth, where scientists were stunned by the findings. Not only had the organoids remained healthy despite being exposed to weeks of weightlessness, but they had also matured at an accelerated rate compared to the same organoids grown on Earth. This faster maturation is significant, as it suggests that space conditions might stimulate certain aspects of brain development.

The researchers noted that while the brain organoids grew healthier, they also exhibited changes that were not ex-

Archaeologists have uncovered a remarkable collection of bronze statues and sacred artefacts from the hot spring at San Casciano dei Bagni in Italy, a site believed to have been used for ancient rituals. Located about 120 kilometers northwest of Rome, the site has been under excavation since 2019. It is thought to have been a place of sacred practices dating back to the third century B.C., originally used by the Etruscans and later by the Romans for making votive offerings, often in hopes of divine protection or healing.

Among the significant discoveries made during the 2024 excavation are several bronze snake statues, some measuring up to 90 centimetres in length. These statues were found in the deeper layers of the spring, likely symbolising the protection of the sacred waters. The presence of these serpentine figures suggests their role in safeguarding the sanctity of the spring, which was a focal point for rituals and offerings.

Other fascinating finds include a bronze statue of a nude male figure inscribed with the name "Gaius Roscius," as well as a depiction of a child priest holding a ball. The child priest figure is believed to have been associated with divination rituals, further illuminating the spiritual practices of the time.

In addition to the statues, the excavation also revealed exceptionally well-preserved organic remains, such as eggs with visible yolks, pine cones, and various plant matter. According to the Italian Ministry of Culture, these organic materials are believed to have held symbolic meaning related to rebirth and regeneration, common themes in ancient rituals. The preservation of these items can be attributed to the rapid burial of the materials in sediment, which helped protect them over the centuries.

These discoveries provide valuable insights into the religious and cultural practices of the Etruscans and Romans, shedding light on how they sought divine favor and connection through sacred offerings and rituals.

As scientists continue to explore the mysteries of space and its effects on the human body, this discovery adds an exciting layer to the field of space biology.

Clickbait titles and thumbnails are designed to lure viewers by promising something eye-catching or sensational, only for the video to fail to deliver on those expectations. These deceptive practices often exploit curiosity, leading to frustration when the video doesn't meet the viewer's needs.

In a recent blog post, YouTube outlined its intention to combat clickbait by increasing enforcement against misleading titles and thumbnails, partic-



ularly in videos about breaking news or current events. The company stated, "You'll start to see us slowly rolling this out in India over the coming months," highlighting that this initiative will initially focus on new video uploads.

"He participated in all the SMAT matches, and he will play in the 50-over games too," More said.
