Tulasi... Kamepalli Tulasi Babu... now this name is making rounds in political circles. Specifically, Mr. Raghurama Krishna Raju, Deputy Speaker of AP, has named him and accused him of being the person who sat on his chest and beat him while in the custody of the CID. The Deputy Speaker has alleged that Tulasi is the benami of CID Ex-Chief Mr. Sunil Kumar. That is why he was at the CID office during Mr. Raju's interrogation by CID officials, he added.

Surprisingly, Mr. Tulasi is now acting like the shadow MLA of Gudivada. He has become the dearest and nearest person to Mr. Venigandla Ramu, MLA of Gudivada. Actually, Mr. Tulasi is from Addanki in Prakasam District. Earlier, he was associated with YCP circles. However, just 10 months before the elections, he came to Gudivada and became a close associate of Mr. Venigandla Ramu.

Mr. Tulasi is credited with rallying TDP followers against Kodali Nani. Even now, he is the person directing TDP followers on how to embarrass and control Kodali Nani, preventing him from interfering in constituency affairs at any cost. Allegedly, Mr. Tulasi is handling all illegal collections in the constituency. Be it liquor,

Sunil Kumar and allegedly became his benami. Mr. Venigandla Ramu was introduced to Tulasi during a deal in Guntur, and since then, they have been close. After securing the Gudivada ticket, Mr. Ramu invited Tulasi to Gudivada, and the two have worked together ever since.

This highlights how politics and political affiliations seem applicable only to the common man, while politicians can align with anyone from any party to further their business interests and sustain their positions. Similarly, Mr. Tulasi, who earlier worked with YCP circles, is now associated with TDP circles.

As per available information, Mr. Kamepalli Tulasi Babu has studied LLB. He is a director at People's Pulse Pvt. Ltd., a psephology company. He is also a director at Inventus Financial Services Pvt. Ltd., NTV Agro Marine Foods Pvt. Ltd., Amrutha Solar Systems (India) Pvt. Ltd., and Velocity Cabs Pvt. Ltd. In several companies, Kandimalla Praveen is listed as a co-director with Tulasi, while in one company, Kothapalli Brahmam is a co-director.

The details of these companies raise eyebrows and allegedly appear to be benami entities for a few influential individuals. This aligns with Mr. Raghurama Krishna Raju's statement that Tulasi Babu is the benami of Sunil Kumar.

The Cabinet today approved several policies aimed at improving the economic situation of Andhra Pradesh. Among the major decisions was the approval of the IT and Global Competitive Centers Policy 2024-29. This policy includes provisions for coworking spaces and subsidies to promote their growth. Minister Parthasarathy stated that the goal is to develop Andhra Pradesh as an IT hub and provide employment to the large number of graduates entering the workforce each year. Task Force Formed to Probe PDS Rice Smuggling at Kakinada Port

A five-member task force has been formed to investigate the alleged illegal smuggling of Public Distribution System (PDS) rice found aboard the West Africa-bound cargo ship Stella L Panama at Kakinada Port. The team comprises officials from Customs, Anchorage Port, Police, Revenue, and Civil Supplies departments.

The ship, which was carrying 38,000 metric tons of rice, was seized following instructions from Deputy Chief Minister Pawan Kalyan. Authorities

suspect that a significant portion of the rice onboard was meant for PDS beneficiaries and may have been diverted for smuggling.

Kakinada District Collector S. Shan Mohan, addressing the media on Tuesday, stated that the investigation will focus on the origins of the rice and the exporters involved. "We will investigate how the exporters obtained the rice and how much of the stock is PDS rice. Each load of rice will be checked to ensure that the rice meant for beneficiaries is not being diverted for illegal activities," the collector explained. To aid the investigation and crack

down on illegal smuggling, the collector announced a dedicated helpline number (7993332244). The public can use this number to report any suspicious activities related to PDS rice diversions, especially in the Kakinada Port area. "Any information on PDS rice diversions can be shared with us, and we will act immediately with our task force teams," the collector assured.

The investigation aims to not only identify the exporters behind the smuggling but also ensure that PDS resources reach the intended beneficiaries without any hindrance.



Raghurama Case District Court to Hear Dr. Prabhavathi's **Anticipatory Bail** Petition

Government doctor Dr. Prabhavathi is facing charges in the custodial torture case of AP Assembly Deputy Speaker Raghurama Krishna Raju. Following Raghurama's custody by the CID during the previous government's tenure, a medical team examined him and issued a report. However, it is alleged that Dr. Prabhavathi tampered with the findings in this report.

In response to these allegations, Dr. Prabhavathi has filed an anticipatory bail petition in the Guntur District Court. The court heard her petition today, during which Raghurama's lawyer, Lakshminarayana, filed an impleadment petition on his behalf. In her petition, Lakshminarayana explained that Raghurama was subjected to third-degree methods during custody, resulting in severe blows to both legs and visible swelling. However, Dr. Prabhavathi reportedly submitted a medical report that contradicted the actual findings, thereby implicating her as an accomplice in the alleged attempt to harm Raghurama. The lawyer further stated that Raghurama had previously undergone bypass surgery, and such physical trauma could have severe health consequences. She accused Dr. Prabhavathi of deliberately ignoring this critical fact in her report. Lakshminarayana appealed to the court not to grant anticipatory bail to Dr. Prabhavathi, citing her alleged complicity in the case. The court is expected to deliberate on these submissions and take a decision on the anticipatory bail petition in the coming days.

We Are Depositing Money in Farmers' **Accounts Within 24 Hours!!**

AP Civil Supplies Minister Nadendla Manohar has affirmed the coalition government's unwavering support for farmers. Addressing the media, he highlighted the stark difference in grain procurement under the previous and current governments. While the previous government collected 4.43 metric tons of grain during this period, the coalition government has already procured 9.14 metric tons.

The Minister emphasized that payments are being deposited into farmers' accounts within 24 hours of grain procurement. "We are standing by the farmers 100 percent," Nadendla stated, reiterating the government's commitment to the farming community.

He also responded to a tweet by former Chief Minister YS Jagan Mohan Reddy, which alleged that Chandrababu Naidu's administration had abandoned farmers by delaying grain procurement. Minister Nadendla countered these claims, explaining that the current coalition government has taken swift and effective measures to ensure timely support for farmers.

Nadendla further provided a district-wise breakdown of grain procurement for 2023-24 and 2024-25, underscoring the government's proactive efforts in aiding the agricultural sector. He concluded by stating that

the coalition government remains committed to safeguarding the interests of farmers and addressing their needs efficiently.

Kakinada District Collector Shagili Shanmohan stated that the ration rice previously found aboard the Stella L1 during Pawan Kalyan's visit had been seized, but its owner went to court and secured its release. However, an investigation is underway to determine how the rice reappeared on the ship. The Collector clarified that if the rice was previously released by court orders, no action can be taken against the ship based solely on that. Amid ongoing debates about the authenticity of the rice, Collector Shanmohan announced the formation of a committee to resolve the issue.

The Collector revealed that a multi-disciplinary committee comprising officials from five departments, including Revenue, Police, Civil Supply, Customs, and Port authorities, is being established to address the matter. He acknowledged failures by officials in preventing the illegal movement of ration rice and noted that the ship had been seized as part of the investigation.

The committee will investigate the illegal transportation of ration rice, including how it was moved from the godown to the ship. The Collector emphasized that authorities have the power to inspect ships at Kakinada Port and confirmed that the Stella L1 is currently in the custody of the Port Officer.

The investigation is expected to shed light on the loopholes and mismanagement that enabled the illegal activities, paving the way for stricter enforcement measures to prevent similar incidents in the future.

State Urban Development Minister Narayana has made a key announcement regarding the construction of Andhra Pradesh's capital, Amaravati. He revealed the decision to reissue tenders for Amaravati works. A committee of engineers has been formed to review the stalled projects, and based on their report, the old tenders have been canceled. The Minister stated that new tenders would be issued by the end of December, with the works resuming in January 2024.

Minister Narayana disclosed that the estimated cost of Amaravati's works is ₹11,471 crore. He highlighted that assets constructed in Amaravati had incurred a loss of ₹286 crore during the previous government's tenure, with an additional ₹150 crore loss due to road damage. Furthermore, the cancellation and reissuance of tenders have added an additional GST burden of ₹452 crore.

The Minister explained that the value of the remaining works from 2014-19 stands at ₹7,391 crore. However, due to delays, the cost of these works has increased by ₹2,507 crore. Minister Narayana stated that if the previous government had completed the works on time, this burden on the current administration could have been avoided. The Minister also noted significant cost increases, in-

cluding ₹461 crore for trunk roads. Additionally, 320 km of main roads and 1,200 km of layout roads remain incomplete in Amaravati. Major infrastructure projects such as the Assembly building, High Court building, five administrative buildings, and 3,600 apartments are still pending.

Minister Narayana confirmed that all technical and legal issues related to the Amaravati capital works have been resolved. He assured that new tenders would be issued by the end of December and construction would commence in January. A comprehensive plan has been prepared to complete all pending works within three years.

He further stated that an initial estimate of ₹41,000 crore had been prepared for the capital works, but due to delays and cost escalations, an additional 30% increase in expenses is now expected. Minister Narayana reaffirmed the government's commitment to completing Amaravati as a functional and modern capital.

Minister Parthasarathy explained that investors will be divided into three categories, and subsidies will be allocated accordingly. In addition, the Cabinet approved the AP Maritime Policy 4.0, focusing on the development of ports and related infrastructure along the state's 975-km coastline. Efforts are also underway to establish a mega shipyard in the state.

Other key decisions include the establishment of Uddanam, Pulivendula, and Don drinking water projects under the Panchayat Raj and Rural Development Department. The Cabinet has also resolved to expedite the completion of houses allotted to the state by the Central government. Additionally, the Cabinet approved amendments to the Ayurveda and Homeopathy Medical Practitioner Registration Act and the implementation of Real-Time Governance 4.0, including the introduction of a system for issuing certificates via WhatsApp.

Significant funding of ₹11,471 crores was approved for development works in the capital city of Amaravati. The Capital Region Development Authority (CRDA) had already given its approval yesterday. The Cabinet concluded that a loss of ₹286.74 crores was incurred due to the abandonment of Amaravati development works during the previous YSRCP government. Minister Narayana noted that past tender processes converted VAT to GST, resulting in an increase of ₹452.35 crores. Additionally, cost increases over time have added ₹2,500 crores to the project budget. Minister Narayana stated that all legal and technical obstacles have been resolved, and tenders for Amaravati projects will be called by the end of this month, with work starting next month.

Mudragada Giri Appointed as YCP Coordinator for Prathipadu Constituency

The YSR Congress Party (YSRCP) is taking significant steps to rebuild its organizational strength following its defeat in the general elections. In a bid to prepare for potential early elections, the party leadership, under Chief Minister YS Jagan Mohan Reddy, has been implementing major changes and appointing new leaders to key positions. As part of these efforts, Mudragada Giri, son of prominent leader Mudragada Padmanabham, has been appointed as the coordinator for the Prathipadu Assembly constituency in Kakinada district. The appointment was announced by the party's central office in

Mid-Day Meal for Intermediate Students

Minister Nara Lokesh's Key Decision

Minister Nara Lokesh has announced a groundbreaking decision to improve attendance and educational standards in government colleges across Andhra Pradesh. The State Education, IT, and Electronics Minister has decided to extend the mid-day meal program to intermediate students as well. The decision was made during a review meeting held at his residence in Undavalli with senior officials from the School Education and Intermediate Education Departments.

Speaking at the meeting, Lokesh pointed out the high dropout rate among poor students after completing their tenth standard. He emphasized that providing mid-day meals in Minister Chandrababu Naidu. government intermediate colleges could help reduce dropouts significantly.

He also suggested that a question bank be provided to support academically weaker students in intermediate. Backward students will be identified through assessments conducted under the Sankalp program, and lecturers and college staff will be appointed as caretakers for their progress. Lokesh directed officials to carry out repairs in severely damaged government junior colleges to improve infrastructure.

The Minister instructed officials to organize upcoming mega parent-teacher meetings (PTMs) on December 7 in a festive manner. He emphasized that ministers and legislators should attend the PTMs in their respective constituencies without party flags or extravagant displays. Lokesh confirmed he would participate in the mega PTM at Bapatla Government High School alongside Chief



The meeting also focused on introducing a star rating system for government schools to enhance educational standards and infrastructure. Lokesh suggested using 18 specific criteria for rating schools.

He advised officials to consult State Government Advisor Chaganti Koteswara Rao, particularly for creating a curriculum that fosters moral values. Awareness on gender equality and civic sense will be promoted to ensure boys and girls feel equal from a young age. Lokesh also proposed incorporating Japanese-style life skills into the curriculum.

In light of repealing GO 117, brought by the previous government, Lokesh proposed holding village-level opinion polls to develop better policies. School management committees will also be invited to participate in these discussions. He further clarified that school grounds should not be used for any activities other than job fairs.

AP Leads with 14,87,631 Lakhpati Didis; Punjab Records 31,700

Andhra Pradesh, Bihar, and West Bengal are the top three large states leading in the creation of Lakhpati Didis, as India now boasts a total of 1,15,00,274 such women entrepreneurs, the Lok Sabha was informed on Tuesday.

Minister of State for Ru-Development Chanral dra Sekhar Pemmasani, in a written reply, stated that Andhra Pradesh has 14,87,631 Lakhpati Didis, followed by Bihar with 13,47,649, and West Bengal with 11,81,852.

Other states with a significant number of Lakhpati Didis include Madhya Pradesh (10,51,069), Maharashtra (10,04,338), Uttar Pradesh (8,41,923), Telangana (7,58,693), Gujarat (5,38,760), Odisha (5,37,350), Jharkhand (3,51,808), Tamil Nadu (3,18,101), Kerala (2,84,616), Rajasthan (2,70,405), and Karnataka (2, 36, 315).

In contrast, northern states like Punjab and Haryana reported lower numbers, with Punjab having 31,700 and Haryana 62,743 Lakhpati Didis.

Replying to questions from Kota Srinivasa Poojary and Chamala Kiran Kumar Reddy, the Minister also highlighted the progress of the Namo Drone Didi Scheme, under which 503 drones have been provided till December 3. Andhra Pradesh received the maximum number of drones (97), followed by Karnataka (84), Telangana (72), Madhya Pradesh



(34), Uttar Pradesh (32), Maharashtra (30), Punjab (23), and Haryana (22).

The Minister stated that under the Deendayal Antyodaya Yojana – National Rural Livelihoods Mission (DAY-NRLM), a centrally sponsored scheme of the Ministry of Rural Development, 10.05 crore women have been mobilized into 90.87 lakh Self Help Groups (SHGs) till October 2024. An impact evaluation study conducted in 2019-20 by the International Initiative for Impact Evaluation (3ie), with support from the World Bank, revealed that

DAY-NRLM led to a 19% increase in income, a 20% reduction in the share of informal loans, and a 28% increase in savings among SHG members.

The DAY-NRLM program aims to alleviate rural poverty by organizing women into SHGs and providing continuous support to help them achieve sustainable income growth, improve their quality of life, and rise out of poverty. The Lakhpati Didi initiative, a significant outcome of DAY-NRLM, ensures that SHG members earn a minimum of ₹1 lakh per year sustainably through structured interventions.

The scheme is being implemented nationwide (except in Delhi and Chandigarh) through various benefits like the Revolving Fund, Community Investment Fund, and Bank Linkage, extended to SHGs based on their eligibility and demands.

AP Congress Chief YS Sharmila has once again criticized the policies of the Andhra Pradesh government. After recently questioning the government about illegal transportation of ration rice, YS Sharmila has now raised concerns about Gangavaram Port. Using the platform X, she compared the previous YCP government with the current TDP-led coalition government, accusing both of policy failures. According to her, asset grabbing was a hallmark of the YSR Congress Party, while inaction has become the trademark of the TDP, Janasena, and BJP coalition government.

They acknowledged their mistake and sought forgiveness from devotees, emphasizing that they had no intention of undermining Tirumala's sanctity.

The incident occurred during their recent visit to Tirumala for Sri Venkateswara Swamy's darshan. While walking on the Alipiri footpath, particularly between the seventh milestone (known for leopard sightings) and the Lakshmi Narasimha Swamy temple, the couple recorded a reel pretending to flee from a leopard. Later, they clarified there was no actual leopard, and the video was meant in jest.

However, the video did not sit well with devotees, who urged the TTD to take action against the couple for what they perceived as disrespectful behavior in a sacred area. Fishermen Protest Against Pharma Companies in Pithapuram

Despite the issue being brought to the state government's notice, tensions escalated after allegations surfaced of certain fishermen leaders being bribed by pharma company owners.

According to fishermen from Konapapapet village in U. Kothapalli Mandal,



six fishermen leaders were allegedly paid ₹6 crores to dilute the movement. The matter came to light when three of the six leaders reportedly did not leaders of the Jana Sena Party, while

YCP leaders were also allegedly involved. However, the YCP leaders, not receiving the bribes, disclosed the issue as evidence.

The fishermen claim the pollution from companies such as Aurobindo and Divis is destroying marine life, leaving around 3,000 traditional fishing families in Kona Papapeta struggling to survive. Fishermen demanded action against the leaders who allegedly sold out their movement and called for the protection of fisheries from pharmaceutical waste.

Another Low-Pressure Area Looms Over AP, More Rain Likely

A new low-pressure area is likely to form over the Bay of Bengal between December 9 and 16, with the potential to intensify into a depression. If it strengthens near Tamil Nadu, it could significantly impact Andhra Pradesh's southern coastal districts.

Farmers, already worried about unseasonal rains during the crucial harvesting period, now face further anxiety over this latest weather forecast.

The situation demands vigilant monitoring and preparedness to mitigate the impact on daily life and agriculture.

Winter Session of Parliament: **Deadlock, Distractions, and Unanswered Questions**

Winter Session, the first week was largely unproductive due to a deadlock between the Opposition and the Union government. The Opposition, including parties like the Trinamool Congress and the Samajwadi Party, is demanding discussions on critical national issues such as price rises, unemployment, the situation in the North East, especially Manipur, the deprivation of funds from states, and the violence in Sambhal, Uttar Pradesh. The Congress, the principal Opposition party, has also called for a discussion on alleged financial irregularities involving the Adani group. However, a deadlock remains.

Recent media reports suggest that the deadlock might be resolved with an agreement between the government and the Opposition, according to which a discussion on the Constitution will take place in mid-December, almost two weeks from now. While an agreement on future discussions is important, it raises questions. Why wait for two weeks to implement an agreement made now? Why not start the discussions immediately instead of further delaying parliamentary proceedings? The Modi-led NDA coalition appears to be delaying important debates, causing frustration among those demanding urgent attention to pressing issues.

Historically, the BJP has downplayed the significance of active and productive parliamentary sessions. As BJP stalwarts like Arun Jaitley and Sushma Swaraj have noted, sometimes the obstruction of Parliament can serve democracy. However, the Modi government's track record in Parliament speaks volumes. In the 15th Lok Sabha (2009-14), seven out of ten bills were sent to committees for scrutiny, whereas, in the 17th Lok Sabha (2019-24), only two bills were sent for scrutiny. Furthermore, numerous bills are rushed through with minimal discussion,

As Parliament enters its second week of the often with zero or incomplete consultations.

Adding to the dysfunction, not a single notice from the Opposition has been accepted for discussion under Rule 267 in the Rajya Sabha for the past eight years. The Prime Minister has also failed to answer any questions in Parliament, undermining the principles of accountability and transparency. This behavior raises concerns about the current government's willingness to engage in meaningful debates.

On the topic of the Joint Parliamentary Committee (JPC), Opposition parties have demanded its formation to investigate alleged financial irregularities. However, given the ruling party's dominance in Parliament, the credibility of any JPC is in question. The committee's composition is determined by the ruling party's strength, and key decisions—such as choosing witnesses and approving reports-would be controlled by the Treasury benches, compromising its independence. Historical JPCs, such as those during the Bofors scandal and the Harshad Mehta scam, have been marred by boycotts and dissent, as the Opposition's views were consistently sidelined. Even when JPCs issue recommendations, they are often ignored or diluted. The 2001 JPC on the stock market scam and the 2011 JPC on spectrum allocation both saw crucial reforms overlooked, highlighting the inefficacy of such committees in delivering tangible results.

over 60,000 have been displaced. The situation is marked by the destruction of religious structures, further deepening the divisions between the communities.

The recent escalation, including the deaths of 10 militants from the Hmar tribe in November, and protests against the state government's failure to restore order, highlight the increasing volatility. On November 17, the National People's Party (NPP), a key ally of the BJP-led Manipur government, withdrew support, citing the government's inability to address the growing crisis.

The Government of India has failed to learn the critical lesson in handling tribal unrest. While military action is essential to curbing violence, it must be paired with significant political initiatives to address the underlying grievances. This could involve forming peace committees, initiating dialogue between rival groups, and establishing confidence-building measures.



The Prime Minister further emphasized the significant transformation in the legal framework, including the removal of the sedition charge and the establishment of the position of 'Director of Prosecution' to address corruption. He explained that the new laws aim to build a legal system that is not only efficient but also serves to empower citizens rather than penalize them. PM Modi also expressed his satisfaction over the implementation of the laws, noting that the impact would be felt nationwide within the next three years. He stressed that the laws were developed with inputs from numerous judicial bodies and experts, ensuring their relevance and effectiveness in today's context. The successful rollout in Chandigarh is seen as a milestone, with the aim to extend the reforms across India in the coming years.

Amit Shah Congratulates Chandigarh, **First City To Implement Criminal Laws**

Union Home Minister Amit Shah on Tuesday congratulated Chandigarh for becoming the first city in India to fully implement three significant new criminal laws: the Bharatiya Nyay Sanhita (BNS), Bharatiya Nagrik Suraksha Sanhita (BNSS), and Bharatiya Sakshya Adhiniyam (BSA). These laws, Shah stated, will be implemented across the entire country within the next three years.

Addressing a program to dedicate these laws to the nation, Shah called it a "golden day for the Indian criminal justice system," as Chandigarh became the first jurisdiction to fully adopt the comprehensive legal framework. The laws are now operational across police, judicial, prosecution, jail, and forensic departments.

Shah criticized the previous colonial-era laws, such as the Indian Penal Code (IPC), Code of Criminal Procedure (CrPC), and the Evidence Act, which were enacted by the British Parliament. He emphasized that these laws were designed to protect British interests rather than those of the Indian people. In contrast, the new laws are crafted by Indians, aiming to deliver justice, not punishment. Shah assured that the new laws, which focus on fairness and justice, will be implemented nationwide in three years.

Among the significant changes, Shah high-

lighted the creation of the post of Director

of Prosecution to combat corruption, as well



as the replacement of the term "sedition" with "treason" in the legal framework. Additionally, Shah revealed that over 11 lakh FIRs had been filed under the new system, with nearly 9,500 cases already resolved within just four months.

Prime Minister Narendra Modi, who also spoke at the event, reiterated the historical context of the old criminal laws, designed by the British to subjugate Indians. He un-

derscored that these laws were meant to control and oppress, not protect the citizens of the nation. The new laws, Modi said, reflect the democratic spirit of "Of the People, By the People, For the People."

The new criminal laws, which came into effect on July 1, 2024, are intended to modernize India's legal system, making it more transparent, efficient, and responsive to the needs of contemporary society..

CM M.K. Stalin Condoles Loss in Tiruvannamalai Landslide, Announces Compensation

Tamil Nadu Chief Minister M.K. Stalin expressed his condolences following a tragic landslide incident in Tiruvannamalai on December 1, which claimed seven lives. The disaster occurred when a massive boulder and mudslide collapsed onto a house on 11th Street in V.O.C. Nagar, following heavy rainfall in the region. In response to the loss, Stalin announced a compensation of ₹5 lakh each to the families of the victims.

The victims, identified as Rajkumar (36), Meena (27), R. Gowtham (9), R. Iniya (7), S. Ramya (7), M. Vinothini (14), and S. Maha (7), tragically lost their lives despite rescue tional Disaster Response Force (NDRF). In the aftermath of the incident, over 500 residents from the nearby areas were safely relocated to community halls for protection.



Experts have raised alarms about the potential for future landslides in the area, especially given the encroachments near the efforts by about 40 personnel from the Na- hills. Retired IIT Chennai professors Mohan, Naravana Rao, and Bhoominathan inspected the site following the incident on the Chief Minister's request. They advised that while light rainfall may not pose a significant threat, heavy rainfall could trigger further landslides. They also recommended that individuals planning construction near the hills consult qualified engineers to ensure safety.

Harbhajan Singh **Issues Stern Warning** to Pakistan

Former Indian cricketer Harbhajan Singh has delivered a strong message to Pakistan, suggesting that the country's absence from future ICC events in India will not have significant consequences. His remarks come amid rising tensions and debates surrounding the ICC Champions Trophy 2025, with Pakistan's refusal to participate in the tournament unless a hybrid model is introduced.

Pakistan has been adamant about its demand for a hybrid model for all ICC events hosted in India until 2031, following India's stance on not traveling to Pakistan for the 2025 Champions Trophy. The Pakistan Cricket Board (PCB) has emphasized the need for the hybrid model, which would allow matches to be played in



neutral locations, due to the ongoing political tensions between the two countries.

However, Harbhajan Singh, known for his outspoken views, made it clear that Pakistan's absence would not affect the success or prestige of any tournament hosted in India. "If Pakistan doesn't come to India, it won't make much of a difference," Harbhajan said. He pointed out that India is more than capable of hosting successful cricket events without Pakistan's participation.

Harbhajan further added that while cricket fans in both countries cherish the rivalry, the sport must continue regardless of any political disputes. His comments underline the fact that India has hosted and will continue to host major international events with or without Pakistan's involvement.

The region, part of the Tiruvannamalai range, is home to seven Reserved Forests (RFs), including Chippakadu, Athipakkam, Adinamalai, and Sorakolathur. Cool Drinks Classified as 'Sin Goods' Alongside Cigarettes

The Group of Ministers (GoM) on GST rate criticized for their high sugar content, have rationalization, headed by Bihar Deputy Chief Minister Samrat Chaudhary, has proposed a significant tax hike for products categorized as 'Sin Goods,' including tobacco, tobacco products, and aerated drinks. Currently subject to a 28% GST rate, the proposed slab would increase this to 35%, ef-

fectively aligning cool drinks with tobacco and alcohol in terms of taxation.

Sin taxes are levied on goods deemed detrimental to society, such as liquor, tobacco products, and gambling. Aer-

ated drinks already face an additional 12% compensation cess, bringing their total tax have fueled massive consumption, eviburden to 40%. With the new GST hike, this could rise to a staggering 47%. Critics argue that while these taxes are justified as a deterrent for harmful consumption, governments continue to permit the sale of these products, reaping significant revenues under the guise of public health concerns.

If the GST Council approves these recommendations, the cost of aerated drinks, popularly known as cool drinks, will likely soar. These beverages, which are often been linked to severe health issues such as obesity, diabetes, cardiovascular diseases, and even infertility. India's status as the global leader in obesity and diabetes only underscores the gravity of the problem.

Despite these health concerns, the afford-



ability of aerated drinks remains a critical issue. Small bottles can cost as little as ₹20, while larger 2.25-liter bottles are priced around ₹100-₹110, with online platforms and supermarkets offering hefty discounts. This

widespread availability and low pricing denced by the Indian carbonated soft drink market's revenue of \$18.25 billion in 2022, with a consumption volume of 9.29 billion liters.

Industry stakeholders are now advocating for a tax system based on sugar content rather than a blanket hike. Several countries, including the UK, France, and Thailand, have adopted a sugar-tiered tax approach, which incentivizes companies to reduce sugar levels in their products.

Lok Sabha Speaker Om Birla on Tuesday issued a stern warning to Members of Parliament (MPs) regarding further disruptions in the House. He stated that if adjournments continue, he would have no choice but to extend the proceedings over the weekend to compensate for lost time. Birla's statement came in the wake of ongoing protests and adjournments that have marred the smooth functioning of the House.

The warning follows an agreement between the government and opposition parties to end a week-long deadlock in Parliament. This breakthrough paved the way for a much-awaited discussion on the Constitution, marking its 75th year of adoption. The Lower House will conduct the discussion on December 13 and 14, while the Upper House will take up the debate on December 16 and 17.

"If the adjournments continue, we will have to hold the proceedings on Saturday and Sunday to make up for the time lost," Birla said, adding that he had not approved any adjournment notices for the day. His comments came shortly after the Question Hour, which had been disrupted due to protests by opposition MPs on various issues.

In recent days, the Lok Sabha proceedings had been severely disrupted due to protests related to the Adani indictment issue, violence in Uttar Pradesh's Sambhal district, and other matters raised by opposition members. These disruptions resulted in a washout of the House's functioning for several days last week.

With the new announcement, Birla emphasized the importance of maintaining the decorum of Parliament and ensuring that the legislative work is completed without further delays. The government and opposition have agreed to resume discussions, and the Speaker's warning highlights the urgency of using the available time effectively to address key issues.






Biden Administration Approves \$1.17 Billion Helicopter Equipment Sale to India

The Biden administration has approved the sale of significant defense equipment to India, weeks before the completion of its fouryear term. The U.S. government notified Congress on Monday about its decision to approve the sale of MH-60R Multi-Mission Helicopter Equipment and related systems, valued at approximately \$1.17 billion.

According to the Defense Security Cooperation Agency (DSCA), the proposed sale is aimed at enhancing India's defense capabilities, specifically in the area of anti-submarine warfare. The MH-60R helicopters, which are versatile, multi-mission aircraft, will help India strengthen its maritime security and ability to deter both current and potential future threats in the region.

The sale of these helicopters is expected to significantly bolster India's naval forces, allowing for advanced capabilities in anti-submarine operations, search and rescue missions, and overall maritime security. The MH-60R helicopters are designed for a variety of roles, including surveillance, reconnaissance, and combat operations, making them a critical asset for India's defense strategy.

The U.S. government has emphasized that the sale aligns with the ongoing defense partnership between the two countries and supports their shared interests in promoting peace and stability in the Indo-Pacific re-



gion. India has been increasingly strengthening its military ties with the United States as part of efforts to counterbalance growing regional security challenges, particularly from China.

This approval marks another step in the deepening defense relationship between the U.S. and India, with both countries working closely on strategic defense and security

Yoon explained that opposition parties had effectively "taken hostage" the parliamentary process, driving the nation to a critical juncture.

President Yoon emphasized that his decision was made to safeguard the free and constitutional order of the Republic of Korea. He voiced concerns over growing threats from North Korean communist forces and alleged domestic pro-North Korean anti-state groups, which,

according to him, were undermining the nation's freedom and security.

US President-elect Donald Trump issued a stern warning to Gaza militants on Monday, threatening severe consequences if hostages taken during the October 7, 2023 attack are not released before his inauguration on January 20, 2025. The threat follows diplomatic efforts by outgoing President Joe Biden's administration that have yet to yield a breakthrough in securing a hostage release or ending the ongoing Israel-Gaza conflict.

On his Truth Social platform, Trump stated, "If the hostages are not released prior to January 20, 2025, the date that I proudly assume office as President of the United States, there will be ALL HELL TO PAY in the Middle East, and for those in charge who

In pivot from India, Nepal PM visits China to seek investment

Nepal's veteran communist politician, K P Sharma Oli, has returned as the country's prime minister for the fourth time this year, and his first foreign visit since taking office in July was to China. Oli aims to revive momentum for planned infrastructure projects between the two nations during his days-long visit. This visit marks a shift from Nepal's usual diplomatic focus on India, with which Kathmandu shares centuries-old ties.

During his visit, Oli is set to meet Chinese President Xi Jinping and Premier Li Qiang for detailed discussions about strengthening ties and advancing key infrastructure projects. Xi Jinping had previously expressed China's commitment to helping Nepal transform from a landlocked nation to a "land-linked" one. This is part of China's broader ambition to expand its Belt and Road Initiative (BRI), which aims to build infrastructure and promote trade across Asia and beyond.

Although India remains Nepal's dominant trade partner, accounting for two-thirds of its international trade, China has been increasing its influence. Currently, China holds 14 percent of Nepal's foreign trade share, but it has also emerged as a significant creditor. According to World Bank data, China has lent more than \$310 million to Nepal, surpassing India by \$30 million in two-way loans. These loans are part of China's growing presence in Nepal, particularly through infrastructure projects like highways, hydropower plants, and airports.

Oli's visit is expected to focus on boosting economic cooperation and securing funding for several key infrastructure projects. The discussions with Chinese leadership will explore new avenues for bilateral cooperation, with the goal of improving Nepal's connectivity and reducing its dependence on India for trade. This visit signals Nepal's broader strategic effort to balance its relationships with both China and India, especially as Beijing's influence continues to grow in the region.

Yoon's remarks reflect heightened political polarization within South Korea, where opposition parties have accused the government of overreach and authoritarianism. While the full scope of martial law has not been disclosed, the measure is expected to lead to significant political and social ramifications in the coming weeks. The international community will be watching closely as South Korea navigates these turbulent waters. harshest retaliation, asserting that "those responsible will be hit harder than anybody has been hit in the long and storied History of the United States of America."

At COP16, Saudi Arabia Bets On Climate Tech To Make Deserts Bloom

Saudi Arabia is investing heavily in green technologies to transform its desert landscapes, but its efforts are being met with skepticism, with some critics accusing the country of greenwashing. The Gulf nation is hosting the United Nations COP16 conference on drought and desertification, issues that are particularly relevant to the kingdom, which aims to restore 40 million hectares of degraded land. However, while Saudi Arabia is a major investor in climate tech, its continued defense of oil and critics' claims of limited environmental benefits raise concerns about the sincerity of its green initiatives.

In 2023, Saudi Arabia accounted for nearly 75% of Middle Eastern investment in cli-



mate technology start-ups, according to a report by PwC. However, the majority of this investment is focused on energy solutions, with \$363 million channeled into climate-friendly energy technologies—nearly ten times the amount allocated to innovations in food, agriculture, and land-use. One notable project in the kingdom is a wastewater treatment facility at the King Abdullah University of Science and Technology (KAUST). The facility uses microorganisms to reduce the energy cost of wastewater treatment and generates energy from methane produced in the process. The purified water can be used to irrigate plants, combat desertification, or produce feed for livestock.

In addition, Saudi Arabia's Middle East Green Initiative aims to plant 10 billion trees and rehabilitate 74 million hectares of land. However, experts like Himanshu Mishra at KAUST believe efficient water and soil management are crucial to these goals.

Pak Ex-PM Imran Khan Placed on 14-Day Judicial Remand in Seven New Cases

Pakistan's former Prime Minister Imran Khan has been placed on a 14-day judicial remand by the Anti-Terrorism Court (ATC) in connection with seven new cases, as reported on Monday. The ATC hearing, presided over by Judge Amjad Ali Shah, resulted in the court approving Khan's remand in the New Town police station case and six other cases related to protests held on September 28, October 4, and October 5, 2023.

Currently held in Adiala Jail, Imran Khan's arrest follows his previous bail in the Toshakhana 2.0 case. His legal troubles stem from protests organized by his party, Pakistan Tehreek-e-Insaf (PTI), which resulted in multiple charges. Despite requests for physical remand in six other cases from the protests during the mentioned dates, the court decided to send Khan to jail on judicial remand.

In addition to these cases, Imran Khan faces further legal battles, including 28 cases linked to the November 24 protest, for which no arrests have been made as of now. The ATC is also set to hear 13 cases related to the May 9, 2023, violence, alongside the remand of 1,494 PTI workers arrested during the November 24 protest march in Islamabad.

The ATC proceedings continue, with PTI lawyers planning to appear in the Adiala Jail for the hearing of Imran Khan's case. The hearing is expected to be followed by a visit from the judge to Adiala Jail for further remand proceedings. Imran Khan's sister, Aleema Khan, might also attend as Imran has not been able to meet with his lawyers or family in the past 10 days.





Markets Rally on Global Cues, RBI Action

 $D_{\text{surged for a second straight}}^{\text{omestic stock markets}}$ session on Tuesday, driven by positive global cues and the Reserve Bank of India's intervention to stabilize the rupee after it touched a lifetime low against MURTHY NAIDU PAADAM the dollar. The rally was bolstered by gains in energy, met-



als, and banking stocks, with the Nifty breaching the crucial 24,350 resistance level.

The BSE Sensex, which closed at 80,248 on Monday, opened higher at 80,529 and touched an intraday low of 80,244 before climbing to a high of 80,949. It closed at 80,845, up 597 points. The NSE Nifty opened at 24,367, hit a low of 24,280 and a high of 24,481, before settling at 24,457 with a gain of 181 points. The Bank Nifty rose 586 points to close at 52,695.

Among the Nifty50, 41 companies advanced, while 9 declined. Adani Ports, NTPC, Adani Enterprises, Axis Bank, and SBI were the top gainers, while Bharti Airtel, Hero Moto, ITC, HDFC Life, and Sun Pharma were the top losers. Sectorally, FMCG and pharma indices posted marginal gains, while banking, finance, media, and metal indices showed mixed performance. Across the NSE, 2,057 of 2,907 stocks advanced, while 774 declined. Notably, 108 stocks hit 52week highs, and 12 recorded 52-week lows.

In other highlights, Torrent Power reached an 11-week high, and ICICI Insurance climbed to a five-month high. HSBC gave Bajaj Finance a "buy" rating with a target price of ₹7,740, while Citi maintained its "buy" rating on M&M with a target of ₹3,520. New Clues Point To Possible Alien Life Beneath Mars' Surface



Scientists Discover New Deep-Sea Mollusc After Two Decades of Research

Ateam of researchers from the Monterey Bay Aquarium Research Institute (MBARI) has officially identified a new species of sea slug, known as *Bathydevius Caudactylus*, or more commonly, the "mystery mollusc." The discovery, published in the journal *Deep-Sea Research*, marks the culmination of over 20 years of research.



was found in deep-sea environments, a region that has long been difficult for researchers to explore due to its challenging conditions. The team used MBARI's advanced ROVs to observe the creature and collect samples for analysis. This discovery not only sheds light on the biodiversity of deepsea ecosystems but also highlights the importance of continued exploration in the world's oceans.

Mars, once a warm and wet world, may still hold the potential for life deep beneath its surface. A team of scientists led by Andrea Butturini believes that microbial life, particularly methanogens, could be lurking in the subsurface of the ancient Martian plain, Acidalia Planitia. This area, located in the northern hemisphere of Mars, has piqued the interest of researchers as a possible haven for life.

By analyzing data from various Mars missions, including orbiters and rovers, the team identified a subsurface zone between 4.3 and 8.8 kilometers deep that may harbor conditions suitable for microbial activity. This environment, shielded from the planet's harsh surface conditions, could retain remnants of ancient water and geothermal heat—two crucial ingredients for life. While the idea of Martian microbes may seem speculative, this discovery fuels hope and provides a compelling reason to continue searching for extraterrestrial life.

Acidalia Planitia, a vast 3,000-kilometer-wide plain, seems to offer the right conditions for methanogens—bacteria that produce methane. The researchers suggest that these microbes could thrive in the deep subsurface, where they would be protected from the planet's extreme surface temperatures and radiation. The findings provide a promising target for future missions aimed at searching for evidence of life on Mars.

However, uncovering evidence of life on Mars is no small feat. The researchers note that to verify the existence of microbial life, future missions would likely need to drill several miles beneath the Martian surface. Despite the challenges, this discovery opens up exciting new possibilities for the search for life on Mars and could reshape our understanding of extraterrestrial biology.

As space exploration continues, this research adds to the growing body of evidence suggesting that Mars may still harbor the potential for life, sparking new interest and enthusiasm for the Red Planet's exploration. The mystery mollusc was first spotted in February 2000 during a research mission using the remotely operated vehicle (ROV) Tiburon. Since then, the elusive creature has intrigued scientists, but its true nature remained a mystery. Thanks to continued observations and extensive research, the team was able to classify it as a species of nudibranch, a type of sea

E-Commerce Platform Meesho Was Defrauded Of ₹ 5 Crore By Fake Seller

In a major breakthrough, the cyber police have uncovered a fraud that caused a loss of over ₹5 crore to the popular e-commerce platform Meesho. Three individuals have been arrested in connection with the scam, which involved posing as fake sellers and placing fraudulent orders on the platform.

According to the cyber police, the suspects operated under the name "OM Shree Enterprises," a fake company based in Surat. They used fake names and addresses to place orders

on Meesho, only to later claim refunds by alleging that the products were damaged. To support their claims, they sent videos of the damaged goods to the company. Once the products were returned due to the fraudulent addresses, the criminals replaced them with damaged items and collected refunds.

The scam operated between January and July of this year, during which the fraudsters managed to siphon off ₹5.5 crore through



various bank accounts. The scale of the operation prompted Meesho's nodal officer to file a complaint with the cyber police in July, leading to the investigation and the formation of a special team to track the culprits.

The cyber police traced the bank accounts and mobile numbers used by the suspects, eventually leading to their arrest in Surat on November 21. During questioning, the suspects confessed to their involvement in the fraud and revealed the

identities of their associates. Efforts are now underway to locate the other members of the group.

The suspects were also found to have been involved in a similar fraud case in 2023, which further highlights the sophistication and scale of their operations. The police are continuing their investigation into the matter, with plans to further investigate the extent of the fraud and bring all involved to justice.
