## Siddaramaiah and Somanna Clash Over Karnataka's **Underperformance in Jal Jeevan Mission**

Karnataka, Feb 16

Karnataka's underperformance in the Jal Jeevan Mission (JJM) has sparked a war of words between Chief Minister Siddaramaiah and MoS V Somanna. Both leaders have blamed each other for the slow pace of the program, aimed at providing piped drinking water to rural households.

Siddaramaiah accused the Central Government of failing to release adequate funds for the mission. He claimed that the Centre has only released Rs 11,760 crore out of its Rs 26,119 crore commitment, meeting just 45% of the pledged amount. In contrast, he said the Karnataka government has already disbursed Rs 20,442 crore, fulfilling 88.3% of its own commitment. Despite this, he argued, the Modi government continues to block Karnataka's rightful share of funds, which has hampered the state's progress in the

Siddaramaiah further highlighted the financial discrepancies, stating that in the 2024-25 fiscal year, the Centre allocated Rs 3,804 crore but released only Rs 570 crore. On the other hand, Karnataka has released Rs 4,977 crore from its own budget against an allocation of Rs 7,652 crore. He criticized the Centre for not releasing further funds despite the state government's repeated requests. He also accused BJP leaders, including Somanna, of spreading misinformation about the mission.

In response, Somanna hit back by ques-



tioning the state's efficiency in executing the mission. He pointed to Karnataka's poor ranking, stating that the state is 22nd among 34 states and UTs in terms of JJM implementation. He claimed that Karnataka has achieved only 52.16% of its 2024-25 target, which is 15 lakh connections, while only managing 2,430 connections per day. To meet the target, Karnataka needs to achieve 9,744 connections daily, a gap Somanna pointed out as evidence of the state's inefficiency. Somanna argued that despite the allocation of substantial funds,



the pace of the program in Karnataka remains slow due to inefficiencies and delays in implementation. He urged the Siddaramaiah government to focus on accelerating the mission's progress.

The verbal exchange underscores the political divide in the state regarding the success of the Jal Jeevan Mission. Both leaders are at odds over the role of the Centre and the state government in ensuring timely execution of the scheme, which remains crucial for improving access to clean water in Karnataka's rural areas.



#### 20,000 Reunited with **Families Through Digital Lost and Found** at Maha Kumbh

Similarly, 598 devotees were traced and brought back to their families during the Makar Sankranti bathing event, while 813 pilgrims were reunited during Basant Panchami Amrit Snan. In addition to these major events, the centres have facilitated over 10,000 reunifications, with a significant portion involving women. Centres were inaugurated by Chief Minister Yogi Adityanath on December 7, 2024, to ensure smooth and hassle-free experiences for attendees.

## **Ex-Goa MLA Lavoo Mamiedar** 1 **Dies After Altercation with Auto Driver in Belagavi**

Former Goa MLA Lavoo Suryaji Mamledar, who represented the Ponda constituency from 2012 to 2017, tragically passed away after a physical altercation with an auto Saturday afternoon.

Mamledar, 69, was traveling to Belagavi and had checked into a hotel in Khade Bazar when the incident occurred. According to police, his car brushed against an autorickshaw while navigating a narrow curve. This led to a dispute with the auto driver, who demanded compensation for the damage. Mamledar refused to pay and proceeded towards his hotel.

However, the auto driver followed him to the hotel and allegedly attacked Mamledar outside his car. The former MLA collapsed shortly after the confrontation and was Sawant wrote. rushed to the government civil hospital, where he was declared dead. Belagavi City DCP Rohan Jagadeesh confirmed that the auto driver has been taken into custody, and authorities are investigating the

cause of Mamledar's death, including any potential underlying health conditions.

Lavoo Mamledar, a retired police officer, had served as an MLA from the Maharashtrawadi Gomantak Party (MGP) in 2012 but lost his driver in Belagavi, Karnataka, on re-election bid in 2017. He was later expelled from MGP for anti-party activities and briefly joined the Trinamool Congress before switching to Congress in 2022. He contested the 2022 elections from the Marcaim constituency but lost again. Goa Chief Minister Pramod Sawant expressed his sorrow on social media, remembering Mamledar for his dedicated service as both a police officer and a legislator. "The State administration is in close coordination with the local authorities in Belagavi to ensure a thorough investigation into the circumstances surrounding the incident,"

Several political leaders, including Congress MLA Carlos Ferreira, also expressed condolences, describing Mamledar as a compassionate and empathetic individual, deeply respected by all who knew him.

## **US Plane Carrying 120 Indian Migrants** to Land in Amritsar

A special flight carrying 120 illegal Indian immigrants, deported from the US, is scheduled to land in Amritsar around 10 pm on saturday. This marks the second batch of deportees under the Trump administration's crackdown on illegal immigration. Demographics of Deportees:

Over 60 deportees are from Punjab.

More than 30 hail from Haryana. The remaining deportees are from Gujarat, Uttar Pradesh, Goa, Maharashtra, Rajasthan, Himachal Pradesh,

and Jammu and Kashmir. A third flight, carrying 157 deportees, is expected to arrive in Amritsar on February 16, with 59 from Haryana, 52 from Punjab, and others from states

like Gujarat. Background on Deportation:

■ The first deportation flight carrying Political Reactions: 104 illegal Indian immigrants landed on February 5. Most of these individuals had entered the US illegally through risky routes and spent large amounts of money for their migration attempt.

Many deportees expressed their desire for a better life for their families in the US, though they were caught at the border and faced restraints while Mann criticized the central governbeing deported.



External Affairs Minister S. Jaishankar clarified that the restraints on deportees were part of the US's standard operating procedures and that women and children were not restrained. He assured that India is engaging with the Trump administration to ensure deportees' proper treatment.

Punjab Chief Minister Bhagwant ment for choosing Amritsar as the

landing site for deported immigrants, while the BJP dismissed the issue as exaggerated.

Prime Minister Narendra Modi addressed the matter of illegal immigration and human trafficking, stating that those living illegally in the US would be returned to India. ## RBI Defends Credit Rating Firms' Access to Banking Data, Says No Consent Needed

The Reserve Bank of India (RBI) has defended the practice of credit rating companies (CICs) collecting banking data, stating that these companies are legally empowered to access individuals' financial information for the purpose of creating credit scores. In a counter affidavit filed before the Supreme Court, the RBI argued that consent from borrowers is not necessary as per the Credit Information Companies (Regulation) Act, 2005 (CICR Act), which regulates such activities.



The case stemmed from a petition filed by Surya Prakash, a Bengaluru-based entrepreneur, who accused

CICs of illegally collecting financial data without proper consent. He further alleged that the collected data is sold to members of the CICs, violating privacy rights. Prakash's plea also claimed that the RBI and the Centre are involved in an "unholy alliance" with these firms, undermining citizens' rights. In response, the RBI asserted that the CICR Act was specifically enacted to prevent the accumulation of non-performing assets (NPAs) in the banking sector by enabling lenders to access credit information for informed decision-making.



## Karnataka State Receives Rs 10.27 Lakh Crore in Investment Proposals at Investors' Summit

Bengaluru, Feb 16

Karnataka has secured investment proposals worth Rs 10.27 lakh crore during the three-day Invest Karnataka summit held in Bengaluru. The state is aiming to convert at least 70% of these commitments into tangible projects over the next two years, which is expected to generate over six lakh

At the close of the summit, **MB Patil**, Karnataka's Minister for Large and Medium Scale Industries, announced that 45% of the total proposed investments are directed toward North Karnataka, aligning with the government's push for regional economic balance. Notably, nearly 75% of the proposals are aimed at areas outside Bengaluru, reinforcing the state's focus on decentralizing growth.

The total investment comprises Rs 4.03 lakh crore from publicly announced commitments and Rs 6.23 lakh crore from MoUs signed during the summit. A large portion of the investments is geared toward the renewable energy **sector**, which accounts for 41% of the



total proposals, followed by manufacturing at 25%. Other sectors include infrastructure, logistics, and startups. Some of the key investments announced include **JSW Group's** Rs 1.2 lakh crore in renewable energy, cement, and steel, and Baldota Steel & **Power Limited's** Rs 54,000 crore for an integrated steel plant. The **semiconductor industry** received a boost with Lam Research's Rs 10,000 crore commitment to manufacturing and R&D. In the automotive sector, Volvo announced a Rs 1,400 crore investment

in electric truck manufacturing, while Honda committed Rs 600 crore for electric two-wheeler production. Samvardhana Motherson and Tata Advanced Systems Limited (TASL) also made significant investments in manufacturing and assembly units.

The renewable energy sector saw further commitments, such as Hero **Future Energies'** Rs 22,200 crore for green energy and Mahindra Susten's Rs 36,000 crore for green energy and tourism. Additionally, Suzlon Energy pledged Rs 21,950 crore for wind power projects, and Emmvee Energy committed Rs 15,000 crore for solar photovoltaic manufacturing. Logistics and industrial parks also saw significant investments, with ESR Advisers planning a Rs 2,500 crore expansion and TVS Motor Company earmarking Rs 2,000 crore for R&D. The **food processing sector** received investments from Balaji Wafers and Wings Viterra, amounting to Rs 550 crore and Rs 350 crore, respectively.

These announcements signal a robust trajectory for Karnataka's economic development in the coming years.



#### **Emphasis on Enforcing Child Protection Policy in Karnataka Schools**

The policy is designed to provide a safe and supportive environment for students, ensuring their well-being both inside and outside the classroom. Ramatnal's warning comes as part of the ongoing efforts to strengthen child protection measures in educational institutions. The RTE Act mandates free and compulsory education for children aged 6 to 14, while the Child Protection Policy aims to prevent abuse and exploitation in schools. The KSCPCR is committed to ensuring these laws are rigorously followed, and will take appropriate steps if schools fail to

## **Indian Railways to Introduce Train Connectivity to** Bengaluru Airport, Announces **Ashwini Vaishnaw**

Railway Minister Ashwini Vaishnaw announced on Saturday that Indian Railways will soon provide train connectivity to Kempegowda International Airport, Bengaluru, enhancing the city's already diverse travel options. The airport is currently accessible via metro rail, road, and the suburban railway project managed by the Rail Infrastructure Development Company (K-RIDE).

Vaishnaw highlighted that while the metro, road, and K-RIDE services are under development to improve urban rail connectivity, the addition of a dedicated train service to the airport will provide a much-needed alternative for

Addressing reporters, Vaishnaw explained that while there are technical challenges to overcome—particularly the construction of a rail flyover—the Railway team is actively working on resolving them. During a previous visit to Bengaluru, Vaishnaw experienced a 40-45 minute train ride from the airport to the city, which he described as comfortable. However, the need for infrastructure adjustments, including the flyover,



was noted as a hurdle.

The K-RIDE project, a joint venture between the Center and the state, is focused on enhancing Bengaluru's urban rail network. With the new railway connectivity, Vaishnaw said, travelers will soon have another convenient option to reach the airport, complementing the ongoing developments in metro and road transport.

## **RBI Defends Credit** Rating Firms' Access to Banking Data, Says No **Consent Needed**

The RBI explained that the law permits CICs to collect, store, process, and share credit information without needing explicit consent from individuals. The RBI's counter affidavit also emphasized that four CICs — TransUnion CIBIL, Experian, Equifax, and CRIF High Mark have been registered to collect and disseminate credit information. Furthermore, it highlighted safeguards in place to protect users' data. The RBI stated that CICs must maintain the confidentiality of the information, providing it only to authorized users. Any unauthorized disclosure could result in fines of up to Rs 1 crore. Another point raised by Prakash's petition was the retention period for credit data. The petitioner claimed that CICs were storing data beyond the legally mandated 7-year period, infringing on privacy rights. However, the RBI clarified that the 7-year retention is the minimum requirement, and there is no upper limit specified in the CICR Act for how long the data can be kept. On the issue of financial discrimination, where CICs generate credit scores and classify individuals as "creditworthy" or not, the RBI dismissed these concerns as baseless, stating that credit scores are not discriminatory but rather a tool to help lenders assess financial reliability. The case is slated for further hearing by the Supreme Court on February 17, with K Parameswar appointed as amicus curiae to assist in the matter.

### Jayalalithaa's Multi-Crore Assets, Jewels Returned to **Tamil Nadu Government**

In a significant development, a special court in Bengaluru has ordered the handover of former Tamil Nadu Chief Minister Jayalalithaa's assets, including gold ornaments and properties worth thousands of crores, to the Tamil Nadu government. This comes after the Supreme Court upheld her conviction in the disproportionate assets case.

On February 15, 2025, Special Court Judge H.A. Mohan issued an order to return 1606 items belonging to Jayalalithaa, including a gold crown, gold sword, watches, and a gold dabu, along with 27 kilograms of gold and diamond jewelry. These valuables, along with old currency notes worth ₹2,20,384, bank fixed deposits worth ₹10.18 crore, and a luxury bus, were previously held

al Tamil Nadu districts, including Chennai, Thanjavur, and Kanchipuram, be reserved for public use instead of auctioned off. These lands can either be distributed to the poor or sold in a public auction, with the proceeds earmarked for public welfare, including rural infrastructure, education, and healthcare. The court also ruled that the gold ornaments should be sold to the Reserve Bank of India, with the proceeds benefiting the people of Tamil Nadu. Moreover, the convicts, including Sasikala, paid a fine of ₹20 crore, of which ₹13 crore was allocated to the Karnataka government as litigation fees. This handover of assets marks the culmination of a lengthy legal process, with Jayalalithaa's once massive personal fortune now being repurposed for the public good in Tamil Nadu.

#### Karnataka Court Rejects Bail Plea of Harvana Man Accused in Telangana Businessman's Murder

A district court in Kodagu, Karnataka, has rejected the bail plea of Ankur Rana, a 32-year-old driver from Haryana, accused of conspiring to murder Telangana businessman Ramesh Kumar. Rana is alleged to have collaborated with Kumar's estranged wife and her boyfriend in the gruesome killing, which took place in October 2024.


Rana, along with Panthalu Niharika alias Nikita, Kumar's 29-year-old estranged wife, and her boyfriend Mai Reddy Nikhil, 28, was arrested following the discovery of Kumar's semiburnt body in a private coffee estate in Suntikoppa, Kodagu. Kumar's body was found on October 8, 2024, nearly 12 days after the crime. The investigation revealed that the murder was meticulously planned by Niharika, who sought to gain access to a property worth Rs 8 crore, which her husband had not shared with her.

The police probe showed that Niharika and Rana,



who had met in prison in 2021, orchestrated the murder after Niharika lured Kumar to a meeting on October 4. Rana allegedly strangled Kumar in a car on the outskirts of Hyderabad before transporting the body over 850 km to Kodagu in a Mercedes Benz loaned to Kumar by a friend.

During the investigation, Rana escaped from police custody in October but was later re-arrested in Jaipur, Rajasthan, in November 2024. The court cited his previous escape from custody as one of the reasons for denying bail. The court also emphasized the severity of the crime and Rana's apparent disregard for the law. The case has also uncovered Niharika's criminal past, including her involvement in honey-trapping schemes targeting software engineers in Bengaluru, further complicating the investigation. Rana's role in the crime, along with Niharika's actions, highlights the disturbing lengths to which the conspirators went to carry out the murder.



#### Bengaluru Cops Catch **Elusive Thief Who** 'Ghosted' Them for Years

Bengaluru, Feb 16 In a gripping turn of events, Bengaluru police have finally caught a thief who village in Gujarat's Anand had been eluding them for district. Living in Bengalunearly six years, leaving only fingerprints behind at multiple crime scenes. The burglar, who operated between 2010 and 2016, successfully broke into houses and made off with valuables, particularly gold, in just 10-15 minutes. Despite repeated collection of his fingerprints, investigators treated as a respected elder couldn't make any headway, as the prints failed to match any known records. The breakthrough came in 2016, when a CCTV camera captured footage of the suspect entering a house in Bengaluru's Vinayanagar. The police, led by ACP S K Umesh, circulated the visuals among officers and informants, but the case went cold for another three months until a keen-eyed constable, Sadiq Pasha, spotted a man resembling the suspect. His quick of the persistence needed thinking led to a chase, cul-

The thief, identified as Talapad Navaganbhai alias Shankar, hailed from Ode ru since 2007 with his second wife, Shankar had been melting and recasting stolen gold at a foundry he had set up in his residence. Investigators also uncovered his ties to Gujarat, prompting a team to travel there to recover the stolen goods. To their surprise, Shankar was in his village, where he had even built a temple for his father.

Despite his community's reverence, Shankar's criminal activities caught up with him, revealing a man who lived a double life. His arrest marked the end of a years-long pursuit and was a testament to the dedication of Bengaluru's police officers, who refused to give up on a case that had seemed unsolvable. The case serves as a reminder in solving complex crimes, minating in the suspect's no matter how elusive the capture while attempting criminal may seem.

## Foreign Currency Smuggling Racket Exposed at **Bengaluru Airport; Three Arrested**

Bengaluru, Feb 16

A major foreign currency smuggling racket was uncovered at Kempegowda International Airport when security personnel arrested three individuals attempting to smuggle currencies worth Rs 2.12 crore. The arrested suspects include two Sri Lankan nationals, Vimalraj Thuraisingam and Thileepan Jayanthikumar, as well as Indian national Veera Kumar.

The discovery was made by a sharpeyed officer from the Central Industrial Security Force (CISF), Vishal Kumar, who was part of the Crime and Intelligence Wing at the airport. He noticed suspicious behavior from the three passengers, which led him to initiate an investigation.

Upon searching the individuals, authorities found substantial amounts of efforts to combat such crimes. foreign currencies in their possession. The authorities are now investigating

These included Euros, US Dollars, Rials, and several other international denominations. The total value of the seized currencies amounted to Rs 2.12 crore, making it a significant operation.

The three suspects were immediately detained, and the Enforcement Directorate (ED) has taken over the investigation. The authorities suspect that the smuggled foreign currencies were intended to be illegally exported, bypassing official channels and regulations. This bust highlights the persistent issue of illegal currency smuggling at airports, with international networks often attempting to move large sums of money across borders without proper documentation. The CISF, in collaboration with other enforcement agencies, continues to monitor suspicious activities at the airport as part of its ongoing



whether this incident is part of a larger smuggling network and are working to trace the source and intended destination of the seized funds. As the investigation progresses, further arrests may be made.

This is the latest in a series of similar incidents where customs and security personnel have intercepted large-scale smuggling operations at Bengaluru's Kempegowda International Airport, which serves as a key hub for both domestic and international flights.

#### Four Arrested for Brutal Murder of **Notorious Criminal Bhagappa Harijan** in Karnataka

alias Gadigeppa Shankarappa Benakopp.

Bhagappa's daughter, Gangubai, filed a complaint naming **Prakash** as the prime suspect in the murder.

The motive for the killing is believed to be linked to a previous murder involving Ravi Melinakeri, a relative and former business associate of Bhagappa, who was allegedly murdered by Bhagappa's asso-

Bhagappa had a long criminal history, with involvement in over ten criminal cases, including **six murders**. The police continue to investigate the case thoroughly as they gather more details about the motive behind this brutal attack.

## Bangalore Development Authority Forces Panchayat to Withdraw Occupancy Certificate for 86 Villas

Bengaluru, Feb 16: In a significant development, the Bangalore Development Authority (BDA) has compelled the Bettahalasur panchayat to withdraw the Occupancy Certificate (OC) issued for 86 villas in the ultra-luxurious villa project 'After The Rain' located in Bengaluru North. The issue arose when the builder, Total Environment Building Systems Private Limited, after two failed attempts to secure the OC from the BDA, obtained it from the local panchayat, which did not have the authority to issue such a certificate.

After learning of the unauthorized OC issuance, BDA officials ordered the panchayat to retract the certificate, which was subsequently withdrawn on February 14, 2024. The panchayat had issued the OC on January 10, 2024, despite the project falling under BDA's jurisdiction, which is the authorized body for granting such approvals.

The builder had been granted multiple extensions to complete the 240-villa project, originally due for completion by June 30, 2019. With three extensions, the final deadline was set for April 30, 2022. Correspondence obtained by The New Indian Express reveals that the panchayat was informed by BDA about its jurisdiction over the project area, thus requiring the OC to be withdrawn.



#### **Illegal Dumping of** Sewage and Fish Waste in Mangaluru: Tankers Fined

Mangaluru, Feb 16:

Mangaluru City Corporation (MCC) officials have seized three tankers for illegally dumping sewage and waste into the Nethravathi River and wet wells in Mangaluru. The MCC team uncovered an illegal network transporting sewage from Kerala, via Talapady, into Mangaluru. Two of the tankers were fined for carrying sewage, while a third tanker was penalized for disposing of fish waste

MCC had authorized 20 suction tankers to transport septage from septic tanks to designated wet wells for treatment, and these vehicles are monitored using GPS and geofencing to track their movement. Following complaints about illegal dumping, MCC officials conducted a raid on February 7 and intercepted a tanker entering Mangaluru through Talapady. Further investigations revealed the ongoing illegal disposal activities, leading to penalties being imposed on the responsible tankers.

## A Forgotten Crisis? Nagaland's Peace Process **Drags On For Years But Sees No Solution**

The Naga peace process has been dragging on for decades, with little to show for the significant efforts made by both the Indian government and insurgent groups. Despite multiple agreements, the situation remains unresolved, leaving Nagaland in a state of turmoil. On February 12, the National Socialist Council of Nagaland (Isak-Muivah) or NSCN (I-M) clarified that the 2015 Framework Agreement with the Indian government should not be seen as the final peace deal. Instead, it emphasized that the agreement was just a starting point for future negotiations and should not be confused with the Agreed Position signed with the Naga National Political Groups (NNPGs) in 2017.

The NSCN (I-M) has been in talks with New Delhi since 1997, with the 2015 Framework Agreement initially hailed as a historic step. However, internal disagreements and key demands, such as the call for a separate Naga constitution and flag, have kept the peace process from reaching a resolution. The Indian government has been firm in rejecting these demands, fearing that granting such concessions would encourage separatism, as seen in Jammu and Kashmir.

Recently, 21 opposition parliamentarians raised concerns about the stalled peace process, pointing out the absence of a full-time interlocutor since 2021. They also criticized the lack of



transparency in the negotiations. However, the MPs overlooked the Agreed Position signed by the NNPGs, sidelining a crucial part of the peace process. This omission undermines the role of the NNPGs, who represent a significant portion of the Naga population and have worked alongside the NSCN (I-M) to resolve the issue.

Additionally, the former interlocutor, N Ravi, caused confusion by claiming that the talks had concluded in 2019. If the talks were indeed completed, why is the peace process still

at an impasse? This raises questions about whether the NSCN (I-M) has been stalling the process by refusing to compromise. The demand for a separate constitution and flag remains a major obstacle. The Indian government cannot afford to grant such provisions, as they would set a dangerous precedent for separatism. For peace to prevail, all parties must engage in constructive dialogue and work together to find a lasting solution that addresses the aspirations of all Naga

However, for many, the core issue was not Marxism but a struggle against perceived injustice by the state. This makes the situation complex, as force cannot be the only solution.

While security forces are necessary for tackling violent uprisings, a more constructive and compassionate approach could yield better results. A ceasefire, even for a short period, could encourage the Naxals to come forward and surrender. The government could promise rehabilitation, address individual cases, and ensure justice for those who have grievances. Such an approach would not only prevent further bloodshed but would also offer a chance for

In contrast, the current strategy of relentless force and the ongoing "war on Naxals" has resulted in heavy casualties on both sides. Reports of killings in Chhattisgarh and other Naxal-affected regions only add to the cycle of violence. The government's current rhetoric of eradicating Naxalism by 2026 is concerning because it risks alienating the very people who need to be brought into the fold.

A broader strategy must include political initiatives, land reforms, and socio-economic inclusion for the tribals who have been left behind. The state must stop viewing the Naxals as a simple enemy to be defeated and instead address the root causes of their discontent. A balanced approach, combining firmness with empathy, could lead to long-lasting peace.

The Naxal issue cannot be solved on a strict timeline. Past home ministers, such as P Chidambaram and Rajnath Singh, set deadlines that proved unrealistic. Instead, the government should focus on genuine engagement with the people and recalibrate its approach to foster peace and stability without resorting to endless violence.



#### Law says everyone innocent until proven guilty: J&K CM Criticizes Dismissals

Jammu and Kashmir Chief Minister Omar Abdullah raised concerns on Saturday over the dismissal of government employees accused of terror links by the Lt Governor, questioning the legal process behind such actions. He highlighted that the law presumes innocence until proven guilty and emphasized that dismissals without clear proof or a fair hearing could undermine this principle.

Lt Governor Manoj Sinha invoked Article 311 (2) (c) of the Constitution on Saturday to terminate the services of three government employees after investigations by law enforcement and intelligence agencies allegedly linked them to terror activities. This follows a series of similar dismissals over the past few years, bringing the total number of government employees dismissed on similar grounds to over 70.

While reacting to the latest dismissals, Abdullah raised concerns about

the lack of a fair trial, pointing out that every accused individual is entitled to a hearing and an opportunity to prove their innocence. "If there is proof against them and they are given an opportunity to clear the allegations but fail, then such steps could be justified," Abdullah said. He also emphasized that the law presumes all accused are innocent until proven guilty.

Furthermore, Abdullah responded to questions regarding Punjab Chief Minister Bhagwant Mann's remarks about the government choosing Amritsar as the landing site for Indian deportees from the United States. Abdullah stated that Mann, as the CM of Punjab, had a vested interest in the issue and would naturally express his concerns regarding such decisions.

Punjab Chief Minister Bhagwant Singh Mann has vehemently opposed the Centre's decision to land deportation flights carrying Indians back from the US at Amritsar airport, accusing the BJP-led Union government of orchestrating a conspiracy to tarnish Punjab's image.

Addressing the media, Mann strongly criticized the government's actions, claiming that despite Punjab's vital contributions to the country as the "food bowl" and "sword arm," the Cen-

## PM Modi's Meeting with Trump Called a "Masterclass" by US Media

#### Protests In New York As 'Transgender', 'Queer' Scrubbed From Rights Website

The National Park Service (NPS) has removed references to transgender and queer individuals from its website dedicated to the Stonewall National Monument, a key site in the LGBTQ rights movement. The monument, located at the historic Stonewall Inn in Greenwich Village, commemorates the 1969 Stonewall riots, which were pivotal in the fight for LGBTQ rights.

The website, which previously included the acronym "LGBTQ" (Lesbian, Gay, Bisexual, Transgender, and Queer), now only uses "LGB," erasing mentions of transgender and non-binary individuals who do not identify strictly as male or female. This change has sparked protests in New York City, with hundreds of activists gathering to express their outrage. Slogans like "Silence = Death" and "There's no Stonewall without the T" were displayed during the demonstration, calling for the recognition of transgender people's vital contributions to the movement

The controversy comes amid broader political shifts, as President Donald Trump has advocated for a return to a binary definition of gender. This stance has been reflected in various executive orders, such as one that restricts gender recognition to male and female, excluding non-binary and transgender individuals.

# Hamas Releases 3 Israeli Hostages In Exchange For 369 Palestinian Prisoners

On Saturday, Hamas released three Israe-li hostages—Israeli-Argentine Yair Horn, Israeli-American Sagui Dekel-Chen, and Israeli-Russian Sasha Troufanov—following successful mediation efforts by Egyptian and Qatari officials. The hostages had been seized by Hamas militants during an attack on October 7, 2023. The release, part of a broader prisoner swap agreement, saw 369 Palestinian prisoners freed in exchange for the Israeli captives. The hostages were handed over to the International Committee of the Red Cross in Gaza's southern city of Khan Yunis before being transported to

Israeli forces. The Israeli military confirmed that the freed hostages have returned to Israel and are reportedly in good health. The hostages were seen holding gift bags and certificates marking the end of their captivity.

This release is part of ongoing efforts to maintain a fragile ceasefire between Israel and Hamas. However, tensions remain high in the region. The Israeli military has been accused of obstructing aid shipments to Gaza, worsening the already dire humanitarian crisis. Hamas has warned that it may suspend further hostage releases if Israel does not meet its aid obligations.





# Donald Trump Fires 'Disease Detectives' As Bird Flu Fears Rise

In a significant move that has raised concerns within the public health community, the Trump administration dismissed nearly half of the elite Epidemic Intelligence Service (EIS) program officers, widely known as "disease detectives." The decision, which affects about 30 officers from two graduating classes, comes at a time when fears of a potential bird flu pandemic are growing, as well as growing concerns over future health crises.

The cuts, as part of the broader downsizing efforts by Elon Musk's Department of Government Efficiency, are particularly controversial because the affected individuals had been integral to the CDC's ability to respond to outbreaks. The EIS program, established in 1951, has been a critical part of the CDC's efforts in investigating and containing health threats such as Ebola and Covid-19. Former officers, who have helped eliminate smallpox globally, have expressed deep concern over the cuts.

"I'm so angry," said a senior epidemiologist from the CDC, who supervises several of the dismissed employees. "We're on the verge of potentially another pandemic and we're firing the people who have probably more expertise than anyone else in the country collectively." The decision affects the class of 2024 and leaves the class of 2023 in uncertain status, though some officers remain protected due to their hiring through different mechanisms under the US Public Health Service.

With approximately 1,300 CDC employees dismissed in total, the EIS program's elimination is seen as a direct threat to national health security. Experts like infectious disease physician Amesh Adalja have voiced strong opposition to this move, emphasizing the program's importance to the nation's health infrastructure.



# Yunus and Musk in talks for Starlink satellite service in Bangladesh

Bangladesh's Chief Adviser, Professor Muhammad Yunus, revealed on Friday that he has held discussions with Tesla CEO Elon Musk about the possibility of launching Starlink satellite internet services in Bangladesh.

In a post on X (formerly Twitter), Yunus shared details of his meeting with Musk, stating, "Had great meeting with Mr @ elonmusk. We agreed to work together. Hoping to launch Starlink in Bangladesh soon together with him."

The conversation took place following a video call on Thursday, where Yunus and Musk explored potential collaborations, specifically to introduce Starlink, a satellite internet service developed by Musk's company SpaceX. The service, which aims to provide high-speed internet access in underserved areas, could significantly improve connectivity in Bangladesh, where internet access remains a challenge in rural and remote areas.

Yunus also extended an invitation to Musk to visit Bangladesh for the potential launch of the service. Musk responded positively to the invitation, underscoring the importance of the initiative for Bangladesh's development.

The collaboration is expected to play a pivotal role in enhancing internet accessibility across Bangladesh, offering a solution to the country's digital infrastructure challenges. If successful, the Starlink service would help bridge the connectivity gap, providing high-speed internet to more people and businesses, contributing to the country's growth.

## India's Merchandise Exports Projected to Reach \$446.5 Billion in FY25



India's total merchandise exports for the financial year 2024-25 are expected to reach \$446.5 billion, marking a 2.2% increase from the previous fiscal year, according to the Export-Import Bank of India. In the fourth quarter of FY25, goods exports are forecasted to hit \$124.8 billion, reflecting a 3.64% year-on-year growth. The positive growth trend is anticipated to continue into the first quarter of FY26, although challenges such as trade policy uncertainty and geopolitical tensions remain risks to the outlook.

## **India's Forex Reserves Grow for Third Consecutive** Week, Adding \$7.65 Billion



India's foreign exchange reserves have increased for the third consecutive week, following a period of nearly four months of decline. As of the week ending February 7, the reserves rose by \$7.65 billion, reaching a total of \$638.261 billion, according to data from the Reserve Bank of India (RBI). This marks a significant rebound after a prolonged downward trend that saw reserves drop in 15 of the previous 16 weeks, hitting an 11-month

The decline in India's forex reserves began after they peaked at an all-time high of \$704.89 billion in September. As of now, reserves are approximately 10% lower than their peak. The decrease in reserves is widely attributed to the RBI's interventions aimed at curbing a sharp depreciation of the Indian Rupee. The Rupee is currently near its historic low against the US dollar, prompting the central bank to take action to stabilize the currency.

The latest RBI data reveals that India's foreign currency assets (FCA), which make up the largest portion of the country's forex reserves, stand at \$544.106 billion. Additionally, gold reserves are valued at \$72.208 billion.

India's forex reserves are considered sufficient to cover approximately 11 months of projected imports. In 2023, India's foreign exchange reserves increased by around \$58 billion, a contrast to the \$71 billion decline in 2022. In 2024, reserves have grown by just over \$20 billion.

Foreign exchange reserves are crucial for a nation's economic stability, as they provide a buffer against external shocks, such as currency volatility or global market fluctuations. The RBI frequently manages liquidity by buying or selling foreign currencies, including dollars, to prevent excessive fluctuations in the exchange rate. The strategic purchase of dollars strengthens the Rupee, while selling dollars helps mitigate depreciation pressures.

## **Gold and Silver Prices Soar Amid Heavy** Buying, Silver Hits Rs 1 Lakh Mark

Gold prices surged to a new all-time high of Rs 89,400 per 10 grams on Friday, witnessing a sharp increase of Rs 1,300, driven by heavy buying from jewellers and retailers. This rise follows a closing price of Rs 88,100 per 10 grams the previous day, according to the All India Sarafa Associa-

Gold of 99.5% purity also saw a similar climb, increasing by Rs 1,300 to hit Rs 89,000 per 10 grams, compared to its previous close of Rs 87,700 per 10 grams. The relentless demand from the retail sector, particularly due to festival-related purchases and a favorable sentiment in the global market, has contributed to this steep price hike.

In addition to gold, silver prices also witnessed a significant ral- As demand for both gold and silver remains high, particularly in ly, rising by Rs 2,000 to touch Rs 1 lakh per kilogram. The metal had closed at Rs 98,000 per kilogram on Thursday. This sharp rise marks silver's highest price in four months, and it comes as

a result of a combination of factors including investor interest and heightened buying activity in the retail market.

Futures trading on the Multi Commodity Exchange (MCX) also showed an upward trend for gold. Gold contracts for April delivery rose by Rs 184, bringing the price to Rs 85,993 per 10 grams, reflecting market optimism and expectations of continued demand. Experts believe that the upward momentum in gold and silver prices could persist due to factors such as geopolitical tensions, inflation fears, and a weaker dollar, all of which tend to drive investor interest toward safe-haven assets like precious metals.

A recent claim circulating on social media suggested that Zepto, the quick-commerce platform, had partnered with Skoda India to deliver cars to customers within 10 minutes. The post, shared by a user on X (formerly Twitter), read: "Big news! Skoda and Zepto are partnering to deliver cars in just 10 minutes." However, PTI Fact Check has debunked the claim, finding it to be false.

Zepto clarified that the campaign was not about delivering full-scale vehicles but was focused on generating interest in Skoda Kushag test drives. The campaign, which launched in early February, was designed to create curiosity around Skoda's latest offerings, particularly the Kushaq, and was not related to any 10-minute car delivery service.

To investigate the claim, the PTI Fact Check Desk traced the viral image using Google Lens and found that several social media users had shared the same post, which led to confusion. A closer look at Zepto's official Instagram account revealed a post from February 4, which included a teaser about a collaboration with Skoda In-



dia. The caption stated, "Humare pass mixer hai, phone hai, tablet hai, aur abb...Coming soon on 8th Feb!" This post was shared by both Zepto and Skoda India, teasing an upcoming announcement but not about car deliveries.

Zepto's partnership with Skoda was aimed at promoting the test-driving experience, not facilitating quick car deliver-

ies. The post created curiosity, leading to a misunderstanding about the nature of the campaign.

Thus, the viral claim of Zepto offering 10-minute car deliveries is not true. Instead, the focus was on a promotional campaign designed to generate buzz around Skoda's test drives, not vehicle deliveries.




