**TPN Correspondent Bengaluru, Feb 18** Tensions within the Karnataka Congress have resurfaced, with several ministers close to Chief Minister Siddaramaiah once again questioning the continued tenure of D.K. Shivakumar as the state party president. Despite earlier efforts to quell factionalism, the simmering discord has intensified following the Congress's performance



in the Delhi Assembly elections. Ministers like Co-operation Minister K.N. Rajanna and Public Works Minister Satish Jarkiholi, who are considered allies of Siddaramaiah, have raised concerns over the "one man, one post" policy, demanding clarity on whether Shivakumar should remain in his role until the Lok Sabha elections. The debate also touches on whether Shivakumar, currently both the state Congress chief and Deputy CM, should continue in both positions.Shivakumar has maintained silence on the leadership demands but defend-

ed Siddaramaiah's role, stating, "Siddaramaiah is our leader. His name should not be misused every day." Meanwhile, some of Siddaramaiah's supporters argue for his continued leadership, asserting that his experience and political clout are critical for the party's success in upcoming elections.In a broader context, the Karnataka Congress's internal struggle over leadership positions highlights ongoing power struggles, with Siddaramaiah's long-time supporters seeking to ensure his continued influence while Shivakumar aims to solidify his position.

## **Gyanesh Kumar Appointed as New Chief Election Commissioner**

**TPN Correspondent** New Delhi, Feb 18 Gyanesh Kumar has been appointed as the new Chief Election Commissioner (CEC), the Union Law Ministry announced. His appointment comes after a meeting of the Election Committee, which included Prime Minister Narendra Modi, Union Home Minister Amit Shah, and Leader of Opposition Rahul Gandhi. Gyanesh Kumar, who is the senior-most Election Commissioner, will succeed Rajiv Kumar, whose term concludes with his retirement at the age of 65 on Tuesday. The new Chief Election Commissioner will hold office for a term of six years or until reaching the age of 65, whichever comes first. Kumar's appointment marks a significant moment as he becomes the first Chief Election Commissioner to be appointed under the new law regarding the selection of Election Commissioners, a law that has recently come into effect. The selection process took place at the Prime Minister's



Office in South Block, Delhi, on Monday evening, where the Election Committee recommended the names of candidates shortlisted by the search committee.Despite the smooth transition, the announcement was met with some political contention. The Congress party had earlier urged the government to delay the appointment until the Supreme Court hears the petition regarding the formation of the selection committee, scheduled for February 19. Congress leaders argue that the appointment should be put on hold until the court gives its opinion on the matter. As Gyanesh Kumar takes charge, his leadership will be closely watched, particularly as he steps into the role of ensuring free and fair elections at a crucial time for India's democratic processes.

# **State Government Hikes Fees for Birth and Death Certificates**

Certificate fees raised from ₹5 to ₹50

**Fines for delayed applications** significantly increased

#### Citizens struggle with added financial burden

The Karnataka state government has issued an order increasing the fees for birth and death certificates, causing widespread concern among the public. The certificate, which was earlier available for just ₹5, will now cost ₹50, a tenfold increase that has hit the common man hard.

Birth and death certificates are essential for various official purposes. A birth certificate is required for school admissions, obtaining an Aadhaar card, and other legal processes. Similarly, a death certificate is mandatory for transferring property and settling legal matters related to a deceased individual. These certificates are typically issued by local bodies, including Gram Panchayats and the Revenue Department.

As per the new order, applications for birth and death certificates must be submitted within 21 days of the event to receive a free copy. If the application is made after 21 days but within 30 days, a fine of ₹20 will be levied, a steep increase from the previous ₹2 per day fine. For applications made between 30



days and one year after the event, a fine of ₹5 was previously applicable, but now citizens will have to pay ₹50, adding to their financial burden.

The sharp increase in certificate fees has led to confusion and frustration among citizens. In Bengaluru, around 450 to 500 applications for birth and death certificates are received monthly at each zonal office under the jurisdiction of the Municipal Corporation. The additional costs have created significant distress among the public, especially among lower-income groups who find the sudden increase unreasonable.

Citizens have expressed concerns that the

The unexpected hike in fees for birth and death certificates has triggered widespread dissatisfaction. While the government justifies the increase as a necessary step for administrative costs, the public sees it as an additional financial burden. ## Family of Four Found Dead in Mysuru Apartment

## **Aadhaar Seeding Initiative** Gains Momentum in Karnataka

The Karnataka state government has made significant progress in its Aadhaar seeding initiative, linking over 2,22,83,817 households to Aadhaar. Revenue Minister Krishna Byre Gowda highlighted the crucial role of this project in preventing illegal registrations, ensuring timely assistance to farmers, and delivering government benefits directly to beneficiaries.

To achieve this ambitious target, village administrative officers (VAOs) and village assistants played a pivotal role by actively visiting households and completing the Aadhaar linking process. Many of them went beyond their duties, even spending their own money to facilitate the project. Recognizing their efforts, the government has announced a remuneration of ₹1 per Aadhaar linkage under the Digital India Land Records Modernization Programme (DILRMP).Under the 'Bhu Suraksha' scheme, ₹4,45,67,634 has been allocated from the District Collector's Child Account for disbursing remuneration to VAOs and village assistants. According to the directive, those who have carried out Aadhaar linking until January 31, 2025, will be eligible for the compensation. For every 1,000 Aadhaar linkages, ₹2,000 will be provided—₹1,000 for the VAO and ₹1,000 for the village assistant. The Aadhaar linkage details will be collected from Tahsildars, ensuring accuracy and preventing discrepancies. The government has directed those payments be processed through the PFMS software to ensure transparency and efficiency. Additionally, officers have been instructed to verify records strictly and ensure that the remuneration is distributed based on the period of service. All necessary bank details of VAOs and village assistants must be collected from the concerned Tahsildars, and the payments must be processed by February 21, 2025, as per the official guidelines. Authorities have been advised to ensure that no delays or errors occur in the distribution process. The Aadhaar seeding project has been instrumental in improving the delivery of government services and reducing fraudulent transactions. The state government's recognition and financial support for field officers highlight the importance of grassroots efforts in executing large-scale digital

## Namma Metro Fare Hike Triggers Public **Transport Debate in Bengaluru**

Citizens, experts voice concerns over affordability

**BMRCL's expansion strategy** questioned

Metro yet to establish itself as a mass transport system

WBengaluru's public transport sector is in turmoil following Namma Metro's steep fare hike last week. The increased ticket prices have sparked widespread criticism, with commuters and experts debating the affordability and effectiveness of Metro services in the city. Bangalore Metro Rail Corporation Limited (BMRCL) officials are facing backlash for their stance on the issue, with their response further fueling public frustration. Despite its growing ridership, the Metro has not yet become Bengaluru's primary mode of transport. Long queues, crowded coaches, and limited connectivity prevent it from being the city's go-to transit option. Many commuters still rely on BMTC buses, autorickshaws, and taxis due to last-mile connectivity challenges. The city's traffic congestion and deteriorating road conditions continue to make commuting a daily struggle. Urban mobility experts attribute the Metro's shortcomings to a lack of coordination between government agencies. Prof. Ashish Verma from IISc pointed out that BMRCL seems to prioritize profit over public service. "Metro is



meant for public welfare, not as a business entity. The government must ensure affordable and seamless transport as a fundamental right," he stated. A senior official from the Urban Development Department acknowledged that the Metro is essential but noted that it is far from becoming Bengaluru's lifeline, akin to the Delhi Metro. Slow-paced construction and affordability remain significant hurdles in its expansion and accessibility. The fare hike has deterred many commuters, with BMRCL officials confirming a dip in ridership. Citizens argue that transportation costs in Bengaluru are among the highest in the country, with Metro fares adding to the financial strain. Sakshi K, a college student, highlighted her struggle: "Metro fares are high, and I still need to take an auto to reach college. This fare hike is unreasonable and forces me to cut back on other expenses."Experts emphasize that BMRCL's issues stem from an attitude problem and lack of account-

ability. They argue that the corporation must prioritize expansion in high-density corridors instead of focusing on connecting far-off towns like Bidadi and BMRCL is working on Phase-3 of the Metro, covering 44.65 km by 2029. However, concerns about slow progress persist. The Metro has only covered 76.95 km in 14 years, despite Bengaluru spanning 857 sq. km. The failure to enhance Metro frequency and capacity has further exacerbated commuter woes. Instead of nine-coach trains running every 90 seconds, only six-coach trains operate at intervals of 4-15 minutes, increasing waiting times and travel burdens. Rajkumar Dugar, founder of Citizens for Citizens, criticized the lack of planning in Metro coverage. "Government agencies work in silos. Though the BMLTA Act was passed in December 2022, it has not been activated yet. BMLTA should be the authority overseeing transport planning in Bengaluru," he said. Land acquisition issues, bureaucratic hurdles, and financial constraints continue to slow down Metro expansion. Multiple agencies, including the Railways, Waqf Board, and Forest Department, hold crucial lands needed for Metro projects, leading to prolonged clearance processes. Delays in contractor execution and financial setbacks further stall progress. Bengaluru's Metro expansion is critical to improving urban mobility, but its affordability and efficiency remain major concerns. While BMRCL has ambitious plans, the government must ensure rapid execution and better coordination to make Metro a viable transport solution for all citizens.

## Karnataka's State Action Plan for Clean Air Aims to Tackle **Pollution in Bengaluru**

In response to escalating air pollution levels in Bengaluru, the state government has unveiled the State Action Plan for Clean Air in Karnataka. This initiative, part of the National Clean Air Programme (NCAP), seeks to reduce emissions across sectors such as industry, transportation, agriculture, construction, and waste management. The plan's primary focus is addressing PM10 emissions, which have become a pressing concern due to heavy vehicular traffic and industrial activities in the city. It aims to control not just vehicular exhaust but also roadside dust and soil particles, both major contributors to poor air quality. Among the key provisions, the plan advocates for the replacement of solid fuels like coal with LPG to curb the harmful effects of burning wood and other solid fuels. The retrofitting of older power generators to meet the emission standards set in 2022 also plays a vital role in reducing pollution levels. The construction and demolition (C&D) sector, a significant source of airborne dust, will face new regulations under the plan. Bengaluru, the plan introduces air quality monitoring for 17 categories of "highly polluting" industries across Karnataka. With 28,716 industries currently in the state, including 2,652 classified as high-risk, the Karnataka State Pollution Control Board (KSPCB) is pushing industries to install continuous ambient air quality monitoring stations and publish their environmental data online. The plan also highlights the importance of managing electronic waste and other refuse in an environmentally sound manner. Recycling initiatives, composting, bio-methanation, refuse-derived fuel (RDF), and waste-to-energy technologies are some of the recommended practices for effective solid waste management. For longterm success, the document stresses the need for strong governance and financial backing, particularly during the initial phases of implementation. The plan aims to integrate climate-conscious strategies into Karnataka's broader development framework.In a related move, the Karnataka government has allocated Rs 535 crore under the 15th Finance Commission to support air quality improvement initiatives in Bengaluru. Shivakumar, who also oversees the development of Bengaluru, visited several ongoing roadwork sites to evaluate the progress and quality of the work. White-topping is currently underway on 97 roads, covering a 150 km

## Bengaluru's 10.8 km Major Arterial Road Set to **Improve Connectivity**

The new 10-lane stretch runs from Challaghatta (near the Namma Metro depot) on Mysuru Road to Kadabagere Cross on Magadi Road. It serves as an alternative route to the tolled NICE corridor, located approximately 2 km away. ## **Devanahalli Farmers Stand Firm Against Land** Acquisition for Bengaluru's New Railway Terminal

In the face of Bengaluru's ever-expanding growth, the government's proposal to build a massive railway terminal in Devanahalli, located on the city's outskirts, has sparked intense opposition from local farmers. The planned terminal is set to address the increasing railway congestion in the city but requires the acquisition of thousands of acres of land from five nearby villages. This has led to strong protests from farmers who fear losing their livelihoods. The government's vision is to establish a major railway terminal with 40 platforms and advanced tracks in Devanahalli taluk, which lies in Bengaluru Rural District. The proposed mega-terminal and suburban railway project aim to alleviate the strain on the current city railway station, which is running out of space due to the city's rapid growth. The government's plan to take over this land for the railway terminal has only intensified the farmers' opposition. Many of them are already preparing for a fierce struggle, as they are not willing to part with their land, despite the allure of development.The government con-

ducted a survey earlier to assess the land needed for the terminal and suburban railway lines. Despite the survey being completed, the farmers remain resolute. They have vowed to resist any attempts at land acquisition, with many planning to escalate their protests if authorities move forward with the process. As the situation develops, it remains to be seen whether the farmers' resistance will lead to a significant delay or revision of the government's project. The tension between rural landowners and urban expansion continues to grow in the region.

## Man Arrested for Duping KAS **Officer with Fake Job Offer Linked** to Chief Minister's Office

In a shocking case of fraud, a 45-year-old man, Raghavendra, has been arrested for allegedly duping a Karnataka Administrative Service (KAS) officer with a fake promise of a prime posting in Bengaluru. The accused, a former personal assistant to several legislators, reportedly claimed to have close ties with the Chief Minister's Office (CMO) and forged official documents to make his scam appear credible.According to police reports, Raghavendra approached the KAS officer and convinced him that he could secure a prestigious posting in Bengaluru. The officer, believing Raghavendra's claims, paid ₹50,000 as an advance to finalize the alleged appointment. To further support his fraudulent offer, Raghavendra provided a forged document that resembled an official note from the CMO, which included instructions for the Department of Personnel and Administrative Reforms (DPAR) secretary to approve the posting.

However, the DPAR officials grew suspicious upon reviewing the document and requested verification from the CMO. Upon closer inspection, the document was found to be a forgery, with the signature of the Chief Minister's secretary falsely applied. This revelation led to the exposure of the scam.Following confirmation of his involvement, police officers arrested Raghavendra from Ranebennur. He has been charged under Section 319 of the Indian Penal Code for cheating



by personation and has been remanded to judicial custody for 14 days after being produced before the ACMM court. Authorities revealed that Raghavendra had a history of misconduct, having previously worked in Vidhana Soudha as a personal assistant to multiple legislators before his dismissal for inappropriate behavior. His arrest has drawn attention to the growing concerns of fraud within official circles, highlighting the need for vigilance in government appointments. The case is under further investigation as authorities work to uncover any additional individuals involved in the scam.

# A worker sitting on a 500 feet high chimney: **Do you know what the demand is?**

TPN Correspondent/Karnataka, Feb 18 A worker who was dismissed from his job at the Pandavapura Cooperative Sugar Factory (PSSK) in Mandya staged a dramatic protest by climbing the factory's 500-foot-high chimney and refusing to come down for 15 hours. The worker, identified as Ramakrishna, demanded reinstatement and only agreed to descend after the management assured him that a decision would be taken by Wednesday. The PSSK sugar factory, once a prestigious establishment, was handed over to a private company five years ago after the government cited financial losses. At the time of the lease agreement, the factory's management assured workers that there would be no layoffs. However, over time, the company, Nirani Sugars, began terminating employees, violating the original agreement. Ramakrishna, one of the dismissed employees, took a desperate stand by climbing the towering chimney in the early hours of the morning, determined to protest against the management's decision.

Authorities, including police officials and factory representatives, attempted to persuade Ramakrishna to come down for hours. Despite their efforts, he refused, insisting that he would only descend if given a written order of reinstatement. His protest created panic among workers



and local residents, fearing for his safety. Eventually, after prolonged negotiations, the management board promised to review the decision by Wednesday, following which Ramakrishna agreed to come down.

This protest has highlighted the growing frustration among former employees of PSSK. Nirani Sugars, which took over the factory on a 40-year lease, initially agreed to continue employing the existing workers or provide them with a voluntary retirement scheme (VRS). However, in recent years, the company has gradually terminated employees, leaving many without a livelihood. The sudden layoffs have affected 45 long-term employees, pushing their families into financial distress.

Ramakrishna's protest underscores the ongoing struggles of workers who were promised job security but were later dismissed. The issue has now drawn attention to the working conditions under Nirani Sugars and whether the company has adhered to its contractual commitments. With the management set to make a decision on Ramakrishna's demand by Wednesday, other affected workers are closely watching the developments, hoping for justice and fair treatment.

## Mega alliance with AIADMK for 2026 Tamil Nadu assembly elections: Palaniswami

AIADMK general secretary Edappadi K. Palaniswami has announced that his party will lead the largest electoral alliance in the 2026 Tamil Nadu Assembly elections, positioning itself as the strongest contender against the ruling DMK. Speaking at a Yuva Morcha event in Vellore district, Palaniswami emphasized that electoral alliances and party ideology are separate matters, asserting that alliances are necessary to prevent vote division and secure a decisive victory. His statement comes amid growing speculation about AIADMK's coalition-building efforts, especially after actor-turned-politician Thalapathy Vijay's TVK party ruled out any possibility of aligning with AIADMK. However, Palaniswami remains confident that his party will form a broad coalition to challenge the DMK government. The AIADMK leader also launched a sharp critique of Chief Minister M.K. Recently, a group of Congress MLAs held a closed-door meeting to discuss political developments and the government's functioning. This led to heightened tensions within the party, prompting the leadership to convene a Congress Legislative Party (CLP) meeting to reassure the MLAs. Party leaders urged them to remain patient, assuring that the high command

Pradesh, Feb 18 As many as 7,069 children have been rescued from child labour in Andhra Pradesh between 2020 and 2024, according to data from the Women and Child Welfare Department. The year 2024 saw the highest number of rescues in recent years, with 2,245 children saved from exploitative labour conditions. The rescue numbers have been steadily rising over the years, reflecting both the persistent issue of child labour and increased enforcement efforts. In 2020, 671 children were rescued, followed by 1,028 in 2021. The trend continued upward with 1,229 children rescued in 2022 and a significant jump to 1,895 in 2023.A district-wise breakdown of 2024 data shows that Chittoor recorded the highest number of child labour rescues with 258 children, followed by Nellore (237), Vizianagaram (226), Srikakulam (214), and NTR (200). These figures highlight the concentrated prevalence of child labour in certain regions, while also showcasing proactive interventions by local authorities. However, some districts reported alarmingly low or zero rescues, raising concerns about underreporting. Ambedkar Konaseema reported zero rescues, while Anakapalli (1), Alluri Sitaram Raju (6), and Parvathipuram (9) had minimal cases.

Experts suggest that either child labour is less prevalent in these areas or enforcement efforts need to be strengthened.

The Child Labour (Prohibition and Regulation) Act of 1986, amended in 2016, strictly bans the employment of children be-

and prohibits adolescents (14-18 years) from hazardous work. Violators face stringent penalties, including fines and imprisonment. Additionally, authorities focus on rehabilitation, ensuring rescued children receive education and proper care.

Among the 2,246 children rescued in 2024, 677 were placed in rehabilitation programs, while 1,569 were reunited with their families. Women and Child Welfare Department Director G. Venugopal Reddy emphasized that family reintegration remains the top priority, as it provides a nurturing environment for rescued children. However, in cases where children are orphans or their parents are unable to care for them, they are placed in child care institutions under the Child Welfare Committee's (CWC) guidance.To bridge the educational gap for rescued children, the department, in collaboration with the Education Department, offers bridge courses and counseling sessions. "When rescued children are sent to rehabilitation centres, we first provide counseling. Then, with support from the Education Department, we help them integrate into mainstream schooling," Reddy explained.Pragada Vasu, secretary of the Association for Urban and Tribal Development (AUTD) in Visakhapatnam, noted that some rescued children return to work within months due to their families' economic dependence on their earnings. Additionally, some children end up using their wages to buy addictive substances, such as whitener.

## **Bihar Railway Official Stunned as Women Claim Modi Allowed Free Travel to Prayagraj**

TPN Correspondent/Patna, Feb 18 A group of rural women at Buxar railway station in Bihar claimed that Prime Minister Narendra Modi had allowed them to travel without tickets to Prayagraj for the Maha Kumbh. When Danapur Divisional Railway Manager (DRM) Jayant Kumar questioned them about their tickets, they confidently stated that they had received permission from the Prime Minister himself. The DRM was left momentarily stunned before clarifying that no such exemption had been granted by any authority and that traveling without a ticket would be considered a legal violation. This incident comes amid an unprecedented rush at the Maha Kumbh, which has continued far beyond the expected timelines. Despite preparations for a large footfall, authorities have been grappling with the overwhelming number of pilgrims, leading to logistical challenges at railway stations. The Maha Kumbh, which officially concludes on February 26, has already witnessed a record turnout of over 50 crore devotees seeking a holy dip in the sacred confluence of the Ganga, Yamuna, and Saraswati rivers. A senior railway official in Bihar was left in shock when a group of women at Buxar railway station claimed that Prime Minister Narendra Modi had allowed them to travel to Prayagraj without purchasing tickets. ## **President's Rule in Manipur: A Political** Move, Not a Solution to the Crisis

# **New Delhi Station Stampede Highlights Urgent Need for Railway Modernization**

On February 15, 2025, a tragic stampede at New Delhi Railway Station claimed the lives of at least 18 people and injured many others. This incident has once again brought attention to the perennial problem of overcrowding at the station, which, despite being the busiest in India, continues to operate at outdated capacity levels. While the standard rituals-condolences from the government, compensation for the victims, and the announcement of a high-level inquiry have been swiftly completed, the underlying issue remains unaddressed: the lack of modern infrastructure at one of the most critical transport hubs in the country.



#### The Growing Traffic Surge and Its Risks

New Delhi station is not just the busiest station in India; it generates the highest passenger revenue, accounting for over Rs 3,337 crore in 2023-24. However, the station's infrastructure, which opened in 1955, has not been upgraded to handle the ever-growing number of passengers. Officially, the station's capacity reached its limit by 2000, with daily traffic hovering around 500,000 passengers. This is in stark contrast to the current numbers, where the station regularly handles between 7 to 8 lakh passengers during peak seasons, causing congestion that can turn hazardous in a heartbeat.

Despite the seasonal surge in passenger traffic being predictable, Indian Railways (IR) continues to rely on rudimentary measures to manage this influx. As the recent stampede tragically demonstrated, the lack of adequate infrastructure to handle surges leaves passengers vulnerable, and this vulnerability will only increase as the number of rail users continues to rise.

#### **A Long Delayed Modernization Plan**

The need for New Delhi station's modernization has been apparent for over two decades. The first attempt to modernize the station was conceived in the early 2000s, around the same time as the modernization of Delhi's international airport. In 2007, a design was finalized by the renowned architecture firm Farrells, with the plan to increase station capacity, improve amenities, and create a new urban space above the railway tracks. Despite this ambitious plan, it never came to fruition due to delays, opposition from local authorities, and failed tenders.

The first failed attempt came in 2008, with confusion surrounding tender clauses, followed by another cancellation in 2009 due to bureaucratic

hurdles. A third attempt in 2022 saw a scaledback version of the original plan, but that, too, failed when the winning bidder, L&T, quoted over Rs 8,000 crore, exceeding the government's estimate of Rs 5,000 crore.

In 2023, Indian Railways reduced the scope of work further and attempted to launch the project on a smaller scale, yet the tender was withdrawn in early 2024. The Rail Land Development Authority (RLDA) has since fragmented the project into smaller tenders in hopes of attracting more bidders, but as of now, the modernization effort remains stalled.

#### **Effective Measures to Prevent Future** Accidents

While the tragic stampede at New Delhi Station highlights the urgency of modernization, it is also a reminder that such incidents can be prevented with the right measures. Here are some strategies that can be adopted to manage the surge in passenger traffic:

**Optimizing Platform Capacity: This in**volves increasing the number of platforms and utilizing space more efficiently to accommodate more trains and passengers.

- **Technology-Based Solutions: Implement**ing smart ticketing systems, AI-based crowd management tools, and real-time passenger flow tracking can help manage congestion.
- **Improved Signage and Barriers: Clear and** visible signage to direct passenger movement can reduce chaos, especially during peak hours. Barriers can be used to separate different streams of passenger flow.
- Adequate Staffing: Adequate staff presence at critical locations, including ticket counters, platforms, and gates, is essential for maintaining order and directing passengers effectively.
- **Coordination with Train Schedules:** Well-coordinated train schedules during peak times can reduce overcrowding on platforms and in trains.
- **Crowd Control Measures:** Barriers, ropes, and entry/exit points should be designed to channel passengers in a way that prevents overcrowding, especially at entry and exit points.
- **Emergency Preparedness:** Stations should have well-established emergency re-

sponse protocols, with staff trained to handle crises efficiently.

Infrastructure Upgrades: Finally, upgrading station infrastructure to handle the increased traffic and to provide adequate facilities for passengers is key to preventing such accidents.

New Delhi Railway Station stands as a symbol of India's growth in terms of rail passenger traffic, but its outdated infrastructure is a stark reminder of how critical modernization efforts can be in preventing avoidable tragedies. As the busiest station in the country, it is inconceivable that New Delhi Railway Station is still grappling with capacity issues, especially when its modernization plan has been on the table for over 20 years. The failure of successive efforts to upgrade the station is a reflection of the inefficiencies within Indian Railways, and the recent stampede should serve as a wake-up call for both the government and the railway authorities. If such accidents are to be avoided in the future, New Delhi Station's modernization needs to move beyond planning stages into actionable, urgent steps—before another tragedy strikes.





# India Can Turn "Fast Fashion" Waste Into Opportunity: PM Modi At Bharat Tex 2025

He also noted that by 2030, fashion waste could reach 148 million tons, with less than a quarter currently being recycled.

PM Modi suggested that India's rich traditional skills in textile



recycling and upcycling could address this issue. He cited examples from Maharashtra, where old fabrics are transformed into mats, rugs, and quilts. The Prime Minister encouraged innovation in these practices, which could help tap into global market opportunities. Reflecting on India's prosperous past, where the textile industry played a crucial role, the Prime Minister reiterated that as the country strives towards becoming a Viksit Bharat, the textile sector would again be pivotal. He lauded Bharat Tex as a strong platform for global engagement, collaboration, and partnership, with over 120 countries participating in the event.

He also urged the banking sector to support textile entrepreneurs, fostering business growth and job creation. Bharat Tex 2025, held at Bharat Mandapam from February 14-17, is one of the largest events of its kind, showcasing the entire textile ecosystem and providing a platform for innovation and collaboration.

## **Gyanesh Kumar Likely to Become India's** Next Chief Election Commissioner

Gyanesh Kumar, who was appointed as an Election Commissioner in March of last year, is set to replace Rajiv Kumar as the Chief Election Commissioner (CEC) of India, sources told NDTV on Monday evening. If confirmed, Mr. Kumar will oversee the conduct of several crucial elections, including the Bihar Assembly election later this year, as well as elections in Bengal, Assam, and Tamil Nadu next year.

Mr. Kumar, a 1988-batch IAS officer from the Kerala cadre, is currently the senior-most commissioner on the three-member Election Commission panel, which was previously led by Rajiv Kumar. The other commissioner on the panel is Sukhbir Singh Sandhu from the Uttarakhand cadre. However, Mr. Kumar's appointment has yet to be formally ratified.

The Congress party has raised objections to the swift move to appoint a new CEC, pointing out that the Supreme Court is set to hear a challenge to the 2023 law that governs the selection process. Critics of the law argue that it allows the ruling BJP to have control over the CEC appointment, with the process being decided by a three-member panel consisting of the Prime Minister, the Home Minister, and the Leader of the Opposition.

Mr. Kumar, 61, has held several key positions in the Indian civil services. Prior to his appointment as Election Commissioner, he was part of the Union Home Ministry, where he played a crucial role in drafting the bill that scrapped Article 370 in Jammu and Kashmir in 2019. He was also responsible for handling key documents related to the Supreme Court case on the Ram Temple in Ayodhya. Additionally, he is known to have a close rela-



tionship with Home Minister Amit Shah.

Before retiring in January last year, Mr. Kumar served as the Secretary of the Ministry of Cooperation, a position also overseen by Amit Shah. He has previously held roles in the Ministry of Parliamentary Affairs and the Defence Ministry during the Congress-led UPA government. Mr. Kumar holds a B.Tech in Civil Engineering from the Indian Institute of Engineering in Kanpur, along with degrees in Business Finance and Environmental Economics from the Institute of Chartered Financial Analysts of India and Harvard University, respectively.

Rajiv Kumar, the outgoing Chief Election Commissioner, stepped down this morning after a tenure marked by efforts to modernize the election process. In his farewell speech, Mr. Kumar emphasized the importance of innovations such as remote voting for NRIs and migrant workers, biometric voting systems, and safeguarding against postpoll violence by ensuring the non-disclosure of votes. He also highlighted the need for greater financial transparency in election campaign expenses and the growing role of Artificial Intelligence in the future of elections.

## To Ban or Not to Ban: Alcohol Divides J&K's Political Landscape

The ruling National Conference (NC) in Jammu and Kashmir is facing significant criticism for its change of stance on the issue of liquor sales in the region. The NC's volte-face has sparked a backlash, especially from political and religious figures, as well as civil society groups. The controversy revolves around the Bills to be introduced in the upcoming assembly session, which seek to ban the sale and consumption of liquor in Jammu and Kashmir.

Mirwaiz Umar Farooq, the chairman of the Moderate Hurriyat, condemned NC leader Tanvir Sadiq's defense of liquor sales, which he justified under the pretext of boosting tourism. Mirwaiz, speaking at an interfaith event in Budgam district on February 16, questioned the morality of such a move in a Muslim-majority region, emphasizing the harm caused to society by drug abuse. He criticized the NC for ignoring the example of other Indian states, such as Gujarat, where alcohol is banned and tourism continues to thrive.

Sadiq had earlier argued that liquor sales should be allowed to support tourism, noting that several countries in the Arab world permit alcohol for tourists. He insisted that the local stakeholders, including travel agents, should be consulted before taking any drastic steps.

However, Mirwaiz dismissed this argument, pointing out that no consultation had been held with the stakeholders of Jammu and Kashmir regarding the issue. Opposition parties, including the Peoples Democratic Party (PDP), also expressed their disapproval, arguing that linking tourism to alcohol sales is flawed. PDP leader Waheed Parra pointed to Gujarat's success as a dry state, where tourism has flourished without the need for liquor sales.

In the upcoming legislative session, at least three private member Bills will be introduced, seeking a ban on alcohol in Jammu and Kashmir. These Bills have garnered support from various quarters, including BJP leader Darakhshan Andrabi, who welcomed the move as a step toward protecting the youth from drug abuse.

The ongoing debate reflects the deepening divide over the future of alcohol sales in Jammu and Kashmir, with strong opinions from both sides of the political spectrum. Stalin posted a video of Pradhan speaking on social media, stating that the Union Minister's remarks were disrespectful and threatening, warning that Tamil Nadu might show Delhi the "real trait" of its people in response. The Chief Minister's comment resonated with opposition parties across Tamil Nadu, who strongly criticized the Union government's stance on this issue.

Edappadi K. Palaniswami, General Secretary of AIADMK and Leader of the Opposition in Tamil Nadu, also condemned the central government's decision. He remarked that the Centre's refusal to release funds based on Tamil Nadu's rejection of the three-language policy was unjust. Palaniswami emphasized that Tamil Nadu had been a pioneer in the field of education and that the Centre should focus on the welfare of the people, not the political leaders in power.

The stance was echoed by Seeman, the chief of the Naam Tamilar Katchi (NTK), who criticized the NEP's push to make Hindi mandatory. He argued that while the people of Tamil Nadu could choose to learn Hindi, the Centre should not impose the language on them. Seeman expressed that India's unity lies in its linguistic diversity and that Tamil Nadu's opposition to the NEP should not result in withholding educational funds.

The controversy highlights the growing tensions between the state and central governments over educational policies, with Tamil Nadu leaders continuing to reject the imposition of Hindi and the three-language policy.

Assam Chief Minister Himanta Biswa Sarma has ordered a case against a Pakistani national, Ali Tauqeer Sheikh, for allegedly attempting to interfere in domestic matters in Assam and India. Sarma also revealed that Elizabeth Colburn, the wife of Congress MP Gaurav Gogoi, will be investigated for her alleged ties to Pakistan and its intelligence agency, ISI.

Sarma's decision came after a cabinet meeting on Sunday, where he cited reports of Sheikh's online activities and his connections with Colburn. According to Sarma, Sheikh, who founded LEAD Pakistan, a non-profit organization focused on climate change, has had direct contact with Colburn, who was involved with the organization during her time in Islamabad. Both Sheikh and Colburn were part of the global climate action group, the Climate and Development Knowledge Network (CDKN), which operates in both India and Pakistan.

Sarma raised concerns over the national security implications of the situation, particularly given Assam's historical vulnerabilities to destabilization by Pakistani actors. The Chief Minister also pointed out that Colburn, a British citizen, allegedly campaigned for Gogoi during two Lok Sabha elections, which would be a violation of visa norms. Sarma questioned the appropriateness of a foreign national participating in Indian elections, especially given her potential involvement in sensitive issues raised by her husband in Parliament, including nuclear radars and uranium mines.

Gaurav Gogoi, in response, dismissed the accusations as "dirty and baseless" politics and rejected the charges as "laughable and entertaining." He stated that his focus remains on improving Assam's economy, education, and healthcare policies, and expressed frustration with the ongoing political drama.

Sarma has called for a thorough investigation, involving central agencies, into the allegations against Colburn and Sheikh, stressing the importance of national security. He plans to share all relevant documents with Congress leaders to verify the facts.

Myanmar frees 1,000 scam center workers as crackdown widens

Myanmar's military government announced it is ready to hand over around 1,000 foreign nationals who were rescued from cyber scam centers near the Thai border. The victims, mostly from Asia and East Africa, were trafficked or tricked into working at these illicit centers. Myanmar authorities have vowed to intensify efforts to combat transnational criminal groups responsible for the operations.

Over the past three weeks, approximately 1,030 foreign nationals have been rescued from these scam centers, which are believed to be involved in online fraud. The Myanmar government has already repatriated 61 of the victims to their home countries, while the remaining individuals are set to be returned in the coming days, according to a statement from the State Administration Council, Myanmar's ruling military body.

The majority of the victims come from Asian countries, including China and India, although some are from East Africa. The victims were reportedly coerced or deceived into participating in online scams, where they were forced to defraud people across the globe. Many of the centers were located near the border with Thailand, a region notorious for transnational human trafficking and cybercrime activities.

The military junta launched a large-scale operation to combat online scams and human trafficking following mounting pressure from neighboring countries like Thailand and China. The high-profile trafficking of a Chinese actor, which highlighted the scale of criminal activities in the region, spurred Myanmar to take action.

The recent operation is part of a broader effort to dismantle criminal networks operating across Myanmar's borders. The government has promised to continue its crackdown on these illegal operations, although human rights organizations have raised concerns about the safety and treatment of the victims during the rescue and repatriation process. Myanmar's actions come amid growing regional concerns over the rise of cybercrime and human trafficking in Southeast Asia.

# Kim Jong Un Visits Father's Mausoleum, **Pledges Commitment to 'Sacred Struggle'**

North Korean leader Kim Jong Un made a rare visit to the Kumsusan Palace of the Sun in Pyongyang on Monday to mark the birthday of his late father, Kim Jong Il. This significant visit, which came on February 16—celebrated annually as the Day of the Shining Star—was the first in four years for Kim Jong Un to pay his respects at the mausoleum, where the embalmed bodies of his father and grandfather, Kim Il Sung, are housed.

# China Names Its Moon Spacesuit and Rover Ahead of Lunar Mission



China has officially unveiled the names for its next-generation lunar spacesuit and crewed moon rover, key components for its planned human moon landing before 2030. The China Manned Space Agency (CMSA) revealed that the spacesuit will be called "Wangyu," meaning "gazing into the cosmos," while the rover has been named "Tansuo," which translates to "explore." Over 9,000 suggestions were submitted during a public participation process in 2024, culminating in the final selection of these names.

The spacesuit, Wangyu, is designed to withstand the harsh conditions of the moon's surface, providing astronauts with enhanced mobility and protection. According to Zhang Wanxin, director of the spacesuit engineering office at the China Astronaut Research and Training Center, the prototype has already been developed, and performance assessments are currently underway to ensure it meets the required operational standards.

The Tansuo rover, which will facilitate lunar surface exploration, is also pro-

gressing through its development phase. Zhang Chongfeng, a spacecraft designer at CMSA, revealed that the rover prototype has been tested in a simulated lunar surface environment. The rover is undergoing design refinements and engineering assessments to ensure its effectiveness in transporting astronauts across the moon's challenging terrain.

China's lunar mission framework is taking shape as the nation aims to land astronauts on the moon before 2030. CMSA has made significant progress in the development of ground facilities for production and testing, and construction at the Wenchang Spacecraft Launch Site in Hainan is advancing. Additionally, CMSA announced the names of other mission components, including the crew spacecraft, "Mengzhou" ("Dream Vessel"), and the lunar lander, "Lanyue" ("Embracing the Moon").

This mission is part of China's broader space exploration goals, which include advancing technology and scientific research beyond low Earth orbit. With an integrated system of heavy-lift launch vehicles, crewed spacecraft, and lunar surface mobility solutions, China is taking significant steps toward its ambitious goal of establishing a human presence on the moon.

# **OpenAl** Shifts Focus to GPT-5, **Cancels Standalone** o3 Al Model



OpenAI CEO Sam Altman recently announced that the company has decided not to release the highly anticipated o3 artificial intelligence (AI) model. Instead of launching the o3 model as planned, OpenAI will now focus on a unified GPT-5 model, which will integrate the capabilities of o3.

Altman shared details about the company's updated AI roadmap, revealing that OpenAI will simplify its product offerings with the release of GPT-4.5 and GPT-5. The goal is to eliminate user confusion when choosing between various models for different tasks. Instead of offering multiple specialized models, GPT-5 will be designed to deliver "unified intelligence," meaning it will be capable of utilizing all OpenAI tools and know when to apply reasoning without users having to choose the appropriate model for each task.

The cancellation of the o3 model's standalone release marks the end of the o-series of AI models, with the company opting to integrate the features of o3 di-

rectly into GPT-5. Altman also announced changes to OpenAI's tiered subscription model. When GPT-5 is launched, all ChatGPT users will have access to the AI model, with free-tier users receiving unlimited chat access at the standard intelligence level. To prevent misuse, the company will impose abuse thresholds. Pro subscribers will get access to a higher intelligence level, and the top-tier subscribers will have the most advanced capabilities. GPT-5 will also introduce new features, including Advanced Voice, Canvas, Search, and Deep Research. However, before GPT-5 arrives, OpenAI plans to launch GPT-4.5, its last non-chain-ofthought (non-CoT) model. While the exact release date is still unclear, Altman suggested that GPT-4.5 could arrive in the coming weeks or months. Interestingly, GPT-4.5, internally referred to as "Orion," was initially rumored to be GPT-5 itself.

With these developments, OpenAI is aiming to streamline its AI offerings and deliver a more efficient, user-friendly experience.

Achinese zoo has come under scrutiny after it allegedly painted donkeys to pass them off as zebras in an attempt to attract more visitors. The stunt, which took place at a zoo in Zibo City, Shandong province, quickly backfired after keeneyed netizens recognized the creatures

for what they truly were—donkeys, not zebras.

The controversy began when a video went viral showing a zoo worker standing next to a donkey with black and white stripes across its body. However, the worker left the donkey's face untouched, which made it even more obvious that it was not a zebra. The attempt to disguise the donkey as a zebra was so poorly executed that online viewers immediately noticed the difference, sparking a wave of jokes and criticism across social media platforms.

In response to the growing uproar, representatives from the amusement park told Chinese media that the painted donkeys were part of a "marketing strategy." However, their explanation did little to quell the backlash, with many criticizing the zoo for trying to deceive visitors. The debacle has raised questions about the ethics of using such deceptive practices in animal exhibits. While the zoo's marketing attempt may have been intended to draw attention, it ultimately served as a reminder of the power of social media and the sharp eye of internet users. The incident also highlights the importance of authenticity in tourism, with visitors increasingly expecting transparency and honesty from attractions.

Despite the failed stunt, the story has given the zoo a fleeting moment of fame—though likely not the kind they had hoped for. Instead of gaining new visitors through their creativity, they have become the subject of ridicule and mockery online.

The exact timeline for the launch of ads on Apple Maps has not been confirmed, but business owners will soon be able to begin promoting their locations to potential customers directly through the platform. This change may offer new opportunities for businesses looking to increase their visibility within the app, while also contributing to Apple's overall revenue growth.


