

BJP Slams Sonia Gandhi's Comment on President



TPN Correspondent | New Delhi The Budget Session of Parliament began with controversy after Congress MP Sonia Gandhi's remarks on President Droupadi Murmu's address sparked outrage. Referring to the President's exhaustion after her speech, Mrs Gandhi said, "She could hardly speak, poor thing," a comment that the BJP has denounced as "derogatory" and demanded an apology for.

Following President Murmu's address, reporters outside Parliament asked Mrs Gandhi for her reaction. Flanked by Rahul Gandhi and Priyanka Gandhi Vadra, she responded, "The President was getting very

tired by the end. She could hardly speak, poor thing." Rahul Gandhi was also heard prompting his mother with remarks about the speech being repetitive.

The BJP strongly condemned Mrs Gandhi's comment, with party president JP Nadda calling it "deeply disrespectful" and reflective of the Congress party's "elitist and feudal mindset." He accused the opposition of mocking the empowerment of backward classes and women, particularly under Prime Minister Narendra Modi's leadership. "The deliberate use of such words shows

## 'Congrats Delhiites! Yamuna No Longer Poisonous': Arvind Kejriwal

Former Delhi Chief Minister Arvind Kejriwal has claimed that the toxicity of Yamuna water in Delhi has decreased due to protests by the Aam Aadmi Party (AAP) and residents. He also alleged that the Election Commission had threatened to punish him for his stance on the Yamuna water issue ahead of the Delhi Assembly elections.

Taking to X, Kejriwal stated that the contamination in the Yamuna had significantly reduced. "Many congratulations to the people of Delhi. Our struggle bore fruit. The poisonous water that was being sent to Delhi has now stopped. The amount of ammonia in the water coming to Delhi has decreased from 7 ppm to 2 ppm," he wrote.

He further asserted that had AAP not raised its voice, half



the population of Delhi would have been deprived of water. "We saved Delhi from a major water crisis. The Election Commission has issued a notice to me and threatened to punish me," he added, sharing a picture of his response to the poll

The Yamuna has emerged as a key election issue, with both AAP and the BJP trading accusations. While the BJP has criticized AAP for failing to clean the river despite its promises, AAP has accused the BJP-led Harvana government of attempting to create an artificial water crisis in the national capital just before the elections.

# "My Mother Is 78": Priyanka Gandhi Defends Sonia Gadhi

Congress leader Priyanka Gandhi has defended her mother. Sonia Gandhi, after a controversy erupted over her remarks on President Droupadi Murmu's speech in Parliament. She insisted that the comments were being misinterpreted and accused the BJP of twisting the issue.

The controversy stems from a video where Sonia Gandhi, speaking informally with her children Rahul Gandhi and Priyanka Gandhi Vadra, commented on the President's apparent exhaustion.

"The poor lady, the President, was getting very tired by the end... she could hardly speak, poor thing," Sonia Gandhi was heard saying. The BJP condemned the remark as derogatory and demanded an

Responding to the backlash, Priyanka Gandhi said there was no disrespect in-

"My mother is 78 years old. She simply said that the President read such a long speech and must have been tired, poor thing. She fully respects the President of India. It is unfortunate that this is being twisted. BJP should first apologise for

The President's office condemned the remarks, calling them "unacceptable" and stating that they "hurt the dignity of the high office."

"Nothing could be farther from the truth. The President was not tired at any point. Speaking up for marginalized communities, women, and farmers, as she did in her address, can never be tiring," the statement read.

The Rashtrapati Bhavan also suggested that Congress leaders might not be well-acquainted with Hindi idioms, leading to a misunderstanding.

"In any case, such comments are in poor taste, unfortunate, and entirely avoidable," it concluded.

## Delhi Court to Rule on Sajjan Kumar in 1984 Riots Case on Feb 7

A Delhi court will pronounce its verdict on February 7 in a 1984 anti-Sikh riots murder case against former Congress MP Sajjan Kumar. The case pertains to the alleged killings of two individuals in Saraswati Vihar during the riots that followed the assassination of former Prime Minister Indira

Special Judge Kaveri Baweja reserved the verdict after the prosecution completed its arguments. On December 21, the court allowed the prosecution to argue on specific points raised by the state, which were deemed essential for the case's adjudication. The prosecution had sought permission to counter certain submissions made by the defense on January 8.

The case involves the murders of Jaswant Singh and his son Tarundeep Singh on November 1, 1984. Initially registered at the Punjabi Bagh police station, the case was later taken over by a Special Investigation Team (SIT).

According to the prosecution, a violent mob, armed with deadly weapons, engaged in large-scale looting and arson targeting Sikhs. The mob allegedly attacked the complainant's house, killing her husband and son before setting the property on fire.

In December 2021, the court framed charges against Kumar, stating there was enough material to establish that he was not only part of the mob but had also led it. The court's verdict will determine his fate in this long-pending case.

# **Registered Ahead of Delhi Polls**

**Over 900 MCC Violation Cases**

With just days left for the Delhi Assembly elections, authorities have registered over 900 cases of alleged violations of the Model Code of Conduct (MCC) since it came into effect on January 7. Officials reported intensified vigilance and crackdowns on illegal activities across the capital.

Between January 7 and January 30, Delhi Police recorded 916 cases of MCC violations. During this period, 29,172 people were arrested under various legal provisions, including the Excise Act. Law enforcement officials have also seized 426 illegal firearms, 487 cartridges, and arrested 439 individuals under the Arms Act. Additionally, authorities con-

fiscated 99,285 litres of illicit liquor and arrested 1,194 people in related cases. A significant amount of contraband, including 166.99 kg of drugs valued at over ₹75.4 crore and more than 1,200 banned injections, was seized, leading to 162 arrests.

Financial monitoring teams have also recovered ₹10.10 crore in unaccounted cash and 37.39 kg of silver. Police checkpoints across the city have been reinforced to prevent the smuggling of arms, liquor, and narcotics ahead of polling day.

The election for the 70-member Delhi Assembly is scheduled for February 5, with the results set to be declared on February 8.

# Two Men Held by Delhi Police's IGI Airport Unit for Visa Fraud

The arrests follow the deportation of two men from Dubai who were caught utilizing forged documents.

The suspects, identified as Udaypal Singh alias Raja and Tajinder Singh alias Lucky Singh, targeted unsuspecting travelers with promises of lucrative job opportunities abroad. Among their victims were two young men from Baghpat, Uttar Pradesh, Sarrav Kumar Singh, 25, and Sumir Kumar, 27. The duo was detained at the Dubai airport after officials discovered they were attempting to travel on counterfeit visas.

Parliamentary Affairs Minister Kiren Rijiju also criticized Mrs Gandhi's statement, stating, "Our President, a tribal woman, is not weak. #### The Candidates

Lovely previously served in the Sheila Dikshit-led Congress government and was elected as an MLA from Gandhi Nagar four consecutive times (1998, 2003, 2008, and 2013). He also contested the 2019 Lok Sabha elections from East Delhi but lost to BJP's Gautam Gambhir by over 3.91 lakh votes. #### The Electorate & Key Issues

Part of the East Delhi Lok Sabha constituency, Gandhi Nagar is bound by Yamuna Pushta Road in the west, GT Road in the north, Swami Dayanand Marg in the east, and Vikas Marg in the south. The area has a diverse voter base, comprising Hindu, Punjabi, and Muslim communities. Muslims, forming about 25% of the electorate, are concentrated in Shastri Park, Seelampur, Kanand priests, are spread across Gandhi Nagar, Dharampura, Raghubarpura, Rajgarh Colony, Seelampur, Azad Nagar, cerns. and Shankar Nagar.

Due to the high density of businesses, the locality faces several civic challenges. Traffic congestion is a major issue, worsened by encroachments, narrow lanes, illegal parking, and a rise in e-rickshaws. The primary road from Pushta Road to the market remains severely clogged. Traders complain about poor traffic management and inadequate parking facilities. Drainage and sewerage problems, broken roads, and unreliable water supply add to the woes of residents, who often rely on bottled water or expensive purifiers due to contaminated tap water.

In 2023, the Delhi government announced a redevelopment plan for Gandhi Nagar market, including the construction of two multi-level parking lots, road and drainage improvements, enhanced fire safety measures, and the deployment of golf carts for better last-mile connectivity. However, the project remains stalled, leaving traders and residents frustrated.

As the constituency heads for elections, the battle among political turncoats is set to be closely watched, with issues of infrastructure, business growth, and public amenities at the forefront of voters' con-

Maharashtra Chief Minister Devendra Fadnavis took a sharp dig at Aam Aadmi Party leader Arvind Kejriwal, recall-

ing his unfulfilled promise to clean the Yamuna River and take a dip in it with his cabinet. Addressing a campaign rally for BJP candidate Praveen Nimesh in Gokal Pur, Fadnavis accused Kejriwal of failing to deliver on his commitments and leaving the river more polluted than before.

"Kejriwal had assured the people of Delhi that he would clean the Yamuna and take a dip in it, but today, the river is even dirtier than before," Fadnavis said. Taking a jibe, he added, "Now, he and his cabinet should take a dip in a handful of water and bid farewell to Delhi—this is what the people are saying."

The Maharashtra CM also asserted that Delhi voters, particularly women, would bring



the BJP to power under Prime Minister Narendra Modi's leadership. He further accused Kejriwal of betraying social activist Anna Hazare for political gains. "I frequently meet Anna Hazare, and he tells me that if there is anyone most dishonest in this country, it is Arvind Kejriwal," Fadnavis claimed. The remarks come amid the ongoing controversy over Kejriwal's claim that the BJPled Haryana government was

# **Haryana Court Summons Arvind Kejriwal Over 'Poisoning' Yamuna Claims**

A Harvana court has summoned Aam Aadmi Party chief Arvind Kejriwal over his allegations that the Haryana government was "poisoning" the Yamuna's water to disrupt Delhi's water supply. The court has directed Kejriwal to appear before it by February 17, warning that action will be taken if he fails to comply.

The summons follows a statement from Haryana Revenue and Disaster Management Minister Vipul Goel, who announced that the state government would file a case against Kejriwal for his "irresponsible" remarks, which he claimed were intended to create panic ahead of the Delhi Assembly elections. He stated that the complaint would be filed in the Chief Judicial Magistrate's court in Sonipat under Sections 2(D) and 54 of the Disaster Management Act.

Goel criticized Kejriwal, asserting that his claims were false and that Haryana officials had already verified the quality of water being supplied to Delhi. He accused the former Delhi Chief Minister of misleading the public for political gain.

Prime Minister Narendra Modi also weighed in on the controversy, condemning Kejriwal's remarks as "disgusting" and questioning how the BJP-led Haryana government could poison the Yamuna's water when even the Prime Minister himself consumes the same supply. Modi said the accusations reflected AAP's desperation ahead of the elections. He pointed out that diplomats, judges, and all Delhi residents drink the same water coming from Hary-

Haryana Chief Minister Nayab Singh Saini also responded by visiting Palla Ghat in Delhi, drinking Yamuna water himself, and dismissing Kejriwal's claims as baseless fear-mongering. He accused the AAP leader of attempting to mislead people for political benefits.

Kejriwal had made the allegations in a post on X, claiming that the Haryana government was deliberately contaminating Delhi's water supply. He warned that the situation was dangerous, asserting that the pollution in the water was beyond the capacity of treatment plants to clean. He further accused the BJP of attempting "mass murder" by poisoning Delhi residents through the Yamuna's water supply.





## Shubhanshu Shukla: **The Indian Astronaut Who Will Pilot Axiom-4 To Space**

First Indian on a Private Space Mission -Shubhanshu Shukla will pilot Axiom Mission 4 (Ax-4) to the ISS. Experienced Combat Pilot - Over 2,000 flight hours on multiple aircraft, including MiG-21 and Su-30 MKI.Training Across Continents - Trained in Russia, India, and selected for ISRO's Gaganyaan mission.

Indian Air Force (IAF) Group Captain Shubhanshu Shukla has been selected as the pilot for Axiom Mission 4 (Ax-4), NASA announced on Thursday. With this, he will become the first Indian astronaut to travel to the International Space Station (ISS) on a private mission. The mission, a collaboration between NASA and ISRO, is scheduled for spring 2025 and will launch from Kennedy Space Center in Florida aboard a SpaceX Dragon spacecraft. The crew will spend up to 14 days in space, conducting scientific experiments, outreach programs, and commercial activities in microgravity

Who is Shubhanshu Shukla?

Born on October 10, 1985, in Lucknow, Uttar Pradesh, Shubhanshu Shukla is a highly decorated pilot and one of India's most promising astronauts. He graduated from the National Defence Academy (NDA) in 2005 and was commissioned into the fighter stream of the Indian Air Force in June 2006. Over the years, he has flown a variety of aircraft, including An-32, Jaguar, Hawk, MiG-21, MiG-29, and Su-30 MKI, accumulating over 2,000 hours of flying experience

In 2019, he was selected for the Indian astronaut program through the Institute of Aerospace Medicine (IAM), and in 2021, he completed basic spaceflight training at the Gagarin Cosmonaut Training Center in Russia. Upon returning to India, he continued training at ISRO's Astronaut Training Facility in Bengaluru. He was promoted to group captain in 2024, just before being selected for Axiom Mission 4

Second Indian to Fly to Space

With this mission, Shubhanshu Shukla will become the second Indian to travel to space, following Rakesh Sharma, who flew aboard the Salyut 7 space station in 1984. His selection for Axiom Mission 4 is also seen as a major step toward his potential role in ISRO's Gaganyaan mission, which aims to send India's first astronauts into space aboard an indigenous spacecraft

Shukla is the youngest of three siblings and the first in his family to join the armed forces. He is married to Kamna Shubha Shukla, a dentist, and has remained committed to advancing India's space ambitions. His upcoming mission will be a landmark moment in Indian space history, paving the way for future astronaut collaborations between ISRO and global space agencies

# "India's GDP Growth At 6.3-6.8%, **Inflation To Stay Under Control**"

The Indian economy is projected to expand at a growth rate of 6.3% to 6.8% in the financial year 2025-26 (FY26), according to the Economic Survey 2024-25 presented in Parliament by Finance Minister Nirmala Sitharaman. The survey, released ahead of the Union Budget, highlights strong domestic economic fundamentals, declining unemployment, and stable inflation as key factors underpinning this growth forecast.

The Economic Survey states that the domestic economy remains robust, supported by a strong external account, calibrated fiscal consolidation, and stable private consumption. These factors are expected to drive growth within the projected range, although the 6.3%-6.8% forecast marks the lowest growth rate since the COVID-19 pandemic year of 2020-21, when India experienced a negative growth of 5.8%. In contrast, India's GDP growth rates for 2021-22, 2022-23, and 2023-24 were 9.7%, 7%, and 8.2%, respectively.

The survey also points out that rupee depreciation in 2024 was largely driven by a strong US dollar amid geopolitical tensions and uncertainties surrounding the US election. Additionally, it warns that a significant market correction in 2025 could have adverse effects, particularly due to the increased participation of new retail investors.



Sitharaman is scheduled to present the Union Budget 2025-26 on Saturday, and the survey has outlined several key highlights:

- Food inflation is expected to ease in Q4 FY25 due to the seasonal drop in vegetable prices and Kharif harvest arrivals.
- India's economic prospects for FY26 are balanced, with challenges arising from elevated geopolitical and trade uncertainties.
- Managing global challenges will require strategic policy management and strengthening of domestic fundamentals.
- To boost global competitiveness, India needs to implement grassroots-level structural reforms and
- The risk of inflation from higher commodity prices is limited for FY26, but geopolitical tensions remain a concern.
- The survey also raises concerns about the potential misuse of AI technologies due to the lack of an appropriate governance framework.
- It highlights that the Insolvency and Bankruptcy Code has been successful in encouraging early distress

# **India Sets Standards for HMPV Testing Amid Surge in Cases**

## CDSCO and ICMR Work to Establish Uniform Protocols for Diagnostic Kits

India is taking steps to standardize Human Metapneumovirus (HMPV) testing kits, as the Central Drugs Standard Control Organization (CDS-CO) and the Indian Council of Medical Research (ICMR) work on quality and performance protocols following a surge in reported cases. The Union Health Ministry confirmed two HMPV cases in Karnataka earlier this month, but surveillance reports indicate at least 200 cases were detected across the country last year.

HMPV, a respiratory virus causing flu-like symptoms, gained global attention after a spike in cases in China. However, testing variations due to a lack of uniform evaluation have led Indian authorities to draft standardized guidelines to ensure consistency and reliability in diagnostic results.

Ensuring Accurate Testing and Industry Compliance

The draft guidelines focus on real-time PCR kits, which currently undergo testing at institutions like the National Institute of Virology (NIV).



## **Shashi Tharoor Dismisses India Unveils Ambitious** AI Plan to Compete with | Trump's Tariff Threat Against **India, Calls It 'Empty'**

President Donald Trump recently threatened to impose 100% tariffs on BRICS nations if the group attempted to move away from the US dollar in international trade. However, Indian Congress MP Shashi Tharoor dismissed the threat as an "empty" one, noting that no concrete plans were in place to replace the dollar with a new currency.

Speaking on the matter, Tharoor stated, "I don't think there is any particular plan whatsoever to do that. And therefore, the threats of the president seem a bit empty because it's only if there is an actual proposal that comes up and that countries like India are taking forward seriously. I don't see any support in the Indian government for such a proposal. So, until that happens, why should we worry?"

While there has been some limited discussion on alternatives to the dollar, including trade deals using national currencies like the Rupee-Ruble trade with Russia or the Rupee-Riyal trade with Iran, Tharoor emphasized that the dollar remains a practical convenience for most countries.

BRICS, a grouping of

emerging economies, includes ten nations: Brazil, Russia, India, China, South Africa, Egypt, Ethiopia, Indonesia, Iran, and the United Arab Emirates. The group has explored alternatives to the US dollar in recent years, particularly by countries like Russia and China, which have suggested the creation of a new BRICS currency. However, India, according to External Affairs Minister S. Jaishankar, is not supportive of such a move, with no official proposal on the table.



# **Can't Use Live Market Prices In Videos, SEBI Tells Finfluencers**

The Securities and Exchange Board of India (SEBI) has introduced a new regulation that bans financial influencers, also known as "finfluencers," from using real-time stock prices in their educational content. Under the new rule, these influencers are required to use stock prices from up to three months ago, rather than live market data, when discussing stock market trends and securities.

This move is aimed at curbing the impact of finfluencers who offer stock tips and predictions without being officially registered as investment advisers. SEBI has expressed concerns that such influencers, who often base their advice on live stock prices, could mislead viewers into making impulsive or risky investment decisions. The regulator emphasized that influencers should not provide predictions or advice about future prices, as this could lead to market manipulation or misinformed trading decisions.

SEBI's new regulation focuses on shifting the emphasis in financial education away from real-time



trading and towards a more knowledge-based approach. The goal is to protect investors from being swayed by short-term market fluctuations, which can be amplified by unregulated influencers. Under the new guidelines, anyone wishing to provide stock market advice must first register with SEBI.

This regulation builds on previous steps taken by SEBI, including a restriction in October that prevented registered entities, such as stock brokers and mutual fund distributors, from collaborating with unregistered individuals or groups. The circular issued by SEBI states that those engaged solely in educational content should refrain from using live market prices, displaying or referring to securities by their code names, or offering price predictions.

# **White House Offers Buyouts to Federal Employees Opposed to In-Person Work**

Trump Administration Moves to End COVID-19 Remote Work Policies

- Federal employees must return to in-person work
- · Workers can resign with pay and benefits
- Deadline Offer expires **February 6, 2025**

In a sweeping move to eliminate COVID-19era remote work policies, the White House has introduced a buyout offer for federal employees unwilling to return to office. The plan, part of President Donald Trump's directives, could lead to the departure of thousands of government workers, reshaping the federal workforce.

Currently, only 6% of the federal workforce which includes over 2 million employees works in-person full-time. The administration estimates that 5% to 10% of employees may take the buyout, impacting hundreds of thousands of positions.

How the Buyout Works

According to the Office of Personnel Management (OPM), employees who opt for the buyout will receive administrative leave



with pay and benefits. The resignation process is simple, requiring employees to reply to an official government email with the word "Resign" in the body of their message.

Certain groups, including military personnel, postal workers, immigration enforcement officials, and national security employees, are exempt from the program.

## **Trump's Workforce** Overhaul

## **Ukraine Receives Largest Swedish Defense Package** Worth USD 1.23 Billion

On January 31, 2025, Ukrainian President Volodymyr Zelenskyy expressed his gratitude towards Sweden for providing the 18th and largest defense aid package to Ukraine. The Swedish defense package, totaling 13.5 billion SEK (approximately USD 1.23 billion), is set to significantly bolster Ukraine's military capabilities, particularly in strengthening its defense and long-range capabilities.

In a post shared on X, Zelenskyy thanked Swedish Prime Minister Ulf Kristersson, the Swedish Government, and the Swedish people for their continued support. He emphasized that this substantial military aid would directly address Ukraine's urgent defense needs. The President stated, "We deeply appreciate that this military aid meets the urgent needs of the Ukrainian army and significantly contributes to strengthening our defense capabilities. Its reinforcement of our long-range capabilities and investments in weapons production in Ukraine are invaluable."

Zelenskyy also stressed the importance of collective strength in the face of ongoing threats, particularly from Russia. He noted that the support provided by Sweden helps solidify Ukraine's defenses, ensuring peace through strength. "We must all remember that threats like Russia's do not stop on their own; they advance only until the line where they are met with strength. That is why we must continue to strengthen this line together—from the Black Sea to the Baltic—to ensure peace and protect lives," Zelenskyy concluded.

Along with thanking Sweden for the defense package, Zelenskyy also shared updates on the tragic situation in Sumy, a city in northeastern Ukraine. He reported that a residential building was destroyed following a Russian Shahed drone strike, resulting in the deaths of nine people and injuries to thirteen others, including a child. Zelenskyy extended his condolences to the victims' families and assured that those injured were receiving medical assistance.

## **Israeli Hostages Freed** from Gaza: Netanyahu **Welcomes Their Return**

## **Imran Khan Writes Letter** to Pakistan's Chief Justice on Electoral&Human **Rights Violations**

Former Pakistan Prime Minister Imran Khan has written a 349-page letter to Pakistan's Chief Justice Yahya Afridi and Justice Aminuddin, addressing serious concerns over electoral fraud, human rights violations, and the arrests of Pakistan Tehreek-e-Insaf (PTI) members. The letter includes reports of alleged election rigging, the detention of PTI workers, and widespread human rights abuses, particularly around November 26,

In his letter, Khan claims that numerous PTI workers were arrested between November 24 and 27 of last year, with some hospital records being sealed and altered to cover up the facts. He also accused the judiciary of failing to deliver justice, despite multiple petitions highlighting electoral malpractice and human rights violations over the past 18 months. Khan asserted that PTI members have faced extrajudicial killings and forced disappearances under the current regime.

Khan criticized the government for coming to power through "electoral fraud and historic rigging," while accusing them of severe oppression against PTI, including demolishing party offices and subjecting leaders to brutal torture. He also recounted his own arrest on May 9, 2023, which he described as unlawful, and claimed the authorities deliberately aired the event to incite public outrage.



## **Travel Vlogger Drew Binsky** Misses Mahakumbh Mela After 19-Hour Traffic Ordeal

Trapped in Traffic - Binsky stuck 21 km from Mahakumbh, unable to attend. Exhausting Travel Experience - Police checkpoints, smog, and chaos hampered his journey. Missed Opportunity – Vlogger reflects on the once-in-alifetime event missed, with 144 years until the next.

US-based travel vlogger Drew Binsky recently shared his disappointment over missing the Mahakumbh Mela, one of the world's largest human gatherings, despite months of meticulous planning. In a heartfelt social media post, Binsky recounted his 19-hour ordeal stuck in bumper-tobumper traffic, just 21 kilometers away from the sacred event in Prayagraj.

Describing the situation as "complete chaos," Binsky explained the roadblocks, police checkpoints, and smog that made his journey almost impossible. He even contemplated walking the remaining distance but ultimately spent the night in his car, unable to reach the site.

This was a particularly frustrating experience for Binsky, as it was the first time since starting his travel vlogging journey in 2017 that he failed to capture a story. Reflecting on the rarity of the Mahakumbh Mela, which only takes place once every 12 years and will not occur again for another 144 years, Binsky expressed his disappointment.

Despite the setback, Binsky shared plans to head to Beirut, hoping to reflect on his travels and move forward from the experience.



## **Sunita Williams Breaks Spacewalking Record During 92nd US Spacewalk**

On January 30, 2025, NASA astronaut Sunita "Suni" Williams set a new milestone in space exploration by breaking the total spacewalking time record previously held by Peggy Whitson. The achievement was announced during Expedition 72, as Williams spent several hours outside the International Space Station (ISS) to maintain hardware and collect surface samples for analysis. This spacewalk, which began at 8 am EST, was the 92nd US spacewalk. Williams, donning a red-striped space suit, was joined by Butch Wilmore on his fifth spacewalk. Despite the challenging nature of the spacewalk, it was a momentous occasion for Williams, who had already completed nine spacewalks. Controversy surrounding delayed astronaut returns emerged after Elon Musk made comments about the astronauts, including Williams and Wilmore, being "stranded" on the ISS due to delays in their Boeing Starliner capsule. Despite the confusion, the astronauts' safety was never in jeopardy, and their return to Earth was scheduled for March 2025.

## Passenger Load Factor Surpasses US and China, **Reflecting Rapid Growth**

India has emerged as the leader in domestic air travel with a passenger load factor of 86.4% in 2024, surpassing the US and China, according to the latest report from the International Air Transport Association (IATA). The country transported 16.3 crore passengers on domestic flights, as per data compiled by the Directorate General of Civil Aviation (DGCA)

The US secured the second spot with a passenger load factor of 84.1%, followed by China at 83.2%. Brazil ranked fourth with 81.9%, while Australia

(81.8%) and Japan (78%) fol-

lowed closely

IATA's report revealed that total air traffic, measured in revenue passenger kilometers (RPKs), grew by 10.4% compared to 2023, exceeding pre-pandemic (2019) levels by 3.8%. Capacity, measured in available seat kilometers (ASK), also increased by 8.7% in 2024, leading to a record-high global load factor of 83.5%

IATA Director General Willie Walsh emphasized that the aviation sector's growth is a clear indication of people's strong desire to travel. He noted that airlines have achieved record efficiency, filling 83.5% of all available seats

Looking ahead, IATA projects continued growth in air travel, estimating an 8% increase in 2025, which aligns with historical trends. However, Walsh also acknowledged ongoing challenges, particularly in ensuring aviation safety, following a tragic accident in Washington. He reiterated that safety remains the industry's top priority

# **Indian Navy Women Officers Cross Point Nemo, Earth's Most Remote Location**

Two female officers from the Indian Navy, Lieutenant Commander Dilna K and Lieutenant Commander Roopa A, achieved a remarkable feat as they crossed Point Nemo the most remote location on Earthaboard the Indian Naval Sailing Vessel (INSV) Tarini. The officers reached this isolated location at 12:30 am IST on Thursday during the third leg of their circumnavigation journey from Lyttelton, New Zeal and, to Port Stanley, Falkland Islands

Point Nemo, located in the South Pacific Ocean, is known as the Oceanic Pole of Inaccessibility and is situated approximately 2,688 kilometers from the nearest landmass. It is

considered the farthest point from any human habitation, making this achievement a significant milestone in India's naval exploration efforts. The mission is part of Navika Sagar Parikrama II, an initiative aimed at furthering maritime exploration and scientific research Crossing achieved solely under sail, marking a notable maritime navigation accomplishment Water samples collected for research by the National Institute of Oceanography.Part of India's larger mission to support scientific exploration and collab-

As part of their passage through this isolated region, the officers collected water samples, which will be analyzed for marine biodiversity and chemical composition. This data will contribute to ongoing oceanographic research, the Indian Navy said in a statement. Their mission, \*\*Navika Sagar Parikrama II\*\*, represents India's continued commitment to global scientific cooperation and maritime advancements

The officers began their circumnavigation journey from Goa on October 2, 2024, aboard INSV Tarini. They successfully reached Lyttelton Port, New Zealand, on December 22 completing the second leg of the voyage before setting sail for Port Stanley, Falkland Islandsa stretch spanning approximately 5,600 nautical miles. # **Trump Warns BRICS of 100% Tariffs Over De-Dollarization Efforts**

Former US President Donald Trump has reiterated his warning to BRICS nations, including India, against attempts to reduce reliance on the US dollar in global trade. He threatened 100% tariffs on countries that support a BRICS currency or any alternative to the dollar. Trump, in a statement on Truth Social, declared, "We are going to require a commitment from these seemingly hostile countries that they will nei-

ther create a new BRICS currency nor back any other currency to replace the mighty US dollar, or they will face 100% tariffs." His remarks come ahead of the February 1 deadline for deciding on tariffs against Canada and Mexico. The BRICS bloc—comprising Brazil, Russia, India, China, and South Africa—has been exploring ways to reduce dependence on the dollar, particularly after the US removed Russia from SWIFT. Russian President Vladimir Putin has previously advocated for increased trade in

national currencies within BRICS. However, India has maintained a cautious approach, focusing on gradual financial diversification rather than outright dollar replacement. Russia has warned that US attempts to enforce dollar dominance could backfire. Meanwhile, Trump's comments coincide with rising concerns in India over potential economic impacts. His administration has already used tariff threats to pressure nations on trade and geopolitical issues, raising fears of disruption in Indo-US trade relations.



India's economy has made significant strides in the last decade, moving from the 10th-largest by GDP in 2014 to the fifth-largest today. Much of this success can be attributed to the country's infrastructure development, job creation, and the growing middle class. ## **Economic Survey 2024-**25: Growth Strong, But **Wage and Employment Gap Remains a Concern**

The Economic Survey 2024-25 highlights a strong economic growth trajectory, projecting a real GDP growth of 7% for FY25. However, the Survey also underscores the widening gap between corporate earnings, job creation, and wage growth, posing a potential threat to long-term economic sustainability.

While corporate profits have surged by 22.3% in FY24, employment in these firms increased by a mere 1.5%. Employee expenses only rose by 13%, a slowdown compared to 17% in FY23. This indicates that companies are more focused on cost-cutting rather than expanding their workforce, which is a key issue for the broader economy. Despite this, private investment activity has shown positive signs, with resource mobilization from primary markets reaching Rs 11.1 lakh crore between April and December 2024, marking a 5% increase from the previous year. The number of IPOs surged 32.1%, with capital raised almost tripling from Rs 53,023 crore in 2023 to Rs 1,53,987 crore in 2024. However, India's corporate bond market remains underdeveloped compared to global standards, accounting for only 18% of GDP, which is far behind South Korea's 80% and China's 36%.

While the Economic Survey 2024-25 acknowledges private capital revival, it highlights the persistent wage stagnation problem. Nominal wages have risen by around 5-7% annually in agriculture and non-agriculture sectors, but inflation-adjusted wage growth has remained below 2%. This stagnant wage growth, combined with limited employment expansion, results in sluggish demand growth, as workers' purchasing power remains constrained. Despite rising corporate profits, real wage growth remains stagnant, contributing to a growing disconnect between economic growth and living standards.

The Survey also discusses the concept of "enlightened self-interest" for businesses, encouraging them to raise wages to boost consumption and support corporate revenues.

## The Maha Kumbh Tragedy: A Fatal Glimpse into the Dark Side of Blind Faith and Governance



On the occasion of Mauni Amavasaya, thirty pilgrims tragically lost their lives during the Maha Kumbh, as they were crushed in a stampede. This calamity occurred just days after the Union Home Minister, accompanied by Uttar Pradesh's Chief Minister and Baba Ramdev, participated in the grand Kumbh rituals, showcasing the event for political and religious purposes. However, this tragedy quickly punctured the BJP-led government's self-congratulatory narrative, revealing the flaws in managing such large gatherings and exposing the dangerous intersection of faith, politics, and governance.

Despite the tragic loss of life, the Ut-

tar Pradesh government attempted to downplay the incident, framing it as an unfortunate but inevitable consequence of large-scale religious gatherings. A judicial inquiry was promptly announced, but the tragedy was glossed over with no significant accountability. This attempt to sidestep responsibility is hardly surprising, as it fits a pattern of evading blame and shifting focus to avoid addressing systemic failures.

Perhaps more troubling is the argument propagated by a section of the saffron ecosystem, which tries to divert attention from the tragedy by emphasizing the triumph of faith. According to this view, the Kumbh must be celebrated, not

overshadowed by the death of a few pilgrims. This perspective echoes a dangerous regressive mindset, reminiscent of a bygone era of fatalism, where faith was placed above all else, and inaction was justified by divine will.

The excessive glorification of "faith" has been manipulated for political gain, distracting the public from pressing issues such as inequality, corruption, and governance failures. This argument, which seeks to justify the loss of life in the name of religious celebration, diminishes the importance of political accountability. Such rhetoric diminishes the sanctity of human life, fostering a dangerous national insensitivity.

## **The Growing Disenchantment** of India's Middle Class with the Government

For months now, I have been observing a growing sense of disenchantment within India's middle class, the very demographic that propelled Narendra Modi and the BJP to power. While the middle class lacks the electoral weight to swing outcomes on its own, it was once Modi's core constituency. Despite unmet promises over the past two terms, this group held firm in its support. However, that may now be changing.

In recent weeks, I have sensed a deeper shift, one that goes beyond frustration over inflation or high taxation. There's an underlying concern that the government is failing to deliver on the broader promise of India's global ascent. When the BJP first came to power a decade ago, many educated Indians believed the country was on the cusp of greatness. The idea of the "Indian century" was alive; we were



poised to be a dominant global power, both politically and economically. There were high hopes that foreign investment would flood into India, the rupee would stabilize, and the world would respect the Indian passport.

Yet, nearly all of these expectations have been shattered. The rupee has not strengthened but has weakened considerably. From a value of Rs 59 to the dollar under the UPA government, it now hovers around Rs 86-87. The Indian passport, once a symbol of rising global stature, has fallen in rank, and it's more difficult than ever for Indians to secure visas to Schengen countries or the United States. Instead of becoming a trusted partner to the US, India now finds itself at odds with Washington, as President Trump has expressed dissatisfaction with India's tariffs and warned of retaliatory mea-



# Need A \$1 Massage In China? Better Own An iPhone, Porsche Or Luxury Bags

Amassage parlour in Shen-zhen, China, has caused a stir with a unique promotional offer: an 80-minute full-body detox treatment for just 9 yuan, or \$1. While the deal seems too good to pass up, there's a catch—only women who meet specific, high-end criteria are eligible for the offer.

According to a report by the South China Morning Post, the parlour's promotion is limited to women who meet at least one of 27 conditions, including owning luxury property, driving high-end cars like Audi or Porsche, or working for major tech companies such as Tencent or Huawei. Other criteria in-

clude carrying designer luggage, having residency in Hong Kong or Macau, or having traveled to Europe or the United States. The parlour also targets social media influencers with over 500,000 followers, as well as professionals like doctors and bankers.

In a message shared by the parlour, it stated, "If you do not meet the conditions, keep working hard in 2025!" The business defended its controversial offer, claiming it was meant to inspire self-improvement and not merely provide personal gratification.



Despite the exclusivity, the parlour has already received over 100 orders through its app, although one anonymous customer reported that the detox service itself felt no different from a typical massage. This has led to mixed reactions from the public, with some questioning the discriminatory nature of the promo-

The parlour's selective approach has sparked concerns that it may be violating China's Consumer Rights Protection Law, which ensures fair trade practices for all

consumers. Critics have also pointed out that those meeting the lavish criteria are unlikely to be motivated by the low price, raising doubts about the sincerity of the offer.

This isn't the first instance of exclusivity in China drawing criticism. In August 2024, a swimming club in Jiangsu province only allowed women under 45 with high IQs and specific personal qualities to join, further fueling debates about discrimination and the societal implications of such policies.
