Dy CM Shivakumar Responds to Irrigation Projects, **Declines Comment on Triveni Sangam Water Quality**

TPN Correspondent/Bengaluru, Feb 20 Karnataka's Deputy Chief Minister, D.K. Shivakumar, expressed confidence that the central government would approve the state's irrigation projects during his visit to the All India State Water Resources Ministers' Conference in Udaipur. The Union Hydropower Minister has scheduled a visit on February 25, and Shivakumar assured that a proposal for irrigation projects would be submitted. Shivakumar emphasized his belief that the central government would support projects such as Mahadayi, Mekedatu, and Krishma Upper Bank. He noted that the conference provided an opportunity for state ministers to introduce their best irrigation practices and discuss challenges with the Union Ministry of Hydropower. The main aim of the conference, he explained, was to encourage water conservation and reuse, rather than viewing irrigation projects through a political lens. Further, Shivakumar called on the central government to help resolve inter-state water disputes. He mentioned discussions with the ministers of Andhra Pradesh and Telangana regarding the conservation of Tungabhadra river water. A strategy involving all three states,



he stated, should be developed to maximize the efficient use of the river's water. On the issue of Triveni Sangam's water quality in Prayagraj, which has reportedly been deemed unsuitable for bathing, Shivakumar refrained from commenting. When asked by the media, he responded that he would only address matters pertaining to

Karnataka, avoiding involvement in issues concerning other states. As the conference wrapped up, Shivakumar also highlighted the importance of irrigation planning to support farmers, industries, drinking water supply, and urban development. He reiterated the need for a clear national blueprint and more funding for irrigation projects.

BBMP launches online system for new property accounts

The Brihat Bengaluru Mahanagara Palike (BBMP) has implemented a new online system to help property owners apply for a property account (Khata) digitally. This initiative, introduced following directives from CM Siddaramaiah and Deputy CM D.K. Shivakumar, aims to eliminate physical visits to government offices and simplify the process of obtaining property accounts.

BBMP has set a target of issuing 10,000 new accounts across Bengaluru and has urged property owners to utilize this digital service. The application process can be completed in five simple steps through the official BBMP website.

How to Apply Online for a New Property Account

- Visit the BBMP website: **BBMP New Khata Portal**
- Login using mobile number and OTP.
- Enter property details, including the sales/registration number, which will be verified with the Sub-Registrar's records.
- Complete registration with Aadhaar details and upload necessary documents (Encumbrance Certificate, Bescom ID, and a recent property photo). Ensure property tax payments are up to date. Once all details are verified, the account will be created online.

If a property already has a handwritten account, applying for a new account is a criminal offense. Property owners without an existing handwritten account should apply online.

This initiative is expected to streamline property registration and enhance transparency in asset management across Bengaluru.

Rekha Gupta to Take Oath as Delhi's **New Chief Minister by Today**

The tension over who will be the new Chief Minister of Delhi has been resolved, with Rekha Gupta being named as the BJP's choice for the position. Gupta, who won the Shalimar Bagh constituency in the recent Delhi Assembly elections, will take the oath today afternoon at 12:35 PM.The decision was finalized during a Delhi BJP Legislative Party meeting held on Wednesday evening, where Gupta's name was unanimously agreed upon. She previously served as the BJP's state secretary and is a graduate of Delhi University.Despite initial reports suggesting that Parvesh Verma, who famously defeated AAP

chief Arvind Kejriwal in the elections, was a front-runner for the CM post, the BJP high command made a surprise move by selecting Rekha Gupta.In addition to the new Chief Minister, Parvesh Verma will take on the role of Deputy Chief Minister, while Vijayendra Gupta has been appointed as the Speaker of the Delhi Assembly. Along with the oath of the new CM, six cabinet ministers are expected to be sworn in as well. This marks a significant moment for the BJP, as it returns to power in Delhi after a gap of 27 years. The oath-taking ceremony, which will be held in a grand manner, is set to be a pivotal event in the political landscape of the capital.



Kumaraswamy Accuses Congress of Political Vendetta Over

Land Survey

Former Chief Minister H.D. Kumaraswamy has strongly criticized the state Congress government for allegedly targeting him through a land survey in Ketiganahalli near Bidadi, calling it a case of political vendetta. Kumaraswamy, whose land purchase dates back to 1984, has been under investigation since 2012, with authorities repeatedly scrutinizing his property. He accused the Congress government of using the survey as a tool to intimidate him, stating that he is politically helpless and that the matter has been kept alive for over 40 years. In a press conference, Kumaraswamy clarified that he bought the land with money earned as a movie distributor and has always maintained proper documentation. He refuted allegations of land usurpation, highlighting that earlier complaints, including one filed in 1986 by former MLA CM Lingappa and Zilla Panchayat member Ramachandra, did not accuse him of illegal acquisition but merely raised concerns about the land's ownership.

TPN Correspondent /Ben- "I have not engaged in any illegal activity. I am simply cultivating the land I purchased," he said.Kumaraswamy also condemned the formation of a Special Investigation Team (SIT) led by IAS officers, calling it a continuation of baseless investigations. He claimed that despite years of scrutiny, nothing illegal has been found. He further criticized the government's efforts to bring forward new complainants at a time when no one had raised concerns decades.Responding to the SIT's activities, Ku-

maraswamy said he had contacted the Collector and the Principal Secretary of the Revenue Department, requesting proper notice before conducting any survey. He urged the authorities to bring in global-level surveyors to ensure transparency, reiterating that there was no illegality in his land purchase.The former Chief Minister also took aim at what he perceived as the misuse of constitutional institutions and investigation systems, accusing the Congress government of trying to tarnish his reputation without justification.

TPN Correspondent | Karnataka, Feb 20 Karnataka Chief Minister Siddaramaiah, his wife B M Parvathy, brother-in-law Mallikarjuna Swamy, and land seller J Devaraju have been given a clean chit in the Mysuru Urban Development Authority (MUDA) alternate site allotment case, following an investigation by the Lokayukta Police of Mysuru.

In a notice issued on Wednesday, Lokayukta Police informed complainant Snehamayi Krishna that the allegations against Siddaramaiah and the three others could not be proven due to a lack of evidence. The Lokayukta will submit the final report to the special court in Bengaluru, which handles cases involving elected representatives.

However, the Lokayukta has stated that other individuals involved in MUDA's alternate site allotments between 2016 and 2024 will continue to be investigated. As per Section 173(8) of the CrPC, an additional final report will be submitted after further inquiries. The case was initiated following an FIR filed



against Siddaramaiah and others on Sep- land. Following her request, on December 12, tember 27, 2024. Earlier, on September 25, the special court in Bengaluru directed the jurisdictional Lokayukta Police in Mysuru to investigate the complaint filed by RTI activist Snehamayi Krishna.The land in question was originally sold by J Devaraju to Mallikarjuna Swamy on August 25, 2004, and later converted from agricultural to non-agricultural use. On October 6, 2010, Swamy gifted the land to his sister, B M Parvathy, who later sought compensation from the Mysuru Urban Development Authority (MUDA) from 2014 onwards for the acquired

2021, then MUDA Commissioner D B Natesh allotted 14 alternate sites in a developed area under a 50:50 compensation scheme. However, in a significant development, Parvathy returned all the allotted sites to MUDA on October 3, 2024, effectively withdrawing her claim. With the clean chit from the Lokayukta Police, Siddaramaiah and his family have been legally cleared of any wrongdoing in this case. However, the ongoing probe into MUDA's broader alternate site allotments is expected to reveal further details about the allocation process in the coming months.

Tiger Death in Shivamogga

Tiger carcass discovered in Ambaligola reservoir backwaters

Possible bullet injury reported; authorities to verify the claim

Karnataka's Minister for Forest, Ecology, and Environment, Eshwar Khandre, has directed officials to conduct a detailed investigation into the death of a seven to eight-year-old male tiger, whose carcass was found in the backwaters of the Ambaligola reservoir near Byrapura in Shivamogga district.In a note addressed to the Principal Chief Conservator of Forests & Chief Wildlife Warden on February 18, the Minister cited pictorial media reports suggesting that the tiger had a possible bullet (pellet) injury. He has instructed officials to verify the authenticity of these reports and submit a factual report within 10 days. Additionally, concerns have been raised by local residents, who suspect that the tiger was killed elsewhere and later dumped at the reservoir. Their suspicion stems from the fact that the area where the carcass was discovered is not known to have a tiger presence. The Minister has directed officials to examine this angle as well and determine whether the tiger's death was due to poaching or any other foul play. The discovery of the carcass has sparked discussions on wildlife protection and conservation efforts in Karnataka. The state, known for its significant tiger population, has been actively working on conservation measures, and any suspected case of illegal wildlife activity is taken seriously. Forest department officials are expected to conduct a thorough examination of the carcass, including forensic analysis, to determine the cause of death. The results of this investigation will help authorities decide on further legal or conservation measures. As the probe continues, wildlife activists and conservationists have urged authorities to ensure that any illegal activity related to the tiger's death is uncovered and addressed promptly. The incident underscores the importance of strict anti-poaching laws and enhanced monitoring of wildlife habitats to prevent such occurrences in the future. The department's findings, expected within the stipulated time frame, will provide clarity on the circumstances surrounding the tiger's death, ensuring accountability and reinforcing efforts to protect Karnataka's wildlife.

Karnataka to Resume Additional 5 kg Rice **Supply Under Anna Bhagya Scheme**

Beneficiaries to receive 10 kg of rice monthly from February

State to procure rice from FCI at ₹22.5 per kg

Scheme expected to cost ₹536.71 crore per month

The Karnataka government will begin providing an additional 5 kg of rice per month to each Below Poverty Line beneficiary under the Anna Bhagya scheme from February, State Minister K H Muniyappa announced on Wednesday.The Congress government had promised to supply 10 kg of rice per beneficiary every month, including 5 kg provided by the Centre under the National Food Security Act, 2013 (NFSA). However, due to an insufficient supply



of food grains, the state government had been transferring ₹170 per person to beneficiaries' bank accounts instead of the additional rice. This practice, which continued until January, will now be discontinued.The Congress had accused the Central government of attempting to sabotage the scheme by withholding rice stocks, despite ample reserves in the Food Corporation of India (FCI) warehouses. Muniyappa confirmed that after negotiations with Union Food and Civil Sup-

state has secured an agreement to procure 2.1 lakh tonnes of rice per month at a rate of ₹22.5 per kg."The Centre has assured us of a consistent rice supply for the next two years. From February, we will distribute 5 kg of rice per person per month instead of providing Direct Benefit Transfers, Muniyappa stated. The implementation of the scheme will require an estimated ₹536.71 crore per month. Muniyappa also noted that the Centre procures rice at ₹40 per kg, including transportation costs, and distributes it under the NFSA. The Anna Bhagya scheme was one of the five key guarantees made by the Congress in the run-up to the Karnataka Assembly elections in May 2023. With the upcoming Lok Sabha elections, the revival of direct rice distribution is expected to bolster the party's support among BPL families.

Infosys Denies Intimidation in Trainee Layoffs, **Assures Cooperation with Labour Authorities**

Karnataka, Feb 20 Infosys has refuted allegations of using force or intimidation tactics when terminating over 300 trainees at its Mysuru campus due to performance issues. Chief Human Resources Officer Shaji Mathew stated that the company has been transparent with the Karnataka Labour Department, explaining the circumstances surrounding the layoffs. While acknowledging that failure rates in assessments were slightly higher than usual, Mathew denied claims that the tests were designed to fail trainees. He emphasized that Infosys has a vested interest in seeing trainees succeed, as the company invests in their selection, training, and salary payments. Following the termina-

Labour and Employment directed the Karnataka Labour Department to investigate. Reports suggest that officials visited Infosys campuses in Bengaluru and Mysuru to evaluate the situation.Mathew confirmed Infosys' full cooperation, stating that authorities have been briefed on the company's training process, assessment criteria, and talent development approach. According to him, the department has been supportive and raised no further demands, including reinstating the terminated trainees.

The layoffs sparked criticism from the IT employees' union NITES, which accused Infosys of forcing trainees to sign 'mutual separation' agreements. The union urged govern-

tions, India's Ministry of ment intervention, claiming that Infosys engaged in unethical termination

practices. Mathew firmly dismissed allegations that bouncers were used to intimidate trainees. "We never considered such an approach. These are our trainees, and we respect them," he asserted. He also clarified that trainees who wished to stay on campus post-termination were allowed to do so.

In response to concerns over high failure rates, Infosys has postponed upcoming internal assessments for another batch of 800 trainees by a week to allow them more preparation time. Mathew stressed that the company wants all trainees to succeed and is providing extra support, including counselling services.



Bengaluru Man Wins Case Against PVR INOX Over Excessive Advertisements

uru, Feb 20

A Bengaluru man, Abhishek M R, has won a consumer case against PVR INOX after filing a complaint about excessive advertisements before a movie screening. The case, filed in 2023 after he went to watch Sam Bahadur, highlighted how 25-minute-long ads delayed the film, disrupting his schedule. The district consumer forum ruled in favor of Abhishek, stating that PVR INOX cannot "engage in unfair practices and waste moviegoers' time by showing long commercial ads during the time slot meant for the movie itself." The court directed the theater chain to clearly mention the actual start time of the movie on tickets instead of when advertisements begin. This ruling ensures that customers are better informed and not misled by vague showtimes. As part of the judgment, the court also awarded Abhishek a total of ₹1.28 lakh in compensation. This includes ₹20,000 for mental distress caused by the excessive advertisements, ₹8,000 to cover his legal expenses, and ₹1 lakh in punitive damages for unfair trade practheater chain argued that government regulations mandate the screening of public service announcements (PSAs) before

The court also ruled that BookMyShow, an online ticketing platform named in the case, cannot be held responsible since it does not control te screening schedule or the duration of advertisements. During the proceedings, Abhishek provided video recordings as evidence to prove the duration of the ads. In response, PVR INOX claimed that recording content inside the theater violated anti-piracy laws. However, the court dismissed this argument, clarifying that Abhishek had only recorded the advertisements and not the movie itself. It further noted that the complaint was made in the public interest, as prolonged ads affect all moviegoers. The judgment establishes a significant precedent by ensuring greater transparency in cinema scheduling and protecting consumers' rights. With this ruling, movie theatres' must now adhere to stricter guidelines regarding advertisements and ensure that viewers are given accurate information about showtimes. BWSSB Collects ₹21 Lakh in Fines for Water Misuse in 2024

BWSSB collected ₹21 lakh in fines for violations in 2024.

TPN Correspondent | Bengaluru, Feb 20 With Bengaluru continuing to grapple with a severe water crisis, the Bangalore Water Supply and Sewerage Board (BWSSB) has once again imposed strict restrictions on the use of potable water for non-essential purposes. In 2024, the board booked over 400 cases and collected ₹21 lakh in fines for violations. This crackdown was introduced after a drought-stricken 2023 led to an acute shortage of water in the city.On February 17, BWSSB reaffirmed that potable water should not be used for activities such as gardening, washing vehicles, construction, fountains, and road works. To ensure compliance, a fine of ₹5,000 per offence has been introduced. The decision comes as authorities prepare for an intense summer season, aiming to conserve water resources and promote sustainable usage.Citizens can report any violations of the water usage ban through the dedicated 1916 helpline set up by BWSSB. To promote the use of treated water, the board has launched the 'Parisara Snehi' app, allowing easy procurement for non-essential activities such as construction. Additionally, BWS-SB has collaborated with various government and private Sewage Treatment shift to treated water, highlighting chal-



Plants (STPs) to ensure a steady supply of treated water to builders, reducing dependency on potable water and encouraging sustainable water management. In an effort to streamline enforcement, BWSSB has set up a dedicated helpline (1916) for citizens to report any misuse of water. Additionally, the board has introduced the 'Parisara Snehi' app, which allows builders and contractors to procure treated water for construction purposes. Officials believe these measures will make it easier to implement the ban this year, reducing dependency on potable water for non-essential needs. BWSSB Chairman Ram Prasath Manohar emphasized that the construction sector is one of the largest consumers of water. To address this, the board has partnered with both government and private Sewage Treatment Plants (STPs) to provide treated water. "Builders can now book water online through the Parisara Snehi app, ensuring a smooth transition to sustainable alternatives," Manohar said.

CREDAI has raised concerns over logistical constraints in implementing the lenges related to transportation and the overall feasibility of the supply chain. Developers worry about the availability, distance, and smooth delivery of treated water to construction sites. In response, BWSSB has assured continued monitoring and support to address these challenges, working closely with stakeholders to streamline the process and ensure an efficient water distribution system. Despite BWSSB's initiatives, the Confederation of Real Estate Developers' Associations of India (CREDAI) has expressed concerns over the feasibility of using treated water. Suresh Hari, Secretary of CREDAI Karnataka, highlighted logistical challenges, including transportation and accessibility. "A proper supply chain must be in place to make this initiative viable. We support the move, but practical challenges need to be addressed," he said.BWSSB has assured builders that they will work closely with industry stakeholders, including the Bangalore Apartment Federation, to resolve any procurement issues. With stricter enforcement, authorities hope to ensure Bengaluru's water security amid rising demand and limited supply.

Heritage Maritime Museum to come up in Bengaluru

The Karnataka Maritime Board (KMB) has announced plans to establish a heritage Maritime Museum near the historic lighthouse in Hoigebazar, Mangaluru. Speaking at the Coastal Karnataka Tourism workshop, KMB CEO Jayaram Raipura stated that a detailed project report (DPR) has been prepared, and the Board is awaiting funding approval from the state government. "We are hopeful of a budgetary allocation in the upcoming state budget," he added. Highlighting the importance of the project, Raipura noted that Karnataka is the only coastal state in India without a maritime museum. The proposed museum will preserve the region's rich maritime heritage and will be developed under the Public-Private Partnership (PPP) model, with KMB constructing the permanent infrastructure. In an effort to improve water transport, the KMB has proposed a Water Metro project on the Gurupura River in Mangaluru, modeled after the Kochi Water Metro. The first phase of the project envisions 17 jetties, 10 boats, and 20 buses for last-mile connectivity. It aims to enhance shore-to-shore transportation, daily commuting, and tourism. The second phase will expand the project by linking the Swarna, Nethravathi, and Gurupura rivers. The KMB is also working towards setting up a dedicated Lakshadweep jetty in Mangaluru to facilitate better connectivity with the island territory. Additionally, water dromes' have been proposed at Ganesh Gudi, Linganamakki, Kabini River, and Nethravathi River to boost water-based tourism and trans-



port.To position Mangaluru as a key player in international cruise tourism, the KMB has proposed an international cruise and tourism port at Battappady in Someshwara with an 18-metre draft. A pre-feasibility report has been completed, and IIT Madras is currently preparing the DPR. The project will be open for private partnerships soon and will initially include a container terminal, later transitioning into a full-fledged cruise port connecting to Sri Lanka, Mauritius, the Gulf, and Europe. Several leading cruise operators have already shown interest in the project.In a major push for coastal tourism, seven islands in Uttara Kannada, including Kurumgad, Madhyalingad, Kangiguda, and Hog Island, have been identified for development, subject to Coastal Regulation Zone (CRZ) regulations. Meanwhile, islands in Dakshina Kannada and Udupi districts are being studied for similar development. As part of the Shoreline Management Plan, a DPR is being prepared for each coastal district to address sea erosion.

The Lokayukta informed complainant Snehamayikrishna that the case was not worthy of investigation. However, opposition leaders have expressed outrage over the report, alleging a cover-up and demanding a probe by the Central Bureau of Investigation (CBI).Leader of Opposition R. Ashok criticized the report, sarcastically remarking that it was "not a clean chit but a wash with Nirma powder." Speaking to the media in Bengaluru, he questioned why expensive lawyers were hired if there was no wrongdoing. He alleged that the police officers involved in the case were seeking transfers and promotions, leading to the closure of the case. Ashok further accused the Lokayukta of issuing a pre-determined report, calling it a deliberate attempt to shield those in power. Ashok also raised questions about the return of 14 sites, stating, "If there was no mistake, why did they give back the sites?" He claimed that the illegal layout was ignored until the accused wanted a 50:50 site division. He also suggested that CM Siddaramaiah was too cautious to leave any direct evidence such as phone calls or letters. He insisted that only an independent investigation could uncover the truth, reiterating that justice had not been served.Chalavadi Narayanaswamy, Leader of Opposition in the Legislative Council, also slammed the Lokayukta's decision. He stated that a CBI investigation was necessary to reveal the truth. He guestioned the Congress party's trust in the CBI, pointing to alleged past misuse of the agency. Caste census will be made public: CM Siddaramaiah



NGT Pulls Up UPPCB Over Water Quality Reports at Maha Kumbh

The National Green Tribunal (NGT) reprimanded the Uttar Pradesh Pollution Control Board (UPPCB) for failing to submit adequate information regarding water quality, particularly faecal coliform levels, in the Ganga and Yamuna rivers at Prayagraj during the ongoing Maha Kumbh.A report submitted earlier this month by the Central Pollution Control Board (CPCB) highlighted alarmingly high levels of faecal coliform—microbes originating from human and animal waste at the confluence of these rivers, where millions are taking part in ritual bathing.Additional Advocate General Garima Prashad, representing the Uttar Pradesh government, stated that while the State government is not contesting the CPCB's findings, it is seeking clarification on the sampling points used for data collection. The NGT noted that the UPPCB's report, submitted to the court, only included water samples collected until January 12, prior to the commencement of the Maha Kumbh. Expressing its dissatisfaction, the tribunal questioned why the report, spanning 250 pages, lacked crucial details on faecal coliform levels. The bench criticized the submission, suggesting it was an attempt to waste the tribunal's time. The Principal Bench of the NGT, consist-



ing of Chairperson Justice Prakash Shrivastava, Judicial Member Justice Sudhir Agarwal, and Expert Member A. Senthil Vel, is reviewing a plea concerning the water quality of the Ganga and Yamuna rivers at Prayagraj.In its February 17 order, the NGT referenced the CPCB report, which stated, "River water quality was not conforming with the primary water quality for bathing with respect to Fecal Coliform (FC) at all monitored lo-

cations on various occasions. The large number of people bathing at Prayagraj during the Maha Kumbh Mela, especially on auspicious days, has significantly increased faecal concentration."The UP-PCB informed the tribunal that it possesses the latest reports on water quality. Consequently, the NGT directed the State pollution board to file the updated report within a week and scheduled the next hearing for February 28.

Flu Outbreak Triggers Poultry Price Drop, Mutton and Seafood Costs Surge

The ongoing bird flu outbreak has significantly impacted the poultry industry, leading to a sharp decline in chicken prices across several districts in the state. At the same time, consumers shifting away from poultry have fueled a surge in the demand and cost of mutton and seafood. In Guntur, the price of skinless chicken has fallen to ₹160 per kg, down from ₹180-₹210, while chicken with skin has dropped from ₹160 to ₹140 per kg. Similarly, a tray of 30 eggs, which previously cost ₹170-₹190, is now being sold for ₹160. In Kakinada, the price of skinless chicken has reduced from ₹260 to ₹240 per kg, and chicken with skin is now ₹220 per kg, down from ₹240. The price of eggs has also seen a decline, dropping from ₹6.70 to ₹5.30 per piece.A similar trend is observed in Tirupati, where live chicken prices have plummeted from ₹155 to ₹133 per kg, and dressed chicken has dropped from ₹190 to ₹163 per kg. Additionally, the cost of 100 eggs has decreased from ₹560 to ₹500.While chicken prices have slightly increased in some parts of YSR district, egg prices have continued to decline. However, the shift away from poultry has caused a surge in mutton prices. In Guntur, mutton, which was previously priced between ₹750 and ₹900 per kg, has now soared to ₹1,000 per kg. Similar price hikes have been recorded in Tirupati and Anantapur. The seafood market has also witnessed a significant rise in prices. Prawns, which were previously available at ₹400 per kg, are now being sold for ₹600 per kg. Fish prices have also surged, with Pandugappa fish increasing from ₹500 to ₹800 per kg. This increased demand for seafood has contributed to a 10% rise in fish production. However, concerns have emerged regarding the use of chicken waste as fish feed, prompting authorities to closely monitor the situation to prevent potential health risks. As the bird flu outbreak continues, authorities are urging consumers to take necessary precautions while handling and consuming poultry products. poultry farmers are facing heavy losses due to the sudden drop in demand, and industry experts anticipate that it may take weeks for the market to stabilize.



Two Arrested in Rs 1.56 **Crore Online Trading** Scam in Chennai

The cybercrime wing of the Avadi Central Crime Branch (CCB) has arrested two individuals for their involvement in an online trading scam that defrauded a civil engineer from Mangadu of Rs 1.56 crore. The accused, identified as A Ajith Kumar (29) from Sivagangai and P Prakash (41) from Puducherry, acted as money mules, providing their bank accounts for fraudulent transactions and facilitating

the transfer of funds abroad.

According to police sources, the victim, Jayaraman (55), fell prey to the scam after receiving a WhatsApp advertisement in June 2023 that promised assured 100% profits through online trading. Upon responding, he was added to a WhatsApp group consisting of over a hundred members. The group included individuals who frequently posted messages claiming to have earned high returns. Some members also reached out to Jayaraman privately, encouraging him to invest.

Believing the scheme to be legitimate, Jayaraman initially invested Rs 5,000. Over the following months, he continued making investments, eventually depositing Rs 1.56 crore by July 2024. He transferred funds to a bank account provided within the group. However, he became suspicious when he was unable to withdraw his displayed profits. Realizing he had been de-

Correspondent IUttar frauded, he lodged a complaint with the police in September. Investigations led to a fake company registered in Puducherry under the name of Ajith Kumar, who had only completed Class X and was working in an eatery in

Chennai. Police discovered that Jayaraman had transferred all his money into this account, from where it was redirected to another account belonging to P Prakash, a BA graduate from Puducherry.

Ajith and Prakash were allegedly recruited by a cybercrime syndicate to run an office dedicated to the scam. Ajith was responsible for receiving funds from victims, which he then transferred to Prakash. The latter managed the further transfer of funds to international accounts. In return, Ajith earned Rs 1.5 lakh as commission, while Prakash received Rs 1.1 lakh.

According to police, a separate WhatsApp group was created to communicate with victims, reinforcing the illusion of a legitimate trading platform. Authorities are currently investigating how the money was laundered and transferred abroad. Efforts are also underway to identify the masterminds behind the operation.

The police have urged the public to be cautious of online investment schemes that promise unrealistic returns and to verify the legitimacy of trading platforms before making any financial commitments.



"If Forced, We Can Be Aggressive **Too": Army Chief On Pakistan**

Indian Army Chief General Upendra Dwivedi has stated that India's stance toward Pakistan, particularly along the Line of Control (LoC), has become significantly more assertive since 2014. In an exclusive interview with ANI, General Dwivedi conveyed that India's communication with Pakistan now makes it clear that any provocation would be met with a robust response.

"We have been clear that we will be assertive in our communication and, if needed, aggressive," General Dwivedi said, emphasizing India's resolve in protecting its interests. The Army Chief underscored that both sides have understood India's commitment to its security and its intent to act when provoked.

A key point in General Dwivedi's interview was his assessment of the situation in Jammu and Kashmir (J&K) following the abrogation of Article 370 in August 2019. He noted that the revocation had significantly reduced the number of terrorists and local recruits in the region, while eliminating the confusion among the people about their identity.

"The recruitment has reduced. Local terrorist numbers have gone down," he explained. He further explained how the abrogation helped resolve the identity crisis, with children now clearly identifying as part of India, symbolized by their choice to draw the Indian flag in school.

General Dwivedi also highlighted the security forces' collaborative efforts, including the theme of "terrorism to tourism," which he sees as having brought success. With over five lakh pilgrims participating in the Amarnath Yatra, a figure previously unheard of, the Army Chief noted that efforts to foster development in the region are yielding positive results.



In First "Green Budget", Rajasthan Announces 1.25 Lakh **Government Jobs**

Rajasthan Deputy Chief Minister and Finance Minister, Diya Kumari, has unveiled the state's first "green budget," placing a strong emphasis on climate change adaptation, environmental sustainability, and large-scale infrastructure development. The budget aims to steer Rajasthan toward becoming a \$350 billion economy by 2030.

In her 138-minute budget speech, Diya Kumari announced several key measures, starting with an ambitious plan to generate employment opportunities. The state plans to recruit 1.25 lakh government jobs in the coming year, with an additional 1.5 lakh jobs expected in the private sector. To further promote youth employment, Rajasthan will implement the Rajasthan Employment Policy 2025.

The budget also sets an estimated revenue receipt of Rs 2,94,536.49 crore for 2025-26, with revenue expenditure projected at Rs 3,25,545 crore, resulting in a revenue deficit of Rs 31,009.41 crore and a fiscal deficit of Rs 84,643 crore, equaling 4.25% of the state's Gross Domestic Product (GSDP).

Infrastructure development is another major focus. The Finance Minister announced the creation of a New Aero City near Kota Airport and the improvement of 29 airstrips across the state. Rs 250 crore has been allocated to improve Jaipur's traffic system, and Rs 12,000 crore has been earmarked for expanding metro services. An ambitious plan for developing 9 GreenField Expressways will receive Rs 60,000 crore in funding.

Rajasthan is also prioritizing renewable energy. Households installing solar plants will receive 150 free electricity units per month, and Rs 250 crore has been allocated for the Green Aravalli Development Project. To enhance energy production, the state will add 6,400 MW in 2025-26 and introduce new agricultural and domestic connections.

Water availability is a key concern, with new water connections planned for 20 lakh households. The budget also includes provisions for the industrial sector, including the establishment of the Rajasthan Mineral Exploration Company and the Center of Excellence for Mines and Minerals.

Tamil Nadu Ready For Language War": **Udhayanidhi Stalin Amid Row Over Hindi**

The ongoing battle between Tamil Nadu's ruling DMK and the BJP escalated on Tuesday, fueled by the center's proposed three-language policy and accusations of Hindi imposition. Deputy Chief Minister Udhayanidhi Stalin sparked fresh tensions by stating, "States that accept Hindi lose their mother tongue," and declaring that Tamil Nadu was prepared for a "language war" over the issue.

Mr. Stalin's remarks were a direct challenge to Union Education Minister Dharmendra Pradhan's stance, which had linked the state's eligibility for around Rs 2,400 crore in funding for the Samagra Siksha mission to its adoption of the National Education Policy (NEP), which includes the controversial three-language formula. This policy advocates the teaching of Hindi, along with regional languages and English, in schools across India.

Stalin also reiterated a criticism from Chief Minister MK Stalin, who had earlier accused Pradhan of "blackmail," pointing out that Tamil Nadu is merely seeking its due both in terms of education funding from the central government and the fair share of tax devolution.

Trump Signs Executive Order To Expanding Access To IVF Treatments

President Donald Trump took a significant step toward increasing access to in vitro fertilization (IVF) by signing an executive order aimed at reducing the cost and improving availability of the treatment. The order directs his advisors to provide recommendations within 90 days on how to protect and expand access to IVF, while also focusing on lowering out-of-pocket and insurance costs for families seeking fertility assistance.

"My Administration recognizes the importance of family formation, and as a nation, our public policy must make it easier for loving and longing mothers and fathers to have children," the order reads. "Americans need reliable access to IVF and more affordable treatment options," it continued.



Trump expressed confidence in the support of families, saying, "I think the women and families, husbands, are very appreciative of it," during a press conference at his Mar-a-Lago estate in Florida This move is seen as a surprising development from a president whose administration has been aligned with conservative policies on issues like abortion. While Trump made headlines for his role in the Supreme Court's 2022 decision that overturned federal abortion protections, which earned him strong support from the anti-abortion movement, his support for IVF has stirred controversy within conservative circles.


Though IVF is praised by some as a vital tool for family-building, others in the religious right oppose the procedure, as it often involves creating multiple

embryos, some of which may not be used. In the past, many Republicans, including a majority in the Senate, voted against guaranteeing IVF access.

The Supreme Court's 2022 abortion ruling raised concerns among reproductive rights advocates that IVF could be next on the chopping block, particularly after a court in Alabama ruled that frozen embryos could be considered people, leading some clinics to pause treatments temporarily.

With this executive order, Trump seems to be trying to balance his appeal to conservatives with an eye toward addressing broader voter concerns about fertility treatments. However, the move may provoke opposition from those within his own party who view IVF as inconsistent with pro-life principles.

Mumbai, Kolkata Vulnerable? NASA Says Chances Of 'City-Killer' Asteroid Hitting Earth impact on December 22, 2032.

NASA has increased the likelihood of asteroid 2024 YR4 colliding with Earth to 3.1 percent, tracking its trajectory as the asteroid continues its orbit. While the risk remains low, the potential impact corridor of 2024 YR4 spans several regions, including the eastern Pacific Ocean, northern South America, the Atlantic Ocean, Africa, the Arabian Sea, and South Asia. This trajectory puts some of the world's most popu-

lated cities at risk, including Mumbai, Kolkata, Dhaka, Bogotá, Abidjan, Lagos, and Khartoum, which together house over 110 million people.

Astronomers have labeled 2024 YR4 as a "city-killer" asteroid, meaning that while its impact would not threaten the planet as a whole, it could cause devastating damage to a city. NASA's predictions were updated from an earlier 2.3% chance of collision, with a revised risk probability for a potential

NASA has been monitoring the asteroid using ground-based telescopes from the International Asteroid Warning Network, and while it is visible through April, it will become too faint to observe until around June 2028. The asteroid's size is estimated to be between 130 and 300 feet wide, and its composition appears typical, without rare metals. If it does not hit Earth, experts predict it could explode midair with the force of approximately eight megatons of TNT, over 500 times the power of the Hiroshima bomb.

NASA's report noted that while the risk of impact is still extremely low, the asteroid's path will be better understood as more data becomes available. It is also possible that 2024 YR4 could be ruled out as a threat, as many objects in the past have been after further analysis. The asteroid was first identified on December 27, 2024, by the NASA-funded Asteroid Terrestrial-impact Last Alert System in Chile and quickly made it to NASA's Sentry risk list on December 31,

Hamas Proposes Large-Scale Hostage Release for Permanent Ceasefire with Israel

Hamas has presented a significant proposal in the ongoing ceasefire talks with Israel, offering to release all remaining captives in the Gaza Strip in one large-scale exchange. This proposal is contingent on securing a lasting ceasefire and the complete withdrawal of Israeli forces from Gaza. Hazem Qassem, a spokesman for Hamas, emphasized the group's commitment to this plan, stating, "We are ready for a second phase in which the prisoners will be exchanged in one go, within the criterion of reaching an agreement that leads to a permanent ceasefire and a complete withdrawal from the Strip."

This offer represents a crucial development in the negotiations, as Hamas seeks not only the release of captives but also the end of Israel's military presence in Gaza. The group, however, rejected Israel's demand for its disar-



mament and removal from Gaza, dismissing such requests as part of a "ridiculous psychological war." Qassem further stressed that the withdrawal or disarmament of Hamas from Gaza is unacceptable.

In a move to demonstrate its commitment to the negotiation process, Hamas has agreed to increase the number of captives to be freed during the next exchange on Saturday, from three to six. The Hostages and Missing

Families Forum welcomed the decision, expressing profound joy at the return of Eliya Cohen, Tal Shoham, Omer Shem Tov, Omer Wenkert, Hisham Al-Sayed, and Avera Mengistu. Hamas made this adjustment in response to requests from mediators and to show their

seriousness in upholding the terms of the agreement.

The proposal comes as U.S. President Donald Trump voiced opposition to a phased release of hostages, advocating for all captives to be freed simultaneously, a sentiment echoed by the families of the remaining hostages. Meanwhile, the humanitarian situation in Gaza continues to worsen, with the death toll surpassing 61,000, as reported by Gaza's Ministry of Health.

Poll Gives Zelensky 57% Approval Rating Despite Trump's 4% Claims

A recent poll conducted by the Kyiv International Institute of Sociology revealed that Ukrainian President Volodymyr Zelensky enjoys an approval rating of 57%, contradicting claims made by former US President Donald Trump, who suggested Zelensky's approval rating was as low as 4%. Trump's comments, made on Tuesday, came amidst his call for presidential elections in Ukraine, a process that is currently banned under the country's martial law.

Trump's assertion that Zelensky's popularity had plummeted to just 4% was widely criticized, as the Kyiv International Institute of Sociology's poll, which surveyed 1,000 people, found that 57% of respondents expressed trust in the Ukrainian leader. Only 37% of those surveyed disapproved, with the remaining respondents being undecided. The poll also indicated a 5% increase in trust for Zelensky compared to December, despite the ongoing military challenges Ukraine faces due to the war with Russia.

Zelensky's approval ratings had skyrocketed to 90% in March 2022, shortly after Russia's invasion, as Ukrainians rallied behind their president during the early stages of the conflict. Despite setbacks, the poll's authors noted that Zelensky continues to retain a relatively high level of trust from the Ukrainian public.

Trump's remarks align with Russian President Vladimir Putin's assertions that Zelensky is not the legitimate president of Ukraine. However, the Ukrainian constitution, while restricting presidents to a five-year term, allows for an extension until a successor is elected, which has led to debates over Zelensky's term during the ongoing war. Zelensky himself has argued that holding elections is currently impractical due to the war, the large number of Ukrainians either fighting or living abroad, and the significant security risks involved.

The authors of the poll noted that most Ukrainians believe elections should be held only after the war concludes. Despite the contrast in approval figures, it remains unclear how Trump arrived at the 4% rating, with Russian political analysts speculating that it reflects Trump's disregard for factual accuracy.



Elon Musk uncovers 'biggest fraud in (US) history': Is there any truth to it?

Billionaire entrepreneur Elon Musk has once again stirred controversy, claiming that his Department of Government Efficiency (Doge) has uncovered massive fraud within the U.S. Social Security Administration (SSA). According to Musk, millions of payments are being made to individuals over 150 years old, which he dubbed "the biggest fraud in history."

Musk made these claims during a February 11 press conference in the Oval Office, where he stated that a "cursory examination of Social Security" revealed "crazy things." He specifically pointed to records showing individuals who appeared to be 150 years old. "Now, do you know anyone who's 150? I don't, OK. They should be in the Guinness Book of World Records. I think they're probably dead, or they should be very famous," Musk remarked.

His comments quickly went viral on social media, especially on his platform X, but have since been widely questioned by experts. A closer examination of the situation suggests that Musk's interpretation may be based on a misunderstanding of the SSA's aging technology systems.

The core issue lies with the outdated COBOL programming language used by the SSA, which has been in operation for decades. Experts in computer programming explain that COBOL lacks a built-in date type, which can cause errors in the recording of birthdates. 


