



The Group 2 exam saga has sparked heated debates across Andhra Pradesh, with fingers pointing in all directions over who botched the process. The chaos kicked off back in 2023 under the Jagan-led administration, which rolled out a flawed job notification just

as elections loomed on the horizon. In a pre-election gambit, the YSRCP government trumpeted 899 openings for Group 2 posts. But job hopefuls quickly cried foul, accusing the regime of bungling the reservation quotas. Critics slammed the move as a blatant ploy to woo young voters rather than a genuine effort to fill positions. Disgruntled candidates hauled the matter into court, arguing the allocation of slots was riddled with errors.

The preliminary round saw 92,250 contenders clear the hurdle for the

mains, only for the roster mess to trigger a judicial showdown. The High Court stepped in, mandating that the mains proceed as scheduled on FebruThe Group II Mains examination concluded smoothly today, with 92,250 candidates appearing for the test. Despite calls for a boycott, the turnout remained unaffected, recording an impressive 92% attendance. The results of the exam, however, will only be released after the High Court's decision, as cases related to errors in the roster system are still pending. Aspirants had urged the government to rectify these errors before conducting the exam, but the APPSC dismissed their concerns, arguing that most protestors were those who did not qualify for the mains and were pushing for a fresh notification. The APPSC also claimed that coaching center lobbies were behind the postponement demands for their own benefit. While protests escalated last night, threatening to derail the exam, the turnout figures suggest they had no impact. Officials reported that the highest attendance was recorded in Visakhapatnam district, while Nellore saw the lowest participation. The 8% absentee rate was deemed routine by authorities.

Students showed up, begrudgingly penciling in answers, while the fallout from Jagan's hasty 2023 vote-grabbing stunt lingers. The current administration, boxed in by legal and electoral shackles, can do little but watch. The real losers? The aspirants caught in this tangle, all thanks to a sloppy scheme cooked up by the previous rulers to charm the youth.

Will Jagan Walk Through Gate-4 as a Regular MLA?

The Andhra Pradesh Assembly budget session begins today, with the 2025-26 financial year budget set to be presented. YSRCP chief Jagan Mohan Reddy, along with his party MLAs, will be attending the session. However, as Jagan does not hold the status of Leader of Opposition, he will be participating as a regular MLA. As per Assembly protocol, entry gates are

assigned based on position. The Governor, Chief Minister, Deputy CM, Speaker, and Deputy Speaker enter through Gate No. 1, while ministers use Gate No. 2. Regular MLAs and MLCs must enter through Gate No. 4. Since Jagan is now an ordinary MLA, he is expected to walk through Gate No. 4, sparking a debate. Speculation is also growing over whether the Speaker might exercise discretion to allow Jagan to enter through Gate No.

Jagan Set to Enter the Assembly: Strategic Move or Forced Compromise?

The echoes of "I am coming," which were heard before 2019, are now making waves again on social media. However, this time, it's not about Jagan Mohan Reddy returning to power but about his long-awaited entry into the Andhra Pradesh Assembly. The suspense remains—what will Jagan do once he steps inside? Will he stay till the end of the Governor's speech? Will he use the moment for a strategic political move or simply mark his attendance and leave?

Will He Face Ragging

As an MLA without opposition status, Jagan will not be entitled to the privileges usually accorded to the Leader of the Opposition. He will only have the same speaking rights as an ordinary MLA, limiting his ability to counter the government effectively. This situation may put him in an uncomfortable po-

sition, as political opponents are expected to target him with criticism. The challenge for Jagan is whether to endure these attacks in silence—potentially gaining public sympathy—or to engage in heated debates, which could lead to further criticism. If he chooses to boycott the session after a brief appearance, he risks being accused of running away. Meanwhile, the ruling alliance is prepared to remind him of how YSRCP MLAs once humiliated Chandrababu Naidu in the Assembly when Jagan was in power. Now, they see this as the perfect moment to settle scores.

The Andhra Pradesh Assembly budget sessions are set to begin today, with Governor Justice Abdul Nazeer addressing both houses. After his speech, the house will be adjourned to the next day, followed by a Business Advisory Committee (BAC) meeting to finalize the session's duration and agenda. The budget sessions are expected to last for two to three weeks.

YSRCP chief and former Chief Minister YS Jagan Mohan Reddy, along with other party MLAs, will be attending the sessions. In light of this, authorities have implemented strict security measures, including regulated movement and entry into the premises. Special passes have been issued to ministers, MLAs, MLCs, media personnel, visitors, and police officers. Only those with valid passes will be allowed inside, with different color codes designating access to various areas within the assembly and council.

As per the new protocol, only the Speaker, Deputy Speaker, Chief Minister, and Deputy Chief Minister can enter through Assembly Gate 1, while ministers will use Gate 2. MLAs and MLCs will enter through Gate 4. Unauthorized access to corridors used by the Speaker, CM, and Chairman of the Council has been strictly prohibited.

For security reasons, weapons, batons, placards, and whistles are banned inside the assembly premises. Personal assistants of ministers and members will only be allowed if deemed necessary. Additionally, members and ministers have been instructed to hold media interactions only at designated media points within the Assembly. Protests, dharnas, and demonstrations have been completely restricted in the Legislative Assembly premises.

AP Eyes Tesla Investment with Land and Port Offer?

Andhra Pradesh is making a strong push to attract global electric vehicle giant Tesla as it prepares to enter the Indian market. With reports suggesting Tesla is keen on a largescale entry into the country, several state governments are in a race to secure the investment. The TDP-led government, under Chief Minister N. Chandrababu Naidu and IT Minister Nara Lokesh, is actively working to position Andhra Pradesh as the ideal destination.

According to national media reports, the state's Economic Development Board (EDB) has presented a compelling case to Tesla, highlighting Andhra Pradesh's strategic advantages, including port connectivity and a vast land bank. The state government is offering prime industrial land and access to its well-developed ports to facilitate Tesla's initial import operations before it sets up a full-fledged manufacturing unit.

The groundwork for Tesla's entry into Andhra Pradesh began in October 2024 when IT Minister Nara Lokesh engaged in discussions with Tesla's Chief Financial Officer, Vaibhav Taneja, during his visit to the United States. With Tesla intensifying its hiring efforts in India following a recent meeting between CEO Elon Musk and Prime Minister



Narendra Modi, Andhra Pradesh has stepped up its efforts to establish direct communication with the company and expedite a potential agreement.

Andhra Pradesh has a proven track record of successfully onboarding global automotive companies, with Kia Motors being a notable example. The seamless setup and rapid growth of Kia's operations in the state serve as a case study to attract Tesla, which prioritizes efficiency and results. The Naidu government is leveraging this success story to convince Tesla of Andhra Pradesh's investment-friendly environment. Additionally, the state's past engagement with Tesla could prove beneficial in securing the deal. In 2017,

Chandrababu Naidu signed an MoU with Tesla, and Elon Musk committed to providing technological expertise for the development of two solar energy storage units in the state. This previous association, coupled with the government's proactive approach, strengthens Andhra Pradesh's position in the competition for Tesla's investment.

With a well-established industrial ecosystem, extensive port infrastructure, and a business-friendly government, Andhra Pradesh is emerging as a strong contender to host Tesla's India operations. As the race among Indian states heats up, the coming months will determine whether Tesla chooses Andhra Pradesh as its preferred destination.

per quintal for chilli. If the Center fails, she insisted the state government implement a price stabilization fund and provide a bonus to chilli farmers to offset their losses.

Tomato farmers, too, are in distress. With production costs reaching ₹2.5 lakh per acre, many are barely earning ₹50,000, as market prices have crashed. While tomatoes sell for ₹15 per kg, farmers are receiving just ₹3 to ₹4 per kg, pushing them into financial despair.

The Congress party has demanded immediate action from the government to stabilize tomato prices and provide urgent relief to struggling farmers.

YSRCP chief YS Jagan Mohan Reddy's recent jail visit to meet Vallabhaneni Vamsi, who is on remand in a kidnapping case, has stirred controversy. His visit has now become a major talking point, especially in light of his absence from the latest hearing in the Kodi Kathi case at the Vizag NIA court. At the recent hearing, the accused in the case, Kodi Kathi Srinivas, was present, while Jagan, the complainant, skipped the session. The court has now

adjourned the case to March 21. This repeated absence has drawn sharp criticism from SC Committee convenor Busi Venkatrao, who accused Jagan of conveniently avoiding legal proceedings while actively participating in political activities.

Venkatrao questioned how Jagan could find time to visit Vamsi, who is facing serious charges, but not attend court in a case where he himself is the victim. He alleged that Jagan is deliberately avoiding the legal process despite the case dragging on for years.

The Kodi Kathi case has already gone through over 20 hearings, yet Jagan has not appeared for a single one. Meanwhile, the accused, Srinivas, has remained out on bail, waiting for the final verdict. Venkatrao pointed out that while Srinivas spent five years in jail over the case, Jagan's reluctance to appear in court shows a disregard for due process.

Critics argue that Jagan's actions raise serious questions about his credibility. While he engages in political meetings and visits accused party members in jail, he continues to ignore court proceedings in his own case. With the next hearing set for March, all eyes will be on whether Jagan finally appears before the court or continues to sidestep legal scrutiny.

AP BC Association Demands ₹20,000 Crore Allocation for BC Welfare

Jagan Attending Assembly Out of Fear, Not for People

With the Andhra Pradesh Assembly budget session set to begin tomorrow (February 24), YSRCP chief Jagan Mohan Reddy is making a return to the Assembly after nearly seven months. Minister Nimmala Ramanaidu responded sharply to this, alleging that Jagan has been avoiding the Assembly for years. Ramanaidu stated that Jagan is not attending out of concern for the people or to discuss public issues but out of fear of losing his MLA post. He criticized Jagan, claiming he is appearing in the Assembly only to safeguard his position.

The Andhra Pradesh BC Association has urged the state government to allocate ₹20,000 crore for BC welfare in the upcoming budget. In a meeting held at the association's state office, State President Dr. N. Maresh emphasized the need for direct loan disbursal to BCs without bank intermediaries.

Will Targeting Babu Backfire on BRS Again?

The Bharat Rashtra Samithi (BRS) seems to be walking down a familiar and risky path—attacking Andhra Pradesh Chief Minister Chandrababu Naidu. A recent statement by senior BRS leader Jagadeeswar Reddy has sparked controversy, raising questions about whether the party has learned from its past mistakes.

During a public address, Reddy claimed that the former BRS government had "kicked and sent away Babu" in reference to Krishna water disputes. His statement, "Babu ni thanni tharimesam," was meant to portray K. Chandrasekhar Rao (KCR) as a strong leader who aggressively defended Telangana's interests against Naidu's administration from 2014 to 2019. However, the use of such language has drawn criticism from political observers and

voters alike.

This incident brings back memories of a similar miscalculation by BRS in 2023. When Naidu was arrested by the Jagan Mohan Reddy-led government, BRS working president K.T. Rama Rao (KTR) dismissed the issue, stating that there was no reason for protests in Telangana. This remark hurt the sentiments of Andhra settlers in the state, leading to electoral consequences. Realizing the damage, KTR later softened his stance and spoke respectfully about Naidu.

Despite the lessons from that experience, Jagadeeswar Reddy's latest remarks indicate that some within BRS continue to underestimate the political impact of attacking Naidu. Analysts point out that while BRS remained silent when Jagan diverted Krishna waters for the Pothireddypadu project,

they are now trying to claim dominance over Naidu, who was known for his balanced approach in negotiations. The bigger question is whether such rhetoric will benefit BRS or prove counterproductive. Telangana's political landscape has changed significantly, and settlers from Andhra Pradesh play a key role in several constituencies. Repeating past mistakes could alienate these voters further.

As BRS works to rebuild its political presence after its 2023 defeat, targeting Naidu in an aggressive manner might not be the most strategic move. Observers suggest that instead of focusing on rhetoric, the party should focus on constructive opposition and relevant issues that matter to Telangana's people. Whether BRS realizes this or continues with its old playbook remains to be seen.

Corruption scandals continue to surface in the Vijayawada Municipal Corporation (VMC), exposing rampant mismanagement across multiple departments. Following allegations against corrupt supervisors in the Chief Medical Health Office (CMHO) and a "collection king" biologist in the Malaria Department, new revelations indicate massive irregularities in the Park Section as well.

According to reports, several workers in the Park Section, including both permanent and contract employees, are not at-

tending their duties properly but continue to draw salaries without accountability. The maintenance of parks and roadside greenery in the city is officially managed under the supervision of the Assistant Director of Horticulture (ADH). However, discrepancies have been found in records related to plant procurement and placement.

Concerns have been raised about where the plants are being purchased from, at what cost, and how many are actually being procured. There are allegations that the process is riddled with financial irregularities, pointing to possible misappropriation of funds.

Further, corruption is alleged in the operation of water tankers that have been contracted from a private vendor to irrigate plants along roadsides and medians. Despite awarding the contract, there is no official oversight to ensure that the tankers are actually being used for watering plants. Crucial details, such as diesel expenditure, issuance of fuel coupons, and the officials responsible for certifying the contract payments, remain unclear. It is also alleged that water tankers are being operated in violation of government regulations, yet the contractor continues to get bill approvals without scrutiny. Sources claim that officials in the Park Section are receiving bribes from contractors in exchange for signing off on these

transactions, resulting in the neglect of greenery maintenance across the city. Adding to the concerns, several citizens

have complained that the Commissioner is not responding to grievances. Meanwhile, CMHO supervisors are reportedly claiming that no action will be taken against them, further fueling allegations of systemic corruption.

It remains to be seen whether the Commissioner will intervene to address these serious allegations or if the corrupt officials will continue their unchecked activities.

More details on another corruption scandal will be revealed in tomorrow's report.

Police Crack ₹5 Crore Gold Theft Case in Mangalagiri

Guntur district SP Satish Kumar disclosed the details of the case to the media.

According to the police, Ramu, the owner of DVR Jewellers in Vijayawada, regularly supplies gold ornaments to shops in Nalgonda, Suryapet, and Nakrekal. As part of this, he handed over 5 kg of gold ornaments to Nagaraju for delivery to his residence in Mangalagiri. Upon receiving the complaint, police formed six special teams and analyzed CCTV footage of the incident. The footage showed that Nagaraju did not put up any resistance when the alleged robbers took the bag, raising suspicions. When interrogated, Nagaraju confessed to planning the theft with his former colleagues from a jewelry shop. The police arrested Nagaraju's accomplices—Bharat, Naveen, Irfan, Mohan, Lokesh, Chandu, and Arun-who had assisted him in the heist. Vijayawada Police Recover 420 Stolen Phones Worth ₹50 Lakh

Vijayawada police have successfully identified and recovered 420 lost and stolen mobile phones, valued at approximately ₹50 lakh, and returned them to their rightful owners. City Police Commissioner Rajasekhar Babu stated that the recovery was made possible through advanced technology and swift action by the police teams.

"We identified and tracked the phones using technology. If people inform the police immediately after losing their phones, there is a high chance of quick recovery. We have conducted similar seizures in the past as well," said CP Rajasekhar Babu.

He emphasized the importance of mobile phones in today's life, as they are linked to bank transactions and government identity cards. The Commissioner also noted that more stolen phones are yet to be identified and assured that they will be seized soon.

Additionally, CP Rajasekhar Babu warned about the rising cases of investment frauds. "Fraudsters first gain your trust by returning small amounts, then lure you into investing larger sums and eventually steal lakhs from your accounts. People must remain cautious and avoid falling for such scams," he cautioned.

Highlighting the efforts in cyber and road safety, he urged citizens to stay vigilant. "Safety committees are working effectively, and under the leadership of Krishna Lanka CI Nagaraju, CCTV cameras have been installed across Vijayawada to solve cases efficiently. So far, 1,260 cameras have been set up in various parts of the city," he added.

He also announced a new initiative set to launch in March, mandating apartment complexes to install CCTV cameras both inside and outside their premises. In a bid to curb vehicle thefts, the police are deploying technology that will enable the immediate identification of stolen bikes.

Urging people to follow traffic rules, the Commissioner said, "Every citizen should wear helmets and seat belts while driving. Remember, your safety is crucial for your family's well-being."

The YSRCP has strongly criticized the state government for misleading Group-2 candidates, accusing it of creating confusion and chaos over the exam. YSRCP leader Potina Venkata Mahesh alleged that Chief Minister Chandrababu Naidu has deceived not only unemployed youth and government employees but all sections of society.

"For three weeks, he pretended to listen to the objections of Group-2 candidates, giving them false hope. In the end, he has pushed them into a pit of uncertainty," Mahesh said. He also pointed out the contradictory statements made by TDP leaders. "Lokesh garu says one thing, while Chandrababu Naidu garu says another. On one hand, they claim the exam is being postponed, and on the other, they say it is not in their hands. This proves the incompetence of the government," he added.

"This is the most confused and chaotic government I have ever seen. The administration kept misleading Group-2 candidates till the last moment,

making them believe the exam would be postponed," he remarked. He demanded that the government hold an emergency meeting to provide clarity to the candidates, asserting that conducting the exam amid such confusion was completely unacceptable. The YSRCP also condemned the police action against protesting candidates. "We strongly oppose the lathi charge on students and demand the immediate and unconditional release of those who were detained," Mahesh stated. He called the police crackdown a brutal attack on young aspirants and another example of how the government was deceiving the people.

Criticizing the handling of job recruitment, he pointed out that the DSC notification issued by the previous YSRCP government was canceled, and the so-called "Mega DSC" has only caused delays without providing a single job. "The government releases a job calendar every January, but never follows through. It promised ₹10,000 to volunteers while simultaneously terminating 2.4 lakh jobs," he said.

Ensuring Healthcare as a Right: Experts Urge Govt Action



Dr. Sujatha Rao criticizes privatization, calls for policy reforms

Retired IAS officers have strongly advocated for making health a fundamental right in the country, criticizing the increasing privatization of the healthcare sector. Speaking at a conference on 'Health Sector in Andhra Pradesh – Social Responsibility' at SV Medical College Auditorium, Tirupati, former Health Secretary Dr. K. Sujatha Rao and senior IAS officer Dr. PV Ramesh Kumar voiced their concerns over government neglect in the health sector. The event was organized by Vemana Vigyan Kendra, Praja Arogya Vedika, and SV Medical College.

Dr. Sujatha Rao lamented that despite discussions on health policy beginning in 1948, it was only in 1983 that the country adopted a formal health policy. "Over the years, governments have shirked their responsibility, pushing healthcare into the private sector. As a result, the poor are unable to access basic medical services," she said. She pointed out that while Kerala has set an example with low mortality rates and accessible healthcare, Andhra Pradesh lags in providing quality public health services.

Highlighting alarming statistics, Dr. Sujatha Rao noted, "In India, the mortality rate for children under five is 32 per thousand, while in Andhra Pradesh, it stands at 27, and in Kerala, just 10. In Germany, it is only four." She criticized the Andhra Pradesh government for privatizing Chittoor Government Hospital, partnering with private institutions for medical colleges, and permitting exorbitant capitation fees for students.

"The government has allowed the medical sector to become a business, where profit matters more than people's well-being. Corporate hospitals exploit patients by making unnecessary MRI and CT scan recommendations, looting crores in the process," she remarked. She further slammed the privatization of district hospitals in Madhya Pradesh, citing public resistance that prevented nine out of ten hospitals from being privatized.

Dr. Rao also criticized the media for failing to promote scientific understanding. "Instead of educating people about healthcare and technology, media channels focus on pujas, mantras, and temples," she said. She demanded the abolition of the capitation fee system and emphasized that scholarships and infrastructure should be prioritized to improve medical education.

Dr. PV Ramesh Kumar dismissed the state government's claim that insurance-based

healthcare is a solution. "Providing insurance does not ensure healthcare; it simply shifts the government's responsibility to private players," he asserted. He urged people to vote against parties that treat health as a business rather than a right. Recalling an experience in Davos in 2015 with then-CM N. Chandrababu Naidu, Dr. Ramesh said, "When a colleague was injured, we sought the best private hospital. But in Switzerland, private hospitals don't exist—government hospitals provide the best care. This is what India should strive for."

He further pointed out that medical education is turning into a business, leading to unemployed doctors, similar to engineers. "What's the use of producing doctors who paid crores for their degrees but lack knowledge? Their sole focus will be on recovering their investment, not on public service," he said.

The conference unanimously passed a resolution, introduced by Praja Arogya Vedika General Secretary Kameswara Rao, demanding the implementation of a Health Security Act in Andhra Pradesh, recognizing health as a fundamental right, and preventing excessive privatization.

State President of Praja Arogya Vedika, NV Ramanaiah, emphasized the organization's contributions during the COVID-19 crisis and called for effective public healthcare policies. The event saw participation from senior medical professionals, including SWIMS Deemed University Dean Alladi Mohan, SV Medical College Principal Dr. P.A. Chandrasekhar, and Ruia Hospital Superintendent Dr. Ravi Prabhu, along with faculty and students from various medical institutions.

Rescue Efforts Intensify at Collapsed Telangana Tunnel as Water, Debris Hinder Progress

Rescue operations continue in Telangana's Nagarkurnool district as authorities struggle to reach eight workers trapped inside a collapsed tunnel near the Srisailam dam foi over 24 hours. The tunnel roof collapsed yesterday morning while workers were inside to repair a leak, cutting off all communication with them. Muck mixed with water has spread over a 200-metre stretch, making access difficult for rescue teams. Four NDRF teams are en route to the site, while several agencies are already engaged in efforts to clear debris and dewater the tunnel. Reports indicate that shifting boulders have made the collapsed section unstable. Water is gushing in from a fracture on the tunnel wall, necessitating dewatering before any significant rescue progress can be made. The collapsed section is about 13 km from the tunnel's





Chromosomal Microarray is a test that detects chromosomal abnormalities, such as missing or extra pieces of chromosomes, which can lead to developmental delays, genetic disorders like Down Syndrome, and other syndromes.

Judiciary **Doesn't Have Right to Amend** Constitution

Vice President Jagdeep Dhankhar asserted that the judiciary does not have the authority to amend the Constitution, emphasizing that only Parliament and state legislatures hold that right. Speaking at the inauguration of the Constitution Awareness Year celebrations, he underscored the importance of nationalism, urging people to prioritize the nation above politics and personal interests.

Dhankhar warned against external influences in India's democratic system, referring to recent reports of alleged USAID funding aimed at influencing voter turnout. "By getting funds from outside, the democratic system is being made unholy. The persons of their choice are made to win polls. This is dangerous and cannot be tolerated," he remarked.

Highlighting the importance of constitutional awareness, he praised the Constitution's framers for their meaningful dialogue and high-level debates. "They never let the prestige of the temple of democracy go down," he said, while criticizing disruptions in parliamentary proceedings.

"The more we learn about the Constitution, the more we will turn towards nationalism," Dhankhar stated, adding that fundamental rights must be nurtured responsibly. He also recalled the Emergency of 1975 as the "darkest hour" in India's democratic history, condemning the Supreme Court's decision at the time to uphold the government's stance. Referring to the historical significance of the Constitution, he noted that it contains 22 demonstrative images representing India's rich cultural heritage, including Lord Ram, Lord Krishna, and Chhatrapati Shivaji Maharaj. Reiterating the supremacy of elected legislatures in constitutional amendments, Dhankhar stated, "No one else has this right, not even the judiciary.

Udit Raj seeks protection over threats from BSP workers

- Udit Raj said Mayawati should be "throttled".

Congress leader Udit Raj has approached the Delhi Police, seeking protection against alleged threats from Bahujan Samaj Party (BSP) workers, including its leader Akash Anand. The move follows a controversy over his recent remarks against BSP chief Mayawati.

In a letter to the Delhi Police Commissioner, Udit Raj claimed that a video circulating on the YouTube channel 'Bahujan Dastak' features an interviewer inciting the public to attack him. "The interviewer has openly called for my throat to be slit and even announced a reward of ₹1 lakh for such an act," he stated.

He further alleged that since the release of the video, he has noticed unusual movements near his house, raising serious concerns about his safety. "I apprehend that any untoward incident may occur if adequate security is not provided immediately," he wrote, urging the police to file an FIR and take strict legal action against those responsible.

Udit Raj, who also heads the All India Unorganised Workers and Employees Congress (KKC) and the Dalit, OBC, Minority, and Adivasi Parisangh (DOMA Parisangh), revealed that he has been receiving threatening calls



since February 17, the day after his controversial remarks against Mayawati.

He claimed that on the evening of February 17, a caller allegedly told his PSO that Mayawati and Akash Anand had ordered him to harm Udit Raj. The Congress leader insists that the threats have escalated, making immediate police intervention necessary.

The controversy erupted after Udit Raj's remarks in Lucknow, where he suggested that Mayawati should be "throttled" for allegedly suppressing social welfare movements. His statement triggered a strong backlash from Mayawati, who accused the

Congress of historically opposing the ideology of B.R. Ambedkar.

Political reactions have been swift. BJP national spokesperson Shahnawaz Hussain criticized Udit Raj, saying, "Congress is insulting Dalits with this statement. They are targeting a prominent Dalit leader like Mayawati. This will cost them dearly."

JD(U) leader Rajeev Ranjan Prasad also condemned the remark, stating, "Such statements are unacceptable in a democracy. The Congress is speaking out of frustration."

As tensions rise, Udit Raj awaits police action, demanding both security and accountability for the alleged threats.

Maharashtra Suspends Bus Services to Karnataka After Attack on Driver

Maharashtra Transport Minister Pratap Sarnaik on Saturday announced the suspension of state transport bus services to Karnataka after an MSRTC bus was attacked in Chitradurga.

The Maharashtra State Road Transport Corporation (MSRTC) bus, traveling from Bengaluru to Mumbai, was attacked around 9:10 pm on Friday by pro-Kannada activists. The assailants blackened the face of the driver, Bhaskar Jadhav, and assaulted him, Sarnaik said. A police case has been registered in Karnataka regarding the attack.

"Bus services to Karnataka won't resume unless the Karnataka government makes its stand clear on the issue," the minister stated. On the same day, a Karnataka transport corporation conductor was allegedly assaulted

near Belagavi for not responding to a girl in Marathi. The incident has led to heightened tensions between the two states.

In response to the Belagavi incident, Karnataka police arrested four individuals for assaulting the conductor, Mahadevappa Mallappa Hukkeri. However, the conductor has also been booked under the POCSO Act following a counter-complaint by the 14-year-old girl, alleging derogatory remarks.

Belagavi Police Commissioner Iada Martin Marbaniang assured a neutral investigation, stating that law and order would be maintained. Meanwhile, pro-Kannada activists staged protests, blocking roads and burning effigies, while Marathi groups condemned the assault on the MSRTC driver. The Belagavi region has long been a flashpoint due to border disputes and linguistic tensions, with this latest episode adding to the ongoing friction.





Despite Their Attacks Giorgia Meloni Backs Modi, Trump At CPAC

Italian Prime Minister Giorgia Meloni delivered a sharp critique of the global Left, accusing liberals of hypocrisy and reacting with "hysteria" to the rise of right-wing leaders. Speaking via video link at the Conservative Political Action Conference (CPAC) in Washington DC, she praised US President Donald Trump and Vice President JD Vance while condemning left-wing "elites."

PM Meloni argued that liberals have grown increasingly frustrated with the electoral success of conservative leaders, especially following Trump's return to the White House.

"When Bill Clinton and Tony Blair created the global leftist liberal network in the 90s, they were called statesmen," she remarked. "Today, when Trump, Meloni, (Javier) Milei, or maybe (Narendra) Modi talk, they are called a threat to democracy. This is the Left's double standard, but we are used to it. And the good news is people no longer believe in their lies. Despite all the mud they throw at us, citizens keep voting for us," she said.

She described Trump as a resilient leader committed to global conservative cooperation, able to defend Italian and European interests

claiming that left-wing forces were growing anxious. "The Left is nervous, and with Trump's victory, their irritation has turned into hysteria. Not only because conservatives are winning, but because conservatives are now collaborating globally," she added.

As leader of the far-right Brothers of Italy party, PM Meloni was the only EU head of government to attend Trump's inauguration in January.

Her participation in CPAC drew strong opposition in Italy, particularly after Steve Bannon, Trump's former chief strategist, appeared to use a Nazi salute during the conference. Critics, including opposition MPs, called on Meloni to cancel her address, pointing to French far-right leader Jordan Bardella's decision to withdraw from the event over Bannon's gesture.

Elly Schlein, leader of Italy's center-left Democratic Party, condemned Meloni's association with CPAC. "She should have the decency to disassociate herself from this neo-fascist gathering," Schlein said. "She has not said a word for days about Trump's insults and frontal attacks on Ukraine and the European Union. She is un-

Israeli Jets Fly Over Hezbollah **Chief's Funeral Amid Mass Gathering**

Israeli fighter jets flew over Beirut today as thousands gathered for the funeral of Hezbollah leader Hassan Nasrallah, nearly five months after his death in an Israeli airstrike. The low-flying aircraft momentarily drowned out the chants of Hezbollah supporters, intensifying the tension surrounding the event.

Visuals from the funeral showed four Israeli F-16 jets passing over the stadium, an act seen as a show of dominance by Israel. Meanwhile, the Israeli army marked the occasion with a post on X, stating, "Today is Hassan Nasrallah's funeral. Today the world is a better place."

Nasrallah, who led Hezbollah for decades, was killed in an Israeli strike that dealt a severe blow to the Iran-backed militant group. His death was part of a broader Israeli offensive that significantly weakened Hezbollah's command structure. The mass funeral, held at the 55,000-seat Camille Chamoun Sports City stadium in Beirut's

southern suburbs, was attended by a sea of Hezbollah supporters carrying flags and portraits of their slain leader.

Iran's Supreme Leader Ayatollah Ali Khamenei issued a statement vowing continued resistance against Israel. "The enemy should know that resistance against oppression and arrogance is not over. It will continue until the desired goal is achieved," he declared.

Hezbollah has faced a series of setbacks in recent months, with much of its leadership eliminated and its military strength eroded. The impact was worsened by the fall of its key ally, Bashar al-Assad, in Syria, disrupting Hezbollah's supply routes.

Despite these challenges, supporters at the funeral vowed to keep the movement alive.

"We may have lost a great leader, but we have not lost the spirit of resistance," said Hassan Nasreddine, a mourner who traveled from southern Lebanon for the event. The ceremony also honored Hashem Safieddine, who briefly led Hezbollah after Nasrallah's death but was killed in an Israeli strike before he could be officially named as his successor. Nasrallah was initially buried next to his son, Hadi, who died fighting for Hezbollah in 1997. His formal funeral was postponed until the withdrawal of Israeli forces from southern Lebanon, as part of a U.S.-brokered ceasefire that ended last year's war.

Peskov reaffirmed Russia's stance, citing Moscow-held referendums widely condemned as illegitimate. "No one will ever sell off these territories. That's the most important thing," he declared.

Meanwhile, Putin marked Rusportant that nothing prevents us land Day" by framing the war in Ukraine as a divine mission. Addressing Russian servicemen, he stated, "Fate willed it so, God willed it so. A mission as difficult as it is honorable-defending Russia—has been placed on our and your shoulders." The statement came just a day before the third anniversary of the war, as Russia escalated attacks on Ukraine. Kyiv reported that Moscow launched a record 267 drone strikes overnight, with 138 intercepted and 119 lost, while multiple regions, including the capital, were hit.

Trump's engagement with Putin and his harsh rhetoric against Ukrainian President Volodymyr Zelensky have unsettled Western allies. Trump has falsely claimed that Kyiv started the war and questioned Zelensky's popularity. In response, Zelensky urged continued Western unity, stating, "We must do our best to achieve a lasting and just peace for Ukraine. This is possible with the strength of all partners—Europe, America, and all who seek peace."

Moscow, however, has seized on Trump's attacks on Zelensky. Peskov dismissed the Ukrainian leader's criticism of Trump, saying, "No president would tolerate that kind of treatment. So his reaction is completely understandable."

NASA Lowers Risk of Asteroid 2024 YR4 **Impact in 2032**



TPN Correspondent | Washington, D.C. NASA has significantly reduced concerns regarding asteroid 2024 YR4, revising its estimated impact probability in 2032 from 1 in 32 to 1 in 360. The 55-meter-wide asteroid, initially considered the most hazardous object on NASA's Center for Near-Earth Object Studies (CNEOS) Sentry Risk Table, now has a 99.72% chance of completely missing Earth.

The reassessment follows new observational data collected between February 18 and February 20, allowing for refined calculations of the asteroid's trajectory. As a result, NASA has downgraded its classification to Level 1 on the Torino Scale, which assesses the threat posed by near-Earth objects. Richard Binzel, creator of the Torino Scale, indicated that further observations might move

2024 YR4 to Level 0, signifying no risk. Despite the risk reduction, asteroid 2024 YR4 remains the most concerning object on the Sentry Risk Table, followed by asteroid 1950 DA, which has a 0.039% chance of impacting Earth in the year 2880. Experts stress that continuous monitoring will provide greater clarity, especially when the asteroid makes another approach in 2028.

David Rankin, an astronomer with the Catalina Sky Survey, explained that small uncertainties in measurements could result in large trajectory shifts over time. However, he reassured that additional observations will likely continue lowering any remaining impact probabilities.

NASA also acknowledged a minor possibility that 2024 YR4 could collide with the Moon, though the likelihood remains extremely low. The asteroid is now moving away from Earth and will not be visible to ground-based telescopes until 2028, when further tracking will refine its projected path. Scientists remain confident that it will continue its orbit around the Sun without posing any danger to Earth.

Amazonian Town Faces Crisis as Massive Sinkholes Expand

The city of Buriticupu in Brazil's northeastern Amazon is facing a growing crisis as massive sinkholes continue to expand, threatening the homes of at least 1,200 residents. The municipal government recently declared a state of emergency as the situation worsened.

In a decree issued earlier this month, officials warned that the sinkholes have been expanding "exponentially" in recent months, putting more homes at risk. Several buildings have already collapsed, and the danger continues to increase. The issue has been unfolding for nearly 30 years due to heavy rains eroding sandy soils, worsened by deforestation and poorly planned construction. Known as "vocoroca" in Brazil—a term of indigenous origin meaning "to tear the earth"-these sinkholes have now reached a critical stage.

The situation is particularly dire during the current rainy season, according to geographer Marcelino Farias of the Federal University of Maranhao. Longtime resident Antonia dos Anjos, 65, expressed her fears, saying, "There's this danger right in front of us, and nobody knows where the next hole will open up."

Buriticupu's secretary of public works, Lucas Conceicao, admitted that the municipality lacks the resources to handle the crisis. "The challenges range from stopping the erosion to relocating people from risk areas," he said.

Record Number Of Olive Ridley Turtles Arrive For Nesting At Odisha Beach

The Rushikulya river mouth in Odisha's Ganjam district has witnessed a record-breaking mass nesting of endangered Olive Ridley turtles, with over 6.82 lakh turtles laying eggs so far. This surpasses the previous high of 6.37 lakh turtles recorded in 2023.

The mass nesting began on February 16, and the numbers are expected to increase further, said Berhampur Divisional Forest Officer (DFO) Sunny Khokkar.

Favorable climatic conditions are believed

to be a key factor behind the increased nesting activity. "The better climatic conditions this year have helped more turtles lay eggs in the Rushikulya river mouth, which is emerging as a major rookery,' said senior scientist Bivas Pandav from the Wildlife Institute of India (WII), Dehradun.

Experts also anticipate a higher number of hatchlings due to the timely nesting. "Since the mass nesting has occurred on time, we expect a good number of hatchlings," said Zoological Survey of India (ZSI) scientist Basudev Tripathy.

Meanwhile, conservation efforts are in full swing. The government has installed protective fencing along a 9-km stretch from New Podampeta to Prayagi to safeguard the eggs from predators. "We have taken utmost care to protect the eggs, which may hatch after 45 days," said Dibya Shankar Behera, Range Officer of Khallikote.

Additionally, researchers have recaptured over 330 turtles that were GPS-tagged between 2021 and 2023, providing valuable insights into their migratory patterns, said ZSI scientist Anil Mohapatra.



The latest report indicates that the feature is now becoming widephased rollout controlled via a server-side update. As a result, some users, including Gadgets 360 staff members, have yet to see the feature on their devices, including Pixel phones.

Additional Spam Protection Features

The new call sorting feature adds to Google's ongoing efforts to improve spam protection and enhance user convenience. One of the key tools in this regard is the Call Screen feature available on Pixel devices. It acts as an intermediary, screening calls by asking the caller their name and reason for calling, then providing a transcript to the receiver before they decide whether to answer.

Another notable feature is reverse lookup, which helps users identify unknown numbers and filter out spam calls. These measures are part of Google's broader strategy to reduce call spam and improve the overall calling experience for Android users.







Virat Kohli's 51st ODI century powers India past Pakistan in Champions Trophy clash



Virat Kohli once again proved his dominance in high-pres-sure encounters, smashing his 51st ODI century to lead India to a commanding six-wicket victory over Pakistan in the Champions Trophy 2025. The win not only strengthened India's hold on the top spot in Group A but also virtually secured their place in the semifinals.

Chasing a target of 242, Kohli anchored the innings with an unbeaten 100 off 111 balls, featuring seven fours. He found valuable support from Shreyas Iyer (56 off 67) and Shubman Gill (46 off 52) as India comfortably overhauled the total with more than seven overs to spare.

The match began with Shaheen Shah Afridi giving Pakistan a brief moment of hope, dismissing Rohit Sharma (20) with a toe-crushing yorker. However, Kohli remained unfazed, expertly handling Pakistan's pace attack and playing cautiously against leg-spinner Abrar Ahmed. His partnership with Iyer, worth 114 runs for the third wicket, effectively shut Pakistan out of the contest.

Earlier, Pakistan struggled to accelerate despite a fighting half-century from Saud Shakeel (62 off 76) and a steady 46

from skipper Mohammad Rizwan. The duo added 104 runs for the third wicket, but tight bowling from Kuldeep Yadav (3/40) and Hardik Pandya (2/39) restricted them to 241.

Babar Azam (23) looked promising but edged behind while attempting an expansive drive off Pandya. Imam-ul-Haq (10) was run out after a mix-up, leaving Pakistan at 47/2. Their innings stagnated as India's disciplined bowling attack denied them easy runs, with a 55-ball stretch without a boundary in the middle overs.

Shakeel and Rizwan stabilized the innings before India struck back. Rizwan was bowled by Axar Patel, while Shakeel holed out attempting a pull shot off Pandya. The lower order, including Shaheen and Naseem Shah, fell cheaply to Kuldeep's spin, while Khushdil Shah's late 38-run cameo pushed Pakistan past 240.

Despite brief injury concerns for Mohammed Shami and Rohit Sharma during Pakistan's innings, India remained in full control. Kohli, underlining his big-match temperament, became the fastest player to reach 14,000 ODI runs during his innings, adding yet another feather to his illustrious cap.
