

DENDULURU HAVING ANY TIME LIQUOR UNDER MLA SIR

Despite Chief Minister Chandrababu Naidu's strict warnings against belt shops, they continue to thrive in various villages of Eluru district. The new liquor policy implemented by the TDP coalition transferred liquor shop management to private hands, but it has also led to the unchecked rise of belt shops connected to licensed liquor stores.

Liquor license holders are allegedly setting up belt shops across the district, selling alcohol at inflated prices and exploiting the poor. The excise department, responsible for regulation, remains a silent spectator. Open drinking areas have been set up in several licensed liquor stores without any official permission.

In Denduluru constituency alone, the state government has permitted 15 licensed liquor shops. However, nearly every village has an unregulated belt shop operating nearby, openly selling liquor. While legal wine shops function from 10 AM to 10 PM, belt shops operate 24/7 selling liquor even on national holidays like Gandhi Jayanti.

Shockingly, liquor is being sold in grocery stores, tiffin centers, and even cool drink stalls. Some wine shop owners have reportedly formed a syndicate, ensuring a steady liquor supply in rural areas. Belt shop owners are allegedly charging ₹50 extra per quarter bottle, further exploiting consumers.

Local sources claim that a public representative and his followers are backing the illegal liquor trade. Despite knowing the situation, excise officials seem to be targeting small street vendors while ignoring the rampant belt shop operations. Unauthorized open sittings have been set up at licensed wine shops, serving food and alcohol without permits.

Though the government has pledged strict action against belt shops, the reality on the ground tells a different story. Liquor sales continue unabated, raising serious concerns about enforcement and political influence in the trade. Only a decisive crackdown can curb this widespread illegal business.

AP Cabinet Approves 34% Reservation for BCs in Nominated Posts

In a significant decision, the AP Cabinet, chaired by Chief Minister Chandrababu Naidu, has approved 34% reservation for Backward Classes (BCs) in nominated posts. This decision aims to increase representation for BCs in important positions, further promoting social equity and inclusion. The

Uncertain Future for Rajahmundry's Sahitya Peetha

Rajamahendravaram, once a hub of Telugu literature and culture, is witnessing a slow erosion of its Sahitya Peetha. The Sahitya Peetha, which has nurtured generations of artists and scholars, is now on the verge of disappearing, with Potti Sriramulu Telugu University in Bommoor facing an uncertain future.

For decades, Rajahmundry has been home to vibrant literary events poet gatherings, book launches, Harikatha performances, and music concerts keeping the spirit of Telugu culture alive. However, the situation has drastically changed, and the historic literary seat may soon fade into obscurity.

Admissions for the current academic year were expected, but in August last year, the government issued a notification restricting admissions to Telangana alone, effectively shutting the doors for students in Andhra Pradesh. The Telugu University

campus in Bommoor, spread over 45 acres, now faces an existential threat.

Established in 1985 through a special legislative act, Potti Sriramulu Telugu University was envisioned as a center for Telugu language, literature, history, culture, and arts. Over the years, it expanded with additional campuses, including Siddhendra Kalakshetra in Kuchipudi. The university played a crucial role in promoting Telugu language and literature, not only within Andhra Pradesh but also across the country and abroad.

However, bureaucratic indifference has taken its toll. During the previous YSRCP government, land allocations within the Bommoor campus were ordered to be repurposed, raising concerns over the university's future. Former MP Undavalli Arun Kumar intervened, urging the government to revoke these orders, but the issue remains unresolved.

With the 10-year joint capital status between Telangana and Andhra Pradesh ending on June 2, 2024, Telugu University

in Hyderabad now falls under Telangana's jurisdiction. The AP government requested the university to continue admissions, but no response was received from the Telangana government. As a result, a notification was issued limiting admissions solely to Telangana students, effectively sidelining Andhra Pradesh from its own linguistic institution.

Rajahmundry has a rich political and cultural background, producing leaders who have held significant positions in the central and state governments. Yet, apart from Undavalli Arun Kumar, no leader has raised concerns over the university's decline. If immediate action is not taken, Telugu University's Literary Peetha will meet the same fate as Gautami Cultural School and Abhilekhana Kendra, which have already been relocated from Rajahmundry.

Will the state cultural department step in to revive Telugu University's lost glory? Or will this historic institution fade into oblivion? The fate of Telugu literature in Andhra Pradesh hangs in the balance.





Raghurama Krishnam Raju Demands Immediate Suspension of PV Sunil Kumar

Raghurama Krishnam Raju, Deputy Speaker of the Andhra Pradesh Legislative Assembly, has sharply criticized IPS officer PV Sunil Kumar for inciting casteism and being involved in illegal activities. Raghurama Krishnam Raju pointed out that Sunil Kumar's followers, who arrived in a police vehicle with stickers, were involved in a violent incident at the Akividu Municipal Office. The vehicle was registered under Joga Rao, a business partner of Sunil Kumar's sons, leading Raghurama Krishnam Raju to accuse Sunil Kumar of misusing police resources for personal

Raghurama Krishnam Raju also addressed the issue of encroachments around Dharmapuram Lake in Aakiveedu Nagar Panchayat, which the Supreme Court had ordered to be cleared. Despite the legal order, the encroachments remain, and Raghurama Krishnam Raju believes Sunil Kumar's followers were involved in obstructing the process. He demanded that the government take immediate action against the perpetrators.

Raghurama Krishnam Raju further criticized Sunil Kumar for violating service rules by establishing the Ambedkar India Mission, which he claimed promotes divisive politics and violates ethical standards. constructions up to 1,000 yards in areas where people have built homes on government lands with no objections in the past. This decision aims to provide relief to families who had constructed homes on these lands before official objections were raised.

The Cabinet also approved an amendment to the Pattadar book law, which is intended to streamline land ownership and transfer processes, offering more clarity and better access to land records.

A significant development in the educational and skills sector was the approval of the AP Knowledge Society, Capacity Building 2025 initiative. This proposal aims to strengthen the state's educational framework and enhance its capacity-building efforts to prepare the youth for future challenges.

AP Government Announces Incentives for Sportspersons

In a significant move for Andhra Pradesh's sportspersons, the Chandrababu Naidu-led coalition government has announced the release of Rs. 7.96 crore in cash incentives for athletes. This decision comes after the efforts of Sports Minister Ramprasad Reddy and SAAP Chairman Ravi Naidu, who raised concerns about the pending sports incentives worth Rs. 11.68 crore from the previous YSRCP regime.

According to Ravi Naidu, 224 sportspersons in the state had been facing considerable hardships due to the delay in receiving their due incentives. He thanked Chief Minister Chandrababu Naidu and Minister Nara Lokesh for ensuring the release of these funds. A total of 189 athletes have been credited with their share of the incentives, offering them

much-needed relief.

The announcement has been welcomed by both the players and sports associations, who have expressed



their gratitude for the coalition government's swift action. Previously, under the YSRCP government, sportspersons faced significant neglect, with no incentives provided for a prolonged period. This led to severe difficulties for athletes across the state.

Additionally, while the Aadudam Andhra sports event organized just before the elections aimed to support players, it failed to deliver meaningful results, and allegations of a possible scam have surfaced regarding the event.

Trusting Chandrababu Is Like "Putting Your Head in the Tiger's Mouth"

YSRCP President and former CM Y.S. Jagan Mohan Reddy launched a sharp attack on the coalition government led by Chandrababu Naidu, accusing it of severe financial mismanagement and fraud. Speaking at a press conference, Jagan claimed the government has borrowed ₹80,000 crore in just 9 months and is planning to borrow another ₹52,000 crore for the Amaravati construction project, which he called a fraudulent move.

Jagan ridiculed the coalition's campaign slogan, "Babu Surety-Future Guarantee," asserting that it had now turned into "Babu Surety-Fraud Guarantee." He questioned the government's failure to deliver on key promises, such as providing ₹15,000 to everyone and fulfilling welfare schemes, asking, "Where are the promises and bonds given to the people?"

He further criticized the mounting debt, which he claims has now reached ₹1.45 lakh crore, questioning where this money has gone and who is benefiting from it. Jagan pointed out that, rather than creating new jobs, the government has slashed existing ones, including the 2.6 lakh village volunteers and 18,000 liquor shop workers.

Regarding the liquor case involving Mithun Reddy, Jagan strongly condemned his alleged involvement, asking which minister's department his father belonged to and how that relates to the case. He accused the government of fabricating charges to embarrass individuals.

Jagan also addressed the resignation of Rajya Sabha members from YSRCP, particularly criticizing Vijayasai Reddy, stressing that credibility is essential in politics and should not be compromised. Finally, Jagan demanded that his party be granted opposition status in the assembly, stating he would not attend unless his party receives equal speaking time as the Chief Minister. His demand has sparked debate, given the YSRCP's poor performance in the 2024 elections. This press conference solidifies Jagan's strategy of opposing the ruling government on economic mismanagement, unfulfilled promises, and political maneuvering in the assembly.

AP Committee of Ministers Discusses Measures to Control Inflation and Monitor Market Prices.

A key meeting of the Committee of Ministers on Price Monitoring was convened at the AP Secretariat under the chairmanship of State Food, Civil Supplies, and Consumer Affairs Minister Nadendla Manohar. The meeting was attended by Finance Minister Payyavula Keshav, Agriculture Minister Atchannaidu, Health Minister Satya Kumar Yadav, and top state officials.

The primary focus of the meeting was to address the current market price situation, identify strategies to control inflation, and promote the consumption of millets. The ministers and officials reviewed the price trends and discussed several measures to ensure price stability in the state.

As of December 2024, Andhra Pradesh's inflation rate stood at 4.34%, which is notably lower than the national average of 5.22%. The government is actively monitoring prices by collecting and analyzing data every day through the CP app in 154 mandal centers. Additionally, 151 farmers' bazaars



are also being closely monitored to keep track of price fluctuations.

A total of 69 essential commodities, including grains, vegetables, cooking oil, and spices, are under constant surveillance in the state. The review revealed that prices for key items have seen a decrease compared to the previous year, including lentils (down 13%), groundnut oil (down 4%), and chili (down 27%). One of the notable decisions from the meeting was the promotion of jowar and ragi through initiatives like AP Mission Millet. These efforts include inte-

grating millets into the mid-day meals program and other welfare schemes to encourage their consumption. The government has also committed to providing regular price information to farmers to help them make informed decisions.

Addressing the rising costs of transport across the state, which has contributed to price hikes in some areas, the officials have been directed to implement appropriate measures to control and stabilize prices, ensuring economic stability for consumers and farmers alike.

urged the Center to provide clarity on the Polavaram project and stated that the Sadhana Samiti would take up the matter with both the Center and the State. He also criticized the claim that Polavaram is merely a general project rather than a multipurpose one.

Chalasani Srinivas accused the Center of deceiving Andhra Pradesh, highlighting

cant allocations, Andhra Pradesh was neglected in the Union Budget. He noted that Polavaram was being portrayed as a dead storage project globally. He pointed out that while the railway budget allocated ₹278 crores to Andhra Pradesh, Gujarat received ₹17,155 crores, with Maharashtra's bullet train project given high priority.

Srinivas further criticized the budget, stating that while Amaravati is securing loans from the World Bank, the state is being given inadequate financial support. He also alleged that not a single rupee has been received from the ₹17,000 crore KBK and Gundelkan package meant for Seema and Uttarandhra. Taking a dig at the Prime Minister, he remarked that there was no need for Modi to make grand statements in Davos while failing to address kev issues in Andhra Pradesh.

He also called on Chandrababu Naidu to speak the truth, stating that if special status and privileges were granted to the state, it would significantly benefit the youth by fostering industrial growth.

Jagan Lost Even Opposition Status - MLA Adinarayana Reddy

Jammalamadugu MLA and Government Whip Adinarayana Reddy strongly criticized YSRCP chief Jagan Mohan Reddy, stating that people have rejected him entirely, denying him even the status of the opposition. Speaking at an event in Kadapa, Reddy declared that the BJP is set to dominate Delhi and drive national and state development.

He ridiculed Jagan's past claims of ruling for 30 years with 175 MLAs and 25 MPs, saying the public has shattered his political future. He accused YSRCP leaders of corruption, likening Jagan to a "big shop," with Avinash Reddy, Peddireddy, and Vijayasai Reddy operating as a "supermarket."

Addressing the Vivekananda Reddy murder case, Reddy alleged that Jagan applies double standards—labeling minor incidents against himself as murder attempts while showing no concern for real crimes. He claimed police were obstructed from arresting Avinash Reddy in Kurnool.

Reddy vowed to crack down on anti-social activities in Jammalamadugu, warning that



offenders would face strict action. "If anyone engages in illegal activities, I will personally ensure the police act," he stated.

On development, he announced a ₹10,000 crore steel plant for Kadapa and highlighted investments discussed in Davos. He also emphasized the government's commitment to the Jal Jeevan Mission for statewide water supply.

Regarding internal party matters, Reddy dismissed rumors of disputes with MP Ramesh, saying external forces influenced the MP's letter. He assured that he personally requested a police investigation into the issues raised.

Reddy concluded by asserting that the NDA government will continue for another 30 years, ensuring development while sidelining Jagan from Andhra Pradesh's political landscape.

MLA GV Anjaneyulu Criticizes Jagan's Leadership

Palnadu district's Vinukonda constituency witnessed a strong political statement from Chief Whip GV Anjanevulu, who launched a scathing attack on YSRCP leader Jagan Mohan Reddy. Speaking at a media conference, he remarked that Jagan's overseas visit had not tempered his political approach but rather intensified it.

Anjaneyulu pointed out that Jagan, who is the A1 accused in 11 CBI cases, no longer holds the status of a responsible opposition leader. He asserted that if the ongoing CBI and ED cases progress, Jagan would not only lose his opposition leader status but also be ineli-

gible to contest as an MLA. Further, he alleged that Jagan's latest political moves were an attempt to shield his party members who are distancing themselves from YS-RCP. "Jagan has a history of abandoning those who once trusted him, and now he is desperately trying to retain control," he stated.

Referring to Jagan's claim of a political resurgence, Anjaneyulu remarked, "If people grant him a 2.0 version, it will not be a revival but a complete rejection with zero seats." He also criticized Jagan's statements on the coalition government's policies on sand and liquor, stating that he had no moral right to comment on governance.



CPI Leader Ramakrishna Urges Chandrababu to Release White Paper on Central Funds

CPI State Secretary K. Ramakrishna has written a letter to Andhra Pradesh Chief Minister N. Chandrababu Naidu, urging the government to release a white paper on the funds received from the Central Government for the financial year 2024-25. He raised concerns over reports that AP received ₹3,324 crore less this year and sought an official clarification on the matter.

Ramakrishna questioned the accuracy of Union Home Minister Amit Shah's claim that ₹3 lakh crore had been allocated to the state. He criticized the Centre for failing to provide a transparent breakdown of the funds and alleged that the financial assistance to AP has decreased compared to the previous year.

Addressing the Visakhapatnam Steel Plant issue, Ramakrishna argued that the Centre's proposed ₹11,500 crore package is insufficient to resolve the crisis, as the plant's debt reportedly stands at ₹17,000 crore. He reiterated the demand for a permanent solution, suggesting that the plant be merged with the Steel Authority of India Limited (SAIL) and allocated its own iron ore mines.

The CPI leader expressed skepticism over the Centre's commitment to halting the privatization of the Vizag Steel Plant, stating that doubts remain about the government's true intentions. He called for a firm assurance that the steel plant would remain under public sector control and not be privatized under any circumstances.

YS Jagan Ruled with Criminals Over Five Years - Buddha Venkanna

TDP senior leader Buddha Venkanna strongly criticized former CM and YSRCP he ruled the state with criminals for five years. Addressing the media at the TDP office on Thursday, Buddha Venkanna stated that the people outright rejected Jagan, denying him even the status of the Opposition.

Expressing his frustration, Buddha Venkanna remarked that Jagan's wife Bharati should take him to psychiatric experts. He accused Jagan of living under the illusion that he would continue as Chief Minister for 30 years, despite facing a resounding defeat seven months ago. He claimed that even YSRCP leaders were disillusioned with Jagan's leadership, and activists had distanced themselves from him.

Buddha Venkanna questioned whether land encroachments had continued after the NDA government took charge,

chief Jaganmohan Reddy, alleging that asserting that such incidents were rampant under Jagan's rule. He alleged that the former CM manipulated governance to benefit his close circles while ignoring public welfare. He further criticized Jagan's past behavior in the Assembly, claiming that degrading remarks against women were made during his tenure. In contrast, he asserted that the NDA government upholds the dignity of women.

Challenging Jagan to prove his credibility, Buddha Venkanna urged him to step into the Assembly and genuinely represent the people instead of making misleading statements before the media. He concluded by stating that "Jagan 2.0" would only lead to the complete downfall of YSRCP, emphasizing that the party may not even retain the 11 seats it currently holds.



Huge Scam on the Name Of Jagananna Colonies, Says BJP MLA Parthasarathy

TPN Correspondent Kurnool, Feb 07

BJP MLA Dr. Parthasarathy has submitted a memorandum to the Kurnool District Collector, demanding an inquiry into alleged large-scale corruption in the land acquisition process for Jagananna Colonies. Speaking to the media on Thursday, he claimed that a massive ₹2,500 crore scam took place across the state in the allocation of

lands for the housing scheme. He alleged that lands were identified at low prices and agreements were made with farmers at ₹5 lakh per acre, but the same lands were later handed over to the government at inflated rates ranging between ₹13 lakh and ₹23 lakh per acre. Specifically, he pointed out that in Mandagiri village of Adoni mandal, 65 farmers were affected by this fraudulent transaction.

Dr. Parthasarathy accused local leaders of opening bank accounts in farmers' names but keeping control over their passbooks. In Adoni constituency alone, he claimed that while the government allocated ₹23 crore, only ₹13 crore reached the farmers, with the rest allegedly siphoned off by YSRCP leaders.

Vijayawada Municipal Corporation (VMC), once expected to drive the city's progress, has recently become embroiled in corruption allegations, particularly within its sanitation and town planning departments. Commissioner Dhyanachandra, who has actively worked towards the city's development, including tackling the Budameru floods and ensuring sanitation during the Dussehra festival, now faces significant challenges as corrupt practices plague the corporation.

Despite Commissioner Dhyanachandra's best efforts, reports suggest that the city's municipal operations are being tainted by widespread corruption among lower-level staff. Allegations indicate that VMC officials have been selling outsourcing posts, which include positions for sweepers, gardeners, and sanitary workers, for hefty sums ranging between ₹2 and ₹3 lakh. Many workers reportedly pay large bribes to secure their jobs, with the approval of officials.

The corporation's City Medical and Health Officers (CMHO) department, which is essential to the city's sanitation efforts, is under scrutiny. Out of the four designated Assistant Medical and Health Officers (AMHOs), only one is actively serving, while the others have either retired or been absent. Under the remaining AMHO, supervisors are allegedly exploiting the system for financial gain, with claims of bribes being collected from sanitary inspectors to secure promotions. In one instance, it is reported that inspectors who lacked proper educational qualifications paid ₹2-3 lakh each for their appoint-

Reports further suggest that the situation in the VMC's workforce is far from transparent. There are about 5,000 workers employed in the corporation, but many positions left vacant by retiring or leaving



staff are not being filled. Sanitary workers are allegedly being used as tools by supervisors to collect bribes, with certain figures reportedly wielding significant power over the workers' roles. A sanitary worker named Ramireddy is allegedly using his influence to control workers and engage in business dealings related to trade licenses.

In the 38th division, allegations of exploitation by mason Nakka Srinivas have surfaced, with claims that he has been offering high-interest loans to workers while threatening them and engaging in inappropriate behavior toward female staff. Further complicating the matter, Srinivas's son-in-law and son are reportedly continuing his practices, ensuring the corruption runs through the ranks. Sanitary supervisors in the One Town area have reportedly been in power for

maintain control and run a racket involving sanitary inspectors. The previous government's decision to recruit 150 workers under outsourcing has added to the corruption. Despite the interviews held at Indira Gandhi Stadium, no clear results were announced, raising suspicions that jobs were sold under the table.

Under the YSRCP government, Mayor Bhagyalakshmi and former Minister Vellampalli have been accused of facilitating bribes for these outsourcing positions. The VMC accounts section is also said to be complicit in this corruption, with 2-5% commissions allegedly being charged on approved bills.

With these corrupt practices running unchecked, questions remain about whether Commissioner Dhyanachandra is aware of these issues and if he is able to take action against the widespread cor-

PMKSY-AIBP Projects in AP Targeted for Completion by 2025-26

Union Minister of State for Jal Shakti, Raj Bhushan Chowdhury, has stated that eight key medium-term irrigation projects in Andhra Pradesh under the Pradhan Mantri Krishi Sinchai Yojana (PMKSY) - Accelerated Irrigation Benefit Programme (AIBP) are being expedited to meet the state's irrigation needs. He assured that the pending projects are targeted for completion by 2025-26.

Responding to a query raised by Vijayawada MP Kesineni Shiva-

nath (Chinni) in the Lok Sabha, the minister provided details on the progress of these projects and the funds allocated by the central government. He mentioned that no funds were released to Andhra Pradesh under PMKSY-AIBP between 2019 and 2024. However, in the financial year 2024-25, the central government allocated ₹5.97 crore for the Gundlakamma project, ₹2.619 crore for Tadipudi LIS, ₹21.518 crore for the Thotapalli project, and ₹19.8 lakh for Pushkara LIS.

The targeted completion timelines for these projects are:

- Gundlakamma: June 2026
- Tadipudi LIS: December 2025
- Thotapalli: June 2025
- · Tarakarama Tirtha Sagaram: June 2026
- Musurumilli: December 2026
- Pushkara LIS: December 2025 • Yerrakalva: December 2026
- The minister also informed that irrigation capacity generated by these projects has not seen significant improvement so far. He emphasized that the Central Water Commission (CWC) and the Project Management Unit (PMU) are conducting regular reviews to monitor progress and submitting reports to the central

Serious allegations of corruption have surfaced in Tuni Municipality, East Godavari district, where officials are accused of misappropriating ₹6 crore in municipal revenue. Despite structured revenue collection processes, the disappearance of funds has raised concerns about governance and accountability. Tuni Municipality generates significant revenue through its 615 commercial shops. Shop

rents are meant to be renewed every three years, but officials allegedly obstructed the process to manipulate collections. Reports indicate that over 200 shops have failed to pay rent for four years, yet no strict enforcement—such as legal notices, tax penalties, or electricity disconnections—was undertaken. This inaction has led to suspicions that collected funds may have been embezzled.

Records show that certain shops owe over ₹10 lakh each, yet officials failed to act, reinforcing corruption allegations. The controversy gained traction after the formation of the Telugu Desam Party-led coalition government, prompting scrutiny of the revenue department.

In December 2024, Municipal Administration Regional Director CH Naga Narasimha Rao inspected the revenue department and raised concerns. Show-cause notices were issued to Commissioner Venkat Rao, Revenue Officer Salmon Raju,

former Revenue Inspector SK N M Valli, and Junior Assistant Vamsi. However, officials claim some of the mismanagement predates their tenure.

Following the inspection, ₹2.1 crore was reportedly recovered. However, many unanswered questions remain. Are the arrears genuine, or has the collected money been misappropriated? A high-level inquiry is essential to expose the truth and bring those responsible to

Family Movies Making a Comeback, Is **South Cinema Finally Done With Violence?**

The South Indian film industry seems to be witnessing a surprising shift in 2025, as family-oriented films have gained significant traction at the box office. One standout is the Telugu film Sankranthiki Vasthunam, which was released on January 14 this year and has grossed an impressive Rs 300 crore worldwide in just three weeks. Directed by Anil Ravipudi, this film has become the highest-grossing Telugu film for Sankranti 2025, surpassing even the highly anticipated *ame Changer, directed by Shankar and starring Ram Charan. Notably, both films were produced by Dil Raju.

In Tamil cinema, director Sundar C's *Madha Gaja Raja* has resonated with family audiences, grossing over Rs 55 crore since its release on January 12. Another family film, *Kudumbasthan*, which debuted on January 24, has earned around Rs 18 crore, despite being a modest production. This raises an intriguing question: are family movies making a strong return in South Indian cinema?

The Setback of 2024

for South Indian cinema, with the Malayalam and Tamil industries facing significant financial losses. The Malayalam film industry suffered Rs 700 crore in losses, while Tamil cinema saw a deficit of Rs 1,000 crore. Several big-budget films, such as Indian 2, Kanguva, and Game Changer, failed to meet box-office expectations, leaving the industry in a slump. Against this backdrop, the success of films like Sankranthiki Vasthunam and Madha Gaja Raja has been a surprise.

Notably, Sankranthiki Vasthunam did not feature an A-list cast, starring 64-year-old Venkatesh along-



side Meenakshi Dixit and Aishwarya Rajesh. Similarly, Madha Gaja Raja, which was completed in 2013 but delayed due to legal and financial issues, finally made its debut in January 2025. Kudumbasthan, starring actor-writer Manikandan, also attracted a significontent.

Trump stirs the Gaza pot



US President Donald Trump's recent remarks on Gaza have sparked widespread condemnation and confusion, with many questioning the legality and morality of his proposals. Speaking alongside Israeli Prime Minister Benjamin Netanyahu on February 4, Trump declared that the US would "take over the Gaza Strip" and be responsible for its development, describing it as a "long-term ownership position." This statement, delivered in a formal White House press briefing, has been met with both diplomatic outrage and concern for its potential consequences in the Middle East.

Trump's comments were not entirely unexpected, as similar sentiments had been expressed in the days leading up to his announcement. However, his suggestion that Jordan and Egypt should absorb around 2.3 million displaced Palestinians from Gaza has drawn sharp criticism from Arab nations. On February 1, foreign ministers from Arab countries, including Jordan and Egypt, condemned any plan that would forcibly displace Palestinians from their land, warning it could destabilize the region and hinder prospects for peace. Saudi Arabia also issued a firm response, reaffirming its commitment to Palestinian sovereignty and rejecting any attempts to infringe on their rights.

The proposal has placed Egypt and Jordan in difficult positions. Both nations have long-standing relations with the US but now face the possibility of being asked to take in large numbers of Palestinian refugees. Egypt, which has already been involved in numerous ceasefire negotiations between Israel and Gaza, is particularly concerned that Trump's remarks could destabilize its economy and political situation. Similarly, Jordan, home to a significant Palestinian population, would find it difficult to absorb more refugees without exacerbating existing tensions.

Beyond these immediate concerns, Trump's statements raise a host of questions that remain unanswered. How would the US enforce such a proposal? Would it involve military intervention, and what impact would that have on American foreign policy? Moreover, Trump's focus on developing Gaza as a real-estate project has raised alarms, with some questioning whether his administration views the suffering of Palestinians as an opportunity for business development, rather than addressing the region's long-standing humanitarian crisis.

Karnataka Excise Sector **Reforms: Committee Proposes** Lifting Liquor License Freeze



A committee led by retired IAS officer K P Krishnan to purchase liquor in bulk from nearby towns, only has recommended significant reforms in Karnataka's excise sector, including lifting the 33-year-old freeze on new liquor licences for retail stores (CL-2) and bars/restaurants (CL-9), along with an increase in fees for existing licenses. According to the committee's interim report, these reforms could generate an additional Rs 2,200 crore in revenue for the state, offering a potential solution to Karnataka's fiscal challenges.

The freeze on new licences, which has been in place since 1992, has resulted in a market where the existing 3,995 CL-2 and 3,637 CL-9 licences have become highly sought-after assets. This scarcity has led to inflated prices, with licences often changing hands through informal and illegal transactions. As a result, the state has been deprived of substantial legitimate revenue, while an underground market flourishes. Lifting the freeze aims to break this monopolistic system and bring more transparency to the sector.

The growing population of Karnataka, especially in rural areas, has further escalated the demand for liquor outlets. Currently, many rural residents have to sell it unofficially at inflated prices, contributing to unregulated bootlegging. By allowing new licences, the government hopes to meet the increasing demand while curbing these illicit operations.

While the proposal may seem like a practical solution to address fiscal concerns, it must be approached with caution. Critics argue that the expansion of liquor outlets could exacerbate social issues, including alcohol abuse and its impact on public health and safety. The increased availability of alcohol might lead to more social and economic costs, potentially offsetting the financial gains from the reforms.

It is essential that the state carefully assesses the long-term effects of lifting the freeze on liquor licences, weighing the potential revenue boost against possible adverse outcomes. Transparent regulation, along with stricter enforcement of licensing rules, will be crucial in ensuring that the benefits of these reforms outweigh the risks. By addressing these concerns, the government can ensure that the excise sector reforms contribute positively to Karnataka's economy while minimizing any negative consequences.





'One Nation One Election' constitutionally unsustainable: Udayanidhi Stalin

Saif Ali Khan's Attack: Two **Staffers Identify Arrested** Bangladeshi Man as Assailant

In a significant development in the case involving the attack on Bollywood actor Saif Ali Khan, two staff members at his residence have identified Shariful Fakir, a Bangladeshi national, as the person who assaulted the actor last month. Fakir, 30, was arrested in connection with the incident and is currently in judicial custody.

The identification took place during an Identification Parade conducted by the Mumbai police at Arthur Road jail on Wednesday. Eliyamma Phillip (56), a staffer at Khan's house, and Junu, a househelp, both confirmed that Fakir was the individual responsible for the attack on Khan, according to police officials. Phillip is considered a key witness, as she was also reportedly attacked by the assailant during the break-in.

On January 16, Fakir allegedly broke into Khan's apartment in the Satguru Sharan building in the Bandra area. Once inside, he reportedly stabbed Khan six times before fleeing the scene. Authorities quickly launched an investigation, which included reviewing CCTV footage from the building. The footage was instrumental in identifying Fakir, and a subsequent facial recognition test confirmed that the man arrested in Thane was the same person seen in the CCTV.

Following the attack, Fakir was apprehended three days later in Thane, a neighboring city. The police revealed that Fakir had entered the apartment in the early hours of the morning and carried out the attack. Investigators have indicated that the motive behind the attack remains unclear, and they are continuing to probe the circumstances surrounding the incident.

The identification parade played a critical role in confirming Fakir's involvement in the attack. Both Phillip and Junu positively identified him as the assailant, which strengthens the case against the accused.

Saif Ali Khan, who sustained multiple stab wounds in the attack, was reportedly in a stable condition after the incident. His family and team members have refrained from commenting publicly on the ongoing investigation.

The police are continuing their investigation into the incident and are looking into Fakir's background to determine how he gained access to Khan's residence and if there were any connections that might have led to the attack.

Defence Ministry Signs Over Rs 10,000 Crore Deal For Pinaka Rocket System

The Indian government has signed defence contracts worth over ₹10,000 crore to bolster the firepower capabilities of the Indian Army. These contracts, finalized on Thursday, focus on the procurement of advanced munitions, including Area Denial Munition Type-1 (ADM) and high-explosive rockets with enhanced range for the Pinaka Multiple Launch Rocket System (MLRS).

According to a statement from the Ministry of Defence, the contracts were signed with Economic Explosives Limited (EEL) and Munitions India Limited (MIL) to procure ADM Type-1 (DPICM) and High Explosive Pre-Fragmented (HEPF) Mk-1 (Enhanced) rockets. The total cost of these contracts amounts to ₹10,147 crore.

The HEPF Mk-1 (Enhanced) rockets are an upgraded version of the in-service HEPF rockets, offering an enhanced range to strike deep into enemy territory with precision and devastating impact. The ADM Type-1 of the Pinaka MLRS comes with a specialized warhead capable of dispersing sub-munitions over a larger area. This will target enemy



mechanized forces, vehicles, and personnel, denying specific areas to the enemy.

These advanced munitions are part of the

ongoing modernization of India's artillery rocket regiments and will significantly enhance the Army's firepower by enabling long-range and accurate strikes. The procurement is a key milestone in modernizing India's defence infrastructure, empowering domestic industries, and advancing the government's "Aatmanirbhar Bharat" initiative. In addition to strengthening national defence, these projects will create direct and indirect employment opportunities, particularly by promoting the Indian MSME sector through component manufacturing. Defence Secretary Rajesh Kumar Singh attended the contract signing event in New Delhi, underscoring the strategic importance of these procurements for India's defence preparedness.

US Secretary of State Rubio to Skip G20 Talks in South Africa

Rubio cites "anti-American" agenda, escalating tensions over land reform

US Secretary of State Marco Rubio announced on Wednesday that he would be skipping the upcoming Group of 20 (G20) foreign ministers' talks in South Africa, accusing the host nation of pursuing an "anti-American" agenda. Rubio's decision follows a fiery response from US President Donald Trump, who recently criticized South Africa's land reform policies that aim to address inequalities from the apartheid era.

Rubio, echoing Trump's combative rhetoric, posted on X (formerly Twitter) that he would not participate in the foreign ministers' summit scheduled for February 20-21 in Johannesburg. In his post, Rubio condemned South Africa's actions, claiming the country was "expropriating private property" and using the G20 forum to promote agendas like "solidarity, equality, & sustainability." He accused the South African government of prioritizing initiatives related to diversity, equity, and inclusion (DEI) as well as climate change—both of which have become subjects of scorn for Trump and his supporters.

"My job is to advance America's national interests, not waste taxpayer money or coddle anti-Americanism," Rubio asserted in his post, signaling his frustration with South Africa's position on issues like land reform and international policy agendas.

The tensions over land ownership in the diplomatic rift between the two South Africa remain high. Despite the countries continues to widen.



country's transition to democracy three decades ago, most of the nation's farmland is still controlled by white landowners. The South African government has been under growing pressure to implement reforms that would allow for the redistribution of land to rectify the racial disparities left by apartheid policies. These reforms have provoked backlash from critics, including Trump, who has condemned South Africa for what he perceives as "confiscating" land.

South African President Cyril Ramaphosa strongly rejected Trump's accusations, calling them misinformation. Earlier this week, Ramaphosa also reached out to Elon Musk, a prominent Trump ally, to express his concerns about what he described as disinformation circulating in the US media. Despite these efforts,

The absence of the United States, the world's largest economy, from the G20 talks would deal a significant blow to the forum. The G20 is intended to represent the leading global economies, and such a high-profile boycott would undermine the legitimacy of the talks. This diplomatic snub also means that Rubio, a key figure in US foreign policy, would miss an opportunity to engage with Russian Foreign Minister Sergei Lavrov. Trump has expressed interest in fostering dialogue with Russia on issues such as the ongoing conflict in Ukraine, and this meeting could have offered a first opportunity for such diplomacy.

Overall, the growing tension between the US and South Africa highlights the challenges of navigating global policy while balancing national interests and diplomatic concerns.

Netanyahu Supports Trump's Proposal to Displace Palestinians from Gaza





Israeli Prime Minister Benjamin Netanyahu defended former US President Donald Trump's controversial proposal to displace Palestinians from Gaza, despite widespread international condemnation. The proposal, which included suggestions for permanently displacing Palestinians and allowing them to return at will, was met with fierce criticism from rights groups, who labeled it as ethnic cleansing.

During an interview on Fox News, Netanyahu did not specifically address Trump's idea of a US takeover of Gaza but endorsed the concept of giving Palestinians in Gaza the option to leave. He stated, "What's wrong with that? They can leave, they can then come back, they can relocate and come back. But you have to rebuild Gaza."

Netanyahu further downplayed concerns, claiming that Trump's idea didn't involve sending US troops to Gaza or having Washington foot the bill for the region's reconstruction. He characterized Trump's proposal as "the first good idea" he had heard regarding the situation and called for it to be "examined and pursued." Netanyahu argued that the plan could bring about a "different future for everyone," reflecting his approval of the idea despite its controversy. Trump's proposal, first floated on January 25, suggests that Palestinians in Gaza should be resettled in neighboring Arab nations like Egypt and Jordan. This idea has been outright rejected by both Palestinian leaders and the Arab states in question. Trump's aides later attempted to clarify and distance themselves from aspects of the plan in response to the backlash.

This proposal emerged in the context of an ongoing and brutal military campaign by Israel against Gaza. Since the start of the conflict, Israel's airstrikes and ground assaults have resulted in over 47,000 Palestinian deaths, according to Gaza's health ministry. The violence has also sparked accusations of war crimes and genocide, which Israel has denied. Despite a fragile ceasefire, the human toll of the conflict continues to grow, with nearly all of Gaza's population displaced and widespread hunger exacerbating the crisis.



Australia Passes Strict Anti-Hate Crime Laws in Response to Rising Antisemitism

On Thursday, Australia passed tough new anti-hate crime legislation aimed at combating the recent surge in antisemitism. The laws introduce mandatory minimum sentences for various hate crimes, including terror-related offences and the display of hate symbols. The new legislation mandates prison terms ranging from 12 months for less severe offences, such as publicly giving a Nazi salute, to six years for individuals convicted of terrorism-related crimes.

Prime Minister Anthony Albanese, who had previously opposed mandatory minimum sentences, voiced his strong support for the new laws, emphasizing the importance of holding those engaged in antisemitism accountable. "I want people who are engaged in antisemitism to be held to account, to be charged, to be incarcerated," Albanese stated in an interview with Sky News.

The government's hate crimes bill, which was first introduced to parliament last year, also creates new criminal offences for any acts of force or violence targeting individuals based on factors like race, religion, nationality, political opinion, sex, sexual orientation, gender identity, and intersex status. The legislation is designed to address a significant uptick in antisemitic incidents across the country.

In recent months, Australia has witnessed a disturbing rise in attacks on Jewish community sites, including synagogues, Jewish-owned businesses, and cars. One particularly alarming incident involved the discovery of a caravan loaded with explosives and a list of Jewish targets in Sydney.

Panama Canal Denies Fee Waiver for US Vessels

The Panama Canal Authority (PCA) has clarified that it has not made any changes to the fees for US government vessels transiting the Panama Canal, following a statement from the US State Department suggesting otherwise. The PCA took to social media platform X to refute claims that Panama had agreed to waive the tolls for US government ships, emphasizing that the Authority, which has the power to set tolls and fees, had not altered its fee structure.

The official post from the Panama Canal Authority stated, "In response to a publication released by the United States Department of State, the Panama Canal Authority, which is for transiting the Canal, reports that it has not made any adjustments to them. The Panama Canal Authority, as it has indicated, is fully prepared to engage in dialogue with relevant United States officials regarding the transit of U.S. warships."

This clarification came after a US State Department announcement claimed Panama had agreed to waive the tolls

Canal. According to the statement, this move would save the US government millions of dollars annually. The announcement was made public following US Secretary of State Marco Rubio's trip to Panama on February 1, marking his first official visit to the country since assuming the role.

The US State Department's post on X read, "US government vessels can now transit the Panama Canal without charge fees, saving the US government millions of dollars a year." The decision was positioned as a significant financial relief for the United States, especially given the strategic importance of the Panama Canal for naval and commercial shipping.

DeepSeek Faces Global Scrutiny and Bans Over Security Cocerns

DeepSeek's rapid rise to prominence has sparked widespread concern among regulators and governments worldwide, leading to multiple countries imposing restrictions or outright bans on the Chinese AI app. Privacy watchdogs and national security officials have raised alarms about the app's data collection practices and potential security risks, prompting actions in several re-

Italy was one of the first to act, banning the app after an investigation by the Italian Data Protection Authority (Garante) into DeepSeek's compliance with EU data protection laws. The authorities found the app's response to their inquiries "completely insufficient," leading to the removal of DeepSeek from the Apple and Google app stores in Italy. The Italian regulators also noted that the app claimed not to operate in Italy, further complicating its legal standing within the European Union. Taiwan followed suit, banning government agencies, state-owned businesses, and public schools from using DeepSeek. The Ministry of Digital Affairs expressed concerns over the app's potential to endanger national security, pointing out that it is a Chinese product with implications for cross-border data transmission. Taiwan's restrictions were particularly focused on the risk of information leaks, a concern amplified by the app's Chinese origins.

Australia also acted swiftly, prohibiting government workers from using DeepSeek. The country's Department of Home Affairs issued a directive that forbids the installation or use of DeepSeek products on any government systems or devices, citing unacceptable security risks. However, the ban does not extend to private citizens, though Australians have been urged to exercise caution regarding their online data usage and privacy.







Markets Slip Amid Rate Concerns; Nifty Faces Resistance at 50-DMA

Domestic stock markets ended with moderate losses for the second consecutive session. They moved in a range-bound pattern throughout Thursday. The indices, which had gained initially, gradually fell due to mixed signals from international markets. Interest rate-related stocks were dealt a blow in the wake of the RBI monetary meeting. FMCG, realty, banking and finance shares fell as investors remained cautious and did not buy. Once again, the 50-day moving average became a resistance for Nifty. In the end, Nifty lost 90 points and Sensex lost 200 points.

It ended at 78,058, down 213 points. The NSE Nifty, which opened at 23,761, hit a low of 23,556 and a high of 23,773. It closed at 23,603, down 92 points. Mysterious Brain Disease Found in Dead Great White **Sharks AlongAtlantic Coast**



string of unexplained great Astring of unexplained great white shark deaths along the North American Atlantic Coast has raised serious concerns among marine scientists. The first case was reported in August 2023, when a 500-pound juvenile male shark, measuring 8 feet 9 inches, was found dead on a beach in Prince Edward Island, Canada. The shark's carcass was sent to the Atlantic Veterinary College at the University of Prince Edward Island for examination. Initial findings revealed no external injuries, and starvation was ruled out due to a healthy liver. However, a necropsy revealed meningoencephalitis—an inflammation

of the brain tissue—as the cause of death, prompting further investigations.

As additional shark deaths surfaced across the region, a study by the Canadian Wildlife Health Cooperative (C.W.H.C.) found similar brain inflammation in tissue samples from four other great white sharks. Dr. Megan Jones, a veterinary pathologist and regional director of C.W.H.C., noted that three of the five sharks examined showed signs of a potential infectious disease affecting the brain. In total, nine cases of great white sharks with brain swelling have been recorded since July 2022. While brain inflammation has

been linked to bacterial infections in other shark species, no such cause has been identified in these cases.

The lack of baseline mortality data for white sharks in the western North Atlantic complicates the investigation. Dr. Alisa Newton, chief veterinarian for OCEARCH, a Florida-based shark research organization, pointed out that it is difficult to determine whether the deaths are an anomaly or a natural occurrence. Meningoencephalitis was first identified in a white shark in 2022 in Long Island, New York, and has since been found in sharks from South Carolina and Massachusetts.

While investigations continue, experts are exploring various possibilities, including the potential role of viral or bacterial pathogens. Some, such as Tonya Wimmer, executive director of the Marine Animal Response Society (MARS), believe the rising number of beached sharks could be due to population growth, not a new disease.
