TPN Correspondent | New Delhi External Affairs Minister S. Jaishankar addressed the Rajya Sabha on Thursday, responding to opposition concerns over the deportation of Indian nationals from the US. He stated that deportations of illegal migrants have been occurring for years and are not a new development.

ister Modi, emphasized that India is engaging with the US to ensure that deportees are not mistreated. He cited that the number of deported Indians has ranged from 530 in 2012 to over

2,000 in 2019. "It is in our collective interest to encourage legal mobility and discourage illegal movement. Every country has the obligaliving illegally abroad," he said.

The statement came amid outrage over videos posted by US Border Patrol Chief Michael Banks, showing deported Indian citizens handcuffed and shackled aboard statistics showing a C-17 military transport plane to Amritsar. Some deportees reported being restrained for long hours and denied toilet breaks, sparking opposition protests over possible human rights violations.

Aam Aadmi Party (AAP) leader Sanjay Singh has alleged that the Bharatiya Janata Party (BJP) attempted to lure seven AAP candidates ahead of the Delhi assembly election results by offering ₹15 crore each to switch sides. Addressing a press conference on Thursday, the Rajya Sabha MP claimed that BJP leaders had reached out to these candidates through phone calls and face-to-face meetings.

"This clearly shows that the BJP has accepted its defeat even before the results. That is why they are resorting to such tactics," Singh said. He added that AAP has advised its candidates to record such conversations and use spy cameras if approached with



such offers. The BJP has yet to respond to these allegations. Voting for Delhi's 70 assembly constituencies took place on February 5, with a voter turnout of 60.42%, according to the Election Commission of India (ECI). The results, scheduled to be announced on February 8, will decide whether AAP secures a third consecutive term or if the BJP ends its 27-year-long wait to return to power in the capital. Exit polls have given mixed predictions, with most suggesting the BJP could form the next government. Some forecasts indicate a BJP victory with 51-60 seats, while others predict an AAP win. Congress is expected to continue its poor performance in the assembly polls.

J&K's Rajouri Seals All Pesticide Shops After 17 Wyster Deaths

Authorities in Jammu and Kashmir's Rajouri district have sealed all pesticide and insecticide shops as part of preventive measures following 17 'mysterious' deaths in Budhal village over the past nine weeks. Officials confirmed on Thursday that the action was taken amid an ongoing investigation into the cause of the fatalities.

In a late evening operation, joint teams from the agriculture department, food and drugs control organization, and police, led by an executive magistrate, conducted surprise inspections of pesticide, insecticide, and fertilizer outlets across the district. Following the inspections, all 250 such stores were ordered to shut until further notice.

The decision came after a five-member team of experts from AIIMS Delhi completed a three-day visit to Rajouri, where they examined affected patients, collected samples, and recorded clinical histories. The team included specialists in toxicology who are investigating the possibility of poisoning.

Meanwhile, 11 patients admitted to Government Medical College Hospital (GMCH) in Rajouri with symptoms of the 'mysterious illness' have fully recovered and were discharged on Tuesday. Dr. A.S. Bhatia, principal of GMCH, confirmed that all were treated with atropine, an antidote for organophosphorus poisoning.

Dr. Bhatia indicated that the symptoms of the deceased and affected patients suggest organophosphorus poisoning, but an anomaly in pupil constriction has raised further questions. Typically, such poisoning causes dilated pupils, but patients in Budhal village exhibited constricted pupils along with high fever, vomiting, excessive sweating, and unconsciousness. This unusual presentation is under investigation.

Officials assured that with the timely administration of atropine, all admitted patients have recovered, and no further fatalities have been reported. The authorities continue their probe to determine the source of the poisoning and prevent further incidents.

New **Income Tax Bill Likely** to Get Cabinet Nod Today



TPN Correspondent | New Delhi The Union Cabinet, chaired by Prime Minister Narendra Modi, is expected to approve the new Income Tax Bill today, with its introduction in Lok Sabha likely on February 10, sources said. The bill aims to replace the Income Tax Act of 1961 and simplify tax provi-sions. Finance Minister Nirmala Sitharaman announced the plan in the Union Budget 2025, stating it would be "clear and direct." The Budget session, which started on January 31, will continue until April 4 in two phases. However, no official confirmation on the bill's introduction date has been given yet.

The MP had earlier moved the high court against a city court's refusal to decide on his bail application, citing jurisdiction issues. The court has also sought a response from its registrar general regarding the designation of a court to hear Rashid's bail plea, noting that the MP had been left without legal recourse.

Rashid was arrested in 2019 under the Unlawful Activities (Prevention) Act (UAPA) for alleged involvement in terror financing. The NIA has accused him, along with Hafiz Saeed, Yasin Malik, and others, of channeling illicit funds to fuel unrest in Jammu and Kashmir. The Enforcement Directorate has also filed a money laundering case against the accused, stemming from the NIA's investigation.

The Budget session, which began on January 31, will run in two parts, concluding on April 4. The court will hear the matter further on Friday.

SC Orders Protection to Discovery Officials After **Threats Over Asaram Bapu Documentary**

The Supreme Court on Thursday granted interim police protection to Discovery Communications India officials following alleged threats from followers of self-styled godman Asaram Bapu over the release of the documentary series Cult of Fear: Asaram Bapu.

A bench comprising Chief Justice Sanjiv Khanna and Justice Sanjay Kumar issued notices to the Centre and the governments of Maharashtra, Karnataka, Haryana, Tamil Nadu, Telangana, West Bengal, and Delhi, directing them to ensure the safety of petitioners Shashank Walia and others, as well as their offices.

"Issue notice returnable in the week

commencing March 3, 2025. In the meanwhile, we request the police authorities to ensure that the petitioner gets to use the office and no threats of physical harm are extended to the petitioners," the court stated.

Senior advocate Abhinav Mukerji, representing the petitioners, informed the court that Discovery officials were facing threats from Asaram's followers, making it unsafe for them to travel freely across the country.

The plea detailed an incident on January 30, 2025, when a mob gathered outside Discovery's Mumbai office and attempted unauthorized entry. Although the police dispersed the crowd, no action was taken against those involved.



Triangular Contest in Okhla Turns Election Battle Fierce

The Okhla Assembly seat, historically known for favoring strong candidates over political parties, has become the center of a high-stakes three-way contest in the 2025 Delhi Assembly elections. While the race was initially projected as a direct fight between the Aam Aadmi Party (AAP) and Congress, the entry of Asaduddin Owaisi's All India Majlis-e-Ittehadul Muslimeen (AIMIM) has dramatically altered the political equation.

As per the Election Commission's voter app, Delhi recorded a final polling percentage of 60.44%, marking a significant turnout. The elections in the National Capital Territory (NCT) have always been closely watched, given its unique administrative structure and shifting voter dynamics. While the Bharatiya Janata Party (BJP) has dominated the Lok Sabha elections in Delhi since 2014, the AAP has maintained a stronghold over the assembly, winning in 2015 and 2020. The Congress, once a dominant force under Sheila Dikshit, has struggled to regain lost ground. However, the Okhla constituency remains an unpredictable battleground.

Candidate Over Party: Okhla's Voting History Okhla has traditionally voted based on the strength of individual candidates rather than party affiliations. Parvez Hashmi first won the seat on a Janata Dal ticket in 1993 before switching to Congress, securing victories in 1998, 2003, and 2008. His departure to the Rajya Sabha in 2009 led to a bypoll win for Rashtriya Janata Dal's Asif Muhammad Khan, who later joined Congress and won again in 2013. The 2015 and 2020 elections saw AAP's Amanatullah Khan


secure back-to-back victories, the latter with a record margin of over 1.3 lakh votes.

Despite Amanatullah's dominance, the political landscape in Okhla witnessed a shift during the 2022 Municipal Corporation of Delhi (MCD) elections. AAP lost four of the five wards within Okhla's jurisdiction, two to the BJP and two to Congress, signaling potential voter dissatisfaction. The Congress capitalized on this by fielding Ariba Khan, daughter of former MLA Asif Muhammad Khan, to reclaim lost ground in the 2025 elections.

The Entry of AIMIM: A Game-Changer

Just before the announcement of poll dates, AIMIM fielded Shifa Ur Rehman Khan, former president of the Alumni Association of Jamia Millia Islamia (AAJMI), as its candidate. Cur- benefit the BJP. rently an undertrial prisoner in connection with the 2020 Delhi riots case, Shifa Ur Rehman's candidacy has gained traction, particularly among Jamia alumni and local Muslim voters who perceive his arrest as unjust.

Asaduddin Owaisi's campaign rally in the constituency, particularly in Zakir Nagar and Batla House, significantly boosted Shifa's support. His family's emotional appeal, particularly from his wife and children, resonated with many voters, especially women linked to Jamia Millia Islamia. The surge in AIMIM's popularity forced Congress's Ariba Khan to intensify her campaign against both AAP and AIMIM, accusing Owaisi's party of dividing Muslim votes to



AAP, too, has been echoing a similar narrative, warning that a divided Muslim vote could allow the BJP to gain an unexpected victory in Okhla. The BJP Factor: A Possible Dark Horse?

With AAP, Congress, and AIMIM splitting the Muslim vote, BJP candidate Manish Chaudhary could emerge as a surprise winner. While Okhla's most densely populated areas—such as Zakir Nagar and Abul Fazal Enclave—are Muslim-majority, the Madanpur area has a mixed population with past support for the Bahujan Samaj Party (BSP), though recent trends favor the BJP. Sarita Vihar, a Hindu-majority area, remains a BJP stronghold.

Adding to the BJP's potential advantage is the polarizing nature of the contest. If the three main contenders fail to consolidate votes effectively, the BJP could secure a victory through a solidified Hindu voter base.

What Lies Ahead?

The final outcome for Okhla will be revealed on February 8, but the seat has already become one of the most intriguing battles in the Delhi elections. Initially seen as a Congress vs. AAP contest, it has turned into a three-way fight, with the potential for a four-way surprise if BJP capitalizes on the division.

Meanwhile, exit polls suggest a challenging road ahead for AAP in Delhi, with most predicting a BJP resurgence. While Congress is expected to secure a few seats, AIMIM remains an underdog in overall projections. However, in Okhla, the dynamics have shifted beyond party expectations, making it a crucial constituency to watch on counting day

Pradeep Gupta-led Axis My India exit poll has predicted a strong comeback for the Bharatiya Janata Party (BJP) in the Delhi Assembly elections, projecting the party to win 45-55 seats out of 70. If the prediction holds, the Aam Aadmi Party (AAP), which is seeking a third consecutive term, will suffer a major setback, with projections suggesting it will secure only 15-25 seats. The Congress is expected to win a maximum of one seat.

According to Axis My India, AAP leader Arvind Kejriwal remains the top choice for chief minister among Delhi voters, followed by BJP leaders Parvesh Verma and Manoj Tiwari. In the New Delhi district, BJP is projected to secure seven out of ten seats, while AAP is expected to win three. In North East Delhi, the BJP is likely to

while in South East Delhi, both parties are predicted to get five seats each.

Most exit polls released on Wednesday also predict a clear victory for the BJP, ending AAP's decade-long rule in the capital. While two agencies, WeePreside and Mind Brink, have forecasted an AAP win, the majority of pollsters foresee a comfortable BJP majority.

Peoples Pulse exit poll has projected a massive win for the BJP with 51-60 seats, leaving AAP with only 10-19 seats, and Congress with none. The Chanakya Strategies exit poll predicts 39-44 seats for BJP, 25-28 for AAP, and up to three for Congress. Matrize is the only pollster suggesting a close contest, predicting 35-40 seats for BJP and 32-37 for AAP.

JVC's exit poll estimates BJP will win 39-45 seats, while AAP could secure 22-31, with Conwin six seats and AAP four, gress getting 0-2 seats. P-Marq

forecasts 39-49 seats for BJP, 21-31 for AAP, and 0-1 for Congress. People's Insight projects BJP to win 40-44 seats, AAP 25-29, and Congress 0-1 seat. Poll Diary predicts BJP's victory with 42-50 seats, AAP securing 18-25, and Congress getting 0-2. Delhi recorded a voter turnout of 60.10% on polling day, nearly matching the 62.59% turnout in the 2020 elections, where AAP secured a landslide victory with 62 seats, leaving BJP with eight and Congress with none. Allegations of malpractice, including vote-buying and fake voting, were exchanged between BJP and AAP during the election process. The counting of votes will take place on Saturday, February 8, determining whether BJP will end its 27-year-long wait to reclaim power in Delhi or if AAP will defy predictions and secure another term.

Punjab Chief Minister Bhagwant Mann on Thursday condemned the treatment of deported Indian nationals from the USA, calling the handcuffing and shackling of the deportees a matter of shame for the country. He also criticized the Haryana government for transporting them in prisoner vans upon their arrival in India.

The deportation involved 104 illegal immigrants from various states, who were flown back on a U.S. Air Force C-17 Globemaster aircraft that landed at Amritsar airport on Wednesday. According to reports, among the deportees, 33 were from Haryana and Guja-

Taking to X, Mann expressed his outrage, stating that instead of showing compassion to those who are mentally and economically devastated, the BJP-led Haryana government aggravated their suffering by transporting them in police

"What America did is deeply regrettable. It is a matter of great shame for our country that America sends our citizens in handcuffs and shackles. Instead of applying ointment to the wounds of Indians deported from America who are mentally and economically broken, Modi's Haryana government taking them in police prisoner vans is like rubbing salt in the wounds," Mann said in his post.

The U.S. action comes just days ahead of Prime Minister Narendra Modi's scheduled visit to Washington for high-level discussions with former President Donald Trump.



PM Modi Slams Congress, Accuses Party of Prioritizing Family Over Development Hits back at opposition criticism, defends BJP's governance model

- Modi accused Congress of dynasty politics over national development.
- He criticized past Congress governments for suppressing free speech.
- His speech countered opposition attacks on the US deportation issue.

TPN Correspondent | Delhi Prime Minister Narendra Modi took a strong stance against the Congress party on Thursday, accusing it of not believing in 'sabka saath, sabka vikas' or 'development for all'. His remarks came in response to intense criticism of his government, particularly regarding the deportation of 104 Indians by the United States. During his address in the Rajya Sabha, Modi lashed out at the Congress, asserting that its model of politics prioritizes a single family over the nation's progress.

Modi dismissed the Congress' claim of supporting universal development, arguing that it does not align with the party's traditional agenda, which, according to him, is centered on "family first." "Expecting 'sabka saath, sabka vikas'

from the Congress is a huge mistake," Modi said. "It doesn't suit their roadmap because the party is dedicated to one family." He further criticized the Congress for indulging in appeasement politics during its tenure and contrasted it with the BJP's development model, which he said is not based on appeasement but rather on fulfilling the needs of all citizens, especially marginalized communities such as Other Backward Classes, women, and transgenders.

In an effort to highlight the Congress' past failures, Modi revisited the controversial 'Emergency' imposed by former Prime Minister Indira Gandhi in 1975. He accused the Congress of suppressing freedom of speech during that period and lamented how the party had previously attempted to undermine

the legacy of prominent leaders like Dr. BR Ambedkar. "There was a time when the Congress had a lot of hatred for Ambedkar," Modi remarked. "But today the Congress is forced to say 'Jai Bhim'."

The Prime Minister also revisited the era of Jawaharlal Nehru, claiming that during his leadership, prominent personalities like poet Majrooh Sultanpuri, actor Balraj Sahni, and singer Hridaynath Mangeshkar were jailed or censored for opposing the government. He argued that the Congress had stifled freedom of expression and creative voices throughout its tenure, and that it was only after the BJP came to power in 2014 that India witnessed a shift toward a politics of development and inclusion.

Hasina also warned her opponents, stating that history has a way of taking its revenge. The protests reportedly erupted after news spread that Hasina, who faces an arrest warrant in Bangladesh over charges related to massacres, planned to address her supporters via a Facebook broadcast. She urged the people of Bangladesh to rise against the current regime, led by Nobel Laureate Muhammad Yunus, and defend the national flag, constitution, and the independence that was earned at great cost by the country's martyrs.

Owaisi Criticizes Deportation of Indians from US, Links It to Unemployment Crisis

TPN Correspondent | Delhi Amid growing protests over the deportation of Indian nationals allegedly living illegally in the United States, AIM-IM MP Asaduddin Owaisi has voiced strong concerns, calling on the government to address the issue. Referring to a Pew Research 2022 report, Owaisi highlighted that there are still 675,000 undocumented Indian immigrants in the US, with 18,000 individuals on the final list for deportation. He questioned the government's approach towards these people and warned of the potential economic impact, especially on remittances.

"According to the Pew Research 2022 report, there are still 6,75,000 undocumented Indian immigrants in the USA, and 18,000 people are still on the final list. When all these people return, it will impact remittances as well. The government must also address what it will do for them," Owaisi

stated, urging the authorities that a lack of opportunities is to clarify their stance on supporting these individuals.

Owaisi also criticized the government for its handling of the deportation process, pointing to the disrespectful manner in which Indian nationals were being brought back. "BJP leaders keep saying that Modi ji has elevated India's name and made it a superpower, but what is happening now? Why are they being brought back in such a disrespectful manner?" he questioned.



Further, Owaisi connected the deportation issue to the high levels of unemployment among India's youth, claiming driving many individuals to seek work abroad, often in difficult and unsafe conditions. "This reflects the level of unemployment among the youth in India. 45 per cent of the youth are unemployed. This is why these people are lured by agents, endure hardships, and cross 8-10 countries to reach their destination. The government will have to answer why there is so much unemployment," Owaisi said.

In response to the matter, both houses of Parliament saw adjournments on Thursday as opposition MPs demanded a discussion on the deportation of over 100 Indian nationals from the US. Congress MPs Manickram Tagore, Gaurav Gogoi, and KC Venugopal had moved adjournment notices, urging the government to address the issue of the deportations and the treatment of Indian citizens by foreign authorities.

The deportation took place on a US military aircraft that landed in Amritsar on Wednesday, marking the first batch of Indian deportees under the Donald Trump administration's crackdown on illegal immigrants. Among the 104 deportees, 33 were from Haryana, 33 from Gujarat, 30 from Punjab, three each from Maharashtra and Uttar Pradesh, and two from Chandigarh. Notably, the group included 19 women and 13 minors, with some children as young as four, five, and seven years old.

Upon arrival in Amritsar, the deportees were questioned by various Indian authorities, including the Punjab Police and central intelligence agencies, to determine if they had any criminal records. Those from Amritsar were escorted to their homes in police vehicles, while those from Gujarat arrived at Ahmedabad airport the following morning.

The timing of the deportation has also raised questions, coming just days before Prime Minister Narendra Modi's scheduled visit to Washington for talks with US President Donald Trump on February 13. The deportation incident has added tension to the upcoming diplomatic discussions, with the Indian government under pressure to address the concerns raised by its citizens.

Handcuffed, Chained, Thrown Like Boxes: Indian **Migrants' American Nightmare**

The deportation of 104 Indian migrants from the United States has triggered widespread outrage in India, as the migrants were reportedly shackled and restrained during their journey back home. The US military aircraft carrying the deportees landed in Amritsar on Wednesday, marking the first mass deportation under President Donald Trump's administration. The deportation was part of the Trump administration's crackdown on illegal immigration, and the migrants, who had attempted to enter the US illegally, faced a difficult and dangerous journey across several countries before being detained by US Border Patrol.

Sharif referred to the Lahore Declaration of 1999, an agreement signed by then-Prime Minister Atal Bihari Vajpayee during his visit to Pakistan, and stressed that the only path forward for both countries was peaceful negotiations. Sharif urged India to prioritize peace for progress and stated that Pakistan would continue to offer moral, diplomatic, and political support to Kashmiris until they achieved self-determination.

India has consistently stated its intention to maintain normal relations with Pakistan, provided it operates in an environment free of terrorism,



hostility, and violence. Additionally, India has affirmed that Jammu and Kashmir, along with Ladakh, will always remain an integral part of the country.

Sharif called on the international community to pressure India into allowing Kashmiris to determine their future freely, a step he believes is essential for lasting peace. Family Movies Making a Comeback, Is South Cinema Finally Done With Violence?

The South Indian film industry seems to be witnessing a surprising shift in 2025, as family-oriented films have gained significant traction at the box office. One standout is the Telugu film Sankranthiki Vasthunam, which was released on January 14 this year and has grossed an impressive Rs 300 crore worldwide in just three weeks. Directed by Anil Ravipudi, this film has become the highest-grossing Telugu film for Sankranti 2025, surpassing even the highly anticipated *ame Changer, directed by Shankar and starring Ram Charan. Notably, both films were produced by Dil Raju.

In Tamil cinema, director Sundar C's *Madha Gaja Raja* has resonated with family audiences, grossing over Rs 55 crore since its release on January 12. Another family film, *Kudumbasthan*, which debuted on January 24, has earned around Rs 18 crore, despite being a modest production. This raises an intriguing question: are family movies making a strong return in South Indian cinema?

Against this backdrop, the success of films like Sankranthiki Vasthunam and Madha Gaja Raja has been a surprise.

Notably, Sankranthiki Vasthunam did not feature an A-list cast, starring 64-year-old Venkatesh along-



side Meenakshi Dixit and Aishwarya Rajesh. Similarly, Madha Gaja Raja, which was completed in 2013 but delayed due to legal and financial issues, finally made its debut in January 2025. Kudumbasthan, starring actor-writer Manikandan, also attracted a significontent.

In 2024, Indian cinema leaned heavily toward action-packed films targeting younger audiences, with titles like Raayan, Garudan, Captain Miller, and Devara: Part 1. According to film journalist Bharath Kumar, the industry had long focused on action films while neglecting family-oriented stories. However, the success of family films in January 2025 demon-

strates a growing demand for wholesome content that blends comedy, sentiment, and feel-good factors.

Trump stirs the Gaza pot



Karnataka Excise Sector Reforms: Committee Proposes Lifting Liquor License Freeze

US President Donald Trump's recent remarks on Gaza have sparked widespread condemnation and confusion, with many questioning the legality and morality of his proposals. Speaking alongside Israeli Prime Minister Benjamin Netanyahu on February 4, Trump declared that the US would "take over the Gaza Strip" and be responsible for its development, describing it as a "long-term ownership position." This statement, delivered in a formal White House press briefing, has been met with both diplomatic outrage and concern for its potential consequences in the Middle East.

Trump's comments were not entirely unexpected, as similar sentiments had been expressed in the days leading up to his announcement. However, his suggestion that Jordan and Egypt should absorb around 2.3 million displaced Palestinians from Gaza has drawn sharp criticism from Arab nations. On February 1, foreign ministers from Arab countries, including Jordan and Egypt, condemned any plan that would forcibly displace Palestinians from their land, warning it could destabilize the region and hinder prospects for peace. Saudi Arabia also issued a firm response, reaffirming its commitment to Palestinian sovereignty and rejecting any attempts to infringe on their rights.

The proposal has placed Egypt and Jordan in difficult positions. Both nations have long-standing relations with the US but now face the possibility of being asked to take in large numbers of Palestinian refugees. Egypt, which has already been involved in numerous ceasefire negotiations between Israel and Gaza, is particularly concerned that Trump's remarks could destabilize its economy and political situation. Similarly, Jordan, home to a significant Palestinian population, would find it difficult to absorb more refugees without exacerbating existing tensions.

Beyond these immediate concerns, Trump's statements raise a host of questions that remain unanswered. How would the US enforce such a proposal? Would it involve military intervention, and what impact would that have on American foreign policy? Moreover, Trump's focus on developing Gaza as a real-estate project has raised alarms, with some questioning whether his administration views the suffering of Palestinians as an opportunity for business development, rather than addressing the region's long-standing humanitarian crisis.



A committee led by retired IAS officer K P Krishnan to purchase liquor in bulk from nearby towns, only has recommended significant reforms in Karnataka's excise sector, including lifting the 33-year-old freeze on new liquor licences for retail stores (CL-2) and bars/restaurants (CL-9), along with an increase in fees for existing licenses. According to the committee's interim report, these reforms could generate an additional Rs 2,200 crore in revenue for the state, offering a potential solution to Karnataka's fiscal challenges.

The freeze on new licences, which has been in place since 1992, has resulted in a market where the existing 3,995 CL-2 and 3,637 CL-9 licences have become highly sought-after assets. This scarcity has led to inflated prices, with licences often changing hands through informal and illegal transactions. As a result, the state has been deprived of substantial legitimate revenue, while an underground market flourishes. Lifting the freeze aims to break this monopolistic system and bring more transparency to the sector.

The growing population of Karnataka, especially in rural areas, has further escalated the demand for liquor outlets. Currently, many rural residents have

to sell it unofficially at inflated prices, contributing to unregulated bootlegging. By allowing new licences, the government hopes to meet the increasing demand while curbing these illicit operations. While the proposal may seem like a practical solution to address fiscal concerns, it must be approached with caution. Critics argue that the expansion of liquor outlets could exacerbate social issues, including alcohol abuse and its impact on public health and safety. The increased availability of alcohol might lead to more social and economic costs, potentially offsetting the financial gains from the reforms.

It is essential that the state carefully assesses the long-term effects of lifting the freeze on liquor licences, weighing the potential revenue boost against possible adverse outcomes. Transparent regulation, along with stricter enforcement of licensing rules, will be crucial in ensuring that the benefits of these reforms outweigh the risks. By addressing these concerns, the government can ensure that the excise sector reforms contribute positively to Karnataka's economy while minimizing any negative consequences.





'One Nation One Election' constitutionally unsustainable: Udayanidhi Stalin

Saif Ali Khan's Attack: Two **Staffers Identify Arrested Bangladeshi Man as Assailant**

In a significant development in the case involving the attack on Bollywood actor Saif Ali Khan, two staff members at his residence have identified Shariful Fakir, a Bangladeshi national, as the person who assaulted the actor last month. Fakir, 30, was arrested in connection with the incident and is currently in judicial custody.

The identification took place during an Identification Parade conducted by the Mumbai police at Arthur Road jail on Wednesday. Eliyamma Phillip (56), a staffer at Khan's house, and Junu, a househelp, both confirmed that Fakir was the individual responsible for the attack on Khan, according to police officials. Phillip is considered a key witness, as she was also reportedly attacked by the assailant during the break-in.

On January 16, Fakir allegedly broke into Khan's apartment in the Satguru Sharan building in the Bandra area. Once inside, he reportedly stabbed Khan six times before fleeing the scene. Authorities quickly launched an investigation, which included reviewing CCTV footage from the building. The footage was instrumental in identifying Fakir, and a subsequent facial recognition test confirmed that the man arrested in Thane was the same person seen in the CCTV.

Following the attack, Fakir was apprehended three days later in Thane, a neighboring city. The police revealed that Fakir had entered the apartment in the early hours of the morning and carried out the attack. Investigators have indicated that the motive behind the attack remains unclear, and they are continuing to probe the circumstances surrounding the incident.

The identification parade played a critical role in confirming Fakir's involvement in the attack. Both Phillip and Junu positively identified him as the assailant, which strengthens the case against the accused.

Saif Ali Khan, who sustained multiple stab wounds in the attack, was reportedly in a stable condition after the incident. His family and team members have refrained from commenting publicly on the ongoing investigation.

Defence Ministry Signs Over Rs 10,000 Crore Deal For Pinaka Rocket System

The Indian government has signed defence contracts worth over ₹10,000 crore to bolster the firepower capabilities of the Indian Army. These contracts, finalized on Thursday, focus on the procurement of advanced munitions, including Area Denial Munition Type-1 (ADM) and high-explosive rockets with enhanced range for the Pinaka Multiple Launch Rocket System (MLRS).

According to a statement from the Ministry of Defence, the contracts were signed with Economic Explosives Limited (EEL) and Munitions India Limited (MIL) to procure ADM Type-1 (DPICM) and High Explosive Pre-Fragmented (HEPF) Mk-1 (Enhanced) rockets. The total cost of these contracts amounts to ₹10,147 crore.

The HEPF Mk-1 (Enhanced) rockets are an upgraded version of the in-service HEPF rockets, offering an enhanced range to strike deep into enemy territory with precision and devastating impact. The ADM Type-1 of the Pinaka MLRS comes with a specialized warhead capable of dispersing sub-munitions over a larger area. This will target enemy



mechanized forces, vehicles, and personnel, denying specific areas to the enemy.

These advanced munitions are part of the ongoing modernization of India's artillery rocket regiments and will significantly enhance the Army's firepower by enabling long-range and accurate strikes. The procurement is a key milestone in modernizing India's defence infrastructure, empowering domestic industries, and advancing the government's "Aatmanirbhar Bharat" initiative. In addition to strengthening national defence, these projects will create direct and indirect employment opportunities, particularly by promoting the Indian MSME sector through component manufacturing. US Secretary of State Rubio to Skip G20 Talks in South Africa

Rubio cites "anti-American" agenda, escalating tensions over land reform

US Secretary of State Marco Rubio announced on Wednesday that he would be skipping the upcoming Group of 20 (G20) foreign ministers' talks in South Africa, accusing the host nation of pursuing an "anti-American" agenda. Rubio's decision follows a fiery response from US President Donald Trump, who recently criticized South Africa's land reform policies that aim to address inequalities from the apartheid era.

Rubio, echoing Trump's combative rhetoric, posted on X (formerly Twitter) that he would not participate in the foreign ministers' summit scheduled for February 20-21 in Johannesburg. In his post, Rubio condemned South Africa's actions, claiming the country was "expropriating private property" and using the G20 forum to promote agendas like "solidarity, equality, & sustainability." He accused the South African government of prioritizing initiatives related to diversity, equity, and inclusion (DEI) as well as climate change-both of which have become subjects of scorn for Trump and his supporters.

"My job is to advance America's national interests, not waste taxpayer money or coddle anti-Americanism," Rubio asserted in his post, signaling his frustration with South Africa's position on issues like land reform and international policy agendas.

The tensions over land ownership in the diplomatic rift between the two South Africa remain high. Despite the countries continues to widen.

The South African government has been under growing pressure to implement reforms that would allow for the redistribution of land to rectify the racial disparities left by apartheid policies. These reforms have provoked backlash from critics, including Trump, who has condemned South Africa for what he perceives as "confiscating" land.

South African President Cyril Ramaphosa strongly rejected Trump's accusations, calling them misinformation. Earlier this week, Ramaphosa also reached out to Elon Musk, a prominent Trump ally, to express his concerns about what he described as disinformation circulating in the US media. The absence of the United States, the world's largest economy, from the G20 talks would deal a significant blow to the forum. The G20 is intended to represent the leading global economies, and such a high-profile boycott would undermine the legitimacy of the talks. This diplomatic snub also means that Rubio, a key figure in US foreign policy, would miss an opportunity to engage with Russian Foreign Minister Sergei Lavrov. Trump has expressed interest in fostering dialogue with Russia on issues such as the ongoing conflict in Ukraine, and this meeting could have offered a first opportunity for such diplomacy.

Netanyahu Supports Trump's Proposal to Displace Palestinians from Gaza

Israeli Prime Minister Benjamin Netanyahu defended former US President Donald Trump's controversial proposal to displace Palestinians from Gaza, despite widespread international condemnation. The proposal, which included suggestions for permanently displacing Palestinians and allowing them to return at will, was met with fierce criticism from rights groups, who labeled it as ethnic cleansing.


During an interview on Fox News, Netanyahu did not specifically address Trump's idea of a US takeover of Gaza but endorsed the concept of giving Palestinians in Gaza the option to leave. He stated, "What's wrong with that? They can leave, they can then come back, they can relocate and come back. But you have to rebuild Gaza."

Netanyahu further downplayed concerns, claiming that Trump's idea didn't involve sending US troops to Gaza or having Washington foot the bill for the region's reconstruction. He characterized Trump's proposal as "the first good idea" he had heard regarding the situation and called for it to be "examined and pursued." Netanyahu argued that the plan could bring about a "different future for everyone," reflecting his approval of the idea despite its controversy. Trump's proposal, first floated on January 25, suggests that Palestinians in Gaza should be resettled in neighboring Arab nations like Egypt and Jordan. This idea has been outright rejected by both Palestinian leaders and the Arab states in question. Trump's aides later attempted to clarify and distance themselves from aspects of the plan in response to the backlash.

This proposal emerged in the context of an ongoing and brutal military campaign by Israel against Gaza. Since the start of the conflict, Israel's airstrikes and ground assaults have resulted in over 47,000 Palestinian deaths, according to Gaza's health ministry. The violence has also sparked accusations of war crimes and genocide, which Israel has denied. Despite a fragile ceasefire, the human toll of the conflict continues to grow, with nearly all of Gaza's population displaced and widespread hunger exacerbating the crisis.

Australia Passes Strict Anti-Hate Crime Laws in Response to Rising Antisemitism

On Thursday, Australia passed tough new anti-hate crime legislation aimed at combating the recent surge in antisemitism. The laws introduce mandatory minimum sentences for various hate crimes, including terror-related offences and the display of hate symbols. The new legislation mandates prison terms ranging from 12 months for less severe offences, such as publicly giving a Nazi salute, to six years for individuals convicted of terrorism-related crimes.

Prime Minister Anthony Albanese, who had previously opposed mandatory minimum sentences, voiced his strong support for the new laws, emphasizing the importance of holding those engaged in antisemitism accountable. "I want people who are engaged in antisemitism to be held to account, to be charged, to be incarcerated," Albanese stated in an interview with Sky News.

The government's hate crimes bill, which was first introduced to parliament last year, also creates new criminal offences for any acts of force or violence targeting individuals based on factors like race, religion, nationality, political opinion, sex, sexual orientation, gender identity, and intersex status. The legislation is designed to address a significant uptick in antisemitic incidents across the country.

In recent months, Australia has witnessed a disturbing rise in attacks on Jewish community sites, including synagogues, Jewish-owned businesses, and cars. One particularly alarming incident involved the discovery of a caravan loaded with explosives and a list of Jewish targets in Sydney.

The Panama Canal Authority (PCA) has clarified that it has not made any changes to the fees for US government vessels transiting the Panama Canal, following a statement from the US State Department suggesting otherwise. The PCA took to social media platform X to refute claims that Panama had agreed to waive the tolls for US government ships, emphasizing that the Authority, which has the power to set tolls and fees, had not altered its fee structure.

The official post from the Panama Canal Authority stated, "In response to a publication released by the United States Department of State, the Panama Canal Authority, which is authorized to set tolls and other fees However, the Panama Canal Authorifor transiting the Canal, reports that it has not made any adjustments to them. The Panama Canal Authority, as it has indicated, is fully prepared to engage in dialogue with relevant United States officials regarding the transit of U.S. warships."

This clarification came after a US State Department announcement claimed Panama had agreed to waive the tolls

Canal. According to the statement, this move would save the US government millions of dollars annually. The announcement was made public following US Secretary of State Marco Rubio's trip to Panama on February 1, marking his first official visit to the country since assuming the role.

The US State Department's post on X read, "US government vessels can now transit the Panama Canal without charge fees, saving the US government millions of dollars a year." The decision was positioned as a significant financial relief for the United States, especially given the strategic importance of the Panama Canal for naval and commercial shipping.

DeepSeek Faces Global Scrutiny and Bans Over Security Cocerns

DeepSeek's rapid rise to prominence has sparked widespread concern among regulators and governments worldwide, leading to multiple countries imposing restrictions or outright bans on the Chinese AI app. Privacy watchdogs and national security officials have raised alarms about the app's data collection practices and potential security risks, prompting actions in several regions.

Italy was one of the first to act, banning the app after an investigation by the Italian Data Protection Authority (Garante) into DeepSeek's compliance with EU data protection laws. The authorities found the app's response to their inquiries "completely insufficient," leading to the removal of DeepSeek from the Apple and Google app stores in Italy. The Italian regulators also noted that the app claimed not to operate in Italy, further complicating its legal standing within the European Union. Taiwan followed suit, banning government agencies, state-owned businesses, and public schools from using DeepSeek. The Ministry of Digital Affairs expressed concerns over the app's potential to endanger national security, pointing out that it is a Chinese product with implications for cross-border data transmission. Taiwan's restrictions were particularly focused on the risk of information leaks, a concern amplified by the app's Chinese origins.

Australia also acted swiftly, prohibiting government workers from using DeepSeek. The country's Department of Home Affairs issued a directive that forbids the installation or use of DeepSeek products on any government systems or devices, citing unacceptable security risks. However, the ban does not extend to private citizens, though Australians have been urged to exercise caution regarding their online data usage and privacy.







Markets Slip Amid Rate Concerns; Nifty Faces Resistance at 50-DMA

The Nifty Bank rose 39 points to settle at 50,382.

In the Nifty50, 21 companies gained while 30 lost. IT, pharma and private bank indices gained the most. Realty, consumer durables, media, metal and FMCG indices rose the most. Cipla, Adani Ports, ITC Hotels, Dr. Reddy's, HDFC Life were the top gainers. Trent, BEL, Airtel, Titan, ONGC were the top losers.

Mysterious Brain Disease Found in Dead Great White **Sharks AlongAtlantic Coast**



string of unexplained great Awhite shark deaths along the North American Atlantic Coast has raised serious concerns among marine scientists. The first case was reported in August 2023, when a 500-pound juvenile male shark, measuring 8 feet 9 inches, was found dead on a beach in Prince Edward Island, Canada. The shark's carcass was sent to the Atlantic Veterinary College at the University of Prince Edward Island for examination. Initial findings revealed no external injuries, and starvation was ruled out due to a healthy liver. However, a necropsy revealed meningoencephalitis—an inflammation of the brain tissue—as the cause of death, prompting further investigations.

As additional shark deaths surfaced across the region, a study by the Canadian Wildlife Health Cooperative (C.W.H.C.) found similar brain inflammation in tissue samples from four other great white sharks. Dr. Megan Jones, a veterinary pathologist and regional director of C.W.H.C., noted that three of the five sharks examined showed signs of a potential infectious disease affecting the brain. In total, nine cases of great white sharks with brain swelling have been recorded since July 2022. While brain inflammation has

been linked to bacterial infections in other shark species, no such cause has been identified in these cases.

The lack of baseline mortality data for white sharks in the western North Atlantic complicates the investigation. Dr. Alisa Newton, chief veterinarian for OCEARCH, a Florida-based shark research organization, pointed out that it is difficult to determine whether the deaths are an anomaly or a natural occurrence. Meningoencephalitis was first identified in a white shark in 2022 in Long Island, New York, and has since been found in sharks from South Carolina and Massachusetts.

While investigations continue, experts are exploring various possibilities, including the potential role of viral or bacterial pathogens. Some, such as Tonya Wimmer, executive director of the Marine Animal Response Society (MARS), believe the rising number of beached sharks could be due to population growth, not a new disease.
