Violence Erupts In Nagpur Over Quran Burning Rumours

4 Injured, CM Fadnavis Urges People To Maintain Peace

Tension erupted in central Nagpur on Monday following rumors that the Quran had been burned during a protest by a right-wing organization demanding the removal of Aurangzeb's tomb. The unrest led to clashes between the police and a mob, with stones being hurled at law enforcement officers. The violence left four individuals injured, prompting the police to deploy tear gas shells and resort to a cane charge to disperse the crowd in the Chitnis Park and Mahal areas.

The disturbances quickly spread to the Kotwali and Ganeshpeth areas by the late afternoon, with the Chitnis Park to Shukrawari Talao road being the most severely affected. Reports indicated that rioters set fire to several four-wheelers and threw stones at residents' homes. Thousands of people were reportedly involved in the violent protests, escalating the situation and increasing fears of further unrest.

Maharashtra Chief Minister Devendra Fadnavis, who also holds the Home portfolio, appealed for peace and urged citizens to refrain from believing in rumors. In a statement, Fadnavis reminded the public that Nagpur had long been known as a peaceful city, where people of different communities lived in harmony. "Nagpur has always been a peaceful city where people share each other's joys and sorrows. Do not fall for misinformation," Fadnavis said. He assured the public that he was in constant contact with the police and had instructed them to maintain law and order while cooperating with citizens.

The violent incident has left the city on edge, with authorities working to contain the situation and restore calm. Security forces are closely monitoring the affected areas as tensions remain high following the unrest. The police are investigating the origin of the rumors that sparked the violence and have urged residents to remain vigilant and report any suspicious activity.

Chaos Erupts in Delhi MCD House as AAP and BJP **Councillors Clash**

A dramatic disruption unfolded in the Municipal Corporation of Delhi (MCD) House on Monday as councillors from both the Aam Aadmi Party (AAP) and the Bharatiya Janata Party (BJP) engaged in a heated clash, leading to the adjournment of the General House meeting.

The session, which began later than scheduled, saw BJP councillors immediately rising to demand a vote, arguing that AAP no longer held a majority in the House. In response, AAP members vehemently countered the claim, accusing the BJP of undermining democratic principles and "murdering" the Constitution.

As tensions escalated, the House descended into chaos. BJP councillors began chanting slogans and tearing up agenda papers, while others climbed onto tables to voice their protest. The AAP members, equally vocal, waved the

torn documents and shouted counter-slogans, intensifying the disruption.



Mamata conveys message of peace from Furfura Sharif

West Bengal Chief Minister Mamata Banerjee visited Furfura Sharif in Hooghly district on Monday, conveying a message of "harmony, peace, and unity." She addressed opposition criticism regarding her visit, emphasizing that her intention was purely to foster unity among communities.

Banerjee, who was visiting Furfura Sharif after nearly a decade, met with local religious leaders and participated in the community's Iftar. The shrine, which is dedicated to Mohammad Abu Bakr Siddique, a revered religious leader for a section of Bengali Muslims, holds significant influence within the community. Over the years, political leaders have often sought the support of the 'pirs' (religious leaders) of Furfura Sharif, seen as a key constituency in state elections.

Implemented, Full Execution Expected in Two Years: Amit Shah

Union Home Minister Amit Shah announced on Sunday that 82% of the Bodo Peace Accord, signed in January 2020, has been successfully implemented, with the remaining provisions set to be fulfilled within the next two years. Shah made the statement at the 57th



The Bodo Peace Accord, aimed at bringing lasting peace and development to the Bodoland region, had initially faced skepticism, particularly from the Congress. Shah recalled how Congress leaders had mocked the agreement at its inception, suggesting that peace in Bodoland was an impossible goal. However, with 82% of the accord's clauses already fulfilled, the Home Minister emphasized the progress made under the leadership of Prime Minister Narendra Modi.

Shah assured that the remaining provisions of the accord would be fully executed within the next two years, ensuring lasting peace and stability in the region. He noted that the successful implementation of the accord has already resulted in significant improvements in the Bodoland region, including the reduction of insurgency and an increase



in development activities.

Additionally, Shah directed all northeastern states to ensure that there would be no political interference in cases related to terrorism, mob lynching, or organized crime. During a review meeting in Guwahati on the implementation of new criminal laws, he stressed the importance of training police personnel to protect citizens' rights and strengthen justice delivery.

With insurgency in the region nearly eradicated, Shah urged the police to shift focus to safeguarding lives, property, and dignity. He also advocated for strengthening the Director of Prosecution to ensure more efficient justice delivery across the region.

Shah's remarks marked a significant milestone in the implementation of the Bodo Peace Accord, highlighting the government's commitment to bringing peace and development to the Bodoland region.

Union Minister Anupriya Patel Inaugurates Quad Workshop On Pandemic Preparedness for the Indo-Pacific Region

- Event focuses strengthening global health security
- digital health solutions, and regional resilience

India is hosting the Quad Workshop on Pandemic Preparedness for the Indo-Pacific Region from March 17-19, 2025. The workshop, inaugurated by Union Minister of State for Health and Family Welfare, Anupriya Singh Patel, aims to strengthen global health emergency frameworks and improve pandemic preparedness across the Indo-Pacific region.

Patel, in her inaugural address, highlighted India's role as a leader in digital health technologies. She emphasized that the workshop is a direct outcome of the 6th Quad Leaders' Summit held in September 2024, where the Quad leaders committed to enhancing collaboration on health security and pandemic preparedness. The workshop seeks to improve preparedness, resilience, and coordination in the face of evolving pandemics, focusing on a One Health approach, which integrates human, animal, and environmental health through a multisectoral lens.

Patel stated, "The rise of emerging and re-emerging health threats underscores the need for strengthened preparedness, enhanced surveillance, and coordinated international responses to safeguard global health security." She also highlighted India's significant financial contribution, announcing that India had pledged USD 10 million towards the Pandemic Fund, with an additional USD 12 million to support its ongoing efforts.



The Union Minister also stressed India's leadership in digital health initiatives, which aim to improve healthcare access and outcomes. These initiatives include the Ayushman Bharat Digital Mission (ABDM), CoWIN platform, eSanjeevani, National Telemedicine Service, and the Ni-Kshay portal, which helps track and manage tuberculosis patients. Patel added that India's digital disease surveillance system could serve as a valuable model for other countries looking to strengthen their public health infrastructure.

Prof. Ajay Kumar Sood, Principal Scientific Advisor to the Union government, discussed India's efforts to integrate health services and stressed the importance of regional health networks, especially for countries with significant livestock sectors, to prepare for zoonotic diseases. Punya Salila Srivastava, Union Health Secretary, also highlighted the Quad's collaborative role in health security, leveraging the expertise and resources of its member countries, including India's vaccine production capacity and the technological expertise of the US, Japan, and Australia.

Himachal Pradesh CM Sukhu Presents ₹58,514 Crore Tax-**Free Budget Focused on Rural Development**

Himachal Pradesh Chief Minister Sukhvinder Singh Sukhu presented a tax-free budget with an outlay of ₹58,514 crore for the fiscal year 2025-26. The budget is designed to foster the development of the rural economy by engaging farmrural youth, ers. and women in the growth process. Sukhu, who also

holds the Finance

portfolio, emphasized that the budget's core objective is to accelerate the state's journey toward self-reliance. It focuses on transforming the rural economy while ensuring the conservation of the environment and natural resources throughout the development process. Key sectors highlighted in the budget include agriculture, animal husbandry, and social security, with a clear focus on long-term sustainability.

For the fiscal year 2025-26, the state's revenue receipts are estimated at ₹42,343 crore, while the total revenue expenditure is projected at ₹48,733 crore, leading to a revenue deficit of ₹6,390 crore. The fiscal deficit is estimated at ₹10,338 crore, which constitutes 4.04% of the state's Gross Domestic Product (GDP).

In his address, the Chief Minister criticized the previous BJP government, citing challenges such as a fragile fiscal position, rampant mining mafia activities, and reckless expenditures that had worsened the state's



financial health. Sukhu also pointed out that the Congress government had inherited economic difficulties following their assumption of power on December 11, 2022.

Addressing the state's financial hurdles, Sukhu highlighted the lack of funds due from the Centre, including approximately ₹9,000 crore owed to the state government and its employees under the National Pension Scheme (NPS). Additionally, the state has incurred a total revenue loss of ₹9,478 crore since the implementation of the Goods and Services Tax (GST). The reduction in the Revenue Deficit Grant (RDG) and the end of GST compensation have further strained the state's financial situation.

Sukhu also criticized the Centre for its neglect of the state's economic needs, referencing the abolition of the Planning Commission and continuous imposition of conditions on schemes and financial assistance, leaving Himachal Pradesh consistently marginalized.

Manipur violence: Cases to be tried in Guwahati itself, says Supreme Court

The Supreme Court of India, on March 17, 2025, confirmed that the trial of the Manipur ethnic violence cases, being investigated by the CBI, will be conducted in Guwahati, Assam. This follows the transfer of the cases to Guwahati in August 2023 for pre-trial proceedings. The three-judge bench, led by Chief Justice Sanjiv Khanna, also extended the tenure of the relief and rehabilitation committee until July 31, 2025. The committee, chaired by former Jammu and Kashmir High Court Chief Justice Gita Mittal, was set up in August 2023 to oversee the welfare of the victims of the violence in Manipur.



The top court had previously moved the trials out of Manipur to ensure a fair and unbiased legal process, citing concerns over the "overall environment" in the state. On Monday, the court reiterated that the trial of these transferred cases will be conducted in Guwahati and directed the Gauhati High Court Chief Justice to appoint judicial officers to handle them.

The ethnic violence in Manipur, which accounted for 77% of the violent incidents in the northeastern

region in 2023, has resulted in a significant loss of life and displacement of thousands. As of now, 27 cases, including serious charges such as sexual assault, molestation, and murder, have



been transferred to Assam for trial. These include the high-profile case of two women being paraded naked in a viral video, which brought national attention to the violence.

The court has also been monitoring the efforts of the Manipur government in addressing the grievances of the displaced persons and restoring properties damaged during the violence. In December 2023, the court directed the government to submit a detailed report on the damage to properties, including those looted or encroached upon, and to take necessary legal action against trespassers.

The next hearing is scheduled for the week of July 21, 2025, as the investigation and the relief process continue.

Justice Bagchi sworn in as SC judge, in line to be CJI in 2031

Justice Joymalya Bagchi was sworn in as a Supreme Court judge by Chief Justice of India, Sanjiv Khanna. This appointment brings the judicial strength of the Supreme Court to 33, leaving only one vacancy remaining on the bench.

Before his elevation to the apex court, Justice Bagchi served as a judge at the Calcutta High Court, where he gained extensive experience. His appointment is notable as it brings regional representation from the Calcutta High Court to the Supreme Court, filling a long-standing gap since the retirement of Justice Altamas Kabir in July 2013. The Supreme Court Collegium had recommended Justice Bagchi's name for the position on March 6, 2025, and the government notified the



assent of the President to the appointment on March 10.

Justice Bagchi is poised to take on significant leadership roles in the judiciary. Based on the current seniority structure, he is in line to become the Chief Justice of India (CJI) in May 2031, a position he will hold until his retirement on October 2, 2031. His tenure as a Supreme Court judge will span over six years, further solidifying his legal

The Collegium's recommendation, which also took into account the need for regional representation, highlighted that at present, only one judge from the Calcutta High Court, Justice Dipankar Datta, served on the Supreme Court bench. Justice Bagchi's appointment brings balance and diversity to the composition of the court.

Justice Bagchi's judicial career began when he was appointed to the Calcutta High Court on June 27, 2011. His experience includes a transfer to the Andhra Pradesh High Court in January 2021, before being repatriated to Calcutta in November 2021. With over 13 years of service as a high court judge, Justice Bagchi brings a wealth of experience to his new role on the Supreme Court.

'Muslims Will Never Forgive You': Owaisi Warns Naidu, Nitish Over Waqf Bill

JPC Chief Calls Protest A 'Conspiracy'

Opposition parties led by Congress joined forces with the All India Muslim Personal Law Board (AIMPLB) to protest against the Waqf (Amendment) Bill, 2024. The protest aimed to draw attention to what the board called an "intimidation" of Muslims and an attempt to undermine their constitutional rights, specifically those enshrined in Articles 12 to 35 of the Indian Constitution.

The protest saw participation from several key opposition parties, including Congress, Trinamool Congress, Aam Aadmi Party, CPI (Marxist), Nationalist Congress Party, and the Indian Union Muslim League. Notably, the Biju Janata Dal also aligned itself with the opposition, while BJP allies like the Telugu Desam Party, Janata Dal (United), and Lok Janshakti Party abstained from the protest.

AIMIM leader Asaduddin Owaisi led the charge against BJP allies who supported the government on the Waqf issue. Owaisi criticized Chandrababu Naidu, Chirag Paswan, and Nitish Kumar for backing the bill, warning them that Muslims would not forgive their support for what he called an

unconstitutional law. He also highlighted the bill's potential to allow non-Muslims to dominate Waqf boards, questioning why non-Muslims should have a role in Muslim religious affairs when non-Sikhs and non-Hindus are not allowed in Gurdwaras and temple trusts.

Congress MP Mohammed Jawaid expressed his support for the protest, asserting that the bill was unconstitutional and posed a threat to Muslim properties. Other leaders like Salman Khurshid, Muhibullah Nadvi, and Dharmendra Yadav echoed concerns about the bill's interference in Muslim affairs and its potential to weaken Waqf boards, endan-

gering Muslim properties in the future.

Leading Muslim organizations such as Jamaat-e-Islami Hind and Jamiat Ulama-i-Hind also lent their support, with their leaders emphasizing that the rights given to Muslims through the Waqf Act were similar to those enjoyed by other communities. They warned that the bill was an attack on the Constitution itself.

The protest marked the beginning of a nationwide movement against the Waqf (Amendment) Bill, with AIM-PLB president Khalid Saifullah Rehmani vowing to continue the fight.

Mayawati: Relatives are Part of Bahujan Samaj, Nothing More

Bahujan Samaj Party (BSP) chief Mayawati addressed the media on Monday, emphasizing that her siblings and other relatives are merely part of the 'Bahujan Samaj' and nothing beyond that. She clarified that personal relations will not interfere with the party's interests and growth.

Mayawati assured that anyone from the Bahujan Samaj who works sincerely for the party's cause will be given opportunities to progress, irrespective of family ties. "I will never let my interests, or those of my siblings and relatives, weaken the party as long as I am alive. My relatives are just a part of the Bahujan Samaj, and nothing more," she stated.

These remarks come after Mayawati removed her nephew, Akash Anand, from all party posts on March 2, and announced that there will be no successor to her in the party as long as she remains alive. She also appointed her brother Anand Kumar and Ramji Gautam as national coordinators to manage BSP's affairs na-



tionwide.

Mayawati highlighted the enthusiasm surrounding the 91st birth anniversary celebrations of BSP founder Kanshi Ram on March 15, noting that the event was held with great zeal, despite coinciding with several festivals like Holi. "The resolution taken by Kanshi Ram's followers to strengthen the party at all levels has given me new energy," she added.

On the topic of social change, Mayawati spoke about the importance of moving away from caste-based mentality. She criticized Prime Minister Narendra Modi's repeated references to his poverty, stating

that he has never faced caste discrimination like Dalits or other marginalized communities. Mayawati urged party members to educate the younger generation about the struggles faced by these communities.

Reflecting on the BSP's impact, she praised the social changes brought about during her leadership, particularly the empowerment of Dalits in Uttar Pradesh. She claimed that before the BSP's majority government in 2007, Dalits could not sit with upper-class people, but this changed under her leadership, marking a significant victory for social justice.

Haryana Presents Rs 2.05 Lakh Crore Budget, Aim To Make State "Future Capable"

Haryana Chief Minister Nayab Singh Saini presented the state's budget for the financial year 2025-26 on Monday, outlining a total outlay of Rs 2.05 lakh crore. The budget aims to enhance the state's future capabilities, focusing on technological advancements and economic growth.

In his speech at the Haryana Assembly, CM Saini shared that the state government had received around 11,000 suggestions from various sectors to shape the budget. To make Haryana "future capable," he pro-

posed the creation of a new government department called the "Department of Future," which would drive forward-looking policies and projects.

The budget outlay for 2025-26 is Rs 2,05,017.29 crore, marking a 13.7% increase from the revised estimates of 2024-25. CM Saini emphasized the government's focus on e-governance over the past decade, highlighting that 19 out of the 217 promises made in the election manifesto had already been fulfilled.

Ajit Doval Meets Tulsi Gabbard In Delhi, Chairs **High-Level Security Meet**



- **Discussions** focus on counterterrorism, intelligence-sharing
- Indo-Pacific security amid growing India-US partnership

National Security Advisor (NSA) Ajit Doval met with US Director of National Intelligence Tulsi Gabbard on Sunday in New Delhi, marking the beginning of a two-and-a-half-day visit by Gabbard to India. The meeting focused on enhancing intelligence-sharing and collaboration between India and the US, particularly in the context of the growing India-US global strategic partnership. Doval and Gabbard discussed a range of security issues, including tackling terrorism and addressing the challenges posed by emerging technologies.

This visit is the first high-level trip to India by a senior official from the Donald Trump administration. Gabbard's visit comes after she met with Prime Minister Narendra Modi during his trip to Washington, ed to extradition and immigration

DC. Sources reported that the oneon-one discussions between Doval and Gabbard were productive and focused on strengthening security ties between the two nations.

In addition to the bilateral talks, Doval chaired a closed-door conclave of top global intelligence officials. The conclave, hosted by India, saw participation from intelligence chiefs from several countries, including Canadian spy chief Daniel Rogers, UK National Security Adviser Jonathan Powell, and the intelligence heads of Australia, Germany, New Zealand, and other allied nations. The discussions revolved around intelligence sharing, counterterrorism efforts, and addressing threats from emerging technologies. Security in the Indo-Pacific region, cooperation on counterterrorism financing, and issues relatwere also key topics of deliberation.

The Indian side raised concerns about anti-India elements operating abroad, including pro-Khalistan groups, during the conclave. Additionally, the implications of the Russia-Ukraine war and conflicts in the Middle East were discussed in the context of global security challenges.

Gabbard's visit follows recent tensions between India and Canada, stemming from allegations surrounding the murder of Hardeep Singh Nijjar. The ongoing diplomatic strains between the two countries are expected to be addressed in discussions between Doval and Rogers.

Gabbard is scheduled to speak at the Raisina Dialogue on Tuesday as part of her official visit.

Delhi Airport Sues Centre For Allowing Flights From Defence Airbase

The operator of Delhi's international airport, predominantly owned by GMR Airports, has filed a lawsuit against the Indian government over the approval of commercial flights from a nearby military airbase, according to legal documents set to be heard on Monday. The Delhi International Airport Limited (DIAL), which operates the airport, claims that allowing commercial operations from the Ghaziabad airbase will make the gan operating flights from Hindon in airport economically unfeasible.

DIAL argues that the government's decision to permit commercial flights from Hindon Airforce Station threatens to undermine the financial viability of the Delhi airport. In its lawsuit filed on March 10, DIAL asserts that the government's actions violate aviation regulations, which prevent the establishment of a new commercial airport within 150 kilometers (90 miles) of an existing one unless there is clear passenger demand. The suit is being heard by the Delhi High Court.

The Airports Authority of India, a state-run entity, also holds a stake in DIAL. However, the Ministry of Civil Aviation has yet to respond to requests for comment on the matter. The lawsuit further claims that media reports have indicated Air India Express be-March, which prompted DIAL to take legal action.

Delhi Police Detain Seven Illegal Bangladeshi Immigrants, **Deportation Process Begins**

The Delhi Police have detained seven illegal Bangladeshi immigrants, including a minor, and have initiated their deportation process, an official confirmed on Monday. This is part of the ongoing crackdown on illegal immigration that the Delhi Police launched last December.

The detained individuals—Dilawar Khan (48), Beauty Begum (39), Rafikul (43), Tauhid (20), Md Azhar (28), Zakir Malik (40), and a 15-year-old minor girl—are accused of entering India illegally via river routes. They were found residing in various locations across Delhi and Ghaziabad. According to Deputy Commissioner of Police (East), Abhishek Dhania, the Foreigners Regional Registration Office (FRRO) is assisting with the deportation process.

The detention occurred on March 16 after the police received a tip-off about the presence of illegal immigrants in the Krishna Nagar area. The police detained Dilawar Khan, who initially claimed to be from West Bengal. However, after further questioning and verification, it was



revealed that he was a Bangladeshi national from Khulna district.

Delhi's I&FC and MCD Collaborate for De-silting Sunehri Pul and **Kushak Drains**

The Delhi Irrigation and Flood Control (I&FC) Department has informed the National Green Tribunal (NGT) that it will undertake de-silting work on the open portions of the Sunehri Pul and Kushak drains in South Delhi. Meanwhile, the Municipal Corporation of Delhi (MCD) will be responsible for de-silting the covered portions of these drains.

All 24 major drains in Delhi that flow into the Yamuna River come under the jurisdiction of the I&FC department. However, in this particular case, the I&FC has stated that it will make an exception and collaborate with the MCD. This decision follows a joint meeting held on March 5, 2025, under the chairmanship of the Delhi Chief Secretary, after I&FC clarified that it lacks the necessary expertise to clean covered drains.



The I&FC's submission, dated March 11, outlined the plans for the Sunehri Pul and Kushak drains. For the Sunehri Pul drain, the MCD has committed to cleaning the covered portion by cutting through the section near the bus depot by Dayal Singh College. For the Kushak drain, which is partially covered, the MCD will issue an Expression of Interest (EOI) within seven days to identify effective methods for de-silting the box portion. Additionally, the MCD will take steps to prevent waterlogging in these stretches, ensuring proper drainage and the continued flow of water.

Delhi Metro to launch urban freight services, joins hands with Blue Dart

The Delhi Metro Rail Corporation (DMRC) has teamed up with logistics provider Blue Dart to introduce an urban freight (cargo) service on its metro network, marking a pioneering step in the South Asia Pacific region. Assam Rifles Chief, Mizoram Official On "Historic Moment" In Aizawl

The recent relocation of the Assam Rifles (AR) establishment from Aizawl, Mizoram's capital, has been well-received by the local population, according to Lieutenant General Vikas Lakhera, the Director General of Assam Rifles. In an interview with NDTV, Lakhera explained that the decision to shift the AR from the capital was met with a pos-

itive response, particularly due to the green belt and open space of the new location in Zokhawsang, 15 km away from Aizawl.

The Assam Rifles has been stationed in Mizoram since the 1890s. The Union government made the decision to transfer the land in Aizawl to the state government, as part of a broader effort to meet the needs and aspirations of the people of Mizoram.

"The mood was very positive during the formal ceremony marking the vacating of the land," Lakhera said, adding that Union Home Minister Amit Shah, who oversees the Ministry of Home Affairs, emphasized that the newly vacated space could be used for better urban development in the growing hill city.

The move was part of a long-standing demand from the Mizoram government to relocate the Assam Rifles. The initial request was made in 1988 by the Mizo National Front (MNF) government after a controversial incident in which 11 civilians were killed in a clash with the paramilitary force. After years of negotiations, in February 2019, the Union Home Ministry directed the Assam Rifles to relocate its establishment to Zokhawsang.

Lakhera highlighted that while the new location is close to Aizawl, it offers better infrastructure for the AR, with the sector headquarters remaining in the Khatla neighborhood. "It's a wonderful location and provides better facilities for the Assam Rifles while staying close to Aizawl," he said.

Jonathan Lalremruata, Officer on Special Duty to the Mizoram Chief Minister, called the relocation a historic moment and praised the leadership of Union Home Minister Amit Shah, the Chief Minister, and the Director General of Assam Rifles for making the shift a reality. "We are fortunate that this process has moved forward quickly and effectively," he added.

Encounter Breaks Out Between Security Forces, Terrorists In J&K's Kupwara

Kolkata Police STF Arrests Man with Firearms at **Sealdah Railway Station**

Election Commission Needs Urgent Course Correction on Voter Rolls

However, the is facing growing criticism from Opposition parties over discrepancies in electoral rolls and issues of duplicate Elector Photo Identity Card (EPIC) numbers. As the country approaches a significant milestone of 100 crore eligible voters, these concerns have raised alarm over the integrity of the electoral process. If not addressed swiftly, these issues could undermine the credibility of India's democratic framework.

The ECI has acknowledged that while some EPIC numbers may appear identical, other voter details such as demographic information, assembly constituency, and polling booth are different. However, this assurance has done little to quell concerns, and many believe it is insufficient. The need for a comprehensive national exercise to

ber has become critical. In addition, there must be stronger coordination between the ECI and state electoral officers to ensure accurate and updated voter databases. Lapses by these officers, particularly in managing voter records independently, seem to have contributed to these discrepancies.

A key point of contention is the ECI's move to link voter IDs with Aadhaar. Although current law allows for voluntary linking of Aadhaar details to electoral rolls, the government has assured that those who do not comply will not be removed from the voter list. This approach aims to prevent coercive actions and ensure inclusivity. Aadhaar, being a unique identifier, plays a pivotal role in eliminating duplicate voters, ensuring transparency, and improving

Ukraine Faces Potential "Frozen" Conflict Amid **Ceasefire Talks**

Ukraine may be on the verge of a "frozen" conflict, as international pressure mounts for a ceasefire, yet both sides remain far from agreeing on a lasting peace. The recent proposal for a 30-day ceasefire, brokered by the U.S., has brought global attention to Moscow's stance. While Russian President Vladimir Putin expressed conditional support for a ceasefire, emphasizing that it should address the root causes of the war, Ukrainian President Volodymyr Zelensky has warned that Putin's intentions are manipulative and aimed at gaining further territorial concessions.

Putin's response is strategic; he recognizes that the conflict is not just a military struggle but a geopolitical one, and he aims to prolong negotiations to maximize his gains. With Russia regaining control of significant areas in Ukraine, including the Kursk region, Putin is pushing for a halt to Western military support to Ukraine during the ceasefire period, further complicating negotiations.

The situation mirrors the Korean War's armistice, where an official peace agreement was never signed, only a temporary halt to hostilities. Just as the Korean conflict remained unresolved for years, Ukraine could face a similar fate, with no peace deal in sight. Putin's demands to keep Crimea and parts of Donbas under Russian control are unacceptable to Ukraine, which remains determined to reclaim its territory.

Zelensky, meanwhile, is in a weaker position, as the Trump administration has hinted that Kyiv may have to accept significant territorial losses, including not joining NATO. The ill-fated Ukrainian offensive in Kursk last year only compounded the country's strategic challenges, with Russia regaining lost ground.

While the U.S. puts pressure on Moscow to accept the ceasefire and toughens sanctions on Russian energy and banking sectors, Zelensky is calling for guarantees to ensure Russia adheres to the ceasefire. The Kremlin, however, opposes the idea of European peacekeepers in Ukraine, with Putin preferring a role for countries like India and other BRICS nations, who have maintained neutral relations with Russia.

As talks progress, the conflict risks becoming a prolonged "frozen" war, where violence stops but a lasting peace remains elusive. For Ukraine, the challenge is to ensure its sovereignty while navigating complex international pressures.

India Must Deftly Walk the

Tariff Tightrope

India faces a significant challenge in negotiating trade tariffs with the United States under President Donald Trump. The tariffs being used as leverage for non-trade objectives, such as reducing illegal immigration and bolstering the dollar, have caused global trade turmoil. While Trump's trade war strategy appears erratic, India must navigate these tumultuous waters carefully to avoid serious economic setbacks.

India's trade surplus with the U.S. has become a point of contention for the Trump administration, particularly as India runs a large overall trade deficit with the world. India's high tariffs on agricultural products, automobiles, and alcohol—ranging from 100% to 165%—have particularly drawn criticism. In response, India offered to reduce tariffs on items of American interest, like bourbon whiskey, but this gesture has not mollified Trump.

The situation has become a complex balancing act. On the one hand, India is protective of its domestic industries, such as agriculture and automobiles, where high tariffs shield local businesses and farmers from foreign competition. On the other hand, India has significant vulnerabilities. For instance, if India agrees to reduce tariffs for the U.S., it risks setting a precedent for other countries, such as the European Union and the U.K., who have long sought similar concessions. Moreover, the United States is unlikely to significantly increase its exports even if India cuts tariffs, making this trade dispute more emotional than practical.

India's economic situation is far stronger today compared to 1991, when it faced an economic crisis. The 1991 economic reforms opened up India's economy, making it the world's fifth-largest economy today. However, India's agricultural and automobile sectors remain overprotected, reminiscent of the country's pre-reform era. With growing global competition and changing economic dynamics, India must reconsider its high tariff policies.

Eliminating tariffs on agriculture and manufactured goods would help India integrate more deeply into the global economy, boosting its manufacturing sector and attracting foreign investments. This shift would also create jobs in new indus-



tries, while freeing up resources to address pressing domestic issues such as the over-reliance on agriculture. India should not only focus on tariff reductions but also harness its labor force's potential in emerging sectors like sports, entertainment, and personal services. By retraining workers and investing in global opportunities, India can ensure long-term prosperity without compromising its economic independence. In conclusion, India must tread carefully with the U.S. on tariffs, aiming to strike a deal that protects its interests while positioning itself as an open and competitive player in the global economy.



Pakistan Faces Growing Internal Crisis Amid Baloch Separatism and TTP Resurgence

Pakistan is grappling with a significant internal crisis, driven by escalating separatist insurgencies and a surge in terrorist attacks. The Baloch Liberation Army (BLA) has intensified its activities, conducting at least 14 attacks between 2020 and 2025 against Chinese nationals, killing 20 people and injuring 34. In addition, over 400 Pakistani security personnel have died in similar attacks. While the BLA's militancy continues, the Baloch independence movement is also supported by non-violent activists, such as Mahrang Baloch, advocating for provincial autonomy and social justice.

The BLA's March 13 hijacking of the Jaffar Express, a high-profile operation, has propelled the movement into the international spotlight. This event parallels other global incidents, such as the October 2023 Hamas attack, highlighting the BLA's strategy to rejuvenate the Baloch cause. However, this bold action risks triggering a harsh response from Pakistan's military establishment, which traditionally leans towards military solutions rather than diplomatic engagement.

Pakistan's counterinsurgency history reveals the limits of force in resolving separatist movements. In 1971, the state's heavy-handed tactics led to the separation of East Pakistan (now Bangladesh). Similarly, while Operation Zarb-e-Azb against the Tehreek-e-Taliban Pakistan (TTP) brought temporary peace, it failed to address the underlying issues, with the TTP quickly resurfacing when the Taliban gained control of Afghanistan. The Baloch insurgency shares key similar-

ities with past conflicts, where the state's reliance on military might has proven ineffective. Pakistan's failure to address the grievances of ethnic minorities like the Baloch, Sindhis, and Kashmiris has prolonged regional instability. As the TTP resurges and Baloch separatism gains momentum, Pakistan faces a perilous situation where military responses alone could lead to a prolonged, unwinnable conflict.

Pakistan's military engagement across its borders, including operations along the Durand Line, and its ongoing internal conflicts threaten to undermine recent economic stabilization. With tensions rising and the situation spiraling out of control, Pakistan must reconsider its approach, shifting from forceful suppression to genuine political dialogue to prevent further destabilization.





PM Modi-Christopher Luxon meeting: India, New Zealand ink defence pact

This pact follows a bilateral meeting between Prime Minister Narendra Modi and New Zealand Prime Minister Christopher Luxon on Monday, marking a significant step in strengthening the two nations' ties.

Following the talks, Modi emphasized the decision to strengthen and institutionalize the defence and security relationship between the two countries. He also revealed that a roadmap would be developed to guide future cooperation in the defence industry sector, ensuring more strategic collaboration.

As a member of the Five Eyes intelligence alliance, New Zealand plays a vital role in global security, and this agreement is seen as a move to enhance both countries' strategic interests in the Indo-Pacific region. The focus on maritime safety and security is particularly significant given the increasing geopolitical challenges in the region, which call for stronger partnerships between like-minded nations.

The new agreement is expected to deepen defence engagements and facilitate greater collaboration on training, joint exercises, and the sharing of best practices in the defence sector. Both leaders acknowledged the importance of maintaining a rules-based international order in the maritime domain, and this agreement serves as a step towards enhancing peace and stability in the region.

This development also reflects India's growing global influence and its efforts to strengthen ties with key partners like New Zealand, in line with its broader foreign policy strategy to bolster defence cooperation across the Indo-Pacific.



India and Sweden Aim to Strengthen Trade and Investment Ties

Discussions focus on green technologies, smart infrastructure, and economic cooperation

India and Sweden are actively exploring ways to enhance their bilateral trade and investment relations, with a focus on fostering economic cooperation in key sectors. During a recent meeting in New Delhi, Union Minister of Commerce and Industry, Piyush Goyal, and Swedish Minister for Foreign Affairs, Maria M. Stenergard, discussed opportunities for collaboration in areas such as green technologies, renewable energy, smart infrastructure, and healthcare.

Sweden is currently the 21st largest investor in India, with a cumulative foreign direct investment (FDI) of USD 2.51 billion from April 2000 to March 2024. Key sectors attracting Swedish investments include automobiles, industrial machinery, engineering, electrical equipment, and metallurgy. The two countries aim to further strengthen their trade and investment ties through increased cooperation, opening up new avenues for business in both nations.

Minister Goyal emphasized the importance of these discussions, saying, "We discussed ways to further strengthen the India-Sweden bilateral trade and investment partnership, fostering economic cooperation and opening up new business opportunities in both nations." The Joint Economic Commission (JEC) continues to serve as the primary platform for government-to-government dialogue between India and Sweden.

In recent trade statistics, India's exports to Sweden reached USD 104 million in June 2024, while imports totaled USD 171 million, resulting in a trade deficit of USD 66.6 million. However, compared to June 2023, India's exports to Sweden saw significant growth of 45.2%, while imports increased by 21.6%. Key exports from India to Sweden include ready-made cotton garments, electric machinery, automobile spare parts, and iron and steel products. Imports from Sweden include iron and steel, pulp and waste paper, paper products, auto components, and industrial machinery for various sectors.

This growing engagement between the two countries comes as Sweden strengthens its global partnerships, responding to shifts in international dynamics, including the impact of Russia's invasion of Ukraine and its evolving stance toward China. Both nations continue to deepen their ties, focusing on shared goals of economic growth and mutual prosperity.



RG Kar Rape-Murder Case: SC disposes of parents' plea for fresh CBI probe – 'free to approach Calcutta HC'

The Supreme Court of India on Monday, March 17, dismissed a petition filed by the parents of a victim in the RG Kar rape-murder case, seeking a fresh investigation by the Central Bureau of Investigation (CBI). However, the court granted them the option to pursue their case in the Calcutta High Court.

Chief Justice of India, Sanjiv Khanna, stated, "Without making comments, we dispose of the application observing that the applicant is at liberty to pursue the proceedings before the HC," according to legal news agency LiveLaw.

The case relates to the horrific rape and murder of a 31-year-old post-graduate trainee doctor at the RG Kar Medical College and Hospital in Kolkata. Her body was discovered on August 9, 2024, within the hospital premises. Investigations revealed that the woman had been raped and murdered, sparking widespread protests across the country.

During a prior hearing, the CJI-led Bench directed hospitals and medical colleges nationwide not to penalize doctors and medical professionals who had participated in protests over the case but had returned to their duties after the Supreme Court's appeal. Senior Advocate Karuna Nundi represented the victim's parents, while Solicitor General of India Tushar Mehta appeared on behalf of the CBI.

In February 2025, a special court in Kolkata ordered the CBI to submit a progress report on the case by February 24. The CBI had taken over the investigation following a directive from the Calcutta High Court.



Centre has accorded approval for Chandrayaan-5 Mission: ISRO chief ISRO to Launch 250 kg Rover to Study the Moon TPN Correspondent | Delhi

The Centre has granted approval for the ambitious Chandrayaan-5 mission, aimed at studying the lunar surface, ISRO Chairman V. Narayanan announced on Sunday. Speaking at an event to felicitate his appointment as the new head of the Indian Space Research Organisation (ISRO), Narayanan highlighted the significance of the mission, which will carry a 250 kg rover, a substantial upgrade from the 25-kg rover 'Prayagyaan' aboard Chandrayaan-3.

The Chandrayaan-5 mission, a key part of ISRO's lunar exploration program, will focus on detailed surface studies of the moon. Narayanan noted that this mission would be a step forward in ISRO's lunar exploration capabilities, following the success of the previous Chandrayaan missions. Chandrayaan-1, launched in 2008, provided crucial data on the moon's chemical, mineralogical, and photo-geological characteristics. Despite a partial setback during the Chandrayaan-2 mission in 2019, which was 98% successful, the high-resolution camera on the spacecraft continues to send valuable images from the lunar surface.

Narayanan also spoke about the recent success of the Chandrayaan-3 mission, which achieved a significant milestone with the Vikram lander performing a soft landing on the moon's South Pole on August 23, 2023.



India, New Zealand resume FTA talks, bilateral meet held

India and New Zealand have officially resumed negotiations for a proposed free trade agreement (FTA), marking a significant step towards strengthening economic ties after a nearly decade-long pause. The two countries began discussions on the Comprehensive Economic Cooperation Agreement (CECA) in April 2010, aimed at boosting trade in goods, services, and investment. However, after nine rounds of talks, negotiations stalled in 2015.

The announcement of the resumption of talks came after Commerce and Industry Minister Piyush Goyal met with New Zealand's Minister for Trade and Investment, Todd McClay, during a high-level visit by New Zealand Prime Minister Christopher Luxon to India. The two leaders agreed to pursue a comprehensive and mutually beneficial FTA that seeks to enhance supply chain integration, improve market access, and unlock new business opportunities for both countries.

Bilateral trade between India and New Zealand has been steadily growing, surpassing \$1 billion during April-January 2025. However, a report by the Global Trade Research Initiative (GTRI) suggests that the proposed FTA may offer limited benefits to Indian companies, as many already enjoy duty-free access to a significant portion of goods in the New Zealand market. The report notes that New Zealand's average import tariff is just 2.3%, compared to India's 17.8%. Despite this, the FTA negotiations aim to further enhance trade relations and unlock new opportunities for businesses and consumers. India's exports to New Zealand include clothing, textiles, refined petroleum, agricultural machinery, and basmati rice.







Trump Attempts to Void Biden's Pardons, **Raising Legal and Political Controversies**

U.S. President Donald Trump has moved to annul several of his predecessor Joe Biden's pardons, marking the latest in a series of actions to challenge political opponents. Among the pardons Trump declared void were those granted to Members of the U.S. House of Representatives investigating the January 6, 2020, Capitol attack, as well as prominent figures such as Dr. Anthony Fauci, who headed the Biden Administration's COVID-19 response, and former Joint Chiefs Chairman Mark Milley.

Trump's statement on his 'Truth Social' media platform claimed that these pardons, signed by Biden just before he left office on January 20, were invalid because they were allegedly signed using an autopen. "The 'Pardons' that Sleepy Joe Biden gave to the Unselect Committee of Political Thugs... are hereby declared VOID, VACANT, AND OF NO FURTHER FORCE OR EFFECT," Trump wrote early Monday morning.

The January 6 Select Committee, which Trump criticized, included several high-profile figures, such as Republicans Liz Cheney and Adam Kinzinger, and Democrat Adam Schiff, all vocal critics of Trump. On his first day in office, Trump had pardoned over 1,500 individuals involved in the Capitol attack, further emphasizing his controversial use of pardons.

Trump also claimed—without evidence—that Biden might not have been aware of the pardons and suggested that members of the Select Committee might have signed them on his behalf. He asserted that these individuals, who he accused of destroying evidence during their investigation, should be prepared for high-level scrutiny.

While Trump's attempt to nullify these pardons raises significant questions about executive power, he acknowledged that it would ultimately be up to the courts to decide if the rescinding of presidential pardons is legally valid. Presidential pardoning power, granted by Article II Section 2 of the U.S. Constitution, is broad but has historically been used to protect allies and family members. Despite these powers, the courts have largely refrained from limiting presidential pardons, leaving their scope open to interpretation.

Competition is fine, not conflict: PM Modi on China

• PM Modi Emphasizes **India-China Cooperation** • Criticizes Pakistan's Role in Global Terrorism

Prime Minister Narendra Modi stated on Sunday that cooperation between India and China benefits not only the two nations but also the global community. Speaking to Lex Fridman in a podcast, he highlighted the progress made in normalizing the situation along the Line of Actual Control (LAC) and noted that both countries are working toward restoring the pre-2020 status along the border, although the process might take time.

Modi emphasized that India-China cooperation is crucial for global stability and prosperity, stating, "The 21st century is the Asian century. Competition is natural, but there should not be conflict." Reflecting on the historical ties between India and China, Modi pointed out that the two countries, both ancient civilizations, have learned from each other throughout history. He noted that they once contributed to half of the world's GDP and had little history of conflict.

Looking ahead, Modi expressed India's desire to maintain strong ties with China. "Differences between neighbors are natural, and occasional disagreements are also natural.



do not escalate into disputes. We prioritize dialogue over discord," he said. Modi acknowledged that the 2020 border standoff had strained relations, but emphasized that efforts are underway to rebuild trust.

On relations with Pakistan, Modi reflected on his previous attempts to foster peace, including his invitation to Pakistan at his 2014 swearing-in ceremony. He said, "The biggest breakthrough was inviting Pakistan, but the results were disappointing." Modi criticized Our aim is to ensure that these differences Pakistan for continuing to pursue conflict

instead of peace and harmony, despite the heavy emotional toll of the Partition on India. He pointed to Pakistan's role in global terrorism, particularly its involvement in the 9/11 attacks, as a source of global instability.

Modi urged Pakistan to abandon its policy of state-sponsored terrorism, stating that such actions were harming both India and the world. He expressed hope that Pakistan would eventually choose peace and that its people, too, were frustrated with the ongoing cycle of violence.

Ukraine Appoints Major General Andrii Hnatov as New Chief of General Staff TPN Correspondent | Kyiv

Ukrainian President Volodymyr Zelensky has appointed Major General Andrii Hnatov as the new Chief of the General Staff of the Ukrainian Armed Forces, replacing Lieutenant General Anatolii Barhylevych. The decision, announced through decrees published on the presidential website, did not specify the reasons behind the leadership change.

Defense Minister Rustem Umerov confirmed the reshuffle, emphasizing that the move was aimed at improving the combat effectiveness of the armed forces. Umerov noted that the promotion of Hnatov, which he recommended, is part of Ukraine's broader efforts to transform its military. Hnatov brings over 27 years of military experience to the position, having previously commanded various units, including a marine brigade, Operational Command East, and the Joint Forces of the Ukrainian Armed Forces.

As part of the restructuring, Barhylevych has been appointed chief inspector of the Ministry of Defence. His new role will focus on ensuring compliance with military standards and reinforcing discipline within the Ukrainian military. Barhylevych had served as Chief of the General Staff since February 2024.

NASA has confirmed the return date for astronauts Sunita Williams and Butch Wilmore, who have spent an extended mission aboard the International Space Station (ISS). The pair, along with fellow astronauts Nick Hague and Russian cosmonaut Aleksandr Gorbunov, will return to Earth in mid-March aboard a SpaceX capsule.

Williams and Wilmore were originally scheduled for a brief mission lasting about a week when they launched in June 2024 aboard Boeing's first astronaut flight. However, due to several issues with the Boeing Starliner capsule, which delayed their scheduled return, they ended up spending nearly nine months in space. The capsule had encountered multiple technical problems, forcing NASA to leave

The planned return is set for mid-March. After some additional delays, including extensive repairs to their replacement capsule's batteries, Williams, Wilmore, and their fellow astronauts will undock from the ISS on Tuesday morning and splash down off Florida's coast later that evening. Weather permitting, their return will conclude an extended and challenging mission aboard the space station, with 11 astronauts currently aboard the orbiting laboratory.

"Lack Of Trust": Israel's Netanyahu Seeks **To Fire Internal Security Agency Chief**

Prime Minister Benjamin Netanyahu announced on Sunday, March 17, 2025, that he intends to seek the dismissal of Ronen Bar, the head of Israel's internal security agency, Shin Bet. Netanyahu's decision follows weeks of public disputes between the two, especially after the Hamas attack on October 7, 2023, which triggered the ongoing war in Gaza. Netanyahu criticized Bar's leadership and accused him of failing to prevent the attack, which resulted in over 1,200 Israeli deaths.

In a video statement, Netanyahu explained that the lack of trust between him and Bar had led to the decision, stating that the Shin Bet's leadership needed to be restored in order to meet Israel's war objectives and prevent further disaster. He claimed that Bar's actions, including alleged media leaks, had obstructed necessary reforms within the agency.

However, Bar has rejected the notion that his dismissal is tied to the failures surrounding the October attack. He argued that Netanya-

India's Wholesale Inflation Rises to 2.38% in February, Food Prices Ease



India's wholesale inflation. based on the wholesale price index (WPI), rose to 2.38% in February, slightly up from 2.31% in January, according to provisional data released by the Union Ministry of Commerce on Monday. The increase in inflation was driven by a slower pace of decline in fuel and power prices and a rise in the prices of manufactured products.

The WPI inflation in February was marginally higher than the 2.36% predicted by economists in a Reuters poll.

Food Prices Show Moderate Increase Food prices, a major contributor to the overall inflation, increased by 5.94% annually in February, although this was a decrease compared to December's 8.85% and January's 7.47% rise. Within the food category, Manufactured Products and

cereal prices rose by 6.77% in February, a slight decline from January's 7.33%. Meanwhile, vegetable prices fell by 5.80%, following an 8.35% surge in January. However, the prices of onions and fruits continued to rise.

Despite the softer rise in food prices, they have remained elevated for over a year, largely due to uneven monsoon rains between November 2023 and June 2024.

Sonal Badhan, economist at the Bank of Baroda, noted that food inflation softened, helped by a broad-based slowdown. "The vegetable inflation index eased the most, followed by food grain inflation and inflation for protein-based items like milk, eggs, meat, and fish," she explained.

Fuel Prices Manufactured product prices, which account for about 64% of the WPI, rose by 2.86% year-on-year in February, up from 2.51% in January. The prices of fuel and power fell by 0.71%, a smaller decline compared to January's 2.57% drop.

Rahul Agrawal, senior economist at ICRA Ltd., said that the overall uptick in wholesale inflation was primarily driven by non-food items. He added that the cooling in food inflation was offset by the narrowing deflation in fuel and power and an increase in core WPI inflation, which reached a 24-month high of 1.3%.

Looking ahead, experts predict volatility in commodity prices due to factors like the trade war and uncertainty surrounding US Federal Reserve rate cuts.

The Port-Free, But Apple Scrapped the Idea: Mark Gurman



The iPhone 17 series has been a topic of extensive speculation, with rumors suggesting the lineup will include the iPhone 17, iPhone 17 Air (or iPhone 17 Slim), iPhone 17 Pro, and iPhone 17 Pro Max, with an expected launch in the second quarter of this year. Among these, the iPhone 17 Air was slated to be Apple's thinnest iPhone yet, potentially replacing the Plus variant in the lineup.

Bloomberg's Mark Gurman has revealed new details about the iPhone 17 Air, including an ambitious plan that Apple initially considered. According to Gurman's weekly Power On newsletter, Apple originally planned to make the iPhone 17 Air "Apple's first completely port-free iPhone." The device would have relied on wireless charging and cloud-based data syncing, eliminating the traditional charging ports altogether. This move was intended to pave the way for even slimmer models in the future, with a sleek, minimalist design that further pushed the limits of device thinness. However, Apple reportedly scrapped this plan to avoid potential regulatory issues, particularly from the European Union (EU), which has recently mandated that tech companies like Apple adopt the USB Type-C charging standard. Apple's decision was likely influenced by the need to comply with the EU's regulations and maintain its broad consumer appeal.

The iPhone 17 Air's thin design would have required a thinner battery, which could have compromised battery life. To avoid this, Apple instructed engineers to redesign key components, including the display and silicon, to optimize efficiency while maintaining performance.

Expected Specifications: The iPhone 17 Air is expected to feature a 9.5mm thick profile, including the 4mm camera bump. It may offer a 6.6-inch OLED display with a 120Hz ProMotion refresh rate and Dynamic Island. The device could house a 24MP front camera, a 48MP rear camera, and be made with a titanium frame. It may also include Apple's first 5G modem and Wi-Fi chip. Rumored pricing is between \$1,299 and \$1,500.

Instead, all Alexa voice recordings will be sent to Amazon's cloud for processing, as the company expands Alexa's capabilities with generative AI features. This change affects all Echo devices such as smart speakers and displays. In an email to users who had previously enabled the 'Do Not Send Voice Recordings' option, Amazon explained that on-device processing is being discontinued to enable the new AI-driven features that require the processing power of Amazon's secure cloud. The company emphasized that Alexa voice requests will remain encrypted during transmission to the cloud, where they are processed under security protections. Although voice recordings will still be deleted automatically after processing, the new policy raises privacy concerns. Many users may be uncomfortable with Amazon having access to their voice data, especially in the context of

in-home devices that can listen continuously. Amazon assures users that privacy controls will still be available through the Alexa Privacy dashboard, where they can manage how their data is handled, including the option to prevent their voice recordings from being stored at all. Amazon also announced the upcoming launch of Alexa+, a subscription-based, generative AI version of Alexa, which will include advanced features like Alexa Voice ID. This feature will allow Alexa to recognize individual users based on their voice, and share personalized content like calendar events and music. However, Amazon clarified that Voice ID may not function if users choose not to save voice recordings.
