Chaos in Karnataka Assembly Over CM Siddaramaiah's Remarks on RSS

Speaker expunges CM's remarks and BJP's counter statements

The Karnataka Legislative Assembly descended into chaos on Monday after Chief Minister Siddaramaiah made remarks against the RSS while responding to the Governor's address. Opposition BJP legislators strongly objected, demanding that the comments be removed from records. Speaker UT Khader eventually expunged both Siddaramaiah's remarks and BJP's counterstatements to restore order.

Siddaramaiah claimed that the state's law and order situation had improved compared to the previous BJP government. He presented statistics showing a decline in crimes, including a drop in narcotics cases from 6,406 (2022-23) to 4,188 (till February 2025). He also highlighted reductions in murder, robbery, and atrocities against SC/STs. However, his comments against the RSS sparked outrage, leading to slogans Prime Minister Sardar Vallabhbhai warnings from the Speaker.

and disruptions from BJP MLAs. Leader of Opposition R. Ashoka insisted that the CM withdraw his remarks, emphasizing that even the Prime Minister and Home Minister have RSS backgrounds. Kannada Actress Ranya Rao's **Key Role in Gold Smuggling -DRI Probe Reveals**

The Directorate of Revenue Intelligence (DRI) officials investigating a large-scale gold smuggling racket have identified Kannada actress Ranya Rao as a key player in the illegal trade. Reports indicate that she has been involved in smuggling activities for several years, with crucial details emerging from the ongoing probe. Despite her claims of being falsely implicated, officials have uncovered evidence pointing to her active participation. Another accused, hotelier Tarun Raj, has been iden-

tified as her close associate. Investigations revealed that the duo co-founded Vira Diamond Trading LLC in Dubai in 2023 and have been business partners since then.

Authorities disclosed that Ranya Rao and Tarun Raj maintained strong ties with prominent gold

Speaking in response to an adjournment motion, he stated that Karnataka's crime rate remains lower than that of states like Uttar Pradesh, Rajasthan, and Madhya Pradesh due to strict measures taken by the government.

The Karnataka Legislative Assembly witnessed a tense atmosphere as ruling and opposition members clashed over the alleged diversion of Scheduled Caste Sub-Plan (SCSP) and Tribal Sub-Plan (TSP) funds for the state's guarantee schemes. The situation escalated during Chief Minister Siddaramaiah's reply to the Governor's address at Vidhana Soudha, prompting Speaker UT Khader to issue a stern warning to the Opposition.

As BJP legislators vocally protested, Speaker Khader cautioned them against creating a ruckus, stating there is a limit to everything. He urged them to either sit and listen or leave the House. However, when BJP MLA Harish Poonja continued to disregard instructions and refused to sit in his designated chair, the Speaker firmly asked him to "get out." This remark led to further chaos, with opposition members protesting against the Speaker's language.

Senior BJP MLA CC Patil objected to the Speaker's comments, arguing that no presiding officer had ever spoken in such a manner to members of the House. He also demanded that the Speaker's words be removed from official records, calling them unparliamentary.

Despite the uproar, Speaker Khader maintained his stand, reiterating that order must be maintained in the Assembly. The ruling party members backed his stance, while opposition leaders continued to express dissatisfaction over the handling of the debate.

The controversy arose when BJP leaders questioned the alleged misallocation of SCSP/TSP funds. The debate intensified as CM Siddaramaiah defended the government's actions, leading to disruptions and verbal clashes.

The Speaker's strong intervention and warning have now sparked discussions over parliamentary decorum and the conduct of legislative proceedings in Karna-

Karnataka Govt Introduces **Muslim Quota in Contracts**

- 4% reservation for Muslims in tenders under new Bill

The Karnataka government, led by Chief Minister Siddaramaiah, introduced a Bill in the Assembly on Tuesday to provide a 4% reservation for Muslims in government tenders, citing efforts to address unemployment. The move, however, has sparked strong opposition from the BJP, which has termed it "minority appeasement" and an "unconstitutional misadventure." The party has

announced plans to challenge the Bill in court.

The Karnataka Transparency in Public Procurements (KTPP) Bill, approved by the Cabinet last week, grants a 4% quota for Muslims classified under Category-2B of Other Backward Classes (OBC). Currently, SC/STs have a 24% reservation in construction contracts up to ₹1 crore—17.15% for Scheduled Castes and 6.95% for Scheduled Tribes. The Bill proposes increasing this limit to ₹2 crore. Additionally, OBCs in Category-1 (4%) and Category-2A (15%) already have reservations in contracts up to ₹1 crore.

The Bill extends the reservation structure to include 4% for Muslims, 4% for Category-1, and 15% for Category-2A in government tenders for procuring goods and services up to ₹1 crore. This move aligns with the announcements made in Siddaramaiah's 2025-26 Budget. The government argues that these amendments are essential to implementing Budget propos-

als and addressing unemployment.

The BJP, however, argues that religion-based reservation is unconstitutional. It points out that the previous BJP government, led by Basavaraj Bommai, scrapped the 4% Muslim quota and moved the community to the 10% Economically Weaker Section (EWS) category—a decision currently pending before the Supreme Court.

BJP MP Tejasvi Surya criticized the move, citing Dr. B.R. Ambedkar's opposition to religion-based reservations. Meanwhile, IT/BT Minister Priyank Kharge defended the government, stating that the reservation is merely an extension of existing provisions and does not constitute a special favor for Muslims.

With the BJP set to challenge the Bill in court, the issue is likely to become a major political flashpoint in



Karnataka Govt Proposes Special **Court for Fake Medicine Cases**

The Karnataka government plans to establish a special court to handle cases related to the supply of fake medicines, Health and Family Welfare Minister Dinesh Gundu Rao informed the Legislative Council on Monday. He expressed concerns that judgments in such cases are being delayed, allowing offenders to escape with minimal consequences.

Responding to a query from Congress MLC S Ravi, Rao criticized the current judicial process, stating that accused individuals merely spend a few hours in court as their only punishment. He emphasized that the government is ensuring companies supplying fake medicines face severe financial penalties. Additionally, the government is working on a drug recall policy to further impact fraudulent suppliers and manufacturers.

According to data presented in the House, 20 cases have been registered against fake medicine suppliers over the past three years. However, Rao expressed frustration over the Karnataka Administrative Tribunal (KAT), which has frequently granted stays in such cases. He cited a recent instance where doctors deputed to the Food Safety Department were repatriated to hospitals, but KAT issued a stay, stating the transfers occurred mid-year.

The minister affirmed that steps would be taken to



vacate such stays, stressing that these doctors are needed in hospitals and do not necessarily have to serve as food safety officers. In response to a question by JD(S) MLC T A Saravana, Rao revealed that 27 doctors had been working as food safety officers on deputation.

With the government pushing for stricter measures, the proposed special court is expected to expedite trials and strengthen action against fake medicine suppliers.

Karnataka HC Upholds Microfin Law, Calls It Protective Shield TPN Correspondent | Ben-

The Karnataka High Court upheld the constitutional validity of the Karnataka Micro Loan and Small Loan (Prevention of Coercive Actions) Ordinance, 2025, dismissing a petition filed by the Karnataka Hire Purchase Association.

Justice M Nagaprasanna ruled that the ordinance does not interfere with secured transactions undertaken by regulated financial entities. Instead, it provides a protective shield for borrowers with an annual income of ₹3 lakh or less, preventing coercive

recovery methods used by unsecured microfinance lenders.

The petitioners, motor vehicle financiers operating through hypothecation, hire purchase, and leasing models, argued that the ordinance had stripped them of their rights by mandating the immediate release of all



hypothecations and mortgages from its promulgation date. They claimed the law jeopardized their business by prohibiting future collateralization. However, the court rejected these claims, stating that the ordinance was designed to protect vulnerable groups, including farmers, women,

and workers, from exploitative moneylenders and microfinance entities known for harsh recovery tactics. The court emphasized that legislative records and public knowledge highlight instances where such practices have led to extreme distress and even suicides among debt-ridden borrowers.

Bengaluru-Chennai Expressway faces delays, now

set for 2026 completion

much-anticipated Bengaluru-Chennai Expressway, which aims to enhance connectivity between the two major cities, is now expected to be fully operational by June 2026. This marks a significant delay from the previously announced deadline of August 2025, with construction challenges being cited as the primary reason for the setback, according to the National Highways Authority of India (NHAI).

Spanning 262 km, the expressway has seen only 71 km completed so far,

while the remaining sections continue to face hur-

The Karnataka segment of the highway was completed and informally opened for traffic in December 2024, but work in Andhra Pradesh and Tamil Nadu remains sluggish. Responding to a query from Rajya Sabha MP Lahar Singh Siroya, Union Minister for Road Transport Nitin Gadkari confirmed that the remaining stretches are now scheduled for completion by mid-2026.

Last month, the 68km stretch in Karnataka was made accessible for vehicular traffic, though an official inauguration is still pending. The expressway, which extends through Andhra Pradesh and Tamil Nadu before reaching Sriperumbudur near Chennai, has been designed for high-speed travel with a maximum speed limit of 120 kmph. It is touted as South India's first greenfield expressway and is expected to reduce travel time between Bengaluru and Chennai from seven hours to just three. The ₹17,900-crore

In a recent development, the NHAI has banned two-wheelers from the expressway following a tragic accident that claimed four lives, including that of a two-yearold girl.

Currently, motorists exit the expressway via a village road to reach Mulbagal and the Andhra Pradesh border. With the extended timeline, authorities are hopeful that the expressway will be fully operational by mid-2026, significantly improving regional connectivity and economic activity.



Bengaluru man loses ₹1.4 lakh in 'Kumbh Mela crisis' scam

Bengaluru: A Bengaluru resident was defrauded of ₹1.4 lakh by a scammer posing as a BBMP engineer in distress, who claimed to be stranded at the Kumbh Mela in Prayagraj. The fraudster convinced the victim to transfer money for booking flight tickets, promising repayment upon returning to Benga-

According to reports, the 54-year-old victim, a private firm employee from Banashankari, became involved in the scam after his friend received a call from an un-

known number on March 5. The caller, speaking in Hindi, introduced himself as Venkatesh, a BBMP engineer, and claimed that he and his family had missed their flight back home. Since the victim's friend struggled to understand Hindi, he took over the conversation.

The scammer insisted on urgent financial help, and after confirming that his friend knew a BBMP engineer by that name, the victim transferred ₹1.4 lakh in two transactions through a digital payment

The fraud came to



light when the victim's attempts to reach the caller the following day went unanswered. As days passed without any response, he realized he had been duped and filed a police complaint. Authorities

are now tracing the scammer based on the transaction details.

A senior officer investigating the case pointed out that the victim should have been cautious, as a genuine BBMP official

from Bengaluru would likely speak Kannada instead of Hindi. The incident adds to the growing number of online and phone-based scams targeting unsuspecting individuals.

Earlier in January, a 70-year-old Bengaluru resident lost nearly ₹89 lakh in a sophisticated cyber fraud that involved criminals posing as law enforcement officials. The case highlights the increasing prevalence of digital fraud in the city, prompting police to urge citizens to be vigilant against such scams.

Land acquisition troubles stall Bengaluru Business Corridor-2 project

Bengaluru: The ambitious 52-km Bengaluru Business Corridor-2 (BBC-2), formerly known as Peripheral Ring Road-2, is facing significant hurdles due to land acquisition issues. The Bangalore Development Authority (BDA) has encountered opposition from landowners over approximately 250 acres, creating obstacles for the project, which requires a total of 1,400 acres.

BBC-2 is designed to enhance connectivity by linking Hosur Road to Tumakuru Road via Bannerghatta Road, Kanakapura Road, Mysuru Road, and Magadi Road. However,

the current land dispute stems from BDA's conflicting alignments issued in 2005 and 2006. Initially, the project was set to connect Madavara with Magadi Road in 2005, and a preliminary notification was issued for land acquisition. However, concerns over potential traffic congestion on Tumakuru Road led the authorities to revise the alignment in 2006, shifting the route to pass through Madanayakanahalli instead.

The problem now arises from the fact that the 2006 realignment left out certain land parcels from acquisition, prompting landowners to construct



homes and commercial buildings on those plots. Many of these structures now fall within the newly proposed acquisition area, leading to strong protests from residents who are shocked by the fresh notices from BDA. Officials, however, argue that sev-

eral of these buildings are illegal constructions.

A BDA official explained that the preliminary notification from 2005 was never officially canceled, as doing so would require denotification, which could lead to further legal complications. Meanwhile, land acquisition officers are under scrutiny for issuing notices for both the 2005 and 2006 alignments, causing confusion among affected landowners.

The dispute has already led to tensions, with around 200 landowners storming the BDA's Kengeri office two months ago, protesting against the disconnection of electricity to their homes. BDA had reportedly asked Bescom to cut off power supply to houses situated along the BBC-2 alignment, labeling them as illegal constructions. With tenders for Bengaluru Business Corridor-1 (BBC-1) yet to be floated due to ongoing compensation disputes, the BBC-2 project now faces further uncertainty, delaying its progress indefi-

KDA urges BMRCL to prioritize Kannadiga recruitment

Congress MLA KM Shivalingegowda, known for his well-prepared speeches in the Legislative Assembly, strongly criticized the Union government's tax distribution policy. Notification After Kannada Language Controversy BMRCL withdraws job notification amid backlash

The Bangalore Metro Rail Corporation Limited (BMRCL) has withdrawn its recruitment notification for 50 loco pilot positions following criticism from pro-Kannada organizations and activists. The controversy stemmed from the relaxation of Kannada language norms, which allowed non-Kannada speakers to apply, provided they learned the language within a year.

Karnataka Deputy Chief Minister D.K. Shivakumar took to social media to confirm the decision, stating that he had directed the BMRCL to review its hiring process and ensure it aligns with state policies prioritizing Kannadigas.

"Our government stands by the people of Karnataka. The recruitment for Train Operators (Loco Pilots) requiring a minimum of three years' experience has been withdrawn. I had instructed BMRCL to review the hiring process and ensure state policies are followed, securing rightful opportunities for Kannadigas," Shivakumar posted on X.

The March 12 notification had sparked protests, with Kannada Development Authority Chairman Purushothama Bilimale and local groups arguing



that it disadvantaged native job seekers in favor of candidates from other states. BMRCL is now expected to revise the recruitment norms to align with Karnataka's employment policies, ensuring fair opportunities for local candidates.

Anganwadi Workers Protest Outside Kerala

Following the ongoing protest by Accredited Social Health Activist (ASHA) workers, a section of Anganwadi workers on Tuesday launched an indefinite protest outside the Secretariat, demanding a hike in their minimum wages and post-retirement benefits.

ASHA workers have been demonstrating for over 36 days, demanding post-retirement benefits and an increase in their honorarium. They alleged that those who retired after working for

over 40 years do not receive any pension, despite a deduction of ₹500 from their monthly wages for retirement benefits. The workers also claimed they often have to cover Anganwadi expenses from their own pockets.

On Monday, ASHA workers intensified their protest by blocking the Secretariat's main gate till evening. They also announced an indefinite hunger strike from March 20, with three of their leaders participating as part of the third phase of their agitation.

Although the protesting

workers acknowledged the state government's recent order relaxing 10 eligibility criteria for receiving an honorarium, they stated that their protest would continue until their major demands were met. The Kerala government has cited the lack of financial support from the central government under the National Health Mission (NHM) for 2023-24 as a reason for the delay in meeting their demands. However, the central government refuted these claims, stating that it has provided the required funds but is awaiting Ker-

ala's utilisation certificate before releasing additional payments.

Union Health Minister J. P. Nadda recently informed Parliament that the Mission Steering Group of the NHM has decided to increase incentives for ASHA workers. However, the protesting workers insist that immediate action is necessary to address their financial struggles.The indefinite protests by Anganwadi and ASHA workers continue, highlighting the growing unrest among grassroots health and childcare workers in Kerala.



Kannur Airport Land Acquisition Progress

He emphasized that necessary steps are being taken to resolve any issues related to the acquisition.Responding to submissions by Leader of the Opposition V.D. Satheesan and K.V. Sumesh in the Assembly, Mr. Vijayan acknowledged the urgency of the matter. He noted that and Keezhalloor villag-

the issue has been consistently raised by Mattanur MLA K.K. Shailaja. He stated that in the first phase, 1,113.33 acres of land had already been acquired and handed over to Kannur International Airport Limited (KIAL). The second phase, involving the acquisition of 804.37 acres, is currently underway.In addition to the airport expansion, a new industrial park is planned as part of the project. Of the 1,970.05 hectares required for this, 21.81 hectares from Kolari



es have already been acquired and handed over to the Kerala Industrial Infrastructure Development Corporation (KINFRA). Further, funds have been allocated for acquiring an additional 202.34 hectares in Keezhoor and Pattanur villages, and necessary steps are being taken to complete the process.

For the proposed extension of the airport's

runway to 4,000 meters, 245.33 acres of land in Keezhalloor village have been notified. A ₹900 crore proposal, including ₹750 crore for runway extension and ₹150 crore for rehabilitation, has been submitted by the Kannur District Collector and is currently under government review. The Government Engineering College, Kozhikode, is conducting a valuation of buildings in the affected areas. So far, 39 structures have been assessed, with ₹3,70,466 allocated for the process. The valuation of the remaining 162 structures is pending. Since there is no provision for land allotment in exchange for evictions, the District Collector has been instructed to propose a special rehabilitation package.

Administrative proval has been granted to acquire the properties of 14 displaced families, and the District Collector has been directed to submit a detailed report.The Chief Minister reiterated that all necessary actions will be taken within a set timeframe to ensure the smooth progress of the Kannur airport development project.

Two Students Die After **Consuming Contaminated**

The death toll in the Malavalli food poisoning incident has risen to two as another student succumbed while undergoing treatment at a private hospital in Mysuru. The latest victim, identified as Nami Banthai, was among the students who fell ill after consuming contaminated food during Holi celebrations.

Two days ago, a 13-yearold student named Kerlong also died due to the same incident. Both students hailed from Meghalaya. In total, around 40 students suffered food poisoning after eating food prepared by a hotel and distributed by a businessman. Five students in critical condition were admitted to a private hospital for advanced treat-

Following the incident,



authorities intensified the investigation. The hotel that supplied the contaminated food has been sealed, and multiple arrests have been made, including the hotel owner, the hostel warder, and the school management secretary.

Officials have emphasized the need for stricter food safety regulations in educational institutions. The tragedy has raised concerns about the quality of food provided to students, prompting calls for regular inspections and strict action against viola-

Sri Lankan Navy Arrests Three Indian Fishermen

The Sri Lankan Navy arrested three Indian fishermen from Tamil Nadu's Ramanathapuram district on Tuesday for allegedly crossing the International Maritime Boundary Line (IMBL). Their mechanized fishing boat was also

seized during the operation.

According to sources, the fishermen, who are residents of Thangachimadam, set sail from Rameswaram on Monday night. In the early hours of Tuesday, while patrolling near Neduntheevu (Delft Island), the Sri Lankan

found it to have allegedly trespassed into their territorial waters. As a result, the fishermen were taken into custody, and their boat was confiscated. This incident is part of a series of ongoing arrests, as Indian fishermen frequently get caught crossing into Sri Lankan waters. The absence of clearly marked maritime boundaries and the depletion of fish stocks in Indian waters often force fishermen to venture further into the sea, sometimes unknowingly entering Sri Lankan territory.

Fishermen's associations in Tamil Nadu have strongly condemned the arrest and urged the In-

dian government to intervene diplomatically. They have reiterated their demand for a permanent solution to the issue, which has affected the livelihood of thousands of fishermen. Many have called for negotiations between India and Sri Lanka to establish a sustainable fishing agreement, ensuring that Indian fishermen do not face repeated arrests and boat seizures. Tamil Nadu authorities are closely monitoring the situation and are expected to take necessary steps to secure the release of the detained fishermen. Political leaders from the state have also voiced their concerns, urging the central government to engage in

discussions with Sri Lankan officials to prevent such incidents in the future. Meanwhile, the families of the arrested fishermen are in distress, fearing for their safety. They have appealed to the government for immediate action to bring their loved ones back home. This is not the first time Indian fishermen have been detained by the Sri Lankan Navy. Similar incidents have occurred frequently, leading to strained relations between the fishing communities of both countries. Fishermen are now demanding that the government take stronger measures to protect their rights and ensure their safety at sea.

Security Concerns and Political Challenges

Law and order remain a major concern, with a series of bomb and grenade attacks adding to the state's unrest. Ensuring security while maintaining political stability will be a key test for the government moving forward.

Meanwhile, AAP's national convener, Arvind Kejriwal, has increased his focus on Punjab following the party's significant electoral setback in Delhi. Both Kejriwal and Mann are aware that any misstep now could hurt their long-term prospects. With two more years left in its term, the AAP government faces mounting challenges. Its ability to deliver on governance, fight corruption, and restore public confidence will determine its fate in the next elections.

The Fight for Federalism and Telugu Language Representation

Will begin linking Voter ID card with Aadhaar: EC

- UIDAI and EC's technical experts to start consultations soon
- · Govt says linking is voluntary, no deletion of names for non-linking

The Election Commission (EC) on Tuesday announced that the linkage of voter cards with Aadhaar would be carried out in accordance with prevailing laws and Supreme Court directions. The poll body also confirmed that technical consultations between UIDAI and its experts would commence soon for the exercise.

The EC held a high-level meeting with Union Home Secretary, Legislative Secretary from the Law Ministry, Meity Secretary, and the UIDAI CEO to discuss the process of voter card-Aadhaar seeding. The move comes as part of efforts to streamline voter authentication while ensuring compliance with legal provisions.

The poll authority clarified that while Aadhaar establishes a person's identity, voting and in line with the Supreme Court judgrights can only be granted to Indian citizens under Article 326 of the Constitution. "The linking of elector photo identity card (EPIC) with Aadhaar will be done only as per the provisions of Article 326 of the Constitution, sections 23(4), 23(5), and 23(6) of their Aadhaar details. The law, under the the Representation of the People Act, 1950, Election Laws (Amendment) Act, 2021, al-



ment of 2023," the EC stated.

The government has reiterated that the Aadhaar-voter ID linkage is a voluntary process and no voter's name will be deleted from the electoral rolls for not linking lows electoral registration officers to seek Aadhaar details from voters to establish identity, but only on a voluntary basis. While there is no set deadline for the linkage, the government has assured that the process-driven exercise will be carried out in a systematic manner without any mandatory enforcement.

Sunita Williams and fellow astronaut Butch Wilmore flew to the ISS on June 5, 2023, aboard Boeing's Starliner spacecraft for what was initially planned as a short-duration test mission. However, due to propulsion issues, the spacecraft was deemed unfit to bring them back, leading to an uncrewed return of the vehicle.

NASA reassigned the astronauts to the Crew-9 mission, reducing the incoming crew size to accommodate them on the ISS. Their long-awaited homecoming was made possible after Crew-10 docked with the station on Sunday, allowing them to return along with NASA astronaut Nick Hague and Roscosmos cosmonaut Aleksandr Gorbunov. The journey back to Earth marks the end of an unexpectedly prolonged stay for Williams, who has now completed her third mission in space.

Home Ministry Says No Central Data on Maha Kumbh Stampede Deaths

Six weeks after the deadly stampede at the Maha Kumbh in Uttar Pradesh's Prayagraj, the Union Home Ministry informed the Lok Sabha that it has not conducted an inquiry into the incident and does not maintain data on the number of casualties. Responding to a question from Congress MPs KC Venugopal and Kirsan Namdeo, Junior Home Minister Nityanand Rai stated that handling such disasters and providing financial aid to affected families falls under the purview of the respective state governments.

"State governments are competent to deal with such situations. No such data is maintained centrally," Rai said, clarifying that 'public order' and 'police' are state subjects. He added that organizing religious congregations and crowd management are closely linked to 'public order,' making it the responsibility of the state government to investigate and respond to

The stampede, which occurred on January



60 others injured, according to Vaibhav Krishna, the senior Uttar Pradesh police officer in charge of security during the event.

Venugopal and Namdeo had sought details on the exact number of casualties and the steps taken to probe the cause of the stampede. In response, Rai pointed out that the National Disaster Management Authority and the Bureau of Police Research and Development had issued detailed crowd management guidelines, which were circulated to all states. The Ministry of Home Affairs also advised all states and Union Territories to create their own Standard Operating Procedures (SOPs) based on 29, resulted in at least 30 deaths and left these templates.

The tragic incident has sparked a major political row, with the opposition, led by Samajwadi Party chief and former UP Chief Minister Akhilesh Yadav, attacking the central government. Yadav criticized the administration for its handling of the situation, citing the massive 300-km-long traffic jam that left thousands of devotees stranded.

"Is this 'Viksit Bharat'? The government cannot even manage traffic. What is the point of going to the Moon when we cannot settle issues on Earth?" Yadav questioned in Parliament.

West Bengal Chief Minister Mamata Banerjee also joined the criticism, referring to the event as 'Mrityu Kumbh' (Death Kumbh) and demanding clarity on the actual number of casualties.

The issue was reignited today when Prime Minister Narendra Modi spoke about the success of the Maha Kumbh, which took place between January 13 and February 26. His speech, however, made no mention of the stampede or the people who lost their lives, prompting strong reactions from the opposition.



Six SC Judges to Visit **Manipur Relief Camps, Meet Displaced People**

Six Supreme Court judges will visit relief camps in Manipur on March 22 to assess the condition of internally displaced people and strengthen legal and humanitarian support in the violence-hit state, the National Legal Services Authority (NALSA) announced.

The visiting judges include Justice BR Gavai, who also serves as NALSA's Executive Chairman, along with Justices Surva Kant, Vikram Nath, MM Sundresh, KV Viswanathan, and N Kotiswar Singh. Their visit comes nearly two years after the sectarian violence of May 3, 2023, which resulted in hundreds of deaths and the displacement of over 50,000 people. Many of them continue to live in relief camps, highlighting the ongoing need for legal and humanitarian aid.

During the visit, Justice Gavai will virtually inaugurate legal services and medical camps in all districts of Manipur and open legal aid clinics in Imphal East, Imphal West, and Ukhrul. The judges will also distribute relief materials to displaced in-

NALSA stated that these legal service camps aim to connect the displaced population with government welfare programs, ensuring access to crucial benefits such as healthcare, pensions, employment schemes, and the reconstruction of lost identity documents. Additionally, each participating state department will outline at least five key schemes tailored to support those affected by the crisis.

A team of 25 specialized doctors from Chennai will also set up medical camps in all relief centers, providing sustained healthcare support for six days. They will offer treatment and essential medicines to displaced families.

NALSA has played a crucial role in assisting communities affected by the Manipur violence, having set up 273 special legal aid clinics in relief camps. These clinics have helped people regain access to government benefits, retrieve lost documents, and receive medical assistance.

The upcoming visit by the Supreme Court judges underscores NALSA's commitment to justice, particularly for marginalized and vulnerable communities. By bridging the gap between legal rights and accessibility, NALSA aims to ensure that every displaced person receives the necessary support to rebuild their lives with dignity.

The visit by the Supreme Court judges coincides with the duodecennial event of the Manipur High Court on March 22.

"Uddhav Thackeray Bowed **Before PM Modi": Eknath Shinde's Big Claim**

Maharashtra Deputy Chief Minister Eknath Shinde has claimed that former Chief Minister Uddhav Thackeray had "bowed down" before Prime Minister Narendra Modi, seeking relief from investigating agencies. Speaking in the Legislative Council, Shinde alleged that Thackeray had traveled to Delhi, expressed willingness to form a coalition government with the BJP, but later changed his stance upon returning to Maharashtra.

Shinde further accused Thackeray's Shiv Sena UBT of forsaking the ideals of Chhatrapati Shivaji Maharaj and embracing what he called the "Aurangzebi ideology" by joining hands with Congress. He emphasized that his faction had "freed the bow and arrow," referring to the Shiv Sena symbol, which had come under dispute following the party split.

"We have never been tempted by power and position. Our priority has always been addressing the issues of the people who entrusted us with responsibility," Shinde asserted.

His remarks come amid renewed political tensions after Shiv Sena UBT MP Sanjay Raut claimed that Shinde himself had once sought to join the Congress. "I know what was happening. If Ahmed Patel were alive today, he could confirm it. You can ask Prithviraj Chavan about it," Raut had said.

The controversy follows Maharashtra Congress leader Nana Patole's recent remarks during Holi celebrations, where he suggested that Shinde and Deputy Chief Minister Ajit Pawar could switch to the opposition in exchange for a rotational chief ministerial post.

Ukrainian President Volodymyr Zelenskyy has arrived in Helsinki for an official visit to Finland, ahead of a key meeting with Finnish President Alexander Stubb on Wednesday. The two leaders are set to discuss Finland's continued support for Ukraine in the wake of Russia's ongoing invasion and efforts to end the conflict. The discussions

will include potential measures to advance peace and strengthen cooperation, particularly in defense, with a focus on the defense industry.

The visit comes as US President Donald Trump is engaged in talks with Russian President Vladimir Putin, attempting to negotiate a ceasefire and a more permanent resolution to the three-year-long war between Russia and Ukraine.

Zelenskyy's schedule in Finland will also include discussions with other key officials, such as Finland's finance, defense, and foreign ministers, as well as a meeting with Prime Minister Petteri Orpo and parliament speaker Jussi Halla-aho. The Ukrainian president's wife, Olena Zelenska, is accompanying him on the trip and will be visiting local schools alongside Suzanne Innes-Stubb,

the wife of Finland's president.

Trump Engages in Critical Talks with Putin Over Ukraine Conflict

Trump-Putin Call On Ending Russia-Ukraine War Continues For Over 2 Hours

Nearly three weeks after a tumultuous meeting with Ukraine's President Zelensky at the White House, US President Donald Trump has reached out to Russian President Vladimir Putin in a fresh attempt to broker an end to the ongoing war in Ukraine. The phone call, which began at 10 a.m. Eastern Time, has been ongoing for over two hours, with the White House reporting that "the call is going well, and still in progress."

Both leaders are discussing potential solutions to secure a ceasefire in the Eastern European conflict, which has already claimed tens of thousands of lives and has been raging for more than three years. Trump has expressed his readiness to negotiate with Putin on terms for Russian control over certain parts of Ukraine, including the division of "certain assets," as he mentioned over the weekend.

However, the prospect of dividing up Ukrainian territory has raised concerns in Europe, particularly regarding the future of Ukraine and the risk of Moscow gaining too much leverage. European leaders are anxious that Trump, who has may concede too much to Russia without consulting Ukraine.

In the aftermath of Trump's previous Moscow's demands, firmly stating that



meeting with Zelensky, Ukraine agreed to temporarily halt military operations for 30 days and engage in dialogue with Russia. However, Putin has set stringent conditions, which Moscow insists are non-negotiable. Ukraine, in response, has demanded an "unconditional" ceasefire, with Ukraine's Foreign Minister Andriv Sybiga stressing the importance of



Russia would not accept NATO troops in Ukraine and reaffirming that any ceasefire deal would be contingent on NATO halting arms supplies to Ukraine. Putin has also stated that Russia's forces are "steadily advancing" and has made it clear that any peace deal would need to reflect these advances.

Three Earthquakes Strike Indonesia, **Causing Casualties and Damage**

On Tuesday, Indonesia was rocked by three significant earthquakes, including a 5.5-magnitude tremor that hit North Sumatra province in the morning. The other two quakes, with magnitudes of 5.7 and 5.2, struck Maluku and East Nusa Tenggara provinces earlier in the day, according to the country's Meteorology, Climatology, and Geophysics Agency.

The 5.5-magnitude earthquake in North Sumatra occurred at 5:22 a.m. local time, with its epicenter located 17 kilometers southeast of North Tapanuli Regency, at a depth of 10 kilometers. The quake resulted in one fatality and left another person injured. In addition, several houses and a road were severely damaged, making the road impassable. Sri Wahyuni Pancasilawati, head of the emergency and

logistics unit at North Sumatra's Provincial Disaster Management Agency, stated that risk assessments were ongoing.

Earlier, a 5.7-magnitude earthquake struck Maluku province at 00:32 a.m. local time, initially recorded as a



6.0 magnitude before being revised downward. Just ten minutes later, another earthquake, registering a 5.2 magnitude, hit East Nusa Tenggara province. Fortunately, no tsunami alerts were issued, as the tremors were not expected to generate large waves.

Indonesia, located along the seismically active Pacific Ring of Fire, is no stranger to frequent earthquakes. The country has 127 active volcanoes and is particularly vulnerable to earthquakes and tsunamis. The 2004 Indian Ocean tsunami, triggered by a massive 9.1-magnitude earthquake off the west coast of Sumatra, killed over 165,000 people. Similarly, a tsunami in 2006 struck the south coast of Java, killing more than 600 people.

Due to its geological setting, Indonesia remains highly susceptible to both earthquakes and tsunamis, posing ongoing risks to the archipelago's coastal communities.

Tulsi Gabbard: Trump's 'America First' Policy **Should Not Be Misunderstood as Isolation**

US Director of National Intelligence, Tulsi Gabbard, clarified on Tuesday that President Donald Trump's "America First" policy should not be interpreted as a stance of isolation. Gabbard explained that while President Trump's approach focuses on prioritizing American interests, it should not be seen as America turning inward. She drew a parallel to Prime Minister Narendra Modi's "India First" approach, as-

serting that both leaders are committed to their respective countries while fostering strong global partnerships. "It should not be misunderstood that 'America First' means America alone," Gabbard stated, adding that the US and India share a strong friendship and that the bilateral ties will continue to grow.

Reflecting on the recent meeting between Prime Minister Modi and President Trump in Washington DC, Gabbard described it as a "reconnection of two old friends" and underscored the growing cooperation between the two nations. She also praised the Raisina Dialogue as an essential platform for open discussions on global issues, providing opportunities for direct dialogue between nations on the most pressing matters.

Touching on broader geopolitical issues, Gabbard highlighted President Trump's unwavering commitment to peace and security. She reiterated that Trump's approach is centered on securing peace through strength, noting that Trump has also voiced strong support for ending ongoing conflicts, including the war in Ukraine.

The Raisina Dialogue, held from March 17-19, serves as India's premier conference on geopolitics and geoeconomics, organized by the Observer Research Foundation in partnership with the Ministry of External Affairs. Gabbard's remarks further solidified the growing collaboration between India and the US, particularly in security and intelligence-sharing.

"Stop The Killing": Families Of Hostages To Israel PM After Strike On Gaza

The families of Israeli captives held in Gaza have demanded that Prime Minister Benjamin Netanyahu intervene immediately to stop the killing and disappearance of hostages, following Israel's most deadly airstrikes on Gaza since a ceasefire began in January. The families are seeking urgent assurances regarding the safety and return of their loved ones.

In a statement, the Hostages and Missing Families Forum called for a meeting with Netanyahu, Defense Minister Yoav Gallant, and the head of the negotiation team to discuss how Israel plans to protect the hos-

tages from military actions and work toward their release. "The families of the hostages will demand: Stop the killing and disappearance of the hostages now! First, return them -- then everything else," the statement read.

The families also announced plans to protest outside Netanyahu's office in Jerusalem later on Tuesday, as their calls for meetings with key officials have so far gone unanswered. They expressed frustration, saying that government officials had ignored their pleas for a discussion, and now it appears they were planning to escalate military action, which could endanger the lives of the captives.

Israel's recent airstrikes on Gaza have been its most intense since the ceasefire on January 19, following the brutal October 2023 Hamas attack that led to the abduction of 251 Israelis. Of those taken, 58 remain in Gaza, and the Israeli military reports that 34 of the hostages are believed to have died.

The families are urging Netanyahu's government to focus on bringing the hostages back safely, asserting that their return must be prioritized before any further military escalation. The growing tension between the ongoing conflict and the efforts to secure the captives' release has left families in anguish, calling for decisive action from Israel's leadership.





Stock markets surge as bulls take charge after consolidation

After a period of consolidation, the domestic stock markets witnessed a strong rally on Tuesday, closing with significant gains. Investor sentiment turned highly positive as expectations grew that the US Federal Reserve would maintain interest rates. Additionally, positive global cues and the availability of fundamentally strong stocks at attractive prices encouraged investors to adopt a buy-on-dips strategy. The result was an unrelenting surge in benchmark indices from the opening bell to the closing session.

The BSE Sensex, which had closed at 74,169 in the previous session, opened higher at 74,608 and maintained upward momentum throughout the day. It touched an intraday high of 75,385 before settling at 75,301 with a remarkable gain of 1,131 points. Similarly, the NSE Nifty opened at 22,662, reached a high of 22,857, and ended the session at 22,834, marking an impressive increase of 325 points. The Nifty Bank index also rallied, climbing 960 points to close at 49,314.

Investor enthusiasm was evident in the broad market participation, with 2,288 stocks advancing on the NSE compared to 646 declining, while 82 stocks remained unchanged. The bullish momentum was reflected across all sectoral indices, with media and realty stocks soaring by 3%, while the auto, public sector banks, and metals sectors registered gains of over 2%. Stocks from banking, finance, and consumption segments also played a crucial role in driving the indices higher.

Among the top gainers in the Nifty50 were ICICI Bank, Larsen & Toubro, Shriram Finance, Mahindra & Mahindra, and Tata Motors, while Bajaj



Finserv, Tech Mahindra, and Bharti Airtel emerged as the day's biggest losers. The rupee strengthened by 23 paise to close at 86.56 against the US dollar, reflecting increased investor confidence. India's trade deficit in Feb drops to \$14 bn; petroleum exports to Europe shrink by 30%

India's merchandise trade deficit nar- Gold imports, another significant facrowed sharply to a three-year low of \$14.05 billion in February, according to data released by the Ministry of Commerce and Industry on Monday. This significant reduction was largely driven by a 30% decline in petroleum exports to Europe and a more than 60% drop in gold imports.

The decline in petroleum exports, which had been a major contributor to India's export growth following the Russia-Ukraine war, was particularly notable. The decrease came shortly after the imposition of sweeping US sanctions targeting Russia's oil trade in January 2025, which placed 183 Russian oil tankers under sanctions. The sanctions appear to have had a direct impact on India's petroleum export volumes to Europe, a key market. Additionally, India's petroleum imports also saw a decrease of 26%, contributing further to the reduction in the trade deficit.

tor in India's merchandise trade, fell dramatically by over 60%, further influencing the decline in the trade deficit. Gold has been a major import for India, driven by seasonal demand and cultural factors. However, lower demand for gold, coupled with rising prices, contributed to the steep drop in imports.

With the reduction in both petroleum exports and gold imports, India is likely to focus on diversifying its export base and increasing trade with emerging markets to sustain its economic growth while managing its trade balance.

Amazon Echo Users Will No Longer Have Option to Process Alexa Voice Recordings On-Device



Amazon has announced that starting March 28, Echo users will no longer have the option to process their voice commands and recordings locally on their devices. Instead, all Alexa voice recordings will be sent to Amazon's cloud for processing, as the company expands Alexa's capabilities with generative AI features. This change affects all Echo devices such as smart speakers and displays.

In an email to users who had previously enabled the 'Do Not Send Voice Recordings' option, Amazon explained that on-device processing is being discontinued to enable the new AI-driven features that require the processing power of Amazon's secure cloud. The company emphasized that Alexa voice requests will remain encrypted during transmission to the cloud, where they are processed under security protections.

Although voice recordings will still be deleted automatically after processing, the new policy raises privacy concerns. Many users may be uncomfortable with Amazon having access to their voice data, especially in the context of in-home devices that can listen continuously. Amazon assures users that privacy controls will still be available through the Alexa Privacy dashboard, where they can manage how their data is handled, including the option to prevent their voice recordings from being stored at all. Amazon also announced the upcoming launch of Alexa+, a subscription-based, generative AI version of Alexa, which will include advanced features like Alexa Voice ID. This feature will allow Alexa to recognize individual users based on their voice, and share personalized content like calendar events and music. However, Amazon clarified that Voice ID may not function if users choose not to save voice recordings.

This shift in policy is part of Amazon's ongoing push to enhance Alexa's AI capabilities but raises concerns about privacy, particularly in light of past controversies surrounding the handling of user data. Notably, Amazon has faced scrutiny over allowing employees to listen to Alexa voice recordings for training purposes and other privacy violations related to its Ring doorbell


The restaurant, which spans only eight square

US Vending Machine Goes Viral for Duplicating Keys in Minutes


