The Andhra Pradesh government, under the leadership of Chief Minister Nara Chandrababu Naidu, has presented the much-anticipated 2025-26 state budget, crossing the ₹3 lakh crore milestone for the first time in the state's history. Finance Minister

Payyavula Keshav tabled the budget in ₹3,22,359 crore, a notable increase from last year's ₹2.94 lakh crore. Agriculture and allied sectors have been allocated ₹48,340 crore, marking a substantial jump from previous years. Capital expenditure has also gone up to ₹40,635 crore, while the fiscal deficit stands at ₹79,926 crore, raising concerns about the growing debt burden.

- High Allocations, Implementation Doubts While the budget numbers are impressive, questions remain over the government's capacity to implement

Chief Minister Nara Chandrababu Naidu issued a strong caution to TDP MLAs and cadre, warning that neglecting the party would lead to collective downfall. He urged all leaders to focus on party reconstruction and work with the determination to secure victory in the next elections. He emphasized that party strengthening is a continuous process and everyone should take ownership of it. Chandrababu made these remarks at the TDLP meeting held in the Assembly Committee Hall, attended by MLAs, MLCs, and MPs. Stressing the importance of discipline, he advised MLAs to be careful with their words, warning that unnecessary statements could be exploited by the opposition. He revealed that he is regularly receiving performance reports on leaders and will soon meet with second-tier leaders and activists for direct discussions. Recalling past conspiracies, Chandrababu cited the Vivekananda Reddy murder case and the Kodi Kathi incident as examples of political plots used to damage TDP's reputation, blaming negligence in countering such conspiracies for the party's defeat in 2019. He also raised concerns about the recent fire incident at Jagan's residence in Tadepalli, pointing out the suspicious refusal to provide CCTV footage despite police requests.

### Posani Krishna Murali

Posani was interrogated at Obulavaripalle Police Station in Annamaya district until late last night. He was produced before the court at 9:30 pm, where arguments continued until 5 am. Advocate Ponnavolu Sudhakar represented Posani, strongly arguing for bail, but the court rejected the plea and ordered remand until March 13.

During the proceedings, the court made critical remarks, stating that Posani's statements towards women amount to sexual harassment under the law. Following the court's decision, Posani was transferred to Rajampet sub-jail, where he will remain until further orders.

The case is expected to attract further attention, given Posani's controversial statements and public image, with legal proceedings likely to continue in the coming days.

### **Centre Appoints Finance Secretary Tuhin Kanta Pandey** as New SEBI Chief

The Centre has appointed Finance Secretary Tuhin Kanta Pandey as the new chairman of the Securities and Exchange Board of India (SEBI) for a three-year term, a government order confirmed on Thursday. He succeeds Madhabi Puri Buch, whose tenure concludes this month. Pandey takes charge at a crucial time when SEBI is working to expand regulated financial investment options for investors while also tackling market volatility and curbing malpractice in the derivatives segment.

Appointed as Finance Secretary in September 2024, Pandey also managed the divestment department and was the longest-serving disinvestment secretary, holding the position for over five years. He oversaw the listing of Life Insurance Corporation of India (LIC), the country's largest insurer, and played a pivotal role in the government's successful sale of Air India to Tata Group.

As privatization efforts slowed, Pandey shifted focus towards enhancing value creation in state-run enterprises, ensuring better financial returns and accountability. In his recent role as Finance and Revenue Secretary from January 2025, he advocated for lower import duties on high-end motorcycles as part of India's broader efforts to move away from protectionist policies.

Pandey holds master's degrees in economics and business administration from Panjab University and the University of Birmingham. His leadership at SEBI is expected to influence regulatory strategies in India's evolving financial markets.

## **Green Energy Push Eases DISCOM Debt - Minister** Gottipati Ravi Kumar

Energy Minister Gottipati Ravi Kumar stated that the financial stress on Andhra Pradesh DISCOMs is being significantly reduced through the promotion of large-scale green energy initiatives. Virtually participating in a key meeting organized by the Union Ministry of Power in Mumbai, the Minister said that the current government is prioritizing renewable energy to ensure affordable and quality power supply.

The meeting, attended by Union Minister of State for Power Shripad Yesso Naik, Maharashtra Chief Minister Devendra Fadnavis, and power ministers from several states, focused on strategies to strengthen financially struggling DISCOMs and improve debt recovery mechanisms.

Minister Gottipati Ravi Kumar highlighted that under the leadership of Prime Minister Narendra Modi and Chief Minister N. Chandrababu Naidu, DISCOMs in Andhra Pradesh are gradually stabilizing. Central schemes such as PM Suryagarh and PM Kusum are being effectively implemented to reduce finan-



cial strain and promote green energy adoption.

The Minister requested the Centre to increase the state's battery storage capacity from 1,000 MW to 2,000 MW and enhance the Green Energy Corridor grant. He also appealed for an increase in the number of sanctioned pump sets from 1 lakh to 4.5 lakh to support farmers.

He criticized the previous YS-RCP government for pushing DISCOMs into deep debt, raising liabilities from ₹17,000 crore to ₹67,000 crore in just five years. Unpaid subsidies and mismanagement worsened the crisis. The current coalition government has already cleared ₹11,352 crore in pending dues, putting DIS-COMs on a path to recovery. Minister Gottipati assured that with fiscal discipline and green energy promotion, Andhra Pradesh's power sector will regain stability and emerge as a model for the nation.





## **Budget Filled with Self-Congratulation** and No Justice to Any Section, Says Botsa



- Botsa calls the AP budget a major disappointment
- Alleges failure to allocate funds for key schemes

YCP MLC Botsa Satyanarayana strongly criticized the AP budget presented by Finance Minister Payyavula Keshav, calling it a budget of self-congratulation and self-praise with no real benefit to the people. Botsa expressed disappointment, saying the government ignored every major sector and made only token allocations across the board.

Botsa alleged that the budget was used to curse the previous government and glorify the Chief Minister and his son, continuing a tradition that serves no purpose for the common man. He criticized the coalition for making meager allocations for the promises made to the people and failing to mention crucial welfare schemes like the Rs. 1,500 monthly assistance for women aged 18-50.

He highlighted that there was no mention of the unemployment allowance promised to youth, describing it as a betrayal of the unemployed. On Annadata Sukhibhav, Botsa said only Rs. 6,300 crore was allocated, while Rs. 12,000 crore is required to support 52 lakh farmers. Similarly, for Thaliki Vandanam, Rs. 9,400 crore was allocated for 81 lakh students when at least Rs. 12,000 crore was necessary.

Botsa also criticized the absence of free RTC bus travel for women, which was promised from Ugadi onwards, but found no mention in the budget. He noted that the price stabilization fund, which received Rs. 3,000 crore under the previous government, was slashed to just Rs. 300 crore.

Concluding, Botsa said the budget lacks substance and fails to deliver justice to any section — farmers, women, students, unemployed, or the common man.

AP Congress President YS Sharmila strongly criticized the state government's first full-fledged budget, calling it proof that the coalition led by CM Nara Chandrababu Naidu is a scam-driven government. She slammed the Rs. 3.22 lakh crore budget as a "Super Six - Super Flop", accusing the government of misleading the people with false numbers and ignoring key welfare promises.

"This budget is full of numbers, but empty of real allocations. It's a meaningless fantasy document with no direction. The state is already financially empty, and now this budget has made it hollow," Sharmila said.

She alleged that vital promises made during elections were abandoned, including the much-hyped Super Six schemes.

Sharmila questioned the allocations for farmers, pointing out that Rs. 6,300 crore under Annadata Sukhibhava is far below the Rs. 11,000 crore required. She criticized the meager Rs. 300 crore for price stabilization, calling it a betrayal of farmers.

On education, Sharmila highlighted that Rs. 9,407 crore was allocated for Thaliki Vandanam, far short of the Rs. 12,600 crore required for 84 lakh students, reducing the number of beneficiaries.

She also attacked the slashed funds for the Deepam-2 scheme and the complete omission of funds for free bus travel for women and Mahashakti.

## Budget Book Full of Color, Low on Content - Buggana Rajendranath

 Former Finance Minister slams govt for blaming previous administration

Former Finance Minister and YSRCP MLC Buggana Rajendranath Reddy strongly criticized the coalition government's budget, calling it a glossy document with very little meaningful content. He questioned why the government, which has been in power for almost a year, continues to blame the previous administration instead of focusing on governance.

Buggana highlighted that in the Finance Minister's budget speech, the term 'previous government' was mentioned 25 times, and 'destruction' was repeated 10 times, showing an obsession with the past rather than the future.

He reminded the ruling alliance that there is only one opposition party in the Assembly, and despite that, they seem fixated on blaming others instead of focusing on providing good governance and implementing promised schemes like Super Six.

Buggana asserted that during the Jagan government's tenure, welfare schemes reached all eligible beneficiaries, even if some were misled into believing more

would come. He sarcastically asked whether the public has received even half or a quarter of the promised benefits under Super Six.

He further criticized Chandrababu Naidu's fiscal track record, alleging that whenever Naidu is in power, salaries are delayed and proper financial management is absent. Comparing Naidu to Chanakya or Kautilya, Buggana said these titles do not fit him, as his governance lacks proper calculations and vision.

Buggana concluded by calling the budget document a colorful book with very little real content, highlighting that the lack of systematic financial planning is evident throughout.

### My Husband Is Being Harassed in Jail: Vallabhaneni Vamsi's Wife Pankajasri

Vallabhaneni Vamsi's wife, Pankajasri, has expressed serious concerns about her husband's health and treatment in Vijayawada Central Jail, where he is currently on remand. After meeting him in jail along with YSRCP MLA Tatiparthi Chandrasekhar, Pankajasri spoke to the media, highlighting the harassment and poor conditions Vamsi is facing inside the prison.

She revealed that Vamsi, who suffers from fits and asthma, is being kept in the 6/4 barracks, commonly used as a punishment cell. According to Pankajasri, he is confined to isolation for 22 hours a day, leaving him se-

#### verely depressed.

"My husband's health is already fragile. Instead of providing proper medical care, they are mentally harassing him by keeping him isolated for most of the day. This is not just physical harassment but severe psychological torture," Pankajasri alleged.

She further demanded that Vamsi be moved out of isolation and placed with other inmates, stating that prolonged solitary confinement is only worsening his condition. Pankajasri also claimed that Vamsi has been falsely implicated in cases unrelated to him, calling the remand a politically motivated act.

## We'll Approach the High Court to **Challenge the Remand Order - Ponnavol** Sudhakar Reddy

Actor and YSRCP supporter Posani Krishna Murali has been remanded to 14 days judicial custody by the Railway Kodur Court in connection with his alleged inflammatory comments against Pawan Kalyan and remarks that stirred divisions within the film industry.

Reacting to the court's decision, Posani's lawyer and YS-RCP leader Ponnavol Sudhakar Reddy announced that they will approach the High Court to challenge the remand order.

Ponnavol stated that the court overlooked the application of BNS Section 111, which was imposed on Posani. According to him, the magistrate accepted the police's argument that Posani's remarks were capable of creating enmity between groups, leading to the 14-day remand order.

Describing the situation, Ponnavol remarked, "This is like an operation being successful, but the patient dying." He claimed that their legal team considers this half a success, as they successfully raised objections under BNS Section 111, even though the magistrate ultimately sided with the police on other charges.

The case stems from Posani's controversial comments targeting actor and Jana Sena Party chief Pawan Kalyan, which allegedly spread hatred among different sections of the film industry and public. With Posani now in judicial custody, his legal team is preparing to file an appeal in the High Court, hoping for relief and a more favorable legal interpretation of the charges against him.

### **CPI State Secretary** Ramakrishna Criticizes AP **Budget as Fraudulent**

Ramakrishna strongly criticized the Andhra Pradesh state budget presented by Finance Minister Payyavula Keshav, calling it a deceptive and fraudulent budget. Addressing a press conference at the CPI Eluru district office Sphoorthi Bhavan on Friday evening, Ramakrishna questioned what concrete changes the coalition government had brought in its eight months of rule, despite repeatedly blaming the previous government for the state's decline. Ramakrishna said the proposed ₹3.22 lakh crore budget offers no clarity on how the revenue and cash deficits will be covered, questioning whether it will come from asset sales, loans, or further burdening the people.He slammed the government for neglecting agriculture, which supports over 60% of the population. Despite its critical role, agriculture and irrigation received only 3.5% of the budget—₹11,314 crore—far below the required 10%. Ramakrishna expressed concern that irrigation projects initiated four decades ago remain incomplete and, with the current allocations, may not see completion even in the next 40 years.

He also criticized the central government for reducing the Polavaram project height from 45.72 to 41.15 meters, terming it a grave injustice. He found it ironic that Finance Minister Payyavula Keshav praised Prime Minister Narendra Modi, whose policies he blamed for fragmenting the national economy. Ramakrishna demanded transparency regarding Amit Shah's recent claim that ₹3 lakh crore was allocated to Andhra Pradesh in the past seven months, asking for an explanation on how and where the funds were spent. He also expressed outrage over the exclusion of tenant farmers from the budget and criticized the government for ignoring key promises made during the elections. Commenting on the arrest of Posani Krishna Murali, he called on all parties to restrain leaders from using vulgar language, urging political decorum across all parties. ## **Not Muslims Or Christians - Another Syrian Ethnic Group Caught In Crossfire**



ADruze factions in Syria's southern Suway-da province formed the Suwayda Military Council, a coalition created to protect the Druze community from external threats and government oppression. This announcement came

former Syrian President Bashar al-Assad and the rise of interim President Ahmad al-Sharaa, who is linked to the Islamist group Hayat Tahrir al-Sham (HTS).

The Druze, a unique ethnic minority following amidst uncertainty following the downfall of a faith blending Islam, Hinduism, and Greek

philosophy, have long been wary of external threats. They have faced significant challenges in the past, including massacres at the hands of ISIS and the turmoil after Assad's regime fell. Despite this, they have maintained a cautious independence, particularly in the Suwayda region,

which was under partial control of the Assad regime since 2015.

The newly-formed Suwayda Military Council, led by Tareq Al Shoufi, aims to promote secularism, democracy, and decentralization as the foundation for a just and stable future. The council intends to safeguard civilians, manage public property, and work in cooperation with other security factions to ensure the region's stability. At the same time, they have expressed willingness to work with the Kurdish-led Syrian Democratic Forces (SDF) due to their shared opposition to terrorism and dictatorship.

However, the council's formation has not been without controversy. Syria's Druze spiritual leader, Sheikh Hikmat al-Hajri, rejected the council, accusing it of separatism and claiming it does not represent the Druze community as a whole. Despite these internal divisions, the Suwayda Military Council has garnered local support, with several factions in the region pledging allegiance.

The council's flag, reminiscent of the Kurdish SDF flag, carries a distinct Druze symbol, a five-pointed star, signaling both the community's resistance and its pursuit of independence from government oppression. Their leader, Tareg Al Shoufi, is a former Syrian Arab Army officer who has stood by the Druze community during protests against Assad.

While the formation of the Suwayda Military Council has provided a sense of protection for the Druze, many civilians have expressed uncertainty about the future. "It's a good step for pressuring the government and providing protection. But in the past, armed groups in Suwayda were disorganized, and no large force was ever formed," said Ahmed Al Shareef, a Druze from Suwayda.

Despite this, the growing presence of the Suwayda Military Council symbolizes a new chapter for the Druze in Syria, one focused on self-preservation and independence amidst an unstable political landscape.

The UK has a longstand-▲ ing history of cozying up to authoritarian regimes, a trend that continues despite its self-image as a bastion of democratic values. For more than a century, foreign strongmen have found allies, apologists, or a lack of criticism within British politics, even as the UK proudly stands as a supposed enemy of fascism. This paradox raises an important question: why does Westminster, the heart of British democracy, remain so welcoming to far-right governments?

One reason lies in the pragmatic nature of foreign policy. As Britain navigates an increasingly multipolar world, it often cannot afford to alienate powerful nations. This is especially evident in the relationship between the UK and the Trump administration, where diplomacy often appears to overlook the authoritarian tendencies of

foreign leaders for the sake of strategic cooperation. However, darker impulses also play a role in the UK's tolerance for autocratic rule. For some British politicians, the regimes of strongmen offer a fascinating alternative to the compromises and slow progress of liberal democracy. In moments of disillusionment with democratic processes, autocrats can seem like leaders who "get things done." For instance, Kemi Badenoch, a prominent Tory figure, recently praised the fastpaced, result-driven nature of Trump's leadership, echoing a sentiment shared by other right-wing figures in the UK who admire the transgressive populism that

Trump embodies. This admiration for foreign autocrats isn't new. In the Britain—including figures like Winston Churchill warmly embraced Mussolini's fascist regime, seeing it

British leaders supported the brutal military dictatorship of Augusto Pinochet in Chile, viewing it as an ally in the fight against communism. Today, the fear of Islam and immigration fuels the right's admiration for leaders like Trump, whose aggressive stances on these issues resonate with their own increasingly illiberal policies.

British politicians and media figures have often sought to justify their support for autocrats by focusing on their supposed effectiveness in governance. In the case of Mussolini and

Trump, their personal appeal and decisive rhetoric offered a tantalizing contrast to the perceived failures of liberal democracy. This admiration, however, has consequences. By softening the image of authoritarian leaders, British politicians and journalists inadvertently make them more palatable to the public, rather than influencing them to moderate their behavior.

When these authoritarian figures eventually lose power, as they often do, the UK's support may be remembered as a grave moral and strategic error, much like the post-World War II reckoning with fascist regimes. ## **Mumbai Police Investigate Threat to CM Fadnavis**, **Enhance Security Measures**

Mumbai Traffic Police recently received a threatening WhatsApp message targeting Chief Minister Devendra Fadnavis' office. According to NDTV, the message, which was sent by an individual identified as Malik Shahbaz Humayun Raja Dev, came from a Pakistani number. The authorities have launched an investigation to determine whether the sender is an Indian national or a foreigner.

In response to the threat, security around Chief Minister Fadnavis has been bolstered, with heightened measures around his office and other critical government buildings. The police are carefully assessing the credibility of the threat as part of their ongoing probe.

This threat to Fadnavis follows closely on the heels of a similar situation involving Deputy Chief Minister Eknath Shinde, who received a death threat via email on February 20. The threat was directed to sever-

al locations, including Goregaon and JJ Marg police stations, as well as Mantralaya. Authorities swiftly responded to the threat, and the Mumbai Crime Branch, along with the Buldhana police, arrested two individuals in connection with the email threat. The arrested suspects, identified as Mangesh Wayal (35) and Abhay Shingane (22), residents of Deulgaon Mahi in Buldhana district, were taken to Mumbai, where an FIR was filed against them under various sections of the Indian Penal Code.

This isn't the first time Shinde has faced such threats. Earlier, in 2024, a college student had issued death threats to both Shinde and his MP son, Shrikant Shinde, through social media. This led to the arrest of a 19-year-old student who had sent the threatening messages on February 11, 2024.

As investigations continue into the latest threats, authorities remain vigilant, ensuring the safety and security of the state's leaders and the public.

Stalin has strongly opposed the Centre's proposal to base the determination of parliamentary constituencies solely on population, warning that such an approach would unfairly penalize southern states like Tamil Nadu. 

Narayanan emphasized that the mission would also help in managing the significant propellant onboard the satellites, with additional experiments planned for the third window available in two months.

This project marks a crucial step in ISRO's continued efforts to enhance its space exploration capabilities and establish India as a leader in space technology. The successful outcomes of these experiments are expected to pave the way for more ambitious missions in the coming vears.



Kangana Ranaut Appears in **Court Over Defamation Case Filed by Javed Akhtar**

Bollywood actor and BJP MP Kangana Ranaut appeared before a special court on Friday in connection with a defamation case filed against her by veteran lyricist-screenwriter Javed Akhtar. Ranaut appeared in the special magistrate court designated to handle cases involving MPs and MLAs.

The defamation case was filed by Akhtar in 2020, accusing Ranaut of making defamatory comments about him during a television interview, which allegedly tarnished his reputation. In her interview, Ranaut had mentioned a "coterie" in Bollywood, and Akhtar's name was reportedly dragged into the conversation. TPN Correspondent | Vijayapura Farmers in Karnataka's Krishna basin have strongly opposed the government's decision to release 1.24 TMC of water to Telangana, warning of a potential shortage during peak summer months. The move has sparked outrage, with farmer organizations planning a major protest outside

the District Collector's office on February 28. The state government released 1 TMC of water from the Almatti and Narayanpur reservoirs following Telangana's request for 5 TMC to meet drinking water needs. However, officials confirmed that Karnataka could only spare a fraction of the requested amount. "We released the water as per government orders. Telangana sought 5 TMC, but given the current storage levels, only 1 TMC was released," said Almatti Dam Chief Engineer D Basavaraj.Farmer unions, including the Bharatiya Kisan Sangh (BKS), have condemned the decision, accusing the government of disregarding local needs. "Water is crucial for Karnataka's farmers, especially in the summer months. Yet, Water Resources Minister DK

Shivakumar has shown undue interest in releasing it elsewhere," said BKS secretary Raghavendra Kamanatagi.Amid the growing discontent, Akhanda Karnataka Raita Sangha has announced a large-scale protest on February 28. Despite the backlash, the government has defended its stance, citing past instances of Maharashtra releasing water to Karnataka for drinking purposes. "Providing water for drinking needs is not a mistake. It's a matter of maintaining good relations with neighboring states," said APMC Minister Shivanand Patil.According to official data, the Almatti reservoir currently holds 50.463 TMC of water, with a live storage of 32.843 TMC. As of Thursday, the total discharge stood at 10,475 cusecs.

## Kash Patel Seeks UFC's Help To Train FBI **Agents: Report**

## India, EU set yearend deadline for free trade pact

India and the European Union have set a year-end deadline to finalise a long-awaited free trade agreement, aiming to strengthen economic ties between the two regions. The announcement was made in a joint statement by Prime Minister Narendra Modi and European Commission President Ursula von der Leyen during their meeting in New Delhi.PM Modi emphasised that the India-EU partnership goes beyond trade, stating, "We have prepared a blueprint for collaboration in trade, technology, investment, innovation, green growth, security, skilling, and mobility." He also confirmed that officials have been directed to conclude negotiations before the end of the year, with a formal roadmap set to be launched at the next India-EU summit.

### Challenges in trade deal negotiations

Despite rapid trade growth—rising 90% since 2014, with total bilateral trade exceeding \$137 billion in 2023-24previous attempts to finalise a trade pact stalled due to differences on tariffs and visa regulations. The EU has sought lower tariffs on automobiles, liquor, and other goods, while India is pushing for easier market access for its pharmaceutical and textile sectors.

New Delhi has also opposed Europe's 20-35% carbon tax on industrial goods like cement, steel, and aluminum. Meanwhile, the EU remains hesitant to relax visa restrictions for Indian professionals.

### Push for India-Europe connectivity

In a parallel development, India and the EU reaffirmed their commitment to the India-Middle East-Europe Corridor (IMEEC), a strategic infrastructure project aimed at enhancing trade routes through sea, rail, and road networks. PM Modi described the initiative as an "engine for global commerce and sustainable growth."EU chief von der Leyen highlighted the corridor's potential to strengthen economic integration and improve security, particularly in the Indo-Pacific and Africa. She also stressed the importance of joint naval exercises in securing global trade routes.With both sides prioritising economic and strategic collaboration, the coming months will be crucial in determining whether they can overcome existing barriers and finalise a historic free trade agreement.



India's foreign exchange reserves saw a notable increase of USD 4.758 billion, reaching USD 640.479 billion for the week ended February 21, according to the Reserve Bank of India (RBI) data released on Friday. This comes after a decline in the previous week, where reserves had dropped by USD 2.54 billion to USD 635.721 billion.

The recent uptick in reserves marks a positive shift after several weeks of decline. The decline had primarily been due to factors like revaluation of foreign currency assets and the RBI's market interventions aimed at reducing volatility in the Indian rupee. India's forex reserves had previously peaked at an alltime high of USD 704.885 billion in September 2024.

The latest increase in reserves was largely driven by a rise in foreign currency assets, which rose by USD 4.251 billion, bringing the total to USD 543.843 billion. These foreign currency assets are a major component of the country's total reserves, and their value can fluctuate based on the appreciation or depreciation of non-US currencies such as the euro, pound, and yen that are part of India's forex reserves.

In addition to foreign currency assets, India's gold reserves also saw a boost. The gold reserves increased by USD 426 million, bringing their total value to USD 74.576 billion for the week. This increase in gold holdings reflects India's strategy to diversify its foreign exchange reserves and provide additional stability to its financial standing.

The new directive requires mutual fund houses to specify achievable timelines for fund deployment in the Scheme Information Document (SID) of a new offering. By doing so, Sebi aims to promote transparency and responsible fund management while discouraging any mis-selling of NFOs.

This move comes after rising concerns over the practice of collecting large amounts of money in NFOs without a clear and timely plan for investing the raised capital. Sebi's new rules will help AMCs align their fund-raising strategies with realistic deployment schedules, reducing the risk of mis-selling to investors who might be promised quick returns without proper execution.

With the deadline set at 30 business days, Sebi hopes to ensure that the funds raised through NFOs are invested promptly, which will in turn support the effective management of investor capital. This rule is expected to improve investor confidence, as it guarantees that mutual funds will operate within clear and practical timeframes.

The introduction of these guidelines is also a part of Sebi's broader efforts to enhance the India. governance of the mutual fund industry, en-

sure better accountability, and safeguard the interests of investors. AMCs now have to provide detailed timelines in the SID, which will be subject to scrutiny, ensuring that funds are deployed efficiently and in accordance with the stated objectives of the scheme.

By tightening these regulations, Sebi aims to create a more disciplined and transparent environment for mutual fund investments in

The GPT-4.5 model was developed using cutting-edge techniques such as unsupervised learning alongside traditional supervised fine-tuning (SFT) and reinforcement learning from human feedback (RLHF). These innovations contribute to the model's enhanced conversational and problem-solving abilities.

Currently available as a research preview, GPT-4.5 is being rolled out exclusively to ChatGPT Pro subscribers, with plans to extend access to Plus and Team users by next week. Enterprise and Educational users will likely gain access shortly thereafter. OpenAI is using this phase

to better understand the model's strengths and weaknesses.

While GPT-4.5 supports several new features, including search, file and image uploads, and Canvas, it does not support multimodal functionalities like Voice Mode, real-time video, or screensharing in ChatGPT at this stage. For developers, the model is being introduced in several paid tiers, including the Chat Completions API, Assistants API, and Batch API.

Internal benchmarking reveals that GPT-4.5 performs better than the o3-mini model in areas such as multilingual tasks (MMMLU) and coding-related benchmarks. However, OpenAI CEO Sam Altman emphasized that GPT-4.5 is not intended to be a reasoning model designed to outperform its predecessors across all metrics. Instead, Altman noted that the model represents a "different kind of intelligence" and focuses on enhancing specific aspects of AI capabilities rather than achieving dominance in all areas.


