

DMK-led JAC passes a unanimous 7-point resolution on delimitation.

The DMK-led Joint Action Committee (JAC) convened in Chennai for its first meeting on Friday to discuss the Union government's proposed delimitation exercise. The committee, comprising representatives from multiple political parties, expressed concerns over the lack of transparency in the process and the absence of sufficient consultations with key stakeholders. Following deliberations, the JAC

passed a unanimous 7-point resolution demanding an inclusive on Parliamentary constituencies and transparent approach. It emphasized that any changes in the delimitation of Parliamentary constituencies should involve discussions with all state governments, political parties, and relevant stakeholders to ensure fairness and democratic representation.

Key Resolutions Passed by the JAC

The 7-point resolution stressed that any delimitation exercise must be carried out transparently, allowing political parties from all states, state governments, and other stakeholders to deliberate and contribute to the process. It also highlighted the legislative intent behind the 42nd, 84th, and 87th Constitutional amendments, which sought to protect states that had effectively implemented population control measures.

The JAC demanded that the freeze based on the 1971 Census should be extended by another 25 years, considering that national population stabilization has not yet been achieved. It further asserted that states that successfully implemented population control programs should not be penalized by losing parliamentary representation and

urged the Union Government to enact the necessary constitutional amendments to uphold this princi-

To counter any attempts by the Union Government to undertake delimitation against these principles, the resolution called for the formation of a Core Committee comprising Members of Parliament from the participating states. This committee will coordinate parliamentary strategies and submit a joint representation to the Prime Minister during the ongoing session. Additionally, the resolution encouraged political parties to push for state legislative assembly resolutions against delimitation changes and communicate their stance to the Union Government.

The JAC also resolved to launch a coordinated public awareness campaign to inform citizens about

past delimitation exercises and the potential consequences of the proposed changes.

The meeting was attended by several prominent leaders, including Karnataka Deputy Chief Minister DK Shivakumar, Telangana Chief Minister Revanth Reddy, BRS leader KTR, Punjab Chief Minister Bhagwant Mann, Kerala Chief Minister Pinarayi Vijayan, Odisha Congress President Bhakta Charan Das, and Biju Janata Dal leader Sanjay Kumar Das Burma. Tungabhadra Irrigation Committee's Key Decision, Relief for Farmers, **Drinking Water Assured**

- · Water release extended for drinking and irrigation needs
- 3000 cusecs to be released from April 1 to April 10
- Priority given to drinking water and standing crops

TPN Correspondent | Koppal In a significant decision, the Tungabhadra Irrigation Advisory Committee has an-

nounced the release of water to Raichur, Koppal, Bellary, and Vijayanagar districts to support drinking water needs and protect summer crops. The decision was taken at a meeting held at the Vidhana Soudha Conference Hall in Bengaluru.

Irrigation Advisory Committee Chairman and Minister Shivraj Tangadgi stated that 3000 cusecs of water would be released through the Tungabhadra Left Bank Main Canal from April 1 to April 10. This allocation will ensure the supply of drinking water and support standing crops cultivated by farmers.

The Tungabhadra reservoir currently holds 18 TMC of water, of which 2 TMC is dead storage, and 1.2 TMC is subject to evaporation. The remaining usable water is distributed between Karnataka (11 TMC) and Andhra Pradesh (4 TMC).

Based on availability, the government has prioritized drinking water supply and the preservation of standing crops. Additionally, 150 cusecs of water will be released from April 11 to May 10 through the Vijayanagar Left Bank Canal and its distribution network, or until water availability permits. Furthermore, 450 cusecs will be released from April 1 to April 10 for the Tungabhadra Right Bank Lower Level Canal. The Raya Basavanna Canal will receive 200 cusecs from April 1 to May 31.

To ensure proper water distribution, the Minister directed district authorities to enforce Section 144 and deploy police reinforcements to safeguard drinking water reservoirs. The government reassured farmers and residents that water would be released in a controlled manner without disruptions.

Woman Arrested in **Kollam for Smuggling MDMA** from Bengaluru

A 34-year-old woman, Anila Raveendran, was arrested for smuggling MDMA worth several lakhs from Bengaluru to Kollam, Kerala, police officials confirmed.

Acting on a tip-off, a team from Sakthikulangara police and the Kollam City Anti-Narcotic Special Action Force (DANSAF) attempted to stop her car near the Neendakara bridge. The driver tried to evade the police, leading to a brief chase before the vehicle was intercepted.

Upon searching the car, police found 50 grams of MDMA. A subsequent medical examination revealed that the woman had concealed an additional 40 grams of the drug in her private parts, bringing the estimated total to 90 grams.

Police sources stated that Anila had been smuggling MDMA to supply it to school and college students in Kollam city. She was reportedly involved in a previous MDMA trafficking case as well.

Authorities have seized the car and launched a detailed investigation to trace the source of the contraband.

Union Minister Shobha Karandlaje Urges Karnataka Governor to Reject Muslim Quota Bill

- Union Minister opposes 4% Muslim reservation in public contracts
- Calls the bill unconstitutional and discriminatory

Union Minister of State for Labour and Employment Shobha Karandlaje has urged Karnataka Governor Thaawarchand Gehlot to withhold his consent for the Karnataka Transparency in Public Procurements (Amendment) Bill, 2025. The bill, passed by the Karnataka government, provides a 4% reservation for Muslims in public contracts.

In a letter to the Governor, Karandlaje termed the bill "unconstitutional, discriminatory, and against the ethos of the In-

TPN Correspondent | New dian Constitution." She argued that reservation based on religion directly violates Articles 14 (right to equality), 15 (prohibition of discrimination), and 16 (equal opportunity in public employment).

> Referring to past Supreme Court rulings, the minister emphasized that affirmative action must be based on social and educational backwardness, not religious identity. She warned that the bill could face legal challenges, stating, "The proposed amendment is an open circumvention of constitutional safeguards and is



liable to be struck down by the judiciary."

Accusing the Karnataka government of engaging in appeasement politics, Karandlaje said such policies weaken the nation's secular fabric and set a dangerous precedent. "This reservation is not aimed at empowering the underprivileged but is a blatant attempt at appeasement politics for electoral gains," she wrote.

She further urged the gov-

ernment to focus on uplifting all backward communities based on socio-economic criteria rather than religious identity. Warning of the long-term consequences, she added that such divisive policies could lead to social disharmony and policy corruption.

The bill's passage has sparked political debate, with opposition leaders questioning its legality and potential impact on governance.



BJP MLC Criticizes Poor Execution of SC/ST Welfare Schemes

The Karnataka Legislative Council witnessed chaotic scenes after BJP MLC Sudham Das raised concerns over the ineffective implementation of the Special Component Plan (SCP) and Tribal Sub-Plan (TSP) schemes meant for Scheduled Castes (SCs) and Scheduled Tribes (STs).

Das, a former bureaucrat-turned-legislator, criticized the state government for poor execution of over 140 welfare schemes designed for SCs and STs. He pointed out that by January, only 54% of allocated funds had been spent, questioning how such schemes could be effectively implemented with such low expenditure levels.

He also blamed the existing system, arguing that placing the Social Welfare Department under the Finance Department hampers the smooth execution of these initiatives.

Govt Trying to Suppress Our Struggle, Says Sara Govindu

Pro-Kannada activist Sara Govindu accused the Karnataka government of attempting to suppress the ongoing struggle for Kannada language, land, and water rights. Addressing the media on Saturday, she expressed disappointment over the state's actions against activists supporting the Karnataka Bandh. "Our leader Vatal Nagaraj has been fighting for the rights of Kannada people for 60 years, and I have been part of this movement for 40 years. But never before have we seen such suppression. Land Hurdles Delay Bengaluru Suburban Rail Project, L&T Faces Challenges

The Bengaluru Suburban Rail Project (BSRP) is facing significant delays due to land acquisition issues, particularly affecting Corridor-2 (Baiyappanahalli-Chikkabanavara) and Corridor-4 (Heelalige-Rajanukunte). While some construction progress has been made where land is available, the overall pace remains slow due to pending land handovers and utility shifts. Corridor-2 requires 91.5 acres, including 28.56 acres of private land, while Corridor-4 needs 160.56 acres, with 40.29 acres being private land. Larsen & Toubro (L&T), which is handling the project, has expressed concerns over delays, stating that the lack of land availability and unshifted utilities are major obstacles. L&T sources revealed that work has been completed wherever land has been provided, including the construction of bridges near Heelalige



on Corridor-4.

The Karnataka Rail Infrastructure Development Company (K-RIDE), which is executing the project, has been urged to expedite the handover of private land to ensure progress. Insiders also disclosed that at least five senior engineers working on the project for L&T have resigned, citing frustration over stalled progress, which they believe is affecting traffic congestion.

Explosive Substance Found in Bengaluru Hotel Worker's Bag, Arrest Made

A cracker-like explosive substance was discovered in the bag of a hotel worker on Thanisandra Main Road on Friday. The discovery was made when hotel staff checked his bag while searching for his Aadhaar card, as he had recently joined the establishment. The Sampigehalli police later arrested Abdul Rehman (23), a resident of Bellalli near Kogilu Main Road.

AAI Team to Visit Karnataka in April for Feasibility Study of Bengaluru's Second Airport

Development Minister M.B. Patil announced on Saturday that a multidisciplinary team from the Airports Authority of India (AAI) will visit the state in April to conduct a feasibility study for Bengaluru's second international greenfield airvisit between April 7 and 9 to inspect three shortlisted locations for the proposed airport. Two sites have been identified on Kanakapura Road, while the third is on the Nelamangala-Kunigal Road.Patil revealed that the Karnataka State Industrial and Infrastructure Development Corporation (KSIIDC) has already paid Rs 1.21 crore to the AAI for conducting the feasibility study. He stated that the Karnataka government had written to the AAI on March 5, requesting an inspection of the shortlisted sites. All necessary documents, including revenue maps, 10 years of weather reports, geographic site images, Survey of India maps, and operational details, have already been prepared for the evalua-

The minister emphasized that the need for a second airport in Bengaluru has become urgent due to the increasing pressure on the existing Kem-

Karnataka Infrastructure pegowda International Airport. Additionally, the restriction that prevents the construction of another airport within a 150 km radius of the existing one is set to expire by 2033. With this in mind, the state government is expediting the project to ensure the new airport. The team is scheduled to port becomes operational by that year. Addressing concerns about alternative locations, Patil dismissed suggestions of constructing the airport near Sira in Tumkur, stating that such a location would make it a district-level airport rather than a city-serving facility. He stressed that for the airport to attract investors and be viable, it must be located closer to Bengaluru.

> Meanwhile, Patil also spoke about the protests in Koppal against the proposed Rs 54,000 crore steel plant by the Baldota Group. Environmental concerns have been raised, with Swamiji of Gavimath leading the opposition. Lukewarm Response to Karnataka Bandh in North Karnataka

The Karnataka Bandh called by pro-Kannada organizations on Saturday, March 22, 2025, received a lukewarm response in the districts of Kalyana and Kittur Karnataka. The bandh was organized in response to the alleged assault on a Karnataka State Road Transport Corporation (KSRTC) bus conductor in Belagavi last month for not knowing Marathi. Pro-Kannada groups viewed the incident as an attack on Kannada identity and called for the bandh to demand justice and reaffirm the importance of the Kannada language in the state. However, the lack of strong participation suggests that the issue did not gain widespread traction in the northern districts. Authorities had deployed security personnel in key areas to prevent any untoward incidents.

This clash between the two sides signals a worrying escalation in an already tense situation.

It is unfortunate that both parties have failed to find common ground. In a moment of heightened tensions, they should have come together to exert pressure on the central government to meet the farmers' demands, particularly the provision of a legal guarantee for Minimum Support Price (MSP) for all crops. Instead, the two

sides are locked in a bitter confrontation, with the farming unions losing public support, which has, in turn, empowered the state government to take a firmer stance. Meanwhile, the central government observes passively from the sidelines.

The situation can no longer afford to spiral further. It is imperative for all stakeholders to engage in sincere dialogue with a commitment to resolving the crisis promptly. A flexible and cooperative approach will be essential for all sides to find a mutually beneficial resolution. The central government must learn from its mishandling of the 2020-21 farmer protests at Delhi's borders, which led to the eventual repeal of three controversial farm laws but failed to address the MSP issue.

At the same time, the state government must explain its change in stance after initially positioning itself as a mediator for farmers' rights. While Punjab's economy does need a trade boost, agriculture, which remains its backbone, cannot be sidelined. Both sides must work toward reconciliation to prevent the ongoing unrest from dragging the state further into turmoil.

BJP Leader Shoots Wife and Children in Uttar Pradesh, Two Killed

In a shocking incident in Uttar Pradesh's Saharanpur district, a local BJP leader, Yogesh Rohilla, allegedly shot his wife and three children in the Gangoh police station area. The brutal attack resulted in the death of his son and 11-year-old daughter, while his wife and another child remain in critical condition. The incident has left the local community in shock and raised concerns about domestic violence and unchecked aggression. According to police reports, Rohilla, who holds the position of BJP executive member, was arrested at the scene shortly after the crime. The police also recovered the pistol used in the attack. Senior police officials, including Saharanpur SSP Rohit Sajwan, immediately rushed to the location after receiving reports of the incident. Preliminary investigations suggest that Rohilla acted out of suspicion regarding his wife's character, which allegedly fueled his violent outburst.


SSP Sajwan confirmed that the leader had been under significant mental stress in the days leading up to the incident. However, he had not shared his concerns with neighbors or anyone else in his social circle. The police are now trying to determine whether his suspicions had any basis or if they were the result of paranoia and undue stress. The crime took place in Sangatheda village, leaving residents horrified and fearful. Police officials, along with forensic teams, have launched a thorough investigation to piece together the



sequence of events. Authorities are also questioning the accused to gather more details and understand his motive more clearly. Eyewitness accounts and preliminary findings suggest that after committing the crime, Rohilla himself called the police to report the incident. This led law enforcement officers to the scene, where they found the two children dead and the other victims critically injured. His wife and the surviving child were immediately rushed to Saharanpur District Hospital, where they are currently undergoing treatment.This tragic case has once again brought attention to the rising instances of domestic violence and crimes driven by suspicion and mental distress. The deaths of the two children have sparked widespread outrage, with many demanding stricter laws to prevent such incidents. Authorities have assured a thorough investigation, and the accused will face legal consequences based on the findings. Meanwhile, the community remains in shock, mourning the innocent lives lost in an act of extreme violence.

Jairam Ramesh Questions PM Modi's Absence as SC **Judges Visit Manipur**



Congress MP Jairam Ramesh welcomed the visit of a Supreme Court delegation to Manipur but questioned when Prime Minister Narendra Modi would visit the conflict-ridden state. Speaking to ANI, Ramesh stated, "We welcome the six Supreme Court judges who have visited Manipur. In the past 22 months, hundreds have died, and around 60,000 people remain displaced in relief camps. Even today, fear and uncertainty persist among communities. While President's Rule was imposed on February 13, the real question is why it took 18 months to act after the Supreme Court declared on August 1, 2023, that the constitutional system in Manipur had collapsed. It is good that Supreme Court judges have visited, but when will the Prime Minister go?" A delegation of six Supreme Court judges, including Justices BR Gavai, Surya Kant, Vikram Nath, MM Sundresh, KV Viswanathan, and N Kotishwar, visited a relief camp in Churachandpur, Manipur, on Saturday to assess the ongoing crisis. Ramesh also criticized Union Home Minister Amit Shah, accusing him of ignoring Manipur during discussions on the Ministry of Home Affairs (MHA) in Parliament. "Yesterday, the Home Minister spoke for four hours in the Rajya Sabha about his ministry's work, yet he barely mentioned Manipur. In February 2022, the NDA won the state elections with a massive majority, but within 15 months, Manipur was in flames. Why hasn't the Prime Minister visited?" Ramesh questioned.

The Congress leader further criticized the delay in imposing President's Rule and noted that Amit Shah visited Mizoram but not Manipur. "There is no explanation for why it took so long to impose President's Rule. The Home Minister went to Mizoram but avoided Manipur. Even statements made by the Mizoram Chief Minister after visiting America raise serious concerns," he added. Ramesh urged PM Modi to visit Manipur before or after his upcoming trip to Bangkok for the BIMSTEC Summit from April 2-4. "We hope that on his way to Bangkok or while returning, the Prime Minister takes time to visit Manipur. His visit is crucial for providing a healing touch," he said. Manipur has been in turmoil since May 3, 2024, when violence erupted following protests by the All Tribals Students Union (ATSU) against the demand for Scheduled Tribe status for the Meitei community.

Meerut Murder Victim's Mother Demands Justice, **Custody of Granddaughter**

The mother of Saurabh Rajput, a Meerut man allegedly murdered by his wife Muskan Rustogi and her lover Sahil Shukla, has made an emotional plea for justice. She has urged Prime Minister Narendra Modi and Uttar Pradesh Chief Minister Yogi Adityanath to intervene and ensure the strictest punishment for those responsible. Expressing her grief and anger, she has also demanded custody of her granddaughter, fearing for the child's safety. Saurabh's mother voiced her deep anguish over the tragic incident and questioned the well-being of her granddaughter, who remains with Muskan. "She is our granddaughter; we have the right to see her. If the mother could harm her own husband, what if she did something to the child too? We haven't seen her since the incident, and we want to keep her with us," she stated. Her concern stems from the brutal nature of the crime, which has left the family shattered and desperate for across the region, with many calling for swift legal action against the accused. Reports suggest that Muskan and Sahil conspired to kill Saurabh, allegedly due to an extramarital affair. The murder,

Mark Zaid, a national security lawyer known for representing whistleblowers,



and former Republican lawmaker Adam Kinzinger, also had their clearances revoked.

Notably, Trump had previously had his own security clearance revoked by President Biden in 2021, as is customary for former presidents, in order to ensure access to intelligence and advice on national security matters.

India's Forex Reserves Rise to \$654.27 Billion in March 2025

India's foreign exchange (forex) reserves reached \$654.27 billion for the week ending March 14, 2025, marking an increase of \$305 million, according to data released by the Reserve Bank of India (RBI) on Friday. This increase follows a substantial surge in the previous week, when the reserves had risen by \$15.26 billion to reach \$653.97 billion for the week ending March 7, 2025.

The RBI's Weekly Statistical Supplement detailed various components of the country's forex reserves. Foreign Curren-

cy Assets (FCAs), which are a major component of the reserves, decreased by \$96 million to \$557.19 billion. FCAs represent assets held in foreign currencies, including the euro, pound, and yen, and their value is affected by the appreciation or depreciation of these currencies against the US dollar.

Gold reserves, on the other hand, saw a significant increase of \$66 million, rising to \$74.391 billion. This reflects the continued strength in the global gold market. The Special Drawing Rights (SDRs), another key component of the reserves, increased by \$51 million to \$18.26 billion. Furthermore, India's reserve position with the International



Monetary Fund (IMF) rose by \$283 million, reaching \$4.4 billion.

India's forex reserves are closely monitored as an important indicator of the country's economic health, especially in terms of foreign trade and currency stability. The rise in reserves indicates a positive trend in India's ability to manage external economic shocks and maintain financial stability.

The RBI releases weekly data on India's forex reserves every Friday, offering insight into the nation's financial standing and its capacity to withstand external pressures, especially in a rapidly changing global econ-



Antarctic Ice Melt Weakens Key Ocean Current

cientists have warned cold meltwater from Ant-**S**that rapid Antarctic ice melt is weakening the powerful Antarctic Circumpolar Current (ACC), which plays a crucial role in global ocean circulation. A recent study projects that the ACC could slow down by 20% by 2050, leading to significant impacts on sea levels, temperatures, and marine ecosystems worldwide.


According to research published in Environmental Research Letters, a team led by Bishakhdatta Gayen from the University of Melbourne used advanced climate simulations to analyze how the influx of

arctica is altering ocean dynamics. The study found that this fresh meltwater disrupts ocean density and weakens convection between surface and deep waters, slowing the ACC.

The consequences of this slowdown are alarming. A weaker ACC could allow warm ocean waters to reach deeper into Antarctic waters, accelerating ice melt and contributing to rising global sea levels. Scientists also warn that the current's weakening may enable invasive marine species to reach Antarctica, threatening its

fragile ecosystem. Speaking to Live Science, Gayen compared the process to a "merry-goround," explaining that as the current slows, marine organisms could migrate toward Antarctica at an increased rate. Scientists emphasize the need for long-term monitoring to fully understand the ACC's changing behavior and its

global implications. With ocean circulation patterns already shifting due to climate change, the weakening of Earth's strongest current adds to concerns about long-term disruptions in global climate systems.


