Section Sections The Section TPN Correspondent | Chennai The DMK-led Joint Action Committee (JAC) convened in Chennai for its first meeting on Friday to discuss the Union government's proposed delimitation exercise. The committee, comprising representatives from multiple political parties, expressed concerns over the lack of transparency in the process and the absence of sufficient consultations with key stakeholders.

Following deliberations, the JAC passed a unanimous 7-point resolution demanding an inclusive and transparent approach. It emphasized that any changes in the delimitation of Parliamentary constituencies should involve discussions with all state governments, political parties, and relevant stakeholders to ensure fairness and democratic representation. Key Resolutions Passed by the JAC

The 7-point resolution stressed that any delimitation exercise must be carried out transparently, allowing political parties from all states, state governments, and other stakeholders to deliberate and contribute to the process. It also highlighted the legislative intent behind the 42nd, 84th, and 87th Constitutional amendments, which sought to protect states that had effectively implemented population control measures.

The JAC demanded that the freeze on Parliamentary constituencies based on the 1971 Census should be extended by another 25 years, considering that national population stabilization has not yet been achieved. It further asserted that states that successfully implemented population control programs should not be penalized by losing parliamentary representation and

urged the Union Government to enact the necessary constitutional amendments to uphold this principle.

To counter any attempts by the Union Government to undertake delimitation against these principles, the resolution called for the formation of a Core Committee comprising Members of Parliament from the participating states. This committee will coordinate parliamentary strategies and submit a joint representation to the Prime Minister during the ongoing session. Additionally, the resolution encouraged political parties to push for state legislative assembly resolutions against delimitation changes and communicate their stance to the Union Government.

The JAC also resolved to launch a coordinated public awareness campaign to inform citizens about

past delimitation exercises and the potential consequences of the proposed changes.

#### Key Leaders in Attendance

The meeting was attended by several prominent leaders, including Karnataka Deputy Chief Minister DK Shivakumar, Telangana Chief Minister Revanth Reddy, BRS leader KTR, Punjab Chief Minister Bhagwant Mann, Kerala Chief Minister Pinarayi Vijayan, Odisha Congress President Bhakta Charan Das, and Biju Janata Dal leader Sanjay Kumar Das Burma. Former Odisha Chief Minister Naveen Patnaik participated virtually, while the Mamata Banerjee-led Trinamool Congress (TMC) did not attend the meeting. Tamil Nadu Chief Minister MK Sta-

lin, who convened the meeting, announced that the next JAC meeting on delimitation would be held in Hyderabad.

#### **Criticizes DMK for Emotional Issues Ahead of Elections**

Union Finance Minister Nirmala Sitharaman recently accused the DMK of raising emotional issues, such as alleged Hindi imposition and Parliament delimitation, to divert attention from its own lack of achievements ahead of Tamil Nadu's 2026 Assembly elections. Sitharaman criticized the state government for focusing on these matters instead of

addressing real concerns in the state.

She strongly condemned the law and order situation in Tamil Nadu, describing it as "lawlessness." In particular, she targeted the ruling party over the Anna University sexual assault case, questioning the whereabouts of the accused and whether they were affiliated with the DMK. She also referred to the 2024 Kallakurichi hooch tragedy, demanding answers regarding the incident's aftermath.

Sitharaman further questioned the DMK's governance, asking what distinct achievements the party could claim for Tamil Nadu under its rule. She accused the state government of using emotional issues to mask its failures, corruption, and scandals, drawing parallels with the scams that emerged during the Manmohan Singh-led UPA government, of which the DMK was a part.

On the topic of delimitation, Sitharaman remarked that the DMK was using this issue to prepare for the upcoming 2026 elections. She stressed



that Prime Minister Narendra Modi had made it clear in 2024 that no state would face injustice in the delimitation process. Sitharaman alleged that the DMK's focus on delimitation was an attempt to take the state back to the political debates of the 1960s and 1980s, rather than addressing current concerns.

Sitharaman also responded to the controversy over the alleged Hindi imposition, dismissing it as "false propaganda" that she had heard since her school days. She pointed out that population alone was not the determining factor for the creation of Lok Sabha seats, citing the examples of Ladakh and Lakshadweep, which have fewer representatives despite smaller populations.

Finally, she raised the question of whether Tamil Nadu CM M. K. Stalin raised the Mullaiperiyar Dam issue or the Cauvery river dispute with Kerala CM Pinarayi Vijayan and Karnataka Deputy CM DK Shivakumar, who had attended the DMK's delimitation meeting.

TPN Correspondent | Manipur A team of Supreme Court judges, led by Justice BR Gavai, visited relief camps in Manipur's Churachandpur and Bishnupur districts on Saturday, assuring the displaced people that peace would soon return to the state. The judges distributed essential supplies and inaugurated legal services and medical camps to support those affected by the ongoing ethnic conflict.

Justice Gavai, who is also the execu-

tive chairman of the National Legal Services Authority (NALSA), virtually launched new legal aid clinics in Imphal East, Imphal West, and Ukhrul districts. He was accompanied by Justices Vikram Nath, MM Sundresh, and KV Vishwanathan. Manipur High Court Chief Justice D Krishnakumar and Justice Golmei Gaiphulshilu also participated in the visit.

Justice N Kotiswar Singh, a member of the Meitei community, refrained from visiting Churachandpur after the local bar association objected to his presence, citing concerns that his visit might be misinterpreted and provoke tensions. Churachandpur is a Kuki-dominated district.

Addressing the relief camp residents, Justice Gavai emphasized unity and the strength of the Indian Constitution. "Our country is a true example of unity in diversity. Wherever people are in difficulty, the entire nation comes together to support them," he said. He urged the displaced individuals to trust in the Constitution and assured them that the combined efforts of the executive, legislature, and judiciary would restore peace in the region. The visit comes nearly two years after the violent clashes that erupted on May 3, 2023, between the

### Kerala Governor Rajendra Criticizes SFI Banner Against Savarkar at **Calicut University**

- Governor Arlekar Calls for De-Politicization of family or affairs. **Educational Institutions**

Kerala Governor Rajendra Vishwanath Arlekar, who also serves as the Chancellor of State universities, expressed criticism over a controversial banner displayed by the Students Federation of India (SFI) at the University of Calicut, located in Tenhipalam, Malappuram district. The banner, which was put up several months ago during protests against former Governor Arif Mohammed Khan, reads, "We need a Chancellor and not Savarkar."

The Governor, who attended a Senate meeting at the university on March 22, 2025 — a historic first for the institution — was reportedly taken aback by the banner. In response, he raised questions about the criticism of Vinayak Damodar Savarkar, an Indian independence activist and freedom fighter, asking, "Was Savarkar an enemy of this country?" He emphasized that Savarkar had dedicated his life to the service of others, never prioritizing his own

"I was just reading a banner there now. The Chancellor is here with you. You do whatever you want suggest university security failed to remove to do with the Chancellor. But what bad things have

Savarkar done?" Governor Arlekar said, referring to the provocative banner. He went on to assert that Savarkar's life was one of sacrifice and service to the nation.

Arlekar further emphasized the need for the university to remain free of political influence, urging Vice-Chancellor P. Raveendran to ensure the educational system and institutions remain unaffected by political agendas. His remarks reflect his concerns about the increasing politicization of academic spaces in the state.

Earlier reports indicated that Vice-Chancellor

Raveendran had ordered the removal of the controversial banners and posters, but SFI activists reportedly resisted these efforts, leading to tensions between university authorities and the student group.

The Governor's remarks highlight the ongoing debate over political activism in educational institutions and its potential impact on academic independence.

### AIIMS can take the lead to bring gender parity in healthcare: **President Murmu**

President Droupadi Murmu, during her address at the 49th convocation ceremony of the All India Institute of Medical Sciences (AIIMS) in Delhi on Friday, expressed concerns about the early stages at which some female patients seek treatment for heart ailments and other health conditions. Speaking at Bharat Mandapam, she highlighted that many women tend to visit healthcare facilities when their medical issues have already progressed to

a more severe stage, which could impact the effectiveness of treatment.

"It is of course a larger social issue," President Murmu remarked, acknowledging that this concern is part of a broader societal problem. However, she also emphasized the role of AIIMS in addressing this gap, urging the institution to take a leadership role in promoting gender parity in healthcare protocols. She suggested that AIIMS, as one of the premier medical institutions in the country, could launch a nationwide campaign to raise awareness and encourage women to seek medical help at an earlier stage of illness, thereby preventing the progression of diseases.

Her remarks reflect a growing recognition of the unique challenges women face in accessing healthcare, particularly in areas where heart diseases and other health issues are often diagnosed later than in men.



The president's call for gender-sensitive healthcare protocols aims to ensure that women receive timely medical attention and are not sidelined in terms of medical research and treatment approaches.

The 49th convocation ceremony of AIIMS Delhi was held at Bharat Mandapam, where the president also felicitated awardees for their academic achievements. Her speech underscored the importance of evolving healthcare systems that cater to the needs of both men and women equally and encouraged medical professionals to consider gender-based health disparities when treating patients.

President Murmu's address comes at a critical time, as the country continues to work toward improving healthcare accessibility and quality for all its citizens, with particular attention to addressing gender imbalances in healthcare outcomes.

#### EV insurance demand surges 16x in just 3 years, **Delhi-NCR leads with 18.3% market share**

TPN Correspondent | New Delhi The demand for Electric Vehicle (EV) insurance in India has experienced a remarkable surge, growing 16-fold in just three years, as per internal data from Policybazaar. This significant rise in EV adoption has been accompanied by a growing recognition of the need for specialized insurance coverage to protect these vehicles.

According to a report by the private sector insurer, the share of insurance policies for elec-

tric cars has increased substantially, from a modest 0.50% in FY23 to 14% by March 2025. The growth rate indicates a major shift toward electric mobility in the country. Specifically, the EV insurance share for electric cars now stands at 8.2%, marking a steep rise in the number of electric vehicle owners seeking tailored insurance solutions.



cer (CBO) of General Insurance at Policybazaar, highlighted that this trend signals India's ongoing shift towards sustainable mobility. "The accelerating adoption of EV insurance reflects not only the growing adoption of electric vehicles but also an increasing awareness of the necessity for specialized protection," Chhabra commented.

reveals a significant rise in the number of insured two-wheeler EVs, which now account for 7-8% of all two-wheeler insurance policies under five years. The rise in EV insurance uptake highlights the growing importance of safeguarding electric vehicles, which often require different coverage compared to

conventional vehicles due to their unique components, such as batteries and electric powertrains. As the Indian market continues to shift towards electric mobility, it is expected that the demand for EV insurance will continue to grow, paving the way for more insurers to develop customized policies for these environmentally friendly vehicles.

### **Kashmir Remarks Highlights Zero-Tolerance Policy on Terrorism**

Union Home Minister Amit Shah, in a sharp retort to Congress leader Rahul Gandhi, criticized the opposition leader's comments during his 2023 Bharat Jodo Yatra in Kashmir. Speaking in the Rajya Sabha on March 21, 2025, Shah questioned Gandhi's ability to understand the development in Jammu and Kashmir, remarking, "If someone is sitting with kaala chashma [black glasses] on, how is it possible to show them the development?"

Referring to Gandhi's statement made during his Kashmir visit, where he claimed to have seen terrorists from afar, Shah mocked, "One leader went on a foot march, played Holi with snow with his karyakartas and then claimed he saw terrorists from afar." He further added. "If someone has terrorists in their mind, they will see them even in their dreams and in Kashmir."

Shah also reiterated the Modi government's firm stance on counter-terrorism. emphasizing its 'zero-tolerance' approach. "Whenever we see a terrorist, we shoot right between the eyes. Our government can neither tolerate terrorism nor terrorists," he asserted.

Under the leadership of Prime Minister Narendra Modi, Shah highlighted the sig-



nificant reduction in terrorism-related deaths in Jammu and Kashmir. He noted that the Modi government had introduced a policy of firm action against terrorism. He recalled incidents like the Uri and Pulwama attacks, where the government responded swiftly with surgical and airstrikes within days of the attacks.

Amit Shah Targets Rahul Gandhi Over

Additionally, Shah outlined the government's efforts to strengthen internal security across the country, including tackling Maoism. He expressed confidence that Naxalism would be eradicated by March 21, 2026. "I say it with responsibility: Nax-

alism will be eliminated by the end of our term," he declared, emphasizing the comprehensive steps taken to eliminate the Maoist threat.

Shah's speech also touched on the measures implemented to combat drug abuse, address the challenges in the Northeast, and provide accurate intelligence to security forces handling the Maoist insurgency. He concluded with a message for those who view Naxalism as a mere political issue, stating that it is a serious security challenge that would be dealt with effectively by his government.

The Trinamool Congress (TMC) has announced that it will not send any representatives to the March 22 meeting of States over the delimitation issue, which has been called by Tamil Nadu Chief Minister M.K. Stalin in Chennai. A source within the ruling party of West Bengal confirmed this decision on Friday.

The source explained that the Trinamool Congress considers the issue of duplicate voter ID numbers to be more pressing at the moment. The party believes that this matter could significantly impact the upcoming Assembly elections in several states, including Bihar, Kerala, Tamil Nadu, and West Bengal.

The source emphasized that while the delimitation discussions are important, the duplicate voter ID issue takes electoral reforms like delimipriority, especially with the tation.

elections in Bihar scheduled for later this year, and those in Kerala, Tamil Nadu, and West Bengal due in 2026.

The meeting, which is being led by Stalin and his party, the DMK, aims to address the concerns surrounding delimitation, a process that involves redrawing electoral boundaries. The DMK has reached out to seven states, including Kerala, Karnataka, Andhra Pradesh, Telangana, Odisha, West Bengal, and Punjab, for participation in the meeting.

Despite the invitation, the Trinamool Congress has opted not to attend, focusing instead on the duplicate voter ID issue, which could potentially affect voter registration and the electoral process in the aforementioned states. The decision reflects the party's priority in addressing immediate concerns over long-term

In a strategic move to strengthen its hold on municipal governance, Assembly Speaker Vijender Gupta has nominated 14 MLAs to the Municipal Corporation of Delhi (MCD). This decision boosts the Bharatiya Janata Party (BJP)'s bid to secure the mayoral position in the upcoming elections scheduled for next month.

Out of the 14 nominated MLAs, 11 are from the BJP, and three are from the Aam Aadmi Party (AAP). These nominated members will participate in the voting process for the election of the Mayor and Deputy Mayor, which will take place in April. Gupta stated that the nominated MLAs would help the MCD with budget formulation, civic administration, and urban governance.

The BJP MLAs nominated to the MCD include Anil Sharma, Chandan Choudhary, Jitender Mahajan, Karnail Singh, Manoj Kumar Shokeen, Neelam Pahalwan, Parduymn Singh Rajput, Raj Kumar Bhatia, Ravi Kant, Sanjay Goyal, and Tarvinder Marwah. The three AAP MLAs nominated are Pravesh Ratn, Surendra Kumar, and Ram Singh Netaji.

The AAP won the last mayoral election held in November 2024 by a narrow margin of three votes. However, with the BJP's decisive victory in the February 2025 Delhi Assembly elections, the party is now focused on securing a "triple-engine government" by winning the mayoral post in the MCD. A senior BJP functionary noted that the nomination of 11 party MLAs significantly boosts the chances of winning the Mayor's post. Additionally, the BJP has reportedly received interest from several AAP councillors expressing a desire to join their ranks.

The BJP's victory in the Delhi Assembly polls, where it secured 48 out of 70 seats, has given the party an upper hand in the MCD. The AAP managed only 22 seats, signaling a shift in political power. With the recent defections of three AAP councillors to the BJP, the party now controls the largest number of seats in the MCD, further consolidating its position as it prepares for the upcoming mayoral election.

Maharashtra Chief Minister Devendra Fadnavis on Saturday declared that the government would recover the cost of public property damaged during the recent violence in Nagpur from the rioters responsible. Following a review meeting with police officials regarding the incidents, Fadnavis stated that if the rioters failed to compensate for the damage, their property would be seized, and "bulldozer" action would be taken if necessary.

"Whatever damage has happened will be recovered from the rioters. If they do not pay the money, their property will be sold for the recovery. Wherever required, bulldozers will also be used," Fadnavis said, as quoted by ANI. This stern warning came after the clashes that broke out on March 17, allegedly sparked by rumors that a "chadar" with holy inscriptions had been burned during protests led by the Vishwa Hindu Parishad (VHP), demanding the removal of Mughal emperor Aurangzeb's tomb in Chhatrapati Sambhajinagar.

Fadnavis also warned that police action would be taken against anyone involved in the riots, as well as those aiding the rioters. The authorities are also cracking down on those spreading rumors on social media, with 68 social media posts already identified and deleted. "Those who spread rumors on social media will also be made co-accused," Fadnavis said.



### **Ahead of Ayushman Bharat Launch, Delhi Doctors Discuss Payment Delays and with CM**

DMA and other healthcare professionals are urging a time-bound payment system

## After three-month delay, high drama marks Bar Council polls in Delhi

#### **Chaos and Controversy Mark Bar Council Elections**

However, the lack of proper organization and the failure to adhere to guidelines raised serious concerns about the conduct of the elections and the state of the Bar Council itself.

### **Delhi Police Dismantle Illegal Bangladeshi Immigration Network, Arrest 8**

The Delhi Police have successfully dismantled a network facilitating illegal Bangladeshi immigration, arresting eight individuals, deporting six Bangladeshi nationals, and placing four others under investigation, according to officials. The operation, which uncovered a large-scale identity fraud scheme, led to the arrest of both foreign nationals and Indian citizens implicated in the operation.

Authorities say that Moinuddin, along with his associates, played a pivotal role in enabling illegal immigrants to obtain forged documentation that allowed them to seamlessly integrate into Indian society. A significant part of the operation relied on corrupt Aadhaar agents who helped the illegal immigrants gain official recognition in the country.

The police seized a variety of fraudulent documents during the crackdown, including 23 voter IDs, 19 PAN cards, 17 Aadhaar cards, 11 fake birth certificates, and six blank voter ID cards. Additionally, a computer system used for document forgery was recovered, which further helped in establishing the scope of the illegal operation.

### **Punjab Farmers' Bodies Reject Government's Invitation** for Talks Amid Crackdown

Government's invitation for dialogue, citing a crackdown on protesters

Amid escalating tensions and a crackdown on protesting farmers by Punjab Police, the Samyukt Kisan Morcha (SKM) and Bharti Kisan Union (Ugrahan) (BKU Ugrahan) on Friday, March 21, 2025, declined to participate in a meeting called by the Punjab government. The meeting was intended to discuss the ongoing protests and the farmers' planned march to the Assembly on March 26.

Farmers' bodies strongly criticized the actions of the Aam Aadmi Party (AAP)led government, accusing them of suppressing dissent through police force. They called for the creation of a more conducive environment for meaningful talks and demanded the immediate release of detained protesters. SKM, in particular, announced that it would talks would not be possible under these er unrest.

The Punjab government had invited SKM and BKU (Ugrahan) for a dialogue with Agriculture Minister Gurmeet Singh Khuddian. The invitation was issued ahead of SKM's planned march to the state capital. However, the farmer leaders rejected the offer, stating that the current climate, marked by the police action, was not conducive for productive discussions.

BKU (Ugrahan) President, Joginder Singh Ugrahan, expressed that while the body supports dialogue, the prevailing circumstances raised questions about whether it was appropriate to hold the meeting at all. The SKM leaders echoed similar sentiments, highlighting that

### We shall overcome someday: **Supreme Court judges' peace** message in Manipur

A delegation of Supreme Court judges, led by Justice BR Gavai, visited displaced people in Manipur on Saturday, offering reassurance that peace would soon return to the state, which has been marred by ethnic violence.

Addressing internally displaced individuals in Churachandpur district, Justice Gavai expressed solidarity with the victims and said, "Peace will soon return to Manipur. We know that all of you are going through a difficult phase, but with the assistance of everyone, this phase will pass in a short period. Have faith in the constitution. Our constitution will ensure that peace will return fully one day. One day, we will overcome it."

During their visit, the judges toured relief camps, virtually inaugurating several initiatives, including legal services camps, legal aid clinics, and temporary medical facilities from the Mini Secretariat in Churachandpur. They are scheduled to visit another relief camp at Moirang College in Bishnupur district later.

Justice N Kotiswar Singh, a member of the delegation and a Meitei community member, did not visit

Churachandpur, which has a Kuki-majority population, following objections from a local lawyers' body. Instead, Justice Singh is expected to visit Bishnupur district. The All Manipur Bar Association (AMBA) has called on the Churachandpur Bar Association to withdraw its directive preventing a Meitei Supreme Court judge from visiting the Kuki-Zo-dominated area.

Congress MP Jairam Ramesh also commented on the Supreme Court judges' visit, calling it a positive step but raised questions about the central government's handling of the situation. "Supreme Court judges are in Manipur, which is a good thing. Sixty thousand people have been displaced, and hundreds have been killed. There is an atmosphere of fear in society. Why has the Prime Minister not visited Manipur? He doesn't answer this. Why was President's Rule imposed so late? There is no answer," Ramesh remarked.

The ongoing ethnic violence, which erupted in May 2023, has claimed over 250 lives and left thousands homeless, as clashes between the Imphal Valley-based Meiteis and the Kuki-Zo groups from the hills continue to escalate.

The opening match of the 2025 Indian Premier League (IPL) between Kolkata Knight Riders (KKR) and Royal Challengers Bangalore (RCB) is at risk due to adverse weather conditions. The highly anticipated game, scheduled for March 22 at Kolkata's Eden Gardens, is facing potential rain disruptions.

The India Meteorological Department (IMD) has issued an "orange alert" for parts of West Bengal, forecasting "light to moderate rainfall with thunderstorms, lightning, and gusty winds" across the region, including Kolkata, on the day of the match. The weather department predicts that the city will experience a thunderstorm, with temperatures ranging between 22°C and 29°C.

On the eve of the match, rain caused disruptions to the practice sessions for both teams. KKR and RCB had to cut their practice short as steady drizzle started around 6 pm, forcing the ground staff to take action to protect the pitch. Both teams, who had begun practice at 5 pm, were forced to wrap up early due to

the weather.

The IPL opener is set to start at 7:30 pm, with the toss scheduled for 7:00 pm. However, the uncertainty surrounding the weather could delay or even cancel the match. In addition to the game, the opening ceremony will feature performances from Shreya Ghoshal, Karan Aujla, and Disha Patani, adding to the excitement.

The reigning champions, KKR, will take the field under the captaincy of Ajinkya Rahane, while RCB will be led by Rajat Patidar. Both teams boast star-studded lineups. KKR's squad includes players like Andre Russell, Sunil Narine, and Quinton de Kock, while RCB features Virat Kohli, Josh Hazlewood, and Liam Livingstone.

With the weather forecast uncertain, fans will be eagerly awaiting updates, hoping for clear skies and an uninterrupted start to IPL 2025.

#### Mumbai

Efforts are underway to control a massive fire that erupted late Friday night at the Maharashtra Industrial Development Corporation (MIDC) area in Shiravane, Navi Mumbai. Fire officers reported that the blaze broke out around 11 PM and quickly spread, prompting a large-scale response from the local fire brigade.

New Ragging Allegations Surface at Jadavpur University Amid Ongoing Struggles for Justice

Fresh allegations of ragging have emerged at Kolkata's Jadavpur University, 19 months after a tragic incident in which a student lost his life due to ragging inside the university's hostel. This marks the third reported case of ragging at the prestigious institution.

The latest incident reportedly took place on March 18, when a second-year postgraduate student visited the university's main hostel to meet a friend. According to the student, he was subjected to verbal abuse and harassment for several hours. The perpetrators allegedly threatened to rape his mother and forced him to write an apology letter for "spreading fake news about the ragging culture" at the university.

The victim, a Film Studies department student, shared his frustrations with The Hindu, stating that he had been vocal about the issue of ragging since the tragic death of a student on August 9, 2023, following a ragging incident. The victim believes that he has been targeted by a group of 10-12 known offenders who perpetuate the "ragging culture" inside the hostel. However, he emphasized that he does not believe the entire



university promotes this behavior. "Seniors, juniors, professors, and classmates have shown support. This issue is about specific individuals and should not tarnish the reputation of the entire institution," he added.

In response to the complaint, Jadavpur University's interim Vice Chancellor, Bhaskar Gupta, confirmed that an official complaint had been received and an inquiry committee had been formed. "We will thoroughly investigate the matter," he assured.

The new allegations bring back painful memories of the August 9, 2023, incident when a 17-yearold first-year student was ragged, sexually abused, and later found dead in the hostel. The victim's father, Ramprasad Kundu, expressed his ongoing frustration. He questioned why the university was allowing known abusers to remain scot-free and interact with students. He added that if this culture continued, parents would stop sending their wards to the university even if it was known as one of the best in the State.

## **Govt vs farmers Escalating Tensions Between Govt and Farmers Threaten Punjab's Stability**



 $P {\rm unjab}$  is witnessing increasing tension following the eviction of protesting farmers from Shambhu and Khanauri, a development that has exacerbated the divide between the state government and the farming community. The government's justification for its actions centers on the disruption caused to industries and businesses due to the prolonged closure of vital highways. However, farmer leaders see the move as an oppressive effort to curtail their democratic right to protest.

This clash between the two sides signals a worrying escalation in an already tense situation.

It is unfortunate that both parties have failed to find common ground. In a moment of heightened tensions, they should have come together to exert pressure on the central government to meet the farmers' demands, particularly the provision of a legal guarantee for Minimum Support Price (MSP) for all crops. Instead, the two

sides are locked in a bitter confrontation, with the farming unions losing public support, which has, in turn, empowered the state government to take a firmer stance. Meanwhile, the central government observes passively from the sidelines.

The situation can no longer afford to spiral further. It is imperative for all stakeholders to engage in sincere dialogue with a commitment to resolving the crisis promptly. A flexible and cooperative approach will be essential for all sides to find a mutually beneficial resolution. The central government must learn from its mishandling of the 2020-21 farmer protests at Delhi's borders, which led to the eventual repeal of three controversial farm laws but failed to address the MSP issue.

At the same time, the state government must explain its change in stance after initially positioning itself as a mediator for farmers' rights. While Punjab's economy does need a trade boost, agriculture, which remains its backbone, cannot be sidelined. Both sides must work toward reconciliation to prevent the ongoing unrest from dragging the state further into turmoil.

## **BJP Leader Shoots Wife and Children in Uttar Pradesh, Two Killed**

In a shocking incident in Uttar Pradesh's Saharanpur district, a local BJP leader, Yogesh Rohilla, allegedly shot his wife and three children in the Gangoh police station area. The brutal attack resulted in the death of his son and 11-year-old daughter, while his wife and another child remain in critical condition. The incident has left the local community in shock and raised concerns about domestic violence and unchecked aggression. According to police reports, Rohilla, who holds the position of BJP executive member, was arrested at the scene shortly after the crime. The police also recovered the pistol used in the attack. Senior police officials, including Saharanpur SSP Rohit Sajwan, immediately rushed to the location after receiving reports of the incident. Preliminary investigations suggest that Rohilla acted out of suspicion regarding his wife's character, which allegedly fueled his violent outburst.

SSP Sajwan confirmed that the leader had been under significant mental stress in the days leading up to the incident. However, he had not shared his concerns with neighbors or anyone else in his social circle. The police are now trying to determine whether his suspicions had any basis or if they were the result of paranoia and undue stress. The crime took place in Sangatheda village, leaving residents horrified and fearful. Police officials, along with forensic teams, have launched a thorough investigation to piece together the



sequence of events. Authorities are also questioning the accused to gather more details and understand his motive more clearly. Eyewitness accounts and preliminary findings suggest that after committing the crime, Rohilla himself called the police to report the incident. This led law enforcement officers to the scene, where they found the two children dead and the other victims critically injured. His wife and the surviving child were immediately rushed to Saharanpur District Hospital, where they are currently undergoing treatment.This tragic case has once again brought attention to the rising instances of domestic violence and crimes driven by suspicion and mental distress. The deaths of the two children have sparked widespread outrage, with many demanding stricter laws to prevent such incidents. Authorities have assured a thorough investigation, and the accused will face legal consequences based on the findings. Meanwhile, the community remains in shock, mourning the innocent lives lost in an act of extreme violence.

#### **Jairam Ramesh Questions** PM Modi's Absence as SC Judges Visit Manipur




Congress MP Jairam Ramesh welcomed the visit of a Supreme Court delegation to Manipur but questioned when Prime Minister Narendra Modi would visit the conflict-ridden state. Speaking to ANI, Ramesh stated, "We welcome the six Supreme Court judges who have visited Manipur. In the past 22 months, hundreds have died, and around 60,000 people remain displaced in relief camps. Even today, fear and uncertainty persist among communities. While President's Rule was imposed on February 13, the real question is why it took 18 months to act after the Supreme Court declared on August 1, 2023, that the constitutional system in Manipur had collapsed. It is good that Supreme Court judges have visited, but when will the Prime Minister go?" A delegation of six Supreme Court judges, including Justices BR Gavai, Surya Kant, Vikram Nath, MM Sundresh, KV Viswanathan, and N Kotishwar, visited a relief camp in Churachandpur, Manipur, on Saturday to assess the ongoing crisis. Ramesh also criticized Union Home Minister Amit Shah, accusing him of ignoring Manipur during discussions on the Ministry of Home Affairs (MHA) in Parliament. "Yesterday, the Home Minister spoke for four hours in the Rajya Sabha about his ministry's work, yet he barely mentioned Manipur. In February 2022, the NDA won the state elections with a massive majority, but within 15 months, Manipur was in flames. Why hasn't the Prime Minister visited?" Ramesh questioned. The Congress leader further criticized the delay in imposing President's Rule and noted that Amit Shah visited Mizoram but not Manipur. "There is no explanation for why it took so long to impose President's Rule. The Home Minister went to Mizoram but avoided Manipur. Even statements made by the Mizoram Chief Minister after visiting America raise serious concerns," he added. Ramesh urged PM Modi to visit Manipur before or after his upcoming trip to Bangkok for the BIMSTEC Summit from April 2-4. "We hope that on his way to Bangkok or while returning, the Prime Minister takes time to visit Manipur. His visit is crucial for providing a healing touch," he said. Manipur has been in turmoil since May 3, 2024, when violence erupted following protests by the All Tribals Students Union (ATSU) against the demand for Scheduled Tribe status for the Meitei community.

## **Meerut Murder Victim's Mother Demands Justice**, **Custody of Granddaughter**

The mother of Saurabh Rajput, a Meerut man allegedly murdered by his wife Muskan Rustogi and her lover Sahil Shukla, has made an emotional plea for justice. She has urged Prime Minister Narendra Modi and Uttar Pradesh Chief Minister Yogi Adityanath to intervene and ensure the strictest punishment for those responsible. Expressing her grief and anger, she has also demanded custody of her granddaughter, fearing for the child's safety. Saurabh's mother voiced her deep anguish over the tragic incident and questioned the well-being of her granddaughter, who remains with Muskan. "She is our granddaughter; we have the right to see her. If the mother could harm her own husband, what if she did something to the child too? We haven't seen her since the incident, and we want to keep her with us," she stated. Her concern stems from the brutal nature of the crime, which has left the family shattered and desperate for justice. The case has sent shockwaves in determining the fate of the accused across the region, with many calling for swift legal action against the accused. Reports suggest that Muskan and Sahil conspired to kill Saurabh, allegedly due to an extramarital affair. The murder,

which was reportedly premeditated, has raised serious concerns about the safety and well-being of their child. The victim's family insists that given Muskan's alleged involvement in such a heinous act, she should not be entrusted with the responsibility of raising the child. ### Trump pulls security clearances for Biden, Harris and Hillary Clinton

U.S. President Donald Trump took an unprecedented step by revoking the security clearances of several prominent political figures, including former President Joe Biden, former Vice President Kamala Harris, former Secretary of State Hillary Clinton, and others. ## India's Forex Reserves Rise to **\$654.27 Billion in March 2025**

India's foreign exchange (forex) reserves reached \$654.27 billion for the week ending March 14, 2025, marking an increase of \$305 million, according to data released by the Reserve Bank of India (RBI) on Friday. This increase follows a substantial surge in the previous week, when the reserves had risen by \$15.26 billion to reach \$653.97 billion for the week ending March 7, 2025.

The RBI's Weekly Statistical Supplement detailed various components of the country's forex reserves. Foreign Curren-

cy Assets (FCAs), which are a major component of the reserves, decreased by \$96 million to \$557.19 billion. FCAs represent assets held in foreign currencies, including the euro, pound, and yen, and their value is affected by the appreciation or depreciation of these currencies against the US dollar.

Gold reserves, on the other hand, saw a significant increase of \$66 million, rising to \$74.391 billion. This reflects the continued strength in the global gold market. The Special Drawing Rights (SDRs), another key component of the reserves, increased by \$51 million to \$18.26 billion. Furthermore, India's reserve position with the International



Monetary Fund (IMF) rose by \$283 million, reaching \$4.4 billion.

India's forex reserves are closely monitored as an important indicator of the country's economic health, especially in terms of foreign trade and currency stability. The rise in reserves indicates a positive trend in India's ability to manage external economic shocks and maintain financial stability.

The RBI releases weekly data on India's forex reserves every Friday, offering insight into the nation's financial standing and its capacity to withstand external pressures, especially in a rapidly changing global economy.



## **Antarctic Ice Melt** Weakens Key Ocean Current

**S**that rapid Antarctic ice melt is weakening the powerful Antarctic Circumpolar Current (ACC), which plays a crucial role in global ocean circulation. A recent study projects that the ACC could slow down by 20% by 2050, leading to significant impacts on sea levels, temperatures, and marine ecosystems worldwide. According to research published in Environmental Research Letters, a team led by Bishakhdatta Gayen from the University of Melbourne used advanced climate simulations to analyze how the influx of

Ccientists have warned cold meltwater from Antarctica is altering ocean dynamics. The study found that this fresh meltwater disrupts ocean density and weakens convection between surface and deep waters, slowing the ACC.

> The consequences of this slowdown are alarming. A weaker ACC could allow warm ocean waters to reach deeper into Antarctic waters, accelerating ice melt and contributing to rising global sea levels. Scientists also warn that the current's weakening may enable invasive marine species to reach Antarctica, threatening its

fragile ecosystem. Speaking to Live Science, Gayen compared the process to a "merry-goround," explaining that as the current slows, marine organisms could migrate toward Antarctica at an increased rate. Scientists emphasize the need for long-term monitoring to fully understand the ACC's changing behavior and its global implications. With ocean circulation patterns already shifting due to climate change, the weakening of Earth's

strongest current adds to concerns about long-term disruptions in global climate systems.






