P4 Policy to be Launched in Amaravati on Ugadi

- 20 lakh families to benefit in the first phase
- Initiative to bridge the gap between rich and poor

Andhra Pradesh Chief Minister Nara Chandrababu Naidu has given final shape to the P4 policy, launching it on the occasion of Ugadi in Amaravati. This initiative aims to create a collaborative effort between the rich and the poor, ensuring equal opportunities for all.

During a review meeting at the Secretariat, CM Naidu explained the P4 policy's framework, stating that anyone, including NRIs, can voluntarily participate in supporting underprivileged families.

Those who assist in implementing this policy will be regarded as guides, while the beneficiary families will be recognized as golden families.

As part of the execution plan, village and ward assemblies will prepare a list of beneficiary families, with 20 lakh families benefiting in the first phase. The Chief Minister reiterated that the government is committed to eradicating poverty by 2029 and that this program will play a crucial role in achieving that goal. CM Naidu emphasized that P4 is an independent initiative and is not linked

to any government welfare schemes. The program will continue without interruption, focusing solely on uplifting the weaker sections of society. He assured that the government will ensure effective implementation, making it a model for poverty alleviation.

AP Govt Committed to Creating 20 Lakh Jobs by 2029, Says **Minister Nara Lokesh**

Education and IT Minister Nara Lokesh reaffirmed the government's commitment to generating 20 lakh jobs in Andhra Pradesh by 2029. The second meeting of the sub-committee of ministers on job creation was held at his Undavalli residence, where officials presented a PowerPoint briefing on investments, job creation, and the status of

According to the report, agreements signed so far are expected to bring investments worth ₹8,73,220 crore, creating employment opportunities for 5,27,824 people. Minister Lokesh, who chairs the sub-committee, directed officials to enhance the Investment Tracker Portal by integrating all details related to land allotments and permissions. He emphasized the need for policy reforms to eliminate hurdles for investors and attract global and domestic companies. He also assured that industries already established in the state would receive necessary incentives to expand further.

"Several industrialists are keen on investing in the state. We must ensure quick land allotments, permissions, and subsidies to facilitate their ventures. The MSME sector will play a crucial role in job creation, and we will actively support its growth. ITIs and polytechnics should be leveraged to provide skilled manpower. Additionally, we must focus on port development and tourism investments,"

He also highlighted opportunities in the mining sector and called for efforts to boost investments in this area. The meeting was attended by Industries Minister TG Bharat, Power Minister Gottipati Ravikumar, Urban Development Minister P. Narayana, MSME and SERP Minister Kondapalli Srinivas, Mines Minister Kollu Ravindra, and senior officials Ajay Jain, N. Yuvraj, Katamaneni Bhaskar, Praveen Kumar, Saikanth Verma, and M. Abhishek Kishore.

Swiggy Delivery Boy Attacked by Apartment Owner for Calling Him 'Bro'

- Delivery worker assaulted for addressing customer as 'bro'
- Security personnel allegedly involved in the attack
- Protests by delivery workers demand action against accused

A routine food delivery in Visakhapatnam's Seethamadhara area took a violent turn when a Swiggy delivery boy was allegedly attacked by an apartment owner simply for calling him "bro."

The incident occurred at Block B of Oxygen Towers, where Prasad, a resident, had ordered food through Swiggy. Delivery worker Anil arrived at the apartment and rang the doorbell. A woman answered but did not understand what Anil said, so she informed Prasad, who came out to collect the order.

As Anil handed over the parcel, he reportedly said, "Your food parcel has arrived, bro." The simple remark enraged Prasad, who took offense at being addressed informally. "How dare you call me bro instead of sir?" he allegedly shouted before attack-



ing Anil. What started as an argument quickly escalated, with Prasad and security personnel allegedly assaulting the delivery worker. Reports suggest that they stripped Anil down to his underwear and forced him to stand outside the apartment gate in humiliation. To make matters worse, they allegedly made him write an apology letter.

As news of the incident spread, rumours surfaced that Anil, devastated by the humiliation, had attempted suicide. This triggered an outpouring of anger among delivery workers, who gathered outside Oxygen Towers in protest. They demanded immediate action against Prasad and those involved in the

Amid rising tensions, Dwarka ACP Annepu Narasimhamurthy arrived at the scene and spoke to Anil over the phone, ensuring that he was safe. The protesters calmed down after the ACP assured them that legal action would be taken if Anil filed a formal complaint.

CM Naidu Directs Officials to Prevent Drinking Water Shortage in Summer

- CM reviews summer action plan, orders preventive measures
- Free buttermilk distribution to resume statewide
- ₹39 crore released to address drinking water shortages

With rising temperatures across Andhra Pradesh, Chief Minister Nara Chandrababu Naidu has directed officials to ensure no region faces a drinking water shortage. Chairing a review meeting on the summer action plan at the Secretariat, he instructed the Disaster Management, Panchayat Raj, Municipal, and Health departments to take necessary precautions.

The CM emphasized early warnings about extreme heat and advised officials to alert the public via mobile notifications. He also called for setting up cold storage and buttermilk distribution centers at markets, bus stands, and labor camps, recalling a similar initiative from 2014–19. Urging voluntary organizations to participate, he assured government support for these efforts.

Addressing the drinking water crisis in Rayalaseema and Prakasam districts, Chandrababu Naidu ordered the construction of 12,138 water tanks in villages at a cost of ₹35 crore, ensuring water availability for cattle and rural households. He reiterated the coalition government's commitment to public welfare and urged officials to act swiftly. The CM approved ₹39 crore to resolve water shortages in municipalities. He suggested

villages construct farm ponds through NRE-GA and undertake pond desilting to improve



water storage. He also directed officials to provide NREGA laborers extra working days in summer, along with water, ORS packets, and necessary facilities.

To prevent heat-related illnesses, municipal workers will not be assigned outdoor tasks between 12 PM and 4 PM. The CM also instructed hospitals to ensure adequate beds, doctors, and treatment facilities for sunstroke cases. Additionally, special efforts will be made for mosquito control in tribal areas to prevent disease outbreaks.

Hailstorm to Continue in AP for Four More Days

Unseasonal rains and hailstorms have caused severe damage to crops in several districts of Andhra Pradesh, leaving farmers in distress. The Meteorological Department has warned that the adverse weather will persist for another four days, with thunderstorms and strong winds expected.

Officials stated that cumulonimbus clouds are triggering the thunderstorms, while a surface circulation extending from Vidarbha to Tamil Nadu, reaching 1.5 km above sea level, is influencing the weather patterns. Due to the increased risk of lightning strikes, authorities have advised people to take precautions and avoid open areas and trees during thunderstorms.

With crops already suffering extensive damage, farmers are deeply concerned about further losses. The state government is expected to assess the situation and extend necessary support to the affected farmers. Officials are closely monitoring the conditions and may initiate relief measures to minimize losses.



Govt Focuses on WhatsApp Governance & Speed Up Data Connectivity

He emphasized the need for seamless digital infrastructure to enhance governance through WhatsApp and other digital platforms. In a recent review meeting, Vijayanand instructed officials to assess RTGS operations and improve data-driven decision-making. He stressed the importance of expanding WhatsApp governance to make government services more accessible to people in both urban and rural areas. The WhatsApp governance model, introduced in Andhra Pradesh, allows citizens to access government services, lodge complaints, and receive updates directly on their mobile phones. He asserted that they never applied for land in Amaravati and had legally purchased land at a high price in 2009 during the Congress regime through public auction. He criticized Rajani for making baseless claims without understanding the difference between land auction and land allotment.

He stated that she had not returned the money taken from them and questioned whether she had attempted to stop the case by sending mediators.

He urged Rajani to stop misleading the public and face legal scrutiny instead of making false allegations for political mileage.

YS Jagan Slams NDA Government for Halting Crop Insurance

Former Chief Minister YS Jagan Mohan Reddy toured rain-affected areas in Kadapa district on Monday, inspecting banana, papaya, and other damaged crops in Pulivendula and surrounding villages. He visited Thathireddypalli, Vempalle, and Lingala, interacting with distressed farmers to understand their losses due to untimely rains and storms.

Speaking to the media, Jagan criticized the coalition government, accusing it of halting crop insurance and farmer assurance funds that were provided during his tenure. MP Lavu Srikrishna Devarayalu made explosive revelations in the Lok Sabha, exposing the alleged liquor scam under the previous YSRCP government in Andhra Pradesh. He claimed that the scam, led by former CM Jagan Mohan Reddy, was even bigger than the Delhi liquor

According to Devarayalu, ₹2,000 crore was transferred to Dubai

Reddy, under the guise of an infrastructure company. Additionally, 26 newly established firms, including Adan, Graysons, Leela, JR Associates, and PV Spirits, reportedly made massive profits through illicit means. He alleged that even before liquor production began, fraudulent transactions took

Further, the MP stated that substandard liquor was produced and ₹1,000 crore was funneled to traders linked to the ruling party at the time. He emphasized that the AP state government has already ordered a CID probe into the matter but urged the central government to intervene due to the involvement of foreign transactions.

With mounting pressure for a high-level investigation, the AP liquor scam is likely to trigger major political repercussions in the state.



Vigilance Inquiry Ordered Against Tammineni Sitaram Over Fake Degree Allegations

The Andhra Pradesh government has ordered a Vigilance & Enforcement inquiry against former Speaker and YCP Srikakulam parliamentary incharge Tammineni Sitaram over allegations of securing admission into a law course using fake educational certificates. The investigation was prompted by a long-standing complaint from Amadalavalasa TDP MLA Koona Ravikumar, who exposed the alleged fraud. According to MLA Koona, Tammineni Sitaram, who had only studied up to the intermediate level, obtained admission into Mahatma Gandhi Law College, Hyderabad, in 2020 using forged degree certificates. Documents accessed through the RTI Act revealed that Ambedkar Open University, from which Sitaram claimed to have earned his degree in 2018, had no record of him appearing for the required examinations.

The matter was first raised in March 2023, but the then YCP government allegedly suppressed the issue by misusing its power and avoiding an investigation. However, after the coalition government took charge, MLA Koona renewed pressure on the authorities, leading to the government's directive for an official probe. The AP Vigilance & Enforcement Director General has



now been instructed to investigate the allegations, following orders from Government Principal Secretary S Suresh Kumar (Political) (FAC). The rivalry between Koona

Ravikumar and Tammineni Sitaram has been well known in Amadalavalasa politics. Despite being maternal uncles and close relatives, their political feud has been ongoing for years. While Sitaram switched parties from TDP to PRP, Congress, and YSRCP, Koona has remained with TDP. The political battle intensified after Sitaram became Speaker in 2019, leading to multiple cases being registered against Koona under the YSRCP government.

Now, with the inquiry underway, the future of Tammineni Sitaram remains uncertain, as officials proceed with investigating the alleged fake degree

Political Tension in Visakhapatnam, Kadapa as **YCP Resorts to Camp Politics**

Political turmoil is heating up in Visakhapatnam and Kadapa local bodies as the YSRCP faces challenges from the ruling alliance. In Visakhapatnam, the alliance has initiated a no-confidence motion against Mayor Hari Venkatakumari, making a floor test inevitable. To secure the mayor's seat, the alliance requires 64 votes, with just four more corporators needed to tip the

balance in their favor. However, Deputy Mayor GM Sridhar expressed confidence in retaining power, stating that even those who switched sides are expected to return.

He affirmed that the YS-RCP will win the floor test with the support of party leaders Jagan Mohan Reddy, Botsa Satyanarayana, and Gudivada Amarnath. Meanwhile, in Kadapa, a similar situation is unfolding as the election for the Zilla Parishad (ZP) chairman is set for March 27. Of the 50 ZP seats, the YSRCP currently holds 39. In response to the ongoing political maneuvering, the party has resorted to camp politics, reportedly moving its corporators and ZP members to safe locations in Ooty and Bangalore. Many have allegedly relocated along with their families to prevent any last-minute defections.

AP Prepares ₹10k Crore Bankable Projects Under Urban Challenge Fund

der the leadership of Andhra Pradesh Chief Secretary IAS S. Suresh Kumar to strategize and prepare bankable projects worth Rs. 10,000 crore under the Urban Challenge Fund (UCF). The initiative aligns with the Union Budget 2025-26 announcement, which allocated Rs. 10,000 crore for the current financial year as part of a larger Rs. 1 lakh crore corpus for urban development over the next decade.

The UCF aims to fund projects in three key categories: 'Cities as Growth Hubs' (economic corridors, logistics hubs, and urban employment zones), 'Creative Redevelopment of Cities' (brownfield development, urban regeneration, and sustainable design), and 'Water and Sanitation' (sewerage and solid waste management).

The funding pattern includes up to 25% support from the UCF, up to 25% from local bodies or state government, and a minimum of 50% from financial institutions, bonds, or PPPs. Chief Secretary S. Suresh Kumar in-

structed officials from 17 municipal corporations, including Smart Cities Visakhapatnam, Kakinada, Amarava-



ti, and Tirupati, to prepare Financial Operating Plans (FOPs) to assess creditworthiness and identify bankable projects. A target of Rs. 2,500 crore worth of proposals must be submitted by April 10, 2025. He also urged corporations to utilize Andhra Pradesh Urban Infrastructure Asset Management Limited (APUIAML) for assistance.

Representatives from the World Bank, International Financial Corporation, municipal commissioners, and urban development bodies attended the meeting.

Woman Harassed by In-Laws for Giving Birth to a Girl Child in Nandigama

A shocking case of harassment has come to light in Nandigama, where a woman has accused her husband's family of tormenting her for giving birth to a girl child. She further alleged that Vijay Krishna has been threatening her, stating that no one could take action against him.

According to Haripriya, Vijay Krishna told her, "You must bring gold and money, or else don't come into our house." She also alleged that her husband, Vamsi Krishna, is being prevented from meeting her by his family. Additionally, she stated that her in-laws belittled her, saying, "We all have sons, but you have given birth to a daughter."

Haripriya has appealed for justice, urging authorities to take strict action against those responsible for her ordeal. The case has sparked outrage, raising concerns about gender discrimination and domestic harassment.

Konaseema Aqua Conservation Committee Demand Urgent Govt Support to Aqua Farmers



- Farmers face high feed costs despite duty reductions
- Electricity subsidy exclusion adds financial burden
- Concerns over declining aquaculture expansion

The Konaseema Aqua Conservation Committee has submitted a representation to the District Collector, highlighting the severe challenges faced by aqua farmers due to increasing costs and inadequate government support. Despite last year's budget pro-

posal reducing customs duty on essential aquaculture feed components—including minerals, vitamins, fish oil, and artemisia—the prices of feed remain unchanged, continuing to range between ₹25,000 and ₹30,000 per ton. The lack of quality seeds has further impacted the sector. Farmers have also raised concerns over price control by feed companies and Chinese firms, which jointly hold 50% of the market. At the Aqua Fest-20, held in Vijayawada from February 16-18, CM N. Chandrababu Naidu emphasized expanding the Aqua Zone from 4 lakh acres Konaseema district, land alloin the 2023 notification, affecting farmers.

Another pressing issue is the exclusion of 1,290 electricity connections from the subsidy zone, placing additional financial strain on farmers. They are also burdened with SPL charges, EPC charges, shortfall charges, and coal charges, making sustainable aquaculture increasingly difficult. Additionally, farmers report abrupt electricity disconnections under special drives, further compounding their difficulties.

Despite the NDA government's efforts, the bed rate of aqua products has fluctuated significantly, with shrimp prices dropping to ₹280 per kg from ₹500. While recent market improvements have led to prices reaching ₹40,000 per ton, the profit margins remain unsus-

Police Solve YSRCP Activist Murder Case in Four Days



- Murder linked to an illegal relationship
- Two accused arrested, including victim's wife
- CI confirms no political angle in the case

The police have solved the murder case of YSRCP activist Gandham Bose (35) from Tatiyakula Gudem village, Jeelugumilli mandal, within four days. The case, which initially caused extreme tension, led to a road blockade on the Visakhapatnam-Hyderabad National Highway for four hours.

Bose was attacked with an iron rod while sleeping at his home around midnight on the 17th of this month. He succumbed to injuries while undergoing treatment at Khammam KIMS Hospital. His wife, Gandham Shanthakumari, initially alleged a political conspiracy, blaming a TDP leader. Following this, YSRCP activists and Bose's family staged a dharna, demanding immediate action.

Upon investigation, Jeelugumilli CI B Venkateswara Rao revealed that Shanthakumari and her maternal uncle Songa Gopala Rao were in an illegal relationship and had planned the murder. Bose allegedly harassed his wife physically and financially while struggling with gambling losses. Unable to bear the harassment, Shanthakumari conspired with Gopal Rao to eliminate him.

Taking advantage of viral news about Jagadamba Theertham fund irregularities and an audio clip of a TDP leader allegedly threatening Bose, the accused acted on the night of March 17. While Bose was sleeping, Gopal Rao attacked him with an iron rod, killing him instantly.

The police tracked and arrested both accused on Monday morning on the outskirts of Ashwaraopet. They seized the murder weapon and two mobile phones. CI Venkateswara Rao confirmed that there was no political angle in the case.

District SP Kommi Prathapa Sivakishore took the case seriously and appointed a special team led by Polavaram DSP M Venkateswara Rao, including officers from Jeelugumilli, Buttaygudem, and T Narasapuram police stations, to crack the case swiftly.

Fire Breaks Out at Scrap Shop Near Marikavalasa Highway

A massive fire accident occurred at a scrap shop near Marikavalasa Highway in Visakhapatnam, causing severe damage to property worth approximately Rs. 30 lakhs. Nehru's Obsession with RSS

Opted for selective secularism over fostering a sence of citizenship.

The stance of the Indian National Congress on Hinduism has been a subject of considerable debate and contention over the years. At the forefront of this discourse is Jawaharlal Nehru, India's first Prime Minister, whose limited understanding of Hinduism significantly influenced the party's approach to the religion. Nehru's tendency to conflate Hinduism with the Rashtriya Swayamsevak Sangh (RSS), a Hindu nationalist organization, led to a broad and often unfounded disdain for Hinduism within the Congress framework. This conflation not only misrepresented the diverse and pluralistic nature of Hinduism but also painted it in a negative light, leaving lasting repercussions for the community.

Nehru's policies, driven by a desire to project an image of secularism and liberalism to secure minority votes and gain international recognition, often came at the expense of Hindu interests. In his quest to be seen as a champion of minority rights, he inadvertently marginalized the Hindu community, making them scapegoats for various socio-political issues. This approach fostered an environment where Hindu identity was often viewed with suspicion, leading to a growing sense of alienation among Hindus.


Moreover, Nehru's disconnection from Hindu practices further exemplified this ideological rift. His lack of participation in Hindu rituals and absence from temples were not merely personal choices; they symbolized a broader disconnect between the Congress Failed in promoting the idea that all citizens should first identify with the nation-state.

Nehruvian secularism focused on managing religious diversity through shared sense of citizenship.

For instance, the continuation of separate personal laws for different religious communities, instead of implementing a Uniform Civil Code, is often cited as an example of this selective secularism.

In contrast, an approach centered on citizenship would have emphasized the responsibilities and rights of individuals irrespective of their religious affiliations, fostering a stronger national consciousness.

icant portion of the Indian populace. This detachment contributed to the perception that the Congress party was against the values and beliefs of ordinary Hindus.

In his pursuit of minority votes, Nehru strategically positioned himself and the Congress party as oppositional to Hinduism, perceiving it as a means to consolidate power and maintain a secular image. This political maneuvering laid the groundwork for an anti-Hindu sentiment within the party, which can be traced back to Nehru's era. Over the years, this sentiment has evolved into a significant ideological force within Congress,

influencing its policies and rhet-

oric against Hinduism.

As a result, the relationship between the Congress party and Hinduism has become increasingly fraught, shaped by a complex interplay of political strategy, historical grievances, and cultural identity. The legacy of Nehru's approach continues to resonate, shaping the party's stance on Hinduism and its engagement with the Hindu community in contemporary India. This ongoing tension reflects highlights the challenges of navigating religious identity in a diverse and pluralistic nation.

Jawaharlal Nehru and the Indian National Congress shaped the political landscape of post-independence India. Their emphasis on terms like secularism and the promotion of a liberal society reflected a vision of a nation that embraced diversity and pluralism—primarily for their own electoral strategy.

However, this strategy often overshadowed the fundamental principle of equality among all individuals as citizens. While secularism is undoubtedly important in a country as diverse as India, its prioritization sometimes came at the expense of a more robust discourse on citizenship and the responsibilities that accompany it.

In contrast, many developed nations have historically placed a strong emphasis on citizenship and the rule of law as foundational elements of their democratic frameworks. These nations have built their political identities around the idea that citizenship entails not only rights but also responsibilities, and that the rule of law is essential for ensuring justice and equality for all individuals. This focus on citizenship has fostered a sense of belonging and accountability among citizens, reinforcing the idea that everyone, regardless of background, is entitled to equal treatment under the law.

India, however, presents a unique case. The Congress Party, under Nehru's leadership,

broader societal dynamics and initially prioritized secular propaganda as a means to unify a diverse population and mitigate communal tensions. While this approach was intended to retain power, it often led to the neglect of more foundational aspects of citizenship and responsibilities. The emphasis on secularism, while crucial for maintaining harmony in a multi-religious society, did not sufficiently address the need for a comprehensive understanding of what it means to be a citizen in a democratic

> This divergence in focus has had lasting implications for Indian society. The lack of a strong emphasis on citizenship and responsibilities in the early years of independence may have contributed to ongoing challenges related to social justice, inequality, and the protection of individual rights. The brand, backed by actor Varun Dhawan's endorsement, has quickly scaled up, reaching ₹685 crore in sales by 2023. Smoodh benefits from Parle Agro's massive distribution network of over two million outlets, ensuring easy accessibility across the country.

Rippling founder shares 'Heartbreaking' Legal **Disputes with Wife**

\$10-billion tech company Rippling, is embroiled in a highly publicized legal dispute with his wife, leading to a dramatic turn of events. Facing serious allegations including assault and rape, which he strongly denies, Prasanna claims he is fleeing Tamil Nadu to escape what he describes as police harassment and retaliation over a settlement dispute.

The conflict arose from Prasanna's divorce proceedings with his wife,

Dhivya. He alleges that after refusing to pay more than the agreed ₹9 crore settlement, she retaliated with fabricated accusations. The dispute intensified when Dhivya allegedly took their son to the United States without leading consent, Prasanna to file an international child abduction case. A US court reportedly

ruled in his favor, ordering the child's return to India.

Prasanna insists he has full custody rights under a Memorandum of Understanding and claims that his son was handed over to him voluntarily. However, he says his legal troubles escalated due to police pressure, forcing him into hiding.

Prasanna has detailed his ordeal in a series of posts on Twitter (now X), alleging police intimidation and unlawful detentions. He accused Chennai police of picking up his friend Gokul from Bengaluru without a warrant and holding him in custody to force him into removing his social media

"If I do not remove my Twitter posts, he'd be in trouble," Prasanna wrote,

Prasanna Sankar, co-founder of the highlighting what he sees as an abuse of power. He also claimed to be moving between cities with his 9-year-old son, evading authorities while seeking legal relief.

> Despite the severe allegations, Prasanna remains defiant. "I built an empire from nothing. I can handle this even if a state is on the other side. I'm a survivor, not a victim," he declared. He plans to file a court petition on March 24, seeking protection from police harassment.



Social Media Reactions

Prasanna's revelations have sparked widespread debate online. Many users sympathized with his situation, expressing frustration over alleged misuse of legal provisions.

"Read it once. Then twice. And somewhere between the words, I felt something break. A man. A husband. A father," wrote one user.

Another remarked, "This breaks my heart! The sad state of justice in our country hits harder when things like these happen closer to the neighborhood and to someone who has a lot." As the legal battle unfolds, the case has ignited discussions about **custody** rights, police actions, and the fairness of legal proceedings in domestic disputes.





Plea In Top Court Challenges 1991 Ruling On Immunity To Judges


A petition has been filed in the Supreme Court challenging the 1991 judgment in the K Veeraswami case, which grants immunity to judges from criminal proceedings without prior approval from the Chief Justice of India (CJI). The plea also seeks a directive to the Delhi Police to register an FIR over the alleged discovery of semi-burnt cash at the residence of Delhi High Court judge Yashwant Varma.

The alleged cash discovery followed a fire at Justice Varma's official residence in Lutyens' Delhi at 11:35 pm on March 14, prompting the fire department to respond and extinguish the blaze.

In response to the controversy, CJI Sanjiv Khanna withdrew judicial work from Justice Varma and formed a three-member in-house committee to conduct an inquiry. The Delhi High Court Chief Justice D K Upadhyaya was also directed not to assign judicial duties to Justice Varma until fur-

The petition, filed by advocate Mathews J Nedumpara and three others on March 23, argues that the immunity granted to judges violates the constitutional principle of equality before the law and undermines judicial accountability.

Court ruling, which stated that "no criminal case shall be registered against a High



Court or Supreme Court judge without prior permission from the CJI." The petitioners contend that this decision was made "per incuriam" (in ignorance of law) and "sub silentio" (without explicit legal consideration).

The plea demands the recognition of a cognizable offence in the alleged cash recovery case, urging the Delhi Police to register an FIR. It also seeks a declaration that the in-house inquiry committee lacks ju-The plea challenges the 1991 Supreme risdiction to investigate the incident and calls for the prohibition of external interference in law enforcement duties related

to the case. Additionally, it advocates for the implementation of the Judicial Standards and Accountability Bill, 2010, which aimed to curb judicial corruption but lapsed.

The plea asserts that "equality before law is a fundamental principle of the Constitution" and that the judiciary should not be treated as a special class immune from penal laws. It also questions why, despite the alleged cash recovery, no FIR has been filed against Justice Varma so far.

The Supreme Court is expected to take up the matter for consideration soon.

Sanitation Worker Finds Burnt Rs 500 Notes

Outside Justice Yashwant Varma's House

In a new twist to the 'cash at judge's home' controversy, a sanitation worker discovered burnt ₹500 currency notes while sweeping outside Justice Yashwant Varma's residence at 30, Tughlak Road in central Delhi on Sunday.

The incident caused a minor stir in the high-security area, which is close to the Tughlak Road police station. The sanitation worker, employed by the NDMC, clicked photos of the burnt notes and informed his seniors, who then alerted the police.

This discovery seemingly supports the police's claim that currency notes were burnt in a fire that broke out on Holi night (March 14) in an outhouse of Justice Varma's official residence. However, Justice Varma has strongly denied any presence of cash on his premises, calling the entire episode a conspiracy to malign him. The controversy has led to Chief Justice of India Sanjiv Khanna ordering a probe and directing the Delhi High Court Chief Justice not to assign any judicial work to Justice Varma until the investigation is completed.

On Friday, Chief Justice Khanna constituted a three-member committee to probe the allegations against Justice Varma. The committee has not been given a fixed deadline, and further action will be decided based on its findings once the report is

MPs' Salaries Hiked To Rs 1.24 Lakh Per Month; Allowances, Pensions Also Raised

The Union government has increased the salaries, allowances, and pensions of Members of Parliament (MPs), with the revised pay structure coming into effect from April 1, 2023. The Ministry of Parliamentary Affairs issued a gazette notification announcing the revision, marking

the first major salary hike since 2018. According to the notification, the monthly salary of Lok Sabha and Rajya Sabha MPs has been increased from ₹1 lakh to ₹1.24 lakh. The daily allowance provided to MPs during parliamentary sessions has also been revised, rising from ₹2,000 to ₹2,500. Additionally, the pension for former MPs has been raised from ₹25,000 to ₹31,000

per month. The additional pension for every year of service beyond five years has been increased from ₹2,000 to ₹2,500 per

The allowances covering constituency and office expenses are also set to rise. As per the 2018 revision, MPs received ₹70,000 per month as a constituency allowance and ₹60,000 per month as an office allowance. These figures will now see an upward revision, though exact details are yet to be disclosed.

Apart from salaries and pensions, MPs continue to enjoy several benefits, including 34 free domestic flights annually for themselves and their families, first-class train travel, and a mileage allowance for road travel. They are also entitled to 50,000 free electricity units and 4,000 kilolitres of water annually.

MPs receive rent-free housing in New Delhi for the duration of their tenure, with hostel rooms, apartments, or bungalows allocated based on seniority. Those opting out of official accommodation are eligible for a monthly housing allowance.

The latest revision comes amid the ongoing budget session of Parliament and is aimed at adjusting MPs' compensation in line with inflation and rising living costs.

"Elitists Hired As Paid Agents To Divert Attention"

- Shiv Sena MP On Kunal Kamra Row

Shiv Sena MP Milind Deora on Monday slammed comedian Kunal Kamra, accusing him of being a "paid agent" used to divert public attention from critical issues like the Disha Salian case. His remarks come after Kamra mocked Maharashtra Deputy Chief Minister Eknath Shinde in his show, leading to an angry backlash from Shiv Sena workers.

Deora alleged that political elites have hired classist elitists like Kamra to serve their interests. "I can say this clearly—those who are entitled monarchists in Indian politics have, in a way, hired classist elitist people to do their work, to protect them, and to distract from the Disha Salian case," he said, referring to the death of celebrity manager Disha Salian, which has been a subject of controversy. He also pointed out that Salian's father had filed a petition, suggesting that Kamra's act was a diversion tactic.

While acknowledging the role of comedy in democracy, Deora emphasized the difference between humor and elitism. He criticized Kamra for mocking a leader from a humble background, stating, "We take pride in the fact that the Deputy Chief Minister of India's second-largest state was once an auto-rickshaw driver. We take pride that the Prime Minister of the world's largest democracy was once a tea seller. But the language Kamra used exposes him as a paid agent."

Deora also took aim at Congress for defending Kamra's right to free speech, questioning their selective outrage. "What did the Chief Minister of Telangana say recently? He said journalists should be stripped and beaten publicly. Did Congress react to that? When Aditya Thackeray's father was CM, what did he do for Kangana Ranaut's safety when she was just a Bollywood actress, not an MP? They demolished Kangana's office. Such people have no right to speak about democracy and the Constitution." Earlier, Shiv Sena workers stormed Mumbai's Habitat Studio, where Kamra was performing, and vandalized the venue. The

police later summoned them for questioning. During his show, Kamra had taken a dig at Shinde, using a modified version of a song from 'Dil To Pagal Hai', saying, "Meri nazar se tum dekho toh, gaddar nazar wo aaye. Haaye." The remark, referring to Shinde's 2022 rebellion that led to the split of Shiv Sena, drew laughter from the audience and was later shared by Kamra on social media platform X.

Hindi Was Compulsory 3rd Language **During Congress Rule**

Protests Erupt Across Turkey Over Mayor Ekrem Imamoglu's Arrest

Opposition calls arrest a bid to block 2028 presidential run.

Protests Escalate Following Mayor's Arrest

Turkey is witnessing one of the most significant outbursts of public unrest in over a decade, triggered by the controversial arrest of Istanbul's mayor, Ekrem Imamoglu. The protests, which began on Wednesday following his detention, have spread rapidly across the country, despite government-imposed bans on public gatherings. Imamoglu, a key figure in Turkey's opposition movement, was arrested during a pre-dawn raid by hundreds of police officers, leading to widespread condemnation from his supporters and opposition parties.

In a passionate speech to the crowds gathered outside Istanbul's City Hall, Imamoglu's wife, Dilek Kaya Imamoglu, declared, "He will defeat you! You will lose!" She described the injustice faced by her husband as symbolic of the struggles many ordinary citizens face under the current government. Her words resonated deeply with the protesters, with many expressing that Imamoglu's plight echoed their own frustrations with the state of democracy and governance in Turkey.

The opposition Republican People's Party (CHP) has labeled Imamoglu's arrest a "political coup," arguing that the charges against him were fabricated to eliminate a strong challenger to President Recep Tayyip Erdogan in the upcoming 2028 elections. Imamoglu, who became the mayor of Istanbul in 2019 and was re-elected in 2024, is considered one of the most prominent figures capable of challenging Erdogan's long-standing rule.





Allegations and Charges Against Imamoglu

Imamoglu is facing serious charges including corruption, bribery, and links to terrorism due to his political dealings with a pro-Kurdish party. The Turkish authorities claim that he was involved in creating a criminal organization, rigging tenders, and accepting bribes. Despite the severe nature of these accusations, the court has refrained from formalizing charges related to terrorism, focusing instead on the financial crimes. His arrest and the subsequent legal battles have intensified political tensions, with his supporters accusing the government of using the judicial



system to undermine political opposi-

As protests continue to grow, it is clear that Imamoglu's arrest has become a focal point for broader societal concerns about the erosion of democratic rights, political freedoms, and the stability of Turkey's economic and social systems under Erdogan's rule. The ongoing unrest and Imamoglu's rising popularity signal a challenging period ahead for the Turkish government as public dissatisfaction with the regime intensifies.

Pakistan: Islamabad High Court restores biweekly meetings for Imran Khan in Adiala Jail

Allowed to meet family, lawyers, and friends biweekly, but visitors are prohibited

In a significant ruling on Monday, the Islamabad High Court (IHC) restored biweekly meetings for former Prime Minister Imran Khan, who has been incarcerated in Adiala Jail since August 2023. However, the court imposed strict conditions, particularly prohibiting visitors from making political statements following their meetings with Khan.

According to the court's order, Imran Khan will be allowed to meet his family and legal team on Tuesdays, while friends can visit him on Thursdays. Only those individuals authorized by his coordinator, lawyer Salman Akram Raja, will be permitted to meet the PTI leader.

During the hearing, IHC's Acting Chief Justice Sarfaraz Dogar raised concerns over the use of jail meetings for political purposes. He specifically mentioned that visitors should "meet and leave" without engaging in any political discourse. Additionally, the court emphasized that speaking to the media after these meetings would be unnecessary and should be avoided. Visitors were instructed to sign an undertaking agreeing not to make any public statements related to the meetings.

The decision came after the jail authorities defended the consolidation of Khan's meetings into a single day due to security concerns. They had previously cited the risks involved in allowing sep-

arate meetings on different days. However, the court rejected this argument, reaffirming a prior ruling that allowed biweekly meetings.

Imran Khan's legal team, led by his lawyer Zaheer Abbas, argued that their client's scheduled meetings were being arbitrarily denied. For instance, they claimed that a scheduled meeting on March 20 was not allowed despite repeated requests.

Justice Dogar also directed Imran Khan's legal team to approach the trial court separately if they sought permission for his children to visit him. This decision comes as Khan continues to face multiple legal challenges, with his conviction in corruption cases transforming his status from under-trial to convicted prisoner, which has affected his privileges in prison.

The court's ruling marks a minor relief for the PTI leader and his supporters. However, the prohibition on political statements during meetings indicates that the judiciary intends to prevent jail visits from being used as a platform for political messaging. Any violations of this new rule, particularly regarding media engagements, could result in further legal actions, according to reports from The Express Tribune.

This ruling has been interpreted as a balancing act, allowing Khan's supporters to meet with him but curbing the political messaging that has surrounded his imprisonment.



South Korean Court Dismisses PM Han Duck-soo's Impeachment Over Martial Law

Minister Choi Sang-mok assumed acting president role during the court's review.

South Korea's Constitutional Court ruled on Monday to strike down the impeachment of Prime Minister Han Duck-soo, reinstating him to his position as acting president. This decision followed Han's brief tenure as acting president after the suspension of President Yoon Suk Yeol last year due to his declaration of martial law. Han had been impeached by lawmakers in December, just weeks after stepping into the leadership role in the wake of Yoon's suspension.

The impeachment motion against Han was dismissed with a 7-1 vote by the court's eight justices, with two justices voting to reject the motion entirely. The impeachment, which led to Han's suspension, was primarily based on allegations of his role in the martial law incident, as well as his refusal to appoint three more justices to the Constitutional Court, a demand from the opposition-led parliament.

Han's brief time as acting president began after President Yoon's suspension on December 3, 2024, following his controversial declaration of martial law. The martial law, which lasted only six hours after a strong parliamentary vote to reject it, caused widespread political upheaval. It raised alarms both domestically and internationally, as allies like the United States expressed concern over Yoon's ability to lead in the wake of the crisis. During the turmoil, Han was seen as a stabilizing figure with his extensive political experience, having served in various leadership roles for over three decades under five different presidents.

Despite his long career and reputation for bridging partisan divides, Han became embroiled in the political conflict when he was accused of not doing enough to oppose the martial law decision. This led the opposition-dominated parliament to impeach him in late December. During the impeachment hearings, Han denied any involvement in the martial law declaration and called for the impeachment to be dismissed.

In the meantime, Finance Minister Choi Sang-mok temporarily took over as acting president while the Constitutional Court deliberated on the cases of both President Yoon and Prime Minister Han. Han's reinstatement marks the latest twist in the political crisis that has gripped South Korea since the martial law declaration and the subsequent suspensions of its top leaders.

US Gold Card Scheme A Hit?

Trump's 'Gold Card' Scheme Sees Promising Start with 1,000 Sold in a Single Day

Donald Trump's newly launched 'Gold Card' or 'Golden Visa' program, which offers permanent residency and optional citizenship in the United States for a hefty price of \$5 million per card, is reportedly off to a strong start. According to US Commerce Secretary Howard Lutnick, the program has already gained significant traction, with 1,000 Gold Cards sold in a single day.

Speaking on the 'All-In Podcast,' Lutnick shared that the program would officially roll out in about two weeks, adding that tech mogul Elon Musk is currently working on the software needed for the initiative. Lutnick's revelation about the rapid



sales of Gold Cards paints a picture of high demand for this exclusive opportunity to secure permanent residency in the US. The Gold Card grants individuals permanent residency in the United States without the obligation to pay global taxes, a key feature of the program. Lutnick explained that while the cardholders will not be forced to become US citizens, they will have the right to live in the country indefinitely. This arrangement is appealing to foreign nationals, particularly those from countries with high global tax rates, as the Gold Card holders will only be taxed on income earned within the US.

Lutnick elaborated on the potential benefits for wealthy individuals, citing an example where someone might purchase multiple Gold Cards for their family, ensuring access to the US in times of crisis or instability. "It's a safety net," Lutnick said, emphasizing the freedom and security the card offers. Research by the Trump Administration reportedly shows that around 37 million people worldwide could afford to buy the Gold Card. With the potential for large-scale sales, President Trump has expressed confidence in selling up to a million cards. The funds raised from this program will be used to address the US fiscal deficit and national debt. The Gold Card scheme has no annual cap on issuance, meaning it could generate substantial revenue. If the trend continues, with \$5 billion in sales just 24 hours into the program, it looks set to be a highly profitable venture for both investors and the US government.





Bullish Surge in Indian Stock Markets with Six **Consecutive Sessions of Gains**



Domestic stock markets closed with huge gains on Monday. They surged for the sixth consecutive session. They jumped with doubled enthusiasm. Investors were overjoyed at the

Unified Pension Scheme Notified for Govt Employees

The Pension Fund Regulatory and Development Authority (PFRDA) has officially notified the Unified Pension Scheme (UPS) for central and state government employees, marking a significant shift in the pension structure. This new scheme will come into effect from April 1, 2025, ensuring a structured and assured pension for eligible em-

The UPS aims to provide a guaranteed pension of 50% of the average basic pay drawn over the last 12 months before retirement. This approach ensures stability in post-retirement earnings for government employees. The scheme was approved by the Union Cabinet led by Prime Minister Narendra Modi on August 24, 2024, as an improvement over the existing National Pension Scheme (NPS), which is primarily linked to market returns.

Eligibility Criteria

The scheme is applicable to central government employees who are currently un- mainly in government securities.

der NPS as of April 1, 2025, allowing them the option to switch to UPS. Additionally, newly recruited employees on or after April 1, 2025, will automatically enrolled under this scheme. Around 23 lakh central government employees are eligible to choose between NPS and UPS, depending on their preference for pension security. Employees can access the enrollment and

claim forms online from April 1, 2025, through the official website of Protean CRA at https://npscra.nsdl.co.in. For those preferring an offline process, physical form submissions will also be accepted, as per the notification.

Key Features of UPS

The Unified Pension Scheme ensures an assured pension of 50% of the average of the last 12 months' basic pay before superannuation. To qualify for the full pension benefits, an employee must complete a minimum of 25 years of service. Unlike the old pension system, UPS requires employees to contribute 10% of their basic salary and dearness allowance (DA), while the government will contribute 18.5% toward their pension fund. The final pension payout under this scheme will be partially influenced by market-linked investments,


