

PLEASE CONTINUE APCOS OUTSOURCING EMPLOYEES' REQUEST

APCOS, Andhra Pradesh Corporation for Outsourcing Employees, is going to be closed by the Government of Andhra Pradesh—this is the talk circulating among employees for the last four months. As APCOS was established by the Government under YS JAGANMOHAN REDDY, the present Government is allegedly planning to abolish it and bring back the old system of recruiting outsourcing employees through individual departments.

Earlier, under the TDP regime, outsourcing employees were recruited by individual authorities as per the rules of the Government of Andhra Pradesh. Allegedly, many got jobs through the references of TDP leaders. Keeping that allegation in view, YS JAGANMO-HAN REDDY decided to remove all those employees and start fresh recruitment through the corporation APCOS. By taking this step, YSRC allegedly tried to replace those employees with their affiliated people. Now, the Alliance Government is allegedly trying to abolish APCOS. Though Ministers have denied such allegations, the fear among outsourcing employees has not subsided. Almost 4 lakh outsourcing employees are working under APCOS now, equal to the number of Government Employees. Under APCOS, they receive facilities like ESI, PF, and even reservations are implemented through APCOS recruitment. This is why the associations of outsourcing employees are requesting the Government to continue the corporation. Mr. SAMPATH KUMAR, Vice President, Association of Outsourcing Employees, said, "We are requesting the Government to continue APCOS. If they change the format, the facilities provided by APCOS will be gone. Almost 4 lakh employees are working under APCOS. Though there is a work burden, they are not taking a backstep at any cost. They are working equal to Government Employees but with lower salaries. If APCOS is not there, then those facilities will not be available, and that is what we fear. We request the Government to continue APCOS."



The Andhra Pradesh Collectors' Conference commenced today at the Amaravati Secretariat, where Chief Minister N. Chandrababu Naidu addressed the officials, outlining his governance priorities. Minister Narayana Inspects Amaravati Capital Works

- 90% of tenders for capital works completed
- 186 bungalows for ministers, judges, and secretaries under construction

Municipal Administration and Urban Development Minister Ponguru Narayana visited Amaravati on Tuesday to inspect the progress of capital city development. He reviewed the under-construction bungalows for secretaries and principal secretaries, as well as the CRDA project office. Addressing the media, he emphasized that Amaravati's construction is moving forward systematically, despite challenges left by the previous government.

Minister Narayana reiterated that every state needs a capital, but Andhra Pradesh



remains the only state without one due to previous setbacks. He stated that tenders worth ₹43,000 crore were called for during the previous government, and significant progress had been made before the work was stalled.

"The buildings for officials, MLAs, MLCs, and All India Service officers were nearly complete, but the previous government neglected the project. Even after the coalition government took over, several issues persisted. We brought in IIT Madras to assess the quality of construction,

at ₹400 and gradually increased them to ₹4,000, a scheme unmatched anywhere in the country. He also pointed out the establishment of 204 Anna Canteens, calling them an inspiration for welfare governance.

The Chief Minister announced that the long-awaited Mega DSC notification for teacher recruitment would be released in the first week of April. He emphasized the need for strict implementation of the recruitment process, recalling that the TDP government had provided the highest number of jobs in previous years. He also noted that his administration had given a 10% reservation for Gita workers in liquor shops to promote BC economic development and had abolished GST on handloom weavers.

Chandrababu also spoke about key welfare measures, such as distributing free LPG cylinders to girls under the Deepam scheme, repealing the Land Titling Act, and scrapping the garbage tax. He asserted that welfare should not be seen as charity but as a rightful entitlement for beneficiaries.

Speaking on development projects, Chandrababu highlighted that 29,000 farmers had contributed 34,000 acres for the state capital, setting a precedent for land pooling in projects like the proposed steel plant in Visakhapatnam or Anakapalle. He informed the Collectors that ₹55,000 crore worth of work was underway for national highways, while ₹75,000 crore was allocated for railway projects. He urged officials not to dismiss these as central projects but to ensure their smooth execution in the state. In a significant announcement, the Chief Minister revealed that in May, the government would launch the Thalliki Vandanam initiative, under which ₹15,000 would be given to every mother for each of her children. He called this scheme a tribute to motherhood and a step toward empowering families. The conference set a clear agenda for AP's governance, with a focus on employment, welfare, and infrastructure development.

No Private Land Should Be in 22A: A Satya Prasad

- Govt aims to remove private lands from 22A disputes
- Special drive to resolve land issues and ensure transparency
- District collectors urged to focus on land-related grievances

Revenue, Registration and Stamps Minister Satya Prasad emphasized that no private land should remain in the 22A category in Andhra Pradesh. He urged district collectors to take proactive measures in resolving land-related disputes, ensuring that people, especially the poor, can live without legal complications regarding their properties.

Speaking at the 3rd District Collectors' Conference held at the Secretariat on Tuesday, the minister highlighted Chief Minister Nara Chandrababu Naidu's commitment to justice for the poor. He noted that the coalition government has prioritized addressing public concerns through frequent collectors' conferences—three times in just nine months, an unprecedented move in the state's history.

Satya Prasad criticized the previous administration's approach to land reforms, stating that many landowners were unaware of why their properties were listed under 22A. He pointed out that the current government repealed the controversial Land Titling Act and introduced the Land Grabbing Prevention Act and amendments to the ROR Act. By shifting appeal powers from DROs to RDOs, the government aims to expedite dispute resolution.

Special Drive to Resolve Land Disputes The minister announced a state-wide special drive to regularize land holdings for the poor and address 22A-related issues. He called on district collectors to actively par-



ticipate and ensure that rightful landowners receive due recognition. He criticized the re-survey conducted by the previous government, citing numerous errors. The coalition government has since taken corrective measures, conducting re-surveys in a phased manner at a rate of 20 acres per day while issuing new passbooks with geotagging for enhanced transparency.

Satya Prasad also emphasized the importance of resolving court cases related to land disputes. He instructed district collectors to coordinate with government pleaders for speedy resolutions. Additionally, he directed field-level officials to provide clear explanations to landowners when disputes cannot be settled immediately.

Special Real Estate Committees in Districts To prevent land disputes from hindering investment, the minister proposed the formation of special real estate committees at the district level. These committees will include representatives from the revenue department, municipalities, panchayats, urban development bodies, and banks. They are expected to meet every one to two months to resolve government land-related issues, ensuring a smoother investment climate in Andhra Pradesh.

Satya Prasad concluded by reiterating that Chief Minister Chandrababu Naidu's vision is to make land management more transparent, efficient, and citizen-friendly. He urged all officials, especially those in MRO offices, to adopt a service-oriented approach and resolve public grievances efficiently.

Major Fire Accident in NTR District

Chilli Stock Worth ₹12 Crore Gutted

A massive fire broke out in Sai Tirumala Mirchi Cold Storage in Torraguntapalem, Jaggayyapet mandal, leading to the destruction of chilli stocks worth an estimated ₹12 crore. The fire, which spread rapidly, caused heavy smoke that affected nearby villages, including Sher Mohammed Peta, Jaggayyapet Shantinagar, and Anumanchipalli.

Upon receiving information at 2:30 am, Jaggayyapet MLA Sri Sriram Rajagopal (Tataiah) rushed to the spot and alerted fire personnel from Jaggayyapet and Nandigama, along with police and revenue officials. Firefighters managed to control the flames, but the exact cause of the accident is yet to be determined.

The thick smoke led to panic among local residents, prompting youth in Shantinagar and Sher Mohammed Peta to advise people to wear masks as a precaution. The MLA, along with officials, interacted with affected chilli farmers and directed them to register their details with the Revenue Department for necessary assistance.

AP Fire DG Madireddy Pratap also visited the site along with MLA Rajagopal to assess the damage. Authorities are working to determine the full extent of losses and support the affected farmers.

Key Developments in Capital Construction

Minister Narayana provided key updates on the ongoing works, stating that 186 bungalows are being constructed for ministers, judges, secretaries, and principal secretaries. Additionally, 1,440 houses are being built for gazetted officers, while 1,995 structures are being developed for NGOs. He mentioned that 16.85 lakh square feet have been allocated for the High Court, and the Assembly is planned to be constructed at a height of 250 meters. He also assured that the necessary infrastructure for contractors will be in place within 15 days. He clarified that 90% of the required tenders have been completed and that work initially began with large-scale cleaning operations.

"No Financial Burden on the Public"

Minister Narayana assured that Amaravati's construction would be completed without imposing any financial burden on the people. "We have secured loans from the World Bank and ADB. Once land values rise, the loans will be repaid. The opposition's claims that public money is being wasted are completely baseless," he stated. The Andhra Pradesh government has taken a significant decision regarding parking fees in multiplexes and malls, addressing a long-standing concern among motorists. Despite multiple consumer forum and court rulings on parking charges, enforcement has remained inconsistent. In response, the state government has introduced new regulations to standardize parking fees. According to the latest directive, vehicle parking in multiplex and mall parking lots will be completely free for the first 30 minutes. After this period, parking fees can be charged, but with specific conditions. Those attending movies in multiplex theaters will not be required to pay for parking upon presenting their movie tickets. Similarly, individuals shopping at malls will be exempt from parking fees if they show their purchase receipts.

However, visitors who do not shop or watch a movie will be charged parking fees after the initial 30-minute free period. The government order does not specify the exact parking rates, implying that the existing charges in multiplexes and malls will continue to apply. These new rules are set to take effect from the 1st of next month, offering relief to moviegoers and shoppers while ensuring regulated parking charges.

Rushikonda Beach Reclaims Blue Flag

- What Went Wrong & How It Was Restored?

The prestigious Blue Flag certification for Visakhapatnam's Rushikonda Beach, which was revoked due to management lapses, has now been restored. The cancellation of this international recognition had sparked debate across Andhra Pradesh. However, following concerted efforts by the state government and tourism department, Blue Flag representatives have confirmed its reinstatement.

Officials from the Foundation for Environmental Education (FEE), which grants the certification, visited Rushikonda Beach from Delhi to conduct inspections. They later informed Vi-

sakhapatnam District Collector Harendri Prasad of their decision to restore the Blue Flag status. As a result, AP Tourism Minister Kandula Durgesh will oversee the official flag hoisting ceremony at Rushikonda Beach, marking the return of beach activities. Expressing his happiness, Minister Kandula Durgesh emphasized that the government has fulfilled its promise of regaining the certification, which was lost due to administrative lapses during the previous YSRCP regime. He credited the swift response from tourism department officials and the district administration for regaining the certification in record time. He also extended gratitude to CM Chandrababu Naidu and Deputy CM Pawan Kaly-

an for their support in the process. Rushikonda Beach was among the first eight beaches in India to receive Blue Flag recognition. To maintain its status, the state government has directed officials to implement strict measures, including enhanced safety protocols, environmental conservation, improved traffic management, water purification, and waste disposal. Additionally, the government is now considering proposals to secure Blue Flag certification for more beaches across Andhra Pradesh to boost tourism and environmental standards.

The Blue Flag certification is awarded by Denmark-based FEE to beaches, marinas, and boating zones that



meet 33 stringent criteria, including water quality, environmental education, safety, and tourist facilities. Given its international significance, only eight beaches in India currently hold

this distinction. Rushikonda Beach had lost its certification temporarily due to mismanagement, but proactive measures by the AP government have ensured its swift reinstatement.



Big Blow to YS Avinash Reddy as AP Govt Submits Affidavit in SC

In a significant development, the Andhra Pradesh government has filed an affidavit in the Supreme Court regarding YSR Congress MP YS Avinash Reddy's alleged involvement in the murder case of his uncle, former minister YS Vivekananda Reddy. This move comes as a major setback for Avinash Reddy, who is currently out on bail after being accused by the CBI in the case. The Supreme Court's response to this affidavit is now eagerly awaited.

The CBI launched an investigation following the murder of YS Vivekananda Reddy, initially

suspecting his personal assistant (PA) Krishna Reddy's involvement. However, Krishna Reddy later filed a police complaint against CBI SP Ram Singh, Viveka's daughter Sunitha Reddy, and son-in-law Narreddy Rajasekhar Reddy, leading the Pulivendula police to register a case.

Upon further inquiry, the police determined that Krishna Reddy's complaint was fabricated and was allegedly filed under the instructions of YS Avinash Reddy. According to the affidavit submitted to the Pulivendula court, Avinash Reddy, with Krishna Reddy's help, attempted to falsely implicate Vivekananda Reddy's daughter and son-inlaw in the murder case. Now, an additional affidavit has been submitted in the Supreme Court reinforcing these claims.

This latest development has intensified the legal troubles for Avinash Reddy, raising questions about the Supreme Court's upcoming decision in the case.

Education and IT Minister Nara Lokesh reiterated that 20 lakh jobs will be created in the state by 2029. The second meeting of the Sub-committee of Ministers on job creation was held today at his Undavalli residence. Officials presented a PowerPoint report detailing investments received, job creation, and the status of various MoUs.

Minister Lokesh stated that agreements signed so far are expected to bring in investments worth ₹8,73,220 crore, which will create employment for 5,27,824 people. As Chairman of the Sub-committee, he issued key directives to officials, stressing the importance of making the Investment Tracker Portal more efficient. He instructed that all land allotment and permission details be integrated into the tracker. He emphasized the need for policy reforms to remove hurdles for investors and called for efforts to attract both domestic and international companies. Minister Lokesh also stressed the importance of supporting industries already operating in the state by offering necessary

subsidies and incentives to facilitate expansion.

"Many industrialists are keen to invest in Andhra Pradesh. Necessary land allotments, permissions, and subsidies should be granted promptly. The MSME sector will play a major role in job creation, and it must be encouraged on a large scale. ITIs and polytechnics should focus on providing the skilled workforce required by industries. Additionally, the development of ports and tourism investments should receive special attention," he stated.

Minister Lokesh also highlighted the untapped potential in the mining sector and directed officials to explore opportunities for investment and job creation in this field.

Industries Minister TG Bharat, Power Minister Gottipati Ravikumar, Urban Development Minister P. Andhra Pradesh Congress Committee (APCC) President YS Sharmila has slammed both the ruling TDP and opposition YSRCP, accusing them of engaging in "dirty politics" over fuel price reductions. She alleged that both parties have burdened the people with high taxes on petrol and diesel while making misleading promises.

Sharmila pointed out that fuel prices in Andhra Pradesh are higher than in neighboring states like Telangana, Tamil Nadu, and Karnataka. "Currently, the price of petrol per liter in Andhra Pradesh is ₹109.60, while diesel is ₹97.47. In Tamil Nadu, petrol is ₹100.86, and diesel is ₹92.39; in Karnataka, petrol is ₹102.90, and diesel is ₹88.99; in Telangana, petrol is ₹107.46, and diesel is ₹95.70. It is clear that Andhra Pradesh has higher fuel prices than other states due to excessive taxa-

Criticizing the past and present leadership, Sharmila reminded that TDP chief and current

Chief Minister N Chandrababu Naidu, during his tenure as opposition leader, had demanded a ₹17 per liter reduction in petrol prices. "Now that he is in power, he should fulfill his own demand. Similarly, Jagan Mohan Reddy, when in opposition, had criticized high fuel prices but later increased them after forming the government. Both these parties have looted ₹50,000 crore from the people in the name of fuel taxes," she alleged.

Sharmila demanded an immediate reduction in fuel prices, as promised by the TDP before



ancing his roles as both an actor and a politician effectively. He also shared his observations on changes in Tirumala, particularly after B.R. Naidu took charge as the TTD Chairman. He pointed out that crucial decisions favoring common devotees are being made in governing body meetings, leading to improved facilities.

10th class paper leak in Kadapa goes viral on WhatsApp

A 10th class mathematics exam paper was leaked on WhatsApp at the 'B' centre of Vallur Zilla Parishad High School in YSR Kadapa district. Officials discovered that a water boy at the school had sent the paper to Vivekananda School's Vigneswara Reddy, leading to the suspension of multiple individuals involved.

The ongoing 10th board exams in both Andhra Pradesh and Telangana have been

marred by paper leaks. Recently, a similar incident occurred in Telangana, where the Telugu question paper from Nakirekal Gurukula School in Nalgonda district was leaked on March 21 and circulated on social media.

In the Kadapa case, officials inspecting the exam centre found that the mathematics paper had been shared on WhatsApp before the exam concluded. Further investigation revealed that the school's water

boy took the paper from students and forwarded it to Vigneswara Reddy through WhatsApp.

Following this, the police registered a case against the water boy and launched an investigation. Based on findings, officials suspended multiple staff members, including the Chief Superintendent, Department Officer, and Invigilators.

ers of Kotha Kummari Lova in Tuni Mandal are in distress as the ongoing excavations for the Polavaram canal are taking lives and destroying homes. The situation has worsened due to open blasting activities behind Tallur, which are causing severe damage, particularly to the nearby village. To date, around 12 houses, including water tanks, have suffered partial damage, leaving the villagers in a state of anxiety and uncertainty

about their future. The villagers have expressed concerns that if the blasting continues, there is a significant risk of houses collapsing, which could result in loss of life. The negligence of the authorities, who have not provided compensation to the residents of the new Kummarilowa area, has come under scrutiny. These villagers are among those who were excluded from compensation despite being affected by the construction work.

Villagers' Agitation

In response to the repeated damage caused by the blasting, the villagers have launched an agitation. Reports indicate that senior officials, including Yesubabu, a senior engineer from the Irrigation Department, visited the area to inspect the damages. When the villagers sought clarification, Yesubabu reportedly assured them that the blasting would be changed to controlled blasting to minimize further damage. However, it was pointed out that the vibrations from the explosions could spread up

to 500 meters, yet only an area of 350 feet was considered for safety measures, showing clear negligence from the authorities.

Polavaram Technical SE is expected to conduct further inspections on Wednesday, but the villagers remain doubtful about the effectiveness of these actions, as their homes continue to suffer.

Compensation Concerns

The villagers are also questioning whether they will receive compensation for the damages and losses already incurred. While those who received the RR package for the bridge construction did not face similar issues, the residents of the new Kummarilowa area, who were excluded from compensation, are bearing the brunt of the damage. Authorities have yet to clarify whether these affected individuals will receive any support, further deepening the doubts and frustrations of the villagers.

As the situation remains unresolved, the villagers demand immediate action and compensation for their losses, urging the authorities to take responsibility for the damage caused by the ongoing excavation work.

Trump's New Social Media Policy

- Indian Green Card Holders may have to disclose social media handles
- Policy extends existing visa scrutiny to permanent residency seekers

Green card holders in the United States may soon be required to submit their social media account details to the government under a new policy proposed by President Donald Trump's administration. While visa applicants applying from outside the country already need to provide their social media handles, this policy seeks to extend the requirement to those living in the US legally and applying for permanent residency or asylum.

The move has sparked concerns, particularly among Indian immigrants, many of whom are vocal about political issues in both India and the US. Critics argue that this increased scrutiny could discourage open expression on social media due to fear of government action. The policy could potentially be used to deny immigration benefits to individuals based on their online activity.

Purpose of the Policy

A notice issued by the US Citizenship and Immigration Services (USCIS) on March 5 outlined the administration's rationale for the proposal. According to the notice, USCIS has identified a need to collect social media handles and platform names from applicants as part of national security and identity verification measures. The agency claims that monitoring social media activity is crucial for vetting individuals and ensuring public safety.

"The vetting of social media accounts is necessary for enhanced identity verification, vetting, and national security screening," the document states. The government is currently



seeking public feedback on the policy before finalizing its implementation. **Impact on Green Card Holders**

Currently, social media screening applies only to visa applicants outside the US. However, this proposed change will bring green card applicants and asylum seekers under the same level of scrutiny. Individuals already residing in the US on valid visas but seeking permanent residency will need to disclose their social media activities, allowing authorities to monitor their online presence.

This could have significant implications, particularly for Indian immigrants who use social media to engage in discussions about US and Indian politics. Experts fear that this increased surveillance might push people to self-censor their views due to concerns about how their online activity could be interpreted by immigration officials.

Part of Trump's Broader Immigration Crackdown

Since returning to the White House, in the US.

Trump has taken a hardline stance on immigration. On his first day back in office, he signed an executive order directing federal agencies to take aggressive action against illegal immigration, describing it as an "invasion" threatening national security. His administration has ramped up enforcement efforts, with federal law enforcement agencies conducting widespread raids and arrests.

Trump has frequently claimed that undocumented immigrants are responsible for crime and economic instability, although these assertions are not fully supported by government data. His administration's immigration policies have drawn sharp criticism for being overly harsh and targeting legal residents as well.

Is the Government **Considering Bringing Back NJAC?**

Hyderabad, March 26: The controversy surrounding Delhi High Court Judge Justice Yashwant Varma and the discovery of burnt cash at his residence has brought the issue of judicial appointments and accountability back into focus. While the immediate fallout centers around the credibility of Justice Varma and his involvement, the bigger picture is about the integrity and transparency of India's judicial system. This raises an important question: is it time for the government to revive the National Judicial Appointments Commission (NJAC) and replace the existing collegium system?

The Background of NJAC vs Collegium

In 2015, the Supreme Court struck down the National Judicial Appointments Commission (NJAC) Act, which sought to replace the collegium system of judicial appointments with a body consisting of both judiciary and executive representatives. The Court argued that NJAC violated the Constitution's basic structure and undermined judicial independence. This ruling entrenched the collegium system, in which a group of senior judges, without any direct electoral mandate, decides the appointment of judges to the highest courts in the country. The NJAC, introduced through the 99th Constitutional Amendment, was designed to ensure a balanced, transparent, and democratic approach to judicial appointments. The idea was to bring accountability and prevent allegations of nepotism or favoritism within the judiciary. However, the Supreme Court's verdict left the power of judicial appointments entirely within the hands of the judiciary, effectively sidelining the executive's role in the process.

Is the Collegium System Truly Democratic?

The collegium system, while championed for its focus on judicial independence, also raises critical concerns about accountability. The primary issue lies in the fact that the people, through their elected representatives, do not have a say in selecting the judges who will interpret laws, make decisions on public policies, and influence governance. The judiciary's actions have a profound impact on the lives of ordinary citizens, yet those sitting in judgment are not directly accountable to the public.

The collegium system, without any checks from the legislative or executive branches, creates a scenario where a group of unelected judges appoints their peers. This setup not only perpetuates an insular and self-reinforcing system, but it also makes it difficult to address concerns about transparency and fairness. As we've seen in the case of Justice Varma, the discovery of cash raises questions about the accountability of judges in the absence of external scrutiny or oversight.

In a major reform aimed at enhancing financial flexibility for India's workforce, the Employees' Provident Fund Organisation (EPFO) will soon enable Provident Fund (PF) withdrawals through Unified Payments Interface (UPI) and ATMs. This significant initiative, approved by the Labour and Employment Ministry, is expected to be rolled out by the end of May or June this year, providing seamless and instant access to PF savings.

Sumita Dawra, Secretary of the Ministry of Labour and Employment, announced the development, stating that the integration of UPI with the EPFO system would allow members to instantly withdraw up to ₹1 lakh. Additionally, the introduction of ATM-based withdrawals will offer another convenient mode of accessing funds, reducing the dependency on traditional claim processes.

With this upgrade, PF account holders will be able to check their balance directly via UPI, transfer funds to their preferred bank accounts, and execute instant withdrawals. This initiative is in line with Prime Minister Narendra Modi's vision of "ease of living," aiming to simplify social security procedures for employees and employers across the country.

Expanded Withdrawal Options for Members

The EPFO has expanded the scope of withdrawals beyond retirement benefits. Members can now withdraw funds for various purposes such as housing, education, and marriage, in addition to the existing provisions for medical emergencies. These changes provide much-needed financial flexibility, allowing workers to access their hard-earned savings when re-



quired without lengthy bureaucratic hurdles.

"The EPFO has significantly strengthened its digital infrastructure, integrating over 120 databases to streamline the withdrawal process. As a result, the claim processing time has been reduced to just three days, with 95% of claims now being processed automatically," Dawra said.

She further added that the governsimplify the withdrawal process, enfunds with minimal delay. The intelike UPI will eliminate unnecessary paperwork and speed up transactions, making EPFO services more accessible to millions of contributors.

The Case for Bringing Back NJAC

The case for bringing back the NJAC is compelling, particularly in light of recent events. If we look at the Justice Varma controversy, the judicial system has once again shown the limitations of an unaccountable body of unelected officials. The centre's decision to convene an all-party meeting on this issue reflects growing concerns about transparency and judicial oversight, but the root issue remains: the judiciary operates in a vacuum, with limited external accountability. A reformed NJAC could serve as a safeguard against the kind of problems that have plagued the collegium system. A body that includes both judiciary and executive members, with clear procedures for selection and monitoring, would ensure more public transparency and offer a mechanism to address grievances. Elected representatives, accountable to the people, could play a role in judicial appointments, creating a more democratic system in which the judiciary remains independent but not entirely isolated.

A System of Balance and Accountability

In a democracy, elected representatives should have a role in lawmaking, policy decisions, and, to some extent, judicial appointments. A system that prioritizes judicial independence must still strike a balance with accountability. The judicial branch must not be an isolated fortress immune to oversight and scrutiny. The NJAC, with proper checks and balances, offers a solution to this dilemma, ensuring the judiciary can function without fear or favor but within the boundaries of the democratic system.

India's legal system must evolve with the times, and reviving a form of NJAC could be the way forward. It would empower the people through their representatives, ensuring that the judiciary remains independent yet accountable. The current status quo—where a group of unelected judges governs judicial appointments—no longer seems sustainable in a democratic framework that values transparency and fairness.

The recent events surrounding Justice Varma and the public outcry over the discovery of cash raise critical questions about judicial accountability. The government's engagement with political parties on the issue indicates a growing concern for a system that can balance judicial independence with transparency and public trust. If the judiciary is to retain its credibility, it must operate within a framework that includes checks and balances, and that framework may very well involve reviving the National Judicial Appointments Commission (NJAC). It is time to reconsider the collegium system and bring accountability into the heart of the judiciary.





New Income Tax Bill to Be Discussed in Monsoon Session: Nirmala Sitharaman



Finance Minister Nirmala Sitharaman announced on Tuesday that the new Income Tax Bill will be taken up for discussion in the monsoon session of Parliament. The bill, which was introduced in the Lok Sabha on February 13, is currently under review by the Select Committee. While addressing discussions on the Finance Bill 2025 in the Lok Sabha, Sitharaman confirmed that the Select Committee has been directed to submit its report by the first day of the upcoming session. "...We will take it (new income tax bill) up in the monsoon session," she stated. The monsoon session of Parliament typically begins in July and continues through August. The new Income Tax Bill aims to bring about a simplified tax structure by reducing complexities and eliminating ambiguities in the existing law. The Income Tax Department previously fessionals alike. highlighted that the revised legislation seeks to provide tax certainty while minimizing litigation and the scope for fresh interpretations. One of the major highlights of the proposed bill is its concise structure compared to the existing Income Tax Act of 1961. The new bill contains 2.6 lakh words, significantly less than the 5.12 lakh words in the current Act. Additionally, it has 536 sections, down from the 819 effective sections in the current law. The number of chapters has also been streamlined from 47 to 23. The revised legislation introduces 57 tables, an increase from the 18 found in the existing Act, but has removed 1,200 provisos and 900 explanatory notes, thereby simplifying legal provisions. These changes aim to create a more comprehensible and user-friendly tax regime for taxpayers and tax pro-

vamp the Income Tax Act is seen as a significant step in modernizing India's tax framework, ensuring greater efficiency and transparency in tax administration. The government hopes that the new law will reduce tax disputes and enhance compliance by making the provisions clearer and more structured. The Select Committee's review and recommendations will be crucial in shaping the final version of the bill before its discussion in Parliament. With its reduced complexity and restructured format, the proposed Income Tax Bill 2025 is expected to be a landmark reform in India's taxation system. Separatism in Kashmir Ends as Two Hurriyat Groups Sever Ties

Union Home Minister Amit Shah on Tuesday announced a significant political shift in Jammu and Kashmir, stating that two factions of the separatist Hurriyat Conference have officially severed ties with separatism. He asserted that this move is a testament to the success of the Modi government's policies aimed at fostering national unity and eliminating separatist tendencies in the region. Hurriyat Conference, an amalgamation of various separatist groups in Jammu and Kashmir, has played a pivotal role in advocating for the region's separation from India for decades. However, recent developments indicate a departure from this ideology, marking what Shah described as a "historic victory" for Bharat's unity. Taking to social media platform 'X', Shah welcomed the decision and urged other separatist groups to follow suit, emphasizing that abandoning separatism is the only path toward peace, development, and progress. "Two organizations associated with the Hurriyat have announced the severing of all ties with separatism. I welcome this step towards strengthening Bharat's unity and urge all such groups to come forward and shed separatism once and for all," Shah posted. The Home Minister further highlighted that the government's strategic policies, including the abrogation of Article 370, development initiatives, and stringent security measures, have played a crucial role in dismantling separatist sentiments in the valley. He credited Prime Minister Narendra Modi's leadership for fostering a sense of belonging and integration among the people of Jammu and Kashmir. Shah reiterated that the government remains committed to transforming the region into a peaceful, developed, and unified part of India. He stated that the latest move by the Hurriyat factions is proof that separatist ideology is losing its ground and that more groups are realizing the benefits of aligning with the national mainstream. The announcement comes in the wake of a series of measures undertaken by the central government to curb separatist activities in Jammu and Kashmir. Over the past few years, authorities have cracked down on terror financing, taken legal action against separatist leaders, and promoted economic development to ensure stability in the region. With this latest development, political analysts believe that the separatist movement in Kashmir has suffered a significant blow. The disintegration of Hurriyat factions from their separatist stance signals a new chapter in the region's history, aligning with the Modi government's broader vision of a peaceful and prosperous Jammu and Kashmir within a unified Bharat.

"India, China Discuss LAC, Strengthen Ties"

India and China held a high-level meeting in Beijing today, marking the 33rd session of the Working Mechanism for Consultation and Coordination (WMCC) on India-China Border Affairs. The discussions primarily focused on reviewing the situation along the Line of Actual Control (LAC) and exploring ways to improve diplomatic and military coordination. Both sides emphasized the importance of maintaining stability and ensuring the early resumption of cross-border cooperation, including trans-border river management and the Kailash-Mansarovar Yatra. The Indian delegation was led by Gourangalal Das, Joint Secretary (East Asia) in the Ministry of External Affairs, while the Chinese delegation was headed by Hong Liang, Director General of the Boundary and Oceanic Affairs Department of the Chinese Ministry of Foreign Affairs. The meeting was described as "positive and constructive," with both nations reaffirming their commitment to strengthening diplomatic channels and enhancing mechanisms for border management. A key outcome was the agreement to make "substantial preparations" for the next meeting of the Special Representatives (SRs) on the boundary question, which is scheduled to take place in Delhi later this year. The Ministry of External Affairs (MEA) stated that the discussions covered various proposals and measures aimed at implementing the decisions made during the 23rd meeting of the Special Representatives on the India-China boundary issue, which was held in Beijing in December 2024. Both nations acknowledged the need to advance effective border management while preventing escalations along the LAC. Additionally, they agreed to strengthen existing diplomatic and military mechanisms to ensure quick resolution of any disputes. Following the meeting, Gourangalal Das paid a courtesy visit to China's Assistant Foreign Minister, Hong Lei, signaling continued diplomatic engagement between the two nations. The discussions are part of broader efforts to return to a pre-2020 status quo along the LAC and improve bilateral ties. This initiative gained momentum after Prime Minister Narendra Modi and Chinese President Xi Jinping met in October 2024 on the sidelines of the BRICS Summit in Kazan, Russia, He stressed the need to rebuild trust and maintain a constructive relationship. Modi also acknowledged the ancient civilizational ties between India and China, emphasizing that the two nations had historically coexisted peacefully for millennia. He advocated for a spirit of healthy competition rather than conflict. China responded positively to Modi's remarks, with the Chinese Foreign Ministry stating that cooperation between the two nations, referred to as a "dragon-elephant dance," was the best path forward. The spokesperson reiterated that in over 2,000 years of interaction, India and China had maintained friendly exchanges and contributed to human progress. The latest diplomatic engagements indicate a continued effort to resolve border tensions and strengthen bilateral cooperation.

Top Maoist with ₹25 Lakh Bounty Killed in Chhattisgarh Encounter"

- Maoist leader killed in encounter.
- ₹25 lakh bounty on head.

A Maoist carrying a reward of ₹25 lakh on his head was among three insurgents killed in an encounter with security forces in Chhattisgarh's Dantewada district on Tuesday, police said. The gunfight took place at around 8 am in a dense forest area along the border of Dantewada and Bijapur districts. Security personnel were conducting an anti-Maoist operation based on intelligence reports about Maoist presence in the forests surrounding Girsapara, Nelgoda, Bodga, and Ikeli villages under the Geedam police station limits, according to Superintendent of Police Gaurav Rai. The operation involved personnel from the District Reserve Guard (DRG) and Bastar Fighters, both special units of the Chhattisgarh state police, known for their expertise in counterinsurgency operations. As the security forces reached the targeted location, a fierce exchange of fire broke out between the two sides. After the gunfight subsided, the security personnel recovered the bodies of three male Maoists from the site, along with an Insas rifle, a .303 rifle, explosive materials, and other items used in their daily activities. Among the three slain Mao-



ists, one was identified as Sudhir, also known as Sudhakar or Murli, a resident of Warangal in Telangana. He was an active member of the Dandakaranya Special Zonal Committee, the most powerful faction of Maoists operating in the region. Authorities had placed a bounty of ₹25 lakh on his head due to his involvement in multiple attacks on security forces and civilians. The identities of the other two deceased Maoists are yet to be confirmed, officials said, adding that search operations are still ongoing in the area to trace any remaining insurgents or hidden weapon caches. Chhattisgarh, particularly the Bastar division, has been a stronghold of Maoist insurgents for decades. However, security forces have intensified their operations in recent years, leading to a significant number of encounters and Maoist casualties. Just a few days prior, on March 20, security forces carried out two major operations in Bijapur and Kanker districts, killing 30 Maoists.. Union Home Minister Amit

Shah recently reaffirmed the government's aggressive stance against Maoist insurgency, stating that the Narendra Modi-led administration is implementing a "zero-tolerance policy" against Maoists who refuse to surrender despite multiple opportunities and rehabilitation offers. He asserted that the government is committed to eradicating Maoism from the country and aims to make India completely Maoist-free by March 31, 2026. The growing success of anti-Maoist operations in Chhattisgarh reflects a shift in the balance of power in favor of security forces. The use of specialized units like the DRG and Bastar Fighters, combined with improved intelligence and coordination, has significantly weakened Maoist influence in the region. However, sporadic attacks by Maoists indicate that the insurgency is not completely dismantled. Authorities remain vigilant, continuing operations to eliminate the remaining Maoist factions and restore lasting peace in the region.







India may interfere in **General Election** on April 28: Canada

Canada's national security agency has raised concerns over possible foreign interference in the upcoming general election, scheduled for April 28, 2025. According to the Canadian Security Intelligence Service (CSIS), both China and India, alongside Russia and Pakistan, are likely to attempt to influence the election.

The warning comes amid growing tensions between Ottawa and both Beijing and New Delhi. Vanessa Lloyd, deputy director of operations at CSIS, highlighted that hostile state actors are increasingly utilizing advanced tools like artificial intelligence to meddle in democratic processes. "The People's Republic of China is highly likely to use AI-enabled tools to attempt interference in Canada's election," Lloyd stated at a press conference.

Canada's relations with both India and China have been strained in recent years. Beijing retaliated against Canada's tariffs on Chinese electric vehicles and steel by imposing tariffs on over \$2.6 billion worth of Canadian agricultural and food products. Additionally, Canada condemned China's execution of four Canadian citizens on drug smuggling charges.

Starlink Poised for Major Expansion in India, Boosting Ambitions for Global Growth

For Musk's Starlink, India Approval Could Unlock Emerging Markets

As Starlink nears regulatory approval for satellite broadband services in India, analysts believe this move could significantly boost the company's global expansion, especially in emerging markets. A successful entry into India could potentially add \$25 billion in revenue, reshaping the country's satellite broadband industry and attracting interest from other developing markets.

However, despite the promising outlook, Starlink faces legal hurdles and stiff competition from players like Eutelsat and China's SpaceSail, which is expanding into Brazil, Malaysia, and Kazakhstan. Additionally, SpaceX contends that U.S. regulations place it at a disadvantage compared to foreign rivals.

Starlink, owned by Elon Musk's SpaceX, has been waiting for licenses to operate commercially in India since 2022. The company has been embroiled in a regulatory standoff over spectrum allocation, with debates on whether India should auction satellite broadband spectrum, benefiting telecom giants like Mukesh Ambani's Reliance Jio casts a significant drop in


and Sunil Mittal's Bharti Airtel, or allocate it administratively to newer players like Starlink. In October, India opted for administrative allocation, giving Starlink a potential edge.

This month, both Reliance Jio and Bharti Airtel signed separate agreements with SpaceX, signaling that regulatory challenges may soon be resolved. Analysts suggest this development indicates that Starlink is closer to entering the Indian market.

The entry into India is a strategic move for Starlink, which operates in over 120 markets globally. Goldman Sachs fore-

prices for low Earth orbit (LEO) broadband services, projecting a reduction from \$148 per month in 2023 to just \$16 by 2035. With India being one of the largest potential markets, analysts expect Starlink to add 3 million global subscribers in 2025, with India being the leading contributor.

Starlink's pricing strategy will be crucial for success, with some experts predicting competitive plans starting at \$15 per month. As the satellite internet market in India grows, Starlink's entry will offer employment opportunities and fuel competition within the sector, enhancing India's global space industry competitiveness.



Canada Cites "India's Growing **Global Influence**" **In Allegation Against Pak**

Canada has raised concerns over potential foreign interference in its upcoming April 28 general election, warning that Pakistan, India, China, and Russia could be involved in attempts to sway the democratic process. Vanessa Lloyd, Deputy Director of Operations at the Canadian Security Intelligence Service (CSIS), highlighted that Pakistan may conduct interference activities to counter India's growing global influence. She explained that Pakistan's actions could align with its strategic aims to maintain political and economic stability while curbing India's rise on the world stage.

Lloyd also addressed the possibility of Indian interference, stating that the Indian government has both the intent and capability to influence Canadian communities and the election process. This builds on similar allegations made last year, which India firmly rejected.

In a 2024 report, CSIS detailed "clandestine" foreign interference by both India and Pakistan during Canada's 2021 and 2019 general elections. The agency accused India of targeting electoral districts with large Indian-origin populations, particularly those sympathetic to the Khalistani movement, and alleged the use of illicit financial support to sway candidates. Similarly, it claimed that Pakistan tried to influence federal politics in 2019 to further its inter-

Malaria Confirmed as Cause of Fatal Outbreak in Northwest DR Congo

Late on Monday, the National Public Health Institute (INSP) of the Democratic Republic of Congo confirmed that an outbreak in the northwest of the country, which claimed the lives of more than 50 people, was caused by malaria. The illness, which primarily affected Equateur province, resulted in 943 reported cases and 52 deaths at the beginning of the year.

The symptoms, which included fever, fatigue, vomiting, and weight loss, initially led health officials to suspect food poisoning or malaria as the potential cause. However, following laboratory tests on samples from affected individuals, malaria was de-

Christian Ngandu, coordinator of the INSP, confirmed the results of the tests over the phone, reassuring the public that the outbreak was now understood. Despite the confirmation, the health institute continues to

await the results of additional tests on water, drinks, and food samples sent abroad to further investigate whether there was any potential contamination involved.

This recent outbreak follows a similar occurrence in December, where an unknown illness initially puzzled health authorities before being traced back to malaria. These outbreaks have prompted increased vigilance and ongoing monitoring in the region.

Health officials have stressed the importance of public awareness regarding the symptoms and prevention of malaria, which is a major health concern in many parts of sub-Saharan Africa. With the confirmation of malaria as the cause, authorities are focusing on controlling the spread of the disease and providing support to affected communities.

As the investigation continues, the INSP has urged the public to seek medical help promptly if they experience symptoms, especially in malaria-prone areas, to prevent further fatalities.

New Income Tax Bill To Be Introduced In Monsoon Session: Nirmala Sitharaman

Finance Minister Nirmala Sitharaman announced on Tuesday that the new Income Tax Bill will be taken up for discussion during the upcoming monsoon session of Parliament. While responding to the debate on the Finance Bill 2025 in the Lok Sabha, Sitharaman clarified that the bill, which was introduced in the House on February 13, is currently under review by the Select Committee. The committee is expected to submit its report by the first day of the next parliamentary session.

"The new income tax bill will be taken up in the monsoon session," said Sitharaman. The monsoon session is typically held from July to August, marking the period when the government expects to finalize discussions on the bill.

The proposed Income Tax Bill aims to simplify the country's taxation system. The new bill, which is significantly shorter than the current 1961 Income Tax Act, seeks to reduce the complexity of tax laws and improve tax certainty. The bill has been designed to minimize the scope for litigation and reinterpretation, a key objective for streamlining the tax process.

The new bill is approximately half the size of the existing law, with a word count of 2.6 lakh compared to 5.12 lakh in the current Act. The number of sections in the bill has also been reduced, from 819 to 536. Additionally, the number of chapters has been halved from 47 to 23, while the number of tables has increased to 57 from the 18 present in the existing Act. The new bill has also removed over 1,200 provisos and 900 explanations, further simplifying the language and structure of tax regulations.

This overhaul of the Income Tax Act is seen as a significant step towards creating a more transparent and efficient taxation system in India, ensuring easier compliance and reducing unnecessary litigation.

S&P Cuts India's GDP Growth Forecast to 6.5% for FY 2025-26



S&P Global Ratings has revised India's GDP growth forecast for the fiscal year 2025-26, reducing it to 6.5%, down from an earlier projection of 6.7%. The global credit rating agency cited exter-

nal factors, including rising US tariffs and a broader pushback against globalization, as key reasons for the downward revision in its Economic Outlook for the Asia-Pacific (APAC) region.

Despite these external headwinds, S&P expects strong domestic demand to drive growth in most emerging-market economies, including India. The revised forecast reflects the agency's belief that the Indian economy will maintain momentum, aided by factors such as the expectation of a normal monsoon season and softening commodity prices, particularly crude oil.

S&P highlighted several domestic factors that could support India's economic growth. These include cooling food inflation, tax benefits introduced in the national budget for FY 2025-26, and lower borrowing costs, which are anticipated to boost discretionary consumption. The ongoing economic recovery in

India is also expected to benefit from government policies designed to stimulate growth, despite the global uncertainties.

The agency also noted that central banks across the APAC region, including the Reserve Bank of India, are likely to continue cutting benchmark interest rates throughout the year, providing further support to the domestic economy.

Although the forecasted 6.5% growth is consistent with the previous fiscal year's outcome, it reflects a more cautious outlook given the global challenges. The revised growth projection underscores the balancing act facing India's economy-navigating external pressures while maintaining robust internal demand.

India slaps Samsung with tax demand of ₹5,156 crore for telecom imports

India has directed Samsung and its executives to pay \$601 million in back taxes and penalties for allegedly evading tariffs on the import of key telecom equipment. This marks one of the largest tax demands in recent years, according to a government order.

The \$601 million demand represents a significant portion of Samsung's net profit in India for the previous year, which was reported at \$955 million. As one of the largest players in India's consumer electronics and smartphone market, the company's operations are under close scrutiny from local tax authorities.

Samsung has the option to challenge the tax demand through a tax tribunal or in the courts. The case is related to allegations that the company avoided paying the necessary import tariffs on certain telecoms equipment. This tax dispute could have significant financial implications for the company, considering the substantial penalty involved.

As the dispute unfolds, Samsung will likely consider its legal options while continuing to operate in one of the world's largest markets for consumer electronics. The outcome of this case could set a precedent for other multinational corporations operating in India and could influence future tax regulations and enforcement practices.


ustralia has an-**A**nounced plans for a new 63,000-seat stadium and an indoor aquatic centre as part of preparations for the 2032 Olympic Games in Brisbane. Queensland Premier David Crisafulli revealed the updated infrastructure strategy, emphasizing long-term benefits over short-term spending.

"Finally, Queensland has a plan. The time has come to just get on with it. And get on with it we will," Crisafulli stated, confirming that the new stadium would be a permanent world-class venue for future sporting events. The aquatic centre, with temporary seating increasing capacity to 25,000, will host swimming, diving, water polo, and other aquatic sports. The main athletes' village will be constructed at the Brisbane Showgrounds, with additional accommodation hubs on the Gold Coast and Sunshine Coast. This new plan replaces an earlier proposal by the previous Labor government, which aimed to renovate the historic Gabba cricket ground and build a 17,000-seat indoor stadium. Crisafulli scrapped those ideas, arguing that billions would have been wasted on temporary venues that lacked lasting value.

In addition to the new stadium and aquatic centre, authorities have earmarked funds for upgrading smaller venues, including the Queensland Tennis Centre and the Gold Coast Hockey Centre. While specific costs have not been disclosed, Australia has set aside approximately \$4 billion for Olympic infrastructure.
