Cabinet to Decide on Milk Price Hike, Says **CM Siddaramaiah**

CM met KMF officials and milk union representatives in Bengaluru.

KMF has proposed a price hike of ₹3 to ₹5 per litre.

The final decision will be made in the Cabinet meeting on Thursday.

Karnataka Chief Minister Siddaramaiah on Monday stated that the decision on increasing milk prices will be taken after discussing the proposal in the Cabinet. He emphasized that the primary objective of milk unions is to support farmers rather than generate profits.

During a meeting with representatives of various milk unions and Karnataka Milk Federation (KMF) officials, Siddaramaiah stressed that profits must be directed toward farmers. "This is the government's stand," he asserted.

He also instructed unions to expenses and avoid unneces-

Currently, three milk unions are running at a loss, and the CM has set a threemonth deadline for them to bring down their expenses, ensuring that administrative costs do not exceed 2% of their total expenditure.

Meanwhile, KMF Chairman Bhima Naik revealed that the federation has already decided to increase milk prices, though the exact hike—whether ₹3 or ₹5 per litre—will be determined by the Cabinet. 



In a major development, all 35 members of the Vijayapura City Corporation have been disqualified following an order issued by Belgaum Regional Commissioner Sanjay Shettennavar on Monday. The move comes after the corporators failed to submit their mandatory asset declaration forms.

The disqualified members include 17 from BJP, 10 from Congress, one

from JDS, two from MIM, and five independents. They were all elected in the 2022 municipal elections. The issue arose when none of the members submitted their asset declaration forms after the mayoral elections held on January 9, 2024. Congress leader Mehejabin Horti was elected as Mayor, while Dinesh Halli secured the Deputy Mayor position. The lapse led former corporator Prakash Mirji Mainuddin Bilagi to approach the Kalaburagi High Court, demanding action against the elected representatives. Following a court directive, the government conducted an inquiry, leading to the disqualification of all 35 members. With the corporation now dissolved, fresh elections are likely to be announced soon to reconstitute the civic body.

TPN Correspondent Bengaluru Kannada and Culture and Backward Classes Welfare Minister Shivaraj S Tangadagi has proposed a new approach to conferring Kannada Rajyotsava awards by eliminating the application process and directly recognising deserving individuals based on their achievements.

Speaking at the Karnataka Sahitya Academy awards distribution ceremony on Monday, Tangadagi stressed that true recognition should come unprompted rather than being requested. He suggested that delivering the awards directly to recipients' homes would en-



hance their prestige and value.

"I will discuss this with the CM and DyCM," he stated, indicating that the government is considering implementing the change.

The minister noted that many literary figures across Karnataka have expressed support for this idea but emphasized the need for further discussions. "There must be a public debate on this matter," he added.

Cloud Strength Influences Rainfall and Movement, IISc Study Finds prespondent Bengaluru spells within this period are de-

TPN Correspondent | Bengaluru A study by researchers at the Indian Institute of Science (IISc) has revealed that the strength of cloud bands plays a crucial role in determining the movement of clouds and the intensity of monsoon rainfall. The research indicates that while winds and local convection remain important, the density of clouds originating from the oceans is a key factor influencing rainfall patterns.

Professor PN Vinayachandran, Chair of the Centre for Atmospheric and Oceanic Sciences (CAOS) and

co-author of the study, stated that cloud band strength not only influences rainfall distribution but also affects the intensity of short bursts of rain. While the movement of clouds has remained relatively stable, the increased moisture-holding capacity of clouds due to climate change has resulted in heavier rainfall over the years.

The study, titled "Equatorial Convection Controls Boreal Summer Intraseasonal Oscillations in the Present and Future Climates," was published in the NPJ Climate and Atmospheric Science journal in February. It highlights the role of Boreal Summer Intraseasonal Oscillations (BSISO) in controlling wet and dry spells during the monsoon season. These oscillations help transport clouds from the equator to the Indian subcontinent, significantly influencing India's monsoon patterns.



termined by the size and strength of cloud bands. Researchers found that if a cloud band originating at the equator is weak, it fails to propagate northward effectively, contradicting earlier assumptions that cloud bands always move toward the Indian subcontinent.

Aditya Kottapalli, a PhD student at CAOS and co-author of the paper, explained, "We have shown that if the cloud band in the equator is weak to start with, then it cannot propagate northwards, unlike what previous literature stated."

The IISc team identified gaps in current climate models and used advanced projections to better understand the factors driving BSISO movement. Their findings suggest that robust northward propagation of BSISO occurs only when the equatorial cloud band is strong. A strong cloud band enhances atmospheric moisture levels over the subcontinent, driven by intensified winds, and triggers more intense wet spells. "It was found that the air-sea interaction in the equatorial Indian Ocean played a major role in driving wet spells in India. This is likely to change in the future because the atmosphere would be warmer," Vinayachandran added. The findings underscore the impact of climate change on monsoon rainfall, with increasing atmospheric tempera-

tures expected to alter cloud dynamics and potentially intensify rainfall patterns. The study provides crucial insights

Power Demand in Karnataka Crosses 18,000MW

Correspon-TPN dent | Bengaluru Karnataka's power demand has surged 18,000MW past in the past two months, with peak demand reaching 18,350MW in February and 18,395MW on March 7. Officials expect this upward trend to

continue, touching 18,500MW in April as sum-

mer intensifies. Karnataka Power Corporation Limited (KPCL) Managing Director Pankaj Kumar Pandey attributed the increase to a 15% rise in agricultural power consumption. He noted that due to heavy rainfall, farmers have opted for additional cropping, significantly impacting demand.

Over the past few years, power consumption in the state has steadily risen. Maximum demand stood at 14,367MW in 2020-21, 14,818MW in 2021-22, 15,828MW in 2022-23, and 17,220MW in 2023-24. This April, the estimated demand is 18,294MW, compared to 16,985MW last year, while May's projec-

tion is 17,122MW, up from 16,826MW in May 2024.

To meet the rising demand, Karnataka has entered into power exchange agreements with Punjab and Uttar Pradesh, securing between 100MW and 1,400MW. Additional Chief Secretary (Energy) Gaurav Gupta stated that from March 1-15, the state procured 310MW from NTPC, with another 100MW added from March 15. Under the fuel security policy, PSCKL will receive 1,000MW of electricity monthly from other states until May. With rising temperatures and increased agricultur-

al activities, Karnataka is gearing up to ensure uninterrupted power supply in the coming months.

HC Directs Advocates' Associations to Implement Women's Quota

The Karnataka High Court has ruled that all advocates' associations in the state must implement the Supreme Court's directive on reserving positions for women in Bar Association elections.

Justice M Nagaprasanna delivered the order on Monday while allowing a petition filed by women members of the Tumakuru District Advocates' Association. The petitioners had sought the creation of an additional post of joint secretary and two executive committee member positions reserved for women. They had earlier written to the Returning Officer and Association president on March 5, requesting 33% reservation for women in the association's governing body.

Referring to the Supreme Court's recent order directing the Advocates' Associa-

tion of Bengaluru (AAB) to earmark the post of treasurer for women candidates, the high court emphasized that all Bar Associations must follow the same precedent. It added that reserving posts for women should not be a temporary measure but a permanent practice to ensure fair representation. The court further stated that women lawyers cannot be denied their right to reservation, as Articles 14 and 15 of the Constitution guarantee equal rights and prohibit discrimination. It stressed that excluding women from reserved positions in Bar Association elections would be unconstitutional.

Observing that providing equal representation to women is both a legal necessity and a moral obligation, the court ruled that all Bar Associations in Karnataka must adopt gender-inclusive policies in their electoral process.









'Quota Should Be Based on Foundation of Social Justice': HDK

Union Minister for Steel and Heavy Industries HD Kumaraswamy on Monday reaffirmed his party JDS' stand on reservations, emphasizing that quota policies should be based on social justice rather than religious appeasement. He dismissed speculation about differences between his party and its alliance partner BJP over the issue of minority reservation in government contracts.

He reiterated that the JDS has always stood for social justice and will continue to support policies that uplift weaker sections of society. "Reservation is

The father of late celebrity manager Disha Salian has filed a fresh complaint with the Mumbai Police Commissioner and Joint Commissioner, alleging the involvement of former Maharashtra minister Aaditya Thackeray, Bollywood actors, and ex-top police officials in her 2020 death.

According to advocate Nilesh Ojha, who filed the complaint on behalf of Salian's father, Aaditya Thackeray played a role in the alleged cover-up of the case. The complaint also names former Mumbai Police Commissioner Parambir Singh, actors Dino Morea and Suraj Pancholi, as well as Sachin Vaze and Rhea Chakraborty,



accusing them of suppressing Dino Morea, Suraj Pancholi the truth.

Meanwhile, regarding the CBI's recent closure report on actor Sushant Singh Rajput's death, Ojha asserted that it holds no legal weight and does not prevent further investigation. He emphasized that a court can still take cognizance of the matter, issue an arrest warrant, or order additional inquiry, similar to past cases like Aarushi Talwar's.

The party, in a social media post, urged AICC president Mallikarjun Kharge to seek Shivakumar's resignation if the Congress high command truly respected Dr. BR Ambedkar and the Constitution.

The controversy has sparked a political storm in Karnataka, with the BJP and JD(S) mounting pressure on the Congress government over its approach to reservations.

Residents of Bengaluru have laid out their expectations for the upcoming Bruhat Bengaluru Mahanagara Palike (BBMP) budget, urging authorities to scrap costly projects like tunnel roads and skydecks while prioritizing waste management, road repairs, and encroachment removal.

Kathyayini Chamaraj, Executive Trustee of CIVIC, highlighted the need for decentralized waste management instead of spending ₹500 crore annually on garbage transportation.

She suggested that every household in Bengaluru could be provided with compost bins for ₹1,200 each, while the remaining funds could be used to establish biomethanation plants in every ward. Providing free biogas to nearby residents, she said, could help ease opposition to such plants.

security checks at airports using privileges granted to Rao. Following this, the government sent Rao, Managing Director of Karnataka State Police Housing and Infrastructure Development Corporation, on compulsory leave from March 15. Meanwhile, the Karnataka High Court has directed the Centre to take steps against media outlets broadcasting defamatory content about Ranya and her father. The family contends that some media houses have engaged in character assassination rather than objective reporting.

The case stems from an incident at Kempegowda International Airport, where authorities seized gold bars worth ₹12.56 crore from Ranya. A subsequent search at her residence reportedly uncovered gold jewelry worth ₹2.06 crore and cash amounting to ₹2.67

crore. On March 12, a civil court had already restrained the media from making statements against Ranya until June 2, a directive later reinforced by the High Court.

The court issued an emergent notice to media houses violating these orders, granting interim relief to Ranya by reinforcing restrictions on defamatory coverage.

"Bengaluru Police Bust Fake Marks Card Racket, Three Arrested"

Bengaluru police have busted a fake marks card racket, leading to the arrest of three individuals involved in producing and distributing fraudulent SSLC and PUC certificates. The arrested suspects have been identified as Prashanth Gundumi, 41, from Chaitanya Nagar in Dharwad; Monish KJ, 36, from Banashankari in Bengaluru; and Rajashekhar H, 41, from Vinayaka Nagar in Gadag. The accused charged between Rs 5,000 and Rs 10,000 for providing fake SSLC and PUC marks cards without requiring candidates to take any written examinations. Investigations have so far revealed that over 350 fake marks cards were issued.

Bengaluru Police Commissioner B Dayananda confirmed during a press conference that some individuals had used these fraudulent documents

Further inquiries uncovered that the Transport Department and other government agencies had contacted the accused for document verification, to which they falsely affirmed the legitimacy of the certificates. Bengaluru Woman Alleges Cab Driver Extortio

A Bengaluru woman has alleged that a cab driver extorted ₹3,000 from her 18-year-old brother in the middle of the night and that the police refused to help him. The woman, Mrinali Priyadarshni, shared the ordeal on LinkedIn, expressing her anger and frustration over the incident.

According to Priyadarshni, her younger brother arrived at Bangalore International Airport around midnight and faced difficulties booking a cab through ride-hailing services like Ola, Uber, and Rapido. Left with no choice, he opted for an airport taxi to Yelahanka, agreeing to pay approximately ₹800 as displayed on the Rapido app. However, once inside

the cab, the driver reportedly started questioning him about whether he was a local and deliberately took a longer route, increasing the distance from 19 km to 24 km.

Things took a terrifying turn when the driver suddenly stopped the cab in an isolated area, stepped out, and started threatening him. Priyadarshni claimed that the driver demanded ₹3,000 and warned her brother that if he refused to pay, he would be taken to the driver's friends, who could harm him. The frightened teenager pleaded with the driver, asking why he was being forced to pay extra, to which the driver allegedly responded, "Because I want it. 

Karnataka HC Halts Action Against Kumaraswamy in Land Case Till March 27

The Karnataka High Court has directed the state government not to take any coercive action against former Chief Minister H D Kumaraswamy until March 27 in a land encroachment case. The ruling came after Kumaraswamy filed a petition challenging an eviction notice issued by the tahsildar regarding alleged clearings on government gomala (grazing) land.

Justice N S Sanjay Gowda, while hearing the case, passed the interim order restraining authorities from proceeding against Kumaraswamy until further legal examination. The eviction notice accused the former Chief Minister of encroaching on government land, prompting legal action. However, Kumaraswamy's legal team argued that the notice was issued without following due process and sought judicial relief.



With the High Court's directive in place, the state gov-

ernment is temporarily barred from taking any immediate steps against Kumaraswamy. The matter is set for further hearing, where the court will decide the legality of the eviction order. The case is being closely watched, as it could have significant political and legal implications in Karnataka. The ruling could influence similar cases related to alleged land encroachments and government action against political figures.

Trump's New Social Media Policy

- Indian Green Card Holders may have to disclose social media handles
- Policy extends existing visa scrutiny to permanent residency seekers

Green card holders in the United States may soon be required to submit their social media account details to the government under a new policy proposed by President Donald Trump's administration. While visa applicants applying from outside the country already need to provide their social media handles, this policy seeks to extend the requirement to those living in the US legally and applying for permanent residency or asylum.

The move has sparked concerns, particularly among Indian immigrants, many of whom are vocal about political issues in both India and the US. Critics argue that this increased scrutiny could discourage open expression on social media due to fear of government action. The policy could potentially be used to deny immigration benefits to individuals based on their online activity.

Purpose of the Policy

A notice issued by the US Citizenship and Immigration Services (USCIS) on March 5 outlined the administration's rationale for the proposal. According to the notice, USCIS has identified a need to collect social media handles and platform names from applicants as part of national security and identity verification measures. The agency claims that monitoring social media activity is crucial for vetting individuals and ensuring public safety.

"The vetting of social media accounts is necessary for enhanced identity verification, vetting, and national security screening," the document states. The government is currently



seeking public feedback on the policy before finalizing its implementation. **Impact on Green Card Holders**

Currently, social media screening applies only to visa applicants outside the US. However, this proposed change will bring green card applicants and asylum seekers under the same level of scrutiny. Individuals already residing in the US on valid visas but seeking permanent residency will need to disclose their social media activities, allowing authorities to monitor their online presence.

This could have significant implications, particularly for Indian immigrants who use social media to engage in discussions about US and Indian politics. Experts fear that this increased surveillance might push people to self-censor their views due to concerns about how their online activity could be interpreted by immigration officials.

Part of Trump's Broader Immigration Crackdown

Trump has taken a hardline stance on immigration. On his first day back in office, he signed an executive order directing federal agencies to take aggressive action against illegal immigration, describing it as an "invasion" threatening national security. His administration has ramped up enforcement efforts, with federal law enforcement agencies conducting widespread raids and arrests.

Trump has frequently claimed that undocumented immigrants are responsible for crime and economic instability, although these assertions are not fully supported by government data. His administration's immigration policies have drawn sharp criticism for being overly harsh and targeting legal residents as well.

Is the Government **Considering Bringing Back NJAC?**

Hyderabad, March 26: The controversy surrounding Delhi High Court Judge Justice Yashwant Varma and the discovery of burnt cash at his residence has brought the issue of judicial appointments and accountability back into focus. While the immediate fallout centers around the credibility of Justice Varma and his involvement, the bigger picture is about the integrity and transparency of India's judicial system. This raises an important question: is it time for the government to revive the National Judicial Appointments Commission (NJAC) and replace the existing collegium system?

The Background of NJAC vs Collegium

In 2015, the Supreme Court struck down the National Judicial Appointments Commission (NJAC) Act, which sought to replace the collegium system of judicial appointments with a body consisting of both judiciary and executive representatives. The Court argued that NJAC violated the Constitution's basic structure and undermined judicial independence. This ruling entrenched the collegium system, in which a group of senior judges, without any direct electoral mandate, decides the appointment of judges to the highest courts in the country. The NJAC, introduced through the 99th Constitutional Amendment, was designed to ensure a balanced, transparent, and democratic approach to judicial appointments. The idea was to bring accountability and prevent allegations of nepotism or favoritism within the judiciary. However, the Supreme Court's verdict left the power of judicial appointments entirely within the hands of the judiciary, effectively sidelining the executive's role in the process.

Is the Collegium System Truly Democratic?

The collegium system, while championed for its focus on judicial independence, also raises critical concerns about accountability. The primary issue lies in the fact that the people, through their elected representatives, do not have a say in selecting the judges who will interpret laws, make decisions on public policies, and influence governance. The judiciary's actions have a profound impact on the lives of ordinary citizens, yet those sitting in judgment are not directly accountable to the public.

The collegium system, without any checks from the legislative or executive branches, creates a scenario where a group of unelected judges appoints their peers. This setup not only perpetuates an insular and self-reinforcing system, but it also makes it difficult to address concerns about transparency and fairness. As we've seen in the case of Justice Varma, the discovery of cash raises questions about the accountability of judges in the absence of external scrutiny or oversight.

In a major reform aimed at enhancing financial flexibility for India's workforce, the Employees' Provident Fund Organisation (EPFO) will soon enable Provident Fund (PF) withdrawals through Unified Payments Interface (UPI) and ATMs. This significant initiative, approved by the Labour and Employment Ministry, is expected to be rolled out by the end of May or June this year, providing seamless and instant access to PF savings.

Sumita Dawra, Secretary of the Ministry of Labour and Employment, announced the development, stating that the integration of UPI with the EPFO system would allow members to instantly withdraw up to ₹1 lakh. Additionally, the introduction of ATM-based withdrawals will offer another convenient mode of accessing funds, reducing the dependency on traditional claim processes.

With this upgrade, PF account holders will be able to check their balance directly via UPI, transfer funds to their preferred bank accounts, and execute instant withdrawals. This initiative is in line with Prime Minister Narendra Modi's vision of "ease of living," aiming to simplify social security procedures for employees and employers across the country.

Expanded Withdrawal Options for Members

The EPFO has expanded the scope of withdrawals beyond retirement benefits. Members can now withdraw funds for various purposes such as housing, education, and marriage, in addition to the existing provisions for medical emergencies. These changes provide much-needed financial flexibility, allowing workers to access their hard-earned savings when re-



quired without lengthy bureaucratic hurdles.

"The EPFO has significantly strengthened its digital infrastructure, integrating over 120 databases to streamline the withdrawal process. As a result, the claim processing time has been reduced to just three days, with 95% of claims now being processed automatically," Dawra said.

She further added that the governsimplify the withdrawal process, enfunds with minimal delay. The intelike UPI will eliminate unnecessary paperwork and speed up transactions, making EPFO services more accessible to millions of contributors.

Improved Pension Withdrawal System

Apart from PF withdrawals, pension- The introduction of UPI and ATMreforms introduced by the EPFO. Since December, nearly 78 lakh pensioners have gained increased flexibility in accessing their funds. Previously, pension withdrawals were restricted to select bank branches, causing inconvenience to many retirees. restrictions.

These measures are part of the government's broader agenda to modernize social security mechanisms and improve the financial convenience of employees and pensioners alike. The reforms also reflect the government's commitment to leveraging digital technology to enhance service delivery in the financial sector.

The case for bringing back the NJAC is compelling, particularly in light of recent events. If we look at the Justice Varma controversy, the judicial system has once again shown the limitations of an unaccountable body of unelected officials. The centre's decision to convene an all-party meeting on this issue reflects growing concerns about transparency and judicial oversight, but the root issue remains: the judiciary operates in a vacuum, with limited external accountability. A reformed NJAC could serve as a safeguard against the kind of problems that have plagued the collegium system. A body that includes both judiciary and executive members, with clear procedures for selection and monitoring, would ensure more public transparency and offer a mechanism to address grievances. Elected representatives, accountable to the people, could play a role in judicial appointments, creating a more democratic system in which the judiciary remains independent but not entirely isolated.

A System of Balance and Accountability

In a democracy, elected representatives should have a role in lawmaking, policy decisions, and, to some extent, judicial appointments. A system that prioritizes judicial independence must still strike a balance with accountability. The judicial branch must not be an isolated fortress immune to oversight and scrutiny. The NJAC, with proper checks and balances, offers a solution to this dilemma, ensuring the judiciary can function without fear or favor but within the boundaries of the democratic system.

India's legal system must evolve with the times, and reviving a form of NJAC could be the way forward. It would empower the people through their representatives, ensuring that the judiciary remains independent yet accountable. The current status quo—where a group of unelected judges governs judicial appointments—no longer seems sustainable in a democratic framework that values transparency and fairness.

The recent events surrounding Justice Varma and the public outcry over the discovery of cash raise critical questions about judicial accountability. The government's engagement with political parties on the issue indicates a growing concern for a system that can balance judicial independence with transparency and public trust. If the judiciary is to retain its credibility, it must operate within a framework that includes checks and balances, and that framework may very well involve reviving the National Judicial Appointments Commission (NJAC). It is time to reconsider the collegium system and bring accountability into the heart of the judiciary.





New Income Tax Bill to Be Discussed in Monsoon Session: Nirmala Sitharaman



Finance Minister Nirmala Sitharaman announced on Tuesday that the new Income Tax Bill will be taken up for discussion in the monsoon session of Parliament. The bill, which was introduced in the Lok Sabha on February 13, is currently under review by the Select Committee. While addressing discussions on the Finance Bill 2025 in the Lok Sabha, Sitharaman confirmed that the Select Committee has been directed to submit its report by the first day of the upcoming session. "...We will take it (new income tax bill) up in the monsoon session," she stated. The monsoon session of Parliament typically begins in July and continues through August. The new Income Tax Bill aims to bring about a simplified tax structure by reducing complexities and eliminating ambiguities in the existing law. The Income Tax Department previously fessionals alike. highlighted that the revised legislation seeks to provide tax certainty while minimizing litigation and the scope for fresh interpretations. One of the major highlights of the proposed bill is its concise structure compared to the existing Income Tax Act of 1961. The new bill contains 2.6 lakh words, significantly less than the 5.12 lakh words in the current Act. Additionally, it has 536 sections, down from the 819 effective sections in the current law. The number of chapters has also been streamlined from 47 to 23. The revised legislation introduces 57 tables, an increase from the 18 found in the existing Act, but has removed 1,200 provisos and 900 explanatory notes, thereby simplifying legal provisions. These changes aim to create a more comprehensible and user-friendly tax regime for taxpayers and tax pro-

vamp the Income Tax Act is seen as a significant step in modernizing India's tax framework, ensuring greater efficiency and transparency in tax administration. The government hopes that the new law will reduce tax disputes and enhance compliance by making the provisions clearer and more structured. Separatism in Kashmir Ends as Two Hurriyat Groups Sever Ties

Union Home Minister Amit Shah on Tuesday announced a significant political shift in Jammu and Kashmir, stating that two factions of the separatist Hurriyat Conference have officially severed ties with separatism. He asserted that this move is a testament to the success of the Modi government's policies aimed at fostering national unity and eliminating separatist tendencies in the region. Hurriyat Conference, an amalgamation of various separatist groups in Jammu and Kashmir, has played a pivotal role in advocating for the region's separation from India for decades. However, recent developments indicate a departure from this ideology, marking what Shah described as a "historic victory" for Bharat's unity. Taking to social media platform 'X', Shah welcomed the decision and urged other separatist groups to follow suit, emphasizing that abandoning separatism is the only path toward peace, development, and progress. "Two organizations associated with the Hurriyat have announced the severing of all ties with separatism. I welcome this step towards strengthening Bharat's unity and urge all such groups to come forward and shed separatism once and for all," Shah posted. The Home Minister further highlighted that the government's strategic policies, including the abrogation of Article 370, development initiatives, and stringent security measures, have played a crucial role in dismantling separatist sentiments in the valley. He credited Prime Minister Narendra Modi's leadership for fostering a sense of belonging and integration among the people of Jammu and Kashmir. Shah reiterated that the government remains committed to transforming the region into a peaceful, developed, and unified part of India. He stated that the latest move by the Hurriyat factions is proof that separatist ideology is losing its ground and that more groups are realizing the benefits of aligning with the national mainstream. The announcement comes in the wake of a series of measures undertaken by the central government to curb separatist activities in Jammu and Kashmir. Over the past few years, authorities have cracked down on terror financing, taken legal action against separatist leaders, and promoted economic development to ensure stability in the region. With this latest development, political analysts believe that the separatist movement in Kashmir has suffered a significant blow. The disintegration of Hurriyat factions from their separatist stance signals a new chapter in the region's history, aligning with the Modi government's broader vision of a peaceful and prosperous Jammu and Kashmir within a unified Bharat.

"India, China Discuss LAC, Strengthen Ties"

India and China held a high-level meeting in Beijing today, marking the 33rd session of the Working Mechanism for Consultation and Coordination (WMCC) on India-China Border Affairs. The discussions primarily focused on reviewing the situation along the Line of Actual Control (LAC) and exploring ways to improve diplomatic and military coordination. Both sides emphasized the importance of maintaining stability and ensuring the early resumption of cross-border cooperation, including trans-border river management and the Kailash-Mansarovar Yatra. The Indian delegation was led by Gourangalal Das, Joint Secretary (East Asia) in the Ministry of External Affairs, while the Chinese delegation was headed by Hong Liang, Director General of the Boundary and Oceanic Affairs Department of the Chinese Ministry of Foreign Affairs. The meeting was described as "positive and constructive," with both nations reaffirming their commitment to strengthening diplomatic channels and enhancing mechanisms for border management. A key outcome was the agreement to make "substantial preparations" for the next meeting of the Special Representatives (SRs) on the boundary question, which is scheduled to take place in Delhi later this year. The Ministry of External Affairs (MEA) stated that the discussions covered various proposals and measures aimed at implementing the decisions made during the 23rd meeting of the Special Representatives on the India-China boundary issue, which was held in Beijing in December 2024. Both nations acknowledged the need to advance effective border management while preventing escalations along the LAC. Additionally, they agreed to strengthen existing diplomatic and military mechanisms to ensure quick resolution of any disputes. Following the meeting, Gourangalal Das paid a courtesy visit to China's Assistant Foreign Minister, Hong Lei, signaling continued diplomatic engagement between the two nations. The discussions are part of broader efforts to return to a pre-2020 status quo along the LAC and improve bilateral ties. This initiative gained momentum after Prime Minister Narendra Modi and Chinese President Xi Jinping met in October 2024 on the sidelines of the BRICS Summit in Kazan, Russia, He stressed the need to rebuild trust and maintain a constructive relationship. Modi also acknowledged the ancient civilizational ties between India and China, emphasizing that the two nations had historically coexisted peacefully for millennia. He advocated for a spirit of healthy competition rather than conflict. China responded positively to Modi's remarks, with the Chinese Foreign Ministry stating that cooperation between the two nations, referred to as a "dragon-elephant dance," was the best path forward. The spokesperson reiterated that in over 2,000 years of interaction, India and China had maintained friendly exchanges and contributed to human progress. The latest diplomatic engagements indicate a continued effort to resolve border tensions and strengthen bilateral cooperation.

Top Maoist with ₹25 Lakh Bounty Killed in Chhattisgarh Encounter"

- Maoist leader killed in encounter.

A Maoist carrying a reward of ₹25 lakh on his head was among three insurgents killed in an encounter with security forces in Chhattisgarh's Dantewada district on Tuesday, police said. The gunfight took place at around 8 am in a dense forest area along the border of Dantewada and Bijapur districts. Security personnel were conducting an anti-Maoist operation based on intelligence reports about Maoist presence in the forests surrounding Girsapara, Nelgoda, Bodga, and Ikeli villages under the Geedam police station limits, according to Superintendent of Police Gaurav Rai. The operation involved personnel from the District Reserve Guard (DRG) and Bastar Fighters, both special units of the Chhattisgarh state police, known for their expertise in counterinsurgency operations. As the security forces reached the targeted location, a fierce exchange of fire broke out between the two sides. After the gunfight subsided, the security personnel recovered the bodies of three male Maoists from the site, along with an Insas rifle, a .303 rifle, explosive materials, and other items used in their daily activities. Among the three slain Mao-



ists, one was identified as Sudhir, also known as Sudhakar or Murli, a resident of Warangal in Telangana. He was an active member of the Dandakaranya Special Zonal Committee, the most powerful faction of Maoists operating in the region. Authorities had placed a bounty of ₹25 lakh on his head due to his involvement in multiple attacks on security forces and civilians. The identities of the other two deceased Maoists are yet to be confirmed, officials said, adding that search operations are still ongoing in the area to trace any remaining insurgents or hidden weapon caches. Chhattisgarh, particularly the Bastar division, has been a stronghold of Maoist insurgents for decades. However, security forces have intensified their operations in recent years, leading to a significant number of encounters and Maoist casualties. Just a few days prior, on March 20, security forces carried out two major operations in Bijapur and Kanker districts, killing 30 Maoists.. Union Home Minister Amit

Shah recently reaffirmed the government's aggressive stance against Maoist insurgency, stating that the Narendra Modi-led administration is implementing a "zero-tolerance policy" against Maoists who refuse to surrender despite multiple opportunities and rehabilitation offers. He asserted that the government is committed to eradicating Maoism from the country and aims to make India completely Maoist-free by March 31, 2026. The growing success of anti-Maoist operations in Chhattisgarh reflects a shift in the balance of power in favor of security forces. The use of specialized units like the DRG and Bastar Fighters, combined with improved intelligence and coordination, has significantly weakened Maoist influence in the region. However, sporadic attacks by Maoists indicate that the insurgency is not completely dismantled. Authorities remain vigilant, continuing operations to eliminate the remaining Maoist factions and restore lasting peace in the region.







India may interfere in **General Election** on April 28: Canada

Canada's national security agency has raised concerns over possible foreign interference in the upcoming general election, scheduled for April 28, 2025. According to the Canadian Security Intelligence Service (CSIS), both China and India, alongside Russia and Pakistan, are likely to attempt to influence the election.

The warning comes amid growing tensions between Ottawa and both Beijing and New Delhi. Vanessa Lloyd, deputy director of operations at CSIS, highlighted that hostile state actors are increasingly utilizing advanced tools like artificial intelligence to meddle in democratic processes. "The People's Republic of China is highly likely to use AI-enabled tools to attempt interference in Canada's election," Lloyd stated at a press conference.

Canada's relations with both India and China have been strained in recent years. Beijing retaliated against Canada's tariffs on Chinese electric vehicles and steel by imposing tariffs on over \$2.6 billion worth of Canadian agricultural and food products. Additionally, Canada condemned China's execution of four Canadian citizens on drug smuggling charges.

Starlink Poised for Major Expansion in India, Boosting Ambitions for Global Growth

For Musk's Starlink, India Approval Could Unlock Emerging Markets

As Starlink nears regulatory approval for satellite broadband services in India, analysts believe this move could significantly boost the company's global expansion, especially in emerging markets. A successful entry into India could potentially add \$25 billion in revenue, reshaping the country's satellite broadband industry and attracting interest from other developing markets.

However, despite the promising outlook, Starlink faces legal hurdles and stiff competition from players like Eutelsat and China's SpaceSail, which is expanding into Brazil, Malaysia, and Kazakhstan. Additionally, SpaceX contends that U.S. regulations place it at a disadvantage compared to foreign rivals.

Starlink, owned by Elon Musk's SpaceX, has been waiting for licenses to operate commercially in India since 2022. The company has been embroiled in a regulatory standoff over spectrum allocation, with debates on whether India should auction satellite broadband spectrum, benefiting telecom giants like Mukesh Ambani's Reliance Jio casts a significant drop in


and Sunil Mittal's Bharti Airtel, or allocate it administratively to newer players like Starlink. In October, India opted for administrative allocation, giving Starlink a potential edge.

This month, both Reliance Jio and Bharti Airtel signed separate agreements with SpaceX, signaling that regulatory challenges may soon be resolved. Analysts suggest this development indicates that Starlink is closer to entering the Indian market.

The entry into India is a strategic move for Starlink, which operates in over 120 markets globally. Goldman Sachs fore-

prices for low Earth orbit (LEO) broadband services, projecting a reduction from \$148 per month in 2023 to just \$16 by 2035. With India being one of the largest potential markets, analysts expect Starlink to add 3 million global subscribers in 2025, with India being the leading contributor.

Starlink's pricing strategy will be crucial for success, with some experts predicting competitive plans starting at \$15 per month. As the satellite internet market in India grows, Starlink's entry will offer employment opportunities and fuel competition within the sector, enhancing India's global space industry competitiveness.



Canada Cites "India's Growing **Global Influence**" **In Allegation Against Pak**

Canada has raised concerns over potential foreign interference in its upcoming April 28 general election, warning that Pakistan, India, China, and Russia could be involved in attempts to sway the democratic process. Vanessa Lloyd, Deputy Director of Operations at the Canadian Security Intelligence Service (CSIS), highlighted that Pakistan may conduct interference activities to counter India's growing global influence. She explained that Pakistan's actions could align with its strategic aims to maintain political and economic stability while curbing India's rise on the world stage.

Lloyd also addressed the possibility of Indian interference, stating that the Indian government has both the intent and capability to influence Canadian communities and the election process. This builds on similar allegations made last year, which India firmly rejected.

In a 2024 report, CSIS detailed "clandestine" foreign interference by both India and Pakistan during Canada's 2021 and 2019 general elections. The agency accused India of targeting electoral districts with large Indian-origin populations, particularly those sympathetic to the Khalistani movement, and alleged the use of illicit financial support to sway candidates. Similarly, it claimed that Pakistan tried to influence federal politics in 2019 to further its inter-

Malaria Confirmed as Cause of Fatal Outbreak in Northwest DR Congo

Late on Monday, the National Public Health Institute (INSP) of the Democratic Republic of Congo confirmed that an outbreak in the northwest of the country, which claimed the lives of more than 50 people, was caused by malaria. The illness, which primarily affected Equateur province, resulted in 943 reported cases and 52 deaths at the beginning of the year.

The symptoms, which included fever, fatigue, vomiting, and weight loss, initially led health officials to suspect food poisoning or malaria as the potential cause. However, following laboratory tests on samples from affected individuals, malaria was de-

Christian Ngandu, coordinator of the INSP, confirmed the results of the tests over the phone, reassuring the public that the outbreak was now understood. Despite the confirmation, the health institute continues to

await the results of additional tests on water, drinks, and food samples sent abroad to further investigate whether there was any potential contamination involved.

This recent outbreak follows a similar occurrence in December, where an unknown illness initially puzzled health authorities before being traced back to malaria. These outbreaks have prompted increased vigilance and ongoing monitoring in the region.

Health officials have stressed the importance of public awareness regarding the symptoms and prevention of malaria, which is a major health concern in many parts of sub-Saharan Africa. With the confirmation of malaria as the cause, authorities are focusing on controlling the spread of the disease and providing support to affected communities.

As the investigation continues, the INSP has urged the public to seek medical help promptly if they experience symptoms, especially in malaria-prone areas, to prevent further fatalities.

The new bill is approximately half the size of the existing law, with a word count of 2.6 lakh compared to 5.12 lakh in the current Act. The number of sections in the bill has also been reduced, from 819 to 536. Additionally, the number of chapters has been halved from 47 to 23, while the number of tables has increased to 57 from the 18 present in the existing Act. The new bill has also removed over 1,200 provisos and 900 explanations, further simplifying the language and structure of tax regulations.

This overhaul of the Income Tax Act is seen as a significant step towards creating a more transparent and efficient taxation system in India, ensuring easier compliance and reducing unnecessary litigation.

S&P Cuts India's GDP Growth Forecast to 6.5% for FY 2025-26



S&P Global Ratings has revised India's GDP growth forecast for the fiscal year 2025-26, reducing it to 6.5%, down from an earlier projection of 6.7%. The global credit rating agency cited exter-

nal factors, including rising US tariffs and a broader pushback against globalization, as key reasons for the downward revision in its Economic Outlook for the Asia-Pacific (APAC) region.

Despite these external headwinds, S&P expects strong domestic demand to drive growth in most emerging-market economies, including India. The revised forecast reflects the agency's belief that the Indian economy will maintain momentum, aided by factors such as the expectation of a normal monsoon season and softening commodity prices, particularly crude oil.

S&P highlighted several domestic factors that could support India's economic growth. These include cooling food inflation, tax benefits introduced in the national budget for FY 2025-26, and lower borrowing costs, which are anticipated to boost discretionary consumption. The ongoing economic recovery in

India is also expected to benefit from government policies designed to stimulate growth, despite the global uncertainties.

The agency also noted that central banks across the APAC region, including the Reserve Bank of India, are likely to continue cutting benchmark interest rates throughout the year, providing further support to the domestic economy.

Although the forecasted 6.5% growth is consistent with the previous fiscal year's outcome, it reflects a more cautious outlook given the global challenges. The revised growth projection underscores the balancing act facing India's economy-navigating external pressures while maintaining robust internal demand.

India slaps Samsung with tax demand of ₹5,156 crore for telecom imports

India has directed Samsung and its executives to pay \$601 million in back taxes and penalties for allegedly evading tariffs on the import of key telecom equipment. This marks one of the largest tax demands in recent years, according to a government order.

The \$601 million demand represents a significant portion of Samsung's net profit in India for the previous year, which was reported at \$955 million. As one of the largest players in India's consumer electronics and smartphone market, the company's operations are under close scrutiny from local tax authorities.

Samsung has the option to challenge the tax demand through a tax tribunal or in the courts. The case is related to allegations that the company avoided paying the necessary import tariffs on certain telecoms equipment. This tax dispute could have significant financial implications for the company, considering the substantial penalty involved.

As the dispute unfolds, Samsung will likely consider its legal options while continuing to operate in one of the world's largest markets for consumer electronics. The outcome of this case could set a precedent for other multinational corporations operating in India and could influence future tax regulations and enforcement practices.

Plans for New Stadium for 2032 **Olympics**




ustralia has an-**A**nounced plans for a new 63,000-seat stadium and an indoor aquatic centre as part of preparations for the 2032 Olympic Games in Brisbane. Queensland Premier David Crisafulli revealed the updated infrastructure strategy, emphasizing long-term benefits over short-term spending.

"Finally, Queensland has a plan. The time has come to just get on with it. And get on with it we will," Crisafulli stated, confirming that the new stadium would be a permanent world-class venue for future sporting events. The aquatic centre, with temporary seating increasing capacity to 25,000, will host swimming, diving, water polo, and other aquatic sports. The main athletes' village will be constructed at the Brisbane Showgrounds, with additional accommodation hubs on the Gold Coast and Sunshine Coast. This new plan replaces an earlier proposal by the previous Labor government, which aimed to renovate the historic Gabba cricket ground and build a 17,000-seat indoor stadium. Crisafulli scrapped those ideas, arguing that billions would have been wasted on temporary venues that lacked lasting value.

In addition to the new stadium and aquatic centre, authorities have earmarked funds for upgrading smaller venues, including the Queensland Tennis Centre and the Gold Coast Hockey Centre. While specific costs have not been disclosed, Australia has set aside approximately \$4 billion for Olympic infrastructure.
