

# Telangana Cabinet Expansion

- Ministers to Take Oath on April 3
- Congress high command approves cabinet expansion
- Oath-taking ceremony likely on April 3
- Four to five new ministers expected to be inducted

The Congress high command has given its nod for the much-awaited cabinet expansion in Telangana, with the oath-taking ceremony scheduled for April 3. Reports suggest that two leaders from the BC community, one Reddy, and one SC representative will be accommodated in the new cabinet reshuffle.

**Possible Ministerial Picks** 

As per sources, the Congress leadership has gathered inputs from the state core committee, CM Revanth Reddy, and PCC Chief Mahesh Kumar Goud before finalizing the names. Among the strong contenders for a ministerial berth are:

Komatireddy Rajagopal Reddy, Sudarshan Reddy, or Mal Reddy from the Reddy commu-

Aadi Srinivas and Srihari Mudiraj from the BC category. Chennur MLA Vivek Venkataswamy is being considered

for the SC quota.

If a minority leader is accommodated, MLC Ameer Ali Khan could get a spot.

Out of the six vacant ministerial positions, reports indicate that four to five may be filled in this expansion.

Strategic Move Ahead of Local Elections

CM Revanth Reddy, Deputy CM Bhatti Vikramarka, and PCC Chief Mahesh Kumar Goud recently visited Delhi, where the AICC leadership discussed the cabinet expansion. With local body elections around the corner, the Congress high command is keen on ensuring ministerial representation across all regions to strengthen the party's prospects. The assembly budget sessions will conclude on March 27, and sources suggest that the cabinet expansion may take place on Ugadi or just before the festival.

# SLBC Tunnel Collapse

### Second Worker's Body Identified Hours After Recovery

The body of the second worker trapped in the SLBC tunnel collapse was identified hours after being recovered on Tuesday, March 25. The worker, identified as Manoj Kumar from Uttar Pradesh, was found following excavation efforts in the last 50 meters of the 14-kmlong tunnel.

Rescue workers had detected a foul odor near the loco track, prompting a focused search in that area, which was believed to be outside the D1 and D2 zones where the missing workers were suspected to be buried. The body was found about 50 meters from the conveyor belt using a mini excavator.

Search operations are ongoing as rescue teams continue their efforts to locate six other missing workers, who are be-



lieved to still be trapped under lapse the rubble.

The collapse of the Srisailam On March 9, the body of a Left Bank Canal (SLBC) tunnel in ruary 22, trapping eight workers, including two engineers. The workers trapped under the

collapsed roof have been identified as Manoj Kumar (UP), Sri Niwas (UP), Sunny Singh (J&K), Gurpreet Singh (Punjab), and Sandeep Sahu, Jegta Xess, Santosh Sahu, and Anuj Sahu, all from Jharkhand.

Earlier, Telangana Chief Minister A Revanth Reddy and State Irrigation Minister N Uttam Kumar Reddy had inspected the rescue operations. The chief minister expressed hope that the damaged conveyor belt would be repaired soon, with officials estimating two to three days to assess the full situation and determine the location of the trapped workers.

CM Revanth Reddy called the incident unfortunate and urged opposition parties to unite in providing support to the affected families, stating that empathy and cooperation were necessary in this difficult time.

### **CPI MLA Slams IT** Sector Exploitation, Calls for Govt's Action

CPI Legislative Party Leader Kunamneni Sambasiva Rao voiced strong concerns over the deteriorating work conditions in the IT sector during the Telangana Assembly session on Monday. He criticized companies for overworking employees and

urged the state government to take immediate action to safeguard workers' rights.

Rao highlighted how software jobs, once considered prestigious, now leave employees exhausted, with many appearing aged by the time they reach their 50s. He questioned whether existing labor laws were being enforced and demanded clarity on work hours, retirement age, and benefits. If necessary laws are lacking, he insisted they should be introduced, ensuring strict regulations on IT firms.

Industrial Development and Municipal Revenues

The CPI MLA also stressed



the need for district-specific industrial zones, citing Telangana's rich mineral reserves. He pointed out the granite and coal resources in Khammam and proposed upgrading a mining college into an Earth Sciences University to boost industrial and educational development.

Additionally, he raised concerns about the government's delay in disbursing municipal revenues, which has resulted in unpaid staff for months. He called for dedicated IAS officers in each district to oversee education and healthcare, ensuring full implementation of welfare schemes.

**Hyderabad:** BRS working president K.T. Rama Rao (KTR) strongly criticized the Congress government in the Telangana Legislative Assembly, questioning its policies and priorities. He highlighted the achievements of the previous KCR-led BRS government, including providing jobs to 550 individuals in the cultural sector, securing UNESCO heritage recognition for Ramappa Temple, and the grand reconstruction of Yadadri Temple.

KTR dismissed claims that nothing was done under KCR's tenure, citing key projects like Ranganayaka Sagar, Konda Pochamma Sagar, and the tourism development in Somashila, Jupally constituency. He also pointed out the successful completion of Warangal's Kaloji Kalakshetra.

Raising concerns, KTR questioned why the Congress government had locked the 125-foot Ambedkar statue and why the Martyrs' Memorial remained inaccessible to the public. He criticized the government's decision to lease the Outer Ring Road (ORR) under the TOT mod-

el for 33 years, asking how a 99year lease in the tourism policy

could be justified.

KTR also targeted the government's decision to cancel the Formula E race, which he claimed generated Rs 700 crore in revenue. He questioned how the Miss World pageant would bring comparable income and job opportunities.

Addressing the agrarian crisis, he stated that 480 farmers had committed suicide due to a lack of irrigation water, while people continued to suffer from drinking water shortages. He urged the government to prioritize public welfare over eventbased expenditures.

### Minister Sridhar Babu Clarifies on 400 Acres in Kancha Gachibowli

IT and Industries Minister Sridhar Babu has issued a clarification regarding the 400 acres of land in Survey No. 25, Kancha Gachibowli, Serilingampally Mandal, Rangareddy District, in response to recent misleading reports. He stated that the land rightfully belongs to the government and is being allotted for development through TGIIC (Telangana State Industrial Infrastructure Corporation).

Background and Legal Proceedings

In 2003, the Andhra Pradesh government allotted this land to IMG Academies Bharat Pvt. Ltd. for sports infrastructure development. However, IMG failed to initiate the project, and the Congress government in 2006 cancelled the allotment due to rule violations.

Following this, IMG Academies filed a petition in the High Court, which ruled on March 7, 2024, in favor of the government's decision. Later, IMG approached the Supreme Court through a Special Leave Petition (SLP), which was dismissed on May 3, 2024, confirming the land as government-owned.

**Land Allotment to TGIIC** 

Minister Sridhar Babu affirmed that the Deputy Collector and Tehsildar of Serilingampally verified the revenue records, confirming that the 400 acres is government land with no links to the Forest Department.

As per the new land allotment policy, the government issued an order on June 26, 2024, allocating the land to



TGIIC. Official handover to TGIIC was completed on July 1, 2024.

TGIIC has assured that there has been no encroachment on the University of Hyderabad land and clarified that no water bodies like Buffalo Lake or Peacock Lakes exist in the 400acre area. Additionally, the stone structures and mushroom-shaped rock formations

within the land will be preserved as a green zone, and an environmental protection plan will be implemented to ensure sustainable development.

TGIIC is now preparing to invite tenders for integrated development on the land, aiming to create world-class infrastructure with a sustainable approach.

# Seethakka Slams Sabitha Over **Education Department Issues**

She further revealed that after the Congress government took charge, they cleared ₹3.5 crore in pending bills left unpaid by the previous administration.

Taking a dig at the BRS gov-



ernment's claims of improving the education sector, Seethakka pointed out that even former CM KCR's grandson was shocked by the poor state of schools. "He visited the Gouli Doddi school and admitted that he had never seen such conditions before," she said.

She criticized the BRS for boasting about increasing the number of schools while

failing to provide even basic infrastructure facilities. Seethakka's remarks underscored the Congress government's commitment to ad-


dressing the shortcomings left behind by the previous administration, ensuring that educational institutions receive proper funding and infrastructure develop-

### MLAs' Disqualification **Petition adjourned** to April 2

The Supreme Court has adjourned the hearing on the BRS MLAs' disqualification petition to April 2, adding a new twist to the ongoing political tussle in Telangana. The hearing, which was expected to bring clarity on the fate of the ten rebel MLAs who switched from BRS to Congress, saw intense arguments from both sides. Lawyers representing the BRS party presented their arguments for nearly two hours in court today. However, the lawyers representing the Telangana Assembly Speaker and Assembly Secretary are scheduled to present their counterarguments on April 2. Following this, the court is likely to deliver its verdict, which could have significant political implications.

Earlier, there was widespread speculation that the Supreme Court would announce its decision today. This uncertainty has created high tension among the ten MLAs, who are now holding discussions with their legal teams to assess possible outcomes. The case has drawn keen interest from political observers, as the verdict could impact the Congress government's sta-



# Komatireddy Confident of Ministerial Post Says He Prefers Home Portfolio

Munugodu MLA Komatireddy Rajagopal Reddy has expressed confidence in securing a ministerial berth in the upcoming Telangana cabinet expansion. While he stated that he has not received any call from Delhi so far, he emphasized that the high command should select ministers based on their capability. He also made it clear that he has a preference for the Home Minister portfolio, asserting that he is ready to take on any responsibility and serve the people efficiently.

The speculation surrounding cabinet expansion has intensified with CM Revanth Reddy, Deputy CM Bhatti Vikramarka, Minister Uttam Kumar Reddy, and PCC Chief Mahesh Kumar Goud visiting Delhi for discussions with the Congress high

command. Reports indicate that Rajagopal Reddy and Bodhan MLA Sudarshan Reddy are likely to be inducted into the cabinet.

At the same time, there are rumors that ministers Konda Surekha and Jupally Krishna Rao might be dropped. Sources suggest that Prem Sagar Rao from the Velama community could replace Jupally Krishna Rao, while there is also speculation that actor-turned-politician Vijayashanti is being considered for a ministerial position. Additionally, Chennur MLA Vivek Venkataswamy is reportedly confirmed for a cabinet berth.

A final decision on the new ministerial lineup is expected in the next couple of days, with the swearing-in ceremony scheduled for April 3.

### Vemula Prashanth Reddy Questions Govt's Budget Allocations in Assembly

BRS MLA Vemula Prashanth Reddy raised several concerns in the Telangana Assembly regarding budget allocations and the implementation of funds across multiple departments, including Tourism, Endowments, Sports, Forest, and Excise.

During the discussion on the Tourism Department Bill, he pointed out that while ₹620 crore was allocated in the 2024-25 budget, the amount has been increased to ₹800 crore in 2025-26. However, he questioned how much of the previous budget was actually spent. "Telangana has immense potential for tourism development, yet the allocated funds are not being effectively utilized," he stated. He urged the government to focus on areas beyond Mahbubnagar and Mulugu, particularly in Balkonda, Nizamabad district, where he proposed developing a boat trip from SRSP to Basara.

Regarding the Endowments Department, Prashanth Reddy noted that ₹237 crore was



allocated in 2024-25 and ₹241 crore in 2025-26. He stressed the need for immediate release of funds for temple development, similar to how

the BRS government under KCR allocated funds ing, reversing the gains made under KCR's for Yadadri and other temples across the state. He also criticized the current government for neglecting the Brahmin Parishad, which was formed under KCR with a ₹100 crore allocation. Additionally, he demanded the release of pending foreign scholarship funds for 300 Brahmin students, while another 340 new students await funding.

Discussing the Sports Department, he acknowledged that Chief Minister Revanth Reddy has shown interest in sports and allocated ₹536 crore in the budget. However, he emphasized the need for concrete policies to support rural athletes and called for serious steps to make Telangana a future host for the Olympics.

On the Forest Department, he criticized the continuous reduction of funds, pointing out that while ₹1,471 crore was allocated in 2023 under the BRS government, it was cut to ₹1,064 crore in 2024 and further reduced to ₹1,023 crore in 2025. He warned that deforestation is increasHaritha Haram program, which saw 273 crore saplings planted over ten years. He urged the government to take strict action against deforestation and tap into central funds to increase allocations for forest conservation.

Prashanth Reddy strongly opposed the Congress government's stance on the Excise Department, condemning the decision to increase the revenue target from ₹38,000 crore last year to ₹50,000 crore this year. ### **Speaker Calls for Removal** of All Conocarpus Trees

On Tuesday, March 25, Telangana Speaker Gaddam Prasad called for the removal of all conocarpus trees planted across the state. Speaking in the state Assembly, Prasad emphasized that the species, which was widely planted under the Haritha Haram program over the last decade, should be uprooted due to its harmful environmental im-

Prasad pointed out that while the conocarpus tree grows easily and requires minimal water, it poses a significant ecological risk, as it absorbs oxygen and releases carbon dioxide. The speaker highlighted that these trees have been planted extensively across the state, including on national highways, and called for their removal as soon as possible. Conocarpus trees, which have been a common sight in Telangana, were also banned in the Greater Hyderabad Municipal Corporation (GHMC) area after research in 2022 revealed their negative environmental effects. In addition, Andhra Pradesh Deputy Chief Minister Pawan Kalyan had announced a ban on the species last year, and the state has reportedly destroyed thousands of these trees.

The former sarpanch of Nagaram village in Manthani, Boodida Mallesh, had also removed the trees after learning about their adverse impact on the environment, further highlighting the growing concern regarding this species in Telangana.

### **MMTS Assault Case**

### **Accused Identified as** Mahesh from Medchal

The Hyderabad police have intensified their probe into the shocking MMTS train assault case, where a young woman was forced to jump off a moving train to escape an attempted rape. The accused has been identified as Mahesh from Medchal, and the victim has confirmed his involve-

The brutal incident occurred when the 23-year-old victim, a private company employee from Anantapur district, was traveling alone in the women's coach of an MMTS train from Secunderabad to Medchal on Sunday night. After two other female passengers disembarked at Alwal station, the accused allegedly attempted to assault her. In a desperate bid to escape, the young woman leaped from the train near Kompally, sustaining severe injuries.

The police, acting swiftly, formed multiple teams and traced the accused based on CCTV footage. Upon presenting his photo to the victim, she positively identified Mahesh as her attacker. Special teams have now been deployed to apprehend him.

Meanwhile, the victim was initially admitted to Gandhi Hospital and later shifted to Yashoda Hospital with the intervention of MP Bandi Sanjay. Reports indicate that she is currently unable to speak due to her injuries.

The incident has sparked outrage, with calls for swift justice. Authorities continue their search for Mahesh as further investigation unfolds.



As of FY 2023, Telangana's IT sector accounts for 31 percent of India's software exports and employs over 9 lakh individuals in the IT/ITES sector, cementing the state's role as a major contributor to the country's software industry.

The police traced the baby to the couple's residence in Sirikonda, rescued him, and placed him under the care of child welfare authorities. Cases have been registered against the biological parents, the buyers, and the middlemen under Section 317 of the Bharatiya Nyaya Sanhita (BNS). Further investigation is underway.



# Fatal Accident in Bhadradri Kothagudem Trolley Falls Into Stream, 25 Agricultural Laborers Affected

# Govt Allocates ₹1,023 Crore for Forest Department Konda Surekha highlights key initiatives

# Trump's New Social **Media Policy**

- Indian Green Card Holders may have to disclose social media handles
- Policy extends existing visa scrutiny to permanent residency seekers

Green card holders in the United States may soon be required to submit their social media account details to the government under a new policy proposed by President Donald Trump's administration. While visa applicants applying from outside the country already need to provide their social media handles, this policy seeks to extend the requirement to those living in the US legally and applying for permanent residency or asylum.

The move has sparked concerns, particularly among Indian immigrants, many of whom are vocal about political issues in both India and the US. Critics argue that this increased scrutiny could discourage open expression on social media due to fear of government action. The policy could potentially be used to deny immigration benefits to individuals based on their online activity.

### **Purpose of the Policy**

A notice issued by the US Citizenship and Immigration Services (USCIS) on March 5 outlined the administration's rationale for the proposal. According to the notice, USCIS has identified a need to collect social media handles and platform names from applicants as part of national security and identity verification measures. The agency claims that monitoring social media activity is crucial for vetting individuals and ensuring public safety.

"The vetting of social media accounts is necessary for enhanced identity verification, vetting, and national security screening," the document states. The government is currently



seeking public feedback on the policy before finalizing its implementation. **Impact on Green Card Holders** 

Currently, social media screening applies only to visa applicants outside the US. However, this proposed change will bring green card applicants and asylum seekers under the same level of scrutiny. Individuals already residing in the US on valid visas but seeking permanent residency will need to disclose their social media activities, allowing authorities to monitor their online presence.

This could have significant implications, particularly for Indian immigrants who use social media to engage in discussions about US and Indian politics. Experts fear that this increased surveillance might push people to self-censor their views due to concerns about how their online activity could be interpreted by immigration officials.

### Part of Trump's Broader **Immigration Crackdown**

Since returning to the White House, in the US.

Trump has taken a hardline stance on immigration. On his first day back in office, he signed an executive order directing federal agencies to take aggressive action against illegal immigration, describing it as an "invasion" threatening national security. His administration has ramped up enforcement efforts, with federal law enforcement agencies conducting widespread raids and arrests.

Trump has frequently claimed that undocumented immigrants are responsible for crime and economic instability, although these assertions are not fully supported by government data. His administration's immigration policies have drawn sharp criticism for being overly harsh and targeting legal residents as well.

The proposed social media scrutiny policy is seen as an extension of this broader crackdown. While the government argues it is a necessary security measure, critics warn that it could be used to suppress free speech and silence dissent among immigrants hoping to settle permanently

# From June, UPI and ATM to Enable **Provident Fund Withdrawals**

In a major reform aimed at enhancing financial flexibility for India's workforce, the Employees' Provident Fund Organisation (EPFO) will soon enable Provident Fund (PF) withdrawals through Unified Payments Interface (UPI) and ATMs. This significant initiative, approved by the Labour and Employment Ministry, is expected to be rolled out by the end of May or June this year, providing seamless and instant access to PF

Sumita Dawra, Secretary of the Ministry of Labour and Employment, announced the development, stating that the integration of UPI with the EPFO system would allow members to instantly withdraw up to ₹1 lakh. Additionally, the introduction of ATM-based withdrawals will offer another convenient mode of accessing funds, reducing the dependency on traditional claim processes.

With this upgrade, PF account holders will be able to check their balance directly via UPI, transfer funds to their preferred bank accounts, and execute instant withdrawals. This initiative is in line with Prime Minister Narendra Modi's vision of "ease of living," aiming to simplify social security procedures for employees and employers across the country.

### **Expanded Withdrawal Options for Members**

The EPFO has expanded the scope of withdrawals beyond retirement benefits. # Is the Government **Considering Bringing Back NJAC?**

Hyderabad, March 26: The controversy surrounding Delhi High Court Judge Justice Yashwant Varma and the discovery of burnt cash at his residence has brought the issue of judicial appointments and accountability back into focus. While the immediate fallout centers around the credibility of Justice Varma and his involvement, the bigger picture is about the integrity and transparency of India's judicial system. This raises an important question: is it time for the government to revive the National Judicial Appointments Commission (NJAC) and replace the existing collegium system?

### The Background of NJAC vs Collegium

In 2015, the Supreme Court struck down the National Judicial Appointments Commission (NJAC) Act, which sought to replace the collegium system of judicial appointments with a body consisting of both judiciary and executive representatives. The Court argued that NJAC violated the Constitution's basic structure and undermined judicial independence. This ruling entrenched the collegium system, in which a group of senior judges, without any direct electoral mandate, decides the appointment of judges to the highest courts in the country.

The NJAC, introduced through the 99th Constitutional Amendment, was designed to ensure a balanced, transparent, and democratic approach to judicial appointments. The idea was to bring accountability and prevent allegations of nepotism or favoritism within the judiciary. However, the Supreme Court's verdict left the power of judicial appointments entirely within the hands of the judiciary, effectively sidelining the executive's role in the process.

### Is the Collegium System Truly Democratic?

The collegium system, while championed for its focus on judicial independence, also raises critical concerns about accountability. The primary issue lies in the fact that the people, through their elected representatives, do not have a say in selecting the judges who will interpret laws, make decisions on public policies, and influence governance. The judiciary's actions have a profound impact on the lives of ordinary citizens, yet those sitting in judgment are not directly accountable to the public.

The collegium system, without any checks from the legislative or executive branches, creates a scenario where a group of unelected judges appoints their peers. This setup not only perpetuates an insular and self-reinforcing system, but it also makes it difficult to address concerns about transparency and fairness. As we've seen in the case of Justice Varma, the discovery of cash raises questions about the accountability of judges in the absence of external scrutiny or oversight.

### The Case for Bringing Back NJAC

The case for bringing back the NJAC is compelling, particularly in light of recent events. If we look at the Justice Varma controversy, the judicial system has once again shown the limitations of an unaccountable body of unelected officials. The centre's decision to convene an all-party meeting on this issue reflects growing concerns about transparency and judicial oversight, but the root issue remains: the judiciary operates in a vacuum, with limited external accountability. A reformed NJAC could serve as a safeguard against the kind of problems that have plagued the collegium system. A body that includes both judiciary and executive members, with clear procedures for selection and monitoring, would ensure more public transparency and offer a mechanism to address grievances. Elected representatives, accountable to the people, could play a role in judicial appointments, creating a more democratic system in which the judiciary remains independent but not entirely isolated.

### A System of Balance and Accountability

In a democracy, elected representatives should have a role in lawmaking, policy decisions, and, to some extent, judicial appointments. A system that prioritizes judicial independence must still strike a balance with accountability. The judicial branch must not be an isolated fortress immune to oversight and scrutiny. The NJAC, with proper checks and balances, offers a solution to this dilemma, ensuring the judiciary can function without fear or favor but within the boundaries of the democratic system.

India's legal system must evolve with the times, and reviving a form of NJAC could be the way forward. It would empower the people through their representatives, ensuring that the judiciary remains independent yet accountable. The current status quo—where a group of unelected judges governs judicial appointments—no longer seems sustainable in a democratic framework that values transparency and fairness.

The recent events surrounding Justice Varma and the public outcry over the discovery of cash raise critical questions about judicial accountability. The government's engagement with political parties on the issue indicates a growing concern for a system that can balance judicial independence with transparency and public trust. If the judiciary is to retain its credibility, it must operate within a framework that includes checks and balances, and that framework may very well involve reviving the National Judicial Appointments Commission (NJAC). It is time to reconsider the collegium system and bring accountability into the heart of the judiciary.





# **New Income Tax Bill to Be** Discussed in Monsoon Session: Nirmala Sitharaman



Finance Minister Nirmala Sitharaman announced on Tuesday that the new Income Tax Bill will be taken up for discussion in the monsoon session of Parliament. The bill, which was introduced in the Lok Sabha on February 13, is currently under review by the Select Committee. While addressing discussions on the Finance Bill 2025 in the Lok Sabha, Sitharaman confirmed that the Select Committee has been directed to submit its report by the first day of the upcoming session. "...We will take it (new income tax bill) up in the monsoon session," she stated. The monsoon session of Parliament typically begins in July and continues through August. The new Income Tax Bill aims to bring about a simplified tax structure by reducing complexities and eliminating ambiguities in the existing law. The Income Tax Department previously fessionals alike. highlighted that the revised legislation seeks to provide tax certainty while minimizing litigation and the scope for fresh interpretations. One of the major highlights of the proposed bill is its concise structure compared to the existing Income Tax Act of 1961. The new bill contains 2.6 lakh words, significantly less than the 5.12 lakh words in the current Act. Additionally, it has 536 sections, down from the 819 effective sections in the current law. The number of chapters has also been streamlined from 47 to 23. The revised legislation introduces 57 tables, an increase from the 18 found in the existing Act, but has removed 1,200 provisos and 900 explanatory notes, thereby simplifying legal provisions. These changes aim to create a more comprehensible and user-friendly tax regime for taxpayers and tax pro-

vamp the Income Tax Act is seen as a significant step in modernizing India's tax framework, ensuring greater efficiency and transparency in tax administration. The government hopes that the new law will reduce tax disputes and enhance compliance by making the provisions clearer and more structured. The Select Committee's review and recommendations will be crucial in shaping the final version of the bill before its discussion in Parliament. With its reduced complexity and restructured format, the proposed Income Tax Bill 2025 is expected to be a landmark reform in India's taxation system. Stakeholders, including businesses and tax professionals, are keenly watching the developments surrounding the bill, as its implementation could have a significant impact on the country's economic and taxation landscape.



### **Separatism in Kashmir Ends as Two Hurriyat Groups Sever Ties**

Union Home Minister Amit Shah on Tuesday announced a significant political shift in Jammu and Kashmir, stating that two factions of the separatist Hurriyat Conference have officially severed ties with separatism. He asserted that this move is a testament to the success of the Modi government's policies aimed at fostering national unity and eliminating separatist tendencies in the region. Hurriyat Conference, an amalgamation of various separatist groups in Jammu and Kashmir, has played a pivotal role in advocating for the region's separation from India for decades. However, recent developments indicate a departure from this ideology, marking what Shah described as a "historic victory" for Bharat's unity. Taking to social media platform 'X', Shah welcomed the decision and urged other separatist groups to follow suit, emphasizing that abandoning separatism is the only path toward peace, development, and progress. "Two organizations associated with the Hurriyat have announced the severing of all ties with separatism. I welcome this step towards strengthening Bharat's unity and urge all such groups to come forward and shed separatism once and for all," Shah posted. The Home Minister further highlighted that the government's strategic policies, including the abrogation of Article 370, development initiatives, and stringent security measures, have played a crucial role in dismantling separatist sentiments in the valley. He credited Prime Minister Narendra Modi's leadership for fostering a sense of belonging and integration among the people of Jammu and Kashmir. Shah reiterated that the government remains committed to transforming the region into a peaceful, developed, and unified part of India. He stated that the latest move by the Hurriyat factions is proof that separatist ideology is losing its ground and that more groups are realizing the benefits of aligning with the national mainstream. The announcement comes in the wake of a series of measures undertaken by the central government to curb separatist activities in Jammu and Kashmir. Over the past few years, authorities have cracked down on terror financing, taken legal action against separatist leaders, and promoted economic development to ensure stability in the region. With this latest development, political analysts believe that the separatist movement in Kashmir has suffered a significant blow. The disintegration of Hurriyat factions from their separatist stance signals a new chapter in the region's history, aligning with the Modi government's broader vision of a peaceful and prosperous Jammu and Kashmir within a unified Bharat.

### "India, China Discuss LAC, Strengthen Ties"

India and China held a high-level meeting in Beijing today, marking the 33rd session of the Working Mechanism for Consultation and Coordination (WMCC) on India-China Border Affairs. The discussions primarily focused on reviewing the situation along the Line of Actual Control (LAC) and exploring ways to improve diplomatic and military coordination. Both sides emphasized the importance of maintaining stability and ensuring the early resumption of cross-border cooperation, including trans-border river management and the Kailash-Mansarovar Yatra. The Indian delegation was led by Gourangalal Das, Joint Secretary (East Asia) in the Ministry of External Affairs, while the Chinese delegation was headed by Hong Liang, Director General of the Boundary and Oceanic Affairs Department of the Chinese Ministry of Foreign Affairs. The meeting was described as "positive and constructive," with both nations reaffirming their commitment to strengthening diplomatic channels and enhancing mechanisms for border management. A key outcome was the agreement to make "substantial preparations" for the next meeting of the Special Representatives (SRs) on the boundary question, which is scheduled to take place in Delhi later this year. The Ministry of External Affairs (MEA) stated that the discussions covered various proposals and measures aimed at implementing the decisions made during the 23rd meeting of the Special Representatives on the India-China boundary issue, which was held in Beijing in December 2024. Both nations acknowledged the need to advance effective border management while preventing escalations along the LAC. Additionally, they agreed to strengthen existing diplomatic and military mechanisms to ensure quick resolution of any disputes. Following the meeting, Gourangalal Das paid a courtesy visit to China's Assistant Foreign Minister, Hong Lei, signaling continued diplomatic engagement between the two nations. The discussions are part of broader efforts to return to a pre-2020 status quo along the LAC and improve bilateral ties. This initiative gained momentum after Prime Minister Narendra Modi and Chinese President Xi Jinping met in October 2024 on the sidelines of the BRICS Summit in Kazan, Russia, He stressed the need to rebuild trust and maintain a constructive relationship. Modi also acknowledged the ancient civilizational ties between India and China, emphasizing that the two nations had historically coexisted peacefully for millennia. He advocated for a spirit of healthy competition rather than conflict. China responded positively to Modi's remarks, with the Chinese Foreign Ministry stating that cooperation between the two nations, referred to as a "dragon-elephant dance," was the best path forward. The spokesperson reiterated that in over 2,000 years of interaction, India and China had maintained friendly exchanges and contributed to human progress. The latest diplomatic engagements indicate a continued effort to resolve border tensions and strengthen bilateral cooperation.

# **Top Maoist with ₹25 Lakh Bounty** Killed in Chhattisgarh Encounter"


A Maoist carrying a reward of ₹25 lakh on his head was among three insurgents killed in an encounter with security forces in Chhattisgarh's Dantewada district on Tuesday, police said. The gunfight took place at around 8 am in a dense forest area along the border of Dantewada and Bijapur districts. Security personnel were conducting an anti-Maoist operation based on intelligence reports about Maoist presence in the forests surrounding Girsapara, Nelgoda, Bodga, and Ikeli villages under the Geedam police station limits, according to Superintendent of Police Gaurav Rai. The operation involved personnel from the District Reserve Guard (DRG) and Bastar Fighters, both special units of the Chhattisgarh state police, known for their expertise in counterinsurgency operations. As the security forces reached the targeted location, a fierce exchange of fire broke out between the two sides. After the gunfight subsided, the security personnel recovered the bodies of three male Maoists from the site, along with an Insas rifle, a .303 rifle, explosive materials, and other items used in their daily activities. Among the three slain Mao-



ists, one was identified as Sudhir, also known as Sudhakar or Murli, a resident of Warangal in Telangana. He was an active member of the Dandakaranya Special Zonal Committee, the most powerful faction of Maoists operating in the region. Authorities had placed a bounty of ₹25 lakh on his head due to his involvement in multiple attacks on security forces and civilians. The identities of the other two deceased Maoists are yet to be confirmed, officials said, adding that search operations are still ongoing in the area to trace any remaining insurgents or hidden weapon caches. Chhattisgarh, particularly the Bastar division, has been a stronghold of Maoist insurgents for decades. However, security forces have intensified their operations in recent years, leading to a significant number of encounters and Maoist casualties. Just a few days prior, on March 20, security forces carried out two major operations in Bijapur and Kanker districts, killing 30 Maoists.. Union Home Minister Amit

Shah recently reaffirmed the government's aggressive stance against Maoist insurgency, stating that the Narendra Modi-led administration is implementing a "zero-tolerance policy" against Maoists who refuse to surrender despite multiple opportunities and rehabilitation offers. He asserted that the government is committed to eradicating Maoism from the country and aims to make India completely Maoist-free by March 31, 2026. The growing success of anti-Maoist operations in Chhattisgarh reflects a shift in the balance of power in favor of security forces. The use of specialized units like the DRG and Bastar Fighters, combined with improved intelligence and coordination, has significantly weakened Maoist influence in the region. However, sporadic attacks by Maoists indicate that the insurgency is not completely dismantled. Authorities remain vigilant, continuing operations to eliminate the remaining Maoist factions and restore lasting peace in the region.





## **India** may interfere in **General Election** on April 28: Canada

Canada's national security agency has raised concerns over possible foreign interference in the upcoming general election, scheduled for April 28, 2025. According to the Canadian Security Intelligence Service (CSIS), both China and India, alongside Russia and Pakistan, are likely to attempt to influence the election.

The warning comes amid growing tensions between Ottawa and both Beijing and New Delhi. Vanessa Lloyd, deputy director of operations at CSIS, highlighted that hostile state actors are increasingly utilizing advanced tools like artificial intelligence to meddle in democratic processes. "The People's Republic of China is highly likely to use AI-enabled tools to attempt interference in Canada's election," Lloyd stated at a press conference.

Canada's relations with both India and China have been strained in recent years. Beijing retaliated against Canada's tariffs on Chinese electric vehicles and steel by imposing tariffs on over \$2.6 billion worth of Canadian agricultural and food products. Additionally, Canada condemned China's execution of four Canadian citizens on drug smuggling charges.

Relations with India have also deteriorated, with Canada expelling six Indian diplomats last year, including the head of mission, after allegations of involvement in a plot against Sikh separatists in Canada.

Despite previous concerns over election interference during the 2019 and 2021 federal elections, an official investigation concluded that the results were not affected by foreign influence. However, the CSIS emphasized that while it may be challenging to directly link foreign interference activities to electoral outcomes, such actions could undermine public confidence in Canada's democratic systems.

Lloyd also cautioned that Russia and Pakistan have the potential to engage in interference activities, further complicating Canada's efforts to safeguard its elections.

The CSIS comments serve as a reminder of the growing risks posed by foreign interference in democratic processes and the increasing use of advanced technology by hostile actors.

# Starlink Poised for Major **Expansion in India, Boosting Ambitions for Global Growth**

For Musk's Starlink, India Approval Could Unlock Emerging Markets

As Starlink nears regulatory approval for satellite broadband services in India, analysts believe this move could significantly boost the company's global expansion, especially in emerging markets. A successful entry into India could potentially add \$25 billion in revenue, reshaping the country's satellite broadband industry and attracting interest from other developing markets.

However, despite the promising outlook, Starlink faces legal hurdles and stiff competition from players like Eutelsat and China's SpaceSail, which is expanding into Brazil, Malaysia, and Kazakhstan. Additionally, SpaceX contends that U.S. regulations place it at a disadvantage compared to foreign rivals.

Starlink, owned by Elon Musk's SpaceX, has been waiting for licenses to operate commercially in India since 2022. The company has been embroiled in a regulatory standoff over spectrum allocation, with debates on whether India should auction satellite broadband spectrum, benefiting telecom giants like Mukesh Ambani's Reliance Jio casts a significant drop in



and Sunil Mittal's Bharti Airtel, or allocate it administratively to newer players like Starlink. In October, India opted for administrative allocation, giving Starlink a potential edge.

This month, both Reliance Jio and Bharti Airtel signed separate agreements with SpaceX, signaling that regulatory challenges may soon be resolved. Analysts suggest this development indicates that Starlink is closer to entering the Indian market.

The entry into India is a strategic move for Starlink, which operates in over 120 markets globally. Goldman Sachs fore-

prices for low Earth orbit (LEO) broadband services, projecting a reduction from \$148 per month in 2023 to just \$16 by 2035. With India being one of the largest potential markets, analysts expect Starlink to add 3 million global subscribers in 2025, with India being the leading contributor.

Starlink's pricing strategy will be crucial for success, with some experts predicting competitive plans starting at \$15 per enhancing India's global space industry competitiveness.



### **Canada Cites** "India's Growing **Global Influence**" **In Allegation Against Pak**

Canada has raised concerns over potential foreign interference in its upcoming April 28 general election, warning that Pakistan, India, China, and Russia could be involved in attempts to sway the democratic process. Vanessa Lloyd, Deputy Director of Operations at the Canadian Security Intelligence Service (CSIS), highlighted that Pakistan may conduct interference activities to counter India's growing global influence. She explained that Pakistan's actions could align with its strategic aims to maintain political and economic stability while curbing India's rise on the world stage.

Lloyd also addressed the possibility of Indian interference, stating that the Indian government has both the intent and capability to influence Canadian communities and the election process. This builds on similar allegations made last year, which India firmly rejected.

In a 2024 report, CSIS detailed "clandestine" foreign interference by both India and Pakistan during Canada's 2021 and 2019 general elections. The agency accused India of targeting electoral districts with large Indian-origin populations, particularly those sympathetic to the Khalistani movement, and alleged the use of illicit financial support to sway candidates. Similarly, it claimed that Pakistan tried to influence federal politics in 2019 to further its inter-

Tensions between India and Canada have escalated in recent months, particularly following allegations from former Prime Minister Justin Trudeau about India's involvement in the killing of Khalistani terrorist Hardeep Singh Nijjar, which India denied as "absurd."

In addition to Pakistan and India, Canada's security agency also warned that China and Russia might attempt to interfere in the election. Lloyd stated that China could use AI-enabled tools and social media to target Chinese-Canadian communities with favorable narratives. Russia, according to the report, may amplify Kremlin talking points via social media and news websites, attempting to manipulate information to influence Canadian voters.

The Canadian government is committed to safeguarding its electoral process and ensuring that foreign interference does not disrupt its democracy.

### Malaria Confirmed as Cause of Fatal Outbreak in Northwest DR Congo

Late on Monday, the National Public Health Institute (INSP) of the Democratic Republic of Congo confirmed that an outbreak in the northwest of the country, which claimed the lives of more than 50 people, was caused by malaria. The illness, which primarily affected Equateur province, resulted in 943 reported cases and 52 deaths at the beginning of the year.

The symptoms, which included fever, fatigue, vomiting, and weight loss, initially led health officials to suspect food poisoning or malaria as the potential cause. However, following laboratory tests on samples from affected individuals, malaria was de-

finitively identified as the culprit.

Christian Ngandu, coordinator of the INSP, confirmed the results of the tests over the phone, reassuring the public that the outbreak was now understood. Despite the confirmation, the health institute continues to await the results of additional tests on water, drinks, and food samples sent abroad to further investigate whether there was any potential contamination involved.

This recent outbreak follows a similar occurrence in December, where an unknown illness initially puzzled health authorities before being traced back to malaria. These outbreaks have prompted increased vigilance and ongoing monitoring in the

Health officials have stressed the importance of public awareness regarding the symptoms and prevention of malaria, which is a major health concern in many parts of sub-Saharan Africa. With the confirmation of malaria as the cause, authorities are focusing on controlling the spread of the disease and providing support to affected communities.

As the investigation continues, the INSP has urged the public to seek medical help promptly if they experience symptoms, especially in malaria-prone areas, to prevent further fatalities.

### **New Income Tax Bill** To Be Introduced In **Monsoon Session:** Nirmala Sitharaman

Finance Minister Nirmala Sitharaman announced on Tuesday that the new Income Tax Bill will be taken up for discussion during the upcoming monsoon session of Parliament. While responding to the debate on the Finance Bill 2025 in the Lok Sabha, Sitharaman clarified that the bill, which was introduced in the House on February 13, is currently under review by the Select Committee. The committee is expected to submit its report by the first day of the next parliamentary

"The new income tax bill will be taken up in the monsoon session," said Sitharaman. The monsoon session is typically held from July to August, marking the period when the government expects to finalize discussions on the bill.

The proposed Income Tax Bill aims to simplify the country's taxation system. The new bill, which is significantly shorter than the current 1961 Income Tax Act, seeks to reduce the complexity of tax laws and improve tax certainty. The bill has been designed to minimize the scope for litigation and reinterpretation, a key objective for streamlining the tax process.

The new bill is approximately half the size of the existing law, with a word count of 2.6 lakh compared to 5.12 lakh in the current Act. The number of sections in the bill has also been reduced, from 819 to 536. Additionally, the number of chapters has been halved from 47 to 23, while the number of tables has increased to 57 from the 18 present in the existing Act. The new bill has also removed over 1,200 provisos and 900 explanations, further simplifying the language and structure of tax regulations.

This overhaul of the Income Tax Act is seen as a significant step towards creating a more transparent and efficient taxation system in India, ensuring easier compliance and reducing unnecessary litigation.



### India slaps Samsung with tax demand of ₹5,156 crore for telecom imports

India has directed Samsung and its executives to pay \$601 million in back taxes and penalties for allegedly evading tariffs on the import of key telecom equipment. This marks one of the largest tax demands in recent years, according to a government order.

The \$601 million demand represents a significant portion of Samsung's net profit in India for the previous year, which was reported at \$955 million. As one of the largest players in India's consumer electronics and smartphone market, the company's operations are under close scrutiny from local tax authorities.

Samsung has the option to challenge the tax demand through a tax tribunal or in the courts. The case is related to allegations that the company avoided paying the necessary import tariffs on certain telecoms equipment. This tax dispute could have significant financial implications for the company, considering the substantial penalty involved.

As the dispute unfolds, Samsung will likely consider its legal options while continuing to operate in one of the world's largest markets for consumer electronics. The outcome of this case could set a precedent for other multinational corporations operating in India and could influence future tax regulations and enforcement practices.



# S&P Cuts India's GDP Growth Forecast to 6.5% for FY 2025-26



S&P Global Ratings has revised India's GDP growth forecast for the fiscal year 2025-26, reducing it to 6.5%, down from an earlier projection of 6.7%. The global credit rating agency cited exter-

nal factors, including rising US tariffs and a broader pushback against globalization, as key reasons for the downward revision in its Economic Outlook for the Asia-Pacific (APAC) region.

Despite these external headwinds, S&P expects strong domestic demand to drive growth in most emerging-market economies, including India. The revised forecast reflects the agency's belief that the Indian economy will maintain momentum, aided by factors such as the expectation of a normal monsoon season and softening commodity prices, particularly crude oil.

S&P highlighted several domestic factors that could support India's economic growth. These include cooling food inflation, tax benefits introduced in the national budget for FY 2025-26, and lower borrowing costs, which are anticipated to boost discretionary consumption. The ongoing economic recovery in

India is also expected to benefit from government policies designed to stimulate growth, despite the global uncertainties.

The agency also noted that central banks across the APAC region, including the Reserve Bank of India, are likely to continue cutting benchmark interest rates throughout the year, providing further support to the domestic economy.

Although the forecasted 6.5% growth is consistent with the previous fiscal year's outcome, it reflects a more cautious outlook given the global challenges. The revised growth projection underscores the balancing act facing India's economy—navigating external pressures while maintaining robust internal demand.

# **BYD Unveils Megawatt EV Charging System**

**C**hinese EV giant BYD has introduced a megawatt fast-charging system, claiming it can charge electric vehicles as quickly as refueling traditional cars. With plans to establish a vast charging network across China, BYD is entering a competitive space dominated by existing fast-charging providers.

Fast-charging technology has become crucial in addressing EV users' concerns about battery range and charging time, particularly for long-distance travel. Chinese automakers have been leveraging such innovations to boost EV adoption, with Tesla and other brands also offering ultra-fast charging solutions.

BYD's "Super E-Platform" boasts a peak charging capacity of 1,000 kilowatts (kW), enabling vehicles to gain a 400 km (249 miles) range with-



in just five minutes. This is made possible through advanced 10C charging multiplier batteries, high-power motors, and fast chargers supporting 1,000 kW of power. In comparison, Tesla's 400volt system caps at 250 kW for most vehicles, with exceptions like the Cybertruck and Semi, which support higher voltages. Other Chinese brands,

including Zeekr, Li Auto, and Xpeng, have also introduced fastcharging technologies that provide over 400 km of range within 10 minutes.

Despite its dominance in EV sales, BYD has relied on third-party charging networks until now. With its new system requiring specialized chargers, the company plans to build over 4,000

charging stations across China. BYD founder Wang Chuanfu has also invited external investors to participate in the expansion.

However, BYD faces stiff competition.
Nio leads China's charging infrastructure with nearly 2,700 fast-charging stations, followed by Tesla, which has built over 2,000 sta-

tions. Li Auto, Xpeng, and Zeekr are rapidly expanding their networks, while Huawei has also entered the space with ultra-fast liquid-cooled charging piles supporting up to 600 kW. As BYD accelerates its charging infrastructure, the battle for the fastest and most accessible EV charging network in China is heating up.



While some in the BCCI favor retaining the trio in A+, others argue for a revision based on current format participation.

In the A category (₹5 crore retainership), Ravichandran Ashwin's retirement means his exclusion is certain. Axar Patel, a key all-rounder and vice-captain for the England T20I series, is a strong contender for promotion from Grade B.

Shreyas Iyer, who missed out last season, is set to return after featuring in 11 ODIs this



year. Young talents like Yashasvi Jaiswal, Akash Deep, and Sarfaraz Khan are likely to be inducted, with their performances meeting the selection criteria. Nitish Kumar Reddy, having played the full Border-Gavaskar series and multiple T20Is, is also expected to be included.
