# **State to Conduct Fresh** Survey for SC Sub-Quota



**Cabinet approves** survey to gather SC empirical data

H.N. Nagamohan Das Commission's recommendations accepted

TPN Correspondent | Bengaluru The Karnataka government has decided to conduct a fresh survey to gather empirical data on Scheduled Castes (SC) in the state.

The decision, made during a re-

cent cabinet meeting led by Chief

Minister Siddaramaiah, aims to

internal reservation, particularly from Dalit Left communities.


The move follows recommendations from the H.N. Nagamohan oversee the survey process and Das Commission, which submitted an interim report to CM Siddaramaiah on March 27. The commission was established to address the issue of internal reservation for Dalit communities.

Law and Parliamentary Affairs Minister H.K. Patil, speaking to reporters after the cabinet meeting, stated that the commission proposed four key recommendations. These include conducting a fresh survey, using modern technologies to complete the survey within 30 to 40 days, preparing a structured questionnaire, and collecting detailed data on SCs and

address the persistent demand for their sub-castes for classification purposes.

> The cabinet has agreed to extend the tenure of the commission to provide further guidance. The survey aims to clarify confusion surrounding sub-caste nomenclature such as Adi Karnataka, Adi Dravida, and Adi Andhra—terms that were historically introduced during the rule of the Mysuru Maharajas to counter caste-based discrimination.

> Dalit activists have consistently argued that these names continue to cause ambiguity in caste classification across various regions. The upcoming survey is expected to address these concerns and provide a clearer framework for internal reservation policies.



### Former CM Basavaraj Bommai **Slams Govt Over Notices to BJP MLAs, Price Hikes**

TPN Correspondent | Bengaluru Former Karnataka Chief Minister and Haveri MP Basavaraj the notices issued to BJP MLAs S.T. Somashekar and Shivaram Hebbar by the party's disciplinary committee. Bommai stated that the concerned MLAs would respond to the notices mismanagement, and declined to comment further on the matter.

Shifting his focus to the state government, Bommai accused it of financial mismanagement, alleging that it has been covering up its failures by increasing prices across essential commodities. According to Bommai, the

government has raised milk prices in the name of supporting farmers but has failed to release pending incentives worth approximately ₹500 crore to milk producers for the last six months.

Bommai further claimed that farmers and milk unions are facing severe difficulties due to the lack of incentives. He criticized the government for imposing additional burdens on the people by hiking prices un-

Bommai has reacted sharply to **Hebbar face party** He also alleged that the state government had raised milk prices by ₹9 in three phases over the past year, terming it an "irresponsible and anti-state" approach. Additionally, Bommai pointed out other price increases, including electricity rates, petrol, diesel, stamp registration fees, and excise tax rates, accusing the government of exploiting the public.

Bommai stated that despite imposing heavy taxes totaling around ₹55,000 crore, the government has taken a loan of ap-

proximately ₹1.16 lakh crore. According to him, this combination of rising taxes and price hikes has severely impacted the middle class and poor communities.

Concluding his remarks, Bommai asserted that the Congress government is directly responsible for the state's current financial instability and urged for its removal, emphasizing that the public is growing increasingly frustrated with its governance.

# CID Launches Probe Into Alleged Honey-Trap Complaint

**Investigation** initiated after complaint from **Minister KN** Rajanna

CID sleuths inspect multiple locations, record statements

Government directions awaited for further legal action



TPN Correspondent | Bengaluru The Criminal Investigation Department (CID) of Karnataka Police has initiated a probe into alleged honey-trapping attempts targeting several politicians across party lines. The investigation was ordered by Director General of Police (DGP) Alok Mohan following a complaint from State Minister and Congress leader KN Rajanna, whose statements in the assembly stirred a massive uproar during the recently concluded budget session.

Rajanna, who serves as the Min-

daramaiah-led state cabinet, ate legal action will be taken," submitted a petition to State Home Minister G Parameshwara, seeking a detailed investigation into the matter. Responding to the complaint, Home Minister Parameshwara referred the issue to the CID for a comprehensive probe.

Confirming the development, CID DGP MA Saleem stated that a copy of the complaint had been received from the DGP and that an inquiry was underway. "We are gathering details of the case, and after receiving directions ister for Cooperation in the Sid- from the government, appropri-

Saleem said.

As part of the investigation process, CID officials visited Rajanna's government residence at Jayanagar in Bengaluru on Thursday. They also inspected the minister's guest house located on Jayamahal Road and recorded statements from household staff members stationed there.

The probe is expected to continue as officials compile evidence and await further instructions from the government regarding the next steps in the legal process.

The Karnataka government's decision to introduce 4% reservations for Muslims in government civil contracts has sparked a political controversy, with allegations of unconstitutional religion-based quotas. The Congress-led government recently amended the Karnataka Transparency in Public



Procurements Act to offer these reservations, drawing sharp criticism from the BJP.

The BJP has alleged that the provision is unconstitutional, claiming it amounts to providing reserva-

tions based on religion. According to the party, the move goes against constitutional principles since affirmative ac-

### **Karnataka High Court Limits Pension Deductions for Loan Recovery**

TPN Correspondent | Bengaluru The Karnataka High Court has ruled that Canara Bank cannot deduct more than 50% of a retired employee's pension for recovering loan dues, emphasizing that pension serves as financial security for retirees. Justice S.G. Pandit delivered the verdict, clarifying that exceptions to this restriction apply only in cases of fraud, forgery, or misconduct.

The case was filed by 70-year-old Murugan O K, a retired Canara Bank employee from Thrissur, Kerala. Despite consistently paying EMIs from his pension, the bank began deducting his entire pension from July 2024 to recover Rs. 8.5 lakh in outstanding dues. Murugan sought legal intervention, also requesting exemption from penal interest on an educational loan for which he was a co-obligant with his daughter.

Justice Pandit highlighted that banks can



recover dues but must protect pensioners' livelihoods, as complete deductions may infringe upon Article 21 of the Indian Constitution, ensuring the right to life and personal liberty. He noted that for active employees, loan deductions generally do not exceed 50% of their take-home salary, a principle that should apply to pensioners as well.

The court advised Canara Bank to explore other legal options for recovery, such as enforcing collateral, ensuring that pensioners' financial stability remains intact.

### **Karnataka HC Reserves Order on ED's Plea Against Single-Bench Ruling Favoring Ex-MUDA Chief Natesh**

The Karnataka High Court reserved its order on the plea filed by the Enforcement Directorate (ED) seeking an interim stay on a single-bench order in favor of former MUDA commissioner D B Natesh. The case involves alleged irregularities in a site allotment scheme linked to Chief Minister Siddaramaiah's wife, Parvathy B M, and others.

A division bench comprising Chief Justice N V Anjaria and Justice K V Aravind reserved the order after hearing Additional Solicitor General S V Raju and Aravind Kamath for the ED, and senior advocate Dushyant Dave representing Natesh.

The ED argued that the single-bench order is being repeatedly cited in several other cases, leading to stays that hamper ongoing investigations. According to the ED, the 'B' summary report filed by the Lokayukta police highlighted that Natesh's actions caused a loss to the exchequer and warranted further



investigation.

In defense, Dushyant Dave stated that the matter pertains to a site allotment scheme that has been upheld by the High Court multiple times and does not involve money laundering aspects. He also alleged that the ED's probe was politically motivated, targeting states governed by the Congress and other opposition parties.

On January 27, 2025, a single bench allowed Natesh's petition, stating that the ED's search and seizure operations lacked prima facie evidence under Section 3 of the Prevention of Money Laundering (PML) Act, terming it an abuse of legal process.

The division bench is expected to pronounce its decision on the ED's plea soon.

# **Karnataka Electricity Bills to Increase from April; Gruha Jyothi Beneficiaries Unaffected**

- Electricity bills to rise from April for households and businesses
- Gruha Jyothi beneficiaries exempted from hike
- Fixed charges to increase gradually over three years

TPN Correspondent | Karnataka The Karnataka Electricity Regulatory Commission (KERC) has approved a hike in electricity bills for households and businesses starting from April, while beneficiaries of the Gruha Jyothi scheme will

remain unaffected. The revised tariffs will reflect in electricity bills from May

Under the new tariff structure, the



per-unit charge has been reduced by 10 paise to ₹5.80 for the first two years and ₹5.75 in 2027-28. However, fixed charges will increase progressively —

by ₹25 in 2025-26, ₹30 in 2026-27, and ₹40 in 2027-28. Currently, the per-unit energy charge stands at ₹5.90, with fixed charges at ₹120.

The decision follows a proposal submitted by electricity supply companies (Escoms) in November 2024, seeking increases of 67 paise per unit for 2025-26, 75 paise for 2026-27, and 91 paise for 2027-28. KERC finalized the new tariffs after conducting public hearings and reviewing the proposals.

While the tariff hike is expected to impact general consumers, those

# Karnataka Police Oppose Disbanding of Anti-Naxal Force

Police in Karnataka are expressing strong opposition to the state government's decision to disband the Anti-Naxal Force (ANF), highlighting concerns that while there may be no active Naxals in Karnataka, Naxalism as an ideology is not dead. The decision was announced in the 2025 budget by Chief Minister Siddaramaiah following the surrender of the last known Maoists in the state earlier this year.

On January 8, six Maoists, including four women, surrendered at a government event attended by the Chief Minister. Shortly thereafter, another Maoist also surrendered. Declaring Karnataka "Naxal-free," the government decided to dissolve the ANF. However, top police officials argue that the decision was made without consulting law enforcement

A high-ranking police officer stated, "This is a wrong move. Just because there are no known Maoists now doesn't mean the movement won't resurface. We must prevent that from happening." The officer further noted that ongoing Naxal crackdowns in Chhattisgarh could potentially push Maoists southwards into Karnataka, making it essential to continue combing operations.

# Ranya Rao Previously Smuggled 14.56 kg **Gold, Claims DRI**

TPN Correspondent | Bengaluru The Directorate of Revenue Intelligence (DRI), investigating the gold smuggling case involving Kannada actress Ranya Rao, has alleged that she previously smuggled around 14.56 kg of gold into India, causing a customs duty loss of approximately Rs 4.45 crore.

According to the DRI, Ranya Rao, with the assistance of Sahil Sakariya Jain, sold the smuggled gold in India through hawala transactions. Jain, identified as the third accused, allegedly played a key role in the smuggling syndicate by facilitating the disposal of gold and managing illicit transactions.



Investigations revealed that Ranya Rao multiple occasions. One such instance

occurred on January 11, when gold worth over Rs 11.55 crore was allegedly brought in by her with Jain's assistance, resulting in a customs duty loss of Rs 4.46 crore. Ranya Rao was arrested on March 3 at Kempegowda International Airport (KIAD) in Bengaluru after DRI officials, acting on a tip-off, intercepted her upon her arrival from Dubai. She was allegedly smuggling 14.8 kilograms of gold at the time of her arrest.

The DRI continues to probe the case, with Jain's arrest on Wednesday providing further insights into the smuggling network. Authorities are expected to intensify their efforts to dis-

### **MP Brijesh Chowta Urges Nitin Gadkari** for Spur Roads to Pilgrimage Sites

Dakshina Kannada MP Brijesh Chowta met Union Minister for Road Transport and Highways Nitin Gadkari in New Delhi to propose the construction of spur roads aimed at improving connectivity to prominent pilgrimage sites Kukke Subrahmanya, Dharmasthala, and Kollur. Belthangady MLA Harish Poonja accompanied him during the meeting.

Chowta requested the development of two spur roads— Periyashanti-Paichar and Guruvayanakere-Bajagoli—to ensure direct travel for devotees and tourists visiting the coastal region's temples. The proposal includes upgrading the Periyashanti-Paichar road to connect NH-75 and NH-275, thereby enhancing accessibility for pilgrims traveling from Bengaluru via Shiradi Ghat and from Kerala through NH-275.

Additionally, Chowta urged Gadkari to review and approve the Guruvayanakere-Bajagoli road as a spur road connecting NH-73 and NH-169. This improvement is expected to reduce travel time for visitors to Dharmasthala and Sri Mookambika Temple in Kollur, while also easing traffic congestion on existing highways in the region.

According to Chowta, these new routes would boost temple tourism, improve local infrastructure, and provide an economic boost to the area with minimal environmental im-

Responding positively, Gadkari assured that a feasibility study would be conducted to assess the benefits and challenges of the proposed projects. He has directed relevant authorities to take the necessary steps for further evaluation and implementation.

### Shivaram Hebbar Warns of Repercussions Following Yatnal's Expulsion

Karnataka Energy Minister K J George has rejected allegations made by the BJP and JDS regarding corruption in the smart meter tender process. Speaking at a press conference at the Vidhana Soudha, George asserted that the tender process was conducted transparently as per the Karnataka Electricity Regulatory Commission (KERC) guidelines.

He clarified that smart meters are being installed only for new and temporary connections as per KERC's orders. The tender process, initiated under

# **Kumaraswamy Targets Congress**led Govt Over Repeated Price Hikes

Former Karnataka Chief Minister HD Kumaraswamy has launched a scathing attack on the Congress-led Karnataka government, accusing it of burdening the public with repeated price hikes in essential commodities like milk and electricity. Kumaraswamy expressed his criticism on X (formerly Twitter), alleging that the government was exploiting people under the pretense of welfare schemes.

price hikes in Nandini milk, Kumaraswamy noted that this was the third time prices

had been increased since the current government assumed power. He detailed that milk prices were first raised by ₹3 in August 2023, followed by another ₹2 increase in June 2024. The most recent hike of ₹4 in March 2025 has left the public distressed, particularly during the festive season of Ugadi.

The former Chief Minister also highlighted the government's decision to increase electricity tariffs, imposing a 36-paise surcharge per unit. He criticized the timing of the hike, describing it as an unwanted "gift" for the people of Karnataka during the festive period. "Is this the Ugadi gift the government wishes to present to the people? # Four Arrested for Smuggling **Exotic Wildlife**

### Three Nepalese Killed, Four Injured in SUV Accident in UP's Balrampur

Balrampur (UP), March 28, 2025: A tragic road accident in Balrampur has claimed the lives of three Nepalese citizens and left four others critically injured. The accident occurred late Thursday evening when an SUV, en route to Varanasi, overturned while attempting to avoid a cyclist. The incident took place in the Jarwa police station area of Balrampur, Uttar Pradesh.

According to local authorities, the vehicle, carrying a total of 10 people, including the driver, was traveling from Dang district in Nepal.

The driver reportedly lost control of the SUV while trying to avoid a cyclist near Nagai Basaidih village. The vehicle veered off the road and flipped over, resulting in the immediate death of 70-year-old Praveer Khatri.

In addition to Khatri's death, two other passengers—Yuvraj, aged 38, and Dhanbali, aged 80—succumbed to their injuries while receiving treatment



at a nearby hospital. Four other passengers sustained serious injuries and are in critical condition. They have been rushed to Bahraich District Hospital for urgent medical care.

Tulsipur Circle Officer Brij Nandan Rai confirmed the details of the accident and stated that the injured are currently under medical supervision. The police have taken the necessary steps, including sending the bodies for post-mortem and launching an investigation into the cause of the accident.

Local authorities are working to gather more information regarding the incident, including the condition of the cyclist involved, who is believed to have been the catalyst for the driver's attempt to swerve and avoid a collision.

## **HIV Cases Rise in Kerala's Malappuram Due** to Shared Syringes Among Drug Users

Health officials in Kerala's Malappuram district have reported a concerning rise in HIV cases, with ten people testing positive in the past two months. Authorities attribute the outbreak to the sharing of syringes among drug users, raising fears of further spread.

The cases were detected during routine inspections as part of the Kerala government's ongoing anti-drug campaign. The Kerala AIDS Control Society's (KACS) screenings of high-risk groups, including drug users and sex workers, uncovered the alarming trend. Officials revealed that some of those infected are migrant workers, highlighting the potential for wider transmission.

Malappuram District Medical Officer, Dr. R Renuka, warned of a possible surge in cases due to the increased vulnerability of drug users. "As part of high-risk category checks, we tested an injectable drug user who was found to be



HIV-positive. We then traced and tested others with whom he had shared needles, leading to the identification of ten HIV-positive cases in the last two months," she explained.

Health authorities are intensifying efforts to curb the spread of the virus by increasing awareness and promoting harm reduction strategies such as needle exchange programs and safe injection practices. They also urge drug users to seek medical assistance and participate in HIV screening programs to prevent further transmission.

Officials stress the impor-

tance of early detection and treatment to control the epidemic.

Public health campaigns are being strengthened to educate communities about the risks of sharing syringes and the importance of preventive measures.

With fears of more undetected cases, the Kerala health department continues to monitor high-risk groups closely, urging individuals to get tested and seek timely medical intervention. Authorities call for collective action to prevent further spread and protect public health in the region.

# From Asking for **Urdu Preference to Mocking Telugu**

Hyderabad, March 29: The hypocrisy of AIMIM leader Akbaruddin Owaisi is once again on full display. Time and again, he has played divisive politics, using religion and language as tools to polarize the electorate. His latest jibe at a Telugu-speaking minister further cements his double standards—demanding Urdu preference on one hand while mocking those who speak Telugu in a Telugu-speaking

If Owaisi truly believes in representing Telangana, he should have learned Telugu by now. His deliberate ignorance of the state's language, coupled with his mockery of those who embrace it, speaks volumes about his priorities. # India's \$2.7 Billion **Electronics Boost**

### A Step Towards Self-Reliance or a Long Road Ahead?

The Indian government's latest approval of a \$2.7 billion (₹22,919 crore) incentive plan to boost local manufacturing of electronic components marks another ambitious step toward self-reliance in the tech sector. With a vision to attract \$7 billion in investments and create over 91,600 jobs in six years, this move is part of India's broader goal of establishing a \$500 billion electronics economy by 2030. While the plan has been welcomed by industry leaders, the real challenge lies in its execution and ensuring that India can move beyond assembly to high-value manufacturing.

### **Breaking Dependency**

For years, India has remained dependent on imports for key electronic components such as semiconductor chips, display modules, and lithium-ion battery cells. While the country has made significant progress in assembling smartphones and electronic gadgets, the lack of a strong component ecosystem has limited value addition within the domestic market.

Union IT Minister Ashwini Vaishnaw acknowledged this gap, stating that India has achieved only 20% value addition in electronics manufacturing over the past decade. The new scheme, aimed at manufacturing both active and passive components, is expected to double this value in the next five years. The government's push aligns with its broader semiconductor mission, which aims to strengthen local production of high-end electronic components.

### **Key Features of the Incentive Plan**

The scheme will provide subsidies of up to 50% for domestic and foreign companies setting up local component manufacturing facilities. The primary focus areas include:

- Sub-assembly of display and camera modules
- Printed circuit boards (PCBs)
- Lithium-ion battery cells
- Enclosures for mobile and electronics hardware

Additionally, incentives will also cover the localization of capital goods and other components used in the manufacturing process. However, a senior government official clarified that the support for these will be below 50% of the company's capital expenditure. The government is also working on reforms in labor laws, customs policies, and taxation to create a more conducive environment for electronic manufacturers.

### A Positive Move for Growth

Industry leaders have responded positively to the initiative. Josh Foulger, president of electronics at Zetwerk, emphasized the importance of building a strong component ecosystem in India, stating that his company is actively seeking partnerships to contribute to this effort.

Ajai Chowdhry, co-founder of HCL Technologies and chairman of Epic Foundation, noted that this move will enable "higher value addition in the country" and attract more investment in system products. He also highlighted the need for a "Design in India" scheme for chips and systems, which would further strengthen India's position in the global electronics industry.

Canadian Prime Minister Mark Carney's response has made it clear: the "old relationship" with the US is over. As economic and military ties between the two nations deteriorate, a critical question arises—has the US-Canada relationship been damaged beyond repair?

### Trump's Trade War Sparks **Outrage**

On March 27, President Trump announced steep tariffs on imported automobiles and parts, set to take effect from April 3, 2025. The move has sparked outrage among key US trading partners, including Canada, Germany, the European Union, and Japan, all of whom are now considering retaliatory measures. Trump has even warned that if the EU and Canada cooperate in opposing these tariffs, the US could impose "far larger" economic actions against them.

For Canada, this is not just another trade dispute. The auto industry is a critical part of the Canadian economy, employing thousands of workers. By imposing tariffs, Trump has directly challenged Canada's economic stabili-



ty. In response, PM Mark Carney called the tariffs a "direct attack" on Canadian workers and pledged immediate retaliation through trade measures designed to hurt the US while minimizing damage to Canada.

### Mark Carney Declares the 'Old Relationship' is Over

In a sharp departure from the usual diplomatic tone between Canada and the US, PM Mark Carney did not hold back in his criticism of the Trump administration. His statement—"It is clear that the United States is no longer a reliable partner"—marked a turning point in how Canada views its long-time ally. Carney made it clear that Canada could no longer depend on the US as it once did. He emphasized the need to "dramatically reduce reliance on the United States" and seek new trade relationships. This marks a significant shift from Canada's traditional approach, which has long been rooted in deep economic and security cooperation with its southern neighbor.

Carney also took issue with Trump's past rhetoric about Canada. During his 2024 re-election campaign, Trump repeatedly referred to then-PM Justin Trudeau as "Governor Trudeau" and even entertained speculation about annexing Canada as the "51st state" of the US. Such remarks were dismissed as campaign rhetoric at the time, but in light of the tariff war and diplomatic tensions, they have taken on a more serious tone.

### Is the US-Canada Relationship Truly Beyond Repair?

While Mark Carney has declared that there is "no turning back," he has not entirely ruled out restoring some level of trust with the US. However, he made it clear that any future partnership would be vastly different from the past. The days of deep economic integration and unquestioned military cooperation between the two countries appear to be

Carney also emphasized that his government will fight back with "retaliatory trade actions of our own that will have maximum impact in the United States and minimum impacts here in Canada." This signals a more aggressive stance than previous Canadian administrations, which have often sought to negotiate rather than retaliate against US trade actions.

### How Americans View Canada **Amid Rising Tensions**

The strained relationship between the two nations is also reflected in shifting public opinion. According to a recent Associated Press-NORC poll conducted between March 20-24, 2025, fewer Americans now see Canada as a close ally compared to previous years.

Before Trump's second term, 70% of Democrats viewed Canada as a close ally. Now, that number has dropped to just 50%. Across all political groups, only 50% of Americans still consider Canada

a close ally, compared to 60% in 2023. Instead, three in 10 respondents now view Canada as merely "friendly but not a close ally," while two in 10 describe the relationship as "not friendly but not enemies."

These shifts highlight a significant deterioration in the US-Canada friendship. While most Americans do not see Canada as an outright adversary, the perception of the once-strong alliance is weakening.

### What's Next for US-Canada **Relations?**

The coming months will be crucial in determining the future of US-Canada relations. Mark Carney has vowed to hold direct talks with President Trump in an attempt to address the crisis. However, given Trump's hardline stance on trade and national interests, it remains unclear whether diplomacy will be enough to mend the fractured relationship.

If Canada moves forward with its plans to pivot trade relationships away from the US, the long-term consequences could be profound. A weakened North American trade bloc could give economic competitors like China and the EU an advantage.

For now, what is certain is that the trust between the US and Canada has been severely damaged. Whether it can be fully restored—or whether this marks the beginning of a permanent separation—remains to be seen.





# **India Ready to Assist Myanmar & Thailand After Devastating Earthquake**

The earthquake, measuring 7.7 on the Richter scale, struck central Myanmar at approximately epicenter was located 16 kilometers northwest of Sagaing at a depth of 10 kilometers, according to the United States Geological Survey (USGS). The quake was followed by a significant aftershock of 6.8 magnitude. The tremors were strong enough to be felt in various parts of India, including Kolkata and Imphal, triggering concerns among residents. While reports of casualties continue to emerge, no tsunami warning has been issued so far. Rescue and relief operations are currently underway in the affected regions as authorities assess the full extent of the damage. One of the most shocking visuals from the disaster was a viral video showing an under-construction skyscraper in Bangkok's Chatuchak neighborhood collapsing due to the tremors. Reports indicate that at least 43 workers are trapped under the debris, with rescue teams racing against time to locate survivors. India's Ministry of External Affairs (MEA) has been directed to stay in close contact with both Myanmar and Thailand to coordinate relief efforts. Indian disaster response teams and humanitarian aid are expected to be mobilized as needed to assist in rescue and recovery operations. The earthquake serves as a grim reminder of the region's vulnerability to seismic activity. As affected communities grapple with the devastation, international support and swift response efforts remain crucial in mitigating the crisis. # "Jaishankar Slams **Pakistan for Minority** Persecution"

External Affairs Minister S. Jaishankar addressed the Lok Sabha on Friday, highlighting the "crimes and atrocities against minorities" in Pakistan. Jaishankar reaffirmed India's stance at the UN, where Pakistan has been criticized for its human rights violations and persecution of minorities. Citing specific incidents, the minister detailed several cases of atrocities that took place in February. "We follow very closely and track the treatment of minorities in Pakistan. In February alone, there were ten cases of atrocities against the Hindu community—seven involving abduction and forced conversion, two related to abduction, and one incident where police took action against students celebrating Holi," Jaishankar informed the Parliament. The minister also highlighted attacks against the Sikh community in Pakistan. "There were three incidents related to the Sikh community. In one case, a Sikh family was attacked. In another, a Sikh family was threatened over the reopening of an old Gurudwara. Additionally, there was an abduction and forced conversion case involving a Sikh girl," he said. Jaishankar's remarks reinforced India's commitment to advocating for the rights of persecuted minorities in Pakistan. He stressed that India would continue to raise these concerns at the highest levels to ensure that such human rights violations do not go unnoticed. The minister's statement comes amid ongoing diplomatic tensions between the two nations, with India frequently calling out Pakistan on international platforms for its record on minority rights and religious freedom. # **J&K Seeks Extension for Special Cells**



The Jammu and Kashmir government has urged the National Commission for Women (NCW) to extend funding for its special cells supporting domestic violence victims for at least another year. These special cells, established in police stations across J&K under the initiative Violence-Free Home – A Woman's Right, were launched in 2021 to provide crucial psycho-social-legal support to women facing domestic violence. The initiative is a joint effort involving the NCW, the Tata Institute of Social Sciences, the J&K Police, and the Social Welfare Department. However, the project was initially set up for a limited period, with funding scheduled to end on March 31, 2025, unless an extension is granted. The J&K Social Welfare Minister, Sakina

Itoo, confirmed that the government has formally requested NCW to extend the project, emphasizing the positive impact these cells have had on women's well-being."We have written to NCW, requesting them to extend the project by one more year as it would further improve the condition of women. However, even if the project is discontinued, the UT has staff centers operating in every district, which will continue to provide support," said Itoo.Since its establishment in 2021, the initiative has assisted nearly 10,000 women, with each special cell comprising two trained social workers to provide necessary guidance and intervention. The cells have been instrumental in offering women a safe space to seek help against domestic abuse and legal guidance to navigate their challenges. Despite the government's plea, sources within NCW claim that the J&K administration has been reluctant to take over the cells, even though they were aware that the Memorandum of Understanding (MoU) was valid only until March 31. The original plan was for NCW to initiate and support the project before the J&K government assumed responsibility.

# **Centre Approves 2% Hike in Dearness Allowance for Government Employees**

The Union Cabinet has approved a 2% increase in the dearness allowance (DA) for central government employees, bringing it up from 53% to 55% of basic pay. This move aims to provide relief against inflation and comes ahead of the 8th Pay Commission's implementation.In the last revision, DA was raised by 3% in October 2024, increasing it to 53% of basic pay. The new hike will further enhance government employees' salaries, helping them manage rising costs. DA is a critical component of salary adjustments for government staff, designed to counteract the impact of inflation.

The Centre approved the 8th Pay Commission in January 2025 to revise wages and allowances for central government employees. The commission's formal constitution, including the appointment of a chairman and at least two members, is expected soon. While



DA and Dearness Relief (DR) are revised biannually, this is likely the final revision before the commission starts consultations with various stakeholders.Employee forums have advocated merging DA and DR with the basic salary before the next Pay Commission report is implemented. Historically, the 5th Pay Commission man-

dated merging DA with basic pay once it exceeded 50%. However, while the government integrated DA with basic pay in 2004, this practice was discontinued under the 6th and 7th Pay Commissions. The 8th Pay Commission is expected to introduce significant changes in salary structures, benefits, and allowances for government employees. The latest DA hike ensures financial relief for employees while they await broader salary reforms under the new pay commission. The upcoming deliberations will determine how future revisions and pay structures are formulated to benefit employees.With the rising cost of living, these adjustments play a vital role in maintaining the financial well-being of government workers. The DA increase reflects the government's commitment to supporting its employees in managing economic challenges effec-



# **Trump Hosts Iftar Dinner At White House, Thanks Muslims For Support**

# 7.7 Magnitude Earthquake Strikes Myanmar, **Tremors Felt Across Southeast Asia**

A powerful 7.7 magnitude earthquake struck near the city of Sagaing, Myanmar, on Friday afternoon, causing widespread devastation and leaving at least 20 people dead, including 10 who died when a mosque collapsed in Mandalay during prayers. The earthquake's epicenter was approximately 260km from the capital Naypyidaw, where a 1000-bed hospital is feared to be a "mass casualty area," according to AFP. Though the number of fatalities at the hospital remains unconfirmed, scenes outside the building showed injured individuals receiving treatment on the streets, with family members offering comfort.

The quake also caused significant damage in other parts of Myanmar, including the destruction of residential buildings in Mandalay, the collapse of an old bridge over the Irrawaddy River, and the demolition of a monastery near the Thai border. In Mandalay, tremors led to further casualties, and reports suggest that more people may be trapped under the rubble.

The tremors were felt as far as northern Thailand, where buildings swayed, and metro services in Bangkok were temporarily suspended. Videos posted on social me-



dia showed people fleeing buildings in panic, and Thai Prime Minister Paetongtarn tremors were also recorded in Kolkata, Shinawatra declared a state of emergency in the capital. Additionally, in Bangkok's Chatuchak district, a 30-floor under-construction building collapsed, trapping 43 people. The building, intended for government offices, was reduced to rubble, and two deaths have been reported so far.

China's Yunnan province also felt the tremors, with the China Earthquake Networks

Center reporting a magnitude of 7.9. Mild parts of Manipur, and Dhaka, Bangladesh.

Residents of Chiang Mai in Thailand recounted their experiences, with one person saying they had to flee their home in their pyjamas as the earthquake shook the city. The extensive damage and aftershocks have left authorities in Southeast Asia scrambling to assess the full extent of the destruction.

Prof. Yunus, who also participated in the Boao Forum annual meeting in Hainan, met President Xi Jinping in Beijing and held high-level discussions with Chinese traders

Additionally, Bangladesh expressed appreciation for China's efforts in facilitating medical treatment for Bangladeshi citizens in the Yunnan province, reflecting the deepening

On the economic front, Bangladesh welcomed Chinese companies to invest in the Mongla Port Facilities Modernisation and Expansion Project and confirmed its interest in further developing the Chinese Economic and Industrial Zone (CEIZ) in Chittagong. 

# India's core sector growth slows to 2.9% in February

India's core infrastructure sectors, natural gas contracted by 5.2% and 6%, which contribute to about 40% of the respectively. country's industrial output, showed a slowdown in February 2025, growing by just 2.9%. This marks the slowest pared to 7.1% growth in the same month the previous year.

The latest data, released by the Union commerce ministry on Friday, revealed that only three out of the eight core sectors experienced a rise in production, with cement and fertilizers standing out with higher output compared to the previous year. However, the overall output of these core sectors was weaker than the previous month, as five out of eight indicators, including coal, crude oil, natural gas, refinery, and cement output, showed a decline.

In February, cement production grew by 10.5%, and fertilizers output rose by 10.2%, marking a positive year-on-year performance. However, cement production growth slowed down on a monthly basis. Coal output showed a modest rise of 1.7%, its slowest in six months, while refinery output increased by 0.8%. In contrast, the output of crude oil and

Steel production grew by 5.6%, and electricity output rose by 2.8%, both showing an improvement compared to January. monthly growth in five months, com- On the other hand, the overall growth of the core sector has moderated, with a significant slowdown seen in coal, crude oil, and natural gas, which contributed to the decline.

> This slowdown in core sector output comes as India's manufacturing sector also faced a dip, with manufacturing growth falling to a 14-month low in February, according to the HSBC India Manufacturing Purchasing Managers' Index (PMI). The moderation in core sector growth is likely to impact the Index of Industrial Production (IIP), with predictions suggesting a dip to 3-3.5% growth for February 2025, down from 5% in January.

> As per Aditi Nayar, chief economist at Icra Ltd., the slower growth was partly due to the high base effect of the leap year. Despite this, the sluggish performance in key sectors raises concerns about the sustainability of India's industrial momentum in the coming months.

# **SEBI Proposes New Expiry Day Restrictions for Equity Derivatives Products**



The Securities and Exchange Board of India (SEBI) has proposed a significant change to the settlement schedule of equity derivatives products offered by stock exchanges. The regulatory body has suggested that the final settlement day or expiry day for these products be restricted to either Tuesday or Thursday. This proposal aims to provide greater predictability and stability for market participants regarding expiry

(F&O) have varying expiry days, which can often lead to uncertainties and market volatility. By limiting expiry days to just two specific days, SEBI intends to streamline the process, reducing the potential for market disruptions while enhancing transparency. This change will help market participants better plan their trading strategies, as they will know exactly when to expect the settlement of their derivative contracts.

and its impact on market liquidity. With multiple expiry dates across the week, traders and investors can sometimes face challenges in managing their portfolios and adjusting positions. A more standardized expiry schedule is expected to improve the efficiency of the equity derivatives market, making it easier for participants to engage in trading without the added uncertainty of fluctuating expiry days.

If implemented, this new restriction would bring Indian equity derivatives products in line with international markets, where more consistent expiry schedules are commonly followed. SEBI's initiative is also likely to enhance the attractiveness of Indian markets to foreign investors, offering a more predictable trading environment.

This proposal is currently under consultation, with SEBI seeking feedback from market participants and other stakeholders before finalizing the decision. If accepted, it could lead to significant changes in the way equity derivatives are traded in India, with potential benefits in terms of both market efficiency and participant confidence.





# **YouTube Tests Notification Reduction System**



oogle has announced that YouTube is testing **G**a new system designed to reduce notifications from subscribed channels that users no longer watch frequently. This experiment aims to strike a balance between keeping users informed and preventing unwanted alerts without requiring them to unsubscribe.Currently, YouTube users can set notifications to "All," ensuring they receive updates from their favorite channels via push notifications. However, this can become frustrating when users continue receiving alerts from channels they no longer engage with. The only existing solution is to unsubscribe, which can be tedious if the user follows many channels. The new system aims to resolve this issue by automatically limiting notifications from infrequently watched channels.

YouTube's New Notification System According to Google, this system will ensure that users who haven't interacted with a channel recently will stop receiving push notifications from it. However, 24 hours.

these notifications will still be available in the You-Tube app's notification inbox. This change does not impact channels that upload infrequently or those with which users actively engage. Rather than adjusting notification settings for each channel individually or disabling all notifications at the app level, this experiment provides a middle ground. By limiting unwanted alerts, YouTube aims to enhance the user experience without affecting creators' reach significantly. However, since this feature is still in the testing phase, only a small group of users currently has access to it.addition to this notification experiment, YouTube recently introduced another test concerning monetization. Earlier this month, the platform began automatically submitting videos with a "Limited or no ads" rating for an additional review. This process ensures that even newly uploaded private videos undergo a monetization assessment, which may take up to


