In his address on Wednesday, the Governor revealed that 15,000 acres of land have been added as reserved forest, strengthening the state's commitment



to ecological conservation. Additionally, the government successfully recovered 5,000 acres of encroached forest land, ensuring that Karnataka's green cover is protected for future generations.


A significant milestone in this direction was the declaration of 5,678 acres of Hesaraghatta Lake area as protected grassland, providing critical habitat protection and preserving the lake's ecological importance. These efforts align with the state's broader commitment to environmental sustainability and climate resilience.

On the housing front, the Governor announced the construction of 3.05 lakh houses under various housing schemes, with a total allocation of ₹4,761 crore. To ease the financial burden on beneficiaries, the government has committed to covering most of the construction costs, ensuring that economically weaker sections and vulnerable communities gain access to safe and affordable housing. The Governor reiterated the government's resolve to create inclusive and sustainable development, where environmental protection and social welfare initiatives go hand-in-hand.

BJP Questions Naxalite Surrender Process in Karnataka

- BJP raises doubts over surrender process
- Says CM's tweet triggered sudden surrender
- **Questions state's law** and order claims

The Opposition BJP on Wednesday questioned the circumstances surrounding the surrender of six Naxalites in Karnataka, raising doubts over the process followed by the Congress government.

During the discussion on the Governor's speech in the Assembly, BJP MLA V Sunil Kumar expressed suspicion over the sequence of events, noting that the Naxalites surrendered just days after Chief Minister Siddaramaiah's social media appeal urging them to give up arms and return to the mainstream.

"For years, these Naxalites evaded po-



lice combing operations and ignored repeated warnings. But suddenly, after the CM's tweet, they turned up at his office to surrender. How did this happen so smoothly?" Sunil Kumar asked.

On January 8, six Naxalites surrendered, a week after Siddaramaiah posted his appeal on 'X'. Following their surrender, the state government declared Karnataka Naxal-free, a move the BJP welcomed in principle but strongly objected to the procedural lapses they claim occurred. Kumar further questioned the state government's claims that law and order was under control, citing recent incidents like the riots at Udayagiri police station, a broad daylight robbery in Bidar, and unrest in Mangaluru.

The BJP leader also invoked the controversial statement made by Congress MLC Ivan D'Souza, who last year warned Governor Thawar Chand Gehlot that he could meet the same fate as Sheikh Hasina Wajed, who was forced to flee Bangladesh. "Wasn't this direct threat to the highest office in the state provocative enough to expose the fragile law and order situation?" Kumar questioned.

Additionally, Kumar called the Congress a 'U-Turn government', accusing Siddaramaiah of contradicting himself over the MUDA site allotment case. He noted that Siddaramaiah publicly denied any scam but his wife later returned 14 sites, which, according to Kumar, exposed the double standards of the government.

The BJP pressed for a transparent explanation regarding the Naxalite surrender, warning that political interference in security matters could undermine public trust and jeopardize ongoing anti-Naxal efforts in the Malnad and coastal regions.

BJP Accuses Karnataka Congress of Planning 4% Reservation for Muslims in Govt Contracts

The Bharatiya Janata Party (BJP) has alleged that the Congress government in Karnataka is planning to introduce 4% reservation for Muslims in government contracts, accusing the ruling party of indulging in minority appeasement.

BJP state president B Y Vijayendra on Wednesday claimed that despite development works stalling across the state, the government is prioritizing a proposal to provide a 4% quota in government contracts for minorities. Vijayendra specifically questioned why the term "minority" is repeatedly equated only with Muslims, despite the presence of several other minority communities in the state and country.

He accused Chief Minister Siddaramaiah of using appeasement tactics and ignoring the interests of backward communities. "If the Chief Minister is truly a champion of backward communities, as he claims, he should focus on empowering them, rather than introducing reli-



gion-based reservations," Vijayendra said, urging people to oppose these policies.

BJP Vijayapura MLA Basanagouda Patil Yatnal echoed these sentiments, calling the proposed reservation anti-Constitutional. nal cited Dr B R Ambedkar, claiming the architect of the Indian Constitution opposed the formation of a Minority Welfare Department.

He alleged that the government's focus on minority appeasement was in direct violation of Constitutional principles.

Both leaders announced that the BJP will strongly raise this issue during the ongoing Assembly session and demanded a clear response from the government.

As of now, the Congress government has not officially responded to the allegations.



Five Bills Tabled in Karnataka Assembly, Including **Three Targeting Illegal Moneylending**

Palace Grounds Bill aims to bypass Rs 3,400 crore TDR payout

Three bills seek to curb exorbitant interest and illegal lending

Agricultural produce marketing reforms also introduced

The Karnataka government on Monday tabled five key bills in the Assembly, including the Bangalore Palace (Utilisation and Regulation of Land) Bill, 2025, aimed at addressing the long-standing dispute over the Palace Grounds land and sidestepping a massive Transferable Development Rights (TDR) payout to the Mysuru royal family.



The bill comes after the Supreme Court's December 2024 order, directing the government to issue TDR worth Rs 3,400 crore to the Mysuru royal family for 15 acres and 39 guntas of land required for expanding Ballari and Jayamahal roads. The government argued that the financial burden would severely impact the state exchequer and urban planning efforts. The Bangalore Palace Bill seeks to regulate the use of land acquired under the Bangalore Palace (Acquisition and Transfer) Act, 1996, which vested 472 acres and 16 guntas of Palace Grounds land with the state. The bill asserts that granting TDR now, while civil appeals challenging the constitutional validity of the 1996 Act are still

In addition to the Palace Grounds Bill, the government tabled three bills targeting illegal moneylending practices:

The Karnataka Prohibition of Charging Exorbitant Interest (Amendment) Bill, 2025, aims to protect vulnerable groups from loan sharks charging excessive interest and using coercive recovery tactics.

The Karnataka Pawn Broker Bill, 2025, and

The Karnataka Money Lenders (Amendment) Bill, 2025, both introduced to further tighten controls on moneylenders and protect borrowers from exploita-

The Assembly also saw the introduction of the Karnataka Agricultural Produce Marketing (Regulation and Development) Bill, 2025, which defines e-commerce platforms and warehouse service providers, extends market committee jurisdiction to sub-market yards, and establishes clearer regulations for warehouse operators and online trading platforms in the agricultural sector. These bills reflect the government's twin focus on land regulation, financial reforms, and agricultural modernization in Karnataka.

Karnataka State Industries Minister MB Patil informed the Legislative Council that sion rate during GIM 2022 the state government is actively following up to realise over 75% of investment commitments made during Invest Karnataka 2025, which attracted proposals worth ₹10.27 lakh CNG Pipeline Fee Fixed at crore.

Patil said 98 MoUs were signed during the Global Investors' Meet (GIM), accounting for ₹6,23,970 crore, while clearances for 1,101 projects would bring in an additional ₹4,03,533 crore. The minister stated that the meet drew participation from 2,892 industrialists from Karnataka, 286 from other states, and 72 foreign investors, showcasing global interest in Karnataka's industrial potential.

Investment proposals cover 21 districts, with Bengacrore from 30 companies, and Bengaluru Urban attracting ₹35,297 crore from 14 companies. Projects in ambitious targets.

Patil noted that the proposal-to-project converstood at 60%, and the government is now working towards increasing it to 75% with systematic follow-ups and project monitoring.

The Karnataka High Court has directed the Director of Municipal Administration to issue clear instructions to all Registrars of Births and Deaths across the state, mandating the surrender and cancellation of original birth certificates when corrected certificates are issued.

The court further ordered that an official endorsement must be issued stating the cancellation of the previous certificate, and necessary corrections must be reflected on the e-Janma portal to ensure consistency in official records. Justice Suraj Govindaraj passed the order while allowing a petition filed by Syeda Afifa Aymehn, a resident of M G Nagar in Hospet, Vijayanagar district. Aymehn approached the court seeking cancellation of a birth certif-



icate issued on May 13, 1993, which incorrectly recorded her birth date as April 15, 1993. The petitioner was actually born on March 15, 1993, and had used the correct date of birth for all official records, including her educational certificates, driving licence, and voter ID. However, due to the error in the original birth certificate, a discrepancy emerged when she applied for a passport.

Following an earlier order from the Lok Adalat, the Registrar issued a corrected birth certificate with the accurate date of birth. However, the passport authorities sought clarification after discovering two different birth

The petitioner applied to the Registrar for a clarification, but on December 5, 2024, the Registrar refused, stating they lacked the authority to issue such clarification without a court order. This forced the petitioner to approach the High Court, resulting in the latest directive to ensure such confusion is avoided in the future by canceling incorrect certificates and updating offi-

The court's directions are expected to streamline birth record management across Karnataka and prevent similar issues for citizens.

Karnataka Forest Minister Orders Reclamation of 444 Acres from Air Force

- Minister Eshwar Khandre directs forest land recovery from Air Force
- Illegal construction halted in Jarakabande reserve forest
- Legal action to be taken for land recovery

Karnataka Forest Minister Eshwar Khandre on Wednesday instructed officials to reclaim 444.12 acres of forest land in the Peenya plantation and Jarakabande reserved forest area of Bengaluru, currently held by the Indian Air Force, as per existing rules and government orders.

The dispute dates back to 1987 when 570 acres were allotted to the Air Force. However, in 2017, the Karnataka government cancelled the sanction of 452 acres, declaring it as notified forest land. Despite this, the Air Force reportedly began construction work on March 1, 2025, without



obtaining mandatory Forest Clearance (FC) permission.

Minister Khandre stated that the government order of 2017 had already completed the mutation process, officially registering this land as reserved forest. The Forest Department had previously notified Air Force officials about this and installed boards declaring the area as reserved forest. A formal letter was also sent to the

Ministry of Defense requesting the clearance of forest land occupied by the Air Force.

Officials informed the Minister that, despite this clear communication, the Air Force continued with illegal construction, prompting the Forest Department to halt

Currently, the Air Force is using approximately 15 acres of the forest land for a shooting range and training activities, while a small office has also been constructed. The rest of the land remains as forest, home to a rich variety of trees and plants.

Minister Khandre directed officials to initiate legal action to reclaim the land and instructed that all necessary applications for land regularisation be submitted through the Parivesh portal. He also stressed the importance of writing to the Air Force once again, urging them to obtain proper Forest Clearance as required by law.

Members Across Parties Slam Karnataka Govt Over Illegal Liquor Sales

Cutting across party lines, members of the Karnataka Assembly strongly criticised the state government on Wednesday over the rampant illegal sale of liquor in petty shops and small grocery stores across rural areas. Legislators blamed the government's 'abnormally high targets' set for the excise department as the root cause of the problem.

Raising the issue during question hour, Congress MLA Mahantesh Koujalgi (Bailahongal) highlighted that illegal liquor sales in village shops and grocery stores were directly contributing to an increase in road accidents and the death of youngsters. He added that during visits to villages, women regularly complained that these sales were causing youth to fall into bad habits, leading to fights and violence. Excise Minister R B Thimmapur admitted that illegal liquor sales were happening in petty shops and assured that the department had acted on the issue. He informed the House that the department had registered 17,390 cases and arrested 18,253 indi-



viduals in connection with these illegal activities.

However, JD(S) floor leader C B Suresh Babu rejected the minister's assurances, arguing that the unreasonably high revenue targets set for the excise department were forcing bar owners to find illegal ways to boost sales. He alleged that bar owners were using delivery boys on bikes to supply liquor directly to labourers at worksites and even selling liquor by the roadside.

Former Home Minister and BJP MLA Araga Jnanendra added that the excise and police departments were working together to allow liquor sales near SC/ST colonies. As a result, many youngsters from these communities were becoming addicted, further worsening social issues in villages.

Legislators from all parties urged the government to review excise targets and take stronger measures to curb illegal liquor sales across the state.

Retired IAS Officer, 2 Officials to Face Trial in Bengaluru Land Fraud Case

- Allegations of fake land documents
- Karnataka HC refuses to quash case

The Karnataka High Court has refused to quash proceedings against retired IAS officer Aravind Jadhav and two other officials in a land fraud case involving two acres of government land in Ramanayakanahalli village, Sarjapur Hobli, Anekal taluk, Bengaluru Rural district.

The land was purchased by Tarabai Maruthi Rao Jadhav, mother of former Karnataka Chief Secretary Aravind Jadhav. A complaint was filed by Bengaluru resident S Bhaskaran, who alleged that retired Bengaluru



Urban Deputy Commissioner V Shankar, surveyor DB Gangaiah, and Joint Director of Land Records Jayaprakash conspired with Aravind Jadhav to create fake land documents, causing loss to the state exchequer. The complaint, initially filed with the Anti-Corruption Bureau (ACB) in August 2016, was later transferred to the Lokayukta police, which filed a charge sheet in a special

The accused officials approached the High Court seeking to quash the complaint and FIR, arguing that the FIR was delayed by two years and that there was no evidence proving the land was government-owned. They also highlighted that while Aravind Jadhav was named, sanction for his prosecution was not granted.

However, Justice HP Sandesh found sufficient prima facie evidence against the petitioners, noting that key land records were altered and processed unusually quickly, allegedly due to Aravind Jadhav's influence. The court highlighted that phodi work (sub-division of land) was completed within three months, a rare occurrence in the Revenue Department, and was done without any formal application.

The court dismissed the petitions, clearing the way for the trial to proceed.

Kannada Actor Ranya Rao Caught Smuggling 14.8 kg Gold at Bengaluru Airport

- DRI seizes 14.8 kg gold worth ₹12 crore
- Actor claims blackmail forced her into smuggling
- Police constable also under scanner

Kannada actor Ranya Rao was arrested by the Directorate of Revenue Intelligence (DRI) at Kempegowda International Airport (KIA) in Bengaluru for allegedly attempting to smuggle 14.8 kg of gold, valued at over ₹12 crore, from Dubai.

According to reports, Ranya Rao was just one step away from clearing airport security when DRI sleuths intercepted her and recovered the gold bars. During interrogation, the actor claimed that she was blackmailed into smuggling gold,



as reported by media.

The investigation has also revealed the involvement of police constable Basavaraju, who reportedly tried to assist Ranya in evading customs checks. Basavaraju has been detained, and his statement has been recorded.

Ranya, known for her roles in films like 'Maanikya' and 'Pataki', was under DRI surveillance due to her suspicious frequent visits to Gulf countries. Within 15 days, she had flown to Dubai four times, raising red flags. Based on this, a targeted operation was planned, leading to her arrest upon her arrival from Dubai on March 3 via an Emirates flight.

Following her arrest, DRI officials raided her Lavelle Road residence, seizing gold jewellery worth ₹2.06 crore and ₹2.67 crore in cash.

Ranya is the stepdaughter of senior IPS officer Ramachandra Rao, currently serving as the Director General of Police (DGP) at the Karnataka State Police Housing Corporation. DGP Rao distanced himself from her activities, stating that she married four months ago and has had no contact with the family since.

"We are unaware of her or her husband's business dealings. This is a huge shock and disappointment. The law will take its own course," DGP Rao told Media.

BDA Property Owners Raise Objections Over Bangalore Business Corridor Project

thority (BDA) is pushing ahead with the ambitious Bangalore Business Corridor (BBC) project, aimed at easing traffic congestion in Bengaluru. Spanning 73 km and estimated to cost ₹27,000 crore, the project involves the creation of a 100-meter wide, six-lane corridor connecting Tumkur Road to Hosur Road, passing through major areas like Hesaraghatta Road, Doddaballapura Road, Bellary Road, Hennur, Whitefield, Channasandra, and Sarjapur Road.

Originally proposed as the Peripheral Ring Road (PRR) in 2007, the project has now been renamed BBC, with the state government securing funding through HUDCO. The BDA has started issuing land acquisition notices across villages including Bylakonehalli, Lakshmipur, Siddhanahalli, and Madanayakanahalli. To handle the large-scale acquisition, nine special land acquisition officers have been appointed.

However, the project faces major hurdles as property owners have raised strong objections. Over 10,000 objections have been submitted, with landowners demanding compensation based on current market rates rather than outdated 2006 valuations. Many have already built homes on the notified land and are resisting eviction, urging the government to save their properties instead of offering compensation. The BDA estimates that 2,600 acres

of land is required for the project, with ₹21,000 crore earmarked for land acquisition alone and ₹6,000 crore for road construction. The BDA also plans to use the land on both sides of the corridor for commercial development, integrating business hubs along the stretch. While the project aims to decongest Bengaluru by linking major highways, the land acquisition dispute is likely to further delay the already long-pending project,

with both landowners and offi-

cials yet to reach a consensus.

The much-delayed Ejipura Flyover project in Koramangala, which had been stuck for several years, is finally moving forward. The Bruhat Bengaluru Mahanagara Palike (BBMP) has confirmed that the long-standing hurdles related to land acquisition and coordination with key institutions have been resolved, paving the way for construction to resume at full speed. The 2.5 km flyover, which connects Koramangala's Central Hall to Ejipura via Inner Ring Road, was initially slated for completion by February 2025.

However, after prolonged delays, a new deadline of December 2025 has been set. With work gaining momentum, BSCPL Infrastructure Company has been entrusted with the project's execution.

A key breakthrough came when two central government institutions — the Indian Institute of Astrophysics (IIA) and St. John's Hospital, both located along the corridor, agreed to part with portions of

The BBMP has granted in-principle approval for the acquisition of 1.5 acres, which is critical for the project's progress. Additionally, 30 private property owners along the stretch have also expressed no objection to land acquisition, clearing another major obstacle. The BBMP plans to issue Transfer of Development Rights (TDR) to the institutions, compensating them with development benefits in exchange for the land.

St. John's Hospital, while agreeing in principle, has demanded TDR benefits or an alternative solution, particularly for the development of a 100-foot road. The BBMP, however, remains confident of securing the land with or without TDR, citing public interest and broader benefits for Bengaluru's commuters. With all major hurdles cleared, BBMP officials expect to complete the Ejipura Flyover by the end of 2025, offering much-needed relief to lakhs of commuters along the busy Koramangala-Ejipura-Hosur Road corridor.



BJP MLAs Protest Over Lack of Visual Coverage in Assembly, House Adjourned

The Congress government's ambitious Brand Bengaluru initiative, which aimed to transform the city into a global brand, has come under fire from the opposition. BJP leader and opposition leader R. Otherwise, hand over the responsibility to someone capable," Ashok remarked. He challenged Shivakumar to list his concrete achievements in Bengaluru over the last 20 months, insisting that work should speak for itself rather than slogans.

Ashok further alleged that under Congress rule, Bengaluru has turned into a pothole city and a dust city, with motorists struggling to navigate dangerous roads.

In response, DK Shivakumar recently inspected white-topping works at locations including MEI Road, the 100-foot ring road near Jalahalli TVS Cross, and Netkalappa Circle Road. He defended the ongoing works under Brand Bengaluru, emphasizing that efforts are being made to ease traffic congestion and improve infrastructure.

The BJP leader further charged that Yediyurappa had consistently deprived the Lingayat community of reservation benefits throughout his political career. Yatnal stated that after former Chief Ministers Veerendra Patil and J H Patel, Yediyurappa was inadvertently accepted by the Veerashai-



va-Lingayat community, despite not belonging to it.

Yatnal's remarks have triggered strong reactions within the party and the Lingayat community, with Yediyurappa's supporters dismissing the claims as baseless and politically motivated.

The controversy comes at a time when BJP's internal power struggles in Karnataka are surfacing ahead of the upcoming elections, adding further complexity to the party's delicate relationship with the influential Lingayat community, which plays a key role in state politics.

Karnataka MLAs Demand Action Against Infosys Over Unused Hubballi Land

Senior legislators in Karnataka have once again targeted IT giant Infosys for failing to utilize 40 acres of prime land allotted to it in Hubballi for over a decade. They demanded that the state government take immediate action, including withdrawal of the land.

The issue was raised during Tuesday's Legislative Council session, where BJP MLC S V Sankanur reminded the House that Infosys was granted the land in 2013 under the Global Investors Meet (GIM) agreement, with a promise to establish an IT campus and generate local employment. However, even after 10 years, the land remains underutilized, with no substantial job creation.

MLC Pradeep Shettar went a step further, accusing Infosys of using the land for personal and recreational purposes instead of industrial development. He alleged that Infosys employees were using the space for walk-

ing, jogging, and hosting private gatherings, which was never part of the agreement.

Industries Minister M B Patil responded that Infosys representatives had recently met him to discuss the matter. However, Legislative Council Chairman Basavaraj Horatti intervened, urging the government not to remain silent just because Infosys is a corporate giant.

Horatti insisted that serious action, including withdrawal of the land, must be considered if Infosys fails to meet its commitments.

Minister Patil assured the Council that he would convene a high-level meeting to review the situation and take appropriate action.

This is not the first time the issue has come up, with similar demands raised during the 2024 Legislature Sessions. Legislators stressed that valuable industrial land must not be wasted, and the government must ensure strict compliance with project commitments.

Govt School Headmaster Goes Missing After Multiple POCSO Cases

TPN Correspondent | Mysuru A headmaster of a government higher primary school in H D Kote taluk, Mysuru district, has gone into hiding after multiple complaints were filed against him for allegedly sexually

abusing minor girl students.

The first complaint was lodged on February 25, following which the headmaster stopped attending the school. Another complaint was registered on March 1, further intensifying the case. Based on the complaints filed by the Block Education Officer (BEO) and parents, police have registered cases under the Protection of Children from Sexual Offences (POCSO) Act.

Local MLA Anil Chikkamadu visited the school on Monday to assess the situation. During his visit, the BEO arrived late, drawing sharp criticism from both the MLA and villagers. Taking serious note of the BEO's absence and alleged negligence, the Education Department suspended BEO K Kantharaju and two other officials for dereliction of duty.

On Tuesday, Mysuru Superintendent of Police Vishnu-



vardhana and Deputy Commissioner G Lakshmikanth Reddy visited the school. Villagers gathered at the school premises and demanded strict action not only against the absconding headmaster but also against officials who failed to act promptly on the initial complaint.

Police have formed two special teams to locate and arrest the headmaster, who has been untraceable since the first case came to light.

The incident has sparked widespread outrage, with local residents and parents urging authorities to tighten safety measures and ensure stricter background checks on school staff to prevent similar incidents in future.





Kannada Actress Ranya Rao Arrested for Smuggling ₹12.56 Crore Worth of Gold

Kannada actress Ranya Rao was arrested on March 5, 2025, at Bengaluru's Kempegowda International Airport after being caught with 14.2 kg of gold worth ₹12.56 crore. Rao, who had made multiple trips to Dubai in recent weeks, was under surveillance by the Directorate of Revenue Intelligence (DRI) due to her suspicious behavior, including wearing the same clothes during each visit. Her frequent travels raised red flags, prompting the authorities to act.

Ranya Rao, who is the stepdaughter of senior Karnataka IPS officer Ramachandra Rao, currently the Director-General of Police at the Karnataka State Police Housing Corporation, was intercepted by DRI officers after arriving in Bengaluru on an Emirates flight from Dubai on March 3. Upon examination, officers discovered that she had cleverly concealed the gold bars on her person.

Following her arrest, a search was conducted at her Bengaluru residence located on Lavelle Road, where officers recovered gold jewelry valued at ₹2.06

TPN Correspondent | Karnata- crore and Indian currency amounting to ₹2.67 crore, bringing the total value of the seized items to ₹17.29 crore. The authorities have charged her with gold smuggling under the Customs Act, 1962.



The seizure of such a large amount of gold raises questions about the involvement of influential individuals in illicit activities, highlighting the need for stricter surveillance and enforcement.

Ranya Rao has been placed under judicial custody and faces serious legal consequences. The authorities are continuing their investigation to determine the full scope of the smuggling operation and whether others were involved in facilitating the illegal import of gold.

This incident underscores the ongoing battle against gold smuggling in India and serves as a reminder of the importance of vigilance and oversight at airports and customs points across the country.

Two Earthquakes, Including One Of 5.7 Magnitude, Hit Manipur

Manipur was rocked by two consecutive earthquakes on Wednesday, including one with a magnitude of 5.7, which caused tremors across the Northeast. According to officials from the Regional Seismological Centre in Shillong, the first earthquake occurred at 11:06 am with a magnitude of 5.7. Its epicenter was located 44 kilometers east of Yairipok in Imphal East district, at a depth of 110 km.

The tremors were felt not only in Manipur but also in Assam, Meghalaya, and other northeastern states, with residents reporting shaking buildings and swaying structures. Around 12:20 pm, a second earthquake of magnitude 4.1 struck Manipur's Kamjong district, at a depth of 66 km.

Following the quakes, several buildings in Manipur were reported to have developed cracks.

Social media footage showed visible damage at a school building in Wangjing Lamding, located in Thoubal district, where a relief camp for people affected by ethnic strife was set up. Local authorities are currently confirming reports of damage, particularly in the areas where the relief camps are located.

Despite the visible cracks in buildings, no casualties or major structural damages have been reported so far in the affected regions. Authorities are monitoring the situation closely and are working to assess any additional impacts in other parts of the Northeast.

The tremors have heightened concerns across the region, with residents remaining on alert for potential aftershocks. While the situation remains under assessment, there have been no immediate reports of significant damage outside of Manipur.

Karnataka's Six-Day Egg Distribution Boosts School Attendance and Nutritional Intake

- Egg distribution to six days a week, boosting school attendance to 98.97%.
- Nutritional impact: 62.15% of students consume eggs, while 15.12% prefer bananas; chikki distribution halted due to quality concerns.
- Kolar leads in egg consumption (84.16%), while Chikkodi reports the lowest (30.97%); banana consumption remains under 32% statewide.

Karnataka's initiative to distribute eggs six days a week as part of the mid-day meal program has led to a significant improvement in student attendance across government and aided schools, according to the Department of Public Instruction (DPI). Prior to this move, when eggs were provided only twice a week, student attendance was at 93.5%. However, following the increase to six days a week, attendance has risen to 98.97%, as reported by DPI officials.

Along with eggs, bananas and groundnut chikkis were also included in the meals to combat malnutrition among schoolchildren. Eggs were initially introduced twice a week, and bananas and chikkis were offered to students who didn't consume eggs. With support from the Azim Premji Foundation for Development (APF), the government expanded the distribution of eggs to six days a week starting in September 2024.



However, chikkis were recently discontinued due to concerns over their quality.

The initiative has seen an increase in the number of beneficiaries. As of August 2024, when eggs were provided twice weekly, 48.13 lakh students (93.66%) benefitted from the program. Of these, 32.33 lakh students received eggs, 7.09 lakh received bananas, and 8.70 lakh consumed chikki. By January 2025, after increasing egg distribution, the number of students consuming eggs surged to 6.64 crore (62.15%), with bananas consumed by 1.61 crore students (15.12%), and 2.32 crore students (21.7%) continuing to consume chikkis.

The highest egg consumption was observed in Kolar district, where 84.16% of students participated, followed by Kodagu (83.89%) and Hassan (81.26%). However, districts like Chikkodi, Belagavi, and Bengaluru North saw lower participation rates. K.V. Trilok Chandra, Commissioner of DPI, highlighted the positive impact of the scheme, noting that not only has attendance increased, but the nutritional benefit for children has also enhanced, leading to potential academic improvements. This initiative is part of Karnataka's broader effort to tackle malnutrition and ensure that students receive adequate nutrition to support both their health and learning.

Delhi, Bengaluru Made Massive Growth In Global Luxury Home Market In 2024



India's next generation of high-net-worth individuals (HNWIs) is increasingly drawn to luxury investments, with a growing interest in luxury real estate. According to a new report by Knight Frank, 25.7% of HNWIs aspire to own a luxury home, making it the second most sought-after luxury asset after high-end cars (46.5%). Art collection (11.9%) and private jets (9.9%) also featured on the luxury wish list.

The survey focused on individuals with an annual income exceeding \$125,000, revealing that nearly 30% of next-gen HNWIs globally prefer high-end real estate, followed by luxury cars at 27.8%, and private jets at

Knight Frank's report highlighted the significant strides made by Delhi and Bengaluru in the global luxury home market. Delhi, in particular, experienced a remarkable surge, moving from 37th place in the Prime International Residential Index (PIRI 100) in 2023 to 18th in 2024. This jump was driven by a 6.7% year-on-year (YoY) increase in luxury residential prices. Bengaluru also saw a positive shift, improving from 59th to 40th place, reflecting growing demand for luxury properties in the city.

The global luxury residential market, overall, saw an av-



erage price increase of 3.6% in 2024. Strong growth was particularly noted in regions like the Middle East and Latin America, where markets rose by 7.2% and 6.3%, respectively. Despite broader global economic challenges, these regions showed resilience, driven by sustained demand in local markets.

The growth of the luxury residential market in cities like Delhi and Bengaluru signals a shift towards highend investments among India's wealthy elite, as the country's urban landscape continues to evolve as a key player in the global luxury real estate market.

Chennai to Roll Out Mini-Bus Services for Last-Mile Connectivity

Chennai is set to enhance its public transportation network with the introduction of mini-bus services aimed at improving last-mile connectivity for residents in the city's extended areas. The initiative comes after the Chennai district administration invited applications from mini-bus operators to cover 72 newly identified routes across the metropolitan area.

Chennai Collector Rashmi Siddharth Zagade announced the plan on February 28, inviting mini-bus operators to apply for permits under the newly sanctioned scheme by the Home Department. The initiative is part of the Tamil Nadu government's broader effort to operate a fleet of 18,750 to 25,000 mini-buses across the state. In Chennai, mini-buses will serve areas such as Tiruvottiyur, Manali, Madhavaram, Ambattur, Valasaravakkam, Alandur, Perungudi, and 240 square kilometers.

The mini-bus services are scheduled



to launch on May 1, and the goal is to improve access to both urban and rural areas while addressing the critical gap in last-mile connectivity. With a minimum capacity of 7 passengers and Sholinganallur, which span a total of a maximum of 25, the mini-buses will provide more accessible and affordable options for commuters who currently

rely on costly autorickshaws.

The routes will cover diverse neighborhoods and link key transit points like metro stations and bus terminals. In the northern parts of Chennai, routes will connect areas such as Ambattur, Red Hills, and Madhavaram, while southern regions like Sholinganallur and Perungudi will also see services linking residential areas to commercial hubs.

A minimum fare of ₹4 has been set for up to 2 kilometers, with the maximum fare capped at ₹10 for longer distances, ensuring affordability for all passengers. However, the core areas of the city, including Tondiarpet, Royapuram, and Anna Nagar, will be excluded from this service in the first phase.

While the Metropolitan Transport Corporation (MTC) previously operated a fleet of mini-buses, these services were deemed unviable. The new mini-bus scheme is expected to address this issue and provide a crucial service for thousands of commuters in the city's extended areas.



The Delimitation Debate: Why Stalin's Argument Falls Flat



Tamil Nadu Chief Minister MK Stalin has recently raised concerns about the upcoming delimitation process based on the 2026 Census, claiming it would unfairly reduce Tamil Nadu's parliamentary strength. In a post on social media, Stalin warned that southern states like Tamil Nadu, which have successfully controlled population growth, could see their representation in Parliament decrease, thus weakening their voice. This claim, however, has been debunked by Union Home Minister Amit Shah, who reassured the southern states that their interests would be safeguarded, and there would be no reduction in their seats.

Stalin's statements are unsur-

prising, considering the DMK's history of exploiting regional sentiments and promoting a North-South divide for political gains. The primary aim is to rally the Dravidian vote bank by creating fear about potential political marginalization. But what exactly is delimitation? Delimitation is the process of redrawing electoral boundaries based on the latest population data to ensure fair representation. It is a constitutional exercise, mandated by Articles 82 and 170 of the Indian Constitution, which requires periodic adjustments to maintain democratic equality. Contrary to Stalin's claims, delimitation is a legitimate and necessary



representation in Parliament and state assemblies.

In India, delimitation has been carried out multiple times, with the last exercise conducted in 2002. Population-based adjustments in the distribution of parliamentary seats are based on Census data, and the 2026 Census will guide the next review. While delimitation can result in an increase or decrease in the number of constituencies, it does not alter the total number of seats in Parliament. As India's population grows, the number of Lok Sabha seats is expected to increase, benefiting the southern states in terms of absolute representation.

For example, based on popuprocess to ensure proportional lation projections, southern

states like Tamil Nadu are likely to see an increase in their parliamentary seats post-delimitation. Tamil Nadu, which currently holds 39 Lok Sabha seats, could see its share rise to 41. This represents a 5.12% increase in Tamil Nadu's seat share, not a decrease, as Stalin claims.

Moreover, Stalin's opposition to delimitation is inconsistent with his party's stance on other issues. For instance, the DMK has not criticized the Congress party's slogan "Jitni Aabadi, Utna Haq," which calls for representation based on population. If population is an acceptable yardstick for reservations, why oppose its use for delimitation?



SEBI Under Scrutiny: A Call for Reform and Accountability

developments surrounding the Securities and Exchange Board of India (SEBI), the country's capital market regulator, have raised significant concerns about its credibility and ability to effectively regulate the stock market. On one hand, former Finance and Revenue Secretary Tuhin Kanta Pandey took over as SEBI's chairperson. On the other, a special court in Mumbai directed the Anti-Corruption Bureau to file a First Information Report (FIR) against Pandey's predecessor, Madhabi Puri Buch, and other officials, regarding alleged stock market fraud and regulatory violations dating back to 1994. The case revolves around the fraudulent listing of a company on the stock exchange, allegedly facilitated by authorities at the time.

Though Buch was SEBI chairperson years after the alleged fraud occurred, the court's directive highlights concerns about inaction by law enforcement and regulatory authorities over the years. The failure of SEBI and other agencies to

address the matter earlier has now triggered a judicial intervention, which calls for a thorough investigation into whether Buch ignored or mishandled complaints related to this historical case. This is a serious issue that requires immediate attention to preserve the integrity of the regulator.

Buch had previously faced another controversy when the now-defunct US short-seller firm, Hindenburg Research, accused her and her husband of having stakes in offshore entities allegedly linked to the Adani Group, a matter that was under SEBI's scrutiny at the time. This accusation triggered calls for her resignation, with critics citing a potential conflict of interest. Although Buch managed to weather the storm and continue in her role, the damage to SEBI's reputation was undeniable. These controversies have cast a long shadow over SEBI, undermining investor confidence and tarnishing its image as an impartial and trustworthy regulator.

Kamal Hasan accuses BJP of creating "Hindia", **Opposes delimitation and Hindi Imposition**

Actor-politician Kamal Haasan has accused the Bharatiya Janata Party (BJP) of trying to create a concept of "Hindia" by imposing Hindi on non-Hindi-speaking states, a move he argues undermines federal principles. Haasan, leader of the Makkal Needhi Maiam (MNM), made these remarks while attending an all-party meeting convened by Tamil Nadu Chief Minister MK Stalin. The meeting primarily focused on issues related to the Centre's proposed delimitation exercise and the three-language formula under the National Education Policy (NEP).

Haasan strongly opposed the Centre's push for the three-language formula, which includes Hindi as a compulsory language alongside regional languages. He said, "They are creating Hindia. Whatever decision taken by the Centre will not be in favour of non-Hindi-speaking states. This decision, which is against federal principles, is unnecessary." The three-language formula has sparked controversy in Tamil Nadu, where many fear it is an attempt to impose Hindi on the state, disregarding regional linguistic diversity.

The actor-politician also pointed out the deep-rooted linguistic pride among Tamilians, stating, "Tamilians have lost their lives for a language. Don't play with those things. Tamilians, even children, know what language they need." His comments resonate with the long-standing cultural and linguistic sensitivities in Tamil Nadu, where there is a strong sentiment against imposing Hindi as a dominant language.

Haasan further criticized the proposed delimitation exercise, which aims to adjust parliamentary constituencies based on population. He questioned the need for such changes, asking, "Why are they repairing something that is not broken? Why are they sending democracy to the workshop for repair?" His concerns reflect fears that southern states, including Tamil Nadu, might lose seats in Parliament due to successful population control measures. During the meeting, Chief Minister Stalin echoed these concerns, suggesting that the delimitation exercise should be based on the 1971 Census for the next 30 years.

Narwal was cremated on Monday evening after her family initially refused to perform the last rites until the accused was arrested.

Former Haryana Chief Minister Bhupinder Singh Hooda spoke to Rohtak's Superintendent of Police regarding the investigation. Congress MLA BB Batra described Narwal as an active party worker and demanded strict punishment for those responsible for her murder.

'Defer delimitation exercise indefinitely,' Vijay tells union government

Tamilaga Vetri Kazhagam (TVK) President and actor Vijay on Wednesday strongly opposed any move to reduce Tamil Nadu's representation in the Lok Sabha based on population growth. He called for the number of seats in the Lok Sabha to be frozen indefinitely at 543, based on the 1971 Census figures, arguing that any changes that would lead to a reduction in the representation of Tamil Nadu and other South Indian states would be seen as "punishment."

Vijay's statement comes ahead of an all-party meeting chaired by Chief Minister M.K. Stalin to discuss the issue. He emphasized that if South Indian states were to lose seats while states like Uttar Pradesh and Bihar gained more due to population, it would be unfair. "Tamil Nadu and other South Indian states have invested heavily in education and population control measures over the past 50 years. A reduction in seats for these states would only punish them," Vijay said.

The actor-politician also strongly opposed using population alone as the basis for delimitation, pointing out that it was a flawed approach. He noted that the new Parliament building has seating arrangements for 888 members, which he believes suggests that the intention is to increase the number of Lok Sabha seats. Vijay stressed that increasing the number of MPs was not a pressing issue for ordinary citizens and that it should not be a priority.

Vijay argued that the number of Lok Sabha seats should be frozen, as the current population-based representation system has not seen



any changes in the last 50 years. He further stated that not all 543 MPs even have the time to ask questions in Parliament, proving that more seats are not necessarily needed.

Vijay also raised concerns over the appointment of Election Commissioners, suggesting that their selection process should be more transparent and carried out with consensus to ensure free and fair elections. He criticized the Centre for unilaterally choosing Election Commissioners and questioned the fairness of the process. In a political dig at the BJP, Vijay said that this issue would reveal which parties truly stand with the people of Tamil Nadu.

NDA govt ended Hindu-Muslim riots in Bihar: Nitish Kumar

Bihar Chief Minister Nitish Kumar on Tuesday asserted that his NDA government had successfully put an end to frequent Hindu-Muslim clashes in the state. Speaking during a debate on the motion of thanks to the governor's address, Kumar highlighted the government's measures, including the fencing of graveyards and bringing perpetrators of communal riots to justice, as key steps in improving law and order in Bihar.

Kumar, who is seeking a fifth consecutive term in office during the upcoming assembly elections, began his address by reminiscing on Bihar's law and order situation prior to the NDA's rise to power in 2005. He stated, "Before we came to power in 2005, the law and order situation was so pathetic that people feared for their safety." His remarks aimed to emphasize the drastic har. improvements made under his administration, particularly in terms of restoring peace and security in the state.

The chief minister claimed that the proactive steps taken by his government, including efforts to address communal tensions and the installation of security measures, had ensured a decline in religious violence. "Other countries have used tariffs against us for decades, and now it's our turn to start using them against those other countries," Trump declared. He further criticized India, saying, "India charges us auto tariffs higher than 100 percent."

Hardest Part Is..: Sunita Williams Discusses Unexpectedly Long Space Stay

NASA astronauts Sunita Williams and Butch Wilmore have been aboard the International Space Station (ISS) since June 2024, initially arriving on a Boeing Co. Starliner spacecraft for a test flight. Their mission, which was intended to last about a week, turned into an unexpectedly extended stay due to technical difficulties with the Starliner. As a result, NASA declared it too risky to bring them back home on the same craft, leaving the astronauts in space for what has now been almost 10 months.

The pair are now set to return to Earth in March 2025 on a SpaceX mission, but their prolonged time in orbit has drawn significant attention. While the extended stay has led to political commentary from figures like former President Donald Trump and SpaceX CEO Elon Musk, both Williams and Wilmore trary to Musk's claims of offering to bring have downplayed the impact of politics on their mission.

Wilmore dismissed political claims, stating, "The words they said, well, that's politics... From my standpoint, politics has not played into this at all." He further explained that there was little information on any potential offers to return them to Earth earlier, con-

In response to Musk's suggestion that the ISS should be retired early, Williams emphasized that the station was still performing at its best. "We're actually in our prime right now," she said, adding that discontinuing the ISS ahead of its planned 2030 retirement would not be the right decision.



If war is what US wants, we're ready: China says fentanyl 'flimsy excuse' to raise tariffs

China has strongly criticized the United States' decision to raise tariffs on Chinese imports, calling the fentanyl issue a "flimsy excuse" to justify the tariff hikes. In a statement posted on social media platform X, the Chinese Foreign Ministry rebuffed Washington's claims that China has not taken adequate steps to combat the fentanyl crisis, stressing that the U.S. is solely responsible for the situation within its borders.

The Chinese government emphasized that, contrary to U.S. accusations, Beijing had made significant efforts to help tackle the fentanyl problem. However, these efforts, according to the ministry, have not been acknowledged by the U.S. Instead, China claims that Washington has used these actions as a pretext to escalate tariffs, viewing it as a form of blackmail and punishment for China's cooperation. "We have taken robust



steps to assist the U.S. in dealing with the The tensions stem from the recent increase issue," the statement read. "But the U.S. has smeared us and used pressure tactics, which will not resolve the problem."

The Chinese Foreign Ministry further stressed that the approach of coercion, threats, and pressure would not work on China. "If the U.S. truly wants to solve the fentanyl issue, the right approach is to consult with China and treat each other as equals," it added. The ministry warned that the U.S. was miscalculating by resorting to maximum pressure

In a response to the U.S. tariffs, the Chinese Embassy in Washington warned that Beijing is prepared for any conflict, whether trade, tariff, or otherwise. "If war is what the U.S. wants, be it a tariff war or any other type of war, we are ready to fight till the end," the embassy posted.

Very dumb thing to do: Trudeau after US imposes 25% tariffs

In response to the U.S.'s recent decision to impose new tariffs, Canadian Prime Minister Justin Trudeau has expressed strong criticism, calling the move "a very dumb thing to do." Speaking to Canadians, Trudeau stated that while it's not common for him to agree with the Wall Street Journal, he found it necessary to acknowledge their viewpoint on the matter. "Donald, they point out that even though you're a very smart guy, this is a very dumb thing to do," said Trudeau in his speech.

The prime minister's remarks came just a day after Canada retaliated with its own import taxes in response to the U.S. tariffs. Trudeau emphasized the negative consequences of the tariff escalation, particularly the impact it would have on the relationship between the two neighboring countries. He also highlighted the broader geopolitical implications, stressing that the ongoing dispute was precisely what global adversaries wanted to see: two close allies fighting each other.

The controversy over tariffs marks the latest chapter in the tense trade relations between the U.S. and Canada. The U.S. tariffs, which are part of broader efforts by President Donald Trump to impose stricter trade measures on various nations, have drawn sharp rebukes from Canadian officials. Trudeau's speech came in the presence of key ministers, including Foreign Affairs Minister Melanie Joly, Finance Minister Dominic LeBlanc, and Public Safety Minister David McGuinty, who are all working to navigate the ongoing trade tensions. Bangladesh got 'no official response' from India on Hasina's extradition request: Yunus

Bangladesh's interim government Chief Adviser, Muhammad Yunus, has revealed that Dhaka sent formal letters to India requesting the extradition of former Prime Minister Sheikh Hasina, but received no official response from New Delhi. Yunus, in an interview with UK-based Sky News, asserted that Hasina would face trial for "crimes against humanity" in Bangladesh, with the state-run BSS news agency reporting his statements.

Hasina, 77, fled Bangladesh on August 5 last year amid a massive student-led protest that led to the collapse of her 16-year rule under the Awami League. Following her departure, the Bangladesh International Crimes Tribunal (ICT) issued arrest warrants for Hasina and several of her close associates, including former ministers, military officers, and civil officials, accusing them of crimes against humanity and genocide.

Yunus emphasized that Hasina, along with her family and associates, would face trial either in person or in absentia, even if she remains in India. Despite Bangladesh's formal communication to India, Yunus confirmed that the Indian government had not responded officially to the extradition request. Last year, India acknowledged receiving a "note verbale" from the Bangladesh High Commission but refrained from commenting on the matter. The accusations against Hasina involve her use of security forces and police to orchestrate the abduction, torture, and murder of hundreds of activists. However, Hasina denies the allegations, claiming political persecution. Yunus also criticized the "House of Mirrors," a secret jail where detainees were allegedly tortured and murdered, calling it "the ugliest thing" he had ever seen.





After Ten Days of Decline, Markets Bounce Back: Tariff Optimism Fuels Rally, Sensex +740, Nifty +254"

The ten-day losing streak has come to an end. Domestic markets gained heavily on Wednesday. They surprised investors with a spectacular rally. It finally closed at 73,730 with a gain of 740 points. The NSE Nifty, which opened at 22,073, reached a low of 22,067 and a high of 22,394. It rose by 254 points in total and closed at 22,337. The Nifty Bank rose by 244 points to settle at 48,289.

In the Nifty50, 46 companies gained while 4 lost. Metal, PSE, media, PSU bank, tourism, energy, defence, commodities and auto stocks were the top gainers. Adani Ports, Tata Steel, Adani Enterprises, Mahindra and Mahindra were the top gainers. Bajaj Finance, IndusInd Bank, HDFC Bank and Shriram Finance were the biggest losers.



SEBI Eases Nomination and Asset Transmission Rules

 $T^{\text{he Securities and Exchange}}_{\text{Board of India (SEBI) has}}$ introduced a new circular to streamline the nomination process and asset transmission procedures in the Indian securities market. The updated guidelines aim to provide greater flexibility and ease for investors, particularly those with single-holding accounts.

Under the new regulations, investors with single-holding demat accounts now have the option to opt out of nomination both online and offline. Depository Participants (DPs), rather than the Depositories themselves, will facilitate the online opt-out process for both new and existing investors.

Additionally, the new rules offer more flexibility for investors. Nominees can now be changed an unlimited number of times, providing greater control over the nomination process.

Transmission



of Assets Made **Simpler**

SEBI has also revised the transmission of assets rules for joint account holders. In the event of a joint account holder's death, the assets will automatically be transferred to the surviving joint holders without the need for fresh Know Your Customer (KYC) verification. However, the existing KYC must be updated to complete the process.

Surviving holders will also have the opportunity to update key details, such as their ad-

dress, mobile number, email, and bank account information during the asset transmission process.

Phased **Implementation**

The new rules will be implemented in a phased manner, starting from March 1, 2025, and are expected to conclude by September 2025. These changes are set to make the securities market more accessible, efficient, and investor-friendly.

Banksy's Reimagined The Singing Butler Sells for \$5.5 Million at Auction



Arare reimagining of Jack Vettriano's iconic painting "The Singing Butler" by street artist Banksy fetched nearly £4.3 million (\$5.5 million) at a Sotheby's auction in London on Tuesday. The sale of the piece, titled "Crude Oil (Vettriano)," came just a day after the announcement of the death of Scottish painter Jack Vettriano, aged 73.

Vettriano's original "The Singing Butler" depicts a couple dancing on a windswept beach, accompanied by a butler and maid holding umbrellas. It became a commercial sensation after it was sold in 2004 for £744,800, setting a Scottish auction record. The image also went on to become the UK's best-selling print reproduction, outselling works by Monet and Van Gogh.

Banksy's version, however, flips the romantic narrative into a stark environmental commentary. In "Crude Oil (Vettriano)," often dubbed "Toxic Beach," the artist adds a sinking oil tanker and two men in hazmat suits unloading toxic waste onto the beach. The piece critiques pressing issues like pollution, environmental damage, and the capitalist-driven destruction of nature.

The artwork was sold by Mark Hoppus, bassist for the band Blink-182, who had purchased it years earlier. Hoppus, speaking at the auction, noted that his family had deeply appreciated the work but hoped to use some of the proceeds to support up-andcoming artists. He also pledged a portion of the sale's proceeds to Los Angeles-based medical charities and the California Fire Foundation, following the wildfires in the state earlier this year.

Banksy's "Crude Oil (Vettriano)" was first exhibited in his 2005 show "Crude Oils: A Gallery of Remixed Masterpieces, Vandalism, and Vermin." Sotheby's described the work as "more relevant today than ever" due to the increasing frequency of environmental disasters.

Meanwhile, tributes have poured in for Vettriano, whose work resonated with fans around the world, despite being rejected by some art critics.

Social Media Giants Urge Australia to **Reconsider YouTube Exemption for** Children's Ban

Cocial media giants, including Meta Platforms (owner of Facebook and Instagram), Snapchat, and TikTok, have called on the Australian government to reconsider its decision to exempt YouTube from new laws that restrict social media echoed this sentiment, calling for fair and impartial applicaaccess for children under the age of 16. 
Under the current law, YouTube is exempted from the ban, as it is seen as a key educational tool and is the only platform permitted for children when part of a family account with parental supervision rights. However, Meta, along with TikTok and Snapchat, argues that YouTube should not be exempt, pointing out that minors using the platform are exposed to the same risks as other social media sites. YouTube, like its competitors, offers algorithmic content recommendations, social interaction features, and potential exposure to harmful content.

Meta expressed its concerns in a blog post, stating that You-Tube's exemption contradicts the stated purpose of the legislation. It called on the government to ensure that the law is applied equally to all social media services, urging a consistent approach across the industry.

TikTok raised similar concerns, arguing that the decision to

exempt YouTube is "illogical, anticompetitive, and short-sighted." The company urged the government to ensure that no platform receives preferential treatment. Likewise, Snapchat

alarms about YouTube, arguing that the platform can expose children to addictive and harmful content, including material that can be just as dangerous as what is found on other social media sites. With increasing scrutiny on how social media affects young people, these companies are urging Australia to revise its approach to ensure a level playing field.



PepsiCo vs Coca-Cola: The Latest Chapter in the Cola Wars



The rivalry between Coca-Cola and PepsiCo, two of the world's leading beverage giants, has flared up again with a new advertising clash. PepsiCo India recently launched its "Anytime is Pepsi Time" campaign, directly taking aim at Coca-Cola's "Half-Time" campaign in the context of the ongoing ICC Champions Trophy tournament.

Coca-Cola's "Half-Time" campaign, which debuted a month ago across TV and digital platforms, positions the drink as the ideal beverage to enjoy during half-time breaks of cricket matches. In contrast, PepsiCo has cleverly flipped the script, urging consumers to enjoy Pepsi "any time" — emphasizing that no pause is necessary to savor the refreshment.

Pepsi's latest campaign evokes nostalgia for its iconic 1996 "Nothing Official About It" ad campaign, which starred cricket legends like Sachin Tendulkar, Vinod Kambli, and Mohammad Azharuddin. At the time, Pepsi boldly took on Coca-Cola's official sponsorship of the cricket World Cup, with the

tagline suggesting that Pepsi was the drink for the people, not the official sponsors. "Nothing Official About It" became a cultural moment, and PepsiCo is clearly trying to channel that same effortless cool with its new campaign. The rivalry between Coca-Cola and PepsiCo is one of the most storied in advertising history. The 'Cola Wars' reached their peak in the 1980s, with Pepsi launching the famous "Pepsi Challenge" — a blind taste test where consumers preferred the sweeter taste of Pepsi over Coke. In response, Coca-Cola famously introduced "New Coke" in 1985, only to face backlash when consumers demanded the return of the original formula, which was rebranded as "Coca-Cola Classic."

While both brands have histories dating back to the late 19th century — Coca-Cola launched in 1886 and Pepsi in 1893 — their rivalry continues to fuel creative marketing and bold advertising moves, with each trying to outdo the other in the battle for global domi-

School In England Removes Mirrors From Toilets To Get Students Back In Class



Aschool in England has sparked controversy by removing mirrors from its toilets to address what it sees as an issue with students spending too much time in the restrooms. Grant Edgar, headteacher of William Farr Comprehensive in Welton, explained that the decision was made to prevent students from gathering in large groups and potentially delaying their return to class.

According to Mr. Edgar, mirrors in the toilets often encourage students to spend excessive time there, which affects punctuality and creates discomfort for others who need to use the facilities. "Mirrors can encourage students to spend too much

time in toilets often in large groups," he stated, adding that this could cause some students to feel uncomfortable.

The decision has sparked a variety of reactions from parents. Some have expressed frustration, with one parent commenting, "They're just mirrors, aren't they? We have mirrors at home, why can't we have them in school?" Others have called the move "silly," "a bit extreme," and "strange." Despite the criticism, Mr. Edgar defended the measure, emphasizing that the school had faced challenges during transition times and that the absence of mirrors would help keep students focused and on time for their lessons.

For students who require mirrors for medical purposes, the school has made provisions, stating they can request a mirror at the reception.

This is not the first time mirrors have been removed from school bathrooms for similar reasons. In January 2024, a middle school in North Carolina removed bathroom mirrors due to concerns about students using class time to create TikTok videos. In 2023, Christopher Whitehead Language College in Worcester replaced mirrors in girls' toilets with posters warning against the harmful effects of makeup.

While the decision has generated debate, the school maintains that the goal is to help students make the most of their learning time and reduce distractions.


