

**Karnataka Cabinet to Finally Discuss Long-Pending Caste Census Report on Friday**

After years of delay and political apprehension, the Karnataka cabinet will finally take up the contentious Socioeconomic and Education Survey report—commonly referred to as the state's caste census—in its meeting scheduled for Friday. The development marks a major turning point in the state's reservation discourse and could reshape Karnataka's political landscape ahead of upcoming elections.

The report, prepared by the Karnataka State Commission for Backward Classes, was submitted to Chief Minister Siddaramaiah in 2023, but has since remained sealed and unaddressed, despite mounting demands for transparency. Sources told The Indian Express that both the Chief Minister's Office and the Law Department have now cleared it for cabinet-level deliberation.

Originally commissioned in 2015 during Siddaramaiah's earlier ten-

ure, the survey was completed by 2017. However, its findings were shelved ahead of the 2018 Assembly elections over fears of political backlash. Successive governments—led by H D Kumaraswamy, B S Yediyurappa, and Basavaraj Bommai—also chose not to act on the report.

The Congress's move to revisit the caste census is seen as part of a broader national strategy to consolidate Other Backward Classes (OBC) support. At a recent Congress Working Committee meeting in Ahmedabad, Rahul Gandhi reportedly urged all state units to prioritise OBC welfare and visibility, signalling a shift in the party's electoral approach.

However, the decision could spark strong resistance from dominant caste groups like the Lingayats and Vokkaligas, who have previously voiced concerns over the survey's implications for the state's reservation structure and political balance. With Karnataka's caste dynamics historically influencing policy and politics, Friday's cabinet discussion will be closely watched by both proponents and opponents of the caste census. A decision to make the report public or act on its recommendations could trigger significant realignments in the state's social and political equations.

#### **Tumkur Railway Station May Be Named After** Shivakumar Swamiji - HM Parameshwara

Karnataka Home Minister Dr. G. Parameshwara announced on Thursday that the state government has received a formal proposal to rename the Tumkur railway station after the late Siddaganga seer, Dr. Shivakumara Swamiji. He stated that the matter will be taken up with Chief Minister Siddaramaiah and the government will proceed with issuing the official order after consultation.

Dr. Parameshwara visited

Siddaganga Mutt on Thursday and received the blessings of Siddalinga Swamiji. Speaking to reporters afterward, he said naming the railway station after Shivakumar Swamiji would be a fitting and permanent tribute to the seer's extraordinary contributions to education, social service, and spirituality. He made it clear that the government does not intend to delay the process and will act swift-

ly upon securing the Chief Minister's nod.

He also mentioned that Union Minister V. Somanna has already taken steps at the central level. According to Parameshwara, the Union government has approved the proposal to name the station after the spiritual leader, which clears a major hurdle in the renaming process.

The late Shivakumar Swamiji, fondly known as the

'Walking God,' is revered across Karnataka and beyond for his decades-long service in establishing educational institutions and supporting lakhs of students from disadvantaged backgrounds. The proposal to name the Tumkur railway station after him has received widespread public and political support, with calls growing louder over the past few months.

Parameshwara concluded by assuring that both the state and central governments are on the same page, and once the internal discussions are complete, an official announcement will follow. The move is seen as a long-awaited recognition of the seer's legacy, particularly in the Tumkur region where his influence remains deeply rooted.

#### **Karnataka HC Directs KPSC** to Let Pregnant Woman **Write Exam from Hometown**

In a strong endorsement of equitable access to public employment, the Karnataka High Court has directed the Karnataka Public Service Commission (KPSC) to facilitate a

pregnant woman's request to write her upcoming Group A recruitment exams in her hometown of Kalaburagi. The woman, in an advanced stage of pregnancy, had approached the court after being assigned examination centres in Bengaluru and Dharwad.

Justice Dr. Chillakur Sumalatha, in her order passed on April 4, emphasized the state's constitutional obligation to ensure equal opportunity, especially when it comes to accommodating deserving candidates with genuine constraints. The order was made public this week.

The petitioner, undergoing treatment and under strict medical supervision, was adagainst long-distance travel, making her assigned centres both risky and unreasonable. Her counsel highlighted the unfair burden such a directive placed on a woman in her condition.

The KPSC opposed the plea, citing logistical difficulties and the need for CCTV surveillance



and uniformity in exam procedures. However, the court dismissed these arguments, stating that the right to equality (Article 14), special protection for women (Article 15), and equal opportunity in public employment (Article 16) outweigh such administrative excuses. In a scathing remark, the court questioned the state's financial priorities, noting:

"Our country is spending crores of rupees for conducting elections and bye-elections... But, here is a case where the State submits that it cannot spend money to conduct examinations for a deserving candidate."

The judgment is being viewed as a landmark affirmation of reasonable accommodation, particularly for women during pregnancy, within the framework of state examinations and public employment rights. Following the court's direction, the KPSC is expected to make arrangements to enable the petitioner to appear for the April 15–19 exams from Kalaburagi.

#### **Baldota Group Enters Steel Sector** with ₹54,000-Cr Plant in Karnataka

The Karnataka-based Baldota Group, known for its presence in renewable energy, mining, shipping, and industrial gases, has announced a major foray into the steel industry with a massive ₹54,000 crore investment to establish a 10.5 million tonne (MT) capacity steel plant in the state.

Once operational, the greenfield project will become Karnataka's second-largest steel plant, generating lakhs of direct and indirect jobs, according to Nagaraj N B, Vice President of the Integrated Steel Project.

The group confirmed that environmental clearance has been obtained from the Ministry of Environment, Forest and Climate Change (MoEF&CC) for the first 3.5 MT phase, following a detailed Environmental Impact Assessment (EIA). Construction for the initial phase is set to begin this year.

The remaining 7 MT of capacity will be added in phases by 2030, aligning with the central government's vision of increasing India's steel-making capacity to 300 MT. India currently stands at 180 MT, and Baldota aims to contribute 10.5 MT towards the national target.

Highlighting sustainability, the proposed steel plant will integrate 295 MW of captive power generation from waste gases and fuels, promoting resource efficiency and reducing emissions.

In response to concerns raised by certain sections of civil society over the project's environmental impact, Baldota Group released its EIA report, which details pollution control, waste management, and ecological safeguards planned during the design stage.

With this bold move, Baldota not only diversifies its industrial portfolio but also positions itself as a significant player in India's steel manufacturing landscape, while addressing environmental responsibilities.



#### **MP PC Mohan Questions BBMP Over Bengaluru Tunnel Road Project**

Bengaluru Central MP PC Mohan has voiced strong opposition to the controversial 18-km tunnel road project proposed by the Bruhat Bengaluru Mahanagara Palike (BBMP), questioning both its public support and financial prudence. In a social media post, he demanded clarity on whether the project would be scrapped if the majority of citizens reject it in the ongoing BBMP opinion survey.

"BBMP says they'll incorporate public comments on tunnel roads. Citizens of Bengaluru have suggested dropping the project. If BBMP is sincere, then the project should be dropped, right? Who's accountable for the ₹14.2 crore spent on the DPR?" Mohan asked.

The ₹8,043 crore tunnel road project, which aims to connect Hebbal and Silk Board Junction, has faced mounting criticism since its announcement. Earlier this year, civic groups urged BBMP to conduct a thorough public consultation, citing concerns over urban planning, cost-effectiveness, and ecological impact.

#### **BJP's R Ashoka Slams Congress Govt, Cites 'Janaakrosha' as Proof** of Administrative Collapse

Leader of the Opposition in Karnataka, R Ashoka, launched a sharp attack on the Siddaramaiah-led Congress government, declaring that the ongoing 'Janaakrosha Yatre' across the state clearly shows a "collapse of administration" and the "limitless corruption" prevailing under the current regime. He referred public participation and sentiment during the Yatre as evidence of widespread discontent.

Addressing media on Thursday, Ashoka cited controversial remarks by the Chief Minister's economic advisor Basavaraj Rayareddy, who said Karnataka ranks highest in corruption, and Minister D Sudhakar, who admitted that the government was only now taking off after 20 months. Ashoka said, "These are certificates of failure from within their own ranks."

The 16-day Janaakrosha Yatre, launched by the BJP on Monday, is being carried out across all districts to protest against the Congress government's policies, including skyrocketing prices, alleged appeasement politics, and fund diversion meant for Dalit welfare.

Ashoka alleged that the ₹ guarantee schemes were unscientifically implemented, leading to an empty treasury and zero new development initiatives. He also questioned the commitment of ministers who, he claimed, rarely step out of Bengaluru and face public wrath when they do. "Even 'Janata Darshan' events ordered by the CM have been ignored by ministers," he added.

Further, he alleged that the administration has effectively shifted to Wayanad, linking recent decisions such as the permission for a Malayalam film shoot in Himavad Gopalaswamy Hills, a protected forest area, to influence from Priyanka Gandhi's Lok Sabha con-

stituency. Ashoka demanded a clarification from the government on who granted the film clearance, quoting a local forest official who stated permission was given at the "government level."

He concluded by questioning Siddaramaiah's political future, suggesting internal speculation of a leadership change is further destabilizing governance, with officials avoiding duties and public grievances going unheard.

#### **Environmentalists, Farmers, and Religious Leaders Unite Against Kalasa-Banduri Project**

Prominent environmentalists, farmers, and religious leaders from Karnataka and Goa gathered in Khanapur to voice strong opposition to the Kalasa-Banduri water diversion project, warning that the plan poses a grave threat to the Mahadayi basin and surrounding ecosystems.

The protest meeting, held under the banner 'Save Mhadei, Save Malaprabha, Save Khanapur Taluka, Save Rains', was marked by fiery speeches and resolutions to intensify resistance to the Karnataka government's push to acquire land for the project. Protesters accused the government of reviving a shelved diversion plan without proper environmental clearances, and in blatant disregard of ecological sensitivities in the Western Ghats region.

Veteran environmentalist Dilip Kamat warned that diverting tributaries like Kalsa and Bhandura to the Malaprabha River

Captain Nitin Dhond, a noted eco-activist, challenged claims that Mhadei waters were being wasted by flowing into the sea. "This narrative is scientifically flawed. Leading institutes like IISc and the Norwegian Institute for Water Research have warned against such diversions," he said, adding that deforestation and

are turning North Karnataka arid.

Farmers like Kallappa Ghadi, who have received land acquisition notices, vowed to fight back, stating that many gram panchayats, including Karambol, have passed resolutions opposing the project. Activist Sujit Mulgund declared, "We will resist this on legal, social, and political fronts. No land acquisition. No dams. No surrender."

A memorandum outlining their objections will be submitted to the Deputy Commissioner of Belagavi, urging authorities to halt the project and protect the Mahadayi basin for future generations.

#### Ballari MLA B Nagendra, **Two Others Convicted in Cheque Bounce Case**

The 42nd Additional Chief Metropolitan Magistrate (ACMM) court in Bengaluru convicted Ballari MLA and former minister B Nagendra, along

with his associates Anil Rajashekhar and Chundur Bhaskar, in a cheque bounce case filed by VSL Steels Limited. The trio has been ordered to pay a fine of ₹1.25 crore, failing which they will each face one year of imprisonment. The case traces back to a prolonged financial dispute dating to 2013 between VSL Steels and the three individuals, who are partners in BC Infrastructure and Resources. As part of a legal settlement, the firm issued a cheque for ₹1 crore in 2022, which later bounced, prompting VSL Steels to initiate legal proceedings under the Negotiable Instruments



Act. Presiding Judge K N Shivakumar, who heads the special court for cases involving sitting and former legislators, delivered the judgment after examining the evidence and ruled in favour of the complainant. The total dues owed by the firm amounted to ₹2.53 crore, of which the bounced cheque was a partial payment. B Nagendra is already under scrutiny in the Karnataka Maharshi Valmiki Scheduled Tribes Development Corporation scam, where he has been named as one of the accused. This conviction adds to his growing legal troubles and could have further political and legal implications.

# Floating Gardens to Beautify Lalbagh Lake

In an effort to rejuvenate the iconic Lalbagh lake in Bengaluru, the Karnataka Horticulture Department has begun work on installing floating gardens to improve both the water quality and the lake's visual appeal. The department has partnered with an external agency to install 22 floating gardens, each built on PVC-pipe bases, strategically placed along the periphery of the 30-acre lake. So far, nearly 80% of the frames have been set up, and officials have announced a 25-day deadline to complete the rest of the work, which includes finalizing the structures, planting saplings, and releasing the completed gardens into the water.


The floating platforms are being constructed in two sizes—12 by 15 feet and 6 by 4 feet—and each will hold between 70 and 300 saplings of Canna Indica, a plant chosen for its cost-effectiveness, water-friendly nature, and ability to bloom throughout the year.

According Jagadeesh, Joint Director of Horticulture (Parks and Gardens), Lalbagh, Canna Indica is especially suitable because its roots absorb nutrients directly

from the water once submerged, playing a crucial role in natural water purification. The initiative, entirely funded by the implementing agency, is expected to not only clean the lake but also add to its beauty with floating gardens featuring differently coloured plants.

These colourful arrangements will help suppress algal growth and attract native bird species such as waterhens, contributing to biodiversity around the lake. Jagadeesh added that the saplings are expected to take around three to four months to grow into a lush, bushy state, at which point flowering will begin, transforming the lake into a vibrant and ecologically balanced space. #### **Sira Airport May** Not Be Viable

Despite growing political support for an international airport at Sira in Karnataka's Tumakuru district, State Infrastructure Minister M B Patil has indicated that the proposal may not be viable as a second international airport for Bengaluru.

While Home Minister G Parameshwara and several legislators across party rga districts rather than lines have endorsed the functioning as a viable idea, Patil clarified that international gateway for if the airport were established in Sira — located about 120 km from Bengaluru — it would more likely serve as a district or regional airport rather than an international one linked to the state capital. The campaign for the Sira airport has been led by senior Congress leader and MLA T B Jayachandra, and has received backing from Union Minister of State the shortlisted sites and and Tumakuru MP V Somanna.

However, the state government has already identified and evaluated three alternative locations for Bengaluru's second airport: two on Kanakapura Road near Harohalli and one on Kunigal Road in Nelamangala. These sites have recently been inspected by a team from the Airports Authority of India (AAI). Patil, while acknowledging Jayachandra's seniority and contribution to the campaign, emphasized that an international airport must be strategically positioned to serve Bengaluru efficiently. In his view, Sira's distance and location make it more suitable for addressing the air travel needs of Tumakuru and Chitradu-Bengaluru.

This distinction is critical, as the demand for a second international airport stems from the need to reduce congestion at Kempegowda International Airport and support Bengaluru's expanding aviation and logistics infrastructure.

With expert evaluations already underway at the AAI involved in technical assessments, the state government appears to be leaning towards locations closer to Bengaluru's existing urban sprawl. As deliberations continue, the Sira proposal may still find merit as a regional hub, but is unlikely to take off as the state capital's next international air terminal.

# **Tipping Turns Costly for Auto Rides**

Bengaluru's auto rickshaw commuters are feeling the pinch as tipping becomes a norm before even securing a ride, turning daily travel into a costly and frustrating experience. Ride-hailing apps now encourage users to add tips upfront—often before searching for available drivers—promising quicker matches, especially during peak hours. However, commuters report that even with rising tip amounts, from Rs 30 up to Rs 50 on busy routes, wait times remain long, sometimes even during off-peak hours.

Rijul Ballal, a citybased psychologist, noted that the system used to check for autos first before asking for a tip if no one accepted the ride, but now it prompts users to tip in advance, making it harder to book without one. Swathi B, a chartered accountant commuting between Race Course Road and Malleswaram, shared that despite offering tips of Rs 10-20, she faces cancellations and delays, particularly in the mornings. Ride aggregators have remained silent on the issue, offering no response to queries.

In May 2024, the Karnataka High Court dis-



missed petitions by these platforms that attempted to challenge a 2022 government notification capping app-based auto fares to no more than 5% above this "tips before trips" regulated rates. With di-

rect fare hikes restricted, the apps appear to be using tips as a workaround. Mobility expert Sathya Arikutharam criticized model, saying it obscures

real-time availability by withholding location data from both drivers and manufacturing a sense of scarcity and nudging passengers toward tipping more.

Manjunath, president of the Adarsh Auto Union, confirmed that many drivers now prefer accepting only high-incentive rides, leading to selective service and further inconvenience. As this opaque tipping model becomes standard practice, commuters are left to navigate not just traffic, but also unpredictable pricing and availability, all while paying extra just to get mov-

#### **BWSSB Hikes Water Tariffs After 11 Years**

After more than a decade, the Bangalore Water Supply and Sewerage Board (BWSSB) has officially announced a water tariff hike, marking the first such revision in 11 years.

The change, aimed at addressing the utility's rising financial burden, will take effect from the next billing cycle and is set to be formally notified on April 10. BWSSB Chairman Ram Prasath Manohar emphasized that the revision was designed to manage operational costs without imposing a heavy burden on the public.

Currently, BWSSB incurs a monthly expenditure of around ₹200 crore, while revenue collection remains at just ₹130 crore,



monthly deficit of ₹70 crore. Under the new system, domestic users will be charged on a slab basis, beginning at 0.15 paisa per litre for usage up to 8,000

leading to a significant litres and reaching 1 paisa bulk rate. per litre for consumption exceeding 1 lakh litres. A is being applied to highrise (domestic-HR) users, replacing the earlier flat

In this category, users consuming up to 2 lakh similar tiered structure litres will pay 0.30 paisa per litre, with charges gradually increasing to 1 paisa per litre for higher

sanitary charges for water drawn from borewells and public sources have also seen a hike — ₹30 more for domestic users and ₹125 more for non-domestic consumers. The move follows years of financial strain and increasing infrastructure costs for the board, especially in the face of Bengaluru's rapidly expanding population and growing water demands.

Officials hope this new pricing structure will not only help in bridging the revenue gap, but also promote judicious water usage among consumers. While BWSSB assures that the impact on the average household will be minimal, the long-overdue hike signals a shift toward sustainable water management in the city.



# Infosys Employee Moonlights as Bike Taxi Rider

# Heatwave Hits North India Early

Summer has made an early and intense entry into northern India, with Punjab, Haryana, and Chandigarh experiencing soaring temperatures in the first week of April well ahead of the usual seasonal trend. According to the India Meteorological Department (IMD), this year is projected to be hotter than the last, and signs of that are already visible, with Chandigarh recordhigher-than-usual temperatures for early April. Senior Meteorol-

ogist Surendra Pal from the Chandigarh Meteorological Center noted that last year such heat was felt only after April 15, but this year, the mercury has risen unusually early. Although a brief period of pleasant weather may offer some temporary relief, heatwave conditions are likely to dominate the region soon. The IMD has forecast a heatwave in Haryana, Punjab, and Rajasthan, with partly cloudy skies and possible rain, thunderstorms, or duststorms in Rajasthan on April 11 and 12, and similar conditions expected in Punjab and Haryana over the next few days. Despite the presence of a Western Disturbance, experts warn it won't be enough to counter the rising heat. Authorities have issued a public advisory urging people to stay indoors unless necessary, remain well-hydrated, wear light and loose-fitting clothes, and minimize direct exposure to the sun. The elderly, children, and those with health conditions are advised to take extra precautions during this period. Light rainfall is expected in parts of Haryana on April 10 and 11, while Punjab may see similar scattered weather activity from April 10 to 13, though these are not likely to bring lasting relief. With temperatures peaking unusually high, the IMD has stressed the importance of community awareness and personal safety to prevent heat-related illnesses. The sudden temperature spike highlights growing concerns over shifting weather patterns and the broader impact of climate change on regional climates.



## **ED Arrests Ex-Bank Chief in Fraud**

In a significant development, the Enforcement Directorate (ED) on Wednesday arrested R M Manjunatha Gowda, the former chairman of the Shimoga District Co-operative Central Bank, in connection with an alleged ₹63 crore financial fraud. The arrest was made under the Prevention of Money Launder- documents and digital reing Act (PMLA), a day after cords that substantiated the ED conducted raids at various locations in Bengaluru and Shivamogga districts of Karnataka as part of its investigation into irregularities at the bank's City Branch. Following his arrest, Gowda was produced before a special court in Bengaluru, which ordered a 14-day ED custody. According to the federal agency, the largescale misappropriation of funds at the City Branch was primarily executed by the branch manager, B Shobha, allegedly under Gowda's directions. The ED stated that the fraudulent activities involved systematic financial manipulation and serious breaches of banking pro-

tocols. The agency further noted that the scale of the irregularities pointed to a deeper nexus and misuse of authority at senior levels within the bank. While neither Gowda nor Shobha, nor their legal representatives, could be reached for a response to the allegations, the ED maintained that the evidence gathered during searches included crucial their claims. The agency's investigation is ongoing, and more arrests could follow as the probe unfolds. This case has stirred political and financial circles in Karnataka, as co-operative banks play a significant role in rural credit and local financial ecosystems. The ED's action underscores a broader crackdown on financial misgovernance and irregularities in the co-operative banking sector. As the investigation progresses, it is expected to cast a spotlight on internal audit failures and regulatory lapses that allowed such a large fraud to take place undetected for an extended period.

# Bangladesh's New Regime Must Tread Carefully

The evolving political landscape in Bangladesh following the ouster of Sheikh Hasina has led to a perceptible strain in India-Bangladesh relations, particularly in light of recent diplomatic exchanges. At the BIM-STEC summit in Bangkok on April 4, a meeting between Indian Prime Minister Narendra Modi and Bangladesh's Interim Adviser stirred controversy, echoing past instances where bilateral talks at the level of foreign ministers and secretaries have been followed by Bangladeshi press briefings emphasizing contentious issues. These post-meeting statements often highlight Bangladeshi demands while downplaying or outright rejecting Indian concerns, fostering a narrative of Dhaka "standing up" to New Delhi. This approach appears to be aligned with the growing anti-India sentiment reportedly prevailing in parts of Bangladesh's new political order. With the Jamaat-e-Islami allegedly exerting significant influence over



witnessing shifts that challenge its foundational secular ethos. These include calls for a revised constitution, efforts to push for an Islamic state, increased hostility toward minorities, renewed ties with Pakistan, and attacks on India's traditional diplomatic and cultural part-

At a time when South Asia's stability is already under stress, any reckless political posturing or ideological regression could invite economic, diplomatic, and strategic consequences that Bangladesh can ill afford.

# **India-China Tensions Demand Strategic Prudence**

India's evolving relationship with China demands far more than diplomatic pleasantries, argues former National Security Advisor M.K. Narayanan in his analysis of the persistent geopolitical unease between the two Asian giants. Under President Xi Jinping, China has abandoned the relatively conciliatory approach of Deng Xiaoping and is instead leaning into a narrative of historical grievance, seeking to reassert its position as a dominant power with ambitions rooted in the past. This self-perception as a "wronged civilization" fuels aggressive maneuvers along its borders, especially with India, as Beijing increasingly invokes the outdated frontiers of the Qing Dynasty to justify present-day territorial claims. Incidents like the border clashes in Depsang (2013), Demchok (2016), Doklam (2017), and Galwan (2020) are not isolated acts but part of a larger strategic blueprint to pressure India into accepting a skewed status quo. Despite seemingly cordial exchanges between Indian and Chinese leaders, Narayanan warns that such diplomatic warmth must be treated with skepticism, particularly when it lacks substantive shifts in behavior from Beijing. While much of the world may interpret these symbolic gestures as signs of a thaw, India—having faced the brunt of China's

take sentiment for sincerity. The global community's surprise at recent bilateral overtures only underscores its detachment from the ground realities of Sino-Indian tensions. India, Narayanan suggests, should draw lessons from its past misreadings and adopt a pragmatic approach rooted in strategic preparedness rather than optimistic diplomacy. The relative calm during Hu Jintao's leadership, which hinted at a more balanced and stable relationship, now appears to have been a fleeting interlude rather than a long-term trajectory. In contrast, the current Chinese regime's assertive policies call for India to recalibrate its defense, diplomatic, and economic strategies. Multilateral coordination, military modernization, and internal resilience must become pillars of India's China policy, ensuring that any dialogue is backed by deterrence. Narayanan emphasizes that for genuine peace and cooperation to emerge, China must offer more than rhetorical goodwill—it must prove through consistent actions that it respects the sovereignty and strategic autonomy of its neighbors. Until then, India must proceed with caution, guided by historical experience and grounded in realism. As he aptly concludes, it will take far more than lofty words for the "Elephant and the Dragon" to truly dance in harmony on the world stage.





# From One Democracy to Another: A **Cautionary Reflection**

In this stirring open letter titled An Open Letter from India to America, author Omair Ahmad extends a heartfelt and sobering message across the Atlantic, blending empathy with caution as he reflects on the political descent of two of the world's largest democracies. Addressing Americans not as distant observers but as kin — as friends, colleagues, and kindred spirits — Ahmad draws parallels between India's current democratic backsliding and the turmoil gripping the United States. He writes not in judgment but in solidarity, recounting how India too believed its democracy was indestructible, rooted in its hard-won independence from colonialism and bolstered by decades of people-powered movements. Yet, this illusion crumbled as the country found itself spiraling into authoritarianism and exclusion, and now sees similar patterns emerging in America. The letter points out a harsh truth: that freedom for all inevitably threatens those who built their identity and privilege on the subjugation of others. Ah-

mad reminds readers that every time a society widens its promise of equality, it also disarms those who benefited from inequality — and in retaliation, these forces often cloak themselves in regressive symbols like masculine dominance, casteism, racial segregation, and fascism, which are not alien but interconnected through shared colonial legacies. He invokes the wisdom of Lincoln — "a house divided against itself cannot stand" — as both warning and lament, underscoring that the conflict is not one of policy but of moral foundations: between those who believe in justice and those who do not. The letter ends not with despair, but with an implicit call to remember the value of solidarity, to honor the difficult and incomplete journey of democracy, and to remain vigilant against the allure of exploitation disguised as power. In doing so, it becomes not just a message to America, but a mirror for India — and perhaps a guidepost for all democracies grappling with their contradic-







## **'Kasab Was Served Biryani': Piyush Goyal Slams Congress**

Union Minister Piyush Goyal has reignited a political controversy by claiming that 26/11 Mumbai terror attacker Ajmal Kasab was "served biryani" during the Congress regime. His remarks come amid the extradition of 26/11 plotter Tahawwur Rana to India from the United States.

Speaking at Mumbai's Taj Palace Hotel, one of the sites attacked during the 2008 terror strike, Goyal accused the previous Congress-led UPA government of failing to take strong action against the terrorists. "During the Congress government, terrorists attacked this very hotel where we are standing. People died here. However, Congress did not do anything to punish the terrorists. The arrested terrorist Kasab was served biryani," Goyal said.

Tahawwur Rana, 64, was brought to India on Thursday after the US Supreme Court rejected his final plea against extradition. He faces trial in India for his alleged involvement in planning the deadly attacks that killed over 170 people.

While Goyal's biryani remark stirred headlines, it is worth noting that former public prosecutor Ujjwal Nikam had earlier clarified in 2015 that the story about Kasab being served biryani was fabricated. "Kasab never demanded biryani and was never served by the government. I concocted it just to break an emotional atmosphere which was taking shape in favour of Kasab during the trial," Nikam

Despite the clarification years ago, the narrative continues to be invoked in political debates.

Goyal further said, "It is because of Prime Minister Narendra Modi's determination that such terrorists are being brought to justice. Those who harm our country will not be spared. Tahawwur Rana will now face trial and be punished under Indian law." Rana's extradition marks a significant step forward in India's efforts to prosecute those involved in the 2008 attacks.

# CJI Khanna to hear pleas against Waqf Act on April 16

- 10 petitions to be heard by a three-judge Supreme Court bench
- Petitioners include AIMIM MP Owaisi, A Raja, Amanatullah Khan
- Act faces challenge for alleged violations of religious rights

A bench led by Chief Justice of India Sanjiv Khanna, along with Justices PV Sanjay Kumar and KV Viswanathan, will hear 10 petitions challenging the Waqf (Amendment) Act, 2025 on April 16. The matter, listed as item 13, involves a range of petitioners including political leaders and religious organisations.

The lead petition was filed by AIMIM MP Asaduddin Owaisi, who called the Act "manifestly arbitrary" and alleged that it discriminates based on religion while violating the Shariat Act. Owaisi argued it strips the Muslim community of the right to manage its own religious institutions.

Among others who moved the top court are DMK MP A Raja, AAP MLA Amanatullah Khan, All India Muslim Personal Law Board (AIM-PLB), Indian Union Muslim League, Jamiat Ulama-i-Hind, Samastha Kerala Jem-iyyathul Ulama, and NGO Association for Protection of Civil Rights.

The DMK, in its petition, stated that the Act was passed despite widespread opposition and without proper consideration of objections raised in the Joint Parliamentary Committee (JPC). The party emphasized the law prejudices the rights of 50 lakh Muslims in Tamil



Nadu and 20 crore Muslims across India. In a press release, AIMPLB spokesperson SQR Ilyas said the amendments infringe upon Articles 25 and 26 of the Constitution, which guarantee the freedom to manage religious and charitable institutions. He accused the government of attempting to assume full control of Waqf properties, thus marginalizing the Muslim community.

The Jamiat Ulama-i-Hind termed the Act a "dangerous conspiracy" against religious freedom and a direct attack on the constitutional values of equality and religious rights. Similarly, Samastha Kerala Jamiath ul Ulema, a Sunni Muslim clerics' body, labelled it a "blatant intrusion" into religious affairs.

AAP MLA Amanatullah Khan, in his plea, asked for the Act to be declared unconstitutional, citing violations of Articles 14, 15, 21, 25, 26, 29, 30 and 300-A of the Constitution.

The Centre has filed a caveat in the Supreme Court, seeking to be heard before any interim orders are passed on the matter.

The Waqf (Amendment) Bill, 2025, passed by Parliament and signed by President Droupadi Murmu, officially came into force on April 8, 2025, as per a notification from the Ministry of Minority Affairs. The bill was passed in the Lok Sabha with 288 votes in favour and 232 against, while the Rajya Sabha passed it with 128 votes supporting and 95 opposing.

Earlier, Prime Minister Narendra Modi had hailed the Waqf Bill as "another major solid step towards social justice."

#### STahawwur Rana Extradited, Arrested in Delhi

#### **Centre Hikes Midday Meal Cost**

Centre to Bear ₹954 Crore Extra as PM-POSHAN Costs Rise Due to Inflation The Union government will bear an additional financial burden of ₹954 crore in the upcoming financial year 2025–26 due to a 9.5% hike in food material costs under the PM-POSH-AN scheme, formerly known as the Midday Meal Scheme. The Ministry of Education announced this adjustment in response to rising food inflation, aiming to ensure continued nutritional support for schoolchildren.

Effective from May 1, 2025, the per-student per-day material cost for balvatika (anganwadi) and primary school children will increase from ₹6.19 to ₹6.78. For students in upper primary classes, the rate will go up from ₹9.29 to ₹10.17. This increase is expected to improve the quality of meals provided to children in government and government-aided schools across the country. The PM-POSHAN scheme plays a crucial role in addressing classroom hunger, improving nutritional levels among children, and encouraging school attendance, especially in underprivileged communities. The scheme covers over 11 crore children in more than 11 lakh schools and anganwadi

centres across India. The Education Ministry noted that the revision is done annually based on the Consumer Price Index for Industrial Workers (CPI-IW), ensuring that the scheme adapts to economic changes. The last major revision was implemented in 2022. The additional expenditure will be entirely borne by the Central government, without passing the burden onto states. This move reflects the Centre's commitment to the welfare of schoolchildren and the continued success of one of the world's largest school feeding programmes.

Experts have welcomed the hike, calling it necessary and timely, but many also argue that further enhancements in infrastructure, meal quality, and nutritional diversity are needed for long-term impact. Advocacy groups have also urged the government to consider increasing allocations for eggs, milk, and other protein-rich items.

With this adjustment, the government aims to sustain its nutrition goals and uphold the constitutional right to education and health for children from economically weaker sections. Further guidelines on the revised cost structure and implementation procedures are expected to be issued to states and UTs before the new rates take effect.

### **Opposition Slams DPDP Act Provision**

The controversial section, they argue, overrides a critical clause in the RTI Act—Section 8(1)(j)—which permits the disclosure of personal information if it is justified by larger public interest. The DPDP Act, which has already received Presidential assent, imposes a blanket prohibition on sharing personal data, even if it concerns public activity or interest. More alarmingly, the DPDP Act removes a vital proviso in the RTI Act that served as a transparency safeguard: "information which cannot be denied to Parliament or a State legislature shall not be denied to any person." According to the INDIA bloc, this change effectively places government actions beyond public scrutiny.

Congress MP Gaurav Gogoi condemned the provision as a "surreptitious, mischievous,


and malicious attempt" to weaken the RTI framework. "This is not just a technical amendment—it's a direct attack on the citizen's right to know and hold the government accountable," he said.

The joint memorandum addressed to Union Electronics and IT Minister Ashwini Vaishnaw urged an immediate rollback of the provision. Opposition leaders stressed that while protecting personal data is important, it should not come at the cost of weakening transparency laws that are essential in a democracy. Priyanka Chaturvedi added that the move could severely hamper journalistic investigations, whistleblower protections, and civil society efforts to expose corruption or misuse of power. "The RTI Act has been instrumental in empowering citizens. Diluting it, especially through another legislation, is both undemocratic and unacceptable," she remarked.

#### **China being dragged** into Ukraine war, says Zelensky

155 Chinese citizens reportedly fighting for Russia

Ukrainian President Volodymyr Zelensky has alleged that Russia is deliberately trying to "drag China into the war" in Ukraine, claiming that over 150 Chinese nationals have been recruited to fight against Ukrainian forces. Zelensky stated that Kyiv has the names and passport details of 155 such individuals and accused Beijing of being aware of the recruitment process.

"This is yet another indication that Moscow simply needs to drag out the fighting," Zelensky told reporters in Kyiv. "Such an overt involvement of Chinese citizens in combat operations on the territory of Ukraine is a deliberate step towards expanding the war."

The statement follows Ukraine's reported capture of two Chinese citizens in the eastern Donetsk region, a development that prompted fresh concerns about the extent of foreign fighters in Russia's ranks. Kyiv says it is prepared to release the captured Chinese nationals in exchange for Ukrainian prisoners of war currently held in Russia.

Zelensky clarified that he does not believe the Chinese government directly dispatched the fighters, but maintained that Chinese authorities were aware of the recruitment process—citing platforms like TikTok and other Chinese social media sites where Russian military recruiters allegedly promote enlistment.

A senior Ukrainian official also shared with AFP a document containing the names and passport details of 168 Chinese citizens allegedly serving in the Russian army, adding that further investigations are underway to iden-

China, however, rejected Zelensky's claims. Chinese Foreign Ministry spokesperson Lin Jian called the accusations "absolutely groundless" and reiterated that Beijing advises its citizens to avoid armed conflicts of any kind. "The Ukrainian side should correctly view China's efforts and constructive role in pushing for a political resolution to the Ukraine crisis," Lin said.

When asked about the development, Kremlin spokesperson Dmitry Peskov declined to comment. Meanwhile, China continues to position itself as a neutral party in the ongoing conflict, though its political and economic alignment with Moscow has drawn criticism from the West. NATO has labeled Beijing a "decisive enabler" of Russia's invasion.

Zelensky also mentioned that Washington views the presence of Chinese fighters on Ukrainian soil as "unacceptable," signaling rising concern within the US over China's indirect involvement. He further revealed that Kyiv is prepared to spend up to \$50 billion on American military equipment and will be holding discussions with a US delegation next week.

The controversy over Chinese nationals fighting for Russia adds a new dimension to the war and raises alarms about the global ramifications of prolonged conflict in Eastern Europe.

# India, UK fast-track FTA talks

Ministers reaffirm commitment to deeper trade and strategic ties during London dialogue

India and the United Kingdom have reaffirmed their commitment to strengthening bilateral relations and accelerating negotiations towards a Free Trade Agreement (FTA) and a Bilateral Investment Treaty. In a joint statement released on Wednesday, Indian Finance Minister Nirmala Sitharaman and UK Chancellor of the Exchequer Rachel Reeves emphasized that talks are "continuing at pace" with the goal of unlocking new opportunities for both economies.

The statement was issued during Sitharaman's six-day visit to the UK and Austria, during which she co-chaired the 13th India-UK Economic and Financial Dialogue (EFD) in London alongside Reeves.

"Both sides agree that a strong and robust UK-India relationship enhances the resilience of both economies, including through trade, macroeconomic cooperation, supply chain resilience and collaboration on global challenges, both bilaterally and multilat-



The India-UK FTA talks resumed earlier this year after an eightmonth pause. Major sticking points in the negotiations include the UK's planned Carbon Border Adjustment Mechanism (CBAM), set to begin in 2026, and differences on the mobility of professionals.

The UK side shared updates on its upcoming Industrial Strategy, with both countries seeing strong potential for collaboraerally," the joint statement read. tion in advanced manufactur-

ing, clean energy, life sciences, defence, financial services, and the creative sectors. The partnership aims to combine India's growing manufacturing capacity with UK's research and innovation ecosystem.

In a boost to strategic ties, both countries also expressed anticipation for the signing of the India-UK Defence Industrial Roadmap, which will bolster collaboration across key industrial sectors and enhance supply

chain integration.

In 2023-24, merchandise exports from India to the UK reached \$12.98 billion, marking a 13.3% annual rise. However, goods exports fell to \$8.4 billion, down 6.10%, according to Ministry of Commerce and Industry data.

Given the backdrop of shifting global trade dynamics and protectionist measures, India is seeking to deepen partnerships that can help it navigate future uncertainties and attract fresh investments.

The ministers also highlighted their cooperation in the G20 and global financial stability bodies such as the Financial Stability Board (FSB). They stressed the importance of working together on enhancing cross-border payments, climate-related financial risk management, and strengthening the non-bank financial intermediation (NBFI) framework. "We support the ongoing work...

to ensure a resilient, inclusive, and stable international financial system," the statement said, underlining the shared ambition to contribute to sustainable and equitable global economic growth.

#### Panama Rejects US military Base Proposal

Panama has firmly rejected the possibility of allowing the United States to reestablish military bases or defense sites within its territory, according to a statement made by Security Minister Frank Abrego during a joint appearance with US Defense Secretary Pete Hegseth.

"Panama made clear, through President Jose Raul Mulino, that we cannot accept military bases tial renewed US military presence or defense sites," Abrego declared, ending speculation over a poten-



in the Central American country. The statement came during Hegseth's official visit to Panama, where broader regional security cooperation and migration control were on the agenda. While no formal proposal for a military base had been publicly disclosed by the US side, Abrego's emphatic statement suggests Panama was responding to informal discussions or suggestions made behind closed doors.

Panama had hosted significant US military infrastructure in the past, most notably the Panama Canal Zone and Howard Air Force Base, until the complete withdrawal of American forces by the end of 1999 following the Torrijos-Carter Treaties. Since then, Panama has maintained a strong stance on sovereignty and neutrality regarding foreign military presence.

Observers see the Panamanian position as a reaffirmation of its longstanding foreign policy principle of avoiding entanglement in military alliances or hosting foreign troops, especially in a region where US influence has historically drawn both cooperation and criticism.

#### India Pulls Plug on Cargo Route for Bangladesh

has terminated the trans-shipment facility that allowed Bangladesh to export goods to third countries via Indian ports and airports. The decision, notified by the Central Board of Indirect Taxes and Customs (CBIC) on April 8, ends a trade route that had supported smooth cross-border flows since June 2020.

The now-rescinded circular had permitted Bangladeshi cargo to pass through Indian Land Customs Stations (LCSs) en route to Indian exit points. However, the CBIC clarified that cargo already

exit under the earlier procedure. In a significant policy shift, India The move comes amid rising trade tensions globally, with the US imposing fresh tariffs on countries including India and Bangladesh. Indian exporters, especially from the apparel sector, had been pressing for the withdrawal of the facility, citing reduced cargo space, rising freight costs, and airport congestion.

"Now we will have more air capacity for our cargo," said Ajay Sahai, Director General of the Federation of Indian Export Organisations (FIEO), welcoming the decision.



Apparel Export Promotion Council (AEPC) Chairman Sudhir Sekhri said daily Bangladeshi truckloads caused delays and inflated air freight charges at Delhi's IGI Airport. "This made Indian exports less competitive," he said.

Think tank GTRI Founder Ajay Srivastava warned the decision could disrupt regional trade logistics, particularly affecting landlocked nations like Nepal and Bhutan that depend on seamless movement through India and Bangladesh.

Under WTO rules, members are obligated to ensure free and efficient transit for goods to and from landlocked countries — a point that may surface in future trade dialogues.

The latest move reinforces India's intent to protect its own exporters while recalibrating trade priorities in the face of shifting global trade dynamics.

#### Aadhaar Act set for key amendments to align with DPDP Act, 2023

New Aadhaar app launched with secure, minimal data sharing features

The central government is planning to amend the Aadhaar (Targeted Delivery of Financial and Other Subsidies, Benefits and Services) Act, 2016 to bring it in line with the provisions of the Digital Personal Data Protection (DPDP) Act, 2023. The move aims to plug existing legal gaps, improve data privacy, and give citizens more control over their personal information, according to officials.

Union Electronics and IT Minister Ashwini Vaishnaw, in a video posted on X on Wednesday, said the government is focused on harmonizing the Aadhaar law with the DPDP Act by keeping "user interest at the centre." He emphasized the need for a new legal framework to streamline consent mechanisms and avoid repeated data sharing during authentication processes.

"There are variety of programmes and uses where citizens are asked for consent again and again, asked to provide their data every time and at different places, for authentication. We need to have a legal framework to avoid this and ensure citizens get access to services easily," Vaishnaw said.

Officials said the amendment will focus on introducing data minimization and data erasure provisions that are currently mandated by the DPDP Act but not strictly adhered to by agencies using Aadhaar authentication. They also noted that the language of the Aadhaar Act will be made more specific to prevent the reuse of Aadhaar data for unintended purposes.

The DPDP Act, passed by Parliament in August 2023, is yet to be fully implemented. Vaishnaw stated that the rules for the Act are nearly finalized and will be notified soon.

In line with the upcoming amendments, the



government on Tuesday also launched a new Aadhaar mobile application that enables residents to share only essential data while availing services. The app includes face ID authentication and supports digital verification through QR codes or requesting applications, eliminating the need for physical Aadhaar card photo-

Tech policy experts welcomed the move. "Amending the Aadhaar Act to integrate DPDP's principles would be crucial to reducing misuse and improving consent-based data use," said Dhruv Garg, partner at the Indian Governance and Policy Project. He also recommended limiting Aadhaar usage where not necessary.

In February this year, the government had expanded Aadhaar use by allowing private companies to perform Aadhaar authentication under the revised Aadhaar Authentication for Good Governance (Social Welfare, Innovation, Knowledge) Amendment Rules, 2025. This was aimed at easing access to services and preventing leakage of welfare benefits.

Officials underscored that these combined measures will help prevent misuse of Aadhaar data and promote better privacy practices in both government and private sector usage.

# BlackRock Bets Big On Adani With \$250 Million Investment

BlackRock, the world's largest asset manager, has become the biggest investor in a \$750 million private bond issuance by the Adani Group, acquiring nearly one-third of the offering. This marks Black-Rock's first private placement in India's infrastructure sector and a major show of confidence amid ongoing scrutiny faced by the conglomerate.

Sources familiar with the matter said the bonds, issued by Renew Exim DMCC—a wholly owned offshore entity of the Adani family—carry a tenure of 3 to 5 years. The capital will primarily finance the acquisition of ITD Cementation and other infrastructure-led growth initiatives.

The move comes even as Adani Group remains under the lens following a U.S. Department of Justice indictment last November in a bribery investigation. Despite this, BlackRock's participation signals it foresees no major operational risks for the group.

"Infrastructure is one of the most exciting long-term investment opportunities," BlackRock

This deal significantly expanded BlackRock's global presence in ports, power, and digital infrastructure—sectors that align closely with Adani's longterm focus.

Five other institutional investors, mostly American and European including funds managed by Sona Asset Management, also participated in the fundraising. The \$750 million issuance by Renew Exim is Adani Group's second major dollar bond transaction in 2024, following a \$200 million raise in February for its Austra-

The recent capital raise is also the largest since the DOJ probe came to light, and signals renewed international investor interest. The acquisition of ITD Cementation, a construction and engineering firm involved in projects such as JNPT and Vizhinjam port, strengthens Adani's infrastructure portfolio. The group had initially purchased a 46.64% stake from the promoters and added another 20.81% through an open offer. Adani officials view BlackRock's involvement as a strong vote of confidence in the conglomerate's financial and operational strength, despite recent headwinds.

#### **Audi Expands EV Network** To 6,500+ **Points Across** India

The Phase-II rollout alone added over 5,500 new charging points, strategically positioned along highways, in urban centers, and at key commercial hubs. With this expansion, the 'Charge My Audi' network now spans across 28 states and union territories, covering over 850 cities and 4,700+ locations.

Customers can locate and operate chargers using real-time features through the 'myAudi Connect' app, which includes route planning, charger availability, and start/stop func-

tions.

Commenting on the development, Mr. Balbir Singh Dhillon, Head of Audi India, said, "With over 6,500 charging points and a focus on DC fast chargers, we are enhancing convenience, reducing charging times, and expanding accessibility for our customers. The second phase marks a major step forward in enhancing the EV ownership experience."

# China Finds Drier Soil on

Tn a significant lunar discovery, Chi-**■**nese scientists have revealed that soil from the far side of the moon is drier than previously thought, containing less than 1.5 micrograms of water per gram—significantly lower than levels recorded on the near side. This insight, based on samples collected by China's Chang'e 6 mission, deepens our understanding of the moon's complex composition and geological history. The research team, led by Sen Hu from the Chinese Academy of Sciences, meticulously analyzed five grams of lunar material retrieved from the South Pole-Aitken Basin, one of the oldest and largest impact craters in the solar system. Using advanced electron microscopy, they examined 578 individual particles, identifying a stark difference in water content compared to samples from the near side. This dryness raises new questions about the moon's formation and the processes that have shaped its two faces over billions of years. Scientists emphasize that understanding the presence and distribution of water on the lunar surface is critical not only for unraveling the moon's evolutionary

story but also for future space exploration and potential colonization, where water could be a vital in-situ resource. While these early findings are groundbreaking, researchers caution that they are based on a limited sample size and stress the need for further collection missions to develop a more comprehensive picture. China's successful landing on the far side in 2024 marked a historic milestone in space exploration, as no other country had previously achieved such a feat. With countries like the U.S., India, and Russia also ramping up their lunar missions, the moon remains a focal point of international scientific rivalry and cooperation. As more data emerges from upcoming expeditions, including future Chinese missions, this discovery may influence the trajectory of lunar science, particularly regarding how water is stored and transported on the moon. For now, the findings suggest the moon's far side may hold more secrets than previously believed, and only through deeper exploration can humanity hope to fully understand our celestial neighbor's past—and its potential future.



# World's Largest Snake Gathering in Canada

 $E^{\rm very}$  spring, a remarkable natural event unfolds in Manitoba, Canada, where the Narcisse Snake Dens become the site of the world's largest snake congregation. Over 75,000 red-sided garter snakes emerge from limestone sinkholes after months of braving sub-zero temperatures underground. These dens, no bigger than a living room, offer insulation during the region's frigid winters that can plunge as low as -45°C, making them ideal hibernation shelters. As the weather warms, the snakes surface in vast numbers for their annual mating ritual, forming dense, swirling masses that blanket the ground in a mesmerizing, if somewhat spine-tingling, spectacle. The sheer scale of the gathering attracts thousands of visitors and scientists every year, turning the quiet Canadian landscape into a temporary wildlife tourism hub. The snakes—largely harmless to humans—entwine in what's known as "mating balls," where dozens of males compete for a single female, creating a chaotic but fascinating sight. Beyond the visual spectacle, new scientific research has uncovered surprising complexity in their behavior. A study published in \*Behavioural Ecology\* in late 2023 revealed that some species of garter snakes, like Butler's garter snakes, display social structures reminiscent of mammals, with groupings organized by age and sex. This challenges the longstanding belief that snakes are solitary creatures and opens new avenues



of research into reptilian social dynamics. The Narcisse Snake Dens not only serve as a critical ecological habitat but also as a living laboratory where scientists can study the interactions, communication, and survival strategies of garter snakes in large populations. For casual observers and researchers alike, this annual phenomenon is a rare and awe-inspiring example of nature's intricacy—an event where biology, survival, and spectacle converge. As concerns about biodiversity and climate change grow, the Narcisse snake gathering also stands as a reminder of the importance of preserving such unique ecosystems for future generations.


# Tabu, Vijay Sethupathi Join Forces
