


Caste Census Promise Will Be Fulfilled, Says CM Siddaramaiah

CM says caste census covered 98% Karnataka with scientific approach.

Vows to present caste census findings in Assembly, calls it a **Congress manifesto** promise.

Hits back at BJP's criticism, slams Shettar's remarks and Centre's fuel pricing policies.

Chief Minister Siddaramaiah reaffirmed his government's commitment of rural, 95% of urban to completing and presenting the caste census, terming it a scientifically conducted exercise covering 98% of Karnataka's rural and 95% of urban population. Speaking to media at Belagavi Airport, he said the census was a key promise in the Congress party's election manifesto and would be fulfilled without delay.

> Rejecting BJP's allegations that the caste census was unscientific, Siddaramaiah said, "The survey was carried out effectively with the help of thousands of schoolteachers. Though covering 100% is always a challenge, we have come very close to full coverage. The data will soon be presented in the Assembly."


> He added that the caste census is critical to assess the socio-economic, educational, and financial status of various communities. "A similar exer-

cise hasn't been done since 1931. Both the High Court and the Supreme Court have asked states to provide empirical data. This makes the caste census not just relevant, but necessary," the Chief Minister explained.

Targeting former CM Jagadish Shettar for calling the census ineffective, Siddaramaiah remarked, "Shettar lacks a basic understanding of how such surveys are conducted. He was unfit as Chief Minister and remains unfit as Opposition leader."

The Chief Minister also responded to the BJP's ongoing Janakrosha campaign against price hikes, questioning their moral authority to protest. "When the Centre itself has hiked petrol, diesel, and LPG prices, how can the BJP claim to care about inflation?" he asked. He pointed out that fuel prices have risen sharply despite international crude oil prices dropping to USD 65 per barrel nearly half the cost during UPA rule when rates touched USD 120 per barrel.

SIT Probe Must Include 60% Graft Charges Against Karnataka Govt - Basavaraj Bommai

BJP MP and former Chief Minister Basavaraj Bommai has demanded that the Special Investigation Team (SIT) proposed by the Karnataka government must also look into the "60 per cent corruption" allegations against the current Congress-led administration. Speaking to reporters in Bengaluru, Bommai said that contractor associations from the public works, excise, and electrical departments have openly accused the government of demanding up to 60 per cent commission for works.

The former CM responded strongly to the government's decision to constitute an SIT to investigate the "40 per cent commission" charges that were levelled against the previous BJP government. He insisted that the Congress government's alleged misdeeds over the past two years should also fall under the SIT's purview.

"In the last two years, multiple allegations have emerged against the present government, far worse than

what was claimed during our tenure. These serious 60 per cent commission charges cannot be ignored," Bommai said. He also demanded that the report of the commission constituted to examine the "false propaganda" about 40 per cent corruption during the BJP's rule be made public.

Highlighting the financial mismanagement, Bommai said, "The government doesn't even have funds to pay for completed projects. Though tenders have been awarded, contractors are reluctant to begin work due to delays in payment." He accused the government of crippling infrastructure development and questioned the sincerity of the Chief Minister Siddaramaiah and Deputy CM DK Shivakumar, who are now asking people to approach the Lokayukta if there are any commission-related complaints. Bommai's remarks come amid growing political friction in Karnataka, with the opposition stepping up its criticism of the state's governance and corruption record.

Trump Tariff Hits Karnataka Granite Exports, Containers Pile up at Chennai Port

The Karnataka granite industry has taken a major hit following the recent imposition of a 10% tariff by US President Donald Trump on Indian goods. Exporters say the move has led to container loads of granite piling up at the Chennai port, with shipments stuck and production disrupted across key quarrying districts. Chamarajanagar, known for its premium black granite used in monuments and tombstones, has seen over 50 quarries either halting or slowing production. Similar scenes are reported from Khanapur, Kalaburagi, Bagalkot, and Bidar. Quarry owners are staring at heavy losses, as each container now incurs an additional cost of approximately Rs 1.5

Quota Hike Likely for 'Backward' Groups Among Muslims, Lingayats in Karnataka

- · State panel recommends OBC quota rise from 32% to 51%

The Karnataka State Backward Classes Commission has recommended a substantial hike in reservations for various backward communities, including Muslims, Vokkaligas, and Lingayats, based on findings from the Socio-Economic and Educational Survey. The state cabinet, scheduled to meet on April 17, is likely to deliberate on the report and may constitute a cabinet sub-committee to examine the propos-

Headed by K Jayaprakash Hegde, the commission submitted its report to under the 2B category from 4% to 8%.



the state government, proposing a restructuring of the reservation system based on the population and degree of backwardness within each community. The proposals, if accepted, would raise the total reservation in Karnataka from 32% to 51%, surpassing the 50% ceiling imposed by the Supreme Court—thus requiring a constitutional amendment.

Key among the recommendations is an increase in the quota for Muslims

Similarly, the quota for Vokkaligas and their sub-sects under 3A could be raised from 3% to 7%, and for Lingayats and their sub-sects under 3B from 4% to 8%.

The report also suggests increases for other backward castes: a 6% hike under Category 1A, 12% under 1B, and 10% under Category II for various eligible groups. These moves aim to provide a more equitable share of reservation benefits in proportion to each community's socio-economic condition and population size.

The Siddaramaiah-led government may push the Centre to take up the issue through a constitutional amendment, given the legal constraints surrounding the 50% cap on quotas. The final decision, however, hinges on the upcoming cabinet discussion and potential political consensus.

Address Regional Imbalance, Curb **Corruption: Experts Urge Karnataka Govt**

Experts and political leaders are calling on the Karnataka government to adopt a balanced, development-centric approach to tackle regional disparity and systemic corruption. The demand gained urgency following remarks by Chief Minister's Economic Advisor and senior Congress leader Basavaraj Rayareddi, who flagged the poor quality of developmental works in Kalyana Karnataka and raised concerns about rampant corruption.

Rayareddi's statements, made during a meeting of the Regional Imbalance Redressal Committee headed by economist Prof Govind Rao, sparked political ripples but also cast a spotlight on long-standing governance concerns in



the state's most backward regions. Kalyana Karnataka continues to rank lowest in key development indicators, including education, healthcare, and per capita income, according to the Karnataka Economic Survey 2024–25. Districts like Yadgir, Kalaburagi, and Raichur fare poorly on the Human Development Index, while Bengaluru Urban and Dakshina Kannada lead the

The committee has been tasked with identifying the structural causes of regional imbalance, such as infrastruc-

ture gaps, historical neglect, and lack of private investment. Its findings are expected to guide future policy and will be submitted by the end of the year. Currently, 76 taluks fall below the state's HDI average of 0.573, and the Ka-

laburagi revenue region ranks lowest in per capita income and educational outcomes, including the recently announced II PU exam results. Experts emphasize the urgent need to boost industries and services in these districts. Prof Govind Rao underlined the importance of urban hubs in driving growth but stressed the foundational role of education and healthcare. He also warned that without proper implementation, even well-intended schemes would fail.

The Ministry of Finance has issued a clarification on the imposition of Goods and Services Tax (GST) on maintenance charges collected by Resident Welfare Associations (RWAs), following widespread confusion highlighted in a recent media report.

According to the official statement, GST at 18% is applicable only if two conditions are met: the maintenance charges exceed ₹7,500 per month per member, and the RWA's annual turnover crosses ₹20 lakh. If either condition is not met, GST is not applicable.

For residents owning multiple apartments, the ₹7,500 exemption is calculated per apartment. However, in cases where the maintenance fee exceeds ₹7,500, GST is charged on the full amount, not just the excess. For example, if maintenance is ₹9,000 per month, the 18% GST is applicable on the full ₹9,000.

The Ministry pointed out that this tax structure follows a decision made during the 25th GST Council meeting held on January 18, 2018, which had raised the exemption limit from ₹5,000 to ₹7,500 to benefit housing so-

In a move aimed at easing the burden on RWAs, the government also reminded stakeholders that RWAs are entitled to Input Tax Credit (ITC) under GST. This means they can claim credit on GST paid on purchases for goods like taps, pipes, and furniture, as well as services like maintenance and repair. Such benefits were not available in the pre-GST era under VAT, making GST relatively more favourable for RWAs managing large residential complexes.

The Ministry's clarification is expected to provide relief and clarity to thousands of housing societies and apartment owners across the country who were uncertain about their tax liabilities.

A controversial set of figures from the Karnataka Socioeconomic and Educational Survey (SES) – 2015, widely regarded as the state's caste census, has surfaced ahead of its official release. Shared by a Congress legislator, the data indicates that Muslims, at 12.87%, constitute the single largest community if treated as a homogenous group, while Scheduled Castes (SCs), when clubbed, make up the largest block at 18.27%.

The survey, conducted by the Karnataka State Backward Classes Commission under Kantharaju's leadership, covered 5.98 crore of the projected 6.35 crore population. About 37 lakh people, or 5.83%, were left out.

The figures reportedly split communities such as Lingayats and Vokkaligas into various sub-castes, which, according to sources, was due to participants preferring to identify themselves by their specific sub-caste during enumeration. For instance, the dominant Lingayat population was fragmented into categories like Panchamasali Lingayats (1.79%), Veerashaiva-Lingayats (2.99%), and smaller groups such as Ganiga, Jangama, and Nonaba Lingayats, reducing the perceived collective strength.

According to the leaked figures:

- **Muslims:** 76.99 lakh (12.87%)
- **Vokkaligas:** 61.68 lakh (10.31%)
- Veerashaiva-Lingayats: 66.35 lakh (11.09%)
- **Kurubas:** 43.72 lakh (7.31%)
- SC Left: 35.99 lakh (6.02%), SC Right: 34.98 lakh (5.85%), SC (**Others**): 19.82 lakh (3.31%)
- **STs**: 42.81 lakh (7.1%)
- **Brahmins:** 15.64 lakh (2.61%)


Communities like Billavas (1.04%), Edigas (0.80%), Besthas (2.12%), and Devangas (1.05%) were also identified separately. Notably, 3.32 lakh individuals (0.56%) chose to identify themselves as having "no caste." Jains and Christians made up 0.70% and 1.44%, respectively.

Cooperation Minister KN Rajanna refuted reports of a leak, stating the data was still under the government's control and would be officially tabled after the Cabinet meeting on April 17. "Constructive criticism will be welcome once the data is public," he said.

In Karnataka Two Booked for Illegal Stone Quarrying on Government Land

The Karkala town police have booked two individuals for illegal stone quarrying on government land in Karkala Taluk, Karnataka. The raids were conduct-



In the first case, Police Sub-Inspector Lohith Kumar CS, along with his team, raided government land located in Survey Number 181/1 of Jarkala. Two individuals were caught in the act, but upon noticing the approaching police vehicle, they fled the scene. Investigations later identified Surendra as the person behind the illegal quarrying. Authorities seized several tools from the site, including two iron crowbars and an iron chain. A case was filed against Surendra un-



In a separate incident, Police Sub-Inspector Shivakumar SR raided another quarry site at Survey Number 245 in Jarkala, Eralpadi village, where no workers were present. However, the site showed clear signs of illegal quarrying. Further inquiries revealed that Ramesh had been conducting quarrying activities for personal gain without the necessary permits. A case has been registered against Ramesh under similar charges. Both individuals face serious charges, and investigations are ongoing to gather further details.

Bhutai's Murder Sends Shock Waves Among Mangaluru Auto Drivers

The murder of Mohammed Sharif (52), popularly known as Bhutai, has deeply shaken the autorickshaw driver community in Mangaluru. Bhutai's body was recovered from a well in Kunjathur, within Manjeshwar police station limits, on Friday. A beloved figure among drivers, he was known for his jovial nature, discipline, and apolitical stance. "He was always smiling, never uttered a foul word, and treated everyone with respect," said Shivanand, a fellow driver at the Kottara Chowki stand. Bhutai hailed from Kolnad in Mulki and was a daily fixture at rickshaw stands across Mangaluru. "He was punctual, never overcharged, and always went back home before midnight," Shivanand added. Bhutai, who earned his nickname from his love for sardine fish, stood out for his neat khaki uniform and well-maintained vehicle. Many drivers suspect he was abducted by addicts posing as customers and murdered while en route home. The possibility of involvement by drug addicts, referred to as the "ganja gang," is being looked into. Kottara Chowki Auto Stand president Manoj Kodikal described the murder as "a jolt" to the entire fraternity. Another driver, Suresh from Bikarnakatte, angrily demanded immediate arrest of the perpetrators, calling them nayilu (dogs) in Tulu. "We are scared now," he said, echoing growing fears about driver safety, especially at night or in isolated areas. The incident has also caught the attention of the Democratic Youth Federation of India (DYFI). DYFI district president B K Imthiyaz and secretary Santhosh Bajal, in a joint statement, demanded a full investigation into the murder and urged that the culprits be brought to justice without delay. They also sought maximum compensation for Sharif's family.

They recalled similar previous cases where auto drivers like Idayath in Natekal, Lancy in Tokkottu, and Rifai in Nettakere were killed under suspicious circumstances. "Auto drivers are increasingly vulnerable amid the district's communal politics," the statement added.

MCC to Join Hands with BPCL to Make Mysuru a Zero-Waste City

Mysuru City Corporation (MCC) has partnered with Bharat Petroleum Corporation Limited (BPCL) to establish a Rs 65 crore Solid Waste Management (SWM) plant aimed at converting organic waste into biogas. This collaboration will help transform the city into a zero-waste model, addressing the challenge of managing the 600 tonnes of solid waste generated daily in Mysuru.

The proposed facility will process 200 tonnes of organic waste per day and generate renewable energy in the form of



Compressed BioGas (CBG), significantly reducing the environmental burden. The plant will be located near the sewage treatment plant at Vidyaranyapuram and is expected to help clear approximately 7 lakh tonnes of legacy

waste, with 40% already processed.

The project, which is in line with national sustainability goals, aims to reduce greenhouse gas emissions from decomposing waste and promote renewable energy gener-

ation. It will also play a critical role in mitigating water pollution caused by leachate during the monsoon season. BPCL will set up and operate the CBG plant, funded through its own resources or through a private partnership model. The company will also handle the long-term operation and maintenance of the plant. The biogas will be purified, converted into CBG, and sold for use as an alternative fuel for transportation.

This initiative is part of the Sustainable Alternative Towards Affordable Transportation (SATAT) scheme, which aims to promote CBG as an affordable and sustainable fuel. BPCL's investment will not only support waste management but also contribute to India's energy independence.

MCC Assistant Executive Engineer Mrutyunjaya confirmed that the project would help integrate various government programs, including Swachh Bharat Mission, Smart Cities, and Clean Air initiatives. The MCC is set to provide land for the plant for 20 years and supply waste for biogas production. This collaboration marks a significant step toward a more sustainable and eco-friendly Mysuru.

KSDMA Flags 82 Landslide-Prone Sites, Districts Yet to Act

With pre-monsoon showers already arriving and the full monsoon barely two months away, the Karnataka State Disaster Management Authority (KSDMA) has raised concerns over the lack of preparedness in vulnerable regions. The KSDMA has expanded its list of landslide-prone sites from 75 to 82, identifying highrisk areas not only in the traditional hilly districts of Kodagu, Chikkamagaluru, Shivamogga, and Hassan but also in new zones like Mangaluru, Belagavi,

Londa, and the Karnata-



ka-Goa border.

Despite issuing multiple circulars and holding meetings, the KSDMA

confirmed that district administrations have not initiated preventive measures on the ground.

"We've advised placing nets on slopes, sandbags in flood-prone areas, and overhanging pruning

branches. But none of this has been implemented," said a senior KSDMA official.

The alarm comes in the backdrop of last year's deadly landslide near Shirur on National Highway 66, where eight lives were lost. Post-tragedy, the KSDMA flagged several hazardous practices like cutting hills at steep angles using heavy machinery. "Sadly, these methods continue," the official noted, expressing frustration over ongoing infrastructure activities without safety safeguards.

KSDMA Commissioner S Honamma reiterated that circulars with detailed anti-landslide protocols have been sent to all deputy commissioners. However, execution remains stalled. The prolonged dry spell from November to March was a window of opportunity that went unused, officials said.

On its part, the National Highways Authority of India (NHAI) claims delays are due to land acquisition and surveys. "Land is essential for road widening and slope protection. In places like Shirur and Udupi, even surveys took 3–4 months, and actual work about 9–10 months," said

NHAI Karnataka Regional Officer Vilas Brahmankar. He added that tenders for works in Sakleshpur and Hassan have been called.

The NHAI, along with the Geological Survey of India, has identified 12 vulnerable sites along NH-66 and is working with the National Institute of Rock Mechanism to implement slope stabilization, drain works, and soil-tightening measures.

Meanwhile, the KSD-MA has appealed to holiday-goers planning trips to the Western Ghats to strictly adhere to safety precautions as monsoon risks loom large.

Bengaluru Cops Crack Down on IPL Betting

In a major crackdown on illegal IPL betting, Bengaluru police have seized Rs 1.15 crore in cash across five separate cases within a week. A significant portion of this — Rs 86 lakh — was confiscated on Thursday alone, pointing to the growing scale and sophistication of betting operations in the city.

Police investigations have uncovered a web of dubious mobile apps and websites being used to facilitate betting on various aspects of IPL matches, including match outcomes, player performances, and even the toss. Some of the prominent platforms discovered include Paarker, Rilex, Dubai Exchange, Lotus, and Biggbull 24/7.

A senior police officer involved in the probe said these apps are cleverly disguised, often mimicking the names and appearance of legitimate financial or trading platforms to evade scrutiny. "Thousands of users access these platforms regularly,



unaware or indifferent to the illegality involved," the officer noted.

Sources in the police department revealed that many of these applications operate through encrypted communication channels, making it difficult to trace transactions and the flow of money. Some apps are hosted on servers based outside India, adding an extra layer of complexity to the investigation.

In addition to cash seizures, police have also detained several individuals suspected of acting as agents or intermediaries. They are now being questioned to gather more details about the network's operations, including links to larger betting syndicates operating across state and international borders.

Authorities have issued a warning to the public to refrain from using unverified apps and websites for betting. Police are working with cybercrime units and financial intelligence teams to track down and block these platforms.

With the IPL season in full swing, law enforcement agencies have intensified surveillance to curb illegal gambling activities. More arrests and seizures are expected as investigations progress.

BBMP Ad Revenue Stalled by Court Case

The Bruhat Bengaluru Mahanagara Palike's (BBMP) ambitious plan to boost revenue through outdoor advertising has hit a legal roadblock, leaving the civic body with zero earnings from this stream in the 2024–25 financial year — despite projecting Rs 500 crore in revenue.

The setback stems from the delay in implementing a new advertisement al clutter and illegal strucpolicy, which remains entangled in a case pending before the High Court of Karnataka. The proposed policy was aimed at bringing transparency to the outdoor advertising sector and breaking the monopoly of a few dominant players. Inspired by Delhi's advertising framework, the BBMP's new policy was designed to replace the 2018 Outdoor Signage and Public Messaging Byelaws. Those older byelaws had imposed a near-blanket ban on commercial hoardings across the city in an attempt to curb visu-



tures.

to dominate the limited space legally available, sidelining broader participation and transparency in ad rights allocation.

The BBMP hoped the new policy would address these issues by opening the sector to fair competition, regularising advertising spaces, and enforcing stricter guidelines on location, size, and design. Officials believed it could become a major revenue source for the city, especially as traditional revenue avenues have been under stress.

Unfortunately, with the policy still stuck in court, the civic body was unable to issue new tenders or formalise any advertising deals this fiscal year. This has further strained BB-MP's finances and delayed potential urban development projects that could have been funded through ad revenues.

Civic officials remain hopeful that the High Court will soon clear the policy, paving the way for a cleaner, more regulated advertising landscape and much-needed revenue for Bengaluru's growing urban needs.

BWSSB Seeks Power to Curb Borewells

Struggling to tackle the growing issue of illegal borewells, the Bangalore Water Supply and Sewerage Board (BWSSB) is considering proposing amendments to the Karnataka Ground Water (Regulation and Control of Development and Management) Act, 2011. The move aims to give the water board greater authority to independently take action against violators.

Under the current provisions of the Act, drilling borewells without permission is treated as a non-cognisable offence. This classification restricts immediate police intervention, often requiring the BWSSB to approach the magistrate before any legal action can be taken.

Dr Ramprasat Manohar V, Chairman of BWSSB, expressed concern over the inefficacy of the current legal framework. "Since it's a non-cognisable offence now, even when we approach the police, they do not take action and we are told to approach the magistrate. This is making it difficult to prevent illegal borewells," he said.

lieve that upgrading the offence to a cognisable category would empower law enforcement agencies to take prompt action, thereby acting as a stronger deterrent against illegal drilling. The water board also seeks increased enforcement authority, allowing it to penalise offenders more effectively without depending heavily on external agencies.

Although the existing law allows for penalties, implementation on the ground has been weak

The proposed legal amendment is likely to include stricter punishment and clearer guidelines for enforcement, including real-time monitoring and coordination with police and local bodies. With Bengaluru already facing severe groundwater depletion and water scarcity

Strengthening the legal framework is seen as a critical step to safeguard the city's dwindling groundwater resources. The BWSSB is expected to formally present its recommendations to the state government in the coming weeks.

Doctors Launch Liver Study for IT Workers

A team of hepatologists in Bengaluru has launched a unique public health initiative titled "Liver Tech Check" to study the growing incidence of liver disease linked to sedentary, tech-driven lifestyles particularly among the city's vast IT workforce.

The study focuses on Metabolic Dysfunction-Associated Steatotic Liver Disease (MASLD),

a condition formerly known as non-alcoholic fatty liver disease. Doctors involved in the initiative warn that this disease is spreading at epidemic proportions, largely due to prolonged physical inactivity, erratic eating patterns, increased screen time, and chronic stress — all common characteristics of digital work environments. "IT professionals are a high-risk group. They spend long

hours sitting, often eat high-calorie food, and get little physical activity. This combination leads to fat accumulation in the liver, which over time can cause inflammation, fibrosis, and even cirrhosis," said one of the lead hepatologists. The "Liver Tech Check" study will survey a large cohort of IT employees from various companies across Bengaluru's tech corridors. The team plans to conduct health


screenings, liver function tests, and lifestyle assessments. The goal is not only to understand the prevalence of MASLD but also to spread awareness about liver health in the tech industry.

Early findings from pilot screenings suggest that a significant number of young professionals already show warning signs of liver dysfunction — often without any symptoms. Doctors emphasize that

the disease is reversible in its early stages through lifestyle modifications like regular exercise, a balanced diet, and stress management.

With Bengaluru being home to India's largest concentration of tech workers, the outcomes of this study could have far-reaching implications for public health planning and workplace wellness programs.

The hepatologists aim to present their findings



to both medical authorities and corporate stakeholders, hoping it will trigger policies promot-

ing healthier work environments and routine liver health check-ups for tech employees.



Tree Felling in Mysuru Sparks Outrage

serene Sunday morning in My-**L**suru turned grim as residents awoke to the shocking sight of 40 fully-grown trees felled overnight along a stretch earmarked for road widening. The move, sanctioned by the Forest Department, was carried out with little public knowledge, sparking widespread condemnation from environmentalists and local citizens alike.

The felling operation, which took place under the cover of darkness, saw the use of heavy earthmovers to swiftly cut local activist. "This isn't

down and begin clearing the trees. The sudden transformation of a once-green stretch into a bare landscape stunned morning walkers and residents. Social media platforms were flooded with images of the destruction, amplifying public outrage and triggering a wave of criticism over the lack of transparency.

Environmentalists termed the action as a blow to the city's already depleting green cover. "These trees were decades old and provided shade, cleaner air, and were home to several birds and small animals," said one development; it's devastation."

Deputy Conservator of Forests, Dr. K.N. Basavaraj, confirmed that the Mysuru City Corporation had obtained official permission for the tree felling as part of a road widening project. "As per compensatory afforestation norms, the corporation will have to plant 10 saplings for every tree cut," he said, adding that a total of 400 saplings will be planted in various locations across the city.

However, critics argue that saplings can never replace the ecological and environmental value of mature trees. "There's no guarantee these saplings will survive. And even if they do, it will take decades for them to provide the benefits those 40 trees did," said a member of a local environmental group.

The incident has reignited debate about balancing infrastructure development with environmental conservation. Citizens are demanding more transparency and community participation in such decisions.

Meanwhile, civic officials insist the road expansion is crucial to reduce traffic bottlenecks in the rapidly growing city. But for many Mysureans,

Chennai's Parandur Airport Takes Flight

After years of delays and deliberations, Chennai's aviation ambitions have received a major boost with the in-principle approval for a second airport at Parandur in Kancheepuram district. The proposed facility, projected to handle up to 100 million passengers annually, marks a significant leap in Tamil Nadu's infrastructure story.

The Parandur airport will feature three midfield terminals and two parallel raised concerns about runways, matching global standards. Karnataka Hikes Minimum Wages Sharply

In a major move aimed at addressing the rising cost of living, the Karnataka government has proposed a sharp increase in minimum wages across various employment categories. As per a draft notification issued by the Labour Department on Friday, the monthly wage for unskilled workers in Zone 3 has been fixed at ₹19,319.36 — a substantial 70% hike from the existing rate. The revised wage

structure, which includes variable dearness allowance, comes at a critical time when inflation and price rise have been squeezing household budgets across the state. The proposed hike is seen as a response to the growing demands from workers' unions and social welfare groups for wage revisions to keep pace with economic realities. According to the draft, highly skilled workers in thermal power stations will now be eligible for wages up to

₹34,225.42 per month the highest under the new schedule. In Zone 1 areas, known for high industrial activity, highly skilled workers will be entitled to a minimum wage of ₹31,114.02.

The notification covers around two crore workers employed in 100 scheduled sectors — including manufacturing, construction, textiles, and transport — with 18 new categories added in recent years. Labour officials noted that the revision aims

to reflect contemporary work conditions and cost dynamics while ensuring economic dignity for workers across both urban and rural areas.

Worker unions have largely welcomed the proposed hike, calling it a long-overdue corrective measure. "This is a victory for labour rights," said a representative of a Bengaluru-based trade union. "But we hope this is implemented without delay and strictly enforced."

Meanwhile, some in-

dustry have expressed concerns over the potential impact on small businesses and MSMEs, urging the government to provide transitional support or subsidies to help adapt to the new wage standards. The draft notification is open for public feedback and objections, after which the government will finalize the revised wage structure. If implemented, it will be one of the most significant wage hikes in Karnataka in recent decades.

Trump's tariff policies spell global economic turbulence


Trump's tariff policies are sounding the alarm bells for what could very well escalate into a full-blown trade war, potentially triggering a global economic disaster or a severe recession. There is a general perception, particularly within government circles, that these tariffs imposed by the United States will not significantly impact India. However, this assumption is far from the truth.

The reality is that India will not remain insulated from the ripple effects of these protectionist measures. While the impact may not be immediately visible, the country's economic growth is likely to become unstable in the foreseeable future. Even when growth resumes, it may neither be steady nor robust, it could be sluggish, if not outright crippling. The contri-

bution of individual states to the national economy is bound to take a hit, as their local economies are poised to slow down under external pressures.

One of the major fallouts of the US tariff regime will be a likely increase in unemployment across sectors, accompanied by a spike in inflation. These twin evils, joblessness and rising prices will directly affect the common man. The already low incomes of the middle and lower-income groups will shrink further, pushing them into greater financial distress. Their struggle for survival will become more acute, and savings, already meagre, will dwindle from their pockets.

With governments facing economic stress and public discontent, public spending is bound to rise. This would

be an attempt to compensate for the economic pain felt by citizens due to sluggish growth and income stagnation. People's expectations from the state will increase, but fulfilling them in a fiscally constrained environment will only add to the government's debt burden. Simultaneously, the pressure of personal loans on individuals is worsening the economic fragility of households.

The volatility in global markets triggered by these tariffs could lead to a sudden fall in stock markets, which in turn will erode the value of people's investments and hard-earned savings. Trump's tariff-driven policy moves, what I call Trump's Tariff Trumpets (TTTs) are in fact severe blows to the global economic system.

India, and more specifically its states, including Andhra Pradesh, cannot remain untouched by this whirlwind. If governments do not address the situation with foresight and effective policy responses, the fallout could derail national developmental visions such as Swachh Bharat and others. But if approached with the right strategies, the crisis could be transformed into an opportunity for course correction and structural reforms.

Failing to act decisively, however, will only exacerbate inequality and deepen poverty. Under such circumstances, economic development will remain a distant dream. TTTs are not mere trade barriers they are ticking time bombs that threaten the very foundation of equitable and sustainable development.

A Tribute to Dr. B.R. Ambedkar – A Visionary Beyond His Time

Tribute to one of the greatest minds and visionaries our nation has ever produced—Dr. Bhimrao Ramji Ambedkar. A jurist, an economist, a social reformer, and above all, a tireless advocate for justice and equality.

But while we celebrate him as the Father of the Indian Constitution, if Dr. Ambedkar had been appointed as India's first Education Minister by Nehru the shaping the destiny of India's youth right from beginning would have been different.

Pandit Nehru's decision : A

History often remembers great leaders for what they did—but it must also reflect on what they failed to do.

One such missed opportunity was Pandit Jawaharlal Nehru's decision not to appoint Dr. B.R. Ambedkar as India's first Education Minister. In doing so, a man who understood the grassroots crisis of illiteracy, who lived through the social exclusion that millions of Indians still face, and who stood as a symbol of the transformative power of education, was sidelined from the very ministry that could have reshaped the destiny of India's youth.


Instead of placing one of the most educated, visionary minds in charge of national education, India handed the reins to others who—while competent—did not carry Ambedkar's lived experience of marginalization or his urgency for educational justice.

This was not just a political oversight—it was a historical wrong.

Ambedkar didn't just believe in education—he embodied its power to liberate. His life was a testament to how knowledge could break chains of caste and poverty. Had he been given the responsibility, India's education system might have focused earlier on equity, social inclusion, and empowerment, not just literacy and bureaucracy.

Today, as we look at the gaps that persist in our education system—whether it's caste-based inequality, dropout rates, or the urban-rural divide—we must also look back and ask: What if Dr. Ambedkar had led us from the very beginning?

It's time we not only honor his memory—but also acknowledge the oppor-



tunities that were denied to him, and through him, denied to generations of Indians.

Imagine a man who had lived through the caste oppression... who rose against all odds to earn multiple doctorates from the world's top universities... who believed with all his heart that education is the ultimate tool of liberation.

With his unmatched intellect, his deep grasp of the grassroots realities of Indian society, and his unwavering belief in the transformative power of learning, Ambedkar would have been the ideal architect of India's post-independence education policy. He knew that true freedom was in-

complete without the education of the masses—especially the marginalized.

In 1947, India needed not just freedom—it needed direction. It needed someone who understood why millions of children couldn't read, why girls weren't in school, and why caste still chained the human mind. That someone was Dr. Ambedkar.

Had he been given charge of shaping India's educational foundations, perhaps our schools would have been more inclusive, our textbooks more empowering, and our youth more awakened—sooner, stronger, freer.

Dr. Ambedkar once said, "Cultivation

of mind should be the ultimate aim of human existence." His vision went beyond literacy—he wanted education that liberates, dignifies, and uplifts.

We honor his legacy, let us not just remember him as the chief architect of our Constitution, but also as the educationist India could have—and should have—fully embraced.

Let us commit ourselves to his dream: an India where every child, regardless of background, has the right to quality education—and a fair shot at dignity and opportunity.

Instead, while he gave India its Constitution, his revolutionary vision for education remained largely unrealized in his lifetime. Had his ideas shaped the foundation of our schools and universities, India might have seen an earlier and deeper social awakening—an educational revolution that reached every village and every child, regardless of caste or class.

Congress's Failure to Honor Dr. Ambedkar: A Nation's Unfinished Acknowledgment

History will never forget that Dr. B.R. Ambedkar gave India its most powerful instrument of justice—the Constitution. Yet, it must also remember that the political establishment, particularly the Congress party, failed to fully honor him when it mattered most.

Despite his monumental intellect and unwavering commitment to the nation, Dr. Ambedkar was not given a cabinet portfolio befitting his vision and capabilities. He was made Law Minister, yes—but not given charge of education, economy, or social justice—areas where his expertise was unmatched.

Ambedkar wasn't just a Dalit icon—he was a national visionary. And if the Congress truly believed in equality, inclusion, and justice, it should have been the first to recognize his unmatched contributions in real time, not decades later when the public demand became too loud to ignore.

Today, India remembers Ambedkar not because he was honored by power—but because he empowered the voiceless. It's a legacy far greater than any title or position—and one that history has finally begun to correct, even if too late.

Ambedkar's Resignation speech: An important Testimony to Nehru's narrow Vision

Pandit Nehru, while celebrated as a statesman, cannot be absolved of how Ambedkar was politically cornered and eventually pushed out of the cabinet. The Congress leadership's discomfort with Ambedkar's radical vision for caste annihilation, social equality, and educational reform created an environment where he was never fully supported—and often isolated.

Ambedkar wasn't given the Education Ministry, despite being one of the most qualified individuals in the country—someone who had studied at Columbia and the London School of Economics, and who deeply understood India's grassroots problems. Had Nehru truly wanted to transform India's education system, Ambedkar was the obvious choice. He wasn't chosen.







Himanta, Jeet Adani **Discuss Assam Investment**

In a significant follow-up to the Advantage Assam 2.0 business summit held in February, Assam Chief Minister Himanta Biswa Sarma met with Jeet Adani, Director of the Adani Group, to discuss the operationalisation of the conglomerate's massive Rs 50,000 crore investment proposal in the state. The meeting, which included senior state officials and members of the Adani leadership team, aimed to push forward projects in multiple sectors, including infrastructure, hospitality, aviation, and cement manufacturing.

Taking to social media platform X, the Chief Minister shared details of the discussion and expressed optimism about the investment commitment translating into tangible development soon. "During AdvantageAssam2, the Adani Group made a Rs 50,000 crore investment commitment. Today, along with my senior officers, we had an in-depth meeting with Mr Jeet Adani and his team to operationalise this commitment," Sarma stated.

The state government is hopeful that the Memorandums of Understanding (MoUs) signed during the summit—covering the development of an aero-city, luxury hotels, a major cement plant, and various infrastructure projects—will be implemented without delay. These projects are expected to generate employment, boost economic activity, and enhance Assam's status as an investment destination in the northeast.

The massive investment push by the Adani Group had originally been announced by Chairman Gautam Adani during the inaugural session of the summit. He had committed the funds towards building long-term assets and infrastructure in Assam, signalling the group's intent to play a transformative role in the state's economic growth.

The Assam government views this partnership as a game-changer for the region. By attracting private capital and global investors, initiatives like these are intended to turn Assam into a logistics and industrial hub in the eastern corridor of India. The meeting between Sarma and Jeet Adani comes at a time when the state is keen to leverage its geographic advantages and improve connectivity, tourism, and manufacturing.

As groundwork begins and formalities move ahead, the focus will be on translating commitments into on-ground execution that can deliver real economic benefits for the people of Assam.

Governor's 'Jai Shri Ram' Remark Sparks Row

Tamil Nadu Governor R.N. Ravi has once again stirred political controversy, this time for reportedly urging students to chant "Jai Shri Ram" during a recent event. The remark, made in an educational setting, has triggered strong reactions from opposition parties, academics, and civil society groups, who have accused the Governor of promoting religious slogans in violation of the Constitution's secular framework. The State Platform for Common School System-Tamil Nadu (SPCSS-TN), a well-known academic advocacy group, issued a sharp statement condemning the Governor's actions, asserting that he had clearly violated Article 159 of the Constitution, which mandates that a Governor uphold constitutional values without bias. The organisation called for his immediate removal, claiming that his encouragement of religious slogans in an official context breaches the secular duty of the office.

The political backlash was swift. Congress leader Sasikanth Senthil criticized the Governor, suggesting that his actions were calculated and meant to provoke



the State Government, especially in light of recent legal setbacks. "After being slammed by the Supreme Court and bypassed by the Tamil Nadu Government, the Governor is now resorting to these public stunts to stay relevant and spark outrage," Senthil said in a social media post. The controversy follows closely on the heels of a major Supreme Court verdict that rebuked Governor Ravi for de-

laying assent to ten bills passed by the State Assembly. The Court ruled that the Governor's actions were arbitrary and not in good faith, further instructing that the bills be treated as passed from the date they were re-submitted by the Assembly.

The Governor's invocation of "Jai Shri Ram" — a slogan associated with political and religious movements — has reignited the broader debate over the constitutional role of Governors and the expectation of religious neutrality in public office. Critics argue that while personal beliefs are a right, promoting religious slogans in state functions or educational institutions crosses a line, especially in a diverse and secular country like India. As the issue escalates, political leaders and civil rights advocates continue to press for accountability, demanding that constitutional offices remain above partisan or religious messaging. The Raj Bhavan has not responded to the allegations yet, leaving the public and media awaiting clarification or official comment on the Governor's controversial remarks.

Pastor John Jebaraj Held in POCSO Case

In a disturbing case that has shocked many, John Jebaraj, a pastor of Kings Generation Church in Coimbatore, was arrested in Kerala's Munnar for allegedly sexually assaulting two minors. The 37-year-old, known for his significant social media following, had been absconding for months and was apprehended by the Central All Women Police Station, Coimbatore.

Jebaraj was arrested last evening and produced before a court earlier today, which remanded him to judicial custody. He faces serious charges under the Protection of Children from Sexual Offences (POCSO) Act, with specific sections pertaining to aggravated sexual assault invoked against



Actor Vijay Joins Waqf Act Challenge

Tamil actor and Tamilaga Vettri Kazhagam (TVK) president Vijay has approached the Supreme Court challenging the constitutionality of the Waqf (Amendment) Act, 2025, joining a growing list of petitioners from across the country who claim the law infringes upon fundamental rights. The amended legislation, passed by Parliament earlier this month and signed into law by President Droupadi Murmu on April 5, has triggered a wave of political and legal opposition.

The Waqf (Amendment) Bill, 2025, was passed in the Rajya Sabha on April 4 with 128 votes in favour and 95 against, following its clearance in the Lok Sabha, where 288 members supported it while 232 opposed. The law seeks to overhaul the management of waqf properties by enhancing administrative powers and introducing new mechanisms for survey, registration, and dispute resolution. However, critics argue that these changes centralize authority, facilitate undue government interference, and threaten the autonomy of Muslim religious endowments.

Actor Vijay's entry into the legal battle adds a

new dimension to the growing controversy. As a popular figure in Tamil Nadu, his move is seen not just as a legal step but also as a political signal from his recently launched party, which has been positioning itself as a defender of constitutional rights and social justice.

Among others who have challenged the law in court are AIMIM MP Asaduddin Owaisi, Congress MPs Mohammad Jawed and Imran Pratapgarhi, AAP's Amanatullah Khan, and Azad Samaj Party leader Chandra Shekhar Azad. Several influential Muslim organizations such as the All India Muslim Personal Law Board (AIMPLB), Jamiat Ulema-i-Hind, and Samastha Kerala Jamiatul Ulema have also voiced strong objections. They argue the amendments are arbitrary, discriminatory, and undermine community rights.

Meanwhile, some groups have filed intervention applications in support of the Act, maintaining that it aligns with constitutional principles and does not violate any community's rights. As the case unfolds, the Supreme Court's verdict will be closely watched across legal, political, and religious spheres.

Waqf Act Sparks Unrest in States

The recent amendments to the Waqf Act, 2025, have sparked widespread protests across India, with Kerala and West Bengal emerging as major flashpoints. In Kerala, the unrest was led by the Solidarity Youth Movement and the Students Islamic Organisation of India (SIO), both affiliated with Jamaat-e-Islami. Demonstrations reached a peak on April 9 near Karippur Airport in Kozhikode, where protesters displayed controversial images of Islamist figures, including leaders of Hamas and ideologues like Hassan al-Banna and Sayyid Qutb. These visuals drew strong criticism from the BJP, which accused the groups of promoting extremist ideologies under the guise of protest. Responding to the outrage, Kerala Police launched investigations into the incident, as political tensions heightened.

Meanwhile, West Bengal witnessed more intense and violent demonstrations, particularly in Murshidabad district. Clashes erupted in towns such as Suti, Samserganj, and Jangipur, leading to the deaths of at least three individuals and injuries to several others, including police officers. Protesters vandalized public property, set vehicles on fire, and disrupted railway operations by blocking tracks and pelting stones at trains. In response, the Calcutta High Court directed the deployment of central forces to curb the violence and restore order. Authorities also arrested over 130 individuals in connection with the unrest.

Chief Minister Mamata Banerjee responded firmly, stating that the Waqf (Amendment) Act will not be implemented in West Bengal. She appealed for peace and warned political actors against exploiting the issue to fuel communal tension. On the other hand, BJP leaders condemned the state government's handling of the crisis, accusing it of being lenient on those responsible for the violence.

The ongoing protests reflect the deep unease and opposition among sections of the Muslim community, who view the amendments as a threat to the autonomy and integrity of Waqf properties. The developments in both Kerala and West Bengal underscore the growing challenge for the central and state governments to address minority concerns while maintaining law and order. As the protests continue, the political and social ramifications of the amended Waqf Act are expected to remain a contentious issue in the months ahead.







Russian missile attack on Ukraine's Sumy: More than 30 people killed, at least 84 injured

- Missiles reportedly used cluster munitions for maximum damage.
- · Sumy, near Russian border, seen as key military zone.
- · Ukraine shares evidence with ICC; war crimes probe underway.

In the deadliest strike on Ukraine this year, two Russian ballistic missiles devastated the northern city of Sumy on Sunday, killing at least 32 people and injuring over 80, according to Ukrainian officials. The brutal attack, which occurred on Palm Sunday, drew widespread condemnation from Ukrainian leaders and prompted fresh calls for international action against Moscow.

President Volodymyr Zelenskyy posted a harrowing video on social media showing bodies lying on the street near a charred bus and destroyed cars. "Only scoundrels can act like this. Taking the lives of ordinary people," Zelenskyy said, adding that the strike targeted civilians on a religious holiday when many were heading to church.

The Russian government has not issued a statement regarding the attack, and Reuters noted that no immediate response was received from Russian authorities.

Interior Minister Ihor Klymenko said the missiles struck a busy street where people were out in vehicles, on foot, or in nearby buildings. He labeled it a "deliberate destruction of civilians" on a day of religious significance. Zelenskyy's chief of staff, Andriy Yermak, revealed that the missiles used in the attack contained cluster munitions, further indicating a deadly intent to cause maximum civilian casualties.

Sumy, a city of around 250,000 people located just 25 kilometers from the Russian border, has previously been a military hub for Ukrainian operations. Though Kyiv's cross-border offensives into Russia last year were largely repelled, the region remains a sensitive target.

Maryana Bezuhla, a Ukrainian lawmaker known for her candid criticism of the military leadership, suggested on Telegram that the strike may have followed a leak regarding a potential troop gathering in the area. However, this claim remains unverified.

This attack comes just weeks after another missile strike on Kryvyi Rih—Zelenskyy's hometown—that killed 20 people, including nine children.

Ukraine's Foreign Minister Andrii Sybiha confirmed that Kyiv is sharing detailed evidence of the strike with international partners and institutions. The International Criminal Court in The Hague, which Ukraine joined officially this year, is currently investigating such incidents as potential war crimes under international law.

Elon Musk's 'Top Secret' Note Sparks Buzz at White House Meeting with Trump

A seemingly ordinary notepad with a cheeky message scribbled on it has sparked viral speculation after being spotted during a high-level cabinet meeting at the White House. The image in question shows tech billionaire Elon Musk seated with a name card bearing his name, a White House-branded notepad, and the words "Top Secret" written in bold blue ink—underlined twice and punctuated with two exclamation points.

Captured during an April 10 meeting led by U.S. President Donald Trump, the image quickly circulated on social media, drawing widespread amusement and theories about Musk's intentions. Users on platform X (formerly Twitter) were quick to speculate whether it was a genuine leak or just another one of Musk's signature pranks.

"Elon knows the games the media plays, so he decided to mess with them by writing 'Top Secret' on his notepad, knowing they'd be snapping pics," one user posted alongside the viral image. Musk himself responded with a laughing emoji, seemingly confirming the note was a light-hearted jab.

The internet erupted with reactions. "Elon is such a troll and I love him for it," wrote one user. Another added, "Oh, Elon... forever the class clown in a room full of serious faces. It's like he brought invisible ink to a spy convention." Someone even joked, "The last page in the notepad should say 'Bottom Secret'..."

While the viral moment drew plenty of laughs, the cabinet meeting itself had serious undertones. It was convened amid Trump's recent announcement of sweeping tariffs on over 60 nations and trading blocs, a move expected to have significant economic repercussions.

Musk, who now serves as the head of the Department of Government Efficiency (DOGE), presented a bold projection during the meeting—claiming that his department is on track to save the U.S. government \$150 billion in fiscal year 2026 by curbing fraud and improving operational efficiency.

However, reports suggest that Musk may soon step back from his formal role at DOGE. According to Politico, Trump and Musk have discussed a possible transition, with Musk potentially continuing in an informal advisory capacity while refocusing on his core businesses like Tesla, SpaceX, and X.

As always, Musk's presence—whether through policy or pranks—continues to leave a mark on Washington.

Zelenskyy Condemns 'Filthy Scum' Putin After Deadly Missile Strike

Ukrainian President Volodymyr Zelenskyy launched a scathing condemnation of Russian President Vladimir Putin on Sunday, calling him a "filthy scum" following a brutal ballistic missile strike that killed at least 31 people in the northern Ukrainian city of Sumy. The attack, which occurred on Palm Sunday, targeted residential areas, schools, and public roads at a time when residents were attending church services.

Among the dead were two children, and over 84 others were injured, including at least 10 children, making it the deadliest assault on Ukrainian civilians since 2023. The missiles slammed into civilian zones, obliterating homes, damaging educational institutions, and leaving scenes of horror on what was supposed to be a day of peace and worship.

Zelenskyy shared a video of the aftermath on X (formerly Twitter), showing bodies lying near destroyed vehicles and burning buildings. "A horrific Russian ballistic missile strike on Sumy. Russian missiles hit an ordinary city street, ordinary life – residential buildings, educational insti-



tutions, cars on the street... And that's on the day when people go to church – Palm Sunday," Zelenskyy wrote.

"According to preliminary information, dozens of civilians were killed and wounded. Only filthy scum can act like this – taking the lives of ordinary people," he added, expressing his condolences to the victims' families and calling for a firm global response. The Ukrainian president urged the international community, including

the United States and European nations, to step up pressure on Russia, emphasizing that peace cannot be achieved through diplomacy alone when missiles continue to fall.

"The world must respond firmly," Zelenskyy said. "Russia wants exactly this kind of terror and is dragging this war out. Without pressure on Russia, peace is impossible... Talks have never stopped ballistic missiles and aerial bombs."

He thanked Ukraine's allies for their continued support and emphasized the need to defend life and sovereignty.

Ukraine's Foreign Minister, Andrii Sybiha, also confirmed that Russia has once again rejected a U.S.-backed ceasefire proposal, marking the second consecutive month of refusal amid escalating civilian casualties.

As rescue operations continue in Sumy, Ukrainian authorities are sharing evidence with international partners, seeking justice through the International Criminal Court and stronger global sanctions against Russia's aggressive campaign

"Leave Now": A 30-Day Warning For Foreign Nationals Staying In US

In a dramatic escalation of immigration enforcement, the Donald Trump administration has issued a stern warning to foreign nationals living illegally in the United States, urging them to self-deport or face stiff penalties, including jail time. The announcement, made via an official post by the Department of Homeland Security (DHS) on social media, marks one of the most aggressive crackdowns yet on undocumented immigrants.

According to the new directive, all foreign nationals present in the U.S. for longer than 30 days must register with federal authorities. Failure to do so constitutes a criminal offense, punishable by fines and imprisonment. "Foreign nationals present in the U.S. longer than 30 days must register with the federal government. Failure to comply is a crime punishable by fines and imprisonment," the DHS post stated. It also tagged President Donald Trump and Krishi Noem, the current Secretary of Homeland Security, making the administration's position unmistakably clear: "Illegal aliens: LEAVE NOW and self-deport."

While the new policy does not imme-



diately impact individuals on legal visas such as H-1B workers or students, it underscores heightened scrutiny for all foreign nationals, especially those who overstay or fall out of status. For example, individuals on H-1B visas who lose employment and do not depart within the grace period could now face legal consequences.

The DHS's announcement includes a detailed list of what it describes as the benefits of voluntary departure. "Self-deportation is safe," the post reads. "Leave on your own terms by picking your departure flight. Keep money earned in the U.S. if you self-deport as a non-criminal illegal alien."

Moreover, the department claims that self-deporting individuals may remain eligible for future legal immigration pathways and even qualify for subsidized flights if they cannot afford to leave on their own.

On the flip side, the consequences for ignoring these guidelines are severe. Illegal residents who stay after receiving a final removal order could be fined \$998 per day. Those who commit to self-deportation but fail to follow through could face additional fines of \$1,000-\$5,000, along with possible imprisonment. Additionally, non-compliant individuals may be permanently barred from re-entering the U.S. legally.

The message is unambiguous: the Trump administration is doubling down on immigration enforcement and signaling a zero-tolerance policy for unauthorized





India's Electronics Exports Gain 20% Advantage Over China Due to U.S. Tariff Exemption

Exports of smartphones, tablets, and laptops from India to the United States are set to become 20% cheaper compared to products shipped from China, thanks to recent tariff exemptions granted by the Trump administration. The U.S. government announced on April 12, 2025, that it would exempt certain electronic devices, including smartphones, tablets, and laptops, from new reciprocal tariffs, easing the financial burden on exporters.

According to the India Cellular and Electronics Association (ICEA), this move levels the playing field between India and Vietnam, both of which now enjoy zero tariffs on electronics exports to the U.S. India's tariff advantage over China could be crucial for companies like Apple, which has seen significant growth in exports from India, with mobile phone exports crossing ₹2 lakh crore in the 2024-25 fiscal year.

ICEA Chairman Pankaj Mohindroo emphasized that while China still faces tariffs on 20% of products like iPhones, laptops, and tablets, India is



well-positioned to benefit from hone exports from India alone the U.S. exemption. Apple's iP- reached ₹1.5 lakh crore in 2024.

This move is expected to further boost India's position as a key player in the global electronics supply chain.

The Trump administration's decision also includes exemptions for items like flat-panel monitors and hard drives, which will now avoid the steep 145% tariffs that were previously imposed on China. These exemptions come as a relief to manufacturers facing challenges from ongoing trade tensions. Industry experts like Ashok Chandak, President of the Indian Electronics and

Semiconductor (IESA), view the U.S. tariff exemptions as a short-term reprieve for global tech manufacturers. However, the shift in trade policy could prompt longterm opportunities for India to become a preferred alternative to China, especially as U.S. imports of electronics continue to grow. With India's electronics export potential still significantly untapped, the sector is poised for substantial growth, leveraging the tariff advantage to gain a stronger foothold in the global market.

Amazon-backed More Retail plans India IPO next year, betting on its hybrid model

In a major cost-cutting move, U.S. Defense Secretary Pete Hegseth has ordered the immediate termination of multiple IT services contracts worth a combined \$5.1 billion. The contracts, held by major consulting firms including Accenture and Deloitte, were deemed by the Pentagon to be non-essential expenditures.

The directive, outlined in a memo dated April 10 and released publicly on April 11, 2025, highlights a shift in the Department of Defense's approach to outsourcing and consultant dependency. Hegseth stated that the terminated contracts "represent non-essential spending on third-party consultants" for tasks that could be performed internally by Pentagon personnel.

"These terminations represent \$5.1 billion in wasteful spending... and nearly \$4 billion in estimated savings," the memo read. It marks one of the largest single cost-cutting actions taken under Hegseth's leadership.

The decision comes amid increasing scrutiny over defense budget allocations and growing calls from lawmakers and watchdog groups to reduce reliance on costly external contractors

for services that do not directly support military readiness or operations.

According to defense officials, many of the cancelled contracts were for IT consulting, project management, and digital transformation services. While these services have been used to modernize various systems, Hegseth argued that the Pentagon has sufficient in-house capability to manage the majority of these functions.

Sources within the Defense Department say the review leading up to the cancellations was part of a broader audit launched earlier this year, aimed at identifying redundancies and inefficiencies in defense spending.

India's Factory Output Growth Slows to Six-Month Low of 2.9% in February

put growth dropping to a six-month low of 2.9%, according to data released by the National Statistics Office (NSO) on Friday. The slowdown was attributed largely to a high base effect and weakening performance across key sectors, including manufacturing, mining, and consumer goods.

The Index of Industrial Production (IIP), a key measure of industrial activity, had recorded stronger growth of 5.2% in January 2025 and 5.6% in February 2024. Gold Hits Record High of \$3,237 as Economic Fears, Trade War Drive Investor Rush

Gold prices surged over 6.5% this Demand isn't just rising among reweek, hitting an all-time high of \$3,237 per troy ounce, as investors sought refuge amid escalating global economic uncertainty. The sharp rally marks the metal's strongest weekly gain since the early months of the Covid-19 pandemic, with analysts linking the move to heightened fears of a recession and a rapidly intensifying US-China trade

The spike in gold came after Pressweeping new tariffs, triggering a significant market sell-off. China retaliated on Friday with a 125% tariff on American imports, stoking fears of a prolonged and damaging trade conflict. As a result, traditional safe-haven assets such as US Treasury bonds and stocks witnessed steep declines, while the US dollar weakened to a three-year low against the euro — further boosting gold's appeal.

"Gold is behaving exactly as a safe-haven should in times of deep market anxiety," said a senior analyst at GlobalCom Finance. "Investors are seeking shelter from rising bond yields, inflation uncertainty, and geopolitical turmoil."

As uncertainty continues to cloud global financial markets, analysts suggest that investors will likely continue turning to gold as a hedge, with prices potentially rising even further if tensions and economic headwinds worsen in the months ahead.

Credit-Fueled Digital Payments Surge in 2024 Amid Regulatory Concerns

Nearly one-third of all domestic digital payment transactions in India during 2024 were driven by credit, either through credit cards or interest-bearing EMIs (equated monthly instalments), according to a recent report analyzing data from over 20,000 merchants. This sharp rise in credit-backed transactions reflects shifting consumer behavior, with more individuals relying on borrowed funds for day-to-day consumption.

The findings arrive as financial regulators tighten scrutiny on consumer lending, aiming to prevent an unsustainable buildup of household debt. Concerns have grown that credit is increasingly being used to finance consumption—such as dining, fashion, and electronics purchases—rather than investment in long-term assets like homes or education.

tailers, and fintechs have all contrib- less credit options during checkout,

making it easier for consumers to opt for 'buy now, pay later' models or EMI conversions. This has especially resonated with India's younger population, many of whom are entering credit markets for the first time and using it to support lifestyle-driven purchases.

Industry experts caution that while credit expansion can support economic growth in the short term, unchecked borrowing without corresponding asset creation could pose long-term financial stability risks. "The growing trend of using credit for non-essential purchases is worrying, especially in the absence of strong financial literacy," one expert noted.

The Reserve Bank of India (RBI) has already taken steps to rein in unsecured lending, introducing stricter norms for non-banking financial companies

(NBFCs) and digital lenders. These measures include higher capital requirements and more transparency in EMI-based products.

At the same time, the demand for credit remains robust, with consumer sentiment buoyed by rising incomes and improved access to credit through digital channels.

The report suggests that financial institutions and regulators must strike a balance—encouraging digital innovation and credit access while ensuring borrowers are protected from over-indebtedness.

As India continues its transition to a cashless economy, the rapid rise in credit-linked digital payments underlines both the opportunities and the emerging risks in the evolving fintech

Girl Found in Suitcase at Haryana Hostel




Abizarre and now-vi-ral incident at OP Jindal Global University has sparked widespread discussion after a student was caught attempting to sneak a girl into the boys' hostel by hiding her inside a suitcase.

The incident, captured on video by a fellow commuter, shows the couple involved in an explicit public display of affection (PDA) while waiting on the metro platform. Shared by the handle 'Karnataka Portfolio' on social media platform X, the video has since gone viral, crossing 3.3 lakh views and attracting a barrage of critical comments.

What shocked viewers even more was the setting: the couple's actions unfolded in full view of other passengers, including senior citizens and families, some of whom appeared visibly disturbed by the scene. Despite

ple reportedly showed no signs of stopping or acknowledging the discomfort of others around them.

The video was captioned, "Is Bengaluru heading towards Delhi Metro culture??? Disturbing public behaviour at Namma Metro station raises questions about decency in Bengaluru." It ignited heated discussion online, with many users urging Bengaluru Metro Rail Corporation Limited (BMRCL) and law enforcement to take appropriate action.

In India, PDA continues to be a contentious subject. While some argue for the right to personal expression, many others believe there are boundaries that should not be crossed in public spaces especially places like metro stations which serve a diverse commuter population.



Metro authorities have not issued a formal response yet, but sources indicate that security footage is being reviewed and action could follow under rules governing public conduct in transport facilities.

Social commentators have also weighed in, pointing to the growing influence of social media and changing cultural norms, while stressing the importance of awareness, respect, and responsibility in public settings.



Deltona, Florida: A 52-year-old woman from Florida has been arrested for selling human body parts on Facebook Marketplace. Kymberlee Anne Schopper, a resident of Deltona, was charged with trading in human tissue and released on a \$7,500 bond after her arrest.

The investigation began when Orange City police received a tip in December 2023 about a local business selling human bones through the platform. Authorities discovered that the business, called Wicked Wonderland, had been advertising human body

parts for sale. Items included two human skulls priced at \$90 each, along with other remains such as a human clavicle, scapula, rib, and vertebrae, ranging from \$35 to \$600.

Upon investigation, police seized the human remains and sent them for testing by a medical examiner. Experts determined that some of the items, including a cranium and skull fragment, were likely archaeological discoveries rather than modern human remains. However, selling human body parts without proper permits or documentation is still illegal.

When questioned about the sale, Schopper claimed she had been selling the body parts for years and did not realize it was illegal to do so. The case highlights the growing concern over illegal sales of human remains, with platforms like Facebook Marketplace becoming an unintended marketplace for such items. Authorities are continuing their investigation to determine the source of the remains and whether there are other individuals involved in the illegal trade.

The space agency is actively preparing for missions that will send humans far beyond Earth, and managing waste in space has become a critical concern. NASA's goal is to minimize space waste, recycle it efficiently, and ensure astronauts can sustain

themselves on long trips without needing to bring back large amounts of waste to Earth.

"NASA is committed to sustainable space exploration. As we prepare for future human space missions, there will be a need to consider how various waste streams, including solid waste, can be minimized — as well as how waste can be stored, processed, and recycled in a space environment so that little or no waste will need to be returned to

Earth," the agency stated. The LunaRecycle Challenge is a two-phase competition aimed at developing the best waste recycling technology. The technology will need to ensure that human waste is processed in a way that doesn't add to the space debris and is sustainable for long missions.

This issue is not new to NASA; during the Apollo 11 mission, astronauts left 96 bags of human waste on the Moon to make room for valuable lunar samples. With future missions planning to stay longer and travel farther, solutions like waste recycling will play a vital role in supporting astronauts' needs in space.

As NASA continues to prepare for its next phases of space exploration, it is looking for groundbreaking ideas that will help create a cleaner and more sustainable space environment.


