A central feature of the bill is the repeal of Section 40, which previously gave Waqf Boards unchecked power to unilaterally declare land as Waqf property. This provision was often misused, leading to illegal land grabs. The new bill closes this

loophole, ensuring that properties are properly regulated and used for public welfare.

Further strengthening governance, the bill mandates financial audits and digitization of Waqf records. This will allow for greater transparency and ensure that the benefits of Waqf properties reach the marginalized sections of the Muslim community, such as Pasmanda Muslims, who have often been sidelined in the decision-making process. Another significant change is the inclusion of non-Muslim members in both state and central Waqf boards. While some critics view this as weakening Muslim representation, the BJP argues that it fosters inclusivity and enhances governance by involving diverse perspectives. Additionally, the bill includes provisions for gender equality, giving women a stronger voice in the management of Wagf properties.



Karnataka Chief Minister Siddaramaiah on Monday said he would comment on the caste census report only after a special cabinet meeting scheduled for April 17. Speaking to reporters after paying tribute to Dr. B.R. Ambedkar on his 134th birth anniversary, he emphasized that the matter will be discussed thoroughly before any public statement is made.

"We have convened a cabinet meeting on April 17 to discuss this lone subject. After the discussion, I will speak," Siddaramaiah said, avoiding any direct remarks on the contents of the controversial caste cen-

The Karnataka cabinet had accepted the Socio-Economic and Educational Survey, commonly referred to as the caste census, on April 11. The data compilation was initially undertaken in 2018 during Siddaramaiah's first term and later finalized by his successor, K. Jayaprakash Hegde, in February 2024.

Meanwhile, Siddaramaiah strongly refuted BJP's repeated allegations that the Congress was responsible for B.R. Ambedkar's defeat in the Lok Sabha elections.



He cited a letter written by Ambedkar himself, where the Constitution's architect clearly named Hindutva ideologue V.D. Savarkar and Communist leader S.A. Dange as contributing to his loss.

He further accused the BJP of attempting to falsely appropriate the legacies of Mahatma Gandhi, Sardar Vallabhbhai Patel, and Dr. Ambedkar. "Those who opposed Ambedkar and assassinated Gandhi are now trying to claim their legacy. The same Manuvadis who were against the Constitution are pretending to be its torchbearers," the CM alleged.

With heightened political tensions around the caste report, all eyes are now on the April 17 cabinet meeting, which will determine the state government's next steps on the contentious issue.

Union Minister of State for Railways and Jal Shakti, V Somanna, on Monday announced that the Karnataka government has officially approved renaming the Tumakuru railway station after the revered seer, Sri Shivakumara Swamiji of Siddaganga Mutt.

Speaking to the media, Somanna, who is also the MP from Tumakuru, thanked Chief Minister Siddaramaiah and District In-charge Minister Dr G Parameshwara for their support. He added that the renaming process had faced a six-month delay, but the state's formal consent has now paved the way for the proposal to progress.

"The Ministry of Railways had written to the Ministry of Home Affairs regarding the renaming. With the state's approval now

Minister in place, I will meet Union Home Minis-Parameshwara give nod for renaming ter Amit Shah soon to push for final clearance," said Somanna.

The railway station will be developed at an estimated cost of Rs 89 crore. The proposal to rename it as Dr Shri Shri Shivakumara Swamiji Railway Station was backed by the state infrastructure development department, citing the seer's extraordinary service to society.

Sri Shivakumara Mahaswamiji, who headed Siddaganga Mutt for nearly 87 years since 1930, is revered as the "walking god" for his contributions in education, food, and shelter to thousands of orphaned and underprivileged children, irrespective of caste or creed.

The Mutt holds immense respect across communities in Karnataka and has been visited by several national leaders, including presidents and prime ministers, acknowledging the Swamiji's legacy of humanitarian service.

Officials are hopeful the Ministry of Home Affairs will positively consider the request and formally rename the station in honour of the seer soon.

Courts Must Prioritize Child's Welfare Over Parental Rights in Custody Battles

TPN Correspondent | Bengaluru Legal experts and judges at the Southern Zone Regional Conference emphasized the need for courts to prioritize a child's emotional wellbeing over the battle for parental rights in custody disputes. The session, "Parental Custody of Children: Orders Regarding Visitation Rights and Custody Issues," concluded as part of the two-day event organized by the Family Courts Committee, Supreme Court of India, and Karnataka Judicial Academy.

Experts, including judges from high courts across Kerala, Tamil Nadu, and Telangana, pointed out the importance of understanding how children emotionally process conflict and separation. They stressed the need for custody arrangements that are devel-



opmentally appropriate, not just legally sound, and criticized the current system that often ignores the emotional consequences for children.

S. Sushila, an advocate and mediator based in Bengaluru, noted that the current system of alternating custody or visitation frequently disregards how children experience parental conflict. She argued that children's emotional safety and security should guide custody orders, rather than a simple balancing of parental rights. "For a child, family is not just about biological parents, but anyone they are emotionally attached to," Sushila said.

The conference also discussed challenges posed by cross-border custody disputes. Justice Moushumi Bhattacharya of the Telangana High Court highlighted the complexities

of international cases and stressed the need for a sensitive, case-by-case approach to custody matters. The experts called for a uniform approach rooted in the "best interests of the child" principle, in line with Article 3 of the UN Convention on the Rights of the Child.

KDA to Address Mispronunciations of Town and Village Names on Google Maps

- KDA collaborates with ISRO and Google to fix issues.

The Kannada Development Authority (KDA) is working to address the issue of mispronounced town and village names on Google Maps, which has raised concerns about the accuracy of local pronunciations. For instance, the village of Bilimale in Dakshina Kannada is mispronounced on Google Maps, altering its intended meaning. KDA Chairman Purushothama Bilimale stressed that the names of towns and villages in Karnataka are closely linked to the local environment, his-



tory, and communities. Over time, the pronunciations of these names have evolved, but the introduction of Google Maps has further distorted their correct pronunciations.

To address this, KDA is collaborating with ISRO and Google to correct the pronunciations of over 75,000 towns and villages in Karnataka. Bilimale mentioned that while ISRO's Nav-IC system offers more accurate pronunciations, it is not widely adopted outside India. KDA plans to meet with Google officials to discuss how Google Maps can incorporate accurate voiceovers for these place names.

KDA is also deploying volunteers across each district to help recheck the names on Google Maps. If everything proceeds as planned, the corrections are expected to be completed within five to six months. Additionally, KDA has written to Chief Secretary Shalini Rajneesh, urging that commercial establishments include the correct names of villages and towns on their name boards to foster regional cultural awareness.

This initiative aims to preserve the linguistic and cultural heritage of Karnataka's place names while enhancing their global visibility.

Caste Census Report a Political Move to Divide, Claims Ashoka actions,

Karnataka Leader of Opposition R Ashoka has raised serious allegations against the state's caste census report, calling it a deliberate attempt to divide communities for political advantage. According to Ashoka, the re-

port was allegedly prepared at the residence of Chief Minister Siddaramaiah, who dictated its contents to the then Backward Commission Chairman, Kantharaju. Ashoka claims that Kantharaju refused to sign the report in protest and left In addition, Ashoka criticized the report's cost, alleging that Rs 150 crore was spent on its preparation, and demanded a full investigation into the misuse of these funds. He further accused the state government of manip-

> ulating the report to serve a Muslim vote bank, claiming that the findings exaggerated the Muslim population figures as part of a larger conspiracy.

Drawing connections between the caste census and the government's previous

actions, Ashoka pointed out that the Siddaramaiah-led government had celebrated Tipu Jayanti, allocated Rs 10,000 crore for Muslim welfare, and ensured a 4% reservation in government contracts for Muslims. He argued that the caste census report is simply another tool in the government's strategy to consolidate its base along caste and religious lines.

Ashoka called on the people of Karnataka to recognize the government's divisive motives and reject the caste census report as a politically driven initiative that aims to create rifts within society.

Congress Channagiri, Basavaraju V Shivaganga, on Monday expressed strong opposition to the recently released caste

census, calling it "confusing" and "unacceptable under any circumstance."

Speaking to reporters, Shivaganga aligned himself with senior Congress leader and All India Veerashaiva Lingayat Mahasabha president Shamanur Shivashankarappa, stating, "I stand by his view. The caste census should have been discussed before its release. It would be an embarrassment for the government if it has to release the report and then amend it."

He highlighted glaring inconsistencies in the reported figures, pointing specifically to the Sadara sub-sect within the Veerashaiva-Lingayat community. "The report mentions only 67,000 Sadara Lingayats in the state. But there are nearly 60,000 in

Channagiri alone. I don't understand how the census was conducted," he said. Shivaganga stressed the importance of accuracy and transparency in such a sensitive matter. "There are about 1.25 crore Veerashaiva Lingayats in Karnataka. If the government wants credibility, it must present clear numbers for each caste without confusion," he added. His remarks reflect growing dissent within the Congress party over the caste survey data, which was compiled over a decade ago but released under pressure from internal and external political quarters. The MLA's concerns add to the chorus of voices urging the Karnataka government to revisit and verify the data before taking any further steps.

NGO Exposes Gaps in National Water Monitoring

Bengaluru-based environmental NGO has uncovered serious lapses in India's National Water Quality Monitoring Programme (NWMP), after finding alarming levels of toxic chemicals in the Arkavathy river. The findings, revealed by the Paani Earth Foundation, have prompted the National Green Tribunal (Southern Zone) to take suo motu cognisance of the matter.

The NGO conducted tests on water and sediment samples from various stretches of the Arkavathy river. The results revealed dangerously high concentrations of mercury, the banned pesticide DDT, and carcinogenic polycyclic aromatic hydrocarbons (PAHs). These pollutants, the foundation says, are going undetected due to critical flaws in the tained through the Right national monitoring sys- to Information (RTI) Act tem. In an interlocutory application filed with the tribunal, the foundation highlighted its communication with the Central Pollution Control Board (CPCB) in January, where



it raised concerns over the limited range of pollutants currently tracked under the NWMP. The NGO urged authorities to include harmful contaminants like PAHs, DDT, other pesticides, and phthalates in the monitoring list.

One of the key issues flagged was the lack of transparency and accessibility of monitoring data. Although records obshow that the Karnataka State Pollution Control Board (KSPCB) operates 80 monitoring stations in the Arkavathy basin, data was publicly available for only 42. Meanwhile, the CPCB's claim that only 40 stations exist adds to the confusion.

The foundation also criticized the CPCB portal for displaying only the annual minimum and maximum pollutant values, which fail to account for seasonal fluctuations or pollution spikes. They argued that such a narrow reporting format does not provide an accurate picture of real-time water quality.In response, the tribunal has directed the foundation to serve its submissions to all concerned respondents. The KSPCB has requested additional time to file a formal

Suspected Theft Sparks Metro Safety Concerns

A suspected pickpocketing attempt at Bengaluru's Central College metro station has raised fresh concerns about commuter safety on the city's expanding metro network. Vinay Kumar, a resident of Indiranagar, shared his unsettling experience while waiting for a train with his wife. He noticed a man behaving suspiciously, standing unusually close behind him. "When we moved to a different door marking, the man followed us again," Kumar said. Trusting his instincts, he and his wife quickly shifted positions as the train arrived, moving toward the last coach. The suspect did not follow, seemingly caught off guard. Although nothing was stolen, Kumar said the situation was uncomfortable, and the absence security personnel on the platform made it worse. "With the growing crowd in the coaches, it's

hard to find help or even



register a complaint on the spot," he added. The incident has brought attention to the gaps in metro security, especially during peak hours when trains and platforms are crowded. At present, the Bangalore Metro Rail Corporation Limited (BMRCL) relies on station-based security personnel and CCTV surveillance. However, there is little to no deployment of security staff inside the coaches themselves. When asked for comment, a senior BMRCL official downplayed the issue, saying such cases remain rare. "There has been no significant rise in complaints of pickpocketing. That said, we will review the matter and make

improvements if necessary," the official stated.

Despite these assurances, regular commuters and citizen groups argue that the current safety measures are inadequate. Suggestions include deploying mobile security staff within trains, increasing visibility of guards on platforms, ensuring all emergency communication systems are functional, and conducting awareness campaigns to help commuters report suspicious behavior effectively. As Bengaluru's metro ridership grows, so too does the need for a more responsive and proactive security system to ensure passenger trust and safety.

Engineer's Suicide Bid Near Raj Bhavan

In a dramatic turn of events on Sunday evening, a 26-year-old man attempted to immolate himself near the Karnataka Raj Bhavan in Bengaluru, allegedly to draw media attention to his personal grievances.

The man, identified as Zuhail Ahmed, a resident of Hebbal and an engineer at a private company, arrived at the site around 4:30 pm. His act coincided with a press briefing by a political leader, which had drawn a crowd of reporters to the area. Taking advantage of the media presence, Ahmed doused himself in petrol, reportedly intending to set himself on fire.

who noticed his actions rushed to intervene and managed to snatch the plastic bottle containing petrol from him. Notably, Ahmed was not found carrying a matchbox or lighter. Bystanders further doused him with water and immediately alerted the police.

Police from the Vidhatempt was thwarted by na Soudha station took public nuisance. Preliminary investigations suggest that Ahmed's actions were a desperate call for attention following alleged domestic abuse.

Speaking briefly to the press, Ahmed claimed that he had been assaulted by his wife and had been previously admitted to a hospital due to his injuries. His wife, who resides in Chikkaballapur, had

earlier filed a complaint against him, leading to a case under IPC Section 498A, which pertains to cruelty by a husband or his relatives.

A senior police officer familiar with the case confirmed that the Chikkaballapur police had registered the complaint against Ahmed earlier. His attempt near Raj Bhavan, the officer said, seemed to be more about making a public statement than an actual suicide attempt, given the lack of means to ignite the fuel.

Authorities are now verifying his claims and reviewing both sides of the domestic dispute. Meanwhile, Ahmed remains in police custody, and further action will be determined based on the outcome of the investiga-

Karnataka Revises Forest Proposal for Yettinahole

the Union environment ministry, the Karnataka government has revised its forest land diversion proposal for the controversial Yettinahole drinking water project, seeking a consolidated clearance for 428 acres of forest land across Hassan and Tumakuru districts. The revised proposal, submitted on March 17 by the additional chief secretary of the state forest department, marks a shift from the state's earlier approach of seeking "pieceapprovals. The application, submitted to the Union Ministry of Environment, Forest and



Climate Change (MoEFCC), seeks Stage 1 (in-principle) clearance for forest diversion by the implementing agency, Visvesvaraya Jala Nigam Limited (VJNL). The plan includes the felling of approximately 9,000 trees. This move comes in response to repeated objections from the Centre. In August 2024, the MoEF-CC had flagged the state's tendency to split forest land requests into smaller proposals — a violation

of forest clearance guidelines meant to ensure transparency in assessing environmental impact. The Yettinahole project's fragmented approach, the ministry warned, misrepresented the true scale of ecological damage.

The Yettinahole project's Detailed Project Report (DPR) had estimated a requirement of over 2,965 acres of land, with nearly half of it being forest. Yet, the state had submitted multiple small-scale proposals for diversion, attracting criticism for lack of clarity and potential violations. A 2016 proposal, for example, sought diversion of just 13.93 hectares (34.42 acres), and in later years, additional

requests were submitted without clear links to the projectMoreover, main the Centre also flagged violations dating back to 2019, including evidence from satellite imagery that showed project activities occurring in forest areas not yet officially cleared — raising serious compliance concerns.The revised 428-acre proposal aims to resolve these concerns and potentially fasttrack the Yettinahole project, which has long been mired in controversy over environmental impacts, procedural lapses, and forest clearance delays. The state now awaits the Centre's decision on the

revised application.

Fire Destroys 40 Labour Colony Sheds

A massive fire broke out at a labourers' colony in Veerannapalya, Govindapura, Bengaluru, on the night of April 12, 2025, destroying at least 40 makeshift sheds. Fortunately, there were no injuries reported, as residents managed to escape to safety in time. The colony houses workers employed at a local toy factory and daily wage labourers hailing from various parts of Karnataka. The fire is believed to have started in one of the sheds and quickly spread to the others, fueled by the closely packed structures and flammable materials inside. Residents noticed the blaze and immediately raised an alarm, helping their family members and neighbours evacuate before the fire could escalate further. While there was no loss of life, the incident caused significant material damage, with belongings, essential supplies, and goods worth several lakhs reduced to ashes.

The Govindapura Police and personnel from the Fire and Emergency Services arrived at the scene promptly and battled the

flames for nearly four hours before finally bringing the situation under control. Firefighters had to work in challenging conditions, as the tightly packed layout of the colony made it difficult to access the core of the blaze.

Preliminary ments suggest that the fire may have been triggered by an electrical short circuit, but a detailed investigation is underway to determine the exact cause. The incident has once again highlighted the vulnerability of labour colonies in the city, which often lack proper



infrastructure, fire safety systems, and emergency response mechanisms. Authorities are expected to assess the damage and may provide temporary relief measures for the affected families. The displaced residents have appealed for support to help rebuild their lives and recover from the loss.

Mumbai Water Tanker Strike Ends After Talks

The Mumbai Water Tanker Association has called off its four-day strike after a productive meeting with the Brihanmumbai Municipal Corporation (BMC) chief.

The strike began as a response to the BMC's issuance of notices to private well owners supplying water to the tankers, causing significant disruption in water deliveries to residential societies, railways, and construction projects.

BMC Municipal Commissioner Bhushan Gagrani assured the as-



sociation that the notices would be revoked and the issue would be addressed in coordination with the Central Ground Water Authority (CGWA). This move helped resolve the immediate impasse.

Amol Mandhare, Treasurer of the Mumbai Water Tanker Association, confirmed the strike's end, stating that their intent was never to harm the residents of Mumbai. He added that the associconcerns to the BMC Commissioner, who promised to resolve them with the central government. The association also plans to take legal action regarding the issue.

The strike had affected the water supply to numerous sectors, but with the issue now moving forward for resolution, water tankers are expected to resume operations immediately. The association operates over 1,700 registered tankers, with each capable of carrying up to 20,000 liters of water across Mumbai.

Trump's Tariff U-Turn Rattles Globe

In a stunning reversal, US President Donald Trump has put a temporary pause on his sweeping reciprocal tariffs-except those aimed at Chinasending ripples across global markets and evoking comparisons to the erratic rule of medieval sultan Muhammad bin Tughlaq. While this partial ceasefire has calmed some immediate anxieties, the unpredictable manner in which these economic policies are being implemented and revoked continues to deeply unsettle financial markets and global stakeholders.

Trump had earlier launched an allout trade war, threatening punitive tariffs on imports from nearly every major economy. However, in his latest move, he has narrowed the scope, leaving only China facing the brunt of new tariffs—now raised to a whopping 125%, while other countries are being subjected to a 10% tariff for the next 90 days. The sudden narrowing of this economic offensive has been widely interpreted as both arbitrary and reac-

The global community is grappling with the unprecedented nature of Trump's policy-making. Economists and political observers are drawing attention to how critical financial decisions are being made and reversed



with alarming casualness. There's no modern parallel to this kind of highstakes economic improvisation in international trade policy.

The bilateralization of the trade war now essentially a standoff between the US and China—has left analysts puzzled. Was this reversal driven by sheer unpredictability, or was it a strategic retreat in response to the severe backlash from equity and bond markets? Some believe Trump may have been

influenced by feedback from key business leaders and economic advisors, as well as public concern in the US about the impact of his tariffs.

Others suggest that this was part of a long-orchestrated plan to economically

isolate China while keeping the rest of the world on relatively neutral ground. However, that theory is hard to reconcile with the initial universal scope of the tariff plan. Sustaining a tariff war with China, without affecting other economies, is far from simple in an interconnected global supply chain.

During Trump's first term, the US had already imposed tariffs on a wide range of Chinese goods, and many expected Trump 2.0 to double down. Yet the flip-flop nature of these decisions has left many questioning whether there is any coherent strategy at all.

The uncertainty unleashed by this chaotic approach is particularly damaging. Long-term economic planning, investment, and supply chain management all depend on policy stability and predictability—elements now clearly missing. While a policy can be announced or revoked within days, rebuilding trust and trade infrastructure takes years, if not decades.

In the end, Trump's claim that he hopes for a "good deal with China" only adds another layer of ambiguity. As global markets brace for the next twist, the world watches with concern, unsure of whether diplomacy or disruption will define the next phase of this economic drama.

Ambedkar's Vision of Manuski and Dignity



Dr. B.R. Ambedkar's idea of manus (human) and manuski (human dignity) was rooted not just in Western liberal humanism, but in a deeper, vernacular, and performative understanding of what it means to be human in a caste-based society. His concept of humanness was not merely biological • — it was social, ethical, and enacted through dignity, justice, and equality. On April 14, Ambedkar Jayanti, it's worth revisiting how central these concepts were to Ambedkar's political and philosophical vision, especially in the context of Dalit liberation.

In his 1925 speech to the Mumbai Province Bahishkrut Parishad in Belgaon, Ambedkar called on Dalits to fight for their manuski — to not just live, but to live with dignity. He posed a fundamental question to the Untouchables: "Do you want sukh (comfort) or manuski?" (Bahishkrut Bharat, Feb 3, 1928). This was not a rhetorical question. Ambedkar was pointing out that dignity, not mere survival or comfort, was the foundation of full personhood. To reclaim manuski, Ambedkar emphasised political representation, social transformation, and the annihilation of caste. He understood that Hinduism, structured on rigid human hierarchies, offered no path to dignity for Dalits. In his seminal — though undelivered — speech Annihilation of Caste (1936), he argued that dismantling caste was essential to creating universally shared.

Gujarat ATS, Coast Guard Seize ₹1,800 Crore Worth of Drugs in **High-Seas Operation**

In a major anti-narcotics operation, the Gujarat Anti-Terrorist Squad (ATS) and the Indian Coast Guard (ICG) jointly seized 300 kilograms of suspected methamphetamine valued at ₹1,800 crore after smugglers dumped the contraband into the Arabian Sea and fled across the International Maritime Boundary Line (IMBL), officials said on Monday.

The overnight operation was conducted on April 12-13 in the Arabian Sea near the IMBL off the Gujarat coast, based on specific intelligence received by the Gujarat ATS. Acting swiftly, the ICG diverted one of its ships from the Western Region to intercept the suspect vessel.

According to an official release, the Coast Guard ship managed to locate the suspicious boat despite challenging visibility conditions. Upon spotting the approaching patrol vessel, the smugglers quickly jettisoned their cargo into the sea and escaped across the IMBL, taking advantage of their proximity to international waters and the distance between the vessels at the time of detection.

"The ICG ship deployed its sea boat immediately to recover the jettisoned narcotics while commencing a hot pursuit of the fleeing vessel," the release stated. However, due to the geographical constraints and the swift movement of the smugglers, intercep-



tion could not be achieved.

Despite the challenges of operating in darkness and rough seas, the Coast Guard successfully recovered the dumped contraband. The narcotics, believed to be methamphetamine, were brought ashore to Porbandar and handed over to the Gujarat ATS for further investigation.

Officials noted that this operation marks the 13th successful joint mission by the Gujarat ATS and the Indian Coast Guard in recent

years, highlighting the strong synergy and coordination between the two agencies in safeguarding national interests and coastal security.

The seizure underscores the persistent threat of drug trafficking through maritime routes and the increasing need for coordinated intelligence-led operations. Investigations are ongoing to trace the origins and intended recipients of the consignment, and efforts are underway to identify and apprehend the smugglers who escaped into international waters.

The Congress party is reportedly considering a significant move to elevate Priyanka Gandhi Vadra to the post of vice president as part of a broader push for structural reforms within the organisation. While an official decision is yet to be made, party insiders say discussions around her formal promotion have intensified in recent weeks.

Currently, Priyanka Gandhi serves as the General Secretary of the party, though she does not hold any specific organisational charge. Despite this, she has been actively involved behind the scenes, particularly in driving new initiatives aimed at strengthening the party's grassroots

One of her major recent contributions is a pilot project focused on empowering district Congress presidents, beginning with Gujarat. If the pilot proves effective in Gujarat, the Congress plans to expand the model to other states across the country.

Karun Nair Disappointed Despite **IPL Half-Century**

Karun Nair, the experienced Vidarbha batter, made a strong comeback in the 2025 Indian Premier League (IPL) with a scintillating knock of 89 runs off 40 balls. His performance, however, came in a losing effort as Delhi Capitals succumbed to Mumbai Indians in their latest encounter. Despite his remarkable innings, which included his first IPL half-century in seven years, Nair remained disappointed, emphasizing that individual performances hold little value if the team does not win.

The 33-year-old, who had been absent from the IPL for three years, was brought in as an Impact Player and delivered a solid contribution. However, he refused to dwell on his personal achievement during the post-match interview. Nair expressed his disappointment with the outcome, underscoring the importance of team success over individual milestones. "We play to win the match, so there is disappointment. No matter how much we score, if the team does not win, then there is no value of it," he remarked, adding that winning was his primary focus.

The knock was a welcome return for Nair, especially after a long absence from the IPL, but he felt his efforts were futile as Delhi Capitals couldn't finish the job. He noted how important it was for the set batters to stay at the crease for longer periods. "Obviously, it was easier for the set batter to play than for the new batter," Nair explained. "It was very important for a set batter to continue, but we lost wickets at regular intervals, making it tough to chase down the target."

Despite the loss, Nair acknowledged Mumbai Indians' strong bowling performance, which



kept the Capitals under pressure throughout the match. He pointed out that the team struggled to form partnerships, an essential aspect in T20 cricket. "We were all looking to score runs quickly, but we couldn't stitch together partnerships," he added.

The batter remains hopeful that his team will learn from this defeat and continue their momentum in future games. Nair's perspective on the loss reflects his commitment to the team's success and his determination to contribute to their winning efforts in the coming matches.

Anti-Waqf Violence Spreads in Bengal

Violent protests over the Wagf (Amendment) Act continue to escalate in West Bengal, with fresh reports of unrest emerging from a second district. After days of clashes in Murshidabad's Jangipur area, the tension has now reportedly spread to parts of Malda, raising alarm among authorities and prompting urgent legal and security interventions.

Court seeking a court-monitored Special Investigation Team (SIT) probe into the violence. Sheikh Hasina sends a 'play with fire, you burn too' warning to Yunus govt

Saying 'their audacity astonishes me'

Former Bangladesh Prime Minister Sheikh Hasina, who was ousted from office last year, issued a strong warning to the country's interim caretaker government on Tuesday, cautioning that "if you play with fire, it will burn you too." Hasina's remarks come in the wake of increasing threats to ban her long-standing political party, the Awami League, which has been a central force in Bangladesh's politics for decades.

In a virtual address from India, where she has been living since fleeing Bangladesh last August, Hasina condemned the interim government for its audacity in attempting to erase the Awami League's historical role in the country's independence struggle. She specifically accused Professor Muhammad Yunus, who has been linked to efforts undermining the Awami League, of erasing the party's contributions to the Liberation War.

Hasina, 77, emphasized that the Awami League, founded in 1948, was instrumental in securing the rights of the people of East Pakistan, which later became Bangladesh. She reminded the public that the country's independence in 1971 was achieved under the leadership of her father, Sheikh Mujibur Rahman, the founding father of the nation, and through the organizational strength of the Awami League. "The name of the country where they now live was given by Bangabandhu Sheikh Mujib," Hasina said, reinforcing her father's role in uniting the people of Bengal and securing the nation's freedom.

The call to ban the Awami League, led by Hasina's supporters, has been met with resistance from rival political groups like the Bangladesh Nationalist Party (BNP). While some extreme right-wing factions continue to demand the party's disbandment, the proposal has failed to gain substantial backing from other major political players in Bangladesh.

Hasina also addressed the violence that erupted in 2024, which resulted in significant casualties among Awami League activists, police officers, and members of minority communities. Reflecting on the human toll of the crisis, Hasina questioned the actions of the current regime and warned that their attempts to suppress her party could have dire consequences.

As political tensions escalate in Bangladesh, Hasina's statements underscore the growing divide and the uncertain future of the country's political landscape.

Russian missile attack on Ukraine's Sumy: More than 30 people killed, at least 84 injured

In the deadliest strike on Ukraine this year, two Russian ballistic missiles devastated the northern city of Sumy on Sunday, killing at least 32 people and injuring over 80, according to Ukrainian officials. The brutal attack, which occurred on Palm Sunday, drew widespread condemnation from Ukrainian leaders and prompted fresh calls for international action against Moscow.

President Volodymyr Zelenskyy posted a harrowing video on social media showing bodies lying on the street near a charred bus and destroyed cars. "Only scoundrels can act like this. Taking the

lives of ordinary people," Zelenskyy said, adding that the strike targeted civilians on a religious holiday when many were heading to church.

The Russian government has not issued a statement regarding the attack, and Reuters noted that no immediate response was received from Russian authorities.

Interior Minister Ihor Klymenko said the missiles struck a busy street where people were out in vehicles, on foot, or in nearby buildings. He labeled it a "deliberate destruction of civilians" on a day of religious significance. Zelenskyy's chief of staff, Andriy Yermak, revealed that the

missiles used in the attack contained cluster munitions, further indicating a deadly intent to cause maximum civilian casualties.

Sumy, a city of around 250,000 people located just 25 kilometers from the Russian border, has previously been a military hub for Ukrainian operations. Though Kyiv's cross-border offensives into Russia last year were largely repelled, the region remains a sensitive target.

Maryana Bezuhla, a Ukrainian lawmaker known for her candid criticism of the military leadership, suggested on Telegram that the strike may have followed a

leak regarding a potential troop gathering in the area. However, this claim remains unverified.

This attack comes just weeks after another missile strike on Kryvyi Rih-Zelenskyy's hometown—that killed 20 people, including nine children.

Ukraine's Foreign Minister Andrii Sybiha confirmed that Kyiv is sharing detailed evidence of the strike with international partners and institutions. The International Criminal Court in The Hague, which Ukraine joined officially this year, is currently investigating such incidents as potential war crimes under international law.

As tensions between the United States and China intensify, Beijing has suspended the export of several key rare earth elements, metals, and magnets—critical materials used across industries such as defense, electronics, automotive, aerospace, and semiconductors. The move, seen as a strategic response to President Donald Trump's latest tariff hike on Chinese goods, threatens to disrupt global supply chains and significantly impact American manufacturers.

According to a report by The New York Times. new regulatory framework for rare earth exports. While this system is being developed, shipments of these crucial materials have been halted at several Chinese ports. Once implemented, the new system may permanently restrict access to these materials for select companies, particularly American military contractors.

China, which produces about 90% of the Chinese imports.

Chinese authorities are currently drafting a world's rare earth elements, has placed seven categories of medium and heavy rare earths—such as samarium, gadolinium, terbium, dysprosium, lutetium, scandium, and yttrium—on an export control list. These elements are vital for manufacturing high-tech equipment, including missiles, EV motors, jet engines, and semiconductors. The United States, by contrast, has only one rare earth mine and remains heavily dependent on

Beijing imposed these new export restrictions on April 2, coinciding with its broader retaliatory package against the US, which includes increased tariffs and specific product bans. While not an outright ban, China now requires special export licenses to ship rare earths and associated finished products abroad. Industry experts warn that the licensing system is currently underdevel-

oped, raising concerns about prolonged delays and dwindling international supplies.

The decision underscores China's strategic use of its dominance in the rare earth sector as a geopolitical tool. Lockheed Martin, Tesla, and Apple are among major US companies that rely on Chinese rare earths. Though the US maintains some stockpiles, they are insufficient to sustain long-term defense manufacturing.

Meta Faces Landmark Antitrust Trial Over Instagram and WhatsApp Acquisitions

Meta Platforms Inc is heading into a historic antitrust trial that could potentially force the tech giant to divest Instagram and WhatsApp — two of its most valuable platforms. The trial, which begins Monday, marks a major test for the Federal Trade Commission's (FTC) efforts to rein in Big Tech.

The case stems from a 2020 lawsuit filed during former President Donald Trump's administration, accusing Meta — then Facebook — of engaging in anti-competitive practices by acquiring Instagram in 2012 and WhatsApp in 2014. The FTC alleges these deals were part of a strategy to eliminate competition and maintain Meta's monopoly in the social media space.

Tim Cook's Viral Video Explains Why Apple Still Builds iPhones in China Despite Rising US Pressure

Apple CEO Tim Cook is once again in the spotlight as a resurfaced 2024 video gains traction online, offering rare insight into why the tech giant continues to manufacture iPhones in China instead of shifting operations to the United States. In the widely shared clip, Cook challenges the long-held assumption that Apple's presence in China is driven by low labour costs.

"The popular conception is that companies come to China because of low labour costs. I'm not sure what part of China they go to, but the truth is China stopped being the low labor cost country years ago," Cook says in the video.

Instead, Cook emphasizes China's unparalleled manufacturing infrastructure and skilled workforce as the real reasons behind Apple's deep-rooted production presence there. He highlights the scale and precision required to manufacture Apple devices processes that demand specialised tooling engineers and high-level materials handling capabilities. According to Cook, while it may be difficult to gather a roomful of such engineers in the US, China could fill several football fields with them.

The video has gone viral amid rising political



calls in the US to repatriate manufacturing jobs. President Donald Trump recently expressed a desire for tech companies like Apple to start producing more devices domestically. The White House has also pointed to Apple's planned \$500 billion US investment as a potential signal of shifting priorities.

However, industry experts caution that Apple is unlikely to bring large-scale manufacturing back to the US anytime soon. Reports from Bloomberg suggest that the US lacks the skilled labor, supplier ecosystem, and infrastructure necessary to support Apple's complex production needs at scale.

Meanwhile, Apple is making moves to diversify its supply chain. India has emerged as a key partner in this strategy. Apple, through contract manufacturer Foxconn, is expanding a 300-acre iPhone plant in Bengaluru.

Indian Shrimp Exporters Get Relief as US Pauses Higher Tariff

India's seafood exporters are gearing up to ship 35,000 to 40,000 tonnes of shrimp to the United States after President Donald Trump temporarily paused a planned tariff hike. The proposed reciprocal duty of 26% was rolled back to 10%, bringing a wave of relief to exporters and ensuring continued trade momentum.

K.N. Raghavan, Secretary General of the Seafood Exporters Association of India, told PTI, "There is a lot of relief now as we are at par with other exporters to the US. The shipments that were held back will now be processed." According to him, nearly 2,000 containers of shrimp, which had been delayed due to tariff uncertainty, are now being readied for export.

Trump's decision on April 9 to hold off on the tariff hike, just a week after it was announced, gives Indian exporters a crucial 90-day window to fulfil existing orders without facing additional costs. This decision retains a 10% blanket tariff on seafood imports from most countries, excluding China, which continues to face a steep 145% duty.

Currently, Indian shrimp exports to the US are subject to an effective customs duty of 17.7%, which includes a 5.7% countervailing



duty and 1.8% anti-dumping duty. Under delivery duty-paid (DDP) arrangements, Indian exporters typically absorb these costs themselves, making the temporary pause even more significant for preserving profit margins on already contracted shipments.

Despite the tariff concerns, the US remains India's largest shrimp market, both in terms of volume and value. In the 2023-24 fiscal year, India exported shrimp worth \$2.7 billion to the United States. Encouragingly, industry sources have reported no decline in orders.

The Seafood Exporters Association is now urging the Indian government to push for long-term solutions during upcoming trade negotiations, particularly focusing on establishing a level playing field for India's seafood industry before the 90-day tariff pause ex-

The temporary relief has re-energized the sector, offering exporters a window of opportunity to maintain strong trade ties with their largest customer.

China's Exports Surge Ahead of Looming U.S. Tariffs

China's exports saw an unexpected and that the tariff hike would likely disrupt sharp rebound in March 2025, jumping 12.4% year-on-year in dollar terms, according to data released by the country's customs authority on Monday. The growth, which comes just ahead of major tariff hikes announced by the United States, marks a significant reversal from the 3% decline recorded in February.

The latest numbers surpassed all estimates in a Bloomberg survey of analysts, where the median forecast had predicted a more modest 4.6% increase. This performance highlights China's aggressive push to ship goods before fresh trade barriers take effect, particularly with exports to Southeast Asia reaching near-record levels.

Economists suggest that the spike is largely driven by front-loading activity, as exporters rushed to fulfill orders before Washington's new tariff

measures are enforced. The U.S. administration under President Donald Trump has recently escalated its trade stance on China, reintroducing and expanding duties on a wide range of Chinese goods as part of its broader "America First" trade policy.

The Chinese government is closely monitoring the situation. In a statement earlier on Monday, the Commerce Ministry called on the U.S. to "correct its mistakes" and to "heed rational voices" that support stable trade relations. The Ministry also warned

global supply chains and hurt consumers and businesses on both sides.

Meanwhile, the rise in exports is seen as a temporary boost amid a more uncertain long-term outlook. Analysts caution that while March's numbers reflect strong external demand and proactive exporter behavior, the upcoming tariffs could result in a



slowdown over the next quarter, particularly if retaliatory measures are implemented or trade tensions escalate further.

This export rebound comes at a crucial time for China's economy, which is working to regain momentum after periods of sluggish domestic consumption and external uncertainty. Strong export figures may offer short-term relief, but the threat of a prolonged trade standoff with the U.S. remains a major concern for Beijing and global markets alike.

India's Manufacturing Sector Shows Late FY25 Uptick, But FY26 Q1 Outlook Mixed

India's industrial production showed signs of recovery towards the end of the financial year 2024-25, backed by strong performances in high-frequency indicators such as the manufacturing Purchasing Managers' Index (PMI), Goods and Services Tax (GST) collections, and e-way bill generations, according to a recent report by the Bank of Baroda (BoB).

The report indicated that these positive signals suggest a rebound in production in the closing months of FY25. "Given the latest improvement in manufacturing PMI for March 2024, along with a pick-up in e-way bill generations and GST collections, we expect production to have reported some improvement towards the end of the last fiscal year," the report noted.

However, the outlook for the first quarter of FY26 remains cautious. BoB warned of emerging headwinds, particularly due to uncertain a significant risk factor, especially amid geopolitical and economic volatility, including continued tensions between the United States and China.

The report also emphasized that the Reserve Bank of India's (RBI) recent decision to reduce policy interest rates could serve as a tailwind for the manufacturing sector by lowering borrowing costs and incentivizing investment and production. Additionally, a 90-day pause announced by the Trump administration on the imposition of new country-specific tariffs, alongside a decline in global commodity prices, has further buoyed near-term expectations.

Nonetheless, India's Index of Industrial Production (IIP) data for February 2025 revealed a more nuanced picture. IIP growth slowed to 2.9%, down from 5.6% in February 2024 and

global trade dynamics. Export growth remains 5.2% in January 2025. The decline was broadbased, affecting key sectors such as mining and electricity, with the manufacturing segment also seeing moderate weakening.

> Within manufacturing, industries like basic metals, motor vehicles, chemicals, and apparel reported lower output, while pharmaceuticals, textiles, and electronics registered modest growth. Among use-based classifications, only capital goods saw year-on-year growth, whereas consumer durables, infrastructure, and non-durables declined.

Overall, IIP growth for the fiscal year to date stands at 4.1%, down from 6% in the same period last year. While positive domestic signals provided a lift at the end of FY25, the mixed global environment suggests a cautious start to FY26 for India's manufacturing sector.







Tn a candid and timely reflection on today's job mar-▲ket, Bombay Shaving Company CEO Shantanu Deshpande recently addressed a growing and unsettling trend—professionals in their 40s facing layoffs across industries. Calling it a *"global phenomenon,"* Deshpande highlighted how individuals in this age group, often in the peak of their earning years, are increasingly being let go by companies seeking to cut costs. Deshpande described the 40s to early 50s as a "golden salary period"—a time when professionals typically command high salaries after decades of experience. However, it's also when financial responsibilities tend to peak, with expenses like children's education, home loans, and elderly parents' healthcare pressing hard. Being laid off during this phase can be not just a financial jolt but an emotional one too.

The conversation struck a chord online, with many sharing personal stories. One Instagram user, Shweta Gadia, shared how she lost her job at 42 despite having an impressive professional profile. Since then, she's been struggling to find a role that matches her experience and expectations. After moving to Mumbai in his youth, Kamath joined his brother's restaurant business but soon realized his true passion lay in creating desserts, especially fruitbased ones. Drawing inspiration from his family's fruit-selling legacy, he began experimenting with seasonal fruits and milk to craft simple, natural ice creams—free from artificial colors and preservatives. In 1984, he opened his first Naturals



Ice Cream outlet in Juhu, Mumbai, with just five flavors: mango, sitaphal (custard apple), jackfruit, banana, and chikoo (sapodilla). It was a modest shop attached to his father's South Indian restaurant.

What set Naturals apart was its commitment to quality and word-ofmouth marketing. Kamath believed the product would speak for itself, and he was right. As customers kept coming back for more, the brand grew steadily, driven by authenticity, consistency, and customer trust. Despite having no formal training in business or advertising, Kamath's

were spot on. Over the years, Naturals expanded across the country with over 150 outlets, retaining its family-run ethos and focus on fruit-based, handmade ice creams. Kamath's inspiring journey proves that success doesn't always follow a straight path through business schools or big capital. Sometimes, it's the taste of home, a dedication to quality, and a deep understanding of your roots that can turn mangoes into millions. Kamath passed away in May 2024, but his legacy continues to delight gen-
