

ED chargesheet against Sonia, Rahul nothing but 'politics of vendetta':

The case first gained prominence in 2012, when BJP leader Subramanian Swamy filed a private complaint alleging that Sonia and Rahul Gandhi had acquired control over AJL through the non-profit Young Indian Pvt Ltd, in which they held majority shares. The complaint claimed that AJL's real estate assets, valued in the hundreds of crores, were effectively transferred to Young Indian, bypassing legal procedures and financial accountability.

While the Congress leadership has repeatedly dismissed these claims as baseless, the ED has continued its investigation under the Prevention of Money Laundering Act (PMLA), citing fresh financial evidence and witness testimonies.

The outcome of the April 25 hearing could set the tone for the next phase of the legal battle, with implications not only for the Gandhis but also for the political landscape in the run-up to the next general elections.

Hindu Petitioners Challenge Constitutional Validity of Waqf Act in **Supreme Court**



TPN Correspondent | New Delhi Amid intensifying legal scrutiny of the recent amendments to the Waqf Act, 1995—modified under the Waqf (Amendment) Act, 2025—a group of Hindu petitioners has approached the Supreme Court, questioning the constitutional validity of key provisions in the law. The petition, filed by Advocate Hari Shankar Jain and others, was mentioned for urgent listing before the apex court on Tuesday by Advocate Vishnu Shankar Jain.

The petition argues that several provisions of the Waqf Act unfairly favor the Muslim community and facilitate the alleged illegal acquisition of public and Hindu religious properties. It claims that these provisions violate Articles 14 (right to equality) and 25 (freedom of religion) of the Constitution by granting "undue benefits" to Muslims while threatening the property and religious rights of Hindus.

The plea specifically targets Sections 4 and 5 of the Act, which empower Waqf Boards to survey and register properties as Waqf without requiring public notice or giving affected parties a chance to be heard. This, the petitioners argue, is "illegal, arbitrary, and non-transparent," leading to wrongful classifications of public lands and Hindu properties as Waqf.

The petition also asserts that the current law has allowed a "Waqf empire" to emerge, generating crores in revenue, allegedly at the expense of the general public and other religious communities. It highlights instances where government land, public infrastructure, and gram sabha land have reportedly been included under Waqf jurisdiction without due process.In their plea, the petitioners have sought several directions from the court, including:Declaring that no actions under Sections 4 and 5 can affect Hindu or non-Muslim properties.

- Government-led identification and restoration of Hindu properties allegedly misclassified as Waqf.
- Empowering civil courts to hear grievances of Hindus and other non-Muslims against Waqf-related actions.
- Mandating public notice and hearing before any property is declared Waqf.



Tamil Nadu CM Stalin Forms High-Level Panel to Review Centre-State Relations

In a significant move aimed at strengthening federalism and enhancing State autonomy, Tamil Nadu Chief Minister M.K. Stalin on Tuesday announced the formation of a high-level committee to review the Constitution, laws, and policies concerning Centre-State relations.

Addressing the Tamil Nadu Legislative Assembly, CM Stalin said the three-member committee would critically examine the existing legal and constitutional framework that governs the balance of power between the Centre and the States. The objective, he noted, is to recommend practical and legal steps that can help protect and reinforce the rights of States within the federal structure of India.

Union Minister Gadkari Promises June Completion Of Mumbai-Goa Highway


Union Minister for Road Transport and Highways Nitin Gadkari announced that the long-awaited Mumbai-Goa highway project will be completed by June this year, bringing long-overdue relief to commuters and travelers heading to the Konkan region. The project, plagued by delays for years, has been a major concern due to poor road conditions and pothole-ridden stretches.

Speaking at the Vasant Vyakhyanmala event organized by Amar Hind Mandal in Mumbai's Dadar area on Monday, Mr. Gadkari said the highway will not only reduce travel time between Mumbai and Goa but also accelerate development across the Konkan belt.

"There were numerous difficulties with the Mumbai-Goa highway, including land acquisition issues and legal disputes," he said. "Fights among family members over land, court cases, and complications in providing compensation all contributed to the delay. But all of that has now been resolved, and we will complete the highway 100% by June."

He acknowledged that the Mumbai-Goa and Delhi-Jaipur highways have been "black spots" in the ministry's infrastructure plans due to persistent challenges.

Looking ahead, Mr. Gadkari expressed optimism about India's road network. "In the next two years, India's road infrastructure will be better than that of the United States," he declared.



The minister also reiterated the government's plan to eliminate physical toll booths nationwide. He said the Centre is set to introduce a new toll policy within the next 15 days. "I won't go into detail now, but once the new policy is implemented, there will be no reason for anyone to complain about tolls," he assured.

The upcoming toll system will leverage advanced technology, including satellite tracking and automatic number plate recognition. This will enable automatic toll deductions directly from vehicle owners' bank accounts, eliminating the need for manual toll collection and long queues at toll pla-

Mr. Gadkari's announcement has raised hopes among daily commuters and tourists who have long struggled with delays, poor road conditions, and toll-related issues along the Mumbai-Goa high-

Petitions in SC Seek Probe into Waqf Law-Related Violence in West Bengal

Two petitions have been filed in the Supreme Court, calling for a court-monitored investigation into the recent violence in West Bengal following the enactment of the Waqf (Amendment) Act. The petitions, which highlight concerns over the law's impact, come in the wake of fresh violence reported in the Bhangar area of South 24 Parganas district on April 14.

The violence erupted as tensions surrounding the Waqf law continue to escalate. The petitions urge the court to step in and ensure a thorough and impartial investigation into the incidents, which are believed to be linked to the new legislation. The Waqf (Amendment) Act, which seeks to amend provisions relating to the management of Waqf properties, has sparked widespread protests, particularly in West Bengal, with critics alleging that it could lead to the mismanagement and unlawful occupation of Waqf lands.

Despite the violence, the police have stated that the situation in Murshidabad, another district that was previously a hotspot for riots related to the law, remains under control. However, the renewed unrest in Bhangar has raised concerns about the law's

potential to ignite further clashes across the state.

Authorities are working to restore peace and order in the affected areas, but the petitions in the Supreme Court highlight the urgency of a fair and transparent investigation into the violence. Legal experts argue that a court-monitored probe would help ensure accountability and prevent further unrest.

The Supreme Court's intervention could play a critical role in addressing the legal and social concerns raised by the protests, which have led to clashes between different communities in the state. As the situation remains tense, many are watching closely to see how the judiciary will respond to these petitions and the ongoing crisis in West Bengal.



Delhi CM Rekha Gupta reacts | Mamata Banerjee calls to private schools' fee hike

'No right to harass students, will take action'

Delhi Chief Minister Rekha Gupta on Tuesday responded strongly to allegations of steep fee hikes by several private schools in the city, assuring parents that the government would not tolerate any exploitation or harassment of students and their families.

Speaking to reporters at the Delhi Secretariat, Gupta confirmed that her office had received numerous complaints from concerned parents about abnormal increases in school fees. "Parents have been meeting me with their grievances. No school has the right to harass or threaten students and their families with unjustified fee hikes. There are rules in place, and if any school is found violating them, strict intervention.

action will follow," she said.

The chief minister added that notices are being issued to schools named in complaints and that authorities would take all necessary steps to protect parents' rights. "Notices will go out today to all those institutions against whom we've received credible complaints," she said.

The matter came into the spotlight after a protest last week by parents of students at a private school in Dwarka. Protesters alleged that their children had been subjected to a "library arrest" — confined to the school library for the past 25 days — after families opposed the fee hike. The incident has sparked widespread outrage and demands for government

Delhi Education Minister Ashish Sood also addressed the situation, confirming that a special inspection team had visited the Dwarka school and that the government had begun a broader crackdown on fee irregularities. "Sub-divisional magistrates (SDMs) have been instructed to inspect schools across the city and collect responses to an 18-point compliance questionnaire," he said.

Sood added that a committee has been formed, comprising the Deputy Director of Education and the Director of Accounts, to further investigate the matter. The education department has also launched a dedicated email ID for parents to submit complaints about arbitrary fee hikes.

Uttar Pradesh Chief Minister Yogi Adityanath launched a sharp critique of West Bengal Chief Minister Mamata Banerjee on Tuesday, questioning her "silence" over the recent violence in Murshidabad and other parts of the state, sparked by protests against the newly-enacted Waqf (Amendment) Act.

The entire Murshidabad has been on fire for the last week, yet the government remains silent. Such anarchy must be brought under control."

Waqf Act Amendments Aim to **Correct Past Mistakes, Not Target** Muslims: Kiren Rijiju

Union Minority Affairs Minister Kiren Rijiju on Tuesday clarified that the recent amendments to the Waqf Act are not aimed at targeting the Muslim community but are instead intended to correct "mistakes of the past." Speaking to the media in Kochi, Kerala, Rijiju emphasized that the move is focused on preventing the forceful and unilateral takeover of land under the guise of Waqf property.

"The intention of the government is clear—there should be no provision for any individual or institution to arbitrarily take over someone else's land," Rijiju said. He noted that earlier provisions in the Waqf Act gave "unprecedented power" to Waqf Boards, which needed to be reconsidered in the interest of fairness and transparency.

Punjab Congress President and Ludhiana MP Amarinder Singh Raja Warring has strongly criticized the AAP-led Punjab government following the registration of an FIR against Leader of Opposition and senior Congress leader Partap Singh Bajwa in connection with a grenade attack incident.

Warring accused Chief Minister Bhagwant Mann of using state machinery to settle political scores. "It seems it was the Chief Minister's personal decision on when and how to send Partap Bajwa to jail. The way the FIR was lodged reeks

of political revenge. Within no time, officers arrived, and the FIR was filed the same evening. This level of coordination clearly shows this was pre-planned," Warring said.

He also alleged that the case was registered merely half an hour after Bajwa gave a media interview, suggesting a larger conspiracy by the government to trap him. "This is not coincidence. It's a strategy. The Punjab government is trying to frame him intentionally," he added.

Warring further questioned why the information used to file the case against Bajwa—

information that had already appeared in multiple Punjabi newspapers—was ignored earlier. "If this was so sensitive, why was no action taken before?" he asked.

Citing the grenade attack on BJP leader Manoranjan Kalia's house, Warring also criticized the performance of Punjab's Intelligence wing. "They had prior information about the attack but did nothing. Now the CM says there was no intel. This reflects complete failure of the government," he asserted.

Issuing a caution to the police, he warned, "I advise the DGP and officers not to act like puppets. Work ethically, because political winds can change anytime."

In his defense, Bajwa clarified that his remarks about bombs in Punjab came from a concerned source who feared for Bajwa's safety. "My source warned me about a serious threat. I shared this to stay alert," he said.





Delhi to Get Six New Air Quality Monitoring Stations as AQI Holds 'Moderate' for Fourth Day



- Total CAAQMS in the city will rise to 46.
- Air quality expected to worsen to "poor" midweek.
- Temperature hits 37.8°C; both max and min above normal.

The Delhi government will install six new Continuous Ambient Air Quality Monitoring Stations (CAAQMS) across the city, bringing the total number of such stations in the Capital to 46. The announcement was made by Delhi Environment Minister Manjinder Singh Sirsa on Monday, who said the initiative is part of the government's ongoing efforts to improve the city's air quality.

The new stations will be set up at key locations including Jawaharlal Nehru University (JNU), Indira Gandhi National Open University (IGNOU), Delhi Cantonment, Netaji Subhash University (West Campus), and the Commonwealth Games Sports Com-

stallation by June 30. The Delhi government is committed to enhancing our pollution-monitoring infrastructure to take informed actions for cleaner air," said Sirsa.

This development comes as Delhi recorded its fourth consecutive day of "moderate" air quality. According to data from the Central Pollution Control Board (CPCB), the city registered (AQI) of 194 at 4 pm on Monday.

The AQI was 178 on Sunday, 166 on Saturday, and 164 on Friday — all in the "moderate" category. However, on Thursday, the city experienced "poor" air with an AQI of 256.

Forecasts from the Air Quality Early Warning System (AQEWS) suggest that air quality is likely to deteriorate "We are targeting completion of in- again, moving into the "poor" cat-

egory on Tuesday and Wednesday, before returning to "moderate" levels by Thursday. The outlook for the following six days indicates a range between "moderate" and "poor."

Meanwhile, temperatures in the Capital continued to climb due to clear skies. Delhi recorded a maximum temperature of 37.8°C on Monday - 1.7°C above the seasonal average. a 24-hour average Air Quality Index The minimum temperature also rose slightly to 21.6°C, up from 20.2°C the previous day, and stood 0.6°C above normal.

Delhi Airport Terminal-2 Shuts For Maintenance, Flights Shifted To **Terminal 1**

IndiGo and Akasa Air will shift all their domestic flight operations to Terminal 1 (T1) at Delhi's Indira Gandhi International Airport (IGIA), as Terminal 2 (T2) will be temporarily closed for maintenance

Currently, both airlines operate several flights from T2, which handles approximately 270-280 air traffic movements and serves over 46,000 passengers daily. With the closure of T2, the newly expanded T1 will now be fully operational, taking over its load.

IGIA, managed by Delhi International Airport Limited (DIAL), has three terminals—T1, T2, and T3—and four runways. While T3 serves both international and domestic flights, T1 and T2 have been used exclusively for domestic operations. One of the runways is also closed for maintenance alongside T2.

IndiGo, which operates the highest number of domestic flights in the country, said it has taken proactive steps to ensure a smooth transition for travelers. "Passengers and travel agents are being notified via SMS, calls, and emails," the airline said in a statement. It also recommended that passengers check their flight terminal details using the airline's website or mobile app before heading to the airport.

Akasa Air also announced on social media that all its Delhi operations will shift to T1 (Terminal 1D) starting April 15. "Our teams are working diligently to ensure a



seamless transition," the airline stated.

According to DIAL, the newly upgraded T1 terminal can now accommodate up to 40 million passengers annually—almost triple its earlier capacity. It will feature 100 check-in counters, including 36 Self Baggage Drop kiosks, 108 Common Usage Self-Service kiosks, and 20 Automated Tray Retrieval Systems to streamline security checks.

Additional facilities include 10 baggage reclaim carousels, and the baggage handling capacity has increased from 3,240 to 6,000 bags per hour. The terminal area has expanded from 55,740 sq m to 206,950 sq m, with integrated arrival and departure zones designed to enhance passenger convenience.

Civil Aviation Secretary Vumlunmang Vualnam assured that T1 and T3 would effectively manage passenger traffic, and congestion is unlikely despite the temporary shutdown of T2.

Air India's Chennai-Delhi Flight Delayed, Passengers **Deboarded After An Hour**

Passengers aboard Air India flight AI 2836 from Chennai to Delhi faced a frustrating delay of nearly five hours on Tuesday, prompting criticism over the airline's handling of the situation. Scheduled to take off at 11:20 am, the flight was delayed due to what airline staff described as a "technical snag."

According to passengers, they were initially boarded onto the aircraft but were asked to deboard after waiting inside for nearly an hour. One passenger said that staff informed them the delay was caused by the unavailability of a crucial part, which had to be flown in from Delhi. The aircraft reportedly had around 180 passengers on board.

The delay sparked a wave of complaints online. In a post on X (formerly Twitter), Air India responded to mounting criticism by stating the flight was delayed "due to operational reasons" and that it would be departing shortly. "Our team is trying their best to minimize the inconvenience caused. Requesting your patience in this

regard," the airline said in a reply to a passenger's complaint.

Frustrated travelers expressed concerns over the lack of clear communication and comfort during the extended wait. Some also questioned why the issue wasn't addressed before boarding had commenced.

The flight, which was originally expected to land in Delhi at 2:15 pm, is now rescheduled to depart at 4 pm and reach the national capital around 7 pm. The delay comes at a time when Delhi's air traffic operations are already under strain. Just last week, the Indira Gandhi International Airport faced massive congestion, with over 450 flights delayed and several others canceled due to a sudden dust storm that disrupted schedules.

This latest disruption adds to growing passenger dissatisfaction with airline operations, especially during peak travel times. Many have called for improved transparency and better contingency planning from airlines like Air India to avoid such inconveniences in the future.

Woman found dead with bullet wounds in Delhi's GTB Enclave

Robert Vadra Deems ED Summons Politically Motivated

Vows Full Cooperation in Gurugram Land Case

Businessman Robert Vadra, the son-inlaw of Congress leader Sonia Gandhi, appeared before the Enforcement Directorate (ED) in Delhi on Tuesday in connection with the Gurugram land deal case. Addressing the media during a break in questioning, Vadra strongly asserted that he would not be intimidated by the government or any investigative agency.

"This government or any agency cannot scare me. I have always cooperated and will continue to do so. I will answer all

their questions," Vadra told ANI, dismissing the summons as a politically motivated move.

Vadra claimed that the ED's latest action was an attempt to divert attention from core national issues. "They summon me whenever they want to distract people from real issues. There's absolutely nothing in this case," he said.

He further highlighted that he had already submitted an extensive set of documents in relation to the same matter. "Back in 2019, I submitted more than 23,000 documents. The case they are referring to is over 20 years old. We have always followed all rules and regulations during any transaction," Vadra added.

Walking from his residence to the ED office earlier in the day, Vadra spoke to reporters and maintained that the case lacked substance. "Case mein kuch nahin hai yaar (There's nothing in this case)... I just hope this ends soon," he said.

Vadra reiterated that such summons are part of a pattern by the ruling government to misuse investigative agencies for political gains. Despite the circumstances, he maintained a calm and cooperative stance. "They can ask me as many questions as they like. I have nothing to hide. Everything is good," he assured.

The Gurugram land case has been under ED scrutiny for years, with allegations related to land deals and potential money laundering. Vadra, however, continues to deny any wrongdoing and frames the investigation as part of a larger political vendetta.

As the inquiry proceeds, Vadra's defiant tone and willingness to engage with investigators signal his intent to fight back legally and politically.

Karnataka Truckers' Strike **Disrupts Economic Activities Amid Fuel Price Hikes and Toll Issues**

Truckers in Karnataka have launched an indefinite strike in protest against rising fuel prices and issues related to toll plazas, which began at midnight between Monday and Tuesday. The strike, led by the Federation of Karnataka State Lorry Owners and Agents Association (FOKSLOAA), is expected to significantly disrupt economic activities in the state.

FOKSLOAA, an umbrella organization representing 129 trucker associations with a membership of six lakh individuals including drivers, agents, and truck owners—has called the strike to address long-standing grievances regarding fuel price hikes and alleged harassment by toll operators. The truckers' strike could have serious repercussions, including higher prices for essential goods, as transportation disruptions are likely to lead to supply chain issues.

Language Row Erupts Over Hindi Display at Bengaluru Airport; **BIAL Clarifies**

Amid ongoing debates over language imposition between the Centre and southern states, a social media post has reignited controversy after claiming that Hindi was removed from display boards at Bengaluru's Kempegowda International Airport (KIA).

The post, shared on X last week, featured a video showing digital flight information screens at the airport displaying details such as flight numbers, destinations, and gate numbers solely in Kannada and English. The user who posted the video said, "Today, a surprise awaited at the T1 terminal of Kempegowda International Airport in Bengaluru. All the digital boards displaying flight information, arrivals, and departures were only in English and Kannada."

Following this, the user shared multiple videos confirming the absence of Hindi on the digital displays, which quickly went viral and sparked a heated debate online.

In response, the Bangalore International Airport Limited (BIAL), which manages KIA, issued a statement clarifying that no changes had been made to the flight information display system. According to a BIAL spokesperson, it has long been standard practice to feature only Kannada and English on digital flight spaces.

61-day fishing ban begins in TN; fishermen urge vigilance against illegal trawling

The 61-day annual fishing ban along Tamil Nadu's coastline commenced early Tuesday and will continue until June 14, as per the Tamil Nadu Marine Fishing Regulation Act, 1983. The ban, enforced during the peak breeding season, aims to safeguard marine biodiversity by preventing mechanised boats and trawlers from venturing into the sea.

As part of the enforcement, nearly 1,500 mechanised vessels across various coastal jetties have been anchored, including 809 boats in Chennai alone. In Thoothukudi district, more than 550 boats at local fishing harbours such as Thoothukudi, Tharuvaikulam, and Vembar are staying ashore.

Fishermen leaders have called on the Tamil Nadu government to ramp up coastal surveillance to prevent illegal fishing during the ban. They have urged for the deployment of the Indian Coast Guard and the state's marine police to monitor the waters and catch violators. "We must ensure no unauthorized fishing takes place, especially by boats from Kanniyakumari or Kerala," said Pugal, Secretary of the Deep Sea Fishermen Welfare Association.

Traditional country boats, however, are permitted to operate during the ban. Offi-



cials have also warned fishermen to avoid venturing into Andhra Pradesh waters, where a complete fishing ban is in place, including for traditional boats. There have been past incidents of confrontation with locals, with fishermen being assaulted and their equipment seized.

To aid the affected fishermen, the Tamil Nadu government has announced a financial relief of ₹8,000 for each registered fisherman. Boat owners are encouraged to use the break for vessel maintenance. However, many in the fishing community

are demanding higher compensation due to inflation and rising prices.

Ahead of the ban, fish prices surged. At the Kasimedu fishing harbour in Chennai, Seer fish was sold at ₹900–₹1,000 per kg, white pomfret at ₹1,100 per kg, and red snapper at ₹500-₹600 per kg. With local fishing halted, markets will rely on fish from neighbouring states like Kerala and Karnataka, while consumers may visit coastal hamlets to buy directly from traditional fishermen.

BJP-AIADMK Reunion: Strategy Over Sentiment



In a dramatic political shift, the BJP and AIADMK have reunited in Tamil Nadu ahead of the 2026 state assembly elections. After a bitter fallout in 2023, this renewed alliance is seen as a strategic move by both parties to counter the rising influence of the ruling DMK and regain lost ground.

Union Home Minister Amit Shah announced the reunion on April 11, confirming that the alliance will contest the 2026 polls under the leadership of AIADMK chief Edappadi K. Palaniswami (EPS). The NDA is also likely to include parties like PMK and TMC (Moopanar), adding more strength to the coalition.

The reunion comes after a disappointing performance in the 2024 Lok Sabha elections. The AIADMK secured 20.46% of the vote, while the BJP-led alliance got 18%. Meanwhile, the DMK-led alliance's share rose to 47%, thanks in part to the opposition split. A united front, BJP and AIADMK believe, can consolidate votes and offer a strong alternative to DMK.

A major development was the replacement of state BJP chief K. Annamalai with senior MLA Nainar Nagendran. While Annamalai did boost the BJP's vote share from 3.7% in 2019 to 11.24% in 2024, his feud with AIADMK—especially with EPS—and controversial remarks about Jayalalithaa and Annadurai damaged ties. Both Annamalai and EPS hail from the Gounder community in western Tamil Nadu, making them rivals for the same voter base.

Nagendran, a Thevar leader from southern Tamil Nadu, brings caste balance and minority appeal. He is aligned with the BJP's broader strategy of combining Hindu Dalits and the most backward classes. The BJP has also agreed not to interfere in AIADMK's internal affairs, and any decisions about sidelined leaders like OPS or TTV Dhinakaran will be taken jointly. Amit Shah's declaration that EPS will lead the alliance also aims to restore stability within the AIADMK.

The reunion is also a response to growing concerns over MK Stalin's rising influence in national politics and the emergence of actor Vijay's TVK party, which has criticized both DMK and BJP—but remained silent on AIADMK.

By reviving this alliance, the BJP and AIADMK aim to rejuvenate their base and challenge the DMK more effectively in 2026, making Tamil Nadu's political landscape more competitive than ever.

It needs to go beyond symbolic gestures and develop a grounded, issue-based political strategy. Whether it's the economy, social justice, federalism, or youth aspirations, the Congress must articulate clear, actionable positions.

The path forward will demand bold decisions—about leadership, alliances, and policy direction. Without this, the party risks becoming inalso its purpose.



Fear, Polarisation, and the Waqf Act: A Volatile Mix in West Bengal

The recently passed Waqf Amendment Act, 2025 has sparked widespread unrest, particularly in West Bengal, where Muslims make up over 27% of the population. Districts like Murshidabad, with a Muslim majority, have witnessed violent protests that tragically led to loss of life and the deployment of central forces under orders from the Calcutta High Court. The violence bears echoes of the 2019 CAA-NRC agitations, especially in the same region.

West Bengal's history of political violence is well known, but the recent pattern of frequent communal clashes is alarming. This trend stems from



growing polarisation — driven in part by both the BJP and Trinamool Congress since around 2017. Their competitive tactics to consolidate vote banks have fostered radicalisation among

both majority and minority groups, bringing religious extremism into the political mainstream and fraying the state's delicate communal balance.

While restoring law and order in affected areas like Murshidabad is urgent, it is equally vital to examine the deeper causes behind the volatility. Since 2014, several central policies including the abrogation of Article 370, the construction of the Ram Mandir, the Assam NRC, the CAA, and moves toward a Uniform Civil Code — have raised fears among Muslims. These developments have left the community feeling targeted and marginalised. The Waqf Amendment Act appears to

reinforce those anxieties.

However, in Bengal, misunderstandings surrounding the Act are also fanning the flames. A clear, fact-based understanding of the legislation is essential to avoid further misinformation and unrest.

The Act, now renamed the Unified Waqf Management, Empowerment, Efficiency and Development Act, introduces significant structural changes. It redefines what qualifies as "waqf" property and centralises control over its management. Waqf properties religious or charitable endowments such as mosques, madrasas, orphanages, and graveyards — are a crucial part of Muslim religious and cultural life. Critics argue that the new provisions infringe on constitutional guarantees of religious freedom, equality before the law, and federalism.

If not handled sensitively, the legislation may worsen communal divisions. The protest movement must stay peaceful and democratic. Political leaders must also resist exploiting the situation for electoral gain. What West Bengal — and India — needs is a commitment to constitutional principles, inclusive governance, and communal harmony, not further escalation of fear and polarisation.

Tejashwi Says Nitish 'Hijacked', NDA Out

RJD leader Tejashwi Yadav launched a sharp attack on Bihar Chief Minister Nitish Kumar on Tuesday, claiming he has been "hijacked" and asserting that the NDA will not return to power in the state after the upcoming assembly elections later this year.

After meeting senior Congress leaders in Delhi, Tejashwi expressed strong confidence in the opposition alliance, 'Mahagathbandhan', winning the Bihar polls. He also said that the alliance partners would collectively decide on the chief ministerial candidate, hinting that the leadership issue would be resolved amicably.

"We will discuss and unanimously decide the CM face. Nitish Ji to hijack ho chuke hain (Nitish Kumar has already been hijacked). NDA is not forming the government in Bihar this time," Tejashwi told reporters. The next meeting of the opposition alliance is scheduled to be held in Patna on April 17, where strategy and seat-sharing are likely to be discussed.

Earlier, Tejashwi had also criticized Nitish Kumar for speaking during the national anthem, calling him "not mentally and physically stable," further intensifying his political attack ahead of the elections.

The political temperature in Bihar is rising rapidly, with both camps preparing for a fierce battle for control of the state later this year.



Jaishankar Slams Pakistan's 'Old Habits'

External Affairs Minister S Jaishankar on Tuesday delivered a sharp rebuke to Pakistan, saying India need not waste its "precious time" on a neighbor that continues with its old habits and refuses to change, even as India has transformed significantly over the last decade.

Speaking at Charotar University of Science and Technology in Gujarat, Jaishankar pointed to the 2008 Mumbai terror attacks as a turning point in India's perception of Pakistan. "That was when the Indian public, cutting across political lines, felt this was too much to tolerate," he said. He noted that while public sentiment was clear, the government of the time may not have responded with sufficient clarity.

Jaishankar highlighted the significant changes in India's global stature and domestic growth since 2014, under Prime Minister Narendra Modi's leadership. "India has changed. I wish I could say the same for Pakistan. Unfortunately, they continue with their bad habits," he said.

He asserted that Pakistan has been given a firm message in recent years — that acts of terrorism will have consequences. "Our economic and political stature has grown globally, but Pakistan sticks to its old playbook," he added.

Jaishankar also criticized Pakistan's role in Afghanistan, saying it tried to play both sides during the US and NATO presence, maintaining ties with both the Taliban and the Afghan government. "Pakistan was playing a double game. But after the Americans left, that game collapsed. The very terrorism industry they nurtured has now turned against them," he remarked.

Responding to a question on why India doesn't talk much about Pakistan anymore, Jaishankar remarked, "Why waste precious time on them?"

The Minister's comments come amid heightened tensions in the subcontinent following debates around the Waqf Amendment Act, which Pakistan had criticized. India firmly rejected Pakistan's remarks, calling them baseless and pointing to Islamabad's poor record on minority rights.

Jaishankar's sharp tone reflects New Delhi's current stance of strategic firmness and minimal engagement with Pakistan until it takes credible steps against cross-border terrorism.

India, US Push Trade Talks Forward

India has taken a significant step toward trade liberalisation with the United States, as both nations signed the terms of reference for a bilateral trade agreement's first phase. Commerce Secretary Sunil Barthwal confirmed on Tuesday that the process has formally begun, with virtual discussions slated for this month and in-person negotiations set for mid-May.

This development follows a February agreement between the two countries to begin working on a phased trade deal, targeting completion by the end of 2025. The broader goal is to increase bilateral trade to \$500 billion by 2030.

India's Astronauts Ready for ISS

India's astronaut-designates are spaceflight. India is covering the ready for liftoff, having completed intensive NASA training ahead of a historic mission to the International Space Station (ISS) aboard the SpaceX Falcon-9 Shubhanshu Shukla has been selected as the primary astronaut, with Group Captain Prasanth Balakrishnan Nair as his backup for the nearly two-week Axiom Mission 4 (Ax-4).

Houston-based Axiom Space announced the successful completion of training at NASA's Johnson Space Center, where the international four-member crew has been preparing since August 2024. Their training included simulations, emergency drills, microgravity adaptation, underwater re-entry practice, and photo documentation tasks. The mission could launch as early as end-May. The team marked the end of training with a traditional NASA patch-hanging ceremony, symbolizing their formal readiness for

full cost of this commercial mission, estimated at \$60–70 million. Group Captain Shukla, an Indian Air Force officer, underwent rigorous drills in fire-fighting, first aid, and Crew Dragon. Group Captain and medical response for in-space emergencies. He also trained in European centers to adapt to zero-gravity environments and re-entry water landings.

> Onboard the ISS, Shukla will perform seven simple scientific experiments developed by the Indian Space Research Organisation (ISRO), contributing to India's long-term space research goals. His personal mission includes photo-documenting daily activities in orbit. This will be India's second human spaceflight, following Wing Commander Rakesh Sharma's milestone 1984 journey to a Russian space station. Shukla, who wasn't born then, will make history again under the Gaganyaan initiative, through ISRO's collaborations with NASA and Axiom Space.

India's Haj Quota Raised to 1.75 Lakh

India's Haj quota for 2025 has been increased to 1,75,025, a significant rise from 1,36,020 in 2014, the year Prime Minister Narendra Modi took office, the Ministry of Minority Affairs announced on

the Ministry said the rise reflects the government's continued efforts to facilitate the pilgrimage for Indian Muslims. "The Government of India accords high priority to facilitating the Haj pilgrimage for Indian Muslims. Due to sustained efforts, India's Haj quota has risen from 136,020 in 2014 to 175,025 in 2025 — finalized annually by Saudi authorities," it stated.

Of the total quota, 1,22,518 pilgrims are being accommodated through the Haj Committee of India under the main quota. The Ministry confirmed that all necessary arrangements including flights, transport, Mina camps, accommodation, and services have been completed in line with Saudi guidelines.

The remaining quota was allotted to 26 Combined Haj Group Operators (CHGOs), which replaced over 800 individual private tour operators due to new Saudi regulations. These CHGOs were tasked with managing arrangements for their share of pilgrims. However, many failed to meet Saudi deadlines and were unable to finalize contracts for crucial services like accommodation and Mina camp bookings.







Trump Warns Iran Amid Renewed Nuclear Deal Talks, Hints at Possible Military Strike

As Iran moves closer to finalising a new nuclear agreement with the United States, President Donald Trump has issued a stern warning to Tehran, asserting that the U.S. will not hesitate to use military force if Iran pursues nuclear weapons. Trump's comments come amid renewed diplomatic engagement between the two countries, with American and Iranian officials recently holding "constructive" talks in Oman.

Speaking to reporters following a meeting between U.S. special envoy Steve Witkoff and a senior Iranian official in Oman, Trump accused Iran of deliberately delaying progress on the deal. "I think they're tapping us along," Trump said. He added, "Iran has to get rid of the concept of a nuclear weapon. They cannot have a nuclear weapon."

When asked whether military options are on the table should Iran continue its nuclear ambitions, Trump responded unequivocally: "Of course it does." He emphasized the urgency of the matter, claiming that Tehran is "fairly close" to developing a nuclear weapon, and urged swift action from Iranian authorities to avoid a severe response.

Despite U.S. suspicions, Iran has repeatedly denied that it is developing nuclear weapons, maintaining that its nuclear program is intended solely for peaceful purposes.

Both Washington and Tehran described the Oman discussions as positive, and a second round of talks is expected to take place in Rome soon. According to a Reuters report, these meetings aim to explore a broad framework for a potential agreement, possibly reviving the spirit of the 2015 nu-

Iranian Foreign Minister Abbas Araghchi is also scheduled to visit Russia this week to consult on the ongoing negotiations. Russia, a signatory to the original 2015 deal, along with China, has remained an active diplomatic player in the matter.

Previous efforts at indirect dialogue during President Joe Biden's administration made little headway, with the last direct U.S.-Iran negotiations taking place during Barack Obama's presidency. Trump had withdrawn from the 2015 deal during his earlier term, prompting Iran to gradually scale back its commitments. In March, Trump re-engaged with Iran after returning to office, sending a direct message to Supreme Leader Ayatollah Ali Khamenei urging talks and cautioning against defiance.

In the deadliest strike on Ukraine this year, two Russian ballistic missiles devastated the northern city of Sumy on Sunday, killing at least 32 people and injuring over 80, according to Ukrainian officials. The brutal attack, which occurred on Palm Sunday, drew widespread condemnation from Ukrainian leaders and prompted fresh calls for international action against Moscow.

President Volodymyr Zelenskyy posted a harrowing video on social media showing bodies lying on the street near a charred bus and destroyed cars. "Only scoundrels can act like this. Taking the lives of ordinary people," Zelenskyy said, adding that the strike targeted civilians on a religious holiday when many were heading to church.

The Russian government has not issued a statement regarding the attack, and Reuters noted that no immediate response was received from Russian authorities.



Interior Minister Ihor Klymenko said the missiles struck a busy street where people were out in vehicles, on foot, or in nearby buildings. He labeled it a "deliberate destruction of civilians" on a day of religious significance. Zelenskyy's chief of staff, Andriy Yermak, re-

Ukraine's Foreign Minister Andrii Sybiha confirmed that Kyiv is sharing detailed evidence of the strike with international partners and institutions. US-China Trade War Escalates, Beijing Suspends Boeing Jet Deliveries

In a significant escalation of trade tensions between the United States and China, Beijing has reportedly directed its domestic airlines to suspend all new aircraft deliveries from American aerospace giant Boeing. The decision, reported on Tuesday, April 15, 2025, comes amid growing friction between the two largest global economies and could have wide-ranging implications for the aviation industry.

The directive appears to be a direct response to recent actions by the United States, including the imposition of steep tariffs on a wide range of Chinese imports. Since President Donald Trump took office in January 2025, the U.S. administration has ramped up protectionist trade policies, with tariffs on Chinese goods now reaching up to 145%. These measures have triggered a retaliatory response from Beijing, further straining bilateral ties.

The aviation industry, which had previously been somewhat insulated from the ongoing tariff battles, is now clearly caught in the crossfire. Boe-



ing, a longtime supplier of commercial aircraft to Chinese carriers, stands to lose significantly from the move. China represents one of Boeing's most crucial international markets, both in terms of current deliveries and future orders.

Industry experts note that the suspension of Boeing deliveries may also signal China's intent to strengthen its domestic aircraft manufacturing capabilities. The country has been aggressively promoting its homegrown aerospace company, COMAC (Commercial Aircraft Corporation of China), which is developing the C919 jet to compete directly with Boeing's 737 series.

India's trade deficit surged to \$21.54 billion in March 2025, a sharp increase from the three-year low of \$14.05 billion recorded in February, according to official data released on Tuesday. The spike in the trade gap was driven by a rise in imports, while export growth remained relatively steady. Economists had earlier predicted the deficit to be around \$16 billion, as per a Reuters poll, making the actual figure significantly higher than expectations.

Merchandise exports in March stood at \$41.97 billion, a notable improvement from \$36.91 billion in February. However, imports saw an even sharper jump, increasing to \$64.51 billion in March compared to \$50.96 billion the previous month. This imbalance between exports and imports led to the wider trade gap.

For the fiscal year 2024–25, India's total merchandise exports were recorded at \$437.42 billion, slightly higher than the \$437.07 billion reported in FY24. Meanwhile, the country's overall exports, which include both goods and services, rose by 5.5% year-on-year to reach \$820.93 billion, reflecting growth in service sector earnings and resilient global demand in certain sectors.

March also saw a rise in total exports (merchandise plus services), reaching \$73.61 billion—an increase from \$71.71 billion in the same month in 2023. On the flip side, overall imports for March rose to \$77.23 billion, compared to \$73.63 billion a year ago, pointing toward heightened domestic consumption and possibly increased input costs for Indian manufacturers.

Global trade volatility and ongoing geopolitical tensions, including tariff threats from the U.S. and other policy shifts, are believed to be influencing trade flows. Analysts suggest that the widening trade deficit could place additional pressure on India's current account, especially if global commodity prices remain elevated.

As the new fiscal year begins, policymakers are expected to closely monitor global developments and adjust trade strategies to safeguard the country's economic interests while aiming to boost export competitiveness.



India's Wholesale Inflation Drops to Four-Month Low of 2.05% in March 2025

India's wholesale inflation eased to a four-month low of 2.05% in March 2025, down from 2.38% in January, according to official data released by the Ministry of Commerce and Industry on Tuesday. The latest figure came in below economists' expectations, as a Reuters poll had projected the Wholesale Price Index (WPI)-based inflation to be around 2.5%.

WPI inflation, often seen as a proxy for producer prices, provides an indication of cost pressures faced by manufacturers and can be a leading indicator for retail inflation trends. The softening in March inflation was primarily attributed to a moderation in food and primary articles' prices.

Government data showed that the easing inflation rate in March was largely due to a slower rise in the prices of food articles, primary goods, and fuel-related



commodities. However, prices of manufactured food products, textiles, and electricity remained on an upward trend, contributing to the overall positive rate of inflation. Wholesale food inflation, in particular, saw a significant decline, slowing to 4.66% in March from 5.94% in February. This decline came amid easing prices of vegetables and pulses. The inflation rate for primary articles also dropped notably to 0.76% from 2.81% in the previous month.

On the other hand, inflation in manu-

factured products continued to be positive, reflecting higher input costs and sustained demand in sectors such as food processing, textiles, and chemicals.

The data signals some relief for policymakers who are keeping a close watch on inflation trends, especially as global commodity prices remain volatile and could impact domestic pricing in the coming months. While WPI inflation has moderated, retail inflation continues to stay above the Reserve Bank of India's (RBI) medium-term target, keeping the central bank cautious in its monetary policy stance.

Experts believe that the moderation in wholesale inflation may help ease cost pressures on businesses, which could eventually reflect in consumer prices. However, continued monitoring of food and energy prices will be essential to ensure price stability going forward.

SEBI Cracks Down on Gensol Engineering Promoters Over Fund Diversion, Halts Stock Split

ties and Exchange Board of India (SEBI) has barred Gensol Engineering Ltd (GEL) and its promoters, Anmol Singh Jaggi and Puneet Singh Jaggi, from participating in the securities market until further allegations of financial misconduct, including fund diversion and falsification of documents.SEBI has also directed Gensol Engineering to suspend its recently announced stock split, citing ongoing investigations into irregularities in the company's financial practices. Additionally, the market watchdog has appointed a forensic auditor to conduct a thorough examination of the company's books.

The action follows a complaint received in June 2024, which alleged manipulation of GEL's share prices and misappropriation of company funds. Upon

The decision comes amid serious In a 29-page interim order, SEBI stated, "The prima facie findings have shown mis-utilisation and diversion of funds of the company (GEL) in a fraudulent manner by its promoter directors, Anmol Singh Jaggi and Puneet Singh Jaggi, who are also the direct beneficiaries of the diverted funds."

> It further revealed that the promoters submitted forged conduct letters, falsely claiming they were issued by company lenders. These misleading documents were reportedly used to deceive SEBI, credit rating agencies, lenders, and investors.

SEBI accused the Jaggi brothers of running GEL like a personal proprietorship rather than a publicly listed company. Funds were allegedly siphoned off to related parties and used for purposes unrelated to business operations. The regulator warned that such diversions, if not recovered, may have to be written off, resulting in financial losses to shareholders."The company reflects a culture of weak internal controls," SEBI's wholetime member Ashwani Bhatia stated. "There is prima facie evidence of blatant violations of corporate governance rules. Borrowed funds ring-fenced for specific purposes were freely rerouted at the whims of the promoters."This crackdown underscores SEBI's commitment to upholding market integrity and protecting investor interests, as the forensic probe into Gensol Engineering continues.





Eagle and Flag Over Jagannath Temple

An unusual and symbolic moment near the Jagannath Temple in Puri has captivated devotees and netizens alike. A video of an eagle soaring into the sky while carrying what appeared to be a sacred cloth resembling the temple's flag has gone viral, sparking widespread theories and interpretations online.

The incident occurred around 5 PM on Saturday evening, just as a brief Nor'wester storm swept through the coastal city. The eagle was seen circling above the Srimandir, clutching the cloth, before flying toward the sea and vanishing. Eyewitnesses reported that it first approached the temple's western gate before heading seaward, disappearing from sight.

The origin of the cloth remains uncertain. Though it strongly resembles the sacred flags traditionally flown atop the Jagannath Temple, officials have yet to confirm whether the item was indeed a temple flag or simply a similar-looking piece of fabric. Regardless, the symbolism has stirred deep sentiment among devotees and observers.

While some online speculations have labeled the event a "bad omen," suggesting it could forewarn of conflict or disaster, many others interpret it positively. One viral comment likened the event to divine intervention, suggesting that Garuda — the mythical eagle mount of Lord Vishnu — was carrying Lord Jagannath's blessings skyward. The act, they said, symbolizes renewal, divine protection, and the global spread of Lord Jagannath's spiritual energy.

Theories continue to swirl online, blending mythology, faith, and a sense of cosmic mystery. For many, the eagle's flight isn't just a curious natural event but a powerful, celestial metaphor — one that connects earth and sky, tradition and transcendence.

As discussions grow, the moment stands as a reminder of how deeply faith and symbolism are interwoven in India's spiritual landscape — and how even a fleeting sight in the skies above a temple can ignite imaginations and stir the collective soul.

The suborbital flight, which launched from western Texas, carried six women, including Bezos' fiancée Lauren Sanchez, past the Karman Line — the widely accepted boundary of space — reaching over 60 miles above Earth. The entire trip lasted around 10 minutes.

After landing safely, Perry shared her thoughts, calling the experience "a 10 out of 10." She added, "You never know how much love you have to give and how loved you are until the day you launch." She was even seen kissing the ground after exiting the capsule. In a heartwarming moment, she sang What a Wonderful World during the flight, sharing that the act came from a deeper spiritual impulse rather than a performance mindset.

Other members of the crew included civil rights activist Amanda Nguyen, entrepreneur and former NASA rocket scientist Aisha Bowe, TV presenter Gayle King, and film producer Kerianne Flynn. The journey symbolized empowerment, exploration, and a message of inclusion in the field of space

Zuckerberg Testifies in Antitrust Trial



Meta CEO and co-founder Mark Zuckerberg appeared in court on Monday in a pivotal U.S. antitrust trial, where Meta is accused of monopolistic practices tied to its acquisitions of Instagram and WhatsApp. The case, led by the Federal Trade Commission (FTC), alleges that Meta leveraged its dominant market position to eliminate potential competition before it could emerge.

At the heart of the case are Meta's high-profile purchases: Instagram in 2012 for \$1 billion, and WhatsApp in 2014 for \$19 billion. FTC lawyers argue that these takeovers weren't just strategic business decisions, but calculated moves to suppress rivals and maintain Facebook's dominance in the social media landscape.


According to the FTC, Meta's behavior fits a pattern of "buy or bury" — a tactic used to absorb emerging competitors that posed any threat to Facebook's supremacy. Zuckerberg's internal communications and past public comments are key components of the case, as they reportedly reflect his belief that controlling fast-growing platforms was crucial to keeping Facebook

Zuckerberg's testimony is considered a landmark moment, given his central role in the company's strategic direction. On the stand, he defended Meta's actions, arguing that both Instagram and WhatsApp were significantly developed and scaled after acquisition, suggesting their success was driven by Meta's investments and innovation not monopolistic suppression.

This case is one of the most significant antitrust challenges faced by a tech giant in the U.S. in recent years and could set a precedent for how regulators approach big tech consolidation. If the FTC succeeds, it could potentially lead to court-ordered divestitures of Instagram and WhatsApp, reshaping the future of Meta and the social media industry at large.

The trial continues, with more testimonies and evidence expected in the coming weeks.

TUP SI Mistakes Judge for Accused



Tn a bizarre case of negligence, a **⊥**sub-inspector in Uttar Pradesh attempted to arrest a judge instead of the actual accused in a theft case, leaving officials stunned and the incident widely ridiculed.

The incident occurred in Firozabad district, where a theft case dating back to 2012 involved an accused named Raj Kumar alias Pappu. The Chief Judicial Magistrate (CJM), Nagma Khan, had issued a non-bailable warrant against Raj Kumar and later invoked Section 82 of the Criminal Procedure Code

(CrPC), proclaiming him as an ab-

However, instead of locating Raj Kumar, Sub-Inspector Bhanwarilal bizarrely misread the legal order. Believing the proclamation was against CJM Nagma Khan herself, he launched a search for the judge. Mistaking her for the accused, he even visited her official residence and later submitted a report to the court stating that "Nagma Khan" was not found at the mentioned address.

The confusion came to light on

March 23 during a court hearing when the case file was reviewed. It was then discovered that the sub-inspector had wrongly assumed the name of the judge as that of the proclaimed offender. According to Bar and Bench, the SI had failed to understand who issued the order, for whom it was intended, and what action was required.

The court came down heavily on

the SI for his gross negligence, stating that such carelessness from a police officer reflects poorly on the law enforcement system. The court noted that not reading judicial orders properly and mistaking a magistrate for a criminal was a serious dereliction of duty. The judge labeled the act a violation of fundamental rights and directed senior police officials to initiate disciplinary action against the SI. As a result, Sub-Inspector Bhanwarilal has been suspended, and the court has forwarded its order to the Inspector General (IG) of Agra Range to ensure such incidents are not repeated in the future.

Fitness Influencer Slammed for **Train Stunt**

Afitness influencer from Delhi is facing widespread backlash after a video of her performing a dangerous stunt near a speeding train went viral. Piku Singh, known for her unique running videos on Instagram, shared a clip of herself sprinting alongside a railway track as a train zoomed past her at high speed. The post was captioned simply: "Running with train." While the video gained traction quickly, garnering views and comments, it also sparked fierce criticism from viewers who called out the recklessness of the act. Many argued that such stunts not

only put the performer's

life at risk, but could also

inspire copycat behavior, especially among impressionable followers seeking viral fame.

Despite some users admiring her fitness and dar-

ing, the overwhelming sentiment was negative. Critics questioned her motive, stating that chasing virality should not come at the cost of safety.


