YCP MP Mithun Reddy Files Petition for SIT Investigation

- Mithun Reddy requests SIT probe in HC petition
- HC directs CID to review investigation recording **Petition seeks**
- transparency and legal oversight in inquiry

YSR Congress Party (YSRCP) MP Mithun Reddy has filed a petition in the High Court seeking a Special Investigation Team (SIT) inquiry into a matter of public concern, requesting that lawyers be present during the investigation. The petition calls for a transparent and thorough examination of the case, ensuring that all legal procedures are followed.

In response, the High Court directed the Criminal Investigation Department (CID) to examine the issue surrounding the recording of the investigation. The court's directive underscores the importance of maintaining clarity and accountability during the probe.

The development follows concerns over the integrity of the ongoing investigation, with Mithun Reddy emphasizing the need for independent oversight. His plea to have lawyers present during the investigation highlights his desire for transparency in the process.

The High Court's involvement has brought greater attention to the matter, with legal experts expecting further scrutiny of the CID's actions as they review the recording protocols. This case could set a significant precedent for future investigations, especially in high-profile cases involving political figures.

Mr. YS Jaganmohan Reddy, Former Chief Minister of Andhra Pradesh, has become weak after the exit of Mr. Vijayasai Reddy from the party. remains to be seen. **ED Seizes ₹793 Crore Assets in Jagan DA**

- ₹377 Cr land part of Bharti Cements quid pro quo
- · ED links illegal Kadapa mining to political favoritism

The Enforcement Directorate (ED) has seized assets worth ₹793 crore from Dalmia Bharat Group companies in connection with the disproportionate assets case involving former Andhra Pradesh Chief Minister Y.S. Jaganmohan Reddy. The assets include land valued at ₹377 crore, allegedly given as quid pro quo for investments in Bharti Cements Corporation. According to the ED, Dalmia Cement secured illegal limestone mining leases in Kadapa district during the previous YSRCP regime. In return, the company made substantial investments in Bharti Cements, promoted by Jagan. These dealings, the ED noted, constitute

a clear violation of financial and ethical norms.





The investigation stems from FIRs registered by the CBI in 2011, followed by a chargesheet in 2013. Based on these FIRs, the ED initiated its probe under the Prevention of Money Laundering Act (PMLA). The agency found that Dalmia Bharat MD Puneet Dalmia had entered into an understanding with YSRCP MP V. Vijayasai Reddy to secure benefits in exchange for investing in Bharti Cements.

Roja's Remarks on Tirumala Cow **Deaths and Dy CM Spark Political Row**

- RK Roja accused the TDPled coalition of silence over alleged cow deaths in Tirumala Gosala.
- She questioned Pawan Kalyan's commitment to Sanatana Dharma, indirectly commenting on his son.
- Jana Sena leaders and supporters expressed outrage over Roja's remarks on social media.

Former YSRCP Minister RK Roja launched a scathing attack on the TDP-led coalition government, alleging inaction over reported cow deaths in the Tirumala Gosala. Referring to former TTD Chairman Bhumana Karunakar Reddy's claims of numerous cow deaths since the coalition came to power, Roja demanded a thorough probe and strong action against those responsible.

She criticized the silence of the government despite alleged irregularities atop the sacred Tirumala hills and questioned why Pawan Kalyan, who calls himself a follower of Sanatana Dharma, remained silent. "Is this the price of packages and positions?" she asked, implying political compromise. Roja warned that those harming Kaliyuga Deity Sri Venkateswara Swamy must face strict punishment. Roja also took veiled digs at TDP chief Chandrababu Naidu, claiming he knows the real story behind misdeeds related to the temple's assets and sanctity. She warned both Naidu and Pawan Kalyan not to interfere with the spiritual sanctity of Tirumala. However, her indirect comments referencing Pawan's son, Mark Shankar, sparked backlash. The child, who is recovering from a serious school fire accident in Singapore, became the subject of political controversy after Roja's remarks. Jana Sena supporters and leaders expressed strong disapproval, condemning Roja for dragging a child into political discourse.

Tirumala Cow Deaths Spark Political Showdown at Cow Shelter

- Bhumana Karunakar Reddy alleged 100 cow deaths at the Tirupati TTD Gosala in 3 months.
- **TDP** leaders questioned his absence after challenging him to a joint inspection.
- · Police presence and restrictions led to a protest and heated exchanges between leaders.

The political battle over alleged cow deaths at the Sri Venkateswara Cow Shelter in Tirupati escalated on Thursday, with former TTD Chairman and YSRCP leader Bhumana Karunakar Reddy claiming that over 100 cows have died at the Gosala in the past three months. The issue has triggered a war of words between the ruling coalition and the opposition.

TDP State President Palla Srinivasulu publicly challenged YSRCP leader YS Jagan Mohan Reddy to visit the Gosala, invoking Bhumana's name, prompting Bhumana to accept the challenge. However, due to concerns over law and order, police issued strict directives prohibiting rallies or protests during the inspection.

Since morning, police deployed forces outside Bhumana's residence, preventing him and other YSRCP



leaders, including Tirupati MP Gurumurthy and former MLAs, from proceeding to the site. In protest, Bhumana staged a sit-in while arguing with police to allow a small team to inspect the premises.

Meanwhile, coalition MLAs and arrived at the Gosala and questioned Bhumana's absence. MLA Pulivarthi

Nani contacted Bojjala Sudheer Reddy and insisted they were waiting and willing to provide an escort. Bhumana reportedly agreed to come.

Later, police permitted Gurumurthy to enter the Gosala. However, coalition MLAs mocked leaders from the joint Chittoor district his solo presence and asked why Bhumana, the original challenger, had not come. Gurumurthy claimed



he had scaled the wall as police denied entry. A heated exchange followed, and the MP exited the premises. The situation continues to stir political tension as both sides trade accusations over the handling of the Gosala and the alleged cow deaths.


On the occasion of Good Friday, Chief Minister N. Chandrababu Naidu extended a meaningful gesture to Christian pastors across Andhra Pradesh. The CM approved a monthly honorarium of ₹5,000 to 8,427 pastors across the state, fulfilling a pre-election promise made by TDP National General Secretary Nara Lokesh during his Yuvagalam Padayatra in 2023.

The honorarium will be released for the seven-month period from May to November 2024, amounting to ₹35,000 per pastor. To facilitate this, the coalition government has sanctioned ₹30 crore. Dy CM Pawan Kalyan Investigation Ordered into Leopard Death

In a concerning incident, a female leopard was found dead after falling into a trap near Ponnutipalaem in Annamaya district. Deputy Chief Minister and Minister for Forest and Environment, Pawan Kalyan, has ordered a thorough investigation into the death. It was reported that the leopard struggled for hours before succumbing to its injuries. Tragically, two cubs were discovered dead in the womb of the leopard.

Upon receiving the information, Pawan Kalyan immediately directed that the matter be investigated thoroughly. He appointed Principal Chief Conservator of Forests (PCCF), Chalapathi Rao, as the officer in charge of the investigation. The Deputy Chief Minister also instructed the investigation team to review the field-level information and the response of the relevant authorities following the inci-

Pawan Kalyan emphasized the need for increased vigilance against hunters who set traps for animals in both forest areas and nearby villages. He stressed that such crimes must be actively monitored and prevented. Additionally, Forest Department Advisor Mallikarjuna Rao was tasked with overseeing the

This incident highlights the ongoing challenges of wildlife protection and the dangers posed by illegal hunting practices. The investigation is expected to reveal key details about how the trap was set and who may be responsible for the death of the leopard and its cubs. Vijayasai Reddy Avoids SIT **Inquiry On Liquor Scam Case**

In a significant turn of events, Vijayasai Reddy, a key political figure, has managed to avoid the scheduled SIT inquiry regarding the liquor scam by opting to appear a day earlier than required. Originally served with a notice to appear for questioning on the April 18th, Reddy made the decision to respond to the summons a day ahead of the scheduled inquiry date.

The Special Investigation Team (SIT), tasked with investigating the controversial liquor scam, had issued notices to Reddy, as part of its ongoing probe. As per the current updates, SIT officials are stationed at the CP office in Vijayawada, awaiting his arrival for questioning. Reddy's decision to appear ahead of schedule has raised eyebrows, with some speculating whether the move is an attempt to get ahead of the investigation. While no official statement has been made about the timing of his appearance, it is seen as a strategic move in the face of mounting pressure from the investigation.

The liquor scam, which has become a major topic of discussion in political circles, has now taken a new turn with this development. As the SIT continues its probe, this inquiry is expected to shed light on key aspects of the case. Authorities have indicated that this is a critical step in the investigation, and more information may emerge depending on the details disclosed during the questioning.

Minister Nadendla Manohar Urges **Bankers to Support Development**

Civil Supplies Minister Nadendla Manohar has called on bankers to actively cooperate with the government in supporting welfare and development programs, especially those benefiting farmers and ration beneficiaries. He made these remarks during a key meeting held with bankers at the Civil Supply Bhavan in Kanur, Vijayawada on Thursday.

Manohar highlighted that lakhs of people in the state depend on government-provided ration every month. Stressing the importance of smooth ration distribution and financial support for farmers, he said that the previous administration had left dues of ₹1,674 crore unpaid to farmers. However, since the new coalition government came into power, these outstanding payments were settled, and nearly ₹24,000 crore has been disbursed to farmers in just nine months.

As part of administrative reforms, the Minister introduced a new technology-driven approach for paddy procurement. Notably, a WhatsApp-based system was launched, through which 17,000 farmers successfully sold their grain. During the recent Kharif season, 38 lakh metric tons of grain were pur-



chased from six lakh farmers. Manohar said that funds were deposited into farmers' accounts within 24 hours of grain procurement, boosting their confidence and satisfaction.

To prevent ration diversion, the Minister said the government had cracked down on the ration mafia and planned to issue new ration cards using advanced tech. Additionally, AI-powered cameras would be installed at all house godowns to ensure transparency and curb malpractice.

He urged bankers to reduce interest rates and extend better financial support to strengthen these developmental initiatives. "Bankers should stand with the government and the people to ensure seamless execution of welfare programs," he said.

AP Govt Issues Ordinance on SC Classification

In a significant move toward social justice, the Andhra Pradesh government led by Chief Minister N. Chandrababu Naidu has officially issued the Scheduled Castes (SC) classification ordinance. YS Sharmila Slams PM Modi Ahead of **Amaravati Visit**

As Prime Minister Narendra Modi gears up to visit Amaravati on May 2 to resume the capital's reconstruction works, Andhra Pradesh Congress President Y. S. Sharmila has launched a scathing attack, demanding that he answer several key questions before laying another foundation stone. In a sharp social media post, Sharmila mocked the upcoming event, saying, "Modi's contribution to Amaravati so far is just a little water and a handful of soil." She accused him of repeating the same symbolic gestures while offering no real progress. "Back then, he used a Air motor to sprinkle mud on the scalp of Andhra's... Now he's coming to lay lime again," she said, calling it a mockery of the people's aspirations.

Sharmila alleged that Amaravati, once a symbol of Andhra's self-respect, has been reduced to a mere "Modi foundation project" with no substance. She questioned why the Prime Minister, who promised to build a capital grander than Delhi, remained silent for nine years while the YSRCP pushed the three-capital idea. "Why didn't you stop your adopted son? Why no word when farmers came all the way to Delhi?" she asked.

Calling the BJP's handling of the capital issue a "complete fraud," she slammed Modi for boasting about Amaravati while betraying the state on key bifurcation promises. She criticized the reduction in Polavaram dam height and asked whether the final height was 45 meters or 41.

Sharmila demanded full central funding for Amaravati, implementation of the 10-year special status promise, and decisive steps on pending issues like Kadapa Steel, industrial corridors, and merging Vizag Steel with SAIL.

Finally, she declared that the failure to build a capital in 10 year's rests with "A1 Modi, A2 Chandrababu, and A3 Jagan," urging accountability before any fresh inauguration.

Former TTD Chairman Bhumana Slams Govt. Will Stand by My Version

Former TTD Chairman and YSRCP leader Bhumana Karunakar Reddy alleged that the ruling coalition government deliberately blocked his visit to the TTD Gosala to avoid exposure of the truth behind largescale cow deaths. Speaking to the media on Thursday, he said that despite informing authorities about the visit by five YSRCP leaders, including MP Gurumoorthy, former ministers Narayanaswamy and RK Roja, and an MLC, police personnel prevented their entry.

"We planned to visit the Gosala and prove our claims, but since morning a large contingent of police surrounded our homes. We staged a sit-in protest, but the SP



said only I could go after the ruling party delegation leaves. Even when I informed Chandragiri and Srikalahasti MLAs about this, they denied police involvement — but own figures say 170 cows died the police did not yield," Bhumana since June 2023, but our estimate said.

He reiterated his statement that the deaths of cows occurred on a large scale after the coalition government assumed office. "TTD's is even higher. I challenge them again — allow us into the Gosala with five leaders and let's prove our version."

Bhumana said that during the YS-RCP rule, a Vigilance inquiry was ordered into Gosala operations, and former EO Jawahar Reddy, a veterinary doctor, led cow welfare reforms. "We brought 550 cows from across India and introduced Navneetha Seva. This government stopped all our initiatives and is levelling false and baseless allegations," he added.

Calling the coalition's tenure full of unsavoury incidents, from liquor sales to assaults in Tirumala, he said, "Even after eleven months, they couldn't prove a single allegation. I stand by my word and am ready for a visit anytime."

Appalaraju Slams Amaravati Project Costs, Alleges Mismanagement and Neglect of Public Welfare

Former Minister and YSRCP Doctors' Wing President Seediri Appalaraju launched a strong attack on the coalition government, accusing it of financial mismanagement and skewed priorities in the Amaravati capital project. Speaking to the media on thursday, Appalaraju claimed that Amaravati's projected cost has been inflated from Rs. 44,000 crore to Rs. 77,000 crore, with the secretariat's cost alone doubling from Rs. 2,271 crore to Rs. 4,689 crore. He said the state has borrowed Rs. 1.47 lakh crore in the last 11 months without implementing a single major welfare scheme. "The government is treating Amaravati like a real estate venture, ignoring essential services like schools, medical colleges, and welfare programs such as Amma Vodi and Rythu Bharosa," he said. Appalaraju criticized the government for misleading the 16th Finance Commission by inflating funding requirements, citing efforts to secure Rs. 44,000 crore more after already obtaining Rs. 31,000 crore loans from HUDCO, World Bank, AIB, and KfW. Despite flood warnings from World Bank and IIT Chennai, the government is planning to spend Rs. 1,400 crore on flood prevention, he added.

Alleging insider trading, he accused CM Chandrababu Naidu of altering Amaravati's infrastructure plan to benefit close associates. "TCS was given Rs. 100 crore worth of land in Visakhapatnam for just 99 paise," he said.

"Atheist Preaching Hinduism is Shameful": Minister Anam **Defends TTD on Cow Deaths**

- Minister Anam slams critics, says Tirumala sanctity shouldn't be questioned by non-believers
- Clarifies that cow deaths in TTD goshala are due to natural causes, not negligence
- Labels accusations against TTD and government as baseless and politically motivated

Minister for Endowments Anam Ramanarayana Reddy came down heavily on critics questioning the management of the TTD goshala and alleged cow deaths, calling their remarks painful and misleading. He asserted that no negligence occurred in the maintenance of the cows under the Tirumala Tirupati Devasthanams (TTD) and condemned the politicization of the issue.

Addressing the media, Minister Anam said, "It is shameful that an atheist is now preaching to us about Hinduism, the sanctity of Tirumala, and the welfare of cows. Those who don't believe in the traditions of our temples have no moral right to criticize them."

He clarified that cow deaths at the TTD goshala have occurred only due to natural reasons such as age or health-related complications. "It is extremely painful to hear baseless statements that these cows died because of negligence by TTD or the government. Such comments are made only to mislead the public and tarnish the image of our revered institutions," he

The minister further noted that the TTD



maintains its goshala with high standards of care and that routine deaths due to natural causes are being deliberately misrepresented. He added that strict protocols are followed in the upkeep and treatment of animals in all temple-run facilities.

Katasani Rambhupal **Reddy Accuses Police of Partiality and Acting on TDP's Instructions**

Food, Civil Supplies, and Consumer Affairs Minister Nadendla Manohar chaired a meeting with oil company representatives at the Civil Supply Bhavan in Vijayawada on Thursday to review the implementation of the Deepam-2 scheme and address concerns regarding the subsidy deposit process.

Minister Manohar reiterated the coalition government's commitment to fulfilling its promise of providing three free gas cylinders per year to every girl child under the Super Six guarantee. He addressed the technical problems raised by oil companies regarding subsidy deposits for cylinders delivered in April to beneficiaries who booked by March

In response, the Minister directed officials to ensure the immediate deposit of subsidies into the accounts of affected beneficiaries. He also emphasized the need for a comprehensive awareness campaign about the Deepam-2 scheme to ensure maximum

The Minister highlighted that 99.22 lakh beneficiaries have already received their first free cylinder. He reminded attendees that the government has allocated Rs. 2,684 crore for the scheme, aimed at making cooking gas affordable for low-income households. Under the scheme, beneficiaries are required to pay the full price for their cylinders upfront, with delivery taking place within 24 hours in urban areas and 48 hours in rural areas. The amount paid is then reimbursed within 48 hours. Beneficiaries have the opportunity to book three free cylinders in a year, within a four-month period.

Minister Manohar also encouraged beneficiaries facing issues or errors to contact the toll-free number 1967 for assistance. Civil Supplies Commissioner Saurabh Gaur, MD Manazir Jilani, and representatives from major oil companies participated in the meeting.

Child Recovers After Rare Surgery at Ankura Hospital

A five-year-old girl who suffered from continuous urine dribbling for four years has been successfully treated at Ankura Hospital, Vijayawada, after a rare diagnosis of ectopic ureter. This marks a significant milestone in pediatric healthcare in the region.

The child had been misdiagnosed with a neurogenic bladder and underwent multiple treatments across hospitals without success. When brought to Ankura, a detailed evaluation by the pediatric urology team revealed that urine was leaking from the vaginal area—an indicator of ectopic ureter, a rare congenital condition.

Further imaging through ultrasound and MRI urogram confirmed that the girl had a duplex kidney system on the left side. The upper ureter was draining abnormally into the vagina instead of the bladder. The hospital team performed a laparoscopic uretero-ureterostomy, a minimally invasive procedure to correct the drainage.

The child is now free from discomfort and embarrassment that had affected her for years.

The surgery was led by Dr. Varunkumar M (Pedi-



atric Surgeon & Urologist), with support from Dr. Nagaraj (Pediatric Anaesthetist), Dr. Murali Krishna B (Pediatric Nephrologist), and guidance from Dr. VVS Chandrasekharam (Senior Pediatric Urologist). Dr. Vijay Kumar, Medical Director of Ankura Hospital, highlighted the team's precision in diagnosis and treatment. "In girls with continuous urinary dribbling, ectopic ureter must be considered. Accurate diagnosis leads to lasting relief."

Former Minister Perni Nani Files Complaint After Attack on YSRCP Leader's Home

Chinta Mohan Slams BJP Over Press Freedom, Waqf Act, and Reservation Neglect

Senior Congress leader and former Union Minister Dr. Chinta Mohan came down heavily on the BJP-led central government, stating that democracy in India is becoming invisible like the Arundhati star. Addressing the media in Visakhapatnam on Thursday, he warned that freedom of the press is under severe threat and criticized media houses for prioritizing profits over journalistic integrity.

Dr. Chinta Mohan slammed the controversial "Waqf Board Act", calling it unconstitutional and unnecessary. "Neither Vajpayee nor Advani brought such a law. Why now?" he questioned, criticizing Solicitor General Tushar Mehta's arguments in the Supreme Court. He alleged that the bill, introduced by BJP MP Jagadambika Paul and not by any parliamentary committee, will not stand legal scrutiny.

Raising serious questions about selective justice, he cited an incident in Delhi where ₹500 crore allegedly burned in a judge's house went unnoticed by the ED and CBI. "If ₹5 lakh is found in a former CM's house, arrests follow. But ₹500 crore in a judge's house gets no case?" he asked, suggesting the money might be linked to a retired Chief Justice.

Calling for equitable representation, he demanded classification in mining leases, government contracts, and legal appointments. He criticized TDP chief Chandrababu Naidu for ignoring OBCs and SCs in key sectors, urging the AP government to emulate Karnataka's reservation model in contracts.

Condemning ED notices to Sonia and Rahul Gandhi, he said, "Modi didn't even greet Rahul in Parliament. Is this how democracy behaves?"

YCP Leader P. Ravindranath **Reddy Criticizes Govt Over Electricity Rate Hike**

A Democracy Denied

How Gandhiji blocked Sardar Vallabhai Patel and Democracy

India's independence was hard-won—and so were its first steps as a sovereign nation. But one of its earliest and most consequential decisions wasn't made through a democratic vote or policy debate. It came down to Gandhi's influence.

In 1946, the Congress party needed to choose its leader—who would, by default, become independent India's first Prime Minister. Out of 15 Pradesh Congress Committees, 12 nominated Sardar Vallabhbhai Patel. None backed Jawaharlal Nehru. Yet Nehru was chosen. Why? Because Gandhi intervened. He believed Nehru, with his global image and appeal, was the better choice to represent India on the world stage.

That decision changed the course of Indian history. And the more we look back, the clearer it becomes: the promise of Nehru's international image did not deliver in material terms, while Patel's practical leadership was sidelined at a critical moment.

Nehru's Rise to Prime Minister:

Most Dishonest and undemocratic episode in Indian history

Jawaharlal Nehru did not receive a single vote from Congress's provincial committees when the question of leadership came up in 1946. The overwhelming choice was Sardar Vallabhbhai Patel. Yet, Mahatma Gandhi intervened and nominated Nehru. Instead of stepping aside on moral grounds—knowing he lacked majority support—Nehru accepted the position.

This wasn't democratic. It was a back door ascent , driven by personal ambition and Gandhi's influence, not by the will of the majority. Despite this, the Congress party and later narratives painted Nehru as a symbol of democratic values and integrity. That image fabricated by concealing the real facts. His ascent was not just undemocratic—it was a betrayal



of the very principles of democracy.

Nehru's Global Image: Overrated

Gandhi's argument was that Nehru's stature as a statesman would help India gain recognition, respect, and possibly support from major powers. Nehru had relationships abroad, especially in Europe, and was seen as modern, west-

ern-educated, and articulate.

But that global prestige never translated into tangible benefits for India's economy or development in those early years. International banks didn't offer large loans or aid packages. The West didn't rush in to support India financially or strategically. Despite being a founding leader of the Non-Aligned Movement, Nehru struggled to secure meaningful foreign investment or alliances that might have lifted India's struggling economy.

Instead, India chose a path of self-reliance mixed with socialist planningnationalizing industries, regulating private enterprise through the License Raj, and shutting out foreign capital. These policies kept India's economy crawling while other Asian nations—like South Korea and Japan—leapfrogged ahead by embracing private enterprise and export-driven growth.

Patel's Vision: Grounded, Pragmatic, Unfulfilled

Patel, by contrast, was a realist. As India's first Home Minister and Deputy Prime Minister, he oversaw the integration of over 560 princely states into the Indian Union—a logistical and political feat few leaders could have pulled off. He was tough when needed, yet deeply focused on national unity and institutional stability.

His economic ideas leaned toward market-friendly pragmatism. Patel had strong ties to India's industrial class and would likely have encouraged a more mixed economy—one that didn't alienate private enterprise or close India off from global capital.

He also took a firmer line on internal security and was far more skeptical of China than Nehru. In 1950, he warned Nehru against trusting China blindly, especially after Tibet's occupation. Nehru ignored those warnings, leading to the 1962 war, which exposed the deep flaws in India's foreign policy and defense preparedness.

A Political Culture That Could Have Been Different

There's also the question of leadership style. Nehru was a visionary but also an idealist. His charisma helped build a cult of personality, and eventually, the Congress became dynastic under the Nehru-Gandhi family.

Patel, in contrast, was more grounded and didn't seek personal adulation. Had he led India, the Congress might have

evolved into a more institutionally democratic party rather than one centered around a family name. Indian politics could have taken a different, possibly more meritocratic, shape.

Gandhi's Role: A Costly Preference?

Gandhi's influence in shaping India's early leadership was enormous—but not always constructive. In this case, his personal preference overrode the democratic consensus within the Congress. Patel deferred, respecting Gandhi's wish, despite having clear support from the majority.


It's worth questioning: should a personal relationship or ideological preference have determined who led independent India? And what did the nation lose in sidelining a leader like Patel at such a critical juncture?

History is full of what-ifs. But some aren't just academic—they point to missed opportunities. Had Patel become Prime Minister, India might have embraced a more grounded economic model, a sharper foreign policy, and stronger political institutions. Nehru's secularism was selectively applied, and his commitment to democratic values is debatable—after all, he became Prime Minister by sidelining majority opinion. His international image, the very reason Gandhi chose him, failed to bring the concrete benefits it promised.

In the end, India paid the price for choosing symbolism over strategy. And that decision still echoes today.

In 2020, an IIT graduate created an app that auto-filled IRCTC ticket forms—solving a real problem millions face daily. Instead of support, he was arrested. This missed opportunity reflects a deeper issue with India's startup ecosystem—where bureaucracy trumps innovation and genuine problem-solvers are penalised.

Fast forward to 2025, and Union Minister Piyush Goyal is berating Indian entrepreneurs for only building food delivery apps. He asks, "Are we going to be just delivery boys and girls?" The real question is—what options do India's youth have? Our economic model thrives on cheap labour, and our laws often fail to protect it. We attract global investors by highlighting low wages and lax regulations, not innovation or skill.

Meanwhile, China has transformed from a cheap-labour economy into a tech powerhouse. While India's per capita income in 2022 was \$2,388, China surged ahead to \$12,720. Their "Made in China 2025" initiative focused on semiconductors, EVs, drones, and AI—backed by serious funding. In contrast, India allocated just \$23.45 billion to private-sector R&D in the 2025 budget, compared to China's \$496 billion. Even deep-tech entrepreneurs face systemic hur-

dles. One semiconductor startup founder revealed his application for tax benefits was delayed for two years and finally rejected—until a "facilitator" offered guaranteed approval for a bribe. There's space for corruption, but none for rules-based support.

The automobile industry reflects this stagnation—60% of Indian cars use only 10 engines, and innovation is minimal. Chinese automakers, by contrast, offer over 200 models, including electric cars under \$1,000. In India, the cheapest EV is still over ₹7 lakh.

Our public sector, once the foundation of cities like Bengaluru, remains undervalued despite contributing massively to national development. In 2024–25, PSUs provided ₹74,000 crore in dividends. Yet, instead of nurturing them, we are selling them off while celebrating a handful of billionaire-led ventures.

And while the world innovates, we excel at paper leaks and hate-driven influencer content—our real "startups." Without serious investments in health, education, and job creation, India risks losing its demographic dividend to reels, riots, and rigged exams.

UPI Outages Highlight the Need for Greater Resilience and Security

The Unified Payments Interface (UPI), a cornerstone of India's digital economy, faced three significant outages this month, disrupting millions of daily transactions. Retailers, traders, and individual users were left stranded, with confusion erupting across businesses relying heavily on seamless digital payments. While the National Payments Corporation of India (NPCI) managed to restore services within hours, the damage to user confidence was already done.

With around 600 million transactions occurring daily and over 18 billion in March alone—a 14% rise from the previous month—UPI has become indispensable. Accounting for nearly 65% of all digital transactions in India, its stability is crucial. However, recurring glitches—six in the past year and 21 in five years—underscore the urgent need for better system preparedness.

NPCI attributes the latest glitch to an unexpected surge in transaction volume, but such a spike should not have come as a surprise. Digital adoption has been consistently rising since demonetisation and the COVID-19 pandemic, bolstered by increased smartphone penetration and public awareness. As UPI scales, the infrastructure behind it must

There's growing discussion around introducing a new entity into the digital payments space. This could promote competition, innovation, and reduce risk by preventing overreliance on a single system. A more resilient ecosystem would ensure continuity even if one node falters.

Equally concerning is the sharp rise in UPI fraud. The monetary value of such frauds jumped from ₹573 crore in 2022–23 to ₹1,087 crore in 2023–24. While some of this increase may correlate with transaction growth, it exposes vulnerabilities in the system. NPCI has already implemented identity verification and authentication protocols using AI and machine learning. However, with cyber threats growing more sophisticated, continuous upgrades and stricter monitoring are essential.

UPI is a shining example of India's tech prowess, even garnering international interest. But to sustain its global stature, system reliability and user security must be non-negotiable. The time to future-proof UPI is now—before glitches turn into larger cracks in India's digital foundation.









JD(U) Backs **Nitish for CM Till 2030**

Patna, April 17, 2025 — The Janata Dal (United) has made its intentions clear for the upcoming Bihar elections by publicly backing Nitish Kumar to continue as Chief Minister till 2030. A massive poster put up outside the party's state headquarters boldly declared: "25 se 30, phir se Nitish" — signalling a renewed fiveyear term for Bihar's longest-serving CM.

This strong projection of Nitish's leadership comes shortly after Haryana Chief Minister Nayab Singh Saini suggested that the BJP would contest the elections in Bihar under the leadership of Samrat Choudhary, a senior BJP leader and current state president. The JD(U)'s poster is seen as a direct rebuttal to those comments, reaffirming Nitish Kumar's central role in the NDA alliance in Bihar. The statement on the poster not only endorses Nitish's leadership for another term but also aims to consolidate JD(U)'s claim to the top post in any future government formed by the NDA in the state.

Nitish Kumar, currently serving his eighth term as Chief Minister, has become one of the most enduring political figures in Indian state politics. His tenure, known for its focus on development, infrastructure, and social reforms, has seen both praise and criticism, particularly over his frequent political realignments. While no official statement was released by JD(U) leadership, party insiders suggest that the poster reflects the grassroots sentiment and serves as a message to both allies and opponents that Nitish remains the face of governance in Bihar.

Political observers say this internal NDA messaging could lead to tensions within the alliance, especially as the BJP may push to assert greater leadership in the state. However, JD(U)'s public show of support could serve as a bargaining chip in future seat-sharing talks. As Bihar heads toward another election cycle, the slogan "25 se 30, phir se Nitish" sets the tone for JD(U)'s campaign — one firmly anchored around the legacy and leadership of Nitish Kumar.

Dawoodi Bohras Laud Waqf Amendment Act

A delegation from the Dawoodi Bohra community met Prime Minister Narendra Modi on Thursday, extending their heartfelt appreciation for the newly enacted Waqf (Amendment) Act, 2025. The group described the legislation as a long-awaited reform that addresses long-standing concerns within the community.

Expressing confidence in the Prime Minister's inclusive vision, the delegation reaffirmed their belief in his governance motto — "Sabka Saath, Sabka Vikas, Sabka Vishwas" (Together with all, development for all, trust of all).

The Dawoodi Bohras, a Shia Muslim sect predominantly based in western India, have a global presence with community members settled in over 40 countries. They trace their lineage to the Fatimid Imams of Egypt, descendants of the Prophet Muhammad. The community has been guided by the al-dai al-mutlaq (supreme missionary), a spiritual leader who has operated from India for the past 450 years.

However, the passage of the Waqf Amendment Act has also stirred tensions in parts of the country. In Murshidabad, West Bengal, recent protests against the Act led to violence and the death of three people.



In response, Chief Minister Mamata Banerjee appealed to Governor CV Ananda Bose to defer his planned visit to the affected region until normalcy is restored.

At a press conference, Banerjee announced Rs 10 lakh compensation for the families of those killed, and aid for rebuilding damaged homes and shops. She emphasized the need to rebuild public confidence before

any official visits, stating, "Let the confidence be built first."

The Chief Minister also criticized the Union Home Ministry for not sharing intelligence about outsiders allegedly involved in inciting violence. She claimed that expanding the BSF's jurisdiction to 50 km from the border has weakened state control and monitoring systems.

Governor Bose, however, maintained his commitment to visit Murshidabad and personally meet with the victims' families. Calling it an "emotional issue," he stated, "I want to see the ground reality and share the sentiments of the affected families."

The Waqf Amendment Act continues to evoke both commendation and controversy, with its broader social implications yet to fully unfold.

India Watches Pakistan-Bangladesh Rapprochement



India has officially acknowledged the renewed diplomatic engagement between Pakistan and Bangladesh, following the resumption of Foreign Office Consultations (FOC) in Dhaka — the first such dialogue in 15 years.

Ministry of External Affairs (MEA) spokesperson Randhir Jaiswal, during a weekly media briefing in New Delhi, stated, "Yes, we have taken note of it," in response to a question on the evolving ties between the two South Asian neighbours. The FOC talks, held on Thursday, were led by Pakistan's Foreign Secretary Amna Baloch and her Bangladeshi counterpart Md Jashim Uddin. The move marks a significant thaw in relations that had remained stagnant

for over a decade.

This development follows a major political shift in Bangladesh after the fall of Sheikh Hasina's Awami League government, which was triggered by massive student-led protests over reservation policies last year. The interim government under Muhammad Yunus has since taken steps to reset foreign relations.

As part of this renewed engagement, Secretary Baloch is also scheduled to meet interim Prime Minister Yunus and Foreign Affairs Adviser Touhid Hossain. Later in the day, she will participate in a roundtable discussion with think tanks and members of the Pakistani diaspora in Dhaka.

Looking ahead, Pakistan's Deputy Prime Minister and Foreign Minister Ishaq Dar is expected to visit Dhaka on April 27-28, which would be the first high-level visit from Islamabad in more than a decade.

Sources indicate that the warming of ties began discreetly last year through two informal meetings between PM Shehbaz Sharif and interim PM Yunus — first at the UN General Assembly in New York, and later at the D-8 Summit in Cairo.

Following these engagements, Bangladesh eased visa rules for Pakistani nationals and opened direct shipping routes. Pakistan, in turn, has shown interest in enhancing cooperation in trade, tourism, cultural exchange, and investment — signaling a broad-based diplomatic revival.

Naveen Patnaik Set for 9th **Term as BJD Chief**



Bhubaneswar, April 17, 2025 — Naveen Patnaik, former Chief Minister of Odisha and founding leader of the Biju Janata Dal (BJD), filed his nomination on Thursday for the party president post, aiming for a ninth consecutive term.

Speaking at a press conference, BJD State Returning Officer and MLA Pratap Keshari Deb confirmed that Patnaik was the sole nominee for the top post. "Naveen Patnaik filed his nomination between 10 AM and 1 PM today. As there are no other contenders, he will be declared elected unopposed after completing procedural formalities," Deb said.

The nomination filing took place at Sankha Bhawan, the BJD headquarters in Bhubaneswar, in the presence of senior party leaders. Symbolically, the move coincided with the 28th death anniversary of Biju Patnaik, Naveen's father and a towering political figure in Odisha, after whom the regional party is named.

As part of the BJD's ongoing internal elections, the lists of district presidents and state council members have already been finalised, according to Deb. The next step will be the selection of state executive members, who will play a key role in shaping the party's future direction.

Naveen Patnaik has led the BJD since its formation in 1997, winning eight consecutive terms as party president. His leadership once brought unmatched electoral dominance in Odisha, with the BJD ruling the state for 24 years until its recent loss in the 2024 state assembly elections.

In a dramatic shift, the BJP secured a majority in the 2024 Odisha Assembly polls, winning 78 out of 147 seats and forming the government under Mohan Charan Majhi. The BJD managed only 51 seats, and three independent MLAs later joined the BJP, raising its tally to 81 seats. The Congress won 14.

The Lok Sabha elections were even more lopsided, with the BJP capturing 20 of 21 seats, leaving the BJD with none despite its deep roots in the state.

Yet, with this unchallenged nomination, Naveen Patnaik reaffirms his central role in BJD's leadership and its future strategy moving forward.

Addressing an audience of overseas Pakistanis, Munir urged them to take pride in their heritage and stressed that Pakistan was created on the foundation of the two-nation theory — the belief that Hindus and Muslims are fundamentally different in culture, religion, and identity.

Munir emphasized that this ideological divide justified the creation of Pakistan in 1947 and continues to define the country's national narrative. "We are not one nation. Our forefathers made sacrifices because they believed in a separate identity. We must pass this story to the next generation," he said.

His comments strongly backed the two-nation theory and contrasted sharply with India's view of a shared history and its commitment to secularism. The statement underscores Pakistan's long-standing ideological position and the Army's role as the guardian of national identity.



Qatar's Emir Sheikh Tamim bin Hamad Al-Thani assured Russian President Vladimir Putin on Thursday that Syria's new leadership, under President Ahmed al-Sharaa, is interested in building strong ties with Moscow. The statement comes amid a significant shift in the region's power dynamics following the fall of longtime Syrian leader Bashar al-Assad in December.

During a high-level conversation, Sheikh Tamim conveyed that President al-Sharaa, who emerged as the head of the rebel coalition that ousted Assad, is eager to maintain and even deepen diplomatic and strategic relations with Russia. This assurance could be crucial for the Kremlin, which is now working to safeguard its long-standing interests in Syria, particularly its military foothold in the region.

Russia currently operates two critical military bases in Syria—its naval facility in Tartus and the Hmeimim airbase in Latakia. These sites have been instrumental in projecting Russian influence across the Middle East and the Mediterranean. With Assad's departure, concerns have grown in Moscow over the future of its access and operational freedom at these locations.

President Putin has reportedly reached out to several regional allies to ensure continued cooperation from the new Syrian administration. Qatar's role in this diplomatic effort is particularly significant, given its regional influence and its history of Syrian conflict.

Ahmed al-Sharaa's rise to power marks a new chapter for Syria, and many international observers are watching closely to see how the nation's foreign policy may shift under his leadership. While Sharaa has not made detailed public statements regarding Syria's strategic partnerships, the message delivered by Sheikh Tamim suggests that the new leadership is open to maintaining continuity in key international relationships—especially with global powers like Russia.

Ukrainian Parliament Approves 90-Day Extension Of Martial Law & Mobilisation

Ukraine's Parliament has voted to extend both martial law and the country's general military mobilization for another 90 days, continuing emergency measures in place since the Russian invasion in February 2022. The extension will run from May 9 to August 6, according to parliamentar- The United States has also weighed ian Yaroslav Zheleznyak, who shared the outcome on Telegram.

The vote passed with broad support: 357 lawmakers backed the continuation of martial law, and 346 supported the extension of mobilization well above the required 226 votes.

Ukrainian President Volodymyr Zelensky submitted the bills, which were President and leader of the largest opswiftly adopted. Martial law was first enacted on February 24, 2022, and has since been renewed multiple times as the war continues. Under Ukraine's Constitution, no elections—presidential or parliamentary—can take place while martial law is in effect.

This provision has sparked political controversy both within Ukraine and abroad. Zelensky's five-year presidential term officially expired in May 2024. While the Ukrainian government insists that elections are lehave questioned Zelensky's legitima-

China Integrates AI into Education to Drive Innovation and Future Growth

China is set to embed artificial intelligence (AI) into its national education system, including teaching methods, textbooks, and school curricula, in a sweeping effort to modernize learning and foster innovation. The move, detailed in an official government paper released Wednesday, will impact students and educators at the primary, secondary, and higher education levels.

As the world's second-largest economy seeks new engines of growth, the Chinese government is positioning AI as a central pillar in its education overhaul. According to the Ministry of Education, the integration of AI into classrooms aims to strengthen both teaching practices and the fundamental capabilities of students and teachers alike.

For students, AI is expected to cul-



tivate essential skills such as independent thinking, complex problem-solving, communication, and collaboration. For educators, the introduction of AI tools is designed to create more dynamic, engaging, and challenging learning environments.

The education ministry highlighted that promoting AI education would enhance the "core competitiveness of innovative talents" and contribute to the country's broader ambition to become a global innovation leader.

The initiative follows a significant expansion in AI-related courses and enrollments across Chinese universities, spurred in part by domestic advancements in AI technology.

In January, China's AI sector gained international attention when local startup DeepSeek launched a competitive large language model that was more cost-effective to develop than many Western counterparts. This milestone helped fuel national momentum for deeper AI integration in multiple sectors, including education.

The push also aligns with China's long-term vision laid out in its "strong-education nation" action plan, which was also launched in January. This strategic roadmap targets 2035 as the milestone year for establishing a globally advanced education system, with innovation and digital transformation at its core.

Trump's Gold Card Will Be Available Soon

As Elon Musk's role in the U.S. government efficiency task force winds down, President Donald Trump has assigned him a new project: creating a fast-track immigration system called the "Gold Card" for ultra-wealthy foreigners. The initiative, led by the Department of Government Efficiency (DOGE), aims to offer special U.S. residency visas priced at \$5 million each, according to The New York Times.

Engineers from Musk's team are developing an application portal for these high-value visas, collaborating with officials from the State Department, Department of Homeland Security, and U.S. Citizenship and Immigration Services. The "Gold Card" is positioned to replace the existing EB-5 visa program, which currently requires investments of \$800,000 to \$1.05 million and job creation for at least 10 Americans. That program raised around



\$4 billion last year. Trump first announced the Gold Card program in February, calling it a new "route to citizenship" for "very high-level people." While initial details were sparse, the administration later revealed the card would grant permanent residency to affluent individuals, pending background checks. Trump recently showcased a laminated prototype featuring his photo, the Statue of Liberty, and a bald eagle, promising rollout in "less than two weeks."

that made controversial posts about immigration. Coristine, just 19, was previously dismissed from an internship at a data firm over alleged leaks. Despite their backgrounds, both have met with government officials to streamline the vetting process.

The team is working on accelerating the traditionally lengthy immigration review procedures, aiming to approve qualified applicants within two weeks of applying. This includes compressing interviews, background checks, and other formalities.

Commerce Secretary Howard Lutnick claimed on a podcast last month that 1,000 Gold Cards had already been "sold," although no evidence was provided. He emphasized that cardholders must be law-abiding and vetted. Leading the project on DOGE's side Lutnick also confirmed Musk's team is building the system and expects it to launch within two weeks-now revised to a week and a half.

However, a sharp rally in the second half of the session pushed it to an cial services, and PSU banks postintraday high of 78,616, before closing strongly at 78,553, up by 1,508 points. Likewise, the NSE Nifty opened at 23,401, touched a low of 23,298 and rallied to a high of 23,872 before ending at 23,851, gaining 414 standout performer, jumping 1,172 points to settle at 54,290.

Among the Nifty50 constituents, 43 stocks advanced while only 7 declined. Notable gainers included Eicher Motors, Zomato, ICICI Bank,



Bharti Airtel, and Bajaj Finserv. On the downside, Wipro, Hindalco, Tech Mahindra, Hero Moto-Corp, and JSW Steel MURTHY NAIDU PAADAM were among the top losers.

The report highlights how the intensifying trade tensions, particularly those involving the United States, have cast a shadow over global economic prospects.

"It is hard to predict US trade policy with any confidence," Fitch said, noting that growing uncertainty is stifling business investment and eroding household wealth through falling equity prices. Additionally, retaliatory tariffs are expected to further weaken US export performance, Fitch also pointed to the US's recently adding to the global slowdown.

As a result, Fitch has sharply lowered its forecast for global growth in 2025 by 0.4 percentage points. Projections

India's US Exports Hit Record \$86.5 Billion Amid Trade War Fears; China Imports Also Soar

Tndia's exports to the Unit-Led States touched a historic high of \$86.51 billion in the financial year 2024-25, as businesses rushed to ship goods ahead of the reciprocal tariff hikes that took effect on April 2. The surge appears to be a case of front-loading, driven by anxiety over the escalating global trade tensions, particularly between the US and its trading partners.

the Commerce Ministry reveals that exporters scrambled to complete shipments in March, boosting the annual figures to unprecedented levels. The jump in exports underscores how concerns over future trade restrictions can trigger temporary spikes in international commerce, as firms attempt to beat looming dead-

Despite rising geopolitical tensions and a push for "self-reliance" under the government's Atmanirbhar Bharat initiative, trade with China continues to grow, largely driven by India's dependence on critical Chinese goods—especially in sectors like electronics, pharmaceuticals, and industrial machin-

Experts caution that while front-loading may offer a short-term boost, it could lead to a slowdown in subsequent months if demand weakens or tariffs start to bite. They also warn that prolonged trade wars could impact investor confidence, currency stability, and long-term export competitiveness.

Intel to Require Licenses for Al Chip Sales to China Amid **U.S.** Trade Policy Shifts

American semicon-ductor giant Intel has informed its Chinese clients that it will now require export licenses to sell certain high-performance artificial intelligence (AI) chips to China, according to a report by the Financial Times. The move follows a growing wave of restrictions by the U.S. government targeting advanced tech exports to China, intensifying global tensions in the semiconductor sector.

This development comes just a day after rival chipmaker Nvidia revealed it could face a revenue hit of up to \$5.5 billion due to new U.S. export controls on its AI processors specifically designed for the Chinese market. Dutch semiconductor equipment maker ASML also issued a more cautious outlook, citing similar trade headwinds.

Under the leadership of newly appointed CEO Lip-Bu Tan, Intel reportedly informed clients that chips exceeding specific performance benchmarks will now require a license for export to China. These thresholds include chips with a total DRAM bandwidth of 1,400 gigabytes per second (GB/s), I/O bandwidth of 1,100 GB/s, or a combined total of 1,700 GB/s or more. Intel's Gaudi AI chip series, as well as Nvidia's China-focused H20 processor, both surpass these limits, placing them squarely under the new export license requirements.



The announcement has already sent ripples through the market. Intel's stock declined more than 3% on Wednesday, mirroring a broader dip in chip stocks as concerns mount over the ongoing disruption in the global semiconductor trade caused by the U.S.'s evolving trade pol-

These measures are part of Washington's broader strategy to curtail China's access to cutting-edge AI technologies that could have military or surveillance applications. However, industry analysts warn that such restrictions could not only impact China's AI development but also hurt U.S. companies' bottom lines and slow the momentum of the AI chip sector, which had experienced a significant boom over the past two years.

As Big Tech's capital expenditures come under scrutiny and global trade tensions escalate, the AI chip industry appears poised for a period of uncertainty and slowdown.



OpenAl Unveils o3 and o4-Mini Models

OpenAI has announced the release of its newest artificial intelligence models, o3 and o4-mini, designed to advance AI reasoning and bring significant upgrades in how machines understand and interact with the world. The announcement, made on April 17, 2025, underscores OpenAI's commitment to pushing the boundaries of AI's cognitive abilities and real-world application. Both models come with multimodal understanding, a feature that allows them to process and reason with images alongside text—a leap in AI's ability to think contextually. This means the models can now include visual information as part of their decision-making or problem-solving process, rather than relying on text alone. This feature enables more human-like, intuitive reasoning, and is expected to significantly enhance the performance of AI in complex tasks across industries like education, healthcare, design, and content creation.

According to OpenAI, the o3 model is its most advanced reasoning model to date, combining improved memory handling, bet-



ter contextual understanding, and faster response times. Meanwhile, o4-mini offers many of the same capabilities in a more lightweight, efficient form suitable for mobile and embedded applications.

The company also confirmed that older models will be gradually phased out as users transition to the more capable o3 and o4mini models. This move is intended to streamline development and ensure that users benefit from the latest AI capabilities without the limitations of earlier architectures.

These releases mark a significant evolution in OpenAI's model lineup and point toward a future where AI systems are not only faster and smarter but also more perceptive and capable of multimodal reasoning—integrating multiple forms of input into a single chain of thought.

With o3 and o4-mini, OpenAI continues to lead in developing general-purpose AI tools that offer deeper, more flexible understanding across a wide range of human tasks.



Mysterious Lights Over Vancouver Spark Debate


