Minister Nara Lokesh Vows Crackdown on Betting Apps with New Statewide

Minister Nara Lokesh has vowed to launch a decisive war against betting apps in Andhra Pradesh. Responding to a message on social media platform X that highlighted the growing threat of betting apps ruining lives, Lokesh said that the state government will bring a comprehensive policy to ban betting platforms and make Andhra Pradesh a model for the entire country.

"Betting apps are destroying lives. I am hearing hundreds of heartbreaking stories of youth being driven into despair by gambling addiction. This must stop," Lokesh wrote on X. He emphasized that the long-term solution lies in sustained awareness campaigns and strict enforcement measures.

He announced that all legal options will be explored to curtail the operation and spread of these apps, which have been luring people into financial and emotional distress. He said that apart from policy measures, awareness programs will be conducted across the state to educate citizens—especially the youth-about the dangers of online betting. Lokesh also issued a stern warning to those promoting or engaging in gambling through these apps, saying that the government will take stringent action against violators. "We are working on a comprehensive antibetting policy that will set an example for the entire country. We will explore all legal avenues to end this menace," he added. The minister's strong stand comes amid growing concern over the impact of online betting, especially among students and unemployed youth, with several reports surfacing in recent months highlighting addiction and financial ruin due to unchecked digital gambling platforms.

ED Attaches Rs. 800 Crore Assets in Shocking Move Against Jagan

In a major development in the long-standing money laundering investigation against former Andhra



Chief Minister YS Jagan Pradesh Mohan Reddy, the Enforcement Directorate (ED) has attached assets worth Rs. 800 crore. These assets include prime land parcels in Hyderabad and Bengaluru, as well as shares in multiple companies reportedly linked to Jagan's family and close associates.

The case, which dates back to 2009-10 when Jagan was serving as an MP from Kadapa, alleges that he used his political influence to benefit certain companies in return for substantial investments or kickbacks routed through his family-run entities. These funds, the ED believes, were used to acquire immovable properties and corporate shares, now frozen under the Prevention of Money Laundering Act (PMLA).

Sources said that the properties are not in Jagan's direct name but have been traced to firms and individuals closely associated with him, reflecting a web of transactions designed to mask the origin of illicit wealth. The central agency stated that the proceeds of crime were layered and integrated into legitimate-looking businesses to escape scrutiny.

This action is part of the broader investigation that has seen both the ED and the Central Bureau of Investigation (CBI) scrutinizing Jagan's business and political dealings for over a decade. The CBI, which originally registered the corruption case, is continuing its probe into the source of the funds and the manner in which public office was allegedly misused for personal gain.

With this latest move, the ED has signaled its intent to fast-track long-pending probes into political corruption cases with serious financial implications.

The Special Investigation Team (SIT) has ramped up its inquiry into the multi-thousand crore liquor scam that allegedly took place during the YSRCP regime, issuing another notice to MP Mithun Reddy after he failed to appear for questioning on Friday. SIT officials have now directed him to appear on Saturday (April 19).

SIT had summoned both Mithun Reddy and former MP Vijayasai the SIT notice and appear on fri-Reddy to appear for questioning on Friday. While Vijayasai had informed the SIT he would ap-

pear on friday, he failed to do so and instead sent a last-minute message citing other commitments. He assured the team that he would appear on Friday. Officials, including SIT chief SV Rajasekhara Babu, waited for him at the Vijayawada Police Commissioner's office until noon. Meanwhile, Mithun Reddy approached the High Court seeking permission for audio-video recording of his questioning. With the court denying this request, he is now obligated to comply with day.









Dy CM Cracks Down on Land Grabbing

Andhra Pradesh Deputy Chief Minister Pawan Kalyan has issued a stern warning against land grabbing, asserting that the government will take uncompromising action against those encroaching on the properties of the poor or seizing inherited lands. During a teleconference with officials on Friday, he said the state government would ensure protection for victims and restore their rights.

Pawan Kalyan revealed that a flood of complaints related to land encroachments has been received by his office, especially from Visakhapatnam, Kakinada, Tirupati, and Kadapa districts. He noted that several cases involve threats being issued to victims in the name of the coalition government, as well as illegal occupation of government, Brahmin, Satram (inn), endowment, Matham, and industrial lands. A former ruling party leader has reportedly been involved in some of these incidents, particularly in Kakinada and Tirupati.

He made it clear that those forging documents or engaging in unlawful possession will face the full force of the law. "No one will be spared, irrespective of their political connections," he stated.

Reiterating the commitment of the coalition government led by Chief Minister N. Chandrababu Naidu, the Deputy Chief Minister said protecting public and private property is a top priority. He further announced that he would soon visit district collectorates to directly receive petitions from land-grabbing victims and ensure swift action.

Pawan Kalyan also assured that complaints against leaders of the current ruling alliance will not be ignored. "Justice will be delivered without fear or favour," he said.

As the key accused in the scam, Kasireddy Rajasekhar Reddy (Raj Kasireddy) continues to evade authorities, the SIT served a notice to his father Upender Reddy two days ago at his Hyderabad residence. Responding to the notice, Upender appeared before the SIT on friday in Vijayawada. However, he reportedly claimed he had no knowledge of his son's whereabouts or contacts, despite being questioned in detail. He was asked questions such as where Raj usually goes, who he meets frequently, and where he might be hiding. Upender maintained he knew nothing and agreed to be available for further questioning, providing hotel stay details for follow-up. Separately, the SIT has also issued notices to several liquor traders accused of paying bribes under the previous government. Their questioning is scheduled for Saturday and Sunday, as the SIT presses forward in unraveling the full extent of the scam.

Chief Minister N. Chandrababu Naidu has announced the theme for April's 'Swachchha Andhra' program—"E-waste collection and recycling in safe ways." This state-wide initiative, conducted on the third Saturday of every month, is part of the broader Swarnandhra-2047 Sankalpa to promote a cleaner, greener Andhra Pradesh.

Taking to social media, CM Naidu stated that the Swachchha Andhra program would

feature a unique and practical theme every month to inspire widespread public participation. For April, the focus is on managing the growing problem of electronic waste responsibly, promoting awareness and action through safe collection and recycling methods.

CM Naidu emphasized the concept of a circular economy, highlighting how wealth can be generated from garbage if handled systematically. "Reduce, Reuse, Recycle" is the guiding motto of this month's program. He urged people from all walks

of life-including officials, district collectors, public representatives, MLAs, ministers, NGOs, corporate entities, students, and youth-to join hands and contribute to the movement.

He specifically instructed the setup of e-waste collection centers in both rural and urban areas, with active involvement of Self-Help Groups (SHGs). These SHGs will play a key role in managing the centers and raising awareness about the environmental and health hazards associated with improper e-waste disposal.

The Andhra Pradesh government has officially directed the publication of the SC Classification Ordinance in the state Gazette, marking a key step in the implementation of caste-based reservation among Scheduled Castes. The Chief Secretary of AP, K. Vijayanand, issued G.O. MS No. 7 on Friday to facilitate this.

The SC Classification Ordinance, already approved by Governor Abdul Nazeer, provides structured reservation as follows: 1 percent for 12 castes in Group-1, 6.5 percent for 18 castes in Group-2, and 7.5 percent for 29 castes in Group-3. The ordinance, listed as Ordinance No. 2 of 2025, was issued by the Law Department under the supervision of Secretary Gottapu Pratibha Devi.

This policy aims to ensure fair representation for all Scheduled Castes in education and employment opportunities. The classification move is seen as a major initiative by the Chandrababu Naidu-led government to address long-pending demands for internal reservations within SC communities.

In response to the implementation of this significant reform, MRPS chief Padmashri Manda Krishna Madiga met with Chief Secretary Vijayanand at the Secretariat. He expressed gratitude on behalf of the Madiga community for the government's commitment and smooth handling of the process.

Manda Krishna Madiga also visited the CMO and personally thanked CM Principal Secretary Ravichandra, CM Secretary PS Pradyumna, and Additional Secretary AV Rajamouli for their cooperation in completing the classification procedure. The decision to proceed with the ordinance followed a Cabinet meeting chaired by CM Chandrababu Naidu at Velagapudi on April 16, where the focus was to promote equitable opportunities among all SC sub-groups in Andhra Pradesh.

Union Minister Rammohan Naidu assures help for workers in Muscat

Union Minister of State Rammohan Naidu has stepped in to help workers from Srikakulam district who are stranded in Muscat, Oman, after migrating in search of employment. Reports emerged that several workers from the region are facing severe hardships due to the unavailability of jobs and basic support in the Gulf country.

After learning about their situation, Rammohan Naidu immediately connected with the workers via a video call. During the conversation, he listened to their grievances and reassured them that the government will make every effort to bring them back to India safely and at the earliest.

The workers reportedly went to Muscat with hopes of earning a livelihood, but have been left without work or proper accommodation, placing them under emotional and financial stress. Their families back home in Srikakulam also expressed concern over their well-being and safety.

Rammohan Naidu, who represents the Srikakulam parliamentary constituency, assured the families that the central government is treating the



issue with urgency. He stated that coordination is already underway with the Indian Embassy in Oman and officials from the External Affairs Ministry to ensure the workers' safe return. "We will not rest until every worker is safely brought back. Their safety is our priority," he told the families, offering both emotional and administrative support.

The swift response from the Union Minister has brought hope to the stranded workers and their families, who now await further updates on their repatriation process.

E-Waste to be collected across AP under Swachh Andhra program on April 19

Andhra Pradesh will launch a massive state-wide e-waste collection drive on April 19 as part of its monthly Swachhandhra - Swachh Divas initiative. This month's theme, E-check, focuses on the collection and reuse of electronic waste through specially set up centers across municipalities.

Minister for Municipal Administration Dr. P. Narayana, who reviewed the arrangements in a teleconference with Municipal Commissioners and department officials, said that the program reflects Chief Minister N. Chandrababu Naidu's vision of achieving 100 percent cleanliness in the state by holding monthly themed campaigns for twelve consecutive months. Dr. Narayana announced that 222 e-waste collection centers will be operational statewide, many of which are converted RRR centers. The initiative aims to collect damaged or unused electronic items such as mobile phones, TVs, and small gadgets from homes and commercial spaces. To boost employment, the responsibility of man-

aging these centers will be given to women from self-help groups and local associations. The collected e-waste will be exchanged for cash, offering an economic incentive while promoting eco-friendly practices. Several companies have already come forward to recycle the collected materials. The Minister stressed that this campaign will not be limited to one day and that the centers will function throughout the year to facilitate continuous disposal.

The complaint was filed by TTD board member Bhanu Prakash Reddy, who accused Bhumana of spreading false allegations against the sacred SV Gaushala, causing distress among devotees.

According to Bhanu Prakash, Bhumana made baseless claims suggesting that the SV Gaushala, known for its religious sanctity, had been converted into a slaughterhouse. Bhanu strongly refuted these statements and demanded legal

Former Minister Avanti Srinivas' **Daughter Resigns from YSRCP**


In a significant setback to the YSRCP in Visakhapatnam, Muthamsetty Lakshmi Priyanka, the 6th ward corporator and daughter of former minister Avanti Srinivas, has resigned from the party. Her exit comes at a crucial time, just as the no-confidence motion against Greater Visakhapatnam Municipal Corporation (GVMC) Mayor Hari Venkata Kumari gathers momentum.

Lakshmi Priyanka submitted her resignation to YSRCP president Y.S. Jagan Mohan Reddy, citing personal rea-

sons. She thanked the party for the opportunity and support during her term. However, her decision has triggered alarm within the party ranks, as political uncertainty deepens in the city.

With the TDP-led alliance aggressively pursuing the mayor's removal, the YS-RCP had shifted its corporators to undisclosed camps outside the city to prevent potential defections. But Lakshmi Priyanka's resignation after returning to Vizag has reignited fears of more leaders jumping ship.

This development adds to YSRCP's growing list of troubles, as the party is already struggling with losses across

MLA Sudheer Reddy Slams YSRCP **Over Land Allocation Allegations**

He went on to list other controversial land allocations under YS-RCP, including 9,000 acres in Hindupur for the Lepakshi Knowledge Hub and vast land tracts given to firms like Dalmia, India Cements, Bharati Cements, and Shirdi Sai Company. "You glorify Jagan Reddy, who handed out government lands to corrupt industrialists like Diwali sweets, but you can't stomach it when TCS gets a mere 22 acres?" he lashed out.

Reddy emphasized that Chandrababu Naidu's administration is focused on fostering genuine employment by bringing reputed companies like TCS to the state. He also accused YSRCP of orchestrating a misinformation campaign to malign the TDP government's efforts in industrial development.

Jaggampeta MLA Jyothula Nehru defends TTD, slams false propaganda

Engineering in Your Language AICTE Rolls Out Textbooks in 12 Regional Languages

TPN Correspondent | Amaravathi

After successfully introducing MBBS education in regional languages, the central government is now transforming engineering education. The All India Council for Technical Education (AICTE) has launched an ambitious initiative to make engineering textbooks available in Indian regional languages, making higher technical education more inclusive and accessible.

AICTE Chairman Professor TG Sitaram stated that the Council has already completed and uploaded around 600 textbooks for first- and second-year diploma and degree students. These textbooks are now available in 12 Indian languages: Hindi, Telugu, Tamil, Kannada, Malayalam, Marathi, Gujarati, Pun-



jabi, Odia, Bengali, Assamese, and Urdu. Textbooks for thirdand fourth-year students will be completed by December 2026. This effort is especially beneficial to students who have studied in their mother tongue throughout school and face difficulties adjusting to the English medium in engineering. The AICTE is also using artificial intelligence for fast translations, achieving 80% accuracy in just 10 minutes per book, with experts refining the remainder. So far, AICTE has approved 1,140 seats in 18 engineering colleges

across the country for B.Tech programs in regional languages. The uptake is growing steadily—from 233 filled seats

in 2021–22 to 928 in 2023–24. The subjects currently being translated include civil, mechanical, electrical, electronics, and computer science. Although India recognizes 22 languages officially, the focus remains on 12 major ones due to financial constraints. Professor Sitaram emphasized that this is an optional initiative, modeled on successful systems in countries like Russia, China, Canada, and Japan, where higher education is delivered in native languages. This move is expected to significantly improve technical education accessibility for rural and regional students across India.

Violence In Bengal: Is It The Beginning Of The End For TMC?

Some events unfold with a sense of inevitability, and West Bengal today appears caught in one such moment. The recent unrest linked to the Waqf Amendment Bill protests has exposed the cracks in Chief Minister Mamata Banerjee's carefully curated political narrative — one increasingly defined by appeasement and selective outreach.

What initially seemed like a well-timed distraction from the 26,000-strong teacher recruitment scam has now snowballed into communal tension. The violence that erupted — including the tragic deaths of Hari Gobind Das and his son in Murshidabad, and the police firing that killed 17-year-old Izaz Ahmad Sheikh — reveals how quickly Bengal can spiral into unrest. With incidents in sensitive districts like Malda, South 24 Parganas, and Hooghly, the warning signs are glaring.

Bengal has a history of communal flashpoints from the 1946 Calcutta Killings to the more recent Ram Navami clashes. Each incident serves as a reminder of the combustible potential of divisive politics in the state. Mamata Banerjee's open opposition to the Waqf Amendment Bill and her efforts to rally Muslim support with emotional appeals from public platforms might now be backfiring.

Her silence towards the 70% Hindu population amid the chaos stands in stark contrast to her vocal assurances to Muslim constituents. This selective empathy risks alienating a significant portion of the electorate and provides fertile ground for the BJP, which has long sought to consolidate the Hindu vote in Bengal.

Ministers like Siddigullah Chowdhury, openly threatening to paralyze the state while claiming Mamata's backing, only deepen the perception that the administration has lost control. If Banerjee cannot restore order, or appear impartial, she may not only lose political ground but the moral authority to lead.

Why Trump's Move Resonates: Ban **Political Activities in Universities**

Follow the Trump model—fund learning, not lobbying.

"Universities are for education, not agitation. Politics can wait. Education can't."

Russia, China, and Trump have one thing in common: they understand universities are meant for learning, not lobbying. India should take note.

The Trump administration took a clear stance against universities becoming hubs of political activism. It argued that taxpayer dollars should support research, innovation, and education-not ideological warfare. Many Americans agreed, and the argument holds relevance far beyond U.S. borders.

Universities must be safe spaces for intellectual inquiry, not political battlegrounds. While fostering political awareness is important, overt activism often undermines academic integrity. Political protests can erupt into violence, distract from learning, and delay academic schedules. Students, caught in the crossfire, suffer from stress and mental health issues. Some may even abandon institutions altogether, looking for less turbulent educational environments.

The Indian Context

India's universities—JNU, AMU, and others—have frequently turned into ideological war zones. Some hail this as a sign of a vibrant democracy. But here's the flip side: it disrupts education, wastes taxpayer money, and hijacks the future of neutral students who just want to study. University politics breed polarization. Student elections often mimic national politics—full of division, drama, and disruption. Classes get cancelled. Properties are vandalized. Exams are postponed. In the end, it's the apolitical, academically inclined student who pays the price.

India must rethink this system.

- **Enforce national guidelines** to maintain campus neutrality and discipline.

Karnataka Caste Survey Exposes Risks in Rahul Gandhi's OBC Outreach Strategy

The leaked findings of Karnataka's caste survey have ignited political unrest, revealing deep cracks within the Congress party and raising concerns about Rahul Gandhi's OBC-centric electoral strategy. Community leaders from the influential Lingayat and Vokkaliga groups have rejected the survey as flawed and underrepresentative, warning of statewide protests. Meanwhile, some Congress MLAs and ministers have urged the government to discard the report, citing serious data discrepancies and poor execution.

Critics argue the survey's timing is strategic. Observers believe CM Siddaramaiah may be using the findings to weaken dominant caste leaders in Congress, such as M.B. Patil and D.K. Shivakumar, both eyeing the Deputy Chief Minister or Chief Minister posts.

Stalin pushes for state autonomy — Why? Why now?

Tamil Nadu Chief Minister M.K. Stalin's move to establish a high-level committee to safeguard state autonomy has reignited a long-dormant national debate. At the heart of this decision is Stalin's claim that the Centre has been steadily encroaching on state powers, thereby disturbing the delicate constitutional balance between Union and State.

The committee, chaired by retired Supreme Court judge Kurian Joseph, is tasked with reviewing concerns such as the shifting of key subjects like education and health from the State List to the Concurrent List. This shift, critics argue, has enabled the Centre to impose policies such as NEET and the National Education Policy (NEP), which Tamil Nadu opposes for undermining its education system and regional identity.

The controversy also ties into anxieties around the upcoming delimitation exercise, which could reduce Tamil Nadu's representation in Parliament relative to northern states with higher population growth. For a state that has successfully implemented population control, this feels like punishment for progress.

NEET remains a flashpoint. Tamil Nadu had long relied on Class 12 results for medical admissions. The national exam, now mandatory, is seen as favoring urban, wealthy students who can afford coaching, thus disadvantaging rural and marginalized communities. Stalin's argument is that such central policies dilute state autonomy and erode social justice.

Although the reclassification of subjects happened under Indira Gandhi's 42nd Constitutional Amendment during the Emer-




gency, the Modi government's assertive use of concurrent powers — even withholding funds for non-compliance with NEP — has intensified concerns.

State autonomy, once a fringe issue buried in manifestos, is now resurfacing. With regional parties no longer reliant on Congress, and the BJP favoring centralized governance, these parties are seeking distinct electoral narratives. Autonomy offers a powerful platform, especially in states like Tamil Nadu heading into elections in 2026.

For parties like the DMK, autonomy provides a broader vision beyond family politics or freebies — a return to constitutional federalism. Stalin's move is as much about resisting marginalisation as it is about crafting a new political identity in an increasingly centralized India.







Rajnath Vows Self-Reliant Defence Sector

Chhatrapati Sambhajinagar, April 18, 2025 - Defence Minister Rajnath Singh reaffirmed the government's commitment to making India self-reliant in the defence sector during an address to industry representatives on Friday. Speaking in Chhatrapati Sambhajinagar (formerly Aurangabad), Singh highlighted the significant strides made in boosting indigenous defence production and exports under the current administration."The Government of India is fully committed to the vision of 'Aatmanirbhar Bharat' in the defence sector," Singh said. "Our goal is not only to reduce dependency on imports but also to transform India into a global hub for defence manufacturing and exports."

The Defence Minister pointed out the exponential growth in defence exports over the last decade, noting a rise from just ₹600 crore in 2014 to ₹24,000 crore in 2024. "This growth is a testament to our focus on innovation, indigenous technology, and empowering our domestic industry," he said. He further revealed that the current value of defence production in the country stands at ₹1.60 lakh crore and outlined the government's ambitious target of increasing it to ₹3 lakh crore in the coming years. Singh said this would not only boost national security but also create employment and stimulate the economy.

Several reforms have been introduced in recent years to achieve these objectives, including easing foreign direct investment (FDI) norms, establishing defence corridors, and promoting public-private partnerships in the sector. The Defence Acquisition Procedure (DAP) has also been revamped to prioritize purchases from domestic manufacturers.

Singh urged the private sector and startups to take advantage of the conducive policy environment and actively participate in the country's defence growth story. "We want our youth and entrepreneurs to lead the way in advanced defence technologies, from drones to cybersecurity and AI-driven warfare solutions," he added. The event saw enthusiastic participation from industry leaders, who welcomed the government's focus on self-reliance and innovation in defence. As India positions itself on the global stage as a key player in defence production, the roadmap laid out by the Defence Minister reflects a vision of both strategic autonomy and industrial strength.

Modi, Elon Musk Discuss Tech Ties

Prime Minister Narendra Modi announced on Friday, April 18, 2025, that he had a conversation with billionaire entrepreneur Elon Musk, focusing on the potential for collaboration in technology and innovation. The interaction appears to be a follow-up to their in-person meeting held in Washington, D.C., on February 13, 2025.

In a post shared on X (formerly Twitter), Prime Minister Modi stated, "Good conversation with @elonmusk. We discussed a wide range of subjects, including themes from our previous meeting in Washington DC. There is great potential for collaboration in the areas of technology and innovation."

Although the Prime Minister did not specify the exact timing of the latest exchange, his post underlined a shared interest in strengthening technological partnerships between India and the companies led by Musk. The conversation signals India's continuing interest in engaging with global tech leaders to drive digital transformation, boost innovation, and explore opportunities in sectors like electric vehicles, space technology, and artificial intelligence.

The February meeting in Washington D.C. was held during PM Modi's visit to the United States and included discussions on Tesla's possible entry into the Indian market, the expansion of SpaceX services such as Starlink in remote areas of India, and



broader cooperation on cutting-edge technologies.

Elon Musk, the CEO of Tesla and SpaceX, had expressed keen interest in investing in India, calling it one of the most promising markets for the future. Reports at the time indicated that Tesla was exploring possibilities for setting up manufacturing facilities in India, while SpaceX looked at opportunities to launch satellite-based internet services to enhance rural connectivity. Modi's outreach to Musk is seen as

part of his broader strategy to attract global innovation leaders and create a robust ecosystem for emerging technologies in India. It also aligns with the government's focus on self-reliance (Atmanirbhar Bharat) and transitioning toward clean energy and advanced digital infrastructure.

While no formal announcements have been made yet, the tone of the conversation suggests that significant developments could be on the horizon in the India-Musk technology partnership.

Seelampur Murder Sparks Political Row

The tragic murder of a 17-year-old boy in northeast Delhi's Seelampur has intensified the ongoing political tussle between the Aam Aadmi Party (AAP) and the Bharatiya Janata Party (BJP), with both parties trading sharp accusations over the capital's law and order situation.

The incident took place on Thursday in the J Block area of New Seelampur, where the teenager was fatally stabbed, sparking outrage and renewed concerns over public safety in the national capital.

"No GST on UPI Over ₹2,000"

The Finance Ministry on Friday categorically denied reports suggesting the government plans to impose Goods and Services Tax (GST) on Unified Payments Interface (UPI) transactions exceeding ₹2,000, calling such claims "false, misleading, and baseless."

In a statement issued late evening, the Ministry clarified, "There is no proposal under consideration to levy GST on UPI transactions above ₹2,000. Such speculation has no foundation and may mislead the public."

GST is applicable only on specific financial service charges, such as the Merchant Discount Rate (MDR), which is levied on certain payment modes. However, since January 2020, the MDR on Person-to-Merchant (P2M) UPI transactions was waived off as per a Gazette Notification by the Central Board of Direct Taxes (CBDT) issued on December 30, 2019."As there is no MDR on UPI transactions currently, GST is not applicable either," the statement clarified.The Ministry reaffirmed the government's commitment to promoting digital payments, especially through UPI, as part of its broader digital economy strategy. To encourage UPI usage and reduce the cost burden on small merchants, the government has introduced and sustained an incentive scheme for low-value P2M transactions.

According to the Ministry, the government has allocated a total of ₹7,230 crore under this incentive scheme across three fiscal years: ₹1,389 crore in FY2021-22, ₹2,210 crore in FY2022-23, and ₹3,631 crore in FY2023-24. These incentives are aimed at supporting merchant adoption, improving the digital payments infrastructure,



and sustaining UPI's rapid growth.India's dominance in the global digital payments space continues to expand. The ACI Worldwide Report 2024 revealed that India accounted for 49% of the world's real-time digital transactions in 2023.

The total value of UPI transactions surged from ₹21.3 lakh crore in FY2019-20 to ₹260.56 lakh crore by the end of FY2024-25. Notably, P2M transactions have reached ₹59.3 lakh crore, demonstrating increased adoption among merchants and growing trust among consumers.

The Finance Ministry reiterated that it remains focused on fostering a robust, inclusive, and innovation-driven digital payments ecosystem in India.

NCERT Defends Indian Titles for Textbooks

The National Council of Educational Research and Training (NCERT) has defended its decision to use Indian language titles—some of them in Hindi-for its newly released English medium textbooks, stating that the naming was done thoughtfully to reflect India's cultural and educational heritage.

In an official response to the controversy sparked by criticism from sections of the public and educationists, NCERT clarified that the titles were chosen not to promote any particular language but to symbolically connect students with India's civilizational knowledge systems and cultural identity.

"The names of the new textbooks are not exclusively in Hindi, but drawn from various Indian languages," NCERT stated. "These titles were selected after careful consideration of their cultural, linguistic, and pedagogical value. The aim is to instill a sense of rootedness and pride in India's diverse traditions and knowledge heritage."The controversy emerged after several English-language textbooks introduced by NCERT were seen bearing Hindi or Indian-language names, prompting concerns over potential linguistic bias and the imposition of Hindi in non-Hindi speaking states.However, NCERT emphasized that the decision is aligned with the vision of the National Education Policy (NEP) 2020, which encourages integration of Indian knowledge systems into the formal curriculum, alongside promotion of multilingualism.Sources within NCERT further explained that the titles were meant to spark curiosity and provide



a bridge between contemporary education and ancient Indian wisdom. "These titles are more than just names; they are reflections of deep concepts and traditions," an official said. The response also assured stakeholders that the content remains accessible and inclusive, and that the pedagogical approach remains rooted in fostering critical thinking, creativity, and understanding across linguistic boundaries. Despite the clarification, the move continues to draw mixed reactions. While some educators welcomed the effort to culturally contextualize learning materials, others urged NCERT to ensure that linguistic diversity is respected and no regional language feels sidelined.As the new academic year begins, the debate has reignited discussions on language, identity, and inclusivity in India's education system.







First talks in 15 years: **Bangladesh seeks** Pakistan's apology for **1971** atrocities

In a significant diplomatic development, Bangladesh has formally raised long-standing grievances with Pakistan during the first foreign secretary-level talks between the two nations in 15 years, held in Dhaka on Thursday. Central to the discussions were the unresolved issues stemming from the 1971 Liberation War, which led to the creation of an independent Bangladesh following the secession from what was then West Pakistan.

Bangladesh pressed Pakistan for a formal public apology for the atrocities committed by the Pakistani military during the war, which left an estimated three million people dead and displaced millions more. The issue of apology has remained a key emotional and political point in bilateral relations, with Dhaka repeatedly calling for acknowledgment of the events of 1971.

During the talks, Bangladesh also demanded financial compensation in the form of USD 4.3 billion — its claimed share from the combined state assets that were held by the erstwhile united Pakistan prior to the country's split. These assets, according to Dhaka, were never transferred after independence and remain a pending issue in the bilateral relationship.

The discussions mark a cautious but notable step in reviving diplomatic engagement between the two South Asian neighbors. Despite the historical ties and people-to-people connections, relations between Dhaka and Islamabad have remained strained for decades, mainly due to the lingering wounds of the 1971 war and Pakistan's reluctance to formally apologize for its role in the conflict.

Diplomatic sources said that while the talks were held in a "cordial atmosphere," the demands made by Bangladesh underscore the deep-rooted issues that still hinder full normalization of relations. Observers note that any progress on these fronts would require significant political will and a shift in long-standing positions, particularly from Islamabad.

Musk Prepares to Lead U.S. Golden Dome Missile Defense Project

Elon Musk's SpaceX, in partnership with defense tech firms Palantir and Anduril, has emerged as a leading contender for a pivotal role in President Donald Trump's ambitious "Golden Dome" missile defense initiative, according to sources familiar with the matter.

The project, which stems from a January 27 executive order by Trump, aims to build a cutting-edge missile defense shield, which he described as a critical measure to counter "the most catastrophic threat facing the United States." The proposal envisions a two-tier satellite system: a network of 400–1,000 satellites to detect and track missile threats, and a separate fleet of 200 armed satellites to intercept them. SpaceX's bid reportedly focuses on the "custody layer" responsible for sensing and tracking, not weaponization.

While the Pentagon is still in the early stages of evaluating the plan, SpaceX's advantage lies in its existing satellite infrastructure and launch capabilities. The company has proposed a subscription-based model — a novel approach in defense contracting — that would allow the U.S. government to access the technology without owning it. While this could speed up deployment, it has sparked concerns over long-term control and costs.

lite detection layer ranges between \$6 billion and \$10 billion, sources said. If SpaceX's group wins the contract, it would mark a major breakthrough for Silicon Valley in the defense sector, challenging legacy players like Boeing, Northrop Grumman, and Lockheed Martin.

Critics, however, are raising alarms. Some Pentagon officials are wary of relying on a private subscription model for national defense. Lawmakers have also questioned Musk's dual role as a government advisor and bidder on federal contracts, calling it a potential conflict of interest. Senator Jeanne Shaheen has introduced legislation to prevent companies owned by special government employees from receiving federal contracts.

Despite its potential, experts caution that such a massive and complex system may prove vulnerable and prohibitively expensive. "It's still unclear whether this group can deliver a fully reliable national defense system," one source noted. The final decision on Golden Dome contracts is expected in the coming months.

China Denies Zelenskyy's Claims of Weapon Supply to Russia **Reiterates Neutrality in Ukraine War**

China has strongly rejected recent accusations made by Ukrainian President Volodymyr Zelenskyy that it has been supplying weapons to Russia for use in the ongoing conflict in Ukraine. During a regular press briefing on Friday in Beijing, Chinese Foreign Ministry tion would be released next week spokesperson Lin Jian dismissed to support the claim. the claims as "groundless."

Zelenskyy had made the accusations on Thursday, claiming that Ukraine had intelligence indicating that China was supplying Russia with gunpowder and artillery, and that Chinese personnel were actively involved in arms production on Russian territory. He said more detailed informa-



Chinese nationals were reportedly captured by Ukrainian forces while fighting alongside Russian troops. President Zelenskyy alleged that these individuals were among at least 155 Chinese fighters believed to be serving in Russia's military. He accused Moscow of recruiting Chinese citizens via social media and other platforms, with Beijing allegedly "turning a blind eye" to these efforts.

As Bangladesh continues to seek justice and closure on the 1971 atrocities, Thursday's meeting is seen as a potential turning point in pushing historical issues onto the formal diplomatic agenda once again. Whether it leads to concrete action or remains symbolic will likely depend on future engagement at higher political levels.

"China's position on the Ukrainian issue has always been clear," Lin said. "We have never provided lethal weapons to any party induring a press conference. volved in the conflict. China remains committed to promoting a ceasefire, ending hostilities, and encouraging peace talks."

Allegations of Discrimination: TCS Under EEOC Investigation for Bias Against American Employees

The U.S. Equal Employment Opportunity Commission (EEOC) is currently investigating dozens of allegations against Tata Consultancy Services (TCS), India's largest IT outsourcing firm, over claims of discrimination against American employees based on age, race, and national origin. The majority of complaints come from professionals over the age of 40, who claim they were disproportionately targeted in layoffs, while Indian colleagues—particularly those on H-1B visas—were retained, according to a Bloomberg report.

TCS, which employs over 600,000 people worldwide, has strongly refuted the allegations, calling them "meritless and misleading." A company spokesperson stated that TCS maintains a strong record as an equal opportunity employer in the U.S., upholding high standards of integrity and values.

The complaints began surfacing in late 2023, prompting a growing wave of concern about the treatment of non-South Asian employees in the U.S. workplace. The EEOC's investigation, which started under President Joe Biden and has continued under President Donald Trump, remains confidential as per



federal law. In April 2024, U.S. Representative Seth Moulton (D-Mass.) called on the EEOC to deepen its probe, highlighting concerns over TCS's potential misuse of U.S. work visa programs, including H-1B and L-1A visas, intended to address skilled labor shortages. Moulton suggested that TCS's practices could reflect a broader pattern of discriminatory behavior within the company. This isn't the first time TCS has faced such scrutiny. In the UK, former employees have filed similar complaints, alleging discrimination based on age and nationality.

Further controversy arose from comments made by TCS's global head of HR, Milind Lakkad, who reportedly suggested reducing the proportion of American employees in the U.S. workforce from 70% to 50%, stating that this would create more opportunities for Indian staff. The remark has been cited in some EEOC complaints as evidence of discriminatory intent.

U.S. Imposes New Port Fees on Chinese Ships to Revive Domestic Shipbuilding

In a bold move to challenge China's dominance in global shipbuilding and revive America's declining maritime manufacturing sector, the United States announced new port fees targeting Chinese-built and Chinese-operated ships on Thursday, April 17, 2025. The decision comes amid escalating trade tensions between the two superpowers, further fueled by ongoing tariff disputes under former President Donald Trump's trade policy framework.

U.S. Trade Representative Jamieson Greer emphasized the strategic importance of shipping, calling it "vital to American economic security and the free flow of commerce." The new fees, which will go into effect from mid-October, aim to incentivize investment in U.S.-built ships and reduce the country's reliance on Chinese vessels.

The policy introduces per-tonnage and per-container charges for Chinese-linked ships docking in U.S. ports. Notably, these fees will be capped at five instances per year per ship, rather than applying at every port of call. Ship owners can qualify for a waiver if they commit to ordering American-built vessels.

The fees will differ for Chinese-built and Chinese-operated ships and are scheduled to increase progressively over the coming years. Initially, Chinese-built ships will incur fees of \$18 per net ton or \$120 per container. For a large vessel carrying 15,000 containers, the charge could amount to \$1.8 million



per visit.

U.S. shipbuilding, once a post-WWII powerhouse, has seen its global output shrink to a mere 0.1%. In contrast, China alone constructs nearly half of all ships globally, with South Korea and Japan rounding out over 95% of total civil shipbuilding, according to UN data.

Some 30 U.S. industry groups have expressed concerns over the move, warning that the fees could drive up costs for retailers already burdened by tariffs on steel, aluminum, and other imported goods. A business coalition cautioned the added financial strain could be "extraordinary."

The new policy also targets LNG carriers, which will face fees in three years, and introduces tariffs on Chinese cargo handling equipment and ship-toshore cranes. However, exemptions apply for Great Lakes and Caribbean shipping, U.S. territories, and bulk exports from empty vessels.

Conventional electricity projects are set to receive investments to approximateamounting ly ₹99,376 crore. Notably, Bihar will host a massive project worth ₹80,000 crore under this segment, while Odisha and Chhattisgarh are also slated to receive projects of smaller scale.

Revenue growth of states in FY26 expected to be lower than that of FY25

T ndian states are projected to witness La moderation in revenue growth in the financial year 2025-26 (FY26), primarily due to sluggish performance in non-tax revenue and central transfers, according to a recent report by ICICI Bank. The analysis is based on the budget data of 15 major states, which collectively contribute around 90% of the country's GDP.

The report highlights that total revenue growth for states is expected to decelerate to 13% in FY26, down from 16% in FY25. This is attributed to a decline in the growth of 'Own Tax Revenue' and a slowdown in funds transferred from the central government.

Total receipts of these states are estimated to increase by 12% year-on-year (YoY) in FY26, reaching ₹59 trillion. In comparison, the estimated growth for FY25 was 16%. Revenue receipts, which form nearly 75% of total receipts, are projected to rise by 13% to ₹43 trillion in FY26, down from 16% in FY25.

The slowdown is mainly driven by weaker growth in non-tax revenues and a reduction in the pace of central transfers. Non-tax revenue is expected to grow by only 12% in FY26, a significant drop from 23% in FY25. Similarly, transfers In summary, while tax revenue growth appears from the Centre are projected to increase by just stable, weaker growth in non-tax revenue and 10%, compared to 18% in the previous year.

States' Own Tax Revenue (SOTR) remains rela-



tively stable, with a projected growth of 14% in FY26, amounting to ₹23 trillion. This is on par with the growth recorded in FY25. For context, the central government's Net Tax Revenue is expected to rise by 11% over the FY25 Revised Estimates, reaching ₹29 trillion.

Google's Ad Tech Found Monopolistic

 $\mathbf{F}^{\mathrm{or}}_{\mathrm{a}}$ the second time in less than $\mathbf{F}^{\mathrm{or}}_{\mathrm{a}}$ year, tech giant Google has been formally labeled an illegal monopolist by a U.S. federal judge. This time, the ruling targets the company's digital advertising empire, marking a major blow to its dominance in online marketing technologies.

On Thursday, U.S. District Judge Leonie Brinkema, presiding in Virginia, ruled that Google unlawfully exploited its control over key parts of the online advertising ecosystem to inflate profits and entrench its market power. The judgment underscores long-standing accusations that Google has leveraged its position to undercut rivals and manipulate the digital ad marketplace in its favor.

The decision follows an earlier ruling in August 2024, which concluded that Google's search engine operations also violated antitrust laws by suppressing competition and innovation. With both of its core revenue engines—search and ads—now under legal scrutiny, the \$1.8 trillion company faces intensified regulatory pressure and potential structural reforms.

Google's digital advertising platform includes tools that span the full spectrum of the online ad chain—from ad creation and



auctions to placement and performance tracking. Prosecutors argued that Google's control over both the "buy" and "sell" sides of the ad market created an inherent conflict of interest, allowing the company to steer transactions in ways that favored its own services and competitors.

Judge Brinkema agreed with these assertions, declaring Google's behavior as monopolistic and abusive. Remedies could range from fines to a possible breakup of parts of its advertising business—though specific actions are still to be determined in subsequent hearings.

In response, Google defended its ad practices, claiming that its tools benefit advertisers and publishers alike through increased efficiency and reach. The company is expected to appeal the ruling.

As governments and courts grow more aggressive in policing Big Tech, this ruling may set a precedent for further legal action targeting concentrated power in the digital economy.


Budapest Students' Priceless First Bite of Pani Puri

"The Earth won't just explode one day," one scientist explained. "It will slowly become less and less hospitable until no complex life can survive."


