



# Telangana Partners with Japanese Firms to Build Eco Town in Hyderabad





In a landmark move to advance environmental innovation and sustainable development, the Telangana Government signed Letters of Intent (LoIs) with leading Japanese Eco Town companies to collaborate on circular economy initiatives, including the establishment of an Eco Town in Hyderabad.

## RTC to Fill 3038 **Vacancies Soon: Minister Ponnam Prabhakar Announces**

Telangana Transport Minister Ponnam Prabhakar has announced that the state government is set to fill 3,038 vacancies in the Telangana State Road Transport Corporation (RTC) soon. This recruitment marks a significant step after a long gap in hiring for the corporation.

Speaking to the media, Minister Prabhakar expressed satisfaction over the government's decision and revealed that official permission has already been granted for the recruitment. A notification will be released shortly, and the process of hiring will be carried out at the earliest.

He credited Chief Minister Revanth Reddy's leadership for the proactive governance and mentioned that the introduction of free travel for women under the Maha Lakshmi scheme has resulted in a massive rise in female ridership. So far,



165 crore women have availed of free travel, leading to an estimated savings of ₹5,500 crore for women across the state.

Minister Prabhakar also stated that new buses have already been procured to support the scheme, and now RTC is ready to bolster its workforce. This move is expected to strengthen public transport and improve service delivery across Telangana.

The recruitment process is anticipated to begin shortly, giving a major employment push in the public transport sector.

In a sharp attack on the ruling Congress government, BRS leader Patlolla Karthik Reddy declared that the party will soon launch 'COBRA' (Congress Occupied Buildings Retrieval Authority) as a counter to Congress's HYDRA (Hyderabad Asset Protection Authority). Speaking at a media interaction from Telangana Bhavan, Karthik Reddy alleged that Congress leaders, including the Chief Minister and his family, were involved in multiple land encroachment scams.

"Just like they brought in HYDRA under the name of asset protection, we will introduce COBRA to retrieve all the public and private properties

that Congress leaders have illegally occupied," said Karthik, stating that BRS will not remain silent against "organized land loot".

He went further to accuse the Congress regime of functioning like a "drunken truck on a highway" — directionless and chaotic, with leaders more focused on looting than governing. "They don't care about saving the party, only about what they can take before it crash-

es," he quipped. Echoing a similar tone, BRS leader Balka Suman lambasted the Congress government, calling it an "utter flop" and criticized CM Revanth Reddy for "targeting the Kaleshwaram Project out of political vengeance." He also expressed confidence that former CM KCR still lives in the hearts of the people and that Congress will face public revolt soon.

Both leaders expressed certainty that BRS would reclaim power in the next election, and vowed to "set right the damage done" by the Congress administration.

## **Heavy Rain Alert for Southern Telangana Districts**

The Telangana weather continues to remain unpredictable, with scorching heat in some parts and rainfall in others. The Indian Meteorolog-Department (IMD) has issued a rain alert Southern Telangana, forecasting moderate rain accompanied by thunderstorms and lightning over the next few days.

Rain is expected in Hyderabad, Rangareddy, Warangal, Nalgonda, Mahbubnagar, and

Khammam districts, with winds blowing at speeds of 30 to 40 km/h, according to the IMD. These sudden weather changes have left residents uncertain about daily plans, as sunshine quickly turns to showers.

Rainfall was also recorded in some areas on Friday and Saturday, including Hyderabad, where the downpour led to waterlogging on several roads, causing inconvenience to commuters. With temperatures soaring across India, the Bureau of Energy Efficiency (BEE), under the Ministry of Power, has issued a fresh appeal urging citizens and commercial establishments to set air conditioners at 24°C. This initiative is part of a national energy efficiency campaign aimed at reducing energy consumption, lowering electricity bills, and supporting environmental sustainability.

The Bureau estimates that increasing the AC temperature setting by just one degree Celsius can reduce power consumption by up to 6%. By maintaining the default setting at 24°C, the nation could save up to 20 billion units of electricity—resulting in a potential financial saving of ₹10,000 crore an-

Setting air conditioners at 24°C offers multiple benefits, starting with enhanced energy efficiency, as it can reduce electricity consumption by up to 24% compared to a 20°C setting. This leads to significant cost savings for both households and commercial users through lower electricity bills. Environmentally, it contributes to a substantial reduction in carbon

emissions, making it a sustainable choice. Moreover, operating ACs at a moderate temperature reduces strain on the compressor, thereby extending comfort range for most individuals, ensuring a balance between comfort and conservation.

To amplify the impact of this energy-saving measure, BEE has encouraged the use of additional tools such as ceiling or table fans to circulate air, proper insulation to retain cool air indoors, and programmable thermostats to adjust settings based on occupancy and time of day.

BEE Secretary Milind Deore emphasized the importance of this practice, especially in commercial spaces like shopping malls, hotels, government offices, and airports. He has requested air conditioner manufacturers to adopt 24°C as the default setting in new AC units and called on State Designated Agencies (SDAs) to initiate

mass awareness drives.

### **Attack Threat Against MLA** Arekapudi Gandhi **Creates Buzz**

Tension sparked in Telangana as a WhatsApp message claiming an imminent attack on MLA Arekapudi Gandhi began circulating widely. The message, sent by an unidentified individual, stated that four assailants were planning to attack Gandhi with knives after 5 PM while he was visiting a local goshala. The sender even named the alleged attackers — Aravind Kumar, Sai Rithesh Reddy, Kola Vamshi, and Gulla Nagarajulu — and shared their contact numbers.

According to the message, the individuals involved reportedly have past cases related to illegal weapons. However, one of the accused, Aravind Kumar, quickly refuted the allegations, calling them baseless. He announced plans to file a police complaint and demanded action against those spreading false information.

The issue gained more attention due to Arekapudi Gandhi's recent party switch. Originally elected as a BRS (Bharat Rashtra Samithi) MLA, Gandhi later joined the Congress, prompting BRS to file a complaint with the Speaker and take legal action. The party is currently fighting in court to disqualify 10 defected MLAs, including Gandhi. With the case in legal proceedings, speculation grew that BRS supporters could be behind the threat, a narrative echoed across social media platforms and by some Congress leaders. As of now, no concrete evidence has surfaced, but the matter remains under police review. The incident underscores the intensifying political tensions ahead of elections in the state.

In a significant crackdown, the Commissioner's Task Force, South Zone Team, apprehended a 24-year-old man for illegally procuring and selling pharmaceutical drugs without a valid license. The accused, identified as Yawer Hussain alias Adil, a private employee residing in Old Malakpet, was found in possession of 50 bottles of MephenTermin injections, a restricted medication.

Acting on credible information, the task force conducted a swift operation under the jurisdiction of Chadarghat Police Station and seized the injections along with one mobile phone from the accused. Preliminary investigations revealed that the individual was involved in unauthorized distribution of the drugs, violating norms under the Drugs and Cosmetics Act.

Officials stated that such illegal activities pose serious risks to public health, as drugs like MephenTermin are strictly regulated and should only be sold through licensed medical channels. The respondent and the seized materials have been handed over to the Chadarghat SHO for further legal proceedings. Authorities have urged the public to report any such illegal

drug sales in their locality, assuring strict action against those violating pharmaceutical laws. Inspector, South Zone Task Force confirmed the arrest and the ongoing investigation.

#### Illegal Hawala Money Seized at Hanumantekdi, Two Arrested

In a swift operation based on credible intelligence, Sultan Bazar Police intercepted and seized illegal hawala money amounting to Rs. 4.5 lakhs on April 19, 2025, at around 6:00 PM in the Hanumantekdi area, Hyderabad.

Inspector S. Srinivasa Chary along with his team, Police Constables A. Machagiri (PC 5212) and Srinivas (PC 5264), conducted vehicle checking after receiving a tip-off around 5:00 PM. During the operation, two suspicious two-wheelers — a Suzuki Burgman (TS09GC7863) and a Honda Activa (TS09FK8050) — were flagged. The riders attempted to flee but were immediately apprehended by the team.

Upon inspection, the team found a black plastic bag containing a large sum of cash. The suspects were identified as:

- Patel Lala Bhai, 44, a transporter from Ramkoti, Hyderabad (Suzuki Burgman rider)
- · Mohd Sami, 31, a businessman from Khairatabad
- (Honda Activa rider)

During interrogation, Patel Lala Bhai admitted that he was transporting the money on behalf of his employer to hand over to Mohd Sami as part of a hawala transaction. The police seized:

- Rs. 4.5 lakhs in cash
- · Two vehicles
- Three mobile phones (Vivo & Apple iPhone)

The seized material and individuals were shifted to Sultan Bazar Police Station, and the matter has been forwarded to the Income Tax Department for further investigation.

## 2.366 kg of Ganja Seized in Two Separate Cases by STF Teams in Hyderabad

Over the decades, civil services adapted from driving land reforms and spearheading the Green Revolution to enabling Digital India and real-time governance. The expansion to include diplomatic, environmental, and tax services reflected India's growing complexity.

Today, civil servants confront a new generation of challenges that demand agility, innovation, and empathy:

Internal Security requires intelligence-driven policing and cyber-readiness.

Diplomacy calls for mastering geo-economics and strategic communication.

Environmental Stewardship mandates balancing development with sustainability.

Electoral Integrity, social inclusion,

## The Silent Surge: AI, AGI, and the Understudied **Impact on Strategic Affairs**

(AI) arms race are becoming increasingly common as technological advancements accelerate. Much of the global discourse now speculates not only on the growing capabilities of AI but on how close we may be to achieving Artificial General Intelligence (AGI) — a form of AI that can outperform human cognitive abilities across a wide range of tasks and problems. Unlike narrow AI systems that are trained for specific purposes, AGI is envisioned as being capable of autonomous reasoning, learning, and decision-making beyond its initial programming or training.


As the pursuit of AGI intensifies, what remains striking is the lack of comprehensive academic attention on how such transformative technologies may affect strategic affairs. While developers, technologists, and futurists often dominate discussions on AI capabilities and ethics, the implications for international security, military doctrines, arms control, and geopolitical stability remain comparatively underexplored in mainstream strategic scholarship.

Despite the buzz around AI in public and policy circles, the strategic studies community has yet to fully catch up. This gap is critical. As AI becomes increasingly embedded in national defense infrastructures powering surveillance systems, autono-

Concerns about an artificial intelligence mous weapons, cyber tools, and battlefield decision-making—the potential for destabilization grows. Miscalculations fueled by algorithmic opacity, adversarial use of AI to target vulnerabilities, and an over-reliance on machine-led decision-making are real and present dangers.

> AGI, when realized, could compound these risks by enabling states to develop unpredictable and autonomous systems that are not just tools of warfare but actors in their own right. This opens the door to scenarios where the logic of deterrence and escalation management—foundational pillars of strategic stability—could be upended.

> Another concern is the asymmetry in AI development. Not all countries are progressing at the same rate. The digital divide may lead to technological hegemony by a few nations, sparking new forms of geopolitical competition and strategic coercion. As we move deeper into the AI era, a concerted effort is needed to integrate AI and AGI-related developments into the strategic discourse. Think tanks, military colleges, and international bodies must expand research to include the systemic and ethical implications of advanced AI systems in warfare and diplomacy. Without this, the strategic community may find itself ill-prepared for the future they are rapidly approaching.





### Can AI Make the Perfect Idli? A Breakfast **Experiment in Bytes and Batter**

Artificial Intelligence has taken over many domains I called "The Great AI Idli Experiment." But I had a with dazzling success. From composing symphonies to diagnosing diseases, we've watched in awe as algorithms do what once seemed the sole preserve of human intelligence. But can AI conquer the kitchen — more specifically, can it make a truly satisfying plate of idlis?

In my family, this question sparked the kind of debate usually reserved for politics or cricket. Opinions were flung around like mustard seeds in hot oil. My cousin, an AI engineer, firmly believed that if machines could land rockets and write poetry, they could surely steam up some idlis. My aunt, a culinary purist and idli traditionalist, was horrified. "You can't code intuition!" she declared. But it was our family matriarch who ended the discussion with quiet authority: "Artificial intelligence is good for a lot of things," she said. "But making the perfect idli is somewhere between a science and an art, and AI can't get there."

Now, as anyone who has made idlis knows, it all starts with the batter. And here lies the real challenge — getting the ratio of rice to urad dal just right, grinding it to the perfect texture, and then letting it ferment just enough. It's a delicate dance of temperature, time, and gut instinct. The result? Either fluffy, cloud-like discs of joy or sad, rubbery pucks that no amount of chutney can redeem.

To test our theory, I invited the family over for what

secret: instead of grinding batter myself, I used a branded, store-bought mix. The label claimed it was made with AI-powered precision — sensors monitoring temperature and humidity, algorithms calculating exact grain texture, fermentation time optimized down to the hour.

My reasoning? If AI had been employed in crafting this batter, then the idlis it produced would surely be at least semi-AI-made. I steamed the idlis using the same tried-and-tested method — a basic idli stand and steamer, nothing fancy. The kitchen filled with the familiar aroma. They looked fluffy. They felt soft. But how did they taste?

The family gathered, eyeing their plates with a mixture of skepticism and curiosity. The verdict? "Not bad," said my uncle. "Soft, but missing that little zing," noted my cousin. The matriarch chewed thoughtfully and smiled. "This," she said, "is a machine-made idli trying its best to be human."

It wasn't a total failure — AI had gotten close. But there was something missing, something intangible — maybe the hand that stirs the batter with memory, or the instinct that tells you the mix needs just a little more water.

In the end, we agreed: AI might help make a good idli, but the perfect idli? That still needs a human








### **Ex-DGP Murder:** Wife Under Probe

In a shocking development from Bengaluru, Karnataka's former Director General of Police (DGP) Om Prakash was found murdered at his residence in the upscale HSR Layout area on Sunday, April 20. His wife, Pallavi, is currently being questioned as the prime suspect in the case that has sent ripples through the state's police circles.

According to police sources, Om Prakash, 68, was discovered in a pool of blood in the living room with multiple stab wounds, reportedly inflicted with a kitchen knife. The retired IPS officer lived with his wife and daughter, the latter of whom was present in another part of the house during the incident.

What makes the case even more startling is the manner in which it came to light. Sources said that Pallavi called the wife of another retired DGP and allegedly confessed to the crime. Alarmed by the call, the woman immediately dialed the police emergency number 112 and informed authorities. Pallavi was detained by police shortly after the call. She is said to be undergoing detailed questioning as forensic teams examined the crime scene for evidence. No official motive has been confirmed yet, but investigators are looking into both personal and psychological angles.

Bengaluru Additional Commissioner of Police (West) Vikash Kumar Vikash confirmed the incident, stating: "This afternoon, around 4 to 4:30 pm, we received information about the death of former DGP and IGP Om Prakash. His son has been contacted and is in the process of filing a formal complaint. An FIR will be registered based on it."He added that no arrests have been made so far, but a detailed investigation is underway. The news has stunned many within the police community and among the public, as Om Prakash was a wellknown figure in Karnataka's law enforcement history. Questions surrounding the motive and sequence of events remain, but investigators are expected to release more details as the probe progresses. The tragic incident marks a grim chapter in the life of one of Karnataka's senior-most former police officials.



### 16 Militants Held in **Manipur Crackdown**

In a significant security operation in Manipur, police have arrested 16 members of various banned militant outfits over the last 48 hours, officials confirmed on Sunday, April 20, 2025. The crackdown is part of ongoing efforts to restore peace and curb insurgent activities in the region.

Among those apprehended were two cadres belonging to the proscribed United National Liberation Front (Pambei faction), one of Manipur's most notorious insurgent groups. The duo was captured on Saturday, April 19, from Napetpalli Andro road near Nongdam village in Imphal East district. The arrests were made following a targeted operation based on intelligence inputs, police sources said.

In addition to the arrests, security forces recovered a cache of arms and ammunition during the operations. Although authorities have not disclosed the complete inventory, sources revealed that the haul included automatic weapons, live rounds, and communication devices, which are suspected to be used in planned attacks or extortion activities.

The arrested individuals are believed to have been involved in multiple unlawful activities, including recruitment drives, extortion, and disrupting public order. Police are currently interrogating the suspects to uncover more information about their network, logistics, and any possible future threats. Manipur has been grappling with insurgency for decades, with several militant outfits seeking autonomy or independence.

## **Modi-Vance Meet: Trade Talks Ahead**

All eyes are on New Delhi as US Vice President JD Vance arrives in India on Monday for a four-day visit, marking his first trip to the country since Donald Trump's return to the White House earlier this year. His visit is being viewed as a key moment in the ongoing negotiations for a Bilateral Trade Agreement between India and the United States.

Vance is scheduled to land at 10 am at the Palam airbase in the national capital, accompanied by his Indian-origin wife, Usha Vance, and their three children – Ewan, Vivek, and Mirabel. The Vice President's agenda is packed with official engagements, cultural visits, and high-level diplomatic talks, the centerpiece being his meeting with Prime Minister Narendra Modi.Sources indicate that Modi will host a special dinner for the Vance family on Monday evening. This meeting is expected to set the tone for crucial discussions on trade, tariffs, and broader bilateral cooperation. The timing is significant, as the Trump administration's steep reciprocal tariffs—currently on a 90-day pause—have raised concerns in global markets. India was among the most impacted, facing tariffs as high as 26% on key exports to



the US. The Modi-Vance dialogue will likely focus on reducing trade barriers and paving the way for a comprehensive trade agreement, which has eluded both nations despite years of negotiations. Analysts believe this visit could provide the breakthrough needed, especially given the close personal ties between the Indian-American community and the Trump-

Vance leadership.In addition to Delhi, Vice President Vance is also expected to visit Jaipur, where he will engage with local business leaders and cultural figures. The visit underscores the US's strategic interest in deepening ties with India across trade, technology, and defense.

Meanwhile, the Indian government is reportedly making ex-

tensive preparations to welcome the Vice President and his family, with security and diplomatic teams already on the ground. With both nations seeking to reset and refresh their economic ties, this high-profile visit could prove to be a turning point in India-US relations. The world watches closely as Modi and Vance prepare for their first formal meeting.

## Ramban Reels After Deadly Landslides

Devastating landslides triggered by a heavy hailstorm have claimed three lives and left dozens homeless in Jammu and Kashmir's Ramban district. The calamity, which struck overnight, washed away homes, shops, and roads leaving behind destruction and despair.Local residents are now trying to come to terms with their loss. Om Singh, a resident, recounted the horror to ANI: "When I reached here, I saw the whole market, including my shop, had vanished... This is the first time I am seeing something like this." Behind him, damaged homes bore grim testimony to the scale of the disaster.

Ravi Kumar, a shopkeeper, lost both his shops in the deluge. "At 4 am, we heard the market had been washed away. We rushed over, only to find there was nothing left," he said. "We don't know who to turn to. These shops were our only livelihood. Now we have no shops, no land, nothing." He appealed to the government for immediate aid, including loan waivers. The tragic incident has triggered emergency response efforts. Senior Superintendent of Police (SSP) Ramban, Kulbir Singh, confirmed that all police stations have been placed on high alert. Around 100 people have been rescued so far from the affected area of Dharam Kund.

The landslides, described by residents as unprecedented in recent



memory, have not only resulted in loss of life and property but also exposed vulnerabilities in infrastructure and preparedness in the region. ### "No Choice But To Keep Fighting": Netanyahu **Vows To Continue Gaza Offensive**

Israeli Prime Minister Benjamin Netanyahu has reaffirmed his commitment to continue military operations in Gaza, asserting that Israel must fight on to ensure its survival. In a pre-recorded address on Saturday night, Netanyahu declared that the country has "no choice" but to pursue "victory" against Hamas, CNN reported.

"We must continue the war for our very own existence," Netanyahu stated, emphasizing the need for "perseverance and resilience" in both defeating Hamas and securing the release of the 59 Israeli hostages still believed to be held in Gaza.

The prime minister pointed to Hamas' rejection of a recent Israeli ceasefire proposal as justification for the ongoing offensive. The Israeli plan, according to CNN, included provisions for disarming Gaza but stopped short of a permanent cessation of hostilities—two elements that Hamas has consistently opposed.

"If we surrender to Hamas's demands now, all the tremendous achievements gained by our soldiers, our fallen, and our wounded heroes—those achievements will simply be lost," Netanyahu said in his message.

However, his remarks have drawn sharp criticism from the Hostage Families Forum Headquarters, a group representing the families of hostages. In a strongly worded response, the group accused Netanyahu of lacking a concrete strategy to rescue those still held captive. "Many words and slogans will not succeed in hiding the simple truth — Netanyahu has no plan," the forum stated. "It's no surprise there was no time for questions—otherwise, he would have had to answer the most basic one: What exactly is the State of Israel doing to immediately bring back all 59 hostages?"

The Israeli leader's stance also comes amid a wave of dissent within Israel's own military ranks. Israeli Army Radio, as reported by Al Jazeera, stated that over 150 soldiers from the elite Golani Brigade have signed a letter calling for an end to the war and urging the government to prioritize hostage negotiations.

This move follows previous petitions from more than 1,000 Israeli Air Force reservists and other veterans across the navy, armoured corps, and special units, demanding a shift in policy and an end to the prolonged conflict in Gaza.

# 'No Kings In America': Thousands **Hold Anti-Trump Protests Across US**

- Rally Across U.S. **Against Trump Policies in Nationwide Demonstrations**
- **Demonstrators** criticize defunding of research and spread of vaccine misinformation.
- **Coordinated protests** in all 50 states aim to build long-term peaceful resistance.



Thousands of demonstrators gathered across major U.S. cities on Saturday for a second wave of protests against former President Donald Trump and his administration's controversial policies. From New York City to San Francisco, crowds voiced concerns over immigration enforcement, attacks on democratic institutions, and the defunding of science and healthcare programs.

In New York, protesters assembled outside the city's iconic main library holding placards with slogans like "No Kings in America" and "Resist Tyranny." A major focus of the demonstrations was opposition to Immigration and

Customs Enforcement (ICE) and the administration's deportation practices. Chants of "No ICE, no fear, immigrants are welcome here" echoed through the streets.

In Washington, D.C., crowds rallied near the White House, raising alarms about the perceived erosion of constitutional protections. Benjamin Douglas, 41, said the administration's actions represented "a direct assault on the idea of the rule of law." Carrying a sign calling for the release of Mahmoud Khalil, a detained pro-Palestinian protester, Douglas criticized the administration for using individuals as "test cases" to stoke fear and weaken legal safeguards.

New York was 73-year-old Kathy Valy, the daughter of Holocaust survivors. Drawing historical parallels, she warned of creeping authoritarianism, saying, "What happened in Germany is what's happening here," though she added that Trump lacked the strategic intelligence of past fascist leaders.

In Baltimore, science was another central theme. Daniella Butler, a 26-year-old PhD student in immunology, protested the administration's attacks on scientific funding and vaccine misinformation. Holding a map highlighting measles outbreaks in Texas, she declared, "When science is ignored, people die."

Among the demonstrators in Smaller protests took place in peaceful resistance.

conservative areas like Galveston, Texas, where writer Patsy Oliver, 63, said she could no longer wait for elections to make a difference: "We've lost too much already."

On a San Francisco beach, several hundred participants spelled out "IMPEACH + REMOVE" in large letters, while others waved an upside-down American flag—an emblem of national distress.

The protests were coordinated by activist network 50501, symbolizing 50 protests in 50 states and one unified movement. Though turnout was smaller than the April 5 "Hands Off" demonstrations, organizers hoped to build sustained momentum through

### "Day Of Life Will Come": Zelensky To Ukrainians **Amid Putin's Easter Truce**

On Easter Sunday, Ukrainian President Volodymyr Zelensky delivered a heartfelt message urging Ukrainians to hold onto hope and continue their fight for peace, even as the war with Russia enters its 1,152nd day. Dressed in a traditional grey vyshyvanka—a Ukrainian embroidered shirt—Zelensky stood before Kyiv's historic Saint Sophia Cathedral, offering a message filled with emotion, resilience, and quiet strength.

"Ukraine never loses faith," said Zelensky, who is of Jewish heritage, in a video shared across social media platforms. "Because this faith is in each other. In those who stand next to you. In Ukrainian



men, in Ukrainian women. Faith that evil may have its hour but God will have his day."

His words resonated deeply in a country still under siege, as families marked Easter amid air raid warnings, power outages, and the constant uncertainty of life in a warzone. Despite the solemnity of the occasion, Zelensky's speech

was a call to remain hopeful and united.

A temporary ceasefire had been declared by Russian President Vladimir Putin on Saturday, purportedly in honor of the Easter holiday. However, Zelensky dismissed the gesture as hollow, pointing out that Russian forces continued military operations under the guise of a pause.

"They pretend to stop, while still trying to strike us in the dark," he said, referencing overnight attacks reported near the front lines.

Yet, Zelensky focused not on despair, but on the strength of purpose that still unites Ukrainians. "We know what we are defending.

We know what we are fighting for. For whom and for whose sake," he

Ending on a hopeful note, Zelensky envisioned a peaceful future for Ukraine—a day when the country would once again gather around the same table, celebrating Easter free from the shadows of war. "The day of life will come. The day of peace. The day of Ukraine. A day that lasts a century," he said. "And we will be able to gather together again. At one table. On a peaceful Easter."

The message served not only as a spiritual reflection but also as a reaffirmation of Ukraine's collective will to endure, resist, and ultimately heal.

#### Vancouver Gurdwara Vandalised with Pro-Khalistan Graffiti Amid Vaisakhi Celebrations

A prominent gurdwara in Vancouver, Canada, was vandalised overnight with pro-Khalistan graffiti, sparking concern and condemnation from the Sikh community. The incident occurred at the historic Khalsa Diwan Society (KDS) gurdwara, more commonly known as the Ross Street gurdwara, and came to light on Saturday morning—the same day as the world's largest Vaisakhi parade held in nearby Surrey.

Images shared by the gurdwara administration on its official social media channels showed the word "Khalistan" spray-painted multiple times on the exterior walls near the parking area of the Sikh temple. The Khalsa Diwan Society, which hosted its own Vaisakhi parade the previous weekend in Vancouver, had barred pro-Khalistan groups from participating in the celebrations—believed to be a possible motive behind the act of vandalism.

The Vancouver Police Department has launched an investigation into the incident. Canadian media reported that the police are treating the graffiti as a potential hate-motivated act.

In a statement issued later, the Khalsa Diwan Society condemned the incident, calling it a "painful moment" for the community. "A



small group of Sikh separatists, advocating for Khalistan, defaced our sacred walls with divisive slogans like 'Khalistan Zindabad'," the statement read.

The gurdwara said the act was aimed at creating fear and sowing discord within the Canadian Sikh community. "This is part of an ongoing campaign by extremist forces that seek to instill fear and division," KDS said. "Their actions undermine the values of inclusivity, respect, and mutual support that are foundational to both Sikhism and Canadian society."

The statement also highlighted the contributions of past generations who worked hard to establish a strong and united Sikh presence in Canada. "Extremists are undermining the dreams and sacrifices of our elders," the society said. "Their actions seek to divide us, contrary to the unity and peace we hold dear as Canadians."

### **India Chinese Students Join Forces To Sue Trump Over F-1 Visa Revocations**

Three Indian and two Chinese students have filed a class action lawsuit against the U.S. government over what they describe as the "unlawful termination" of their F-1 student visas. The lawsuit, filed in the U.S. District Court in New Hampshire, challenges the Trump-era policies that led to the revocation of visas for "thousands" of international students on what the plaintiffs claim are often minor or unjustified grounds.

The Indian students-Manikanta Pasula, Linkhith Babu Gorrela, and Thanuj Kumar Gummadavelli—are all pursuing their Master's degrees at Rivier University in New Hampshire. The two Chinese students, Hangrui Zhang and Haoyang An, are graduate students at Worcester Polytechnic Institute in Massachusetts. Together, they represent a broader group of international students affected by recent immigration crackdowns.



According to the lawsuit, these students were stripped of their legal status in the U.S., often for minor infractions such as driving without a U.S. license or lapsed insurance. In Pasula's case, he was arrested for driving without a U.S. license despite having a valid Indian license and an International Driving Permit—both acceptable under New Hampshire law for up to 60 days. Although he paid a fine and later obtained a U.S. license, he was informed by the State Department and the U.S. Consulate General in Mumbai that his visa had been revoked.

Gorrela and Gummadavelli faced similar charges and penalties, while the Chinese plaintiffs' cases stemmed from misunderstandings or minor insurance lapses. Despite some of these charges being dismissed, their student status was still terminated, leaving them vulnerable to fines, detention, and deportation.

The students argue that the Department of Homeland Security acted unilaterally, revoking visas without due process or consistent standards. They claim this has led to severe financial and academic hardships, including the inability to complete their degrees or participate in the Optional Practical Training (OPT) program post-graduation.

Representing over half a million Indian and Chinese students in U.S. academia, this lawsuit could have far-reaching implications for international education and visa policy reform in the United

### **India's Forex Reserves Continue Upward** Momentum, Rise by \$1.57 Billion



India's foreign exchange reserves continued their Lupward trajectory for the sixth consecutive week, rising by \$1.567 billion to reach \$677.835 billion for the week ended April 11, 2025, according to data released by the Reserve Bank of India (RBI) on Friday, April 19. This sustained increase follows a significant \$10.872 billion jump in the previous week ending April 4, 2025, taking the reserves closer to the all-time high of \$704.885 billion, which was recorded in September

Foreign currency assets (FCAs), which form the largest portion of the reserves, rose by \$892 million to \$574.98 billion during the week. These assets include investments in foreign currencies like the euro, pound, and yen. Their value, when expressed in U.S. dollars, also reflects the impact of currency exchange fluctuations.

India's gold reserves contributed significantly to the overall rise, increasing by \$638 million to \$79.997 billion. The consistent growth in gold holdings reflects the RBI's ongoing efforts to diversify its reserve portfolio and strengthen the country's financial cushion. However, there was a marginal dip in the Special Drawing Rights (SDRs), which declined by \$6 million to \$18.356 billion. SDRs are international reserve assets created by the International Monetary Fund (IMF) and allocated to member countries to supplement their official reserves.

India's reserve position with the IMF also improved slightly, rising by \$43 million to \$4.502 billion during the reporting week.

The steady climb in forex reserves comes amid a backdrop of global economic uncertainty and continued efforts by the central bank to ensure macroeconomic stability. A robust forex reserve position helps the country maintain investor confidence, manage exchange rate volatility, and meet import requirements in times of external shocks.

As the rupee faces pressures from geopolitical risks and fluctuating oil prices, the increase in reserves offers a critical buffer. Analysts believe that if this trend continues, India could once again approach or even surpass the previous record in the coming months, reinforcing the economy's resilience on the global stage.

### India's Oil & Gas Exploration: **NELP Yields \$36 Billion** Investment and 177 Discoveries

Tndia attracted over \$36 **⊥**billion in investments through nine bidding rounds under the New Licensing Exploration Policy (NELP) conducted before 2014, resulting in 177 oil and gas discoveries, according to a government-commissioned report. The report, prepared by a Joint Working Group (JWG) for the Ministry of Petroleum and Natural Gas, highlights the impact of NELP in expanding the exploration

landscape and drawing both private and foreign investors into the upstream sector.

From 1999 to 2010, 254 blocks were awarded under NELP, attracting \$17.6 billion in exploration spending and another \$18.64 billion in the development of oil and gas discoveries. These efforts led to 67 oil finds and 110 gas discoveries. Notably, Reliance-BP's KG-D6 block and ONGC's KG-D5 block — two of India's most significant natural gas contributors — were awarded during NELP rounds.

However, challenges emerged, including prolonged delays in environmental and regulatory approvals and disputes over cost recovery under the Production Sharing Contract (PSC) model. These issues prompted a strategic shift in 2016 with the introduction of the Hydrocarbon Exploration and Licensing Policy (HELP), which replaced the PSC regime with a Revenue Sharing Contract (RSC) model. Under RSC, companies share a pre-agreed portion of revenues with the government, simplifying operations and reducing bureaucratic friction.



The newer Open Acreage Licensing Policy (OALP), under the HELP framework, saw eight bid rounds between 2018 and 2022. These awarded 144 blocks and attracted \$1.37 billion in exploration investment, leading to six oil and four gas discoveries. Currently, 128 of these blocks remain active.

The government also launched the Discovered Small Fields (DSF) policy in 2015, aimed at monetizing marginal finds. Three DSF bid rounds awarded 85 areas, resulting in \$69 million in exploration and \$192 million in development investments. As of now, 51 of these areas are active.

The JWG, led by Additional Secretary Praveen M. Khanooja, recommended addressing regulatory delays, easing contract modifications, and improving operational flexibility to enhance ease of doing business in the sector. The report highlights that while NELP laid the foundation, ongoing reforms under HELP and DSF policies are reshaping India's E&P sector for greater transparency and global competi-

## **India's Energy Storage Sector** Set for ₹4.79 Lakh Crore **Investment Boom by 2032: IESA**

Tndia's energy storage **L**sector is poised for a massive expansion, with investments projected to reach ₹4.79 lakh crore by 2032, according to the India Energy Storage Alliance (IESA). The announcement was made during the 5th edition of the International Conference on Stationary Energy Storage India (SESI) 2025, recently held in Gandhinagar, Gujarat.

The IESA estimates that the energy storage market will grow five-fold between 2026 and 2032, driven by strong policy support and increasing private sector engagement. As per the National Electricity Plan (NEP), storage capacity is expected to rise sharply—from 16.13 GW in 2026-27 to 73.93 GW by 2031-32. This includes both pumped storage projects and battery energy storage systems (BESS). Energy storage volume will also leap from 82.37 GWh to 411.4 GWh during this period.

Vinayak Walimbe, Managing Director of Customised Energy Solutions (CES), which founded IESA, emphasized the urgent need for investments to foster innovation and create a resilient storage infrastructure. "This is the moment to build an advanced and scalable energy storage ecosystem in India," he said.

Over 200 stakeholders from more than 10 partner countries attended the event, including policymakers, global experts, and leading energy firms. Discussions ranged from upcoming storage tenders and evolving battery standards to



energy storage's role in supporting India's renewable energy transition.

Gujarat Power Corporation's Managing Director, Arun Mahesh Babu, highlighted growing interest in long-duration storage tenders, with bids for 8-hour projects expected soon. Gujarat, with over 30 GW of renewables, is aiming for 100 GW by 2030—expected to significantly boost storage demand.

Looking ahead, SECI CMD RP Gupta revealed even more ambitious goals: 500 GWh of storage capacity by 2030 and 5,000 GWh by 2047. Falling costs are also encouraging investments, with battery storage costs dropping from ₹10 lakh/ MW/month to ₹2.5 lakh/MW in just 2-3 years, said CEA Chairperson Ghanshyam Prasad.

Supported by central and state agencies and private giants like Adani and JSW Energy, the SESI conference reinforced India's goal of becoming a global clean energy innovation hub through advancements in storage, e-mobility, and green hydrogen.





## Boy Swallows Gold Bar, **Needs Surgery**

Tn a startling and unusual case **I**from China's Jiangsu province, an 11-year-old boy had to undergo emergency surgery after swallowing a 100-gram gold bar. The boy, identified by his surname Qian, was playing at home when the incident occurred.After swallowing the bar, Qian informed his parents that he felt an unusual swelling in his abdomen. Although he did not experience any pain or visible distress, the swelling raised immediate concern. His parents quickly took him to the Suzhou University Affiliated Children's Hospital for a medical examination.



Doctors at the hospital conducted an X-ray, which revealed a dense metallic object lodged in the boy's intestines. Further scans and tests confirmed that the item was a solid gold bar weighing approximately 100 grams — about the size of a small candy bar but far heavier and potentially far more dangerous. Medical staff acted swiftly and successfully performed surgery to remove the object. Fortunately, the operation went smoothly, and the boy is now reported to be in stable condition.The incident has sparked conversations online about child safety and parental supervision, especially around small or valuable objects that can easily be mishandled by children. While

swallowing foreign objects is not uncommon among children, ingesting something as dense and potentially obstructive as a gold bar is highly unusual — and extremely risky.

Doctors have issued a public advisory urging parents to closely monitor their children at home, particularly when valuables or hazardous items are within reach. Children's natural curiosity can often lead them to put unfamiliar or shiny objects in their mouths, sometimes with dangerous consequences. This bizarre medical case serves as a reminder that even in seemingly safe environments like the home, accidents can happen. Vigilance, awareness, and prompt medical attention can make all the difference in such situations.

### **Ancient Reptiles That Ruled Earth**

before humans Lemerged, Earth was ruled by colossal reptiles that dominated the land, oceans, and skies. These prehistoric giants thrived for millions of years during a time known as the Mesozoic Era — an age that still fascinates scientists due to the creatures' mysterious rise and extinction.The Mesozoic Era, often referred to as the "Age of Reptiles," spanned roughly 186 million years and is divided into three distinct periods: the Triassic (252–201 million years ago), the Jurassic (201-145 million years ago), and the Creta-

ceous (145–66 million years ago). Each period saw the evolution of incredible species that left a permanent mark on Earth's history.

In the Triassic period, early dinosaurs began to appear alongside marine reptiles and the ancestors of crocodiles. The Jurassic period witnessed a boom in dinosaur diversity, including famous giants like the Stegosaurus and Brachiosaurus. By the Cretaceous, iconic predators such as the Tyrannosaurus rex — the "Tyrant Lizard King" — ruled the terrestrial ecosystems.Not all fearsome reptiles were dinosaurs. The "Super Croc" — formally known as Sarcosuchus — was a monstrous crocodile-like reptile that lived around 112 million years ago. It grew up to 40 feet long and weighed as much as 8 tons, making it



one of the largest crocodilians to ever exist.

In the oceans, Plesiosaurs and Mosasaurus reigned supreme, while the skies were dominated by winged reptiles like Pterosaurs, some with wingspans rivaling that of small aircraft.Despite their dominance, these creatures vanished suddenly around 66 million years ago during the mass extinction event likely caused by a massive asteroid impact and volcanic activity. The extinction wiped out nearly all dinosaurs, paving the way for mammals — and eventually humans — to take over.

Today, fossils and ongoing research continue to unravel the secrets of these ancient rulers, offering glimpses into an Earth that once belonged entirely to reptiles.

### NIV Criticized for Withholding H5N1 Data nificant consequences for outbreak response and disease mon-

The National Institute of Virology (NIV), Pune, is once again under scrutiny for its persistent reluctance to share crucial genomic data before formal publication. This longstanding practice of prioritizing research papers over immediate public access to vital information has raised serious concerns, especially in the context of deadly infections. The latest case involves a two-year-old girl from Narasaraopeta in Palnadu district, Andhra Pradesh, who died from H5N1 infection on March 16, 2025. She was admitted to AIIMS-Mangalagiri on March 4. The Virus Research and Diagnostic Laboratory (VRDL), under the Indian Council of Medical Research (ICMR), first identified the virus as Influenza A on March 7. On ICMR's recommendation, samples were sent to NIV for subtyping.

NIV confirmed the presence of the H5N1 strain, a highly pathogenic avian influenza virus. However, even as of April 20 over three weeks after confirmation — NIV has not disclosed which clade of the virus was involved. This detail, which can



be determined quickly using genome sequencing and phylogenetic analysis, remains unavailable to public health officials and researchers. Experts argue that such delays can have sig-

itoring. Timely clade identification helps determine the virus's virulence, transmissibility, and whether it poses a risk of human-to-human transmission. Withholding this data stalls preparedness and surveillance.

The issue is not new. NIV has previously been criticized for similar practices, including during the case of an 11-year-old boy infected with H5N1 in 2021. The reluctance to promptly release genome sequences and analysis results hampers collaboration and undermines public health efforts. Meanwhile, H5N1 continues to spread in the animal population. As of February 20, 2025, the World Organisation for Animal Health reported 99 infected cats and 18 deaths. Experts and public health advocates are urging NIV and ICMR to adopt open-access policies and prioritize transparency, especially in the face of potentially dangerous viral outbreaks.

The term gained further popularity during the 1840 U.S. presidential campaign of Martin Van Buren, whose nickname was "Old Kinderhook" (based on his hometown in New York). Supporters started using "OK" as a slogan — meaning both "Old Kinderhook" and "Oll Korrect." The catchy term stuck, and it soon spread beyond politics into everyday language.
