

Dy CM Pawan Kalyan's **Key Initiative to Support Livestock in Villages**

- ₹12,500 water tanks for livestock under Employment **Guarantee Scheme**
- ₹56.25 crores allocated for construction of tanks

In a major step to ensure that livestock do not face drinking water shortages, Panchayat Raj and Rural Development Minister Pawan Kalyan has issued key orders for the construction of 12,500 water tanks across rural villages. This initiative, aimed at supporting farmers and their livestock, comes under the Employment Guarantee Scheme.

Speaking to the media, Pawan Kalyan highlighted the significance of this program, which will be implemented using funds from the Employment Guarantee Scheme. A total of Rs. 56.25 crores has been allocated to construct these water tanks, which will ensure a reliable water supply for livestock, especially during the challenging summer months. The Minister emphasized the urgency of the project, instructing officials to complete the construction of all 12,500 tanks by April 15, ensuring that they are fully operational in time for the summer season. This move aims to alleviate the strain on farmers who often struggle with water scarcity for their livestock during the hot months.

Nara Lokesh's Steps Toward Poverty Eradication: A Dream Come True for Mangalagiri's Poor

Fulfilling a key election promise, Nara Lokesh is set to launch the first phase of house title distribution under the 'Mana Illu-Mana Lokesh' initiative on April 3. This program aims to provide permanent rights to people living on government lands, a decades-old dream for the underprivileged residents of Mangalagiri. During the general elections, Lokesh had pledged to address these land issues, and now, his commitment is turning into reality.

Lokesh, who won with a record-breaking 91,413 votes, has personally overseen the process of gathering details from residents on government lands, ensuring a seamless application process. Their misconduct appears to have targeted SC students, with offers of free meals, biryani, and even drugs as part of their manipulative tactics.

Several students who faced harassment eventually dropped out of their studies, unable to cope with the traumatic experiences. Despite a formal complaint filed with Vice-Chancellor Prasanna Sri, no substantial action has been taken. The students claim that the VC initially appeared supportive but later softened her stance, allegedly shielding the accused professors. The allegations include not only sexual harassment but also caste-based discrimination, with students being coerced and threatened if they refused to comply. One female student who reported the incident to the VC provided detailed evidence of harassment, yet no disciplinary measures were initiated. The university's Women's Cell, which was entrusted with the investigation, has reportedly conducted a biased inquiry, failing to consider the victim's testimony seriously.

It is also alleged that the professors are receiving protection from university authorities and the resident advocate, with efforts made to silence the victims and suppress the complaints. Reports suggest that some of the accused are threatening to expel stu-

dents if they continue to pursue justice. The victims are now considering approaching Education Minister Nara Lokesh directly to seek intervention in the matter. They hope that by bringing this issue to the attention of higher authorities, appropriate action will be taken against the accused professors and justice will be served.

The question remains whether VC Prasanna Sri will act decisively or if Minister Nara Lokesh will be compelled to intervene to ensure the safety and dignity of the students at Nannayya University.

Smart Ration Cards Will be Issued From May – Minister Nadendla Manohar

- New ration cards to be issued from May

The Andhra Pradesh government has announced a significant initiative to introduce ATM card-sized ration cards, aimed at enhancing convenience and security. State Food and Civil Supplies Minister Nadendla Manohar stated that the new ration cards will be issued from May, following the completion of e-KYC. These redesigned cards will feature QR codes and additional security measures, allowing for seamless addition, removal of family members, and card splitting.

Minister Nadendla clarified that the number of beneficiaries to receive these cards will be determined post e-KYC. The initiative is part of the government's efforts to streamline the ration card system and make it more user-friendly.

Meanwhile, the second phase of cylinder booking under the Deepam-2 scheme has commenced from April 1st. Minister Nadendla noted that three gas cylinders are being provided free of cost per year under this scheme, with gas companies reporting that 2 lakh new connections have been issued.



Additionally, the minister announced that fine rice would be supplied for the mid-day meal scheme starting from June. An investigation is underway into irregularities in the purchase of MDUs, with 35.93 lakh tonnes of paddy procured during Kharif. Minister Nadendla emphasized that payments are being deposited into farmers' accounts these exports.

SC Orders Dr. **Padmavati to Appear** in RRR Custodial **Torture Case**

In a major development concerning the custodial torture case of Deputy Speaker Raghuramakrishna Raju, the Supreme Court has ordered Dr. Padmavati to appear before the CID for questioning. Dr. Padmavati, who is accused of providing a false medical report, must meet with the investigating officer on April 7th and 8th at 10 AM. The Court issued a stern warning that her interim protection will be revoked if she fails to cooperate with the investigation.

During the hearing, government lawyer Siddharth Luthra presented evidence highlighting Dr. Padmavati's non-cooperation, which led to the Court's decision. The bench, comprising Justice Vikram Nath and Justice K. Viswanatham, emphasized the need for her compliance.

Earlier, Dr. Padmavati had approached the Andhra Pradesh High Court for anticipatory bail, but her plea was rejected. She later moved the Supreme Court, which granted her interim protection. However, her failure to appear for the hearing prompted the government to seek the revocation of this protection. The case has now been adjourned to April 15th for the

Waqf Amendment Bill to Be Tabled In Lok Sabha On Wednesday

The Waqf Amendment Bill, which proposes significant changes to the administration of central and state Waqf boards, will be tabled in the Lok Sabha on Wednesday, announced Union Minority Affairs Minister Kiren Rijiju. The bill, initially introduced in August last year, was subsequently referred to a joint parliamentary committee (JPC) for scrutiny.

The second half of the Budget session of Parliament, set to conclude on Friday, will see the bill discussed for eight hours after the Question Hour. The session duration may be extended at the discretion of Speaker Om Birla. The bill has sparked debates between the ruling BJP and opposition parties, with the latter alleging that the committee's chair rushed through proceedings without adequate consultation.

The JPC, comprising 16 MPs from the BJP and its allies and 10 from the opposition, submitted its report in February. The report proposed 66 changes, of which 23 were from the ruling party, while the remaining 44 were from the opposition. Only 14 of the 23 BJP-backed changes were ultimately cleared, while all opposition amendments were rejected.

The bill's original draft suggested nominating non-Muslim and at least two women members to each Waqf board, along with a Union Minister, three MPs, and individuals of national repute. There was also a proposal to limit donations from Muslims practicing their religion for at least five years. These changes have drawn strong criticism from opposition leaders, who claim the bill violates constitutional rights, including Articles 15 and 30.

Supporters of the bill argue that it aims to empower Muslim women and children and curb illegal land occupancy by Waqf boards. However, the controversy continues, with opposition leaders and community representatives raising concerns about infringement on religious rights.

TDP Supports Waqf Act Amendment Bill; Issues Whip for MPs' Attendance The TDP has announced its support for the Waqf Act Amendment Bill, directing all its MPs to be present in the Lok Sabha on Wednesday. TDP Chief Whip Harish Balayogi issued a 3-line whip, emphasizing the importance of the bill's discussion.

The Modi-led NDA government will present the bill in the Lok Sabha on Wednesday, with the Rajya Sabha discussion scheduled for Thursday. Eight hours have been allotted for discussions in both Houses. The BJP and Congress have also issued whips to their MPs to ensure attendance.

YSRCP Leaders Demand SIT Probe and Justice for Naganjali's Family

YSRCP State Women's President Varudu Kalyani, Official Spokesperson Shvamala, and Former MP Margani Bharat Ram visited the family of pharmacy student Naganjali, who attempted suicide and is undergoing treatment at Bollineni Hospital in Rajamahendravaram. They submitted a petition to the DSP, demanding immediate action and a

thorough investigation. Speaking on the occasion, Kalyani expressed her anguish over seeing Naganjali unconscious when she should have been completing her final year of pharmacy education. She emphasized that her pain is evident in her suicide note and blamed a person named Deepak for inciting the tragic incident. Kalyani questioned why the CCTV footage from the hospital has not yet been provided to the parents, even though the incident occurred 10 days ago. She stressed that the footage could clarify whether Naganjali administered the injection herself or if someone else was involved. Kalyani also criticized Chief Minister Chandrababu Naidu, Deputy CM Pawan Kalyan, and the Home Minister for their silence on the matter. She vowed to continue fighting until justice is served to the victim's family and demanded better medical treatment for

Naganjali.

YSRCP Spokesperson Shyamala echoed these concerns, expressing doubts about whether Naganjali administered the injection herself or if foul play was involved. She condemned the government's alleged reluctance to take decisive action and accused the coalition government of failing to ensure women's safety. Shyamala called for a thorough investigation and immediate justice for the victim's family. Former MP Margani Bharat Ram demanded stern action against Deepak, who is accused of torturing Naganjali. He questioned whether Deepak's uncle, who is allegedly affiliated with the ruling party, had been suspended or protected by the party. Bharat raised concerns over discrepancies in the police investigation and called for a comprehensive inquiry to uncover the truth.

Naganjali's parents, awaiting justice, tearfully demanded that their daughter be returned to them healthy and expressed frustration over the lack of progress in the investigation. Her classmates described Naganjali as a bright and dedicated student, confident that she would not resort to such an act with only a few months left to complete her course and receive a gold medal.

Vallabhaneni Vamsi's Remand Extended Till April 15th

Raja Singh Appeals to Chandrababu Naidu, Nitish Kumar for Waqf Board **Bill Support**

BJP leader and Goshamahal MLA Raja Singh has appealed to Andhra Pradesh Chief Minister Nara Chandrababu Naidu and Bihar Chief Minister Nitish Kumar to support the Waqf Board Bill. Singh emphasized that the Chief Ministers should show the courage to introduce the bill, asserting that Prime Minister Narendra Modi has made the right decision by bringing it forward.

Raja Singh alleged that the Waqf Board had unlawfully seized lands belonging to temples, farmers, and poor people by issuing notices. He stated that the Central Government's proposed bill could effectively halt such acquisitions, thus providing relief to the affected parties.

Singh urged the Chief Minister to grant permission for the event, highlighting its peaceful history and religious significance.

Supreme Court Serves Notices to Former AP CBCID Chief Sanjay

The Supreme Court has served notices to former Andhra Pradesh CBCID chief Sanjay in a corruption case involving the fire department. The notices were issued following the AP government's decision to challenge the anticipatory bail granted to Sanjay by the

The case against Sanjay was registered by the AP government, alleging corrupt practices during his tenure in the fire department. Dissatisfied with the High Court's decision to grant him anticipatory bail, the state government filed a petition in the Supreme Court, prompting the issuance of notices.

In a related development, former minister and YSRCP leader Kakani Govardhan is reportedly facing fresh legal trouble. Reports suggest that an SC/ST case has been registered against him under additional sections concerning a mining case. Allegations have surfaced that explosives were found at Rustom Wines, where tribals were allegedly detained.

Furthermore, accusations have emerged that Govardhan's followers threatened the tribals involved in the incident, intensifying the controversy. The latest developments have sparked a political stir, drawing widespread attention and prompting closer scrutiny from authorities.



AP High Court Makes Key Observations on Kakani Govardhan Reddy's Bail Petition

The Andhra Pradesh High Court made significant observations during the hearing of former minister Kakani Govardhan Reddy's anticipatory bail petition in the illegal mining case. During Tuesday's hear-

ing, Kakani's lawyers contended that the charges against him were not severe and requested anticipatory bail. However, the government lawyer in-

formed the court that an SC/ST case had also been registered against Kakani. The court directed that the details of the SC/ ST case be submitted to the petitioner and presented before the court. While Kakani's lawyers sought a directive to prevent his arrest, the court declined, citing previous orders prohibiting arrest in SC/ST cases. The government lawyer highlighted that indicating he was celebrating Ugadi with

Kakani failed to appear for hearings despite receiving notices twice and was not cooperating with the investigation. The High Court adjourned the hearing to April 3, instructing both parties that the case would be thoroughly investigated on that

Meanwhile, Kakani is facing allegations of illegal looting of quartz ore from Rustum Mines in Podalakur mandal, Nellore district. An FIR has been registered against seven individuals, including Kakani. While two suspects have been arrested and remanded for 14 days, Kakani and four others remain absconding.

Police have issued notices to Kakani twice. On the first attempt, they pasted the notice on the gate of his residence, but Kakani later shared photos on social media,

MLA Bathula Balaramakrishna Reviews Water Supply and Irrigation Projects

Rajanagaram MLA Bathula Balaramakrishna has instructed officials to ensure water supply issues are addressed proactively, keeping in mind the upcoming summer season. On Tuesday, he reviewed the progress of various water supply works with RWS engineering officials in the constituency.

He emphasized that all necessary steps should be taken to resolve water scarcity in areas such as Koonavaram, Gadarada, and Kanupur. Proposals are to be prepared to supply quality drinking water across all villages. The MLA directed officials to coordinate with the Electricity Department to resolve power issues affecting the Muggala Water Tank and Inaganti Vari Peta. Reviewing the construction of water tanks in areas like Jambupatnam, Narasapuram, Mukkinadapakalu, Mallampudi, and others, he ordered immediate commencement of pending works. Construction of



Burugupudi, Narasapuram, and Munagala should be expedited once the tender process is completed.

Balaramakrishna highlighted that out of 19 works worth ₹12 crore, ₹7.89 crore worth of works have been partially completed, while the remaining ₹5.58 crore worth of works are pending due to technical reasons. He assured that pending approvals will be taken up with the government to expedite the tender process.

He also mentioned that works sanctioned under JGM worth ₹1.28 crore in Kesavaram, Burugupudi, Narasapuram, and Dosakaya Palli Munagala should proceed swiftly after tenders are finalized. For the borewell sanctioned under DMF with an estimated cost of ₹16.50 lakh in Chakradwara Bandham, works are expected to begin soon after tender finalization.

During a separate meeting on irrigation projects, Balaramakrishna instructed officials to prepare proposals for strengthening the Venkatanagaram pumping scheme. Due to improper management, irrigation water is not being effectively utilized under this scheme. Proper O&M proposals will be submitted to the government for necessary funding.

The meeting was attended by the Executive Engineer, Deputy Executive Engineer, and Assistant Engineer of the pumping scheme.

The Central Government's Mission for Integrated Development of Horticulture (MIDH) has been striving to comprehensively develop the horticulture sector since 2014-15. Union Minister of State for Agriculture and Farmers Welfare, Ram Nath Thakur, highlighted the scheme's objectives, adding that it is supplemented by initiatives such as the Market Intervention Scheme (MIS) and Price Difference Compensation Payment (MIS-PDPS) to support horticulture farmers. However, Vijayawada MP Kesineni Shivanath (Chinni) raised questions in the Lok Sabha regarding the support provided by the Union Government to horticulture farmers, particularly in Andhra Pradesh, over the past five years. He called for more clarity on the government's efforts to aid these farmers.

Studies conducted by organizations, including NITI Aayog, have evaluated the MIDH scheme. Key issues faced by horticulture farmers were identified, including inadequate remunerative prices, lack of storage facilities, marketing challenges, and water supply problems. To address these concerns, several initiatives have been introduced, including the establishment of Horticulture Excellence Centres (CoEs) to promote modern farming techniques, the Horticulture Cluster Development India.



Programme (HCDP) to foster market-oriented growth, and the Clean Plant Programme (CPP) to ensure the supply of disease-free plants. Additionally, Post-Entry Quarantine (PEQ) facilities aim to improve productivity through quality plant breeding.

In Andhra Pradesh, significant progress has been made in horticulture production under MIDH. The state recorded 28,327 metric tons of production from 1,555 hectares in 2019-20, 26,766 metric tons from 1,553 hectares in 2020-21, 25,999 metric tons from 1,633 hectares in 2021-22, and 28,356 metric tons from 1,676 hectares in 2022-23. In 2023-24, 27,212 metric tons were produced from 1,676 hectares.

The MIDH continues to evolve, aiming to resolve the ongoing challenges in the horticulture sector while promoting sustainable farming practices across

Infant Kidnapping at Rampachodavaram Area Hospital Solved Swiftly

A swift police operation led to the successful recovery of a kidnapped infant from the Rampachodavaram Area Hospital on Monday. \$1.7 Trillion: Why Investors Are Betting Big On US Despite Recession Fears

Despite recession whispers and President Donald Trump's tariff turbulence, the US has secured \$1.7 trillion in investment commitments since his second term began on January 20, 2025, signaling robust faith in its economic future as of April 1. Giants like Apple, TSMC, and Saudi Arabia are driving this influx, betting on long-term gains despite short-term chaos. Syed Zubair Ahmed explores why investors remain bullish.

In under three months, standout pledges include Saudi Arabia's \$600 billion (potentially \$1 trillion) over four years, Apple's \$500 billion for AI infrastructure and 20,000 jobs, and a \$500 billion Stargate project by OpenAI, Oracle, and SoftBank to dominate AI. TSMC's \$100 billion adds to its \$165 billion US total, while Eli Lilly (\$27 billion) and Hyundai (\$21 billion) bolster manufacturing. These moves, tied to Trump's "America First Investment Policy," aim to secure semiconductors and tech supremacy, countering China.

Trump's tariff bravado—set to escalate April 2—has rattled markets, yet his knack for luring capital shines. Infrastructure, AI, and chip production could cushion a downturn, reinforcing the US as an innovation hub. Critics, however, question if these billions will materialize, recalling unfulfilled Saudi promises from his first term. FDI has historically wavered, and lofty announcements often shrink under scrutiny.

Economic headwinds loom: inflation persists, interest rates bite, and the dollar recently slumped 3.4%. Germany's spending surge and Trump's "transition" talk—echoed by Treasury Secretary Scott Bessent's "detox" warning—add uncertainty. Investors love tax cuts but hate unpredictability, and Trump's trade flux keeps them guessing.

Still, Trump 2.0 exudes aggression. His "economic nationalism" pushes onshoring and tariffs, pressuring allies into deals. Supporters see a strongman delivering results; skeptics see hype. Will Apple's factories rise in Houston? Will TSMC's chips roll out of Texas? Or is this another mirage? As of April 1, 2025, \$1.7 trillion hangs on Trump's ability to turn pledges into reality amid a jittery global landscape. Time will tell if this gamble pays off—or fizzles like before.

Yunus' Remarks on Chicken's **Neck Ignite Fury in India**



Bangladesh's interim leader Muhammad Yunus stirred outrage in India with comments spotlighting the landlocked Northeast and the strategic Chicken's Neck corridor. Speaking during a visit to China, Yunus called the seven Northeastern states—termed the "Seven Sisters"—a landlocked region, positioning Bangladesh as their "guardian of the ocean." He suggested this could extend China's economic reach, a remark that has inflamed tensions given Delhi's fraught ties with Beijing post-Doklam and cooling relations with Dhaka since Sheikh Hasina's ouster.


The Chicken's Neck, or Siliguri Corridor, is a slender 20-km-wide strip in West Bengal linking India's Northeast to the mainland. Flanked by Nepal, Bhutan, and Bangladesh, it's the sole land route for road and rail to the region. Its vulnerability was laid bare in the 1962 Sino-Indian War, when China's advance underscored the risk of a chokehold isolating the Northeast. The 2017 Doklam standoff, where India halted China's road-building near Bhutan, further highlighted its sensitivity, ending in a tense disengagement.

Yunus' remarks come as Bangladesh's in-

terim government, in power since Hasina's exit last year, pivots toward China, unsettling India. Historically, Delhi enjoyed warm ties with Dhaka, rooted in the 1971 Liberation War, but recent minority attacks and Bangladesh's outreach to Beijing have strained this bond. Yunus' China trip, including a meeting with Xi Jinping, amplifies India's security concerns over the Chicken's Neck, a lifeline now under geopolitical scrutiny.

Indian leaders reacted swiftly. Assam Chief Minister Himanta Biswa Sarma slammed the comments as "offensive," urging robust rail and road upgrades to bolster the corridor, warning of its persistent vulnerability. Congress leader Pawan Khera accused Bangladesh of inviting China to encircle India, blasting the BJP's "deplorable" foreign policy for failing the Northeast. "A country we helped create is now trying to surround us," he said.

As of April 1, 2025, Yunus' words have thrust the Chicken's Neck into focus, exposing India's strategic anxieties amid shifting regional dynamics and an emboldened Sino-Bangladesh axis.

Unlike Shah Rukh's urban charm or Aamir's cerebral appeal, Khan's kingdom thrives in India's hinterlands—small towns, slums, and mohallas—where his rugged hope resonates with the marginalized, especially working-class Muslims sidelined by post-lib-

Shohini Ghosh ties Khan's 1990s rise to communal tensions, as Muslims faced alienation amid the Hindu Right's ascent. His "bad boy" image marred by legal woes—mirrored their vulnerability, forging a visceral bond. Eid releases transcend films; they're communal affirmations, his body a canvas of defiance and triumph. Being Bhaijaan probes this masculinity, with fans like Shan and Balram internalizing Khan's macho ideals—protection, stoicism—shaping their gender views, sometimes conservatively.

Yet, this devotion carries a homoerotic edge, a "Bhai-code" where fans' intense loyalty—chanting "Jai Salman"—binds them in brotherhood. Khan's body, not the heroine, holds their gaze. This fandom, though fierce, falters when his actions—like his 2014 Modi tie-up—jar their ideals, as seen in Jai Ho's tepid response. Richard Dyer's lens on stardom's fragility fits here: Khan's image, built on muscle and myth, shifts with time. His latest Eid flop, Sikandar (April 2025), underscores a fading vigor, his once-unstoppable frame now hinting at decline—a trueblue star whose descent is as iconic as his rise.





India and Chile Strengthen Ties on Critical Minerals and Trade

Prime Minister Narendra Modi, in a joint press address with Chilean President Gabriel Boric Font at Hyderabad House on Tuesday, announced that India and Chile would initiate discussions on a Comprehensive Economic Partnership Agreement (CEPA), with a significant focus on critical minerals, trade, and economic cooperation. Emphasizing the importance of resilient supply and value chains, PM Modi highlighted that both nations are committed to forming a mutually beneficial economic partnership. He further stated that India is ready to share its expertise in digital public infrastructure, renewable energy, railways, space, and other sectors with Chile.

As part of their collaboration, India and Chile signed a Letter of Intent recognizing Chile's strategic role as a gateway to Antarctica. Given its geographic proximity and the presence of key cities like Punta Arenas, Chile serves as a major departure point for expeditions and scientific research in Antarctica. PM Modi welcomed the agreement and expressed confidence that it would enhance bilateral cooperation in this critical

Health security also featured prominently in discussions, with both leaders acknowledging India's role as a reliable partner in providing medical support to Chile. PM Modi expressed happiness over the growing adoption of yoga in Chile and praised the country's decision to declare November 4 as National Yoga Day. He also highlighted the importance of Ayurveda and traditional medicine, calling for greater collaboration in these fields. The deepening of defence cooperation between the two countries, which



NHAI Hikes Toll Charges by 4-5% Across India



Commuters using national highways and expressways in India will now have to pay higher toll fees, with the National Highways Authority of India (NHAI) announcing an increase of 4-5% in toll charges. This revision, which came into effect on April 1, 2025, is part

of the NHAI's annual process of adjusting toll rates in response to changes in the wholesale price index-based inflation.

The toll fee hike will apply to various highway sections across the country, impacting a significant number of road users. This increase in

toll charges aims to account for rising operational and maintenance costs associated with the upkeep of the national highway network. As per NHAI officials, the revised toll rates will help sustain the infrastructure, ensure road safety, and support ongoing and future highway development projects.

The toll fee adjustment is a routine exercise conducted by the NHAI, and the revised rates reflect the current economic conditions, especially inflationary trends. The NHAI has clarified that the adjustments are necessary to maintain and upgrade India's national highway system, which is crucial for the transportation of goods and people across the country. For many road users, this hike may come as an additional financial burden, especially for frequent travelers. The increase is expected to affect commercial vehicles, daily commuters, and long-distance travelers who rely on the extensive highway network for their journeys. Despite the hike, the NHAI emphasized that the toll rates remain competitive and are in line with inflation adjustments to ensure the sustainable development of India's road infrastructure.

India's 'Operation Brahma' Delivers Aid to Myanmar

India has launched a massive humanitarian relief effort, sending 440 tonnes of essential supplies to earthquake-hit Myanmar as part of 'Operation Brahma.' On Tuesday, the Indian Navy's INS Gharial departed from Visakhapatnam for Yangon, carrying a large consignment of relief materials, including rice, edible oils, and medicines. The shipment is equivalent to nearly 45-48 truckloads of aid, reinforcing India's commitment to assisting its neighbor in the wake of the devastating March 28 earthquake

In addition to INS Gharial, two other Indian Navy warships, INS Karmuk and LCU 52, arrived in Yangon earlier the same day with approximately 30 tonnes of relief supplies. These ships joined the ongoing relief mission, which had already seen INS Satpura and INS Savitri deliver 40 tonnes of humanitarian aid to Myanmar on Monday. Apart from naval support, an Indian Air Force C-130 aircraft also landed in Mandalay, transporting essential medical supplies, water, and diesel generators to assist in the recovery efforts.

The Indian Embassy in Myanmar confirmed on social media that 'Operation Brahma' was launched immediately after the earthquake



struck, with a focus on providing emergency assistance to the hardest-hit regions, including Sagaing, Mandalay, Naypyidaw, Shan, and Bago. India's rapid response included deploying search and rescue teams, medical professionals, and emergency supplies such as food, water, tents, and medicines.

The relief efforts began on March 29, when an Indian Air Force aircraft delivered the first batch of 15 tonnes of humanitarian assistance to Yangon. The supplies were officially handed over by Indian Ambassador to Myanmar, Abhay Thakur, in the presence of Myanmar's Chief Minister U Soe Thein. On the same day, two more C-130 and two C-17 aircraft flew into Naypyidaw, carrying an 80-member National Disaster Response Force (NDRF) team, a 120-member Indian Army medical team, and an additional 85 tonnes of Humanitarian Assistance and Disaster Relief (HADR) aid. Notably, these were the first international aid flights to arrive in Myanmar's capital, Naypyidaw.



Himanta Slams Yunus' Remarks, Calls for NE Bypass

Assam Chief Minister Himanta Biswa Sarma has strongly condemned Bangladesh Chief Adviser Muhammad Yunus' recent remarks on India's Northeast, calling them "offensive and strongly condemnable." Yunus, during a recent four-day visit to China, reportedly described Bangladesh as the "only guardian of the ocean" in the region and suggested that India's northeastern states being landlocked could be an opportunity for Chinese economic expansion. Taking to social media on Tuesday, Sarma lashed out at Yunus' statement, emphasizing that such comments should not be taken lightly as they reflect "deeper strategic considerations and longstanding agendas." Sarma further pointed out that this narrative reinforces the strategic vulnerability of India's 'Chicken's Neck' corridor—the narrow Siliguri Corridor that connects the Northeast to the Indian mainland.

Yunus' comments, which surfaced on social media, implied that the northeastern states lack direct ocean access, making Bangladesh a key maritime link for them. "The seven states of India, the eastern part of India, are called the seven sisters. They are a landlocked region of India. They have no way to reach out to the ocean," Yunus reportedly stated. He also suggested that Bangladesh's role in the region could be leveraged for economic expansion with China's involvement.

Sarma responded sharply, highlighting the historical vulnerability of the 'Chicken's Neck' corridor and warning against narratives that could fuel separatist ideas. He noted that even within India, there have been dangerous discussions about isolating the Northeast from the rest of the country, making it essential to strengthen transport infrastructure.

To counter this strategic concern, Sarma advocated for the development of alternative railway and road networks bypassing the Chicken's Neck corridor. Despite significant engineering challenges, he urged that India must push for innovative and determined efforts to enhance connectivity between the Northeast and the mainland.



Netherlands FM Veldkamp Visits India to Boost Ties

Caspar Veldkamp, the Foreign Minister of the Netherlands, is on his first official visit to India from March 31 to April 1, 2025, aiming to strengthen bilateral relations across multiple sectors, including trade, innovation, and security. His discussions with External Affairs Minister S. Jaishankar focused on expanding cooperation in emerging fields like semiconductors, green hydrogen, and digital technologies, alongside traditional areas such as water management, agriculture, and health.

The two leaders held delegation-level talks on March 31, where they reviewed the growing political, cultural, and economic ties between India and the Netherlands. Both countries have maintained a strong partnership for over 75 years, and this visit is expected to further enhance economic and strategic cooperation. The discussions also covered key global and regional developments, reflecting the evolving geopolitical landscape and the importance of multipolarity in international relations.

Jaishankar welcomed Veldkamp and emphasized the depth of India-Netherlands collaboration, stating, "Delighted to meet FM Caspar Veldkamp of the Netherlands. We discussed our growing cooperation in trade, investments, innovation, water, agriculture, health, security, and people-to-people ties. We also explored new possibilities in semiconductors, green hydrogen, education, and talent flows." Foreign Minister Veldkamp, ahead of his visit, expressed enthusiasm about enhancing collaboration with India, particularly in the context of today's complex geopolitical challenges. "Considering today's geopolitical reality, it is important for both the Netherlands and India to strengthen our cooperation and deepen our relationship," he posted on social media.





'Time for reciprocity': US flags India's 100% tariff on agri goods ahead of April 2 deadline

- New tariffs aim to ensure fairness, details due Wednesday, says White House.
- Trump calls April 2 "Liberation Day," vows to fix unfair trade practices
- Advisors like Lutnick, Bessent, and Vance back Trump's trade overhaul plan.

The White House has spotlighted India's 100% tariff on American agricultural products as a key grievance, accusing New Delhi and other nations of stifling U.S. exports with exorbitant levies. With a deadline looming on April 2, 2025, President Donald Trump has vowed to implement reciprocal tariffs, dubbing the date "Liberation Day" for the U.S. economy. The move, flagged as a "big game-changer," aims

to counter what Trump calls unfair trade practices that have long disadvantaged American workers.

White House Press Secretary Karoline Leavitt, speaking on Monday, April 1, criticized the steep tariffs imposed by multiple countries, including India's 100% duty on U.S. agri-goods, Japan's 700% on American rice, the EU's 50% on dairy, and Canada's nearly 300% on butter and cheese. "These countries have been ripping off our nation for far too long," Leavitt said, display-



ing a chart with India's tariffs highlighted in tricolor circles. She argued that such barriers make it "virtually impossible" for U.S. products to penetrate these markets, costing American jobs and businesses over decades.

Trump has described current U.S. tariffs as "temporary" and "small," promising that the new, reciprocal tariffs—set to roll out on April 2—will level the playing field. While specifics remain under wraps, Leavitt emphasized that

the policy would ensure fairness for Americans, with the President slated to unveil details on Wednesday. "It's time for reciprocity," she declared, framing the shift as a historic correction championed by Trump.

The initiative is backed by a robust team of advisors, including Commerce Secretary Howard Lutnick, Treasury Secretary Scott Bessent, Trade Representative Jamieson Greer, and others like Peter Navarro and Kevin Hassett, with Vice President J.D. Vance also deeply engaged. Leavitt sidestepped questions on which nations would face the new tariffs, leaving that to Trump's forthcoming announcement. As tensions simmer ahead of the deadline, the U.S. stance underscores a broader push to rebalance trade dynamics, with India's agricultural tariffs now a flashpoint in the escalating rhetoric. The clock is ticking toward a policy shift that could reshape global trade ties as of April 1, 2025.

Imran Khan Nominated for Nobel Peace Prize Amid Incarceration

Imran Khan, the former Prime Minister of Pakistan and founder of the Pakistan Tehreek-e-Insaf (PTI) party, has received a second nomination for the Nobel Peace Prize. Khan, who has been imprisoned since August 2023, was put forward for the prestigious award due to his contributions to human rights and democracy in Pakistan. The nomination was announced by Partiet Sentrum, a Norwegian advocacy group, which collaborated with an individual authorized to nominate candidates for the prize.

In a statement shared on X on Sunday, Partiet Sentrum expressed pride in nominating Khan, emphasizing his efforts to advance democratic principles and protect human rights in his home country. "We are pleased to announce on behalf of Partiet Sentrum that in alliance with somebody with the right to nominate, we have nominated Imran Khan, the former prime minister of Pakistan, to the Nobel Peace Prize for his work with human rights and democracy in Pakistan," the group declared. This marks the second time Khan has been recognized as a contender for the award, highlighting his enduring influence despite his current legal challenges.

The Nobel Peace Prize nomination process allows submissions from a wide range of "qualified nominators," including members of national assemblies, government officials, and other designated individuals or organizations. This broad eligibility ensures that diverse voices can propose candidates they believe have made significant contributions to peace and justice. Khan's nomination reflects his reputation as a leader who championed political reform and social equity during his tenure, even as his incarceration has sparked debate about the state of democracy in Pakistan.

Yunus Courts China, Stirs Tensions with India Over Northeastern States

Bangladesh's interim government adviser, Muhammad Yunus, sparked controversy during a recent four-day visit to Beijing by subtly urging China to "extend" its influence in the region, leveraging the landlocked status of India's northeastern "seven sister states." In a video that surfaced on social media upon his return, Yunus suggested that Bangladesh, as the "guardian of the ocean" for India's northeast, could serve as a strategic base for China. He framed this as an economic opportunity, encouraging Beijing to build infrastructure, market goods, and export through Bangladesh, indirectly pressuring India's isolated states.

"The seven states of India... are completely landlocked. They have no way to reach the ocean. We are the only guardian of the region," Yunus stated, adding that this "opens up a huge possibility for China." Defence analysts criticized the remarks as provocative, while Sanjeev Sanyal, a member of PM Modi's economic advisory council, questioned their intent on X, asking, "What exactly is the significance of 7 Indian states being landlocked?"

During his Beijing visit, Yunus held talks with Xi Jinping, securing agreements to deepen China-Bangladesh ties. These include Chinese investment in modernizing Mongla Port with \$400 million, expanding the China Economic and Industrial Zone in Chattogram with \$350 million, and \$150 million for technical assistance. Yunus also sought a 50-year partnership on river water management, praising China as a "master" in the field. Bangladesh requested aid for managing the Teesta River, shared with India, shifting away from previous direct cooperation with New Delhi, and signed a hydrological data-sharing deal for the Yarlung Zangbo-Jamuna River.

The remarks and agreements signal a strategic pivot toward China, raising eyebrows in India. While Yunus thanked Beijing for enhancing maritime and economic collaboration, his comments about India's northeast have drawn scrutiny. As of April 1, 2025, this development underscores Bangladesh's balancing act between its powerful neighbors, with Yunus seemingly testing New Delhi's patience while courting Chinese investment to bolster Dhaka's regional clout.

The leaders also explored cooperation in technology and innovation, with Boric positioning Chile as a reliable partner. "We want to consolidate Chile as a trusted ally in sustainable technology and innovation, where we see immense potential with India," he said. He highlighted cultural exchanges too, citing the "Shoot in Chile" program to attract India's Bollywood industry, adding, "What India has done with Bollywood is tremendously important."

Boric praised Chile's international standing as a respected democracy, a foundation for attracting investment and fostering ties. Beyond economics, he emphasized the cultural and spiritual dimensions of the partnership. "It's not just about commerce but also culture and spirituality. India's ancient civilization offers lessons for the world," he noted.

The visit reflects a shared vision for a multifaceted relationship, blending economic goals with sustainability and cultural synergy. Boric's remarks signal a forward-looking agenda, leveraging India's global influence and Chile's strategic resources to address modern challenges while deepening a historic bond as of April 1, 2025.

Netanyahu Retracts Shin Bet Nominee Amid Coalition Tensions

Israeli Prime Minister Benjamin Netanyahu reversed his decision to appoint ex-admiral Eli Sharvit as director of the Shin Bet security service on April 1, 2025, just 24 hours after announcing it. Netanyahu's office stated that, "after further thought," he informed Sharvit of plans to consider other candidates to succeed Ronen Bar, whose dismissal last month awaits court approval. No specific reason was provided for the abrupt shift, though it follows unease within Netanyahu's religious-right coalition. Some coalition members had opposed Sharvit's nomination, pointing to his alleged presence at a 2023 protest against the government's judicial overhaul—a move that sparked controversy. The Shin Bet, akin to the FBI or MI5, handles



internal security, distinct from Mossad's external intelligence role. Netanyahu's decision to sack Bar had already fueled backlash, with critics accusing him and his allies of purging officials who challenge their stance, particularly on the Caza war against Hamas

larly on the Gaza war against Hamas.

The reversal coincides with brewing discord in Netanyahu's multi-party coalition. Finance

Minister Bezalel Smotrich staged a temporary resignation, a procedural tactic to reclaim his Knesset seat and edge out a member of National Security Minister Itamar Ben-Gvir's party. Israeli media reports suggest Smotrich expects Netanyahu to reappoint him once his parliamentary status is restored. His move protests Ben-Gvir's push for additional ministerial roles after rejoining the government last month, according to Reuters, citing Smotrich's party spokesperson.

The Shin Bet leadership shuffle and coalition friction highlight deepening instability within Netanyahu's administration as of April 1, 2025. The backtrack on Sharvit's nomination reflects sensitivity to internal dissent, while Smotrich's maneuver underscores strategic jockeying among coalition partners.





RBI Announces ₹80,000 Crore OMO to Boost Banking Liquidity

for an open market operation (OMO) to inject ₹80,000 crore into the banking system, a strategic move just days before the April monetary policy committee (MPC) review. Bankers say the infusion aims to enhance the transmission of policy rate cuts, ensuring they effectively influence lending rates and stimulate economic ac-

The announcement follows a notable shift in banking liquidity, which turned surplus on Saturday and Sunday—the first time in over four months—after persistent deficits. Measured via the RBI's liquidity adjustment facility, this surplus provides a cushion for smoother policy rate transmission during an easing cyseeks to sustain this momentum, addressing liquidity tightness that had previously hampered rate cut impacts.

The timing is critical, with the MPC meeting looming. Analysts view the OMO as a preemptive strike to bolster system liquidity, supporting banks in passing on prior and potential future rate reductions to borrowers. Surplus liquidity typically lowers short-term interest rates, aligning them with the RBI's repo rate, a key policy tool. This move signals the central bank's intent to maintain accommodative conditions amid evolving economic pressures. Bankers note that the RBI's action reflects a proactive stance after months of managing liquidity shortfalls, which had con-

Reserve Bank of India (RBI) unveiled plans cle. By pumping in ₹80,000 crore, the RBI strained monetary policy effectiveness. The surplus over the weekend, though modest, hints at easing strains, possibly from government spending or reduced cash demand. The ₹80,000 crore injection aims to lock in this shift, ensuring banks have ample funds to lend and support growth.

As of April 1, 2025, the OMO underscores the RBI's balancing act—fostering growth while guarding against inflation. With the MPC review on the horizon, this liquidity boost could set the stage for further easing, depending on economic data. For now, it's a clear bid to grease the wheels of monetary transmission, reinforcing the RBI's commitment to a responsive and fluid banking system.



GST Collections Surge 9.9% to Over ₹1.96 Lakh Crore in March 2025

India's gross GST collections for March 2025 climbed 9.9% to exceed ₹1.96 lakh crore, according to government data released on April 1, 2025. The robust growth reflects a steady rise in economic activity, with revenue from domestic transactions increasing by 8.8% to ₹1.49 lakh crore. Imports also contributed significantly, with GST from imported goods jumping 13.56% to ₹46,919 crore, signaling strong cross-border trade.

However, the month saw a sharp 41% spike in total refunds, amounting to ₹19,615 crore, a notable increase from the previous year. After accounting for these refunds, the net GST revenue for March stood at over ₹1.76 lakh crore, marking a 7.3% rise compared to the same period in 2024. This net figure, while lower than the gross collection, still underscores a positive trend in tax compliance and economic momentum.

The uptick in domestic revenue highlights resilient consumer spending and business activity, while the higher growth in import-related GST points to India's deepening global trade ties. The refund surge, though, suggests increased claims or administrative adjustments, potentially tied to exporters or input tax credits, which tempered the net reve-

March's performance caps a fiscal year where GST has remained a critical revenue stream for the government, balancing economic recovery with fiscal needs. The 9.9% gross growth outpaces the 7.3% net increase, reflecting the impact of refunds on the final tally. Analysts may view the import revenue



spike as a sign of robust demand for foreign goods, while domestic gains indicate steady internal market strength

As of April 1, 2025, these figures offer a snapshot of India's tax landscape, with GST continuing to evolve as a barometer of economic health. The government will likely leverage this growth to fund infrastructure and welfare, though the refund jump could prompt scrutiny of compliance mechanisms. Overall, March 2025's GST haul reinforces optimism about India's fiscal trajectory, even as it navigates refund-related challenges.

UPI value hits record Rs 24.77 trillion in March, marks new high in FY25

Unified Payments Interface climbing to 590 million from from February's 405 million, (UPI) transactions soared to unprecedented levels in March 2025, reaching ₹24.77 trillion in value and 19.78 billion in volume, according to National Payments Corporation of India (NPCI) data released on April 1, 2025. This reflects a 13% jump in value and a 14% surge in volume from February, fueled by a year-end transaction boom. It's the first time since UPI's launch in April 2016 that value has breached ₹24 trillion and volume has topped 19 billion.

For FY25, UPI recorded a 30% increase in value to ₹260.56 trillion from ₹199.96 trillion in FY24, while volume grew 42% to 131.14 billion transactions from 92.48 billion. March's performance stands out after February's dip, when volume fell 5% to 16.11 billion from January's 16.99 billion, and value dropped 6.5% to ₹21.48 trillion from ₹23.48 trillion. Compared to March 2024, this year's figures show a 36% rise in volume and a 25% uptick in value, with daily transactions February's 575 million.

The surge underscores UPI's dominance in India's digital payment ecosystem, driven by its convenience and widespread adoption. March's spike likely ties to seasonal financial closings, boosting both person-to-person and merchant transactions. The FY25 growth highlights UPI's role in India's cashless economy push, with volumes nearly doubling every two years.

Meanwhile, Immediate Payment Service (IMPS) also saw gains in March, with volume rising 14% to 462 million

and value increasing 19% to ₹6.68 trillion from ₹5.63 trillion. January recorded 444 million transactions worth ₹6.06 trillion. IMPS's uptick complements UPI's dominance, catering to users favoring bank-to-bank transfers. As of April 1, 2025, these milestones reflect India's accelerating shift to digital finance, with UPI setting new benchmarks monthly. The robust March figures signal sustained momentum, positioning UPI as a global model for real-time payments while IMPS holds steady as a reliable alternative.



Capital expenditure not cut, rises to Rs 11.21 trn for FY26: Sitharaman

Finance Minister Nirmala Sitharaman India's post-pandemic recovery. Sithaclarified on April 1, 2025, that the Centre has not reduced capital expenditure, countering speculation during a Raiva Sabha Question Hour session. She announced that the capital outlay for the 2025-26 fiscal year has increased to ₹11.21 lakh crore, up from ₹11.11 lakh

crore in 2024-25. "The capital expenditure has not been cut at all; it has gone up to ₹11.21 lakh crore," Sitharaman emphasized, dispelling concerns of a rollback in infrastructure spending.

Addressing lawmakers, she highlighted a proportional rise in interest-free, 50-year loans provided to states under a special assistance scheme for capital expenditure.

This increase aligns with the enhanced central allocation, ensuring states have greater resources for development projects. "Cutting down capital expenditure is not the case with us," she asserted, reinforcing the government's commitment to boosting economic growth through sustained investment.

The modest hike from ₹11.11 lakh crore to ₹11.21 lakh crore reflects a strategic focus on infrastructure, a key driver of raman's statement comes amid scrutiny over fiscal priorities, with opposition members questioning whether welfare spending might overshadow capital outlays. Her response underscores a balanced approach, maintaining capex momentum while supporting states with long-term financing.

> The special assistance scheme, offering 50-year interest-free loans, has been a cornerstone of Centre-state collaboration, enabling states to fund roads, bridges, and other assets without immediate fiscal strain. The proportional increase in these loans for 2025-26 signals continued trust in this model to spur regional development alongside national projects.

The ₹10,000 crore uptick, though incremental, sustains the capex push initiated in recent budgets, aiming to crowd in private investment and bolster economic resilience. With states also empowered through enhanced loans, the Centre aims to maintain a robust infrastructure pipeline, countering any narrative of austerity in a year poised for economic consolidation.


Copenhagen's Alchemist: Fine Dining or Shock Art?"

Alchemist, an avant-garde restaurant in Copenhagen, has gained global attention for its extravagant 50-course menu curated by chef Rasmus Munk. The dining experience lasts around five hours and costs approximately Rs 60,000 (\$700), offering guests an unusual mix of flavors and thought-provoking presentations. The menu features dishes such as edible butterflies, raw jellyfish, lamb brain mousse served in a bowl resembling a cut-open human head, and even smashed chicken heads. Guests are encouraged to approach the meal with an open mind, as Alchemist warns that its unconventional offerings may

not be suitable for first dates or business meetings. Beyond its experimental cuisine, Alchemist integrates social and environmental commentary into its dishes. Some items aim to highlight critical global issues—such as chicken feet served in a cage to draw attention to factory farming, fish wrapped in edible plastic to symbolize ocean pollution, and a dessert made from frozen pig and lamb's blood to provoke discussions on food ethics. While the restaurant's mission is to use food as a platform for awareness, it has also sparked controversy. Many social media users have pointed out the irony of promoting animal welfare while serving dishes featuring live creatures. Some have questioned whether the experience is about fine dining or simply shock value. Despite the criticism, Alchemist continues to push culinary boundaries, merging gastronomy with storytelling and social activism. For some, it is an extraordinary culinary journey; for others, it raises ethical concerns about where to draw the line between food and performance art. Whether seen as a groundbreaking concept or an overthe-top spectacle, Alchemist remains one of the most talked-about dining experiences in the world.




Thangaraja, Talwar Share Lead at Adani Invitational Golf Championship 2025
