The exchange marked the 75th anniversary of diplomatic relations, reflecting a thaw in tensions following the 2020 Himalayan border clash in Ladakh's Galwan Valley. Xi's vision signals a push for harmony between the two Asian giants amid a complex geopolitical landscape.

In his congratulatory note, Xi emphasized peaceful coexistence, advocating for deeper communication and coordination on global issues and joint efforts to maintain border tranquility. "China and India should find ways to coexist peacefully," he said, per Reuters, highlighting a strategic shift after years of friction along the Line of Actual Control. The message aligns with recent de-escalation moves, building on the Modi-Xi consensus at the 2022 BRICS summit in Kazan.

Delhi Environment Minister Manjinder Sirsa, on April 1, 2025, accused the Aam Aadmi Party (AAP)—ousted by the BJP in February's election—of exacerbating the city's air pollution crisis. Sirsa claimed AAP allowed over 1.08 lakh vehicles to ply despite exceeding carbon monoxide and hydrocarbon limits, as revealed in a Comptroller & Auditor-General (CAG) report tabled by Chief Minister Rekha Gupta. He also alleged corruption, citing over ₹87 lakh wasted on CNG bus tenders and anti-smog towers, including ₹22 crore for a "missing" tower.

Waqf Amendment Bill Set for Lok Sabha **Debate Amid Fierce Opposition**

Union Minority Affairs Minister Kiren Rijiju announced on April 1, 2025, that the Waqf Amendment Bill, proposing reforms to the administration of Muslim charitable properties, will be tabled in the Lok Sabha on Wednesday. With the current Budget session ending Friday, Rijiju, also the Parliamentary Affairs Minister, allocated eight hours for debate-extendable by Speaker Om Birla—ensuring ample discussion on a bill that has ignited a bitter clash between the BJP and opposition.

First introduced in August 2024, the bill was

Pastor Bajinder Singh Sentenced to Life in 2018 Rape Case

On April 1, 2025, a Mohali court in Punjab sentenced self-styled preacher Pastor Bajinder Singh to life imprisonment for a 2018 rape case. The 42-year-old, dubbed the "Yeshu Yeshu prophet," was convicted under Sections 376 (rape), 323 (voluntarily causing hurt), and 506 (criminal intimidation) of the Indian Penal Code. Following the verdict, Singh was transferred to Patiala jail.

The case originated from a complaint lodged at Zirakpur police station in 2018. The complainant alleged that Singh lured her to his Sector 63 residence in Mohali with promises of overseas travel, raped her, and recorded the assault. She claimed he threatened to leak

Key topics include bolstering organizational resilience, streamlining field operations, and enhancing responsiveness to dy-

Assam CM Announces ₹1 Per Unit **Cut in Electricity Rates from April**

Assam Chief Minister Himanta Biswa Sarma declared a significant reduction in electricity tariffs effective April 1, 2025, lowering rates by ₹1 per unit for domestic consumers. With the current rate at ₹5.90 per unit, the new price drops to ₹4.90, a move Sarma assured is no "April Fool's prank." In a social media post, he wrote, "Temperatures will increase, but your bijli bill will decrease. Families in Assam will see a ₹1 per unit drop, plus a year-end rebate," accompanied by a smiling emoji. Commercial establishments, meanwhile, will benefit from a 25-paisa reduction, bringing their rate down from ₹8.60 per unit.

The decision comes amid growing public frustration over rising electricity costs and the rollout of smart meters across Assam, as reported by The Assam Tribune. The Assam Power Distribution Company Limited (APDCL),



regulated by the Assam Electricity Regulatory Commission (AERC), oversees tariff implementation. Domestic tariffs in the state vary by consumption slabs, while residential rates—often higher-depend on usage levels and connection types. The ₹1 cut aims to ease the financial burden on households, with an additional rebate promised at year-end, typically a discount for timely payments or e-payment use.

Sarma's announcement aligns with ef-

forts to address public concerns while maintaining fiscal balance. "This isn't an April Fool Prank," he reiterated, signaling a commitment to affordability. For a typical household, the reduction could notably lower monthly bills, especially as summer demand rises. Commercial users, though receiving a smaller cut, also stand to benefit, with the 25-paisa drop offering modest relief to businesses.

The move follows broader discussions on energy affordability, with Assam bucking trends seen elsewhere—like Karnataka's recent tariff hike. As of April 1, 2025, this policy shift positions Assam as a state prioritizing consumer relief, though its long-term impact on the power sector's sustainability remains to be seen. For now, residents can expect lighter bills and a year-end bonus, a tangible step amid ongoing debates over electricity pricing and infrastructure upgrades.

Supreme Court Refuses To Release YouTuber Ranveer Allahbadia's Passport

The Supreme Court of India, on Tuesday, declined the request to release the passports of popular podcaster and You-Tube personality Ranveer Allahbadia, and fellow YouTuber Ashish Chanchalani, both of whom are under investigation for their controversial comments made during a stand-up comedy show. The case revolves around a re-



mark made by Allahbadia, which was perceived as insensitive and inappropriate. He made a controversial comment about "sex and parents" on the show India's Got Latent, sparking public outcry. In light of this incident, Allahbadia, along with Chanchalani, has been facing charges. The comments were widely criticized on social media, leading to a legal investigation into their conduct. The duo had appealed to the Supreme Court for the release of their passports, which were impounded in relation to the ongoing investigation. However, the Court rejected their requests, ruling that the passports would remain with the authorities until the investigation process is complete. Both Allahbadia and Chanchalani had argued that their passports should be returned so that they could travel abroad for work commitments. However, the Court found the ongoing investigation to be a valid concern and decided not to allow the release of their travel documents.

The case has become a point of discussion across social media, where many have voiced their opinions both in favor of and against the remarks made by the two You-Tubers. While some view their statements as part of the comedy genre, others believe that they crossed the line of decency and respect.

The investigation into the matter continues, and as the legal process unfolds, the Court's decision to withhold the release of the passports marks a significant development in the case. The final outcome could have wider implications on the freedom of expression of digital influencers and creators in India.







"Entire Bloc To Vote Against Waqf Bill": | Lok Sabha Faces Brief Disruption **MP After INDIA Meet**



- RSP's Premachandran vows strong resistance to bill's passage.

India's opposition parties resolved to fiercely contest the Waqf Amendment Bill during a full parliamentary discussion scheduled for Wednesday, vowing to vote against its passage. The decision emerged from a meeting of all opposition groups held Tuesday evening, signaling a unified front against the contentious legislation. "We will actively participate in the discussion and strongly oppose the bill's passage tomorrow," RSP MP NK Premachandran told NDTV, with the Cabinet approving

emphasizing the opposition's consistent resistance at every stage.

The bill, aimed at enhancing the management of Waqf properties, has sparked uproar since its introduction last year. Set for debate and voting in the Lok Sabha on April 2, it has been allocated roughly eight hours, according to Union Minister Kiren Rijiju. Initially referred to a joint parliamentary committee, the bill underwent revisions based on the panel's recommendations,

changes. Yet, the opposition deems it unconstitutional, arguing it undermines fundamental rights and institutional autonomy.

Premachandran underscored the opposition's intent to challenge the bill's core provisions, reflecting widespread concerns over its implications. The Congress, a key player, has issued a three-day whip to its Lok Sabha MPs, ensuring their presence and signaling the debate's high stakes. This coordinated push follows months of contention, with critics alleging the bill centralizes control over Waqf assets, eroding community oversight.



The Wednesday showdown promises a heated clash, with eight hours barely sufficient to unpack the bill's complexities and the opposition's grievances. As of April 1, 2025, the stage is set for a pivotal parliamentary battle, with the opposition leveraging its unity to derail the bill's passage. The outcome could reshape Waqf governance and test the government's ability to navigate a galvanized resistance, making tomorrow's session a defining moment in this legislative saga.

Shah vows to uproot Left-wing extremism by March 2026

Union Home Minister Amit Shah announced on April 1, 2025, that the Centre's uncompromising stance against Naxalism has slashed the number of severely affected districts from 12 to 6, marking a significant step toward a "Naxal-free Bharat." In a post on X, Shah celebrated this milestone, stating, "Today, our nation achieved a new milestone by significantly reducing the number of districts most affected by left-wing extremism to just 6 from 12." He credited the Modi government's relentless approach and holistic development efforts for this progress. Shah emphasized that the government is forging a "Sashakt, Surakshit, and Samriddh Bharat" (Strong, Secure, and Prosperous India) through a dual strategy: a "cut-throat" crackdown on Naxal insurgents and sustained initiatives to uplift affected regions. The reduction reflects years of coordinated operations, improved intelligence, and policies aimed at addressing the root causes of left-wing extremism, such as poverty and underdevelopment.

Lok Sabha witnessed a fleeting uproar as Samajwadi Party (SP) and Trinamool Congress (TMC) members disrupted proceedings over distinct grievances. The SP contingent protested an attack on the residence of their MP, Ramji Lal Suman, linked to his recent comments on Rajput ruler Rana Sanga, while TMC lawmakers sought to highlight the controversial transfer of a judge.

The SP's agitation stemmed from escalating tensions following Suman's remarks, which reportedly provoked outrage among certain groups, culminating in the assault on his home. Party members stormed the well of the House, demanding attention to the incident and condemning the violence as an assault on free SP's focus on Suman's safe-

speech and political representation. Their vocal dissent briefly derailed the session, underscoring simmering regional and historical sensitivities.

Simultaneously, TMC members attempted to spotlight the transfer of a judge, a move they argue reflects undue interference in judicial independence. Though specifics of the case remained unaddressed amid the chaos, their protest signaled broader concerns over institutional integrity, a recurring flashpoint in Parliament. The dual demonstrations, though unrelated, converged to stall proceedings, prompting the Chair to intervene.

'Barbaad bill': Owaisi slams Waqf amendment bill as 'unconstitutional', demands answers

AIMIM chief Asaduddin Owaisi fiercely criticized the Waqf Amendment Bill on April 1, 2025, labeling it unconstitutional and a "grave violation" of Articles 14, 25, 26, and 29 of the Indian Constitution. Court Acquits 12 Men Accused in 2020 Delhi Riots Murders Due to Lack of Evidence



- No Conclusive Evidence linking accused to the crime.
- WhatsApp Chats dismissed as inadmissible evidence.
- Victims Killed during February 2020 CAA protests.
- Mixed Reactions to the acquittal verdict.

A court acquitted 12 men who were accused of murdering two individuals during the 2020 Delhi riots. The Additional Sessions Judge, Pulastya Pramachala, stated that there was

insufficient evidence to prove that any of the accused were part of the mob involved in the killings.

The court's decision followed an evaluation of the available evidence, which included WhatsApp chats from one of the accused,

who had allegedly confessed to the murders. However, the judge ruled that these chats were not "substantive evidence" and could not be used to establish guilt beyond a reasonable doubt. The court emphasized that there was no conclusive proof linking the accused to the actual crime scene or showing their involvement in the mob that carried out the murders.

The two victims were killed during the violence that erupted in the national capital in February 2020, a period marked by widespread riots in the wake of protests against the Citizenship Amendment Act (CAA). The 12 men were accused of being part of the mob responsible for the murders, but the prosecution's case relied largely on circumstantial evidence and the testimony of witnesses, which the court found inadequate.

In acquitting the accused, the court highlighted that the burden of proof lies with the prosecution, and in this case, it failed to establish the involvement of the accused in the killings. The judge's ruling has raised questions about the strength of evidence in cases related to the Delhi riots and the challenges faced by the legal system in delivering justice in such complex cases.

The acquittal of the 12 men has drawn mixed reactions, with some expressing disappointment over the verdict, while others pointed to the challenges of proving guilt in riot-related cases.

Delhi to Implement Fuel Ban for Overage Vehicles by Mid-April

The Delhi government's decision to stop providing fuel to overage vehicles will be enforced by mid-April, according to Environment Minister Manjinder Singh Sirsa. The move, originally scheduled to take effect by April 1, has been delayed due to pending structural adjustments at certain fuel stations.

The new rule targets "overage" or end-of-life vehicles, which includes diesel vehicles older than 10 years and petrol vehicles older than 15 years. These vehicles are not allowed to operate in Delhi as part of the government's ongoing efforts to curb pollution and improve air quality.

In recent years, the Delhi government has taken aggressive steps to deal with such vehicles. If the owners fail to obtain necessary permissions to move these vehicles outside the Delhi-National Capital Region (NCR) or to sell them in other ar-

eas, the authorities seize and scrap them. In addition, vehicles that are left parked on public roads or in other public spaces without necessary clearance are also subject to this action.

Minister Sirsa acknowledged that while the initial date for the fuel ban was set for April 1, the structural modifications required at fuel stations have caused a delay in implementation. full However, the government remains committed to enforcing this regulation by mid-April. The goal is to phase out the operation of polluting vehicles from Delhi's roads, which have contributed significantly to the city's air pollution levels.

This fuel ban is part of a broader set of measures aimed at improving Delhi's air quality and reducing harmful emissions. The government is also actively promoting cleaner alternatives, such as electric vehicles, in an effort to make the city more environmentally sustainable.

Early Summer Heat Causes Surge in Fire Calls in Delhi, Prompting Emergency Measures

The summer season in Delhi has arrived earlier than usual this year, with temperatures soaring from the last week of March. As the heat intensifies, so does the frequenthe Delhi Fire Service responded to 1,809 fire calls, marking a significant increase from 1,328 calls in the same month last year. Delhi Expands Public Spaces Along Yamuna Floodplains with New Redevelopment Projects

In the past two years, Delhi has witnessed the creation of five new public spaces along the floodplains of the Yamuna River, significantly enhancing the city's green and recreational infrastructure. Massive Fire Engulfs Cars at Commercial Complex in Central Delhi's Jhandewalan Extension

A massive fire broke out at a commercial complex in Central Delhi's Jhandewalan Extension on Tuesday, April 1, 2025, severely damaging several cars. Delhi Fire Services officials reported that the blaze erupted at the Anarkali Complex, located in Block E3, around 2:35 PM.

2020 Delhi Riots: Court Orders FIR Against Delhi Minister Kapil Mishra



- Judge finds "prima facie" evidence, notes Mishra's presence during riots.
- Plea by Yamuna Vihar resident Mohammad Ilyas triggers ruling.

A Delhi court has directed the registration of a First Information Report (FIR) against Kapil Mishra, a newly-elected minister, and others, to investigate their alleged involvement in the 2020 Delhi riots. The order, issued by Additional Chief Judicial

Magistrate Vaibhav Chaurasia, follows a finding of "prima facie" evidence suggesting a cognizable offense, necessitating a formal probe. The court's decision marks a significant development in the contentious case tied to the violent unrest that rocked North East Delhi over four years ago.

The judge's ruling came during a hearing on a plea filed by Mohammad Ilyas, a resident of Yamuna Vihar, who demanded an FIR be lodged against Mishra and others implicated in the riots. Ilyas argued that Mishra, a prominent political figure, played a role in inciting the violence that claimed numerous lives and left widespread destruction. The court noted that Mishra was present in the area at the time of the alleged offense, stating, "It is clear that Mishra was in the area at the time of the alleged offence... further probe required." This observation has fueled calls for a deeper investigation into his actions during the turbulent period.

Delhi Police, however, opposed the plea, asserting that Mishra had no direct involvement in the riots. The police argued that the evidence presented did not sufficiently link the minister to the outbreak of violence, urging the court to dismiss the request for an FIR. Despite their objections, the magistrate found enough preliminary evidence to warrant a formal inquiry, overruling the police stance and setting the stage for a potentially explosive legal battle.

The 2020 Delhi riots, sparked amid protests over the Citizenship Amendment Act, remain a deeply polarizing chapter in India's recent history. Mishra, a vocal political figure, has long been accused by critics of delivering inflammatory speeches that allegedly escalated tensions. His supporters, conversely, maintain that he has been unfairly targeted. As of April 1, 2025, this court order reopens a wound that has yet to heal, raising questions about accountability and justice in one of Delhi's darkest episodes.

Fresh Encounter in J&K's Kathua: Security Forces Trap Three Terrorists

A fresh encounter erupted in the Panjthirthi area of Kathua, Jammu and Kashmir, with security forces successfully trapping three terrorists. This marks the second gun battle in the region in just three days. Security forces have launched a large-scale operation, cordoning off the area and intensifying their efforts to neutralize the terrorists.

The operation, which began after a night cordon was established, is being led by multiple security agencies, including the Jammu and Kashmir Police, the Indian Army, National Security Guard (NSG), Border Security Force (BSF), and Central Reserve Police Force (CRPF). Deputy Inspector General Shiv Kumar Sharma confirmed that the operation would continue until all the terrorists are neutralized, emphasizing that the safety of the people in Jammu and Kashmir remains the top priority. Police are fully committed to eradicating terrorism in the region. This encounter follows a previous gun battle on March 27, where five terrorists were initially trapped in the Sanyal forests but later escaped to Juthana, about 20 kilometers away. Despite their escape, they left behind US-made M4 carbines, signaling the high level of armament involved in the attack.

In the earlier incident, two terrorists were killed, and four police personnel lost their lives in action. Additionally, five security officers, including a deputy superintendent of police, were injured and are receiving medical care. Security forces, with the help of helicopters, drones, and bulletproof vehicles, continue to search the region for remaining terrorists.

Nalin Prabhat, the Director General of Jammu and Kashmir Police, expressed confidence that the remaining terrorists would be neutralized. Authorities have also detained three suspects for questioning as part of the ongoing operation. The situation remains tense, with the security forces determined to eliminate the terrorist threat in the area.

Madhya Pradesh Announces Complete Liquor Ban in 19 Religious Cities and Gram Panchayats

The Madhya Pradesh government has officially outlined a liquor ban across 19 religious cities and gram panchayats, with the new policy set to be enforced starting April 1, 2025. The decision, announced by Chief Minister Mohan Yadav, was approved by the state Cabinet during a meeting held in Maheshwar on January 24, 2025.

Under this new policy, all establishments selling alcoholic beverages, including liquor shops and bars, will be required to close within the urban boundaries of the designated cities. The affected areas include major religious cities such as Ujjain, home to the revered Baba Mahakal Temple, Omkareshwar, known for its Omkar Mandhata Temple, and Amarkantak, the origin of the Narmada River, which holds immense significance for the state.

In addition to these cities, the ban will also extend to several gram panchayat regions, including Salkanpur, Kundalpur, and Barmankalan, among others. These 19 areas, both urban and rural, have been chosen due to their religious and cul-



tural importance, and the government's decision is in line with efforts to promote de-addiction and enhance public welfare in regions of religious significance.

Chief Minister Yadav emphasized that this move is a historic step towards combating addiction and fostering healthier communities. The liquor ban will be implemented across various local government divisions, including one Municipal Corporation, six Municipal Councils, six City Councils, and six Gram Panchayats.

The areas where the liquor ban will take effect include some of the state's most sacred locations, such as the Ramraja Temple area in Orchha, the Pitambara Devi Peeth in Datia, and the Nalkheda and Khajuraho regions. By April 1, 2025, liquor will be completely prohibited in these spiritually significant areas, marking a pivotal moment in the state's commitment to promoting religious reverence and public well-being.

\$1.7 Trillion: Why Investors Are Betting Big On US **Despite Recession Fears**

Despite recession whispers and President Donald Trump's tariff turbulence, the US has secured \$1.7 trillion in investment commitments since his second term began on January 20, 2025, signaling robust faith in its economic future as of April 1. Giants like Apple, TSMC, and Saudi Arabia are driving this influx, betting on long-term gains despite short-term chaos. Syed Zubair Ahmed explores why investors remain bullish.

In under three months, standout pledges include Saudi Arabia's \$600 billion (potentially \$1 trillion) over four years, Apple's \$500 billion for AI infrastructure and 20,000 jobs, and a \$500 billion Stargate project by OpenAI, Oracle, and SoftBank to dominate AI. TSMC's \$100 billion adds to its \$165 billion US total, while Eli Lilly (\$27 billion) and Hyundai (\$21 billion) bolster manufacturing. These moves, tied to Trump's "America First Investment Policy," aim to secure semiconductors and tech supremacy, countering China.

Trump's tariff bravado—set to escalate April 2—has rattled markets, yet his knack for luring capital shines. Infrastructure, AI, and chip production could cushion a downturn, reinforcing the US as an innovation hub. Critics, however, question if these billions will materialize, recalling unfulfilled Saudi promises from his first term. FDI has historically wavered, and lofty announcements often shrink under scrutiny.

Economic headwinds loom: inflation persists, interest rates bite, and the dollar recently slumped 3.4%. Germany's spending surge and Trump's "transition" talk—echoed by Treasury Secretary Scott Bessent's "detox" warning-add uncertainty. Investors love tax cuts but hate unpredictability, and Trump's trade flux keeps them guessing.

Still, Trump 2.0 exudes aggression. His "economic nationalism" pushes onshoring and tariffs, pressuring allies into deals. Supporters see a strongman delivering results; skeptics see hype. Will Apple's factories rise in Houston? Will TSMC's chips roll out of Texas? Or is this another mirage? Bangladesh's interim leader Muhammad Yunus stirred outrage in India with comments spotlighting the landlocked Northeast and the strategic Chicken's Neck corridor. Speaking during a visit to China, Yunus called the seven Northeastern states-termed the "Seven Sisters"—a landlocked region, positioning Bangladesh as their "guardian of the ocean." He suggested this could extend China's economic reach, a remark that has inflamed tensions given Delhi's fraught ties with Beijing post-Doklam and cooling relations with Dhaka since Sheikh Hasina's ouster.

The Chicken's Neck, or Siliguri Corridor, is a slender 20-km-wide strip in West Bengal linking India's Northeast to the mainland. Flanked by Nepal, Bhutan, and Bangladesh, it's the sole land route for road and rail to the region. Its vulnerability was laid bare in the 1962 Sino-Indian War, when China's advance underscored the risk of a chokehold isolating the Northeast. The 2017 Doklam standoff, where India halted China's road-building near Bhutan, further highlighted its sensitivity, ending in a tense disengagement.

Yunus' remarks come as Bangladesh's in-

terim government, in power since Hasina's exit last year, pivots toward China, unsettling India. Historically, Delhi enjoyed warm ties with Dhaka, rooted in the 1971 Liberation War, but recent minority attacks and Bangladesh's outreach to Beijing have strained this bond. Yunus' China trip, including a meeting with Xi Jinping, amplifies India's security concerns over the Chicken's Neck, a lifeline now under geopolitical scrutiny.

Indian leaders reacted swiftly. Assam Chief Minister Himanta Biswa Sarma slammed the comments as "offensive," urging robust rail and road upgrades to bolster the corridor, warning of its persistent vulnerability. Congress leader Pawan Khera accused Bangladesh of inviting China to encircle India, blasting the BJP's "deplorable" foreign policy for failing the Northeast. "A country we helped create is now trying to surround us," he said.

As of April 1, 2025, Yunus' words have thrust the Chicken's Neck into focus, exposing India's strategic anxieties amid shifting regional dynamics and an emboldened Sino-Bangladesh axis.

Unlike Shah Rukh's urban charm or Aamir's cerebral appeal, Khan's kingdom thrives in India's hinterlands—small towns, slums, and mohallas—where his rugged hope resonates with the marginalized, especially working-class Muslims sidelined by post-lib-

Shohini Ghosh ties Khan's 1990s rise to communal tensions, as Muslims faced alienation amid the Hindu Right's ascent. His "bad boy" image marred by legal woes-mirrored their vulnerability, forging a visceral bond. Eid releases transcend films; they're communal affirmations, his body a canvas of defiance and triumph. Being Bhaijaan probes this masculinity, with fans like Shan and Balram internalizing Khan's macho ideals—protection, stoicism—shaping their gender views, sometimes conservatively. Yet, this devotion carries a homoerotic edge, a

"Bhai-code" where fans' intense loyalty-chanting "Jai Salman"—binds them in brotherhood. Khan's body, not the heroine, holds their gaze. This fandom, though fierce, falters when his actions—like his 2014 Modi tie-up—jar their ideals, as seen in Jai Ho's tepid response. Richard Dyer's lens on stardom's fragility fits here: Khan's image, built on muscle and myth, shifts with time. His latest Eid flop, Sikandar (April 2025), underscores a fading vigor, his once-unstoppable frame now hinting at decline—a trueblue star whose descent is as iconic as his rise.





India and Chile Strengthen Ties on Critical Minerals and Trade

Prime Minister Narendra Modi, in a joint press address with Chilean President Gabriel Boric Font at Hyderabad House on Tuesday, announced that India and Chile would initiate discussions on a Comprehensive Economic Partnership Agreement (CEPA), with a significant focus on critical minerals, trade, and economic cooperation. Emphasizing the importance of resilient supply and value chains, PM Modi highlighted that both nations are committed to forming a mutually beneficial economic partnership. He further stated that India is ready to share its expertise in digital public infrastructure, renewable energy, railways, space, and other sectors with Chile.

As part of their collaboration, India and Chile signed a Letter of Intent recognizing Chile's strategic role as a gateway to Antarctica. Given its geographic proximity and the presence of key cities like Punta Arenas, Chile serves as a major departure point for expeditions and scientific research in Antarctica. PM Modi welcomed the agreement and expressed confidence that it would enhance bilateral cooperation in this critical area.

Health security also featured prominently in discussions, with both leaders acknowledging India's role as a reliable partner in providing medical support to Chile. PM Modi expressed happiness over the growing adoption of yoga in Chile and praised the country's decision to declare November 4 as National Yoga Day. He also highlighted the importance of Ayurveda and traditional medicine, calling for greater collaboration in these fields. The deepening of defence cooperation between the two countries, which



Welcoming President Boric on his first visit to India, PM Modi lauded his commitment to strengthening bilateral relations and described Chile as an important partner in Latin America. NHAI Hikes Toll Charges by 4-5% Across India



toll charges aims to account for rising operational and maintenance costs associated with the upkeep of the national highway network. As per NHAI officials, the revised toll rates will help sustain the infrastructure, ensure road safety, and support ongoing and future highway development projects. The toll fee adjustment is a routine exercise conducted by the NHAI, and the revised rates reflect the current economic conditions, especially inflationary trends. The NHAI has clarified that the adjustments are necessary to maintain and upgrade India's national highway system, which is crucial for the transportation of goods and people across the country. For many road users, this hike may come as an additional financial burden, especially for frequent travelers. The increase is expected to affect commercial vehicles, daily commuters, and long-distance travelers who rely on the extensive highway network for their journeys. Despite the hike, the NHAI emphasized that the toll rates remain competitive and are in line with inflation adjustments to ensure the sustainable development of India's road infrastructure.



Himanta Slams Yunus' Remarks, Calls for NE Bypass

Assam Chief Minister Himanta Biswa Sarma has strongly condemned Bangladesh Chief Adviser Muhammad Yunus' recent remarks on India's Northeast, calling them "offensive and strongly condemnable." Yunus, during a recent four-day visit to China, reportedly described Bangladesh as the "only guardian of the ocean" in the region and suggested that India's northeastern states being landlocked could be an opportunity for Chinese economic expansion. Taking to social media on Tuesday, Sarma lashed out at Yunus' statement, emphasizing that such comments should not be taken lightly as they reflect "deeper strategic considerations and longstanding agendas." Sarma further pointed out that this narrative reinforces the strategic vulnerability of India's 'Chicken's Neck' corridor-the narrow Siliguri Corridor that connects the Northeast to the Indian mainland.

Yunus' comments, which surfaced on social media, implied that the northeastern states lack direct ocean access, making Bangladesh a key maritime link for them. "The seven states of India, the eastern part of India, are called the seven sisters. They are a landlocked region of India. They have no way to reach out to the ocean," Yunus reportedly stated. He also suggested that Bangladesh's role in the region could be leveraged for economic expansion with China's involvement.

Sarma responded sharply, highlighting the historical vulnerability of the 'Chicken's Neck' corridor and warning against narratives that could fuel separatist ideas. He noted that even within India, there have been dangerous discussions about isolating the Northeast from the rest of the country, making it essential to strengthen transport infrastructure.

To counter this strategic concern, Sarma advocated for the development of alternative railway and road networks bypassing the Chicken's Neck corridor. Despite significant engineering challenges, he urged that India must push for innovative and determined efforts to enhance connectivity between the Northeast and the mainland.



Commuters using national highways and expressways in India will now have to pay higher toll fees, with the National Highways Authority of India (NHAI) announcing an increase of 4-5% in toll charges. This revision, which came into effect on April 1, 2025, is part

of the NHAI's annual process of adjusting toll rates in response to changes in the wholesale price index-based inflation.

The toll fee hike will apply to various highway sections across the country, impacting a significant number of road users. This increase in



India has launched a massive humanitarian relief effort, sending 440 tonnes of essential supplies to earthquake-hit Myanmar as part of 'Operation Brahma.' On Tuesday, the Indian Navy's INS Gharial departed from Visakhapatnam for Yangon, carrying a large consignment of relief materials, including rice, edible oils, and medicines. The shipment is equivalent to nearly 45-48 truckloads of aid, reinforcing India's commitment to assisting its neighbor in the wake of the devastating March 28 earthquake.

In addition to INS Gharial, two other Indian Navy warships, INS Karmuk and LCU 52, arrived in Yangon earlier the same day with approximately 30 tonnes of relief supplies. These ships joined the ongoing relief mission, which had already seen INS Satpura and INS Savitri deliver 40 tonnes of humanitarian aid to Myanmar on Monday. Apart from naval support, an Indian Air Force C-130 aircraft also landed in Mandalay, transporting essential medical supplies, water, and diesel generators to assist in the recovery efforts.

The Indian Embassy in Myanmar confirmed on social media that 'Operation Brahma' was launched immediately after the earthquake



struck, with a focus on providing emergency assistance to the hardest-hit regions, including Sagaing, Mandalay, Naypyidaw, Shan, and Bago. India's rapid response included deploying search and rescue teams, medical professionals, and emergency supplies such as food, water, tents, and medicines.

The relief efforts began on March 29, when an Indian Air Force aircraft delivered the first batch of 15 tonnes of humanitarian assistance to Yangon. The supplies were officially handed over by Indian Ambassador to Myanmar, Abhay Thakur, in the presence of Myanmar's Chief Minister U Soe Thein. On the same day, two more C-130 and two C-17 aircraft flew into Naypyidaw, carrying an 80-member National Disaster Response Force (NDRF) team, a 120-member Indian Army medical team, and an additional 85 tonnes of Humanitarian Assistance and Disaster Relief (HADR) aid. Notably, these were the first international aid flights to arrive in Myanmar's capital, Naypyidaw.

Netherlands FM Veldkamp Visits India to Boost Ties

Caspar Veldkamp, the Foreign Minister of the Netherlands, is on his first official visit to India from March 31 to April 1, 2025, aiming to strengthen bilateral relations across multiple sectors, including trade, innovation, and security. His discussions with External Affairs Minister S. Jaishankar focused on expanding cooperation in emerging fields like semiconductors, green hydrogen, and digital technologies, alongside traditional areas such as water management, agriculture, and health.

The two leaders held delegation-level talks on March 31, where they reviewed the growing political, cultural, and economic ties between India and the Netherlands. Both countries have maintained a strong partnership for over 75 years, and this visit is expected to further enhance economic and strategic cooperation. The discussions also covered key global and regional developments, reflecting the evolving geopolitical landscape and the importance of multipolarity in international relations.

Jaishankar welcomed Veldkamp and emphasized the depth of India-Netherlands collaboration, stating, "Delighted to meet FM Caspar Veldkamp of the Netherlands. We discussed our growing cooperation in trade, investments, innovation, water, agriculture, health, security, and people-to-people ties. We also explored new possibilities in semiconductors, green hydrogen, education, and talent flows." Foreign Minister Veldkamp, ahead of his visit, expressed enthusiasm about enhancing collaboration with India, particularly in the context of today's complex geopolitical challenges. "Considering today's geopolitical reality, it is important for both the Netherlands and India to strengthen our cooperation and deepen our relationship," he posted on social media.



'Time for reciprocity': US flags India's 100% tariff on agri goods ahead of April 2 deadline

- New tariffs aim to ensure fairness, details due Wednesday, says White House.
- Trump calls April 2 "Liberation Day," vows to fix unfair trade practices
- Advisors like Lutnick, Bessent, and Vance back Trump's trade overhaul plan.

The White House has spotlighted India's 100% tariff on American agricultural products as a key grievance, accusing New Delhi and other nations of stifling U.S. exports with exorbitant levies. With a deadline looming on April 2, 2025, President Donald Trump has vowed to implement reciprocal tariffs, dubbing the date "Liberation Day" for the U.S. economy. The move, flagged as a "big game-changer," aims to counter what Trump calls unfair trade practices that have long disadvantaged American workers.

White House Press Secretary Karoline Leavitt, speaking on Monday, April 1, criticized the steep tariffs imposed by multiple countries, including India's 100% duty on U.S. agri-goods, Japan's 700% on American rice, the EU's 50% on dairy, and Canada's nearly 300% on butter and cheese. "These countries have been ripping off our nation for far too long," Leavitt said, display-



ing a chart with India's tariffs highlighted in tricolor circles. She argued that such barriers make it "virtually impossible" for U.S. products to penetrate these markets, costing American jobs and businesses over decades. Trump has described current U.S. tariffs as "temporary" and "small," promising that the new, reciprocal tariffs set to roll out on April 2—will level the playing field. While specifics remain under wraps, Leavitt emphasized that the policy would ensure fairness for Americans, with the President slated to unveil details on Wednesday. "It's time for reciprocity," she declared, framing the shift as a historic correction championed by Trump.

The initiative is backed by a robust team of advisors, including Commerce Secretary Howard Lutnick, Treasury Secretary Scott Bessent, Trade Representative Jamieson Greer, and others like Peter Navarro and Kevin Hassett, with Vice President J.D. Vance also deeply engaged. Leavitt sidestepped questions on which nations would face the new tariffs, leaving that to Trump's forthcoming announcement. As tensions simmer ahead of the deadline, the U.S. stance underscores a broader push to rebalance trade dynamics, with India's agricultural tariffs now a flashpoint in the escalating rhetoric. The clock is ticking toward a policy shift that could reshape global trade ties as of April 1, 2025.

Imran Khan Nominated for Nobel Peace Prize Amid Incarceration

Imran Khan, the former Prime Minister of Pakistan and founder of the Pakistan Tehreek-e-Insaf (PTI) party, has received a second nomination for the Nobel Peace Prize. Khan, who has been imprisoned since August 2023, was put forward for the prestigious award due to his contributions to human rights and democracy in Pakistan. The nomination was announced by Partiet Sentrum, a Norwegian advocacy group, which collaborated with an individual authorized to nominate candidates for the prize. In a statement shared on X on Sunday, Partiet Sentrum expressed pride in nominating Khan, emphasizing his efforts to advance democratic principles and protect human rights in his home country. "We are pleased to announce on behalf of Partiet Sentrum that in alliance with somebody with the right to nominate, we have nominated Imran Khan, the former prime minister of Pakistan, to the Nobel Peace Prize for his work with human rights and democracy in Pakistan," the group declared. This marks the second time Khan has been recognized as a contender for the award, highlighting his enduring influence despite his current legal challenges.

Yunus Courts China, Stirs Tensions with India Over Northeastern States

During his Beijing visit. Yunus held talks with Xi Jinping, securing agreements to deepen China-Bangladesh ties. These include Chinese investment in modernizing Mongla Port with \$400 million, expanding the China Economic and Industrial Zone in Chattogram with \$350 million, and \$150 million for technical assistance. Yunus also sought a 50-year partnership on river water management, praising China as a "master" in the field. Bangladesh requested aid for managing the Teesta River, shared with India, shifting away from previous direct cooperation with New Delhi, and signed a hydrological data-sharing deal for the Yarlung Zangbo-Jamuna River.



Chile's President Boric Highlights Expanding Ties with India During Visit

During his visit to India, Chilean President Gabriel Boric underscored the burgeoning potential for deepening bilateral ties with India, spotlighting trade, investment, and joint efforts on global issues like climate change. Speaking alongside Prime Minister Narendra Modi at Hyderabad House on April 1, 2025, Boric expressed gratitude for the invitation extended during the G20 summit in Rio last November, emphasizing the untapped possibilities in the seven-decade-long relationship between the two nations.

The Nobel Peace Prize nomination process allows submissions from a wide range of "qualified nominators," including members of national assemblies, government officials, and other designated individuals or organizations. This broad eligibility ensures that diverse voices can propose candidates they believe have made significant contributions to peace and justice. Khan's nomination reflects his reputation as a leader who championed political reform and social equity during his tenure, even as his incarceration has sparked debate about the state of democracy in Pakistan.

Bangladesh's interim government adviser, Muhammad Yunus, sparked controversy during a recent four-day visit to Beijing by subtly urging China to "extend" its influence in the region, leveraging the landlocked status of India's northeastern "seven sister states." In a video that surfaced on social media upon his return, Yunus suggested that Bangladesh, as the "guardian of the ocean" for India's northeast, could serve as a strategic base for China. He framed this as an economic opportunity, encouraging Beijing to build infrastructure, market goods, and export through Bangladesh, indirectly pressuring India's isolated states.

"The seven states of India... are completely landlocked. They have no way to reach the ocean. We are the only guardian of the region," Yunus stated, adding that this "opens up a huge possibility for China." Defence analysts criticized the remarks as provocative, while Sanjeev Sanyal, a member of PM Modi's economic advisory council, questioned their intent on X, asking, "What exactly is the significance of 7 Indian states being landlocked?" The remarks and agreements signal a strategic pivot toward China, raising eyebrows in India. While Yunus thanked Beijing for enhancing maritime and economic collaboration, his comments about India's northeast have drawn scrutiny. As of April 1, 2025, this development underscores Bangladesh's balancing act between its powerful neighbors, with Yunus seemingly testing New Delhi's patience while courting Chinese investment to bolster Dhaka's regional clout. Boric, the third Chilean president to visit India in 16 years, hailed the visit as a milestone in consolidating ties. "We have come to strengthen seven decades of relations with India," he said, noting India's rise as Chile's seventh-largest trading partner. He urged further collaboration, particularly in commercial ties and critical minerals like lithium and copper, vital for sustainability and combating climate change. "We discussed investment opportunities and the role of critical minerals in facing global challenges," Boric remarked, framing these as key to a sustainable future.

The leaders also explored cooperation in technology and innovation, with Boric positioning Chile as a reliable partner. "We want to consolidate Chile as a trusted ally in sustainable technology and innovation, where we see immense potential with India," he said. He highlighted cultural exchanges too, citing the "Shoot in Chile" program to attract India's Bollywood industry, adding, "What India has done with Bollywood is tremendously important."

Boric praised Chile's international standing as a respected democracy, a foundation for attracting investment and fostering ties. Beyond economics, he emphasized the cultural and spiritual dimensions of the partnership. "It's not just about commerce but also culture and spirituality. India's ancient civilization offers lessons for the world," he noted.

The visit reflects a shared vision for a multifaceted relationship, blending economic goals with sustainability and cultural synergy. Boric's remarks signal a forward-looking agenda, leveraging India's global influence and Chile's strategic resources to address modern challenges while deepening a historic bond as of April 1, 2025.

Netanyahu Retracts Shin Bet Nominee Amid Coalition Tensions

Israeli Prime Minister Benjamin Netanyahu reversed his decision to appoint ex-admiral Eli Sharvit as director of the Shin Bet security service on April 1, 2025, just 24 hours after announcing it. Netanyahu's office stated that, "after further thought," he informed Sharvit of plans to consider other candidates to succeed Ronen Bar, whose dismissal last month awaits court approval. No specific reason was provided for the abrupt shift, though it follows unease within Netanyahu's religious-right coalition. Some coalition members had opposed Sharvit's nomination, pointing to his alleged presence at a 2023 protest against the government's judicial overhaul—a move that sparked controversy. The Shin Bet, akin to the FBI or MI5, handles



internal security, distinct from Mossad's external intelligence role. Netanyahu's decision to sack Bar had already fueled backlash, with critics accusing him and his allies of purging officials who challenge their stance, particularly on the Gaza war against Hamas.

The reversal coincides with brewing discord in Netanyahu's multi-party coalition. Finance

Minister Bezalel Smotrich staged a temporary resignation, a procedural tactic to reclaim his Knesset seat and edge out a member of National Security Minister Itamar Ben-Gvir's party. Israeli media reports suggest Smotrich expects Netanyahu to reappoint him once his parliamentary status is restored. His move protests Ben-Gvir's push for additional ministerial roles after rejoining the government last month, according to Reuters, citing Smotrich's party spokesperson.

The Shin Bet leadership shuffle and coalition friction highlight deepening instability within Netanyahu's administration as of April 1, 2025. The backtrack on Sharvit's nomination reflects sensitivity to internal dissent, while Smotrich's maneuver underscores strategic jockeying among coalition partners.





RBI Announces ₹80,000 Crore OMO to Boost Banking Liquidity

for an open market operation (OMO) to inject ₹80,000 crore into the banking system, a strategic move just days before the April monetary policy committee (MPC) review. Bankers say the infusion aims to enhance the transmission of policy rate cuts, ensuring they effectively influence lending rates and stimulate economic activity.

The announcement follows a notable shift in banking liquidity, which turned surplus on Saturday and Sunday-the first time in over four months-after persistent deficits. Measured via the RBI's liquidity adjustment facility, this surplus provides a cushion for smoother policy rate transmission during an easing cyseeks to sustain this momentum, addressing liquidity tightness that had previously hampered rate cut impacts.

The timing is critical, with the MPC meeting looming. Analysts view the OMO as a preemptive strike to bolster system liquidity, supporting banks in passing on prior and potential future rate reductions to borrowers. Surplus liquidity typically lowers short-term interest rates, aligning them with the RBI's repo rate, a key policy tool. This move signals the central bank's intent to maintain accommodative conditions amid evolving economic pressures. Bankers note that the RBI's action reflects a proactive stance after months of managing liquidity shortfalls, which had con-

GST Collections Surge 9.9% to Over ₹1.96 Lakh Crore in March 2025

India's gross GST collections for March 2025 climbed 9.9% to exceed ₹1.96 lakh crore, according to government data released on April 1, 2025. The robust growth reflects a steady rise in economic activity, with revenue from domestic transactions increasing by 8.8% to ₹1.49 lakh crore. Imports also contributed significantly, with GST from imported goods jumping 13.56% to ₹46,919 crore, signaling strong cross-border trade.

However, the month saw a sharp 41% spike in total refunds, amounting to ₹19,615 crore, a notable increase from the previous year. After accounting for these refunds, the net GST revenue for March stood at over ₹1.76 lakh crore, marking a 7.3% rise compared to the same period in 2024. This net figure, while lower than the gross collection, still underscores a positive trend in tax compliance and economic momentum.

The uptick in domestic revenue highlights resilient consumer spending and business activity, while the higher growth in import-related GST points to India's deepening global trade ties. The refund surge, though, suggests increased claims or administrative adjustments, potentially tied to exporters or input tax credits, which tempered the net reve-



spike as a sign of robust demand for foreign goods, while domestic gains indicate steady internal market strength

As of April 1, 2025, these figures offer a snapshot of India's tax landscape, with GST continuing to evolve as a barometer of economic health. The government will likely leverage this growth to fund infrastructure and welfare, though the refund jump could prompt scrutiny of compliance mechanisms. Overall, March 2025's GST haul reinforces optimism about India's fiscal trajectory, even as it navigates refund-related challenges.

UPI value hits record Rs 24.77 trillion in March, marks new high in FY25

Unified Payments Interface climbing to 590 million from from February's 405 million, (UPI) transactions soared to unprecedented levels in March 2025, reaching ₹24.77 trillion in value and 19.78 billion in volume, according to National Payments Corporation of India (NPCI) data released on April 1, 2025. This reflects a 13% jump in value and a 14% surge in volume from February, fueled by a year-end transaction boom. It's the first time since UPI's launch in April 2016 that value has breached ₹24 trillion and volume has topped 19 billion.

For FY25, UPI recorded a 30% increase in value to ₹260.56 trillion from ₹199.96 trillion in FY24, while volume grew 42% to 131.14 billion transactions from 92.48 billion. March's performance stands out after February's dip, when volume fell 5% to 16.11 billion from January's 16.99 billion, and value dropped 6.5% to ₹21.48 trillion from ₹23.48 trillion. Compared to March 2024, this year's figures show a 36% rise in volume and a 25% uptick in value, with daily transactions

February's 575 million. The surge underscores UPI's dominance in India's digital payment ecosystem, driven by its convenience and widespread adoption. March's spike likely ties to seasonal financial closings, boosting both person-to-person and merchant transactions. The FY25 growth highlights UPI's role in India's cashless economy push, with volumes nearly doubling every two years.

Meanwhile, Immediate Payment Service (IMPS) also saw gains in March, with volume rising 14% to 462 million

and value increasing 19% to ₹6.68 trillion from ₹5.63 trillion. January recorded 444 million transactions worth ₹6.06 trillion. IMPS's uptick complements UPI's dominance, catering to users favoring bank-to-bank transfers. As of April 1, 2025, these milestones reflect India's accelerating shift to digital finance, with UPI setting new benchmarks monthly. The robust March figures signal sustained momentum, positioning UPI as a global model for real-time payments while IMPS holds steady as a reliable alternative.



March's performance caps a fiscal year where GST has remained a critical revenue stream for the government, balancing economic recovery with fiscal needs. The 9.9% gross growth outpaces the 7.3% net increase, reflecting the impact of refunds on the final tally. Analysts may view the import revenue

clarified on April 1, 2025, that the Centre has not reduced capital expenditure, countering speculation during a Raiva Sabha Question Hour session. She announced that the capital outlay for the 2025-26 fiscal year has increased to ₹11.21 lakh crore, up from ₹11.11 lakh

crore in 2024-25. "The capital expenditure has not been cut at all; it has gone up to ₹11.21 lakh crore," Sitharaman emphasized, dispelling concerns of a rollback in infrastructure spending.

Addressing lawmakers, she highlighted a proportional rise in interest-free, 50-year loans provided to states under a special assistance scheme for capital expenditure.

This increase aligns with the enhanced central allocation, ensuring states have greater resources for development projects. "Cutting down capital expenditure is not the case with us," she asserted, reinforcing the government's commitment to boosting economic growth through sustained investment.

The modest hike from ₹11.11 lakh crore to ₹11.21 lakh crore reflects a strategic focus on infrastructure, a key driver of

Sitharaman's statement comes amid scrutiny over fiscal priorities, with opposition members questioning whether welfare spending might overshadow capital outlays. Investors are torn between the tariff threat and hopes of an Indo-US deal to mitigate fallout. The uncertainty prompted broad-based selling, with sectors sensitive to trade-such as IT, auto, and manufacturing—bearing the brunt. As of April 1, 2025, the crash underscores the market's vulnerability to external shocks, particularly from US policy shifts. Trump's April 2 announcement, dubbed a "game-changer" by the White House, could reshape export-import equations, especially if India's 100% agricultural tariffs face reprisals. With no clarity yet on the tariff scope, the Sensex and Nifty's steep fall reflects a flight to safety, setting a cautious tone for the fiscal year. Investors now await tomorrow's details, hoping for clarity to steady nerves in an increasingly volatile global landscape.






Copenhagen's Alchemist: Fine Dining or Shock Art?"

not be suitable for first dates or business meetings. Bevond its experimental cuisine, Alchemist integrates social and environmental commentary into its dishes. Some items aim to highlight critical global issues—such as chicken feet served in a cage to draw attention to factory farming, fish wrapped in edible plastic to symbolize ocean pollution, and a dessert made from frozen pig and lamb's blood to provoke discussions on food ethics. While the restaurant's mission is to use food as a platform for awareness, it has also sparked controversy. Many social media users have pointed out the irony of promoting animal welfare while serving dishes featuring live creatures. Some have questioned whether the experience is about fine dining or simply shock value. Despite the criticism, Alchemist continues to push culinary boundaries, merging gastronomy with storytelling and social activism. For some, it is an extraordinary culinary journey; for others, it raises ethical concerns about where to draw the line between food and performance art. 



