AP High Court Rejects **Anticipatory Bail** Plea of YSRCP MP **Mithun Reddy**

In a significant blow to YSRCP MP Mithun Reddy, the Andhra Pradesh High Court has dismissed his anticipatory bail petition in connection with the ongoing investigation into the liquor scam case. The MP had approached the court seeking protection from arrest amid allegations of irregularities in liquor policy implementation.

According to sources, Mithun Reddy is accused of manipulating liquor licensing and distribution processes, which allegedly resulted in substantial revenue losses to the state exchequer. The High Court's decision to reject his bail plea is expected to intensify his legal troubles as the investigation continues.

With the anticipatory bail petition dismissed, the possibility of Mithun Reddy's arrest looms larger. Investigating agencies are reportedly gathering evidence to establish irregularities linked to liquor policy violations. The rejection of the petition could accelerate further legal action against the MP.

The court's decision has brought renewed focus on the alleged liquor scam and its implications for the political landscape of Andhra Pradesh. Investigative authorities are expected to proceed with the case, increasing pressure on the YS-RCP leader to clear his name.

Trump's Tariff Tornado

India Caught in the Storm, but Some Sectors Find Shelter

US President Donald Trump has unleashed one of the steepest tariff hikes in American history, imposing a universal 10% import duty and slapping higher levies on 60 nations. India has been hit with a 26% tariff on exports to the US, putting it among the hardest-hit countries, though some

sectors have managed to escape the worst of the impact.

Despite strong personal ties between Trump and Prime Minister Narendra Modi, India did not receive any special exemptions. The tariff is higher than the 20% imposed on the European Union, 24% on Japan, and 25% on South Korea, but significantly lower than China's 54% levy. While India's

rate was initially listed as 26%, a White House annex later indicated a possible increase to 27%. However, experts believe India can navigate these new trade barriers without severe economic distress. Bernstein analysts suggest India is more likely to negotiate than escalate trade tensions.

AP Govt Cancels 15.17 Acres of Ramanaidu Studio Land

The Andhra Pradesh government has taken a key decision to cancel the allotment of 15.17 acres of land originally allocated to Ramanaidu Studio for residential purposes. This decision follows a Supreme Court verdict stating that land allotted for a specific purpose must be used exclusively for that purpose.

Ramanaidu Studio was allotted 34.44 acres of land for constructing a film studio, but during the YSRCP regime, the studio management requested an additional 15.17 acres for developing a house layout. MLA Velagapudi had earlier filed a petition in the Supreme Court, alleging land grab during the YSRCP government's ten-

The Supreme Court ruled that the land provided for a particular purpose cannot be repurposed for any other use. Acting on the verdict, Special Chief Secretary of Revenue Department RP Sisodia issued orders to cancel the land allotment for residential purposes.

Sisodia instructed the Collector to issue show cause notices to the studio management and ensure necessary action is taken within the stipulated time. The cancellation of the 15.17acre allotment highlights the government's commitment to adhering to the Supreme Court's directives and maintaining transparency in land allocations.



In a move aimed at promoting the hospitality sector, the Cabinet approved a significant reduction in bar license fees for three-star and above hotels, bringing the fees down to Rs. 25 lakhs. The PHD Chamber of Commerce and Industry (PHDC-CI) estimates that the tariffs will impact India's GDP by only 0.1% in the short term, thanks to strong domestic manufacturing and government policies like the production-linked incentive (PLI) scheme and Atmanirbhar Bharat.

Pharmaceuticals, Electronics, and Textiles Find Relief Trump's tariffs exempted pharmaceuticals, semiconductors, and copper, providing relief to some of India's key export sectors. The pharmaceutical industry, which supplies 30% of the US's generic drug demand, welcomed the move, citing the importance of affordable medicines in global healthcare.

India's electronics sector also emerged in a better position than rivals China and Vietnam, which face tariffs of up to 54% and 46%, respectively. Industry leaders believe this could give India an edge in manufacturing. Similarly, the textile industry is expected to gain as competitors like Bangladesh, Vietnam, and Cambodia face steeper levies, making India a more attractive sourcing hub for US buyers. India's steel, aluminium, and auto-related exports will bear the brunt of the tariffs, with levies reaching up to 25%. While steel and aluminium were previously taxed under Section 232, the



ACB Questions Former I&PR Commissioner Vijay Kumar for Second Day

Former AP I&PR Commissioner Vijay Kumar Reddy faced a second day of questioning by the Anti-Corruption Bureau (ACB) in Guntur. Following an eight-hour interrogation on Wednesday, ACB officials called him back for further questioning due to alleged non-cooperation.

The investigation revolves around accusations of misusing Rs. 859 crore in government advertisement funds during the YSRCP regime. According to reports, nearly half of the funds were exclusively allocated to Sakshi Media, while the remainder went to media outlets favorable to the YSRCP.

The inquiry, triggered by a vigilance report, focuses on financial discrepancies and alleged favoritism in the distribution of government advertisements between 2019 and 2024. Officials are investigating the decision-making process and potential misuse of power involved in these transactions.

Sources indicate that Vijay Kumar Reddy has remained largely unresponsive to critical questions posed by the ACB, prompting officials to intensify their probe.

The investigation continues, with the ACB aiming to uncover the full extent of the alleged irregularities and hold those responsible accountable.

Minister Nimmala Ramanaidu **Reviews Budameru Modernization Plans**

Minister Nimmala Ramanaidu conducted a review meeting with irrigation officials at the Amaravati Secretariat on Budameru modernization. The meeting was attended by Irrigation Special Chief Secretary G. Sai Prasad, ENC M. Venkateswara Rao, and other senior officials including CEs, SEs, and EEs.

The cabinet approved Rs. 39.05 crore for the repair of Budameru's three dams, with directives to expedite the tender process and complete the work swiftly. During the previous TDP regime, tenders were awarded for Rs. 464 crore to enhance the Budameru diversion channel's capacity to 37,500 cusecs, with 80 percent of the work completed.

Despite the availability of funds during the YS-RCP regime, the remaining 20 percent of the expansion work was stalled. The YSRCP government had canceled the channel expansion project from Enikepadu UT to Kolleru.

Minister Ramanaidu stressed the need for an action plan to finish the pending work to boost the channel's capacity to 37,500 cusecs. The meeting also included comprehensive discussions on proposals to enhance the old channel's capacity from Velagaleru regulator to Kolleru and the development of a new parallel channel with a capacity of 10,000 cusecs. Plans are being prepared to proceed with the cooperation of the Central Government under Disaster Management for controlling Budameru floods. The proposals will be coordinated with the Municipal, Revenue, and Disaster Management departments before being placed before the Chief Minister.

Following a series of allegations against teachers at Rajahmundry's Nannayya University, officials have initiated a thorough investigation after the issue was highlighted by True Point media. The matter was brought to the attention of Education Minister Nara Lokesh, who promptly directed authorities to conduct a detailed probe to uncover the truth. Nannayya University Vice-Chancellor Prasanna Sri has taken the allegations seriously and appointed a special officer from Andhra University to spearhead the investigation. The special officer, who initially examined the matter through a video conference, arrived in Rajahmundry on Thursday to conduct a comprehensive inquiry on-site. During her visit, the special officer has been meeting with various teachers and students to gather firsthand information. The Vijayawada Division of South Central Railway (SCR) has achieved a record-breaking ticket checking revenue of ₹62.03 crore for the financial year 2024-25. This marks the highest-ever earnings in the division's history, surpassing the previous record of ₹60.1 crore registered in FY 2023-24, reflecting a 2.5% increase.

This achievement is attributed to the persistent efforts of the Commercial Department's Ticket Checking Wing, which implemented extensive fortress checks, ambush operations, and magisterial inspections to combat ticketless travel and irregular ticket usage. A total of 9,76,584 cases were detected, indicating a 6.5% increase compared to the previous year.

Revenue breakdown includes ₹37.17 crore from 4,52,887 cases of traveling without tickets, ₹24.69 crore from 5,13,285 cases of irregular travel, and ₹19.46 lakh from 10,412 cases of unbooked luggage.

The need for a new consensus builder of the nation

Mediation and consensus building have played a key role for India since its struggle for independence. In the modern Indian polity, PV Narasimha Rao successfully stitched a coalition to steer India through economic reforms in the early 1990s, Atal Behari Vajpayee led a coalition in the late 90s, and Pranab Mukherjee was the Congress party's go-to person for troubleshooting. However, the present-day political atmosphere in India lacks a strong consensus builder who can navigate through BJP's national agenda and regional aspirations.

Pawan Kalyan has a rare ability to make his policy opposition clear, when necessary, yet remain amicable enough to forge alliances with political opponents to get things done or achieve the goals. PM Modi's Thailand **Visit: Can India Change The Regional Game** With BIMSTEC?

The 6th BIMSTEC Summit, taking place in Bangkok, Thailand, promises to be a critical moment for regional cooperation. Prime Minister Narendra Modi will meet key leaders from the Bay of Bengal Initiative for Multi-Sectoral Technical and Economic Cooperation (BIMSTEC), but the timing could prove challenging. Myanmar is grappling with internal conflict, Thailand has recently faced a devastating earthquake, and tensions between India and Bangladesh may overshadow the summit's potential outcomes.

BIMSTEC, established in 1997, includes seven member states: Bhutan, India, Nepal, Sri Lanka, Myanmar, Bangladesh, and Thailand. The bloc represents 1.73 billion people and a combined GDP of \$5.2 trillion. Initially focused on Bangladesh, India, Sri Lanka, and Thailand, Myanmar joined in 1997, followed by Nepal and Bhutan in 2004. The bloc aims to enhance cooperation across various sectors, such as trade, energy, transport, and counterterrorism.

One of the summit's key developments will be the Maritime Transport Cooperation Agreement, which is set to improve trade and travel across the Bay of Bengal. Additional Memorandums of Understanding (MoUs) with the Indian Ocean Rim Association and the United Nations Office on Drugs and Crime (UNODC) will further solidify regional ties and security.

BIMSTEC aspires to emulate the success of ASEAN, the Association of Southeast Asian Nations. Like Europe with the EU and Africa with the African Union, regional cooperation remains a significant goal for BIMSTEC nations. Historically, the Bay of Bengal served as a thriving hub of trade, and BIMSTEC has the potential to revive these connections. However, unlike SAARC, BIMSTEC offers a unique bridge between South Asia and Southeast Asia, particularly aligned with India's "Neighbourhood First" and "Act East" policies.

India, the largest member of BIMSTEC, plays a central role in driving regional prosperity and covers much of the bloc's operational expenses. While BIMSTEC offers exciting opportunities, it has struggled to make substantial progress, with in-person meetings and breakthroughs being infrequent. Trade agreements, including the long-delayed free trade agreement, remain elusive. However, regional connectivity projects like the India-Myanmar-Thailand Trilateral Highway and the Kaladan Multi-Modal Transit Transport Project (KMMTTP) are helping improve infrastructure, although challenges like Myanmar's ongoing civil unrest have hindered their full realization.

Furthermore, India is advocating for a preferential trade agreement within BIMSTEC, a potential stepping stone toward a comprehensive free trade agreement. Security and energy cooperation are also gaining momentum, as evidenced by MoUs on grid interconnections and India's involvement in BIMSTEC's energy center in Bengaluru. These efforts aim to enhance cooperation in energy-rich nations like Bhutan, Nepal, and Bangladesh.

The summit comes with a significant diplomatic challenge—Bangladesh's strained ties with India. Bangladesh's interim government, led by Muhammad Yunus, has cultivated closer relations with China, which has caused tensions with India. Yunus' recent comments about Bangladesh's strategic role and its relationship with China have further strained relations, leading many to speculate that PM Modi's meeting with Yunus might only be a brief exchange of pleasantries.

A New Era of Protectionism

President Donald Trump marked a significant moment in trade history by declaring it "Liberation Day," a day when American industry was reborn. This bold announcement introduced a series of reciprocal tariffs aimed at addressing what he described as unfair trade practices from both friendly and adversarial nations. As markets reacted to this shift, Asia's stock markets tumbled, and gold prices soared. Trump's renewed focus on tariffs is poised to reshape the global trade landscape, significantly altering relationships between nations.

For countries like India, the conse-

India's electronics, pharmaceuticals, and gems and jewelry sectors are especially vulnerable. With Indian pharmaceuticals making up a substantial portion of the US market for generic drugs, this move could lead to significant price hikes, damaging the competitiveness of Indian exports. Sectors like textiles and jewelry, which have historically thrived due to lower production costs, are also at risk, with India losing its edge to cheaper competitors like Viet-

Although Trump's tariff policies are often viewed as extreme, they aren't entirely unprecedented. Former President Joe Biden, while pursuing his own protectionist measures, maintained many of Trump's tariffs, especially on China. Biden's industrial policies aimed at bolstering domestic manufacturing helped fuel a boom in factory investment by 2023. Critics of Trump's tariffs argue they disproportionately burden consumers, raising prices on goods, while American businesses struggled with supply chain disruptions. The economic fallout from these tariffs was seen in sectors like agriculture, where US farmers suffered due to retaliatory tariffs from China. Yet, despite these challenges, Trump's approach of viewing trade as a zero-sum game continued to resonate with many of his supporters.

Trump's methods contrast with those of previous administrations, which focused on multilateral trade agreements. For instance, Obama's Trans-Pacific Partnership (TPP) sought to balance economic power in the



Asia-Pacific region, but opposition from both sides of the political spectrum led to its collapse. In contrast, Trump and Biden shifted the focus to bilateral agreements and strategic decoupling, highlighting a fundamental shift in US trade policy. Biden's "friend-shoring" approach further emphasized alliances with trusted partners rather than adversaries like

India Evaluates Impact of Trump's Reciprocal Tariffs

India is carefully assessing the impact of the reciprocal tariffs imposed by the Donald Trump administration, which include additional ad-valorem duties ranging from 10% to 50% on imports from all trading partners. The Ministry of Commerce and Industry stated on Thursday, April 3, 2025, that it is engaging with key stakeholders, including Indian industries and exporters, to gather feedback and evaluate the situation.

The government's response comes in light of the Trump administration's recent trade policy shift, which includes a 27% tariff on certain imports. While acknowledging the potential challenges posed by these new trade measures, India is also exploring opportunities that may emerge from the policy change. The Ministry emphasized that its approach aligns with the vision of Viksit Bharat, which aims for a developed and self-reliant India. "We are carefully examining the implications of the various measures and announcements made by the President of the USA," ANI quoted the ministry as saying. The statement further highlighted that the government is proactively assessing strategies to mitigate any adverse effects while identifying potential trade advantages. The US administration's executive order on reciprocal tariffs marks a significant shift in global trade dynamics, impacting multiple countries, including India. As one of the largest trading partners of the US, India is



expected to adopt a balanced approach, focusing on both safeguarding its exports and leveraging new trade opportunities.

Industry experts believe that while higher tariffs on Indian exports to the US could pose short-term challenges, they may also open doors for diversification of trade markets and strengthening domestic manufacturing. The government's engagement with exporters and industry leaders aims to de-

velop a comprehensive strategy to navigate these evolving trade conditions.

As global trade tensions continue to unfold, India's response to these tariffs will be crucial in determining its economic resilience and long-term trade strategies. Further discussions between Indian and US trade representatives are anticipated in the coming weeks to address the implications of the new tariff policies.

Jaishankar Stresses Terrorism and Trafficking at BIMSTEC Meet

External Affairs Minister S. Jaishankar emphasized the urgent need to tackle terrorism, human trafficking, and illicit narcotics trade during the 20th BIMSTEC Ministerial Meeting on April 3, 2025. Addressing his counterparts, he called for a more ambitious approach to regional cooperation in light of increasing global instability.

Jaishankar highlighted the importance of addressing real-world challenges such as cybersecurity, counter-terrorism, and organized crime through robust policy frameworks. "We need to create the necessary frameworks to deal with them effectively," he stated, stressing that BIMSTEC nations must work collectively to confront these threats.

Reflecting on the changing global order, Jaishankar noted that the dominance of a few powerful nations in shaping international policies is a thing of the past. He asserted that developing nations must collaborate to navigate contemporary geopolitical challenges. "The era when a few powers underwrote the international system is now behind us. What we make of our prospects is very much dependent on ourselves," he remarked, underscoring the importance of regional partnerships.

Jaishankar also pointed out that the Bay of Bengal region shares common interests and concerns that must be addressed col-



lectively. He acknowledged that historical factors had previously hindered regional development but urged BIMSTEC nations to leverage their shared past and modern technological advancements to boost connectivity, trade, and investment.

Despite BIMSTEC's potential, Jaishankar admitted that the region's economic performance remains below expectations. "Whether it is connectivity, trade, investment, or services between BIMSTEC members, we are performing below our real potential," he said. He urged nations to har-

ness both traditional strengths and emerging technologies to overcome obstacles and drive economic growth.

As BIMSTEC marks its 28th year, Jaishankar reaffirmed India's commitment to strengthening regional cooperation and ensuring that the organization plays a vital role in shaping a secure and prosperous future for its member states. The meeting concluded with discussions on enhancing trade relations, security cooperation, and economic integration among BIMSTEC countries.

Dy CM Shinde to Vet Files Before CM Fadnavis



In a significant political move, the Maharashtra government has mandated that all official files must now be vetted by Deputy Chief Minister Eknath Shinde before being forwarded to Chief Minister Devendra Fadnavis for approval. The directive was issued by Chief Secretary Sujata Saunik on March 18, marking a shift in administrative protocol. This decision appears to be a strategic

effort to maintain political balance between the two leaders, reviving a system previously in place during 2023 when files were first cleared by the then two Deputy Chief Ministers—Ajit Pawar and Devendra Fadnavis before reaching the Chief Minister, Eknath Shinde. The arrangement was originally introduced after Ajit Pawar, formerly the Leader of Opposition, joined the Shinde-led government on July 2, 2023, along with several Nationalist Congress Party (NCP) MLAs. The latest directive aligns with the earlier framework, wherein Deputy CM Pawar, who held the finance portfolio, processed files before sending them to Fadnavis, who oversaw the home, law, and judiciary departments, before the documents reached CM Shinde for final approval. By reinstating a similar procedure, the government aims to ensure smoother administrative functioning while maintaining equilibrium among the state's key political players.

The move has sparked political discussions, with some viewing it as an attempt to strengthen Shinde's role in governance, while others see it as a power-balancing act between the CM and his deputy. The directive could influence decision-making speed and coordination within the government, particularly in crucial sectors such as finance, law, and infrastructure.

As Maharashtra navigates political complexities ahead of the upcoming elections, this administrative restructuring is likely to shape the state's governance dynamics in the months to come.



Vijay Slams Waqf Bill, Demands Withdrawal

Actor and Tamilaga Vettri Kazhagam (TVK) chief Vijay has strongly criticized the Waqf (Amendment) Bill passed in the Lok Sabha, calling it "anti-democratic" and demanding its immediate withdrawal. In a sharp statement on Thursday, Vijay accused the Bharatiya Janata Party (BJP)-led central government of engaging in "anti-Muslim politics" and warned that if the bill was not repealed, his party would stand in solidarity with the Muslim community in their legal struggle to protect Waqf rights. His remarks come amid growing opposition from various political groups and Muslim organizations, including the Indian Union Muslim League (IUML), which have also pledged to challenge the bill through legal means.

The controversial bill has sparked widespread criticism, with opponents arguing that it undermines the autonomy of Waqf boards and restricts the management of Waqf properties, which are meant for religious and charitable purposes in the Muslim community. Critics claim that the amendments interfere with community rights and are part of a broader pattern of policies targeting minority institutions. The BJP government, however, has defended the bill, asserting that it aims to streamline Waqf management and ensure transparency in land administration. Despite these assurances, protests have erupted in various parts of the country, with Muslim organizations and opposition parties viewing the bill as an infringement on religious freedoms. Vijay's intervention in the matter adds political significance, especially as TVK continues to expand its influence in Tamil Nadu's political landscape. His vocal stance aligns with his broader efforts to position himself as a leader who advocates for social justice and minority rights. Given his massive fan following and emerging political clout, his statement is expected to add momentum to the ongoing resistance against the bill. As protests intensify, legal challenges are also likely to follow, potentially escalating the controversy further. With tensions rising, the demand for a rollback of the bill is gaining traction, setting the stage for a prolonged political and legal battle over Waqf rights

How BJP Secured TDP, JD(U) Support for Waqf Bill

The decision of traditionally secular parties like the Telugu Desam Party (TDP) and Janata Dal United (JD(U)) to back the contentious Waqf Amendment Bill has raised questions, given their historical divergence from the BJP on issues concerning Muslims. However, behind-the-scenes negotiations and strategic assurances from the BJP played a key role in bringing these allies on board. Both parties, which rely heavily on Muslim support, have previously opposed BJP-backed policies such as the Uniform Civil Code. However, sources indicate that senior BJP ministers engaged

in extensive discussions with TDP and JD(U) leaders before the bill's introduction, convincing them of its importance. Apart from these two parties, BJP also reached out to coalition partners like Chirag Paswan's Lok Janshakti Party and Jayant Chaudhary's Rashtriya Lok Dal, explaining that the bill aimed to safeguard Muslim interests and ensure



women's rights rather than create religious divisions, as the opposition had claimed. While the allies broadly agreed, they expressed concerns about certain provisions, especially those affecting existing Waqf properties and potential encroachments on state governments' rights.

To address these concerns, the bill was sent to a Joint Parliamentary Committee, which recommended 14 amendments, including significant inputs from JD(U) and TDP. JD(U) pushed for ensuring the law would not apply retrospectively, preventing interference with existing mosques and religious sites. They also insisted that states must be consulted before making decisions on Waqf land, emphasizing that land remains a state subject. Meanwhile, TDP advocated for greater autonomy for state governments and proposed appointing senior officials above the collector level to handle disputes. They also sought an extended timeline for uploading Waqf-related documents on official portals to facilitate better compliance.

These modifications helped the BJP secure the backing of its allies, ensuring smoother passage of the bill in Parliament. While the move has sparked political debates, it also underscores the BJP's efforts to consolidate its coalition and navigate opposition from minority groups while pushing forward its legislative agenda.

In a bold move reflecting his "America First" agenda, US President Donald Trump on Wednesday unveiled a broad set of tariffs aimed at various nations across the globe. These tariffs, some as high as 49 percent, are part of Trump's ongoing efforts to reshape US trade policies and restore what he claims has been the country's exploitation by both friendly and adversarial nations for decades.

Speaking from the White House Rose Garden, Trump expressed frustration over what he described as the historic mistreatment of the United States by its trading partners. He stated, "For decades, our country has been looted, pillaged, raped, and plundered by nations near and far, both friend and foe alike." The president's tone was combative as he highlighted the tariffs as a necessary step to reclaim the country's economic prosperity. Trump's most severe levies were directed at key global players, including a 34 percent tariff on imports from China, 26 percent on India, 24 percent on Japan, and 20 percent on the European Union. These moves are expected to have a significant impact on global trade flows.

The tariffs, which span a wide range of goods, are seen as a direct challenge to the existing global trading system. Trump defended the measures, claiming that the tariffs would help American industry recover and bring back manufacturing jobs that he argues were outsourced to other countries. China Opposes US Tariffs, Vows Countermeasures in Escalating Trade Dispute

China has strongly condemned the latest round of tariffs imposed by the United States, vowing to take "countermeasures" to protect its rights and interests. The Chinese government's reaction came after US President Donald Trump implemented a series of new levies on imports, including a 10 percent tariff on global goods and an additional 34 percent tariff specifically targeting China.

The Commerce Ministry in Beijing issued a statement expressing firm opposition to the tariffs, which it described as violations of measures would seriously harm the rights and interests of affected countries, warning that they would have far-reaching consequences for global economic development. The ministry also accused the US of engaging

in "unilateral bullying" and called for the immediate cancellation of the tariffs.

However, experts have criticized his administration's claim that other countries' tariffs on US goods are far more damaging than they actually are. China, in its statement, rejected the idea of reciprocity and emphasized that the US had long benefited from international trade, urging Washington to pursue dialogue to resolve the dispute.

The Chinese government stressed that there are no winners in a trade war, reiterating that protectionism is not a viable solution. It pointed out that raising tariffs has never effectively resolved the US's own economic challenges, and warned that the global economy will suffer as a result.

Israeli Prime Minister Netanyahu Arrives in Hungary Amid ICC Arrest Warrant

Rupee Closes Stronger Against **Dollar After Trump Tariffs**

The Indian rupee closed stronger some relief for import-dependent against the US dollar on Thursday, recovering from early losses triggered by the latest tariff announcement from US President Donald Trump. The currency strengthened by 7 paise to settle at 85.44 per dollar, bouncing back after opening at 85.75—its sharpest opening drop since March 10. On Wednesday, the rupee had closed at 85.51 per dollar.

Trump's decision to impose steep reciprocal tariffs on major trading partners, including China and the European Union, initially rattled markets. However, investor sentiment stabilized later in the day, helping the rupee erase its early losses. Brent crude prices also declined, falling 3.2% to \$72.52 per barrel amid a broader market selloff. The drop in oil prices provided economies like India, as energy products, including oil and natural gas, were exempted from the new US tariffs.

"There is considerable uncertainty around implementation and how other countries will retaliate," said Abhishek Goenka, Founder & CEO of India Forex & Asset Management. The US has introduced significantly higher reciprocal tariffs than expected, imposing a minimum 10% duty on all imports while introducing additional levies on 60 countries. For India, the Trump administration has determined that tariffs, factoring in currency manipulation and trade barriers, should be as high as 52%, according to Goenka.

The first phase of these tariffs, a baseline 10% duty, will take effect



on April 5, while the higher tariffs targeting India, China, and the EU will come into force from April 9. Addressing an event titled 'Liberation Day' at the White House, Trump defended the move, stating that the tariffs were necessary to counter "unfair trade policies" that have weakened US manufacturers and disrupted supply chains. He described the new levies as his strongest action yet against what he called an "imbalanced" global trade system.

NCLT rejects insolvency plea against Zomato over Payment Dispute

The National Company Law Tribunal (NCLT) Delhi on Thursday dismissed an insolvency plea filed against food delivery giant Zomato by uniform supplier Nona Lifestyle over an alleged payment default of ₹1.64 crore.

The tribunal rejected the plea on procedural grounds, stating that Nona Lifestyle had failed to comply with the Insolvency and Bankruptcy Code (IBC). It ruled that the company had not properly served the mandatory notice under Section 8 of the IBC before filing the case. The original plea was previously dismissed in November 2024 after Nona Lifestyle's lawyer failed to appear for the hearing. When the company later sought to restore the case, the tribunal denied the request, stating that an invalid plea could not be revived. Nona Lifestyle, a business-to-business apparel manufacturer, had sought to initiate a Corporate Insolvency Resolution Process (CIRP) against Zomato, alleging non-payment for uniforms and merchandise, including ICC World Cup 2023 apparel. According to the company, Zomato placed multiple orders in 2023 for rider uniforms, trousers, and World Cup jerseys but later delayed payments and refused deliveries, citing storage issues. The plea included details of specific purchase orders, such as an order dated July 18, 2023, for 32,724 rider t-shirts, generat-

ing five invoices worth ₹16.47 lakh. While Nona Lifestyle delivered 11,210 t-shirts, the remaining 21,500 were not accepted due to payment disputes, leaving the undelivered stock in the supplier's warehouse. Another order from June 6, 2023, for 35,000 t-shirts worth ₹51.45 lakh also faced delivery delays, attracting penalties under Zomato's agreement.

Nona Lifestyle further alleged that Zomato pressured it into offering discounts through "threats and warnings" and later refused to accept remaining World Cup jerseys, citing a "failed campaign." Since the jerseys were custom-made, they could not be resold.

Zomato denied the allegations, stating that Nona Lifestyle repeatedly missed delivery deadlines, triggering contractual penalties. It argued that the delays caused "substantial reputational and goodwill damage" and maintained that it only paid for delivered jerseys after adjusting penalties and advance payments.

Air India's legacy Boeing 777 **Returns with New Look**

Air India has received the first of its legacy Boeing 777-300ER aircraft after a major revamp, unveiling a fresh look with upgraded interiors. Officials stated that the remaining 12 planes in the fleet will be overhauled by the end of the year.

The refurbishment of the aircraft, conducted in Singapore, took around 50 days. The delay in the refit, which was initially planned for last year, was attributed to supply chain issues. However, Air India has now undertaken a heavy refresh of its older aircraft, enhancing cabins with new seats, carpets, cushions, and entertainment systems while also fixing broken

Air India operates 13 legacy Boeing 777s, which are primarily used for ultra-longhaul flights exceeding 14 hours. These flights connect major destinations such as Toronto and Vancouver in Canada and Newark, New York, San Francisco, and Chicago in the US.

The airline's fleet comprises 67 wide-body aircraft, including 19 B777-300ERs (6 leased

from Etihad Airways), 8 B777-200LRs (5 leased from Delta Air Lines), 7 B787-9s, 27 legacy B787-8s, and 6 A350-600s. The first legacy B787 is scheduled for a retrofit in April. On the narrow-body front, Air India operates 14 A321neos, 94 A320neos, 13 A321ceos, 4 A320ceos, and 6 A319s. As part of Air India's \$400 million retrofit initiative, the first upgraded A320neo has already resumed service, with all 27 A320neos expected to be overhauled by the third quarter of this year. Air India MD and CEO Campbell Wilson stated that all legacy wide-body aircraft are expected to be refurbished by mid-2027. He acknowledged ongoing supply challenges, including shortages of engines for narrow-body aircraft, seat supply issues, and sourcing difficulties for fuselage components.

"Reality is that it is going to remain a supply-constrained market, not just for Air India or India but worldwide, for another four to five years. We are victims of the circumstances, as is every other airline," Wilson remarked.
