CM Naidu Presents Vision for Healthy Andhra Pradesh

TPN Correspondent | Amaravati

Andhra Pradesh Chief Minister N. Chandrababu Naidu on Monday unveiled a comprehensive vision to transform Andhra Pradesh into a "Healthy Andhra Pradesh", combining preventive care, nutrition awareness, technology integration, and infrastructure development. Addressing media at the Secretariat, the CM emphasized public participation to reduce disease burden across the state.

Naidu highlighted the need for lifestyle changes, recommending daily physical activity, yoga, and meditation. He cautioned against the overuse of salt, sugar, and oil, and advised families to adopt millet- and vegetable-rich diets while cutting junk food and polished rice. He warned of the rising cancer burden, especially among women, due to tobacco and alcohol use.

The CM pointed out environmental and agricultural contributors to poor health, urging farmers to reduce pesticide usage and switch to natural farming. He proposed food and nutrition education in schools to build awareness from a young age.

To strengthen healthcare access, the government will establish 100 to 300-bed multi-speciality hospitals in all 175 Assembly constituencies. While 70 already have such facilities, the remaining 105 will be developed through Public-Private Partnership. A state-of-the-art Mega Medicity will be built on 200 acres in Amaravati to serve as a hub for advanced healthcare and medical tourism.

Technology plays a key role in the vision. With 88% Ayushman Bharat health account coverage, digitized health records are being stored in DigiLocker. A Digital Nerve Center has been piloted in Kuppam. Mobile medical vans, virtual hospitals, and hybrid consultations are being planned.

Uncertainty continues to dominate the political climate in Pithapuram, the constituency now represented by JanaSena Party Chief Pawan Kalyan. At the center of this turmoil is former MLA SVSN Varma—known for his calculated moves and cryptic silence.

Varma, once a TDP aspirant, won the Pithapuram seat in 2014 as an independent with indirect support from JanaSena and the backing of dominant Kapu voters. However, his political trajectory has been far from stable—defeated in both 2009 and 2019, and now sidelined with Pawan Kalyan contesting from the same seat in 2024.

With both power struggles and political strategies at play, all eyes are now on how Janasena manages this critical internal challenge in Pithapuram.

In a pioneering step towards energy efficiency and environmental sustainability, Andhra Pradesh has emerged as a national leader in clean cooking initiatives through its large-scale adoption of induction cooktops at Anganwadi Centres (AWCs). The state secured the No.1 rank among 12 major Indian states for energy efficiency, drawing praise from national agencies and central government officials. Launched under the National Efficient Cooking Programme (NECP), the initiative was inaugurated by Chief

Deputy Chief Minister Pawan Kalyan announced a major initiative to improve connectivity in tribal areas, unveiling a ₹400 crore allocation under the National Employment Guarantee Scheme (NREGS) for road development in Adivasi regions. During his visit to Pedapadu village in Dumbriguda mandal as part of the Adivasi Thalli Bata program, he laid the foundation stone for several roads sanctioned under the Janma Bhoomi scheme and reiterated his commitment to uplifting tribal communities.

Addressing a gathering, Pawan said, "If we trust the forest, it will give us sustenance and shade." Highlighting the persistent lack of motorable roads, he criticized the previous YSRCP government for ignoring the region's needs. He recalled personally meeting Chief Minister Chandrababu Naidu to push for immediate action, following which ₹49 crore was promptly sanctioned for road development in the agency area.

"The alliance government built 1069 km of roads in just 8 months, while the previous regime managed only 90 km," he noted. He emphasized that even in areas that did not vote for the alliance, development is being delivered. "Our aim is not revenge, but results," he declared.

Calling for the development of Araku as a national tourist destination, Pawan said he would consult with CM Chandrababu and Minister Durgesh to boost tourism-led employment. He also urged tribal youth to shun ganja cultivation and embrace opportunities in eco-tourism and farming.

AP Govt Launches Disease Mapping Drive to Boost Preventive Healthcare

In a groundbreaking initiative, the Andhra Pradesh government has launched a comprehensive health screening and disease mapping campaign aimed at addressing the root caus-

es of public health challenges across the state. Instead of focusing only on treatment, the program targets early intervention and awareness by analyzing regional health trends.

The state-wide effort has already screened over 2.15 crore individuals aged above 18 — roughly 52% of the adult population. Findings revealed that 19.78 lakh people (9.2%) were diagnosed with hypertension, with a higher prev-

alence among women. An additional 14.29 lakh
The study also flagged districts like Visakhapapeople were flagged for follow-up. Hypertension cases were most common in Konaseema, Kakinada, and NTR districts, and least in Manyam, Alluri, and Sri Sathya Sai districts.

Diabetes was found in 11.13 lakh people (5.1%), with Guntur, NTR, and Krishna districts showing the highest incidence. Nearly 8.76 lakh people were placed under monitoring. Alarming-

ly, over 20.78 lakh individuals were diagnosed with both hypertension and diabetes, with Eluru, NTR, and Krishna districts reporting the highest dual-disease burden.

Cardiovascular disease affected 2.61 lakh individuals, predominantly men, with NTR, Nan-

> dyal, and Guntur topping the chart. The state also recorded 1.19 lakh cancer cases, mostly among women, particularly in Kakinada, Vizianagaram, and Srikakulam. Other major health concerns included kidney diseases (1.73 lakh), neurological disorders (1.07 lakh), respiratory issues (54,362) and liver diseases (30,646). Disease distribution varied significantly based on diet, local environment, and lifestyle.


ASHA Suspends NTR Vaidya Seva Services Over ₹3,500 Cr Pending Dues

In a major blow to Andhra Pradesh's public healthcare delivery system, the Andhra Pradesh Speciality Hospitals Association (ASHA) has suspended all services under the NTR Vaidya Seva Trust starting Monday, citing non-payment of long-pending dues amounting to ₹3,500 crore. This decision directly impacts 730 private hospitals that have been serving lakhs of low-income patients under the state-run scheme.

ASHA had earlier served a formal notice on March 7, demanding the government clear dues. Despite meetings with officials, the association said there was no clear assurance or payment timeline. In its latest communication to the NTR Vaidya Seva CEO, ASHA stated that dues to private hospitals alone exceed ₹2,000 crore and called for an immediate release of at least ₹1,000 crore to prevent further disruption of services.

"We are left with no choice. Hospitals can't sustain ICU operations, pay staff, or maintain infrastructure," said ASHA President Dr. K. Vijay Kumar. Secretary Dr. C. Avinash added, "This isn't *Immediate release of ₹1,000 crore to hospitals* just about dues—it's about preserving quality healthcare in the state. The government must commit to timely payments and revise outdated package rates last updated in 2018."



ASHA also alleged that some field officials are applying undue pressure on hospitals to resume services without resolving the core issue of unpaid bills. The association warned such coercion would worsen the crisis.

The state government has appealed to ASHA to reconsider its decision due to the impact on poor patients. However, ASHA remains firm: services will resume only if the government issues a written commitment to release pending dues and ensure regular payments moving forward.

Timeline for clearing remaining dues Regular payment for ongoing treatments Revision of package rates and introduction of quality-based incentives

YS Sharmila Slams YCP: 'Still Haunted by Chandrababu, Afraid of Congress Rise'

APCC president YS Sharmila launched a sharp counterattack on the YSR Congress Party and its allies, ridiculing their repeated attempts to link Congress activities to the Telugu Desam Party. In a strongly worded statement, Sharmila said, "The disease of jaundice has not yet subsided for YS-RCP and its affiliated organisations. The yellow tint in their vision is proof that they still see Chandrababu in every mirror—and that pains them."

She asserted that the resurgence of the Congress in Andhra Pradesh is causing discomfort to the ruling party. "If Congress is gaining strength as a viable alternative, why are you spreading false allegations? Your frustration proves your incompetence," she added.

Sharmila reminded the public of YSRCP's humiliating losses, saying, "Even after being restricted to 11 seats and metaphorically beaten with sandals by the people, your behavior has not changed. Lies and vilification continue to define your politics." She lambasted the YSRCP leadership,



accusing them of betraying the aspirations of the late Dr YS Rajasekhar Reddy. "You pawned the state's interests at Modi's feet. You tried to capture Rushikonda, brought the Land Title Act to seize people's land, and looted the state for selfish gains," she

Taking on the BJP, Sharmila said, "In AP, BJP means Babu, Jagan, and Pawan. All three serve Modi. It is only the Congress that is bravely raising people's issues and holding the government accountable."

She further questioned the silence of ruling parties on the Polavaram project and the Super Six scams, challenging them to take a stand inside the Assembly. "Your efforts to weaken Congress using money power won't work. Your fear of our rise is showing," she concluded.

Gannavaram Court Grants Anticipatory Bail to Vallabhaneni Vamsi in Land **Grabbing Case**

In a significant development, former MLA Vallabhaneni Vamsi secured anticipatory bail from the Gannavaram court in connection with a land grabbing case registered at the Atkur Police Station. The case pertains to the alleged illegal possession of eight acres of land.

The court, after hearing arguments from both sides, granted anticipatory bail, providing temporary relief to Vamsi in the controversial case. The land dispute had drawn sharp political and legal attention after a formal complaint led to the registration of a case under relevant sections.

Meanwhile, the court also dismissed the custody petition filed by the police seeking to interrogate Vamsi in the same land grabbing case, further

strengthening his legal position. However, Vallabhaneni Vamsi continues to remain on judicial remand in connection with other serious charges, including the attack on the TDP office and an associated kidnapping case. These incidents had triggered widespread political outcry and

public debate.

The legal proceedings against Vamsi are being closely watched as multiple cases involving him are at various stages in the judiciary. With the court granting anticipatory bail in the land case, focus now shifts to the outcomes of the remaining cases, especially those with political ramifications.

MLA Paritala Sunitha Lashes out at Topudurthi Brothers

TDP senior leader and Raptadu MLA Paritala Sunitha came down heavily on the Topudurthi brothers, warning them not to resort to factional politics in Raptadu constituency. Speaking to the media on Monday, Sunitha responded sharply to the ongoing political narrative being pushed by the YSRCP camp after the recent death of

local leader Lingamayya.

Sunitha made it clear that she was the first person who felt deeply saddened by Lingamayya's death and condemned the efforts being made to politicize a personal dispute. She strongly criticized the Topudurthi brothers for "believing in false words" and for using the incident to create unrest in the constituency.

"If Jagan Mohan Reddy has real courage and sincerity towards the



backward classes, let him give the Raptadu ticket to a BC candidate," she challenged. She alleged that the YSRCP's concern for BCs is only superficial and limited to slogans, while the real decisions continue to benefit their close circle.

Warning that the people of Raptadu are not in favor of caste- or faction-based politics, she stated, "We are working for the development of this region. Don't try to disrupt the peace by importing factional rivalries into our constituency."

Paritala Sunitha also questioned the double standards of YSRCP leaders, accusing them of turning personal incidents into political weapons while ignoring the broader needs of the people. "They are trying to cash in on every situation, but the people are watching. We will go to the public with facts," she said.

Former Dy CM's brother **Ahmed Basha remanded for 14** days in land dispute case

Ahmed Basha, the younger brother of former Deputy Chief Minister and YSRCP leader Amzad Basha, has been remanded to 14 days judicial custody by a Kadapa court in connection with a land dispute case dating back to 2022.

Acting on a complaint filed by a man named Mushtaq, who alleged that Ahmed Basha and his associates had attacked him over a land issue in Kadapa, the police traced and arrested Ahmed in Mumbai on Sunday. He was attempting to flee to Kuwait after returning to Andhra Pradesh for the Ramzan festival.

Sources said Ahmed had been residing in Kuwait for several years to avoid legal proceedings. However, his presence in Kadapa during the festival was detected, and while trying to leave India again through

Mumbai airport, immigration officials detained him based on a lookout notice.

After bringing him back to Kadapa, the police interrogated Ahmed for nearly eight hours regarding the land dispute case. He was later presented before the local court, which remanded him to 14 days in judicial custody. He has since been shifted to Kadapa Central

Kadapa police also confirmed that Ahmed Basha is facing at ing those involving assault and land encroachment. The arrest has created political ripples, given his close relationship with a senior YSRCP leader. Further investigations are underway, and police sources said more arrests may follow in the coming days based on the evidence gathered during the interrogation. MLC Varudu Kalyani strongly criticized the ruling coalition government on Monday, alleging a steep rise in crimes against women especially rape cases since it came to power in Andhra Pradesh. She slammed the state leadership for what she described as a "complete failure" in ensuring the safety and dignity of women.

Addressing the media, Kalyani said, "It is deeply disturbing that incidents of sexual violence against women are increasing rapidly under this government. Unfortunately, there is no visible concern from the Chief Minister, Deputy Chief Minister, or even the Home Minister."

She said that law and order under the current regime has deteriorated to an alarming extent, with growing fear among women in both rural and urban areas. "Despite shocking crimes taking place, the state's top leadership continues to remain indifferent. Not a single strong measure has been taken to prevent or control these attacks," Kalyani added.

She demanded that the government initiate a special task force to handle crimes

against women, improve police patrolling in sensitive areas, and ensure fast-track courts deliver swift justice in such cases. Kalyani also pointed out that the silence of the government on brutal cases reflects their lack of political will to protect women. "If this government cannot provide safety to half its population, it has no moral right to continue in power," she said.

She called upon civil society, women's organizations, and political parties to unite and demand accountability from the coalition regime. "This is not just a political issue it is about the lives and safety of our sisters and daughters," she concluded.

Govt to Rescue Aqua Sector with ₹1.50 Power Subsidy, Local Push – Minister Atchannaidu

Agriculture Minister Kinjarapu Atchannaidu assured that the Andhra Pradesh government will take every measure to protect and revive the aqua sector, which is under pressure following the US-imposed 26% tariff on seafood exports. Speaking at a high-level review meeting in Vijayawada, he emphasized that aqua farmers, seed and feed traders, and exporters are the four essential pillars of the sector and must act in coordination.

To provide immediate relief, the government will supply electricity at a subsidized rate of ₹1.50 per unit to registered aqua farmers, without zone distinctions. The Minister also proposed forming district-level Aqua Coordination Committees, modeled after the poultry sector's NECC, to promote domestic consumption of shrimp.

Deputy Speaker Raghurama Krishnamraju encouraged the public to in-



clude shrimp in their diet due to its health benefits and revealed plans to advocate for its inclusion in the Army's food menu. He said increased domestic demand can reduce reliance on exports.

lines. The exam was scheduled from 9:30 AM to 12:30 PM, but In a shocking incident that the entry cutoff left no room for leniency.

The students and parents, visibly distraught, blamed the traffic restrictions imposed by the police for the missed opportunity. "We begged them, showed our admit cards—but nothing helped," said one of the affected students. "We worked hard for months. Is our future less important than a politician's convoy?"

The Deputy CM's visit, which includes inaugurating Adivi thalli Bata and attending Mahasurya Vandanam 2025 in Araku, has now come under public scrutiny for its mismanagement and lack of coordination with education authorities.

Protesters are demanding that Pawan Kalyan personally intervene and request the exam authorities to provide an alternative date or special consideration for the affected students. The state government has yet to respond to the growing public pressure.

Minister Anam Ramanarayana Reddy Launches Sewing Training Program in Atmakur

Endowments and Charities Minister Anam Ramanarayana Reddy on Monday inaugurated a sewing training program in the Atmakur Municipal Corporation, aiming to empower women through skill development and self-employment initiatives.

Addressing the gathering, the minister revealed that 247 online applications were received for the program, out of which 95 candidates have already been selected in the municipal limits. The remaining 152 applicants will also undergo training shortly. All selected women will undergo a three-month training course and receive free sewing machines upon completion.

In total, 1,297 beneficiaries in the Atmakur constituency will receive training and machines, while the initiative will cover 4,967 women across 47 centers in the Nellore district. The government has earmarked ₹10.82 crore for training and equipment distribution.

Highlighting other welfare programs, Minister Anam stated that 4.43 lakh people have received gas connections under the Deepam 2 scheme. In Atmakur alone, around



30,000 beneficiaries are being given three free gas cylinders annually, at a cost of ₹2.37 crore.

The minister also emphasized that the NTR Bharosa pensions, ranging from ₹4,000 to ₹15,000, are being extended to 68 lakh people across the state. In the coming two to three months, ₹56 crore will be spent on infrastructure projects in Atmakur including drinking water, roads, drains, and electricity works.

Plans are also underway to upgrade the Atmakur District Hospital to a 300-bed facility. The Suryagarh housing scheme is being implemented free of cost for SCs and STs, with subsidies of 70% for BCs and 50% for OCs.

Additionally, ₹6.5 crore has been sanctioned for the construction of the Atmakur bypass road. Two-cent plots will be allotted in urban areas and three cents in rural areas for the poor, along with ₹2.5 lakh assistance for house construction.

In a major action against corruption, the Anti-Corruption Bureau (ACB) officials on Monday conducted a surprise raid at the Greater Visakhapatnam Municipal Corporation (GVMC) Zone 4 office in Gnanapura. The raid led to the arrest of two municipal employees who were caught red-handed while accepting a bribe.

According to ACB sources, data entry operator Chandrashekhar and public health supervisor Venkataramana were caught in the act while taking a bribe of ₹20,000 from a complainant. The bribe was allegedly demanded in return for processing and issuing a death certificate.

The accused had initially demanded ₹40,000, but after negotiations, agreed to settle for ₹20,000. Acting on a complaint lodged with the ACB, officials laid a trap and apprehended the duo while the money was being exchanged at the GVMC office.

The ACB officials are currently continuing their raid and verification of documents at the office. Further investigation is underway to ascertain if more officials are involved in the bribery or if similar demands were made in other cases.

The incident has sparked public outrage, as the demand for a bribe in the case of a death certificate—often required urgently by grieving families—has raised serious concerns about the functioning of municipal offices and their sensitivity in handling public services.

Officials stated that both Chandrashekhar and Venkataramana will be produced before the ACB court after completing the necessary formalities. The ACB has reiterated its commitment to taking strict action against any form of corruption in government offices.

India's Window in Trump Tariff Era

On April 2, US President Donald Trump shook the foundations of the post-World War II global trade order by announcing sweeping tariffs across the board, with some targeted country-specific measures that surpassed even the expectations of his staunchest business backers. The global markets responded with shock, plummeting by 10% in the US alone, while the Federal Reserve is now expected to hold off on any planned interest rate cuts, fearing inflation. Analysts are drawing dramatic parallels to the Great Depression of the 1930s, highlighting the potential economic upheaval such trade policies may induce. While countries around the world have expressed concern and maintained their right to retaliate, most have refrained from taking immediate action—except China, which imposed reciprocal 34% tariffs on US imports. However, due to China's larger export volume, the intent appears more strategic—targeting Trump's support base in the agriculture belt to create political discomfort ahead of the elections. Europe's response is fragmented. The European Commission leans towards retaliation, but key nations like Germany and France, mired in political transitions and internal instability, prefer to tread cautiously and negotiate tariff reductions. Meanwhile, Canada and Mexico, who already faced tariffs under Trump's earlier moves targeting steel and aluminum, were excluded from the latest wave of 10% across-the-board tariffs—likely due to their deep integration with the US economy under the USMCA. In Southeast Asia, Singapore's Prime Minister delivered a stark assessment, declaring the death of the multilateral global trade order and warning that smaller nations may lose out significantly if trade deals become predominantly bilateral, as multilateral frameworks erode.

Parliament's **Performance** vs. Pretense

For two consecutive days during the recently concluded Budget session, Parliamentarians sat from 11 am till 4 am the next morning, clocking an exhausting 17 hours. It may seem like democracy is working overtime, but a closer look reveals a far more cynical performance. These all-night sessions, rather than symbolizing democratic vitality, masked a disturbing erosion of parliamentary accountability. As columnist Vir Sanghvi once put it, Parliament is slowly turning into a "deep, dark chamber"—a metaphor disturbingly apt for what transpired. Take, for instance, the debate on the imposition of President's Rule in Manipur. Although the notification was issued on February 13 and Parliament reconvened on March 10, the discussion was postponed until the session's final stretch, that too well past midnight. The Lok Sabha granted it a mere 44 minutes, while in the Rajya Sabha, despite allocating three hours, the ruling BJP used just two minutes of its 75-minute quota. Astonishingly, the BJP's own floor leaders cut short their speaker midway—exemplifying a level of indifference that borders on contempt. The budget session was also marked by moments that demonstrated the resilience of the Opposition, even as procedural neglect continued unabated. In the Rajya Sabha vote on the Waqf Bill, the Opposition tallied an impressive 95 votes. Had a few members not been medically advised against traveling—such as JMM's Shibu Soren and Mahua Majhi, or NCP's Sharad Pawar and AITC's Subrata Bakshi—the count might have touched 100. One Opposition vote was lost due to a technical glitch, yet the strength on display sent a strong message. Meanwhile, the constitutional requirement for a Deputy Speaker in the Lok Sabha remains unmet, even 300 days after the current term began. Article 93 mandates the election of a Deputy Speaker "as soon as may be," but the government appears content to leave the post vacant, a pattern now becoming institutionalized. The systematic side-lining of the Opposition continued unabated. Not a single Opposition notice was admitted for discussion—something that hasn't happened since December 2023. The last Calling Attention Motion was accepted in July 2024, concerning floods in Kerala. Since then, attempts by the Opposition to raise urgent issues such as youth unemployment and voter ID duplications were met with silence. Faced with a communication blockade, the Opposition adopted a tactical shift—brief walkouts replacing longer protests. MPs would exit the House for 10–30 minutes, register their dissent, and return. It was a smart maneuver, drawn from the late Sitaram Yechury's playbook, signaling protest without derailing proceedings. Prime Minister Modi's absence during the Waqf Bill vote was another symbolic moment. With him abroad, he neither supported nor opposed the bill—nor even abstained. History will record his silence. Amidst the high drama, lighter moments reminded everyone that Parliament is also a human space. Forty-eight MPs across 17 parties attended the 15th LAMP (Legislative Assistants to MPs) Convocation at the India International Centre, praising young interns for their year-long contributions. Two DMK MPs found time to launch books—Tiruchi Siva released a compilation of his WhatsApp good morning messages, while Dr. T. Sumathy unveiled her work on Beatrice Webb. Amusingly, both launches were scheduled simultaneously at different venues. Finally, all eyes were on Amit Shah, who emerged as BJP's top performer—piloting three major bills, speaking for 45 minutes on Waqf (though not its pilot), and making rare cafeteria appearances to interact across party lines.

Startups Need More Than Scale

India's entrepreneurial landscape finds itself at a crossroads, caught between the buzz of billion-dollar valuations and the quieter call for true innovation. Commerce Minister Piyush Goyal recently stirred debate by questioning whether India's startup ecosystem is content creating delivery apps rather than pioneering transformative technologies. His comments—criticised by some and praised by others—shine a light on a deeper issue: the difference between upstarts and genuine startups. The distinction is more than semantics; it's about ambition, originality, and a willingness to innovate at the edge rather than replicate existing ideas. Consider Vinod Khosla, a pioneering technologist and venture capitalist who once returned to Delhi before heading back to Silicon Valley to ride the digital wave. His passion lies not in copying successful models but in creating new ones—in AI, biotech, and energy. India needs that mindset. The term "startup" has become synonymous with rapid scaling and high valuations, yet many of India's celebrated unicorns are essentially local adaptations of global ideas. Flipkart mirrored Amazon, Paytm echoed PayPal, and Zomato resembled Yelp. They were smart businesses but not disruptive innovators. This "this of that" culture, as investor



Kashyap Deorah put it, has become dominant—fueled by venture capitalists chasing quick returns and media obsessed with valuation milestones. But true startup culture must be rooted in novelty, intellectual property, and a hunger to solve global problems. India has examples that

fit the mold: InMobi, which turned down a Google acquisition and competes globally in mobile advertising; I-flex Solutions, later bought by Oracle; and Zoho, quietly taking on Microsoft. Yet these firms, despite their scale and substance, lack the glamour associated with unicorn headlines. India hasn't produced a Google or a Tesla—not yet. But unlike China, which is investing heavily in homegrown tech breakthroughs like Deep-Seek, India's ecosystem often orients itself around consumer growth and service models, not scientific breakthroughs. It wasn't always this way.

India has a strong legacy of research through institutions like CSIR, DRDO, and ISRO, which have quietly driven world-class innovation. What's missing now is the bridge between scientific progress and entrepreneurial action. There's a need for entrepreneurs who not only dream big but risk big—those who seek patents over press coverage and breakthroughs over branding. Historical figures like Jamshedji Tata, who built a steel plant in colonial India, or Verghese Kurien, who revolutionized dairy with Amul, exemplify the spirit of innovation and endurance. They operated before "startup" became a buzzword, yet they were more revolutionary than many modern ventures. Risk-taking must be encouraged in the right context, with entrepreneurs distinguishing between gamble and vision. India must also shed the entitlement culture in startup circles—expecting state support, subsidies, and soft landings—while ignoring the grit and patience real innovation demands. Several less-publicized Indian companies like MOSChip in semiconductors or Intellect Design Arena in fintech have created real value without noise. These firms deserve recognition, if not for their size, then for their staying power and focus on intellectual property





LPG, CNG **Prices Hiked Nationwide**

In a significant move affecting households across the country, the government on Monday announced a steep hike in the prices of domestic cooking gas (LPG) and compressed natural gas (CNG), alongside an increase in excise duties on petrol and diesel. Effective from April 8, 2025, the price of an LPG cylinder has been raised by Rs 50, while CNG will cost Re 1 more per kilogram in the national capital and nearby regions. The hike applies to both Ujjawala beneficiaries — who received free LPG connections under the government's flagship scheme for the poor — and general consumers. As per the new rates, Ujjawala consumers in Delhi will pay Rs 553 for a 14.2-kg cylinder, up from Rs 503, while general users will now have to shell out Rs 853 per cylinder.

The announcement was made by Union Oil Minister Hardeep Singh Puri, who attributed the hike to the rising input costs, including a nearly 4% increase in natural gas prices last week. He emphasized that the revisions were necessary to keep pace with global pricing trends and maintain the sustainability of supply. This marks the first price revision for LPG since March last year, when rates were actually reduced by Rs 100 per cylinder, offering temporary relief to consumers. However, with inflationary pressures mounting again and international energy costs rising, the government has opted to increase both product prices and fuel taxes to manage fiscal needs.

The revision in CNG prices will impact public transport, delivery services, and personal mobility costs, particularly in urban areas where CNG is widely used. Additionally, the decision to raise excise duties on petrol and diesel is expected to have a broader impact on transportation costs and commodity prices, potentially fueling inflationary trends. While the government views these changes as a necessary step to boost revenue and manage fiscal deficits, the hikes are likely to spark political and public reactions, especially as they affect lower- and middle-income households directly. The full impact of these changes will unfold in the coming weeks as consumers and transport sectors adjust to the new rates.

President Murmu Begins Portugal State Visit

President Droupadi Murmu arrived in Lisbon on Sunday, April 7, 2025, marking the beginning of a significant four-day State Visit to Portugal and the Slovak Republic. This visit, the first of its kind by an Indian President in nearly three decades, underscores India's renewed diplomatic focus on Europe at a time of global economic realignment. The timing of President Murmu's tour is especially crucial, coinciding with recent trade policy shifts, particularly new tariffs imposed by the United States, which have disrupted global supply chains and are reshaping international commerce. Against this backdrop, India is actively expanding its engagement with European nations to bolster cooperation in trade, technology, education, sustainability, and innovation. Upon her arrival at Lisbon's Figo Maduro military airbase, President Murmu was welcomed with warmth and ceremony by Puneet

Modi Inaugurates Pamban Bridge, Targets DMK

Prime Minister Narendra Modi on Sunday inaugurated India's first vertical lift sea bridge — the Pamban rail bridge — in Ramanathapuram district of Tamil Nadu, hailing it as a "symbol of the union of technology and tradition." The state-of-the-art bridge connects Rameswaram island to the mainland and marks a major infrastructure milestone in the region. However, the inauguration wasn't without political undertones, as Modi took a veiled swipe at the ruling DMK government in Tamil Nadu, particularly noting the absence of Chief Minister M. K. Stalin from the event.

In his address, Prime Minister Modi not only underscored the technological importance of the bridge but also wove in cultural and linguistic references, playing the "Tamil pride" card amid ongoing debates over the "three-language formula" in the state. He urged the Tamil Nadu government to embrace regional language in higher education and medical training, suggesting that Tamil should be introduced as a medium of instruction for medical courses. "Many states across the country have started medical education in the mother tongue. Now, even the sons or daughters of the poorest mothers who have not studied English can become doctors. I would also request the Tamil Nadu government to start medical courses in the Tamil language," he said.

Modi further highlighted the central government's contribution to healthcare infrastructure in the state, noting that 11 new medical colleges had been established in Tamil Nadu in recent years. He emphasized the global interest in Indian culture and heritage, stating that the government is making dedicated efforts to ensure that Tamil language and culture are promoted worldwide.

The Prime Minister's remarks come at a politically sensitive time, with Tamil Nadu's DMK-led government often at odds with the Centre over language policies and federal autonomy. The Pamban event thus became both a showcase of national development and a platform for subtle political messaging. Modi's pitch for Tamil pride is seen as a strategic outreach to the Tamil electorate, especially ahead of key elections, attempting to blend cultural reverence with infrastructural progress.

"Oil Prices Are Down, There Is No Inflation": **Trump Doubles Down On Tariffs**

- Global markets plunge amid trade war fears.

U.S. President Donald Trump has defended his administration's tariff policies, stating that the U.S. economy remains resilient despite mounting concerns over a global economic downturn. Trump's comments come as stock markets across Asia and Europe experienced sharp declines following the announcement of new tariffs, sparking fears of a looming trade war.

In a post on his social media platform, Truth Social, Trump assured Americans, "Oil prices are down, interest rates are down, food prices are down, there is NO INFLATION." He emphasized that tariffs already in place were bringing in billions

of dollars to the U.S. from other nations, particularly those he has called out for "abusing" the U.S. in past trade deals. Trump singled out China, calling it "the biggest abuser of them all" and accused the country of raising its tariffs by 34% in retaliation.

China, in response, announced new tariffs on U.S. imports starting April 10 and threatened to take legal action against Washington at the World Trade Organization. Chinese officials also expressed their displeasure, stating that U.S. tariffs were "economic bullying" and would only serve America's interests, harming global trade relations.

Myanmar Faces Thunderstorms as Earthquake **Devastation Worsens**

People in Myanmar's earthquake-stricken regions are bracing for thunderstorms late Sunday, with heavy rains and strong winds disrupting ongoing rescue and relief operations. The storms have added to the suffering of those who lost their homes in the March 28 earthquake, forcing many to sleep in the open under harsh conditions.

Myanmar's state-run MRTV issued a warning on Sunday evening, forecasting scattered showers and thunderstorms across the country for the next week. "The public is advised to be aware of the possibility of untimely rain accompanied by strong winds, lightning, hail, and landslides," MRTV stated. The weather is expected to worsen, with daytime temperatures reaching 38°C (100°F) by mid-week.

The earthquake, with a magnitude of 7.7, struck near Mandalay, Myanmar's second-largest city. The epicenter hit several regions and states, including the capital Naypyitaw, leaving a significant trail of destruction. As of Sunday, Myanmar's military government confirmed 3,564 deaths, with 5,012 injuries and 210 people still missing.

The disaster severely affected infrastructure, leaving many areas without power or telephone services and damaging roads and bridges. These conditions have hampered efforts to assess the full scale of the damage. Rescue teams were forced to halt electrical equipment temporarily due to the rain, but operations continue despite the challenges posed by the weather.

As rain and strong winds caused further collapses of buildings, rescue workers faced additional obstacles. Reports indicate that at least 80 bodies were found at the Great Wall Hotel in Mandalay after rubble was cleared on Sunday afternoon, though this has yet to be confirmed.

The earthquake's impact is far-reaching, with over 5,000 buildings, 1,800 schools, and numerous religious sites and infrastructure damaged. The recovery and relief efforts are ongoing, but the full extent of the devastation remains unclear due to the challenging conditions.



Gold Prices Dip Worldwide in Wake of **Market Downturn**

Precious metals continued their upward trajectory in March, with both gold and silver posting significant gains. Comex gold, in particular, surged past the psychological \$3,100 mark, reaching a new all-time high.

Government Hikes Excise Duty on Petrol and Diesel by ₹2 per Litre



On Monday, the Government of India announced an increase in excise duty on petrol and diesel by ₹2 per litre, effective from April 8, 2025, as per a notification issued by the Department of Revenue, Ministry of Finance.

As per the official order, the excise duty on petrol has been raised to ₹13 per litre, while diesel will now attract an excise duty of ₹10 per litre. The change comes as part of the government's ongoing efforts to manage its revenue and control economic conditions.

Despite the hike in excise duties, the Ministry of Petroleum and Natural Gas assured the public that there would be no direct impact on consumers. The ministry confirmed that the retail prices of petrol and diesel would not increase, meaning the financial burden will not be passed on to the common man.

The government's decision follows a series of fiscal measures, including the scrapping of the windfall profit tax on domestic crude and fuel exports in December 2024. This tax, initially imposed on July 1, 2022, was removed as global oil prices continued to decline, easing pressure on the domestic fuel market.

The excise duty hike is expected to impact government revenues positively, but the assurance of stable fuel prices aims to maintain public confidence, especially as global oil markets remain volatile.

The increase in excise duties comes at a time when global fuel prices are experiencing fluctuations, and the government is balancing economic policy measures with efforts to shield the common people from price shocks.

As the country continues to navigate through economic challenges, these regulatory measures will play a key role in ensuring that the energy sector remains stable, while the government's fiscal health is maintained.

India's Automobile Retail Sales Grow 6.46% in FY25, Markets **Show Strong Performance**

India's overall automobile retail sales in FY25 (April 2024 to March 2025) experienced a growth of 6.46% compared to the previous year, with passenger vehicles (PV) growing by 4.87%, two-wheelers (2W) rising 7.71%, and commercial vehicles (CV) experiencing a slight decline of 0.17%, according to data released by the Federation of Automobile Dealers Associations (FADA) on April 7, 2025.

Rural markets showed a stronger performance, with two-wheelers increasing by 8.39% in rural areas, compared to a 6.77% growth in urban markets. Three-wheelers in rural regions rose by 8.70%, significantly outperforming the 0.28% growth in urban areas. Similarly, passenger vehicles performed better in rural belts, with a 7.93% growth, compared to a 3.07% increase in urban markets.

For the month of March 2025, overall auto retail sales declined 0.7% year-on-year (YoY) but saw a 12% improvement on a month-on-month (MoM) basis. The early-month weakness, caused by the Kharmas period, was offset by a surge in the final week, fueled by events like Navratri, Gudi Padwa, Eid, and year-end depreciation benefits.

Segment-wise, two-wheelers saw a decline of 1.7%, while three-wheelers and tractors decreased by 5.6% and 5.7%, respectively. However, passenger vehicles and commercial vehicles showed growth, rising by 6% and 2.6% YoY, respectively. FADA president C.S. Vigneshwar praised the adaptability and resilience of India's auto retail sector, noting the strong performance in rural areas as a key highlight. He also commented on March's sales performance, emphasizing the impact of positive triggers in the final week of the month.

Additionally, Vigneshwar stressed the importance of setting mutually attainable targets between original equipment manufacturers (OEMs) and dealers to avoid confusion and financial strain. He highlighted that excessively high targets, set without proper agreement, could hinder sustainable growth and customer satisfaction.

Tata Motors, despite a nearly 3% drop in stock value, continues to gain attention with its strong product strategy, particularly in the electric vehicle (ePV) market.



Rupee Slips to 85.63 Against US Dollar Amid Global Trade War and Market Slump



The Indian rupee fell by 19 paise to 85.63 against the US dollar in early trading on Monday, as the currency market reacted to the global trade war triggered by the US's reciprocal tariffs and China's retaliatory measures. The ongoing trade tensions sent shockwaves through global equity markets, causing them to crash to their lowest levels in years.

Forex traders noted that despite a sharp drop in crude oil prices and a weaker US dollar, the Indian rupee struggled to find support due to persistent foreign fund outflows. The ongoing sell-off in global markets contributed to these outflows, which added pressure on the domestic currency.

Market analysts have highlighted that the global economic uncertainty, driven by the US-China tariff dispute, has created a volatile environment for emerging market currencies, including the rupee. The continued turmoil in equity markets worldwide is adding to the pressure on the rupee, which has struggled to gain stability in the face of global economic challenges.

In the past few weeks, the rupee has witnessed significant fluctuations as a result of global trade tensions, which have led to increased investor caution. The uncertainty around the ongoing trade war, coupled with concerns about an economic slowdown, has resulted in capital outflows from India's equity and bond markets.

On the positive side, crude oil prices have seen a decline, which would typically provide some relief to India's import bill and, in turn, support the rupee. However, the overall global financial instability has overridden this potential benefit, leaving the rupee vulnerable to further declines.

As global equity markets continue to reel from the impact of trade disputes, the outlook for the rupee remains uncertain. Forex experts have urged the Indian government and central bank to closely monitor the situation and take necessary measures to safeguard the currency from further depreciation.






Mahavir Jayanti 2025: **Date and Meaning**

Mahavir Jayanti, the most sacred festival for the Jain community, will be celebrated this year on April 10, 2025 (Thursday). It marks the birth anniversary of Lord Mahavir, the 24th and final Tirthankara in Jainism—a revered spiritual teacher and enlightened soul who showed the path of non-violence, truth, and renunciation. Observed annually on the 13th day of the Chaitra month as per the Hindu lunar calendar, the date varies each year and typically falls between March and April. Also known as Mahaveer Janma Kalyanak, this festival is not only a day of celebration but also a deep reflection on the teachings and life of Lord Mahavir, who was born in 599 BCE in Kundagram, now in Bihar. He was born to King Siddhartha and Queen Trishala, and lived a royal life until he turned 30. Despite his position as a ruler, Mahavir experienced a spiritual awakening and chose to renounce worldly pleasures, embarking on a quest for truth and enlightenment. Through intense meditation and penance, he eventually attained Kevala Jnana (omniscience) and became a guiding light for followers of Jainism. His core principles—Ahimsa (non-violence), Satya (truth), Asteya (non-stealing), Brahmacharya (celibacy), and Aparigraha (non-possessiveness)—form the foundation of Jain philosophy and ethics. On Mahavir Jayanti, devotees engage in prayers, processions, charitable acts, and visits to Jain temples, where the life and teachings of Mahavir are celebrated and remembered. Statues of Mahavir are bathed ceremonially in a ritual called abhisheka, and sermons are delivered to inspire people to walk the path of righteousness. The festival serves as a reminder to live a life of compassion, simplicity, and spiritual discipline, in line with Mahavir's timeless message to the world.

Chinese Gamer Sues Over Insults

Abizarre yet thought-provoking case has emerged from China, where a longtime gamer has sued a gaming company after claiming that virtual bullying led to his depression. The player, going by the pseudonym Qiaoben, has been playing the multiplayer strategy game Three Kingdoms Kill Online for 15 years and currently holds the highest rank in the game. Despite his skill and achievements, Qiaoben alleges that he became the target of constant humiliation from other players who, after each defeat, would mock him by hurling virtual items like eggs and straw sandals at his in-game character. These symbolic acts, often used to insult opponents in East Asian culture, reportedly affected his mental health to the point that he plunged into depression. He blames the game developers for enabling such forms of

emotional harassment and filed a lawsuit demanding accountability. The game, developed by a Hangzhou-based company and released in 2009, typically involves 4 to 8 players and runs for 10 to 30 minutes per session. Qiaoben's story has reignited global debate around the psychological impacts of excessive gaming and toxic behavior in online communities. While some argue that the responsibility lies with the game makers to moderate in-game conduct and limit abuse mechanics, others point to personal responsibility and the need for digital resilience. The case underscores how the virtual world, though intangible, can have tangible consequences on mental well-being. It also raises critical concerns about how game design and user interaction features might unintentionally fuel harassment. As gaming

Non-Veg Biryani **Delivered During Navratri**



Awoman from Noida has sparked controversy online after alleging that she was delivered chicken biryani instead of the vegetarian biryani she ordered through Swiggy during the Navratri festival. The incident, which took place on April 4, involved a meal from the popular restaurant Lakhnavi Kabab Paratha. The woman, identified as Chhaya Sharma, posted a video on social media expressing her distress over receiving non-vegetarian food during the holy period of Navratri, when many people abstain from meat. Her post quickly went viral, drawing sharp reactions from users across platforms and prompting a wave of outrage, especially given the religious sensitivities associated with the festival. In response to the uproar, the Uttar Pradesh Police took swift action by taking one of the restaurant's staff members into custody for questioning. The incident has reignited the conversation around food delivery ac-

countability and the importance of accuracy in orders, especially during religious observances. While Swiggy has not issued a formal statement as of now, the platform is expected to investigate the matter internally. Meanwhile, Lakhnavi Kabab Paratha is also facing heat online, with many calling for stricter checks and greater sensitivity in handling such orders. This episode has highlighted the potential for seemingly small mistakes to escalate into major controversies, particularly in culturally and religiously significant contexts. Users on social media debated whether legal action was warranted, while others stressed the need for better training of delivery and restaurant staff to avoid such incidents in the future. As the investigation continues, the situation has become a talking point not just in Noida, but across the country, reflecting broader concerns over food labeling, consumer rights, and respect for religious practices.

BBMP Revises Residential Parking Tax



The Bruhat Bengaluru Mahanagara Palike (BBMP) has officially revised the parking tax structure for residential buildings, with changes coming into effect from April 1, 2025. This update primarily targets both covered and stilt parking areas and is based on the Unit Area Value (UAV) system—a method used to calculate property taxes by considering the property's location, usage type, and built-up area. BBMP Chief Commissioner Tushar Girinath introduced the proposal last month, seeking public feedback within a seven-day window. The new system aims to create a more uniform and transparent taxation policy, especially for private parking spaces that were often inconsistently taxed under the previous framework. While this revision may bring some benefits to commercial establishments such as shopping malls—thanks to a clearer, standardized valuation—experts believe residential property owners, particularly apartment dwellers with designated parking, may face a greater tax burden. The move is being seen as part of BBMP's larger strategy to boost civic revenue and reduce discrepancies in tax collection across the city. According to civic analysts, while the updated UAV model simplifies tax calculations and improves compliance, it could also place additional financial pressure on homeowners, especially those in areas classified under higher tax slabs. The BBMP maintains that the revision will ultimately help streamline municipal revenue and improve urban infrastructure, but concerns remain over the lack of awareness and sudden implementation of the policy. Residents are advised to review the new UAV-based tax rates to understand how their annual property tax bills will change and ensure they are prepared for potential increases. As Bengaluru continues to urbanize rapidly, with more vertical residential complexes emerging, the impact of this revised parking tax policy could be significant, making it essential for property owners to stay informed and engaged with municipal regulations.




