I said, 'Come on, we are going to do a lot of trade with you guys, so let's stop it.' People would have never really used trade the way I used it. YSRCP General Secretary and State Coordinator Sajjala Ramakrishna Reddy has strongly condemned the recent police actions targeting party leaders across Andhra Pradesh. Addressing a meeting with YSRCP leaders at the party's central office in Tadepalli, Sajjala reacted sharply to the alleged inhumane treatment meted out to former minister Vidadala Rajini and other instances of police overreach under the current coalition government.

He accused the TDP-JSP-BJP alliance of dismantling the democratic fabric of the state by using the police machinery for political vengeance. "The way the police have behaved towards Vidadala Rajini is a clear reflection of how this government is using state forces to settle political scores," he remarked. Sajjala emphasized that this is not just an isolated incident but part of a larger pattern of intimidation and suppression of dissent.

The YSRCP leadership expressed grave concern over the degrading law and order situation and the way the coalition is, in their words, "diluting the police system and eroding constitutional safeguards." Sajjala alleged that the police are filing cases arbitrarily, ignoring legal protocols and bypassing basic civil rights.

Referring to the alleged refusal of the DGP to meet party representatives despite repeated requests, Sajjala said, "It's a clear indication that even top police officials are being pressured or prevented from functioning independently."

Asserting that the YSRCP will not remain silent, Sajjala stated that a counter plan is being prepared to expose the undemocratic functioning of the ruling coalition. "We will act responsibly as an opposition and safeguard institutions under threat. The voices of the people cannot be silenced by police cases," he warned.

Govt Hikes Salaries of Junior College Guest Lecturers

In a major relief to guest lecturers working in government junior colleges across Andhra Pradesh, the state government has issued orders significantly increasing their salaries. The decision, which came into effect immediately, was announced on Monday and is expected to benefit 1,177 guest faculty members employed in 475 junior colleges

According to the government order (GO) released, the hourly remuneration for guest lecturers has been raised from the existing ₹150 to ₹375. In addition, the maximum monthly salary has been fixed at ₹27,000, offering a substantial boost to their financial stability.

Sources from the education department confirmed that this decision was taken on the initiative of State Education and IT Minister Nara Lokesh, who personally reviewed the situation and advocated for the hike. It was also informed that the move comes in response to longstanding demands from guest lecturers who have been requesting better

Officials believe that the salary hike will not only provide economic relief to the lecturers and their families but will also serve as motivation to improve educational quality and commitment within the government junior

The order has been welcomed widely by teaching circles, with many expressing gratitude for the government's swift action in addressing their concerns.



476 Students from AP and TG **Evacuated from J&K Border Areas**

In the wake of heightened tensions along the India-Pakistan border, a total of 476 students and residents from Andhra Pradesh and Telangana have been successfully evacuated from Jammu & Kashmir and other border states, officials from both state governments confirmed

According to an official statement, 350 evacuees from Andhra Pradesh have arrived in the national capital, including 100 who reached on Sunday from J&K and adjacent regions. The Andhra Pradesh Bhavan has reported that 90 of these students have already departed to their respective hometowns, while the remaining 260 are being accommodated and supported in Delhi. A control room operating 24×7 at AP Bhavan has been set up to provide continuous assistance for residents and students from the state stranded in conflict zones near the border. Meanwhile, the Telangana government stated that 126 evacuees have reached Telangana Bhavan, including 91 people who arrived since midnight. The group includes students from NIT Srinagar, Sher-e-Kashmir University of Agricultural Sciences, employees working in J&K, and even students from Lovely Professional University in Punjab.

"57 persons have already left for their hometowns after receiving assistance, while the remaining are being accommodated at Telangana Bhavan," an official confirmed.

Both AP and Telangana Bhavans are offering free food, lodging, medical care, and transport to those evacuated from conflict-affected regions, while maintaining close coordination with district administrations and central authorities to facilitate the smooth return of residents. This mass evacuation follows a recent agreement between India and Pakistan on May 10 to cease mutual military actions, marking a pause after weeks of escalating conflict. The current situation was triggered by a terrorist attack in Pahalgam, South Kashmir, on April 22, which left 26 people dead, most of them tourists.



Sawang Involved in APPSC Scam, Alleges Vijay Kumar

Biodiversity Board Chairman and senior TDP leader Nilayapalem Vijay Kumar has made sensational allegations, claiming that former APPSC Chairman ernment's administration. Vijay Ku-Gautam Sawang and former Secretary PSR Anjaneyulu were deeply involved in a massive scam in the Andhra Pradesh Public Service Commission. Speaking at a press conference at the TDP office in evaluations remotely, without proper Mangalagiri on Monday, Vijay Kumar alleged that key figures in Tadepalli also played a role in the irregularities, and questioned the suspicious circumstances under which Sawang took voluntary retirement with three years of service still remaining.

"If Gautam Sawang had nothing to hide, why did he abruptly take VRS?" Vijay Kumar asked, alleging that the former chairman's sudden exit raises strong doubts. He added that removing an APPSC Chairman is a complex process involving the Supreme Court, Parliament, and a designated committee, implying that Sawang used VRS to es-



cape scrutiny.

dence," he said, adding that Sawang He revealed that the Group-1 examina- even hid related files to conceal the malpractice.

> He pointed out that cases have already been filed against Anjanevulu and Comsign's Chairman Madhu, but insisted that accountability must extend to the top. He condemned the sidelining of Professor Uday Bhaskar, appointed during the TDP regime, and criticized the partisan behavior during the evaluation process.

No Hike in Electricity Tariffs: Minister Gottipati

False propaganda targeting govt, says Minister

Andhra Pradesh Energy Minister Gottipati Ravi Kumar has issued a clear statement amid growing public concern over speculation that electricity tariffs in the state are about to be increased. The minister firmly declared that there will be no hike in electricity tariffs, and the government has no intention of revising the charges in the near future.

Over the past few days, reports and social media discussions have sparked fear among household consumers, who are already feeling burdened by their monthly electricity bills. Addressing these concerns, Minister Gottipati stated, "This is nothing but a false propaganda aimed at misleading the public and defaming the government."

He strongly condemned the rumors being spread against Axis Group Field Energy, suggesting that the misinformation is politically motivated and intended to create unnecessary panic. "We are committed to providing quality power to the people of Andhra Pradesh without imposing any additional financial burden," he added. Highlighting the government's focus on sustainable solutions, Minister Ravi Kumar revealed that a significant push is being made towards the use of renewable energy, especially in Prakasam district. He said an agreement has been signed to supply power at a rate of ₹4.60 per unit even during peak hours, which he described as a landmark step in affordable and reliable power distribution.

He urged citizens not to fall for fake narratives and to trust the government's commitment to protecting public interests. "There is no need to worry. Tariffs will not be increased, and we are working to improve the power infrastructure using cleaner and cost-effective energy solutions," he assured. The minister's clarification is expected to bring relief to lakhs of power consumers across the state who had been worried about possible hikes.

Former MLA Topudurthi Prakash Reddy appeared before the police for interrogation on Monday morning at CKepally Police Station in Sri Sathya Sai district, following allegations of instigating violence during YSRCP chief and former Chief Minister YS Jagan Mohan Reddy's recent visit to

The incident occurred when Jagan's helicopter landed in the village, drawing a large number of party activists and fans. During the commotion, tensions flared, and some activists allegedly pelted stones at the police. Several police personnel were injured in the attack.

According to the police, their preliminary investigation found that Topudurthi's remarks during the crowd's interaction provoked the activists, leading to the unrest. The agitated crowd reportedly reacted harshly when Topudurthi dismissed concerns about Jagan's security arrangements, which were raised by fellow supporters.

Based on this, the police registered a case against Topudurthi and issued formal notices summoning him for questioning. Complying with the summons, he appeared before the CKepally police for interrogation

Authorities are expected to continue the investigation to determine the extent of Topudurthi's role in the incident and whether further legal action is warranted. The situation remains politically sensitive, as it involves both party loyalty and the issue of law and order during a high-profile visit.

Did YCP Govt Spend ₹272 Cr on Volunteers' Training?

The TDP-led NDA government in Andhra Pradesh has begun probing a massive ₹272 crore expenditure incurred by the previous YSRCP regime, allegedly for training village and ward volunteers. What was initially projected as a grassroots governance reform is now raising questions over the actual use — and purpose — of public funds.

Launched to bring welfare services directly to people's doorsteps, the volunteer system deployed over two lakh individuals across the state, each paid ₹5,000 per month. The YSRCP government reportedly allocated ₹68.62 crore annually for training, contracting a private firm named Ram Info to carry out the sessions. However, the new

government is now questioning whether the training ever actually took place.

According deemerging tails, despite the massive allocation, there is little evidence to show that Ram conducted large-scale training on the



ground. Instead, it is suspected that political consultancy I-PAC — closely associated with YSRCP — played a key role in guiding the volunteers, raising serious concerns about the politicization of the scheme.

Leaders from the new administration allege that the volunteer system, rather than acting as a neutral delivery mechanism, was used to promote YCP's political agenda at the grassroots level, especially during elections and welfare program rollouts.

With mounting public scrutiny, the TDP government is expected to order a detailed audit into the entire training contract and expenditure trail. The issue is fast becoming a flashpoint in Andhra Pradesh politics, with accountability and transparency now taking center stage.

UTF Urges Action on School Reorganization Issues

The United Teachers Federation (UTF) has demanded immediate resolution of problems arising from the ongoing school reorganization and teacher adjustment processes being carried out by the School Education Department without clear guidelines. As part of its agitation, UTF staged a dharna in front of the District Education Office in Srikakulam on Monday.

Speaking at the protest, UTF State Secretary S. Kishore Kumar criticized the government for initiating school reorganization and teacher transfers "with one idea per day" and without issuing a clear Government Order (GO). He said that despite bringing their concerns to the government's attention, no action had been taken, prompting this protest. He warned that if the problems are not addressed, UTF will intensify its agitation and gherao the DEO office on May 15.

UTF leaders demanded the repeal of GO 117 and issuance of a new GO to govern the reorganization process. They proposed that teachers be appointed in a 1:20 ratio in all primary schools, GO and for transfers to be completed

and that School Assistant posts not be during the summer break. downgraded, but rather posted only in upper primary and higher schools. Baburao said that teachers who were They emphasized that parallel medium teaching should continue in higher schools, and a second section must be created when class size exceeds 45 in high schools.

UTF District Chief Secretary Bammidi Srirama Murthy added that SGT transfers should be conducted through manual counselling, and Urdu Minor Medium teachers should not be merged with Telugu Medium teachers. He also called for the allocation of both Language and Non-Language School Assistant posts in primary schools, and said model primary schools must have five teachers to handle five classes, with a PSHM post added if students exceed 75.

Further demands included assigning a sixth SGT if high school students exceed 120, and an additional SGT for every 30 students beyond that. For schools with over 300 students, UTF urged the government to appoint a second PD. They also called for the immediate release of the teacher transfer

In addition, UTF District President L rationalized twice after 2021 should receive additional points, and that preference category replacements should be limited to 50% and only for one or two schools. He insisted on resolving promotion-related seniority issues within the district.

District Honorary President K. Vaikuntha Rao stressed the need to protect the seniority of teachers appointed under 610 orders, and that SGTs eligible for promotion to School Assistant (Language) posts should be promoted after the High Court's verdict is implemented.

UTF Treasurer B. Ravikumar urged the government to act swiftly and address the increasing unrest in the education

Trump Returns to West Asia, but Spectacle Alone Won't Deliver Results



Donald Trump's return to West Asia as President comes with familiar theatrics—sword dances, ceremonial pageantry, and bold declarations. Yet, beneath the glitter, the region he once confidently navigated in 2017 has evolved. As Trump begins his second official trip to the Gulf with stops in Saudi Arabia, the UAE, and Qatar (May 13-16), the stakes are higher and his influence more uncertain.

In 2017, Trump's embrace of Saudi Crown Prince Mohammed bin Salman (MBS) and a headline-grabbing \$110 billion arms deal signaled a sharp pivot from Obama-era diplomacy. It was a transactional relationship dressed in opulence. But in 2025, West Asia looks less receptive to the old Trump showmanship. His credibility is under question, with a faltering Ukraine peace promise and economic policies

that have wavered between bravado and retreat.

Despite finally achieving a the regional order remains. breakthrough with Chinaagreeing to ease tariffs in a 90day trade truce—the contrast with Trump's limited progress in West Asia is stark. Conflicts in Gaza rage on, Houthis remain defiant, and US influence is visibly waning. Gulf states, once dependent on Washington, are hedging bets—deepening ties with China, engaging BRICS, and seeking military alternatives to costly American systems like the F-35.

Trump's stance on Gaza—reportedly backing the relocation of over two million Palestinians—has angered Arab nations. Both Saudi Arabia and Qatar insist that normalization with Israel must involve serious moves toward Palestinian statehood. Meanwhile, the Houthis' near-miss missile strike on Tel Aviv underscores how fragile

Despite White House efforts to frame this trip as a chance to revive the "golden age" of US-Gulf relations, many in the region now see Trump as needing them more than they need him. Promises of massive Gulf investments—\$600 billion from Saudi Arabia, \$1.4 trillion from the UAE—may be politically convenient, but they won't substitute for strategic clarity. To regain influence, Trump must move beyond performance. If he delivers real progress—on Gaza, Iran, or the Abraham Accords expansion—he could still shape history. But this time, optics alone won't be enough. The region demands consistency, substance, and a leader who offers more than just spectacle.





This ambiguity highlights the growing trend of the US distancing itself from active involvement in South Asian disputes, leaving India to handle the situation

Turkey are providing Pakistan with advanced defense technology, such as drones and missiles, complicating the already tense situation. The involvement of China, which has long supported Pakistan's military, adds another layer of complexity, especially given its strategic partnership in missile and nuclear capabilities. While Russia has tried to play a balancing role, its influence has waned significantly.

In this new environment, India is forced to adopt a 'Do It Yourself' (DIY) approach, navigating a complex web of international alliances and adversaries. As traditional allies shift their positions, India must rethink its defense strategy, focusing on strengthening its air capabilities and fostering new relationships with countries like Israel and Armenia. The evolving geopolitical landscape demands a fresh approach to ensure India's security and sovereignty in an increasingly fragmented world. The reality is clear: India is largely on its own, with few international players willing to step in.

Without the confidentiality guarantees of the Census Act, the accuracy and integrity of responses in such surveys could be compromised. Make in India: A Startup **Graveyard in Need of Reform**



India, with its vast population and entrepreneurial potential, should be a thriving hub for startups. Yet, despite the promise, the nation's regulatory and policy environment has made it a hostile ground for innovation. The over-complicated documentation, ever-changing rules, and financial barriers create significant obstacles for new businesses to thrive.

Starting a business in India involves navigating through numerous complex steps, from GST registration to environmental clearances and municipal permissions. What should be a straightforward, digital process often becomes a lengthy ordeal, draining both time and capital. This bureaucratic maze discourages entrepreneurs before they even get started.

Another major hurdle is access to capital. India's banks rely on outdated credit systems that penalize young, inexperienced entrepreneurs without borrowing histories. Traditional financial institutions, as well as venture capital, often overlook promising startups, especially those outside major urban areas or without strong professional networks. As a result, many promising ideas die before they get a chance to grow.

Launched in 2014 with high hopes, Make in India was meant to transform the country into a global manufacturing powerhouse. However, it failed to deliver on its ambitious promises due to splintered governance, policy inconsistency, and lack of infrastructure. Instead of being a success story, it became an example of grand rhetoric with disappointing

The consequences are stark. Over the past two years, more than 28,000 startups have shut down, a twelvefold increase compared to the previous years. While sectors like agritech, fintech, and edtech were once seen as revolutionary, they are now littered with failed ventures. India's meager spending on R&D— 0.64% of GDP compared to the global average of 2.6%—limits the potential for breakthroughs in advanced technology

To foster a truly thriving startup ecosystem, India must simplify compliance, eliminate regulatory bottlenecks, and provide transparent access to credit. Cultural shifts are also crucial—failure should be seen as a learning opportunity, not a stigma. Only then can India truly realize its entrepreneurial potential.

"Pakistan tried every means to seek global intervention after being hit where it hurts most — in its terror strongholds," he said, referencing "Let me reiterate — our strikes have areas like Bahawalpur and Muridke, long associated with militant outfits.

> "Pakistan attacked our seema (borders), but we struck their seena

(chest)," Modi stated, claiming that the strikes not only decimated terror infrastructure but also demoralized Pakistan's military and terror networks. He called out Pakistan's long-standing tactic of "nuclear blackmail", affirming India would no longer be restrained by such threats.

Modi described Operation Sindoor as a shift in India's counter-terrorism doctrine. "This is not just an operation; it is a doctrinal change. This is the new normal — India will decisively strike wherever terrorism originates," he declared.

Highlighting the role of indigenous defense manufacturing, the Prime



Minister praised the use of Madeduring the operation, asserting India's strength in modern warfare and self-reliance in defense.

Closing his address, PM Modi modiin-India weapons and equipment fied his well-known phrase, saying: "This is not the era of war, but it is also not the era of terrorism. Zero tolerance against terror is the only path to global peace."

FIR Sought Against Rahul Gandhi Over Remarks On Lord Ram At US Varsity

A legal complaint has been filed against Congress leader Rahul Gandhi in connection with his alleged remarks describing Lord Ram as a "mythological and fictional figure" during a speech at Brown University in Boston, USA. The complaint, filed in a Varanasi court on Monday, accuses Gandhi of hurting the religious sentiments of followers of Sanatan Dharma.

The petitioner, Advocate Harishankar Pandey, lodged the complaint in the MP-MLA court of Additional Chief Judicial Magistrate Neeraj Kumar Tripathi. The court has admitted the complaint and scheduled a hearing for May 19. Notices are expected to be issued to Rahul Gandhi and Uttar Pradesh Congress chief Ajay Rai, who is a resident of Varanasi.

Pandey alleges that Gandhi's statements constitute "hate speech" and have caused offense to devotees of Lord Ram. The complaint also names the All India



Congress Committee (AICC) as a party in the case. Citing a local newspaper as the source, Pandey claims he became aware of Gandhi's speech wherein he reportedly referred to Ram and associated narratives as imaginary.

The legal complaint seeks an FIR to be

registered under several sections of the Bharatiya Nyaya Sanhita (BNS), includ-

Section 196: Promoting enmity between different groups on grounds of religion, race, etc.

Section 351: Criminal intimidation Section 353: Statement conducing to public mischief

Section 356: Defamation

According to Pandey, Gandhi's comments undermine the faith of millions and risk disturbing communal harmony. He urged the court to summon the Congress leader and initiate legal proceedings against him.

The issue has reignited political controversy, with critics accusing Gandhi of disrespecting religious sentiments, while Congress supporters have yet to respond formally. As the matter moves to court, it is likely to fuel further political and public discourse in the days leading up to the May 19 hearing.



'We Did Not Hit Kirana Hills In Pakistan': Indian **Air Force Trashes** Rumours

The Indian Air Force (IAF) on Monday categorically dismissed social media rumours suggesting that India had struck Pakistan's Kirana Hills an area often reported to house underground nuclear storage facilities during its recent military operation codenamed "Operation Sindoor."

Addressing a tri-services media briefing, Director General of Air Operations, Air Marshal AK Bharti clarified that no such strike had taken place. "We have not hit Kirana Hills, whatever is there," he said in response to speculation that India's counter-offensive targeted the sensitive site in Pakistan's Punjab province.

The Kirana Hills area has long been speculated to be home to a covert Pakistani nuclear facility, often linked to storage or development activities. The rumours gained traction after India carried out a series of precision strikes against terror infrastructure and strategic military positions inside Pakistan following a terror attack in Jammu and Kashmir's Pahal-

India's confirmed military target was the Sargodha airbase, a known strategic installation of the Pakistan Air Force. Some reports had connected Sargodha with Kirana Hills due to their proximity and strategic linkage. However,

Air Marshal Bharti unequivocally stated that Kirana Hills was not among the targets struck during the operation.



The three senior officials provided insights into the scope, planning, and objectives of Operation Sindoor, reiterating that the mission aimed solely at eliminating terror launchpads and facilities supporting cross-border ter-

Operation Sindoor, launched in response to a deadly terror strike in India, has been hailed by the government as a demonstration of India's zero-tolerance approach to terrorism. Prime Minister Narendra Modi has also reiterated that the operation is not over but only on hold, depending on Pakistan's actions in dismantling terror infrastructure.

The clarification about Kirana Hills comes amidst heightened tensions between the two nuclear-armed neighbours. India's defence leadership sought to reassure the global community that its military operations are strategic, restrained, and do not escalate into reckless or unverified actions.

US and China Agree to Slash Tariffs in Bid to End Trade War

Reach deal to slash tariffs by 115%

In a significant breakthrough aimed at easing global economic tensions, the United States and China announced on Monday that they have reached a deal to sharply reduce reciprocal tariffs, marking a crucial step toward resolving a prolonged trade war. The announcement followed high-level discussions held in Geneva, where US Treasury Secretary Scott Bessent and senior Chinese officials negotiated the agreement.

The deal includes a 90-day pause on the imposition of new trade measures by both countries and a substantial reduction in existing tariffs—by as much as 115 percent. While the figure may reflect a rollback or compounded percentage on various tariff lines, officials emphasized that this move signals a turning point in US-China economic relations.

The trade war, which has persisted for several years, has disrupted global supply chains, dampened investor sentiment, and rattled financial markets. The latest agreement is expected to restore some stability and confidence, particularly among businesses and industries heavily impacted by the imposed tariffs.

Bessent, addressing reporters after the meeting, highlighted the significance of the agreement: "This is a meaningful step forward for both our nations



and for global markets. A pause in escalating tensions and a commitment to reducing trade barriers sends a strong message of cooperation."

The Chinese delegation echoed similar optimism, suggesting that the agreement lays the groundwork for more comprehensive negotiations in the months to come. They reiterated China's interest in maintaining open trade channels and reducing economic uncertainty.

Market reactions were immediately positive following the announcement, with global stock indices climbing and investor confidence rebounding. Analysts noted that a rollback in tar-

iffs could spur renewed growth in export-driven sectors and reduce costs for

Although challenges remain and a full resolution of the trade conflict is still pending, the current agreement is widely seen as a welcome shift from confrontation to cooperation. Qatar's \$400 Million 'Flying Palace' to **Temporarily Serve as** Trump's Air Force One

Former US President Donald Trump is completed no earlier than 2029 set to receive one of the most luxurious private jets in the world—a \$400 million Boeing 747-8, known as the "Flying Palace"—to serve as a temporary replacement for Air Force One. Originally used by the Qatari royal family and briefly by the Turkish government, the lavish aircraft is now being acquired by the US government to bridge the gap caused by delays in the production of new Air Force One planes.


The opulent jet, referred to as a "flying palace," features extravagant interiors that include designer bathrooms, spacious private bedrooms, and even a grand staircase—amenities rarely seen on presidential aircraft. Trump reportedly toured the plane earlier this year at West Palm Beach International Airport.

This acquisition comes amid significant production delays on two new Boeing 747-8 jets ordered during Trump's first term in 2018. The new aircraft, originally scheduled for delivery in 2024, are now expected to be

Although earlier reports suggested that the jet was being gifted by Qatar during Trump's upcoming visit to the Middle East, Trump clarified via Truth Social that the US had indeed paid for the aircraft. "So the fact that the Defense Department is getting a GIFT, FREE OF CHARGE, of a 747 aircraft to replace the 40-year-old Air Force One, temporarily... bothers the Crooked Democrats," he posted, mocking critics of the deal.

According to ABC News, the Boeing 747-8 will serve as the official aircraft for Trump during his current term and will eventually be handed over to the institution that will run his future presidential library.

With unmatched luxury and a storied history, the Flying Palace adds a new chapter to the tradition of presidential travel while offering a temporary but extravagant solution amid ongoing delays in the development of a new official aircraft fleet.





Series of Earthquakes Jolt Pakistan, Including 4.6 Magnitude **Tremor**

Pakistan experienced another earthquake on Monday as a 4.6-magnitude tremor struck the region, continuing a series of seismic activities over recent days. According to the National Center for Seismology (NCS), the earthquake's epicentre was located at a latitude of 29.67°N and a longitude of 66.10°E, with a shallow depth of just 10 kilometers, making it widely felt in nearby areas. This latest quake comes on the heels of two backto-back earthquakes that hit the country on Saturday. The first struck in the early hours of the morning, at around 1:44 am IST, with a magnitude of 4.0. Just hours later, a stronger quake measuring 5.7 on the Richter scale rattled parts of the country, causing concern among residents and prompting local authorities to monitor the situation closely.

The region has remained seismically active over the past week. On May 5, a 4.2-magnitude earthquake hit parts of both Pakistan and neighboring Afghanistan at 4:00 pm IST, with tremors centered near the Chitral District in the Khyber Pakhtunkhwa province, a region close to the Afghanistan border. Earlier that same day, another quake of similar magnitude (4.2) was recorded in Afghanistan at 12:35 pm IST. These repeated seismic events have heightened public anxiety, especially in areas where infrastructure is not equipped to handle frequent tremors. While no casualties or major damages have been reported so far, residents in affected areas remain on alert.

UK PM Starmer Vows to Cut Migration, Draws Fire for 'Island of Strangers' Remark

In a landmark announcement set to reshape the United Kingdom's immigration landscape, Prime Minister Keir Starmer has pledged a major reduction in net migration by the end of the current parliamentary term. The move, part of a broader strategy to stimulate economic growth and reform public sentiment, marks a decisive shift in immigration policy under his

Addressing a press conference, Starmer challenged the long-standing be-

lief that higher migration drives economic growth. "The theory that higher migration numbers lead to growth has been tested in the last four years. That link doesn't hold on that evidence," he asserted. This statement underpins a broader effort to link immigration reforms with increased investment in domestic skills and training—areas Starmer argues have long been neglected.

Among the most impactful changes is a proposal to double the residency requirement for citizenship, making it significantly harder and

more time-consuming for immigrants to attain British citizenship. While he avoided confirming whether net migration would decrease year-onyear until the next election, he promised a clear drop before the end of the parliamentary term.

Despite these restrictive moves, Starmer stopped short of imposing a hard cap on migrant numbers. His intent, he said, is not to shut Britain off but to ensure it does not become "an island of strangers"—a comment that has drawn intense backlash.

The phrase, seen by critics as echoing anti-immigrant rhetoric, triggered swift condemnation from refugee charities. Steve Smith, CEO of Care4Calais, accused the prime minister of "fanning the fire of the far-right" and using "dangerous language" reminiscent of last year's far-right riots. He demanded a public apology, warning that such remarks risk inciting racial tensions and undermining the safety of vulnerable asylum seekers.

Starmer also took aim at the previous Conservative government, accusing them of hypocrisy. "Between 2019 and 2023, even as they claimed they'd get immigration down, net migration quadrupled," he said, aligning his strategy with the unresolved Brexit promise to "take back control" of the UK's borders. As the UK attempts to balance political pressure, economic needs, and public sentiment, Starmer's approach signals a turning point—one that may significantly reshape the nation's identity and global role.

Israel not committed to ceasefire, only to safe release of hostage Alexander: Netanyahu

Israeli Prime Minister Benjamin Netanyahu has dismissed claims of a broader ceasefire or prisoner exchange agreement with Hamas, asserting that Israel has only agreed to a limited arrangement to secure the release of Israeli-American hostage Edan Alexander. In a statement posted on the official X (formerly Twitter) account of the Prime Minister's Office on Monday, Netanyahu clarified that "Israel has not committed to a ceasefire of any kind or the release of terrorists but only to a safe corridor that will allow for the release of Edan."

This statement comes in response to remarks made by a senior Hamas official, who told Reuters on Sunday that the group was preparing to release Alexander soon. The comments were widely interpreted as a signal of a potential thaw or temporary halt in hostilities. The news was met with cautious optimism by key mediators in the region, including

Qatar and Egypt, both of which have played significant roles in attempting to broker peace and humanitarian agreements between Israel and Hamas since the conflict reignited.

Netanyahu's firm denial aims to dispel any speculation that the Israeli government had agreed to broader concessions, such as releasing Palestinian detainees or halting military operations in Gaza. The Israeli leadership has maintained a strict stance on not negotiating under pressure and has repeatedly stated that its military objectives remain unchanged.



Edan Alexander, a dual citizen of Israel and the United States, has been held hostage in Gaza since being captured by Hamas during the October 7 cross-border assault. His potential release is seen as a positive humanitarian gesture but not necessarily a turning point in the wider

While the safe passage agreement for Alexander's release is being facilitated with the help of international partners, Israeli officials have reiterated that it should not be interpreted as the beginning of a ceasefire or a step toward a broader peace framework. The situation remains tense, with military activity ongoing and diplomatic efforts continuing behind the scenes.

International observers are closely watching how this development unfolds, particularly whether it could open the door for future negotiations on humanitarian corridors, additional hostage releases, or eventual de-escalation. For now, however, Israel remains adamant that its military operations and policy on hostages remain firmly under its own control.

SEBI to Ease Curbs on Index Options Trading and Introduce Stricter **Monitoring Measures**



Tndia's capital markets regu-**L**lator, the Securities and Exchange Board of India (SEBI), is set to relax its proposed restrictions on trading in index options. According to a report by NDTV Profit, SEBI is likely to introduce higher net and gross position limits, offering more flexibility for traders while maintaining market stability.

Under the new guidelines, SEBI is expected to allow a net end-ofday limit of Rs 1,500 crore and a gross limit of Rs 10,000 crore (per side) for index options. This is a significant increase from the initial proposal, which set the net end-of-day limit at Rs 500 crore and the gross limit at Rs 1,500 crore.

Intra-day trading in index options will be exempt from any position caps. However, SEBI plans to implement a more robust surveillance protocol, with exchanges and SEBI coordinating to monitor intra-day positions up to four times a day. If a trader's exposure exceeds specific thresholds, the regulator will conduct investigations to detect

ket manipulation.

Additionally, SEBI is shifting from the traditional notional method to a delta-based open interest metric. This new approach will better reflect the actual economic exposure of options trades, offering a more accurate picture of market risks.

Last week, SEBI also introduced stricter governance rules for key market infrastructure institutions (MIIs), such as stock exchanges, clearing corporations, and depositories. The move aims to prevent conflicts of interest and strengthen market integrity. As part of these changes, SEBI now mandates a cooling-off period for certain directors before they can join competing institutions, ensuring that directors do not leverage sensitive information for competitive advantage.

These steps reflect SEBI's ongoing efforts to enhance transparency, safeguard market integrity, and manage risks in India's dynamic financial markets.

Sensex Soars Over 3,000 Points in Best Rally of the Year

In a remarkable turn of events, Indian stock markets witnessed their strongest rally in a year, as the benchmark BSE Sensex surged over 3.000 points on Monday. The broader NSE Nifty50 also gained nearly 924 points, soaring above the 24,900 mark. Reliance NU Energies Wins 350 MW Solar-BESS **Project from SJVN**

This win represents the largest allocation from SJVN's 1,200 MW solar tender, which includes a total of 600 MW/2,400 MWh of BESS, all connected to the Inter-State Transmission System (ISTS) network. The tender attracted substantial industry interest, with 19 companies participating and 18 qualifying for the final e-reverse auction. The project will be developed under a Build-Own-Operate (BOO) model in accordance with guidelines from the Ministry of Power.

With this addition, Reliance Power's clean energy pipeline now stands at 2.5 GWp of solar capacity and 2.5 GWh of BESS, the largest such portfolio in India. The company is currently awaiting the Letter of Award (LoA) from SJVN to proceed with development.

In a parallel development, Reliance NU Suntech Pvt. Ltd., another subsidiary of Reliance Power, recently signed a 25year Power Purchase Agreement (PPA) with the Solar Energy Corporation of India (SECI) to build Asia's largest integrated solar and BESS project. This ₹10,000 crore initiative will feature 930 MW of solar capacity paired with 465 MW/1860 MWh BESS, at a fixed tariff of ₹3.53/kWh.

With an existing operational portfolio of 5,305 MW, including the world's largest coal-based power plant at Sasan (3,960 MW), Reliance Power's strategic pivot toward renewables is rapidly reshaping its energy future.

LegoGPT: AI Model **Generates Physically Stable Lego Structures**

Agroundbreaking AI model called LegoGPT, developed by researchers from Carnegie Mellon University, has been unveiled to generate three-dimensional (3D) Lego designs that are not only innovative but also stable and buildable. The model is an opensource project aimed at exploring whether AI can create structures that align with real-world physics while maintaining structural integrity.

LegoGPT is based on the LLa-MA-3.2-Instruct large language model (LLM), which has been fine-tuned with one billion parameters. This enables the model to take text prompts and generate corresponding Lego designs that are stable enough to stand upright without collapsing. Examples of prompts include requests for a "streamline elongated vessel" or a "backless bench with armrest." These AI-generated structures are then tested for stability through a combination of human and robotic assembly.

To ensure that the generated designs are physically sound, the researchers incorporated Gurobi, a mathematical optimization solver, into LegoGPT. This solver runs stability analysis on each structure to verify its robustness. The model is also trained using a custom dataset, StableText2Lego, which contains over 47,000 Lego structures and 28,000 unique 3D objects, each accom-



panied by detailed captions, design code, and models.

The stability of these AI-generated designs has been rigorously tested. In one experiment, a dual robot assembly recreated the Lego structures and confirmed their stability. Furthermore, human participants, some with less dexterity, also built the structures, and the results were similarly impressive. According to the research, 99.8% of the generated Lego structures passed the stability test.

LegoGPT is now available for download on GitHub under a permissive MIT license, offering the public the chance to explore and utilize the model for various design and educational purposes. The project showcases the potential of AI in not just creating designs but ensuring they can function in the real world, bridging the gap between creativity and practicality.





Virat Kohli Bids Farewell to Test Cricket After Glorious 14-Year Career

Virat Kohli, one of the modern greats of the game, has officially announced his retirement from Test cricket, bringing an end to a celebrated 14-year journey in the longest format. The 36-year-old confirmed his decision through an emotional Instagram post on May 12, 2025, just days after Rohit Sharma's own Test retirement sent shockwaves through Indian cricket.

Speculation had been building for weeks, and Kohli's announcement came after it was reported that he had informed the selectors of his decision to step away ahead of India's upcoming five-Test series in England, starting June 20.

Kohli made his Test debut in 2011 and went on to play 123 matches, amassing 9,230 runs at an average of 46.85. His record includes **Batting stats** 30 centuries and 31 fifties, with his peak performance coming between 2016 and 2019. However, the last five years saw a dip in form, as he averaged just 30.72 in 39 Tests since 2020, managing only three centuries in that period. His recent tour of Australia was underwhelming, where he scored just 190 runs across nine innings, despite a lone century in Perth.

In his farewell message, Kohli re-

flected on the personal and transformative journey Test cricket has been for him. "It's been 14 years since I first wore the baggy blue in Test cricket. Honestly, I never imagined the journey this format would take me on," he wrote. He spoke of the deep, quiet struggles and unforgettable moments that defined his career in whites.

"There's something deeply personal about playing in whites... It's not easy to step away, but it feels right. I've given it everything, and it's given me back so much more than I could've hoped for," Kohli added, expressing heartfelt gratitude to his teammates, fans, and the game itself.

Signing off as India's 269th Test cricketer, Kohli ends an era filled with passion, intensity, and unmatched commitment to the red-ball game. His departure marks a significant shift in Indian cricket, leaving behind a legacy that will be remembered for generations.

Kohli on May 12, 2025, announced his retirement from Test cricket, ending an illustrious 14-year career (2011-2025) in the format.




