In a development that raises serious concerns about governance and transparency in rural development administration, several Project Directors (PDs) of District Rural Development Agencies (DRDAs) across Andhra Pradesh have reportedly received unofficial directives from individuals claiming to represent a Minister's office (commonly referred to as the "peshi"), instructing them to appoint a specific audit firm for reviewing the accounts of Village Organizations (VOs), Mandal Samakhyas (MSs), and Zilla Samakhyas (ZSs). Sources suggest that the instructions were delivered with veiled ed this process through annual threats: "We will give you the circulars guiding federations to name of the auditing company, empanel qualified audit firms at and you must select them only for the district level—typically 5 to 25 auditing your VO, MS, ZS books of firms per district—ensuring a roaccounts. PDs, fearing potential repercussions, have reportedly complied with the directives.

This development marks a significant deviation from established protocol. Traditionally, under the aegis of the Society for Elimination of Rural Poverty (SERP), a decentralized system governed the appointment of auditors for community-based organizations. As per the MACS Act, 1995, which governs these organizations, federations enjoy legal autonomy and are empowered to select their auditors based on locally-driven evaluations, experience, and resolutions.

# Fire Near Charminar Kills 17 Including 8 Children

A tragic fire broke out in a two-storey building at Gulzar House near the historic Charminar on Sunday morning, claiming the lives of 17 people, including eight children. The incident is one of the deadliest fire accidents in Hyderabad in recent years, exposing serious lapses in fire safety standards and enforcement.

The fire is believed to have started due to a short circuit. The building housed shops on the ground floor and residential units above, a common structure in many parts of the city. Despite efforts to escape, many residents were trapped, resulting in the devastating loss of lives.

This tragedy comes just two days after another fire in a nearby three-storey building in Afzalganj, where timely intervention by the fire brigade saved eight

people, including a baby, with no casualties reported. Both fires have raised concerns about persistent safety violations. Hyderabad and Secunderabad have witnessed several major fire accidents over the past years. Notable incidents include the deaths of ten people in a Nampally building fire in November 2023, six fatalities in Secunderabad's Swapnalok complex in March 2023, and multiple other tragedies involving residential and commercial buildings. These accidents have repeatedly exposed negligence by authorities and poor adherence to fire safety regulations.

Following previous incidents, authorities had promised stringent action against illegal commercial activities in residential buildings and violations of safety norms.

### Tharoor to US, Owaisi to Saudi

- India Sends 59-Member **Delegations to 32 Nations**
- · Centre launches global outreach on terrorism
- Seven MP delegations to visit 32 countries from May 23

In a major diplomatic initiative to highlight India's zero-tolerance stance on terrorism and promote the country's post-Pahalgam response dubbed "Operation Sindoor," the Government of India has announced seven all-party parliamentary delegations that will visit 32 countries starting May 23. The outreach follows the April 22 terrorist attack

in Pahalgam, Jammu and Kashmir. A total of 59 members—including MPs from the BJP, Congress, regional parties, nominated leaders, and former diplomats—will engage with international stakeholders to explain India's counter-terrorism efforts and strategic position. These delegations will be led by prominent leaders such as BJP's Baijayant Panda and Ravi Shankar Prasad, Congress MP Shashi Tharoor, JDU's Sanjay Jha, Shiv Sena MP Shrikant Shinde, DMK's Kanimozhi, and NCP (Sharad Pawar) leader Supriya Sule. Each delegation is supported by former senior diplomats.

However, a sudden policy shift was observed beginning FY 2024-25. SERP issued new instructions suggesting centralized auditor selection, with a single firm or limited firms conducting audits across all districts. Legal experts argue that this approach not only contradicts the federations' legal autonomy under the MACS Act but also undermines the transparency and accountability that auditing is supposed to safeguard.

A similar model was adopted by the Mission for Elimination of Poverty in Municipal Areas (MEPMA), where the Mission Director allegedly bypassed local processes and directly appointed auditors. The policy sparked legal backlash, leading to a writ petition filed in the High Court. The petition challenged the state's authority to unilaterally impose audit firms on independent community bodies and flagged the monopolistic control being exercised over such appointments. The High Court reportedly observed that monopolies in public audits are unacceptable and emphasized the need to ensure fair opportunities for all qualified firms.

Following the court's remarks, SERP appeared to roll back its stance partially and introduced a revised, marks-based scoring model for auditor selection. Official circulars directed PDs to oversee this process and select firms on merit. However, reports now indicate that behind the scenes, the process remains compromised.

Multiple PDs have allegedly been pressured by a personal officer associated with a Minister's office to ensure that only a pre-identified audit firm is selected, irrespective of the firm's eligibility or the outcomes of the official evaluation process. In some cases, PDs have been asked to influence Zilla Samakhyas to pass resolutions appointing the said firm—without naming the source of the directive.

Ironically, the firm being promoted is said to lack the qualifications required under SERP's own circulars, raising questions not only about procedural violations but also about audit integrity. The move has prompted alarm among stakeholders, with experts warning that the credibility of the entire audit process is at risk if external influences dictate the selection of auditors—whose core mandate is to ensure financial accountability and detect irregularities.

With PDs caught between legal obligations and unofficial pressure, and with no clarity on whether the Minister is aware of the situation, the incident has highlighted a troubling governance vacuum. Unless addressed promptly, this interference could severely undermine transparency, financial discipline, and public trust in rural development institutions

### **Liquor Policy In NTR District In Tatters**

- · Bars run openly in wine shops without permits

Despite the coalition government introducing a strict liquor policy with ambitious reforms, the ground reality in NTR district's Kanchikacharla and Veerulapadu mandals paints a grim picture. Wine shops here have transformed into fully operational bars, complete with permit-room-style setups, despite having licenses only to and cigarettes are sold in the same policy in its true spirit.

sell alcohol.

Cold beer is being served in "cold sheds" built right beside wine shops, and in some areas, brandy shop owners are seen consuming liquor openly in front of customers. Traders have even set up pan shops and chicken pakoda stalls next to these outlets, creating tavern-like zones where everything from drinking glasses to snacks

Surprisingly, traders have installed flex banners over the sheds to advertise their services and attract more customers. The illegal belt shops, operating in the middle of roads, are thriving. These belt shops are open 24/7 and sell liquor at inflated prices. Locals allege that not a single one of these operations has the necessary permit for a bar or permit room.

Traders appear emboldened, reportedly claiming, "We invest in lakhs and run business as we wish." Many liquor shops are operating well beyond the government-stipulated hours. Locals strongly suspect that the confidence of these shop owners stems from alleged backing by excise department officials. A disturbing question has emerged: what is the role of vigilance officers in all this? There's little to no visible action from vigilance or excise wings. The syndicate of officers and middlemen is being openly discussed among the public, leading to doubts about whether enforcement bodies are turning a blind eye or are complicit in the racket. Reliable sources say that belt shops and illegal sales are flourishing under the very noses of district-level officials. Residents are demanding immediate intervention from higher authorities to restore order and enforce the liquor

#### Kodali Nani Plans US **Trip Citing Health -Escape Route from Probes?**

Former minister and senior YSRCP leader Kodali Sri Venkateswara Rao, popularly known as Kodali Nani, is currently staying in Hyderabad citing health concerns—but political circles are abuzz that he may be planning to leave for the United States under the pretext of advanced treatment to escape possible legal action.

Nani, who recently returned from Mumbai after undergoing treatment for heart-related issues, is reportedly considering flying to the US for further medical care. However, insiders claim this move is being seen as a strategic attempt to avoid the vigilance and anti-corruption probes initiated by the new TDP government.

Ever since YSRCP lost power, Kodali Nani has been keeping a low profile, avoiding his home turf of Gudivada and staying away from party followers. He has reportedly not been in contact with local leaders or cadres, further fuelling speculation that he is deliberately distancing himself from ongoing developments in Andhra Pradesh.

The TDP government has accused Nani of being involved in large-scale corruption during his tenure as Minister for Civil Supplies and Consumer Affairs. Vigilance officials are said to be gathering evidence related to alleged irregularities and misuse of office in Gudivada.

Known for his aggressive political style and harsh attacks on then opposition leaders N. Chandrababu Naidu and Nara Lokesh, Kodali Nani now finds himself at the receiving end of political pressure and scrutiny. With multiple departments now reportedly investigating his tenure, his sudden focus on seeking treatment abroad has raised evebrows.

Political observers believe this could be a calculated attempt to dodge possible arrest or questioning. "He is trying to use health as an excuse to flee the country, as he knows cases are likely to be filed soon," a senior TDP leader said off record.

As Kodali Nani continues to remain silent and isolated in Hyderabad, uncertainty looms over whether he will face the probe head-on or seek refuge overseas under the guise of medical need.

#### **Ration Through Fair Price Shops** from June 1?

A major change may be coming to the public distribution system in Andhra Pradesh, with growing reports suggesting that ration goods will soon be distributed through govern-

ment-run fair price shops instead of the Mobile Delivery Unit (MDU) vehicles, starting from June 1. Civil Supplies Minister Nadendla Manohar has stated that a final decision on the matter will be taken in the next two days. Since the formation of the new coalition government, speculation has intensified over the fate of the MDU sys-

tem introduced by the previous YSRCP government, which aimed to deliver ration directly to households. However, many within the ruling alliance claim the vehicles have turned into "street ration" rather than door delivery, and that the system is placing an unnecessary financial burden on the state. Public representatives in various constituencies have already begun informing local residents that the distribution method is likely

to return to the traditional model through

cheap price shops. Ruling party leaders have also conducted meetings with local dealers, instructing them to ensure smooth and transparent distribution to ration cardhold-

Minister Nadendla Manohar had earlier crit-

icized the efficiency of the MDU model, stating it had failed to serve its intended purpose and instead contributed to logistical inefficiencies. In line with this, the government also gathered feedback from beneficiaries to assess public opinion on continuing MDU services versus returning to shopbased distribution. The feed-

back, however, appears to have been mixed. During a program held in Tenali, Guntur district on Saturday, a woman raised a concern regarding the MDU service. She noted that due to her unavailability at home during the vehicle's arrival, she had missed receiving her ration and had no way to get it later. Responding to this, Minister Manohar assured that the government is actively considering all aspects and that a clear decision will be announced within two days.

#### **Attack on TDP Worker: Nandigam Suresh Arrested**

Former YSR Congress Party MP Nandigam Suresh has been arrested in connection with the alleged attack on a TDP worker, Isakapalli Raju, in the Amaravati region. The incident took place last night near Uddandarayunipalem when a car reportedly sped through the area, prompting Raju to reprimand the driver.

Following this, allegations surfaced that Nandigam Suresh's followers assaulted Raju and forcibly took him to the residence of the former MP. In her complaint to the Tullur police, Raju's wife Lakshmi accused Nandigam Suresh and his brother Prabhudas of physically



attacking her husband at their home.

Based on the complaint, the Tullur police registered a case and arrested Suresh today. He was taken into custody and brought to the Tullur police station for questioning. Authorities have also launched a search operation to locate his brother Prabhudas and other individuals allegedly involved in the attack.

Meanwhile, Nandigam Suresh's wife strongly opposed the arrest and staged a protest outside the Tullur police station, demanding his immediate release and condemning the action taken by the authorities.

However, recurring tragedies suggest those assurances have not translated into effective measures on the ground. Union Minister and Secunderabad MP G. Kishan Reddy expressed shock over the latest incident and urged all responsible departments—including police, fire services, GHMC, and electricity boards—to enforce fire safety regulations strictly. He emphasized the urgent need for coordinated action to prevent such disasters in the future.

The government has ordered a detailed inquiry into the fire, and political leaders visiting the site have called for strong preventive measures. The city's residents demand that authorities prioritize public safety to avoid the recurrence of such tragic incidents.







#### **Jagan Condemns Attack On Dalit Student In Tirupati**

- · YCP chief says law and order has collapsed in AP
- Alleges growing attacks on Dalits and weaker sections
- Demands strict action against those involved in the assault

YCP president and former Chief Minister Y.S. Jagan Mohan Reddy has strongly condemned the attack on Dalit engineering student James in Tirupati, calling it a glaring example of the deteriorating law and order situation under the current TDP-led government. Jagan expressed his concerns through a strongly worded message on social media.

"I strongly condemn the attack on Dalit engineering student James in Tirupati. This incident is an example of the deteriorating law and order situation in the state and the increasing attacks on Dalits," Jagan posted.

He alleged that attacks on Dalits and marginalized groups have become alarmingly frequent across Andhra Pradesh. He claimed that the police have become partisan and ineffective, acting under the pressure of ruling party leaders, particularly under the direction of Chief Minister Chandrababu Naidu.

"Dalits and other groups who cannot make their voices heard are left defenseless in this state. Such incidents are happening because the police machinery, which is immersed in partisan activities under the direction of Chandrababu and the ruling party leaders, completely ignores its responsibility to protect citizens," Jagan remarked. He further stated that the public has lost faith in the police system, as filing complaints often results in counter-cases against the victims themselves. Referring specifically to the Tirupati incident, Jagan alleged that political interference had reached a point where the police were not even accepting formal complaints from the victim's

"The police machinery has not only failed in the attack on James, but due to political interference, it is not even possible to accept a complaint," he

Jagan concluded by demanding strict legal action against those responsible for the attack and urged the state government to act impartially in safeguarding Dalits and other vulnerable communities.

# Free Bus Scheme to Cost ₹3,182 Cr Annually

- Scheme to roll out from August 15;
- Concerns over viability and impact on transport sector

Chief Minister N. Chandrababu Naidu's flagship welfare initiative—offering free bus travel for women across Andhra Pradeshis set to be launched on August 15. While the move has been welcomed by many for its social impact, it's also sparked a debate over its financial and logistical implications. The Andhra Pradesh State Road Transport Corporation (APSRTC) is estimated to require an annual reimbursement of ₹3,182 crore from the state government to run the scheme.

As per preliminary projections, the occupancy rate in buses is expected to surge from the current 69% to 94% once the scheme is implemented. Daily female ridership is likely to rise by an additional 10.84 lakh passengers, drastically increasing the burden on public transport infrastructure.

Reactions to the scheme are sharply divided. Supporters argue that free travel for women is a



much-needed step toward gender equity, especially benefiting daily wage earners, students, and working women. They highlight that this will reduce financial pressure on households and promote female participation in education and the workforce.

Critics, however, describe it as another populist measure that will strain the state exchequer. There are concerns that men, especially in peak hours, may find it harder to secure seats. The ripple effect could hurt private transport operators, including auto drivers and cab aggregators, many of whom rely on daily income.

One of the core apprehensions is whether APSRTC will receive timely reimbursements from the government. Given that public transport corporations have often been underfunded and neglected by successive governments, any delay in payments could deepen the financial crisis of the RTC.

Furthermore, the potential misuse of the scheme through non-essential travel or joyrides remains a challenge. Regulating and monitoring ridership to prevent such misuse would be crucial to ensure the scheme's sustainability.

During the recent legislative sessions, Transport Minister V. Sandhya Rani hinted that the free bus travel scheme might be restricted to intra-district routes. If this limitation is enforced, it could help reduce losses and prevent misuse, though an official clarification is awaited.

The scheme, while ambitious and socially progressive, will depend heavily on transparent execution, financial discipline, and effective monitoring to ensure it does not derail APSRTC's operations while striving to uplift women.

# **CM Mourns Death Of 7 Children In Two Tragic Incidents**

Chief Minister N. Chandrababu Naidu expressed profound sorrow over the tragic deaths of seven children in two separate incidents that occurred on the same day in Chittoor and Vizianagaram districts. The Chief Minister said these incidents have left him deeply distressed.

In the first tragedy, three children from the same family died after falling into a pond in Devarajpuram village of Kuppam mandal, Chittoor district. The children — Gautami, Shalini, and Ashwin reportedly fell into the pond while playing. Despite immediate efforts, all three lost their lives. The children. Chief Minister offered his heartfelt condolences to the grieving family members who are mourn-

ing the irreplaceable loss of their of Vizianagaram district. According to initial reports, the children had gone out to play and entered a parked car, which accidentally got locked. Unable to open the doors

or call for help, the children were trapped and eventually died due to suffocation. The victims have been identified as Uday, Jashrita, Charulata, and Maniswari — all under the age of 10.

Chandrababu Naidu said the news of these back-to-back tragedies has caused him immense pain. He expressed his deep condolences to the parents and families of the deceased and said the state government would extend all necessary support to the bereaved families. "These accidents, which claimed the lives of very young children, are heart-wrenching. We will stand by the affected families and ensure that they receive all the help they need," the Chief Minister stated. He also urged parents and communities to stay vigilant to prevent such unfortunate incidents in the future.

# **Kadapa Shop Demolitions Spark Political Storm**

The demolition of temporary structures in front of shops at the YSR Shopping Complex in Kadapa Municipal Corporation has ignited a political controversy. Town Planning officials demolished these structures citing encroachments, including the building leased by YCP leader Jayachandra Reddy's brother, currently managed by Jayachandra. Nine other shops in the complex were also affected.

Shop tenants had installed temporary rakes and ramps outside their shops for ease of access. Despite this, municipal authorities demolished these structures at night without prior notice. Critics point out that public toilets near the Municipal Urdu Boys High School and facilities at the Municipal Stadium, also close by, were left untouched, raising questions about selective enforcement.

YCP leaders claim the demolitions are politically motivated under the orders of Kadapa MLA Madhav Reddy, targeting those opposing him. Jayachandra Reddy, vocal against the MLA's alleged factional activities and recent political defections, said these actions are aimed at silencing



The demolition has left around 50 families homeless, triggering protests from the city mayor Suresh Babu, corporators, and YCP leaders who gathered at the site in large numbers. They warned that such measures will only strengthen their resolve to question government failures and seek

The YCP corporators vowed to oppose these illegal demolitions at the polls and demanded restoration of the affected families' rights and properties.

### **YCP Ex-MLA Bats for Jagan-Modi Alliance in Next Elections**

#### Calls past decision to skip BJP tie-up a mistake

Senior YSR Congress Party leader and former Kovvur MLA, Nallapureddy Prasanna Kumar Reddy, has stirred a new debate in the political circles with his latest remarks. Speaking to the media, Reddy ex-

pressed his strong desire for an alliance between YSRCP and the Bharatiya Janata Party (BJP) in the upcoming elections.

He said he would personally convey this suggestion to party chief and former Chief Minister Y.S. Jagan Mohan Reddy. "I want to see YSRCP contesting along with BJP in the next elections. I believe that will be a

stronger and more strategic move," Reddy said. Prasanna Kumar Reddy didn't hold back from criticizing his own party's earlier stance. He stated that the decision to contest the 2024 elections without aligning with the BJP was a significant mistake. He pointed out that the YSRCP had extended support to the Modi-led NDA government throughout its previous tenure and said there was nothing wrong in forming an electoral alliance with them.

"The YSRCP stood by Modi's government for five years. It was unfortunate that despite this support, we didn't proceed with a formal alliance. That misstep gave an opportunity for the BJP to shift towards TDP and Janasena," Reddy commented.

Highlighting BJP's uneasy history with TDP chief N.

Chandrababu Naidu, Reddy said, "Prime Minister Narendra Modi and Union Home Minister Amit Shah never had a favorable view of Naidu, especially after the past criticism and protests led by TDP against the Centre."

He argued that the BJP was initially inclined towards partnering with the YSR Congress Party, but due to Jagan's silence, they

eventually went with the TDP-Janasena combine. "There's still a chance. If such an opportunity arises again, Jagan should not let it slip away," he empha-

Reddy's statement has now opened up speculation about potential future alliances in Andhra Pradesh politics. With the shifting dynamics post the 2024 elections, many in the YSRCP may start viewing the BJP alliance as a pragmatic path forward.

#### **One Killed, Two Critically Injured in Auto-Lorry Collision**

### Telugu State Theaters To Shut From June 1??

Exhibitors oppose rental system, demand revenue share Decision taken in Film Chamber meeting with Dil Raju, Suresh Babu Releases of upcoming films likely to be affected

A major development has rocked the Telugu film industry as theater exhibitors across Andhra Pradesh and Telangana have decided to shut down cinema theaters indefinitely starting June 1. This decision comes in protest against the existing rental model for screening films, with exhibitors demanding a shift to a percentage-based revenue sharing system.

The decision was taken on

Sunday during a key meeting held at the Telugu Film Chamber of Commerce in Hyderabad. Prominent producers and industry leaders, including Dil Raju and D. Suresh Babu, were present. Exhibitors from both Telugu states raised their concerns and conveyed their inability to continue operations under the current model.

"We are incurring heavy losses due to the rising operational costs. The rental system is no longer sustainable for us. From now, we want a share of the film collections through a percentage system," the exhibitors reportedly said during the meeting.

They unanimously resolved not to screen any films from June 1 unless their demand is accepted. An official letter will soon be submitted to the producers, informing them of the decision and urging them to consider the percentage-based

This development is likely to have serious implications for the Telugu film release calendar. Several small and mid-budget films scheduled for release from June 1 could face delays or cancellations. The decision has sparked concern across the industry, with stakeholders waiting to see how the producers will respond.

Industry insiders that if no compromise is reached soon, the entire distribution-exhibition ecosystem could face disruption. Talks are expected to continue in the coming days to find a mutually acceptable solution.

### **Terror Suspects Nabbed** in Vizianagaram

Explosive materials recovered from local residence Accused revealed links leading to Hyderabad arrest Police to produce both suspects in court

Tension gripped Vizianagaram town after police unearthed a suspected terror plot involving explosive materials. Following a specific intelligence input, the Vizianagaram police raided a house in the town and arrested a 29-year-old man identified as Siraj Ur

During the operation, the police recovered ammonia, sulphur, and aluminium powder, which are commonly used in the making of explosives. These materials were reportedly found in Siraj Ur Rehman's possession.

Officials confirmed that after interrogating Rehman, they obtained leads pointing to another suspect based in Hyderabad. Acting swiftly on the information, police arrested Syed Sameer, 28, from Hyderabad, in connection with the case.

Authorities stated that both individuals are being questioned further, and will be produced in court soon. The police have not yet disclosed the motive or intended target, but the arrest has raised serious concerns over potential terror activities being planned from within the region.

Security has been tightened in and around Vizianagaram, and the police are continuing their investigation to uncover any broader network or plot linked to the arrested individuals.



### **The Awkward Truth About Creditworthiness: A Modern Financial Dilemma**

Creditworthiness is a word that carries but because of the past. Creditworthiness weight, power, and often, a fair amount of discomfort. It's the silent evaluator that hovers over financial decisions—from buying a home or car to simply applying for a credit card. While it sounds like a straightforward concept—your ability to repay debt—it's laced with awkwardness, misunderstandings, and an emotional complexity that few openly talk about.

Many find themselves in a paradox they need credit to build credit, but can't access meaningful credit because they don't have a history. So they start with small credit cards or loans, each decision scrutinized, and one misstep-a missed payment or high utilization—can haunt them for years. It's like being graded on a test you didn't know you were taking.

Then there's the issue of financial trauma or past mistakes. Many people have faced economic hardship—job losses, medical emergencies, or simply poor financial decisions made under stress or lack of knowledge. These situations often tank a credit score, creating a sense of shame or failure. The awkwardness intensifies when they're denied a loan or apartment lease, not because they can't afford it now,

doesn't easily account for personal growth or recovery. There's also the systemic awkwardness-how the credit system, while seemingly impartial, often disadvantages those from marginalized communities. Access to credit, financial literacy, and even fair banking institutions are not distributed evenly. The result is a lopsided system where some must work much harder to prove their "worthiness."

And then comes the strange dance of improving your credit. People start doing things that seem counterintuitive—taking out loans they don't need, keeping old credit cards open just to maintain a longer credit history, or juggling multiple cards to keep utilization rates low. It becomes less about genuine financial behavior and more about playing the game right.

Even conversations around creditworthiness are awkward. It's not something people are comfortable discussing, like salary or debt. Yet it's a major factor in one's financial life. People often feel isolated in their credit struggles, unaware that many others are navigating the same maze of rules, penalties, and arbitrary metrics. Ultimately, the awkwardness of creditworthiness lies in its invisibility and influence. It quietly shapes financial lives, opens or closes doors, and yet feels disconnected from the full picture of a person's financial reality. As we move toward more inclusive financial systems, perhaps the future of credit will consider more than just numbers. Until then, many will continue to live under the quiet discomfort of being judged by their financial past.



# INDIA in tatters: Congress not doing enough

Senior Congress leader and former Union Finance Minister P. Chidambaram has voiced what many within political and public circles have been whispering for months—the once-promising INDIA bloc is now little more than a fragmented memory. Formed nearly two years ago as a grand alliance of Opposition parties with the intent to counter the might of the Bharatiya Janata Party (BJP), the bloc has gradually drifted into political obscurity, and Chidambaram's recent remarks only underline its near comatose state.

Speaking candidly, Chidambaram admitted he is unsure whether the INDIA alliance, designed to unify diverse regional and national Opposition forces under one banner, is even "intact" anymore. While expressing a faint hope that the alliance can "still be put together," his tone carried more doubt than optimism. The honesty of his assessment reflects the deepening cracks and lack of cohesion within the bloc—issues that have remained unaddressed for far too long.

What makes his statement even more



striking is the unexpected praise he directed toward the BJP, calling it the most "formidably organised" political party in India's history. For a senior Congress leader to publicly acknowledge the BJP's unparalleled electoral machinery, grassroots penetration, and political discipline is significant, and perhaps uncomfortable, especially for his own party, which has struggled to project unity, purpose, or clar-

ity in recent times.

This recognition of the BJP's formidable strength comes at a time when the Modi government is riding high on both perception and performance, with a strong narrative control and continued popularity among large sections of the electorate. The BJP's ability to dominate both national and regional discourse, align state units

with central leadership seamlessly, and outmaneuver fractured Opposition fronts is precisely what the IN-DIA bloc was supposed to counter. But instead of offering a cohesive alternative, the bloc has become a study in contradictions, plagued by personality clashes, ideological rifts, and electoral one-upmanship among allies.

Chidambaram's comments, there-

fore, are not merely a critique—they are a warning. The Congress, as the principal Opposition party, cannot afford to remain passive or internally divided while praising the strategic brilliance of its main adversary. That kind of acknowledgment, while intellectually honest, risks demoralising party cadres and further disillusioning voters who are seeking a viable alternative.

Moreover, his words come at a sensitive time. With national elections looming closer, and the BJP consolidating its influence across key states, the vacuum left by a disjointed Opposition could further tilt the balance in the ruling party's favor. If the INDIA bloc is to have any future relevance, now is the time for a radical course correction—one that demands humility, unity, and a clear common agenda, not just rhetoric.

In the end, P. Chidambaram has done what few in Indian politics dare to do: speak an uncomfortable truth. Whether his party and allies will listen—or continue down the path of disintegration—remains to be seen.





### PM Modi To Chair NITI Aayog Meet On May 24, **Focus on Viksit Bharat 2047 Vision**

Centre to Collaborate with States on Development Strategy **Post-Operation Sindoor**

# "3 Pillars Of Democracy Equal": Chief Justice BR Gavai's Big Protocol Remark

Chief Justice of India (CJI) BR Gavai, during his first official visit to Maharashtra after assuming office, subtly criticized the state's Executive over a breach in protocol. His remarks have sparked renewed attention on the ongoing debate surrounding judicial overreach and the balance of power between the three pillars of democracy.

Speaking at a felicitation event organized by the Bar Council of Maharashtra and Goa in Mumbai, CJI Gavai pointed out the absence of three key officials — the Chief Secretary, Director General of Police, and Mumbai Police Commissioner. He emphasized that constitutional institutions must respect each other and noted that such protocol lapses raise important questions.

"If a constitutional head visits their home state for the first time and is not received appropriately, it warrants reflection. Had judges done the same, debates around Article 142 would have erupted," he said.



Article 142 grants the Supreme Court the power to pass any order necessary for doing complete justice.

After his comments, the aforementioned officials appeared at Chaitya Bhoomi, where CJI Gavai paid homage to Dr. B.R. Ambedkar. Speaking to the press there, he downplayed the incident, stating he was "not fussy" about protocol, but merely pointed out a factual lapse.

The CJI's remarks come amid a broader The episode underscores the fragile baldebate over the judiciary's role in governance, especially following a Supreme

Court ruling on Tamil Nadu's legislative standoff with Governor RN Ravi. Using Article 142, the court had directed that delayed Bills be cleared, terming the Governor's inaction "arbitrary." This ruling prompted President Droupadi Murmu to question whether courts could impose timelines on Governors, who enjoy constitutional discretion under Articles 200 and 201.

President Murmu sought clarity on whether the President or Governor's decisions under these articles are justiciable, citing Article 361, which offers them immunity from legal accountability while in office. Political reactions followed swiftly. BJP MP Nishikant Dubey criticized the court, accusing it of overstepping its bounds. However, the Supreme Court chose not to entertain a contempt plea, stating courts are "not fragile as flowers," though it called the remarks "highly irresponsible."

### ISRO's 101st Space Mission Fails as **PSLV Rocket Malfunctions After Launch**

In a rare setback for India's space programme, the Indian Space Research Organisation (ISRO) faced failure in its 101st space mission as the PSLV-C61 rocket malfunctioned minutes after liftoff on Sunday morning. The mission was intended to launch the Earth Observation Satellite EOS-09 into a sun-synchronous orbit but was unsuccessful due to issues with the rocket's third stage.

The launch took place at 5:59 am from the the intended orbit," ISRO stated, without Satish Dhawan Space Centre in Sriharikota. While the lift-off proceeded normally, telemetry data soon indicated a deviation in performance, leading to an incomplete orbital injection. ISRO, in a brief official statement, confirmed that an anomaly had occurred during the third stage of the flight. Further details are expected after a full analysis of flight data.

"An anomaly was observed in the third stage of the PSLV-C61 mission, which prevented the satellite from being placed in



elaborating on the technical failure or the fate of the EOS-09 satellite.

The EOS-09 satellite was designed for earth observation purposes, including agricultural monitoring, land use mapping, and disaster management support. The failed deployment marks a significant disruption in ISRO's otherwise consistent record of successful PSLV launches-often referred to as the "workhorse" of India's space programme.

This mission was ISRO's 101st from Sriharikota and was expected to reinforce the reliability of the PSLV after recent successes, including multiple satellite launches and collaborations with international space agencies. The failure has come as a setback not just for ISRO but also for several scientific institutions relying on data from the EOS-09.

An internal failure review committee is likely to be constituted immediately to investigate the anomaly. ISRO is expected to make a detailed presentation on the root cause and corrective measures in the coming weeks.

Despite the failure, experts affirm that IS-RO's overall mission success rate remains high and that such incidents, while unfortunate, are part of complex space operations.



#### **India Shines Amid Global Economic Slowdown, Tops UN Growth Forecasts**

In a world grappling with economic uncertainty, India has emerged as a standout performer, leading global growth projections, according to the United Nations' mid-year update of the World Economic Situation and Prospects. The report forecasts India's GDP to grow at 6.3% in FY 2025, the highest among major economies, and slightly higher at 6.4% in 2026.

This optimistic outlook comes as the global economy faces multiple headwinds — from trade tensions and waning cross-border investments to persistent policy uncertainty. The UN has downgraded its global growth projection for 2025 to 2.4%, from 2.9% in 2024.

India's performance is driven by strong domestic demand, robust capital markets, record-breaking exports, and consistent government spending. Inflation is expected to stay contained at 4.3%, well within the Reserve Bank of India's target range, thanks to stable employment and prudent fiscal management.

#### **Capital Markets & Manufacturing Surge**

India's financial markets have remained buoyant, with indices climbing to record highs. A vibrant primary market has attracted global players like Hyundai and LG, who are listing their local subsidiaries, signaling India's strategic importance in the global financial system. The manufacturing sector has shown exceptional growth. The Gross Value Added (GVA) of manufacturing at constant prices nearly doubled in the last decade — from ₹15.6 lakh crore in 2013–14 to an estimated ₹27.5 lakh crore in 2023–24, according to the Ministry of Statistics.

#### **Export & Defence Milestones**

India's exports touched a historic high of \$824.9 billion in 2024–25, a 6% increase over the previous year and a dramatic leap from \$466 billion a decade ago. In the defence sector, indigenous manufacturing hit ₹1.27 lakh crore in 2023–24, marking a 174% rise since 2014–15. Defence exports soared from just ₹686 crore in 2013–14 to ₹23,622 crore in 2024–25, with Indian defence equipment now reaching nearly 100 countries. The UN report highlights that India's structural reforms, export strength, and proactive policies have positioned it as a beacon of stability in an otherwise fragile global economic environment.

### Jaishankar to Embark on Six-Day Europe Tour from Today

External Affairs Minister S. Jaishankar will begin a crucial six-day official visit to Europe from May 19 to 24, covering the Netherlands, Denmark, and Germany. The tour aims to bolster India's strategic and economic partnerships with these key European nations amid rapidly evolving global dynamics.

According to an official release, Jaishankar will hold bilateral meet-


ings with the top leadership and foreign ministers of the three countries. Discussions are expected to cover a broad spectrum of bilateral ties, with a strong focus on trade, technology, renewable energy, and defense cooperation. Regional and international issues of shared concern—including Indo-Pacific security, climate change, and the Russia-Ukraine conflict—will also be on the agenda.

The visit to the Netherlands will include engagements with Dutch Prime Minister Mark Rutte and other senior officials. India and the Netherlands enjoy a long-standing relationship

rooted in shared democratic values and strong trade ties, especially in sectors like water management, agriculture, and innovation.

In Denmark, Jaishankar is expected to follow up on the outcomes of the Green Strategic Partnership, launched during Prime Minister Narendra Modi's 2022 visit. This partnership emphasizes cooperation in sustainable development, green technologies, and climate action areas where Denmark has global expertise.

Germany will be the final stop of the visit, where Jaishankar will engage with Chancellor Olaf Scholz's administration. India and Germany have deep-rooted economic and defense relations, and the two sides have been working closely on strengthening their bilateral partnership under the Inter-Governmental Consultations framework. Discussions in Berlin will likely include collaboration on AI, cybersecurity, and critical technologies, as well as furthering investments in manufacturing and green energy.







# Trump to Call Putin in Effort to End Ukraine 'Bloodbath'

#### Intervenes as Civilian Deaths Mount in Ukraine War

In a significant development following the first direct talks between Russia and Ukraine in over three years, U.S. President Donald Trump announced on Saturday, May 18, 2025, that he will speak with Russian President Vladimir Putin by phone on Monday to push for an end to what he called the "bloodbath" in Ukraine.

Trump has been urging Moscow to agree to a 30-day unconditional ceasefire as a first step toward halting hostilities. Kremlin spokesman Dmitry Peskov confirmed to Russia's state TASS news agency that preparations for the call are underway.

The call announcement comes just a day after Ukrainian and Russian delegations met in Istanbul and reached an agreement to exchange 1,000 prisoners on each side—the first such deal since the early months of the war in 2022. Ukrainian Defence Minister and lead negotiator Rustem Umerov hailed the exchange and indicated that the next step could be a high-level meeting between Ukrainian President Volodymyr Zelenskyy and Putin.

However, the Kremlin has stated that a meeting between the two leaders would only occur once both sides have reached a preliminary agreement. Russian negotiator Vladimir Medinsky said both parties are expected to present their respective visions for a possible ceasefire soon.



Despite the progress, violence continues. On Saturday, a Russian drone strike on a civilian minibus in Ukraine's eastern Sumy region killed nine people and injured five. In a separate attack in the Kyiv region, a drone strike killed a woman and wounded three others, including a child.

President Zelenskyy condemned the attacks and reiterated his call for tougher sanctions against Moscow. "Without stronger pressure, there will be no meaningful diplomacy," he warned.

Posting on Truth Social, Trump emphasized his desire to end the violence, stating, "A ceasefire will take place, and this very violent war... will end." He added that after his call with Putin, he would also speak with Zelenskyy and NATO officials.

Both Washington and Moscow have acknowledged the importance of Trump and Putin meeting directly to discuss the conflict's future, with Trump insisting that real progress hinges on personal diplomacy.

# IMF Imposes 11 New Conditions on Pakistan, Warns of Risks Amid India Tensions

The International Monetary Fund (IMF) has imposed 11 new conditions on Pakistan for the release of the next tranche of its bailout package, raising the total number of conditions to 50, according to a report by The Express Tribune on Sunday, May 18, 2025. The IMF also warned that escalating tensions with India could pose significant risks to the programme's fiscal, external, and reform objectives.

Among the newly imposed requirements is the parliamentary approval of a massive ₹17.6 trillion federal budget, which includes a 12% increase in defence spending, bringing the allocation to ₹2.414 trillion. However, the Pakistani government has reportedly proposed a defence budget exceeding ₹2.5 trillion—an 18% jump—following the military confrontation with India earlier in May. This comes in the wake of India's 'Operation Sindoor' on May 7, which targeted terror infrastructure in response to the April 22 Pahalgam terror attack that



claimed 26 lives.

Despite the recent cross-border tensions, financial markets in Pakistan have shown modest reaction. The stock market has largely retained its gains, though bond spreads have widened slightly.

The IMF's newly outlined conditions span several critical sectors. In energy, the government must rebalance electricity tariffs by July 1 and adjust gas tariffs by February 15, 2026, to ensure cost recovery. Parliament must also legislate to make the captive power levy permanent and remove the current ₹3.21 per unit cap on the debt service surcharge—measures seen as necessary to curb rising circular debt and address inefficiencies in the power sector.

Additionally, provinces are now required to implement new agriculture income tax laws, complete with a system for return processing, taxpayer registration, and compliance plans. This move must be finalized by June 2025.

The IMF has also called for a governance action plan to address administrative shortcomings, and the development of a financial strategy for the post-2027 period. Furthermore, Pakistan must submit legislation to Parliament by July to lift restrictions on importing used motor vehicles up to five years old.

Lastly, a roadmap for phasing out tax incentives for Special Technology Zones and industrial parks by 2035 must be prepared before the end of this year.

# Russia Launches Largest Drone Attack on Ukraine Following Failed Ceasefire Talks

In a dramatic escalation of its war on Ukraine, Russia launched its most intense drone assault since the start of the full-scale invasion in 2022, with a total of 273 drones fired into Ukrainian territory. This attack came after the collapse of the first direct peace talks between Moscow and Kyiv in years, which failed to produce a ceasefire agreement.

Russian President Vladimir Putin rejected Ukrainian President Volodymyr Zelenskyy's offer for a face-to-face meeting in Turkey, despite initially proposing direct negotiations as an alternative to Ukraine's demand for a 30-day ceasefire. The talks, which took place in Istanbul on Friday, lasted less than two hours before breaking down. However, both sides did agree to exchange 1,000 prisoners of war each, with Kyrylo Budanov, Ukraine's intelligence chief, suggesting that the exchange could occur as soon as next week. The drone attack, launched overnight into Sunday, targeted multiple regions of Ukraine, including Kyiv, Dnipropetrovsk, and Donetsk. According



to Ukraine's air force, 88 drones were intercepted, and a further 128 were likely disabled due to electronic jamming. Despite these defenses, the attack remains the most significant drone strike since Russia's invasion began, surpassing the previous largest attack on the third anniversary of the war, when Russia deployed 267 drones.

The barrage also led to casualties in the Kyiv region, where Mykola Kalashnyk, the regional governor, confirmed that a 28-year-old wom-

an was killed, and three others, including a 4-year-old child, were injured in the attacks. On the Russian side, the Defense Ministry reported shooting down seven Ukrainian drones overnight and 18 more on Sunday morning, as the conflict shows no signs of de-escalating.

In the midst of these escalating hostilities, US President Donald Trump announced plans to speak with Putin on Monday, followed by discussions with Zelenskyy and NATO leaders about efforts to end the war.

#### Netanyahu Signals Openness to Gaza Ceasefire Deal as Pressure Mounts Over Hostage Crisis



In a notable shift in Israel's approach to the Gaza conflict, Prime Minister Benjamin Netanyahu has indicated that his government is now open to a potential agreement with Hamas to "end the fighting." The announcement comes amid growing domestic and international pressure to secure the release of Israeli hostages held in Gaza.

According to a statement from the Prime Minister's Office (PMO), Israel's negotiation team in Doha is actively exploring every avenue for a deal. This includes considering a proposal by U.S. special envoy Steve Witkoff, which outlines two options: a limited exchange involving some hostages and a temporary ceasefire, or a broader agreement that could end the war entirely.

The more comprehensive option would require Hamas to release all remaining hostages, surrender its operatives, and agree to disarmament. "Even at this very moment, the negotiation team in Doha is working to exhaust every possibility for a deal — whether according to the Witkoff framework or as part of ending the fighting," the PMO stated

Currently, Israel estimates that 58 hostages are still being held in Gaza, with only 23 believed to be alive. The shift in tone from Netanyahu's government is significant, as it has previously insisted that military operations in Gaza would not cease until Hamas is fully dismantled.

In parallel, Hamas has stated that it will not release hostages unless Israel agrees to a complete ceasefire. Mediators from Egypt and Qatar, supported by the United States, resumed indirect ceasefire talks over the weekend.

Further complicating the situation are reports—unconfirmed by both sides—that Hamas leader Mohammed Sinwar may have been killed in an Israeli airstrike. Meanwhile, the Israeli military continues its operations in Gaza, with recent overnight strikes reportedly killing at least 100 Palestinians in anticipation of a new ground offensive.

Back home, Netanyahu is facing increasing criticism. Einav Zangauker, mother of hostage Matan Zangauker, accused the Prime Minister of placing political interests above the lives of hostages. "The government still insists on only partial deals. They are deliberately tormenting us," she said in a social media post, echoing a sentiment shared by many frustrated Israeli families.

#### Pakistan Announces Peace Delegation Led by Bilawal Bhutto Zardari Following India's Diplomatic Push

In an apparent response to India's recent diplomatic initiatives, Pakistan has announced a delegation led by Bilawal Bhutto Zardari to advocate for peace on the global stage. This move follows India's extensive diplomatic outreach, where New Delhi sent seven multi-party delegations to various international forums to highlight the success of Operation Sindoor and its commitment to combating cross-border terrorism.

On Saturday, Bilawal Bhutto Zardari, chairman of the Pakistan People's Party (PPP), revealed that Prime Minister Shehbaz Sharif had appointed him to lead the peace delegation. Zardari emphasized that the delegation's goal was to present Pakistan's stance on the growing tensions between India and Pakistan, particularly in the aftermath of Operation Sindoor.

The operation, launched by India on May 7, targeted terrorist infrastructure across Pakistan and Pakistan-occupied Kashmir (PoK), resulting in over 100 terrorist casualties. India's subsequent military actions, including cross-border shelling and airstrikes, intensified tensions between the two nations, leading to calls for global attention on Pakistan's alleged support for terrorism.

Pakistan's decision to send Zardari as its representative is seen as a move to salvage its international reputation, which has been heavily criticized due to its historical ties with terrorist groups. Despite Pakistan's intentions, the delegation faces an uphill battle in convincing the global community, given the ongoing international concerns about Pakistan's role in cross-border terrorism. Meanwhile, India's Union Minister Kiren Rijiju announced that the seven multi-party delegations would visit key partner countries, including members of the UN Security Council, to present India's united front on its stance against terrorism. The delegations, which include prominent Indian politicians such as Shashi Tharoor and Ravi Shankar Prasad, aim to communicate India's zero-tolerance approach to terrorism and project national unity in the face of growing security challenges.

The rise marks a strong rebound in the domestic bullion market even as international gold prices showed signs of weakening.Gold of 99.9% purity climbed to ₹96,450 per 10 grams, while 99.5% pure gold settled at ₹96,000, both inclusive of all applicable taxes. This represents a steep gain from Thursday's closing prices of ₹95,050 and ₹94,600, respectively. Silver also followed suit, appreciating by ₹1,000 to reach ₹98,000 per kilogram, up from ₹97,000 in the previous session.

However, the domestic rally came in contrast to a decline in global gold prices. Spot gold in international markets dropped by USD 50.85, or around 1.57%, to USD 3,189.25 per ounce. The pullback was attributed to market reactions surrounding anticipated trade agreements between the United States and key economic partners, including the United Kingdom and China.

Jateen Trivedi, Vice President – Research Analyst for Commodity and Currency at LKP Securities, noted that global gold prices remained volatile around the USD 3,200 mark. He pointed out that the lack of a dovish stance from the US Federal Reserve, particularly in terms of delaying any immediate interest rate cuts, has capped global bullion buying momentum.Kaynat Chainwala, AVP of Commodity Research at Kotak Securities, highlighted that investors are now awaiting fresh macroeconomic cues from the US. Key data expected includes housing market statistics and the preliminary University of Michigan's Consumer Sentiment and Inflation Expectations reports for May. Additionally, comments from Federal Open Market Committee (FOMC) member Mary Daly later in the day are likely to influence market sentiment.

Analysts believe that these data points and the Fed's tone will offer clearer direction for the interest rate outlook and may impact global gold prices in the coming sessions. For now, however, Indian bullion markets remain buoyant on the back of strong local demand.

#### India limits 42% of imports from Bangladesh, targeting \$770 million in goods

India has introduced fresh restrictions on imports from Bangladesh through land ports, significantly affecting goods worth around USD 770 million—approximately 42% of the total bilateral imports between the two nations. The move, announced by the Union Ministry of Commerce and Industry on Saturday, comes under directives from the Directorate General of Foreign Trade (DGFT).

According to the Global Trade Research Initiative (GTRI), the new policy restricts several major Bangladeshi export categories such as readymade garments, processed foods, and plastic items from entering India via traditional land routes. Instead, many of these goods are now limited to specific sea ports or, in some cases, face outright import bans through landbased entry points.

One of the most heavily impacted sectors is the garment industry. Bangladeshi apparel exports to India, which are valued at approximately USD 618 million annually, will now be restricted to entry through only two designated seaports—Kolkata and Nhava Sheva. This effectively blocks access through several previously active land ports along the India-Bangladesh border, including those in West Bengal, Assam, and Tripura.

Trade analysts believe the move will severely disrupt Bangladesh's garment supply chain into India, raising logistics costs and delivery times. The policy could also affect small and medium exporters who rely on cross-border trade through land ports due to their cost efficiency and proximity.

Besides garments, exports of pro-



cessed food items and plastic goods from Bangladesh will also face similar limitations. These restrictions are expected to impact a wide range of small-scale Bangladeshi businesses that have built trade linkages with Indian importers through overland channels.

While the Indian government has not officially stated the reason behind the move, experts suggest it may be aimed at improving regulatory oversight, quality control, and customs procedures by consolidating imports through major ports.

However, this development could strain trade relations between the two countries and is likely to trigger discussions at the diplomatic level. Trade bodies on both sides are expected to seek clarification or request a review of the policy in the coming days.

# Over 30,000 Ancient Roman Coins Found Off Sardinia Coast, Indicates Hidden Shipwreck

In a stunning archaeological find, over 30,000 ancient Roman bronze coins have been recovered from the waters off the coast of Sardinia, Italy, near the town of Arzachena. The discovery was made after a diver spotted unusual metallic objects in shallow water, prompting an official investigation by Italy's Culture Ministry.

The coins, known as follis, date back to between 324 and 340 CE and were first introduced during the reign of Roman Emperor Diocletian. These coins were also used later during the Byzantine era. The Culture Ministry noted that although more than 30,000 coins have already been found, the total number could be as high as 50,000, as the process of sorting and cataloging them continues.

A team comprising divers from the ministry's underwater archaeology department and an art protection squad was deployed to the site. The coins were discovered near the northeast shore of Sardinia, a region rich in maritime history. Remarkably, most of the coins are in exceptional condition, with even the few damaged pieces retaining clearly legible inscriptions.

Experts believe the find points to the likely presence of a sunken Roman ship, as the coins were located in a compact area often associated with ancient shipwrecks. This theory is being supported by further investigation into the surrounding seabed. Luigi La Rocca, Director General of Archaeology, Fine



sized the significance of the discovery. "The treasure found in the waters of Arzachena represents one of the most important numismatic finds in recent years," he said. La Rocca also highlighted the vulnerability of such underwater sites, which are constantly at risk from both natural elements and human interference.

# **UK Man Sets** World **Record with 667 Tattoos** of Daughter's Name



Speaking about the experience, Evans recalled, "It felt weird—because there were two tattooists doing it at the same time, the pain was kind of cancelled out." Despite the unusual nature of his achievement, he takes pride in what he calls a "living tribute."

"I love that I'm literally wearing my record and it goes everywhere with me," he said. For Evans, this remarkable display of dedication is both a personal celebration and a lasting symbol of paternal love.





# A Cup Final 2025: Crystal Palace Stuns **Manchester City with Historic 1-0 Victory**

In a stunning upset at Wemblev Stadium, Crystal Palace defeated Manchester City 1-0 on May 17, 2025, to win the FA Cup for the first time in the club's history. Eberechi Eze's decisive first-half goal etched Palace's name into football folklore and ended City's season without silverware for the first time in eight years.

The result ranks among the biggest FA Cup shocks, reminiscent of Wigan's 2013 win over City and Wimbledon's 1988 upset against Liverpool. For Palace, the victory marks a moment of redemption after losing their two previous FA Cup finals in 1990 and 2016, both to Manchester United.

For Pep Guardiola's City, it was the latest blow in a disappointing campaign. After four consecutive Premier League titles, the team surrendered their domestic crown, crashed out of the Champions League playoffs, and now lost the FA Cup final for the second year in a row. With only two league games remaining, City is still fighting to secure a top-five finish to qualify for next season's Champions League.

While City's focus now shifts to the Club World Cup, it's Palace celebrating a landmark moment—one that will be remembered for years as a symbol of resilience, belief, and a truly historic triumph.



#### **Sporting Lisbon Clinch Primeira Liga Title on Final Day with 2-0 Win Over Guimaraes**

Sporting Lisbon successfully defended their Primeira Liga title on the final day of the Portuguese season, securing a 2-0 win over Vitoria Guimaraes on Saturday to edge out rivals Benfica in a thrilling conclusion to the campaign.

Heading into the final round, both Sporting and Benfica were level on points, with last weekend's tense 1-1 Lisbon derby draw leaving the championship race finely balanced. Benfica needed to better Sporting's result to claim the title but could only manage a 1-1 draw at Braga. Even a victory wouldn't have been enough, as Sporting held the superior head-to-head record.

In front of a packed Estádio José Alvalade, Pedro Goncalves opened the scoring in the second half to calm nerves. Shortly after, Viktor Gyökeres, the league's standout striker, sealed the win with his 39th goal of the season, capping off a sensational individual

The triumph marks Sporting's 21st top-flight title and further solidifies their resurgence as a dominant force in Portuguese football. It also sets the stage for a potential domestic double, with Sporting set to face Benfica once again next Sunday in the Portuguese Cup final.

The journey to the title was not without turbulence. After winning the league last season under Ruben Amorim, the coach left in November for Manchester United. His replacement, Joao Pereira, lasted just six weeks in a rocky spell before the club turned to Rui Borges. Under Borges, Sporting stabilized and regained momentum, showing resilience and consistency when it mattered most.

Benfica, despite a strong run-in, fell short again and will now pin their hopes on salvaging silverware in the upcoming cup final.

Sporting's latest triumph is a testament to their squad depth, tactical discipline, and the scoring brilliance of Gyökeres, who has firmly established himself as one of Europe's most prolific forwards this season. As celebrations erupt in Lisbon, the club now turns its attention to completing the season with a historic double.

#### **PSG's European Glory Masks Deep Crisis in French Football**

Paris Saint-Germain's march to the UEFA Champions League final should be a moment of celebration for French football. However, their success only serves to highlight the wider struggles plaguing the domestic game, as the 2024–25 Ligue 1 season comes to a close.

While PSG have once again dominated domestically—claiming their fourth consecutive league title and poised for a French Cup final—the rest of French football is grappling with financial instability, underachievement in Europe, and a crumbling television rights


PSG, backed by Qatari wealth, are aiming to become just the second French club to win Europe's premier club competition, following Marseille's triumph in 1993. Despite France's strong international presence—winning the FIFA World Cup twice—its clubs have consistently underperformed in Europe. The country's tally of European Cup wins remains on par with Scotland and Romania, and below that of Nottingham Forest.

There is a rare unity among rival fans and coaches supporting PSG in their final clash against Inter Milan on May 31. "I support Nice, not Paris," said Nice coach Franck Haise. "But I want PSG to win because I'm French—just like when Marseille won in 1993."

Yet, behind the scenes, cracks are growing. One of France's biggest clubs, Lyon, is drowning in debt. With financial losses reaching €540 million, the club faces UEFA sanctions and potential relegation to Ligue 2 unless urgent fiscal reforms are implemented. Their failure to qualify for European competitions only compounds the problem.

Meanwhile, Ligue 1's television rights crisis remains unresolved. A last-minute deal with streaming platform DAZN guaranteed just €400 million annually—far below the league's €1 billion target. With the agreement likely to collapse early, the French league is now considering launching its own channel to manage broadcasts.

In stark contrast, the Premier League's domestic rights are valued at over €2 billion per season, underscoring the growing disparity. PSG's financial firepower and potential Club World Cup earnings up to \$125 million for the winner—further distance them from domestic rivals. Unless structural reforms take place, PSG's dominance may become even more unassailable in the seasons to come.





#### Harpreet Brar, Nehal Wadhera **Shine As PBKS Inch Towards Playoff Berth With Win Over RR**

Punjab Kings inched closer to securing a playoff berth with a thrilling 10-run win over Rajasthan Royals in a high-scoring encounter at the Sawai Mansingh Stadium on Sunday. 

#### **Tollywood Faces Crisis: Theatre Shutdown Likely From June 1 Over Revenue Model Dispute**

Tollywood may be heading towards a major crisis, as theatre exhibitors from Andhra Pradesh and Telangana have proposed a complete shutdown of single-screen theatres starting June 1, in protest against the current rental-based revenue system.

In a high-stakes joint meeting held earlier today, over 60 exhibitors, including industry veterans Dil Raju and Suresh Babu, discussed their growing dissatisfaction with the flat rental model. Instead, they are pushing for a percentage-based revenue sharing model, which they argue is more sustainable and equitable, especially for single-screen operators who face declining footfalls and rising maintenance costs.

According to insiders, the majority of exhibitors present agreed to pursue the new model, demonstrating a rare show of unity across the sector. However, the meeting saw a noticeable absence of several top producers and distributors, fueling speculation that many are not on board with the proposed changes. Producers fear that a percentage model could significantly cut into their profits, especially for big-budget

The exhibitors plan to submit a formal bandh notice along with a written request to initiate dialogue with other stakeholders. If unresolved, the move could severely disrupt several high-profile June releases.

The first major film likely to be affected is Kamal Haasan's "Thug Life", especially its Telugu dubbed version, which may not find screens in Telugu states if the bandh goes ahead. Multiplex chains not aligned with the exhibitor association might still screen it, but coverage could be limited.

More critical is the potential impact on Pawan Kalyan's much-awaited "Hari Hara Veera Mallu", scheduled for release on June 12. With substantial investments and distribution advances at stake, any halt in screenings could lead to serious financial losses and contractual disputes.

With nearly two weeks remaining before the proposed shutdown, industry leaders and senior producers are expected to intervene and try to broker a compromise. A quick and balanced resolution is crucial to avoid a full-blown industry standoff.
