LG Electronics to Set Up Huge **Unit in Sri City**

- **Foundation Stone to** Be Laid by Minister Lokesh on May 8
- **LG Electronics to** invest Rs. 5,001 crore in phases over six years


Inasignificantmovetowards industrial development and employment generation in the state, LG Electronics will set up a massive unit in Sri City near Tirupati. The foundation stone for this state-of-the-art manufacturing plant will be laid by Andhra Pradesh State IT, Electronics, and Education Minister Nara Lokesh on May 8.

The investment, which will total Rs. 5,001 crore over the next six years, is expected to create around 2,000 direct jobs. LG plans to manufacture a wide range of products, including refrigerators, washing machines, air conditioners, high-end other electronic devices at the new facility. Additionally, essential components such as compressors, motor compressors, and heat exchangers will also be produced in Andhra Pradesh to meet the demands of the manufacturing process.

Apart from the main unit, LG has also planned to establish five subsidiary units at an investment of Rs. 839 crore. These subsidiary units will be set up within the same time frame, significantly boosting the state's industrial landscape. This project is a direct result of Minister Nara efforts Lokesh's promote Andhra Pradesh as a hub for electronics manufacturing. Last year, he met with a delegation from LG and highlighted the investor-friendly policies in the state, including the government's focus on developing Rayalaseema as an electronics hub.

AP Releases New Electronics Policy for Major Manufacturing Push

The Andhra Pradesh government has unveiled a new electronics manufacturing policy aimed at boosting the sector's growth in the state. The government has set an ambitious target of achieving Rs. 4.2 lakh crore in electronics production and attracting \$10 billion in investments over the coming years.

The new policy offers a range of incentives for electronics manufacturing units, including 100% stamp duty exemption and financial support for each employee appointed in the industry. Under this initiative, companies will receive monthly incentives ranging from Rs. 4,000 to Rs. 6,000 for each employee for up to five years. One of the key highlights of the policy is in the national and global electronics the provision of subsidized electricity to manufacturing industry.

electronics industries. The government has announced that for the next five years, a unit of electricity will be supplied at just Rs. 1, which is expected to provide a significant boost to industrial operations.

The government also pointed out that the state is well-positioned to attract investments, citing existing electronic clusters in regions like Visakhapatnam, Tirupati, Sri City, and others. With a skilled workforce, government-friendly policies, and improved logistics networks, Andhra Pradesh is set to become a key hub in the electronics manufacturing sector.

With these strategic measures, the government hopes to create substantial employment opportunities for the youth and position the state as a leading player

Nationwide Mock Drill Today

- · Centre initiates drills to prepare citizens for emergency scenarios

In response to heightened tensions with Pakistan following the recent Pahalgam terror attack, the Union Government has ordered a nationwide civil defence mock drill to be conducted today, May 7 (Wednesday). The Ministry of Home Affairs has issued directives to all states and union territories to carry out these drills with full seriousness, aiming to increase public preparedness in the event of a surprise enemy attack.

The core objective of this civil defence mock drill is to create awareness and train citizens, students, and local authorities in emergency response, including evacuation, self-protection, and infrastructure safeguarding. Officials said this is part of a broader effort to ensure the country is not caught unprepared in case of external aggression. What the drill involves:

The exercise will simulate war-like scenarios, starting with the sounding of air raid warning sirens. States have been instructed to activate emergency hotline and radio communication systems linked to the Indian Air Force, establish operational control rooms and auxiliary shadow control rooms, and review their overall emergency coordination systems.

The drills will also include training civilians and students in basic self-defense and emergency response, conducting 'crash blackouts' to shut down power supply in sensitive zones, camouflaging important installations to protect them from aerial detection, cleaning and readying existing bunkers and trenches, and reviewing and rehearsing evacuation plans for high-risk areas. These activities are designed to ensure that communities are well-prepared and can respond effectively in case of emergencies.

Authorities stressed that these measures are preventive and educational, aiming to instill confidence and readiness among the public. With tensions simmering and the threat of retaliation looming large, today's mock drills are a significant step in India's civil defence preparedness strategy.

Sajjala Family Land **Grab Confirmed**

- Inquiry finds 63.72 acres illegally occupied in YSR district
- 52.40 acres of forest land encroached by Sajjala family

The allegations of land grabbing against the family of former government advisor and YSRCP leader Sajjala Ramakrishna Reddy have been confirmed. A threemember inquiry committee appointed by the government

has submitted its report stating that Sajjala's family encroached a total of 63.72 acres of land, including a significant portion of forest land, in CK Dinne village of YSR district. According to the committee, the Sajjala family encroached 52.40 acres of forest land spread across eight locations in survey number 1629. Apart from that, 8.05 acres of government land previously acquired for the Payavanka reservoir and assigned lands were also found to be under



their illegal possession. The family constructed a guest house and four additional rooms on the encroached land without any official permissions. The report also revealed that the Sajjala family, particularly Sajjala Sandeep Reddy (Sajjala's elder son) and six other members, cultivated mango orchards on the forest land after clearing trees and disrupting the local ecosystem.

Moreover, they reportedly availed subsidies under government agriculture schemes for drip irrigation systems and infrastructure, further deepening the illegality.

The matter had earlier come to light through complaints made by local resident Raja Nayak since 2022, but no action was taken during the previous government's tenure. After a change in government, the inquiry was initiated, although Sandeep Reddy and others challenged it in the High Court, claiming possession of 184.32 acres. The court, however, allowed the inquiry to continue while ordering a status quo.

The detailed survey conducted in February and March under the supervision of the YSR District Collector, Kadapa RDO, Land Records Assistant Director, and Badvel Sub-Divisional Forest Officer revealed that the family was in possession of 201.17 acres, though they legally owned only 137.45 acres. The rest—63.72 acres—

was declared as illegally occupied. Interestingly, the committee noted that forest officials had already issued notices to the family back in 2014 regarding the encroachments. The recent findings have reignited concerns over political misuse of forest land and government resources. The committee strongly recommended Forest Department the immediately recover the 52.40 acres of forest land and reinforce protection to prevent further encroachments. It also urged the government to initiate strict action against the Sajjala family under applicable forest and environmental laws. Further developments are awaited as the government examines the report.

The government's swift approval process, which granted all necessary permissions and subsidies in just five months, played a pivotal role in LG's decision to invest in the state.

Additional Paddy Procurement Approved in WG, Eluru

In a major relief to farmers affected by unseasonal rains, State Food and Civil Supplies Minister Nadendla Manohar on Tuesday assured that the government will stand by every farmer and take up additional procurement of paddy beyond the targeted limits in West Godavari and Eluru dis-

Speaking after a high-level review meeting with public representatives, district collectors, and rice millers at the Bhimavaram Collectorate's Vasishtha Conference Hall, the minister said: "Farmers need not worry. The government is with you. We will do justice to every farmer who has suffered losses due to untimely rains."

In response to requests from district officials and MLAs, the government has granted permis-



lakh metric tonnes of paddy for West Godavari and 50,000 metric tonnes for Eluru. This decision comes after farmers raised concerns over soaked paddy due to recent rains and expressed fear over delays in procurement.

West Godavari Joint Collector T. Rahul Kumar Reddy stated that out of the 6 lakh metric tonnes target, 4.88 lakh tonnes have already been procured, with cash payments being made within 24 hours. He also mentioned the need for 30 lakh more bags to continue the process smoothly. Eluru Joint Collector P. Dhatri Reddy added that out of a target of 3.53 lakh metric tonnes, 2.20 lakh tonnes have been collected so far, with ₹487 crore credited to farmers' accounts.

Minister Manohar highlighted that the present government has achieved record procurement by

sion to procure an additional 1 buying 48.90 lakh metric tonnes of paddy and depositing ₹11,400 crore into farmers' accounts—far exceeding the previous government's 37 lakh MT mark. He also stated that the current administration has cleared ₹1,574 crore in pending dues left by the earlier regime.

> In addition to procurement, the government is set to distribute tarpaulins worth ₹50 crore to farmers at a 50% subsidy through the Food Corporation of India (FCI). The minister assured that there would be no shortage of gunny bags and directed that sugarcane bags be made available at Rythu Seva Kendras, with swift action on vehicle permits.

> Civil Supplies Corporation MD Dr. Manazir Jilani Samul said the procurement system would be further streamlined and millers would be held accountable under a 1:2 guarantee ratio.

Action Plan to Control Road Accidents in Eluru

State Housing, Information, and Public Relations Minister Kolusu Parthasarathy has directed officials to develop an action plan to address the growing number of road accidents, particularly on the national highway in Eluru district. During a District Road Safety Committee meeting at the Gautami Conference Hall, Minister Parthasarathy emphasized the need to control unauthorized dabas and hotels along the highway, which contribute to accidents due to heavy vehicle parking and speeding.

The Minister also highlighted the importance of constant highway patrolling, enhanced lighting in accident-prone areas, and the creation of service roads along the Kalaparru to Gundugolanu stretch. Furthermore, he called for the identification of black spots—locations with a high frequency of accidents—and swift

measures to prevent further incidents. Minister Parthasarathy proposed the establishment of safety committee meetings at both the district and constituency levels, as well as awareness programs on road safety, helmet usage, and other precautions at the mandal level in every college. Eluru MP Putta Mahesh Kumar urged coordination among district authorities to curb accidents, while Denduluru MLA Chintamaneni Prabhakar stressed the need for service roads and foot over bridges, especially near schools, to improve pedestrian safety.

The meeting also discussed the poor maintenance of garden dividers by contractors along the national highway. District officials, including Collector K. Vetriselvi, SP K. Pratap Shiva Kishore, and various department heads, participated in the meeting and pledged to take immediate action to improve road safety measures across the district.

Visakhapatnam Metro Rail **Project Gaining Traction**

The Andhra Pradesh government is making swift progress on the Visakhapatnam Metro Rail Project as part of its efforts to improve urban transport infrastructure. The Andhra Pradesh Metro Rail Corporation Limited (APMRCL) has invited tenders for the selection of a consultancy that will oversee the planning, tendering process, supervision, and successful completion of the project.

A pre-bid meeting was organized by APMRCL, which saw active participation from 28 representatives of domestic and foreign consultancies. While 14 representatives attended the meeting in person, 8 others joined virtually. This marks a crucial step in moving the project forward, with the selection of the consultancy being a key milestone. The tenders will be opened on June 9, with the chosen consultancy expected to drive the planning and execution phases of the metro project. Fraud Allegations in My3Ads Scheme

- Victims from Veeravalli cheated in Zinsta Marketing's My3Ads scheme
- · Each invested ₹1.5 lakh; company failed to pay returns for over two years

A major financial fraud has come to light in Vijayawada involving the My3Ads scheme operated by Zinsta Marketing Company, based on Shivalayam Street, Enikepadu. Victims from Veeravalli village in Bapulapadu mandal, Krishna district, have alleged that they were duped by the company, which promised to double their investments but failed to return the money even after two years.

According to the complaint filed at the Public Complaints Forum in the Vijayawada Police Commissionerate and Patamata Police Station, each of the three victims invested ₹1.5 lakh, lured by promises

of lucrative returns. The scheme initially required a monthly deposit of ₹12,000, but even after regular payments, no returns were issued.

One of the victims, Dindi Subbarao, an auto driver by profession, revealed that he invested ₹3.66 lakh in total through accounts in the names of his wife Dindi Rangamma and his mother-in-law Reddy Ramanamma. "We trusted the company to help us save money for our children's education. Now we're left with nothing," Subbarao said tearfully.

He added that for the past six months, the company had been falsely assuring that the payments would be credited soon. Frustrated by continuous delays and lack of response, the victims approached the police and demanded immediate action. They also urged the state government to intervene, fearing that hundreds more across the state may have fallen into the same trap.

The police have taken up the complaint and have initiated a preliminary investigation into the alleged scam. The victims appealed for swift justice and requested that the culprits behind the fraudulent scheme be brought to justice to prevent further exploitation of innocent people.

Gali Janardhan Reddy Gets 7 Years Jail

CBI court convicts 5 in Obulapuram mining case after 15-year trial

- Gali Janardhan Reddy, OMC MD and 3 others sentenced
- Sabitha Indra Reddy, Kripanandam acquitted of all charges

The CBI Special Court in Nampally has pronounced its final verdict in the sensational Obulapuram Mining Company (OMC) case, convicting former Karnataka minister and mining baron Gali Janardhan Reddy and four others. The judgment comes after a 15-year-long trial that had deep political and bureaucratic ramifi-

The court sentenced Gali Janard-



han Reddy (A2), BV Srinivasa Reddy (OMC Managing Director - A1), his personal assistant K. Mefaz Ali Khan (A7), former Andhra Pradesh Mines Director VD Rajagopal (A3), and the OMC company itself (A4) to seven years of imprisonment each. All were found guilty of serious irregularities and criminal conspiracy in illegal mining operations.

However, the court acquitted former united Andhra Pradesh Mines Minister Sabitha Indra Reddy (A9) and former Industries Secretary Kripanandam (A8), stating that the prosecution had failed to prove the charges against them beyond reasonable doubt. This verdict provides significant relief to the two former bureaucrats and political leaders.

The case, which revolves around large-scale illegal mining activities by OMC in Anantapur district and allegations of government officials colluding with the company, has been under investigation since 2009. Forest officer Linga Reddy (A5), another accused in the case, passed away during the course of the trial. Additionally, senior IAS officer Y. Srilakshmi (A6) was discharged from the case by the Telangana High Court in 2022.

The verdict is being viewed as a major milestone in the fight against corruption in the mining sector. Legal experts say the conviction of influential individuals including a former minister, bureaucrats, and corporate executives underscores the significance of judicial accountability in long-pending corruption cases. The court is expected to issue de-

tailed orders regarding fines and further procedural directions in the coming days. The convicted individuals are likely to approach higher courts for appeals against the sentencing.

Sharmila Goes on Hunger Strike in Support of Visakha Steel Plant Workers

In a strong show of solidarity with the workers of the Visakha Steel Plant, APCC Chief YS Sharmila Reddy has announced her decision to go on a hunger strike starting on the 21st of May. The hunger strike is in support of the workers' ongoing agitation that began on the 20th of this month, demanding the immediate reinstatement of 2,000 dismissed contract workers.

Speaking on the issue, Sharmila Reddy condemned the attempts at privatizing the plant, claiming it was part of a conspiracy to benefit corporate entities like Adani. She highlighted the long-standing challenges faced by the steel plant under the current BJP-led government, accusing them of intentionally weakening the plant to facilitate its privatization.

She also raised concerns over the dismissal of workers and the mounting financial difficulties faced by the plant. "The workers have not been paid their pending salaries, and yet the government boasts of financial assistance while taking back the funds through loans," Reddy said.

The hunger strike comes as the workers' fight for justice has now entered its 1545th day, with no resolution in sight. Sharmila Reddy vowed to risk her life to save the plant, emphasizing that Congress would not tolerate the privatization of what she called "the pride of Andhras."

The Congress party's firm stance against the privatization of Visakha Steel Plant and their full support for the workers' strike sets the stage for further escalations. The issue has become a flashpoint for the Congress party, which has promised to intensify its efforts until the workers are reinstated and their demands addressed.

TDP Senior Leader Sugavasi Palakonda Rayudu Passes Away

Senior Telugu Desam Party (TDP) leader, former MP and former MLA Sugavasi Palakonda Rayudu passed away at the age of 80 in Rayachoti. He had been battling health issues and was recently admitted to a private hospital in Bengaluru, where he breathed his last at 3 AM on Tuesday.

Sugavasi Palakonda Rayudu had a long and impactful political career. He was elected as Rayachoti MLA four times and as Rajampet MP once. His journey began in 1978 when he won from Rayachoti as a Janata Party candidate. In 1983, he contested independently and retained the seat. He joined the Telugu Desam Party and went on to win the Rajampet Lok Sabha seat in 1984. He was later elected as a TDP MLA from Rayachoti in the 1999 and 2004 elections.

Rayudu is survived by his wife, two sons, and a daughter. His elder son, Sugavasi Balasubramaniam, has continued in politics and



contested from the Rajampet Assembly seat in the 2024 elections but lost. His younger son, Prasada Babu, served on the TTD board. Though Palakondrayudu had distanced himself from active politics in recent years, his contributions remained deeply respected.

Forensic Evidence Crucial in Criminal Investigations



He asserted that the previous YSRCP government signed a power purchase agreement at ₹5.12 per unit, while the current TDP government renegotiated the deal and brought it down to ₹4.60 per unit, resulting in a savings of ₹2,719 crore for the state.

Speaking at a press meet at the TDP central office, Pattabhiram alleged that YSRCP leaders were deliberately misleading the public to divert attention from their own scams. He said. "Is saving public money a crime in Jagan's eyes? What kind of mind does Jagan Reddy have if he opposes a transparent deal that saves thousands of crores?" He accused Jagan of peddling lies through what he called the "Pakodi channel" and handpicked media pamphlets.

Pattabhiram claimed that all YSRCP leaders involved in scams would eventually end up in jail and sarcastically remarked that they could soon have joyful conversations in prison together. He also clarified that all decisions related to power purchases are made only based on the guidelines and approvals of the Andhra Pradesh Electricity Reg-



ulatory Commission (APERC). He reminded that the previous YSRCP regime had issued a Government Order to cancel existing PPAs, which led to companies approaching the courts. Eventually, in August 2022, the YCP government filed an affidavit in the High Court agreeing to continue with the old agreements, and in November, they signed the Access PPA at ₹5.12 as per the rate fixed by APERC.

Refuting the YSRCP's accusation that the current PPA was overpriced, Pattabhiram pointed out that the current agreement is cheaper than both the earlier deal and market rates for firm and dispatchable renewable energy projects. He emphasized that APERC clearly stated battery

storage costs were to be borne by the developer, not the government.

He further criticized the YSRCP for earlier purchases at exorbitant rates—up to ₹11.78 per unit during peak evening hours and an average of ₹9.30 in 2022-23. "How can it be wrong now when we're purchasing at ₹4.60?" he asked, adding that TDP's only agenda is to ensure governance that eases the burden on the people.

Pattabhiram concluded that Chandrababu Naidu's leadership is focused solely on the welfare and economic stability of the state and accused YSRCP of trying to hide their failures with baseless allegations.

Vamsi Faces Another Setback as Remand Extended Again

Court rejects bail plea in kidnapping case Vamsi's remand extended till May 13 in Satyavardhan case

Former MLA and YSRCP leader Vallabhaneni Vamsi Mohan continues to face legal troubles as the Vijayawada court has once again extended his judicial remand in the high-profile Satyavardhan kidnapping case. The remand of Vamsi, along with other accused in the case, has been extended till May 13, 2025. The court also rejected Vamsi's bail petition, dealing another blow to the embattled leader. Vamsi, who was arrested on February 13 this year, has been named the prime accused (A1) in the case. According to police, a case was registered against him based on a complaint from M. Satyavardhan, a Dalit youth and former computer operator. The complaint alleges that Vamsi, along with his followers, kidnapped, threatened, and attempted to extort the victim following the violent attack on the TDP office in Gannavaram in 2023. Police investigations revealed that during the course of the abduction, the victim was taken across cities — from Hyderabad to Visakhapatnam. SCR Cracks Down on Unauthorized Vendors at Vijayawada Station



TPN Correspondent | Vijayawada In a decisive move to curb unauthorized vending and improve passenger safety, the South Central Railway (SCR) Vigilance Department, in coordination with the Railway Protection Force (RPF), conducted a special inspection at Vijayawada Railway Station on May 5, 2025. The operation targeted unlicensed vendors operating without valid permissions on the station premises. The inspection, carried out during peak evening hours for maximum visibility and effectiveness, aimed to reduce congestion, uphold hygiene standards, and enhance overall station efficiency. Unauthorized vending not only causes obstruction on platforms but also compromises the safety and service quality

for commuters.

During the drive, vendor credentials such as identity cards and stall permits were thoroughly verified. So far, fines amounting to ₹4.65 lakh have been collected from violators.

Green signal given for Rs 50 crore road over bridge project

Union Minister Rammohan Naidu has successfully secured approval for the construction of a road over bridge (ROB) at Talabadra on the Visakhapatnam-Bhubaneswar railway line, addressing long-standing traffic issues faced by the residents of Talabadra, near Palasa town in Srikakulam district. The project, estimated at Rs 50 crore, aims to replace the existing Talabadra railway gate, which has been a major traffic bottleneck for years.

The project was initially planned with a 50:50 funding share from the central and state governments, but delays in fund allocation over the past five years had stalled progress. Minister Rammohan Naidu took a proactive approach by meeting Railway Minister Ashwini Vaishnav to present the situation and secure 100% Railway funding for the construction of the overbridge. This effort mirrors his previous success in getting the AMB (Approach Motor Bridge) at Palasa Chinnabadam funded entirely by the Railways.

The Railway Department has now taken responsibility for the Talabadra ROB as well, with the General Arrangement Drawing (GAD) and detailed estimates already approved. According to Railway General Manager Parameshwar Funkwal, the project will soon move to the tender stage. Once completed, the two overbridges—at Talabadra and Palasa—will significantly ease the traffic congestion in the region, providing smoother travel for the locals.

Residents of Palasa and Talabadra have expressed their gratitude for Union Minister Rammohan Naidu's dedicated efforts, viewing the two upcoming bridges as a substantial improvement to the city's infrastructure.



Al's Growing Energy Footprint: Can Nuclear Power Offer a Sustainable Future?



The rise of generative AI has revolutionized creativity and productivity — from producing Studio Ghibli-style portraits in seconds to automating complex writing tasks. But beneath this technological convenience lies a rapidly growing energy crisis. Every prompt submitted to tools like ChatGPT draws power from massive data centres, and the environmental toll of this energy consumption is becoming increasingly unsustainable.

Sam Altman, CEO of OpenAI, recently highlighted the strain, tweeting, "It's super fun seeing people love images in ChatGPT, but our GPUs are melting." His remark isn't hyperbole — it reflects the staggering energy demands of AI systems operating at scale. Experts estimate that by 2030, data centres could consume up to 10% of global electricity, a significant leap from today's levels.

Currently, much of this energy is sourced from fossil fuels, which undermines global climate goals. While India, for now, has sufficient electricity generation to meet domestic AI needs, growing AI adoption and ambitions — especially in high-demand sectors like healthcare, finance, and governance — will require significant foresight and infrastructure adaptation. The question is no longer whether AI is sustainable, but how it can be made so.

This is where nuclear energy, particularly Small Modular Reactors (SMRs), comes into the conversation. SMRs are compact, scalable nuclear power plants that promise clean, consistent energy without the extensive footprint or cost of traditional nuclear facilities. Unlike solar and wind, which are intermittent, SMRs can provide stable, 24/7 pow-

er — a crucial feature for AI's non-stop operations.

SMRs could be strategically deployed near high-performance computing clusters or data centre hubs to reduce transmission losses and offer localized clean energy solutions. Their modular design allows for quicker deployment and more flexible integration into national grids.

However, integrating SMRs requires regulatory support, public acceptance, and significant investment. Still, as the global tech ecosystem leans harder into AI, nations must explore such bold solutions to reconcile innovation with environmental responsibility.

If the future is powered by AI, ensuring that it is also powered sustainably — perhaps even by nuclear — must become a central part of the conversation.

India's Chip Dreams on Hold: With Adani and Zoho Exits, Is SIP 2.0 Already Dead?

India's ambitious semiconductor manufacturing dreams appear to be faltering. In the past few days, two high-profile projects — the Adani Group's \$10 billion partnership with Israel's Tower Semiconductor and Zoho's \$700 million chip manufacturing venture — have been shelved. Both groups cited strategic and financial impracticalities, exposing the daunting realities of building a domestic chip industry.

These developments cast serious doubt on the future of India's ₹76,000 crore (\$10 billion) Semiconductors India Programme (SIP), launched in December 2021 to catalyse the country's entry into chip fabrication. So far, five projects have been approved under the SIP: three outsourced semiconductor assembly and test (OSAT) facilities and two fabTata Electronics (with a tie-up with Taiwan's Powerchip) and Micron. However, the budget for SIP has nearly been exhausted, and several pending applications now await a SIP 2.0 that may never come.

landscape is intensely competitive and capital-heavy. There are 438 chip fabs worldwide, with Japan, the US, China, and Taiwan dominating. Taiwan alone accounts for 60% of global chip production and 90% of advanced chips. India, by contrast, has only four fabs with minimal output and negligible global market share.

China's Shadow Over Vizhinjam: Strategic Port Raises Questions on Security and Sovereignty

Prime Minister Narendra Modi recently inaugurated the Vizhinjam International Seaport Limited (VISL), India's first fully automated deep-water transshipment port. Built at a cost of ₹8,867 crore, this strategically significant project is fully owned by the Kerala government and executed by Adani Ports and SEZ Ltd, with Union government support. Touted as a gateway to Kerala's economic transformation, Vizhinjam is already drawing attention—not just for its potential, but for the pronounced involvement of China.

All 32 automated cranes at the port, including ship-to-shore and yard cranes, were supplied by Shanghai Zhenhua Heavy Industries (ZPMC), a Chinese state-owned company. ZPMC also provided essential sub-systems like container management software and refrigeration units. Holding 70% of the global market share in quay cranes, ZPMC has long dominated the sector, despite allegations of intellectual property theft by competitors—claims even acknowledged by its founder.

The company's massive global footprint has grown under China's Belt and Road Initiative (BRI), and its presence now spans over 270 ports in 106 countries. However, concerns about surveillance and national security are growing. A 2023 U.S. Congressional probe found undocumented communication equipment in over 200 ZPMC cranes at American ports, raising fears of espionage or sabotage—though the company denied wrongdoing.

India's engagement with ZPMC has



been inconsistent. Though the government denied security clearance to a Chinese-led consortium for Vizhinjam in 2006 and placed restrictions on Chinese port involvement since 1997, over 250 ZPMC cranes were operational across Indian ports by 2020. The Vizhinjam procurement, initiated in 2018, preceded the Union government's 2020 restrictions on vendors from border-sharing nations, exempting it on a technicality.

Adding to the complexity is Kerala's vision of developing Vizhinjam along the lines of China's Shenzhen Special Development Zones, aiming to attract private and diaspora investments. This ideational inspiration, coupled with China's real-time industrial footprint, underscores Beijing's layered influence.

Vizhinjam's launch highlights the need for India to reassess its strategic posture—not just in safeguarding critical infrastructure but also in matching China's global economic leverage with robust domestic policy and competitive capacity.

Who Gets to Be 'Natural'? Questioning the **Fairness of Testosterone Bans in Sports**

The regulation of testosterone levels in competitive sports reveals deep inconsistencies in the way fairness is defined and enforced. While anti-doping policies claim to prevent artificial enhancement, female athletes with naturally high testosterone due to Differences in Sexual Development (DSD) are required to medically suppress their hormone levels to compete — a rule that forces them to alter their bodies, raising significant ethical and legal concerns.

The selective focus on testosterone overlooks other natural performance factors. In the landmark Dutee Chand case, the Court of Arbitration for Sport found insufficient evidence linking natural testosterone levels to an unfair advantage. Meanwhile, male athletes like Finnish skier Eero Mäntyranta and swimmer Michael Phelps have benefitted from unique biological traits — such as enhanced oxygen-carrying capacity and physical proportions — without facing similar scrutiny or exclusion.

Despite strict doping rules, athletes continue to exploit loopholes through microdosing and the abuse of Therapeutic Use Exemptions (TUEs). In contrast, DSD athletes face permanent bans unless they undergo invasive hormonal treatments. While banned athletes like Ben Johnson and Justin Gatlin have returned after serving suspensions for steroid use, women like Caster Semenya remain barred from competing in their natural



The discrimination is even more evident in how these rules apply. DSD regulations target only certain female athletes, particularly those with a 46 XY karyotype competing in specific track events. These athletes are singled out based on phenotype and perceived "masculinity," reflecting outdated and racially biased standards. Such policies violate basic principles of equality under instruments like Article 14 of the European Convention on Human Rights. A fair sporting system must move beyond arbitrary hormone thresholds and instead focus on comprehensive, science-based approaches to doping. Policymakers should differentiate between natural variation and artificial enhancement, avoid gender-biased enforcement, and ensure all athletes are treated equitably.

PM Modi cancelled Kashmir trip after intelligence report on possible terror attack: Mallikarjun Kharge

Congress President Mallikarjun Kharge has sparked a political firestorm with his explosive allegation that Prime Minister Narendra Modi cancelled a planned visit to Kashmir just three days before the April 22 Pahalgam terror attack, citing prior intelligence warnings. Addressing a 'Samvidhan Bachao' rally in Jharkhand, Kharge accused the government of failing to act on advance intelligence despite knowing about the potential threat.

"I have received information, and also read in a newspaper, that the PM received an intelligence alert three days before the attack and cancelled his Kashmir visit based on that," Kharge said. He questioned why the government did not take steps to protect civilians and tourists in the region if it had prior warnings.

The Pahalgam attack, which left 26 people dead, including tourists and a pony ride operator, has been described as one of the deadliest in Kashmir in recent decades. The Congress president slammed the government for what he called an intelligence failure, asking why preventive security measures weren't taken if threats were known in advance.

Despite the criticism, Kharge reaffirmed his party's support for the Centre in any firm response against Pakistan, which has been blamed for harbouring terrorist elements. "Whatever strong decision the government takes in the fight against terrorism, we will stand with it. National security is paramount, and everything else comes after that," he said, emphasizing the Congress's history of sacrifice for the nation.

In response, the Bharatiya Janata Party (BJP) lashed out at Kharge, calling his comments "treacherous" and accusing him of playing politics over a national tragedy. BJP leader CR Kesavan labelled Kharge a "modern-day Mir Jaffar", saying the Congress chief's remarks were "toxic, baseless, and unpardonable."



Gaganyaan Mission To Be Held In First Quarter Of 2027: ISRO Chief

India's ambitious maiden human spaceflight mission, Gaganyaan, has been officially pushed to the first quarter of 2027, marking a nearly five-year delay from its original 2022 launch target. The announcement was made by Indian Space Research Organisation (ISRO) Chairman V. Narayanan during a press conference ahead of the Global Space Exploration Conference (GLEX 2025) in Bengaluru.

The mission has seen multiple reschedules, with delays attributed to the COVID-19 pandemic, which hampered astronaut training, and the technological complexities involved in launching a human into space and returning them safely. Originally unveiled by Prime Minister Narendra Modi in 2018, Gaganyaan aims to send Indian astronauts into low-Earth orbit (LEO) at an altitude of 400 km for a few days.

Before the manned flight, ISRO will conduct three uncrewed missions, with the first expected later in 2025. These will test key systems, including the launch vehicle and spacecraft. A half-humanoid robot named Vyommitra will be part of these test missions, simulating human physiological conditions and system interactions onboard.

Narayanan emphasized the development of critical technologies for human spaceflight, particularly the Environment Control and Life Support System (ECLSS). This complex system is essential to maintaining cabin pressure, temperature, humidity, air quality, and hygiene during the astronauts' stay in space. He said, "Ninety percent of the ECLSS work is complete, and we are in the final qualification phase."



Air India Extends Suspension of Flights to Tel Aviv Until May 8

Air India has extended the suspension of its flights to and from Tel Aviv until May 8, following a missile attack near the airport in the Israeli city. Initially, the airline had decided to suspend services until May 6 after one of its flights from Delhi to Tel Aviv was diverted to Abu Dhabi due to safety concerns related to the missile strike.

Air India typically operates five weekly flights to Tel Aviv, a key route for the airline. However, in light of the ongoing security situation, the airline announced a further extension of the suspension, ensuring the safety of both passengers and crew. In a statement shared on social media platform X, Air India clarified that its flights to Tel Aviv would remain suspended until May 8. The airline also reassured affected passengers that its teams on the ground are actively assisting those impacted by the disruption. Passengers holding valid tickets for travel through May 8, 2025, are being offered a one-time waiver on rescheduling charges. Alternatively, those who wish to cancel their travel plans can request a full refund. The suspension of flights to Tel Aviv highlights the growing concern

over safety in the region. As the situation continues to unfold, airlines and authorities are prioritizing passenger safety and making necessary adjustments to flight schedules to avoid potential risks. Air India's commitment to customer support during this period of disruption reflects its focus on ensuring that impacted travelers are accommodated with flexible options for rebooking or refunds.



'Let Involved?': UN Security Council Blasts Pakistan Over Pahalgam

Rejects 'False Flag' Claims

In a significant diplomatic development, the United Nations Security Council (UNSC) strongly rebuked Pakistan during a closed-door consultation over escalating tensions with India and the deadly terror attack in Jammu and Kashmir's Pahalgam. According to ANI, citing sources, UNSC members grilled Islamabad over the involvement of Pakistan-based terror group Lashkar-e-Taiba in the April 22 attack, in which 25 Indian tourists and a local pony ride operator were brutally killed.

non-permanent members of the UNSC, had requested the Greek presidency of the Council to hold the consultations, hoping to internationalise the issue. However, the effort largely backfired as Council members not only condemned the terror attack but also flagged Pakistan's recent missile tests and its use of nuclear rheto-



ric as dangerously escalatory.

Pakistan, currently one of the 10 The hour-long session reportedly saw UNSC members express serious concerns about Pakistan's internal handling of terrorism. The Council strongly called for accountability and justice for the victims, particularly emphasising that the attack in Pahalgam appeared to target civilians based on religion. Member states dismissed Pakistan's "false flag"

claims and reiterated their support for a bilateral resolution to the crisis.

Despite Pakistan's denials of involvement, its position found little sympathy. Pakistani envoy Asim Iftikhar, addressing media after the session, rejected all allegations and accused India of violating international law by suspending the Indus Waters Treaty. However, no official statements were issued by either the Security Council or India.

Tunisian diplomat Khaled Mohamed Khiari described the situation as "volatile" and emphasized the need for dialogue. Greek envoy and UNSC President for May, Evangelos Sekeris, termed the talks "productive and helpful," while a Russian diplomat urged for "de-escalation."

UN Secretary-General António Guterres, ahead of the meeting, had voiced deep concern, urging both nations to exercise restraint. Condemning the attack, he stressed that "targeting civilians is unacceptable," and those responsible "must be brought to justice through credible and lawful means." India has responded to the Pahalgam massacre by suspending the Indus Waters Treaty and cancelling visas of Pakistani nationals, underscoring the rising diplomatic fallout from the deadliest terror attack in Kashmir in recent decades.

Pakistan bombs its own people

Islamabad's Lal Masjid cleric Abdul Aziz Ghazi on 'war' with India

In a fiery sermon delivered at Islamabad's Lal Masjid, controversial cleric Abdul Aziz Ghazi launched a scathing attack on the Pakistani government, accusing it of systemic oppression and violence against its citizens. The sermon, which was shared widely on social media, paints a grim picture of Pakistan's internal turmoil and highlights Ghazi's discontent with the state of affairs in the country.

Speaking to a congregation during Friday prayers, Ghazi posed a provocative question, asking, "If a war breaks out between Pakistan and India, how many of you will support Pakistan? Raise your hands." The lack of response from the crowd led Ghazi to remark, "Very few hands are visible. That means a good level of awareness has developed. The issue is that the war between Pakistan and India is not an Islamic war."

The cleric, known for his con-



troversial stance, continued to condemn the Pakistani state, describing it as a "system of disbelief" (kufr) and accusing the government of being more tyrannical than India's. He argued that the level of oppression in Pakistan was far worse than in India, pointing to events such as the infamous Lal Masjid operation as evidence of the state's brutality.

Ghazi also compared the situation in Pakistan to the alleged atrocities in Waziristan and Khyber Pakhtunkhwa, questioning whether such incidents had occurred in India. He criticized the Pakistani government's use of force, including airstrikes on its own people, and pointed out the ongoing issue of missing persons, including clerics, journalists, and political figures. "Here, people are exhausted from staging protests in search of their loved ones," he said.

The remarks reflect a growing frustration among some segments of the population with the Pakistani government's policies, especially concerning issues of human rights and internal conflicts. Ghazi's sermon underscores the deepening political and social unrest in Pakistan, as well as the increasing disillusionment with the state's actions.

Bangladesh court issues new arrest orders against detained Hindu leader **Chinmoy Krishna Das**

A Bangladesh court has issued arrest orders for Hindu leader Chinmoy Krishna Das in four additional cases, just a day after similar action was taken in connection with a murder case. The Chattogram Metropolitan Magistrate, SM Alauddin Mahmud, authorized the orders following a virtual hearing, as reported by the state-run BSS news agency.

Das, a former leader of the ISKCON movement, was arrested at Dhaka's Hazrat Shahjalal International Airport on November 25, 2024. His detention was linked to a sedition case involving alleged defamation of the national flag. The court rejected his bail petition, sending him to jail the following day. His arrest sparked widespread protests from his followers, who took to the streets in Dhaka and other regions.

The four new cases that led to Tuesday's arrest orders include charges of obstructing police duties at the Kotwali police station, as well as attacks on lawyers and justice seekers. Assistant Public Prosecutor Md Raihanul Wazed Chowdhury confirmed that the court approved a plea to show Das as arrested following the hearing. Das appeared in court virtually due to concerns about his "security and overall situation," an official stated. In response to the



hearing, security around the Chattogram court and jail premises was heightened throughout the day.

Earlier, on Monday, the court had also ordered Das' arrest in connection with the murder of Assistant Government Prosecutor Saiful Islam Alif, who was killed during violent protests triggered by Das's arrest.

On April 30, a High Court bench had ordered Das' release on bail, but this decision was later challenged before the Appellate Division, which stayed the ruling. Attempts by Das's defense lawyers to secure bail at the lower court level had been unsuccessful.

The allegations surrounding Das's supposed disrespect of the national flag have been denied by his defense, with top lawyer Apurba Kumar Bhattacharya asserting that the flag in question was not the national flag.





Additionally, tensions in various regions, such as the South China Sea and the Middle East, as well as the conflict in Ukraine, are adding to global instability and influencing investment decisions.

Overall, while the global economy faces significant risks, Moody's expects India to maintain steady growth but acknowledges that external factors will continue to pose challenges for its economic recovery.

Buddha-Linked Gems Head to Auction, Sparking Global **Ethical Outcry**

fresh controver-Asy has erupted in the global art and heritage world as Sotheby's prepares to auction rare gems believed to be linked to the mortal remains of the Buddha. The artefacts, set to go under the hammer today in

Hong Kong, were originally discovered in 1898 at Piprahwa, a site located in present-day Uttar Pradesh, India. The sale has triggered widespread condemnation from Buddhist scholars, religious leaders, and cultural historians, who argue that these sacred relics should never have become private property or commercial assets.

The artefacts, which include amethysts, garnets, pearls, gold, coral, and rock crystals, were discovered by British engineer William Claxton Peppé during an excavation of a stupa near Lumbini — widely accepted as the birthplace of the Buddha. Some of the gems are believed to have been mixed with the cremated remains of the Buddha himself. Peppé handed these relics over to the British colonial government under the Indian Treasure Trove Act of 1878, and parts of the find were distributed to Buddhist-majority nations like Thailand, Sri Lanka, and Myanmar. A large portion also ended up in the Indian Museum in Kolkata.



Zhao Xintong Makes History as China's First World Snooker Champion

7hao Xintong has made history by Lbecoming the first Chinese player to win the World Snooker Championship, securing a remarkable 18-12 victory over Mark Williams in the final. The 28-year-old's triumph at Sheffield's iconic Crucible Theatre on Monday ended with Zhao needing only seven frames to clinch the title, having already built a commanding 11-6 lead in Sunday's sessions.

Zhao's victory marks a significant milestone for Asian snooker, as he becomes only the second Chinese player to reach the World Championship final, following Ding Junhui's runner-up finish in 2016. Unlike Ding, who lost to Mark Selby in that final, Zhao held his composure and outplayed the three-time champion Williams.

Zhao's win earned him £500,000 (USD 663,000) in prize money, marking the



culmination of his stunning journey. His victory is even more impressive considering he was playing as an amateur after serving a 20-month ban related to a 2023 betting scandal. Despite the suspension, which saw him banned for his involvement in match-fixing, Zhao's comeback has been meteoric. He had to qualify through four rounds to reach the

World Championship main draw, a testament to his resilience and skill.

Nicknamed "The Cyclone," Zhao's victory was all the more remarkable as he was only the third player in history, after Terry Griffiths and Shaun Murphy, to win the World Championship as a qualifier in the 48-year history of the Crucible era. His victory over seven-time champion Ronnie O'Sullivan in the semi-finals was equally stunning, further adding to his reputation as one of snooker's rising stars.

The win also marks a significant achievement for China, with the nation now holding both male and female world snooker champions, following Bai Yulu's 2024 World Women's Snooker Championship victory. Zhao's title represents not only personal redemption but also the growing influence of Chinese players on the global snooker stage.
