US Urges India-Pak De-escalation

Rubio Calls Jaishankar

Amid escalating tensions between India and Pakistan, United States Secretary of State Marco Rubio on Thursday urged India to pursue immediate de-escalation, following a sharp spike in cross-border hostility. Rubio spoke to External Af-

in the day and expressed support for direct dialogue between India and Pakistan, reaffirming Washington's commitment to work closely with India in combating terrorism. The conversation took place just hours before Pakistan launched missiles and drones targeting multiple Indian cities, marking a significant military provocation.

In a late-night briefing, US State Department Spokesperson Tammy Bruce stated, "Secretary Marco Rubio spoke today with Indian External Affairs Minister Subrahmanyam Jaishankar. The Secretary emphasised the need for immedi-

IPL 2025 At Risk Of **Being Called Off**

son could be called off amid the escalating India-Pakistan border tensions. The IPL match between Punjab Kings and Delhi Capitals in Dharamsala was cancelled midway on Thursday, following air raid alerts in the neighbouring cities of Jam-

mu and Pathankot. The match was in progress with Punjab at 122 for 1 in 10.1 overs when floodlights failed, initially leading to speculation of a technical issue. However, the situation escalated when the lights went out, and authorities decided to evacuate the stadium for the safety of both the teams and the spectators. The ground, which holds a capacity of around 23,000, was filled to about 80% of its capacity when the evacuation took place.

We Introduced Hydra Before Hyderabad Faces Crises Like Other Metros

Telangana Chief Minister Revanth Reddy launched the dedicated 'Hydra' police station at Buddha Bhavan in Secunderabad with a clear message: Hyderabad must not become another victim of the urban disasters plaguing major metros like Bangalore, Mumbai, Chennai, and Delhi. He asserted that Hydra has been established as a preventive force to safeguard Hyderabad's environment, public property, and urban infrastructure.

Speaking at the inauguration, Revanth said, "We are seeing water shortages in Bangalore, floods in Chennai and Mumbai, and dangerous air pollution in Delhi. We created Hydra to ensure such problems don't arrive here. We will act strictly on encroachments, no matter the criticism."

Hydra has been designed specifically to protect government lands, ponds, drains, and other public assets from illegal en-

In a major push for rural youth empowerment, Minister for IT and Industries Duddilla Sridhar Babu on Thursday inaugurated the TCS iON Placement Success Program (PSP) in Hyderabad. Bhatti added that no other state has committed such a massive budget simultaneously for tribal agricultural development. Rains Likely in Telangana for Next 3 Days

The India Meteorological Department (IMD) has predicted light to moderate rains accompanied by thunderstorms, lightning, and gusty winds across several districts of Telangana over the next three days. A yellow alert has been issued for 20 districts warning of gusty winds blowing at speeds of 30-40 km per hour till May 11.

The IMD stated that the upcoming rains are expected to bring a 2 to 3°C drop in daytime temperatures, offering temporary relief from the persistent summer heatwave. However, temperatures are likely to hover between 36°C and 40°C during this period, with a possible rise above 40°C anticipated afterward.

On Friday, May 9, the following districts are likely to witness thunderstorms and gusty winds: Karimnagar, Peddapalli, Jayashankar Bhupalapally, Mulugu, Bhadradri Kothagudem, Khammam, Nalgonda, Suryapet, Mahabubabad, Warangal, Hanamkonda, Jangaon, Siddipet, Yadadri Bhuvangiri, Rangareddy, Hyderabad, Medchal Malkajigiri, Nagarkurnool, Wanaparthy, and Jogulamba Gadwal. A similar pattern is likely to persist on Saturday, May 10, affecting many of the same districts. On Sunday, May 11, the IMD has forecast thunderstorms and gusty winds across isolated places throughout the state, with the weather warning valid till 8:30 am on May 12.

Judson Accuses CM, **Brother of Corruption in** avnirman Company

Expelled Congress leader Bakka Judson has launched a scathing attack on Telangana Chief Minister Revanth Reddy and his brother Anumula Krishna Reddy, accusing them of looting public wealth through a company named Navnirman. Addressing the media on Thursday, Judson claimed he has complete evidence to back his charges and challenged the government to verify the documents he possesses. He alleged that massive corruption and misuse of power are being carried out in the name of infrastructure contracts, and that the Chief Minister and his brother are diverting public money for personal gain. "I have full proof of how much Revanth Reddy and his brother are looting from Navnirman. They are draining the wealth of Telangana shamelessly," Judson declared.

Reiterating his readiness to face consequences, he boldly stated, "If the evidence I have is false, then hang me. I am not afraid of cases or threats. The people of Telangana need to know the truth."

Judson also demanded a CBI inquiry into the operations of Navnirman and the financial transactions linked to it. He said he would soon submit all the documents to appropriate investigation agencies and take the fight to the courts if necessary.

This explosive allegation has sparked political ripples across Telangana, and responses from the Chief Minister or his office are awaited.

Seethakka Reviews Indiramma Housing **Progress in ITDA Areas**

Minister for Tribal Welfare Seethakka held a high-level review meeting at the Secretariat on Thursday to assess the progress of Indiramma house construction within Integrated Tribal Development Agency (ITDA) limits. The meeting was conducted in coordination with Housing Department Secretary Jyothibuddha Prakash, Housing Corporation MD V.C. Gautam, Tribal Welfare Secretary A. Sarath, and Additional Director Sarveshwar Reddy.

The meeting was convened as per the directions of Housing Minister Ponguleti Srinivas Reddy, to ensure that housing development efforts in tribal areas align with government priori-

Minister Seethakka issued key directives to streamline and expedite the construction process. She emphasized that while district collectors are overseeing housing work in general areas, ITDA project officers (POs) should be exclusively tasked with supervising the implementation within ITDA regions.

To ensure accuracy in beneficiary identification, Seethakka instructed officials to forward housing applications directly to ITDA POs for verification. She stressed the need to identify eligible tribal families quickly, especially those still living in Pakal (temporary shelters), and give them first priority for house sanctioning.

"Many tribal people are still re-



siding in huts within ITDA areas. We must act with urgency and compassion to provide them permanent homes," Seethakka urged the officials.

The meeting also addressed the procedural framework and

coordination mechanisms required to accelerate the construction under the Indiramma housing scheme, which aims to provide dignified living conditions to the underprivileged.

Harish Rao Slams Delay In AE, JTO Appointments

BRS MLA and former Minister T Harish Rao lashed out at the Congress government on Thursday for its continued delay in issuing appointment letters to candidates selected for engineering posts in the Irrigation department. In a strongly worded statement, Harish Rao accused the government of betraying the aspirations of youth. He pointed out that a total of 224 Assistant Engineers (AEs) and 199 Junior Technical Officers (JTOs), who were selected during the previous BRS regime, are still awaiting appointment letters, even after successfully clearing the recruitment process.

TPDMA Boycotts Degree Exams Over Fee Arrears

The Telangana Private Degree and PG Colleges Management Association (TPDMA) has announced its decision to boycott university degree examinations scheduled to begin on May 14, 2025, across the state. The boycott comes in protest against the State government's delay in releasing fee reimbursement arrears owed to private colleges for the past two academic years.

In an online meeting held with college managements, the association expressed deep frustration over the government's repeated failure to address the long-pending issue. Despite several appeals, the arrears remain unpaid, pushing many colleges into severe financial distress. As a result, TPDMA has resolved not to cooperate with exam proceedings, which includes refusing to collect exam materials, download hall tickets, or register students for upcoming exams.

Earlier, TPDMA had already boycotted the Mahatma Gandhi University and Telangana University exams over the same issue. The latest decision is expected to disrupt exams under multiple universities, including Osmania University and Satavahana University, where the second, fourth, and sixth semester exams are scheduled.

The association revealed that numerous colleges have been unable to pay students' exam fees or register them due to a lack of funds. Moreover, some colleges were not included in the ongoing DOST 2025 counselling, further aggravating the crisis. According to TPDMA, at least ₹300 crore in reimbursements needs to be released immediately for institutions to function and exams to proceed.

TPDMA general secretary Ramakrishna stated that owners of about 10 colleges have locked the buildings due to unpaid rent and financial non-viability. "We are not against students," emphasized Dr B Suryanarayana Reddy, president of TPDMA, "but we are fighting to protect the institutions that serve them."

Unless the government acts swiftly, thousands of students may face uncertainty regarding their examinations and academic progression.

Cyber Crime Unit Arrests Accused in Digital Arrest Fraud Case

The Cyber Crime Police in Hyderabad have arrested Ramprasad Sahebrao Salunke, a 33-year-old private employee from Pune, Maharashtra, for his involvement in Fedex/Digital Arrest frauds. The accused is linked to four cases in Telangana and 22 cases across various states. The case dates back to October 29, 2024, when a 45-year-old doctor from Hyderabad received a call from a number claiming to be from the Indian Post Office. The caller told the victim that a parcel in his name contained police uniforms, ID cards, bank debit cards, and ketamine injections. After a heated argument, the victim was connected to fake police officers who threatened him with arrest in connection to drugs. Following several days of threats, the victim transferred ₹1.23 crore to the accused's account under the pretext of a financial verification.

Office or law enforcement. These callers falsely claimed to have intercepted parcels containing illegal items. Fake police officers would then use video calls to intimidate victims into transferring money. The accused was arrested in Pune, and a cell phone was seized as part of the investigation. The individual is linked to multiple cases across various states, including Andhra Pradesh, Maharashtra, Uttar Pradesh, West Bengal, Delhi, Gujarat, Karnataka, Punjab, Tamil Nadu, and Telangana. In light of these incidents, the public is advised to avoid answering calls from unknown numbers and to immediately report any threatening calls from fake officials (such as CBI, ED, Customs, or Police). Victims should never transfer money to unknown bank accounts under duress. For those affected by cybercrime, immediate assistance can be sought by calling 1930 or visiting cybercrime.gov.in.

Tensions Erupt Over Hydra **Demolitions in Old City**

Locals clash with police as shops razed in Akbar Nagar Demolitions carried out under tight security in Chandrayangutta

TPN Correspondent | Hyderabad A tense situation prevailed in Akbar Nagar of Chandrayangutta, Hyderabad, on Wednesday as authorities initiated demolition operations using a Hydra crane and JCBs. The action, reportedly aimed at removing unauthorized structures, triggered strong resistance from local residents and political representatives.

The demolitions, carried out amid heavy police deployment, led to confrontations between the police and residents of the Old City. In a desperate attempt to stop the operation, several locals climbed onto the Hydra and lay down in front of the JCBs, blocking their movement.

MIM corporators also joined the protests, raising slogans against the use of force and questioning the role of officials, including Ranganath, who was reportedly overseeing the drive. They alleged the demolitions were



sudden and carried out without giving the affected shopkeepers adequate notice.

Rabi Farmers Hit by Paddy **Procurement Delays**

- · Unseasonal rains damage paddy in Nalgonda
- Trucks face 4-5 day delays at rice mills
- Only 25 LMT procured so far against 70 LMT target

Paddy procurement during the Rabi 2025 season has hit a major roadblock across Telangana, with farmers facing serious delays in transportation and lifting of their produce. The situation turned more distressing following unseasonal rains on Tuesday evening at Lakshmidevigudem in Nalgonda district, which damaged large quantities of already weighed paddy that was awaiting transport.

At the Lakshmidevigudem procurement center, farmer Nagulavancha Srinivasa Rao lamented that 260 bags of paddy he brought were weighed five days ago but had not been picked up by transporters. The sudden rain left the grain soaked, requiring additional drying, thus adding to his burimmediate intervention.

procurement mechanism, though ambitious, is struggling with logistical bottlenecks. The Munugode Lorry Association submitted a petition to the Tehsildar, requesting that unique serial numbers be assigned to paddy-laden trucks from Munugode mandal. This move, they say, will help streamline unloading at rice mills, which are currently overwhelmed by trucks coming in from multiple mandals such as Chandur, Kanagal, and Nalgonda.

Due to this congestion, trucks from Munugode are waiting four to five days before being allowed to unload at rice mills. Farmers worry that prolonged wait times, coupled with unpredictable weather, could lead to further crop damage and financial loss.

Adding to their grievances, residents revealed that they are being threatened with disconnection of water connections if they fail to pay taxes and charges, even though they haven't received water for weeks. "When we complain, no one listens. But when it comes to taxes, they threaten us," said one of the protestors.

The demonstrators warned that this was just the beginning and vowed to intensify their agitation if the problem was not resolved immediately. "We are ready to go to any extent to protect our right to water," they declared.





For the sake of Maharashtra, it's about time the Mahayuti acted like a coalition

Maharashtra's dynamic political terrain has seen a transformative shift with the rise of two major alliances — the Maha Vikas Aghadi (MVA) and the Mahayuti. The Mahayuti coalition, comprising the BJP, Shiv Sena (led by Eknath Shinde), and the NCP (Ajit Pawar faction), came to power with a decisive mandate in the November 2024 Assembly elections. While their initial performance has been promising on paper, growing internal rifts threaten the long-term stability and governance of the alliance.

In its first 100 days, the Mahayuti solve key issues — such as the government reported that of the 48 ministries, 12 achieved full targets and 18 met 80% of their goals. These figures suggest that the government's performance is well above average. However, this

success is being overshadowed by isters — has begun to hamper open discord between coalition the functioning of the governpartners. The conflict between Shiv Sena and the NCP over the Mukhyamantri Ladki Bahin Yojana — a welfare scheme offering financial aid to women from families earning under ₹2.5 lakh annually — is a prime example of the lack of coordination. Though the scheme was instrumental in winning public support during the elections, it has now become a source of internal competition and controversy.

The Mahayuti's inability to requestion of seniority between the two Deputy Chief Ministers, delays in administrative file movement, uneven resource allocation, and disputes over the appointment of guardian min-

ment. The role of guardian ministers is especially important, as they head the District Planning Committees. Without permanent appointments, district-level governance remains stalled and ineffective.

Furthermore, the financial burden of running the Ladki Bahin Yojana has created pressure on the state's treasury. With limited resources and competing political interests, the scheme's implementation has suffered from rushed beneficiary lists, inadequate verification, and inconsistent branding — with some partners allegedly omitting the "Mukhyamantri" prefix to claim political credit. These issues reflect a broader problem: the coalition is operating more like a collection of rival factions than a unified government.

To maintain credibility and ensure effective governance, Mahayuti leaders must urgently adopt a more cooperative approach. Internal discipline, transparent decision-making, and mutual respect among allies are essential to prevent administrative paralysis. Maharashtra's people voted for stability and progress. If the Mahayuti fails to function as a cohesive unit, it risks not only losing public trust but also derailing the developmental momentum it has claimed to build. A genuine coalition mindset, rooted in shared vision rather than individual ambition, is now the need of the hour.

India's Caste Census Gap: Why Truthful Data Matters for Real Equity



The conversation around a caste census in India is no longer just about statistics—it's about visibility, fairness, and the realities we choose to acknowledge or ignore. Caste continues to shape access to opportunity, yet our understanding of its reach is built on outdated or incomplete data. The last comprehensive caste count was conducted in 1931—under colonial rule. Since then, efforts like the 2011 Socio-Economic and Caste Census have failed, marred by misclassification and duplication, leaving over 46 lakh caste names in disarray. As a result, the data was never officially released.

Today, our policies still depend on broad categories like Scheduled Castes (SC), Scheduled Tribes (ST), and Other Backward Classes (OBC). While useful at a high level, these groupings overlook deep inequalities within each category. Some sub-groups have gained significant political and economic power, while others remain invisible, their needs buried under generalised labels.

This blanket approach harms the vulnerable. Government benefits often reach more dominant sub-groups that can organise and demand attention, while the truly disadvantaged are left out. Take land ownership: SCs make up 16% of the population but hold only 7.2% of agricultural land, as per NSS data. Even that figure lacks granular insight into which SC communities are most deprived.

Moreover, caste discrimination isn't isolated. It intersects with class, gender, and geography. A Dalit woman in rural Bihar faces different challenges than an OBC man in urban Karnataka—but policy frameworks fail to reflect such nuances. Worse, reservations and welfare schemes still rely on colonial-era caste population estimates.

While states like Bihar have initiated their own caste surveys, national-level data remains missing. In its absence, political decisions often rely on guesswork, ignoring the needs of the most marginalised. What India urgently needs is a transparent, updated caste and economic survey—capturing education, land, occupation, and access to services.

India-UK Trade Deal: A Sign **That Globalization Marches On**

After three years of negotiations, India and the UK finalized a pact earlier this week, marking a significant step in economic integration between two major economies. For instance, India had to abandon its longstanding demand for more visas for Indian workers and students, a critical point of contention in past negotiations. The UK's current political climate, influenced by rising anti-migrant sentiment, made this concession essential.

Despite skepticism about global trade, the In- This deal is particularly interesting because both India and the UK have seen their manufacturing sectors lose global competitiveness, while their services industries remain robust. The agreement shifts focus towards sectors where both countries excel, such as services, while offering more consumer-friendly deals. For example, Indian consumers can look forward to cheaper Scotch whisky and Jaguars, while British consumers may soon enjoy more affordable shrimp from India. These small, tangible benefits mark a shift in how trade agreements are being struc-

> The India-UK deal is just one part of a broader trend. Countries like Canada are seeking new partnerships, and Japan, China, and South Korea are deepening their cooperation. The biggest prize, however, is a potential trade agreement between India and the European Union, a deal that has been in the works for years but may finally come to fruition by the end of this year.

> As global trade continues to evolve, the India-UK deal signals that, despite challenges, the world remains committed to economic integration and consumer benefits.



However, success in this domain depends not only on innovation but also on inclusive access and international cooperation.

The digital divide remains a fundamental barrier. In many developing countries, large segments of the population—especially in rural and underserved areas—lack access to reliable internet, digital devices, and AI tools. Bridging this divide requires significant investment in digital infrastructure. International collaboration can play a key role in this effort, allowing countries to share best practices, technologies, and financial resources. Partnerships with global institutions and private sector leaders can accelerate the rollout of broadband connectivity, digital public services, and AI tools tailored to local needs.

Moreover, developing countries must proactively address the challenge of workforce displacement due to automation. AI-driven innovation may enhance productivity, but it also threatens traditional job sectors, particularly in manufacturing, agriculture, and lowskill services. To ensure the benefits of AI are widespread and equitable, governments must invest in large-scale reskilling and upskilling programs. Vocational training, digital literacy initiatives, and public-private training partnerships are essential to prepare the current and future workforce for new AI-driven roles.

Public access to AI must also be a policy priority. Making AI tools available for small businesses, educational institutions, and local governments can foster innovation from the



grassroots. Particularly in rural areas, AI has the potential to revolutionize sectors like agriculture, education, and healthcare. By enabling farmers to predict weather patterns, teachers to access personalized learning platforms, and doctors to use AI diagnostics, the technology can directly enhance quality of life and productivity.

The definition of economic development itself continues to evolve alongside global challenges and priorities. A decade ago, metrics such as access to renewable energy became central in light of the climate crisis. During the COVID-19 pandemic, the strength of healthcare systems was viewed as a vital indicator of resilience. Today, a country's readiness to harness AI has emerged as a key measure of its developmental status. Countries like the USA and China are setting benchmarks, but the journey for developing nations must be inclusive, ethical, and tailored to their unique socio-economic contexts. Only through such a balanced approach can AI truly become a tool for equitable progress.







Jaishankar: India Doesn't **Seek Escalation but Will Respond Firmly to Any Military Attack**

External Affairs Minister S. Jaishankar stated on Thursday that while India has no intention to escalate tensions with Pakistan, any military aggression against the country will be met with a "very, very firm response." His comments came during a high-level meeting in New Delhi with Iranian Foreign Minister Abbas Araghchi, who arrived late Wednesday night for a scheduled diplomatic visit amid heightened tensions in South Asia.

Addressing the recent flare-up, Jaishankar referred to the Pahalgam terror attack as a "barbaric" act that necessitated India's military response. The April 22 attack, which claimed the lives of 26 people in Jammu and Kashmir, was blamed on Pakistan-based terror groups. In response, India launched Operation Sindoor on May 7, targeting multiple terror camps across Pakistan-occupied Kashmir and parts of Pakistan's Punjab province.

"This attack compelled us to respond on May 7 by striking at the cross-border terrorist infrastructure," Jaishankar said. "Our response was targeted and measured." He emphasized that the Indian military's actions were precise, aimed at dismantling terror infrastructure, and not intended as a broader escalation.

However, Jaishankar made it clear that any direct military provocation by Pakistan would not be tolerated. "It is not our intention to escalate the situation. However, if there are military attacks on us, there should be no doubt that it will be met with a very, very firm response," he warned.

During the meeting, Jaishankar underlined the importance of India's partners, particularly Iran, understanding the gravity and context of the situation. He said that as a close neighbour and strategic partner, it was essential that Iran be fully informed of the challenges India faces with cross-border terrorism.

Iranian Foreign Minister Araghchi's visit takes place at a crucial moment, with both New Delhi and Tehran navigating regional complexities and shared interests in security and stability. The meeting underscored India's diplomatic push to inform key allies of its position, even as it reiterates its preference for restraint, provided its national security is not jeopardized.

The dialogue reflects India's broader strategy of measured deterrence and diplomatic transparency in the face of persistent security threats from across its western border.

Operation Sindoor: PM Modi chairs meeting with Ministries amid heightened security concerns

Prime Minister Narendra Modi on Thursday chaired a high-level meeting with Union Secretaries to assess the country's national security preparedness and inter-ministerial coordination in light of recent developments, particularly following the Pahalgam terror attack and India's subsequent military response under Operation Sindoor.

The meeting comes as India faces a heightened security situation after the April 22 terrorist attack in South Kashmir's Pahalgam, which claimed 26 civilian lives. In retaliation, Indian armed forces carried out precision strikes on May 7, targeting terrorist infrastructure in Pakistan and Pakistan-occupied Kashmir (PoK).

According to an official release, the Prime Minister stressed the need for constant vigilance, strong institutional synergy, and clear internal communication mechanisms. He reiterated the central government's unwavering commitment to protecting national



security, maintaining operational readiness, and ensuring the safety of citizens across the country.

"All ministries are fully prepared to respond to emerging situations," the government said, confirming that actionable steps have been identified across departments. Ministries have been instructed to reinforce institutional processes and maintain close coordination with state governments and local

authorities.

The review covered a wide range of topics, including enhancing civil defence protocols, countering the spread of misinformation, and protecting critical infrastructure such as power grids, communication networks, and transportation systems. Departments were directed to ensure continuity of essential services and improve emergency response frameworks.

The Prime Minister emphasized "whole-of-government" approach, urging seamless collaboration between ministries and departments to uphold national resilience and preparedness. Secretaries from key ministries — including Defence, Home, External Affairs, Power, Health, Telecommunications, and Information & Broadcasting — presented their preparedness strategies.

PM Modi directed all ministries to conduct internal audits of their preparedness levels and ensure proactive contingency planning. He also called for enhanced coordination with intelligence and security agencies to mitigate any further threats.

The meeting was attended by the Cabinet Secretary, senior officials from the Prime Minister's Office, and other top bureaucrats. The comprehensive review signals India's proactive stance amid an evolving security environment, with Operation Sindoor still ongoing and cross-border tensions high.

India thwarts missile attack on 15 cities, hits Pakistan defences

In a significant escalation of hostilities, Pakistan attempted coordinated attacks late Wednesday night and early Thursday morning on military installations in 15 Indian cities, including key targets in Jammu and Kashmir, Punjab, and Gujarat. The Indian government

confirmed that these provocations were effectively countered by Indian forces, which neutralised the threats using advanced air defence systems and precision strikes.

According to the government, Pakistan deployed drones and missiles aimed at military facilities in This attempted Pakistani assault cities such as Srinagar, Pathankot,

Amritsar, Ludhiana, and Chandigarh. However, these were intercepted and destroyed by India's air defence systems, including the Russian-made S-400. In response, India targeted and disabled multiple Pakistani air defence radars and systems in locations including Lahore.

Government sources revealed that India used HARPY drones to take down Pakistani radar installations and followed up with targeted strikes in retaliation. "The Indian response was in the same domain and with the same intensity," officials emphasised, underlining the measured nature of the operation.

Debris from downed Pakistani drones and missiles is being collected and analysed, which the government says will serve as further evidence of Pakistan's deep state support for cross-border terrorism, including funding and training of terrorist operatives.

came just one day after India

launched Operation Sindoor, a retaliatory strike on nine terrorist camps—four in Pakistan and five in Pakistan-occupied Kashmir. The strikes began at 1:05 a.m. Wednesday and lasted 25 minutes, utilising a mix of 24 precision munitions, including HAMMER smart bombs and SCALP cruise missiles. Defence Minister Rajnath Singh confirmed that over 100 terrorists were killed in the operation.

Operation Sindoor was India's direct response to the April 22 Pahalgam terror attack, where four Lashkar-e-Taiba-linked terrorists killed 26 people in Jammu and Kashmir.

India has reiterated its commitment to non-escalation, provided Pakistan refrains from further aggression. However, Defence Minister Singh warned that any further provocation will result in continued and forceful retaliation. So far, India has reported 16 civilian deaths and one soldier lost in ongoing cross-border shelling by Pakistan.

Punjab on alert: Orders Nighttime Blackout and Fireworks Ban Amid India-Pakistan Border Tensions

As tensions continue to escalate along the India-Pakistan border in the wake of Operation Sindoor, authorities in Punjab have implemented strict precautionary measures to ensure public safety. A district-wide nighttime blackout has been ordered in Gurdaspur, and bans on the use of fireworks have been imposed across six border districts in the state.

The order for the blackout was issued by the Deputy Commissioner of Gurdaspur on Thursday. According to the directive, all non-essential lighting must be switched off from 9 PM to 5 AM starting tonight and will remain in effect until further notice. However, the blackout will not apply to cantonment areas or other military zones, where security operations and essential services continue without restriction.

The decision comes amid heightened cross-border military activity between India and Pakistan. Following the Pahalgam terror attack that claimed 26 civilian lives, India launched precision strikes under Operation Sindoor targeting terror infrastructure across the Line of Control (LoC). Pakistan has responded with increased shelling and missile threats, prompting civilian safety protocols in vulnerable regions.



In addition to Gurdaspur, deputy commissioners in five other Punjab border districts including Amritsar, Pathankot, Tarn Taran, Ferozepur, and Fazilka — have announced an immediate ban on fireworks. The move is aimed at preventing confusion or panic among residents during a time of military alert, as well as avoiding any visual signals that could be misinterpreted during night operations.

Punjab Chief Minister Bhagwant Mann has been in continuous consultation with defence and civil authorities to monitor the security situation. State officials have assured the public that all necessary measures are being taken to safeguard lives and maintain law and order along the sensitive international

Operation Sindoor Day 2: Pak will be entirely responsible for consequences: FS Vikram Misri

On the second day of Operation Sindoor, India reiterated its commitment to measured military action and warned Pakistan that any further provocation would be met with a firm response. In a detailed press conference on Thursday, Foreign Secretary Vikram Misri firmly stated that no Pakistani civilians were harmed during India's precision strikes targeting terrorist infrastructure in Pakistan and Pakistan-occupied Jammu and Kashmir.

Addressing media alongside Wing Commander Vyomika Singh and Colonel Sofiya Qureshi, Misri clarified that India's actions were a direct response to the April 22 Pahalgam terror attack, where 26 civilians, mostly tourists, were killed by terrorists in Baisaran valley, South Kashmir. Misri emphasized that this attack marked the original escalation, and India's military operations were designed to dismantle terror infrastructure—not to provoke.

"Any further action by Pakistan, some of which we are seeing today, is nothing but escalation by Pakistan once again and will be responded to, and is being responded to appropriately," Misri warned.

India denied Pakistan's claims of civilian casualties and the alleged targeting of civilian infra-



structure, including a dam. Misri called these allegations "absolute fabrication" and warned Pakistan against using such false narratives as justification for retaliatory strikes on Indian infrastructure.

Wing Commander Vyomika Singh added that Pakistan had intensified unprovoked shelling across the Line of Control (LoC), using mortars and heavy artillery in Kupwara, Baramulla, Uri, Poonch, Mendhar, and Rajouri sectors in Jammu and Kashmir. These actions, she said, point to deliberate provocation from Pakistan's side.

Misri underlined that India's airstrikes were carefully calibrated and targeted at nine terrorist facilities across the border under Operation Sindoor, conducted early Wednesday morning. These actions, he noted, were based on credible intelligence and carried out in a restrained and proportionate manner.



UK Parliament Debates India-Pakistan Conflict, Calls for De-escalation Efforts

Bill Gates to Donate 99% of Wealth. Gates **Foundation to Close** by 2045

In a landmark philanthropic decision, Bill Gates announced on Thursday that the Bill & Melinda Gates Foundation will shut down in 2045 after donating 99% of his remaining wealth—estimated at \$107 billion. The tech magnate and Microsoft co-founder plans to channel the remainder of his fortune into the foundation, enabling it to distribute an additional \$200 billion over the next two decades, according to the Associated Press.

"It's kind of thrilling to have that much to be able to put into these causes," Gates said in an interview, explaining that a 20-year window balances the urgency of global challenges with the need for structured, impactful giving.

Established in 2000 with Melinda French Gates, the Gates Foundation has been a transformative force in global health, poverty reduction, and education. To date, it has spent more than \$100 billion supporting scientific innovation, sanitation initiatives, vaccine distribution, and other critical services in lowand middle-income countries.

Gates emphasized that the decision to sunset the foundation by 2045 reflects a strategic shift to concentrate resources in a finite period for maximum impact. "I think 20 years is the right balance between giving as much as we can to make progress on these things and giving people a lot of notice that now this money will be gone," he noted. About 41% of the foundation's total funds have come from Gates' longtime friend and fellow billionaire Warren Buffett, with the rest contributed by Gates himself. Their joint effort helped establish global health programs such as Gavi, the Vaccine Alliance, and the Global Fund, which combats HIV, tuberculosis, and malaria. Gates said this philanthropic journey has become his "second and final career," driven by the stark disparity he discovered in global health funding.

No New Pope Yet: Black Smoke Signals Inconclusive Voting on Day Two of Vatican Conclave

The Catholic Church continues to wait for a new leader, as black smoke once again billowed from the Sistine Chapel chimney on Thursday morning, signaling that the cardinals have yet to agree (0950 GMT), following the second and third ballots of the papal conclave.

With none of the 133 voting cardinals securing the required two-thirds majority—at least 89 votes—the process to elect the 267th pope remains unresolved. The cardinals returned to their Vatican residences for a midday break and lunch before reconvening for an afternoon voting session, during which two more ballots are expected.

On Wednesday, the opening day of the conclave, the first round of voting ended with a similar result. Black smoke poured from the chimney just after 9 p.m., prompting speculation about the unusually long delay. Observers questioned whether the cardinals had needed to repeat the vote, address a health emergency, or accommodate translation needs. Others mused whether the papal preacher's meditation had simply run long.

Despite early predictions of a short conclave, the process has now entered its second day with no clear frontrunner. Historically, conclaves have required anywhere from three to 14 ballots to elect a new pope. Pope John Paul I was on a successor to Pope Francis. The chosen on the fourth ballot in 1978, John smoke appeared at 11:50 a.m. local time Paul II on the eighth, and Pope Francis on the fifth in 2013.

Trump Set to Announce U.S.-U.K. **Trade Deal Amid Tariff Tensions**

Former U.S. President Donald Trump is poised to announce a trade agreement with the United Kingdom on Thursday, May 8, 2025, according to reports from The New York Times and Politico. The announcement is expected during a scheduled news conference at 10:00 a.m. (1400 GMT) in the Oval Office, where Trump will unveil what he described as a "major" trade deal with a "big, and highly respected country."

Though official details remain sparse, sources familiar with the matter suggest the deal will mark the beginning of renewed trade ties between Washington and London, potentially outlining a broader framework that may still be subject to further negotiations. It is unclear whether the agreement has been fully finalized or is still a preliminary outline.

Trump has spent recent weeks promoting the possibility of new trade agreements, following his administration's decision last month to impose sweeping tariffs on multiple global trading partners. Most of these tariffs were temporarily suspended to allow time for negotiations, and Trump has repeatedly stated that several countries are eager to reach agreements with the United States.

This U.S.-U.K. deal comes shortly after Britain finalized a significant free trade agreement with India—its largest since Brexit. That agreement was concluded after renewed discussions resumed in February, spurred in part by concerns over potential U.S. tariff escalations. The India deal reflects Britain's wider strategy to diversify trade relationships following its departure from the European Union, a move that necessitated new bilateral arrangements to sustain economic growth.

For the United Kingdom, strengthening economic ties with major partners such as the U.S. has become increasingly urgent in the post-Brexit era. The British government has actively pursued agreements across Asia and the Americas to offset disruptions caused by the EU exit and avoid the potential fallout from U.S. trade restrictions.

As Trump prepares to present what he called the "first of many" deals, attention now turns to whether the proposed agreement will usher in a new phase of transatlantic trade cooperation—or simply lay the groundwork for future negotiations.



Xi Jinping and Lula Arrive in **Russia Amid Ukraine Conflict for Victory Day Celebrations**

Chinese President Xi Jinping and Brazilian President Luiz Inácio Lula da Silva arrived in Moscow on Wednesday to attend Russia's Victory Day celebrations, marking the 80th anniversary of the end of World War II. Their visit comes at a time when Russia is engaged in intense military conflict with Ukraine, with both sides trading fire just hours before the event.

The commemorations, typically seen as a showcase of Russian military strength, are overshadowed this year by continued hostilities in the Ukraine war. Ukrainian President Volodymyr Zelensky reported that Russia launched a wave of ballistic missile and drone strikes overnight, deploying over 140 attack drones across multiple Ukrainian cities, including Kyiv, Kharkiv, Sumy, and Kyi. Air raid sirens blared throughout the day, with numerous casualties and extensive damage

In response, Ukraine launched its own attacks, prompting Russian forces to shoot down nine drones approaching Moscow, according to Mayor Sergei Sobyanin. These retaliatory strikes occurred just before a Russian-proposed three-day ceasefire was set to begin. While Zelensky has not agreed to Russia's truce proposal, he reiterated Ukraine's earlier offer of a 30day ceasefire, calling it a genuine opportunity for diplomacy. "Russia gives no answer—only more strikes," Zelensky stated, emphasizing who he believes is responsible for prolonging the conflict. President Xi is expected to meet Russian President Vladimir Putin on Thursday for bilateral discussions. Topics on the agenda include the ongoing Ukraine war, strained Russia-U.S. relations, and broader global strategic concerns.

SEBI Takes Action Against STL and Merchant Banker FOCL for Misutilisation of IPO Funds



The Securities and Exchange Board of India (SEBI) has issued an interim order restricting Mumbai-based Synoptics Technologies Ltd (STL) from trading in the securities market due to the diversion and misutilisation of funds raised through its initial public offering (IPO). In a separate move, SEBI has also barred First Overseas Capital Ltd (FOCL), the lead manager to the IPO, from accepting any new assignments related to merchant banking.

STL, a small and medium-sized information technology solutions provider, raised a total of Rs 54.04 crore through its IPO, which was listed on the SME Platform of the National Stock Exchange (NSE) on July 13, 2023. The IPO, priced at Rs 237 per share, included both a fresh issue of shares and an offer for sale. The company raised Rs 35.08 crore through the fresh issue, while Rs 18.96 crore was garnered through the offer for sale from two promoters, Jatin Shah, the company's managing director, and Jagmohan Manilal Shah.

According to the disclosures made in STL's red herring prospectus (RHP), the IPO-related expenses totaled Rs 80 lakh. Of these, Rs 50 lakh were to be paid from the proceeds of the fresh issue, while the remaining Rs 30 lakh was to be covered by the selling shareholders. After deducting these expenses, STL was expected to receive Rs 34.58 crore, which was meant for various purposes. These included repaying borrowings (Rs 5 crore), funding working capital (Rs 17.58 crore), making investments in strategic acquisitions or joint ventures (Rs 5.3 crore), and general corporate purposes (Rs 6.7 crore).

However, SEBI's interim order comes after the regulator discovered that STL had diverted and misused these funds, prompting the restrictions on the company and the barring of FOCL from taking up new IPO-related assignments. The action underscores SEBI's commitment to ensuring transparency and accountability in the capital markets.

Tata Group Stock Climbs After Net Profit Jumps 112%, Check Dividend Announcement



Voltas Ltd's stock witnessed a strong surge on Thursday, gaining up to 3% intraday following the company's stellar Q4 FY25 earnings. The shares climbed to the day's high of ₹1,287.60 apiece on the BSE, compared to the previous close of ₹1,244.45. At the time of reporting, the stock was trading at ₹1,260.90, up 1.32%, taking the company's market capitalisation to ₹41,744.42 crore. Voltas is a constituent of the BSE 200 index.

The rally comes on the back of a robust financial performance for the quarter ended March 31, 2025. The Tata Group company reported a 14% year-on-year increase in consolidated total income, which stood at ₹4,847 crore, compared to ₹4,257 crore in Q4 FY24. 



Meta Reportedly Considered Bringing Facial Recognition Support to Its Smart Glasses

PBKS vs DC Called Off Amid Security Concerns in Dharamsala

The highly anticipated IPL 2025 match between Punjab Kings and Delhi Capitals at the Himachal Pradesh Cricket Association Stadium in Dharamsala was abandoned due to security concerns stemming from regional unrest. The decision to call off Match 58 came after a sudden power outage during the game, followed by the activation of air raid alerts in nearby areas, including a blackout in Jammu, approximately 200 kilometers away.

According to IPL Chairman Arun Dhumal, the match was called off as a "precautionary step" after reports emerged of missile activity and intercepts in Jammu. Initially attributed to floodlight malfunction, the stadium lost lighting tower by tower until only one remained function-

al. Fans were subsequently evacuated, and both teams were taken off the field for their safety.

At the time of abandonment, Punjab Kings were in a commanding position at 122/1 in 10.1 overs. Priyansh Arya had played a blistering knock of 70 off 34 balls before being dismissed by T Natarajan, while Prabhsimran Singh remained unbeaten at 50 from 28 deliveries. The top order's explosive start set a strong foundation before the match came to an abrupt halt.

Reports also noted sirens and blackouts in Dharamsala, possibly linked to national security protocols in response

to the Jammu incident, where Pakistani missiles were reportedly intercepted. This raised speculation about the continuation of the IPL 2025 season, with sources indicating that a final decision on the league's fate may be announced by Friday, May 9.

Both franchises had much at stake, with Punjab Kings in excellent form this season. However, safety took precedence, and authorities acted swiftly to prevent any potential risks. Fans were left disappointed, but the organizers prioritized caution amid escalating regional tensions. As the situation develops, the future of the remaining IPL 2025 matches remains uncertain.


