TPN | V. Krishna Kumar **Hyderabad:** Hydra's name has become synonymous with demolitions and swift action—but only in the suburbs. In the heart of the city, where commercial buildings are blatantly violating municipal rules, not even a single warning or scratch has come from Hydra. Across the city and its adjoin-

ing areas, builders have systematically converted cellar parking spaces into commercial shops and sheds, in clear violation of approved plans. The result: roads clogged with vehicles, regular traffic jams,

and residents in colonies left officials, who seem to convewith no peace or space. The main stretch from Panama Godam to Vanasthalipuram has become a symbol of this unchecked lawlessness. Commercial buildings line both sides of the road, yet not one has retained a cellar for parking. The designated cellar spaces have been turned into businesses, forcing customers and owners to park on the roads, leading to chaos. These violations are clearly visible even to passersby—yet Hydra has not touched them. Frustrated locals are questioning the role of town planning

niently ignore these issues. While there is a dedicated department meant to inspect such structures and ensure cellar usage norms are followed, allegations are rife that violations are overlooked for bribes. The old saying "Khaaya piya chal gaya" (ate, drank, and left) is how people describe the current state of the town planning department.

"This isn't just about inconvenience to motorists," said one colony resident. "It's about fairness.

HC Reserves Verdict on Telangana Panchayat Polls

The Telangana High Court has reserved its verdict in the crucial case concerning the conduct of Gram Panchayat elections in the state. The court on Monday concluded hearings on petitions demanding immediate polls, following the expiration of existing Panchayat terms.

The investigation into the sensational phone tapping case in Telangana has intensified, with the Special Investigation Team (SIT) recording the statements of two top former bureaucrats. Former Chief Secretary Shanthi Kumari and Principal Secretary (Political) of the General Administration Department, Raghunandan Rao, appeared before the SIT in recent days.

According to sources, the SIT has obtained crucial information from both officials regarding the alleged misuse of surveillance protocols during the previous government's tenure. The case pertains to the tapping of phone

As per the SIT's findings, around 618 phone numbers were recommended for tapping by the SIB during the election period. It has now emerged that Shanthi Kumari, in her capacity as Chief Secretary, reportedly forwarded the list to the DoT for necessary telecom permissions.

The SIT is now probing whether the entire process adhered to legal norms or if due protocol was bypassed in the interest of political surveillance. Sources say more top officials could be summoned in the coming days as the investigation unfolds.

Death Threats To MP Raghunandan Rao

Caller claims to be Maoist from Madhya Pradesh

BJP MP from Medak, Raghunandan Rao, received a chilling death threat on Monday, triggering concern among security agencies and political circles. An unidentified caller, claiming to be a Maoist from Madhya Pradesh, called Rao and threatened to kill him by the end of the day. The call came while Raghunandan Rao was attending a school program in Dammayiguda, Medchal district. The caller introduced himself as a Maoist and issued a direct threat, stating that the MP would not live past the evening. Shocked by the threat, Raghunandan

Greater Hyderabad Municipal Corporation (GHMC) Commissioner R.V. Karnan has directed officials to respond responsibly and swiftly to public complaints received through the Prajavani grievance redressal platform. During the Prajavani programme held at the GHMC headquarters on Monday, the Commissioner personally received petitions from citizens who had come from various parts of the city.

He emphasized that every complaint must be thoroughly examined by the respective departments and resolved at the earliest. "There should be improved coordination among departments to avoid repeat complaints," the Commissioner said. All complaints were forwarded to the respective wings for immediate action.

During the programme at the GHMC head office, 78

complaints were received—45 by the Town Planning Department, 13 by the Tax Section, 4 by Sanitation, 3 by Engineering, 2 by HMWSSB, and one each by the Land Acquisition, Finance, AC Legal, and Vigilance Departments, with 7 more through phone-in.

In addition, 146 complaints were received across GHMC's six zones: 57 in Kukatpally, 53 in Secunderabad, 17 in Serilingampally, 8 in Charminar, 6 in LB Nagar, and 5 in Khairatabad.



A total of 224 Receiving Grievance (RG) centres have been set up across GHMC limits to strengthen public interface and ensure that citizen issues are addressed effectively.

Amit Shah to visit Nizamabad on June 29

- MP Arvind predicts BRS downfall in upcoming polls
- Alleges widespread corruption in KCR-led party

Nizamabad MP Dharmapuri Arvind launched a scathing attack on the Bharat Rashtra Samithi (BRS) party, declaring that its working president K.T. Rama Rao (KTR) will certainly be defeated in the next elections and that no one else from the party, except possibly Harish Rao, stands a chance of winning.

Speaking to the media on Monday, Arvind alleged that the BRS is deeply entangled

in corruption and demanded immediate action against its leaders. "They should be sent to jail without delay," he said, claiming that the people are fed up with the misdeeds of the former ruling party.

The BJP MP also criticized the current Chief Minister Revanth Reddy, stating, "If he threatens leaders in the morning and sits down for talks with them in the evening, Congress will have no future." Arvind warned that leniency towards corrupt leaders would send the wrong message to the public.

In a significant announcement, Arvind revealed that Union Home Minister Amit Shah will visit Nizamabad on June 29. As part of the visit, Shah will inaugurate the long-awaited Turmeric Board office, a major demand of turmeric farmers in the region. Arvind expressed confidence that this initiative will usher in a new era for local agriculture. Along with the inauguration, Amit Shah will unveil a statue of senior Congress leader and former MP D. Srinivas, a prominent figure from the region. Later, Shah will participate in a large-scale 'Rythu Sammelanam' (farmers' gathering) at the polytechnic college grounds in Nizamabad, where he is expected to address thousands of farmers and local residents.

The visit is being seen as a major political event in Telangana, signaling BJP's continued push to strengthen its presence in the state ahead of the next elections.

Tractors Without Diesel, Garbage Uncollected for 20 Days: Harish Rao

TPN Correspondent | Medak "There is no diesel in the tractors, and garbage collection has come to a standstill for 20 days. Is this the change Congress promised?" asked former minister Harish Rao during his visit to Chippal Turthi in Narsapur constituency.

Former Finance Minister Harish Rao launched a scathing attack on the Revanth Reddy-led Congress government over the deteriorating state of sanitation services in rural Telangana. Accompanied by local MLA Sunitha Lakshma Reddy, Harish Rao visited the village secretariat at Chippal Turthi and found that a tractor provided under the previous KCR government for garbage collection had not moved in 20 days due to the lack of diesel.

"The tractor driver and the worker themselves confirmed that neither diesel was provided nor the tractor serviced. It has no insurance, no road tax, and even the funds handed over to the MPDO for diesel were apparently unused," he alleged.

Harish Rao reminded that former CM KCR had provided tractors, tankers, trolleys, garbage bins, and dump yards to all gram panchayats to make Gandhiji's dream of village self-governance a reality. "But



this government cannot even infrastructure, he pointed out afford diesel. Is this the Congress model of change?" he questioned.

He added that with the arrival of the rainy season, lack of sanitation and garbage clearance can lead to the spread of diseases like malaria and diarrhea. "The Revanth Reddy government will be responsible for any outbreaks," he warned.

Sanitation workers too are reportedly struggling, having not received their salaries for the past three months. "They are unable to feed their families, and some have even been forced to spend from their own pockets to keep village affairs running," said Harish Rao. He cited an instance where the village secretary claimed to have spent ₹80,000 of his own money on Gram Panchayat expenses without reimbursement.

that out of 110 street lights in the village, only 30 are functional. "There is no money for street lights, but the government has money to fuel helicopters. If you don't give commissions, there's no money—this is the current state of governance," he said.

He accused the government of releasing funds only after collecting 10% to 20% commission from contractors and asked if sanitation workers were being denied salaries just because they don't pay bribes.

Harish Rao also criticized Chief Minister Revanth Reddy's lack of presence in the Secretariat. "The CM doesn't visit the Secretariat even once a month. His priority is flying between Hyderabad and Delhi," he said. "The Congress government has turned Telangana's once model

Kishan Reddy Calls out Congress govt for delays in ₹2 lakh farm loan waiver

TPN Correspondent | Hyderabad currently serving as lead banks Union Minister and BJP Telangana President G. Kishan Reddy addressed the media following the Telangana State Level Bankers Committee (SLBC) meeting held on Monday. During the interaction, he emphasized the significant progress made in banking services under the Narendra Modi-led Central Government, while also raising serious concerns about the non-implementation of the farm loan waiver promised by the Congress government in Telangana.

Kishan Reddy pointed out that banking infrastructure in Telangana has expanded significantly since 2014. While the number of bank branches in the state was around 6,000 then, nearly 600 new branches have been added in the last 10 years. He also noted the strengthening of the Banking Correspondent system, with 80,931 bank correspondents now delivering doorstep banking services in rural areas.

He stated that SBI, Union Bank of India, and Canara Bank are in Telangana districts, playing a vital role in disbursing central government schemes and loans. Discussions during the SLBC meeting emphasized the need for awareness programs about various banking services, including education loans, housing loans, Kisan Credit Cards, and MSME sector loans.

Awareness drives will also focus on Vishwakarma Yojana, Mudra Yojana, and street vendor loans, Kishan Reddy said. Every bank branch has now been directed to issue at least one loan annually to an SC/ST person and one to a woman borrower, as part of the central government's inclusive approach.

Highlighting the Central Government's commitment to farmers, Kishan Reddy revealed that agricultural loans in Telangana rose from ₹27,676 crore in 2013–14 to ₹1,37,346 crore in 2024–25, marking nearly a five-fold increase in just over a decade. He said this data proves the Modi government's consistent support for



Telangana's farming communitv.

However, Kishan Reddy took sharp aim at the Congress-led state government, accusing it of failing to implement the ₹2 lakh farm loan waiver. He cited that around 15,000 farmers in Telangana Gramin Bank are yet to receive the promised waiver amount due to lack of funds being deposited by the state government.

"Even farmers with loans under

₹1 lakh have not received any waiver benefits yet," he alleged, urging the state government to act swiftly, gather data from banks, and complete the waiver for all eligible farmers.

The SLBC meeting concluded with a decision to coordinate with state officials to speed up the waiver process and conduct regular review meetings to monitor progress on financial inclusion and welfare program implementation.

He also said that Prime Minister Modi is actively working towards realizing Mukherjee's dream of economic self-reliance through initiatives like Make in India, helping India emerge as a powerful economic competitor globally.

A 50-year-old man was arrested by the Afzalgunj police for allegedly duping a real estate businessman in a fraudulent gold deal that led to a loss of ₹65 lakh. The accused has been identified as Jaya Kumar, a resident of Manvi in Karnataka's Raichur district.

According to police, the accused, along with two other absconding associates, hatched a plan to lure victims by offering "original gold" at throwaway prices. The complainant, Munukuntla Niranjan, a realtor from Choutuppal, was contacted in March by a man who identified himself as 'Reddy'. Over a series of phone conversations and meetings at Pedda Amberpet, Reddy convinced Niranjan and his associate Dharmender to agree to a gold deal. On May 12, as instructed by the suspects, Niranjan and Dharmender arrived in Dilsukhnagar with ₹65 lakh in cash. They were further directed to Putlibowli X Road in Afzalgunj, where the



cash was handed over near an Irani tea stall to a man identified as Raghu.

In exchange, they were given a bag supposedly containing gold. However, moments after the handover, the accused fled the scene on motorcycles without number plates. Upon checking the contents of the bag, the victims discovered

it was filled with sarees and stones instead of gold.

With no initial leads, the police formed a special team under the supervision of senior officers. Through technical surveillance, CCTV footage analysis, and field-level investigation, the police were able to track down and apprehend Jaya Kumar on June 22.

The police seized ₹40 lakh in cash and a Hyundai Creta used in the crime from his possession. A case has been registered, and efforts are on to trace the two remaining accused.

The Afzalgunj police are continuing the investigation to recover the remaining amount and apprehend the other suspects involved in the fake gold racket. Authorities have advised the public to remain cautious and not fall prey to too-good-to-be-true gold offers.

Hyderabad Police Bust ₹30 Lakh International Drug Racket

Three arrested including Nigerian student; Goa–Hyderabad link exposed

In a major breakthrough, Hyderabad police have busted an international drug racket operating out of a flat in Manikonda, seizing cocaine and ecstasy pills worth ₹30 lakh and arresting three individuals. The arrested include a Nigerian student and two Indian nationals with previous drug-related cases registered at the Raidurgam police station. The key accused is Chukwumeka Wisdom Onyeka (22), a Nigerian national and student at Gokul Global University in Gujarat. Also arrested were Gopishetty Rajesh rian passport from a handler

(40), a wedding planner from the same apartment complex, and Bommadevara Veera Raju (32), a car and real estate dealer from Rajahmundry, Andhra Pradesh.Based on intelligence inputs about a Goa-Hyderabad narcotics supply chain, police raided the Manikonda apartment on June 22. They recovered 107 grams of cocaine and 25 grams of ecstasy pills, allegedly during a drug deal in progress.Investigations revealed that Chukwumeka entered India using a Sudanese passport under a fake identity. He later acquired a Nige-



named Max in Goa, returned to Nigeria in 2024, destroyed the passport, and re-entered India using new documents

under his real name.According to police, the drug syndicate is operated by Max, a Nigeria-based kingpin who uses

multiple aliases—Princewel, Buchi, and Gabriel—to manage international narcotics routes. He reportedly recruits African students in India using fake or multiple passports to handle distribution networks.Meanwhile, Rajesh and Veera Raju, initially consumers, became part of the supply chain after building connections with elite clients, including celebrities. They regularly travelled to Goa to procure drugs and delivered them in Hyderabad and parts of Andhra Pradesh.One such delivery reportedly took place on May 29 for a rave party at a farmhouse in Aziz Nagar, al-

legedly organized by a regular customer named Phani Raj. Another delivery was made in Mangalagiri on May 31.

Along with the drugs, police seized six mobile phones used in coordination and delivery. Two major suppliers have been identified: Max from Nigeria and Hanumant Babuso Divkar alias Baba from Goa.Officials have also identified several high-profile consumers, including individuals named Phani Raj, Pavithra Reddy, Satish, Sada Shiva, Sudhir, and Bhanu. Further arrests and a wider crackdown are expected as the investigation progresses.





Wife, Her Lover, and Mother **Behind Brutal Murder**

Husband killed just a month after marriage over illicit affair Wife spoke to lover 2,000 times after marriage Bank employee had affair with both mother and daughter

A shocking murder case has come to light in Telangana's Jogulamba Gadwal district, where a private surveyor named Tejeshwar (32) was brutally killed just a month after his marriage. Police investigations have revealed that his wife Aishwarya, her mother Sujatha, and her alleged lover — a bank employee — were involved in plotting the murder for personal and financial motives.

Tejeshwar was engaged to Aishwarya from Kurnool on February 13. However, just five days before the wedding, Aishwarya disappeared, raising suspicions. At the time, rumours spread that she had eloped with a bank employee with whom she was allegedly having an affair. But she returned on February 16 and emotionally convinced Tejeshwar that there was no affair. Trusting her, and despite his family's concerns, Tejeshwar went ahead with the marriage on May 18.

But from the second day of marriage, tensions emerged. Aishwarya frequently stayed on her phone, neglecting her husband, and the couple reportedly argued often. On June 17, Tejeshwar went missing. After his brother filed a missing complaint, police found Tejeshwar's body at Sugalimettu near Panyam in Andhra Pradesh.

Under suspicion, police detained Aishwarya and her mother Sujatha, which led to explosive revelations. It was discovered that Sujatha, a

sweeper in a well-known Kurnool bank, was involved in an extramarital affair with a bank employee. That same employee later entered into a relationship with Aishwarya as well.

Even after marriage, Aishwarya reportedly maintained her affair — speaking to the bank employee 2,000 times on the phone within just one month. Investigators believe the trio plotted to eliminate Tejeshwar, hoping to continue the relationship and gain access to his property.



The murder was executed on employee, who is suspected to June 17, when hired men — including the bank employee's driver — lured Tejeshwar into a car under the pretext of buying land. On the way, they attacked him with knives and slit his throat. His body was dumped near Panyam and the culprits fled the scene.

Aishwarya and her mother have been arrested. The bank

Ganja Worth ₹50 Lakh Seized at ORR, One Held

Accused was transporting drugs from Visakhapatnam to Haryana; 4 others absconding

The Medchal Special Operations Team (SOT) and Dundigal Police on Sunday evening intercepted a major drug transportation attempt and seized 120 kilograms of ganja, valued at ₹50 lakh, during a vehicle check at Exit 5 of the Hyderabad Outer Ring Road (ORR).

During a press conference held at the Dundigal Police Station, Medchal DCP Kotireddy revealed that the arrested individual was caught while transporting the contraband from Visakhapatnam in Andhra Pradesh to Haryana.

Has Trump Just Ignited Another 'Forever War' in the Middle East?

For a president elected on promises to end America's long-standing wars, Donald Trump's recent decision to strike key Iranian nuclear sites marks a dramatic shift, pushing the Middle East closer to a new major conflict. On Sunday, US forces targeted Iran's Fordow, Natanz, and Isfahan nuclear facilities, deploying the powerful 30,000-pound "bunker buster" bomb—the Massive Ordnance Penetrator (MOP)-to destroy deeply buried sites. This move follows a brief two-week ultimatum Trump gave Iran to enter serious negotiations, which was cut short to just two days before the strikes.

In his White House address, Trump declared the facilities "totally obliterated," warning of further strikes if Iran does not pursue peace. Tehran



condemned the attacks as "outrageous" and vowed "everlasting consequences," reserving "all options"

to defend its sovereignty. While the US hinted the operation might be a singular show of strength without aiming to topple Trump appears to be betting on the regime, Trump contradicted this by suggesting on Truth Social that regime change could still be on the table if Iran fails to "Make Iran Great Again." Iranian Foreign Minister Abbas Araghchi admitted the strikes crossed a "very big red line," leaving uncertain how much room for diplomacy remains. Meanwhile, Iran's Supreme Leader Ayatollah Khamenei warned that any US military intervention would bring "irreparable damage," signaling a likely forceful response.

Iran's allies, including Yemen's Houthis, have threatened to target US ships in the Red Sea, and Tehran has approved plans to close the strategic Strait of Hormuz, escalating tensions further.

How Fringe Groups and a Crucial Bypoll Have Shaken Kerala's Political Landscape

The bypoll, held just months ahead of the 2026 assembly elections, has seen traditional parties reaching out to radical groups, despite Kerala's reputation for political maturity and communal harmony.

The Communist Party of India-Marxist (CPI-M), leading the Left Democratic Front (LDF), has openly courted support from Abdul Nasar Madani's People's Democratic Party (PDP), a controversial figure known for extremist views. The Left even extended a 'secular certificate' to the PDP, signaling a strategic alliance. Meanwhile, social media still shows CPI-M members accusing the PDP of violence, highlighting the uneasy, transactional nature of this partnership.

On the other side, the Congress-led United Democratic Front (UDF) has accepted backing from the Welfare Party



of India, linked to the Jamaat-e-Isla- VD Satheesan defended the Jamaat Congress candidate, Aryadan Mumi, an Islamist group with a contentious history and banned in other countries. Kerala's opposition leader

The Bharatiya Janata Party (BJP), though historically weak in Kerala, has gained ground and fielded a candidate to attract Christian voters. Oddly, the Hindu Mahasabha has backed the CPI-M candidate to oppose the BJP's 'outsider', illustrating the strange alliances shaping this contest. Even international issues seeped into the campaign, with the Left condemning Israel's attacks on Iran, evoking memories of past election tactics. Meanwhile, essential local concerns, such as human-wildlife conflict in Nilambur, remain sidelined.

This bypoll exposes how Kerala's politics is increasingly influenced by fringe and communal forces, threatening the secular ethos that has defined the state for decades.



India wary about Iran's nuclear project: Voted against in 2005, abstained in 2024

Nearly two decades after India cast its first vote against Iran's nuclear programme, New Delhi once again finds itself navigating a complex diplomatic balancing act — this time amid heightened geopolitical tensions involving Israel, the United States, and Iran.

Back on September 24, 2005, India took a significant step by voting in favour of an International Atomic Energy Agency (IAEA) resolution (GOV/2005/77) that found Iran in non-compliance with its nuclear safeguards obligations. That vote, aligned with the U.S. and other Western powers, marked a notable shift in India's foreign policy, reflecting its concerns about nuclear proliferation, especially in its ex-



tended neighbourhood.

The decision drew attention because it appeared to distance India from a country with which it shared deep historical, cultural, and civilisational ties. Iran, a long-

time regional partner, had traditionally enjoyed a favourable position in India's strategic calculus, particularly due to energy ties and connectivity projects like Chabahar Port.

However, India's vote highlight-

ed its growing unease over the prospect of a nuclear-armed Iran, which could further destabilise an already volatile region. At the same time, it reflected India's broader ambition of integrating more deeply with the global non-proliferation order and strengthening ties with the U.S., especially in the context of the then-emerging India-U.S. civil nuclear agreement.

Today, as tensions again rise over Iran's nuclear ambitions, India's balancing act has resurfaced with closer ties to both Israel and the U.S., and enduring interests in Iran. The challenge lies in safeguarding strategic partnerships on both sides, while ensuring regional stability and energy security in an increasingly polarised global order.

NIA Secures 5-Day Custody of Two Accused in Pahalgam Terror Attack Case

A local court on Monday granted the National Investigation Agency (NIA) five-day custody of two individuals arrested in connection with the Pahalgam terror attack that took place in April this year. The accused, identified as Parvaiz Ahmad Jothar from Batkote and Bashir Ahmad Jothar of Hill Park — both residents of Pahalgam — were apprehended on Sunday in a significant breakthrough in the case.

The duo is accused of sheltering three Pakistani terrorists affiliated with the banned Lashkar-e-Taiba (LeT), who carried out the deadly assault on April 22. The attack claimed the lives of 26 people, most of them tourists, and left 16 others seriously injured.

According to the NIA, during preliminary interrogation, the arrested men revealed the identities of the three gunmen and confirmed their Pakistani nationality and LeT affiliation. Investigators said that Parvaiz and Bashir had provided food, shelter, and other logistical support to the militants, who had taken refuge in a seasonal dhok (hut) at Hill Park before launching the strike. The two accused were presented before Additional District and Sessions Judge Ritesh Kumar Dubey in Jammu, who remanded them to NIA custody till June 27. Officials described the arrests as the first major development in the high-profile probe.

The NIA has alleged that the attack was carried out with a clear motive, as the terrorists selectively targeted victims based on religious identity, making the incident one of the most brutal terror strikes in recent memory. Meanwhile, the Financial Action Task Force (FATF) has strongly condemned the Pahalgam attack and is expected to issue a report addressing state-sponsored terrorism for the first time.

AAP Defeats BJP In Big Gujarat Bypoll, Congress Scores Kerala Seat

Prime asset for India: Shashi Tharoor's big praise for PM on Op Sindoor outreach

Tharoor, who was part of the multi-party delegation, emphasized that the mission showcased India's unity and strategic clarity. He wrote that the outreach reinforced the importance of "the power of unity, the efficacy of clear communication, the strategic value of soft power, and the imperative of sustained public diplomacy" in navigating today's complex international landscape. He also noted that India's future global strategy should be driven by the "three T's"—tech, trade, and tradition—to build a "more just, secure and prosperous world."

Addressing criticism from within his own party over his praise for the Modi government's handling of Operation Sindoor, Tharoor defended his stance, saying the delegation clearly explained that India's actions were a legitimate exercise of



self-defense against persistent terrorism. reach when Colombia initially expressed condolences for casualties in Pakistan but retracted the statement after Tharoor's intervention, underlining the importance of factual diplomacy.

Tharoor also pointed out the continued global acknowledgment of Pakistan's links to terrorism. He revealed that while a Pakistani delegation was present in Washington DC, US officials echoed India's concerns about terror groups like Lashkar-e-Taiba and Jaish-e-Mohammed, validating India's narrative with "verifiable facts and consistent advocacy."

Despite facing backlash from Congress colleagues, Tharoor dismissed critics as distorters of his views and reaffirmed his commitment to constructive dialogue. He recently met PM Modi on June 11, alongside other delegation members, following the conclusion of the outreach mission.

India Poised to Outpace G7 Economies in **Growth, Says Equirus Report**

India is set to significantly outpace major G7 economies in economic growth, driven by robust structural advantages and policy momentum, according to a new report by wealth management firm Equirus, released on June 23, 2025.

Highlighting India's rising global economic influence, the report projects the country will contribute over 15% to global GDP growth between 2025 and 2030—far surpassing Japan (under 1%) and Germany (just over 1.3%).

"India is no longer just the fastest-growing economy on paper it's structurally better positioned than most G7 nations. That's a seismic shift," said Mitesh Shah, CEO of Equirus Credence Family Office.

Key drivers of this growth include strong macroeconomic fundamentals, government-led capital expenditure, a revival in ru-

ral consumption, and structural shifts in global manufacturing. The report emphasizes a notable rise in rural fast-moving consumer goods (FMCG) demand, which grew 6% compared to just 2.8% in urban areas. Over the past decade, the spending gap between rural and urban households has narrowed from 84% to 70%.

A 17.4% surge in capital expenditure, backed by both central and state governments, is also a major growth engine. The report notes this is supported by a ₹2.5 lakh crore liquidity boost from phased CRR (Cash Reserve Ratio) cuts.

Global tailwinds are also reinforcing India's position. A 6% decline in the US Dollar Index from its peak and stable crude oil prices at \$70 per barrel are easing inflation and import pressures.

The report critiques the traditional 60/40 investment portfolio model, calling it outdated in today's volatile global landscape. Instead, it urges investors to adopt a dynamic, diversified strategy across geographies and sectors, with India at the center of longterm alpha generation and capital preservation.







Putin Meets Iranian Foreign Minister, Slams US Strikes as 'Unprovoked Aggression'

Russian President Vladimir Putin met with Iranian Foreign Minister Abbas Araghchi at the Kremlin on Monday, June 23, 2025, in a strong show of support for Tehran amid escalating tensions in the Middle East. The meeting comes just days after the United States launched major airstrikes on Iranian nuclear facilities, including the underground Fordo site.

Putin condemned the US attacks as "absolutely unprovoked aggression," saying they had no legal or moral justification. "This is an absolutely unprovoked aggression against Iran; it has no basis or justification," Putin told reporters during the meeting. He emphasized Russia's commitment to aiding Iran and reaffirmed the "long-standing, good, reliable relations" between the two countries.

Iranian Foreign Minister Araghchi, in turn, thanked Russia for standing by Tehran and for condemning the military actions of both the United States and Israel. He described the strikes as illegitimate and in violation of international law. "These aggressive actions by Israel and the US are completely illegitimate and violate international rules and norms. We are defending our sovereignty and our country, and our defence is legitimate," Araghchi stated.

He also acknowledged Russia's continued cooperation in Iran's peaceful nuclear programme, highlighting Moscow's role in constructing the Bushehr nuclear power plant and acting as a mediator during previous nuclear negotiations.

The Kremlin meeting comes at a time of mounting global concern over the escalating conflict in the region. Russia's backing adds a new layer of complexity to the unfolding crisis, as world powers align behind opposing sides. The meeting not only signals strengthened strategic ties between Moscow and Tehran but also positions Russia as a vocal critic of Western military interventions in the Middle East, particularly those led by the United States and Israel.

South Korea Appoints First Civilian Defence Minister in 64 Years Amid Cabinet Overhaul

South Korean President Lee Jae Myung has named veteran lawmaker Ahn Gyu-back as the country's first civilian Defence Minister in 64 years, fulfilling a key campaign promise following last December's martial law controversy. The announcement was made on June 23, 2025, as part of a broader cabinet reshuffle aimed at restoring public trust and stabilizing governance.

Lee, who assumed office on June 4 after winning a snap election triggered by the impeachment of former President Yoon Suk Yeol, also nominated ten other Cabinet Ministers. These include former U.N. ambassador Cho Hyun as Foreign Minister and Chung Dong-young, a North Korea diplomacy advocate, as Unification Minister. Lee's administration is working quickly to form a new government and

Pakistan Faces Backlash for Nominating Donald Trump for Nobel Peace Prize

The Pakistan government and its military establishment are under fire from citizens and commentators alike after Deputy Prime Minister Ishaq Dar formally nominated U.S. President Donald Trump for the Nobel Peace Prize. The announcement, which came in the form of an official letter sent to the Nobel Committee in Norway, sparked a wave of outrage across social media platforms, especially X (formerly Twitter).

Zelenskyy Accuses Russia of Returning Dead Soldiers in Prisoner Exchanges

Ukrainian President Volodymyr Zelenskyy has publicly condemned Russia for sending back the bodies of at least 20 deceased Russian soldiers during recent exchanges involving prisoners of war and fallen troops. Speaking to The Guardian, Zelenskyy described the act as a grim and disrespectful gesture, stating, "They threw the corpses of their citizens at us."

According to Zelenskyy, the returned remains were part of the ongoing prisoner swaps and exchanges of war dead between the two countries amid the prolonged conflict. The Ukrainian leader highlighted the disturbing nature of these returns, emphasizing the toll the war is exacting on both sides.

Among the bodies returned was reportedly an individual identified as an "Israeli mercenary" fighting alongside Russian forces, reflecting the complex and multinational composition of troops involved in the conflict. Zelenskyy did not provide further details on this mercenary but suggested that the identities of many of the deceased have been difficult to confirm.

some of the returned bodies were found to still carry Russian passports, raising questions about the authenticity of Russia's military casualties and the circumstances surrounding the deaths. This detail hinted at possible irregularities or attempts by Moscow to obscure the full extent of its losses.

Israel Strikes Iran's Fordo Nuclear Site Again Amid Escalating Tensions

Israel launched another airstrike on Iran's heavily fortified Fordo underground nuclear facility on Monday, June 23, marking a sharp escalation in the ongoing conflict. Iranian state media confirmed the attack but did not provide details on the extent of the damage or the parties responsible. However, Israeli airstrikes throughout the day strongly suggest its involvement.

This latest strike follows the United States' significant military action on Sunday, targeting three major Iranian nucle-

ar sites, including Fordo, using advanced bunker-buster bombs. The Biden administration, while distancing itself from calls for regime change, emphasized the attacks were strictly aimed at Iran's nuclear capabilities. Nevertheless, former U.S. President Donald Trump reignited speculation with a provocative social media post questioning Iran's leadership and hinting at the need for regime change.

Iran responded swiftly and forcefully. On Monday, it launched a barrage of missiles and drones at Israel, targeting cities like Haifa and Tel Aviv as part of "Operation True Promise 3." Israel activated its missile defense systems and urged citizens to seek shelter in response.

Meanwhile, the International Atomic Energy Agency (IAEA) confirmed "very heavy damage" at the Fordo site. Iran's parliament is now considering a bill to suspend cooperation with the



IAEA, accusing the body of bias and political manipulation.

In related developments, an Israeli drone was downed in Iranian territory, and Israel's military reported multiple airstrikes on missile facilities across western Iran. Iran also executed a man accused of collaborating with Israeli intelligence, underscoring rising internal tensions.

Commercial airlines are re-evaluating routes across the Middle East, with major carriers like Singapore Airlines and British Airways cautiously resuming flights to hubs such as Dubai and Doha.

As the region edges closer to open conflict, both Washington and Tehran are navigating a precarious balance between strategic deterrence and uncontrollable escalation.

In 2014-15, India's coffee exports were valued at just over USD 800 million. The figure climbed steadily to USD 1.14 billion in 2022-23, followed by USD 1.28 billion in 2023-24, culminating in the current surge to USD 1.8 billion. This significant growth highlights India's expanding footprint in the global coffee market.

Europe remains the largest importer of Indian coffee, with countries such as Italy, Germany, and Belgium leading demand. Other key markets include Middle Eastern nations, South Korea, and Japan, underscoring India's diversified export portfolio.

Several initiatives by the Coffee Board of India have been instrumental in boosting these exports. These include streamlining processes through the online issuance of critical documents such as registration-cum-membership certificates (RCMCs), export permits, and certificates of origin, all digitally signed for faster turnaround. The Board also maintains regular engagement with exporters to identify and resolve bottlenecks, ensuring smoother trade operations.

Additionally, the Coffee Board provides exporters with timely global market insights and intelligence to help them make informed decisions and stay competitive. SEBI to Simplify Mutual Fund Regulations for Investors and Industry

The Securities and Exchange Board of India (SEBI) is undertaking a major review of mutual fund regulations aimed at making them more investor-friendly and easier for the industry to navigate, a senior official announced on June 21, 2025.

Speaking at the 17th Mutual Fund Summit in Kolkata, SEBI Executive Director Manoj Kumar said the regulator is revisiting the entire regulatory framework to enhance the ease of doing business for all stakeholders, including itself. Kumar acknowledged that existing rules are among the most complex and lengthy, necessitating simplification to keep pace with changing investor demands and industry innovation.

Though no exact timeline was provided, Kumar stated that a draft of the revised regulations will soon be shared for public feedback and consultation before finalization. Alongside this, SEBI is preparing a consultation paper on advisory regulations within the mutual fund sector.

Highlighting mutual funds as a key pillar for inclusive financial growth and investor protection, Kumar noted that while India's mutual fund assets under management (AUM) have crossed Rs 72 lakh crore, with monthly SIPs reaching Rs 28,000 crore, the investor base remains limited to about five crore people in a population of 140 crore.

SEBI is also working on simplifying scheme categorization to make it more intuitive and prevent mis-selling. The regulator has recently approved a new product category called SIF,



targeting investors with ticket sizes between Rs 10 lakh and Rs 50 lakh, managed by mutual funds for their governance standards. Additionally, registration for Portfolio Management Services (PMS) and Alternative Investment Funds (AIF) has been accelerated. Addressing concerns about disclosure requirements, particularly stress tests for mid- and small-cap funds, Kumar emphasized SEBI's commitment to transparency while remaining open to streamlining procedures. He encouraged the industry to proactively avoid regulatory issues, reinforcing that SEBI's aim is to support business growth, not disrupt it.

Kumar also identified eastern India, including West Bengal and the Northeast, as strategic regions for expanding mutual fund penetration. Echoing this vision, AMFI CEO V N Chalasani emphasized the need to improve financial literacy and deepen mutual fund adoption beyond urban centers through education and new product innovation, aiming to transform every Indian into a wealth creator.

India's Crude Oil Imports Hit Record High in May Amid Rising Demand and Global Tensions

∎ndia's crude oil imports soared Lto a record 23.32 million metric tons in May 2025, marking a nearly 10% increase monthon-month, government data revealed on Monday. This surge reflects robust economic and industrial activity in the country, which is the world's third-largest importer and consumer of crude oil.

The Oil Ministry's data also showed that fuel demand in India rose to 21.32 million metric tons in May — the highest level in over a year. This uptick comes amid heightened geopolitical tensions following U.S. airstrikes on Iran's nuclear facilities, raising concerns about potential disrup-

tions to oil and gas supplies from the Middle East. Consequently, global oil prices surged to their highest point since January. Addressing the situation, India's Oil Minister Hardeep Singh Puri assured that the government will take necessary steps to safeguard domestic

fuel supplies in response to these risks. While overall crude oil imports climbed 5.9% compared to May 2024's 22.03 million metric tons, the share of Russian oil in India's imports dipped slightly. Refineries reduced their purchases from Russia by 15.7% to 1.7 million barrels per day, reflecting shifts in sourcing amid global sanctions and market dynamics.

In contrast to rising crude imports, India's imports of refined petroleum products fell about



3.9% year-on-year to 4.20 million metric tons in May. Meanwhile, exports of petroleum products increased over 7% to 5.63 million metric tons, highlighting India's growing role as a regional fuel supplier.

This data underscores India's expanding energy needs driven by sustained industrial growth and rising fuel consumption. It also highlights the country's efforts to diversify oil sources and balance imports amid volatile global markets. With ongoing geopolitical uncertainties and energy prices remaining high, India's strategic focus remains on securing stable and affordable fuel supplies to support its economic growth trajectory.





'I Can't Stay Silent **Anymore': Former Zepto Employee Exposes Food Safety Violations**



uick-commerce startup Zep-**X**to is under fire after a forfood safety violations and poor working conditions, prompting public outrage and regulatory action. The revelations come as the Maharashtra Food and Drug Administration (FDA) has already suspended Zepto's food business license in Mumbai's Dharavi for breaching hygiene and safety standards.

The whistleblower, who claims to have worked at Zepto for three years, detailed disturbing practices in a now-viral Reddit post. "I can't stay silent anymore," the post begins. One specific instance cility found fungal contaminadescribes expired Greek yogurt being knowingly delivered to a customer after management allegedly said, "Give it anyway."

The employee paints a grim picture of daily operations, including packing groceries in monsoon-flooded warehouses in Pune, often filled with gutter water. "We worked more than 9 hours in that dirty water without shoes. Many of us fell sick, but no medical compensation was

given," the post reads. Damaged fruits, rotting vegetables, and mer employee exposed alarming expired products, the employee claims, were routinely packed and sent to customers.

> Public reaction has been swift. Several social media users shared their own experiences with delayed deliveries, spoiled groceries, and lack of customer support. "These apps were supposed to make life easier—now they're just unreliable," one user commented. Others pointed to competitors like Blinkit and BigBasket as better alternatives.

> Earlier this month, a raid by the Maharashtra FDA on a Zepto fation on food, poor cold storage, and generally unsanitary conditions—leading to the license suspension.

> The incident raises serious concerns about food safety in India's booming quick-commerce sector. While Zepto has yet to issue a detailed public response, calls for greater regulation and consumer transparency are growing louder in light of the controversy.

Woman Wears Makeup Daily for 22 Years, Suffers Severe Skin Damage

she revealed the devastating effects of wearing makeup every single day for 22 years—without ever properly removing it. Known online as Niuyoumian, the 37-year-old from China's Jilin province shared her painful story, drawing attention to the long-term risks of poor skincare and heavy cosmetic use.

In a video widely circulated on social media, Niuyoumian appears with visibly inflamed, red, and swollen skinsymptoms of what she refers to as "hormone face," a chronic skin condition caused by prolonged exposure to cosmetic chemicals and inadequate cleansing routines.

According to South China Morning Post, her skin problems began as early as age 14 after using an unsuitable acne cream. By 15, she was wearing makeup daily and continued the habit for over two decades. Working in the beauty and hair industry, she was also regularly exposed to strong salon chemicals. Using inexpensive, low-quality foundations only worsened her condition.

Despite suffering early signs like redness and itching, she ignored them. "I thought it could be fixed with some



ointment," she admitted. "But after 25, everything changed."

Niuyoumian eventually turned to facial injections in 2011, hoping to improve her skin. However, these treatments backfired, further damaging her complexion. She has since been diagnosed with rosacea and Demodex mite infestations. "At its worst, it felt like ants crawling on my face," she said.

Reflecting on her journey, she acknowl-

edged that her impatience and constant switching of skincare products only made things worse. Now, with nearly 30,000 followers, she urges others: "Don't blindly trust beauty products just because someone else says they work." Her experience has sparked widespread discussion online about responsible makeup use, the importance of proper skincare, and the hidden costs of beauty standards.

Brain's Built-In Signal Threshold Helps Distinguish Imagination from Reality

 $\mathbf{N}^{ ext{ew}}$ research reveals that the brain uses a built-in "signal threshold" to differentiate between real visual experiences and imagined ones. This discovery sheds light on how our minds distinguish reality from imagination and has important implications for understanding mental health conditions like schizophrenia, where this distinction often blurs. Scientists at University College London conducted a study using functional MRI scans on 26 volunteers. Participants were shown diagonal lines on a noisy screen sometimes real, sometimes imagined. When participants imagined lines that matched the expected visual input, they were more likely to report seeing something even if nothing was actually shown. This suggested that strong internal signals from imagination can trick the



brain into perceiving something as real.

Both real and imagined visuals activated the fusiform gyrus, a key brain region involved in visual processing. However, the brain only recognized the input as "real" when the activity in this region passed a certain intensity threshold. Alongside the fusiform gyrus, the anterior

insula—a region linked to decision-making—also became active, possibly acting as a "reader" that evaluates the strength of the visual signal.

Lead researcher Nadine Dijkstra explained that although imagination stimulates the same brain area as real visuals, the signal generated by imagination is usually too

weak to convince the brain that it is perceiving actual external input. Understanding this threshold system offers new insights into hallucinations and other mental health disorders that affect perception.

Experts say these findings represent a significant step forward in understanding how the brain monitors reality versus imagination. Future research will explore more complex visual stimuli and real-world perceptions, including faces and animals. There is also interest in whether brain stimulation techniques could enhance imagined perception or help address perception-related disorders.

This study provides a crucial foundation for unraveling the neural mechanisms behind how we experience and interpret reality.

The stampede near Bengaluru's M. Chinnaswamy Stadium led to the death of 11 people and left over 50 injured, prompting widespread concerns over crowd management and event planning.

BCCI secretary Devajit Saikia confirmed that the incident is under serious investigation and that the newly issued protocols will be mandatory for all IPL fran-

chises. "We are responsible for cricket in India, and again," Saikia stated.

Alexander Bublik Defeats Medvedev to Clinch Fifth ATP Title in Halle

Kazakhstan's Alexander Bublik se-cured his fifth ATP title on Saturday with a straight-sets victory over Daniil Medvedev in the final of the Halle Open, a key grass-court warm-up ahead of Wimbledon. The 28-year-old triumphed 6-3, 7-6(4) in just 82 minutes, marking his first-ever win over Medvedev in seven career meetings.

Ranked 45th in the world going into the tournament, Bublik stunned world number one Jannik Sinner in the second round and carried that momentum all the way to the title. His impressive run culminated with a commanding performance against third-seeded Medvedev, who was appearing in his first final in 15 months.

This win marks Bublik's second Halle title, having previously lifted the trophy in 2023. He also owns titles from Montpellier (2022, 2024) and Antwerp (2023), estab-



lishing himself as a formidable player on both hard and grass courts.

With the victory, Bublik is projected to climb to No. 30 in the ATP rankingshis highest in recent months. "This win means a lot," Bublik said after the match. "Beating Daniil and getting this title right before Wimbledon gives me great confidence."

For Medvedev, the defeat was a bitter one. The former world No. 1, who last won a title at the Rome Masters in May 2023, has now lost six consecutive finals. Despite reaching the final, he couldn't find an answer to Bublik's powerful serve and unpredictable shot-making. Still, Medvedev's run in Halle will push him up to No. 9 in the ATP rankings, a much-needed boost heading into Wimbledon. As both players prepare for the year's third Grand Slam, Bublik's form on grass could make him a dark horse at the All England Club.

Censor Board Halts Release of Suresh Gopi's Film Over 'Janaki' Title Controversy

The release of the Malayalam film Janaki vs State of Kerala, starring Union Minister and actor Suresh Gopi, has been stalled following the Central Board of Film Certification's (CBFC) demand to change the film's title. The censor board objected to the use of the name 'Janaki' because it is also a name of the Hindu goddess Sita, raising religious concerns. The film was originally scheduled for release on June 27, 2025. The movie narrates the story of a woman who faces sexual assault and pursues a legal battle against the state. According to the CBFC, the name of a revered goddess should not be associated with a character who endured such trauma. The film had been cleared by the CBFC's regional office in Thiruvananthapuram with a U/A certificate, but the Mumbai headquarters later demanded the title change, which has delayed the release.

Changing the title would also require



modifying numerous dialogues within the film where the name 'Janaki' is used, complicating the process further. The Film Employees Federation of Kerala (FEFKA) has condemned the CBFC's demand and warned of protests if the board does not retract its request. Director MB Padmakumar shared that his own film Token Number faced a similar issue, where he had to change the character's name from Janaki to Jayanthi to secure certification. He expressed frustration at the inconsistency, explaining that while the Trivandrum office cleared the film, the Mumbai office later intervened with demands communicated unofficially through WhatsApp messages.

Padmakumar suggested that this could be the result of personal biases among officials rather than a government directive, noting, "If there was such an agenda, the film would have been sent to the revising committee officially." The controversy has sparked widespread criticism within the Malayalam film industry.
