

Is the Telangana Narcotics Team **Iooking for Mr. Pulaparti Prashant?**

- Allegations link MLA Anjibabu's son to drug use
- Hyderabad Narcotics Team reportedly trying to locate him
- Prashant's name surfaced in customer data seized during raids

Yes, say officials. Mr. Pulaparti Prashant, who is Bhimavaram MLA Anjibabu's son, and Son-inlaw of Mr. MLA Ganta Srinivasa Rao, has recently been in the spotlight due to controversies involving a cricket franchise. His name has also surfaced in connection with poker and wine businesses running in the Bhimavaram constituency. There are allegations that he is managing Bhimavaram's affairs as if he were the MLA himself.

Though not a dominant figure in Bhimavaram politics earlier, Prashanth was born there. As he is son-in-law of Ganta Srinivasa Rao, He used to stay at Vizag also. But locals say he has more influence in Hyderabad than in either of those places. Even when he visits Bhimavaram, he reportedly doesn't go home but spends time with friends in Suite No. 8888 at the Fortune Hotel, which is their own. But now, a new and serious Prashanth currently serves as issue has come to light allegations of drug use. Known for his fondness for alcohol and card games, Prashanth's social habits have already raised eyebrows. Locals claim such habits are common among many nowadays, but the mention of drugs has taken everyone by surprise. This information didn't come from the public — it came directly from a official of Hyderabad

Narcotics Team. Recently, the Narcotics and Task Force teams busted several gangs supplying drugs and reportedly extracted detailed customer data. Based on this data, they identified various users and supply centers — and according to sources, Prashanth's name is on that list allegedly. It is said the Narcotics Team is currently searching for him as per the sources. He is not at his home in Hyderabad, and officials report that his phone is switched off. His whereabouts are unknown, but an official stated that his mobile's last known location was Shamshabad Airport, suggesting he may have flown abroad. However, since no charges have been confirmed yet, no further details have been officially checked. At present, there are only suspicions of drug use. What makes the situation

more concerning is the suspicions are proven true. Vice President of the Andhra Cricket Association. If proven to be a drug user, questions will arise about whether someone facing such allegations can hold a leadership position in an association that strictly monitors its players for drug use. the allegations as baseless. They insist he may have gone abroad on business. Moreover, he's a helpful figure in Bhimavaram, they claimed. They argue that while there are always rumors, Prashanth is known for resolving local issues effectively. They also claim that handling transfers, postings, and contracts is standard practice for any MLA or their circle — and there's nothing unusual about it.

Prashanth is listed as a director in multiple companies — some possible fallout if these active, others in name only. Records show that influential face legal trouble, although individuals are associated with these ventures, mostly from his friend circle in Bhimavaram and Hyderabad. They argue that such associations are to be expected. Interestingly, Prashanth appears to have no social media presence. MLA Anjibabu, once known as a respected figure with vast aquaculture assets, reportedly faced significant debts by the last election cycle but is said to have cleared them. Given the

scale of operations Prashanth now oversees — from cricket franchises to local influence many wonder who's backing him. MP Sana Satish and Uncle Ganta Srinivasa Rao are the supporters to him.

Still, the fact that Prashanth's name is being linked to a drug case is worrisome. In the past, authorities have imposed strict legal action on drug suppliers under severe sections.

Now, even consumption or possession of drugs is treated as a serious crime. There are concerns that Prashanth may

Amaravati: The Andhra Pradesh government is developing the country's first dedicated Quantum Valley in Amaravati. Scheduled for inauguration on January 1, 2026, Chief Minister N. Chandrababu Naidu, renowned for ushering in the IT revolution in the 1990s, now leads this transformative effort. Spread over 50 acres, the Quantum Valley will house cutting-edge facilities, including IBM's 156-qubit Quantum System Two, India's most powerful quantum computer. The Quantum Valley Tech Park is envisioned as more than a research hub; it's a complete innovation ecosystem integrating academia, industry, startups, and government. Andhra University and other state institutions will introduce degree programs in quantum computing from the 2025–26 academic year to build a future-ready workforce. Global partnerships with Purdue University (USA) and the University of Tokyo (Japan) have already been signed, highlighting its international appeal.

Beyond computing, the Valley will encompass fields like artificial intelligence, semiconductor design, post-quantum cryptography, advanced materials, aerospace, and defence technologies. It is expected to attract investments from MNCs, defence agencies like ISRO and DRDO, and space-tech firms, creating a vibrant, multi-disciplinary R&D and manufacturing cluster. The Quantum Valley also reinforces national missions such as

However, Prashanth's close friends and admirers dismiss some argue that even in such cases, bail is usually granted and major issues may be avoided. East Godavari: The river of life, Godavari... is becoming lifeless in the hands of the sand mafia. They have no regard for the Supreme Court verdicts. They ignore the orders of the National Green Tribunal. They dig recklessly with machines, destroying the riverbed. What is striking is the complete indifference shown by public representatives and officials, despite this large-scale destruction.

Ever since the coalition government came to power, the sand mafia has been raging across the East Godavari district. Allegations are widespread

that a man named RK (Ramakrishna) from Guntur has become the don of the sand mafia in this region.

After the joint government announced the free sand policy and permitted sand ramps, irregularities at these ramps have become rampant. Excavations and sales are carried out without necessary permits or supervision. Since the Collector's directives in June, illegal excavation and transactions have been happening openly at the ramps, led by middlemen. There are no laborers in sight — only dredging boats filling up the Godavari. It is an open secret that RK is overseeing the entire operation.

During the YSRCP regime, RK flaunted photos with then-minister Peddireddy Ramachandra Reddy and Chief Advisor Sajjala Ramakrishna Reddy, claiming close relations to run his illegal empire. He earned crores. After the coalition government came to power, he seamlessly continued his operations, now hand-in-hand with the new regime. The same Telugu Desam, Jana Sena, and BJP leaders who once criticized RK are now being questioned for their silence.

Now, locals are raising doubts about their silence as

the same RK continues his illegal operations.

Illegal transportation of sand, unregulated dredging — all continue unabated across Dhavaleswaram, Burrilanka, Kateru, and other parts of Rajahmundry Rural. It's evident that RK has successfully influenced leaders and officials. No rules, no respect for the Green Tribunal, no oversight — just 25 boats digging up and transporting sand with dredging engines. District-level officials are silent spectators.

Ironically, even in Rajahmundry Rural — where the District Collectorate is located — sand is being illegally dredged from the Godavari in Dhavaleswaram, Burrilanka, and Kateru, especially at night. SEB, Irrigation, Mining, and Police officials are reportedly watching silently as the sand mafia dredges from 8 pm to 5 am — completely against the rules. Despite assurances that the Godavari would be protected, neither the ruling nor opposition leaders have questioned the sand mafia's activities. In fact, complaints are mounting that the new government's sand policy is worse than the YSRCP's.

During the YSRCP regime, sand mining rights were handed over to JC Company, which sub-leased management to another firm — Arki. Allegations continue that dredging under both these entities has heavily damaged the Godavari. What's shocking is that these operations have continued under the joint government without any fresh permissions.

Dredging is being touted as a "blessing" — but it is a curse. Dredging boats have become the sand mafia's gold mines. The illegal operations begin after 7 pm and run until 5 am. Even after the District Collector warned that bridges on the Godavari are at risk due to this activity, Vigilance and SEB officials are not acting.

In East Godavari, sand ramps managed by boatsmen are more active than official reaches. Rajahmundry Rural's Kateru, Dhavaleswaram, and Jonnada areas are hotspots where dredging boats operate illegally round the clock under the boatsmen's leadership. It's widely known that all these dredging machines originate from Vijjeswaram. Shocking allegations suggest that some irrigation staff are not only allowing but also carrying out the dredging. Vigilance officials allegedly collude by showing only ordinary boats during inspections.

If caught by SEB, the mafia pays hefty penalties — but no criminal cases are filed. In fact, mafia members themselves admit that fines are routine and expected. The same boats are used for dredging and regular transport — blurring the lines and making it harder for enforcement agencies to act. These dredging machines, however, are causing severe ecological damage by removing massive amounts of sand from the Godavari riverbed. Recently, RDOs and Joint Collectors conducted surprise inspections across East Godavari. Dredging machines and lorries were seized; many ramps were shut down. Authorities have temporarily halted operations at open reaches. After receiving night-time violation complaints, the RDO-led raids intensified, with machinery seizures and criminal cases being filed. Still, the reality is undeniable — even as District Collector Prasanthi announced stricter action, departments like Mines, Irrigation, Police, and Vigilance had to join hands for surprise raids. The crackdown revealed the scale of illegal activity and the need for urgent, continued action to save the lifeline of Andhra Pradesh — the Godavari.

Farmers Demand Return of Lands Taken for Jindal Project in Vizianagaram

- Farmers protest as Jindal project remains unfulfilled after 17 years
- Allegations of land being sold to private players at high prices

Vizianagaram: Farmers from Kilthampalem, Cheedipalem, Pedakhandepally, and Moola Boddavara villages in Srungavarapukot mandal of Vizianagaram district are intensifying their protests, demanding that the lands acquired from them in 2007 for Jindal's aluminium project be returned.

The lands, measuring 1048.65 acres,

were acquired by the then Congress government for setting up a Jindal Aluminium factory with a projected capacity of 1.4 million tonnes. Seventeen years on, not only has the company failed to materialise, but none of the promises made to farmers—jobs, company shares, or proper compensation—have been fulfilled, the farmers allege.

Adding to their frustration, farm-

handed over to other private companies, with no consultation or consent from those who originally gave up their lands. Many farmers say they were forced to part with their lands at very low rates based on assurances from Jindal management that have now proven hollow. "The Jindal group took our land with promises of jobs and equity, but they didn't even lay a foundaers claim the lands are now being tion stone for the factory," said one



protesting farmer. "Now we hear our lands are being resold at higher prices to private players-this is betrayal.'

The aggrieved farmers emphasized that they are not opposing development or industrialisation but want justice for those who sacrificed their livelihoods. They demanded either their lands be returned or the government take possession of the unused lands and ensure local youth get jobs as originally promised. MLA Kolla Lalitha Kumari of Srungavarapukot has assured the agitating farmers that their concerns will be addressed. Speaking to reporters, she stated, "We will do justice to all land-displaced farmers. Soon, we will hold village-level meetings in the presence of government officials to identify genuine land donors and escalate the issue to higher authorities."

She added that development in the region should go hand-in-hand with justice for the local communities and expressed hope that future industrial growth would also secure employment for the youth of the region.



Chief Minister Nara Chandrababu Naidu on Tuesday drew a sharp parallel between the 1975 Emergency and the recent five-year rule of the YSRCP, calling both glaring examples of how democracy should not function. Addressing the gathering at the "Samvidhan Hatya Diwas" program held at Tummalapalli Kalakshetra, Vijayawada, the CM paid tribute to Dr. B.R. Ambedkar and recalled the grave violations of rights and democratic values that occurred during the Emergency imposed 50 years ago.

"Emergency is a destruction of a case study in dictatorship, democracy," said Chandrababu, describing June 25, 1975, as the day India's Constitution and fundamental rights were trampled. He condemned the then government's crackdown on dissent, including the imprisonment of leaders like Jayaprakash Narayan, Vajpayee, Advani, George Fernandes, and many from Andhra Pradesh. 
In a significant development in Rayalaseema politics, senior TDP leader Sugavasi Balasubrahmanyam has left the Telugu Desam Party and joined the YSR Congress Party. The former chairman of the united Kadapa Zilla Parishad officially joined the YSRCP in the presence of party president and former Chief Minister Y.S. Jagan Mohan Reddy.

Speaking on the occasion, Balasubrahmanyam said that he had taken the decision to leave the TDP after enduring continuous insults and political marginalization in the Rajampet unit of the party. "Unable to bear the humiliation anymore, I have decided to work under the able leadership of Jagan Mohan Reddy, who has a clear vision for the development of the state," he stated.

Balasubrahmanyam began his political journey in 1995 as the heir of prominent leader Sugavasi Palakondrayudu, winning the ZPTC from Rayachoti. He later served as the Chairman of the united Kadapa Zilla Parishad in 2000, and was re-elected as ZPTC in 2001. Despite multiple electoral defeats, including from Rayachoti in 2012 and most recently from Rajampet in the 2024 general elections as a TDP candidate, he has remained an active political figure.

His switch to the YSRCP is being viewed as a setback to the TDP's prospects in the Rajampet region, especially considering his experience and influence in the local political landscape. His entry is expected to strengthen the YSRCP's base in the Rayachoti-Rajampet belt, which continues to be a politically sensitive zone in Kadapa district.

Liquor Scam: Mohit Reddy Seeks Time, Skips SIT Hearing

The investigation into the high-profile liquor scam rocking Andhra Pradesh has intensified, with the Special Investigation Team (SIT) tightening its focus on accused individuals. Among them is Chevireddy Mohit Reddy, son of senior YSRCP leader Chevireddy Bhaskar Reddy, who has now emerged as Accused No. 39 (A-39) in the case. Despite being summoned by the SIT for questioning today, Mohit Reddy failed to appear before the investigating team. Sources say he cited personal reasons and has sought three more days to present himself for the inquiry.

Meanwhile, in an apparent move to preempt arrest, Mohit Reddy has filed an



anticipatory bail petition in the Vijayawada ACB court. The court is expected to hear the petition today, even as the SIT continues to pursue the case against him and other accused.

The SIT has already arrested Chevireddy Bhaskar Reddy, along with his alleged benami Venkatesh Naidu, in connection with the scam. In its remand report submitted to the court, the SIT revealed direct involvement of both father and son, highlighting financial irregularities and suspicious transactions related to the alleged scam.

The scam, which has drawn widespread attention, involves allegations of massive irregularities in liquor contracts and illegal earnings. As more names surface, the case is likely to have significant political ramifications, especially given the stature of the individuals involved. With the SIT digging deeper and court proceedings underway, all eyes are now on Mohit Reddy's next move, and the court's decision on his anticipatory bail plea.

CITU Calls Panchayat Workers to Join July 9 Strike

The Centre of Indian Trade Unions (CITU) has urged panchayat workers across the country to participate in a nationwide strike on July 9, pressing for better wages and working conditions. Addressing a preparatory meeting in Pathapadu, CITU NTR district leader M. Someswara Rao called upon all rural workers to support the agitation to protect their rights.

Strike notices were formally submitted to the Gram Panchayat Secretaries of Pathapadu (P. Kotilingamma), P. Nainavaram (Santosh), and Ambapuram, indicating strong local mobilization in support of the national call. Rao demanded the implementation of a minimum wage of ₹26,000, along with Employees' State Insurance (ESI) and Provident Fund (PF) benefits for panchayat workers. He also stressed the need to repeal the four controversial labor codes introduced by the BJP-led central government, accusing Prime Minister Narendra Modi's administration of enacting pro-corporate legislation at the cost of workers' welfare.

"Since Modi came to power, the labor laws have been modified to benefit corporations, weakening hard-



won labor protections," Rao asserted. He urged all rural workers to unite and voice their demands collectively on July 9.

CITU leaders M. Anjaneyalu, along with local Gram Panchayat Union leaders Durga Rao, Shankar, Shyam Kumar, and Vamsi, were also present at the meeting. The leaders emphasized that only through mass participation and solidarity can the working class compel the government to address their demands.

Vijayarau added that quantum computing, combined with AI, is advancing risk analysis, climate change solutions, and supply chain management.

The Quantum Valley is expected to generate significant employment opportunities, particularly for startups, and foster collaboration with educational institutions. Bhaskar debunked myths about job losses due to quantum technology, clarifying that it complements traditional computing and addresses complex problems unsolvable in short timeframes. Admissions Must Rise in Govt Schools: Collector Shyam Prasad

District Collector A. Shyam Prasad on Thursday directed education department officials to intensify the student enrollment drive across the district and ensure a significant rise in admissions to government schools. Addressing a review meeting with education officials and junior college principals at the Collectorate, the

Collector expressed concern over the sharp drop in Class 1 admissions this year. "There are 4,132 fewer Class 1 students compared to last year. This gap must be filled through the enrollment campaign," he emphasized.

The Collector instructed that the drive must involve digital assistants, teachers, Panchayat secretaries, Anganwadi supervisors, and VROs, who should actively reach out to communities to encourage parents to admit their children into government institutions.

He pointed out that students who have already joined schools but have not completed online registration must be updated in the system within the next two days. "Every student must be allotted a Permanent Education Number (PEN), which is essential for registration and for availing benefits like the Mother's Salute program," he said. Shyam Prasad underlined that government schools are now offering better infrastructure, academic standards, and free provisions including textbooks, uniforms, shoes, notebooks, and nutritious mid-day meals. He stated that these advantages should be properly communicated to parents to shift the perception in favor of government schools.

He also emphasized the importance

of re-enrolling dropout students and instructed teachers to lead this initiative at the grassroots level. "The Mother's Salute program is a step toward improving student retention and involvement of mothers. Necessary certificates must be obtained for this scheme to be valid," the Collector clarified.

The enrollment process, including PEN allocation and awareness efforts, must be completed by July 1st, he said, adding that accountability would be ensured at every level to achieve the targets set for the academic year.

From Emergency to Neo-Emergency: A Democracy **Caught Between Memory and Manipulation**

As India marks the 50th anniversary of the 1975 Emergency on June 26, 2025, the political atmosphere is thick with symbolism, rhetoric, and irony. What should have been a solemn moment of national reflection has become an arena of political theatre. The ruling Bharatiya Janata Party (BJP), invoking the dark past of the Emergency, has launched a full-throttle campaign against the Congress, declaring June 25 as Samvidhaan Hatya Diwas (Murder of Constitution Day). Prime Minister Narendra Modi, Union Home Minister Amit Shah, and even President Draupadi Murmu have echoed this line, presenting themselves as the protectors of democracy and constitutional values.

However, critics argue that this commemoration is not about remembering the past but rewriting it. The same government that claims to honour democracy is accused by its opponents of engineering an undeclared "neo-Emergency"—marked by institutional capture, suppression of dissent, and governance by fear. The Congress and the INDIA bloc have responded fiercely, accusing the BJP of exploiting the memory of Emergency to erase opposition, delegitimise dissent, and entrench authoritarianism.



Historically, the 1975 Emergency was a dark time. Declared by then Prime Minister Indira Gandhi, it suspended civil liberties and fundamental rights. Opposition leaders, including Jayaprakash Narayan (JP), were jailed. JP—an icon of moral courage and democratic integrity—emerged as a beacon of resistance. His peaceful defiance and the subsequent electoral ouster of the Congress in 1977 restored

India's democratic pride.

Today, as the ruling regime commemorates that resistance, critics question whether it truly honours those ideals. The irony is stark: those condemning past authoritarianism are accused of imposing a similar regime now though more sophisticated and silent in its operation. Unlike the overt censorship and mass arrests of 1975,

today's repression is more veiled-enabled by pliant institutions, weakened opposition, surveillance, and polarised media.

The promise of Indian democracy was rooted in the Constitution, which begins with the collective voice: "We, the People of India..."—committing to justice, liberty, equality, and fraternity. But in today's climate, these

ideals are fraying. Justice is inaccessible to the common citizen, liberty is compromised, equality is replaced by widening economic and social disparities, and fraternity is under siege due to growing hate and polarisation.

Voices from the past like Rabindranath Tagore and Subramanya Bharati envisioned a fearless India. Their dreams remain unfulfilled as a fearful silence grips citizens and institutions alike. Leadership today is stifled—by politics, by bureaucracy, even by academia. Youthful dissent is extinguished before it can mature, and political parties, obsessed with power and loyalty, reward mediocrity over merit.

Yet, despite this gloom, there are flickers of resistance-individuals of courage and conscience who move quietly, preparing for a new dawn. These figures, though in silhouette now, may one day emerge to rebuild a democratic India.

As we remember the Emergency of 1975, we must also recognise the neo-Emergency of 2025. The struggle for democracy is not over; it is simply being waged in new forms. The challenge before us is not just to remember history—but to resist the repeating of it.

Skill India at a Crossroads: Leadership Crisis, Mismanagement, and a **Shrinking Demographic Window**

Against a backdrop of factories and promise, the program. Skill India logo symbolizes a national ambition: to empower India's vast youth population with employable skills. But despite this vision, the country's skill development ecosystem is plagued by leadership failures, financial opacity, and misaligned priorities—at a time when the urgency to act has never been greater.

Vocational education in India is largely financed by the government, with minimal participation from the formal private sector. Yet the outcomes remain dismal. Most Indian youth, after receiving a lackluster school education, are either absorbed into the informal sector as unpaid trainees or funneled into the sprawling but underperforming government skill ecosystem.

There are five principal avenues for vocational training: the roughly 14,000 Industrial Training Institutes (mostly private), optional vocational courses in secondary school, short-term government-funded programs like the Prime Minister's Kaushal Vikas Yojana (PMKVY), schemes under other ministries such as the Deen Dayal Upadhyaya Grameen Kaushalya Yojana, and finally, public-private apprenticeship programs.

The PMKVY, managed by the National Skill Development Corporation (NSDC)—a public-private partnership under the Ministry of Skill Development and Entrepreneurship (MSDE)—has come under increasing scrutiny. Over ₹10,000 crore has been spent on Skill India initiatives so far, with a substantial share routed through NSDC. However, the organization's leadership vacuum has raised serious concerns. Key roles like CEO and Chairperson remained vacant for years, and in 2025, NSDC's officiating CEO Ved Mani Tiwari was abruptly terminated after allegations of unauthorized title usage—casting a shadow over the credibility and seriousness of the

Worse, NSDC has become opaque since 2021, launching a new entity-NSDC International-without clear cabinet approval or public transparency. It is unclear what unique role this subsidiary plays, given its parent's similar mandate. Its financial reports are not publicly available, raising questions about oversight and accountability in the use of public funds.

Earlier, in 2015, the Comptroller and Auditor General (CAG) had flagged serious operational lapses within NSDC. Since then, public audits and internal reviews have been largely withheld. Changes in accounting methodology under Tiwari's tenure also warrant close examination—were they aimed at enhancing transparency, or simply improving optics?

NSDC has also invested significantly in technology platforms like ASEEM and SMART, yet India still lacks a fully functional Labour Market Information System (LMIS). Ironically, this critical task may now fall to the Ministry of Labour via its National Career Service portal. Meanwhile, Skill India platforms duplicate functionalities without solving the core problem: generating reliable, real-time labour market data.

Despite the Union Budget for 2025-26 allocating ₹36,000 crore to skill development—up from ₹20,000 crore—the results remain underwhelming. NSDC's 6,000+ short-term training partners under PMKVY have produced a long-term employability rate of just 22%.

India's demographic advantage is fading fast. By 2040, the window closes, and the country enters the phase of an aging population. The rise of artificial intelligence will further disrupt the job market, making it critical that India's youth are adequately skilled.

Bihar's political landscape has long been Morcha (HAM). framed by the rhetoric of social justice—a legacy born from the 1970s 'Total Revolution' led by Jaiprakash Narayan. This transformative movement gave rise to a generation of leaders like Lalu Prasad Yadav, Nitish Kumar, and Ram Vilas Paswan, and promised empowerment for the marginalised, particularly the Dalits or Scheduled Castes, who constitute nearly 20% of the state's population. Yet, five decades later, the Dalit community continues to be shackled by economic deprivation, social exclusion, and political fragmentation.

Unlike Uttar Pradesh, where the Bahujan Samaj Party (BSP) unified Dalits under an Ambedkarite identity, Bihar's Dalit vote is deeply splintered. The three largest Dalit subcastes—Chamars (31.3%), Paswans (30.9%), and Musahars (13.9%)—exhibit divergent political loyalties, diluting their collective bargaining power. This lack of unity has prevented the emergence of a cohesive Dalit political force capable of challenging entrenched social hierarchies.

In the 1990s, Lalu Prasad Yadav's Rashtriya Janata Dal (RJD) garnered substantial Dalit support by emphasizing dignity, representation, and resistance to upper-caste dominance. However, Nitish Kumar's Janata Dal (United) disrupted this alignment by crafting the 'Mahadalit' category, which excluded influential groups like the Paswans and focused on smaller, more marginalised sub-castes. This reconfiguration allowed him to target welfare schemes more strategically and create a new leadership base, most notably Jitan Ram Manjhi, who later formed the Hindustani Awam

Meanwhile, Chirag Paswan's Lok Janshakti Party (LJP) claims to represent Paswan interests. However, both HAM and LJP have aligned with larger coalitions like the National Democratic Alliance (NDA), often limiting their ability to advocate independently for Dalit concerns. Personal rivalries and public spats between leaders like Manjhi and Paswan have further fractured Dalit solidarity.

The Bharatiya Janata Party (BJP), in alliance with JD(U), has adeptly exploited these divisions. It has extended a blend of cultural nationalism, welfare initiatives, and strategic symbolism—integrating Dalit icons into its Hindutva narrative. This approach has helped it secure a segment of the Dalit vote, especially through partnerships with leaders like Manjhi and Paswan.

On the other hand, the RJD-Congress-led Mahagathbandhan has attempted to reignite Dalit support by advocating for policies like the caste census and showcasing Dalit icons like Dashrath Manjhi. However, their failure to elevate significant Dalit voices within their ranks has hampered trust and credibility. Interestingly, the Communist Party of India (Marxist-Leninist) Liberation, which won 12 of 19 seats it contested in the last Assembly election, is gaining traction among Dalits disillusioned with mainstream parties, though its influence remains regionally limited. The socio-economic challenges facing Dalits are staggering. A recent caste survey revealed widespread landlessness, institutional underrepresentation, and persistent caste discrimination.

Former Delhi Chief Minister and Aam Aadmi Party (AAP) national convenor Arvind Kejriwal on Wednesday (June 25, 2025) described the party's recent victories in the Punjab and Gujarat Assembly bypolls as a "semifinal" ahead of the 2027 Assembly elections, declaring that AAP is on the path to forming governments in both states.

Kejriwal confidently declared that AAP would form the next government in Gujarat in 2027. He emphasized that the bypoll results indicate a shift in public sentiment and growing trust in AAP's governance model. Shubhanshu Shukla Becomes Second Indian in Space, Heads to ISS on Axiom-4 Mission

India has marked a historic moment in space exploration as Group Captain Shubhanshu Shukla of the Indian Air Force launched aboard the Axiom-4 mission to the International Space Station (ISS). The launch took place on June 25, 2025, from Launch Complex 39A at NASA's Kennedy Space Center in Florida — the same iconic site from which Apollo 11 began its journey to the Moon in 1969.

Group Captain Shukla becomes the second Indian to travel to space, following Wing Commander Rakesh Sharma who flew as part of a Soviet mission in 1984. Shukla has undergone rigorous training and spent more than a month in quarantine to ensure mission safety and health readiness.

DMK Launches 45-Day 'Oraniyil Tamil Nadu' Campaign to **Challenge Centre Over State Rights and Keeladi**

In a bold political move, the ruling DMK in Tamil Nadu has announced a 45-day statewide campaign titled 'Oraniyil Tamil Nadu' (Tamil Nadu in One), aimed at highlighting what it calls the Union Government's continued "betrayal" of the state. The campaign, to be flagged off by Chief Minister and party president M.K. Stalin on July 1, will formally begin on July 3. Covering all 234 assembly constituencies, the campaign will start simultaneously from Palaverkadu to Kanyakumari and Anaikattai to Nagapattinam. It will focus on key issues including the Centre's non-recognition of the Keeladi archaeological findings and the withholding of education-related funds.

Industries Minister T.R.B. Rajaa, who is spearheading the effort, accused the Union Government of systematically eroding Tamil Nadu's rights while the DMK government continues to deliver on its promises. "The Keeladi excavations reveal the deep cultural and civilizational roots of Tamil Nadu, yet the Centre refuses to acknowledge their significance," he said. He also criticized the lack of adequate central funding for the state's education sector.

Described as a "first-of-its-kind" outreach, the campaign aims to connect with two crore households through door-to-door visits, public rallies, and meetings. A state-wide membership drive—including new enrolments and renewals-will be conducted in parallel. On June 27 and 28, DMK representatives from all constituencies will train booth-level agents to ensure grassroots mobilisation. Rajaa also took a jab at opposition parties, stating they lack both infrastructure and outreach compared to DMK's strong cadre network and digital capabilities.





"It's Done": Indian Origin Democrat Zohran **Mamdani Wins New York Mayoral Primary**

Pakistan Court Rejects Imran Khan's Bail in May 9 Riots Cases

A Pakistani court on Tuesday dismissed former Prime Minister Imran Khan's petitions for post-arrest bail in eight terrorism cases linked to the violent protests of May 9, 2023. The decision marks another legal setback for the Pakistan Tehreek-e-Insaf (PTI) founder, who has been incarcerated for nearly two years on multiple charges.

The cases stem from widespread violence that erupted following Khan's dramatic arrest by paramilitary Rangers from the Islamabad High Court premises. The protests led to attacks on several government and military facilities, allegedly incited by Khan and his supporters.

The eight cases in which bail was denied include high-profile incidents such as:

The Jinnah House attack The Askari Tower assault The burning of the Pakistan Muslim League-Nawaz (PML-N) office The arson of the Shadman police station

Authorities accuse Khan of inciting unrest and enabling these violent acts. His legal team, however, argues that the cases are politically motivated and intends to challenge the Lahore High Court's ruling in the Supreme Court.

Meanwhile, PTI has raised serious concerns over Khan's treatment in jail. The party claims that the former prime minister is being kept in solitary confinement and that electricity to his prison cell has been cut, which they describe as a violation of basic human rights.

Imran Khan, once Pakistan's most powerful civilian leader, has faced increasing legal pressure and political isolation since his ouster in 2022. The May 9 riots have become a focal point in the government's crackdown on PTI, resulting in hundreds of arrests and ongoing trials. Khan's legal battles continue to shape the country's volatile political landscape as the PTI fights to remain relevant amid mounting challenges.

Explosive Attack in Gaza Kills 7 Israeli Soldiers; Conflict Death Toll Surges

Seven Israeli soldiers were killed on Tuesday in southern Gaza's Khan Younis when an armoured military vehicle was hit by an explosive device, according to an Israeli military official. Six of the soldiers' names have been released to the public, while the identity of one remains confidential.

This marks one of the deadliest single incidents for Israeli forc-

es in Gaza. Since the war erupted following Hamas's October 7, 2023 attack, more than 860 Israeli soldiers have been killed, with over 400 deaths occurring during ground operations inside Gaza.

Also on Tuesday, another Israeli soldier was seriously wounded by gunfire in the Khan Younis region. Meanwhile, Hamas's military wing, the Al-Qassam Brigades, claimed responsibility for an ambush in the area, stating that its fighters targeted Israeli soldiers hiding in a residential building using a Yassin 105 missile followed by another explosive strike. They also claimed to have used machine guns to attack the building. It remains unclear whether this was the same incident as the armoured vehicle explosion.

According to the Gaza Health Ministry, the Palestinian death toll has now exceeded 56,000 since Israel launched its military re-



sponse, including 5,759 deaths since March 18, when hostilities resumed after a brief ceasefire. The ministry reports that more than half of the deceased are women and children. It does not distinguish between civilians and militants.

Israel maintains that it targets only militants, blaming Hamas for civilian casualties due to their operations within densely populated areas. Israel claims to have killed over 20,000 Hamas fighters, though this figure remains unverified.

In a separate incident on Wednesday, Israeli police launched an investigation into the death of a woman from east Jerusalem who arrived fatally wounded at a checkpoint.

This ongoing conflict continues to claim lives on both sides, with no clear end in sight.

S&P Global Ratings on Tues-day, June 24, 2025, revised India's GDP growth forecast for FY26 upward to 6.5%, citing supportive domestic conditions and a favorable external environment. The forecast aligns with the Reserve Bank of India's (RBI) earlier projection and assumes a normal monsoon, lower global crude oil prices, income tax concessions, and monetary policy easing.

This revision comes just a month after S&P had downgraded India's FY26 estimate to 6.3%, largely due to concerns over global uncertainties and potential economic shocks from new U.S. tariffs. However, improved domestic indicators and stabilizing global energy markets have prompted the agency to adopt a more optimistic view.

India, which imports about 90% of its crude oil and roughly half of its natural gas, is highly sensitive to global energy price fluctuations. S&P acknowledged the escalating geopolitical tensions in the Middle East. fundamentals. As the world particularly the recent U.S. military strikes on Iran's key nuclear sites following Israeli counterattacks. While these developments could

raise the risk of sustained oil price hikes, S&P believes current global oil markets are well-supplied, minimizing the chances of a long-term energy price shock.



Despite suffering early signs like redness and itching, she ignored them. "I thought it could be fixed with some ointment," she admitted. "But after 25, everything changed."

Niuyoumian eventually turned to facial injections in 2011, hoping to improve her skin. However, these treatments backfired, further damaging her complexion. She has since been diagnosed with rosacea and Demodex mite infestations. "At its worst, it felt like ants crawling on my face," she said.

Reflecting on her journey, she acknowledged that her impatience and constant switching of skincare products only made things worse. Now, with nearly 30,000 followers, she urges others: "Don't blindly trust beauty products just because someone else says they work."

Searches were also carried out at the residences of several members of the film unit.

According to officials, the raids were based on allegations of tax and GST evasion related to the massive budget of the film. The film, which reportedly cost between ₹120 crore and ₹200 crore, has caught the attention of authorities, especially after Vishnu himself admitted in an interview that the project involved a large financial risk.
