again raising concerns across India, with the number of active coronavirus cases steadily increasing. According to the latest bulletin issued by the Union Ministry of Health and Family Welfare at 8 am on Friday, the total number of active Covid cases in the country has risen to 5,364.

In the past 24 hours alone, India recorded 498 new coronavirus cases. The surge has also led to four fresh fatalities — two from Kerala and one each from Punjab and Karnataka. With these, the total number of Covid-related deaths during this new outbreak has reached 55.

The public fallout between Tesla and SpaceX CEO Elon Musk and former US President Donald Trump has escalated sharply, sending shockwaves through political and financial circles. Elon Musk, reacting strongly to recent events, has hinted at forming a new political party, signaling a significant shift in his political engagement.

The dispute ignited when Musk criticized a recent government spending bill, calling it a "disgusting piece of garbage." Trump responded with threats to cancel government contracts awarded to Musk's companies. In retaliation, Musk warned about potentially decommissioning SpaceX's Dragon spacecraft. The tension further deepened as Musk alleged Trump's involvement in the Jeffrey Epstein files, which have not been made public. Musk tweeted, "Time to drop the really big bomb: [Donald Trump] is in the Epstein files. That is the real reason they have not been made public. Have a nice day, DJT!" Trump fired back via his social media platform Truth Social, expressing disappointment with Musk and accusing him of overreacting to the bill's EV mandate cuts.

CBI counsel PSP Suresh Kumar presented the agency's findings before the court on Thursday during the hearing on bail petitions filed by the accused. The court was told that the Supreme Court-appointed Special Investigation Team (SIT) found Bholebaba Dairy had no proper infrastructure to procure milk or manufacture ghee, as confirmed by farmers. The SIT concluded that fake ghee was being manufactured with palm oil and other chemicals and supplied to TTD via AR and Vaishnavi Dairies under a coordinated conspiracy.

CM Naidu Plans Vizag Economic Region with 8 Districts

Andhra Pradesh Chief Minister N. Chandrababu Naidu is stepping up efforts to transform the state into a major economic hub, with a special focus on Visakhapatnam. On Friday, the Chief Minister met NITI Aayog CEO B.V.R. Subrahmanyam at the Secretariat, where a detailed discussion was held on accelerating the state's

development through strategic infrastructure and economic policies.

During the meeting, Naidu revealed plans to establish a Visakhapatnam Economic Region by integrating eight districts around the city. The CM said this initiative aims to transform Visakhapatnam into a vibrant economic zone that could mirror Mumbai in terms of infrastructure and financial activity. He added that the state is targeting a \$120 billion economy by the year 2032, and this new region will play a critical role in achieving that target.

To support this ambitious goal, the Chief Minister directed officials to identify one lakh acres of land across the state to accommodate upcoming industrial and development projects. Naidu stressed that improving infrastructure is central to his government's vision, with a focus on industrial clusters, ports, and urban transformation.

As part of enhancing coastal connectivity and promoting tourism, the Chief Minister also announced plans to develop a beach road corridor from Moolapet to Kakinada. This proposed corridor, he said, will not only strengthen transport links but also boost tourism-related activity in the region.

The meeting with NITI Aayog is seen as a significant step in aligning Andhra Pradesh's development blueprint with national growth strategies. Analysts believe these bold decisions signal a renewed push by the new government to position Andhra Pradesh as a leading economic and industrial state in the country.

In a major step toward making Andhra Pradesh a leader in artificial intelligence (AI), the state government signed a significant agreement with global AI computing giant NVIDIA. The Memorandum of Understanding (MoU), signed in the presence of Education and IT Minister Nara Lokesh, aims to collaborate on the establishment of an AI University and provide skill training to youth in AI technologies. The agreement is part of the coalition government's broad-

er vision to transform Andhra Pradesh into a hub for AI research, innovation, and advanced education. As per the MoU, skill development training in AI will be provided to 10,000 students across engineering colleges in the state. Additionally, support will be extended for the incubation and growth of 500 AI-based startups. This initiative follows a meeting held in October last year,

where Minister Nara Lokesh met NVIDIA CEO Jensen Huang in Mumbai and proposed collaboration for setting up the board, the project is moving into execution mode.

The government also plans to equip the AI University with cutting-edge computing resources, advanced software platforms, and robust hardware infrastructure. The partnership will enable a collaborative ecosystem among the gov-

ernment, private sector, and academic institutions. It will also open up opportunities for student projects, research collaborations, mentorship, and market linkages — laying a solid foundation for an innovation-driven startup ecosys-

AP Liquor Case Hearing Postponed To June 10

The ongoing high-profile liquor scam case in Andhra Pradesh has witnessed another delay as the Vijayawada court postponed the hearing scheduled for this week to June 10. The court was hearing bail petitions filed by some of the accused in the case. After listening to arguments from both prosecution and defense, the judge decided to adjourn the proceedings, citing the need for more time.

This development comes at a time when investigative agencies, including the Enforcement Directorate (ED) and Anti-Corruption Bureau (ACB), have intensified their probe into the scam. The agencies are uncovering more critical details, making the case more

Among the key accused facing charges are Raj Kasireddy, former Chief Minister YS Jagan's former secretary K. Dhananjaya Reddy, and P. Krishna Mohan Reddy. Their names surfaced prominently in remand reports linked to other accused in the investigation. In a recent development, Dhananjaya Reddy, Krishna Mohan Reddy, and Bharati Cements Director Govindappa sought anticipatory bail from the Andhra Pradesh High Court, but their petitions were rejected, indicating the seriousness of the charges against them.

The postponement of the hearing has sparked discussions on the increasing pressure on the government and law enforcement agencies to expedite the investigation and bring clarity to this scandal that has captured public attention in Andhra Pradesh.

Mega DSC 2025 Exams Begin in Andhra Pradesh

- Strict rules in place across 154 centers

The much-awaited Mega DSC 2025 teacher recruitment exams began across Andhra Pradesh on Friday, marking a crucial step toward filling 16,347 vacant teaching posts in the state. Conducted in a computer-based format, the exams are being held in two daily shifts and will continue until June 30.

Chief Minister N. Chandrababu Naidu extended his wishes to the candidates appearing for the exams through a post on X (formerly Twitter). "Best wishes to the candidates appearing for the AP DSC 2025 Teacher Recruitment Exam!" he wrote, acknowledging the significance of the process for lakhs of unemployed teacher aspirants.

The exams are being conducted at 154 centers—137 within Andhra Pradesh and 17 outside the state. Each day will have two sessions, with the morning session running from 9:30 am to 12:00 pm, and the afternoon session

• **16,347 teacher posts to be** from 2:30 pm to 5:00 pm. Authorities have laid down strict rules and guidelines to ensure a smooth and fair examination process. DSC Convener Venkata Krishna Reddy emphasized that no candidate will be allowed into the exam center even a minute after the scheduled time, urging all aspirants to report on time and strictly follow the instructions.

> Additionally, for candidates whose hall tickets lack photographs, officials have instructed them to carry two recent passport-size photographs. In cases of errors in hall tickets, candidates are advised to bring valid government-issued ID proof such as Aadhaar card, PAN card, or Voter ID.

> Officials have also asked candidates to maintain discipline and cooperate with exam staff, as the large-scale recruitment is being conducted under tight security and monitoring. The Mega DSC 2025 is seen as a significant step by the government in strengthening the state's education system and addressing long-pending teacher shortages.

Telangana Will Not Accept Banakacharla Project: Uttam

AP's Banakacharla project violates all inter-state water guidelines

State Irrigation Minister Uttam Kumar Reddy on Friday strongly objected to the Andhra Pradesh government's move on the Banakacharla irrigation project, asserting that Telangana will not accept the project under any circumstances. He alleged that the project blatantly violates all norms related to inter-state water dispute resolution, including the guidelines issued by the GRMB, CWC, and the Apex Council.

Speaking to the media, Uttam revealed that he had already

Former Andhra Pradesh Chief Minister and YSR Congress Party chief YS Jaganmohan Reddy reached out to the bereaved family of YS-RCP leader Narayana Reddy from Maidukuru constituency, who tragically ended his life on Thursday. The family accused the local police of severe harassment during his custody, particularly because he was unable to pay a bribe. They said that this humiliation and custodial pressure drove him to



despair and ultimately to suicide. His death has left his wife and two children in a vulnerable state, with their future now uncertain.

YS Jagan expressed his deep sorrow over the incident and consoled the grieving family, urging them not to lose hope. He assured them that the party would provide necessary support to ensure their well-being and pledged to take up the matter with seriousness.

Fertilizers Adequately Available for Kharif Season

11.09 LMT fertilizer stock available across Andhra Pradesh Nano Urea and Nano D.A.P. introduced as eco-friendly alternatives Farmers urged to verify MRP, report black marketing

In preparation for the Kharif 2025 season, the Government of Andhra Pradesh has ensured the abundant availability of fertilizers across the state, according to Director of Agriculture Sri S. Dilli Rao, IAS. The Department of Agriculture, through a robust supply mechanism, has made all key fertilizers available to support uninterrupted agricultural operations during the upcoming season.

As per the Fertilizer Distribution Plan -Kharif 2025, a total of 16.76 lakh metric tonnes (LMT) of fertilizers are planned for distribution. This includes Urea (6.22 LMT), D.A.P. (2.60 LMT), M.O.P. (0.70 LMT), S.S.P. (0.94 LMT) and Complex Fertilizers (6.30 LMT).

The opening stock as of April 1, 2025, was 7.14 LMT, and between April 1 and June 6, 3.95 LMT of fertilizers have already been supplied, exceeding the demand of 2.07 LMT during the same period.

As of June 6, 2025, 11.09 LMT of fertilizers are available in the state, with 9.09 LMT in stock across Co-operative Societies, Rythu Seva Kendras (RSKs), MARK-FED Warehouses, Retailers, and Company Godowns. Additionally, 2.01 LMT is ready for immediate distribution through RSKs and co-operative networks.

So far, 2.00 LMT of fertilizers have already been sold to farmers across the state, including 0.92 LMT Urea, 0.15 LMT D.A.P., 0.14 LMT M.O.P., 0.18 LMT S.S.P., and 0.62 LMT Complex Fertilizers.

For the month of June alone, the Government of India has allocated 2.35 LMT of fertilizers to Andhra Pradesh, which includes significant quantities of all key categories. These will be monitored and supplied through authorized channels under the direct supervision of the Agriculture Department.

The department also announced the availability of new Nano Urea and Nano D.A.P., touted as 100% efficient alternatives to conventional fertilizers, aiming to promote sustainable agricultural prac-

Advisory to Farmers:

Always verify the Maximum Retail Price (MRP) on the fertilizer bags.

Pay only the MRP and insist on a receipt. Report any cases of hoarding, overpricing, or black marketing. Strict legal action will be taken under the Fertilizer Control Order, 1985, and licenses will be cancelled for any violations.

The Department emphasized that there is no shortage of fertilizers and both domestic production and imports are meeting current demands.

This assurance comes as a significant relief to farmers preparing for the Kharif season, reinforcing the state's commitment to agricultural productivity and farmer welfare.

VMC Chief Plans Comprehensive Measures to Tackle Monsoon Challenges

TPN Correspondent | Vijayawada Vijayawada Municipal Corporation Commissioner Dhyanachandra H M conducted a teleconference on Friday morning with the heads, staff and secretaries of the Engineering, Sanitation, Town Planning departments. The discussion focused on identifying and addressing problems arising during rainfall in the VMC limits.

The Commissioner instructed officials to identify monsoon-related issues in all three constituencies under VMC and implement necessary measures for immediate and long-term solutions. He directed them to submit a detailed report covering the nature of problems encountered during rains at the Secretariat, ward, and constituency levels, along with proposed temporary and permanent solutions.

Each Secretariat has been asked to identify and report the number and location of dangerous potholes, and to ensure that they are repaired immediately. Locations where rainwater tends to stagnate should be



marked as black spots, and VMC vehicles must be deployed to clear the water. If the existing fleet is insufficient, additional vehicles should be arranged.

He also directed that roads with potholes that may pose a danger during rains should be repaired promptly. If repair is not possible immediately, warning signboards should be placed to alert the public. The Commissioner asked officials to analyze the causes of water stagnation in the city and submit a report with both short-term and long-term remedies so that rainwater does not remain stagnant on city roads.

In case of unexpected floods, areas prone to waterlogging must be identified in advance, and necessary arrangements should be made to inform residents and shift them to designated rehabilitation centers. He questioned officials about flood-prone zones in each constituency, and officials shared the relevant information with the Commissioner.

Additionally, officials were instructed to identify the rehabilitation centers where the affected population can be relocated and submit a detailed report on the

On another note, the Commissioner stressed the need to accelerate the desilting process in city canals. He stated that desilting must be an ongoing process, and that drains within the city as well as the outfall drains leading to final discharge points should be covered completely.

The core issue under debate is whether to continue exempting traditional card payments from certain reporting requirements while denying the same relief to instant payment systems (IPS) like India's Unified Payments Interface (UPI), despite IPS often having equal or superior security measures.

Currently, FATF's rules favor card net-

tries, assuming they are less risky. However, evidence contradicts this. UPI handled over \$2.2 trillion in transactions in FY 2023-24, with a fraud rate below 0.01%, lower than many card payment systems in OECD countries. UPI employs real-time monitoring, dual-factor authentication, and strong regulatory oversight, making it highly secure. Yet, IPS systems do not receive the same regulatory exemptions, putting them at a competitive disadvantage.

India, along with countries like Brazil, Indonesia, and Malaysia, has strongly pushed FATF to adopt a fairer approach—treating payment systems

FATF Secretariat has even suggested a middle ground: exempt IPS that meet specific AML and counter-terrorism financing (CFT) standards. Still, some FATF members remain hesitant to make this change.

This hesitation risks perpetuating an outdated framework that favors legacy Western card networks over innovative payment solutions emerging in developing countries. Such bias undermines the FATF's goal of technology-neutral and globally inclusive standards. It also raises questions about the organization's legitimacy and fairness in the eyes of the Global South, where IPS are critical for finan-



cial inclusion.

India insists that if equitable treatment for IPS is not included, the entire R.16 reform should be postponed. With FATF's current leadership prioritizing financial inclusion, sidelining

IPS would contradict this focus. The world watches as FATF decides whether to embrace innovation and fairness or cling to legacy rules that hinder progress.

Rana, a Pakistani-origin Canadian national, is considered a close associate of David Coleman Headley (also known as Daood Gilani), the main conspirator behind the 2008 Mumbai attacks. Headley, a U.S. citizen of Pakistani descent, had conducted reconnaissance missions ahead of the attacks and is currently serving a 35-year sentence in the United States after turning approver.

Tahawwur Rana was extradited to India earincluding one targeting a Danish newspaper.

Rana's arrest and extradition are viewed as a significant step in India's ongoing efforts to bring all perpetrators of the 26/11 attacks to justice. The brutal assault on Mumbai began on November 26, 2008, when 10 heavily armed Pakistani terrorists infiltrated the city via sea and targeted multiple high-profile locations — including the Chhatrapati Shivaji Maharaj Terminus, Taj Mahal Palace Hotel, Oberoi Trident Hotel, and the Nariman House Jewish center.

Over 166 people, including foreign nationals, lost their lives in the nearly 60-hour siege, which remains one of the deadliest terror attacks on Indian soil. Investigations into the wider network of conspirators are ongoing.

Kamal Haasan, DMK, AIADMK Candidates File Nominations for Rajya Sabha Polls in Tamil Nadu

In a significant political development, six candidates, including top actor and Makkal Needhi Maiam (MNM) president Kamal Haasan, filed their nomination papers on Friday for the June 19 Rajya Sabha biennial elections from Tamil Nadu. All six are expected to be elected unopposed, filling the vacancies of members retiring on July 24, 2025.

Kamal Haasan, whose MNM allied with the ruling DMK ahead of the 2024 Lok Sabha polls, submitted his nomination papers at the Secretariat in Chennai in the presence of Chief Minister M.K. Stalin. The move marks Haasan's formal entry into parliamentary politics after his active cam-

paigning for the DMK alliance in papers to Returning Officer B. the previous general elections.

Also filing nominations were three candidates from the DMK: SR Sivalingam, a senior party leader from Salem,

P. Wilson, a prominent advocate and sitting Rajya Sabha MP re-nominated by the party, and Ruqayya Malik alias Kavignar Salma, a poet, writer, and DMK office-bearer.

The AIADMK, led by general secretary Edappadi K. Palaniswami, nominated:

I.S. Inbadurai, Advocate Wing Secretary, and

M. Dhanapal, a former MLA and Chengelpet East District Presidium Chairman.

Several political leaders and allies were present, including Deputy Chief Minister Udhayanidhi Stalin, VCK chief Thol Thirumavalavan, Congress' K. Selvaperunthagai, and CPI(M)'s P. Shanmugam. The elections were announced by the Election Commission last month to fill the seats of outgoing Rajya Sabha members, including MDMK's Vaiko and PMK's Anbumani Ramadoss. Indian Navy to Commission First Next-Gen Anti-Submarine Ship 'Arnala' on June 18

TPN Correspondent | Delhi major milestone in India's maritime defense capabilities, the Indian Navy will commission its first next-generation Anti-Submarine Warfare Shallow Water Craft (ASW-SWC), named 'Arnala', on June 18 at the Naval Dockyard in Visakhapatnam.

Built by Garden Reach Shipbuilders and Engineers (GRSE) under a public-private partnership with L&T Shipbuilders, 'Arnala' is the lead ship of a 16-vessel fleet being constructed at an estimated cost of ₹13,000 crore. The ship will be formally inducted into service in a ceremony presided over by Chief of Defence Staff General Anil Chauhan.

New Delhi, June 6, 2025 — Marking a Designed for subsurface surveillance in coastal and shallow waters, 'Arnala' is also equipped to carry out search and rescue operations, mine laying, and low-intensity maritime combat missions. With its advanced sonar systems and maneuverability, the ship will enhance India's ability to detect and neutralize underwater threats, especially enemy submarines operating close to the coastline.

> The ASW-SWC project is being jointly executed by two of India's premier shipyards — GRSE in Kolkata and Cochin Shipyard Limited, each tasked with building eight ships. The induction of these vessels will significantly augment the Navy's coastal defense

preparedness and underwater warfare capabilities.

Named after the historic Arnala Fort off the Vasai coast in Maharashtra, the ship symbolizes India's maritime legacy and strategic vision. The Navy said in a statement, "The ship is designed to have a formidable presence at sea. Its robust construction and advanced capabilities ensure that it can withstand the challenges of the maritime domain, safeguarding India's waters from emerging threats."

With The Man Who Lost His Mind?" Trump Rejects Talks Of **A Call With Musk**

Less than 24 hours after a fiery exchange of words and social media attacks, rumors circulated about a potential phone call between U.S. President Donald Trump and Tesla CEO Elon Musk, aimed at de-escalating their very public dispute. However, the damage had already been done. Elon Musk's companies saw their valuation tumble by over \$150 billion, while Trump faced mounting allegations threatening to shake his presidency.

A Missed Call?

Reports initially suggested that President Trump's aides had scheduled a call with Musk for Friday morning, which was later confirmed by a White House official. However, just hours before the call was to take place, another official contradicted the statement, claiming there were no plans for a conversation.

In an early morning phone interview with ABC



News, Trump dismissed the idea with a sharp jab, saying, "You mean the man who has lost his mind?" Trump added that he was "not par-

ticularly" interested in speaking with Musk and implied that it was Musk who sought the conversation, not the other way around.

The Fallout: A Bitter Break-Up

This public snub came after a volatile week that saw the relationship between the two billionaires go from friendly to explosive. Their falling-out centered around the controversial 'One Big Beautiful Bill,' which Trump passed, removing tax cuts for electric vehicle manufacturers, including Tesla. Musk, who had fought fiercely to retain these tax incentives, saw Tesla's stock plummet by over 14%, wiping out \$150 billion in value.

Musk, feeling betrayed, publicly reminded Trump that his political career owed much to Musk's financial and moral backing during the 2024 election. The once-close relationship between Trump and Musk, which had been characterized by mutual praise, appeared to be irreparably damaged after these events.

School Bombing in Northwest Pakistan Highlights Ongoing Threat to Education

A government high school in Khyber Pakhtunkhwa's Tank district was bombed early Friday morning by unidentified assailants, in yet another attack targeting educational institutions in northwest Pakistan, police confirmed.

The explosion occurred in Akbari village, under the jurisdiction of the Gul Imam police station. According to police sources, the attackers used explosives to destroy the school

building, causing several classrooms to collapse. No casualties were reported, but the infrastructure suffered significant damage.

No militant group has claimed responsibility so far. However, local authorities suspect splinter factions of the banned Tehreek-e-Taliban Pakistan (TTP), which are The Pakistani Taliban held sway in many known to operate in the Tank district and parts of Khyber Pakhtunkhwa and nearby have a history of targeting schools — particularly those educating girls.

These attacks are part of a long-standing campaign by extremist groups opposing formal education, especially for girls. According to figures compiled by local non-governmental organizations, over 450 schools have been destroyed in Khyber Pakhtunkhwa in the past decade alone. Many students have been forced to either abandon their education or study amid the ruins of damaged buildings.



This incident follows a deadly school bus explosion in Balochistan that killed five people, including three children, underscoring the persistent risks faced by students and educators across Pakistan's volatile regions.



Japan's Ispace Loses Contact With Moon Lander 'Resilience' **After Touchdown Attempt**

Japanese space startup Ispace has announced it was unable to re-establish communication with its uncrewed lunar lander Resilience following a touchdown attempt on the Moon early Friday morning. The mission, dubbed Hakuto-R Mission 2, was Ispace's second bid to achieve a successful lunar landing after a failed attempt in 2023.



According to a live data feed provided by Ispace, the lander's altitude abruptly dropped to zero just before the expected landing time. However, no confirmation of a successful landing or subsequent data transmission was received. The company stated that it is currently analyzing telemetry data to determine what went wrong during the critical final moments of the descent.

"We have not been able to establish communication with the lander after the expected touchdown time," Ispace said in a statement. "We are continuing to investigate the situation and will yound Earth orbit.

provide updates as soon as we have more information."

This marks the second unsuccessful attempt by Ispace to land on the Moon. Its first mission in April 2023 ended in failure when the lander crashed during the final descent phase due to a navigation error.

Despite the setback, Ispace remains one of the leading contenders in the private lunar exploration sector, aiming to provide commercial transport services to the Moon in partnership with international space agencies and commercial partners.

Former Nepal PM Madhav Kumar Nepal Charged in Patanjali Land **Misappropriation Case**

Kathmandu: In a significant political and legal development, Nepal's anti-corruption body has filed a graft case against former Prime Minister and CPN-Unified Socialist chairman Madhav Kumar Nepal, along with 93 others. The charges relate to a land misappropriation scandal involving Patanjali Yogpeeth-Nepal.

The Commission of Inquiry into Abuse of Authority (CIAA) on Thursday formally accused Madhav Nepal of facilitating the questionable purchase of government and public land in the Kavre district, roughly 40 kilometers from Kathmandu. The land was reportedly allocated for Patanjali Yogpeeth to establish a yoga center and herbal farming project — a venture said to be backed by Indian spiritual leader and Patanjali founder Baba Ramdev.

The CIAA alleges that the transaction was carried out in violation of land acquisition norms and that Nepal, during his tenure, played a key role in bypassing regulatory processes to benefit the organization.

As a direct consequence of the chargesheet, Madhav Nepal, a sitting member of Nepal's federal parliament, has automatically lost his parliamentary seat — in accordance with the country's legal provisions disqualifying indicted individuals from holding public office.

The filing of the case has stirred political waters in Nepal, with opposition parties demanding broader investigations

into alleged collusion between political figures and foreign-linked entities. Patanjali's land dealings in Nepal have long been under scrutiny, with civil society groups raising concerns over transparency, land use, and national interest.

This marks one of the most high-profile corruption cases in recent Nepalese political history, implicating a former prime minister and a prominent political leader. The case now heads to the Special Court, where proceedings will determine the extent of legal culpability of Madhav Nepal and others involved in the deal.

US Army Develops 3D-Printed Skin to Heal Soldiers' Battle Wounds The US Army is advancing cutting-edge bioprinting technology to produce 3D-print-

ed skin and tissues that could revolutionize battlefield medicine. In collaboration with the University of Hawaii, the US Army Combat Capabilities Development Command Chemical Biological Center (DEVCOM CBC) has launched a research initiative aimed at treating soldiers' injuries more effectively – particularly severe burns and wounds.

Bioprinting uses bio-inks made from living cells, proteins, and nutrients to create three-dimensional, functional replicas of human tissues and organs. The technology holds immense potential for military medicine, enabling rapid tissue repair and even organ regeneration on the battlefield or in remote areas.

Under a Cooperative Research and Development Agreement (CRADA), DEVCOM CBC and the University of Hawaii are executing two joint work statements (JWS). One of these focuses on developing advanced organ models using bioprinting. Dr. Jason Barnhill, an associate research professor at the John A. Burns School of Medicine (JABSOM), is partnering with DEVCOM CBC's bioengineering expert Priscilla Lee to create tools for evaluating chemical compounds and responses in



Dean Sam Shomaker of JABSOM highlighted the global impact of the project, saying, "These efforts have the potential to save the lives of frontline soldiers and civilians. Introducing innovative biofabrication technologies to remote regions supports not only USINDOPACOM's mission but global humanitarian efforts."

Lee is specifically researching immune responses using bioprinted cell culture models, which could lead to new biomaterials for treating wounds from burns, toxic gas exposure, and antibiotic-resistant infections.

Bioprinting stands as a beacon of innovation in medicine, with its ultimate goal being the ability to print entire organs using a patient's own cells. If successful, this technology may redefine how we treat injuries — both in combat zones and in hospitals worldwide.

Adani Group's Tax **Contribution Soars** to Rs 74,945 Crore in FY25, Up 29%



The Adani Group announced a significant 29% increase in its total tax contribution to the exchequer for fiscal year 2025, reaching Rs 74,945 crore compared to Rs 58,104 crore in FY24. This growth reflects the company's expanding business operations and its commitment to tax transparency as part of its broader Environmental, Social, and Governance (ESG) framework.

Out of the total tax contribution, direct taxes amounted to Rs 28,720 crore, while indirect taxes contributed Rs 45,407 crore. Other contributions, including social security benefits for employees, totaled Rs 818 crore. To give context, the Rs 74,945 crore tax paid by the group is nearly equivalent to the cost of building the entire Mumbai Metro network or hosting a modern Olympic Games.

Key contributors within the group's portfolio include Adani Enterprises Limited (AEL), Adani Cement Limited (ACL), Adani Ports and Special Economic Zone (APSEZ), and Adani Green Energy Limited (AGEL). Additionally, the figures incorporate taxes paid by NDTV, ACC, and Sanghi Industries, which are held by these entities.

RBI Slashes Repo Rate by 50 bps to Spur Growth, Shifts **Policy Stance to Neutral**


Tn a significant move **L**aimed at stimulating economic growth, the Reserve Bank of India (RBI) on June 6, 2025, reduced the policy repo rate by 50 basis points to 5.50%. This marks the second rate cut this year, following a cumulative reduction of 100 bps since February 2025.

RBI Governor Sanjay Malhotra, while delivering the Monetary Policy Committee (MPC) statement, emphasized that the decision is aligned with the central bank's medium-term inflation target of 4% (within a +/- 2% band), while simultaneously supporting growth recovery. With this adjustment, the Standing Deposit

Facility (SDF) rate now stands at 5.25%, and both the Marginal Standing Facility (MSF) rate and the Bank Rate have been revised to 5.75%.

In addition to the repo rate cut, the RBI also announced a reduction in the Cash Reserve Ratio (CRR) by 100 basis points, bringing it down to 3.0% of net demand and time liabilities (NDTL). This cut will be implemented in a staggered manner throughout the year to infuse durable liquidity into the banking system.

The RBI has also revised its monetary policy stance from "accommodative" to "neutral," signaling a cautious approach ahead. "Monetary



policy space has narrowed after recent rate cuts. From here, our stance will depend on incoming data and evolving global conditions," Governor Malhotra noted.

For FY26, the central bank projects real GDP growth at 6.5%, with quarterly estimates ranging between 6.3% and 6.7%. CPI inflation is projected to average 3.7% for the year, assuming a normal monsoon, with risks deemed evenly balanced.

The move reflects the RBI's balancing act between fostering growth and maintaining price stability in a volatile global economic environment.

Gold Loan Stocks Surge as **RBI Proposes Higher LTV Limit for Small Loans**



old loan stocks saw a notable rally on Friday, June 6, 2025, after RBI Governor Sanjay Malhotra proposed a hike in the loan-tovalue (LTV) ratio for small-ticket gold loans. The new guideline suggests increasing the LTV ratio to 85% for gold loans up to ₹2.5 lakh, compared to the current limit of 75%. This change is aimed at boosting lending flexibility for non-banking financial companies (NBFCs).

The announcement triggered sharp buying in shares of gold-financing firms. Muthoot Finance surged over 7% intraday, trading at ₹2,450.40 against its previous close of ₹2,294.60. Manappuram Finance also rose more than 5%, touching ₹248.46 from an opening price of ₹234.84. IIFL Finance and other lenders in the gold loan segment witnessed similar upward momentum.

The LTV ratio defines the maximum loan one can receive against the pledged gold. A higher LTV ratio means customers can borrow more money for the same gold value, which

is expected to increase loan disbursements and widen the customer base for gold financiers. This move is also seen as a potential earnings booster for NBFCs specializing in gold-backed lending.

The RBI's revised proposal comes as a shift from earlier draft norms, which had suggested a uniform 75% LTV cap for both banks and NBFCs. In addition to the LTV hike, the RBI also announced simplified operational norms, including no mandatory credit appraisal for small-ticket loans and relaxed end-use monitoring, especially for non-PSL

Governor Malhotra noted that final guidelines would be released by today or Monday morning, emphasizing regulatory clarity and compliance consistency.

The announcement followed a broader 50 basis points repo rate cut to 5.50%, sparking optimism across the financial and banking





Customer Allegedly Finds Ants in Maggi Ordered from Zepto Café

Company Responds Amid Rising Concerns

Acustomer's shocking discovery of ants in a bowl of Maggi noodles ordered from Zepto Cafe has sparked outrage on social media. The incident, highlighted in a viral Instagram video, shows four bowls of noodles — one empty and three partially eaten — with multiple dead ants clearly visible at the bottom.



The post quickly gained traction, amassing over two million views.

Tagging Zepto's official handle, the customer wrote, "@zeptonow this is disgusting. However, I'm shocked to see their cafe still operating with deceptive offers like 'Buy 1 get 1 free' — serving food with insects is unacceptable! They're prioritizing fast delivery over hygiene and health."

Zepto, a 10-minute quick-commerce food delivery platform, responded in the comments section: "Hey! At Zepto, we take quality seriously, and we regret any inconvenience caused if this product doesn't meet your expectations. Please DM us your order details so we can address this promptly at Zepto speed!"

In response, the customer replied, "@zeptonow we got our refunds gladly, but what about this kind of food which we consumed? These were just ants. What if there was a cockroach or any other insect? This is all about hygiene! People can get food poisoning — we expect better food quality, not just fast deliveries."

This isn't the first time Zepto's food safety practices have been questioned. Chenab Rail Bridge: Inside the Tech Powering the World's Tallest Railway Bridge

The Chenab Rail Bridge, hailed as the highest rail- tonnes and was installed using the world's tallest caway bridge in the world, is set to be inaugurated by Prime Minister Narendra Modi, marking a milestone in India's infrastructure journey. Located in the Reasi district of Jammu and Kashmir, the bridge spans 1,315 meters across the deep Chenab River gorge and is a part of the ambitious Udhampur-Srinagar-Baramulla Rail Link (USBRL) project.

Constructed by Afcons Infrastructure under the Konkan Railway Corporation, the bridge towers 359 meters above the riverbed—making it 35 meters taller than the Eiffel Tower. With a total project cost of ₹1,486 crore, the Chenab Rail Bridge has a designed lifespan of 120 years and is built to withstand wind speeds of up to 266 kmph and train speeds of 100 kmph.

The bridge's unique two-rib steel arch with open spandrel design ensures strength and flexibility. Each of its massive steel segments weighs 34 metric

ble crane, supported by a 127-meter-high pylon—taller than Delhi's Qutub Minar.

To withstand the harsh environment and seismic activity in the region (zone V), the bridge is made from weathering steel, which resists corrosion and adapts to extreme temperatures ranging from -20°C to 45°C. Its 5.84 lakh kilometers of welds—almost equal to the distance between Jammu Tawi and New Delhi—were tested using Phased Array Ultrasonic Testing, a first for Indian Railways.

For safety, over 100 advanced sensors are embedded throughout the structure. These are part of a real-time Structural Health Monitoring (SHM) system that tracks wind, load, vibration, and temperature. If any abnormal readings are detected, automated alerts are sent to halt train movement, ensuring complete operational safety.

Woman Books Ola Ride for Just 180 Metres to Escape Street Dogs, Internet Amused

Tn a quirky yet relatable moment **⊥**that has gone viral on social media, a woman booked an Ola Bike ride to travel a mere 180 metres — and the reason has left netizens both amused and sympathetic. Captured in a short video shared by the rider, the clip begins with the Ola driver arriving at the pickup point and asking the woman for the one-time password (OTP). However, when he checked the destination, he was visibly surprised to find it was just 180 metres away.

World Champion D. Gukesh continues to press hard for the Norway Chess title after a crucial victory over China's Wei Yi in the ninth round of the prestigious Stavanger tournament. With one round remaining, Gukesh sits second with 14.5 points, just half a point behind fivetime World Champion Magnus Carlsen, who edged past American Grandmaster Fabiano Caruana in a tense battle.



Gukesh's win came after Wei Yi missed a critical Bishop move on the 40th turn, allowing the Indian prodigy, playing White, to seize the advantage and force a resignation. This marked Gukesh's third classical victory in the tournament, following wins against Carlsen and fellow Indian Arjun Erigaisi. Reflecting on the match, Gukesh said, "I'm happy with today's game and hopeful for another strong performance in the final round."

The final round promises a gripping finish: Gukesh will face Caruana, while Carlsen takes on Erigaisi. Carlsen's recent comeback win against Caruana, capitalizing on a late blunder, boosted his chances of clinching his seventh Norway Chess title since 2016. "This win improves my situation a lot. Erigaisi will fight hard, so I'm ready for a battle," Carlsen

commented.

Meanwhile, American GM Hikaru Nakamura, with 13 points, remains in contention but will need favorable outcomes elsewhere.

In the women's section, two-time world rapid champion Koneru Humpy lost to China's Lei Tingjie, missing a chance to secure the title. Humpy now trails Ukrainian GM Anna Muzychuk, who leads by two points after a dominant win over Chinese world champion Ju Wenjun. The final round will be decisive for the women's crown as well.

Thursday's results set the stage for a thrilling conclusion in both the open and women's categories at Norway Chess 2025.

Walter's coaching resume is impressive. He previously served as South Africa's limited-overs coach from January 2023 until April 2025, leading the team to the semifinals of the

2023 ICC World Cup and the Champions Trophy in ODIs, as well as the final of the T20 World Cup last year. Before his stint with South Africa, Walter was well-established in New Zealand domestic cricket, coaching Otago for five years and working with Central Districts.

"From representing India at the highest level to being part of the victorious 2007 T20 and 2011 ODI World Cup squads, every moment in this incredible journey has been nothing short of a blessing," he wrote.

Chawla also enjoyed a fruitful IPL career, playing for multiple franchises including Punjab Kings, Kolkata Knight Riders, Chennai Super Kings, and Mumbai Indians. He was part of KKR's 2014 title-winning squad and famously scored the winning runs in the final



Instead of tightening the mystery, the film spirals into an illogical frenzy, packed with cringe-inducing comedy and dragged-out gags.

Akshay Kumar, Riteish Deshmukh, and Abhishek Bachchan play three men claiming to be "Jolly," each accompanied by their respective "wives" — played by Nargis Fakhri, Sonam Bajwa, and Jacqueline Fernandez. The women serve little purpose beyond dance numbers
