# Lokesh's Bengaluru Visit Delivers Big: Two Projects for Vizag

#### Satva, ANSR to create 35,000 jobs in Andhra Pradesh's IT hub

- ₹1,500 crore Satva Vantage campus coming to Visakhapatnam
- ANSR to set up GCC Innovation Campus with 10,000 jobs
- · Lokesh's proactive pitch attracts major investments

The investment tour of Andhra Pradesh IT and HRD Minister Nara Lokesh to Bengaluru has yielded impressive results, with two major projects being secured for Visakhapatnam in a single day. The deals, finalized during his meetings with top industry leaders, are expected to generate direct employment for 35,000 people.

In a key development, Lokesh held discussions with representatives of Satva Group, a prominent name in Indian real estate. Responding swiftly to the state's investment-friendly pitch, the company has announced a ₹1,500 crore investment to develop a mixed-use modern campus named 'Satva Vantage' on 30 acres of land in Visakhapatnam. The project will feature Grade-A office spaces and premium international-standard residences, and is expected to create 25,000 jobs. During the same visit, Lokesh also facilitated a Memorandum of Understanding (MoU) with ANSR, a company known for enabling Global Capability Centers (GCCs) for international clients. As part of this agreement, ANSR will establish a GCC Innovation Campus in Visakhapatnam aimed at providing 10,000 jobs in the next phase of expansion. This back-to-back success on a single day highlights Visakhapatnam's rapid emergence as Andhra Pradesh's IT and innovation capital, with Nara Lokesh playing a key role in fast-tracking major collaborations. The proactive outreach by the minister is expected to add further momentum to the state's industrial and digital infrastructure development.

# CM Releases Water to Krishna River

- 4 gates lifted, water released from full Srisailam reservoir
- Deadlines set for water to Jeedipally, Kuppam, and Madanapalle

Andhra Pradesh Chief Minister N. Chandrababu Naidu visited the Srisailam Project today and released water to Krishnamma by lifting four gates of the dam. The CM, accompanied by Water Resources Minister Nimmala Ramanaidu, emphasized his government's commitment to the irrigation and development needs of Rayalaseema, setting strict timelines for water supply to drought-prone areas. Before initiating water release, Chandrababu performed special pujas to Lord Mallikarjuna at the temple and prayed for the prosperity of Rayalaseema. "This is the happiest day of my life," he said, expressing joy that the Srisailam reservoir was filled in the first week of July with 200 TMC of water now available. "Water is our real wealth, and irrigation projects are the modern temples," he remarked.

He criticized the previous YSRCP government for neglecting irrigation and development in the region. "They failed to even focus on the Srisailam dam," he said. In contrast, Chandrababu pointed out that his earlier government had spent ₹68,000 crore on irrigation projects and laid the foundation for development with key projects like Polavaram, Pothireddypadu, Galeru-Nagari, and Gandikota. The CM announced that the government has set a target of July 15 for supplying water to Jeedipally and July 30 for Kuppam and Madanapalle. He said he is personally monitoring the progress. "Rayalaseema will soon become a land of gems with the blessings of Mallanna and our government's commitment," he said.

Chandrababu reiterated that a clear blueprint is in place for Rayalaseema's transformation, with plans to develop Kopparthi and Orvakal into industrial hubs and expand road infrastructure to national standards. "Our aim is to make the Telugu nation number one in the world," he concluded.

Andhra Pradesh: In a shocking incident, Sri Seetha Ramachandraswamy Temple Executive Officer (EO) Ramadevi was attacked by a large group of villagers from Purushottapatnam while trying to prevent illegal constructions on temple lands. The clash resulted in her fainting on the spot, and she is currently undergoing treatment at KIMS Hospital.

Temple EO attacked during inspection
The incident took place when EO Ramadevi, along with 30 temple staff, reached Purushottapatnam village in Edapaka Mandal of East Godavari district after receiving information about unauthorized house constructions on lands belonging to the Bhadrachalam temple. As she attempted to halt the illegal activity, an enraged crowd of about 500 villagers confronted and attacked the EO and her staff. In the chaos, Ramadevi collapsed and had to be rushed for medical care.

Disputed lands belong to Ramalayam
The disputed 1200 acres originally belonged to the Sri Seetha Ramachandraswamy Devasthanam in Bhadrachalam Mandal of the erstwhile Khammam district in united Andhra Pradesh. Poststate bifurcation, the land came under the jurisdiction of Purushottapatnam village in Edapaka

## Legal community voices concern

Reacting to the incident, High Court Advocate Dannana Tarun Kumar condemned

the attack and stated: "The EO and staff visited the disputed land area with rightful intent. It is painful to see the state of affairs today through photos and videos. Though such incidents have happened earlier, no action was taken.



Authorities must now act decisively and prevent recurrence."

The incident has reignited the long-standing land dispute involving the Bhadrachalam Ramalayam and highlighted the urgent need for inter-state coordination and enforcement of court orders to protect temple assets.

#### "10 Designs for **NTR Statue...**

In a significant move to honor Telugu cinema legend and former Chief Minister N.T. Rama Rao, the Andhra Pradesh government is set to construct a grand statue and memorial in the Neerukonda Hill area of Amaravati. State Municipal Administration Minister Dr. P. Narayana held a crucial review meeting on the designs and developmental plans for the statue and surrounding infrastructure.

The meeting was held with representatives of SHELADIA, the consultancy entrusted with the planning of the statue and memorial project. The consultancy presented initial design concepts and models for the NTR statue, and discussed complementary structures such as the NTR museum, walkways, and landscape planning. Minister Narayana instructed the agency to prepare at least 10 different statue models and present them to Chief Minister N. Chandrababu Naidu for final selection.

"The final decision on the statue model will be taken by our Chief Minister," said Narayana. He also stated that suggestions from senior TDP leader TD Janardhan will be taken into consideration during the design process.

The first phase of the project will include the installation of the NTR statue and the NTR museum, which will highlight the legendary leader's life journey, achievements in politics, and contribution to Telugu cinema. The Minister added that soil testing and other preliminary surveys have already begun in the designated area to ensure the site is technically suitable for such a large-scale monument.

The government intends to make this project a cultural landmark of Amaravati, symbolizing the legacy of NTR and the vision of the capital city. The upcoming weeks will be key as model designs are finalized and detailed construction plans are set in motion.

East Godavari. For four decades, the villagers had been farming these lands on lease. However, in recent years, they began claiming ownership and started constructing homes and laying foundations for colonies.

According to official land records and survey numbers available online, the lands clearly belong to the temple. Despite this, around 900 acres are still under cultivation by villagers while constructions are being carried out illegally on the remaining 300 acres.

State negligence post bifurcation

Locals claim that successive governments in Andhra Pradesh — both TDP and YSRCP — have overlooked this issue since the bifurcation, which has emboldened villagers to claim permanent ownership. Despite a ruling by the Andhra Pradesh High Court in favor of the temple, no enforcement has taken place. This has led to repeated tensions, and now the situation has escalated into a physical attack on officials.

EO Ramadevi, who has been working diligently to reclaim temple lands, has faced similar hostile encounters in the past. However, due to lack of coordinated support from the administrative machinery, her efforts remain fraught with resis-

Telangana Endowments Minister Konda Surekha, after being informed of the incident, called EO Ramadevi and expressed deep anguish over the attack. She instructed the local MLA to ensure immediate and proper medical assistance to the injured EO. She also ordered that stringent legal action be initiated against those responsible, warning that no one involved in the assault would be spared.

# **Swift Action on Women's Crimes Through Shakthi Teams**

The Andhra Pradesh Police have intensified efforts to ensure justice in crimes against women and children through faster registration of cases using Zero FIRs, the Shakthi mobile app, and WhatsApp. Every police station in the state has been directed to immediately register complaints involving offences against women and girls and begin prompt investigations.

In addition, 156 Shakthi Teams have been deployed across all 26 districts and the two Police Commissionerates in Andhra Pradesh. These teams patrol regularly, counsel women in isolated places, monitor suspicious activity, and identify threats like eve-teasers and open alcohol spots. So far, 900 hotspots have been identified, and the Shakthi teams have visited them 36,659 times.

To raise awareness, the teams have conducted 20,928 public programs educating women and communities about their safety and rights. Moreover, 1,266 SOS calls have been received and addressed successfully. The teams have also visited 32,021 open areas to monitor illegal activity.

Advanced tools like drone surveillance are also being used to track In a major development, Bhimapotential offenders. Some notable interventions include rescu-



ing a woman attempting suicide in Eluru, tracing missing women in Srikakulam and Palnadu, and apprehending eve-teasers in Vizianagaram.

These efforts have contributed to 261 convictions in women's crime cases across Andhra Pradesh courts between June 1, 2024, and now. Sentences include 4 death sentences, 66 life imprisonments, 7 for 25 years, 47 for 20 years and 137 for 10 years or less.

Officials say these strict punishments are creating a visible deterrent effect.

Life Term For Repeated Rape Of Minor Girl

varam POCSO Court has sentenced Neelapu Gopi Krishna, 22, of Relangi village in West Godavari, to life imprisonment for repeatedly raping a minor girl after threatening her with an acid attack.

The case was registered at Iragavaram Police Station on 8 July 2021 under Crime No. 310/2021, based on a complaint from the victim's grandfather. The accused was charged under IPC Sections 376(3), 376(2)(n), 354-D, 448, 506 and Sec. 5(1) r/w 6 of POCSO Act.

Following trial, Judge B. Lakshminarayana convicted Gopi Krishna under Section 235(2) CrPC and issued the following sentences Life imprisonment for the main offence, plus ₹1,00,000 fine, 6 months RI for trespass, ₹1,000 fine, 2 years RI for stalking, ₹5,000 fine and 1 year RI for threats, ₹5,000 fine (All sentences to run concurrently).

The court also ordered that ₹1,00,000 of the total fine be given to the victim as compensation under Section 357 CrPC.

Public Prosecutor Sri Brahmaiah argued the case, while SI Jana Satish, Head Constables Venkateswara Rao and Ramesh were praised for ensuring timely witness attendance and effective case handling. They received special appreciation from the District SP.

The case stands as a strong message that Andhra Pradesh will not tolerate crimes against women and children and will ensure swift and strict punishment.



#### **Good News for Gram Panchayat** Workers

₹150 crore released for April, May, and June salaries

In a major relief to thousands of employees working at the grassroots level, the Andhra Pradesh government has released pending salaries for multi-purpose workers (MPWs) serving in gram panchayats across the state. The Finance Department has sanctioned ₹150 crore to cover three months' salaries — April, May, and June — for these workers.

Officials have confirmed that the funds have already been deposited in gram panchayat accounts and that the salary amounts will be credited to individual workers within the next couple of days.

This announcement brings long-awaited financial relief to nearly 53,000 multi-purpose workers who have been tirelessly serving rural communities without pay for the past three months. These workers, crucial to sanitation, public health, and local governance functions, had been facing growing hardship due to the delay in salaries. With this step, the government has addressed growing concerns from panchayat-level workers and their families and reaffirmed its commitment to rural administration and workforce welfare.

## **Storm Of Allegations Surrounds Senior Assistant At RD Office**

Whistleblower Claims ₹1 Crore Scam, Fake Appointments & Promotion Fraud

Amaravati: A cloud of serious allegations has engulfed Sri Jagadish, currently serving as a Senior Assistant at the Regional Director of Medical and Health Services (RD) Office in Rajamahendravaram. Starting his career as a sweeper, Jagadish reportedly climbed the ranks over 27 years to become a Senior Assistant — a journey now mired in controversy over alleged financial fraud, misuse of tribal reservations, and systemic manipulation. During the bifurcation of Andhra Pradesh and Telangana, Jagadish is accused of taking advantage of administrative chaos to siphon off over ₹1 crore from at least 10 Primary Health Centres (PHCs) through schemes such as HDS and NRHM. These alleged irregularities reportedly escaped audits from both state governments.

His transfers from Nellipaka PHC to Maredumilli PHC, and later to the Additional DM&HO Office, Rampachodavaram, were marked by more controversy. Jagadish is alleged to have orchestrated large-scale irregularities in MPHA (M) recruitment, a process meant to benefit local tribal youth. Instead, fake training certificates were mass-printed and sold to ineligible candidates for hefty sums. With reported support from ITDA and even Collectorate insiders, these can-

didates were issued appointment orders, bypassing the merit-based pro-

Jagadish later secured a transfer to the RD Office under the "Tribal Priority" category. There, he allegedly teamed up with another Senior Assistant, Sri Arji Narasimha Murthy, to fabricate backdated documents and manipulate the Junior to Senior Assistant promotion cycle. Key vacancies were allegedly suppressed to delay promotions and create space for influential lateral transfers.

Sources say Murthy applied just before the official promotion window, using G.O. loopholes, despite not being eligible. This transfer violated G.O.Ms. No.23, which mandates transfers within the erstwhile district, zone, and multi-zone limits. Murthy, from Eluru, should not have been posted to Rajamahendravaram, yet allegedly reached there due to internal collusion. From August 2024, promotion processes for deserving Junior Assistants were intentionally delayed, with reports suggesting the manipulation was part of a broader effort to install loyalists in key posts. During the MPHS (F) general transfers, vacancy lists were selectively hidden to benefit insiders, only reappearing once initial counseling sessions concluded. The misuse of G.O.Rt.No.344, which allows transfers for employees working in one unit for over three years, has also come under the scan-

guidelines, officials allegedly used this provision to illegally accommodate Murthy at the RD Office, with the prior groundwork laid by Jagadish. Deputy Director Sri Sesha Reddy is also under scrutiny. Sources allege he issued internal instructions over Zoom calls, guiding Murthy through procedural loopholes. A review of call records and digital communications is being demanded to reveal the ex-

# AP Seeks Central Support for Farmers...

Achchennaidu Meets Union Agriculture Minister AP Minister seeks ₹12 support price for Totapuri mangoes Demands crop-specific boards for chilli, cashew, and mango farmers Requests Central Agricultural University in Srikakulam under Reorganisation Act

Andhra Pradesh Agriculture Minister Kinjarapu Achchennaidu met Union Agriculture and Farmers' Welfare Minister Shivraj Singh Chouhan in New Delhi on Tuesday to discuss critical issues faced by farmers in the state, with a particular focus on the plight of mango farmers. The meeting, held at Krishi Bhavan, was attended by Union Civil Aviation Minister Kinjarapu Rammohan Naidu and MLA Gonda Shankar, reflecting a collaborative effort to address agricultural challenges in Andhra Pradesh.

During the courtesy call, Minister Achchennaidu highlighted the urgent need for comprehensive central government support to strengthen the state's agricultural sector and ensure its holistic development. A key concern raised was the sharp decline in the price of Totapuri mangoes, which

has plummeted to ₹8 per unit, causing significant financial losses for farmers. To mitigate this crisis, Achchennaidu urged the central government to intervene and provide a support price of ₹12 per unit under the Price Deficiency Payment Scheme. He estimated that approximately 6.5 lakh metric tonnes of Totapuri mangoes would need to be procured, with the state government committing ₹260 crore to the initiative. However, he emphasized the necessity of central government partnership to make the scheme viable and prevent further losses for farmers.

Achchennaidu also proposed several long-term measures to bolster agriculture in Andhra Pradesh. He requested enhanced subsidies for micro-irrigation schemes, particularly for backward districts, drawing parallels with the support provided to the

Bundelkhand region, Additionally, he advocated for the establishment of specialized agricultural boards to promote key crops in the state, including a Chilli Board in Guntur, a Cashew Board in Srikakulam, and a Mango Board in Chittoor. These boards, he argued, would provide focused support to farmers and improve market access and crop-specific research.

Further, the minister reiterated the state's demand for a Central Agricultural University in Srikakulam, as mandated under the Andhra Pradesh Reorganisation Act. Such an institution, he noted, would drive agricultural innovation and education, benefiting farmers in the region and beyond. Union Minister Shivraj Singh Chouhan responded positively to Achchennaidu's requests, assuring cooperation to address the concerns raised. The discussions

scored the central government's commitment to engaging with states to resolve farmers' issues through dialogue and collaborative action, aligning with Chouhan's broader approach to agricultural reforms.

The presence of Union Minister Kinjarapu Rammohan Naidu and MLA Gonda Shankar highlighted the unified effort of Andhra Pradesh's leadership to advocate for its farmers. The state's proactive measures, coupled with its appeal for central support, signal a determined push to safeguard the livelihoods of farmers grappling with market fluctuations and infrastructural challenges.

As Andhra Pradesh continues to navigate the complexities of agricultural development, the outcome of this meeting could pave the way for targeted interventions to uplift farmers and ensure sustainable growth in the

Surprise raids held near educational institutions; banned gutka, tobacco seized Students sensitized on drug, tobacco risks through awareness drives

The NTR District Police have launched 'Operation Safe Campus Zone' to tackle the illegal sale of gutka, ganja, and tobacco products around schools and colleges. This initiative follows instructions from Andhra Pradesh DGP Harish Kumar Gupta, IPS, aiming to safeguard students from harmful substances and raise awareness about their ill effects.

Under the guidance of Commissioner S.V. Rajasekhar Babu, IPS, and supervision of DCPs K.G.V. Saritha, IPS, and K.M. Police teams, including ACPs and local officers, conducted raids on pan shops and petty stalls. Several vendors were found selling banned gutka and storing tobac-

co products illegally. These items were seized, and cases were registered against the violators under relevant public health and narcotics laws.

As part of the campaign, awareness programs were also held in various colleges. Experts and health professionals explained the harmful effects of addictive substances such as ganja, gutka, and tobacco. Students were urged to stay away from such habits and focus on their well-being and future.

## Fake ST Claims Won't Be **Tolerated: Adivasi Parishad**

• Benthu Oriya claim challenged in Srikakulam

Adivasi Sankshema Parishad leaders have raised strong objections to the alleged misuse of Scheduled Tribe (ST) status by individuals from the Benthu Oriya community in Srikakulam district. State Vice President Vaba Yogi has demanded an immediate inquiry and cancellation of all such allegedly fake caste certificates.

Addressing the media in Kashibugga on July 8, Yogi alleged that individuals like Bisai Naresh, Sushant Bisai, and Vaishnavi Bisai misled the High Court to gain ST recognition under the Benthu Oriya category—despite the community not being officially listed as a Scheduled Tribe in the district. He emphasized that the group traditionally belongs to the Backward Classes-A (BCA) category and lacks tribal characteristics.

Yogi cited multiple official reports—including studies by the Tribal Cultural Research and Training Institute (TCR&-TI), the Social Welfare Department, and the Anthropology



Survey of India—which confirmed that no such tribe exists in Srikakulam. Even the Tekkali RDO's 1942-43 birth and death registers and the Principal Secretary of Tribal Welfare's 2022 court submission support the same.

He alleged that around 10,000 individuals from the BCA community have already secured government jobs using forged ST certificates, depriving genuine tribal candidates of rightful opportunities. Warning of district-wide pro-

tiny Committee (DLSC) fails to take action, Yogi said, "We will not remain silent. This is a betrayal of our tribal communities, and we are ready for any sacrifice to protect our rights." Other leaders including Dis-

trict JAC President Savara Rambabu, Assistant Secretary Venkatesh, and representatives like Papa Rao, Surapu Naidu, Bhaskar Rao, and Delhi Rao also voiced their support.

Addressing a gathering at the TDP office in Tuni on Tuesday during the 'First Step in Good Governance' program, the Minister asserted that Andhra Pradesh will strictly follow Dr. B.R. Ambedkar's Constitution, and not be swayed by misleading polit-

Speaking to party activists, Parthasarathy acknowledged public expectations, stating that even after winning 164 seats, Chief Minister Chandrababu Naidu has been under pressure, carrying the burden of ₹10 lakh crore debt left by the previous YSRCP regime, while also working tirelessly to launch the promised "Super Six" schemes. He added that public impatience and activist queries were natural but assured that every scheme will be implemented effectively. Highlighting the contrast in governance, the Minister criticized the previous YSRCP government, saying, "They called themselves brand ambassadors of welfare, but failed to deliver even basic relief." In comparison, he said the new government raised pensions by ₹1,000 in a single decision—something the YSRCP couldn't do in five years. # Of Prada, Dior, and the Manufactured Meanings of Luxury Fashion

"What the garment signifies is not what it is, but what it permits us to imagine it is." This is not just a trendy Instagram quote but a profound insight from Roland Barthes, one of the most influential philosophers and semioticians of the 20th century. Though often remembered for his work in linguistics, Barthes interpreted fashion as a complex language, where meaning is arbitrarily assigned and constantly manufactured. His notion that "Fashion is above all a system of signs" offers a powerful lens to understand today's global luxury fashion scene, especially the controversies surrounding brands like Prada and Dior.

The recent accusations against Prada and Dior for "stealing" Indian artisanal crafts such as Kolhapuri footwear and Muqaish embroidery highlight the ongoing power imbalance between the Global North and South. Such exploitative practices are, unfortunately, common in the luxury fashion industry, where accountability often takes a back seat to profit and prestige. However, Barthes's ideas can also help us see fashion as a potential tool to challenge these hegemonies much like how Indian writers appropriated the English language to resist colonial intellectual dominance.

Cultural appropriation in fashion is nothing new. From Aztec prints to Amazonian jewelry, Javanese batik to Odisha's Ikat weaving, and Persian embroidery to Han Chinese tradition-



al dress, powerful designers have borrowed freely without proper acknowledgment. This lack of credit, while exploitative, also serves as a trigger for conversation and critique. The brazen copying exposes the industry's unwillingness to respect the origins of its inspiration, and this, paradoxically, can become its undoing.

Yet, beyond appropriation lies another subtle problem — the creation of what might be called an "aesthetic strawman." When indigenous traditions are selectively picked and reassembled into luxury collections, they

often end up as caricatures. This can lead native artisans and aesthetes to ask: "Is this really the best representation of our rich cultural heritage?"

Louis Vuitton's latest India-inspired spring-summer 2026 men's collection exemplifies this issue. The brand proudly cites Pharrell Williams drawing inspiration from India and its global sartorial influence. However, the result feels more like an over-thetop pastiche dominated by excessive jewel tones and flashy motifs rather than a respectful tribute to India's vast artisan diversity. This reductive

portrayal reduces centuries-old craftsmanship to mere exotic decoration for luxury products.

Christian Louboutin's recent India-themed collection suffered similarly, relying heavily on gold and glitter without capturing the true spirit of Indian artistry. Notably, Louboutin shoes, while iconic for their red soles and bold aesthetics, are notoriously uncomfortable, prioritizing style over practicality. This disconnect underscores a wider issue in luxury fashion: a focus on surface glamour rather than authentic substance or function-

ality.

Barthes's framework is particularly useful here. He distinguished between "real clothing" (the tangible garment), "image clothing" (stylized, idealized representations in media), and "written clothing" (the narratives crafted around a product to create desire and identity). Fashion, then, is less about the real item and more about these manufactured images and stories, which often bear little resemblance to reality. This packaging of ordinariness into extraordinary allure is essentially a con—selling dreams more than products.

These manufactured meanings become central to how fashion operates, fueling cycles of appropriation, whether stealthy or blatant. Sociologist Dick Hebdige captured this when he noted that objects are "appropriated, bricolaged, and made to carry meanings which they did not originally possess." Until we start valuing the authenticity of these objects and respect their origins, the luxury industry will continue to perpetuate this cycle of exploitation and superficiality.

In essence, the challenge is to look beyond logos, glitter, and hype — to truly honor the cultural and artisanal roots beneath the surface. Only then can fashion move from mere image-making to genuine storytelling and respect for the craftsmanship it draws upon.

# Growth push: Betting big on R&D

Currently, India's R&D expenditure stands at approximately 0.65% of its GDP, which is considerably lower than global leaders. For comparison, the United States invests over 2.5% of its GDP in R&D, China around 2.4%, and South Korea also makes significant investments. This gap highlights the urgent need for India to increase its R&D intensity to remain competitive on the global stage. Moreover, the private sector's contribution to R&D in India is relatively low, accounting for only 35% of the total investment. This contrasts sharply with countries like the US and China, where private industry funds about 75% of R&D

activity. Strengthening private sector participation is vital for fostering innovation and driving technological advancements.

A robust R&D ecosystem is critical for India's ambition to emerge as a global innovation hub. Innovation not only helps develop new products and processes but also enhances the competitiveness of Indian companies across various sectors. The government's initiative is expected to stimulate research in key areas such as industry, science, engineering, and agriculture — sectors that are foundational to the country's economic growth and sustainability.

The initiative also envisions fostering collaboration between academic institutions, research organizations, and industry players, which is essential for translating research into viable commercial products. By bridging the gap between laboratory discoveries and market-ready innovations, the foundation hopes to create a seamless pipeline that accelerates technological adoption and economic growth.

In conclusion, the Union Cabinet's approval of the Anusandhan National Research Foundation marks a pivotal step toward revitalizing India's research and innovation ecosystem. By increasing funding, encouraging private sector involvement, and supporting research across diverse sectors, this initiative aims to position India as a global leader in science and technology. The success of this program could redefine India's research capabilities and fuel sustained economic development in the years to come.

# Science in the Hills: Empowering Mountain Children Through Local Museums

In the shadow of India's mighty Himalayas lies a generation of curious minds brimming with questions but lacking access to the tools needed to explore them. For students growing up in remote mountain communities, science is not an abstract concept—it is lived daily through landslides, erratic rainfall, snowmelt, and seasonal water shortages. Yet, these natural phenomena often remain unexplained and underexplored, especially in regions where educational infrastructure is limited.

As India pushes ahead in its journey of science, technology, and innovation, it must pause to ask: Are we reaching every child, regardless of geography?

## Mountain Education: Rich in Experience, Poor in Access

In the rugged, high-altitude landscapes of states like Himachal Pradesh, Uttarakhand, Sikkim, and across the North-East, schoolchildren often walk miles to reach government schools perched on hillsides. Classrooms, where available, are modest. Science labs are rare. Frequent weather-related disruptions like snow, landslides, and isolation further hinder learning.

Despite these challenges, mountain children grow up closely connected to nature. They watch rivers swell with snowmelt, see vegetation shift with changing altitudes, and notice how climate patterns affect their crops and daily lives. Their world is a natural science lab, yet formal scientific exposure is minimal.

What these students need is not just access to textbooks, but to immersive experiences. This is where science museums, designed with mountain realities in mind, play a transformative role.

#### Science Museums: A Gateway to Understanding

For many children from remote areas, a science museum visit becomes their first encounter with a microscope, a telescope, or a physics demonstration. For a student who's only read about gravity, seeing it demonstrated through interactive exhibits can ignite a lifelong interest. A child who has experienced earthquakes or seen disappearing springs can finally understand the geology behind them.

One student from rural Himachal Pradesh shared, "I've seen cloudbursts and snowmelt all my life, but I never knew why they happened.



After the museum visit, I finally understood what I've been witnessing." These are the moments when curiosity becomes inquiry, and inquiry becomes possibility.

Creating Equity Through Scientific Access
Science museums in mountain regions are
more than learning spaces—they are bridges
to equity. They provide:

- Hands-on learning for students with no lab facilities.
- STEM exposure for children who've never seen a research centre.
- Contextual exhibits on biodiversity, climate, seismic activity, and indigenous knowledge.
- A platform for local engagement, making science relevant to lived experiences.
   Crucially, they send a powerful message: sci-

ence belongs to everyone, no matter where they live.

#### A Model for the Nation

A successful example is the science museum on the outskirts of Shimla. Backed by the Himachal Pradesh Government and academically supported by Shoolini University, it has welcomed thousands of students from far-flung areas. With interactive exhibits and mountain-specific themes, it has become a vibrant hub of learning and inspiration.

#### The Path Ahead

It's time to replicate this success across India's hill states. Imagine centres in Sikkim, Arunachal Pradesh, or remote Uttarakhand—designed for local ecosystems and cultures, offering workshops, training, and mentorship. These centres could become catalysts for both scientific curiosity and community development.

The mountains are home to some of India's most observant and resilient students. Let's ensure they are also among its most empowered.







## **BJP Demands Apology from Kharge Over 'Distasteful' Remark on President Murmu**

- Congress chief accused of anti-tribal, anti-Dalit rhetoric
- BJP says comments insult highest constitutional office

The Bharatiya Janata Party (BJP) on Tuesday launched a scathing attack on Congress president Mallikarjun Kharge, demanding a written apology for his remarks allegedly disrespecting President Droupadi Murmu and former President Ram Nath Kovind. BJP spokesperson Gaurav Bhatia accused Kharge of making a "distasteful and derogatory" statement that insults tribal and Dalit communities.

Speaking at a rally in Raipur, Chhattisgarh, Kharge had questioned the BJP's intent behind elevating leaders from marginalised communities to top constitutional posts. "Yes, you made Murmu ji and Kovind ji President, but for what? To snatch our land, our forests, our water?" Kharge had said, referring to alleged exploitation of tribal areas.

Responding, Bhatia said the remarks re- Kharge's comments have drawn sharp flect the Congress's "anti-Adivasi and anti-Dalit DNA." He also alleged that Kharge was a "remote-controlled president" act-

ing at the behest of Rahul Gandhi, the Leader of the Opposition in the Lok Sabha.

Bhatia claimed that such remarks aim to portray President Murmu — India's first tribal woman President — as complicit in land-grabbing, a baseless and insulting allegation. "This is not just disrespect to one individual but to the dignity of the President's office," he said.

The BJP spokesperson pointed to past incidents, including a written apology by Congress MP Adhir Ranjan Chowdhury for similar remarks, and demanded Kharge issue a written apology as well.

Accusing the Congress of attacking every constitutional institution, Bhatia said, "From the Prime Minister to the Election Commission, the Congress has left no office untouched."

# **RSS Declares All Indian Languages as National Amid Hindi Imposition Row**

In the wake of an escalating language controversy in Maharashtra and Tamil Nadu, the Rashtriya Swayamsevak Sangh (RSS) has issued a clarifying statement, asserting that it does not support the imposition of any single language and considers all Indian languages as national languages.

The statement, made during a recent internal meeting of the RSS, comes as the implementation of the 'three-language formula' under the New Education Policy (NEP) has sparked political tensions. Opposition leaders have accused the central government of attempting to promote Hindi at the cost of regional languages.

In Maharashtra, the controversy led to the withdrawal of two government resolutions related to the three-language policy after widespread protests. Critics claimed the policy was an indirect attempt to diminish the status of Marathi. In response, Chief Minister Devendra Fadnavis clarified that the government was not against any language, including Hindi. He also alleged that the initial push for Hindi in schools originated during former CM Uddhav Thackeray's tenure.

Following the rollback, the Maharashtra government declared October 3 as Abhijat Marathi Bhasha Diwas (Classical Marathi Language Day), commemorating the recognition of Marathi as a classical language in 2024. Officials said the initiative aims to deepen linguistic research and cultural pride.

In Tamil Nadu, Chief Minister MK Stalin celebrated the Maharashtra government's retreat as a victory against the "Hindi imposition agenda" of the BJP. Congratulating both Uddhav and Raj Thackeray, Stalin said the anti-imposition movement had now become a national struggle, led by parties like the DMK.

Meanwhile, the RSS also used its meeting to discuss future directions, including expanding grassroots outreach and preparing for its centenary celebrations. Leaders emphasized unity and cultural diversity as foundational principles of Indian identity.



#### **Delhi Airport Ranked 9th Busiest** in the World in 2024, Marks **Major Milestone for India**

The Indira Gandhi International Airport (IGIA) in Delhi has been ranked the world's 9th busiest airport in 2024, according to data released by Airports Council International (ACI). This marks a notable rise from its 10th place position in 2023 and underscores India's growing significance in global aviation.

In 2024, IGIA handled 7,78,20,834 passengers, based on enplaned and deplaned travelers. Passengers in transit were counted only once. This growth comes amid a global surge in air travel, with total passenger traffic reaching a record high of 9.4 billion — an 8.4% increase from 2023 and 2.7% higher than pre-pandemic levels in 2019.

The world's busiest airport in 2024 remained Atlanta's Hartsfield-Jackson (USA), handling over 10.8 crore passengers, followed by Dubai International (9.2 crore), and Dallas/Fort Worth (8.7 crore). Other airports in the top 10 include Tokyo Haneda (4th), London Heathrow (5th), Denver (6th), Istanbul (7th), Chicago O'Hare (8th), and Shanghai Pudong (10th).

Delhi's climb to 9th place is seen as a landmark achievement for India's aviation sector. In terms of aircraft movements, IGIA also improved its global position, rising two spots to 15th with 4,77,509 total flights handled in 2024. Atlanta again led in this category with 7,96,224 movements.

Globally, aircraft movements crossed 100.6 million in 2024, reflecting a 3.9% annual increase. The top 20 airports alone accounted for 11.08 million movements, up 5.4% year-over-year.

ACI represents 830 members operating over 2,180 airports across 170 countries. Its Director General, Justin Erbacci, highlighted the aviation industry's resilience and ongoing growth despite global challenges.



#### Ludhiana bypoll win people's endorsement of Mann govt's work in Punjab: Kejriwal

Aam Aadmi Party (AAP) chief Arvind Kejriwal on Monday hailed the party's recent bypoll victories in Punjab and Gujarat as a strong endorsement of its governance and a preview of bigger wins in the 2027 assembly elections.

Speaking at a 'Dhanwad Sabha' (thanksgiving rally) in Ludhiana, Kejriwal celebrated the party's win in the Ludhiana West assembly bypoll, where AAP candidate Sanjeev Arora defeated Congress nominee Bharat Bhushan Ashu by over 10,000 votes. The by-election, held on June 19, was necessitated by the passing of AAP MLA Gurpreet Bassi Gogi earlier in January.

Kejriwal credited the victory to the work of Punjab Chief Minister Bhagwant Mann's government over the last three years. "This win is the public's stamp of approval for the work done in Punjab — in education, healthcare, roads, electricity, water supply, and drug de-addiction," he said.

Targeting the Congress and BJP, Kejriwal alleged that both parties had nothing to offer the people apart from opposing his potential nomination to the Rajya Sabha. "While we talk about real issues, they spread false rumours to distract the public," he said.

Referring to another key bypoll in Gujarat's Visavadar constituency — a BJP stronghold — Kejriwal noted that the AAP candidate's victory by over 17,000 votes had rattled the ruling party. He alleged that in response, the BJP arrested an AAP MLA "out of frustration." Kejriwal termed the Ludhiana and Visavadar bypoll results as "semi-finals" ahead of the 2027 assembly elections in Punjab and Gujarat. He confidently asserted that AAP would form the government in both states with a sweeping majority.

## Close to making deal with India, says Trump amid fresh tariffs on 14 countries

U.S. President Donald Trump has announced that the United States is on the verge of finalizing a trade agreement with India, even as his administration escalates trade tensions with 14 other countries by imposing steep new tariffs.

Speaking at the White House on Monday ahead of a dinner with Israeli Prime Minister Benjamin Netanyahu, Trump stated, "We're close to making a deal with India. We've already made deals with the United Kingdom and China. Other countries couldn't reach an agreement, so we just sent them letters—either you pay the tariffs, or there's no deal."

The Trump administration issued letters to 14 countries, including Japan, South Korea, Malaysia, Bangladesh, and In-



donesia, detailing new tariff rates effective August 1. Japan and South Korea will face 25% tariffs, while Laos will see the highest at 40%. Cambodia and Thailand will be taxed at 36%, with other countries such as Serbia, Bangladesh, and South

Africa facing between 30% and 35%.

These letters also warned countries not to retaliate by raising their own import duties or face even more severe Trump claimed that these nations had been "ripping off" the U.S. with exorbitant import duties and said the new tariff regime was encouraging companies to relocate to the United States. "Some countries were charging 200% tariffs. What we're doing is forcing fair trade," he added.

In a controversial remark, Trump reiterated his past claim that he stopped a potential war between India and Pakistan earlier this year. "They were maybe at a nuclear stage. We told them we won't trade if they keep fighting," Trump asserted, referencing tensions following India's Operation Sindoor on May 7.

Trump also criticized the ongoing Russia-Ukraine conflict, blaming President Biden, and again floated his desire to receive a Nobel Peace Prize for his foreign policy efforts.

#### **Pakistan Denies Receiving External Military Support During Four-Day Conflict with India**

Pakistan Army Chief General Asim Munir has strongly rejected claims that Pakistan received military assistance from external powers during the recent four-day conflict with India, dubbed Operation Sindoor. Addressing the media in Islamabad, General Munir called such assertions "factually incorrect and misleading," emphasizing Pakistan's independent operational capabilities and national defense preparedness.

The remarks come in response to comments made by Indian Army Deputy Chief Lt. Gen. Rahul R. Singh, who had suggested that China had provided active military support to Pakistan during the brief but intense confrontation along the Line of Control. Lt. Gen. Singh's statement stirred diplomatic ripples, especially as tensions remain high following the conflict, which saw cross-border artillery exchanges and limited aerial operations. General Munir firmly dismissed these allegations, stating, "Pakistan's armed forces conducted operations independently, without any military aid or involvement from foreign governments. Our defense strategy remains autonomous, and our response was guided solely by the situation on the ground."

Pakistan's Foreign Ministry echoed Munir's stance, warning against "irresponsible rhetoric" and urging regional players to avoid escalating tensions through unverified claims. Analysts in Islamabad have noted that while China and Pakistan maintain strong strategic relations, there is no credible evidence to suggest direct Chinese involvement in the conflict.

The four-day engagement, which took place in late June, marked one of the most significant military flare-ups between India and Pakistan in recent years. While both sides have since stepped back, the political and strategic aftershocks continue to unfold. As diplomatic efforts resume through back-channel talks, Islamabad has reiterated its commitment to regional peace but stressed that it will not tolerate "baseless accusations" that undermine Pakistan's sovereignty or distort the reality of military engagements.



#### Japan's \$1 Trillion **Trade Gamble on Trump Backfires as Tariffs Loom**

Japan's attempt to court favor with former U.S. President Donald Trump through a massive investment pledge has unraveled, as Washington prepares to impose steep new tariffs on Japanese imports. The move comes as a blow to Prime Minister Shigeru Ishiba's administration, which had hoped to shield key sectors—especially agriculture—from U.S. pressure.

When Ishiba met Trump in February, he offered a \$1 trillion investment commitment into the U.S. economy. Trump welcomed the pledge and declared there would be "no problem whatsoever" in reaching a favorable trade agreement, praising the "fantastic relationship" between the two nations.

In the months that followed, Japan's trade negotiators remained cautious, aiming to avoid concessions on politically sensitive imports such as U.S. rice. Tokyo hoped the goodwill from the investment promise would buy time and shield them from harsh trade measures.

Instead, that strategy has backfired. Last week, Trump lashed out on social media, calling Japan "spoiled" and accusing it of avoiding fair trade by refusing to buy enough U.S. rice. On Monday, he officially informed Ishiba that the U.S. would impose 25% tariffs on Japanese imports starting August 1.

"It's a sign of Trump's frustration," said Kazuhiro Maeshima, a foreign policy expert at Tokyo's Sophia University. "He sees Japan as resistant, and now he's using tariffs to force compliance." The announcement leaves Tokyo with few viable options to protect its export-driven economy. The tariffs could severely impact key sectors, including automotive and electronics, and further strain U.S.-Japan economic ties.

## 'Forging peace as we speak': Netanyahu nominates Trump for Nobel Peace Prize

Israeli Prime Minister Benjamin Netanyahu has nominated former U.S. President Donald Trump for the Nobel Peace Prize, citing his role in recent joint strikes on Iranian nuclear facilities and ongoing efforts to broker peace in the Middle East. The announcement came during a dinner at the White House Blue Room on July 7, 2025, where the two leaders met to celebrate the military operation and discuss a proposed 60-day ceasefire in Gaza.

## India Eyes July 8 Trade Deal Deadline with U.S., May Extend to August if Terms Fall Short

New Delhi, July 8- India is aiming to finalise a limited trade agreement with the United States by July 8, but sources indicate the timeline could stretch to August 1 if the current deal terms don't meet India's expectations.


U.S. President Donald Trump had earlier announced a 90-day pause on his April 2 tariff plan—dubbed 'Liberation Day' tariffs—which imposed duties of up to 40% on certain imports. Without a deal in place, Indian exports could face tariffs of around 26% once the pause ends at midnight on July 8.

However, Indian officials say they will not rush into an agreement that doesn't serve national interests. "We are still operating under the July 8 deadline," said a senior government official, "but if the specifics aren't suitable, we can use the extended August 1 window." Notably, India is not among the 14 countries that have received formal tariff warning letters from the U.S.

President Trump confirmed ongoing talks with India, saying, "We are close to making a deal with India." He added that while deals have been struck with the UK and China, others may face tariffs if negotiations fail.

A mini trade deal with India has been under discussion for months. A team of Indian negotiators led by Special Secretary Rajesh Agrawal recently returned from the U.S., having submitted India's final proposals. India is not expected to revise its position further.

Key sticking points remain: the U.S. wants India to holding firm on protecting its core interests.

#### **Adani Power Acquires Vidarbha Industries Power, Targets** 30,670 MW Capacity by 2030



dani Power Ltd. (APL) has success-Adam Power Liu. (Art) has successfully completed the acquisition of Vidarbha Industries Power Ltd. (VIPL) for ₹4,000 crore, marking a significant step in the company's strategy to strengthen its base-load power generation capacity. The acquisition, confirmed by APL on Tuesday morning, follows the approval of its resolution plan by the National Company Law Tribunal (NCLT), Mumbai Bench, on June 18, 2025. The implementation was finalized on July 7.

VIPL, which operates a 2×300 MW coalfired power plant in Butibori, Nagpur district of Maharashtra, was undergoing the Corporate Insolvency Resolution Process (CIRP) under the Insolvency and Bankruptcy Code (IBC).

With this acquisition, Adani Power's total operational capacity now stands at 18,150 MW. The company stated that the addition is aligned with its broader mission to transform underperforming or stressed assets into productive power

generators.

"This acquisition is a key milestone in our journey to unlock value through the revival of stressed assets," said SB Khyalia, CEO of Adani Power Ltd. ## **SEBI Study Reveals** 41% Surge in **F&O Losses for Individual Traders** in FY25



Tndividual traders in India's **L**equity derivatives segment (EDS) incurred a staggering net loss of ₹1.06 lakh crore in FY25, marking a sharp 41% increase from ₹74,812 crore in FY24, according to a recent study by the Securities and Exchange Board of India (SEBI).

The study, covering trading activity between December 2024 and May 2025, analyzed profits and losses of individual traders using data from the top 13 stock brokers. These brokers collectively represent about 96 lakh unique traders in EDS, out of approximately 107 lakh across the entire market.

Despite the increasing popularity of futures and options (F&O) trading among retail investors, the SEBI study found that the risks continue to outweigh the rewards for most participants. A staggering 91% of individual traders continued to report net losses in FY25, a percentage nearly unchanged from the previous financial year.

"The study indicates that net losses of individual traders widened significantly by 41%, reaching ₹1,05,603 crore in FY25, even after accounting for transaction costs," SEBI noted.

This latest data comes amid growing concerns over the rapid rise in speculative trading by inexperienced retail investors, often driven by social media trends and the illusion of quick profits. While derivative markets are essential for hedging and risk management, SEBI has consistently warned that they carry substantial risks for individual investors who may lack sufficient knowledge or capital.

The findings are expected to add urgency to ongoing regulatory discussions around curbing excessive retail participation in high-risk F&O trading. SEBI is reportedly considering stricter risk disclosures, higher margins, and investor education initiatives to protect small investors from unsustainable losses in the derivatives space.

**T**ndian equity markets **⊥**showed signs of recovery on Tuesday after a cautious start, as investor sentiment improved following U.S. President Donald Trump's statement that a trade deal with India is nearing completion. After opening weak, the BSE Sensex initially dipped 121.55 points to 83,320.95, and the NSE Nifty slipped 37.15 points to 25,424.15. However, both indices soon rebounded. The Sensex rose 86.13 points to 83,526.55, while the Nifty gained 19.75 points to reach 25,481.05 in morning trade.

## **Capgemini to Acquire WNS for \$3.3 Billion, Signals New Era of Tech Industry Consolidation**

 $P_{\text{7, 2025} - \text{Capgemini}}^{\text{aris/Mumbai,}} \text{July}$ has announced the acquisition of India-born business process management (BPM) firm WNS for \$3.3 billion in cash, a move that analysts say could shake up the global consulting and tech services landscape, particularly challenging the dominance of the Big 4 — Deloitte, PwC, EY, and KPMG.

The deal, unanimously approved by the boards

of both companies, is expected to close by the end of 2025. Capgemini will pay \$76.50 per share for NYSE-listed WNS — a premium of 28% over its 90-day average share price.

Industry experts say this acquisition could mark the beginning of a fresh wave of consolidation in the tech and BPM sectors, particularly as firms prepare for the



sweeping impact of artificial intelligence

"This gives Capgemini a powerful new position in competing with the Big 4," said Phil Fersht, CEO of HFS Research. "The integration of WNS could create an ideal platform to develop Services-as-Software solutions to target the \$1.5 trillion market emerging from AI-led transformation."

Peter Bendor-Samuel, founder of Everest Group, called the move a "return to Capgemini's acquisition-led growth model" and said it could set off a chain reaction of strategic mergers and acquisitions across the industry.

WNS brings deep domain expertise, a strong North American and UK client base, and strategic sourcing capabilities, especially from its 2017 acquisition of Denali. Analysts say Capgemini can now offer end-to-end trans-

formation services at price points below those of traditional players.

Capgemini CEO Aiman Ezzat said the deal positions the group to lead in AI-powered "Intelligent Operations," while WNS CEO Keshav R. Murugesh noted that enterprises are now "shifting from automation to autonomy" with AI embedded at their core.





#### **170-Foot-Tall Tazia Collapses on Power Line During Muharram Procession in UP, No Injuries Reported**



Amassive 170-foot-tall Tazia, a symbolic replica of Imam Hussain's tomb, collapsed during a Muharram procession in Uttar Pradesh's Lakhimpur Kheri on Sunday, causing widespread panic among thousands of attendees. The incident occurred around 4:30 PM at the Karbala ground in the Sadar Kotwali area of Banwaripur.

Captured on CCTV, the Tazia was in the process of being lifted when it suddenly tilted and fell, crashing into an 11,000-volt high-tension wire. Fortunately, there were no casualties or injuries reported, as power supply in the area had been cut off in advance, preventing a potential disas-

Visuals from the scene showed three towering Tazias—each around 170 feet tall—standing in the procession. As one of them lost balance, people nearby were seen scrambling to avoid being hit. Made from bamboo and adorned with color-

ful paper and cloth, such large Tazias are central to Muharram processions, commemorating the martyrdom of Hazrat Imam Hussain, the grandson of Prophet Muhammad.

Police and emergency teams rushed to the location following the collapse. Deepak Tiwari, the local police station in-charge, confirmed that the situation was brought under control quickly, and the event continued peacefully.

Muharram, one of the holiest months in the Islamic calendar after Ramadan, began on June 27 this year. It marks a 10-day mourning period culminating in Ashura, observed in memory of the Battle of Karbala.

The incident raised concerns about safety protocols during such large religious gatherings, though the prompt response by organizers and authorities helped avert a major tragedy.



"I think the pressure tennis players handle is insane. The only comparable intensity for us is an India-Pakistan World Cup match or a semifinal or final," said Kohli. "Your legs are literally shaking in those moments. But tennis players face that kind of pressure from the quarterfinals onward week after week."

He applauded the composure and physical demands tennis demands, saying he has "tremen-



dous respect" for players who maintain that mental sharpness and fitness continuously.

Kohli also pointed out that tennis allows players the chance to bounce back mid-match—unlike cricket where "one mistake and you're out, and then you spend the rest of the day clapping from the pavilion."

Comparing environments, Kohli remarked on the unique intensity of Wimbledon's Centre Court. "Even though cricket stadiums are massive and full of energy, they're less intimidating than tennis arenas like Centre Court, where fans are seated almost right on top of you."


