### Microsoft to Launch R&D Hub in **Quantum Valley**

Amaravati: In a major boost to India's tech aspirations, global tech giant Microsoft is all set to establish a Quantum Research Center in Amaravati, Andhra Pradesh. As part of the ambitious "Quantum Valley" project, the AP government has initiated talks with several global players—talks with Microsoft have now reached an advanced stage, with a formal MoU expected to be signed soon.

The upcoming Quantum Valley in Amaravati is envisioned as the country's first and most powerful quantum computing hub. Tech majors like IBM, TCS, and L&T are collaborating to build India's most advanced quantum computer—powered by the 156-qubit Heron Processor, also known as Quantum System-2.

Slated for inauguration on January 1, 2026, the Quantum Valley is being developed under the National Quantum Mission with support from the central government. It will house quantum computer manufacturing units, research incubators, data centers, and state-of-theart tech parks. Industry experts call it a "game-changer" for India's future in deep tech.

Microsoft's entry into the project is expected to further elevate the Valley's profile. The company plans to build a dedicated facility spread across 4,000 sq. ft within the tech zone. With its deep expertise in AI, cloud, and advanced computing, Microsoft aims to push the boundaries of quantum technology and scale innovation from India.

Only a handful of countries—such as the US, China, France, Canada, and Finland—currently have a foothold in quantum computing. India's move to establish its own high-end infrastructure, backed by global leaders like Microsoft, signals its serious intent to compete on the world stage.

## **Special Committee** on Banakacharla...

Will Talks Water Down the Dispute?

In a key meeting convened by Union Water Resources Minister CR Patil at Shram Shakti Bhavan in Delhi, the Chief Ministers of the two Telugu states—Chandrababu Naidu and Revanth Reddy came face-to-face amid growing tensions over the proposed Godavari-Banakacharla linkage project. However, Telangana Chief Minister Revanth Reddy clarified that the contentious project did not even come up for discussion.

### Revanth Reddy: "Banakacharla Wasn't on the Agenda"

Addressing the media after the meeting, CM Revanth Reddy said, "The proposal to build the Godavari-Banakacharla project from Andhra Pradesh was not even on the table. So, the question of opposing it does not arise." He made it clear that this was not an Apex Council meeting and added that both states agreed to form a committee of engineers and officials to address Krishna and Godavari water disputes. Revanth also emphasized that the meeting's objective was to sort out pending issues, not stir up fresh controversies.

Taking a swipe at his predecessor, he accused KCR of having surrendered Telangana's rightful water share during the BRS regime. "We are now trying to undo the damage," he said. Telangana's focus in the meeting remained on securing national status for the Palamuru-Rangareddy, Dindi, and Ichampalli projects on the Krishna River and obtaining necessary permissions for pending works.

#### Chandrababu Naidu: "AP Has the Right to Surplus Water"

Meanwhile, Andhra Pradesh CM Chandrababu Naidu stood firm on his state's claim over surplus Godavari water. In a separate meeting with Union Home Minister Amit Shah, Chandrababu asserted that AP, being at the tail end of the Godavari River,





### **Gandikota Girl's Death** Still a Mystery

Kadapa: The tragic death of 17-year-old Intermediate student Vaishnavi near the historic Gandikota has sparked a flurry of speculation and investigation, with police now stating that her boyfriend Lokesh is not involved in the murder, nor was there any sexual assault, contrary to initial fears.

According to police, Lokesh took the minor girl to Gandikota around 8:30 AM on Monday but returned alone by 10:40 AM. When Vaishnavi's family discovered she hadn't gone to college, they grew suspicious. Fearing trouble, Lokesh allegedly abandoned her at the spot and fled. Later, Vaishnavi's relative Surendra reportedly went to Gandikota as well. What happened between then and her death remains unknown.

DIG Praveen, who visited the location with the SP, said that crucial clues have been gathered and a special investigation team, along with a dog squad, has been deployed. The girl's body was found unclothed, leading to initial fears of sexual assault. However, forensic findings ruled out any such act, said the DIG.

Police are also looking into the possibility of honor killing or other motives, and have not ruled out questioning the girl's family. CCTV footage from the Gandikota area is being analyzed for leads. The death has stirred emotional reactions locally, with many questioning how a minor girl was left alone in such a remote location. Despite multiple twists and claims, the case remains unresolved. Authorities assure the culprits will be identified soon.

### **Jagan Fires Back: "Kootami** Won't Last 3 Years"

Amaravati: In a fiery press conference that shook the political stage, former Andhra Pradesh Chief Minister and YSRCP Chief Y.S. Jagan Mohan Reddy came out all guns blazing against the NDA coalition government in the state. Accusing the current regime of vendetta politics, fake promises, and systematic suppression, Jagan predicted that the coalition government "won't survive beyond three

Jagan declared that five lakh pensions were removed under the coalition regime and questioned why 30 lakh mothers haven't received the "Talli Ki Vandanam" scheme. "Is it a crime to ask for the ₹1,500 promised to women?" he asked. He also lambasted the government for ignoring farmers, failing to provide schemes like Annadata Sukhibhava or input subsidies. On mango prices, he accused the government of ruining farmer livelihoods due to delayed procurement and lack of planning.

#### Police Misused, Officers Humiliated

Calling it the "worst misuse of police machinery," Jagan said the current administration has created a mafia-like situation in the police force. "DIGs are behaving like dons. Cops are collecting bribes and funneling them to politi-



cians," he alleged.

He further said that IPS officers like Siddharth Kaushal were forced to leave as they refused to bend to dirty politics. "Over 100 inspectors and hundreds of constables remain in VR, with senior officers suspended or without postings," Jagan added.

#### On Mango Farmers and Protests

Jagan slammed the arrest of protesters at Bangarupalyam. "Is standing with distressed mango farmers a crime?" he asked. "Despite cases, notices, and arrests, people came out in thousands. It shows who they trust," he

said, claiming YSRCP is the only true opposition in the

is entitled to utilise surplus flows that continue for 90 to 120 days even after upper riparian states are served. He explained that the Polavaram-Banakacharla linkage is a well-intentioned plan to divert surplus water to the drought-hit Rayalaseema region. "This is not just about politics—it's about delivering water to regions that have suffered for decades," he reportedly told the Union Minister.

#### Uttam Kumar Reddy: "AP Agrees to Telemetry—Finally!"

Telangana Irrigation Minister Uttam Kumar Reddy, who also attended the meeting, said Andhra Pradesh has agreed to install telemetry systems at all major reservoirs and canals to monitor water usage. "They've finally agreed—on a war footing," he said, adding that Telangana is even willing to fund the installation if the Centre doesn't.

He blamed the previous Telangana administration for neglecting this crucial technology and said the current government is committed to ensuring full transparency in Krishna River water usage.

#### Nimmala Ramanaidu: "Positive Vibes and Productive Talks"

Andhra Pradesh Irrigation Minister Nimmala Ramanaidu described the meeting as a landmark step in Telugu state relations. "The talks were held in a positive atmosphere. We discussed the technical merits of the proposals. Most importantly, it was decided to keep the Krishna River Management Board in Amaravati and the Godavari Board in Hyderabad," he said. He also confirmed that a special committee would be formed by Monday to specifically address the Banakacharla issue.

While there was no clear resolution on the Banakacharla project itself, the tone of the meeting suggested a willingness to work through institutional channels. For now, it's a wait-and-watch situation as both states dig into their positions—with water, politics, and parched lands hanging in the balance.

## **Chandrababu meets Union Sports Minister Mandaviya**

Chief Minister Chandrababu Naidu has urged the central government to extend support for setting up a world-class badminton training centre in Amaravati. On the second day of his visit to Delhi, the CM met with Union Minister for Youth Affairs and Sports, Mansukh Mandaviya. The Chief Minister discussed key projects and infrastructure plans needed to boost sports development in the state.


He highlighted the opportunity to establish a National Water Sports Training Hub in Amaravati and explained the potential for setting up water sports training centres along the banks of the Krishna river. The CM informed the Union Minister that the state government has already submitted multiple proposals related to sports infrastructure and development projects.

He shared proposals to set up National Centres of Excellence at Nagarjuna University and in Kakinada. He also requested the timely completion of infrastructure projects under the Khelo India scheme in Tirupati, Rajamahendravaram, Kakinada, and Narasaraopet.

The Chief Minister also sought ₹27 crore funds for upgrading the Indira Gandhi Stadium in Vijayawada, ₹170 crore funds for developing a multi-sports complex at the BR Stadium in Guntur, and ₹341 crore funds for the overall sports development across various regions of the state.

He also stressed upon the additional Khelo India Centres to be sanctioned for identifying talented sportspersons at the district level. The CM further proposed that the Centre should consider establishing a Sports Authority of India training centre in Tirupati, located in the Rayalaseema region.

He stated that under the Andhra Pradesh Sports Policy 2024-29, the state has initiated important steps to build a comprehensive sports ecosystem. The CM expressed his gratitude to Union Minister Mandaviya for considering Andhra Pradesh as the host for the Khelo India Martial Arts Games 2025, adding that these games will be conducted at top-tier venues in cities like Vijayawada and Visakhapatnam. He also urged the Centre to sanction ₹25 crore for hosting the Khelo India Martial Arts Games.



### **Permit Rooms Back in Focus!**

Kovvur: In a bid to boost revenue, the Excise Department in East Godavari is once again pushing for permit rooms beside liquor shops. Reliable sources say a proposal has been sent to the government suggesting the move could generate income starting this September.

Last year, the government earned ₹28.849 crore through private applications under the liquor policy. But with the current liquor shop permits valid till next year, there's no scope for fresh application fees this cycle. So, the Excise Department is now exploring other income routes — and permit rooms top the list.

Throwback to 2014, permit rooms beside liquor shops were legal, with fees ranging from ₹5 lakh in municipalities to ₹7.5 lakh in corporations. Though the last government's cabinet sub-committee rejected this proposal, the lack of income this time around may tilt the scales in favour.

Meanwhile, in reality, illegal permit rooms are already operating in full swing. In Kovvur, at least three liquor shops have set up massive sheds at the back, openly catering to drinkers. If official permits come through, it's good news for tipplers — but a nightmare for the police.

Already, these unofficial sheds are hotspots for brawls and law-and-order issues. Gone are the days when a police siren would scatter drinkers. Now, they sip boldly, and if things go overboard, scuffles erupt — even full-blown chaos at times.

If the government gives a green signal, the police may find themselves on a tightrope. Act tough, and the reply will be: "This is a licensed room, we paid the fee!" On the flip side, staying silent means letting chaos grow.

Worse yet, many liquor shop owners reportedly belong to the ruling party — making enforcement even more complicated. For the police, it's a classic catch-22: damned if you do, damned if you don't. One thing's certain — stormy days lie ahead for the lawkeepers if these permit rooms become official.

## Chandrababu Seeks ₹10,000 Cr from Centre Under SASCI

Chief Minister N. Chandrababu Naidu has urged the Central Government to allocate ₹10,000 crore to Andhra Pradesh under the Special Assistance Scheme for Capital Investment (SASCI). During a meeting with Union Finance Minister Nirmala Sitharaman in New Delhi on Wednesday, Chandrababu requested financial support for ongoing and pending state development projects, especially for the capital city Amaravati and revenue deficit compensation.

The Chief Minister highlighted that Andhra Pradesh continues to suffer due to the financial imbalance created after bifurcation. He appealed to the Union Government to recognize and settle the state's revenue deficit under the recommendations of the 16th Finance Commission.

Referring to Amaravati's development, Chandrababu said the capital construction would require a total of ₹79,280 crore, of which ₹44,351 crore is currently proposed for execution. So far, the state has managed to mobilize ₹26,000 crore. He urged the Union Minister to release the second installment of funds for Amaravati as a grant.

The CM also reminded the Finance Minister ity. about the pending commitments for the Polavaram irrigation project, emphasizing that both Amaravati and Polavaram are crucial



for the state's long-term growth and stabil-

Thanking the Centre for past assistance to Amaravati and Polavaram, Chandrababu stressed the need for continued support to rebuild Andhra Pradesh as per the promises made in the AP Reorganization Act. He reiterated that timely financial aid would help fast-track infrastructure development, create jobs, and restore investor confidence.

### **PVN Madhav Meets** Media, Vows Collaborative **Progress**

BJP Andhra Pradesh State President PVN Madhav held an informal, friendly interaction with print media journalists on Tuesday, engaging in a two-hour long candid conversation. The meeting was marked by cheerful exchanges and a positive atmosphere, with wide-ranging discussions covering key state and national issues.

Responding to queries, PVN Madhav stated that the development of Andhra Pradesh under the NDA coalition would be clearly visible within the next four years. "My journey will continue to shape party workers into capable public representatives at the grassroots," he said. He highlighted that many engineering graduates in the state are struggling due to lack of employment, often forced to migrate to neighboring states despite Andhra Pradesh having vast resources and potential. "With the NDA government in place, investments are flowing in, and opportunities are expanding," he added.

PVN Madhav stressed the need for establishing a Mango Board in the state to boost agri-economy and ensure export infrastructure. He also pointed out the importance of spice cultivation in regions like Araku, where special focus is needed.

On Prime Minister Narendra Modi's governance, Madhav said, "Every scheme under Modi ji's leadership is implemented with the intention of helping the poor, not promoting names. Unlike previous regimes, Modi avoids political branding in welfare schemes."

He appreciated the positive public response to BJP's Vaaradhi program in AP and noted that BJP public representatives are now in a stronger position to raise important issues in the Assembly. Madhav also announced that the party would soon launch special initiatives for Denotified Tribes in the state.

### Krishna-Godavari Talks Fruitful, Says Nimmala

New Delhi: A high-level meeting on Krishna and Godavari river water sharing, chaired by Union Jal Shakti Minister C.R. Patil, was held in New Delhi on Wednesday. The meeting was attended by Andhra Pradesh Chief Minister N. Chandrababu Naidu, Telangana Chief Minister Revanth Reddy, water resources ministers from both states, Central Water Commission (CWC) officials, engineers, and irrigation officers.

Andhra Pradesh Water Resources Minister Nimmala Ramanaidu said the talks were held in a friendly and cooperative atmosphere and led to concrete agreements on three major issues concerning inter-state river water management.

First, both states agreed to install telemeters to monitor outflows from major reservoirs into canals. This measure will help ensure accurate and transparent tracking of water discharges, fostering trust and cooperation between the states.

Second, the two governments reached a consensus to jointly protect and maintain the Srisailam project, a vital lifeline for both states and a shared Telugu heritage. They agreed to promptly implement the recommendations of the CWC and expert engineers regarding structural repairs and protection of the plunge pool.

Third, the long-pending issue regarding the location of river management boards was resolved. It was mutually decided that the Krishna River Management Board (KRMB) would be headquartered in Amaravati, while the Godavari River Management Board (GRMB) would function from Hyderabad.

### **Palangi Post in** Limbo: JSP's Hunt **Continues**

In the Undrajavaram Mandal, Jana Sena Party is still grappling with internal chaos over the appointment of the Palangi Society Chairman. Of the 10 society positions distributed under the TDP-JSP alliance, JSP was allocated three—Tadiparru, Palangi, and Satyavada. TDP secured the remaining seven.

While JSP cadres fought hard to claim five societies, they had to settle for three. Their main issue? Lack of strong candidates—a fact many inside the party are unwilling to admit.

Of the three JSP-assigned societies, Palangi has become the knot that refuses to untie. Days of deliberations, negotiations, and backchannel deals have gone nowhere. The candidate remains a mystery. A major setback came when a JSP MPTC member tried and failed to bag a society in a known TDP stronghold. The party even approached a leader from a dominant community, previously aligned with YSRCP, to switch sides and take the post. However, he reportedly declined, throwing JSP's plan off balance. Meanwhile, a local JSP TC leader is said to be making a power push—insisting the Palangi post go to "his person" and claiming the selection happens only under his watch. To cement this, he's lobbying aggressively through a close associate of a key state-level figure and even using the personal aide of a prominent minister's relative, sources say.

Allegations are also swirling in Savaram village that large bribes are being offered for the post. The buzz is loud in the streets—money is being used to tip the scales. By Wednesday, 9 of the 10 society chairmen had been finalized. Only Palangi remains stuck in a whirlpool of lobbying, money talk, and internal one-upmanship. If the current course continues, what should have been a routine appointment might soon turn into a stain on the party's credibility.

### **Hindupur Set for Industrial Growth: Minister Anagani**

### **Govt Buys Tobacco** for First Time in AP

Addanki: In a first-of-its-kind initiative, the Andhra Pradesh coalition government has begun direct procurement of tobacco from farmers. State Ministers G. Ravikumar (Power) and K. Acchannaidu (Agriculture) inaugurated a new Nallaburley Tobacco Procurement Centre at the Santamaguluru Agricultural Market Yard in Addanki constituency.

Speaking at the inauguration, Minister Gottipati Ravi said, "For the first time in India's history, a State government is directly purchasing tobacco. We allocated ₹270 crore for this effort. Similarly, ₹4 per kg was given additionally for mango crop purchases. Our goal is to stand by farmers in times of distress caused by market fluctuations due to bumper crops of tobacco, cocoa, and mango this season."

Highlighting the coalition's welfare initiatives, the minister said ₹4,000 pensions are being distributed to 65 lakh beneficiaries and that ₹33,000 crore was allotted for pension distribution. Free gas cylinders under the Deepam 2 scheme are also being given every four months, with free bus travel for women starting from

## Ableism vs. Special Needs: Policy Challenges and Social Misconceptions in Work and Education

The terms "ableism" and "special needs" represent two distinct yet interconnected concepts that profoundly shape individual experiences globally, often leading to discrimination. While "special needs" refers to a physical, mental, intellectual, or sensory requirement that, in interaction with various barriers, may hinder full societal participation, ableism is the discrimination and social prejudice against individuals with special needs, rooted in the belief that typical abilities are superior. This pervasive ideology manifests overtly and subtly, creating significant challenges within governmental policies and fostering widespread social myths, particularly in education. Addressing these issues is crucial for building truly inclusive and equitable societies.

At its core, ableism assumes non-special needs individuals represent the ideal human form, implying that those with special needs require "fixing" or are inherently "less than." This belief perpetuates a negative view, framing special needs as "Disability", a flaw rather than a natural variation of human experience. Ableism ranges from hostile acts like bullying to benevolent but damaging attitudes that view individuals with special needs as vulnerable or objects of pity. Systemically, it is ingrained in societal norms and power structures, often operating unconsciously, making its identification and resolution challenging.

A critical lens for understanding special needs and societal challenges is the social model. Unlike the medical model, which views special needs as an individual deficit, the social model posits that challenges arise from societal barriers. These barriers, not the individual's condition, limit participation. For instance, a person using a wheelchair is not inherently limited by their mobility, but by the absence of ramps or accessible transportation. This perspective shifts responsibility to society to adapt and remove obstacles, rather than labeling individuals as "disabled." The very terms "disability" and "disable" are problematic; instead of defining individuals by what they cannot commonly perform, we to achieve tasks differently, recognising them as "differently abled."

A glaring challenge lies in creating and maintaining inaccessible environments and curricula. Policies often fail to mandate universal design in public spaces, transportation, and digital platforms, leading to physical barriers like stairs without ramps, inaccessible toilets, a lack of audio descriptions on videos and images, or complex online services incompatible with assistive technologies. This systemic oversight excludes differently abled individuals from essential services, employment, and civic participation. Historically, policies were overtly discriminatory, such as the eugenics movement or denying voting rights. Even today, policies indirectly discriminate through insufficient funding for accommodations in education, healthcare, and employment, or through complex bureau-

Conversely, some are viewed as "inspirational" simply for navigating daily life, a phenomenon termed "inspiration porn," which reduces their experiences to a spectacle. These stereotypes strip individuals of autonomy, leading to overprotection, condescending attitudes, and assumptions about their inability to lead fulfilling lives or be productive. Microaggressions, subtle verbal or behavioral slights like ableist language or invasive questions, toll on mental health. The cumulative impact of ableist governmental policies and pervasive social misunderstanding is profound. Individuals with special needs face higher rates of unemployment, poverty, and isolation. It is 99% for people with blindness and equal for deaf also. They encounter significant barriers to quality education, healthcare, and community participation. Disturbingly, hundreds of crores of rupees allocated annually for Children with Special Needs' education often evaporate into salaries and programmatic expenses, yielding nothing on educational equity or excellence. A major portion of these funds, including CSR funding, goes to NGOs running special schools, often perpetuating a cycle where children remain dependent, fit for pensions rather than becoming tax-paying cit-

The constant battle against systemic barriers and prejudiced attitudes leads to chronic stress, mental health challenges, and diminished quality of life. Moreover, society suffers from this exclusion, missing out on the diverse talents, perspectives, and contributions that differently abled individuals offer. In conclusion, distinguishing between special needs as a lived experience and ableism as a discriminatory ideology is fundamental to fostering a just world. The challenges embedded in governmental policies—from inaccessible infrastructure to discriminatory practices—and the widespread social misunderstanding perpetuated by harmful stereotypes and microaggressions collectively create formidable barriers to the full inclusion and equality of differently abled people. Overcoming these challenges requires concerted effort: governments must enact and rigorously enforce truly inclusive policies, ensuring universal accessibility and equitable opportunities. Simultaneously, societal attitudes must undergo a transformative shift, moving away from pity and prejudice towards genuine respect, understanding, and recognition of differently abled individuals as diverse, capable, and integral members of the human community. accumulate daily, taking a significant By centering their voices and experiences, we can dismantle ableist structures and build a truly accessible and equitable future for all.

### Mohan Bhagwat's 'Retire at 75' Remark: What It Really Means for Modi and BJP

RSS chief Mohan Bhagwat's recent statement that leaders should consider stepping down after the age of 75—has set off intense political speculation, particularly as Prime Minister Narendra Modi approaches that milestone on September 17 this year. Delivered in Hindi during a largely Marathi speech, Bhagwat's remark was clearly deliberate, not a slip. Yet, it would be premature to interpret it as a direct signal to Modi.

The BJP, especially in its relationship with the RSS, has often followed its own path. History shows us that even strong suggestions from the Sangh do not automatically lead to immediate changes. For example, in 2005, then-RSS chief K.S. Sudarshan publicly urged Atal Bihari Vajpayee and L.K. Advani to make way for younger leadership. Though his comments were criticized at the time, they



Today, the BJP's internal structure is among the most meritocratic in Indian politics. Its leaders have consistently promoted younger talent—be it in choosing young chief ministers or party presidents. Modi himself was a product of this system, rising to national prominence after his successive electoral victories in Gujarat.

Importantly, there is no official "75-year rule" in the BJP. While some senior leaders like Advani

and Murli Manohar Joshi were sidelined at that age, others continued to hold roles as ministers or governors. Even Hema Malini was fielded in 2024 despite being over 75, indicating that the socalled rule is flexible.

If Bhagwat himself retires on his 75th birthday, September 11, that could reignite conversations within the party. But a challenge to Modi is high-



eventually paved the way for a new generation ly unlikely. His dominance in the BJP-RSS ecosystem is such that he will determine his own timeline. Modi, who remains physically fit and politically strong, is expected to lead the BJP into the 2029 elections, by which time he'll be 79 around the same age as Donald Trump now.

> While ambitious leaders may already be quietly preparing for a post-Modi era, any transition will happen on Modi's terms, not due to a public nudge from the RSS. The countdown to September may be politically charged, but Modi's position remains firmly unshaken—for now.

### **Elon Musk and the America Party:** Can 'Vibes' Disrupt U.S. Politics?

On July 4th, while Americans celebrated independence with barbecues and fireworks, Elon Musk launched something entirely different — a political party. Spurred by an online poll where over a million users voted "yes" to his question about forming a new party, Musk declared the birth of the "America Party." But is this a serious political force or just another impulsive startup wrapped in memes and ambition?

Musk, never shy about grand ventures from Mars colonies to robotaxis — now aims to disrupt American politics. He claims the two dominant parties form a corrupt "Uniparty" and that the America Party is a path to reclaim independence. His message resonates with voters tired of conventional politics, but critics argue it's more about Musk's ego than a viable political movement.

His fallout with Donald Trump only intensifies the spectacle. Once allies, Musk and Trump now trade barbs over taxes, debt, and electric vehicles. Musk, disillusioned by recent Republican spending, pledged to fund primary challengers and create a political alternative. However, the America Party lacks registration, infrastructure, and candidates — it's more mood than machine.

Still, Musk's resources are formidable. With billions at his disposal, control over the social media platform X, and a devoted fanbase, he could sway close elections by focusing on a handful of Senate or House races. It's a strategy similar to Ross Perot's in the 1990s, whose third-party bid briefly led in polls before fizzling out.

The real challenge lies in America's political



system. Strict ballot access laws, state-bystate requirements, and entrenched party loyalties make it hard for third parties to succeed. Movements built around one figure often collapse without a clear platform. So far, Musk's message seems to be "no taxes, more memes, trust billionaires who launch rockets."

Democrats watch with cautious amusement, hoping Musk's insurgency splits conservative votes. But the deeper truth is that American politics is shifting. Musk's rise symbolizes a generational fracture — between traditional conservatism and a tech-driven, anti-establishment ethos.

Whether the America Party becomes a real force or another billionaire fantasy, one thing is clear: in 2025, the boundary between political disruption and digital spectacle is vanishing fast — and Musk is surfing the

### Govt Launches ₹1.44 Lakh **Crore Farm Push by Merging** 36 Schemes under PM Dhan-Dhaanya Krishi Yojana

In a major agriculture sector reform, the Union Cabinet on Wednesday approved the launch of the Prime Minister Dhan-Dhaanya Krishi Yojana (PMD-DKY), a consolidated national programme aimed at boosting farm productivity, promoting sustainable practices, and strengthening rural livelihoods. Announced in the 2025 Union Budget, PMDDKY brings together 36 schemes across 11 Ministries into one integrated framework. The scheme will have an annual outlay of ₹24,000 crore for six years, totaling ₹1.44 lakh crore, and is expected to benefit over 1.7 crore farmers nationwide.

Union Minister Ashwini Vaishnaw, while briefing the press, said the scheme marks a "first-of-its-kind convergence model" dedicated exclusively to agriculture and allied sectors. "It will address gaps in post-harvest storage, irrigation, credit availability, and promote natural farming," he said.

### **Key Features of PMDDKY:**

- Focus Areas: Productivity enhancement, soil and water conservation, crop diversification, promotion of organic and natural farming, and increasing farmer self-reliance.
- District Targeting: 100 districts with low productivity, cropping intensity, and credit penetration will be prioritized. Every State/UT will have at least one selected district.
- Governance Structure: District, State, and national-level committees will oversee implementation. Each district will create a District Agriculture and Allied Activities Plan, approved by a District Dhan Dhaanya Samiti, including progressive farmers.
- Monitoring: Monthly progress reviews and alignment with national goals of sustainable agriculture and value-chain development.

The programme is modelled on the Centre's Aspirational Districts Programme, aiming to transform underperforming agricultural areas through collaborative efforts involving local governance and private partners.

Experts welcomed the scheme but suggested refining the district selection criteria. Abhishek Jain, Director at CEEW, noted, "While the focus on sustainability and value addition is commendable, reliance on low credit disbursement as a key indicator may misguide district selection. A shift to metrics like net farm income per hectare would be more appropri-

### 'Uddhav Ji Can Join Ruling Party': Fadnavis Jibes at Thackeray During Farewell Speech in Council

A pointed remark during the farewell of Shiv Sena (UBT) leader Uddhav Thackeray from the Maharashtra Legislative Council, Chief Minister Devendra Fadnavis suggested that Thackeray consider switching sides, saying the current government will not face opposition status "at least till 2029."

Speaking during the session, Fadnavis said, "At least till 2029, there is no scope of us coming there [Opposition]. Uddhav ji can think about coming to this side [Ruling party]. That can be thought about differently, but there is absolutely no scope of us coming to the opposition."

The dig comes in the backdrop of long-standing tensions between the ruling BJP-Shiv Sena alliance and the Thackeray-led Shiv Sena (UBT), which has been in the opposition since the 2022 political upheaval in Maharashtra.

The veiled invitation appears to be both a jab and a strategic nudge, as Thackeray remains a key opposition figure amid shifting political alliances ahead of the 2029 Assembly polls.

Meanwhile, addressing the Question Hour in the Council, Fadnavis highlighted achievements in tracking missing persons. Under 'Operation Muskaan', 41,193 missing children have been traced to date. In 2025 alone, 'Operation Khoj' helped recover 4,960 women and 1,364 children.

The Chief Minister also emphasized that a Missing Cell has been set up in every police station,



led by senior female officers. He added that coordination between the state and central governments is being strengthened via the Missing Persons Portal, ensuring real-time data updates across departments.

Fadnavis' dual focus on governance and political commentary during Thackeray's farewell set the tone for Maharashtra's evolving political landscape — one that may still see surprises before 2029.

### Y.S Jagan Advocates English as **Medium of Instruction Across India**

Former Andhra Pradesh Chief Minister and YSRCP President Y.S. Jagan Mohan Reddy has called for English to be adopted as the medium of education in all schools across India, stating it is essential for the country's prog-

Amid ongoing debates on the alleged imposition of Hindi, Jagan said, "Hindi can be learned, but the medium of education must be English. It is the global language. Until students in government schools are fluent in English, they cannot compete on equal footing."

Speaking to the media, Jagan emphasized that English should be the foundation of education nationwide. However, he maintained that mother tongue must remain the first language, with Hindi or any other language as the second or third, based on student choice. "There's nothing wrong in learning Hindi," he added, recalling that it was the first language in the school he attended.

On state issues, Jagan raised alarm over the future of the Godavari-Banakacherla project, expressing concern over Chhattisgarh's plans to harness water from the Indravati River, a key tributary of the Godavari. He warned this could reduce water availability for Andhra Pradesh, especially if the Polavaram dam height is restricted to 41.72 meters.



The YSRCP leader accused Chief Minister Chandrababu Naidu of compromising on the Polavaram dam issue, insisting that the dam's height must reach 45.72 meters to allow surplus water to be diverted to the Krishna River. If the Centre restricts funding beyond 41.72 meters, Jagan demanded the state raise ₹15,000 crore to complete the project to its full potential, safeguarding Andhra Pradesh's long-term water security



### **Trump Plans 10%+ Tariffs on Goods from Africa, Caribbean, and Over 100 Smaller Nations**

U.S. President Donald Trump announced on Tuesday that his administration is preparing to impose tariffs of "a little over 10%" on imports from more than 100 smaller countries, including many in Africa and the Caribbean.

Speaking to reporters, President Trump stated, "We'll probably set one tariff for all of them," referring to countries that the administration sees as having minor trade volumes with the United States. Commerce Secretary Howard Lutnick added that these countries represent a relatively small portion of overall U.S. trade and would not significantly impact Trump's broader goal of reducing global



trade imbalances.

The new tariff policy is expected to take effect on August 1, part of a larger trade agenda nations, including members of the European Union, outlining new import tax rates. This follows the April 2 tariff hike that rattled financial markets and

The administration has also announced 30% tariffs on goods from the EU and Mexico, beginning August 1, marking one of the most aggressive trade policy stances in U.S. history.

In addition, President Trump hinted at upcoming tariffs on pharmaceutical products, likely to be announced by the end of the month. He also noted plans for graduated tariffs on computer chips, allowing companies a year to relocate manufacturing to the U.S. before facing steeper import duties.

This sweeping tariff initiative signals a renewed push for trade protectionism and domestic manufacturing, aligning with Trump's long-standing "America First" economic agen-

Alberta Premier Danielle Smith has called on Canadian Prime Minister Mark Carney and his cabinet to formally designate the Lawrence Bishnoi gang as a "terrorist entity," citing the gang's growing influence in international organized crime and violence within Canada.

In a post shared on X (formerly Twitter), Smith described the Bishnoi gang as a "transnational criminal network" involved in violent crimes, extortion, drug trafficking, and targeted killings. She emphasized that the gang's global reach and operations pose a significant threat not only abroad but also within Canadian borders.

"The Lawrence Bishnoi Gang is a transnational criminal network responsible for violence, extortion, drug trafficking, and



targeted killings, including here gang "know no boundaries and in Canada. Its reach is global, and its intent is criminal and violent," Smith stated in her message.

Premier Smith underscored the urgent need for action, asserting that organized criminal networks like the Bishnoi

respect no borders." She added that Alberta wants to send a strong message: "You are not welcome here.'

By officially labeling the Bishnoi gang as a terrorist entity, Smith said law enforcement agencies at both provincial and municipal levels would gain stronger legal tools and resources to crack down on the group's operations more effectively. "Formally designating the Bishnoi Gang as a terrorist entity will unlock critical powers," she explained.

The Premier urged the federal government to act swiftly and decisively to protect Canadians from rising organized crime threats, calling on PM Carney to stand united with Alberta in combating transnational gangs.

Lawrence Bishnoi, the gang's alleged leader, is currently in Indian custody, facing multiple charges including links to the high-profile murder of Punjabi singer Sidhu Moose Wala in 2022. The gang also claimed responsibility for the 2024 assassination of Indian politician Baba Siddique.



### 'Tell Putin to get serious or face sanctions'

NATO Secretary General Mark Rutte has issued a stern warning to countries like India, China, and Brazil, cautioning them about potential "massive" secondary sanctions if they continue business with Russia amid the ongoing war in Ukraine.

Speaking with reporters during a visit to the US Congress, Rutte said these countries risk serious economic consequences unless they pressure Russian President Vladimir Putin to commit to peace talks. "If you live in Beijing, or in Delhi, or you are the president of Brazil, you might want to take a look into this," Rutte said, urging these nations to reconsider their ties with Moscow.

Rutte's comments came a day after former President Donald Trump, who has re-emerged as a major influence on US foreign policy, announced new military aid for Ukraine and threatened 100% secondary tariffs on any country continuing trade with Russia unless a peace deal is reached within

"So please make the phone call to Vladimir Putin and tell him that he has to get serious about peace talks, because otherwise this will slam back on Brazil, on India and on China in a massive way," Rutte added.

While Trump's announcement was welcomed by some, Republican Senator Thom Tillis expressed concern over the 50-day delay, fearing that it could give Putin time to gain further ground in Ukraine. "We should make clear that any gains made by Russia in that window are off the table," he

Rutte confirmed that under a new transatlantic agreement, the US will provide Ukraine with a large shipment of weapons, including air defense systems, missiles, and ammunition, funded largely by European nations. He also hinted that both defensive and offensive weapons are being considered, though final decisions will be made in consultation with the Pentagon and NATO military leadership.

## China to hold SCO summit in Tianjin from August 31 to September 1: Wang Yi

Chinese Foreign Minister Wang Yi has officially announced that the Shanghai Cooperation Organisation (SCO) Tianjin Summit will be held from August 31 to September 1 this year. The announcement was made during a joint press briefing with SCO Secretary-General Nurlan Yermekbayev, as reported by China's state-run Xinhua news agen-

The summit is expected to see participation from key global leaders, including Indian Prime Minister Narendra Modi, Russian President Vladimir Putin, and other heads of state from SCO member countries.

Earlier in the day, the Foreign Ministers of the 10-member SCO convened for a high-level meeting aimed at laying the political groundwork for the upcoming summit. The gathering focused on strengthening multilateral cooperation across various sectors, and addressing regional and global security challenges, according to Chinese broadcaster CGTN.

Several key resolutions and official documents were signed during the meeting, reinforcing the SCO's commitment to regional stability and devel-

The meeting was presided over by Chinese Foreign Minister Wang Yi and included the presence of notable diplomats such as India's External Affairs Minister S. Jaishankar, Russia's Sergey Lavrov, Pakistan's Ishaq Dar, and Iranian Foreign Minister Abbas Araghchi.

The SCO, comprising India, China, Russia, Pakistan, Kazakhstan, Kyrgyzstan, Tajikistan, Uzbekistan, Iran, and Belarus, has grown into one of the world's most significant transregional organizations focused on economic, political, and security cooperation.

Ahead of the Foreign Ministers' meeting, the delegation had an audience with Chinese President Xi Jinping, who urged member states to strengthen internal mechanisms for dealing with emerging security threats and challenges.

As anticipation builds for the Tianjin Summit, the SCO continues to cement its role as a central force in shaping regional diplomacy and strategic partnerships across Eurasia.



### Israeli Airstrike Targets Syrian Military HQ Amid Sweida Clashes

In a dramatic escalation of regional tensions, the Israeli military confirmed on Wednesday that it launched a strike targeting the entrance of the Syrian regime's military headquarters in the capital city of Damascus. The strike reportedly hit near the Syrian defence ministry as well, according to Syrian security sources cited by Reuters.

The attack comes amid intense fighting in southern Syria, particularly in the Druze-majority city of Sweida, where clashes have erupted between Druze militias and Sunni Bedouin tribes. The Israeli military stated that its strike was in response to growing violence and instability in the region, particularly its concern for the safety of the Druze community.

"A short while ago, the Israel Defense Forces (IDF) struck the entrance of the Syrian regime's military headquarters in Damascus," read an official statement from the Israeli military. The statement did not elaborate on whether the strike caused casualties or the extent of damage inflicted.

The backdrop of this escalation is the breakdown of a fragile ceasefire in Sweida, where Syrian government forces have attempted to reassert control over areas previously under the influence of local Druze armed groups. The latest unrest began Sunday, when clashes between Druze fighters and Bedouin tribes—who have a long-standing history of conflict in the region—left over 100 people

In response to the escalating violence, the Syrian regime deployed reinforcements to Sweida, seeking to reestablish order. However, Israel claims its military intervention is a protective measure aimed at supporting the Druze community, a significant religious minority in Syria with deep historical and cultural ties to Israel.

The Druze sect, which originated in the 10th century as an offshoot of Ismaili Shiite Islam, has around one million adherents globally, with large populations in Syria, Lebanon, and Israel, including the contested Golan



The State Bank of India (SBI), India's largest public sector Lender, announced on Wednesday that it plans to raise up to ₹20,000 crore through the issuance of bonds during the current financial year. The move comes as part of the bank's capital-raising strategy aimed at supporting its business growth and maintaining adequate capital buffers.

The bond issuance will be made available to domestic investors, with SBI aiming to tap into the strong demand for high-quality debt instruments in the Indian market. These bonds are likely to be issued in tranches depending on market conditions and the bank's capital requirements. The funds raised will primarily be used to bolster long-term resources for infrastructure lending and general banking needs.

Following the announcement, SBI shares saw a notable uptick in trading. The stock climbed over 2% to trade at ₹833.55 per share on the National Stock Exchange (NSE) as of 2:19 PM on Wednesday. The rise in share price reflects investor optimism around the bank's growth trajectory and prudent capital management.

As per NSE data, the total market capitalization of the PSU banking giant now stands at approximately ₹7.44 lakh crore, cementing its position as one of India's most valuable banks. SBI is also a key component of the BSE Sensex, and any significant movement in its stock price tends to influence overall market sentiment.

This development comes at a time when Indian banks, particularly public sector lenders, are witnessing strong credit demand and improving asset quality. SBI has consistently shown robust financial performance in recent quarters, supported by healthy loan growth, better margins, and lower

Analysts believe that the bond issuance will enhance SBI's ability to lend further and maintain its leadership position in the Indian banking sector. Investors and market watchers will now keep an eye on the pricing and structure of the upcoming bond tranches as SBI moves ahead with its capital-raising plan in FY25.

### Sebi Reviewing Jane Street's Plea to Lift Trading Restrictions After ₹4,843 **Crore Deposit**

Mumbai: The Securities and Exchange Board of India (Sebi) is currently examining a request from global proprietary trading giant Jane Street to ease restrictions placed on it earlier this month. This development comes after the firm deposited ₹4,843.57 crore—allegedly gained through manipulative trading practices—into an escrow account with a lien in favor of Sebi.

The move follows Sebi's interim order on July 3, 2025, which had imposed several restrictions on Jane Street, including barring the US-based firm from participating in India's capital markets. The regulator had taken action based on findings of alleged manipulation and front-runsecurities.

According to regulatory sources, discussions between Sebi and Jane Street are still in the preliminary stage. The regulator is carefully evaluating the firm's formal request to revoke or relax some of the penal-

ning in a series of trades involving Indian ties imposed in the interim order. Any re-

lief granted would depend on the progress of Sebi's ongoing investigation, the cooperation shown by Jane Street, and assurances regarding future compliance.

Jane Street's deposit of nearly ₹4,844 crore is seen as a significant gesture toward complying with Sebi's directives. The funds, believed to represent the profits gained through the alleged trading misconduct, are now secured under Sebi's supervision. This is likely to be a key consideration as Sebi deliberates on whether to ease restrictions or allow limited access to markets.

Industry observers note that this case marks one of the most high-profile enforcement actions involving a major foreign entity in India's capital markets. It has also sent a strong message about Sebi's increasing vigilance and zero-tolerance approach toward manipulation. As of now, Jane Street remains barred

from trading or engaging in market activity in India. The firm, known for its algorithmic and high-frequency trading strategies globally, has not yet issued a public statement regarding the case.

Sebi is expected to issue a follow-up order after completing its review and receiving inputs from relevant stakeholders.

## **Gold Drops ₹200 to ₹99,370/10g; Silver** Falls Sharply by ₹3,000 to ₹1.12 Lakh/kg

New Delhi: Gold prices witnessed a marginal dip of ₹200 on Tuesday, settling at ₹99,370 per 10 grams in the national capital, as per the All India Sarafa Association. The decline was attributed to fresh selling by stockists, likely driven by global cues and profit-booking by investors ahead of key economic data.

On Monday, gold of 99.9% purity had closed at ₹99,570 per 10 grams, while gold of 99.5% purity also fell ₹200, reaching ₹98,800 per 10 grams from its previous level of ₹99,000.

Silver, meanwhile, experienced a steep fall of ₹3,000 per kilogram, dropping to ₹1,12,000/kg from the record high of ₹1,15,000/kg hit just a day earlier. This significant decline follows a sharp rally in recent sessions and comes amid heightened volatility in the global bullion markets.

According to Rahul Kalantri, Vice-President of Commodities at Mehta Equities, "Gold and silver witnessed sharp intraday volatility. Prices initially rose but later retreated from their highs as the US Dollar Index rebounded, prompting traders to book profits." He added that investor caution ahead of the US inflation data release has also added to the sell-off in precious metals.

In the international market, spot gold saw a modest rise, trading at USD 3,364.14 per ounce—up by USD 20.62 or 0.62%. Despite the price uptick, analysts noted that gold remains range-bound.

Chintan Mehta, CEO of Abans Financial Services, explained, "Safe-haven demand has risen slightly due to elevated geopolitical



and trade tensions. However, optimism around potential negotiations after former US President Donald Trump's announcement of a 30% tariff on imports from Mexico and the EU has limited gold's upward momentum."

Overall, analysts suggest that bullion prices may remain volatile in the short term, especially as global economic indicators and geopolitical developments continue to influence market sentiment.

## The Untold Story Behind the Rupee Symbol: Two **Architects, One Icon**

 $B_{ ext{dia}}^{ ext{efore}}$  2010, India didn't have a unique currency symbol. The abbreviation "Rs" was commonly used, but it lacked the distinctive identity that other global currencies like the dollar (\$), euro (€), or pound (£) enjoyed. That changed with the introduction of the rupee symbol (₹), a simple yet powerful design that now apfrom currency notes to mobile screens.

The winning design was created by Udaya Kumar, a

young and talented architect from Tamil Nadu. In 2009, the Indian government held a nationwide competition inviting artists and designers to create a symbol that reflected Indian culture and identity. Out of over 3,000 entries, Udaya Kumar's design stood out. His concept beautifully merged the Devanagari letter "风" (Ra) with the Latin capital letter "R", minus its vertical bar symbolizing a blend of Indian tradition and international appeal.

However, what most people don't know is that there were two key individuals in the running whose designs made it to the final stages. While Udaya Kumar rose to fame, the other design-



er, whose contribution was also highly praised, gradually faded into obscurity. The story recently resurfaced through a viral Instagram video that highlighted how one symbol came to represent India's financial identity—yet not everyone who contributed to it received recognition.

Udaya Kumar's rupee symbol was officially adopted in July 2010, marking a historic moment for India's economy. Today, it stands not just as a currency sign, but as a cultural icon. While the spotlight has largely remained on the winner, the journey and creativity of all participants played a role in shaping what the rupee symbol means to over a billion people today.

## Why Pilots Oppose Cameras in Cockpits: A Debate Reignited After AI 171 Crash

The tragic crash of Air India flight AI 171 on June 12 in Ahmedabad, which claimed at least 270 lives, has reignited discussions around cockpit safetv—and why many pilots are against having cameras inside the cockpit.

A 15-page interim report investigating the crash revealed that the Boeing 787-8

## **Health Warnings On** Samosa, Jalebi Soon?

health warnings on beloved Indian snacks like samosas, jalebis, and laddoos have caused quite a stir. However, the Press Information Bureau (PIB) has stepped in to set the record straight. In a post on X (formerly Twitter), PIB's factcheck unit dismissed these claims as false. It clarified that the Union Health Ministry has not issued any advisory mandating warning labels on street foods or traditional Indian snacks. "This claim is fake," PIB stated, adding that no such move has been made to target local vendors or specific food categories.

The clarification comes in response to viral reports that claimed government canteens and restaurants were being asked to display boards showing oil, sugar, and fat content in popular foods such as samosas, jalebis, burgers, pizzas, and soft drinks. These reports linked the move to the government's broader health push under the Fit India Movement.






